Indian Army chief General Bipin Rawat has been named India's first Chief of Defence Staff, said sources. An official announcement on the same, however, remains awaited, General Rawat was named the CDS just a day before he was to retire from service after completing a full three-year term as the Chief of Army Staff. The Union Cabinet on December 24, approved the CDS post and its charter and duties. The CDS will act as the Principal Military Adviser to the Defence Minister on tri-services matters.

Addressing a media conference after inspecting the Mid Manair project named as Sri Raja Rajeshwara Reservoir (SRR), KCR said the region could fill the Lower and Mid Manair projects with 50 tmc ft of water from Kaleshwaram without the need of SRSP waters

He said an additional 60 tmc ft would be filled in the barrages and the farmer in this region need not wait for the rains in the coming days.

The Chief Minister said that in 2001, he had dreamt of a

Medical colleges can now appoint private doctors, including overseas citizens, on part-time basis to teach MBBS and post-graduate students, according to a government notification.

The new regulations do not apply to all AIIMS institutions, PGI Chandigarh and JIPMER in Puducherry established under stand-alone Acts of Parliament, a senior health

ministry official said. The decision by the Board of Governors, which is vested with powers of the medical



education regulator MCI, is aimed at addressing the shortage of teachers in private and government colleges. The BoG has now incorpo-

rated a new clause by amending existing regulations on minimum qualification for teachers in medical institu-

tions. The teachers who would be hired on part-time basis would be called 'visiting faculty', according to the new reg-ulations titled 'Minimum qualification for teachers in medical institutions Regulations 2019'.

"With a view to enhance the comprehensiveness and quality of teaching of both undergraduate and PG students in pre-clinical, para-clinical and clinical departments, medical colleges/ institutions can appoint additional faculty on part-time basis who would be known as "visiting faculty," the notification read.

The onion prices, which have

jacked up for quite some time, are gradually easing. A month ago, a quintal of onion was traded anywhere between Rs 12,000- Rs 13,000, while it came down to RS 8,500-9,000 on Monday in the wholesale market here.

In the wholesale market, currently a kg of onions is priced between Rs 90-100 as against Rs 150-200 a month ago. The market here received imports for the past two days. According to a wholesale trader, the prices of onions are likely to decrease further after a fortnight.

Dacoits 'inspired' by chaddi gang, land in police dragnet

A joint operation, involving a Special Operations Team (SOT) from LB Nagar, the Central Crime Station and the Hayathnagar Police arrested a notorious inter-state dacoity gang on Monday. The officials seized valuables worth Rs 6.5 lakh from their possession. SUNBURN FESTIVAL Mystery shrouds death of Telugu youth in Goa

A Hyderabadi youth died under mysterious circumstances while partying at the three-day Sunburn Klassique at Goa on Sunday night. The death brings the total number of casualties at the electronic dance music festival to three as the incident comes just days after two men from AP died at the venue, also under suspicious circumstances.

The Congress party has demanded a SIT investigation headed by a retired High Court judge. According to Goa police, 24-year-old automobile engineer Phanideep Khota fell unconscious at 9:30 pm while dancing on Sunday at the venue on the last day of the festival. The revelers reported that Khota's friends took him to a first-aid centre set up by



the event organisers. When medical attendants found Khota unresponsive, they decided to shift him to a private hospital at Vagator. Due to a traffic jam caused by haphazard parking and lakhs of partygoers, it took them 30 minutes to cover 2 km to reach the hospital, where the doctors declared him brought dead. Khota worked as a sales

executive in Bengaluru but hailed from Hyderabad. Goa police said that Khota had arrived in Goa along with five other friends on December 28 to ring in the New Year. He stayed at a guesthouse in Calangute, a hotspot for domestic tourists.

son at Sunburn Klassique evoked a sharp reaction from Congress and GFP, demanding that CBI should conduct an inquiry. "The government is responsible for the deaths of three youngsters over the last two days," said GFP vice president Durgadas Kamat.

GFP's Šiolim MLA Vinod Paliencar had warned about drugs being available at music festivals and rave parties. The deaths of three men have once again brought the spotlight on the use of drugs and other illicit substances. On the first day of Sunburn, two vouths died while standing in a queue to attend Sunburn Klassique on December 27. Police said that both tourists - IT engineer Sai Prasad (32) of Hyderabad and Visakhapatnam-based businessperson Venkat (31) - were in Goa to attend the festival.

With no clear industrial policy in place even after the new government was formed, business activities have taken a backseat.

Moreover, the state government held up all the projects with a budget of over Rs 5 crore. Sand scarcity also stopped the construction sector in its tracks.

IT Minister M Goutham Reddy maintains that the big projects would take off and the industries are keen in it.

According to him, the TDP Government had allocated 136 acres of land near Tirupati to the Reliance group without verifying the plans properly as most of the land parcels were caught up in legal tangle. Hence, the state government had written to the group that alternative lands would be allocated elsewhere for the project in elsewhere for the project in the same area. "Many of the issues we owe to the legacy of the previous government. We assumed charge only months ago and we are sorting things out one by one," he said.

On Adani Data project, Ga-utham Reddy said: "We have asked the group to come up with a clear investment plan so that land parcels could be allocated in a phased manner. The group is very interested to set up its data centre in Vizag."

Citing the reason behind thoroughly going into the proposed projects, he said the allocation of lands to industries blindly without verifying their credentials had resulted in land crunch. Consequently, the state government is left with not enough land bank to

allocate to genuine players. Former president of AP Chambers of Commerce and Industry Federation, G. Sambasiva Rao said the year was not an encouraging one for the industry in AP.

Novel 'invisible ink' may help detect fake currency PNS GREATER NOIDA

Scientists at Shiv Nadar University here have developed a low-cost security ink that may help detect counterfeit currency, and could be employed in official documents and medical diagnosis.

The new ink, described in the peer-reviewed Journal of Physical Chemistry C, offers improved security features compared to existing inks that are multi-component and, therefore, more expensive, the researchers said.

These materials can be used in other applications, such as security signs, emergency route signs, traffic signage, in addition to medical diagnosis, and background-independent bio emitting probes, they said. "Our white security ink is

Sporting success

As the 2010s come to a close, we should celebrate a great decade for Indian sport and look forward to the 2020s

he 2010s began with a bang for Indian sport with its success at the 2011 Cricket World Cup. whose finals were held at the

Wankhede Stadium in Mumbai. The 2012 Summer Olympics held in London also saw India's best-ever haul with six medals, albeit we finished without a Gold. Things have been a bit disappointing since then. While the Indian men's cricket team tops the world rankings in Test series, it has faltered at the semi-final stages of the subsequent One-Day International World Cups and has also failed to win a second T20 World Cup to follow up from the 2007 win. However, the seismic impact of the 2007 win was felt in the creation of the Indian Premier League (IPL), which in the past decade has cemented its position as the leading franchise-based T20 tournament in the world. The Indian women's team has also enjoyed great success over the past decade with their appearance in the finals of the International Cricket Council's women's World Cup. But while this decade has cemented the adage that "India is cricket and cricket is India", it has also seen the emergence of new professional leagues that have enjoyed success as well as the rise of new champions in other sports. The premier Kabaddi League is a genuine success story, particularly in a traditionally Indian sport. On the flip side though, India's failure to win both kabaddi Gold medals, particularly in the men's competition at the 2018 Asian Games, can be attributed in part to the arrogance of newly-rich professional players. On the other hand, the emergence of champions like PV Sindhu has been a singularly impressive achievement. Her standing as World Champion must go down as India's greatest sporting success in the past decade. Alongside Sindhu stands boxer Mary Kom, who despite age and motherhood, is still a champion though she ended the decade on a sour note. Dipa Karmakar's heroic feat at the Rio Olympics, too, is noteworthy as was Sushil Kumar's World Championship in 2010, which gave a fillip to wrestling that has been taken forward by the Phogat sisters.

However, not everything was a success. The response to the Indian Super League in football and the Hockey India League was tepid at the very least and miserable at worst. India's reputation in certain sports, particularly weightlifting, has been tarnished, thanks to constant reports of serious doping. That said, drugs are an active problem throughout the world of sports. There have been serious issues with the Government's ambition to clean up Indian sports federations from its political patronage. Much still needs to be done on this front if India is to achieve its potential in the world of sports — football being a particular case in point. India enjoyed some success in the previous decade. After climbing inside the top 100 rankings in the sport, it has seemingly frittered away some of those gains in the last 24 months. Can India finally make a mark in football? The 2020s will show the way. It is likely that an Indian-born player may make it big for a major team in Europe, which could finally crack the market. At the same time, special mention should be given to the "Khelo India" programme and the games that have been ushered under the Narendra Modi administration. A focus on sports under capable Ministers has meant that India is looking forward to the 2020 Tokyo Olympics with a glimmer of hope previously unheard of. So much so that a double-digit haul is on the cards with Indian shooters, pugilists, wrestlers, badminton players and possible track and field athletes such as javelin ace Neeraj Chopra, all being in the race for medals. Expectations are that others will join Abhinav Bindra in the list of individual Indian Gold medallists. As for cricket, India has a packed year coming up. Will India finish the year as reigning ICC Test match champions? Can it make it count in the T20 World Cup to be held in Australia early next year? And where will the IPL and franchise cricket go in the coming months? Can other sports replicate the success of kabaddi? There are many questions that will be asked of Indian sports in the coming decade but we hope that whatever happens, it will only climb to heights never previously achieved.

Why we need data

Preparation of a NPR and decennial census is a legitimate activity of the Union Government and the data thrown up by these exercises form the basis for policy-making

he false propaganda unleashed by some political parties against the Citizenship Amendment Act, 2019, has now got extended to the mandated programme to prepare the National Population Register (NPR) and the conduct of the decennial census, which are scheduled for 2020 and 2021. Several opponents of the current establishment in New Delhi have been spreading disinformation about the NPR and the decennial census, both of which are tools essential for governance.

The purpose of the CAA is to provide citizenship to persecuted religious minorities in Pakistan, Bangladesh and Afghanistan, who crossed the borders and came into India before December 31, 2014. This has nothing to do with any Indian citizen, whatever be his or her religion. Nor does it open the floodgates for migrants because of the deadline fixed in the Act. The NPR and the decennial census are meant to get demographic information and also inputs on the social and economic status of the population in different regions of the country. Neither of these exercises is aimed at disenfranchising anybody.

The NPR exercise was formulated and introduced by the Congress-led United Progressive Alliance (UPA) in 2010, to collect demographic and biometric information about individuals. Here, enumerators go door-to-door and gather particulars about "usual residents" — individuals residing at a given place for the preceding six months. It is, therefore, strange to find that the Congress, the very initiator of this idea, is now opposing it and is doing so with such vehemence that it all looks like a theatrical act.

The census in India is primarily a head count and has been rightly described as the largest administrative and statistical exercise in the world. Three million individuals will be deployed to collect the data and for the first time, the enumerators will be using a mobile app and other modern applications to collect and collate data from the field.

The decennial census is being conducted in India since 1892 without a break and this is an important exercise from a national point of view because it tells us about the demographic changes that have taken place at the national and local level in the preceding 10 years. Both these surveys provide policy-makers critical data that enables them to formulate national programmes, especially with regard to basic amenities to the lessadvantaged sections of society.

No more welcome

Following internet shutdowns, the tourism sector is the latest victim of the Government's high-handedness



he Government may be consistently playing down the countrywide protests over the Citizenship Amendment Act (CAA) and the National Register of Citizens (NRC) as a conspiracy of intellectuals to jeopardise its legitimate existence. But with the protests showing no signs of abating — they have now turned into a people's movement over exclusionary and discriminatory policies that breed hatred and disunity ---- the clampdown on freedom of expression has been severe. So harsh that internet and mobile network shutdowns

have indefinitely become the order of the day. This has elicited strong admonitions and travel advisories against India, impacting our tourism business severely. For example, tour operators in Agra, the home of Taj Mahal, have unofficially reported a loss of about 50 per cent revenue during the holiday season. Nowhere has the clampdown been as draconian as it has been in Uttar Pradesh with over 19 people killed and more than 1,100 arrests. The visitors' count for December has been the most dismal. A paltry 4.5 lakh tourists arrived at Agra's Taj Mahal over the new year weekend, which is down from seven lakh the same month, last year. Tourists from the US, the UK, China, France and Japan are understandably cautious after reports emerged of foreign students being deported for extending moral support to protesters. Internet cafes, a favourite among young travellers to keep folks connected to them back home, are running dry.

As the tourists have been dissuaded from travelling to India — in part because the message from New Delhi has been that it will not buckle down and, instead, has sharpened its attack on anti-CAA protesters and tightened the noose of police action — their numbers fell well before November, when the crucial Ayodhya verdict was to be announced by the Supreme Court. The month, which saw a footfall of 6.7 lakh tourists last year, saw only 5.4 lakh tourists this year. Agra alone attracts over 6.5 million tourists every year, generating nearly \$14 million annually from entrance fees. Similar is the story elsewhere. Overall, the hospitality sector has been hit. Assam has already faced a loss of ₹400 crore. Mysuru saw a 20 per cent dip in tourism. Revenues for many hotels, tour operators and guides have plunged with many tourists, both domestic and foreign, either cancelling their trips or cutting them short. This is understandable. Protests are now dragging on into the second month and have shown little signs of abating even as the Government has issued "clarifications." There are plenty of signs of matters turning more violent as both police and marchers up the ante. The larger question, however, is whether the tourism sector will be able to absorb the damage once normalcy returns. For an industry, which the Government pegged as a growth driver even in a slowing economy, this is a bad sign. In this business, perception matters and the atithi is certainly not feeling welcome anymore.

The judiciary and the executive cannot be at loggerheads in a welfare State as it would make citizens jittery and lose faith in the system

he kind of storm which the Citizenship Amendment Act (CAA). 2019 has kicked up is, perhaps, unprecedented as it deals with the subject of future citizenship and not the current. The matter is now resting the opinion of the Supreme Court (SC) for its con-stitutional validity, which will hear 59 petitions filed in opposition of the law on January 22, 2020. It would be interesting to note whether the views of the judiciary and the executive would converge on an issue as sensitive as this one. In the case of Ayodhya, the apex court's verdict has established well that law cannot be detached from the interests of the people it serves. There was a raging debate whether the Ayodhya verdict was based on credible and admissible evidence or was it influenced by the faith and belief of the majority? Irrespective, the verdict was peacefully accepted by all the factions, not necessarily for its veracity but for bringing to end a painful impasse. What is clearly visible and undebatable is that it brought peace finally.


There would be peace if two conditions are fulfilled. One, the interests of the larger sections of the people must be put above all else. To punish a few guilty, we cannot make the masses suffer along with them. Second, there cannot be a chasm between the views of the executive and the judiciary, which would otherwise make citizens jittery and lose faith in the system altogether. Imagine being brought up by two warring parents.

This ethos of acting in public interest and going along with the views of the executive must now be extended to end pain in other areas as well. Take livelihoods as an example, where the case of Goans has been hanging for far too long. Goa was the only State where mining rights were granted to its citizens by the Portuguese Government in perpetuity, but were eventually revoked by the Indian Government. Ever since the apex court abruptly cancelled 88 mining leases in the State on February 7, 2018, life has come to a grinding, tragic halt for mining dependents in the State. This is now no longer just an eco-nomic crisis — which is severely debilitating in its own right — but a grave human crisis as well. Such is the situation that the Goa Government has requested a review of the ban by the SC, which is also pending. Jobs and livelihoods disappearing overnight as a result of judicial intervention is painful, particularly at a time when India is going through the worst employment crisis in the last 40 years. According to the National Sample Survey Office (NSSO), the country's employment reached the lowest rate in 2017-2018.

Earlier, in 2012, the SC cancelled 122 spectrum licences in response to a PIL filed by a host of activists and to answer the question whether the Government had a right to distribute natural resources in a manner that was not "fair and transparent." This affected 5.3 crore telephone connections. It was alleged that the exchequer lost ₹1.76 lakh crore in revenue and a few private telecom players were the beneficiaries. This case was highlighted as among the top 10 abuses of power by Time magazine. The verdict shook the country, changed the contours of a developing telecom industry, made new telecom operators wrap up their business and gave the reins of the sector into the hands of a few business groups.

In a reversal in 2017, a special court in New Delhi acquitted all the accused in the 2G spectrum case citing that the CBI could not find any evidence against the accused in seven years. As per the judgment, "Some people created a scam by artfully arranging a few selected facts and exaggerating things beyond recognition to astronomical levels." The matter now rests with the Delhi High Court on basis of appeals filed by the CBI and the Enforcement Directorate. The key question is as to why the case could not have been tried without cancelling the licences? The court should have allowed business to continue, while the case would have carried on. By invoking closure of business, the court caused collateral damage to the industry, the economy and most importantly to the livelihoods of people employed by the companies that had to close shop. Studies have established that India's Maoist movement is deeply rooted in socio-economic conditions prevalent in parts of India with large tribal populations. It has mostly affected areas where there is a conflict between the State and the populace on the economic derivation of forest produce and mining such as in Chhattisgarh and Jharkhand and agriculture in parts of Andhra Pradesh and Odisha. Such aggressive posturing by citizens has huge direct and indirect costs. The purpose of the law is to create a conducive environment for the citizens of the State. However, sometimes, like in the Goa mining ban and the spectrum case, the law and its interpretation has spelled doom for citizens and businesses. This cannot become a precedent and must be addressed immediately. Situations like these need more complex solutions, just like the CAA. It is simplistic to penalise lakhs of people for the actions of the few with the stroke of a pen, and it is certainly not done.

Since the early 1990s, there has been a sense of optimism with regards to India's econom-ic progress. The process of like with the progress. The process of liberalisation during 1991 brought with it a sense of hope regarding a dramatic turnaround in the country's economic fortunes. While the nation's growth did accelerate from the 1980s onwards, however, it wasn't comparable to other emerging economies, including China.

The first decade of the 21st century was believed to be India's time as it had a Government that was looking at the next generation of eco-nomic reforms. These transformations happened nomic reforms. These transformations happened and the country witnessed the first serious pri-vatisation of several public sector enterprises (PSEs) along with a drastic reduction in small savings rates. India's macroeconomic situation was stable and gradually growth started to increase along with its investment rates. This growth continued till 2007, after which it start-ed to lose steam due to lack of economic reforms ed to lose steam due to lack of economic reforms and then the 2008 crisis hit the country along with the rest of the world.

While many thought the impact of the 2008 crisis wasn't as much on India as elsewhere, the reasons behind this were the policy instruments which were deployed to address the risks that emerged. These instruments, combined with a lack of reforms and an entitlement-based regime brought a fresh macroeconomic challenge in the second decade of the 21st century.

Two decades have elapsed and India is yet to justify the sense of optimism that prevailed at the start of the century. But to be fair, the second decade wasn't that bad considering that India's growth in 2014, 2015 and 2016 was fairly decent even when one ignores the fact that it witnessed two successive droughts in 2014 and 2015. The country's macroeconomic situation has improved significantly since 2014 and the Government has undertaken several reforms that will have long-term growth implications such as the Goods and Services Tax (GST), the Insolvency and Bankruptcy Code (IBC) and the Real Estate (Regulation and Development) Act (RERA)

Clearly, India's got a problem on the monetary side, which needs to be rectified if it is aiming to grow at seven per cent or more. Some progress has been made on this by the RBI, however, it continues to be conservative and the longer it takes for it to recognise the extent of the problem, the more prolonged the bottom of the U.

Irrespective of these short-term challenges, the outlook for economic growth for the country in the mediumterm is completely positive as some of the current supply-side issues will get resolved and India will witness a growth of 5.0-5.4 per cent in the third quarter (Q3) of the current Financial Year (FY) followed by a 6.2-6.6 per cent growth in the fourth quarter (Q4) of the current FY. India will end the decade with a modest growth rate; however, the

will further augment productivity. There's also talk of a GST overhaul which may happen during the next couple of years. This, when combined with land, labour and agricultural reforms, will be critical to unlocking India's productive potential. Demographics, too, favour India as it has the world's largest workforce which will act as a check in wage costs, thereby giving it a competitive edge over other emerging market economies for the next two decades. All of this is essential to experience the kind of transformation that several of the country's peers experienced during the 1980s and 1990s.

Of course, fresh reforms will be required — but they are already on the agenda of the Government as the labour codes are coming into effect. Many of these reforms will be aided by the fact that there's a mandate of 303, which enables the Government to take decisions that would be extremely dif. ficult to push for in a divided Parliament. Global conditions, too, seem to be conducive for India as Boris Johnson's election in the United Kingdom (UK) will end uncertainty regarding Brexit. He has expressed his willingness to enter into a trade agreement with India and the nation should be closing trade deals with the UK, Europe and the US to further integrate itself into global trade. Global economic growth is also likely to recover in 2020, which means that external factors will be conducive for India's growth, provided it can address some of its domestic constraints. The year 2019 goes down in Indian economic history for many reasons. For starters, it marks the first time in the history of India where a reformist Government was brought back into power and that, too, with a

huge majority. This shows how electoral preferences are maturing in India.

The outcome of the election made it possible to take three significant economic decisions. First was the merger of 10 PSBs into four. This is likely to consolidate the sector and improve its efficiency over a period. It also opens up interesting possibilities for future privatisation of some of these big four banks as there's no need for having four big PSBs, especially at a time when the nation has already pumped in ₹3 tril-lion into them without any positive outcome so far.

The second was to do with the corporate tax cut, which was promised in the previous tenure. Indeed, many consider it just a tax cut, however, it is a deep structural reform that will have long-term positive implications for financial stability and financing of investments. More importantly, it illustrates a shift in thinking of tax now recognise that tax revenues can increase at lower rates due to improvements in tax compliance. The third decision was of privatisation of several firms, including BPCL. This is a bold move as it signals a staunch commitment to the phrase that "the Government has no business to be in business. This move has signalled to the world that India is finally opening greater space for private players in its economy, which has hit all the right notes. Índeed, a lot of economic progress was made in 2019 and some of it could be because of the slowdown. However, 2019 will mark a structural break for India as we enter into a decade which will certainly belong to the country's entrepreneurs and its economic ambitions. There were a few negative devel-

opments as well. Violent attacks on doctors, health care providers and facilities were reported from different parts of the country, followed by protests and strikes by the medical fraternity.

In the summer of 2019, encephalitis deaths were reported from Muzaffarpur in Bihar. The experts were once again divided on the cause of this and consequently, the children of the nation are still waiting for scientific and long-term solutions to prevent such tragedies

Hence, it is clear that there are many issues that need to be addressed in this crucial sector.

Legislative approach in health works: The Motor Vehicle (Amendment) Act, which has hiked the penalties for traffic violations, has the potential to improve health, as nearly one in every 10 preventable deaths occurred due to road accidents. After the Mental Healthcare Act of 2017, mental health services in India received a boost at the implementation level as the Insurance Regulatory and Development Authority directed companies to include mental health care services in their insurance package as one in every seven peo-

Beverages sweetened with sugar, including fruit juices, must be taxed as demerit goods at higher rates. And last but not the least, healthy behaviour should be encouraged at all levels, especially in schools and colleges, with ban on sale of "junk food" near schools and colleges.





Oil regulator seeks to rationalise gas pipeline tariff

Oil regulator PNGRB is seeking to rationalise natural gas pipeline tariff structure so as to increase usage of environmentfriendly fuel by aligning charges paid for transporting the fuel with the best global practices.

The Petroleum and Natural Gas Regulatory Board (PNGRB) is seeking bids for the appointment of consultants for the job, saying the government has envisaged ushering into a gas-based economy by increasing the share of the fuel in primary energy mix of the country from current level of about 6 per cent to 15 per cent by 2030.

This is to be done by increasing the availability of natural gas by enhancing domestic gas production, encouraging the



import of Liquefied Natural pipelines, with each having a different tariff. 

I come from a poor family and had to overcome many chal-lenges to be here. Hence each adventure I take part in is not just for the excitement and the thrills but also for change."

Speaking about his journey so far, Tukaram says, "It was the NCC (National Cadet Corps) that sparked the passion of mountaineering in me. But, I come from a background where financial stability is more or less a dream and hence sponsors are important to pursue such a goal. I knocked the doors of several benefactors only to get rejected. I even approached the state gov-ernment which initially agreed to fund me but later abruptly. to fund me but later abruptly rejected my plea. I faced this

problem until I found sponsors in private agencies." "Fortunately, the number of people who began to come forward with financial aid steadily grew with each peak I scaled. Now I have sponsors like Tridandi Sri Srimannarayana

Ramanuja Chinna Jeeyar Swamiji, RamachandruTejavath, a retired IAS officer and organi-sations like the NGO, Vikasa Tarangini, backing me on my upcoming expeditions," he adds.

Apart from the rigorous train-ing and planning that he has to undergo before each ascent, Tukaram is also aware of the risks and dangers that lie in his path. "The journey to the top teaches several life lessons. Any amount of grit and determination is futile in front of nature. I faced many challenges while climbing Mt. Everest. During the climb, I faced near-death situations several times, especially when I ran out of oxygen in my tank, and when I ran out of the water to drink. I even saw one of my friends die right before my eyes. That is the harsh reality of mountaineering. For me, it is always a do-or-die situation. I can't return to face my family and my sponsors If I can't suc-ceed. But it's through their bless-ing that I am able to succeed and

return home safely," he says. "Even after I climbed the Mt Everest I can't afford to undervalue the effort needed for my next expedition. That will only be my downfall. I believe it is important to never underesti-mate any challenge, and always be prepared for the worst case scenario," he says.

Mountaineer Malavath Poorna has recently scaled Mt Vinson Massif and has become the youngest tribal woman in the world to scale six tallest peaks in six continents, and is just one more mountain (Mt Denali, North America's tallest mountain) away from completing the seven-summit goal



Theatre in Hyderabad is booming today and several factors are being attributed to this upward trend.

Given the amount of effort put in by several theatre groups such as Samahaara, Udaan, Nishumbita, Sutradhar and several others the state of theatre and performing arts in the city a few years ago, Hyderabad has undergone a huge paradigm shift.

Towards the end of 2019, two annual largescale theatre festivals, the Natotsav and the Qadir Ali Baig Theatre Festival were received enthusiastically. The Natotsav, an annual festival presented by Nishumbita (Ballet & Theatre), included an extensive two-day workshop with Mahesh Dattani this year.

The niche that theatre has now begun to carve for itself has become more welcoming not just by professional adults who used to be the face of theatre for years, but

as well for the more experimental and creatively inclined age-group, youngsters. There has been a significant increase in the number of youngsters participating in theatre over the past few years.

"Several factors influenced the theatre culture in the city. One of those was the inflow of people from other states of the country where the theatre culture is already prevalent, into Hyderabad. These people were key to contributing to the then budding theatre in Hyderabad. Also, when we started the theatre festival in the city, theatre groups got a platform here in Hyderabad to showcase their performances while they could also network with other theatre groups," says Anjali Parvati Koda, founder of Samahaara theatre group.

"Another factor that is also drawing youngsters towards the theatre scene is that the new-age actors like Vijay Deverakonda and Punarnavi also had their beginnings in theatre here

Akhil Bhaneshwar who was an active member of the Nishumbita theatre group. "With the rise of several **THEATRE HAS BEGUN**

new groups in Hyderabad, youngsters now have access to theatre and cultural arts especially at a time when they understand the importance of theatre as an art form. And more and more theatre workshops are also being conducted across the city, thus giving the audience clarity about theatre as an art form and making it more relatable to youngsters," says Akhil who was an alumnus of the National School of Drama, Bangalore.

"Often times people who practice drama and theatre in their lives find it easier to cope with their daily stress as they get a boost of confidence while being able to witness an overall development in their capabilities. As refreshing as it is to see the youth coming forward to participate in theatre, it would be better if we could have people who could remain committed in the field," he concluded.







ing their comprehensive win in Perth. Cricket great Warne has championed Swepson and over the weekend flagged the idea of axing Lyon if selectors opt for one spinner in Sydney. "Just giving Mitchell Swepson a

taste of it, giving him a chance, I reckon it will pay dividends in the long run," Warne said.

But Lyon, who took four wickets on Sunday to wrap up late New Zealand second innings resistance, said there was no way he would be standing aside.

"Did Warnie ever want a rest and give Stuart MacGill a go?" he asked, noting the lack of opportunity given to Warne's leg-spin rival at the height of their careers.

"I won't be resting. I haven't met any Australian cricketers that would like to be rested

"It's that hard playing Test cricket, but it's that rewarding as well so every opportunity you get to play cricket for Australia it means the world to us. "So I can't imagine Mitch Starc, Pat

(Cummins) or Patto (James Pattinson) putting his hand up to say I need a rest.

Queensland's Swepson has been added to Australia's squad for Sydney, where conditions often assist slow bowlers, and was taking tips from Warne in Melbourne.

There is a chance that Australia will play two specialist spinners in the third Test, with the call to be made after Paine and selectors look at the pitch.

Swepson, who has taken 12 wickets from six Sheffield Shield games at 26.58, was a member of Australia's Test squad for tours of India and Bangladesh in 2017 but has yet to make his debut.

Lyon said if both of them played,

he would be more than happy. "Mitch has been bowling brilliant-ly for Queensland," he said. "He's a great fella to start off with, but he gives it a rip and that's what I really love to see. "I'm a big fan of Mitch, it's great to see him in and around our squad so he gets his chance and fingers crossed we can have a great combination togeth-

er. If Australia go down that road, they would almost certainly retain Cummins, Starc and Pattinson, meaning a batsman would be axed with Matthew Wade the likely candidate after Travis Head scored a century in Melbourne.

Du Plessis criticises 'big three' move

Oouth African cricket captain Faf du Plessis Sbelieves cricket needs more, not fewer, elite nations

Speaking after South Africa's 107-run win in the first Test against England on Sunday, Du Plessis was asked his opinion about plans for an annual 'Super Series' of one-day games, involving the socalled 'Big Three' of India, Australia and England, with one other country to be invited on a revolving basis.

"The last year or so you can see what's going on in terms of the big three countries," he said.

'There's a lot of movement going towards that, a lot more matches being played against the top three, or big three. It's probably better if you include more teams, the better to grow the game as much as vou can."

Du Plessis pointed out that there was inequality of fixtures, especially in Test cricket, with new Test nations such as Ireland and Afghanistan struggling to get fixtures. "There's a lot of smaller nations not playing a

lot of Test cricket, they're actually playing less," he said





Ailing NZ call up Somerville for third Test

Off-spinner Somerville, who was raised in Australia and played Sheffield Shield for New South Wales, will replace injured pace bowler Trent Boult for the Test starting in Sydney on Friday

Coach Gary Stead said the inclusion of the lanky 1.93 metre (6ft 4in) Somerville was a nod to the expected conditions at the Sydney Cricket Ground.

"There's no secret the SCG pitch is one of the more spin-friendly in Australia," Stead said.

"Will offers something different to our two other spinners in the squad with his right arm off-spin and height.

The fact he's played a lot of cricket in Sydney during his career for New South Wales will also be helpful an average of 23.14.

Tests, taking seven wickets on his debut against Pakistan in Abu Dhabi last year and a total of seven in two Tests away to Sri Lanka four months ago

Boult is returning to New Zealand after suffering a fracture to his right hand in the second Test which Australia won comfortably by 247 runs on Sunday within four days in Melbourne.

Australia won the first Test by 296 runs, again wrapping up the match inside four days.

New Zealand already have Matt Henry and Kyle Jamieson in the squad to provide fast bowling cover while Somerville's height and local knowledge could see him overtake the incumbent spinners Mitchell Santner and Todd Astle.

Somerville was one of the leading bowlers in Australia's Sheffield Shield in 2016-17 season with 35 wickets at
