SBI cuts interest rate on home loans

State Bank of India has again cut its lending rate making it more attractive for borrowers to avail loans from the bank. The quantum of cut is 25 basis points, from 8.05% to 7.8%. This new rate will be effective January 1, 2020. With this reduction, interest rate for existing home loan customers as well as MSME borrowers who have availed loans linked to External Benchmark Based Rate would come down by 25 bps. New home buyers will now starting from 7.90% p.a. (previously at 8.15% p.a.).

Fog disrupts air, rail traffic in north India

The thick blanket of fog ty in the winter-battered north India has affected the operation of over 300 flights, with around 260 delayed between 6 a.m. to 12 noon, Delhi airport website said on Monday. Besides, another 50 flights scheduled for departure as well as arrival between 12-6 p.m. have been delayed as well. Private airlines IndiGo and Vistara on Monday issued a travel advisory for their passengers saying flights to and from the national capital have been impacted due to bad weather and poor visibility.

NTPC-Simhadri to instal FGD tech to check pollution

To comply with the new emission norms stipulated by the Ministry of Environment, Forest and Climate Change, the NTPC Simhadri is installing flue-gas desulpharisation (FGD) technology in its all units (4x500MW) with a financial outlay of Rs 871.50 crore.

The NTPC has entrusted the work of construction, erection and commissioning of the system to General Electric Power India Limited. The commissioning of the system for all four units will be completed by March 2022.

Chief General Manager of Simhadri Sudharshan Babu kick-started the construction works with the ceremonial inauguration of the excavation for new chimnevs on December 30.



The year that Andhra economy would like to forget

SUMIT ONKA VISAKHAPATNAM

While the rest of the country reeled due to the economy slowing down, the problem was far more acutely felt in Andhra Pradesh, thanks to the elections and the new government in the State holding up the projects sanctioned by its predecessor in the name of reviewing them to bring transparency.

Earlier, the state had one of India's fastest growing economies. GDP expanded by an average of more than 13 per average of more than 13 per cent annually between 2011 and 2016, and by 11.2 per cent in 2017, and total GDP now stands at about \$125bn. The state attracted FDI inflows totalling \$18.47bn between April 2000 and March 2019 April 2000 and March 2019, according to India's Department for Promotion of Industry and Internal Trade.

However, in the first quarter of 2019, the TDP-led state government, which was concentrating on drawing investments since the time it came to power in 2014, switched its focus to social welfare projects, doling out freebees as the elections neared.

The schemes, with plans to credit

CBI takes over probe in death case of IIT-M student

NEW DELHI: The CBI has taken over the investigation in the case involving the death of Indian Institute of Technology-Madras (IIT-M) student Fathima Latheef, officials said on Monday. The Special Crime Branch of the agency's Chennai unit re-registered the FIR of the local police on December 27 and took over the investigation in the matter. Hailing from Kollam in Kerala. Latheef was a first-vear student of the humanities stream (five-year integrated MA programme) in IIT-Madras. Her body was found hanging from a fan in her hostel room on November 9. officials said. The case was earlier being probed by the Kotturpuram police of Chennai and later transferred to the CCB. The investigation was transferred to the Central Bureau of Investigation (CBI) when her parents Abdul Latheef and Sajitha, along with a delegation of Kerala MPs, met Prime Minister Narendra Modi and Union Home Minister Amit Shah here on December 5 and sought justice for their daughter. Fathima's family had found her suicide notes on her mobile phone.

Novel 'invisible ink' may help detect fake currency

Scientists at Shiv Nadar University here have developed a low-cost security ink that may help detect counterfeit currency, and could be employed in official documents and medical diagnosis.

The new ink, described in the peer-reviewed Journal of Physical Chemistry C, offers improved security features compared to existing inks that are multi-component and, therefore, more expensive, the researchers said.

These materials can be used in other applications, such as security signs, emergency route signs, traffic signage, in addition to medical diagnosis, and background-independent bio emitting probes, they said. "Our white security ink is

made from cheaper, organic compounds that can be used in daylight as they show white emission with afterglow feature covering visible range of the spectrum (400-700 nanometres) under UV light exposure," Debdas Ray, a professor at Shiv Nadar University, told PTI.

"These single component security inks give better stability, colour reproducibility and simple device fabrication over the multi-component security inks that are costly, toxic and work under different back-

ground," Ray said.

To prepare an ink, these commercially available cheaper transparent polymers in organic solvent or other gluelike materials, according to the researchers. It takes only 45 minutes to

develop this ink which costs around Rs. 1000 per gram, the researchers said.

Any characters of interest, such as symbols, pictures, shapes, bar code, etc. can be written on the document i.e. a

white background to provide additional security, they said.

tional security in the bank note, official documents, defence security, etc," Ray noted.

After writing the characters, the document can be stored in daylight as the written characters will be invisible due to their transparent colour.

In order to view the characters by naked eye, the document needs to be simply exposed to UV-light.



PAPER WITH PASSION = **Sporting success**

As the 2010s come to a close, we should celebrate a great decade for Indian sport and look forward to the 2020s



he 2010s began with a bang for Indian sport with its success at the 2011 Cricket World Cup. whose finals were held at the

Wankhede Stadium in Mumbai. The 2012 Summer Olympics held in London also saw India's best-ever haul with six medals, albeit we finished without a Gold. Things have been a bit disappointing since then. While the Indian men's cricket team tops the world rankings in Test series, it has faltered at the semi-final stages of the subsequent One-Day International World Cups and has also failed to win a second T20 World Cup to follow up from the 2007 win. However, the seismic impact of the 2007 win was felt in the creation of the Indian Premier League (IPL), which in the past decade has cemented its position as the leading franchise-based T20 tournament in the world. The Indian women's team has also enjoyed great success over the past decade with their appearance in the finals of the International Cricket Council's women's World Cup. But while this decade has cemented the adage that "India is cricket and cricket is India". it has also seen the emergence of new professional leagues that have enjoyed success as well as the rise of new champions in other sports. The premier Kabaddi League is a genuine success story, particularly in a traditionally Indian sport. On the flip side though, India's failure to win both kabaddi Gold medals, particularly in the men's competition at the 2018 Asian Games, can be attributed in part to the arrogance of newly-rich professional players. On the other hand, the emergence of champions like PV Sindhu has been a singularly impressive achievement. Her standing as World Champion must go down as India's greatest sporting success in the past decade. Alongside Sindhu stands boxer Mary Kom, who despite age and motherhood, is still a champion though she ended the decade on a sour note. Dipa Karmakar's heroic feat at the Rio Olympics, too, is noteworthy as was Sushil Kumar's World Championship in 2010, which gave a fillip to wrestling that has been taken forward by the Phogat sisters.

However, not everything was a success. The response to the Indian Super League in football and the Hockey India League was tepid at the very least and miserable at worst. India's reputation in certain sports, particularly weightlifting, has been tarnished, thanks to constant reports of serious doping. That said, drugs are an active problem throughout the world of sports. There have been serious issues with the Government's ambition to clean up Indian sports federations from its political patronage. Much still needs to be done on this front if India is to achieve its potential in the world of sports — football being a particular case in point. India enjoyed some success in the previous decade. After climbing inside the top 100 rankings in the sport, it has seemingly frittered away some of those gains in the last 24 months. Can India finally make a mark in football? The 2020s will show the way. It is likely that an Indian-born player may make it big for a major team in Europe, which could finally crack the market. At the same time, special mention should be given to the "Khelo India" programme and the games that have been ushered under the Narendra Modi administration. A focus on sports under capable Ministers has meant that India is looking forward to the 2020 Tokyo Olympics with a glimmer of hope previously unheard of. So much so that a double-digit haul is on the cards with Indian shooters, pugilists, wrestlers, badminton players and possible track and field athletes such as javelin ace Neerai Chopra, all being in the race for medals. Expectations are that others will join Abhinav Bindra in the list of individual Indian Gold medallists. As for cricket, India has a packed year coming up. Will India finish the year as reigning ICC Test match champions? Can it make it count in the T20 World Cup to be held in Australia early next year? And where will the IPL and franchise cricket go in the coming months? Can other sports replicate the success of kabaddi? There are many questions that will be asked of Indian sports in the coming decade but we hope that whatever happens, it will only climb to heights never previously achieved.

No more welcome

Following internet shutdowns, the tourism sector is the latest victim of the Government's high-handedness



The Government may be consistently playing down the countrywide protests over the Citizenship Amendment Act (CAA) and the National Register of Citizens (NRC) as a conspiracy of intellectuals to jeopardise its legitimate existence. But with the protests showing no signs of abating — they have now turned into a people's movement over exclusionary and discriminatory policies that breed hatred and disunity — the clampdown on freedom of expression has been severe. So harsh that internet and mobile network shutdowns

have indefinitely become the order of the day. This has elicited strong admonitions and travel advisories against India, impacting our tourism business severely. For example, tour operators in Agra, the home of Taj Mahal, have unofficially reported a loss of about 50 per cent revenue during the holiday season. Nowhere has the clampdown been as draconian as it has been in Uttar Pradesh with over 19 people killed and more than 1,100 arrests. The visitors' count for December has been the most dismal. A paltry 4.5 lakh tourists arrived at Agra's Taj Mahal over the new year weekend, which is down from seven lakh the same month, last year. Tourists from the US, the UK, China, France and Japan are understandably cautious after reports emerged of foreign students being deported for extending moral support to protesters. Internet cafes, a favourite among young travellers to keep folks connected to them back home, are running dry.

As the tourists have been dissuaded from travelling to India — in part because the message from New Delhi has been that it will not buckle down and, instead, has sharpened its attack on anti-CAA protesters and tightened the noose of police action — their numbers fell well before November, when the crucial Ayodhya verdict was to be announced by the Supreme Court. The month, which saw a footfall of 6.7 lakh tourists last year, saw only 5.4 lakh tourists this year. Agra alone attracts over 6.5 million tourists every year, generating nearly \$14 million annually from entrance fees. Similar is the story elsewhere. Overall, the hospitality sector has been hit. Assam has already faced a loss of ₹400 crore. Mysuru saw a 20 per cent dip in tourism. Revenues for many hotels, tour operators and guides have plunged with many tourists, both domestic and foreign, either cancelling their trips or cutting them short. This is understandable. Protests are now dragging on into the second month and have shown little signs of abating even as the Government has issued "clarifications." There are plenty of signs of matters turning more violent as both police and marchers up the ante. The larger question, however, is whether the tourism sector will be able to absorb the damage once normalcy returns. For an industry, which the Government pegged as a growth driver even in a slowing economy, this is a bad sign. In this business, perception matters and the atithi is certainly not feeling welcome anymore.

Why we need data

Preparation of a NPR and decennial census is a legitimate activity of the Union Government and the data thrown up by these exercises form the basis for policy-making

he false propaganda unleashed by some political parties against the Citizenship Amendment Act, 2019, has now got extended to the mandated programme to prepare the National Population Register (NPR) and the conduct of the decennial census, which are scheduled for 2020 and 2021. Several opponents of the current establishment in New Delhi have been spreading disinformation about the NPR and the decennial census, both of which are tools essential for governance.

The purpose of the CAA is to provide citizenship to persecuted religious minorities in Pakistan, Bangladesh and Afghanistan, who crossed the borders and came into India before December 31, 2014. This has nothing to do with any Indian citizen, whatever be his or her religion. Nor does it open the floodgates for migrants because of the deadline fixed in the Act. The NPR and the decennial census are meant to get demographic information and also inputs on the social and economic status of the population in different regions of the country. Neither of these exercises is aimed at disenfranchising anybody.

The NPR exercise was formulated and introduced by the Congress-led United Progressive Alliance (UPA) in 2010, to collect demographic and biometric information about individuals. Here, enumerators go door-to-door and gather particulars about "usual residents" — individuals residing at a given place for the preceding six months. It is, therefore, strange to find that the Congress, the very initiator of this idea, is now opposing it and is doing so with such vehemence that it all looks like a theatrical act.

The census in India is primarily a head count and has been rightly described as the largest administrative and statistical exercise in the world. Three million individuals will be deployed to collect the data and for the first time, the enumerators will be using a mobile app and other modern applications to collect and collate data from the field.

The decennial census is being conducted in India since 1892 without a break and this is an important exercise from a national point of view because it tells us about the demographic changes that have taken place at the national and local level in the preceding 10 years. Both these surveys provide policy-makers critical data that enables them to formulate national programmes, especially with regard to basic amenities to the lessadvantaged sections of society.

As stated by the Gover is the biggest source of primary data at the village, town and ward level, providing microlevel data on various parameters, which includes housing, education, economic activity, literacy, migration, fertility, language, religion, scheduled castes and scheduled tribes.

State Governments have formulated policies and welfare schemes especially to ameliorate the conditions of the religious and linguistic minorities. The steep rise in the Muslim population in India over the decades and the huge difference between the decadal growth rates of Muslims vis-a-vis the Hindus, Christians, Buddhists, Jains and Parsis, will nail the lie that Muslims are persecuted in

Indian citizens, who are fore, guard against the false narrative of this minuscule minority of pseudo-secularists and should not allow themselves to be persuaded to oppose the NPR or the census. India will become ungovernable if such tendencies emerge.

Handle sensitive issues carefully

The judiciary and the executive cannot be at loggerheads in a welfare State as it would make citizens jittery and lose faith in the system



he kind of storm which the Citizenship Amendment Act (CAA). 2019 has kicked up is, perhaps, unprecedented as it deals with the subject of future citizenship and not the current. The matter is now resting the opinion of the Supreme Court (SC) for its constitutional validity, which will hear 59 petitions filed in opposition of the law on January 22, 2020. It would be interesting to note whether the views of the judiciary and the executive would converge on an issue as sensitive as this one. In the case of Ayodhya, the apex court's verdict has established well that law cannot be detached from the interests of the people it serves. There was a raging debate whether the Ayodhya verdict was based on credible and admissible evidence or was it influenced by the faith and belief of the majority? Irrespective, the verdict was peacefully accepted by all the factions, not necessarily for its veracity but for bringing to end a painful impasse. What is clearly visible and undebatable is that it brought peace finally.

There would be peace if two conditions are fulfilled. One, the interests of the larger sections of the people must be put above all else. To punish a few guilty, we cannot make the masses suffer along with them. Second, there cannot be a chasm between the views of the executive and the judiciary, which would otherwise make citizens jittery and lose faith in the system altogether. Imagine being brought up by two warring parents.

This ethos of acting in public interest and going along with the views of the executive must now be extended to end pain in other areas as well. Take livelihoods as an example, where the case of Goans has been hanging for far too long. Goa was the only State where mining rights were granted to its citizens by the Portuguese Government in perpetuity, but were eventually revoked by the Indian Government. Ever since the apex court abruptly cancelled 88 mining leases in the State on February 7, 2018, life has come to a grinding, tragic halt for mining dependents in the State. This is now no longer just an economic crisis — which is severely debilitating in its own right — but a grave human crisis as well. Such is the situation that the Goa Government has requested a review of the ban by the SC, which is also pending. Jobs and livelihoods disappearing overnight as a result of judicial intervention is painful, particularly at a time when India is going through the worst employment crisis in the last 40 years. According to the National Sample Survey Office (NSSO), the country's employment reached the lowest rate in 2017-2018.

Earlier, in 2012, the SC cancelled 122 spectrum licences in response to a PIL filed by a host of activists and to answer the question whether the Government had a right to distribute natural resources in a manner that was not "fair and transparent." This affected 5.3 crore telephone connections. It was alleged that the exchequer lost ₹1.76 lakh crore in revenue and a few private telecom players were the beneficiaries. This case was highlighted as among the top 10 abuses of power by Time magazine. The verdict shook the country, changed the contours of a developing telecom industry, made new telecom operators wrap up their business and gave the reins of the sector into the hands of a few business groups.

In a reversal in 2017, a special court in New Delhi acquitted all the accused in the 2G spectrum case citing that the CBI could not find any evidence against the accused in seven years. As per the judgment, "Some people created a scam by artfully arranging a few selected facts and exaggerating things beyond recognition to astronomical levels." The matter now rests with the Delhi High Court on basis of appeals filed by the CBI and the Enforcement Directorate. The key question is as to why the case could not have been tried without cancelling the licences? The court should have allowed business to continue, while the case would have carried on. By invoking closure of business, the court caused collateral damage to the industry, the economy and most importantly to the livelihoods of people employed by the companies that had to close shop.

Studies have established that India's Maoist movement is deeply rooted in socio-economic conditions prevalent in parts of India with large tribal populations. It has mostly affected areas where there is a conflict between the State and the populace on the economic derivation of forest produce and mining such as in Chhattisgarh and Jharkhand and agriculture in parts of Andhra Pradesh and Odisha. Such aggressive posturing by citizens has huge direct and indirect costs. The purpose of the law is to create a conducive environment for the citizens of the State. However, sometimes, like in the Goa mining ban and the spectrum case, the law and its interpretation has spelled doom for citizens and businesses. This cannot become a precedent and must be addressed immediately. Situations like these need more complex solutions, just like the CAA. It is simplistic to penalise lakhs of people for the actions of the few with the stroke of a pen, and it is certainly not done.

since the early 1990s, there has been a sense of optimism with regards to India's economic progress. The process of the proces progress. The process of liberalisation during 1991 brought with it a sense of hope regarding a dramatic turnaround in the country's economic fortunes. While the nation's growth did accelerate from the 1980s onwards, however, it wasn't comparable to other emerging economies, including China.

The first decade of the 21st century was believed to be India's time as it had a Government that was looking at the next generation of eco-nomic reforms. These transformations happened nomic reforms. These transformations happened and the country witnessed the first serious privatisation of several public sector enterprises (PSEs) along with a drastic reduction in small savings rates. India's macroeconomic situation was stable and gradually growth started to increase along with its investment rates. This growth continued till 2007, after which it started to lose steam due to lack of economic reforms ed to lose steam due to lack of economic reforms and then the 2008 crisis hit the country along with the rest of the world.

While many thought the impact of the 2008 crisis wasn't as much on India as elsewhere, the reasons behind this were the policy instruments which were deployed to address the risks that emerged. These instruments, combined with a lack of reforms and an entitlement-based regime brought a fresh macroeconomic challenge in the second decade of the 21st century.

Two decades have elapsed and India is yet to justify the sense of optimism that prevailed at the start of the century. But to be fair, the second decade wasn't that bad considering that India's growth in 2014, 2015 and 2016 was fairly decent even when one ignores the fact that it witnessed two successive droughts in 2014 and 2015. The country's macroeconomic situation has improved significantly since 2014 and the Government has undertaken several reforms that will have long-term growth implications such as the Goods and Services Tax (GST), the Insolvency and Bankruptcy Code (IBC) and the Real Estate (Regulation and Development) Act

Despite these reforms, growth slowed half of 2019. This has led people to question whether the third decade will be any different from the previous two decades. However, there are compelling reasons that point at how this time, it will be different. For starters, the current slowdown is not because of any inherent structural factors but is a direct outcome of the financial sector stress which spread over from banks to Non-Banking Financial Companies (NBFCs). The reasons behind the build-up of this stress are more to do with reckless lending during the first decade of the century as the attempt to fix it started only post the introduction of the Insolvency and Bankruptcy Act.

As the Reserve Bank of India's (RBI) latest Financial Stability Report suggests, the Public Sector Banks' (PSBs) Non-Performing Assets (NPAs) may increase by September 2020 and this poses fresh concerns regarding the ability of the PSBs to take prudent lending decisions. The recent spike in NPAs could also be because of the high cost of capital compared to the moderation in inflation, which has artificially kept the real

rates at one of the highest levels in the

Clearly, India's got a problem on the monetary side, which needs to be rectified if it is aiming to grow at seven per cent or more. Some progress has been made on this by the RBI, however, it continues to be conservative and the longer it takes for it to recognise the extent of the problem, the more prolonged the bottom of the U.

Irrespective of these short-term challenges, the outlook for economic growth for the country in the mediumterm is completely positive as some of the current supply-side issues will get resolved and India will witness a growth of 5.0-5.4 per cent in the third quarter (Q3) of the current Financial Year (FY) followed by a 6.2-6.6 per cent growth in the fourth quarter (Q4) of the current FY. India will end the decade with a modest growth rate; however, the cent or higher growth rate in the FY 2020-21.

The question is whether this rate will be sustained throughout the decade or not. There is a reasonable belief that India will sustain a seven per cent growth this decade and it may even attain an eight per cent or high growth rate towards the end of the decade as it witnesses a steady revival of investments as a percentage of the Gross Domestic Product (GDP). This improvement will be a direct product of some of the painful reforms that were undertaken in the past, which will unleash the nation's productive potential. The recent corporate tax cut would result in steady improvements in corporate sector balance sheets, which will result in fresh investments from 2022 onwards. At the same time, implementation of the Direct Tax Code (DTC) will simplify taxation procedures, which

will further augment productivity. There's also talk of a GST overhaul

which may happen during the next couple of years. This, when combined with land, labour and agricultural reforms, will be critical to unlocking India's productive potential. Demographics, too, favour India as it has the world's largest workforce which will act as a check in wage costs, thereby giving it a competitive edge over other emerging market economies for the next two decades. All of this is essential to experience the kind of transformation that several of the country's peers experienced during

the 1980s and 1990s. Of course, fresh reforms will be required — but they are already on the agenda of the Government as the labour codes are coming into effect. Many of these reforms will be aided by the fact that there's a mandate of 303, which enables the Government to take decisions that would be extremely dif ficult to push for in a divided Parliament.

Global conditions, too, seem to be conducive for India as Boris Johnson's election in the United Kingdom (UK) will end uncertainty regarding Brexit. He has expressed his willingness to enter into a trade agreement with India and the nation should be closing trade deals with the UK, Europe and the US to further integrate itself into global trade.

Global economic growth is also likely to recover in 2020, which means that external factors will be conducive for India's growth, provided it can address some of its domestic constraints. The year 2019 goes down in Indian economic history for many reasons. For starters, it marks the first time in the history of India where a reformist Government was brought back into power and that, too, with a

huge majority. This shows how electoral preferences are maturing in India.

The outcome of the election made it possible to take three significant economic decisions. First was the merger of 10 PSBs into four. This is likely to consolidate the sector and improve its efficiency over a period. It also opens up interesting possibilities for future privatisation of some of these big four banks as there's no need for having four big PSBs, especially at a time when the nation has already pumped in ₹3 trillion into them without any positive outcome so far.

The second was to do with the corporate tax cut, which was promised in the previous tenure. Indeed, many consider it just a tax cut, however, it is a deep structural reform that will have long-term positive implications for financial stability and financing of investments. More importantly, it illustrates a shift in thinking of tax now recognise that tax revenues can increase at lower rates due to improvements in tax compliance.

The third decision was of privatisation of several firms, including BPCL. This is a bold move as it signals a staunch commitment to the phrase that "the Government has no business to be in business.

This move has signalled to the world that India is finally opening greater space for private players in its economy, which has hit all the right notes. Indeed, a lot of economic progress was made in 2019 and some of it could be because of the slowdown. However, 2019 will mark a structural break for India as we enter into a decade which will certainly belong to the country's entrepreneurs and its economic ambitions.

A few States, namely Rajasthan, Madhya Pradesh and Chhattisgarh, deliberated about enacting the right to health legislation. During the year, public health experts argued that the Ayushman Bharat Yojana, announced in 2018, had put health higher on the political agenda and nearly six States started a variant of Mohalla Clinics (neighbourhood clinics) to increase the provision of free primary health care services.

There were a few negative developments as well. Violent attacks on doctors, health care providers and facilities were reported from different parts of the country, followed by protests and strikes by the medical fraternity.

In the summer of 2019, encephalitis deaths were reported from Muzaffarpur in Bihar. The experts were once again divided on the cause of this and consequently, the children of the nation are still waiting for scientific and long-term solutions to prevent such tragedies

In the last quarter, poor air quality returned to affect the health of the people in many districts of north India and all policymakers did was to question the proven evidence on the impact of air pollution on people. Hence, it is clear that there are many issues that need to be addressed in this crucial sector.

Legislative approach in health works: The Motor Vehicle (Amendment) Act, which has hiked the penalties for traffic violations, has the potential to improve health, as nearly one in every 10 preventable deaths occurred due to road accidents. After the Mental Healthcare Act of 2017, mental health services in India received a boost at the implementation level as the Insurance Regulatory and Development Authority directed companies to include mental health care services in their insurance package as one in every seven people have one or other mental health care needs.

Though the Bill to protect doctors and health care workers could not develop a consensus, it is also This highlights the need for a cent annual increase in Government senior public health specialist.)

approach. Improving the quality of health services, preventing com-mercialisation of health services and changing health-seeking behaviour to get early care is the need of the hour. A realistic expectation from health services needs to be developed and the "market-based belief" that every health condition is treatable, needs to be addressed. In health services, the outcomes are completely unpredictable and even the best of the treatment and advanced care may not save a person, while another person with a similar health condition may quickly recover with basic health interven-

The product is a generic version of Hospira Inc's Nitropress injection, 50 mg/2ml, it added. As per IQVIA Health data, Nitropress brand and generics had US sales of around USD 8 million MAT for the twelve months to October 2019, Dr Reddy's said.



Sensex, Nifty end

MUMBAI: Market benchmarks Sensex and Nifty closed mixed after a see-saw trade on Monday amid lack of domestic as well as global cues. After swinging over 260 points during the day, the 30-share BSE Sensex ended 17.14 points, or 0.04 per cent, lower at 41.558. The broader NSE Nifty, however, closed 10.05 points, or 0.08 per cent, higher at 12,255,85, ICICI Bank was the top loser in the Sensex pack, shedding 0.99 per cent, followed by SBI, TCS. HUL. Asian Paints and Axis Bank. On the other hand. Nestle India, Hero MotoCorp. Mahindra and Mahindra Bharti Airtel and Tata Steel were among the gainers Analysts attributed this lacklustre trading pattern to absence of any major trigger points in the market. Globally bourses in Shanghai and Hong Kong ended higher, while those in Tokyo and Seoul settled in the red. Stock exchanges in Europe started on a negative note

Gold to shine in 2020; may touch Rs 45K per 10 gram

Always a pricey possession, gold is set to remain more pricey in the New Year too as continuing geopolitical tremors, economic woes and rupee volatility are expected to push the yellow metal even to Rs 45,000 for 10 gram.

Thanks to various government policies and soaring stock market, gold witnessed periodic as well as steep price fluctuations in 2019, with bias towards the higher side in the second half of this year.

Data from the World Gold Council shows that 14 central banks, including the RBI, have reportedly added more than one tonne to their reserve.

"As we look to 2020, we believe investors will face increasing geopolitical concerns, while many pre-existing ones will be pushed back rather than being resolved.

"In addition, the low level of interest rates worldwide will keep stock prices high and valuations at extreme levels, on the verge of peaking out. Therefore, we believe there are reasons for higher levels of safe-haven assets like gold," Commtrendz Research Director Gnanasekar Thiagarajan told PTI.

From US-China trade turmoil to conflicts in the Middle East, geopolitical issues are galore for the global markets which might also await cues from the US presidential polls towards end of 2020.

The potential medium-term target lies at Rs 41,000-41,500 per 10 gram at MCX (USD 1,640-1,650). Further, the level could rise to Rs 44,500-45,000

ppetite, Thiagarajan said. World Gold Council Managing Director (India) Somasundaram P R said local currency prices in almost all markets, including rupee, breached previous life time highs, leading to muted consumer demand across markets.

"Indian demand also lost significant momentum in Q3, and though Q4 saw a revival with its traditional wedding and festival season, overall demand for the full year is expected to be at the lower end of 700-750 tonne. ETF (Exchange Traded Fund) demand in the US and Europe, and central bank buying across nations, however, continue to be strong," he noted.

According to him, the Reserve Bank of India (RBI) was one of the main buyers of gold in 2019, increasing its reserves by over 60 tonne.

China and Russia have been the biggest buyers of gold till now. Besides, countries like India, Turkey, Poland and Kazakhstan have also joined the bandwagon in purchasing the yellow metal.

In the first half of this year, gold was relatively more attractive for consumers as the price ruled at around Rs 31,500-32,000 for every 10 gram.

However, in July demand began to become weak as prices started to climb. Depreciation of Rupee along with the government increasing customs duty by 2.5 percentage points during Budget to 12.5 per cent from 10 per cent made it even more costly in the domestic market.

In 2019, gold peaked at USD 1,557 an ounce and Rs 39,900

All India Gem & Jewellery Domestic Council (GJC) Chairman Padmanaban said that from consumer perspective, 2019 was a mixed year as the first half was

very good in terms of demand. However, since July as the gold prices moved up, the demand dwindled as jewellery became a very costly affair after the added burden of customs duty and Goods and Services Tax (GST), he noted.

He also pointed out that untimely rains that damaged crops further attributed to the negative sentiment as around 70 per cent of the demand in India is from rural areas.

India Bullion and Jewellers Association (IBJA) National President Prithviraj Kothari opined that gold price trend is rising and the market would soon reach newer high ideally in the next 2-3 years.

"Also, the global economic slowdown, liquidity crisis in India and depreciation of the rupee against the US dollar which has now reached Rs 71, and is likely to reach Rs 72 soon, will support the gold market. I am positive that in 2020, the gold prices will be in the range of Rs 38,000 on the downside and Rs 42,000 on the upside," he added.

Motilal Oswal Financial Services VP (Commodity Research) Navneet Damani said that in the short term, strong support for gold is placed in the range of Rs 37,100-36,900 levels on MCX. On the higher side gold price is likely to move higher towards Rs 39,900 levels followed by Rs 41,500, he added.

Government may provide tax incentives for startups in Budget

The government is expected to provide tax incentives to start-ups in the forthcoming budget to support the growth of budding entrepreneurs, sources said.

The Department for Promotion of Industry and Internal Trade (DPIIT) has suggested several measures to the finance ministry for startups in the budget.

The recommendations include extension of tax incentives to incubators supported under Innovation Mission; reduction in GST (Goods and Services Tax) rates on AIF (alternate investment fund) management fees; and tax benefits on ESOPs, they said.

Start-ups need talented workforce and ESOPs are one of the best options to attract skilled people as giving just high cash payout add to the burden on cash-starved enter-

prises, industry players said. Tiger Global-backed tea cafe chain Chaayos founder Nitin Saluja said that there should be

less tax on ESOPs. "It should attract as little tax as possible. ESOPs are one of the best options for startups at their early stages," Saluja said. Further fees charged by

fund manager of AIF domiciled in India is liable to 18 per cent GST as it qualifies as a taxable supply. Sources said that reduction

in GST rates will help India to become an investment hub.

Startup India initiative of the government aims at fostering entrepreneurship and promoting innovation by creating an ecosystem that is conducive to growth of budding entre-

There are 19 components under the Startup India action plan spanning across areas such as simplification and hand holding, funding support and incentives, and industryacademia partnership and incubation.

Housing sales still pain point in realty sector

Residential property as an investment has always been the poor cousin of commercial real estate, and 2019 couldn't have been a better testimony to this statement, as housing sales were plagued by demand slowdown amid surplus inventory and office space leasing hit a record

, While sale of residential properties increased only marginally despite plethora of steps taken by the government through the year, office space leasing rose 40 high of 46.5 million sq ft -- a trend that drew investors to lap up India's first Real Estate Investment Trust at an issue size of nearly Rs 5,000 crore.

Real estate developers in the housing segment struggled to stay afloat due to poor sales and acute cash crunch, and homebuyers continued their battle to get their dream homes, dragging many builders to insolvency

court. "The year 2019 witnessed no significant momentum for the realty sector in India, economic slowdown to challenges such as liquidity crunch, delayed delivery of insolvent projects and un-regularised cases in National Company Law Tribunal (NCLT) deterred the growth of the sector," CREDAI (National) President Satish Magar told

The apex realtor body's Chairman Jaxay Shah listed liquidity as a major challenge currently faced by the sector. He, however, hopes for revival next vear aided government like tax sops, a sharp cut in GST rates on under-construction flats and a Rs 25,000 crore fund to salvage stalled residential projects.

According to property brokerage firm Anarock, housing sales rose by a mere 5 per cent to 2,61,370 units in 2019 across seven major cities compared to 2,48,310 units in the

the group of (GoM), headed by Home Minister Amit Shah. It was decided that higher buffer stock of about 1 lakh tonne will be created for next year," the official told PTI. Cooperative Nafed, which

Reliance, BP pay \$36 mn for exit of Niko in KG-D6 block

Reliance Industries and UK's BP plc paid USD 36 million to get their defaulting Canadian partner Niko Resources to exit from the eastern offshore KG-D6 block. In a statement, Niko said it has exited from the KG-DWN-98/3 block and its 10 per cent stake has been taken over by Reliance and BP.

The firm was paid USD 36 million to settle an arbitration it had initiated against Reliance and BP trying to force it out of the block over default in payment.

"An amendment to the production sharing contract for the D6 Block in India has been executed, reflecting the assignment of the 10 per cent interest previously held by the company's indirect subsidiary, Niko (NECO) Ltd to the remaining interest holders in the block, Reliance Industries Ltd and BP Exploration (Alpha) Ltd," the statement said.

Subsequent to this, Reliance's stake in KG-D6 has gone up to 66.67 per cent from the previous 60 per cent and that of BP to 33.33 per cent from 30 per cent.

'Niko NECO had entered into a settlement agreement with Reliance and BPEAL under which it agreed to withdraw from D6 PSC and settle its arbitration case filed under the rules of the London Court of International Arbitration in December 2017 in exchange for a settlement amount of USD 36 million, subject to adjustment prior to closing," it said.



Oil regulator seeks to rationalise gas pipeline tariff

Oil regulator PNGRB is seeking to rationalise natural gas pipeline tariff structure so as to increase usage of environmentfriendly fuel by aligning charges paid for transporting the fuel with the best global practices

The Petroleum and Natural Gas Regulatory Board (PNGRB) is seeking bids for the appointment of consultants for the job, saying the government has envisaged ushering into a gas-based economy by increasing the share of the fuel in primary energy mix of the country from current level of about 6 per cent to 15 per cent by 2030.

This is to be done by increasing the availability of natural gas by enhancing domestic gas production, encouraging the



import of Liquefied Natural Gas (LNG), completion of national gas pipeline grid (NGG) and speedier roll out of city gas distribution networks,

Presently, the country has a network of 16,981-km of

pipelines, with each having a different tariff. The present tariffs policy provides for lower transportation charges in the area closer to the source of gas and this progressively increases that leads to a scenario where the users in hinterland

"PNGRB proposes to hire a consultancy firm to provide assistance in analyzing different options for rationalization of natural gas pipeline tariff structure, reviewing interna-

tional practices adopted on natural gas pipeline tariff design/ determination in USA, Australia, Japan, Russia, UK, and EU nations, and suggest the best-suited tariff mechanism in Indian perspective," the regulator said.

In the tender inviting bids, it said the consultant will also review current regulations and draft of new proposed regula-

The move by PNGRB follows the government in October seeking a concept paper on rationalization of natural gas pipeline tariff structure and framing new tariff regulations. The consultant will have to review international practices and identify the challenges present tariff regime in India poses to the growth of

pipeline infrastructure. A matrix will be created to identify a model best suited for the Indian scenario," it said, adding the tariff structure needs to provide reasonable returns to entities building pipelines and promote the development of the gas infrastructure, while at the same time developing a pan-India gas market.

The public consultation will be done on the tariff structure proposed by the consultant, following which IT-based tools will be developed for implementation of the regulations, it added.

This exercise is in parallel to the mandate PNGRB has given to global consultancy ICF for carrying out an assessment of India's natural gas demand and the infrastructure needed to unleash the country's massive pent-up requirement, its Chairman Dinesh K Sarraf said.



Theatre in Hyderabad is booming today and several factors are being attributed to this upward trend.

Given the amount of effort put in by several theatre groups such as Samahaara, Udaan, Nishumbita, Sutradhar and several others the state of theatre and performing arts in the city a few years ago, Hyderabad has undergone a huge paradigm shift.

Towards the end of 2019, two annual largescale theatre festivals, the Natotsav and the Qadir Ali Baig Theatre Festival were received enthusiastically. The Natotsav, an annual festival presented by Nishumbita (Ballet & Theatre), included an extensive two-day workshop with Mahesh Dattani this year.

The niche that theatre has now begun to carve for itself has become more welcoming not just by professional adults who used to be the face of theatre for years, but

as well for the more experimental and creatively inclined age-group, youngsters. There has been a significant increase in the number of youngsters participating in theatre over the past few years. "Several factors influ-

Asked about how colleges and schools contribute towards the increasing participation of youngsters in theatre, Saurabh Gharipurikar says, "It is safe to say that the relatively recent addition of theatre into school and college curriculums has played a decent role in nurturing the interest of students towards theatre as an art form." Gharipurikar is the founder of 'Udaan Academy of Arts and Education'.

In order to understand the interest youth have for participating in theatre and drama, *The Pioneer* spoke to Akhil Bhaneshwar who was an active member of the Nishumbita theatre group.

"With the rise of several new groups in Hyderabad, youngsters now have access to theatre and cultural arts especially at a time when they understand the importance of theatre as an art form. And more and more theatre workshops are also being conducted across the city, thus giving the audience clarity about theatre as an art form and making it more relatable to youngsters," says Akhil who was an alumnus of the National School of Drama, Bangalore.

"Often times people who practice drama and theatre in their lives find it easier to cope with their daily stress as they get a boost of confidence while being able to witness an overall development in their capabilities. As refreshing as it is to see the youth coming forward to participate in theatre, it would be better if we could have people who could remain committed in the field," he concluded.

ctor John Abraham says his biggest advantage is that he is not afraid of failure.







Off-spinner Somerville, who was raised in Australia and played Sheffield Shield for New South Wales, will replace injured pace bowler Trent Boult for the Test starting in Sydney on Friday

Coach Gary Stead said the inclusion of the lanky 1.93 metre (6ft 4in) Somerville was a nod to the expected conditions at the Sydney Cricket Ground.

"There's no secret the SCG pitch is one of the more spin-friendly in

Australia," Stead said. "Will offers something different to our two other spinners in the squad

with his right arm off-spin and height. The fact he's played a lot of cricket in Sydney during his career for New South Wales will also be helpful an average of 23.14.

Somerville, 35, has played three Tests, taking seven wickets on his debut against Pakistan in Abu Dhabi last year and a total of seven in two Tests away to Sri Lanka four months Boult is returning to New Zealand

after suffering a fracture to his right hand in the second Test which Australia won comfortably by 247 runs on Sunday within four days in Melbourne.

Australia won the first Test by 296 runs, again wrapping up the match inside four days.

New Zealand already have Matt Henry and Kyle Jamieson in the squad to provide fast bowling cover while Somerville's height and local knowledge could see him overtake the incumbent spinners Mitchell Santner and Todd Astle.

Somerville was one of the leading bowlers in Australia's Sheffield Shield in 2016-17 season with 35 wickets at
