Rahul tears into BJP at Jaipur

India belongs to Hindus, not Hindutvavadis, says Cong scion

Touted as the relaunch of Rahul Gandhi, the Congress on Sunday held a mega 'Mehengai Hatao' rally in Jaipur addressed by Rahul, general secretary Priyanka Gandhi and other leaders in the presence of party chief Sonia Gandhi. However, Sonia did not address the rally due to ill-health.

Around one lakh people gathered at the venue in Jaipur and the Pink City was peppered with huge cut-outs and placards of the Gandhi family. However, Rahul got the maxim visibility on the posters, giving enough indications about the party's effort to present him as its leader of the future.

The Congress is working to bring back Rahul as party president, a post he quit on moral grounds following the 2019 Lok Sabha election deba-cle. AICC sources said that the party cadre was hinting that the rally must focus only on Rahul and should be "crafted" as part of the strategy for his "installation" as the head of the party in a few months. Sonia is currently working as interim

Rahul at once launched an ideological attack on the BJP,

saying that Hindu and 'Hindutvavadi' were two different terms and that the country was of Hindus and not Hindutvavadis.

There is a collision of two words in the politics of the country today. One word Hindutvavadi searches for

Hindu and the other word Hindutva. I am a Hindu and

not a Hindutvavadi. The difference between Hindu and Hindutvavadi is that Hindu searches for the power and it is called as Sattagraha," Rahul said

addressing the gathering.
"Mahatma Gan Gandhi searched for the truth, Nathuram Godse pumped three bullets into him. He (Godse) was a Hindutvavadi. A

Hindu is interested in Satyagrah. Hindutvavadi are only after power, they don't care about the truth. A Hindutvavadi is only after Sattagrah (search for power)."

Last month, Rahul sought to differentiate between Hinduism and Hindutva at an internal meet of the party.

"Is Hinduism about beating a Sikh, or a Muslim. Hindutva, of course, is. In which book is it written? I have not seen it. I have read

have not seen it. I have read the Upanishads. I have not read it," he said.

"We say there is a difference between Hindutva and Hindu religion. It is a simple logic -- if you are a Hindu then why do you need Hindutva? Why do you need this new name?" Rahul added.

Targeting the Narendra Modi Government, Rahul said, "Today one per cent of the population of India has 33 per cent wealth in their hands while 10 per cent of the population has 65 per cent of the money in their hands. And the poorest 50 per cent of the population has only six per cent of the money in their hands."

"Those who ask what the Congress has done in 70 years, I want to ask you, leave this talk about 70 years. talk about 70 years. What have you done in the past seven years? The AIIMS, the airport from where your plane flies, the Congress built them. The BIP Government is selling what the Congress created in 70 years. This Government is working only for its industrialists," stated Rahul.

4 more Omicron cases detected in India, tally now 38

VV ing positive for Omicron infection on Sunday, India's tally of new variant of Covid-19 has climbed to 38. For the first time, Andhra Pradesh, Kerala and Chandigarh reported Omicron cases.

Till now the new SARS-CoV-2 "variant of concern" in the country has been detected in Maharashtra (18), Rajasthan (9), Karnataka (3), Karnataka (3), Andhra Pradesh (1), Delhi (2), Chandigarh (1), and Kerala

"During the meeting between Punjab Chief Minister Charanjit Singh Channi and 32 kisan organisations on December 17, the issue of complete loan waiver would be raised vociferously. Punjab Congress should immediately fulfil the promises made in the election manifesto before 2017 Assembly elections, as the forthcoming elections are very close but the farmers are burdened with debt," said Bhartiya Kisan Union-Ekta (Dakonda)

During the agitation, seven trains were halted midway in Bathinda, Barnala, and Sangrui areas under the Ambala Division of railways, while 10 trains were delayed under the Ferozepur Division. The agitation was organ-

AQI plunges to 256 as wind speed increases in city

 $D_{(AQI)\, plunged\, to\, 256\, from}^{elhi's\, air\, quality\, index}$ 310 on the previous day, as per the System of Air Quality and Weather Forecasting And Research (SAFAR).

Values of both the Particulate Matters (PM) - 10 and 2.5 were recorded 207 and 107 micrograms per cubic.

In short rage weather and air quality forecast, SAFAR said, "AQI today indicates 'Poor' air quality. For the next two days (13th, 14th), winds are likely to be low to moderate. Partially cloudy conditions and moderate mixing layer height (~ 1 km) are likely to keep air quality within 'poor'



of very poor' during night and early morning hours for the next two days. From 15th onwards air quality is likely to improve due to relatively high wind speeds but within 'poor' or 'lower end of very poor' cat-


In a health advisory, SAFAR recommended that outdoor activities stop early in the morning and after sunset. "Avoid prolonged or heavy

An AQI between zero and 50 is considered good, 51 and 100 satisfactory, 101 and 200 moderate, 201 and 300 poor, 301 and 400 very poor, and 401 and 500 severe.

DU's exam fee collection doubles

New Delhi: The Delhi University collected nearly ₹9.5 crore from around 1.4 lakh students towards fees for the examinations that are underway, thanks to the transparency introduced with the Centre's Samarth portal, officials said.

With Samarth,

This is almost double the amount the university previously fetched from exam fees. Earlier, several colleges would not entirely transfer the exam fees to the university as there was no effective mechanism to ensure checks and balances, they said.

The university has been conducting open book exams for students since last year due to Covid-19 and the semester exams began on November 30. A minimum examination fees of ₹500 is levied per semester on each student while he has to pay another ₹200 for each practical exam. Ex-students appearing for re-exams need to pay an additional ₹500.

"Samarth has made exam fees collection a centralised process. Earlier, colleges would collect this money but many wouldn't pay to the university in full. It was difficult to keep a track of the number of students and the corresponding fee from various colleges under the university," an official from

the university said. "Another issue was that several colleges used to collect examination fees at the time of a student's admission itself and hence it would not be clear what papers the student would opt for. So, it was quite a possibility that either the student was paying higher or lower than the exact amount," he

According to the official, the university has asked the

colleges to refund the exam fees to the students in case they

during admission to the course.

DS Rawat, Dean, Examinations, said it took the university more than three months to upload details of nearly 1.4 lakh students on Samarth. "This time, students filled their examination forms on the portal. This solved several logistical issues that we were facing earlier," he said.

A student needs to score an average of at least 50 per cent marks in the first and second semesters in order to be promoted to the third.

Highlighting the loopholes earlier, Rawat said, "Earlier, sometimes, colleges would promote students to the third semester and even allow them to take exams without ascertaining whether they had cleared the previous semesters," he said.

Rawat said the university's in-house software, too, was not equipped to check such cases.

Now, students who have not cleared their previous semester do not even receive their result and cannot open examination forms for the new semester," he said, adding the portal carries all academic information of every student.

"Even when the student is filling the form, their subjects and paper codes are ticked beforehand. Earlier, students had to fill their details manually and key in the paper codes, sometimes leading to errors," he said. The university is planning to use the data on students for printing their degree certificates and hand them over during convocation.

An inmate of Delhi's Tihar Jail was attacked allegedly by other inmates using the barber's scissors while having hair cut in their ward. The prison authorities said that the incident took place on December 10 and the duo sustained injuries which were not serious.

According to prison official, on Friday, one inmate inside Central Jail no 8 of Tihar was suddenly attacked by another inmate using the barber's scissor when they were getting haircut by a barber in their ward.

"During the grappling, the victim and one of the attackers'

sustained injuries and were immediately separated by jail staff. The injuries of both the inmates were not serious," he

They were sent to Deen Dayal Úpadhyay hospital for treatment from where they were discharged the same day and came back to jail, he said. Staff at the Hari Nagar

police station received information from the hospital about victim Yogesh, who was found admitted after allegedly assaulted by other inmates, police said. The injured did not want to file any complaint, however an information of the incident was received from jail authorities, a senior police officer said.

Haryana Chief Minister Manohar Lal Khattar on Sunday directed all the Deputy Commissioners of the state to strictly implement the PNDT Act in the districts and encourage various voluntary organizations, social workers and pensioners of the districts to register themselves on the Samarpan portal.
The Chief Minister also

Khattar also directed to arrange for government vehicles to deliver the question papers to the examination centres and ensure that adequate number of security personnel are deployed with them. He also asked to make alternate arrangements for traffic and to ensure the arrangement of traffic police so that the general public does not face any problem due to high vehicular movement during the exami-

The political potboiler in Punjab refuses to settle with the state Congress president Navjot Singh Sidhu continued to attack his own party's government, especially those holding the reins of power".

A day after he expressed "helplessness" even in the appointment of office bearers in the state despite being Punjab Congress president, Sidhu on Sunday went on to declare that he will not just be anyone's "pawn or showpiece".

"In politics, a good man is made a show piece. He is used as a pawn to win the election. After all the campaigning and winning elections, he is kept aside as a showpiece. Now, I will not be anyone's show-piece or pawn," said Sidhu while answering the people's questions in the 'Bolda Punjab' programme at Chandigarh's Law Auditorium.

Sidhu's statement assumed significance as it came a day after he, during a rally in Baba Bakala, admitted that he did not enjoy administrative power and could not even appoint anyone as general secretary or on other posts.
At the same time, Sidhu

declared that he would always stay with the Gandhi siblings-Rahul and Priyanka Gandhi. "Both Priyanka and Rahul are family members. I can't leave them. I will perform the duty which they will give. But in case, after the elections, the present situation remains the same...Even after the formation

of the Congress Government, if there is no change, then I will not take the responsibility...I will leave," he said, in response

However, Sidhu did not make it clear whether he would step down as the party president, leave the party, or Rahul and Priyanka.

"I myself belong to a rural environment and understand the problems of sheep farmers very well and have had a special attachment and relationship with the Gaddi community and have received the same love and respect from this community as well", he said.

The Chief Minister directed that compensation should be provided without delay to the Gaddis on loss of their sheep or goats due to natural disaster or pandemic. He also

directed the concerned officers to ensure timely vaccination of the sheep and goats of Gaddis to protect their flock from various serious diseases.

He further asked the concerned officers to separately examine the issues raised in the meeting regarding opening and upgradation of health and educational institutions in the tribal and hard areas. The concerned department should ensure that no one transfer the to other person as this would viewed seriously, he added.

Thakur also said that it was due to the benevolence of late Prime Minister Atal Bihari Vajpayee that Gaddi community was given this special tribal status in the year 2003.

The State Government would consider including adequate representation of tribal people in Scheduled Castes Scheduled Tribe Commission so that participation of the Scheduled Tribes must be ensured.

Steps would be taken to make adequate provision of budget for tribal people living in non-tribal areas, he said.

Will build world class schools; transform future of 24L students in Punjab: Kejriwal

Highlighting the "abysmal" state of Punjab's government schools, the Aam Aadmi Party's national convenor and Delhi Chief Minister Arvind Kejriwal on Sunday promised to "completely revolutionize schools" and change the face of government education in Punjab, "just like Delhi".

"This (1971) war also shows that India's division on the basis of religion was a historic mistake. Pakistan's birth took place in the name of one religion but it couldn't remain as one," the minister said.

Following the defeat wherein more than 90,000 Pakistani military personnel surrendered, he said Pakistan has ever since continued to engage in a proxy-war against

Pakistan, he said, "wants to break India by promoting terrorism and other anti-India activities. Indian forces foiled its plans in 1971 and now work is going on to eliminate roots of terrorism by our brave forces. We have won in the direct war, and will achieve victory in the proxy was as "The feeling of antagonism towards India is so deeprooted in Pakistan that it can be seen in the name that it has given to its missiles," the min-

Pakistan's missiles have been named after Ghauri, Ghaznavi and Abdali who invaded India, the minister added. to be held in a particular year, only an individual who has attained the age of 18 years as on January 1 of that year or before is eligible to be enrolled in the voters' list. Due to only one qualifying or cut-off date, a person attaining the age of 18 years on January 2 cannot be registered. Therefore, a person

who turns 18 after January 1 will have to wait for next year to get registered. The EC had been pushing for multiple cutoff dates to allow more eligible people to register as voters.

The EC had told the government that the January 1 cutoff date set for the purpose deprives several youngsters from participating in the elec-

toral exercise held in a particular year. The law ministry has told a parliamentary panel that "it is proposed to amend section 14(b) of the Representation of the People Act to insert four qualifying dates (or cut-off dates) --January 1, April 1, July 1, and October 1 -- of every year".

It said a comprehensive draft cabinet note "containing this proposal (of four qualifying dates) as well as a few other important electoral reform proposals taken up by the Election Commission is under preparation". The Parliamentary Standing Committee on Law and Personnel on Friday tabled its 109th report on "Action Taken on 107th report of the Committee on Demands for Grants (2021-22) pertaining to the Ministry of Law and Justice" in the Lok Sabha.

The committee referred to its earlier observation where it had reiterated its recommendation for the implementation of a common electoral roll in the country and desired that "all-out efforts" should be made in this regard.

Responding to the recommendation, the ministry said according to section 13D of the Representation of the People Act, the electoral roll for every parliamentary constituency should consist of the electoral rolls for all the Assembly constituencies within the Lok Sabha segment and it should not be necessary to separately prepare or revise the electoral roll for any such parliamentary



Now, residential complexes will have to adopt energy-efficient techniques Cooperation and Counsellor,

fter commercial buildings **A**now the Government is in the process of bringing large residential complexes under the ambit of the proposed Energy Conservation Act 2001 amendments to integrate energy efficiency measures into such buildings and reduce energy consumption to address climate change threats.

In 2017, the Energy Conservation Building Code (ECBC) was revised for new commercial buildings which sets minimum energy standards for commercial buildings having a connected load of 100kW or contract demand of 120 KVA and above.

"Large-sized residential complexes are now given an obligation to adopt energy efficiency techniques, constructions and interiors. Why residential buildings?

"Buildings consume around 31% of the electricity in the country and being the main source of energy consumption we have to see that all the new buildings especially the large residential buildings complexes are energy efficient,"

Alok Kumar, Union Secretary

Power Ministry said here. He was addressing a 'National Workshop on Energy Efficiency in the Indian Residential Sector' organized in hybrid mode by the Bureau of Energy Efficiency (BEE), under the Union Ministry of Power recently, in collaboration with the Federal Department of Foreign Affairs (FDFA) of the Swiss Confederation.

Kumar also deliberated about India's performance on the front of its commitment to the Nationally Determined Contributions (NDCs) made at the COP26 and highlighted that India has achieved some of them even before time.

"It is very essential that energy efficiency techniques and materials are used at the design and construction stage of buildings. This is all the more important as India is poised to urbanize very rapidly in one or two decades. More urbanization, more new buildings and we will see huge residential complexes coming up in all the old and new cities. Since 75 percent of energy demand comes from residential buildings, it is very impor-

he reasoned The official also lauded BEE for ensuring sufficient technical material and knowledge products are available to

tant that they are eco-friendly,"

the public. During the occasion, four knowledge products with support from Indo-Swiss Building Energy Efficiency Project (BEEP), a bilateral co-operation project between the Ministry of Power and the Swiss Government. It is being implemented by the BEE.

Aimed to facilitate energy efficiency measures in building sector, these knowledge products are a booklet on

"Understanding heart transfer in buildings through numerical examples", "Building envelope solution sets for Eco-Niwas Samhita 2018," "Vayu Pravah-an openfoam software tool on Computational Fluid Dynamics (CFD)" and manual on "external movable shading systems."

To promote green buildings, the government has provided numerous initiatives like the Green Rating for Integrated Habitat Assessment (GRIHA). This system restricts the use of resources by 30 percent as the ultimate goal. The government has also mandated for all central government and PSU

buildings to get at least 3-star ratings under GRIHA, said Deputy Director General (BEE) Ashok Kumar. "A sharp increase in ener-

gy consumption in buildings is being observed, particularly in countries with fast growing economies such as India. "With average temperatures rising globally, energy consumption and Co2 emissions are bound to increase, while buildings may fail to provide adequate thermal comfort. Therefore it is imperative to integrate energy efficiency measures into buildings," said Swiss Agency Development and Cooperation (SDC) head of

Jonathan Demenge. He pointed out that by

adopting ambitious energy efficiency measures, Switzerland was able to reduce energy consumption in new buildings by 75 per cent. "SDC with Swiss and Indian partners are working to bring in this experience, co-develop knowledge and expertise and translate these into energy efficient building design, technologies and policies in India through the BEEP project," said Demenge.

At the event, Architect Ashok B Lall, who has worked on several green buildings, suggested an "adaptive comfort" range of 19-32 degrees Celsius in the house, which allows little to no dependence on air conditioning or heaters. While it is easier for newer buildings to save on energy from the start, older buildings can also adapt quickly.

For instance, he said, Windows facing the sun are a major source of heat being trapped inside a house. Any shade or the use of blinds can prevent that from happening. Similarly, if the temperature outside is high, warm air can be

prevented from entering inside through airtight windows. Cracks or crevices allow the cooler air inside to escape, which puts additional load on

He stressed on creating awareness among stakeholders about the need for green buildings for better health which has become all the more important in the Covid times. Dr Sameer Maithel, director at Greentech Knowledge debunked the myth that building energy efficient building designs is a costly affair. Adjustments in older

buildings, which can be as basic as painting the roof with a reflective paint, can save thousands of rupees each month in electricity bills. "The use of external shades and roofs outside a window to prevent direct sunlight from entering the room is important. While insulating the roof is preferred, cheaper options include applying reflective paint, which reduces absorption of heat considerably. Hollow clay tiles can be paved on the roofs along with a layer of concrete to prevent sunlight from being absorbed," said Maithel.

In a feather in the cap of the Mumbai police, the sleuths from the unit-6 of the city Crime branch traced a minor girl of Indian origin – who had gone 'missing' from Sweden – to her Instagram friend living at down Instagram friend living at down-market Cheetah Camp at Trombay in north-eastern Mumbai

Within a week after the Interpol put out a Yellow notice about the disappearance of a Swedish girl of Indian origin, a team of Crime branch sleuths of the Mumbai police tracked down the Instagram friend of the missing girl who lives at Subhash Nagar at Trombay's Cheetah camp area.
"After our officers quizzed

her Instagram friend tactfully, the boy revealed that the Swedish girl was staying at Subhash Nagar. Afterwards our officers traced the place and took charge of the girl safely and handed her over to Children's Home at Dongri in Mumbai. The Crime Branch immediately notified the Swedish Embassy and Interpol in New Delhi about the safe rescue of the missing Swedish girl," a senior police officer said.

The crime branch requisitioned the help of Swedish Embassy in New Delhi, InterPol and other agencies to get in touch

girl. Her father Saradar Tamar, who flew down in Mumbai from Stockholm on Friday, identified his daughter. After he produced relevant documents and also the No Objection Certificate (NOC) issued by the Mumbai police, the authorities at the Children's Home at Dongri handed over his daughter to him.

Copter crash: Mobile phone of eyewitness sent for forensic test

Coonoor: The mobile phone of the person, who had video graphed the helicopter that crashed near here leading to the death of Chief of Defence Staff Gen Bipin Rawat and 12 others, has been sent for forensic examination, police said on Sunday.

Joe, a wedding photographer from Coimbatore, had gone to Katteri area in the hilly Nilgiris district along with his friend Nazar and some of his family members to click photographs on December 8. Out of curiosity he had recorded the video of the ill-fated helicopter on his mobile phone, apparently moments before it crashed.

The video of the chopper disappearing into the fog has since gone viral in the social media. The district police have collected Joe's mobile phone and sent it to forensic lab in Coimbatore, as part of investigation in the case. A probe is also underway to ascertain why the photographer and few others with him had gone to the dense forest region, which is a prohibited area due to the frequent movement of wild animals, they said.

Meanwhile, the police department has sought details relating to weather and temperature in the region on the fateful day, from the Meterological department in Chennai.

Besides, police are questioning witnesses to gather clues about the crash, they said. General Rawat, his wife and 11 others were killed when the Mi-17VH helicopter crashed in a wooded valley at Katteri-Nanjappanchathram area in Coonoor on Wednesday. Partying hard-ly

The Govt has a tough choice: To instantly curb festivities or wait to know more about Omicron?

he year-end festivities generally begin on December 15 and last till January 5 in the new year. Globally, the travel, tourism, hospitality and entertainment industries rake in their maximum revenues in this period. The high streets in world capitals turn night into day as millions of tourists shop and window-dress. Is Omicron about to put a dampener on the celebrations this year? Looks likely. Governments across the world are planning to put a brake on the year-end events citing three factors. One, though not much is known about the new Coronavirus mutant's infective abilities, it is clear that it is more easily transmissible, with a greater risk of re-infection than Delta. Two, nearly all the Omicron cases in the world are linked to travel. Three, since Omicron affects people irrespective of their vaccination status, gatherings in large numbers are a clear invitation to the infection. The Governments' cautious approach is justified after



the bitter Delta experience. Incoming tourists are a trickle in Israel and Japan. Christmas shopping in Berlin and Munich in Germany may not happen on a large scale this year. Brazil has already stopped mass gathering in this season. The famous December 31 celebration on Copacabana beaches stands cancelled. The American authorities have called off

one of the spectacular fireworks shows in Baltimore. And, in New York, only the fully vaccinated can come to Times Square to watch the ball drop on New Year's eve.

In India, Odisha became the first State to ban people from gathering in hotels and clubs and other public places on December 31 and January 1. The question before the world Governments is whether to stop international travel to contain the spread of Omicron. They can test and trace Omicron positive cases coming in, but the risk of more such cases travelling by air cannot be ruled out. Scientists should advice on a travel option that minimises the risk. Flights from high-risk countries pose the biggest problem. There will come a point when two things will happen simultaneously: More and more cases will be detected at airports while they contribute to increased re-infections among the general population. This is the classic introduction to a wave that must be avoided at all costs. The UK, without any restrictions as of date, is facing the risk of a major wave this January, according to scientists. Vaccinations and booster shots will only help reduce the risk of death, but once hospitalisations stress the health care infrastructure, things can go awry. The Indian Government has a tough call to make. Should it wait till more is known about Omicron or announce festive season restrictions right away? Already, there is mounting fear of advance tourist bookings being cancelled, people seeking refunds of foreign package trips and doubts about people reserving their tables at restaurants. The tourism and hospitality industries that took a severe hit last year are only now beginning to revive. Omicron has the potential to crush their hopes this year.

to have failed to grasp people's mood and that the movement is now much bigger than Suu Kyi and that she hardly has any hold on the sporadic yet orchestrated people's anger. All that the Myanmar army could get by arresting and sending her to jail was international condemnation, isolating it further. The United Nations Special Rapporteur for human rights in Myanmar, Tom Andrews, called the verdict a "theatre of the absurd" and described the country's junta as "a criminal gang". Human Rights Watch said the military was "using this sham court proceeding to wipe out all opposition

to military dictatorship".

You don't have to be a genius to figure out that she has been jailed on frivolous charges. Her sentence: Initially, four years in prison for incitement and breaking COVID-19 rules during the election campaign. But she still faces 10 more charges that could see her imprisoned for the rest of her life. Suu Kyi was Myanmar's State Counsellor and de facto leader before she was ousted and detained when the military seized power on February 1, 2021. Known as "Mother Suu" to supporters, her party won the 2015 elections with a thumping majority and she became the State Counsellor. However, she fell from grace when she overlooked the Rohingya massacre and went on to defend the army for its pogrom against them. Ethnic cleansing has been systematically going on in Myanmar for decades now and hundreds and thousands of people have been killed by the army. The same army Generals that she defended have now arrested her and, if they have their way, they would keep her incarcerated forever. Poetic justice, some would say!

The need for Chief of Defence Staff

everal months after the conclusion of the 1971 Bangladesh Liberation War, rumours had begun to fly that, due to its success, the Army might take over power from the then Congress Government. Prime Minister Indira Gandhi was anxious for her own reasons. That inflation was increasing if not raging which, she believed, was a frequent cause for losing elections. She, therefore, asked General Sam Maneckshaw to meet her. While chatting, she happened to mention rumours of an Army takeover, and asked the General if he had any such plans. Maneckshaw, with his wry sense of humour, reacted by asking: "So?"

This made Indira Gandhi nervous, but eventually she got an assurance that Maneckshaw had no such plans. This episode put a lid on the concept of the integration of the three services of the armed forces under a single chief of staff. Divide and rule through bureaucrats remained the system, whose seed had been sown by Jawaharlal Nehru, who was doubly convinced that he was right when Ayub Khan seized power in Pakistan in 1958. Nehru had apprehensions the morrow Independence. At the time, the British interim commander-inchief of the Indian Army, General William Lockhart, asked Nehru as to the scale and style of the Army he would like the Cin-C to plan for. To this, the Prime Minister's reply was that India was a peaceful country and therefore had "no need for an army". The police would suffice to protect the country. The style and scale therefore, ought to be to whittle down the Army.

VK Krishna Menon, İndia's then Foreign Minister, Nehru's friend and guru on foreign affairs and international relations, also believed that the armed forces generally were a threat to the civilian Government of a Third World country. He also believed that no Communist country would even attack india because it was looked upon as a "fraternal when he retired that the post power". The Chinese of Chief of Defence Staff Communist Party by then was (CDS) was created and

winning that country's civil war and was expected to defeat the Nationalist Kuo Min Tang of Chiang Kai Shek, which it eventually did in October 1949.

As time went on, the Indian Government's policy was to appoint gentle and obedient generals as commanders-in-chief, soon to be watered down to Chief of Staff. Only when there were strong candidates who could not be superseded were less gentle generals appointed to the top post. Generals Thimayya and Choudhary were examples.

This issue of a joint commander was not only swept under the carpet, but was dug deep into its grave. It was publicly raised for the first time when the BJP first came to power with Atal Bihari Vajpavee as the Prime Minister. After that, the idea was tossed about with the respect a shuttlecock deserves.

It was not until the incumbent Prime Minister took over in 2014 that the idea of a Joint Chief of Defence Staff starting jelling seriously in political circles. The late General Bipin Rawat was first elevated to the position of Chief of Staff. It is only Chinese of Chief of Defence Staff

General Rawat was appointed there. His was perfectly a professional appointment. It is just possible that if the CDS had been in place in 1962, the Indian Air Force (IAF) might have been deployed in Ladakh, Arunachal Pradesh, or both. As it happened, Prime Minister Nehru was flabbergasted so much as to weep on the radio with the words, "Assam is in danger." The then Chief of Army Staff General Thapar had resigned, while General Brijmohan Kaul had no combat experience. In the meantime, the Indian soldiers, sent up at the last minute, had hardly any woollen clothes while trying to fight at up to 16,000-feet attitude. The Sino-Indian war of 1962 was possibly the most amateurishly fought by one side in the history of warfare, whereas the invading forces were welltrained and better equipped. Such a one-sided affair might have been avoided had there been more experience of generalship with the help of a joint command of the three wings of the armed forces.

Much water has flowed in the Ladakh rivers since. Warfare in the modern age is a multidimensional affair with an awesome variety of weaponry. It calls for a great deal of knowledge and experience, which a joint command would help to provide

with Generals, including naval and air, sharing thoughts and inputs together. The air force in a war has today become indispensable. The navy has become a combination of war in the air as well as water. Even the Army needs its own aircraft in today's theatres of war. The outcomes that flow from these permutations and combinations are truly mind-

Military commanders have to be thorough professionals in their domains and not the personal choices of the Prime Minister or political leadership. This is particularly important for our country because its culture has traditionally been inspirational as distinct from empirical. From mathematics to medicine, ancient India's contribution has flowed through inspired rishis as opposed to research, experimentation and debate. For example, the great physician Charak revealed ayurveda without seeing the inside of a human body. Therefore, we emphasise that our appointments should be strictly professional; neither personal nor inspirational.

FRST COLUMN INDIA'S CLIMBING RATE OF CLIMATE REFUGEES

Affected people will keep getting displaced unless effective measures curb climate change impact

uman displacement and consequent sufferings have always been associated with strife and conflict for political or economic reasons. However, of late, deteriorating environment on account of climate change is giving rise to climate disasters and extreme weather events that in turn are displacing more human population than conflicts and disturbances. The recent decade has been a testament to this new and concerning pattern wherein climate caused disasters have displaced millions of people globally making them climate refugees. The World Migration Report 2022 of the United Nations maps the worsening displacement of people due to climate-change-related events. 2020 witnessed displacement of 30.7 million people across 145 countries. There is also the mater of internal displacement countries on account of climate related disasters. The Philippines experienced the highest absolute numbers of 5.1 million displacements caused by natural disasters in



2020, whereas China reported five million new disaster-related displacements by the end of 2020. Storms accounted for 14.6 million displacements and floods, 14.1 million. Extreme temperatures displaced 46,000 people while droughts caused new displacement of 32,000 people in 2020. During 2008-2020, about 2.4 million new displacements were caused by droughts and over 1.1 million by extreme temperatures. A World Bank estimate predicts that 143 million people would migrate within their countries by 2050 due to climate change related events in sub-Saharan Africa, South Asia and Latin America. The United Nations Convention to Combat Desertification (UNCCD) also estimates that droughts could lead to the migration of 22 million more people in Africa, 12 million in South America and 10 million in Asia by 2059. These reports make the writing on the wall very much clear that displacement caused by climate disasters is an emerging problem and the rate of climate refugees is rising alarmingly every year. India especially is increasingly finding the rate of the climate refugees spiralling out of control. The Internal Displacement Monitoring Centre (IDMC) says that approximately 1.4 crore people in India have been displaced due to climate and envi-

As per the report, the "costs of climate inaction" will force over 4.5 crore people to migrate from their homes by 2050. The Centre data shows that over 38 lakh new displacements took place in India due to environmental disasters in 2020, which is 989 times more than the 3,900 displacements caused by conflicts. Given the scale of climate refugee numbers in India, the government must expedite work on a two-pronged strategy of preventing deterioration of the environment and rehabilitating the climate refugees through effective regulations and laws. Currently, climate refugees in India are not acknowledged and recognised explicitly under any specific law as a result scores of climate disaster displaced people have no identity nor recourse to relief and rehabilitation. Even at the international level, there is a conspicuous absence of clear-cut laws that deal with the subject of climate refugees. Given this scenario, it would bode well for India to make a bold first move in this sphere by launching social initiatives and legislative laws that not only recognise the plight of the refugees but also provide them the chance to reclaim their life, dignity and livelihoods. This path-breaking initiative will bring recognition to India on the international forum and help showcase India's concern and action regarding a critical subject on which no country globally has taken any concrete steps. Climate disasters and climate refugees are two sides of the same coin. Unless effective measures start reining in climate change, people impacted by the same will keep getting displaced. When climate change wanes, climate disasters too will come down and so will the numbers of climate refugees.

The Chinese march towards west Balkans

rmed with its foreign aid diplomacy, China has elbowed its way into the European geopolitical chessboard via Eastern Europe. In 2012 it launched its 16 + 1 cooperation framework, including all the Western Balkan states (excluding Kosovo) and nine other Central and Eastern European (CEE). Later next year, Greece joined in to make the initiative "17 + 1", thereby promoting what many strategic experts call multilateral bilateralism. Within the framework of BRI, Chinese economic cooperation with these 17 countries fulfils their mutual investment needs and strategic interests.

In the context of the Western Balkan states, Beijing from 2005 to 2019 has invested approximately \$14.6 billion (sans Albania), particularly in Bosnia and Herzegovina, Montenegro, North Macedonia, and Serbia in different projects, and more than 80 percent of these investments constitute loans with conditions as 'pre-agreements' on firms, workers, tax cuts. This has led to a situation of asymmetric interdependence that Beijing can essentially use as an essential bargaining tool vis-à-vis EU and the US.

Even during the Covid-19 lockdown, China successfully created a "health silk road" in the Balkans when in March 2020 European Commission decided to block essential pandemic goods. Both Russia and China used the opportune moment when they supplied them with the medical and surveillance equipment for COVID 19. Although later the EU coughed up \$9 million, given the trajectories of the pandemic, the help was a little late, and China's proactive health diplomacy was appreciated amongst the Balkan countries.

Closely associated with Chinese strategic inroads in the Western Balkans is EU membership. Of the six countries in the Western Balkans, official candidates for accession are Montenegro, Serbia, the Republic of North Macedonia and Albania, and potential member countries are Bosnia and Herzegovina and Kosovo. Although the official note from various EU platforms is a positive one, i.e., considering them for membership owing to their geographical and cultural affinity with the community, yet, there is hesitation on the part of EU, especially France, to finance the projects that do not sound 'lucrative' and are 'unaffordable' apart from the fractious olitical nature of their societies. Beijing has taken initiatives that are probably 'nonprofitable, such as the BRI-funded railway between Belgrade and Budapest, Chinese loans thus seem to be an attractive option for they can strategically communicate to EU to focus less on the political and the economic reforms for its membership apart from inviting more rigorous investment plans. Dorde Radulovic, the Minister of Foreign Affairs of Montenegro, apparently called the "heart of Europe", recently stated on the insufficient funding of EU and the US that it has "left an empty geopo-

litical space here in the Western Balkans,China jumped in". Beijing's economic presence

in the region is governed by debt trap conditions similar to South Asian and African countries. Projects are implemented by stateowned companies with Chinese workers employed, thereby increasing the geopolitical influence of Beijing. Imagining induced cultural changes through increased interactions to set the narratives of geopolitical changes perhaps would not be wrong if one looks at the previous case studies of small countries like Nepal and Myanmar falling into the trap of China. The vicious circle of being denied membership because of less political and financial credibility result-ing in Beijing's lucrativeness should be avoided to weaken its strategic outreach and the risks associated with it. If not so, the Balkans might perhaps land themselves in a situation of total political backsliding harming the long-term interests of the EU and North America.

Second, the strategic interests of China in the Western Balkans and other states can be understood in terms of the NATO membership of Albania, Montenegro and North Macedonia and Serbia's refusal to join the organisation for the reason of military neutrality. Bosnia and Herzegovina, on the other hand, are eager to join NATO owing to the Russian influence on the Serb community and consequently fear the collapse of the existing powersharing agreement. China, too, has made efforts to deepen its ties with the country, making it a fourth political actor after EU, NATO and Russia seeking influence. For example, Beijing has recently decided to finance coal plants in the country despite President Xi Jinping's pledge to reduce the projects sanctioned for

the usage of coal. The smart cities project and 5G communication networks have further increased China's influence. Such and other 'no strings attached' measures that seem affordable to the economically disadvantaged countries only enhance China's stakes in the is the creat within the Europe. Further, just as the tensions between the US and Russia on Ukraine reach the brim, the locational importance of the Balkans should not be missed by the strategic experts. Nevertheless, the larger aim of China is to construct a 'Land-Sea' route to connect the port of Piraeus (Greece) to act as a hub for EU-China trade. As envisioned by Xi, it is the Mediterranean's largest container transit port and serves as the southern gate of Central and Eastern Europe.

The third aspect that China capitalises on is an ideological one. Beijing has carefully increased its presence through the ideological similarities that it shares with some of the Balkan and Central European countries. These similarities in the near future will play an essential determining role in making crucial decisions such as voting in favour of China or possibly even military bases at an appropriate time. For instance, there is China-CEEC Political Parties' Dialogue and the China-CEEC Young Political Leaders Forum active participation in the World Political Parties' Dialogue to strengthen its linkages with the world communist countries, and finally, party to party cooperation with Montenegrin Democratic Party of Socialists and Serbian Progressive Party (SNS) apart from Yugoslavia. Further, although not recognised by Beijing, Kosovo maintains informal relationships and adheres to its 'One China' policy concerning Taiwan. The result


is the creation of sharp divisions within the European community.

The democratic summit hosted by the US has further divided Europe. With countries like Serbia, Albania, North Macedonia invited and Belarus, Hungary, and Bosnia and Herzegovina not invited, it has sharpened the divisions within Europe. China might fill the 'political vacuum' and extract advantages that perhaps could be detrimental to the interests of Europe and the US.

Europe has lately awakened to the Chinese threat, and in September 2021, EU adopted a new China policy that emphasised the Xinjiang human rights violations and the disinformation apart from "fostering strategic autonomy and defending European interests and values". The European Commission has recently aimed to evolve its role to that of a "geopolitical commission" that aims to strengthen the trade rules making it fully comply with the existing international law for trade. Launching the "Global Gateway" strategy worth Euro 300 billion focussing on digital, transport and energy projects apart from strengthening democratic partnerships has increasingly been seen as a response to China's debt trap practices.

Finally, from a different perspective, the role of the Western Balkans should be pondered over. The Balkans strategically would expect favours such as EU waiving off its debt owning to the Chinese strategic inroads and might expect a reciprocal move as a counterresponse from China. Alternatively, the countries might expect EU to pay off the Chinese debt in place of military favours. In either case, the transfer of the European wealth to the Chinese banks thus seems to

be inevitable.

Safe motherhood is key to self-reliant India

Health workers and the community at large should support pregnant women in becoming advocates for their health and make informed decisions

A society of healthy women lays the foundation of a healthy, dynamic and progressive nation. Constant development of the country can thus be achieved only if we take holistic care of our women and children. The rapid decline in maternal and infant mortality rates can be attributed to the efforts of our government since 2014, political commitment, well-designed policies and significant investment in the National Health Mission under the leadership of PM Narendra Modi. Ensuring quality maternal health is one of the top priorities of our government. I echo the Prime Minister's words at the Partners' Forum in 2018: "Health of mothers will determine the health of our

From instilling a behavioural change for helping more women deliver in hospitals through Janani Suraksha Yojana, for absolutely free services under the Janani Shishu Suraksha Karyakaram (JSSK), we have come a long way now in providing quality and



respectful maternity care throughout pregnancy and childbirth. Surakshit Matritva Aashwasan (SUMAN) 2019, aims to build a proper maternal ecosystem to assure respectful delivery of quality healthcare services at no cost and zero tolerance for denial of services to any woman and her new born visiting a public health facility in order to end all preventable maternal and new born deaths and morbidities. This is weaved with many other initiatives including the Labour room Quality improvement initiative (LaQshya) 2017, to provide quality maternal healthcare at public health facilities.

Under the current government, the country has also witnessed innovative ideas being translated into action in the field including those related to health and wellbeing of pregnant women. The Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA), launched in 2016, guarantees a minimum package of antenatal care services to women in their second and third trimesters of pregnancy at designated government health facilities by a physician or specialist. Moreover, under the guidance of Minister of Health Family Welfare Mansukh Mandaviya, Maternal Perinatal

Response (MPCDSR) software has been recently launched to streamline actionable data in order to eliminate preventable maternal mortality.

Lately, it became crucial for the country to establish "birth models" that promote cultural awareness in birth practices, respect woman's autonomy, preferences and choices during child birth, overall contributing to a positive birthing experience. Scaling new frontiers, in 2018, the GoI took a policy decision to roll out Midwifery Services with the help of Nurse Practitioner in Midwifery (NPM) in the country to provide a positive birthing experience. This will require making a palpable shift to the way

Russia's military build-up near the Ukrainian border has dominated talks among foreign ministers from the Group of Seven wealthy democracies in the English city of Liverpool.

The US and its NATO and G-7 allies worry that the movement of Russian troops and weapons to the border region could be precursor to an invasion, and have vowed to inflict economy if that happens.

Moscow denies having any plans to attack Ukraine and accuses Kyiv of its own allegedly aggressive designs.

Truss, who discussed the crisis with US Secretary of State Antony Blinken and other G-7 diplomats, said the group was sending a "powerful signal to our adversaries and our

"We've been clear that any incursion by Russia into would be a severe cost," she said at a news conference on the final day of the weekend meeting.

Top diplomats from the G-

7 nations — the UK, the United States, Canada, France, Germany, Italy and Japan — are likely to deliver a stern warning to Moscow as part of their conclusions to the conference later Sunday. It's less clear how much detail they will give about the measures they might take. When it comes to economic sanctions, Truss said the G-7 was "considering all

A senior US official who participated in the G-7 discussions said the ministers were united in their "extreme concern" about developments on the Russia-Ukraine border and agreed on the need for strong measures that could be implemented "very, very fast" if Russia did not heed warnings to back down.

The US and its allies have played down talk of a military response to defend Ukraine, with efforts focusing on tough sanctions that would hit the Russian economy, rather than iust individuals.

G-7 nations are also increasingly concerned about China's growing economic and technological dominance, especially in developing countries. The G-7 has launched a "Build Back Better World" initiative to offer developing nations funding for big infrastructure projects as an alternative to money from China that, the West argues, often comes with strings attached.

Truss said the G-7 was "concerned about the coercive economic policies of China."

"And what we want to do is build the investment, reach the economic trade reach of like-minded, freedom loving democracies," she said. "That is why we are stepping up our investment into low- and middle-income countries."

A unified stance towards China continues to prove elusive, however, with the US and Britain generally more hawkish than other G-7 members.

Tornado tears middle of US, leaves dozens dead in 5 States

monstrous tornado, carv-Amoustious tornade, the longest on record, ripped across the middle of the U.S. In a stormfront that killed dozens and tore apart a candle factory, crushed a nursing home, derailed a train and smashed an Amazon warehouse.

"I pray that there will be another rescue. I pray that there be another one or two," Kentucky Gov. Andy Beshear said, as crews sifted through the wreckage of the candle factory in Mayfield, where 110 people were working overnight Friday when the storm hit. Forty of them were rescued.

'We had to, at times, crawl over casualties to get to live victims," said Jeremy Creason, the city's fire chief and EMS

In Kentucky alone, 22 were confirmed dead by Saturday afternoon, including 11 in and around Bowling Green. But Beshear said upwards of 70 may have been killed when a twister touched down for more than 200 miles (320 kilometres) in his state and that the number of deaths could eventually exceed 100 across 10 or more

The death toll of 36 across five states includes six people in Illinois, where an Amazon facility was hit; four in Tennessee: two in Arkansas. where a nursing home was destroyed; and two in Missouri.

If early reports are confirmed, the twister "will likely go down perhaps as one of the longest track violent tornadoes in United States history," said Victor Genzini, a researcher on extreme weather at Northern Illinois University.

The longest tornado on record, in March 1925, tracked for about 220 miles (355 kilometres) through Missouri, Illinois and Indiana. But Genzini said this twister may have had touched down for nearly 250 miles (400 kilometres). The storm was all the more remarkable because it came in December when normally colder weather limits tornadoes, he said.

Debris from destroyed buildings and shredded trees covered the ground in Mayfield, a city of about 10,000 in western Kentucky. Twisted metal sheeting, downed power lines and wrecked vehicles

lined the streets. Windows and roofs were blown off the buildings that were still standing.

Budget: Govt unlikely to announce capital infusion for PSBs

New Delhi: The Government is unlikely to announce capital infusion for public sector banks (PSBs) in the upcoming Budget, as their financial health has improved on the back of reduction in bad loans, sources

To augment their resources, banks would be encouraged to raise funds from the market and also by selling their noncore assets, they added. During the current financial year, the government has earmarked ₹20,000 crore for the recapitalisa-

Finance Minister Nirmala Sitharaman is expected to present the fourth budget of the Modi 2.0 Government on February 1. It is to be noted that the net profit of PSBs surged to ₹14,012 crore in the first quarter, which further rose to ₹17,132 crore in the second quarter ended September 2021.

The combined profit of the first half of the current fiscal is close to the total profit earned in the entire previous financial

During the last financial year, PSBs raised capital funds to the tune of ₹ 58,697 crore, the highest amount mobilised in a

Capital Adequacy Ratio (CAR) of PSBs increased to 14.3 per cent at the end of June, 2021 while the provision coverage ratio of public sector banks rose to an 8year high of 84 per cent. In some of the non-performing assets, banks have done provisions up to 100 per cent, sources said, adding that recovery from those

accounts will straightaway form part of the bottomline.

Banks have been asked to focus on the recovery process as this would further boost their financial health.

Meanwhile, banks are also working to expand their balance sheet under the credit outreach programme started October 16. 2021. Various reforms undertaken by the Government including recognition, resolution and recapitalisation resulted in progressive decline in non-performing assets NPAs) and subsequent rise in profit.

NPAs of PSBs declined from ₹7,39,541 crore as on March 31, 2019, to ₹ 6,78,317 crore as on March 31, 2020 and further to ₹6,16,616 crore as on March 31, 2021 (pro-

Provision Coverage Ratio (PCR) at the same time increased sequentially to a high of 84 per cent. As a result, PSBs in aggregate recorded a profit of Rs 31,816 crore, highest in five years, despite 7.3 per cent contraction in economy in 2020-21 due to Covid-19 pandemic.

The primary reason for PSBs to post Rs 57,832-crore turnaround in last financial year, from a loss of ₹ 26,015 crore in 2019-20 to a combined profit of ₹31,816 crore was the end of their legacy bad loan problem.

At the same time, comprehensive steps were taken to control and to boost recovery in NPAs, which enabled PSBs to recover ₹ 5,01,479 crore over the last six finan-



"There will be a gap between demand and supply although it will narrow if companies upskill and reskill existing employees on technology side, and new industry-ready courses are developed to



meet the requirements of gaming and mobitech segments," he

Vohra said 5G is expected to further speed up demand for professionals across domains.

"We are seeing demand for professionals coming in for 5G technology, and 5G engineering domains...There are positions to be filled in areas like network operations, mobile towers, optical fibre..." Vohra noted.

Recently, Communications Minister Ashwini Vaishnaw said he expects the auction for the 5G spectrum to take place around April-May next year.

Telecom regulator Trai, in November-end, released a detailed consultation paper to discuss modalities for auction of 5G spectrum bands, including pricing, quantum, valuation methodology and auction nuances.

Trai will provide its recommendations on issues such as applicable reserve price, band

plan, block size, quantum of spectrum to be auctioned and associated conditions for auction of radiowaves in 526-698 MHz, 700 MHz, 800 MHz, 900 MHz, 1800 MHz, 2100 MHz, 2300 MHz, 2500 MHz, 3300-3670 MHz and 24.25-28.5 GHz bands.

Mobile operators, in partnership with telecom equipment makers, are currently in the process of conducting 5G trials, in

"Solutions developed by companies that are into fintech, mobile tech, gaming, entertainment, OTT (over-the-top) and telecom will fuel demand for skilled professionals, and hirings will have to keep pace with the growing requirements," Vohra said. PTI

Depositors should be careful while chasing high returns: RBI Guv

New Delhi: Reserve Bank of India (RBI) Governor Shaktikanta Das on Sunday cautioned depositors to be careful while chasing high returns as it comes with greater

Observing that depositors themselves also need to be very discerning, he said it is important to keep in mind that higher returns or higher interest rates are usually associated with higher risks.

"So, just because a bank is offering higher interest, the depositors themselves should be very careful before putting in money while chasing such high returns because usually, our experience is that high returns or high interest rates are associated with higher risks," he

However, he said there are institutions that are offering higher interest and are still viable but depositors should always be very careful.

Speaking at the 'Depositors First' event here, Das said the Reserve Bank remains committed to ensuring that the banking system remains robust and resilient but it has to be a joint effort.

"Every stakeholder whether it is the management of banks, whether it is the board of banks, whether it is the various committees of



banks, the audit committee, the risk management committee, or any other regulatory authority that is associated, it has to be a joint responsibility for all of us," he said.

Das stressed that the payment of the deposit insurance amount should be seen as a measure of last resort. "The RBI has been adopting a proactive strategy to strengthen the regulatory guidelines to strengthen the supervisory methods and to look at things which will ensure that going forward the banks function in a very resilient manner.'

Recalling his statement in the recent monetary policy statement, Das said, "I had said that the country has demonstrated working together during this entire pandemic and India's moment has come where India can become a growth driver for the world economy.' It will be possible if all stakeholders in the banking system work together, he added. *PTI*

FPIs net sellers at ₹8,879 cr in Dec

New Delhi: Foreign portfolio investors (FPIs) were net sellers in the Indian markets to the tune of ₹8,879 crore so far in December. As per depositories' data, they

took out ₹7,462 crore from equities, ₹1,272 crore from the debt segment and ₹145 crore from hybrid instruments during December 1-10.

This took the total net outflow to ₹8,879 crore during the period. In November, FPIs were net sellers to the tune of ₹2,521 crore in Indian markets.

There continues to be concerns over the highly transmissible Omicron variant of coronavirus, which has impacted global growth outlook and could play a spoilsport, said Himanshu Srivastava, associate director (manager research) of Morningstar India.

This has already turned investors risk-averse.

Adding to it, Shrikant Chouhan, head- equity research tion and expectation of monetary tightening by the US Federal

V K Vijayakumar, chief investment strategist at Geojit Financial Services, said sustained selling has been witnessed in banking in which FPIs have the largest holding.

They have been sellers in information technology (IT), too.

"Paradoxically, banking and IT are two segments that have good earnings visibility," he added.

The pace of selling is likely to come down if the markets remain resilient, he said. For the debt segment,

Srivastava said the flow has largely been driven by the direction of the US dollar and US treasury

"The surge in the US treasury yields this week could have also triggered some outflows form the Indian bond market," he said.

Power consumption rises 1.3% to 34 bn units in first ten days of December

New Delhi: India's power consumption grew by 1.3 per cent in the first ten days of this month from December 1 to 10 to 34.23 billion units (BU) over the same period a year ago, according to power ministry data. In 2020, power consumption was 33.78 BU during December

1 to 10. In the entire month of December 2020, consumption was 105.62 BU, up from 101.08 BU in December 2019. Experts are of the view that

power consumption as well as demand would grow at a steady pace in December with improvement in economic activities across the country.

During the first 10 days of December this year, the peak power demand met or the highest supply in a day, touched 169.12 Gigawatt (GW) compared to 165.42 GW in the same period in 2020. The peak power demand met in December 2020 was 182.78 GW up from 170.49 In November this year, the

power consumption grew by 2.6 per cent to 99.37 BU. Last year in November, power consumption stood at 96.88 BU and in the same month in 2019, it was at 93.94 BU. The country's power con-

sumption had grown by 3.3 per

cent in October this year to 112.79 BU compared to 109.17 BU in the same month last year.

Many States had imposed

lockdown restrictions after the second wave of the pandemic hit the nation in April this year and affected the recovery in commercial and industrial power demand as states started imposof the month. Curbs were gradually lifted as the number of COVID cases fell. Power consumption witnessed 6.6 per cent year-on-year growth in May this year at 108.80 BU, despite a low base of 102.08 BU in the same

In June, it grew nearly 9 per cent to 114.48 BU, compared to 105.08 BU in the same month last

In July, it rose to 123.72 BU from 112.14 BU in the same month a year ago. In August this year, power consumption grew by over 17 per cent at 127.88 BU compared to 109.21 BU in the

Power consumption in September this year witnessed subdued recovery with almost flat growth at 112.43 BU mainly due to delayed monsoon (heavy rains). In September last year, power consumption was 112.24





STAY STRESS-FREE

DR CHANDNI TUGNAIT explains ways of breaking the normalcy developed around anxiety amongst employees

Research has proven that our brains are 'wired' specifically to detect patterns, identify dangers and react accordingly. However, through intense pressure that we subject ourselves to, in our day-to-day lives, the mind is often unable to distinguish between stress that is real and the stress that is imagined; if we think something has the potential to put us in harm's way, it will trigger the same response as actual danger

Stress can be self-created or self-perpetuated simply by thinking about it. In other words, when an employee feels they have a looming deadline, their brain automatically reacts as if their deadline were right around the corner, even if they have free time on their hands. It is important that we promote the leader mindset at work and do not normalise stress and anxiety. The important thing is to get into the action mode instead of focussing on stress and allowing it to increase exponentially through self-perpetuation.

Employees cannot be expected to avoid every piece of stress that comes into their lives; however, they can be trained on how to handle stress more effectively when it does come along by breaking the normal stress patterns and

Stress is known to lead to insomnia, headache, irritable bowel syndrome, breathing issues, ulcers, high blood pressure, obesity, suppression of the immune system, diabetes, heart ailments, depression, panic attacks and pain in the body. An excess of stress, also known as the distress syndrome, can prove to be very harmful for one's mental, emotional and physical health. In the current fast-paced world, many times, we start perceiving the excessive workload, driving in traffic, family concerns, daily deadlines of emails, and so on as stress. The unconscious algorithms are running for all of us. The key is to be aware and then to be able to change the state. Promote healthy eating instead of 'stress eating'. When we are stressed, the brain releases cortisol that makes us crave salt, sugar and fats for temporary pleasure. It is important to encourage healthy eating habits at work to handle pressure in better ways.

SET AN EXAMPLE

As a leader, take out time for selfcare. If employees see you stretching yourself beyond your capacity, working round the clock, not prioritising your health, they are more likely to get impacted by it all and continue to stay overwhelmed. Walk the talk — set the culture right.

OFFER PROFESSIONAL

It is important to confide in someone who offers a non-judgmental space to share all that one desires. Hold the space for your employees to connect with you and have authentic communication. Offer them support in the ways you can. In case of chronic stress, connect your employees to an expert who can help them cope better.

It's about time people acknowledge the colossal impact of stress at work, break the normalcy around it and make some lifestyle changes to address the stressors before stress takes over every aspect of their lives and business. Stay stress-free!


Ethical concerns while developing economy

Rajyogi Brahmakumar Nikunj ji says that economics, estranged from ethics, leads to man's moral downfall



A POSSIBLE CURE FOR PARKINSON'S DISEASE?

Amolecule that shows promise in preventing Parkinson's Adisease has been refined by scientists at the University of Bath in the UK.

Professor Jody Mason, who led the research, explains, "Work still needs to happen, but this molecule has the potential to be a pre-cursor to a drug. We hope to develop a drug that can return people to good health before symptoms develop.

A peptide known to prevent the protein error that gives rise to Parkinson's disease has been optimised by scientists. The new peptide is a strong candidate for future development into a cure.

Parkinson's disease is characterised by a protein in human cells 'misfolding', where it becomes aggregated and malfunctions. The protein, alpha-synuclein (aS), is abundant in all human brains. After misfolding, it accumulates in large masses, known as Lewy bodies, which comprise aS aggregates that are toxic to dopamine-producing brain cells, causing them to die. This triggers the symptoms of Parkinson's disease

AIR POLLUTION INCREASES RISK OF COVID-19

Jonty hundred, Sangwan fivefor help Delhi beat Haryana by 10 runs

Former India U-19 captain Jonty Sidhu hit a run-a-ball hundred while skipper Pardeep Sangwan grabbed a five wicket haul as Delhi beat Haryana by 10 runs in an exciting Group C league game of the Vijay Hazare Trophy here on Sunday.

Delhi scored 267 for 5 in their 50 overs with left-handed Sidhu hitting eight fours and three sixes while adding 145 runs for the fifth wicket with former Delhi Capitals player Lalit Yadav (75 off 92 balls).

In reply, Haryana were all out for 257 in exactly 50 overs with Shivam Chauhan, who scored a hundred (107 off 136 balls), and Pramod Chandila (78) adding 166 runs for the fourth wicket. Haryana were cruising along at 236 for 3 before Sangwan (5/52) and Mayank Yadav (3/61) removed
