Russia raises N spectre

Putin puts nuclear forces on alert; EU closes airspace, vows to arm Ukraine

In a dramatic escalation of East-West tensions over Russia's invasion of Ukraine, President Vladimir Putin ordered Russian nuclear forces put on high alert Sunday in response to what he called "aggressive statements" by leading NATO powers.

In response to this, the European Union (EU) decided to close its airspace to Russian airlines, fund weapons purchase to Ukraine and ban some pro-Kremlin media outlet, European Commission officials said late on Sunday night. The measures, which Commission President Ursula von der Leven said she expected to be endorsed, would mark the first time the 27-nation bloc finances the purchase and delivery of weapons and equipment to a country under attack.

"Another taboo has fallen. The taboo that the European Union was not providing arms in a war," said the EU's foreign policy chief Josep

Earlier in the day, street fighting broke out in Ukraine's second-largest city and Russian

troops squeezed strategic ports in the country's south Sunday, advances that appeared to mark a new phase of Russia's invasion following a wave of attacks on airfields and fuel facilities elsewhere in the country. Following its gains on the ground, Russia sent a delegation to Belarus for peace talks with Ukraine, according to the Kremlin. Ukraine's president suggested other locations, saying his country was unwilling to meet in Bélarus because it served as a staging ground for the invasion.Putin's latest order means he wants Russia's nuclear weapons prepared for increased readiness to launch and raises the threat that Moscow's inva-

4th Covid wave to hit in June, says IIT-K

'Severity will depend on new variant'

PNS NEW DELHI

Just when India has started relaxing Covid-induced restrictions, a team of Indian Institute of Technology (IIT) Kanpur, has warned that the fourth Covid wave might arrive in mid to late June. They said the surge is likely to continue for about 4 months — to be precise from around June 22 to be continued till October 24.

The IIT team has been quite accurate in their previous forecast about Covid-19 onset, with a deviation of only a few

The severity, however, will depend on the emergence of the new variant, its nature, the vaccination status as well as administration of booster doses across the country, the IIT team said.

The statistical prediction was published on the preprint server MedRxiv on February 24. However, it is yet to be peerreviewed. According to their paper, the curve will peak sometime around August 15 to

31 and decline thereafter. Predictions by



Rajeshbhai, Subhra Sankar Dhar and Shalabh of the department of mathematics and statistics of IIT-K — used a statistical model and said the fourth wave in India may arrive 936 days after the initial available date of the Covid-19 outbreak which was January 30,

"Therefore, the fourth wave (presumed) starts from June 22, reaching its peak on August 23 and ending on October 24,"
they said. The team used a
methodology called "bootstrap"
to compute the confidence
interval of the time point of the peak of a fourth wave," it said.

According to the researches, the method can also be used to forecast a fourth and other waves in other countries as

There is always a fair chance that a new variant of this virus may have an intense impact on the whole analysis. The intensity of the impact will depend on various factors like infectibility, fatality etc., the researchers said

US eases visa norms for Indian students and workers

The United States (US) has waived in-person interview requirements for many visa applicants, including students and workers, at its diplomatic missions in India through December 31 this year, a senior American diplomat has told Indian community leaders.

These applicants eligible for the waiver are students (F, M, and academic J visas), workers (H-1, H-2, H-3, and individual L visas), Culture and extraordinary ability (O, P,

and Q visas).

"This is much-needed support to visa applicants. This would be very helpful to our friends and immediate family members and remove a lot of their concerns and remove inconveniences," Ajay Jain Bhutoria, South Asian Community Leader and US President Joe Biden's Advisor for Asian Americans, said after his meeting with Assistant Secretary of State for South Central Asia, Donal

Will serve Varanasi till dying day: Modi

PM says felt happy when people 'prayed' for his death

Prime Minister Narendra Modi on Sunday said it will be a privilege to serve people of Varanasi till his dying day, alluding to a remark by Samajwadi Party leader Akhilesh Yadav that people come to the city in their final

Addressing BJP workers in his Lok Sabha constituency, Modi also alleged that opposition leaders take their parties as private property and they can never challenge the BJP, which is a party of workers.

Without taking any name, Modi said, "When people prayed for my death in Kashi,

I was very happy."
"I realised that neither Varanasi nor the people here

ilege for me to die while serving people of Varanasi," Modi said alluding to the remark made by Yadav weeks

On the day Modi inaugurated the Kashi Vishwanath corridor in Varanasi last December, Yadav had taunted him, saying people stay in Kashi "when the end is

Modi said for him party workers are a university, from which he learnt a lot of

The dynasts who consider their parties as their private properties can never challenge the BJP, which is a party of its workers and works only for the development of the country,' Modi said speaking at the event on the Sampurnanand university

Modi also accused previous government of neglecting the pilgrim city and said criminals had a free in the state.

Terrorists used to "operate

without any fear" during the Samajwadi Party's rule in Uttar Pradesh, Modi alleged.

"Under the rule of dynasts, temples of Varanasi were looted by people and bombs use to explode at temple but nothing was done under the Samajwadi Party, which did everything to protect those accused of terrorism," he alleged.

Modi said the dynasts neglected Varanasi, which is now changing.

"After so many years, the Kashi Vishwanath temple has met the bank of river Ganga again. The double-engine govrnment is taking UP to newer heights," said the PM.

Modi said UP had only 33 medical colleges before 2017 and now their number has gone up to 65. The BJP government has constructed over 10 lakh houses for the poor, he

The government gave free ration to 15 crore families, including the Dalits, backward classes and the general category people, he said.

Girls should marry after proper education: RSS women's wing

A head of the annual meeting of the RSS' highest decision-making body, its women wing Rashtriya Sevika Samiti on Sunday said that girls should marry after getting proper education, but suggested that "imposing" a marriage age might not yield desired results.

The three-day meeting of Rashtriya Swayamsevak Sangh's Pratinidhi Sabha will start from March 11 where a host of issues are expected to be discussed including the proposed raising of the marriage age of females from 18

During the Winter session of parliament in December, Union Women and Child Development Minister Smriti Irani introduced the bill proposing to raise the marriage age of females from 18 to 21 years, on a par with

But the bill was later referred to a parliamentary standing committee by Lok Sabha for wider discussions. Prime Minister Narendra Modi and his government have projected the proposed legislation as an important step to provide equal opportunities to girls and boys in

society. Underlining that Rashtriya Sevika Samiti "opposes" child marriage, its prachar pramukh Sunila Sohwani said, "Girls should marry after proper upbringing and education so that they can become an able person."

When asked about the

overnment's bill proposing to increase marriage age, Sohwani said the organisation has gathered feedback from society and there were different opinions both favouring and opposing it.

"According to the feed-back gathered by us from our workers and society, there were both types of views regarding raising the marriage age of girls.
"'It has been observed that

imposing something on society on social issues such as marriage age of females might not yield desired results. Such issues are better to be dealt with public awareness and

On the question of the BJP-led central government's approach, Sohwani termed it as "appropriate" and said the government has been holding wider discussions on this issue.

Sohwani said the Samiti has also shared its views with the parliamentary standing committee examining the

Parliamentary Standing Committee on Education, Sports and Women and Child Development, chaired by senior BJP leader Vinay Sahasrabuddhe, has invited suggestions from the public on the issue.

The bill was drafted on the basis of the suggestions of a task force headed by former Samata Party president Jaya

The task force was assigned by the ministry to look into the correlation between the age of marriage with issues of women's nutrition, the prevalence of anemia, infant mortality rate and other social indices.

Guj Cong promises electricity concessions, jobs, gas cylinder price cap if voted to power

The Gujarat Congress on Sunday promised to pro-The Gujarat Congress on vide electricity free of cost or at concessional rates to domestic users, a cap on domestic gas cylinder price at Rs 500, and creation of 10 lakh jobs annually if voted to power in the state Assembly polls scheduled to be held later this year.

The opposition party also promised Rs 4 lakh assistance and a government job to the kin of COVID-19 victims and said it would free farmers from debt, cut their power bills by half and provide direct assistance of Rs 70,000 per year under the 'Nyay Yojana to needy families. The Congress promised to re-introduce the 2004 pension scheme, start the 'Mahatma Gandhi Education Complex' model to "liberate parents from exploitation through commercialisation of education" as well as a "timely recruitment calendar" to fill more than five lakh government vacancies.

Releasing the party's 'Dwarka Sankalp Patra' (resolution) on the last day of its three-day conclave organised at

Dwarka, state unit president Jagdish Thakor said people were left with no option but to go in for change as the BJP government was witnessing policy paralysis.

The administration has also been BJP-ised, and it is used more for political pur-poses than for the welfare of the people. The BJP government has not lived up to the expectations of the people. Its promises have proved to be false. The condition of the people has deteriorated instead of improv-

ing," he told a gathering.
"The Congress will ensure nobody has to pay more than Rs 500 per gas cylinder. Provision will be made to provide electricity on free or concessional basis depending on the residential electricity bill," Thakor said. Denied entry into Poland, Slovakia: Stranded Indians

aught between a rock and Ca hard place is the situation of many Indian nationals, including Malayalis, trapped in Ukraine as they are allegedly not being allowed through at the Polish and Slovakian borders and have no place to go in

Turned away at the Polish and Slovakian borders, after travelling hundreds of kilometres from their respective colleges and standing in long queues for hours, prompted many students, in desperation, to resort to making video calls to media outlets to let the Indian authorities know the problems they are suffering.

Their desperate messages appear to have reached some

Minister Pinarayi Vijayan shot off a letter to Prime Minister Narendra Modi inviting his attention to this problem.

The Kerala CM also raised the issue in his discussion with External Affairs Minister S Jaishankar who, according to the CMO, assured that there are Indian officials at the borders who can deal with the problem of Indians not being allowed through. However, one set of students, who are stuck at the Slovakian border for several hours now, in their video call to a news channel said that Indians were being turned away and Ukrainian women and children were being given priority there.

The students, many of them women, claimed that the

ears too as Kerala Chief border authorities were not letting them through as they have not received any communication from the Indian Embassy about allowing Indian nationals through.

Earlier in the day, a student had shared visuals of alleged Ukrainian army personnel assaulting Indian students at the Polish border and preventing them from going through. Subsequently, several video

messages of stranded Indian students complaining about being not allowed through at the Polish borders, went viral.

Meanwhile, Kerala Pradesh Congress Committee president and MP K Sudhakaran also wrote to Jaishankar drawing his attention to the request by around 250 students from National Medical University

in Odessa, Ukraine, seeking the Indian Mission's intervention to secure permission to cross the checkpoint in Moldova enroute to Romania for boarding an Air India evacuation

"The students have arranged buses to reach the Moldovan border and I would appreciate it if you would kindly look into the matter with utmost priority," Sudhakaran has said in his letter. In the evening, Foreign Secretary Harsh Vardhan Shringla held a press meet where he said that he spoke with the Ukrainian Ambassador on the border issue and he came to know that the Ukrainian Immigration authorities have been informed about the problem and they are working on it.

States that don't appoint MGNREGA ombudsperson won't get funds

From the next fiscal, the Centre will not give funds for employment guarantee scheme MGNREGS to states that do not appoint ombudspersons in 80 per cent of their districts where the scheme has been applied, a top government official said on

As per details available with the Union Rural Development Ministry, states such as BJP-ruled Gujarat, Arunachal Pradesh and Goa, and TRS-ruled Telangana, and union territories such as Puducherry, Andaman and Nicobar Islands, Lakshadweep, and Dadra and Nagar Haveli do not a single ombudsperson for the Mahatma Gandhi National Rural Employment Guarantee Scheme (MDNREGS).

Similarly, there are states

ombudspersons in very few districts such as Congressruled Rajasthan, where only four out of the 33 districts under the scheme have ombudspersons. In TMC-ruled West Bengal, ombudspersons have been appointed in four out of 23 districts under the

The situation is similar in Haryana and Punjab. Both have 22 districts each under the scheme, but only four such districts in Haryana and seven in Punjab have ombudspersons, as per data available with the ministry. "Ideally, states should appoint ombudspersons in all their districts under the MGNREGS. The states which don't appoint ombudspersons in at least 80 per cent of the total districts under MGENREGS, which is the minimum threshold limit, would not get funds from the next financial year for the implementation of the employment guarantee scheme, Secretary, Rural Development, Nagendra Nath Sinha told PTI. Launching

Ombudsperson app for MGN-

REGS on Thursday, Union Rural Development Minister Giriraj Singh had expressed concerns over non-appointment of ombudspersons in various districts, and said it has been noticed that persons belonging to political parties were appointed at many places. "The ministry would not

release funds to those states which don't appoint ombudspersons as per the provision of the MGNREGA, Singh told PTI.

The minister also requested all states and union territories to cooperate with the central government in making MGNREGA more transparent by using the Ombudsperson

According to the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), states are mandated to appoint an ombudsperson for each district for receiving grievances, enquiring and passing awards as per guidelines of the Union Rural Development Ministry, which is the nodal ministry for implementation of the employguarantee programme.

MGNREGA is aimed at enhancing livelihood security of households in rural areas of the country by providing at least 100 days of guaranteed wage employment in a financial year to every household whose adult members volunteer to do unskilled manual

Amid the worrying development, the office of Ukraine's President said a delegation would meet with Russian officials as Moscow's troops drew closer to Kyiv. Putin, in giving the nuclear alert directive, cited not only the alleged statements by NATO members but the hardhitting financial sanctions imposed by the West against Russia, including the Russian leader himself.

Speaking at a meeting with his top officials, Putin told his Defense Minister and the Chief of the Military's General Staff to put the nuclear deterrent forces in a "special regime of ABC's "This Week" that Russia

only taking unfriendly actions against our country in the economic sphere, but top officials from leading NATO members made aggressive statements regarding our country," Putin said in televised comments.

White House Press Secretary Jen Psaki said Putin was resorting to a pattern he used in the weeks before launching the invasion of Ukraine, "which is to manufacture threats that don't exist in order to justify further aggression. The global community and American people should look at it through that prism. We've seen him do this time and time again." She told has not been under threat from

Putin threatened in the days before Russia's invasion to retaliate harshly against any nations that intervened directly in the conflict in Ukraine, and he specifically raised the specter of his country's status as a nuclear power. The US Ambassador to the United Nations responded to the news from Moscow while appearing

on a Sunday news programme. "President Putin is continuing to escalate this war in a manner that is totally unacceptable," Ambassador Linda Thomas-Greenfield said. "And we have to continue to condemn his actions in the most strong, strongest possible way."

announced six more special flights to be sent between February 28 and March 2 to bring back stranded Indian nationals from Ukraine. The fourth evacuation flight carrying 198 Indian nationals from Bucharest landed in Delhi in the evening. Following the closure of Ukrainian airspace, India is facilitating the evacuation of stranded Indians from Ukraine through its land border crossings with Romania, Hungary, Poland, and Slovakia.

"I've shared the locations where Indian citizens are concentrated. Both ambassadors took note of our concerns and assured us of the safety of Indian citizens," Shringla said. The Foreign Secretary said border crossing to Hungary and Romania is functioning. However, he said, the exit point to Poland is clogged due to lakhs of foreign nationals trying to escape from that

point.

Those who are near the borders of Hungary and Romania are guided towards their border points in phases, he added. "We estimated that about 15,000 citizens were left in Ukraine," the Foreign Secretary said.

'Low check dams improving drain water quality'

Delhi Govt executing plans to treat largest polluters of Yamuna

STAFF REPORTER ■ NEW DELHI

The Delhi Government's ini-**⊥** tiatives to construct weirs (low check dams) on major drains have substantially helped to clean the drains by improving their biochemical oxygen demand (BOD) level and decreasing the amount of other pollutants as well. The project was launched by Water Minister Satyendar Jain to improve the quality of the water in the drains falling into the Yamuna.

In line with the ongoing activities for cleaning Yamuna, the Irrigation and Flood Control Department of the Delhi Government is executing their plans to treat the largest



polluters of the Yamuna, i.e. Najafgarh and supplementary drain on the river stretch with focus on solving the problem of pollution from drains directly into the Yamuna

Minister of the Irrigation Flood Control Department, Jain said, "Cleaning the contributing drains of Yamuna will directly lead us towards cleaning the river. Construction of temporary weirs is proving to be an

impactful approach to reduce the amount of pollutants contaminating the contributing drains of Yamuna"Following the same, the Delhi government has successfully initiated the work to improve the water quality of the Najafgarh Drain

and Supplementary Drain. The initiative tends to polish the Najafgarh drain that enters Delhi at Dhansa, runs about 57 km before falling into the Yamuna, and the sup-

off from near Kakrola Regulator and outfalls into the Najafgarh Drain.A weir is a small barrier built across a stream or river that helps to raise the water level slightly on the upstream side. Weirs allow water to pool

behind them while allowing water to flow steadily over top of the weir. Weirs are erected in the mid-flow of the drain to increase the retention of flowing water. Currently, DJB treats the wastewater of the drains falling into both the Najafgarh as well as the Supplementary drain, only by trapping it through its Interceptor Sewer Project (ISP).

Apart from this, measures that are being carried out by the Irrigation and Flood Control department include, desilting of the drains, installation of trash barriers, floating boom to trap floating solid materials, removal of municipal solid

and demolition (C&D) waste from the drains, removal of hyacinth, garbage, patera, and other weeds, Raising and repairing of boundary walls to prevent dumping in drain land, erection of wire mesh jalies at bridges, installation of warning boards and fixing of jalies at the mouth of inlets.

Under this project, construction of 11 weirs has been completed on Supplementary Drain and 3 weirs have been completed on the Najafgarh Drain, while work on 10 weirs is in progress. The recently constructed weirs have already started to show positive results, and thus the project is bound to turn out tremendously successful in the long run.

After implementing the measures, the Irrigation and Flood Control Department submitted a test report about the impact of these initiatives. The test report of the drain

STP, Rohini Sector 11 Weir, Rohini Sector 16 Weir, and Rohini Sector 15 Weir shows that there is a drastic reduction in suspended solids after the construction of the temporary weirs and the total suspended solids went down from 166 mg/L in Rithala to just 49 mg/L in Rohini Sector 15.

Subsequently, the government to boost this process administratively, the Yamuna Cleaning Cell (YCC) was constituted in November last year, under the direction of Chief Minister Arvind Kejriwal, to ensure better coordination and an integrated approach to achieve the objective of Yamuna Cleaning.

The cell is responsible for the execution of the Yamuna Cleaning Action Plan. The decision taken by the Cell is executed by the members of the respective departments to ensure time-bound action.

Poor people have been denied Feb ration: BJP

Delhi BJP Spokesperson has said that lakh of poor labour class people are every month forced to buy expensive

"Though all poor are unhappy but those registered under One Nation One Ration Card scheme as the ration in their parent state has been distributed and here they aren't getting it. The fear their ration card might be cancelled for not taking ration regularly," he added.

Sonu Dariyapur gang member arrested

3 held for supplying arms, ammo, stolen motorcycles to gang members

Complete absence of motive weighs in favour of accused: SC

The "complete absence" of I motive assumes a different complexion and definitely weighs in favour of the accused the Supreme Court has said while acquitting a man sentenced to life imprisonment in a murder case of 1997.

A three-judge bench headed by Justice U U Lalit observed it is not that the case of prosecution must be discarded in the absence of

The bench, also comprising Justices S R Bhat and P S Narasimha, set aside the judgement delivered in May 2014 by the High Court of Chhattisgarh which had dismissed an appeal filed by the accused against the trial court verdict convicting and awarding him life imprisonment in the case.

"It is not as if motive alone becomes the crucial link in the case to be established by the prosecution and in its absence the case of prosecution must be discarded. But, at the same time, complete absence of motive assumes a different complexion and such absence



the accused," the bench said in its February 25 verdict.

Air India flights to bring back Indians from Ukraine costing Govt ₹7-8L/hour

ir India flights being oper-Air India flights being operated to bring back hundreds of Indian nationals stranded in Ukraine are costing ₹7-8 lakh per hour. The amount will go up depending on the duration of the flights.

Sources said that the cost of operating a chartered flight with the Dreamliner is around ₹7 to 8 lakh per hour and the total amount will depend "on where we are going and how far we are going". The total cost will include expenses related to crew, fuel, navigation, landing and parking charges.

The airline is operating the services with wide-body Boeing 787 plane, better known as Dreamliner, from neighbouring countries of conflictridden Ukraine, including Romania and Hungary. Currently, Air India is operating flights to Bucharest (Romania) and Budapest (Hungary) and both are offline stations for the airline, which means it does not have scheduled services to these places.

According to sources, as the cost will be between ₹7 to 8 lakh per hour, the total cost for a round trip will be more than ₹1.10 crore. The figure is calculated under the assumption that overall duration of the to and fro flight is around 14 hours. The expenses will shoot up in case the duration is

According to flight tracking website FlightAware, the flight from Bucharest to Mumbai that landed on Saturday night was for a duration of nearly six hours. The flight from Budapest to Delhi was for about six hours and another flight from Delhi to hours. An Air India flight from Bucharest to Delhi took over 5

The government is not charging people for the evacuation flights. Some state governments have also announced that they will bear the expenses of people from their respective states who are returning from Ukraine. The Dreamliner has more than 250 seats.

According to pilots who fly Dreamliners, the aircraft on an average consumes 5 tonnes of fuel per hour. The source said that once the operations are complete, the exact cost will be worked out and then the airline will send the bill to the government for reimbursement.

The trio has been charged under various Sections of the Indian Penal Code, Arms Act, Explosive Substance Act, Criminal Law Amendment (CLA) Act and Unlawful Activities (Prevention) Act.

The tweet from the hackers read, "Stand with the people of Ukraine. Now accepting cryptocurrency donations. Bitcoins and Ethereum." The tweet had a message in Hindi and addresses to Bitcoin and Ethereum wallets. The tweet was posted at 9:52 AM. Within 10 minutes, another tweet was posted suggesting the account was hacked, and people should support Russia. Soon after the second tweet, both tweets were deleted within a few minutes and his access was

Effectiveness of Covid vaccine may decline after 6 months: Study

 $E_{\text{of vaccines in enhancing}}^{\text{mphasising the importance}}$ immunity, a study has said that the effectiveness of the Covid-19 vaccine may substantially decline after six months if booster shots are not taken. For the study, a research team had examined data from nearly 50,000 hospital admissions between April and November

Published in The Lancet Respiratory Medicine, the researchers in the study indicated that vaccines were 94 per cent effective at preventing hospitalisation 50-100 days after receiving the shot but fell to 80.4 per cent 200-250 days later, with even more rapid declines after 250 days.

'This data helps us understand differences in waning protection by vaccine type and identify the key risk factors for

severe breakthrough infections to help inform the targeting of potential vaccine booster programmes, said Amy Compton-Phillips, Providence chief clinical officer.

studies, our data stretched beyond six months, where we found evidence of rapidly waning protection, especially for patients 80 or older," Compton-Phillips

"Unlike most other

In addition to examining the effectiveness of vaccines over time, the Providence study was also able to identify factors associated with reduced vaccine effectiveness.

Key risk factors for a severe breakthrough" infection included advanced age (80+), comorbidities such as cancer, transplants, chronic kidney disease, hypertension, or heart

failure, the amount of time that had elapsed since being vaccinated, and the type of vaccine one received.

For the latter factor, the study found that the Moderna vaccine offered the best overall protection over time, while the Pfizer-BioNTech vaccine offered initial protection equivalent to Moderna's but declined more rapidly over time.

Persons receiving the Janssen vaccine also had higher odds of experiencing a severe breakthrough infection com-pared to Moderna.

Wildfires to get 50% more frequent by end of 2100: UN report

 B^{y}_{2100} , extreme wildfires are likely to become more frequent and intense — as high as 50 per cent — due to climate change and land-use change globally including India, according to a new UN

However, the global warming and urbanisation impact will start to be visible within the next seven years itself when wildfires will increase to 14 per cent by 2030 and 30 per cent by the end of 2050 itself, the report paints a scary scenario for the future. People's and animal's health is directly affected by inhaling wildfire smoke, causing respiratory and cardiovascular impacts and increased health effects for the most vulnerable.

The report by the UN Environment Programme (UNEP) and GRID-Arendal calls for a radical change in government spending on wildfires, shifting their investresponse to prevention and

Titled "Spreading like Wildfire: The Rising Threat of Extraordinary Landscape Fires," the extensive report finds an elevated risk even for the Arctic and other regions previously unaffected by wildfires. The report is released before representatives of 193 nations convene in Nairobi for the resumed 5th session of the UN Environment Assembly (UNEA-5.2), between 28 February and 2 March, 2022.

According to Andrew llivan, Scientist, Sullivan, Commonwealth Scientific and Industrial Research Organisation, Australia, who is one of the report's authors, uncontrollable and devastating wildfires are becoming an expected part of the seasonal calendars in many parts of the

world. He said, 'We have seen a great increase in recent fires in northern Syria, northern Siberia, the eastern side of

the situation is dire and eliminating wildfire risks is impossible, communities can still reduce their risk and exposure. Where wildfires have historically occurred, they may increase; however, where wildfires have not historically occurred, they may become

more common. He added that extreme wildfires can be devastating to people, biodiversity and ecosystems. They also exacerbate climate change, contributing significant green-house gasses to the atmosphere, he said.

The authors have called upon the governments to adopt a new 'Fire Ready Formula,' with two-thirds of spending devoted to planning, prevention, preparedness, and recovery, with one third left for response. Currently, direct responses to wildfires typically receive over half of related expenditures, while planning and prevention receive less than one per cent.

We have to minimize the risk of extreme wildfires by being better prepared: invest more in fire risk reduction, work with local communities, and strengthen global commitment to fight climate

SII seeks permission from DCGI to conduct phase 3 study of Covovax

Pune-based Serum Institute of India (SII) has sought permission from the Drug Controller General of India (DCGI) to conduct a phase-3 study of its Covid-19 vaccine Covovax as a booster dose in

On December 8 last year, the DCGI had approved the vaccine for restricted use in emergency situations in adults. It is yet to be included in the country's inoculation programme which at present majorly has two vaccines namely Covaxine (by Bharat Biotech from Hyderabad) and Covishield by the SII.

Prakash Kumar Singh, Director, Government and Regulatory Affairs at SII had last week submitted an application to DCGI seeking nod for phase-3, observer-blind, ran-

domised, controlled study to evaluate the safety and immunogenicity of Covovax as booster dose on those who have received primary vaccination either with Covishield or Covaxin at least three months ago, an official source said. Singh has stated that many countries are already administering booster doses to their citizens considering the uncertainties of the COVID-19 pandemic.

"We are sure that your approval for conducting this clinical trial will ensure an early availability of Covovax for booster dose use for people of our country as well as the world in line with our prime minister's vision of 'Making in India for the World'," Singh is learnt to have stated in the application.

Working to facilitate more border transit points: Indian Embassy in Ukraine

The Indian embassy in is continuously exploring to facilitate opening up more border transit points with neighbouring countries for the evacuation of Indian citizens from

Ukraine. In an advisory, the embassy said it is closely monitoring the developing situation, especially in the eastern regions of Ukraine, and that it is in constant touch with the authorities for the safety of Indian citizens.

"As and when curfew is lifted and there is considerable movement of people in your respective neighbourhoods, Indian nationals are advised to use nearby railway stations for movement out of regions of active conflict and proceed towards the western regions,"

the embassy said.

"The transportation mode of railways is operational and safer. If tickets are available on regular trains, they may be booked. In addition, Ukrainian Railways is also operating special trains for evacuation of people free of charge on first come first serve basis at the railway station and for which tickets are not required," it added.

The embassy said Indian citizens are being evacuated from Ukraine through Romania and Hungary.

'We are continuously exploring and working to open up more borders with neighbouring countries for our cit-

izens," it added. It said preference at the railway stations is being given to children, women and elder-



The embassy urged people

to stay calm and safe. "Please stay calm and safe. Carry only essentials in a rucksack/bag. Wear heavy winter clothing for warmth at night and if possible, a blanket and essential medicines. Carry cash as much as possible," it said.

"Those who judge that the situation is not conducive for travel, or are unable to leave due to any reason, may wait until further developments, may also plan accordingly by remaining in groups, keeping enough essentials, following existing instructions on safety and security," the embassy

India on Friday managed to set up camp offices in Lviv and Chernivtsi towns in western Ukraine to facilitate the transit of Indians to Hungary, Romania and Poland.

It also positioned teams of officials at the Zahony border post in Hungary, Krakowiec as well as the Shehyni-Medyka land border points in Poland, Vysne Nemecke in the Slovak Republic and the Suceava transit point in Romania to coordinate the exit of Indian nation-

als from Ukraine. At present, Indian citizens are being evacuated from Ukraine through its border with Romania and Hungary.

History continued to repeat even as blatant booth-capturing, attacks on Opposition candidates and media persons marked the ruling Trinamool Congress' "khela" (game) in Sunday's elections to 108 municipal boards of Bengal.

In protest, principal Opposition BJP immediately called a dawn-to-dusk bandh on Monday terming the votes "nothing but a farce."


India's abstention at the UNSC resolution against Russia sends out conflicting signals

hy did India abstain from a US-sponsored resolution of the UN Security Council that deplored Russia's aggression against Ukraine? China, a permanent mem-V ber of the Security Council, and the UAE, also abstained, but the internal debate in India remains largely focused on the country's stand. India's stand is consistent and balanced, the Government argues. The logic is India's abstention allows it to continue talking to both sides; that is, aggressor Russia and victim Ukraine. In keeping with the balanced stand, Prime Minister Narendra Modi spoke with Russian President Vladimir Putin as well as Ukrainian President Volodymyr Zelenskiy. He called Putin for "an immediate cessation of violence" and "return to the path of diplomatic negotiations and dialogue". He told Zelenskiy who called him for "an immediate cessation of violence" and "a return to dialogue". Curiously, the Government's message to both sides is similarly worded. For, it is for Russia to stop the aggression and not Ukraine, the aggrieved party. Congress, India's main Opposition party in Parliament, preferred not to react. It claims to refrain from voicing a contrary stand on international crises for the sake of India putting up a united face. That did not stop some of its leaders like Shashi Tharoor and Manish

Tewari to argue the Government should have unequivocally supported Ukraine. Tewari suggested that while Russia backed India during crisis times, "when a friend commits a mistake, it needs to be corrected".

BJP's vice-president formally defended the abstention because India believes in dialogue and diplomacy. He even distinguished between the abstentions of India and China saying, to quote a news agency, "We are not like China, which abstained with a message which seems like advocating for war." However, neither the United States nor Russia objected to India's abstention. Moscow lauded India's "balanced" stand. The US said,

"We understand, it is okay." What it left unsaid was unambiguously articulated by two Democrat Congressmen. Indian-American Congressman from California Ro Khanna outlined the American perspective tweeting, "It is the US, not Russia, that will stand with India against China's current expansionist plans." His colleague, Congressman Eric Swalwell said, "Khanna and I represent the largest Indian-American districts and this vote is contrary to what we hear from our constituents." So, where do we stand on this abstention? A lot is already being written about it but two things must be kept in mind. First, a nation's policies will always be at variance with its citizens' sentiments because of the big-picture-small-picture binary. Secondly, most probably, coming-of-age India is only now directly involved in a big-ticket Security Council vote on a global security matter. It missed out on the experience during Kargil and Iraq wars because it was not part of the Security Council (as non-permanent member) then. It is, now, till 2023. Still, it may want to ponder why the world appears more concerned about the implications of China's abstention even as it takes India's abstention as nothing out of the ordinary.

mid the din of UP elections, the Manipur poll has not been getting the attention it deserves. As per the rescheduled election, voting for 38 seats in Manipur's Ifirst phase would take place today; the remaining 22 would vote on March 5. Most of the media and parties chose to ignore this Northeast State, which happens to be among the most volatile in the region. The new dispensation could decide the future of Manipur itself. Whether it would be at peace or boil would largely depend on how the various ethnic groups are accommodated in the new Vidhan Sabha. If



one were to go by opinion surveys and expert opinions, the ruling BJP has an edge and Congress is likely to be a close second. Both had an almost similar vote share in 2017. The Congress has forged a six-party alliance, called Manipur Progressive Secular Alliance (MPSA). The reason for BJP's edge is that it got into election mode earlier and that could help it retain power. In the last election, it allied with the Naga People's Party and Naga People's Front but this time it has decided to go it alone.

Regional parties like the NPF and NPP are expected to do well in their pockets but these do not have

a State-wide appeal. In smaller States having around 50 seats, the regional parties or independents always play a big role in Government formation. The key concerns of Manipur's people are price rise, unemployment, the lack of education and health services but, like elsewhere, the parties have chosen to concentrate on negative campaigns. Security is a major issue in this border State with a long history of insurgency. The Kuki National Organisation (KNO), an umbrella organisation of 17 Kuki militant groups, under suspension of operation agreement with the Centre influencing the hills of Manipur supported the BJP. It was largely due to Amit Shah's efforts, who promised to address their core concerns while keeping their aspirations in mind. The NPP had accused the BJP of using extremist groups in the Kuki-Zomi areas to prevent its candidate from filing nominations or campaigning. The Congress has been vocal against BJP's "misrule" and criticised its silence on the controversial AFSPA which is very unpopular in the State. It would be quite a task for any party that comes to power to balance local aspirations with national interests.



nitially, the Pakistan Army's motto used to be 'Ittehad, Yaqeen aur Tanzeem' (Unity, Faith and Discipline) – insisting on functional attributes that reside in any militaristic framework. The forced takeover by General Zia-ul-Haq in 1977 (ironically called 'Operation Fair Play') changed the storyline for posterity. Zia soon initiated systemic sharia-isation of the national narrative, and the Pakistan military was not spared either. Reflecting the deliberate conflation of religion, military and Pakistani identity, the motto of the Pakistani Army was changed to a decidedly religious 'Imaan, Taqwa, Jihad fi Sabilillah' (Faith, Piety, Holy War in the path of Allah). This was not harmless semantics but the calculated posturing of the 'faithful' in a professional Army to fight the 'holy war in the path of Allah'. Jinnah's confused secularism (with underlying two-nation theory) was effectively buried. But just how much personal commitment towards the posited religious tenets would be demonstrated by Pakistani Generals was another matter, beyond the simpler task of changing mottos. Given Pakistan's foundational weakness in 'two-nation theory' that belies the simmering reality of implosive ethnic/sectarian strife (eg, Bangladesh in 1971), the Pakistani military has arrogated a larger-than-constitutionally-mandated role that trumps true democracy.

Pakistani Army has done a far better job of defining and misus-

ing the national narrative to its advantage than it has ever at winning any war. Slogans like Countries have an Army, but Pakistan's Army has a country, or calling Pakistani Generals as 'Crore Commanders' instead of Corp Commanders, have been doing the rounds for decades. Those fortuitous to head the Pakistan Army (under the mistaken assumption of pliancy by politicians) were usually not the most professionally regarded as Mai Gen Sher Ali Khan, who was denied the top post by Gen Ayub Knan, nad later slammed the Gen-turned-President's professional ability to be "limited to barrack and battalion". Ayub's bigot-

Like Zia, Akhtar had endeared himself to Bhutto, especially when he was the GOC of 12 Division at Murree, but shifted loyalties later. Even though Akhtar had not participated in Zia's coup and was known to be opposed to the coup — yet, when contacted by Lt Gen Faiz Ali Chishti to enrol Akhtar's complicity in a possible countercoup against Zia, Akhtar ingratiated himself to Zia's camp by informing him about the plan. Later, Zia rewarded Akhtar with the most coveted post of DG of Pakistani spy agency, Interservices intelligence. Soon Akhtar was to supposedly walk the talk of the newly minted motto, 'Imaan, Taqwa,

Jihad fi Sabilillah', with his shaping of Islamic extremism via Afghan mujahideen, where he was once heard extolling in a presentation, "Kabul must burn! Kabul must burn!" The unholy Operation Cyclone, with ISI-CIA jointsmanship and further funding from Sheikdoms, was Akhtar's doing. Then these dishonourable Generals also institutionalised double-speak and double-dealing that afflicts Pakistan to date.

Over 33 years after the curious case of 'exploding mangoes' that killed both Zia and Akhtar in a mysterious air crash, news of misappropriation of funds for 'Holy War' and stashing of the same in private Swiss accounts of Gen Akhtar's sons surfaced. The reality of 'Holy War in the path of Allah', as practised by the amoral and compromised Pakistani military leadership, has tumbled out again. But with Rawalpindi GHQ still controlling all levers, the financially crippled Pakistan Government recently signed a surreal 15 per cent pay increase for its military. The fate of Pakistan, its Generals and outcome of wars is selfexplanatory.

CHAGOS: RECALLING A 50-YR-OLD CRIME

Pentagon wanted Chagos to be a US bomber base in the Indian Ocean



he object of the exercise is to get some rocks which will remain ours...There will be no indigenous population except seagulls,' wrote Sir Paul Gore-Booth, a senior official at the British Foreign Office, as the plan to expel the 2,000 Chagos Islanders from their homes was taking shape in 1966. "We must surely be very tough about this." Six years later the Chagossians ('llois,' as they call themselves) were scooped up, loaded on ships, and dumped on the waterfront of Port Louis in Mauritius, where most of them have lived in abject poverty ever since. But this month a number of them went back to the islands on a Mauritian ship. The crime that Gore-Booth was shamelessly discussing in 1966 was committed on behalf of the United States. The Chagos Islands, an archipelago of 62 coral atolls in the middle of the Indian Ocean, would make an ideal bomber



base from which to dominate most of south Asia and eastern Africa, and the Pentagon wanted it. Britain, in its usual kiss-up, kick-down mode, was happy to oblige, but there was a problem. The Chagos Islands had been governed as part of the British colony of Mauritius, which was due to get its independence in 1968. The United States wasn't keen on having a major strategic base in an independent African country, so something had to be done. The solution, obviously, was to separate the Chagos Islands from Mauritius and declare them the British Indian Ocean Territory (BIOT). Easily done: offer the Mauritians £3 million for the islands, and tell them they can't have independence unless they accept the deal. However, this was happening at the height of decolonisation, when colonial territories all over the 'Third World' were claiming the right of self-determination. What if the llois do the same? Well, then, we'd better remove all the inhabitants. So that's what Britain did in 1972, falsely claiming that there was no resident population, only contract workers. The llois have not been allowed to return for fifty years, and all the people who were actually born there are getting old, but their children and grandchildren have not forgotten. They actually managed to get a decision in the British courts in 2000 ruling that the expulsion had been unlawful and ordering the British government to let the islanders go home. It might even have been obeyed - except that 2001 brought the 9/11 attacks, and the US base on the Chagos island of Diego Garcia became a key hub in the 'war on terror' American B-52s flying from the Chagos Islands have bombed Afghanistan and Iraq at intervals for twenty years, and Diego Garcia, with no civilian population, became a transit point for prisoners being flown untraceably between American 'black sites' around the planet. The islands were on long lease from the UK, and the US didn't want them given back. Britain still insists it is the sovereign power on the islands (although it is the US that runs them), but since the International Court of Justice ruled in 2019 that the whole expulsion had been illegal it has been on the defensive. The UN General Assembly, and more recently the International Tribunal for the Law of the Sea, have backed that ruling. So the llois will be going home one day soon - and meanwhile, here's a fun fact. The Chagos archipelago is at the bottom of a giant bowl-shaped depression in the ocean almost 100 metres deep. If the sea was actually level - if not for the huge gravitational anomaly that holds that bowl open the Chagos Islands would all be in very deep water.

Naval upgrade: Russia is a tricky trader

Russia aspires to create dependency to use as an instrument of exerting its influence on future Indian foreign and security policies

iven the joint Sino-Pak threat, especially from the sea, the Indian government has the strategic foresight to expand the military capabilities horizontally, i.e., diversification and increasing the lethality of the military assets apart from focussing on significant indigenous inductions such as IAC-1 and INS Vagir. The overall aim is to decrease dependency on defence supplies.

Project -75 was initiated to develop the Air Independent Propulsion (AIP) technology for the Indian submarines. The technology allows the submarines to stay longer underwater and hence are not easily detected by the enemy's surface assets. The AIP system that the Naval Materials Research Laboratory (NMRL) of DRDO has developed under Project-75 would be retrofitted from 2024-25 onwards into six Scorpene submarines. On the other hand, a ten-year lease signed with Russia in 2019 for a new submarine will be delivered in 2025. Hence, the period from 2022-2025 is crucial from a naval security point of view.

Given the security challenges from the adversaries apart from China's naval deployments in Djibouti and acquisitions of naval bases in South Asia, Project 75-I was initiated with an urgency to build six new conventional submarines for the Indian navy. The objective was to enhance naval capabilities. The Project worth Rs 45,000 crore was opened for original equipment manufacturers, and it was France, Germany, Russia, South Korea and Spain that were expected to bid. A mandatory condition of AIP technology in the submarines makes the Project highly tac-

After Germany and South Korea's refusal, Russia has recently refused to bid for the Project. Moscow instead has offered to upgrade the previously purchased Kilo-class submarines. The Russian decision has again brought the growing divergences between the "special and privileged partnership". An important reason for this has been that the component of arms sales in Russia is a "strategic sector" of its economy. By offering India an upgradation, it aims to market its submarines. The financial lucrativeness of selling spare parts and services to the existing and the new weaponry platforms should not be missed either. Thus, Russia aspires to ensure that a path dependency of exerting its influence on the future Indian foreign and security policy. This factor becomes essential in the light of the fact that from 2016-20, the Russian arms imports saw a 53 per cent drop.

On the other hand, Moscow is developing state-of-art non-nuclear submarines with China. It has steadily shifted from a transactional relationship of a buyer-seller into a partnership that encompasses joint research, development and production of significant naval assets. Given the current geopolitical scenario, the development

inimical to India's security.

Russia has supplied China with the upgraded Kilo-Class dieselelectric attack submarine. Beijing has successfully convinced Russia to incorporate some of the features

of Kilo-class submarines into its own domestically produced Yuan class submarines, which is its first AIP powered submarine. Nevertheless, given the Chinese expertise of reverse engineering and indigenisation to supply military technologies to its recipient countries such as Pakistan, an upgraded version of Kilo-class submarines that Russia has offered to India will most likely not suit

India's naval requirements. It is so because China has shared the technology with Pakistan and rechristened the Yuan as Type-039B 'Hangor Class' submarines for its client state. The deal sees the construction split between China Shipbuilding Industry Corporation (CSIC) and Karachi Shipyard andEngineering Works (KŠĖW). Further, the submarines constructed by China would be delivered to Pakistan between 2022-2028. With these facts, the upgradation offer of Moscow, if accepted by the Indian government, would tactically mean that all three countries - China, Pakistan, and India- would have vised versions. The consequences of such a scenario can only be visualised by the Defence Ministry and the military experts.

From an Indo-centric perspective, if India successfully gets new submarines with the state-of-art technology, it can bridge the security gap for the next four to five years, thereby ensuring security by the time DRDO's AIP is retrofitted. Further, this period can also be used for experimentation of different technologies that probably can in the shadow of China aim to offmake the Indian submarines more lethal than that of the arch-rivals of China and Pakistan.

The Russian refusal to bid for Project 75-I was expected and should not be considered a 'sudden development'. From a geopolitical perspective, Russia's refusal is significant in the light of an increasing shift from a Sino-Russo strategic 'partnership' to an 'alliance' and an emerging Russo-Pak bonhomie. The three parallel developments transform the security architecture of South Asia into a new era. Russia has joined China in looking at AUKUS from a Chinese prism. Their joint statement spoke of a "nolimits" friendship and denied any "forbidden" areas of cooperation. The statement without naming Quad criticised the grouping and called it "detriment of the security

Additionally, it named AUKUS and the nuclear submarine cooperation as "contrary to the objectives of security and sustainable development of the Asia-Pacific region". At present, the region has been gradually witnessing the culmination of an 'anti-Quad' block that comprises Russia, China, and Pakistan, which perhaps would be joined in by Iran. The process marks the beginning of power shifts in Asia for

Sino-Russian convergence on an anti-American stand has been well-spoken. However, within the aforesaid platform, rapid convergences between Russia and Pakistan should be a cause of worry for the defence experts. It probably all began with the Russian sales of Mi-35M Hind-E assault helicopters (2015 and 2017) that soon culminated into a 'Security Training Agreement' (2018). The recent advances of Pakistan towards Russia

set the 'special' relationship between New Delhi and Moscow.

India has been accorded Strategic Trade Authorization (STA) Tier- 1 status owing to the West's strategy of Indo-Pacific, thus, making it eligible to get the muchrequired technology, or perhaps even a better one. Russia should understand that the greater the depth of its strategic relations with China and Pakistan, the more the chances of losing India. It could be further 'pushed' into the U.S. alliance system in the emerging scenario. The carefully crafted balance that New Delhi maintained until now can perhaps be lost. As the need of the hour is to have state of the art technology for the naval assets, a probable French, British or American willingness to share the technology should be taken by Russia in the right spirit.
For Russia, the flip side of this

emerging bonhomie is that Pakistan is a minimal market for defence supplies and is financially unstable because of its foreign policy tool of spreading terror in the region. In such a case, Russia should not fall into the trap of China to share the financial burden of keeping a terrorist country like Pakistan functional. Instead, the Russian leadership should well concerns. Moscow's vision of South Asian geopolitics should not be primarily confined to an anti-American stand, and other issues such as Islamic fundamentalism, demographic changes, refugee problems, etc., should be genuinely considered. It should understand Pakistan's manipulative and 'victim' policy. An issue and a theatre-based approach, if adopted by Moscow, could perhaps save the Indo-

Russian ties from diverging further.

Banking and insurance are different businesses

IRDA guidelines silent on invocation of guarantee or how the amount will be settled by the insurance company

nsurance Regulatory and Development Authority of ▲ India has issued IRDAI (Surety Insurance Contracts) Guidelines, 2022 on 3rd January 2022. The guidelines shall come into force with effect from April 1, 2022. These guidelines are applicable for all general insurance companies under registered Insurance Act 1938. The guidelines define different types of guarantees namely Advance Payment bond, Bid bond, Contract bond, Customs and court bond, Performance bond and Retention Money. The guidelines containvarious conditions to be eligible for the surety business like maintenance of solvency margin, premium charged, board approved underwriting philosophy, risk assessment mechanism and

compliance with specific conditions.

Finance Minister Nirmala Sitharaman has said the use of surety bonds issued by insurers as a substitute for bank guarantee will be made acceptable in Government procure-

It is not known what has made the policy makers to allow issue of guarantees by insurance companies. As it is, there are enough number of banks and bank branches to handle this business. The policy makers do not seem have appreciated the nuances of bank guarantees.

Banks provide guarantees to their clients as part of working capital facility. Though at the time of issue of guarantee, there is no outflow of funds, in the eventuality of invocation of



guarantee, there will be outflow of funds from the bank. Hence what initially is treated as a non-fund-based facility may become a fund-based facility. Invoked guarantee or defaulted guarantee is similar to a loan book and ultimately this has to be recovered from the customer.

Banks do collect a margin amount, commission and also

tangible security for issuing loss account? guarantees. They do obtain a 'counter guarantee' from the customer to make good the amount of guarantee in case of invocation. In most of the cases, as the customer is enjoying different other facilities, the collateral security provided will be extended for the guarantees also. Hence in the eventuality of invocation of guarantee, the banks will be able to lay their hands on the securities with them. In no way, this can be done by any insurance company.

The guideline issued by IRDA is silent on invocation of guarantee or how the amount will be settled by the insurance company and how will they recover this amount. Or will they pay for the invoked guarantee out of their profit and

For all practical purposes, guarantees portfolio should be treated only as a financial intermediation, as anytime the guarantee may be invoked and it squarely falls on the domain of banks. İt is not a risk management mechanism and hence not in insurance domain. Why insurance companies must be allowed to enter this field?

Banks guarantees are well accepted by all as there are various guidelines by RBI as to the issue and payment in clear terms. The RBI is categorical that wherever the guarantees are invoked, payment should be made to the beneficiaries without delay and demur. It prescribes that an appropriate procedure for ensuring such immediate honouring of guarantees should be laid down so

that there is no delay on the pretext that legal advice or approval of higher authorities

is being obtained. Over the years the banks have understood that delays on the part of banks in honouring the guarantees when invoked tend to erode the value of the bank guarantees, the sanctity of the scheme of guarantees and image of banks. It also provides an opportunity to the parties to take recourse to courts and obtain injunction orders.

Only where there is an element of fraud in issuing or invoking the guarantees, the payment on the guarantee is withheld. Such occasions are very rare. Time and again courts have made it clear that payment on guarantees cannot

be stopped by banks. There are occasions that

bogus bank guarantees are used by clients. As no payment is involved while issuing a guarantee, it is possible that some guarantees purported to be from banks can be prepared and the beneficiary company can be defrauded. In such cases, only if the guarantees are invoked, the fraud will come to light. To avoid such a situation, banks provide a system to verify and get confirmation of guarantees issued from higher authorities of the bank. IRDA has not made any such provision in their guidelines. Finally when banks are

not allowed to enterthe business of insurance (they only act as distributor for insurance companies), why insurance companies must enter the territory of banks? That too where there is tremendous risk.

Belarus holds constitutional vote amid Ukraine crisis

 $B^{\text{elarusians cast ballots}}_{\text{Sunday in a constitutional}}$ referendum that the country's authoritarian leader called to cement his 27-year-old grip on power, even as he offers the country's territory to his ally Russia to invade Ukraine. Belarusian President Alexander Lukashenko, who has edged even closer to Russia amid crippling Western sanctions over his crackdown on domestic protests, said he was confident that Belarusians will support a set of constitutional amendments that would allow

him to stay in power until 2035. The revised main law also sheds Belarus' neutral status, opening the way for stronger military cooperation with Russia, which deployed forces to Belarusian territory under the pretext of military drills and then sent them rolling into Ukraine as part of the invasion that began Thursday.

Some of those forces quick-

ly closed in on the Ukrainian capital, Kyiv, located just 75 kilometers (less than 50 miles) south of the border. In a video message Sunday, Ukrainian President Volodymyr Zelenskyy rebuked Belarusians for allowing their country to be used as a staging ground for the Russian invasion, adding that Ukrainian cities are facing an attack on a scale unseen since World War II when Belarus and Ukraine faced a Nazi invasion as parts of the Soviet Union. "But you aren't on the

same side with us in the war

that is going on now,"

Zelenskyy said in Russian, which is widely spoken in Belarus. "The Russian military is launching missiles at Ukraine from your territory. From your territory they are kiling our children, they are destroying our homes and trying to blow up everything that has been ilt for decades."

In an emotional speech, the Ukrainian leader questioned how Belarusians will be able "to look into the eyes of your children, into the eyes of each other." "We are your neighbors. Be Belarus, not Russia!" he said.

The Belarusian leader quickly shot back, denigrating the Ukrainian president as an American puppet and charging that the Russian attack resulted from Zelenskyy's failure to accept Russian President Vladimir Putin's demand for Ukraine to renounce its bid to ioin NATO.

The West responded to Belarus hosting Russian troops for the invasion by slamming it with new tough sanctions along with Russia. Lukashenko ominously warned Sunday that more sanctions from the West are "pushing the world to the brink of World War III."

The Belarusian leader, who said previously that his country could host Russian nuclear weapons, said that he warned French President Emmanuel Macron in a call Saturday that he was ready to make the move if the U.S. And its allies deploy nuclear weapons to NATÓ members Poland and Lithuania, which border

"We have developed plans to protect Belarus and agreed with Putin to deploy such weapons here that will make Poles and Lithuanians lose any desire to go to war," he said.

The constitutional amendments bring back limits on presidential terms that had been abolished during Lukashenko's tenure, allowing a president only two five-year terms in office. However, the restriction will only take effect once a "newly elected president" assumes office, which gives Lukashenko an opportunity to run for two more terms after his current one expires in

"This pseudo referendum is being held under the Russian gun barrels and under effective control of the Russian military which has come to stay in Belarus for a long time," Belarus' first post-Soviet leader, Stanislav Sushkevich, told The Associated Press.

'The absurdity that is going on now directly contradicts the existing main law that envisages Belarus' neutral status." Shushkevich warned that "Lukashenko is depriving Belarus of its future and turning the country into a staging ground for Putin's mad games," adding that "the Belarusian leader has no choice, he also is

a pariah." In 2020, Lukashenko relied on Moscow's support to survive the largest and the most sustained wave of mass protests in the country's history.

Demonstrations, the biggest of which drew up to 200,000 people, were triggered by him winning a sixth term in office in a presidential election in August 2020 that the opposition and the West denounced as rigged. Protesters demanda new election and Lukashenko's ouster faced a brutal crackdown from the authorities, with more than 35,000 arrested and thousands brutally beaten. Key opposition figures, including Šviatlana Tsikhanouskaya, Lukashenko's main contender in the election, left the country amid the clampdown, along with thousands of ordinary Belarusians.

The opposition denounced the vote as 'farce" and said it wouldn't recognize its results. "The Belarusians are again being offered a choice between Lukashenko and Lukashenko,

"Belarusians want change, but harsh large-scale repressions forced many to remain silent." She said that Belarusians widely oppose the

Tsikhanouskaya told the AP

Russian invasion of Ukraine. "Belarusians' hearts hurt as it's not just the fate of Ukraine but also our fate that is decided now," Tsilhanouskaya told The Associated Press. "We realize that Belarus' independence is closely connected with Ukraine's independence."

Ukrainians return from abroad to fight Russian invasion

While hundreds of thousands of refugees are leaving Ukraine amid Russia's attack on the country, some Ukrainian men and women are returning home from across Europe to help defend their homeland. At the checkpoint in Medyka, in southeastern Poland, many were standing in a line early Sunday to cross into

"We have to defend our homeland. Who else if not us," said a moustachioed man in front of a group of some 20 Ukrainian truck drivers walking to the checkpoint to enter Ukraine. They came from across Europe to return to Ukraine. They spoke to The Associated Press in Ukrainian and in Russian. comes days after the Russian

Another man in the group said: "The Russians should be afraid. We are not afraid." Members of the group declined to give their names, or only gave their first names, citing their security and that of their families. A man in his 20s, who said his first name was Denis, said he had been working in Poland but was returning to Ukraine where

his "everything" is."I'm on my own here in Poland. Why should I be here? So I go, for the homeland,"

Denis said. Lesa, a woman in her 30s, Lesa, spoke to the AP just before entering the checkpoint building. "I am afraid, but I am a mother and want to be with my children. What can you do? It's scary but I have to."

Another young woman

said she, too, was returning to take care of her children, so that Ukrainian men can defend the country."We have to, we Ukrainians have to take our children away ... To allow our boys to fight," she said.On Ukraine's side of the border, a man was directing those arriving to a place where cars and buses were waiting to take them onward.Ukrainian President Volodymyr Zelenskyy was staying in the capital, Kyiv, boosting the morale of Ukrainian fighters as Russian troops were closing in on the city and huge explosions lit up the sky

early Sunday.

China's new-generation rocket launches 22 satellites into space

hina's new Long March-8 Crocket placed 22 satellites in space on Sunday, setting a domestic record for the most spacecraft launched by a single

The rocket blasted off at 11:06 a.M. (Beijing Time) at the Wenchang Spacecraft Launch Site in the southern Hainan Province before sending the satellites into pre-set orbits, state-run Xinhua news agency reported.

These satellites will be mainly used for commercial remote sensing services, marine environment monitoring, forest fire prevention and disaster mitigation.

The mission marked the 409th flight of the Long March carrier rockets.

The Long March-8 used for Sunday's launch is a modified version of the medium-lift carrier rocket and is 48 meters long with a take-off weight of 198 tonnes. It uses non-toxic and pollution-free propellants with a 3-tonne capacity for sunsynchronous orbit, the Xinhua report said.

Compared with the original model, the modified model does not have side boosters but can launch multiple satellites 50 space launches in 2022, with different orbital require-sending over 140 spacecraft

The Long March-8 is the new generation of China's carrier rocket. Designed and built by the China Academy of Launch Vehicle Technology, the rocket fills a gap in China's launch capability to the sunsynchronous orbit and meets the needs of more than 80 per cent of launch missions for medium and low-orbit space-

Xiao Yun, chief commander of the rocket, said an assembly and test plant for the Long March-8 family is being built outside the Wenchang launch site.

Once completed, it is expected to shorten the launch interval of the Long March-8 rocket to seven days, enabling 50 launches a year. On February 10, China

US, allies to cut off Russian banks from SWIFT messaging system

Seeking to cripple Russia's economy for invading Ukraine, the US and its key allies have decided to expel selected Russian banks from the SWIFT financial messaging system and impose restrictive measures on its central bank to limit Moscow's ability to access its overseas reserves.

The leaders of the US, the European Commission, France, Germany, Italy, the UK and Canada on Saturday also decided to launch a joint task force to hunt down assets of sanctioned Russian companies and oligarchs.

The Society for Worldwide Financial Interbank Telecommunication (SWIFT) is the world's main banking messaging service which links around 11,000 banks and institutions in more than 200 countries, including India.

Based in Belgium, the system is considered central to the smooth functioning of global finances and Russia's exclusion from it would hit the country

"We stand with the Ukrainian government and the Ukrainian people in their heroic efforts to resist Russia's invasion. Russia's war represents an assault on fundamental international rules and norms that have prevailed since the Second World War, which we are committed to defending, the leaders said in a joint statement released by the White House.
"We will hold Russia to

account and collectively ensure that this war is a strategic failure for (President Vladimir) Putin," the allies said in the statement.

Removing banks from SWIFT is deemed to be a severe curb because almost all banks use the system. Russia is heavily reliant on the SWIFT system for its key oil and gas

The joint sanctions are the



harshest measures imposed to date on Russia over its invasion

"As Russian forces unleash their assault on Kyiv and other Ukrainian cities, we are resolved to continue imposing costs on Russia that will further isolate Russia from the international financial system and our economies. We will implement these measures within the coming days," the leaders said.

Govt cancels ₹19k cr tender for connecting villages in 16 States with broadband

State-owned Bharat Broadband Nigam Ltd has cancelled a ₹ 19,000-crore tender that was floated for connecting villages across 16 States with an optical fibre-based high-speed broadband network, following the lack of participation of eligible bidders.

The project was approved in June last year to roll out an optical fibre network under BharatNet in 16 states in a publicprivate partnership model with a total expense of ₹29,430 crore.

The Centre had approved a viability gap fund of ₹19,041 crore for the project that aimed to connect 3.61 lakh villages

The project was divided into nine packages, and tenders for each of the packages were floated separately.

For each of the nine tenders, BBNL on



February 8 said the tender of the corresponding package "with all its corrigenda is hereby cancelled you account of nonparticipation by any bidder"

An e-mail query sent to BBNL elicited no response.

However, an official source told PTI that there was participation from some firms; bids were evaluated; but the participants failed to qualify.

"The tender will be floated again after

taking feedback from the industry. The government is committed to connecting villages with broadband at the earliest," the source, who did not wish to be named

The government opted for a public-private partnership after state-owned firms faced several issues in expediting the projects and missed several deadlines.

The BharatNet project was approved in 2011 as the National Optical Fibre Network with an aim to connect all 2.5 lakh panchayats with the optical fibre network by 2013.

According to official data, over 1.69 lakh village panchayats have been made service-ready for broadband services under BharatNet as of December 31,

KVIC urges Centre to Centre to provide

Khadi and Village Industries Commission (KVIC) has urged the Centre to lift the "export prohibition" on bamboo charcoal for optimum utilisation of raw bamboo and higher profitability in the bamboo industry. KVIC Saxena has written to Union Minister of Commerce and Industries, Piyush Goyal, seeking to lift the export restriction on bamboo charcoal for larger benefit of the bamboo industry.

As per the KVIC data, in India, bamboo is mostly used in manufacturing of Agarbatti wherein, a maximum of 16%, i.e. the upper layers of the bamboo, is used for manufacturing of bamboo sticks while the remaining 84% of bamboo is a complete waste. The Bamboo waste generated in Agarbatti and bamboo craft industries is not being utilized commercially, as a result, the Bamboo input cost for Round Bamboo Sticks is in the range of Rs 25,000 to Rs 40,000 per MT as against the average Bamboo cost of Rs 4,000 to Rs 5,000 per MT. Compared to this, the Bamboo price in China is Rs 8,000 to Rs 10,000 per MT but their input cost is Rs 12,000 to Rs 15,000 per MT owing to 100% waste utiliza-

"One of the biggest challenges that the Indian bamboo industry faces today is the extremely high input cost owing to inadequate utilization of bamboo. However, export of bamboo charcoal would ensure complete utilization of the bamboo waste and thus make profitable," it said. "The bamboo waste can be

best utilized by making "Bamboo Charcoal" which, though, has a very limited use within the domestic market but it is hugely in demand in the international market. However, the Indian bamboo industry is not able to tap the opportunity due to its "export prohibition". Considering the repeated requests of the industry, KVIC has requested the government to consider lifting the export restriction on bamboo charcoal. This would not only enable the industry to exploit huge global demand but also enhance the profitability of existing KVIC units by proper utilisation of bamboo waste and thus contribute to the Hon'ble PM's vision of "Waste to Wealth"," Saxena said.

Notably, the world import demand of bamboo charcoal has been hovering in the range of USD 1.5 to 2 billion and has been growing at the rate of 6% in recent years.

The capital infusion of ₹15,000 crore would go mostly to banks which had got money through non-interestbearing bonds in the previous year as the RBI had raised some concerns on the fair valuation of these instruments, sources said.

As per the RBI, the net present value of infusion made last year through zero-coupon bonds is much lower than face value as they were issued at discount, the sources added.

These special securities with tenure of 10-15 years are non-interest bearing and val-ued at par. Such bonds usually are non-interest bearing and issued at a deep discount to the face value. So, the effective Tier 1 capital levels for the banks could be lower than the regulatory requirement.

According to India Ratings and Research, fair valuing of the equity infused by the Government of India

(GoI) in five PSBs last year through zero-coupon bonds could lower the banks' effective Tier 1 capital levels in the range of 50-175 basis points than reported.

Earlier this month, Punjab & Sind Bank got board approval to raise equity capital worth Rs 4,600 crore by

The Supreme Court has held that an The Supreme Court has held that in individual facing any deficiency in telecom services can approach consumer forums directly with his complaint against the company.

The fact that the remedy of arbitration under the Indian Telegraph Act of 1885 is of a statutory nature would not oust the jurisdiction of the consumer forum in such matters, a bench of Justices DY Chandrachud, Surya Kant and Vikram Nath said.

"It would be open to a consumer to opt for the remedy of arbitration, but there is no compulsion in law to do so and it would be open to a consumer to seek recourse to the remedies which are provided under the (Consumer Protection) Act of 1986, now replaced by the Act of 2019," the bench said.

The top court passed the verdict on an appeal of Vodafone by which the company had challenged an order of National Consumer Disputes Redressal Commission (NCDRC) by which it had affirmed the view of SCDRC that Section 7B of the Act of 1885 would not be applicable to a private service provider since it is not a 'Telegraph Authority".

In its recent order, the court said that the insertion of the expression 'telecom services' in the definition which is contained in Section 2(42) of the Consumer Protection Act of 2019 cannot be construed to mean that telecom services were excluded from the jurisdiction of the consumer forum under the earlier Act of 1986.

"On the contrary, the definition of the expression 'service' in Section 2(o) of the Consumer Protection Act of 1986 was wide enough to comprehend services of every

accepted for the simple reason that the specification of services in Section 2(s) of the earlier Act of 1986 was illustrative. This is apparent from the use of the expression includes but not limited to". The top court further said that the

specification of services in Section 2(s) of the erstwhile Consumer Protection Act was therefore not intended to be an exhaustive prehended within the definition.

"On the contrary, by adopting language which provides that the expression 'service' would mean service of any description

which is made available to potential users, Parliament indicated in unambiguous terms that all services would fall within the ambit of the definition.

"The only exception was in the case of (i) services rendered free of charge; and (ii) services under a contract of personal service", it said.

The bench said that the Consumer Protection Act of 1986 was a milestone in legislative efforts designed to protect the welfare and interest of consumers. It noted that under Section 7B of the

Indian Telegraph Act, any dispute concerning a telegraph line, appliance or apparatus, between the telegraph authority and the person for whose benefit the line, appliance or apparatus is or has been provided has to be determined by arbitration. "Such a dispute has to be referred to an arbitrator appointed by the Central Government either especially for the determination of that dispute or generally for the determination of the disputes under the Section", it said. One Ajay Kumar Agarwal had, on May 25, 2014, instituted a consumer complaintbefore the District Consumer Disputes Redressal Forum, Ahmedabad alleging a deficiency in service on the part of the Vodafone.

The complaint stated that Agarwal had a post-paid mobile connection and was paying an amount of Rs 249 as the monthly basic rent and Vodafone was providing mobile telecom services to him on the basis of which it was asserted that there exists a relationship of consumer and service

Agrawal had subscribed to an 'auto pay' system through a credit card issued by his bankers in terms of which, Vodafone would receive the payment before the due date to facilitate the timely payment of bills. in the vicinity of Rs 555 but for the period between November 8, 2013 and December 7, 2013, the respondent was billed for Rs 24,609.51.

bill to top \$100 bn in current fiscal

India's crude oil import bill is set to exceed USD 100 billion in the current fiscal year ending March 31, almost double its spending last year, as international oil prices trade at seven-year

India spent USD 94.3 billion in the first 10 months (April-January) of the ongoing financial year that started April 1, 2021, according to data from the oil ministry's Petroleum Planning & Analysis Cell (PPAC).

It spent USD 11.6 billion in January alone when oil prices had started to surge. This compared with USD 7.7 billion spending in the same month last year.

In February, oil prices crossed USD 100 per barrel and going at this rate, India, which imports 85 per cent of its crude oil requirements, is expected to almost double its import bill to USD 110-115 billion by the end of the fiscal year 2021-2022.

The imported crude oil is turned into value-added products like petrol and diesel at oil refineries, before being sold to automobiles and other users. India has Higher crude oil import surplus refining capacity and it exports some petroleum products but is short on production of cooking gas LPG, which is imported

from nations like Saudi Import of petroleum

products in April-January of 2021-22 fiscal was 33.6 million tonnes worth USD 19.9 billion. On the other hand, 51.1 million tonnes of petroleum products were also exported for USD 33.4

India had spent USD 62.2 billion on import of 196.5 million tonnes of crude oil in the previous 2020-21 fiscal when global oil prices remained subdued in the wake of the COVID-19 pandemic.

In the current year, it has already imported 175.9 million tonnes of crude

Young, energetic, innovative — these children and youth — are the agents of change in rural India. They are the face of a new vibrant country. They are not scared to dream or work hard to achieve those dreams and bring the necessary changes they perceive that soci-

ety needs. Riya Soni, Ritesh Chauhan and Divisha Parwar represent the symbols of change that rural India so badly needs. They are all part of Youth4Children, an initiative for promoting child rights in Dhar and Jhabua by UNICEF and a local NGO, Vasudha Vikas Sansthan.

The initiative started as Maandal toli in 2016. Maandal is a dholak, a local tribal musical instrument popular in this belt of Madhya Pradesh. These children worked on child rights and other local issues and tried to spread awareness among community members through dholaks, nukkad nataks and other creative ways. As the children grew into youth and continued to be associated with the project, it was named Youth4Children.

Riya Soni, 16, of village Nowgong, of Meghanagar Block of Jhabua, is an extremely active member. She devised a no-cost indigenous handwashing station during the first wave of the pandemic Covid 19 in 2020. "People laughed at me when I was making it," she says recalling that she had seen a foot-operated handwashing station used by the Army on social media. Soni, who aspires to be a doctor, understood the importance of handwashing with soap regularly to combat the Covid 19 virus. She realised that a handwashing station similar to the one she had seen on social media would be expensive for the villagers. So, she used items wooden sticks, used bottles, wire, and stone/brick — that were easily available in any household to make an indigenous handwash-

AGENTS OF CHANGE

Youth4Children, an initiative in Madhya Pradesh, has transformed the lives of youngsters and adults, says Vinati Bhargava Mittal



In the innovative handwashing station devised by her, as soon as one keeps a foot on a wooden panel and pulls the strings, bottles of liquid soap and water hanging from the wires overturn and the liquid flows. The touchfree station proved safe to use during the pandemic. "This local handwashing station involves no cost, except for the handwash. The solution can be made by mixing soap in water," says Dr Gayatri Parihar Mewade, Director, Vasudha.

When Soni, a class XI student of Integrated Higher Secondary School Naugawan, put up a video of her handwashing station on the Maandal toli (UNICEF) WhatsApp group, there was no looking back. Her simple innovation became very popular and was viewed by lakhs of people across the world.





Children from not only her village but from those nearby replicated the model. Nearly 250 such handwashing stations were placed in local schools, community places, the Panchayat and nearby villages. People entering the villages had to first sanitise

their hands

Several national channels beamed her jugaad handwashing station. "Now, people recognise me. Those who laughed at me stopped and congratulated me," says Soni whose father is a labourer working in a fertiliser



factory. In fact, Madhya Pradesh chief minister Shivraj Singh Chauhan congratulated her on Twitter and UNICEF's brand ambassador Sachin Tendulkar spoke to her personally. "He asked me how I came up with the idea," she recalls.

Soni's laurels do not rest here. An advocate of child rights ad menstrual hygiene, Soni has tried to make villagers aware of the drawbacks of child marriage in her small way. During and after the pandemic, along with her team mem bers, she tried to remove the rumours associated with the Covid 19 vaccine, while educating villagers on its importance and the necessity of maintaining the Covid protocol. "Earlier, people did not want to get vaccinated. Men thought they would become impotent, and women were under the impression they would not be able to conceive after getting the jab,"

During the lockdown, Youth4Children members used mobile phones to make villagers aware of the Covid 19 protocol and the necessity of getting a jab. Once the lockdown was lifted, the team visited homes. Today, 100 per cent of the eligible population of Nowgong has received the first dose, claims Soni adding that the response to the second dose has also been overwhelming.

Youth4Children volunteers visited villages during the second wave of the pandemic and found out the kind of problems the villagers faced. He even checked their oxygen levels and body temperatures. Dhar became the first district in Madhya Pradesh to reach 100 per cent Covid 19 vaccination in the 15-18 age group.

Chauhan and other Youth4Children volunteers arranged second hand smart mobile phones for poor children studying in senior classes so that they could attend online school. Éach mobile costs ₹5,000. Following the pandemic, there had been a large number of dropouts in the nearby villages and children had even taken to child labour. Sheela Damor of Gopalpura tried to convince parents to send their wards back to school.

"During the lockdown villagers would be found sitting on the *chaupal*. And, the children would be playing outside. They would not be wearing masks," says Divisha Parwar of Dhar. Not only did she distribute and make them aware of the importance of wearing masks to ward off Covid 19, but spent considerable time finding out the problems that the children faced during online education. She taught students how to use various educative sites. Applauding Soni and others, Michael Juma, then chief of UNICEF, Madhya Pradesh had said, "Progressively, adolescents in Jhabua have been proactive in advancing child rights. We may need to leverage their experiences to roll out sustained advocacy on infection prevention and control and hygiene management practices for Covid 19 response in the district and beyond whilst maintaining social distancing."



Long way home

Shabana Kausar documents how the delay in providing houses under the Pradhan Mantri Awas Yojana (PMAY) in Mendhar, Poonch, is affecting the people

In 2019, Ulfat Bi, a resident of Mankote tehsil in Poonch district of Jammu and Kashmir, applied for the Pradhan Mantri Awas Yojana (PMAY). Earlier known as Indira Awaas Yojana (IAY), it was revamped as Pradhan Mantri Awas Yojana (PMAY) with effect from 2016-2017, with the aim of 'Housing for All by 2022'. Mohammed Shakeel, a local from the village, helped her in submitting the required documents to reap the benefits of this scheme, but three years have passed without any tangible action. Currently 60, Ulfat still waits for a home of her

own.
"My husband abandoned me a few months after our wedding. It has been almost 35 years since. I did not remarry. I requested my mother to live with me. After some time, my mother also passed away. My house, my only haven, collapsed during the 2014 floods, leaving me homeless. I have been staying at my mother's house with

my brothers," said Ulfat. While sharing her experience of dealing with the concerned authorities, Ulfat informed that she has tried talking to them multiple times regarding the delay in the process. 'Whenever I talk with someone regarding the file, they demand a commission. I receive only ₹1,000 as a widow pension which I use for groceries and my medicines. How am I supposed to meet their demands?" she

lamented. Mushtaq Shah,

Block Development Officer, Mankot, said, 'Ulfat's file was among the several files which failed to be uploaded on the official portal due to a technical problem. When we re-surveyed to identify people under the Below Poverty line (BPL) to include them in the PMAY beneficiary list, Ulfat Bi's

name was not on it. I will try to get

her name on the list as soon as pos-

Covid-19, on the other hand, has made Ulfat's life even more difficult. The help she received from neighbours to get her medicines or enquire about the progress of her file also stopped due to lockdown.

Abdul Majeed, another resident from the tehsil, is in the same boat. Despite several attempts, he could not receive the benefits of PMAY, and his house is in a dilapidated state and can

deputy commissioner of Poonch, and him about the difficulties I was facing in the procedure. assured his help and eventually, my file was uploaded. But now it has been

deleted again. According to Ismail, the sarpanch of the village, there was an error that led to the deletion of the file again. I will now have to create a file again," he expressed. Likewise, Saghira Bi, a 50-year-old woman from the same village, is exhausted by the technical procedure, which has left her hopeless. "With great difficulty, I somehow managed to apply for the scheme. However, I recently learned that my file had been deleted due to technical reasons. I have lost all hope as I am not sure if I will be able to invest the same time

and energy at this age is going through the entire process again," she According to a report, under the

Pradhan Mantri Awas Yojanaand Kashmir was set for 1.40 lakh houses. Out of 1.40 lakh houses, 1.39 beneficiaries are registered on Awaas Soft. Further, over 1.36 lakh houses have been sanctioned with verified accounts. Although there is no doubt in how this scheme has benefited several lives, it is imperative to ensure that everyone who applies for the scheme should be catered for. The effort, time and hope that

hapless and elderly people like Ulfat invest in government schemes should not be ignored. They are the ones for whom our policymakers design these schemes. The implementation of such schemes on the ground should be made easier, especially for eldery people like Ulfat. Their lives depend on these files, which are handled haphazardly. The concerned departments should conduct the procedures to make the process smooth for the beneficiaries while ensuring the fulfillment of all the required procedures. So that, during times like Covid-19, they are not left stranded without any help.

ising global temperatures have shifted at least twice the Ramount of freshwater from warm regions towards the Earth's poles than previously thought as the water cycle intensifies, according to new analysis

Climate change has intensified the global water cycle by up to 7.4 per cent compared with previous modelling estimates of 2 per cent to 4 per cent research published in the iournal *Nature* suggests.



The water cycle describes the movement of water on Earth - it evaporates, rises into the atmosphere, cools and condenses into rain or snow and falls again to the surface. "When we learn about the water cycle, we think of it as some unchanging process which is constantly filling and refilling our dams, our lakes, and our water sources," the

study's lead author, Dr Taimoor Sohail of the University of New South Wales, said. The volume of extra freshwater that had already been pushed to the poles as a result of an intensifying water cycle was far greater than previous climate models suggest.

EXCESSIVE HANDWASHING & ENVIRONMENT

Eand use of hand sanitisers during the Covid pandemic has damaged the environment and. ironically, public health

Scientists led by a Trinity College Dublin expert found that the environmental damage was 'significant" and said more eco-friendly hand hygiene options were needed

Plastic packaging, chemicals in hand gels and the increased demand on water have all had a negative impact, they said. The extra manufacturing, packaging, transport and energy use associated with sanitisers produced carbon emissions equivalent to 2 per cent of annual emissions.

Chemical ingredients were damaging to the ozone laver and added toxicity to waste water. The researchers, headed by Dr Brett Duane, associate professor in Trinity's School of Dental Science, acknowledged the importance of hand nygiene in preventing the spread of germs.

BLUE WHALES ARE NOT SELFISH

 $D_{\text{possible}}^{\text{espite}}$ their size and clear need for as many nutrients as possible, blue whales are innately unselfish foragers according to the first study, led by David Cade, a postdoctoral research fellow at Pacific Grove's Hopkins Marine Station, and co-authored by MBARI biological oceanographer John Ryan and incoming MBARI postdoctoral fellow William Oestreich. With Ryan analysing environmental variables and Oestreich speech patterns, the research team found that blue whales,

which often travel in pairs or as individuals, can recognise when a patch of krill (a favorite meal) is especially dense. The whale will send out a call that can travel hundreds of kilometers and alerts other blue whales. According to the study, this can lead to up to 40 blue

whales populating a one-kilometer radius, feeding on the krill swarm. This is remarkable, says Oestreich, since krill populations are often patchy and spread out. He says if whales find food that is going to help them survive, then it's intuitive that they just feed on it but the study shows a propensity for inviting other blue whales



Children living in areas with higher levels of small pollution particles and less green spaces might have up to 62 per cent increased risk of developing ADHD,

according to a study The research. published in the iournal Environment International, found that children living in greener and less polluted areas have a 50 per cent lower risk of developing ADHD, one of the most

prevalent neurodevelopmental disorders.

The researchers led by Matilda van den Bosch, from Barcelona Institute for Global Health (ISGlobal), used data from 37,000 children in Vancouver, Canada. They analysed the possible associations between exposure to greenness, small pollution particles (PM2.5) and noise in early life with later incidence of ADHD, which affects up to approximately 5-10 per cent children and adolescents.

South Africa leads NZ by 211 at stumps after day 3

South Africa held a 211-run lead over New Zealand at stumps Sunday on the third day of the second test at Christchurch, a day on which there were four specific episodes and one general

The binding theme of the day's play was that South Africa held a tenuous upper hand. From the start of play when New Zealand was 157-5 and 207 runs behind South Africa's first innings of 364, the Proteas kept a grip on the match, shaken momentarily by the day's events.

At stumps South Africa was 140-5 in its second innings with Kyle Verreyne 22 not out and Wiaan Mulder 10.

In the first episode of the day, 35year-old allrounder Colin de Grandhomme continued a gallant counter-attacking innings to post his second test century, four years after his first.

De Grandhomme shared a 133-run sixth-wicket partnership with Daryl Mitchell which shored up the New Zealand innings after the home team had



been 91-5 late on the second day. He made a half century from 56 balls before stumps on Saturday and carried on to 90 in the first session Sunday, then spent 47 nervous minutes in the 90s before completing his century.



For Delhi, the tournament is as good as over and only seven points (including a bonus) against Chattisgarh will give them a slim chance in theory. On the day, Jharkhand skipper Virat Singh declared at 307 for 7 leaving Delhi with a target of 335 in just over two and half sessions.



A ustralia arrived for its first tour to Pakistan in 24 years on Sunday with the visitors due to play three test matches, three one-day internationals and a one-off Twenty20 during their six-

Australia last toured to Pakistan in 1998 when it won the test series 1-0 while also winning all the matches in the limited-overs series. Pakistan has struggled to attract visiting sides since a fatal terrorist attack on the visiting Sri Lanka team's bus in 2009, and Australia pulled out of a tour five years earlier after a suicide blast at a Lahore church.

Pakistan has hosted Zimbabwe, Sri Lanka, West Indies, Bangladesh and South Africa over the last six years, but Australia is the first high-profile team that will be touring Pakistan for a fully-fledged bilateral series.

Last year both New Zealand and England pulled out of limited-overs tours to Pakistan due to security concerns. New Zealand abandoned its tour just hours before the toss for the first ODI in Rawalpindi, which is due to host the first test against Australia beginning

Pakistan later this year.

Karachi will host the second Australia test from March 12-16 followed by the third test at Lahore from March 21-25. Rawalpindi will host the ODI series from March 29 before Australia rounds off its tour with a

Twenty20 on April 5.

Security teams from Australia visited Pakistan last year to assess the security arrangements in the three cities before the tour was given the approval by Cricket Australia.

Thousands of security personnel are expected to be deployed during the Australians' stay and the Pakistan cricket board expects fully vaccinated capac-

ity crowds for the tests and limited-overs
