Atiq's son Asad, accomplice shot dead in STF encounter

Duo meet tragic end while trying to flee on motorcycle in Jhansi

PNS LUCKNOW / PRAYAGRAJ

Asad, son of jailed gang-ster-turned-politician Atiq Ahmad, and shoot-er Ghulam Mohammad were killed in an encounter with the Uttar Pradesh Special Task Force (UPSTF) personnel in Jhansi on Thursday afternoon, Special Director General (Law and Order) Prashant Kumar

said on Thursday evening.

Both were wanted in the recent Umesh Pal murder case of Prayagraj and carried a reward of Rs 5 lakh each.

"Sophisticated foreign made weapons were recovered from the accused," Kumar said,

Ghulam Mohammad was led by deputy superintendents of police Navendu Kumar and Vimal Kumar.

Atiq Ahmad was in the court of chief judicial magisadding the UP STF team that court of chief judicial magisgunned down Asad and trate in Prayagraj in connection

with the murder case when the news of Asad's encounter broke. He started crying after hearing the news of his son's death. He asked for water and sat down holding his head in the district court premises.

Atiq Ahmad, a former SP legislator, had earlier expressed apprehension that he himself could be killed by UP Police while being brought to Prayagraj from the Ahmedabad prison, where he was lodged in connection with another case.

K'taka call to end 4% Muslim quota flawed, observes SC

 $E^{\text{xpressing displeasure over}}_{\text{the decision of the }} \\ \text{Karnataka Government to}$ scrap the four per cent reservation for OBC Muslims and raise quotas in government jobs and educational institutions for Vokkaligas and Lingayats by two per cent each, the Supreme Court on Thursday observed the decision prima facie appeared to be on a "highly shaky ground" and "flawed".

A bench of Justices KM Joseph and BV Nagarathna said from the records tabled before the court it appears that the Karnataka Government's decision is based on "absolutely fallacious assumption".

Prime Minister Narendra Modi on Thursday raised the issue of security of Indian diplomatic establishments in the United Kingdom in a telephonic conversation with his British counterpart Rishi Sunak and called for strong action against anti-India elements, a statement said. According to it, Modi also sought progress on the return of economic offenders wanted in

man Vijay Mallya and fugitive diamond merchant Nirav Modi from the UK.

Mallya, who fled to the UK in 2016, is wanted in India over a default of Rs 9,000 crore that was loaned to Kingfisher Airlines by several banks. Nirav Modi is facing charges in the estimated USD 2 billion Punjab National Bank loan scam case.

About the vandalism at the Indian High Commission last month, Sunak conveyed to Modi that the UK considers the attack "totally unacceptable" and assured the security of the Indian Mission and its personnel, the statement said.

Atiq gets 5-day police remand; wife wants to surrender

Prayagraj: A Prayagraj court on Thursday sent gangster-politician Atiq Ahmad and his brother Ashraf to 14-day judi-cial custody and also allowed five-day police remand in con-nection with the Umesh Pal murder case.

Ahmad and Ashraf, alias Khalid Azim, will be kept in judicial custody till April 26, said advocate Vikram Singh, the counsel for Umesh Pal's wife Jaya. The court allowed five-day police remand of the duo which will remain effective till evening of April 17.

Meanwhile, sources said Atiq's wife Shaista Parveen wants to surrender before police in order to have access to the last look at her son Asad before his last rite.

ED books BBC India for foreign funds violations

PNS NEW DELHI

The Enforcement Directorate (ED) has registered a case under Foreign Exchange Management Act (FEMA) against British Broadcasting Corporation (BBC) India for alleged foreign exchange violations.

The agency also summoned BBC staffers for questioning following which its Deputy Managing Editor deposed on Thursday. The ED action came nearly two month the Íncome-Tax after Department surveyed the BBC India's offices in Delhi and Mumbai on February 14. The survey operation lasted for three days. The FEMA case was registered about two weeks back to essentially probe purported foreign direct invest-ment (FDI) violations by the company and related instances, according to officials.

Covid 8-month high at 10K+, but just 1 of 1K patients hospitalised

PNS NEW DELHI

Amid warning that Covid cases in the country will peak in the next couple of weeks, India on Thursday recorded a single-day rise of 10,158 new infections, highest in nearly eight months and up by 30 per cent over the previous day, according to the Union Health Ministry data.

However, low hospitalisation has come as a breather. "Currently, the hospitalisation ratio is 1:1,000 and this is not a wave. It may be an endemic cycle of Covid-19," officials in the Union Health Ministry said. The daily positivity rate was recorded at 4.42 per cent while the weekly positivity rate was 4.02 per cent. The active cases now constitute 0.10 per cent of the total infections, as per the Union Health Ministry

AIIMS, Delhi, has issued an advisory for its staff to fol-low Covid-19 appropriate behaviour saying that people "must use reusable cloth face cover/surgical mask in the workplace. Ensure proper



cleaning and frequent sanitation of the workplace, particularly of the frequently touched surfaces."

A few AIIMS doctors too have tested Covid positive with newborn diagnosed with Covid-19 at Delhi's LNJP Hospital.

The number of active cases has increased to 44,998, the data updated on Thursday showed. India had reported 7,830 coronavirus infections on Wednesday. The nationwide Covid-19 recovery rate has been recorded at 98.71 per cent, according to the Health Ministry website.

The case fatality rate was recorded at 1.19 per cent.



Noida (PTI): A 38-year-old man with formal education till Class 3 has been arrested by Uttar Pradesh's Cyber Crime police over Rs 1.68 crore fraud with a businessman on the pretext of trade with a Canadian firm, officials said on Thursday. The fraudster used Facebook to network with gullible people associated with pharmaceutical productions and represented himself as a middle-man who lured them with good monetary returns,

The accused was arrested from Ballia district by a team of Cyber Crime police station, Noida, which was investigating the case lodged over the complaint of the businessman, who lives in Omaxe NRI City in Greater Noida in February

2021, according to the police. "Accused Durga Prasad Mishra alias Rajeet Mishra, along with his partners, had posed as a middle-man for a Canada-based pharmaceutical company. Mishra told the complainant that this Canadian firm required 'curvin used for manufacturing of some medicines. If he could procure the product, they would sell it to the Canadian company at a good margin," Inspector Reeta Yadav, incharge of Cyber Crime police station here, said.

"However, there was no such Canadian company in reality. The whole story of the

According to police, so far transactions worth Rs 30 lakh have been found in this account

from different sources.

Lucknow (PNS): A patient in severe cardiogenic shock (candidate of heart transplant) was successfully managed at King George's Medical University. KGMU spokesperson Dr Sudhir Singh said that Rajpal Yadav, a 55-year-old man, was brought to the cardiology emergency on March 20 last with complaints of severe breathlessness and chest pain. He was diagnosed with heart failure due to severe aortic valvular stenosis and severe mitral valvular regurgitation.

"On assessment, the patient was found to be in cardiogenic shock. Seeing the habitus, it was clear that he was a candidate of heart transplant, but a high-risk trial was planned by cardiac anaesthesia and cardiac surgery team after discussions with the relatives of the patient," he added. The spokesperson said that a rarely discharged from hospital recently.

available drug called 'Levosimendan' was arranged by cardiac anaesthesia from a city hospital. After an hour of aortic valve replacement and Levosimendan along with other routine ionotropic infusions, the condition of the patient slightly improved," Singh said. Opposition parties in Uttar Pradesh raised questions on the killing of gangsterturned-politician Atiq Ahmad's son Asad and his aide in a police encounter in Jhansi on Thursday and demanded a high-level probe to bring out

the facts before people.

SP chief Akhilesh Yadav alleged that the BJP government was trying to divert attention from real issues with "fake encounters" and BSP supremo Mayawati said the killing could be a repeat of "Vikas Dubey incident".

Deputy Chief Minister Keshav Prasad Maurya, on the other hand, congratulated UP Police on the action.

"Nobody will touch you if you don't commit a crime. And nobody will be spared if they commit a crime," Maurya told PTI. He asserted this was a BJP government and not an SP regime that criminals would be spared.

Within hours of the killing of Asad and his aide Ghulam, both wanted for the daylight murder of Umesh Pal and his two security guards in Prayagraj in February, Yadav suggested the police encounter could be "fake".

"By doing fake encounters, the BJP government is trying to divert attention from real issues. The BJP does not believe in courts at all. Today's and other recent encounters should be thoroughly investigated and the culprits should not be

spared. The government does Asad, their accomplice Ghulam not have the right to decide and others were behind the killing.

Umesh Pal's family what is right or wrong. The BJP is against brotherhood," the

thanked Chief Minister Yogi Adityanath and the police administration. Whatever they have done is right. He (the CM) has pun-

ished the killer of his daughter's husband. I express my grati-tude. He is like a father. Justice has been done," Jaya Pal told the media.

She hoped strict action would be taken against the other accused.

"I leave that (action) to the government. The government is giving me justice," she added. Umesh Pal's mother said the two gunners (Asad and his

aide) had "committed a sin". 'They have been punished today. We have faith, we will get complete justice," she added.

Following the killing of Umesh Pal, Akhilesh Yadav had tried to corner Chief Minister Yogi Adityanath and raised questions over law and order in the state. Adityanath had then retorted to Yadav, blaming his party for "nurturing" criminals. The chief minister had also vowed to "destroy" the mafia in the state.

"The mafia whose name is emerging... is it not true that the Samaiwadi Party had made him an MP.... He was a mafia nurtured by the SP. Our government is working to break their back. 'Mitti me mila denge' (We will destroy the mafia)," Adityanath had said in the

against illicit liquor

The Excise department will ■ start a month-long drive from April 14 to check manufacture, sale and smuggling of illicit liquor in view of the upcoming urban local bodies

Additional Chief Secretary (Excise) Sanjay R Bhoosreddy said in view of the local bodies elections there was a possibili-ty of increase in the demand of liquor in the state. He said for peaceful and fair conduct of elections and for maintaining orderliness, effective prevention on manufacture, sale and smuggling of illicit liquor was necessary. "In view of this, instructions have been issued at state level to run a special enforcement drive from April 14 to May 13," he said in a statement issued here on Thursday.

Bhoosreddy said under the special enforcement drive, joint Revenue Administration, Police and road checking would be done in

areas prone to smuggling.

He said the excise officers had been instructed that if they find any involvement of mafia in the illegal liquor business, FIR under relevant sections of the Indian Penal Code and Excise Act be lodged against them.

"Surprise checks should be conducted at suspicious dhabas located on national and state highways where illicit alcohol tankers often stop. Complaints are often received about transportation of illegal liquor from grocery, fruit and milk vehicles; such suspicious vehicles should also be checked," he said.

He asked to ensure cent per cent compliance with orders issued by Excise headquarters for control of methyl alcohol so that any unpleasant and tragic incidents could be avoided.

"Many instances of manufacture and sale of illegal liquor have been caught in closed factories. Therefore, such closed factories should be marked and a constant watch should be kept on them. Special vigil should be kept on the areas where distilleries are located so that there is no possibility of alcohol theft from them," he

The additional chief secretary said wide publicity should be given in the context of liquor sold from illegal places by advertisements in newspapers, handbills, posters and through electronic media. He said the general public should be warned against buying and drinking alcohol from illegal places and also about methyl alcohol being a deadly poison and its use causing blindness and even death.

Bhoosreddy said that if any person had any information about the manufacture, sale or storage of smuggled liquor at any place or any other kind of information related to liquor, he or she should immediately inform the control room of Excise headquarters at Prayagraj having toll free number "14405" or on WhatsApp number

Four held for filing false cow slaughter FIR

Uttar Pradesh Police have arrested a leader and three other members of the Akhil Bharat Hindu Mahasabha (ABHM) for allegedly filing a false case of cow slaughter to frame a rival group in Agra, officials said on Thursday.

The official said the four -ABHM national spokesperson Sanjay Iat and members Brajesh Bhadoria, Sauray Sharma and Jitendra Kushwaha — were arrested on Wednesday and sent to jail.

Several criminal cases are pending against the four in various police stations of Agra, he

"They all have been booked under IPC section 429 and sections of the Uttar Pradesh Prevention of Cow Slaughter Act," Raj Kumar, in-charge of the Itimad-ud-Daulah police station, told PTI.

Police said Kushwaha had lodged a complaint at the behest of a group of Muslims on March 30, alleging an incident cow slaughter in the Itmad-ud-Daulah area. He had named Rizwan alias Kalla, Nakeem, Viju alias Chhotu, Shanu alias Illi, and Imran in the

Police then arrested two of those named in the FIR - Shanu and Imran.

They told the police that they were being framed in the case by a rival Muslim group, who had contacted the ABHM and got the case filed against them. Assistant Commissioner of Police R K Singh said their investigation found the FIR filed was false and

"The ABHM members, including its national spokesperson Sanjay Jat, were alleged to be involved in lodging the false FIR to put pressure on police to frame the rival group," Singh added.

GANGA POLLUTION IN BALLIA

NGT directs UP chief secretary to ensure remedial action

National Green Tribunal has directed the Chief Secretary of Uttar Pradesh to ensure remedial action, including fixing the responsibility on erring officers, in a matter pertaining to pollution of river Ganga in Ballia district. The NGT was hearing a petition claiming the discharge of sewage and solid waste into the Katahal drain

connected to the Ganga. Underlining that around 20 million litres per day (MLD) of untreated sewage through the drain was being discharged daily into the river, a bench of chairperson Justice AK Goel "We record our dissatisfaction with the failure of the

NEW DELHI (PTI): The state administration, particularly the failure to hold erring officers accountable for wastage of public money and preventing damage to river Ganga."

The bench, also comprising judicial member Justice Sudhir Agarwal and expert members A Senthil Vel and Afroz Ahmad said, "Chief Secretary in coordination with other authorities concerned in the state may ensure remedial action in the present case also for which a special meeting of concerned officers be convened preferably within one month to plan and execute remedial measures, including fixing of responsibility of erring

The bench noted an action taken report filed pursuant to the tribunal's earlier order showed "almost total inaction" of the state authorities except for raising huge demands of money as a pretext for avoid-

ing basic responsibility. It said the funds allocated earlier were not utilised, nor was any attempt made to collect funds locally and accountability was not fixed on erring officials. There was a need to involve higher officers "to fix accountability for the continuing failure of (other) officers involved who appear prima facie to have abused the funds at the cost of public interest," the bench said.

Woman raped by brother's friend

A²¹-year-old woman here in a village was allegedly raped by her brother's friend who also uploaded a private picture of her on social media, police said on Thursday.

According to the woman's complaint, a friend of her brother raped her on April 6 and also took her pictures, which he circulated on WhatsApp, said Ballia City Kotwali Inspector (crime) Sanjay Shukla.

Shukla said the victim in her complaint filed on Tuesday also alleged that the assailant also threatened to kill her. Based on her testimony, police arrested the accused from the NCC crossing of the district headquarters, he added.

She said one could achieve colour removal to the extent of 70-75 per cent in the sugar syrups which is considered excellent and will help in making superior qualwhite sugar. Neelam Chaturvedi and Himanshu

Another research fellow of Organic Chemistry Mamta Shukla derived 'vanillin' from lignin portion of the fibrous material which otherwise was produced from vanilla beans and some other raw materials. She said vanillin known for its vanilla flavour finds its application in various bakery, confectionary, beverage and pharmaceutical industry with significant consumption in ice creams. She added juice contained various carbohydrates and can be utilised for producing ethanol the yield being 45-50 litres per ton of stalk crushed. Anushka Kanodia, team leader said the product had a total enerlower to sugar having 387 kcal/100g and honey having about 320 kcal/100 g. This being one-of-a-kind sugar, has an aroma and taste that was moreearthy and had a glossy finish that attracted its application in barbecue marinades, salad dressings, granolas, cookie manufacturing and many more. She expressed gratitude for ICAR-Indian Institute of Millets Research for providing the seeds for cultivation of five different varieties for sorghum at farm. She said NSI made efforts to exploit the potential of the crop so as to convert this neglected crop to a "Miracle or Wonder Crop" making it attractive to farmers also as they get higher returns.

Man kills mother, hangs self

After reaching the village, Dr Manjula Singh did on-site inspection of a communicable

She said the objective was to make women self-reliant by not only cultivating banana but also preparing fibre from banana peel for manufacturing clothes and other materials. She said production of banana fibre, though required a large number of human resources, yet was not labour-intensive and it was a profitable venture providing employment to people and posed no threat to environment, thus making it a sustainable environment-friendly intervention. She said banana fibres can be used to make ropes, mats, woven fabrics as well as handmade papers and this can fetch extra income to women. She said while the men can go in for banana cultivation women can prepare these products and increase their profits. Dr Pandey said in addition to this banana fibre can be

refined and used to make fine cushion covers, neck ties, bags, table cloths, curtains etc. She said rugs made from banana silk yarn fibres were also very popular the world over. She said banana fibres, which were concentrated near the outer surface, were extracted by hand and they can also be extracted by boiling leaf sheaths in sodium hydroxide solution. She said the handstripped fibres were generally of better quality than those obtained by machines. She said during the monsoon stalks were usually plentiful and extraction of the fibre from the stripped leaf sheath cut to a size by hand scraping using long blunt blades on a soft wooden plank. The pith is then removed continuously until the fibers appear clean. She said the method of extraction was carried out by artisans in the cottage industry sector. She said after that extraction fibres were washed thoroughly and hung up in sunlight to dry as soon as they are stripped. Over 40 women farmers took part in the training. The women were also trained in braiding and knitting and informed how they can prepare clothes and sarees from banana fibre. Dr Mukta Garg, Dr Archana Singh, Dr SK Tripathi, Ankita, Neha and others were present.

Atiq Ahmad, Ashraf sent to 14-day judicial custody

 $A^{\text{Prayagraj}} \ \, \text{court} \quad \text{on} \\ \text{Thursday sent gangster-turned-politician Atiq Ahmad}$ and his brother Ashraf to 14-day judicial custody and also allowed five-day police remand in connection with the Umesh Pal murder case.

The two were produced before Chief Judicial Magistrate Dinesh Gautam at 11:10 am amid heavy security and they remained in the court for over two hours as the arguments proceeded.

Ahmad and Ashraf alias Khalid Azim will be kept in judicial custody till April 26, said advocate Vikram Singh, the counsel for Umesh Pal's

Singh said after arguments on the application submitted by

were completed, the court allowed five-day police remand of the duo which will remain effective till evening of April 17.

According to legal experts, the police remand empowers police to keep the accused in their custody and interrogate them regarding the case.

On the completion of police remand, Ahmad and his brother will be sent back to jail. "Both Atiq Ahmad and Ashraf will be sent back to Sabarmati prison and Bareilly jail, where they are currently lodged, on the completion of police remand to complete the remaining duration of judicial custody," said Singh

The CJM court's verdict came on a day the Uttar Pradesh Police said they have killed Ahmad's son Asad and one of his aides in an encounter in Jhansi. Both Asad and his aide were wanted in the Umesh Pal murder case.

Umesh Pal, a key witness in the 2005 killing of BSP MLA Raju Pal and his two police security guards were shot dead outside his home in Prayagraj's Dhoomanganj area on February 24 this year.

The daylight killing on a busy street had raised questions over law and order in Uttar Pradesh and Chief Minister Yogi Adityanath had vowed in the state assembly that he will "destroy" the mafia in the state. Ahmad, Ashraf, their fam-

ily members and others were made accused in the Umesh Pal murder case based on a complaint by Jaya Pal. Ahmad is also an accused in the Raju Pal murder case. For the court hearing on

Thursday, Ahmad, the 60-year-

old former Samajwadi Party legislator, was brought from Sabarmati jail in Gujarat and Ashraf was brought from Bareilly jail.

This was the second time within a month that Ahmad was brought from the Gujarat jail to Prayagraj via road for a court hearing. On March 28 an MP/MLA court held Ahmad and two others guilty in connection with the kidnapping of Umesh Pal in 2006 and sentenced them to rigorous imprisonment for life.

The FIR in the Umesh Pal murder case was lodged under IPC sections 147 (rioting), 148 (rioting armed with deadly weapons), 149 (unlawful assembly guilty of offence committed in prosecution of common object), 302 (murder) 307 (attempt to murder) and 506 (criminal intimidation).

BHU doctors perform upper jaw transplant

A team of oral and maxillo-facial surgeons at Faculty of Dental Sciences, Institute of Medical Sciences (IMS), Banaras Hindu University itated with patient specific prosthesis for upper jaw (maxilla) in a post operated case of the Black Fungus (mucormycosis). Patient was diagnosed with mucormycosis in 2021 during the second wave of COVĬD-19 pandemic. His upper jaw (maxilla bone) was completely removed which led to oro-nasal communication due to which the patient was unable to eat, drink and speak properly.

The patient reported the same to the Oral & Maxillofacial Surgery Unit and examined by unit head Prof Naresh Kumar Sharma and associate professor Dr Akhilesh Kumar Singh for correction of maxillary defect. The team decided to prepare an artificial 3D printed Titanium jaw which was specific to the patient defect. The artificial jaw was made with the help of computer aided designing/ computer was fixed with the help of



aided manufacturing (CAD-CAM) on the stereolithographic model of the patient's face. The surgery was per-

formed by the team of doctors led by Prof Naresh Kumar Sharma and comprised Dr Akhilesh Kumar Singh, resident doctors Dr Raveena Rajpoot, Dr Ashwathi Krishnan, Dr Arjun Mahajan, Dr Sharanya, Dr Tanisha and the anaesthesia team led by Dr Reena, assistant professor and the resident doctors Dr Kusum, Dr Deepak and Dr Gaurav. The surgery went for the duration of three hours and was uneventful. No facial incision was given to avoid any scar over the face, the prosthetic device intraoral maxillary vestibular incision approach and the implant was fixed to the zygomatic bone with the help of the titanium screws.

The intraoral defect was closed completely so that the patient can eat, drink and speak properly in future. The artificial teeth will be fixed to the prosthesis after three months in the second stage.

Prof Vinay Kumar Srivastava, Dean of Dental Sciences faculty, IMS BHU, congratulated the team of doctors for carrying out the operation successfully and he said he will try to start the 3D printing facility in the department so that more and more patients may get benefitted.



Systemic failure A 12-year-old was tried for murder, convicted, and spent his best years on death row

iranaram Chetanram Chaudhary is a living testament to the pathetic state of our police and justice systems. In 1994, he was 12 years old — and tried for murder on the presumption that he was 22. This happened because somehow he got dragged into a murder case in Pune, in which five women and two children were knifed to death. After class three he ran away from his school at Bikaner in Rajasthan, went to Pune, and began working in a tailoring shop. He doesn't remember why ran away from his home or with whom, nor could any of his brothers. Some cop misspelled his name as Narayan instead of Niranaram, leading to his trial, conviction, and death sentence. What is startling and heartrending is the fact no one in the system — from cops of various ranks and lawyers to judges at different lev-



els in the judicial hierarchy — could even notice that a child was being on trial. A junior police officer may have misspelled the name, but could he tell a 12year-old kid from a 22-year-old youngster? And what about the senior officers? And the prosecuting lawyers and defence counsels? And judges in the trial and appeal courts? A 42-year-old man, if he abuses his own body, may look 52; and a 52-yearold man, who takes good care of his body, may pass off as 42. But how on earth can a 12-year-old boy be mistaken as 22 years of age? Even if he did commit the crime, he could not have been imprisoned for more than three years, as per the juvenile law in effect at that time.

Justice is said to be blind, but those responsible for dispensing it are not supposed to be blind; their cognitive and cogitative faculties ought to be sound. In Chaudhary's case, all these were found wanting — and he paid a terrible price. He had to spend 28 long years in prison, and on death row to boot. The best years of his life — adolescence and most of his youth — were spent behind bars. "When you are on death row, every hope is broken. You just try to get through the day," he recently told a newspaper after his release, adding that he now feels blessed to look at the stars on a dark night after spending years confined to four walls under the glare of lights. In prison, he studied a lot, getting a master's degree in sociology. It was at this time that he realised that he was much younger than the prison records showed. The Supreme Court ended his ordeal in March when it concluded that Niranaram was 12 years and six months old at the time of the murders. School documents and medical examination proved that. The exercise was carried out as part of the National Law University's Project 39A which works on death penalty reform. This episode proves, if any proof is needed, that India's justice and police systems urgently need reforms. Our political masters, however, have not shown great zeal for reforms in the justice system. People like Niranaram Chetanram Chaudhary continue to suffer.



Adapting to climate change is imperative



For a country like ours, which experiences almost extreme weather conditions every year, resilience building must be given top priority

he agriculture sector is highly vulnerable to climate change and is a big challenge for the agrarian economy. Food-bowl Punjab and Haryana farmers' fetish for unsustainable big cereal wheat this time has begun to hurt, as returns diminish due to climate challenges. The climate challenge farmers faced this time was erratic rainfall at the end of March, while crops were ready to harvest, likely to affect the yield significantly. In the case of Punjab, the initial deliberation by the agriculture department has indicated that at least 40 per cent of 35 lakh hectares of wheat sown is impacted by rain, winds, and hailstorms.

The serious challenges from climate change-induced impacts of erratic rainfall and the heat waves are not just a threat to our food security and nutrition as well as to the livelihood of 45 per cent of the country's population that depends on farming. It has an impact on their crop loan cycle to return on time to get fresh lending and to invest back into their

Policymakers, agri-scientists and farmers must come together to confront the challenge of climate change. Various climate change policies are established at international, national and state levels to address the impacts of climate change. Traditionally, the focus of such policies remained on mitigation instead of adaptation measures. Adaptation actions are needed to respond to climate change as these actions help reduce vulnerabilities.

Overuse of resources like water, soil, fertilisers and pesticides to boost yield resulted in Green-House Gases Emissions (GHGs). Take the example of Punjab, after the implementation of the Food Security Act; the nation is again looking toward Punjab, but Punjab farmers need to conserve its soil and water management along with adopting diversification in agricul

Why are the funds dwindling? However, the National Mission on Strategic Knowledge for Climate Change (NMSKCC) seeks to build a dynamic knowledge system that would inform

and support action for responding effectively to the objective of ecologically sustainable development making agriculture climate resilient.

The National Adaptation Fund for Climate Change (NAFCC) was established in 2015 to meet the cost of adaptation for the States but why are the funds dwindling to address this serious challenge? The grants released under NAFCC fell from ₹350 crore in 2015-16 to ₹27.76 crore in 2022-23, while the sub-committee of the Ministry of Finance estimates the cumulative expenditure for adapting to climate change at ₹ 85.60 lakh crore by 2030.

Research and development is the bedrock of climate resistance agriculture but the minuscule investments in R&D impede the ability of science and technology research to tackle multiple challenges. As per the Indian Council of Agriculture Research, around 85 per cent of their budget goes towards salaries and other administrative/establishment expenditures, with little left for research. The same is with state agriculture universities facing a financial crunch for R&D work. The total R&D expenditure in India as a percentage of agricultural GDP has been

Importance of being Dr BR Ambedkar



Our true homage on his jayanti would be to resolve to end poverty and ensure justice and equality for all by sharing national opportunities and facilities

or centuries, we as a nation struggled to cope with untouch-ability and caste-based discrimination. Such inhuman practices demeaned a vast section of Hindus, who were categorized as untouchables. From time to time, great souls tried to salvage us from the repercussions of various social evils. Some of them were Sant Shiromani Ravidas, Sant Chokhamela, Sant Kabir Das, Swami Dayanand Saraswati, Swami Ram Krishna Paramhans and Sant Tukaram to name a few.

At the fag-end of the 19th century, a boy full of promises was enjoying his classroom teaching the school. One day he was made to sit at the back of the classroom when it was found that he was untouchable. Once he was travelling to his maternal uncle's village along with his brother and cousin. The cart man dropped them midway when he came to know that they were untouchables. One day the boy was going somewhere. In between, he stopped to drink water from

a public tap. He was beaten as untouchables were not allowed to use the facility.


The boy was none other than Dr Bhimrao Ramji Ambedkar, popularly known as Babasaheb Ambedkar, born to Ramji Maloji Sakpal, father, and Bhimabai Murbadkar Sakpal, mother, on April 14, 1891, in Mhow Army Cantonment. He was the 14th child of his parents. His tryst with social evils as worse as untouchability, caste-based persecution and discrimination during his childhood left an indelible mark on his life and thought process.

His own experience from the incidents in his life made him realize how deeply casteism, untouchability, insults and humiliation were rooted in Hindu society. Even the cruelty of fate did not spare him. He lost his mother when he was just six years old. Notwithstanding the trauma of discrimination and discrimination, he did not give up and continued his struggle and studies against all odds. It was an incredible example of exemplary grit, determination and a never-say-die spirit.

Dr Ambedkar did his matriculation in 1908 from Elphinstone High School. His father gave him good sanskar and used to share stories and thoughts of great saints like Tukaram, Gyaneshwar, teachings of the Ramayana and the Mahabharata. He studied Economics and Political Science at Elphinstone College. In 1912, he got a degree from Bombay University. With a scholarship from Maharaja of Baroda, he went to Columbia University, New York City where he got a Master's degree in June 1915 after successfully completing his thesis on 'Ancient Indian Commerce.'

In 1916, he went to the London School of Economics and worked on his doctoral thesis – 'The problem of the Rupee: Its Origin and its solution.' He took Rs 5000 as a loan from Chhatrapati Shahu ji Maharaj for his further studies. In 1920, received the D Sc from London University! He also went to the University of Bonn, Germany. In June 1927, he was awarded a Doctorate by the University of Columbia. He was a rare Indian politician of his time who studied at Columbia University, LSE and the University of Bonn.

Dr Ambedkar was worried about the fate of poor people, and untouchables. Dr Ambedkar wanted them to be independent. He established the Depressed Classes Society under the presidency of Baroda Maharaj. In 1920, he started The Mooknayak, a Marathi publication that enabled him to criticize the rigid Hindu



f paramount importance! After completing his studies and defying all hardships, Dr Ambedkar dedicated his life to the cause of the downtrodden, their emancipation and empowerment. Hence, the struggle became an integral part of his life. In 1927, Dr Ambedkar led a peaceful agitation by drinking water from Chowdar tank in Mahad, Raigad district in Maharashtra along with thousands of his followers when untouchables were not allowed to access water from the tank despite a 192 resolution moved by CK Bole and adopted by the Bombay government, allowing all untouchables to use public watering places, wells and Dharamshala, which were maintained through public funds.

Dr Ambedkar led a movement on March 3, 1930, to secure the entry of all Hindus to Kalaram temple in Nasik. He was in favour of a complete overhauling of Hindu

society and Hindu theology and securing equal rights for all Hindus. He was a votary of inclusivity. Casteism and untouchability go against the spirit of Hinduism, the Vedas. Its essence lies in quality, justice, fraternity and brotherhood. He was surprised that Hinduism is so accommodating and yet treats a vast chunk of Hindus as untouchables, even worse than animals. This was his pain. He was not inimical

utva. He had resentment against Hinduism but he was not opposed to Hinduism. His acceptance of Buddhism on October 14, 1956, is a case in point as Buddhism is very much rooted in Bharatiya culture. He did not embrace any other religion though Islamic and Christian scholars tried their best to influence him. It is said that when Dr Ambedkar met Mahatma Gandhi during the second Round Table Conference, he told him that he could not accept a religion that treats humans as cats and dogs, and he will embrace a religion that is less harmful to Hinduism.

The versatility of Dr Ambedkar's personality was matchless. His ability to listen to his critics was simply brilliant. Notwithstanding his differences with Veer Savarkar and Mahatma Gandhi on a number of issues, they were unanimous in their views of achieving the goal of social equality and freeing society from abominable evils such as untouchable. Dr Ambedkar did never support armed struggle but always favoured unity among oppressed social groups to get their socio-political and economic rights. He wanted downtrodden and oppressed sections of society to stay united and acquire knowledge and education so that they are not oppressed.

As the architect of our Constitution, Dr Ambedkar has given us the mantra and roadmap to build a stronger, healthier and more inclusive society. His commitment to the cause of social equality and social justice is a guiding force for all those who are part of public life. He is not only the leader for the oppressed and depressed. He is the leader of 135 crore people in our country - India. He was a true nationalist leader, a true patriot. He has achieved an eternal place in people's hearts. His contributions cannot be estimated but can only felt and lived by all.

Our true homage to Dr BR Ambedkar on his Jayanti would be to resolve to end poverty and ensure justice and equality for all by sharing national opportunities and facilities. We have rejected untouchability but still, a lot needs to be done to end social disparities in totality. Those who are deprived have to be holistically empowered.  $Y^{\mbox{\scriptsize et}}$ another omission, this time removal of references to freedom fighter and India's first Education Minister Maulana Abul Kalam Azad from the new class 11 political science textbook by the National Council of Educational Research and Training (NCERT), has invited sharp reaction from the Opposition parties.

While Congress lashed out at the Government saying there is a concerted attempt to "rewrite" history and pass on a "distorted legacy built on lies", CPI(M) alleged that such 'vengeful rewriting of history" is aimed at creating a false nar-rative to further the RSS' "ideological projects".

The NCERT has, however, claimed that no curriculum trimming has taken place this year and the syllabus was ratio-



As part of its "syllabus rationalisation" exercise last year, the NCERT, citing "overlapping" and "irrelevant" as reasons, dropped certain portions from the course including lessons on Gujarat riots, Mughal courts, Emergency, Cold War, Naxalite movement, among others from its textbooks. The rationalisation note had no mention of any changes in class 11 political science text"Certain changes not find-ing mention of in the rationalised content book could be an 'oversight," NCERT Director Dinesh Saklani reiterated.

In the class 11 political science textbook's first chapter, titled 'Constitution - Why and How, a line has been revised to omit Azad's name from the constituent assembly committee meetings. The revised line now reads, "Usually, Jawaharlal Nehru, Rajendra Prasad, Sardar Patel or BR Ambedkar chaired these Committees.'

In the tenth chapter of the same textbook, titled "The Philosophy of the Constitution", the reference to Jammu and Kashmir's conditional accession has also been deleted.

"For example, the accession of Jammu and Kashmir to the Indian union was based on a commitment to safeguard its autonomy under Article 370 of the Constitution," says the dropped paragraph.

Tender apology for anti-judiciary remarks: SC orders Lalit Modi

 $T^{he\ Supreme\ Court\ on}_{Thursday\ came\ down\ heavily\ on\ ex-IPL\ commissioner}$ Lalit Modi over his remarks against the judiciary made in social media posts and directed him to tender an unconditional apology on social media platforms and national newspapers. Delhi HC speeds up appeal process in 2G scam cases

Speeding up the appeal process in 2G scam cases, the Delhi High Court on Thursday asked the CBI, ED, former Telecom Minister A Raja and others to file their submissions in the appeals challenging the acquittal by the trial court. Justice DK Sharma said the parties shall file brief written submissions not exceeding five pages. The CBI demanded day-to-day hearings and its counsel urged the court to list the matter on an early date when he would argue on the aspect of granting leave to appeal, the judge fixed the matter for May 22 and 23.

The CBI and ED filed appeal against the trial court's verdict acquitting all accused persons on March 2018, five years ago. There were 95 list-ings and seven judges presided on the appeal process. At one point Justice Najmi Waziri in mid 2018, fined some accused for delaying the process and ordered them to plant 16,000 trees at Delhi Ridge forest area.

"The matter requires urgent hearing. Fix anytime of the day for conducting day-today hearing in the matter," the CBI counsel submitted. Though the CBI had earli-

er concluded its submissions on the issue of leave to appeal, it will have to argue the matter afresh due to change of the Leave to appeal is a formal

permission granted by a court to a party to challenge a decision in a higher court.

Earlier, the case was being heard on a day-to-day basis by Justice Brijesh Sethi, who retired on November 30 and had released the matter from his board on November 23 owing to paucity of time. Before retiring, Justice Sethi had decided various petitions and applications filed by the acquitted individuals and firms in the three cases arising out of the 2G scam probe lodged by the CBI and ED.

told reporters from inside a police van. In an apparent reference to Atiq Ahmad, Speciāl Director General (Law and Order) Prashant Kumar said there were intelligence inputs that the convoy bringing the accused might be attacked to free

On Thursday, police said an STF team led by two deputy superintendents of police reached Badagaon area in Jhansi district after getting information about the gangsters. Asad and Ghulam, who carried a reward of Rs 5 lakh each, had tried to flee on a motorcycle, police said. They opened fire at the STF team when it surrounded them and the policemen retaliated, accord-

ing to Kumar. The officer said a British Bulldog revolver and a Walther pistol were recov-

ADG (STF) Amitabh Yash said, "We knew that they had foreign weapons. We were ready. The way this gang killed Umesh Pal and his two gunners, it was not easy to catch these accused. Both had British Bull Dog revolver and Walther pistol. These weapons are rare."

Visuals showed two bodies lying beside a motorcycle at the site of the alleged encounter. An ambulance later took them to the Jhansi Medical College for postmortem examination.

With Thursday's encounter, in con-

Japan to counter China with like-minded countries Pak SC halts bill to

Tapan has unveiled a new plan to provide "like-minded" countries especially in Asia with military aid as it looks to expand its influence in the Indo-Pacific region to counter China's aggressive push over Taiwan and the South China Sea issues.

The guidelines announced by Tokyo early this month included a new programme to strengthen the militaries of likeminded countries by providing "official security assistance" - a move that breaks with its previous policy of avoiding the use of development aid for military purposes other than disaster relief, the Japan Times reported.

Japanese Foreign Ministry officials said the Philippines will be one of the first beneficiaries of Overseas Security Assistance (OSA), with Malaysia, Bangladesh and Fiji also among those being considered, the report said.

Japan, a member of the

US, India and Australia, is actively pursuing the Indo-Pacific strategy which China claims aimed at countering its

Tokyo's decision to use international aid for military purposes is a 'paradigm shift' but won't lead to an arms race in Asia, the Hong Kong-based South China Morning Post reported on Thursday.

The move will not only build up the defence capabilities of Asian nations amid changing security dynamics, but boost the competitiveness of Japan's defence sector, it said.

China rolls out new wartime military recruitment rules

Beijing (PTI): China has released a new set of revised rules for military recruitment in wartime, including giving pri-ority to the veterans, drafting high-calibre soldiers and optimising conscription procedures, which an analyst described as combat readiness for a war over Taiwan.

A set of revised rules regarding military recruitment has been released by the State Council and the Central Military Commission (CMC) the high command of the Chinese military headed by President Xi Jinping - aiming to provide institutional guarantees for consolidating national defence and building strong armed forces, state-run Xinhua news agency reported on

tion, with 74 articles in 11 chapters, focuses on recruiting more high-calibre soldiers, standardising and optimising conscription procedures, and improving the system's efficiency, it said in a brief report. The new rules will come into

effect next month.

The regulations said recruitment should "focus on recruitment should focus on preparing for war" and increase efficiency by calling up "high calibre" recruits, the Hong Kong-based South China Morning Post newspaper reported. For the first time, a separate chapter on wartime recruitment has been included in the regulations, which state that ex-servicemen would be prioritised and expected to join their original units or similar

This was the first visit by the Japanese Foreign Minister to China since 2019.

China and Japan have a long-festering dispute over uninhabited East China Sea islands controlled by Japan but claimed by China. The islands are known as

the Senkakus by Japan, while China named them as Diaoyu. Taiwan also claims the

islands but has forged agreements with Japan to avoid any conflict as Tokyo maintains close defence ties with Taipei. The purpose of Tokyo's new

initiative is to "contribute to the creation of a desirable security environment for Japan," while maintaining Japan's "basic principles as a peaceful nation," according to the Japanese ministry statement.

The OSA is being presented as an expansion of Japan's official development assistance (ODA) - one of the world's largest foreign aid programs - to cover projects "for the benefit of organisations," the Japan Times report said.

The new framework was revealed as Tokyo moves away from a strict non-military approach to ties with its neighbours and looks to realise its vision of a Free and Open Indo-Pacific (FOIP), it said.

According to its fiscal 2023 budget, the Japanese govern-ment has set aside two billion Japanese Yen (USD15 million) for OSA. Funding will be separate from the Yen 570.9 billion in economic and social development assistance that Tokyo provides to developing countries.

While this year's modest OSA budget appears largely symbolic, especially compared with the ODA funds, experts say the decision to launch the program is significant, as it marks another step in Japan's march toward a more robust and proactive defence posture that could ultimately allow it more leeway in defence transfers, Japan Times

limit CJ's powers

Ignoring calls to stop interfering in the domain of parliament, Pakistan's Supreme Court on Thursday stopped operationalisation of a bill aimed at clipping the powers of the chief justice.

The lawmakers on Monday passed for the second time the Supreme Court (Practice and Procedure) Bill 2023 to dilute chief justice's power to take suo motu action and form a panel of judges for hearing of cases.

An eight-member bench headed by Chief Justice Umar Ata Bandial held the first hearing of at least three petitions challenging the bill which is yet to become a law because President Arif Alvi has not endorsed it. However, it would become a law even without Alvi's signature next week after passing of ten days since it was passed by the par-

The bench observed that prima facie the proposed law infringed the powers of the apex court to frame its own rules and it merits a hearing by the court.

The court in its order after hearing stated that any intrusion in its practice and the procedure, even on the most tentative of assessments, would appear to be "inimical to the independence of the

judiciary, no matter how innocuous, benign or even desirable the regulation may facially appear to be".

"It is therefore hereby directed and ordered as follows. The moment that the bill receives the assent of the president or (as the case may be) it is deemed that such assent has been given, then from that very moment onwards and till further orders, the act that comes into being shall not have, take or be given any effect nor be acted upon in any manner," the court stated.

The bench also issued notices to the political parties, the federal government, Attorney General, Pakistan Bar Council (PBC), the Supreme Court Bar Association of Pakistan and other respondents in the case.

Later, the proceedings were adjourned till May 2.

Earlier in the day, representatives of the political parties which are part of the coalition government criticised the court for scheduling the hearing of petitions against the bill.

Separately, the parliament passed a resolution calling for the dissolution of the eightjudge larger bench. The resolution tabled by the Pakistan Peoples Party lawmaker Agha Rafiullah was approved by a majority vote.

Norway expels 15 Russian diplomats for 'spying'

Norway's government said Thursday that it was expelling 15 Russian diplomats from the country, saying they were suspected of spying while working at the Russian Embassy in Oslo. Foreign Minister Anniken Huitfeldt said the move was "an important measure to counter and reduce the scope of Russian intelligence activities in Norway, and thereby secure our national inter-

The Russians declared persona non grata "must leave Norway within a short time," Huitfeldt said, adding: "We will not grant visas to intelligence officers who apply for a visa to Norway."

The minister declined to say whether the government was acting in response to a specific incident, referring questions to Norway's domestic security agency PST for details. The government said the activities of the expelled diplomats were "incompatible with their diplomatic status."

'We are not talking about regular diplomats, but intelligence officers under diplomatic cover. Their activities are a threat to Norwegian inter-

The Russian Foreign Ministry said Moscow would respond in kind to Norway's action, Russia's Tass and RIA Novosti news agencies reported. Huitfeldt reacted during an afternoon news conference, saying: "Russia has no reason to respond. We have Norwegian diplomats stationed in Russia, but none of them are undercov-

er intelligence officers." She called Russia "an unpredictable neighbor" and "many European countries in the past year have expelled hundreds of Russian intelligence officers under diplomat-

At the same time, she stressed that the government in Oslo wants "normal diplomatic relations with Russia, and that Russian diplomats are welcome in Norway'

"We do not want people who claim they are diplomats and who are actually are intelligence officers," she said. "We cannot accept that."

NATO-member Norway has a 198 kilometer-long (123-mile) border with Russia in the Arctic. Norwegian newspaper VG said expulsions would reduce the number of staff members at the Russian missions in Norway - the embassy in Oslo and the consulates in Kirkenes and Barentsburg from about 40 people to about 25.

Barentsburg, which is located on the remote Arctic archipelago of Svalbard, is a Russian coalmining town of about 500 people. Under a 1920 treaty, Norway has sovereignty over the archipelago but other signatory countries have rights to explore its natural resources.

A year ago, Norway expelled three Russian diplomats it identified as intelligence officers.

A man whom the Norwegian Police Security Service alleged used a false name and identity while actually working for one of Russia's intelligence services also was arrested last year. He is awaiting trial in Norway.

Ukraine stands firm on Crimea

Ukraine's foreign minister said Thursday his country wouldn't budge from its demand that Russia withdraw its forces from Crimea, as well as from other parts of Ukraine that Moscow illegally annexed more recently. Calling the war in Ukraine "a bleeding wound in the middle of Europe," Foreign Minister Dmytro Kuleba said all his country's territory must be treated equally in dealing with the Kremlin after its full-scale invasion more than 13 months ago. "We are united by UN

charter principles and the shared conviction that Crimea is Ukraine and it will return under Ukraine's control," said Kuleba, speaking by video link to a gathering in the Romanian capital, Bucharest.

"Every time you hear anyone from any corner of the world saying that Crimea is somehow special and should not be returned to Ukraine, as any other part of our territory, you have to know one thing: Ukraine categorically disagrees with these statements," he said at the Black Sea Security

The Kremlin wants Kyiv to acknowledge Russia's sovereignty over Crimea and also recognise September's annexation of the Ukrainian provinces of Donetsk, Kherson, Luhansk, and Zaporizhzhia. Ukraine has rejected those demands and won't hold talks with Russia until Moscow's troops pull back from all occupied territo-

Though there is no sign of possible peace talks, the two countries have sporadically exchanged prisoners of war and have engaged in a wartime deal for the export of Ukrainian grain and Russian grain and fertilisers. The grain deal has helped ease concerns about the global food supply, especially to countries in Africa, the Middle East and parts of Asia where many are already struggling with hunger. The agreement, which was

brokered by the UN and Turkiye last July is delicate, however, and has been the subject of repeated threats by Moscow to end it.

Russia agreed last month to extend the grain deal for 60 days — instead of the 120 days set under a previous extension — to send a warning signal to

Sweden shuts down Pak embassy

Islamabad (PTI): Sweden has announced closing its embassy in Pakistan "indefinitely" due to the prevailing "security situation" in the crisis-hit country's capital. The embassy did not elaborate on the nature of the threat, but Pakistan's political situation is getting worse amid growing tension between the government and the Supreme Court. Pakistan's Supreme Court was hearing a petition to annul a bill aiming at curbing the powers of the chief justice to form panels of his choice for different cases. "Due to the current security situation in Islamabad, the Embassy of Sweden is closed

The Migration Section is not, at the moment, able to handle requests of any kind," a notice on the embassy's website reads. "Also, we cannot send any documents to our consulates, Gerry's, or to your home address. We understand that this will cause inconvenience. However, the safety of our applicants and staff members is of the highest priority," it said.

The notice also stated that any questions regarding the reopening

of the mission cannot be answered at the moment.

Many believe the decision was linked to the recent incident of the burning of the Quran in Sweden. A Danish-Swedish far-right extremist burned a copy of the Quran in front of the Turkish embassy in Stockholm on January 21 under the protection of Swedish police, drawing condemnation from Muslims worldwide.

Seoul (South Korea): North Korea on Thursday conducted tic missile launch in a month, possibly testing a new more mobile, harder-to-detect missile for the first time, its neighbours said, as it extends its provocative run of weapons tests.

Lahore (PTI): An anti-terrorism court in Pakistan on Thursday extended interim bail to Imran Khan till May 4 in three cases related to the clashes between his supporters and the police during an operation to arrest the former premier in the Toshakhana corruption case last month. Laĥore's Anti-terrorism court (ATC) granted one-time permission to Khan, the chairman of the Pakistan Tehreek-e-Insaf (PTI), to appear for the hearing via video link in the case. Khan had filed petitions for bail in three FIRs registered with the Race Course police station under anti-terror laws.

Khan, 70, has been repeatedly claiming that his life is under threat because of which he was abstaining from attending court hearings. ATC judge Ejaz Ahmad Bhutta asked Khan's lawyer Salman Safdar what he had done for which he was facing threats to his life. To this, Safdar said those who were behind a gun attack on his client (in last November) could answer this."If Imran Khan is assassinated Pakistan will descend into chaos like what had happened after the murder of former premier Benazir Bhutto," he said.

There are credible reports that Mr Khan can be targeted by snipers on his way to courts and these can be verified from the law enforcement agencies," he said. In November last year, Khan survived an assassination attempt on his life. After hearing arguments, the judge allowed Khan to mark his attendance in court through a video link and extended his pre-arrest bail till May 4, a court official said. The Lahore police had booked Khan and hundreds of his party workers in three terrorism cases during clashes with police last month in an operation to arrest him in the Toshakhana case.

Khan has been in the crosshairs for buying gifts, including an expensive Graff wristwatch he had received as the premier at a discounted price from the state depository called Toshakhana, and selling them for profit.

NY fraud lawsuit: Trump set to give 2nd deposition

New York (AP): Former President Donald Trump was expected to visit the offices of New York's attorney general Thursday for his second deposition in a legal battle over his company's business practices.

The Republican was scheduled to meet with lawyers for Attorney General Letitia James, who sued Trump last year. Her lawsuit claims Trump and his family misled banks and business associates by giving them false information about his net worth and the value of assets such as hotels and golf courses. The lawsuit is unrelated to the felony criminal charges filed against Trump by the Manhattan district attorney, which led last week to his historic arraignment, the first for a former president.

Trump and his lawyers have said the Democrat's lawsuit against him is politically motivated and legally baseless. He and the company have denied doing anything wrong. James declined to answer a question about the planned deposition at a news conference on an unrelated matter sition.

Trump previously met with James' lawyers Aug. 10 but refused to answer all but few procedural questions invoking his Fifth Amendment protection against self-incrimination more than 400 times.

"Anyone in my position taking the Fifth Amendment would be a fool, an absolute fool," he said in the session, which was recorded on video and later released publicly. Trump predicted a renegade" prosecutor would try to make a criminal case out of his answers, if he gave them. "One statement or answer that is ever so slightly off, just ever so slightly, by accident, by mistake, such as it was a sunny, beautiful day, when actually it was slightly overcast, would be met by law enforcement at a level seldom seen in this country, because I've experienced it," he said. A trial for the lawsuit is sched-

uled for October. It is unclear whether Trump might answer any questions in his second depo-

Petersburg cafe. Vladlen Tatarsky, 40, an ardent supporter of the war in Ukraine who filed regular reports on the fighting from the front lines, was killed on April 2 as he led a discussion at a riverside cafe in the historic heart of St. Petersburg, Russia's secondlargest city. Over 50 people were injured.

26-year-old St. Petersburg resident, Darya Trepova, who was seen on video moments before the blast presenting Tatarsky with a statuette that contained explosives, was quickly arrest-

According to Russian media reports, Trepova told investigators she was asked to deliver the statuette but didn't know what was inside it.

Syria, Saudi move toward restoring embassies, flights

Syria and Saudi Arabia are moving toward reopening embassies and resuming flights between the two countries for the first time in more than a decade, the countries said on Thursday in a joint statement. The announcement followed a visit by Syria's top diplomat to the kingdom, the first since Saudi Arabia cut off diplomatic relations with Syria

Syria was widely shunned by Arab governments over Syrian President Bashar Assad's brutal crackdown on protester,s and later civilians, in an uprising turned civil war that began in 2011.

The breakdown in relations culminated with Syria being ousted from the Arab League. However, in recent years, as Assad has consolidated control over most of the country, Syria's neighbors have begun to take steps toward rapprochement.

The overtures have picked up pace since the massive February 6 earthquake in ed that Syrian Foreign



Chinese-brokered reestablishment of ties between Saudi Arabia and Iran, regional rivals that had backed opposing sides in the Syrian conflict.

A delegation headed by Syrian Foreign Minister Faisal Mikdad, at the invitation of Saudi Foreign Minister Faisal bin Farhan Al Saud arrived in Saudi Arabia on Wednesday for talks about bilateral relations between the two countries, state media from the two

countries reported. Saudi state media report-

Minister Faisal Mikdad was received by the kingdom's Deputy Foreign Minister Waleed Al-Khuraiji.

The meeting focused on the steps needed to reach a "comprehensive political settlement of the Syrian crisis that would ... achieve national reconciliation, and contribute to the return of Syria to its Arab fold," the two countries said in a joint statement.

Saudi Arabia is hosting the next Arab League summit in May, where a restoration of Syria's membership is widely expected to be on the table.

Khawaja Asif warns of striking TTP hideouts in Afghanistan

Pakistan's Defence Minister Khawaja Asif has warned Afghanistan's Taliban rulers about targeting terrorist hideouts inside the war-torn neighbouring country if the latter were unable to rein in anti-Pakistan militants.

He had earlier said that the banned Tehreek-e-Taliban Pakistan (TTP) were using Afghan soil for carrying out attacks in Pakistan.

In an interview with Voice of America, the defence minister said that in his visit to Afghanistan in late-February, he reminded the Taliban administration to live up to their cross-border security commitments forbidding terrorists from using Afghan soil to plan and conduct attacks on Pakistan or Islamabad will take action, Dawn newspaper

reported on Thursday.

"We have communicated to Kabul during our last visit that please, as our neighbours and brothers, whatever is emanating from Afghan soil is your responsibility," he said.

"If that is not done, at some point we'll have to (...) resort to some measures, which will definitely - wherever (terrorists) are, their sanctuaries on Afghan soil - we'll have to hit them," he said. "We'll have to hit them because we cannot tolerate this situation for long."

Asif went on to say that the Afghans responded to this "really well". "They responded well, really well. Perhaps for them to disentangle the TTP from this stage - of course they want to disentangle, this is my impression [that] they want to disentangle — but this disentanglement, perhaps, will take time. "But they are doing well and we wish them well and we don't want to get into a situation where this situation with the [TTP] escalates and we do something that is not to the liking of our neighbours and brothers in Kabul."

During the interview, Asif was asked whether he believed the Taliban's claim that the TTP were not using Afghan soil to carry out attacks in Pakistan. "They still operate from their soil," he replied.

That the two wins have come without any significant contribution from their star power-hitter Andre Russell and skipper Nitish Rana, make them an even more dangerous side.

It is too late to change action: Bishop's advice to Bumrah

Comeone who has endured Smultiple back injuries himself, former West Indies fast bowler Ian Bishop can imagine what a "generational" talent like Jasprit Bumrah is going through at the moment. The 29-year-old underwent

a surgery in New Zealand last month following recurring back issues that have kept him away from the game since September Bumrah is now racing against time to get fit for the ODI World Cup at home in October-November.

Zhang Hanmin: composing a "symphony" of tiedyeing and coffee

Zhang Hanmin, a 39-yearold tie-dye artist, repeatedly soaked a silk scarf in a dyestuff of ochre-colored coffee grounds while adding Pu'er tea to it. She completed tie-dyeing the scarf in a matter of half an hour.

With spring flowers blossoming, Zhang brought her parents and eldest son to Shanghai. At an intangible cultural heritage-themed Starbucks outlet, she demonstrated the Bai people's tie-dyeing techniques-a national intangible cultural heritage item from Dali, Yunnan. Right in front of a group of coffee lovers, she also showed the unique dyeing and color-fixing effects of coffee grounds and Pu'er tea, composing a "symphony" of

tie-dycing and coffee. Tie-dyeing, originally known as "jiaoxie", is a set of Chinese textile dyeing techniques dating back ancient times, and Zhang's hometown-Dali City, Yunnan Province—is believed to be the birthplace of tie-dyeing. About a decade ago, Zhang set up the Lanxu tie-dyeing studio in the village, which has now opened chain storesdowntown Dali, Kunming, and other places, hiring more than 20 full-time employees and 168 part-time workers in

At the intangible cultural heritage-themed Starbucks outlet, Zhang was dressed in an exquisite ethnic costume. After demonstrating the coffee tie-dyeing techniques, she also taught a group of coffee lovers to try their hands on

Soon, these keen "apprentices" succeeded in producing their own tie-dyeing patterns, such as cloud, pearl, and fish scale patterns.

Zhang explained that


she has named her studio "Lanxu" because she hopes to pass on the "Dali blue" deeply rooted in her memory. "After my grandmother, who took care of me since I was a child, passed away, the dusty loom in her house kept reminding me that if we young people don't work hard to inherit, the tie-dyeing techniques would be lost forever. I felt a strong sense of urgency," Zhang recalled.

About a year ago, Starbucks China joined hands with a Chinese public interest organization in launching the "Starbucks Future" project to empower rural women, pass on intangible cultural heritages, and promote rural development. The project has given Zhang opportunities to travel around the country and better promote the Dali Bai people's tie-dyeing techniques.

"We can dye fabries blue with Baphicacanthus cusia, pink with Caesalpinia sappan, yellow with gardenia fruit, onion skin, and turmeric, yellow-green with pomegranate skin, brown with walnut skin, and light brown with coffee grounds and Pu'er tea leaves. The silk scarfs tie-dyed in this way are not only beautiful but also convey environmental protection concepts such as recycling and reuse," Zhang said.

At 6:00 am, workers at the plantation base of Yunnan Shenchuang Vegetable Cultivation Co Ltd are busy harvesting baby cabbages with lights on head and knives in hand. The Shenchuang baby cabbages will be served on the dining tables in Beijing. Shanghai, Shenzhen and Guangzhou in two days. Carried by cold chain trucks, they will also be sold to ASEAN countries like Vietnam, Thailand, Malaysia and Singapore.

With great weather, Yunnan province is one of the main vegetable producers in China. Various ecological vegetables of high quality are produced here all year round.

At present, Yunnan sells 70% of its vegetable products to more than 150 cities and 40 countries and regions via diverse distribution channels. Thus, Yunnan is becoming the "vegetable garden" for China, and even for the world. According to statistics from Kunming Customs, the export volume of Yunnan vegetables has reached 116,300 tons in the first two months this year with a year-on-year increase of 25,78%.

"In recent years, our vegetables can retain freshness through professional cold storage method, and they can be sold smoothly," said Guo Wang, the General Manager of Shenchuana

al Manager of Shenchuang. Now a China-Laos-Thailand freight train is available for transporting Yunnan vegetables. Compared to the fragmented transport of railway and road in the past, the new transport mode has cut the transport duration by one day and reduced the cost by more than 20%.

With the multiple effect from RCEP, Yunnan will build new channels for cold chain transport of higher efficiency and stability, and its vegetable sales enjoy a promising future.
