Asserting that the world does not have much time to correct the mistakes of the last century, Prime Minister Narendra Modi on Friday announced a "Green Credit Initiative" focused on creating carbon sinks through people's participation and also proposed to host the UN climate conference in 2028, or COP33, in India.

Addressing the high-level segment for heads of state and governments during the UN climate conference (COP28) here, Modi called for a proplanet proactive and positive initiative and said the Green Credits Initiative goes beyond the commercial mindset associated with carbon credits.

"It focuses on creating carbon sinks through people's participation and I invite all of you to join this initiative," he said, stressing the world does not have much time to correct the mistakes of the last century.

This initiative is similar to the Green Credit Programme, notified domestically in October. It is an innovative market-based mechanism designed to reward voluntary environmental actions in different sectors by individuals, communities and the private sector.

Asserting that India has presented a great example to the world of striking balance between development and environment conservation, the Prime Minister said, India is among the only few countries in the world on track to achieve its Nationally Determined Contributions or the national

Modi was the only leader to join COP28 President Sultan Al Jaber on the stage along with the UN Climate Change Executive Secretary Simon Steill at the opening plenary. "Over the past century, a small section of humanity has indiscriminately exploited nature. However, the entire humanity is paying the price for this, especially people living in the Global South," he said.

Thinking only about our own interests will only lead the world into darkness," the prime minister added

Modi's statement came in the context that the poor and developing nations bear the brunt of extreme climate events such as floods, droughts, heat/cold waves as a result of changing climate due to historic carbon emissions by the richer countries that have led to

increased global warming. The Prime Minister called for maintaining a balance between mitigation and adaptation and said that energy transition across the world must be "just and inclusive." He also called rich countries to

transfer technologies to help developing nations combat cli-

mate change. Modi has been championing the Lifestyle for Environment (LiFE movement), which he had announced at the Glasgow COP in 2021), urging countries to adopt planet-friendly living practices and move away from deeply consumerist behaviour. Citing a study by the International Energy Agency, Modi said, "This approach (LiFE) can reduce carbon emissions by 2 billion tonnes." He called on the countries to work together and be decisive

against the climate crisis. "We shall cooperate with each other and shall support each other. We need to give all developing countries our fair share in the global carbon budget," said the Prime

If India's proposal to host

the next big global conference in the country after the G20 Summit earlier this year. India hosted COP8 in New

Delhi in 2002 where countries adopted the Delhi Ministerial Declaration which called for efforts by developed countries to transfer technology and minimise the impact of climate change on developing coun-Rich nations should complete-

ly reduce their carbon footprint "well before" 2050, Prime Minister Narendra Modi said on Friday while calling on the world to deliver a concrete outcome on finance to help developing and poor nations combat climate change. Climate science defines carbon

budget as the amount of greenhouse gases that can be emitted for a given level of global warming (1.5 degrees Celsius in this case).

Developed countries have already consumed more than 80 per cent of the global carbon budget, leaving developing and poor countries with very little carbon space for the future. Modi highlighted that India is home to 17 per cent of the world's population, but its share of global carbon emissions is less than 4 per "India is one of the very few

economies in the world that is on track to achieve its NDC targets," he said.

India achieved its emissions intensity-related targets 11 years ahead of the committed time frame and non-fossil fuel targets nine years ahead of

### **Bengaluru** hit by bomb threat fied," he told reporters.

 $S_{\mathrm{in}}$  and around the city on Friday received emails warning of bomb threat on their premises, triggering panic among the staff and parents, police said. The school authorities immediately alerted police, who reached the institutions concerned with the bomb disposal squads and anti-sabotage check teams, they said, while indicating the bomb threat could be a hoax. Karnataka Chief Minister

Siddaramaiah said he has asked police to seriously investigate the e-mail and its source, and provide adequate security to schools and temples as a precautionary measure.

State Home Minister G Parameshwara said the message had come from an email id "kharijites@beeble.Com," saying bombs have been placed in the schools in Bengaluru and threatened to kill children and

"We are seriously verifying it and its source. I have spoken to the Commissioner and officials and have given the necessary instructions and verification on whether it is true or hoax and measures to be taken accordingly. We will verify as to who is behind it and if there is an involvement of any terrorist organisation, and take measures accordingly. For now, it cannot be said who is behind it. The message in the email asks people to convert and other things--it will be veriAmong 68 schools which received the bomb threat, 48 of them are located within the

city while the rest are in Bengaluru Rural limits, police added. The students and staff were immediately evacuated from the school premises, police

said, adding no suspicious objects were found yet and prima facie, it looks like a hoax City Police Commissioner B Dayananda said bomb detection and disposal squads were sent to all these schools, and most likely it seemed to be a hoax. "Earlier also similar threat letters and emails had

come to schools and they were found to be a hoax for mischief and police had identified those behind it. Police are verifying today's mails too...Officials and personnel have gone to all these spots. I appeal to people not to worry, as most likely all these are hoax calls (mails)," he Another senior officer said

the police teams have not found any suspicious objects on any of the school premises. "Prime facie, it appears to be a hoax message. We are also in the process of registering a case in this regard and a thorough investigation is underway. Students had already reached schools when they got to know about the email threat. Panicstricken parents rushed from their respective offices and homes to get their children back home safely.

# 8 killed, 12 injured as van rams into parked truck

Victims, members of two families, were coming for Tarini

darshan

Light persons were killed and 12 others critically injured when a van by which they were travelling rammed into a stationary truck on National Highway-20 near Balijodi in Keonjhar district, just a few kilometers from the Maa Tarini temple in the wee hours of Friday.

The van with 20 persons on board was on its way to the Maa Tarini shrine in Ghatagaon from Digapahandi in Ganjam when the mishap occurred. The travellers had to have darshan of the goddess.

While seven passengers of the van died on the spot, one other succumbed in the hospital.

As per reports, the deceased



and the injured were from two families from Podamari in Digapahandi. Some deceased were relatives of former Rajya Sabha MP Renubala Pradhan.

The injured were initially admitted to the Ghatagaon hospital. Later, they were shifted to the SCB Medical College Hospital in Cuttack after their conditions deteriorated.

While the exact reason behind the accident was yet to be ascertained, it was suspected that the driver who was speeding on the highway lost

sight of the parked truck and hit it from the rear.

The accident was so severe that the van turned into a mangled heap. Ghatagaon SDPO Surashan

Gangai, who reached the spot, said, "The members of two families Digapahandi were on their way to have Maa Tarini's darshan. The van came at a high speed and hit a parked truck from behind. We will take steps to stop trucks from

parking on the road."

Expressing grief over the

Saccident, Chief Minister Naveen Patnaik announced an ex-gratia of Rs 3 lakh for the next of kin of each deceased. The amount will be provided from the Chief Minister's Relief Fund.

Besides, the CM also declared free treatment for the injured persons.

Ironically, the serious accident took place on the first day of the 'Zero Fatality Week' being observed by the State Government for embracing safety driving practices and safer roads.

## Rs 220-cr cocaine seized from ship in Paradip

he Odisha police, Central Industrial Security Force (CISF) and custom officials on Thursday night seized 22 packets of cocaine worth a market value of Rs 220 crore from a cargo ship anchored at the Paradip Port.

According to customs officer Madhab Chandra Mishra, the cocaine packets were recovered from the ship MV

"We had concrete intelligence inputs about cocaine being carried in the ship. During raids, we found it was hidden under a magnate plate," said Mishra.

The seized contraband, weighing about 20 kilograms, was sent for testing to the State Forensic Laboratory in Bhubaneswar, Later, the test results revealed that the "pow-



der-like" substance in the form of cakes was indeed cocaine and was being smuggled.

As per reports, the ship arrived at Paradip from Indonesia's Gresik port and was scheduled to depart for Denmark carrying steel plates from Odisha.

However, a crane operator first noticed some suspicious packets in the vessel and informed the authorities who came with a dog squad and

seized the packets.

At first, the packets looked like an explosive device. But after the officials scanned the packets, it was revealed that it was drugs concealed in small rectangular packets.

# Depression forms over Bay of Bengal

Storm likely by Dec 3; no warning for Odisha

The well-marked low pressure over south-east Bay of Bengal (BoB) has concentrated into a depression at 5:30 am on Friday over south-east and adjacent south-west BoB, said the India Meteorological Department (IMD) on Friday.

The system is currently at about 790 km east south-east of Puducherry and 800 km south-east of Chennai. It is likely to intensify further into a deep depression and later into a cyclonic storm on Decem-

The cyclonic storm is likely to cross south Andhra Pradesh adjacent to Tamil Nadu coast on early December 4 morn-

While no warning has been issued for Odisha, light to moderate rain or thundershower is very likely to occur in the districts of Malkangiri, Koraput, Rayagada, Gajapati, Ganjam the districts of coastal Odisha, Nabarangpur, Kalahandi, Nuapada, Kandhamal from December 3 to December 6

Under the influence of the cyclonic storm, squally wind speed reaching 40-50 kmph gusting to 60 kmph is likely to occur over southwest BoB from December 1 morning

buy some food. However, an altercation took place on November 5 and he held a grudge against Sasmita. He then purchased a knife from the shop of one Subash Sahu on November 6 evening and asked his friends to watch a sensational news on TV at 9 pm.

He then went to the spot and waited for the customers to leave. He attacked Sasmita with the knife when her husband left the stall to fetch water from a nearby tap. He fled the spot by taking a lift from a passerby and threw the knife on the way near a transformer. The weapon of offence has been seized and the accused was forwarded to court.

# 'One Nation One Election' not compatible with India's federal setup

**≺**hough the idea of One Na tion and One Election sounds good but it is very difficult to implement it under India's federal constitutional setup which enshrines multiparty democracy under a diverse, regional, political, social and cultural environment. The Constitution guarantees internal sovereignty to the States giving the States the law making power on the subjects enumerated in the State list. 'One Nation One Election', theory may not be compatible to constitutional values of dual polity, as both States and Union enjoy sovereign power distinctly assigned to them under the Constitution.

India being a Union of States, both the Chief Minister and Prime Minister are heads of their respec-

tive Government who have discretion to dissolve the respective legislature to call for fresh election, when the term of any House expires or when the Chief Minister or Prime Minister would decide to seek a fresh mandate from the people. The statutory life of a Legislature is five years and unless it is dissolved earlier due to defection or otherwise. In the circumstances extending or reducing tenure of a Legislature by statutory provision would invite multiple constitutional and political problems.

The concept of holding of simultaneous elections practically ended in a fiasco since the 70s due to manipulation of some national parties ruling at the Centre, as they engineered defections in opposition ruled State Legislatures, causing fall of the duly elected State Governments or breaking State Governments by misusing of Article 356, leading to midterm elections.

Therefore, the question that often crops up is why should the regional parties suffer for the wrongdoing of the national parties? Elections are fundamentally a prerequisite to elect distinctively for different Legislatures. With 1.4 billion populations of the country and diverse political, social and ethnic entities, multi phase election aims balancing the authorities between the Union and the States. Since different political parties often take reins of governance in States, separate elections give the voters a chance to build and shape local leaders that creates competitive and multi-tier leadership at regional level. One Nation One Election concept grossly is antithetical to regional aspirations, which would weaken regional parties and in all probability would undermine regional and cultural interests of the

States harming growth of balance

of power. To protect purity of the elections, there is a need to outlaw every kind of defections, a disease that has harmed the health of politics. Luring a legislator directly or indirectly to change the party should be treated as a criminal offence and a judicial clarity would be helpful to check the disease. The need of the hour is to change circumstances that have weakened multi-party system, stopping unwanted and frequent defections, and facilitating equitable opportunity to opposition/regional parties to raise election funds for their survival and taking other electoral reforms to prevent use of black money and muscle power.

Democracy has no alternative, as elections being fundamental it can-

not be valued in terms of money/ election expenditure. Pre election Model Code of Conduct may impede States taking up new project for three months, but it does not any way affects carrying on development works sanctioned during the earlier period of 4.9 years. In case, the Government is determined to adopt the One Nation One Election concept, the pros and cons of such a legislation including post legislation consequences should be examined threadbare to make it compatible to our constitutional philosophy. The matter needs wide consultations among political parties at length to arrive at a consensus before bringing the required legislative measures.

The frequent election is a manmade problem arising from defec-

tions which has undermined stability of the State Governments since 1967, and warranted midterm elections, for which neither the people nor the Constitution is responsible but those who misuse governance to engineer defection are responsible. Dr Ambedkar had remarked them as 'vile' in his concluding speech in the Constituent Assembly. In the present circumstances it would not be wise constitutionally to resynchronize the terms of the Legislatures by amending the Constitution as the same eventually would impede basic philosophy of constitutional federalism.

### **Govt trying to bring back** former Navy men from Qatar

**NEW DELHI** 

The Government is making all efforts to bring back eight former Indian Navy personnel sentenced to death in Qatar last month, Navy Chief Admiral R Hari Kumar said here on Friday. "We are working closely to ensure that their interests are looked after. The Government of India is putting all-out efforts to ensure they are brought back," Admiral Kumar said at a media briefing.

The Indian nationals were on October 26 given death sentence by Qatar's Court of First Instance. India described the ruling as "deeply" shocking and vowed to explore all legal options in the case.

An appeal has already been filed against the death sentence and a higher court in Qatar has already admitted the plea. The appeal has been filed by the legal team of the detained Indian nationals.



The Indian nationals, who worked with private company Al Dahra, were arrested in August last year reportedly in an alleged case of espionage. Neither the Qatari authorities nor New Delhi made the charges public against the Indian nationals.

In its reaction to the ruling by the Qatari court, the Ministry of External Affairs (MEA) last month said it is attaching "high

importance" to this case and is exploring all legal options. The charges were filed against the eight Indian navy veterans on March 25 and they were tried under Qatari law. All of the former Navy officers

had "unblemished stints" of up to 20 years in the Indian Navy and had held important positions, including that of instructors in the force, former military officials had said.

### UN body applauds domestic standards on millets

Indian millets are likely to dominate the global nutricereals platter soon with the Codex Alimentarius Commission (CAC), a UN food standards body applaud food standards body applauding domestic standards on millets at the same time accepting the Government's proposal for the development of international standards for the superfoods.

The Food and Safety Standards Authority of India's proposal for the development of global standards for at least 15 types of millets including finger millet, barnyard millet, kodo millet, proso millet and little millet as group standards as in the case of pulses was unanimously endorsed in the 46th session at FAO in Rome in Italy, said an official from the Union Health Ministry.

The meet is being attended by representatives from 161 member countries, including the European Union (EU), said the

official. The CAC, an international food safety and quality standard-setting body created by

the WHO and the Food and

Agriculture Organization (FAO) of the UN with 188 member countries, currently has standards for sorghum and pearl millet.

The Indian delegation led by FSSAI CEO G Kamala Vardhana Rao had proposed international group standards for millets not only considering that 2023 has been declared as the "International Year of Millets" but also reflecting on the growing international trade in these products, he said.

With the CAC endorsing the proposal, work on the submission of project documents and development of draft standards will now be initiated by India, he said dding that the move will set the benchmark in highlighting millet and its benefits worldwide. Presently, India is exporting

millets to 139 countries across the globe with export value at USD 64 million in FY 2021-22 while there has been an increase in export of millets by 12.5 % during April-December 2023 as compared to the same period last year.

The group standards on millets framed by the FSSAI for 15 types of millets, which specify eight quality parameters, including maximum limits for moisture content, uric acid content, extraneous matter, other edible grains, defects, weevilled grains and immature and shrivelled grains, will act as an important foundation for the development of global standards.

The existing Codex standards

for sorghum and pearl millet would also be reviewed while making the group standards for millets, the official said. Union Health Minister Mansukh Mandaviya congratulated the Indian delegation on the "momentous" occasion and said that India has played a pivotal role in making the millet choice of the common man. The major importing countries were ÚSA, Australia, Japan, Belgium etc in 2011-12 which had been shifted to Nepal (USD 6.09 million), UAE (USD 4.84 million) and Saudi Arabia (USD 3.84 million) in 2021-22. The other seven destinations in the current top-ten list of India's millet export are Libya, Tunisia, Morocco, UK, Yemen, Oman and Algeria, said an official from the

'Combat-ready, Credible, Cohesive, and Future Proof force enabled by what we call our 'ships first' outlook where every single action that we take is aimed to enable our women and men in operational units to perform their duties very well," the Navy chief said. The Navy's footprint of deployments has been satisfying as its ships have been persistently present across the Indo Pacific. Underlining the importance of self-reliance, Admiral Kumar said at present Indian shipyards are building 65 of the 67 warships. These capabilities had their origin in the 1960s and the latest example is induction of the indigenously built aircraft carrier INS Vikrant, he said only six or seven nations have the expertise to build aircraft carriers.

# supplying explosives, drones to Maoists

The National Investigation Agency (NIA) on Friday chargesheeted eight accused in Telangana for allegedly supplying explosives, drones and other equipment to the banned Communist Party of India (Maoist) for attacking security forces in the Maoistaffected areas of the country, an official said.

All the eight accused are in custody following their arrest under sections of the Indian Penal Code, Telangana Public Security Act, Explosive Substances Act and Unlawful Activities (Prevention) Act, the official said.

While three of them, working as couriers for the proscribed outfit, were nabbed on their way to supply the explosives, drones and a lathe machine, the others were apprehended subsequently, a spokesperson of the federal agency said. The official said investigations have revealed that the explo-



the possession of the three arrested -- Punem Nageswar Rao, Devanuri Mallikarjun Rao and Vollepogula Umashankar -- was originally supplied to them by accused Jannu Koti, Arepalli Srikanth, Tallapalli Arogyam and Bontha Mahender. The latter four had procured

the stuff from Sonaboina Kumaraswamy, who held a licence for dealing in explo-

The official said investigations have further revealed that the courier trio of Punem, Devanuri and Vollepogula had purchased and supplied a drilling machine to the Maoists in March.

They had further purchased a lathe machine in May for delivery to CPI (Maoist), a Leftwing extremist organisation involved in various terrorist activities, the spokesperson

said. The official said these accused had also purchased a drone for the Maoists in May intended for spying on the activities of security forces inside the forest. They further received explo-

sive materials, meant to unleash violent attacks on security forces, from their co-accused, to be supplied to the accused underground Maoists, the spokesperson said.

The official said the cache that the three accused were carrying at the time of their arrest was intended for use in manufacturing of countrymade arms, to be deployed against the security forces in India's Maoist-affected areas. The case was initially registered at Cherla police station in Telangana on June 5 and taken over by the NIA on August 3, the spokesperson said, adding further investigations to expose and demolish the CPI (Maoist) outfit's nefarious anti-India designs

## Ajit drops bombshell on Sr Pawar

n a shocking claim that may embarrass NCP chief Sharad Pawar, Maharashtra's Deputy Chief Minister and breakaway NCP leader Ajit Pawar said on Friday that Sr Pawar had himself asked the party workers to go on agitation to demand that he should take back his resignation as the party president in May this year.

Speaking at a "Chintan Shibir" of his party leaders and workers at Karjat in Raigad district. Ajit dada - as Ajit Pawar is known in the political circles claimed that after he announced his resignation as the party president on May 2, Sr Pawar had called two of his confidants

Paranipe and party's women wing leaders and asked them to organise an agitation in front of the YB Chavan centre in south Mumbai.

"Excepting Awhad, there was not even a single MLA among the NCP functionaries who were agitating to demand Pawar sahib to take back his resignation," Ajit dada said.

It may be recalled that Pawar had on May 2 this year dropped a bomb shell in the political circles by announcing his resigna-tion as the NCP president. However, Pawar agreed to continue in the post on May 5 after hundreds of party workers had gone on a spontaneous agitation demanding that he take back his resignation, while party leaders met him on several occasions

and tried to convince him to take back as continue in the

Ajitdada said that he and 10 to 12 MLAs and leaders, including Chhagan Bhujbal, Dilip Walse Patil, Dhananjay Munde, had expressed their intent to join the Eknath Shinde Shiv Sena-BJP government and they wanted Sr Pawar to take a decision in the matter. "Sharad Pawar called me on May 1 and said if he joined the Shinde-BJP government, he would resign as the NCP president. At that time no one had an idea that Pawar would resign from his post as the

party president," he said. "After he announced his resig nation from the party chief's post, Pawar saheb Jitendra Awahad, Anand Paranjpe and

tion," Aiitdada claimed "After he took back his resignation, Sharad Pawar insisted that his Supriya Sule be made the patty's national president. "Later, Pawar saheb did not like our decision to join the Shinde-BJP government on July 2. But on July 17, he assured he would streamline things. He again met at an industrialist's place and assured me he would set things right. All the while, he was trying his trying to catch us unwares," Ajit dada said.

The claims made by Ajitdada are in contrast to the revelation made by Sr Pawar's MP daughter and party's national working president Supriya Sule on

October 12 an upset NCP President (Sr Pawar) had cho-sen to resign as the party chief's post after several of the leaders from the Ajit Pawar camp insist-ed on joining hands with the

"My father never wanted to resign from his post as the NCP president's post. But, after only several of the party leaders - currently belonging to the Ajit Pawar - insisted on joining hands with the BJP, Pawar saheb was pained by the insistence by this kind of a clamour within the party. He then resigned from the NCP chief's post," Supriya had said.

In another revelation, Supriya said that Sr Pawar had no knowledge about Ajit Pawar and eight of NCP senior MLAs being sworn in as ministers in the Eknath Shinde government on July 2. "The decision (to join the Eknath Shinde-led BJP-Shiv Sena government) was taken by keeping him (Sharad Pawar) in the dark," she claimed. Contesting several claims made by Ajit Pawar camp leader Chhagan Bhujbal in a television interview on the circumstances leading to Sharad Pawar's resignation, Supriya said: "You people thought it was all a drama. He tendered his resignation from his post as he was hurt, after all the leaders ( now in the Ajit Pawar) wanted to team up with the BJP".

"After Pawar saheb resigned from his party president's post, all party leaders, party workers and people from across the state insisted that he continue as the party president. At that time, even Chhagan Bhujbal had insisted on continuing in the post as the party's president," she recalled.

Adied of heart attack in Gujarat in the last six months, with 80 per cent of the deceased being in the 11-25 age group, state education minister Kuber Dindor said on Friday.

In view of the rising number of heart attacks, nearly two lakh school teachers and college professors will be provided training in performing cardiopulmonary resuscitation (CPR), a crucial lifesaving intervention during such medical emergencies, Dindor said.

'As many as 1,052 persons have died due to heart attack during the last six months in Gujarat. Nearly 80 per cent of them were in the age-group of 11 to 25 years and these students and youngsters were not even obese. The 108 ambulance service receives 173 cardiac emergency calls per day," said Dindor while addressing the media in Gandhinagar. Youngsters are living in fear

because a majority of the heart attack victims were in their age

group, he claimed "We have seen how people died (due to heart attack) while playing cricket or taking part in garba (a traditional dance form popular during Navratri festivities) in the last six or seven months. I urge teachers to take part in this CPR training camp so that they can save lives," the

minister said. Under this initiative of the state Education Department, CPR training camps will be conduc-ted at 37 medical colleges bet-ween December 3 and 17 to pro-vide training to nearly two lakh school and college teachers, he

Some 2,500 medical experts and doctors will be present at these training camps and certificates will also be provided to the participants, Dindor added. Such training was given earlier to Bharatiya Janata Party workers and police personnel in the state, he pointed out.




COP28 sees developed countries pledging aid to developing nations to fight climate change

**■** orld leaders are in Dubai, the UAE, to take part in the World Climate Action Summit (COP28) which got under way on November 30. The Summit is an important moment for the heads of State and Government to signal their commitment to transform key climate-related decisions into concrete action and credible plans. Sheikh Mohamed bin Zayed Al Nahyan, UN secretary general António Guterres and King Charles III have already spoken at the inauguration ceremony. For 12 days, these leaders would discuss the menace of climate change; it is crucial to reflect on the progress made and the challenges ahead. The key outcomes of COP28 and the steps taken to combat the urgent threat of climate change have not been spectacular but some progress has indeed been achieved. On the COP28 opening day, all parties showed solidarity by agreeing to operationalise the 'loss and damage fund' and funding arrangements. Several countries pledged money to



the fund, totalling around \$300mn. The conclave saw renewed commitment from nations to the goals outlined in the Paris Agreement. Parties reiterated their commitment to limiting global warming to well below 2 degrees Celsius above pre-industrial levels, with efforts to pursue limiting it to 1.5 degrees Celsius. This commitment is crucial for preventing the most severe impacts of climate change. Thankfully, both developing and developed countries have realised the importance of checking climate change. With assured funding, many plans will see the light of the day and go a long way in reducing carbon emissions, including ambitious tar-

gets for reducing greenhouse gas emissions, increasing renewable energy capacity and promoting sustainable development. This conference would be remembered for financing climate action, a breakthrough on the very first day. Developed countries pledged increased financial support to developing nations to help them adapt to climate change impacts and transition to low-carbon economies. The financial commitments aim to bridge the gap between developed and developing nations and recognising the shared responsibility; the conferences have emphasised the importance of innovation and technology transfer. As COP28 highlights the significance of nature-based solutions, the discussions focused on the role of forests, wetlands and other ecosystems in enhancing resilience to climate change. Initiatives were launched to promote sustainable land use and conservation practices. While COP28 has made some headway, challenges remain. Addressing these challenges is crucial for the overall fight against climate change. COP28 must achieve some tangible results when it ends. It is not just a environment issue but a question of survival of many developing nation who may perish if sea level rise or droughts and floods ruin their agriculture. It is now or never!

# Myanmar: Generals under fire

#### The success of the current offensive in Myanmar shows once again that the ruling junta is doomed

he continuing offen-sive by an alliance of resistance groups, that began on the morning of October 27, has panicked Myanmar's ruling junta. This is clear from a report in The Global New Light of Myanmar, the junta's media voice, which said that Acting President Mynt Swe recently told Myanmar's Defence Council that the country was in a critical condition, and could be torn apart if the military did not act effectively against the groups that carried out the attacks, which were a part of the offensive.

The offensive has been launched by The Three Brotherhood Alliance (henceforth Brotherhood Alliance) comprising the ethnic Rakhine armed group, the Arakan Army (AA), the Ta'ang National Liberation Army (TNLA), the armed wing of the Palaung (the Burmese name for the Ta'ang ethnic minority group) and the Myanmar National Democratic Alliance Army (MNDAA) active in the Kokang Special Region of northern Shan State.

It has made significant gains, seizing the military's bases and towns across northern Shan, Kachin and Rakhine states and the upper reaches of Sagaing and Mandalay regions. According to the website, The Irrawaddy, several resistance organisations including the People's Defence Force (PDF), the armed wing of the opposition National Unity Government (NUG), the Karenni Nationalities Defence Force (KNDF), and one of the country's most powerful armed ethnic organisations, the Kachin Independence Army (KIA), are coordinating with the Brotherhood Alliance's opera-

The Brotherhood Alliance has captured over 224 junta bases and seven towns across northern Shan State, including some strategic centres on key Myanmar-China trade routes. It and allied resistance forces fully control Chin Shwe Haw, a trade hub on the Chinese border, and another strategic town, Hiseni, where the Lashio-Muse and Lashio-Chin Shwe Haw trade routes converge, as well as another trade gate—Kyin San Kyawt on the bedevilled by low morale and

China border in Muse Township. The Chin National Army and other Chin resistance groups have captured Reh Khaw Da in Fala town on the India border. Rikhawadar and Laidenpi in Chin State and Khampat in the Sagaing region, are also in the hands of the Junta's opponents.

In coordination with Operation 1027, the Karenni Army, the Karenni National People's Liberation Front (KNPLF), the KNDF, and the PDF, had jointly launched another offensive, Operation 11.11, on November 11, seizing more than 20 junta bases and outposts in Kayah State's Loikaw and Demoso townships as well as the nearby Pekon township in southern Shan State.

They have also captured the strategically important Kunlong township on the Lashio-Chin Shwe Haw Road that is considered be the gateway to the Kokang region. The resistance groups have also blocked strategic arteries like the Mandalay-Lashio-Muse and the Mandalay-Lashio-Chin Shwe Haw roads, which pass through Shan State. They also control several border trade routes with China.

The military, which should be called Sit-1at and not Tatmadaw, had been on the backfoot even before the current offensive began. It was

The latter doubtless has tanks and other armoured vehicles, artillery and air force. Tanks and armoured vehicles are very difficult to deploy in the areas dominated by the ethnic forces. With densely forested mountainous terrains, deep gorges and steep climbs, these are ideal for staging ambushes. Moreover, air-strikes and artillery do not win wars, even when backed by heavily armed and trained infantry. Otherwise, the United States would have won hands down

in Vietnam. The junta will land in history's dustbin--not tomorrow but sooner than many think. India must seriously consider its options. It has to contain China's influence in Myanmar when Beijing has maintained close contact with the ethnic fighters, with some even suspecting that the offensive had its nod

Second, India has its security concerns in its north-eastern parts, which is primarily why it has maintained friendly ties with the Junta. With areas in Myanmar adjoining India's borders increasingly dominated by the ethnic resistance groups, India must consider cooperating closely with the NUG and establishing links with the ethnic forces.

### Fragile hope emerges in Israeli-Hamas conflict



#### The ceasefire gives peace a chance but no lasting peace in Gaza is possible without a two-state solution

fter weeks of intense warfare in Gaza, a four-day truce has offered a glimmer of hope for millions yearning for peace in the beleaguered enclave. The pivotal question now lingers—can this pause pave the way for a permanent resolution to the enduring hostilities between Israel and Hamas, which have claimed thousands of lives and heightened the spectre of a broader conflict?

Under the current agreement, Israel and Hamas have agreed to a temporary cessation of hostilities to facilitate the release of 50 hostages in Gaza in exchange for 150 Palestinians held in Israel. Humanitarian aid is also set to enter the strip. The flexibility of the deal allows for its extension and expansion if the initial phase proceeds smoothly, raising optimism for a more enduring solution to this deeply entrenched issue with global implica-

The first phase, involving the release of hostages and prisoners, is slated to commenced from November 24. However, disconcertingly, the Israeli Prime Minister

asserted that the war against Hamas will persist beyond this truce, emphasizing Israel's commitment to

achieving its objectives, including eliminating Hamas and neutralizing perceived threats from elements in Gaza.

Hamas, in parallel, has echoed similar sentiments, underscoring that the truce does not impede their broader missions. They maintain readiness to defend their people and resist the occupation, while Israel remains firm in its decision to retain military presence in

The aggressive postures of both sides reflect a clash rooted in history, culture, geography, and divergent developmental aspirations. alties in Gaza have swayed

The current conflict stems from Hamas's incursion into Israel on October 7, resulting in significant casualties on both sides.



# The democratisation of forestry: Indian Scenario

Bridging local and global concerns, promoting equity and passionate stakeholders, are crucial for fostering the conservation of forests



In today's world, democracy stands as a beacon of hope, a principle that is both popular and attractive. However, the conundrum of choice between 'decision by merit' and 'decision by majority' presents a unique challenge in the context of the sustainability of forests and natural resources. Historically people lived off natural

resources while forests, producing more than what was extracted, sustained themselves. Communities often followed customary rules and norms related to grazing, firewood collection and more, demonstrating a profound respect for nature. Later the Zamindars and Chieftains formalised rules for exploitation of forest-produce. Management of forests using silvicultural principles started during British time and continued thereafter. Village Panchayats in central India, for example, had a say in the exercise of 'nistar' rights indicated in 'Nistar Patraks' and 'wazib ul arz' and also in 'Du-chand' areas that were twice the 'cultivated area' of the village. However, the relentless tide of rising populations and development pressures led to such area's overexploitation and abuse resulting in a loss of productivity, encroachment, and also diversion.

The National Forest Policy 1988 heralded an era of community-led management practices in forestry. The Joint Forest Management in the 1990s and the Panchayat (Extension to Scheduled Areas) Act 1996, made villagers participants in the domain of forestry. However, with Panchayats saddled with the responsibili-ty of working as the grass-root level governance units for a multitude of social and financial resource-rich sectors and with the emergence of newer livelihood options and development strategies, forestry-related activities had, de facto, a low priority with-

In 2006, the Forest Rights Act (FRA) was passed to redress the 'historical injustice' allegedly done to the 'forest-dwelling scheduled tribes' (FDSTs) and 'other traditional forest dwellers' (OTFDs) and recognize forest rights in their favour. FKA, a unique instrument heralding democratization of the forest right claims' scruiny at the village level provided for vesting of management rights into the eligible communities of FDSTs and OTFDs. Democratization is supposed to equip the management framework with the relevant traditional knowledge and local communities' wisdom. It allows recognition of the interest of communities in preserving forest resources and securing a collective commitment towards their sustainability. While it fosters a sense of ownership and responsibility and the creation of an equitable and just system, it must ensure that marginalized communities are not left behind. India attempted the democratisation of forestry using the paradigm of traditional Gram Sabha/ Panchayats. In the past selection of Panchas was based on local customs, traditions, and community consensus. The system was deeply rooted in the principles of inclusivity and collective decision-making where well-respected individuals with leadership qualities, integrity, wisdom, fairness, competence, and

knowledge of local issues were selected. Village dynamics, however, have undergone a seismic shift with political leaders gaining influence. The impact of the political system on the village-level psyche; already fractured by caste, class, and economic considerations; is a complex and multifaceted issue today. While the political system does foster awareness and civic participation, state or national politics often eclipses local concerns. Interestingly, however, global prioritization of forest conservation seldom trickles down to the village through political leaders and in instances of damage to forests, they tend to favour their electorate. Political expediency becoming the order of the day, and transforming mindsets to favour forest conservation irrespective of political affiliations is a formidable challenge. Further, convincing people to protect and conserve for the sake of stakeholders beyond their village limits is yet another challenging task.

The journey towards the democratization of forestry has been fraught with challenges and limitations. A fundamental obstacle is the persistence of power asymmetry within local communities. This became glaringly evident during FRA's implementation when powerful elites and interest groups attempted to manipulate amendments to its rules and guidelines. The influence on decision-making led to widespread illegal recognition of non-admissible individual and community forest rights, to the disadvantage of genuine beneficiaries. Such instances of 'elite capture' hurt the sustainability of forests and natural resources. The 2021 Status of Forest Report by the Forest Survey of India (FSI) reveals that Maharashtra's Gadchiroli district; with management rights on the majority of forest areas vested, albeit in violation of provisions, in Gram Sabhas; witnessed maximum forest fires in the previous three

Effective forest management in today's context necessitates specialised knowledge in areas like ecology, silviculture, and their interdisciplinary linkages. With the availability of new livelihood options and increased migrations, villages do experience an erosion of traditional knowledge and competencies. Preparation of biodiversity registers under the Biological Diversity Act 2002 by hiring outsiders in many villages is a case in point. Further, a lack of technical knowledge becomes a significant limitation. The case of Mendha Lekha village in Maharashtra serves as a poignant example. Here, a bamboo coupe was clear-felled in 2012 by violating silvicultural prescriptions. The area is yet to regain its productivity creating difficulties for the exercise of forest rights. The desire for quick economic gain

may lead to the prioritisation of short-term gains over long-term sustainability undermining conservation-oriented practices. Bamboo over-harvesting as also neglecting the sanitary felling operations is reported in many villages. In this context, the FSI's 2021 report regarding the loss of about 10,500 sq. km of bamboo-bearing area in the country deserves field-level scrutiny. On the economic front, because of the scale of operation, village-level incomes suffer due to market dynamics and inadequate value chains. The position of the genuine beneficiaries of FRA in the case of the 'tendu leaves' trade controlled by village elites in many villages of Maharashtra is worth exam-

Legal frameworks and implementations with sectoral biases harm community interests and jeopardize the sustainability of resources. In this context, the exclusion of foresters from the FRA's micro-plan preparation committees in . Maĥarashtra warrants a reevaluation. Ministry of Tribal Affairs, GOI issued guidelines for the supersession of existing landscape-based

Working Plans by all village-level micro-plans. While the guidelines have far-reaching implications for the ecosystem continuum vital for biodiversity's survival, they disregard the National Working Plan Code of the MOEFCC, Government of India as well as the Supreme Court's order mandating the sanction of all management plans by the Central Government. Tribal department being the nodal agency for FRA, there is a conspicuous lack of urgency in addressing the mandatalism of action being the constitution of the con ed issue of sustainability of forests and forest resources which is a nonnegotiable precondition for the sustainability of forest rights itself. Exercising effective control on corruption and misgovernance at various levels including that at the panchayat level is yet another serious concern. In the absence of cognizance of violations, FRA's implementation has largely been ignoring the proverb 'Charity beyond law is an injustice to others'.

### Operation 'Firki': Dealing with stray dogs in a humane way

#### The Government should support research to explore inexpensive, non-surgical options for dog sterilisation

n a misty winter morning of the year 2021, I was drawn to a commotion in the frontlane parking area of my residence in a South Delhi colony. A female dog had appeared from somewhere at night and delivered a litter. The people around appeared with all means to feed the mother and make the family comfortable in cold winter

The mother made the nearby area her permanent abode. She was a very scared stray and would even come near the food after being fully assured that no one was around. Given her very fast movements, I named her "Firki" and she is known by this name all over the place. Out of the six pups, one got



crushed under a speeding car and another got injured by a bike. In due course, we arranged for the adoption of

Efforts began to get Firki sterilised to stop further breeding. True to her name, it was a harrowing task catching her. After repeated requests to MCD, they were able to catch her on the fourth attempt. There was a big sigh of relief which did not last long as after 3 days she was dropped back by on the pretext that her blood tests were abnormal. That was the lost opportunity as she is still at large, managed to deliver three more litters with three surviving dogs each from the second and third litters. We managed to get the second litter picked up



for sterilization with great effort and it was discovered after a few months that they too were dropped back without any surgery (for unknown

Firki has grown smarter with time, hiding in the big drain with her family during the day and coming out for meals in the morning and night only. The overenthusiastic residents have employed dog feeders for dozens of strays in the vicinity and also ensure continued feeding from their

MCD office, personal requests to the vet, social media posts tagging senior MCD officers, and messages to RWA did not fructify in catching Firki. Many times, when we managed to corner Firki and inform the MCD team, their approach was very casual and pathetic resulting in failed attempts. On advice from a private vet, I could manage to sedate her but the attempt failed again. My desperation and helplessness knew no bounds, to the extent of announcing a reward of INR 10,000 to catch her. This followed dog catchers, colony guards, garbage collectors, cleaners, and some NGOs making attempts to catch but Firki The National Rabies Control tion strategy. Non-surgical

homes. Repeated calls and evaded every attempt. We visits to the South Delhi also got the male dogs in the also got the male dogs in the surrounding area sterilized but there was always some unsterilized dog who would mate resulting in a new litter. So, from a stray dog-free part of the lane, we now have seven dogs all over the place, chasing vehicles and barking throughout the night.

The presence of unvaccinate ed free-roaming dogs (FRD) or street dogs, amidst human settlements is a major contributor to the high incidence of endemic Rabies in India. Stray dogs chasing morning-walkers, cyclists, and two-wheeler riders, have resulted in serious injuries and death of innocent persons on innumerable occa-

Programme in India has been under implementation for more than a decade. The "National Action Plan for Dog Mediated Rabies Elimination from India by 2030" is being implemented jointly by various stakeholders. Successful Rabies control programmes have been implemented throughout the world, demonstrating that elimination is technically fea-

Dog-mediated Rabies has been eliminated from Western Europe, Canada, the USA, Japan, and some Latin American countries. Even low-income countries such as regions of sub-Saharan Africa and Asia have been able to reduce the burden significantly by mass dog vaccina-

methods have existed in the past, however, they have not been widely adopted due to a lack of will and coordination among concerned stakeholders, lack of research, costeffectiveness and other reasons including rampant corruption.

There is a need for more concerted efforts including ownership and enhanced coordination among concerned partner agencies. In addition, the Government should support research to explore inexpensive, non-surgical options for dog sterilization. RWAs should be more sensitive and help with monitoring count and anti-rabies vaccination of stray dogs.

### Israeli airstrikes on Gaza resume after truce ends

(GAZA STRIP)

Israel's war with Hamas resumed in full force Friday, with airstrikes hitting targets in the Gaza Strip minutes after a weeklong truce expired. Black smoke billowed from the besieged territory, and Israel dropped leaflets over Gaza City and southern parts of the enclave, urging civilians to leave their homes to avoid the fighting. In Israel, sirens warned of incoming rockets at several communal farms near Gaza, a sign that militants also restarted attacks. The renewed hostilities heightened concerns for Palestinians — many of whom have been displaced by the war — as well as about 140 hostages still in Gaza, after more than 100 were freed during the truce.

Qatar, which has served as a mediator along with Egypt, said negotiators were still trying to restart the cease-fire.

gled out Israel's role in the resumption of fighting and said it "complicates mediation efforts and exacerbates the

humanitarian catastrophe". A day earlier, US Secretary of State Antony Blinken met with Israeli officials and urged them to do more to protect Palestinian civilians as they seek to destroy Hamas. Blinken arrived Friday at the COP28 climate talks in Dubai, where he was to meet with Arab foreign ministers and other offi-

Israel's retaliation for Hamas' deadly Oct 7 raid has thousands Palestinians, uprooted most of Gaza's 2.3 million people and led to a humanitarian crisis. Hundreds of thousands of displaced people are now crammed into the territory's south with no exit, raising questions over how any Israeli offensive there could avoid

Prime Minister Benjamin Netanyahu will heed appeals from the United States, Israel's most important ally.

Netanyahu's office said Friday that Israel "is committed to achieving the goals of the war: releasing the hostages, eliminating Hamas and ensuring that Gaza never again constitutes a threat to the residents of Israel". Only hours in to the renewed offensive, the Health Ministry of Hamas-controlled Gaza said 109 people had been killed and dozens wounded. In the leaflets it dropped in

southern Gaza, Israel urged people to leave homes east of Khan Younis, warning that the southern town was now a "dangerous battle zone". Other leaflets warned residents of several neighbourhoods in Gaza City in the north to move

The Israeli military also released a map carving up the Gaza Strip into hundreds of residents to learn the number associated with their location in case of an eventual evacuation. It was not immediately clear how Palestinians would be updated on calls for evacuation. Hundreds of thousands of people fled northern Gaza earlier in the war, in an extraordinary mass exodus that saw many take shelter in Khan Younis and other places in the south.

One of the first airstrikes Friday destroyed a large build-ing in Khan Younis. Moments later, residents were seen frantically searching the rubble for survivors medics approached. One wounded person was carried away on a stretcher.

In Hamad City, a Qatarifunded housing development near the city, a strike hit an apartment in a multi-story residential building, while other parts of the building appeared largely intact. Elsewhere, a strike hit a home near Gaza refugee camp of Maghazi, in central Gaza, rescuers clawed through the rubble of a large building hit by warplanes. Israel has said it is target-

ing Hamas operatives and blames civilian casualties on the group, accusing the militants of operating in residential neighbourhoods. Since the war erupted Oct 7, in response to a deadly Hamas attack on southern Israel, many of those killed in Israeli bombardments have been women and chil-

In Israel, white smoke trails could be seen in the skies over Sderot on the border with northern Gaza after Israel's missile protection systems activated. Netanyahu said the war resumed because Hamas had violated the terms of the truce. "It has not met its obligation to release all of the women hostages today and has izens," he said in a statement.

Hamas claimed Israel had asked for the release of 10 female soldiers, which it rejected. Hamas blamed Israel for the end of the truce, saying in a statement that it had rejected all offers Hamas made to release more hostages and bodies of the dead.

The Israeli military's announcement of the resumption of strikes came only 30 minutes after the cease-fire expired early Friday. During the weeklong truce, Hamas and other mili-

tants in Gaza released more than 100 hostages, most of them Israelis, in return for 240 Palestinians freed from prisons

Virtually all of those freed were women and children, but the fact that few such hostages now remain in Gaza made it hard to reach a deal to extend the cease-fire. Hamas, a milied to set a higher price for the remaining hostages, especially Israeli soldiers.

Netanyahu has been under intense pressure from families of the hostages to bring them home. But his far-right governing partners have also pushed him to continue the war until Hamas is destroyed, and could abandon his coalition if he is seen as making too many concessions. A total of 81 Israelis, including dual nationals, were freed during the truce, most of whom appeared physically well but shaken. Another 24 hostages — 23 Thais and one Filipino — were also released, including several men.

The Palestinian prisoners who were released were mostly teenagers accused of throwing stones and firebombs during confrontations with Israeli forces. Several were women who were convicted by military courts of attempting to attack

### 'Israel already knew about Hamas attack'

Jerusalem (AP): Israel's military was aware of Hamas' plan to launch an attack on İsraeli soil over a year before the devastating Oct 7 opera-tion that killed hundreds of people, The New York Times reported Friday. It was the latest in a series of signs that top Israeli commanders either ignored or played down warnings that Hamas was plotting the attack, which triggered a war against the Islamic militant group that has devastated the Gaza Strip. The Times said Israeli offi-

cials were in possession of a 40-page battle plan, code-named "Jericho Wall", that detailed a hypothetical Hamas attack on southern Israeli communities.

It was unclear how the document was obtained by Israel, but the article said that it had been translated — indicating it may have been in Arabic and directly intercepted from Hamas.

The Israeli military declined to comment on the report, saying it was "currently focused on eliminating the threat from the terrorist organisation Hamas". "Questions of this kind

will be looked into in a later stage," it said.

The document was seen by many Israeli military and intelligence officials, the report said, though it was unclear if Prime Minister Benjamin Netanyahu or other top leaders had seen it. The document ers had seen it. The document predicted that Hamas would bombard Israel with rockets, use drones to disable Israel's security and surveillance abilities at the border wall, and take over southern communities and military bases. Another 2016 Israeli defense memo obtained by the Times said Hamas intended to take hostages back to Gaza. The Oct 7 attack — in which 1,200 people were killed and 240 people were abducted and taken to Gaza — would uncannily mirror the one outlined in the battle plan. But Israeli officials had brushed off the plan, the report said, dismissing it as "aspirational" rather than something that could practically take place,

### Resumption of Israel-Hamas war casts shadow over COP28 climate summit

As world leaders gathered for the COP28 climate summit in Dubai, the collapse of a cease-fire in the Israel-Hamas war Friday plunged the conflict back into open combat and cast a long shadow over the talks. Israel's top diplomat for the Middle East huddled with leaders at the summit as his colleagues went through a book of posters of those held hostage by the militant group Hamas, placing yellow "released" stickers by some while looking at others still held.

Meanwhile, just a street away at the Palestinian territories' first-ever pavilion, an official gave a horrified look when Associated Press journalists gave her the news that Israeli airstrikes and ground fighting in the Gaza Strip had resumed.Even United Nations Secretary-General Antonio Guterres brought up the fighting in his remarks at a COP conference meant to focus on restraining global warming.

### Indian student beaten, forced into labour for months in US; 3 charged

uthorities in the US have Authorities in the 22 rescued a 20-year-old Indian student, who was held captive for months without access to a bathroom, viciously beaten, and forced to work at three homes by his cousin and two other Indian-origin men in an incident described as "absolutely inhumane and unconscionable."

The victim, whose name was not disclosed, spent months trapped in three homes in the US state of Missouri.

On Wednesday, police descended upon a home on a rural highway in St Charles County. They later arrested

Varma Penumetcha and Nikhil Verma Penmatsa, and on Thursday charged them with offences including human trafficking, kidnapping and assault.

Police were dispatched to investigate the home after a concerned citizen became aware of his situation and called 911.The victim is safe and being treated at a hospital for multiple bone fractures, as well as lacerations and injuries covering his entire body, said prosecutor Joe McCulloch.

Over seven months, the men locked the student in a basement and forced him to sleep on an unfinished floor without access to a bathroom, scraps in nearby restaurant dumpsters and was beaten with electrical wire, PVC pipe, metal rods, wooden boards, sticks and a water supply hose for a washing machine, St Louis Post-Dispatch, a major regional newspaper, reported.

"It's absolutely inhumane

and unconscionable that one human being could treat another human being like this," said McCulloch at a news conference Thursday. The three defendants are accused of confining and abusing the victim at three different homes owned by Sattaru in Defiance, Dardenne Prairie and O'Fallon, starting in April 2023, accord-

investigators as the ringleader and lives in the O'Fallon home with his wife and children.

### How secret trip by Kissinger grew into 50-yr relationship with China

Officially China has called Henry Kissinger "an old friend". A commentator likened him to a giant panda, a goodwill ambassador between two countries that have been at odds more often than not over the decades.

Kissinger, who died Wednesday, developed a special relationship with China in the second half of his 100-yearlong life. It started with a secret trip in 1971, when he feigned illness while at a meeting in Pakistan and flew undercover to Beijing for unprecedented talks that led to US President Richard Nixon's groundbreaking visit the next year.

For that act, he is remembered positively in China as an

look ideological differences at the height of the Cold War and to engineer a rapprochement that over time brought communist-ruled China fully back into the family of nations. Many Chinese people mourned Kissinger's death on social

"This is one of the main reasons for him to be revered," Zhao Minghao, an international relations professor at Fudan University in Shanghai, said. "He helped Nixon open China's door and promoted a thaw in China-US relations."

The willingness to overlook differences took on renewed importance in recent years as US-China relations frayed and attacks on China mounted from both Democrats and

### **US** to step up efforts in pushing China to negotiate with Dalai Lama envoys

#### Congressional committee passes bill

Apowerful Congressional Committee has passed a bill to strengthen US efforts in pushing China to negotiate with the Dalai Lama's envoys to resolve the longstanding Tibet-China dispute and counter the Communist Party's propaganda about the history of Tibet.

The bill, which among other things also dismisses as inaccurate the Chinese claim that Tibet has been part of China since antiquity, was passed unanimously by the House Foreign Affairs

"This bill stresses the need for a dialogue between the Chinese Communist Party (CCP) and the democratically elected leaders of Tibet. Any resolution must include the wishes and the voices of the Tibetan people," House Foreign Affairs Committee Chairman Michael McCaul said during the

racy-loving people who wish to practice their own religion freely and have their own wishes and desires acknowledged as we do in the United States of America. The freedoms that we enjoy, we want to be enjoyed by the people of Tibet," McCaul said. The bill, an amended House version of legislation introduced last year by Congressmen Jim McGovern and Michael McCaul, as well as Senators Jeff Merkley, and Todd Young, will pressure the Chinese government to resume negotiations with the Dalai Lama's envoys or the democratically elected leaders of the Tibetan people. The dialogue process has been

stalled since 2010. McCaul said the ruling Chinese Communist Party or CCP has a long and violent record of oppression against the people of Tibet.

In October of 1950, Chinese Communist troops annexed Tibet, killing tens of thousands of Tibetans and monks. The CCP's ongoing oppression of the people of Tibet ultimately forced the Dalai Lama to flee to India. This persecution has continued to this day, he said. Promoting a Resolution to the Tibet-China

CCP propaganda about the history of Tibet. "The United States has never accepted that Tibet was part of China since ancient times," as the CCP falsely claims. This legislation clarifies US policy, highlights the unique language, religion, and culture of the Tibetan people, and directs US diplomacy to push back against CCP propaganda," McCaul said.

McGovern, another main sponsor of the bill, said under international law, Tibetans are people who have the right to determine their own destiny. Also under international law, there is a right to truth. The truth is that Tibet has not always been part of China, as the Chinese government claims. "My bill requires the State Department to counter the PRC's disinformation about Tibet, its history and its institutions, including that of the Dalai Lama. Rather than lie about the history of Tibet, I call on the Chinese Government to restart dialogue with the Dalai Lama to resolve the long-standing dispute between Tibet and China and respect the aspirations of the Tibetan people," he

"I can't avoid thinking sometimes that they would suddenly barge into our territory," said Daisy Cojamco, a 51-year-old mother of three whose husband works as a town government employee. Surrounded by white beaches, the tadpole-shaped Thitu of nine islands, islets and atolls that have been occupied by Philippine forces since the 1970s in the South China Sea's Spratlys archipelago.

The Philippines claims the region as its most remote offshore township, under its western island province of Palawan. It has encouraged fishing families to move there with incentives such as free rice, to underscore its control over an area also claimed by China and Vietnam. The 37hectare (91-acre) island now boasts internet and cellphone connections, a more stable power and water supply, a newly cemented runway, a wharf, grade school, gymnasium and even an evacuation centre in times of typhoons.

However, Thitu remains a meagre frontier settlement compared to the Chinese-built Subi island, more than 22 km (14 miles) away. Subi is one of seven mostly submerged reefs that China transformed starting about a decade ago into a missile-protected cluster of island bases, three of them with military-grade runways, sparking alarm among other claimant states in the South China Sea. It also recently launched joint sea and air patrols with the United States and Australia in a new deterrent strategy that puts the two allied powers on a collision course with Beijing. China has warned that

such joint naval patrols must not hurt its "territorial sovereignty and maritime rights and interests".

Since President Ferdinand

the Philippines has been deepening its security ties with Washington and ÚS allies like Japan and Australia in a major shift from his predecessor, Rodrigo Duterte, who had nurtured cozy relations with Chinese President Xi Jinping and Russian leader Vladimir Putin while criticising Western security policies. Duterte had mostly kept

the territorial disputes with Beijing on a backburner during his six-year term. Early this year, the Marcos administration launched a strategy of exposing China's aggressive actions in the South China Sea, including the Chinese coast guard's use of a militarygrade laser and water cannons and the blocking of Philippine patrol ships and supply boats near disputed shoals, to draw international attention to such aggression, according to Philippine officials.

#### 11 civilians killed in attack by gunmen in **Iraq's eastern Diyala province**

**iau (AP):** A group with explosives and guns killed 11 people in eastern Iraq, security officials said Friday. The attack took place Thursday night in the area of Muqdadiyah in Diyala province. A roadside bomb exploded and gunmen then opened fire on rescuers and bystanders at the scene, two security officials said. They spoke on condition of anonymity because they were not authorized to speak to the media.

The victims were all civilians, the officials said. The gunmen fled and no group immediately claimed responsibility for the attack. Divala province has seen periodic attacks by Islamic State cells and sporadic violence due to sectarian tensions between Shiites and Sunnis, as well as fighting between rival militias and their tribal and political allies struggling over influence and lucrative racketeering networks. The province, which borders both Īran and Iraq's autonomous Kurdish region, is a prime conduit for smuggling. The Iraqi military's joint operations command said in a statement that it would form a committee to investigate the attack. Lt Gen Qais al-Muhammadawi, deputy commander of the joint operations, travelled to Diyala on Friday to attend a funeral for the victims and and "determine the circumstances of the incident", the statement said.

The provincial governor of Diyala, Muthanna al-Tamimi, vowed in a statement to "pursue the perpetrators of the terrorist attack". Nechirvan Barzani, president of the Kurdish region to the north, said the attack "proves the fact that terrorism still poses a real threat and challenge, and that we must confront them with all our force and ability". He called for greater cooperation between the Iraqi army, Kurdish peshmerga forces and other security forces, as well as with the USled international coalition

The Al-Qadir Trust case is about the settlement of 190 million pounds, about Rs 50 billion, which the UK's National Crime Agency sent to Pakistan after recovering the amount from a Pakistani property tycoon. Being the prime minister then, Khan, instead of depositing in the national treasury, allowed the businessman to use the amount to partly settle a fine of about Rs 450 billion imposed by the Supreme Court some years ago.


## Nifty hits lifetime high, Sensex jumps 493 points on favourable macro data

At present, cars imported as completely built units (CBUs) from 60 per cent to 100 per cent, depending on engine size and cost, insurance and freight (CIF) value less or above USD 40,000. "Never. UEFA said Friday that it "strongly condemns the unacceptable violence" that took place.

Rohit, who led India to the ODI World Cup final at home, and Virat Kohli have taken a "break" and will miss the white-ball leg of the upcoming South Africa tour, beginning December 10. Talking to reporters, Ganguly said the duo deserved rest so that they come back "fresh" for the hectic calendar ahead.

"Once Rohit is back playing all formats, he should be the captain of India, because he has done so well in the World Cup," said the former BCCI president, who was named the Dabur Chyawanprash's brand ambassador for East India, during a

"You saw in the World Cup how well they played. They are absolutely integral and an important part of Indian crick-

Interestingly, both Rohit and Kohli haven't played a T20I since the semifinals against England in the 2022 T20 World Cup and the BCCI was not clear whether the duo should be in India's scheme of things for the T20 global showpiece in six months time. After the 2022 T20 World Cup, Hardik Pandya was named India's T20 captain but following his injury during the ODI World Cup, Suryakumar Yadav is leading the team in the ongoing five-T20 series against Australia.

"I'm not surprised that they have shown faith in Dravid. When I was president of the Board, we convinced him to do this job. And I'm so happy to see yesterday that his tenure has been extended.

"It was always the case, depend-
