Rhetoric from Pakistan impacting UK Muslims; Islamist extremism 'primary threat' to UK, says Govt review

 $R^{\text{adicalisation of the UK}}_{\text{Muslims on the issue of}}$ Kashmir and "potentially toxic" pro-Khalistan extremism are major concerns for the country, a review into the UK's Government scheme set up to prevent terrorism has flagged. It also made recommendations for improvements to tackle Islamist extremism as the "primary threat" to the coun-

The review into the Government's counter-terrorism early intervention "Prevent" strategy published this week warned that rhetoric from Pakistan is impacting UK Muslim communities when it comes to "inflaming anti-India sentiment, particularly around the subject of Kashmir".

The review carried out by The review carried out of Commissioner for Public Appointments William Appointments Shawcross also warns against a false narrative being disseminated by a tiny number of pro-Khalistan groups operating in

Qaeda.'

crossover between those who seek to impose limits around blasphemy with those who voice incendiary rhetoric on Kashmir.

"I have seen evidence of UK extremist groups, as well as a Pakistani cleric with a UK following, calling for the use of violence in Kashmir. I have also seen evidence demonstrating that flashpoints related to Kashmir lead to a significant surge in interest from UK Islamists," says Shawcross in the review. It noted that there is no reason to believe this issue will disappear as a grievance that Islamists will seek to exploit in years to come.

This has potential relevance to 'Prevent', as there are examples of those convicted of terrorism offences in the UK who had first fought in Kashmir. This includes those

The "Delhi Declaration on Terrorism" last year has come in for praise by the United Nations Security Council (UNSC) which said it offers a "solid basis" to counter the use of new and emerging technologies for terrorist purposes and symbolises the Council's "shared determination" to address the challenge.

SC: Investors' interests need to be protected

Consider expert panel to boost protection against market volatility, court tells Centre

PNS NEW DELHI

With aim to protect interests of Indian investors against market volatility against the backdrop of the Adani stocks rout, the Supreme Court on Friday asked the Centre to consider setting up a panel of domain experts headed by a former judge to look into strengthening the regulatory mechanisms.

It also sought the views of the Securities and Exchange Board of India (SEBI) and the Centre as to how to ensure putting a robust mechanism in place since the capital movement now is "seamless" in the

Noting that the stock market is not the place where only high value investors invest, the court said with the changing financial and tax regime the investments are being made by the wide spectrum of middle

It noted that as per some reports the total loss suffered by Indian investors due to the recent Adani stocks rout was in the range of several lakh crores of rupees.

The top court, which was hearing PILs alleging exploita-Continued on Page 2 tion of innocent investors and "artificial crashing" of the



Adani Group's stock value, assured the officials of the SEBI that it was not "planning any witch hunt" and would tread with "very great caution" as its observations would affect the stock market which "goes

largely by sentiments".
"We have indicated to the Solicitor General (Tushar Mehta) the concerns with regard to ensuring that the regulatory mechanisms within the country are duly strengthened so as to ensure that Indian investors are protected against certain volatility, the kind of which has been witnessed in the recent two weeks.

'That in turn would require due assessment of existing regulatory framework, the relevant causal factors, need for strengthening the regulatory framework in the interest of the investors and the stable operations and development of the securities market," the Chief Justice DY Chandrachud-led bench said.

On the issue of strength-

ening existing regulatory regime, the bench, also comprising justices PS Narasimha and JB Pardiwala, mooted an expert committee which can comprise experts from the securities areas, the international banking sector and a wise guiding figure in the form of a former judge".

'We have also suggested to the Solicitor General, if they are willing to accede to forming a committee to see the overall situation. If the Union Government is so inclined to accept the suggestion, the necessary submissions can be urged on the constitution of the committee to that end," it said in the order.

The bench asked the top law officer to place a brief note on both factual and legal aspects to take the deliberations further on February 13, the

next date of hearing.

One PIL filed by lawyer Vishal Tiwari sought a direction to the Centre to constitute a committee monitored by a retired apex court judge to inquire into the Hindenburg Research report which has made a slew of allegations against the business conglomerate led by industrialist Gautam Adani

Another PIL filed by advo-cate M L Sharma sought prosecution of short-seller Nathan Anderson of the US-based Hindenburg Research and his associates in India and the US for allegedly exploiting innocent investors and the "artificial crashing" of the Adani Group's stock value in the market.

SC rejects plea for ban on BBC **India operation**

The Supreme Court on Friday dismissed a plea seeking to impose a complete ban on the British Broadcasting Corporation (BBC) in India in wake of a controversial documentary regarding the 2002 Gujarat riots, terming it "entirely misconceived" and "absolutely meritless"

A bench comprising Justices Sanjiv Khanna and M M Sundresh passed the order while hearing a plea filed by Vishnu Gupta, president of the Hindu Sena, and Beerendra Kumar Singh, a farmer.

"The writ petition is entirely misconceived and has no merit and is accordingly dismissed," the bench said. Continued on Page 2

Pvt member resolution in RS seeks Sachar report implementation

A private member resolution seeking that the government implement the recommendations of the Sachar Committee report and other reports that have discussed the educational and social backwardness of Muslims and enact a legislation for the prevention of atrocities against minorities was moved in the Rajya Sabha on Friday.

'During the private members' business in the Upper House of Parliament, Abdul Wahab of the Indian Union Muslim League (IUML) moved the resolution and demanded the formation of a Joint Parliamentary Committee (JPC) or a judicial commission headed by a retired Supreme Court judge "to study the evic-

tions that have been carried out

as a form of collective and arbitrary punishment against the Muslim minority and lowincome communities".

""Sachar Committee Report, 2006 and Ranganath Mishra Commission Report, 2007 reveal that the condition of Muslims in India is worse than SCs (Scheduled Castes) and STs (Scheduled Tribes)," Wahab said.

'One-fourth of the Muslim children in the age group of 6-14 years have either never attended school or are dropouts, he said, citing the Committee

The ED had initiated money laundering investigation based on the FIR registered by Shivajinagar Police Station, Pune, in 2020 based on a complaint lodged by the Statutory Auditor of Shivajirao Bhosale Sahakari Bank.

"ED investigation has revealed the financial fraud was done by the Accused persons in multiple ways viz. cash siphoned off from Bank on oral instructions without any official entry/record in the Core Banking System; misappropriation of funds of the bank by transferring huge funds to themselves and related parties; fraudulent disbursal of loans and diversion of such loans by the Key Managerial Persons of the Bank and others; bogus cheque discounting facility done to reduce the status of NPA of the Bank," the agency said.

India jumps to 55 in global aviation safety list

m ndia}$ has jumped to the 55th position from 112th place in the ranking of oversight capability of global aviation Safety. According to the Directorate General of Civil Aviation (DGCA), after the final report India's safety oversight capability ranking has climbed from 112 to 55.

The ICAO had last month audited the DGCA to check its effective implementation (EI) of critical safety elements. The ICAO undertakes audit of all the contracting states under this programme. "It may be noted that this ranking is dynamic and is contingent upon the outcomes of various Audits undertaken by ICAO," it said.

Under its Universal Safety Oversight Audit Programme (USOAP) Continuous Monitoring Approach, an ICAO Coordinated Validation Mission (ICVM) was undertaken in India from November 9 to 16, 2022. According to the statement, as the scope of the mission did not include the areas of AIG and ANS, the updated overall EI of 85.65 per cent is calculated based on the latest USOAP results on record for these two areas. AIG is Aircraft Accident and Incident Investigation, and ANS is Air Navigation

Adani Group stocks have taken a beating on the bourses after the Hindenburg Research made a litany of allegations, including fraudulent transactions and share-price manipulation, against the business conglomerate. At the outset, the bench said, "This is just an open dialogue. They have brought an issue before the court. It said when it happened on a small scale, then nobody was bothered. "But the point is this if it happens on a large scale, then it concerns small investors... As per some reports, the total loss suffered by Indian investors goes in the range of

several lakh crores of rupees." "You have fund inflow and outflow from India. How do we ensure in future that Indian investors are protected... Everybody is now in the market. Even a small lawyer is there in the market. But, they have no control," it said, adding "What role do we envisage for SEBI? For instance, in a different con-

text, you have circuit breakers." The law officer said it was "a little premature" for him to answer immediately.

'The trigger point was the (Hindenburg) report, which is outside. This was beyond our territorial jurisdiction. There are regulations which deal with the concerns. We are also concerned," Solicitor General Tushar Mehta said, adding the market regulator was closely monitoring the situation. The bench said it was not casting any doubt on SEBI or the regulatory agencies.

"You may get some inputs from the Government and perhaps then you can take a call whether modification of our statutory provisions are required. Then again this is a matter for the government. Beyond a certain stage we cannot enter into the policy domain but we can at least use our own good office to put into place some mechanism to ensure that it does not happen in future."

HC stays Mehrauli slum demolition drive till hearing on Feb 14

The Delhi High Court on ☐ Friday directed the authorities - Delhi Urban Shelter Improvement Board (DUSIB) and Delhi Development Authority (DDA) — to maintain the status quo on 400 jhuggis of a slum colony in Mehrauli, which were to be demolished during the day. Meanwhile, the AAP has lashed out at the BJP over the Mehrauli demolition drive and accused it was replicating what British did during their rule.

The high court listed the matter for further hearing on February 14 noting that the counsel for the authorities, including DUSIB and DDA did not have complete instructions

made in the petition that Ghosiya Slum Colony is a jhuggi cluster duly enlisted in the list published by DUSIB on its official website, which records 400 jhuggis, as also the 2015 policy and the fact that the respondents do not have instructions in the matter, the respondents are directed to maintain status quo with respect to the 400 jhuggis verified by DUSIB, until the next date of hearing," Justice Manpreet Pritam Singh Arora

Earlier in the day, the DDA has started a demolition drive in the Mehrauli area amid police security. Locals claimed that the drive that started in the morning was demolishing two and three-storeyed buildings

near Aulia Masjid at Andehria More along with shanties.

The land on which the alleged encroachment was done belonged to multiple agencies including DDA, Waqf Board, and ASI, they claimed.

"A demolition drive is

being carried out by the Horticulture Department of the Delhi Disaster Management Authority. Police Disaster personnel have been deployed on the spot as preventive protection for DDA officials to carry out their duties and also to maintain law and order in the locality. Initially, the localities had staged a protest against the demolition but the situation was later brought under control," said a senior police official. According to the demoli-

tion notice, the land on which

out is a part of the Mehrauli Archaeological Park and the 'existing unauthorised encroachment' is acting as a hindrance to the development of the park.

Addressing a press conference, AAP leader Durgesh Pathak accused the BJP of reneging on its poll promises of 'Jahan Jhuggi Wahan Makaan' and said they were demolishing unauthorised colonies and slum areas to exact revenge for losing the Vidhan Sabha and MCD polls.

Probe sale of Chinese manjha, HC tells police

¬he Delhi High Court on Friday directed the crime branch of Delhi Police to investigate the manufacturing, sale, purchase and storage of Chinese synthetic "manjha", used for kite flying, in markets and shops.

The high court said such dangerous threads are used by children and young adults for kite flying and it is the duty of authorities to ensure that they are not made available.

It directed the crime branch to file a report giving details of manufacturers, importers, traders and shopkeepers supplying Chinese manjha and the details of markets where this thread is sold. "It is directed that the FIRs lodged in cases of deaths by Chinese manjha shall be investigated by the crime branch. Give details whether such shopkeepers have been arrayed

they have been alerted about the ban on sale of Chinese manjha or not.

What is the status of these FIRs and whether any proceedings have been initiated against officials who are duty bound to stop the sale of Chinese manjha shall also be submitted in the court," Justice Prathiba M Singh said, adding that the deaths of innocents caused due to Chinese manjha will also be considered as dereliction of duty.

The high court, which listed the matter for further hearing on April 12, said the notices which will be issued to traders dealing in Chinese manjha shall also include those who are selling it on e-commerce web-

The court was hearing four petitions by family members of those who died or got injured by Chinese manjha while riding motorcycles, seeking action

The petitioners' counsel submitted that many people died after their throats were slit by Chinese manjha while riding two-wheelers and added that the law imposing ban on the use of Chinese manjha was already there but the issue was regarding its proper implementation.

The high court said that in addition to paying compensation, more needs to be done to control this problem and added that areas where such dangerous threads are sold need to be identified and police need to identify the shopkeepers selling it and lodge a criminal case against them.

As the court wanted to know how the thread harms a rider while wearing a helmet, the petitioners' counsel said it slits the throat in a barbaric manner. It said that despite the orders of the National Green Tribunal (NGT) as well as

Waiting for the External Affairs Ministry's clearance for her Harvard University visit, Delhi Commission for Women (DCW) chief Swati Maliwal on Friday said she was missing the working style of former foreign minister Sushma Swaraj.

Maliwal has been invited by the United States Harvard University to address their annual conference. The file was sent to the Delhi government on January 16, from where it was sent to Delhi Lieutenant Governor Vinai Kumar Saxena on January 18, the Delhi Commission For Women said in a statement. The LG office, at length, gave its permission for travel on February 8 and asked Maliwal to seek approval from the Ministry of External



Affairs, it said.

The file was then sent to the MEA for political clearance but, according to her, she has not received any response from the ministry.

"Since the conference is on 11 Feb, there is hardly any time left for attending the same," DCW said. Maliwal also raised the matter on Twitter saying she is missing the working style of former External Affairs

Minister Sushma Swaraj, who, she added, considered every Indian as her family, and her, as her own daughter.

"It is sad that today's Ministry of External Affairs is sitting on the file and is refusing to approve or reject the same. Had Sushma ji been there, this would never have happened," Maliwal lamented and wondered what the ministry's stance on her visit was.

Delhi BJYM chief expelled for fake kidnapping to abandon baby girl



Delhi unit Bharatiya Janata Yuva Morcha (BJYM) president Vasu Rukhar was expelled from the organisation on Friday following a controversy over the fake kidnapping of his daughter who was later found abandoned near a temple. It turned out that Rukhar's wife was forced to abandon her baby girl as she was being harassed over having three daughters.

Delhi BJP working president Virendra Sachdeva issued a letter, saying Rukhar's pri-mary membership was terminated and he was expelled from the party.

"In view of your behaviour and activities, you are immediately relieved of your primary membership and immedi ately expelled from the party, said the letter signed by the Delhi BJP president.

The daughter of the Delhi president of the Bharatiya Janata Yuva Morcha (BJYM) was said to have been abducted from Jhandewalan in central Delhi on Wednesday and abandoned near a temple in Maurice Nagar, police had said. However, sources in the BJP alleged that Rukhar's wife was forced to abandon her oneand-a-half-year-old child as she already had two other daughters before this.

No immediate reaction was available from Rukhar over his expulsion. Sources in the BJP said the decision to expel Rukhar was taken based on the investigation done by police and an in-house probe by the party. A senior police officer said the probe revealed that the mother of the infant girl had "purposely" abandoned the child and later made the PCR call. "We suspect that she must have done this to get rid of the girl child but we are still probing the reason behind her action," he said.

The Delhi Commission for Women had also issued a notice to police in connection with the alleged kidnapping of Rukhar's daughter.

Budget will enable higher disposable income: FM

Affirming that the union Budget "astutely balances" the requirement of development imperatives within the limits of fiscal prudence, Finance Minister Nirmala Sitharaman on Friday said the new tax regime, which offers a rebate on annual income of up to Rs 7 lakh, will leave higher disposable income in the hands of people.

Sitharaman hailed the government's economic policies during the reply to the Budget 2023 debate in Lok Sabha and asserted despite of global slowdown India is still the fastest-growing major econ-

The government chose



omy as it has a great multiplier effect, she added.

"If I can put in a few words the essence of budget 2023-24it balances the requirement for India's development imperatives within the limits of fiscal prudence," said Sitharaman.

She said the total resources being transferred to states, that is, Central share from taxes and sored schemes put together was estimated to be at 17.98 Lakh Crores and this was higher by 1.55 Lakh crores compared to last year.

Replying to the discussion on Union Budget for 2023-24, Sitharaman said the Budget focuses on the middle class, employment generation, MSME, agri sector, rural population, health and green

The finance minister said the new tax regime announced in the Budget is "very attractive" as the tax exemption limit has been hiked to Rs 3 lakh, from Rs 2.5 lakh earlier. Besides, a standard deduction of Rs 50,000 too has been allowed under the scheme.

This new tax regime will benefit the majority of middleclass taxpayers, she said, adding that the rebate has been provided on an income of up to Rs

"Since the enhanced rebate limit is unconditional, it leaves higher disposable income in the hands of people, Sitharaman said.

Under the revamped concessional tax regime, which will be effective from the next fiscal, no tax would be levied for income up to Rs 3 lakh. Income between Rs 3-6 lakh would be taxed at 5 per cent; Rs 6-9 lakh at 10 per cent, Rs 9-12 lakh at 15 per cent, Rs 12-15 lakh at 20 per cent and income of Rs 15 lakh and above will be taxed at 30 per cent.

States using Ayushmaan Bharat funds for healthcare with different names, says Govt

"We release scheme-based grants. If they don't utilise the scheme and follow its provisions, we are not left with any other option," he added.

The minister was replying to a question asked by YSRCP member K Raghu Rama Krishna Raju. "Several state govern-

ments are violating that (MoU), (they) have given their own names (to the scheme)...," he said.

Citing one example, the Minister said health infrastructure has been created in Punjab with utilisation of the funds provided by the central government under the Ayushman Bharat-Health and 23 सितंबर, 2018

"This should not be done," Mandaviya said while replying to a question in Lok Sabha during Zero Hour.

'China flexing muscles in Indo-Pacific so US is enhancing ties with India'

With China flexing its muscle in the strategically important Indo-Pacific region, the US is enhancing defence ties with India to uphold a favourable bal-

This assertion was made by Ely Ratner, Assistant Secretary of Defence, Indo-Pacific Security Affairs told members of the Senate Foreign Relations committee during a Congressional hearing on China.

He said "Earlier this month, the US Government launched the inaugural technology initiative with India, including in-depth discussions about opportunities for co-production of major defence platforms. "We are making significant investments in our defence ties with India to uphold a favourable balance of

power in the Indo-Pacific region," he said. Deputy Secretary of State Wendy Sherman said the US has invested in the Quad partnership with India,

Australia, and Japan. We are aligning with like-minded partners around the world to strengthen our shared interests and values of democracy, openness, and fairness – and to address the challenges posed by the PRC (People's Republic of

Senator Roger Wicker, Chairman of the Senate Foreign Relations Committee said Beijing, for decades, has been active and aggressive in expanding its claims of sovereignty and territory.

"In the last 60 years, China almost risked a nuclear



conflict with the Soviet Union, fought a war with Vietnam and engaged in multiple bloody skirmishes with India as recently as last month to assert their territorial claim," he

It continues to make egregious territorial claims in the South and East China Sea, all in the name of expanding the reach of the Chinese Communist Party, Wicker

. "Americans saw firsthand President Xi's disregard for our own sovereignty over the past week, as a Chinese spy balloon violated US airspace uncontested for several days just the latest in Beijing's string of provocative actions," he told his Senatorial colleagues.

rime Minister Narendra Prime Minister Additional Modi inaugurated the Uttar Pradesh Global Investigation 2023 in tors' (UPGIS) Summit-2023 in Lucknow on Friday. He also inaugurated the Global Trade Show and launched Invest UP 2.0 during the programme.

"New opportunities for wealth creators are being made here. Very soon UP will be known as the only State with five international airports. Freight corridor will connect the State directly with the sea coast in Maharashtra," Modi said addressing the UPGIS-2023, the flagship investment summit of the UP Government.

The 3-day summit will bring together policymakers, industry leaders, academia, think tanks and leaders from across the world to collectively explore business opportunities and forge partnerships.

"Meaningful change in governance and the Government's thinking is visible in UP, which has ensured ease of doing business. Today, UP has become a source of hope and inspiration. UP has become a bright spot for the nation just like India has become a bright spot on the global stage," he said. He also stressed that initiatives for better infrastructure in UP were



Noting the capabilities of the State, Modi drew attention to the unwanted tags such as underdevelopment, BIMARU, and the poor law and order situation attached to UP.

Modi said within 5-6 years, UP had established a new identity. "Now Uttar Pradesh is known for good governance. better law and order situation, peace and stability," he added.

Modi mentioned that UP has emerged as a champion when it comes to developing a new value and supply chain. He noted the vibrant network of tra-

ditional and modern micro, small and medium enterprises (MSMEs) that were present in the State and gave the example of silk from Bhadohi and Varanasi which had made UP the textile hub of India.

He informed that 60 per cent of India's mobile phones along with maximum mobile components were manufactured in UP. He also drew attention that one of the two Defence Industrial Corridors in the country was being developed in UP. He underlined the commitment of the Government to provide 'Made in India' Defence systems and platforms to the İndian Army.

Modi welcomed the investor community, industry leaders and policymakers both as a Prime Minister and as a Member of Parliament from UP. He emphasised that the land of UP was known for its cultural splendour, glorious history and rich heritage. The prime minister said that every credible voice in the world was optimistic about the ascending course of the Indian economy as it had not only shown resilience in the face of the pandemic and war but also showed rapid recovery.

SRO on Friday tasted maiden Lsuccess in the small satellite launch vehicle segment, with its SSLV D2 rocket injecting three satellites into an intended circular orbit, months after the maiden mission failed to bring in the desired results. Buoyed by today's success, the premier agency said the launch has "set the tone" for its activities this year, dotted with a number of proposed PSLV and GSLV missions, among others.

The payloads launched by SSLV D2 rocket on Friday included ISRO's earth observation satellite EOS-07.

ISRO's first mission in 2023

and SSLV's August 2022 sequel saw a strange coincidence--a 9.18 AM launch, the same time the vehicle lifted off from the Satish Dhawan Space Centre here on August 7 last but could not deliver due to orbit anomaly and flight path deviation.

With the earlier SSLV not living up to the expectations, 'corrective measures' were put in its successor. A visibly relieved Chairman

of the Indian Space Research Oragnisation (ISRO), S Somanath said SSLV in its second flight put the three satellites in the intended orbit accurately.

One of the senior scientists described the SSLV as a "smart

In its second attempt today, SSLV D2 has placed the EOS-07 satellite into the intended orbit very accurately. Along with EOS-07 two more satellites were placed in the required orbit. Janus-1 through NSIL (NewSpace India Ltd) and from ANTARIS and AzaadiSat through In-Space, realised by

SpaceKidz," he said.

SSC scam: **HC** terminates iobs of 1,911 school staff

Tn a landmark order the Calcutta High Court on Friday directed the West Bengal Board of Secondary Education to terminate the jobs of about 1,911 Group D employees illegally appointed in various schools.

The order was passed by the Bench of Justice Abhijit Ganguly who has been hearing a bundle of matters related to school-level recruitment tests. An additional batch of about 900 people may also lose their jobs in a similar

Apart from ordering the termination of their jobs the HC also directed the terminated staff to return their salaries in tranches.

They have also been barred from appearing in any tests for Government jobs without the permission of the court.

The order came after the HC found that the 1,911 candidates had secured their jobs owing to manipulation of their OMR sheets for the recruitment examination held in 2016. Their names were recommended by the School Service Commission to WBBSE.

Justice Ganguly directed the WBBSE to cancel the appointment of the 1,911 candidates, whose names had been wrongly recommended by the School Service Commission the umbrella authority that conducts recruitment tests for all levels of school services.

While hearing the matter the Court had a few months ago directed the illegally appointed persons to voluntarily tender their resignations so as to avoid returning of their salary. The Judge had then ordered that those who would voluntarily come forward to resign their jobs would not only be allowed to appear in future examinations but also be spared the task of returning their salaries.

However as they would not abide by the earlier Court order "they will now face the harsher consequence," an advocate said.

The court also directed former North Bengal University Vice-Chancellor and the then SSC Chairman Dr Subires Bhattacharya — during whose tenure the scam took place — to disclose the names of the persons who directed him to manipulate the results or else he would be taken to the mastermind of the scam. The court also directed him not to use his doc-



The two Vande Bharat Express trains that Modi inaugurated were Mumbai-Solapur and Mumbai-Sainagar Shirdi trains. He also kick-started two road projects in Santacruz Chembur Link Road and Kurar underpass routes to ease road traffic congestion and streamline the movement of vehicles in

The Mumbai-Solapur and Mumbai-Sainagar Shirdi trains were the ninth and tenth Vande Bharat trains flagged off in the

The first train will improve connectivity between Mumbai and Solapur and will also facilitate travel to important pilgrimage centers like Siddheshwar in Solapur, Akkalkot, Tuliapur, Pandharpur near Solapur and Alandi near Pune. The Mumbai-Sainagar Shirdi Vande Bharat will help improve connectivity to important pilgrimage centers in Maharashtra like Nashik, Trimbakeshwar, Sainagar Shirdi, and Shani Singanapur. Similarly, to ease road traffic congestion and streamline the movement of vehicles in Mumbai, the Prime Minister dedicated the Santacruz Chembur Link Road (SCLR) and Kurar underpass. Having arrived on platform no. 18 of CSMT,



Modi inspected the Mumbai-Sainagar Shirdi Vande Bharat and also interacted with the train crew and the children inside the coach.Addressing a meeting after inaugurating four major projects, Modi said: "It is a huge day for Railways in India, especially for advanced connectivity in Maharashtra as this is the first time that two Vande Bharat trains have been flagged off on

Yogi means business

With Global Investors Summit 2023, the UP CM is laying out the red carpet for investors

Inhen Prime Minister Narendra Modi says that Uttar Pradesh is driving the growth of New India, he is not just lauding the administration of the largest state which is under his own party; he is highlighting the fact that UP has turned the corner. On December 19, around 50 industrialists from different states met Chief Minister Yogi Adityanath for investment opportunities. And now the roadshows for the Global Investors Summit 2023 attracted investment proposals worth Rs 32.92 lakh crore, Adityanath said on Friday. All proposals may not fructify, but even a fraction of that will go a long way in industrialising the state which has suffered for decades because of ideological squabbling, political sloth, and bureaucratic incompetence.



If businesspersons are showing interest in the state, it is because they feel safer than they did in the last few decades. The law and order situation has improved dramatically. This is not to say that under Adityanath, and the 'double-engine sarkar,' the state has become a Ramrajya; but the situation has improved in the last few years. According to the National Crime Records Bureau (NCRB), the state witnessed a decline in the overall crime rate. There were 6.08 lakh crimes in 2021, which was 7.5 per cent less than 6.57 lakh incidents in 2020 and 3.2 per cent less than 6.28 lakh cases registered in 2019. Some of the measures adopted by the state administration have been criticised as harsh, but they

have proved to be effective.

The condition of law and order as a sine qua non of industrial development often doesn't get acknowledged. However, CM Adityanath laid considerable emphasis on reining in mafia dons, organised crime, and other felons. Also, the state Government complemented and supplemented the Centre's works in infrastructure. "Along with infrastructure, UP has changed its 'Soch and Approach' for ease of doing business," PM Modi said. This is much more than smart coinage; this underlines a paradigm shift in the premises and principles that steer a government's policies. Unlike the previous administrations, the Adityanath Government is not focused on the divisive, casteoriented agendas, the agendas that were predicated upon the notion of zero-sum game: that one caste, community, group, etc., can thrive only at the expense of another one. For instance, the state Government's One District One Product (ODOP) scheme has benefited people from all sections and communities. In May last year, the state Government found that more than 72 per cent of the total exports from the state in 2021-22 were from the ODOP scheme. In the ultimate analysis, what attracts investors to a state or country is not the promises it makes but how it keeps them. CM Adityanath has shown that he means business. Importantly, his business is letting businesses do business, not setting up public sector enterprises. Hopefully, he stays the course.

Ballooning crisis

The shooting down of a Chinese balloon by the US could escalate the US-China tension

lmost a direct confrontation between China and the US has sent shockwaves across the world. The US decided to shoot a Chinese balloon which the US claims was a surveillance device hovering over their nuclear facilities in Montana. The incident has sparked outrage in China, with the Chinese government calling the shooting a "provocative act" and demanding an explanation from the US. The latter, on the other hand, has defended its actions, stating that the balloon posed a potential threat to national security. It is not the first time that tension between the two countries have risen over the issue of aerial surveillance. In recent years, both the United States and China have been accused of flying military aircraft and drones into each other's airspace, often leading to diplomatic spats. This latest shooting, how-

ever, marks a significant escalation in tensions, as it marks the first time that a Chinese balloon has been shot down over American soil. munications which satellites can't. If it was a weather balloon as the Chinese claim, they should have informed the US administration as it was flying over US soil. Besides, Chinese activities are suspect across the world. Its hegemonistic designs are now skyrocketing. Allegedly the same balloon was blown over India in the Bay of Bengal to collect sensitive strategic information. China must be made aware by the world that it cannot rule the world just with brute power and its newly found economic might. Though the Chinese balloon mission is over, its intentions of world dominance are not. But the escalation of tension is in nobody's interest. It is now up to both governments to work together to find a peaceful solution to this issue and to prevent it from escalating into a larger conflict.

GIVING GUARANTEES IS NOT INSURERS' JOB

Banks must protect their business of handing out guarantees

ransport and Highways Minister Nitin Gadakari has sarcastically commented that the insurance regulator IRDAI did a 'deep study' for three years on a proposal of allowing 'surety bonds' by insurance companies. He was taking a dig at the IRDAI, while launching the country's first surety bond specially designed for highway projects by Bajaj Allianz insurance company.

He said that he got the idea from former SBI chairman Rajnish Kumar on the following lines: "He told me that there is a concept of surety bond in other countries in place of bank guarantees. I took it up with our finance minister. I would thank IRDAI for their deep study for three years before giving the approval. I thank those who expeditiously approved it in three years. It is better late than never."

When banking circles are wondering how a lucrative business from their portfolio is allowed to be taken out, it is strange that the proposal has emanated from the Government and the banking regulator Reserve Bank of India has not objected to such a proposal

Areas of operation of insurance companies and banking companies are well demarcated. Insurance companies are supposed to do the business of insurance, which means that they are entering into a contract of indemnity



Section 124 of Indian Contract Act 1872 defines Contract of indemnity as "a contract by which one party promises to save the other from loss caused to him by the conduct of the promisor himself, or by the conduct of any other person". Issue of surety bond does not fit into the business of contract of indemnity.

The issue of surety bond belongs to the category of contract of guarantee. Section 126 of Indian Contract Act 1872 defines Contract of guarantee as a contract to perform the promise, or discharge the liability, of a third person in case of his default.

Since the inception of the banking system in India, issuing bank guarantees has been the domain of banks. Though the definition of guarantee provides for 'performing the promise' banks issue guarantees to discharge the liability and also to pay at agreed terms when the promise is not performed by their clients.

When any guarantee is issued, no outflow of funds are involved. It a 'non-fund based' business. But the moment the bank is ca to pay on the basis of guarantee on the failure of its client, it has to discharge the liability and it becomes a fund-based one. Whenever such an eventuality happens, banks pay under the head 'Defaulted Guarantees' and banks have to ultimately recover the amount like any other loan recovery. The RBI has also stipulated various other guidelines for issue of guarantee by banks—(1) It should be for a definite period and definite amount; (2) Maximum period can be 10 years; (3) Claim period should be mentioned; (4) Ceilings for unsecured guarantees; (5) Cannot be repayment of deposits by finance companies, etc.; (6) Provision for confirmation from higher authorities.

In January 2022, IRDAI issued 'Surety Insurance Contracts' guidelines 2022. While the guidelines cover essential features, types of surety contracts, underwriting requirements, etc., it is silent on how the insurance company will recover the defaulted guarantees. It does not contain any stipulation of counter guarantee or collateral security.

When there is strict regulation by the RBI that invoked guarantee should be paid immediately, there does not seem to be any such instruction from IRDAI. Banks do pay for the invoked guarantees immediately so

as to keep the trust of the people on the guarantees issued by them. It is time for the Indian Banks Association and the RBI to retain the business of guarantee with the banks.

Delink disinvestment from Budget exercise



The Union Government must set up a holding company where all of its shares in the Central Public Sector Undertakings (CPSUs) are placed

n Budget for 2022-23, Finance Minister Nirmala Sitharaman had set a target of Rs 65,000 crore for proceeds of sale of Union government shareholding in central public sec-tor undertakings (CPSUs). Against this, the revised estimate (RE) is placed at just about Rs 31,000 crore which works out to 47 per cent of the target. For 2023-24, Sitharaman has set a target of Rs 51,000 crore.

During the last eight years since 2015-16 when this government started disinvestment with particular focus on 'strategic' sale (a sophisticated nomenclature for share sale that reduces its holding in the CPSU to below 50 per cent), barring two years viz. 2017-18 and 2018-19 when the actual proceeds exceeded the target, in the remaining six years, the achievement was far short.

Even during those two exceptional years, the good performance was made possible primarily due to two big ticket sales of Union Government shares in one CPSU to another viz. (i) sale of its 51.11 per cent shareholding in Hindustan Petroleum Corporation Limited (HPCL) to the Oil and Natural Gas Corporation (ONGC) during 2017-18 yielding Rs 37,000 crore; (ii) sale of 52.63 per cent stake in Rural Electrification Corporation (REC) to the Power Finance Corporation (PFC) during 2018-19 yielding Rs 13,000 crore.

These sales can't be termed as strategic as the purchaser being another CPSU namely ONGC/PFC, the Government continues to have effective ownership and control over the divested entity viz. HPCL/REC. An overarching reason as to why the actual proceeds from disinvestment have fallen short of the target has to do with the very premise of treating these as a source of revenue (albeit for plugging fiscal deficit) which is flawed.

In cases where strategic sale is mooted, the government faces a bigger challenge as it needs bidders with deep pockets. For instance, in case of Bharat Petroleum Corporation Limited or BPCL (sale of the entire 53.29 per cent of government's share in this oil refining and marketing CPSU was originally planned for 2019-20), it needed a strategic investor who could pay around Rs 60,000 crore.

The lengthy and cumbersome process of approval and bureaucratic red-tape further undermines the chances of the Government kicking the ball rolling just around the time when the strategic investors are ready to put in their bets.

The Niti Aayog identifies companies for divestment which are then considered by the Core Group of Secretaries on Divestment (CGD), a long-drawn process by itself, which takes it to the Alternative Mechanism (AM) – a group of ministers, including finance, road transport & highways, administrative reforms, etc., - for approval. After AM's approval, the Department of Investment and Public Asset Management (DIPAM) moved a pro-

posal for in-principle approval of the Cabinet Committee on Economic Affairs (CCEA).

This leads to delay and by the time all approvals are in place, the market scenario becomes adverse. For instance, in case of BPCL, during 2019-20, the international price of crude oil (fortunes of oil companies move in tandem with it) was hovering around \$70 per barrel. But the bureaucrats were not ready.

In 2020-21, Covid-19 spoiled the party as the average crude price plunged to a low of \$20 per barrel in April 2020. During 2021-22, even as the price ruled above \$70 per barrel most of the time, the officials were not ready yet again.
During 2022-23, the market turned even more favorable with crude price zooming past \$80 per barrel (courtesy, Ukraine War and resulting disruption in supplies) yet, the government has not pursued; in fact, it seems to have deferred it indefinitely.

Meanwhile, a number of other strategic sales such as Container Corporation or ConCor (30 per cent), Shipping Corporation of India or SCI (63.75 per cent), and DBI Bank have been under consideration since FY 2019-20. They have been hamstrung due to bureaucratic red-tape and uncertainties of the investment environment. The government now intends to complete all these trans-

actions during FY 2023-24. In a post-Budget interaction, Sitharaman reiterated that all CPSUs in non-strategic sectors will be privatized (all loss-making enterprises will be closed), whereas in the strategic sector also, the undertakings will be privatized with the caveat that at least one (and a maximum of four) will be retained in the public sector. To buttress this strategy (as laid down in the Budget for 2021-22), she cited the example of Air India incurring a loss of Rs 20 crore per day when it was under the government's ownership and control.

While this should clear the policy uncertainty, thereby imparting momentum to the process, contrary signals emerge from a statement in FM's Budget speech for FY 2019-20. She had stated the intent was to change the existing policy from "directly" holding 51 per cent or above in a CPSU, to one whereby its total holding, "direct" plus "indirect", is maintained at 51 per cent.

To illustrate this, let us take the case of Indian Oil Corporation Limited (IOCL). In addition to its direct stake of 51.5 per cent, the Union Government holds more than 51 per cent in other CPSUs, which in turn, hold shares in IOCL. Life Insurance Corporation (LIC), which is 95 per cent owned by the GOI, holds 6.5 per cent in IOCL. ONGC which is 63 per cent Government-owned, noids 14 per cent in IOCL. Oil India Limited (OIL), which is 60 per cent owned by the Union Government, holds five per cent shares in IOCL.

The "indirect" stake of the Union Government in IOCL via LIC/ONGC/OIL being 25.5 per cent, it can reduce its direct stake in IOCL to 25.5 per cent (thereby sending a message that it has been privatized) and yet, including the 'indirect" control, it will still have majority stake of 51 per cent.

Privatization could also be stymied in case the government asks another PSU to buy the shares of the CPSU up for strategic disinvestment as happened with HPCL/REC. Although there is an order of the Ministry of Finance (MoF) that prohibits such purchase, a caveat in the order "...unless otherwise specifically approved by the Central Government in public interest" can always be relied upon to make it happen if the powers that be so wish.

To conclude, the very act of linking disinvestment with budgetary exercise is a flawed idea. Even while not guaranteeing the intended receipt from the share sale (as we have seen during the last eight years), it undermines the chances of conducting the exercise in an efficient manner and getting handsome proceeds. The process inefficiencies are aggravated by bureaucratic red-tape and a desire of the top brass to remain in the

The government should delink disinvestment from the budget and pursue it as an objective by itself. It must de-bureaucratise the process by setting up a holding company (HC) where all government shares in CPSUs are placed. The HC to be manned by eminent professionals should be fully empowered and given freedom to take all decisions in regard to valuation, quantum of shares, timing of sale, etc., keeping in mind the market conditions.

Under this arrangement, the share sale process will be faster, more efficient and yield much more revenue.

Turkey's lax policing of building codes flagged before quake

¬urkey has for years tempted I fate by not enforcing modern construction codes while allowing — and in some cases, encouraging — a real estate boom in earthquake-prone areas, experts say.

The lax enforcement, which experts in geology and engineering have long warned about, is gaining renewed scrutiny in the aftermath of this week's devastating earthquakes, which flattened thousands of buildings and killed more than 20,000 people across Turkey and Syria.

"This is a disaster caused by shoddy construction, not by an earthquake," said David Alexander, a professor of emergency planning at University College London. It is common knowledge that many buildings in the areas pummeled by this week's two massive earthquakes were built with inferior materials and



He had been trapped there for 94 hours, forced to drink his own urine to survive.

"Thank God you arrived," he said, embracing his mother and others who leaned down to kiss and hug him as he was being loaded into an ambulance.

For one of the rescuers, identified only as Yasemin, Adnan's survival hit home hard.

"I have a son just like you, she told him after giving him a warm hug. "I swear to you, I have not slept for four days. ... I was trying to get you out."

In Adiyaman, meanwhile, rescue crews pulled 4-year-old Yagiz Komsu from the debris of his home, 105 hours after the quake struck. They later managed to rescue his mother, Ayfer Komsu, who survived with a fractured rib, according the HaberTurk television, which broadcast the rescue live. The crowd was asked not to cheer or applaud to avoid scaring the child, who was given a jelly bean, the station reported.

But the flurry of dramatic rescues — some broadcast live on Turkish television - could not obscure the overwhelming devastation of what Turkey's president called one of the greatest disasters in his nation's history. China calls US House resolution 'political manipulation'

hina on Friday dismissed a US House of ✓ Representatives resolution condemning Beijing over a suspected Chinese spy balloon shot down above US Waters as "purely political manipulation and hyping up."

"China is strongly dissatisfied with this and firmly opposes it," Foreign Ministry spokesperson Mao Ning told

reporters at a daily briefing.
"The resolution by the U.S. Congress was purely political manipulation and hyping up,' Mao said.

The resolution, which passed unanimously on Thursday, condemned China for a "brazen violation" of U.S. Sovereignty and efforts to "deceive the international community through false claims about its intelligence collection

the Biden administration for not acting sooner to shoot down the balloon, but both parties' lawmakers came together on the vote, 419-0.

China insists the object was a civilian weather balloon that had been blown off course, but has not said whom it belonged to or offered other details. Meanwhile, China's

Defense Ministry said it refused a call from Ú.S. Defense Secretary Lloyd Austin following the downing of the balloon because the U.S. Had "not created the proper atmosphere" for dialogue and exchange.

The U.S. Action "seriously violated international norms and set a pernicious precedent," ministry spokesperson Tan Kefei said in a statement issued late Thursday.

"Given that this irresponsible and seriously wrong

create the proper atmosphere for dialogue and exchanges between the two militaries, China did not accept the U.S. Proposal for a phone call between the two defense ministers," Tan said.

China, Tan added, "reserves the right to use necessary means to deal with similar situations.

After initially expressing "regret" over the incident, China's rhetoric has hardened in recent days as the FBI gathers debris from the site of the downing in U.S. Territorial waters off the coast of South Carolina and sends it to the FBI's lab in Quantico, Virginia, for investigation.

Beijing said the U.S. "overreacted" by shooting it down. The Foreign Ministry has labeled the action "irresponsible" and calls U.S. Claims that it was spying "part of the U.S.



Side's information warfare against China."

Austin had sought on Saturday to discuss the balloon issue with his Chinese counterpart, Wei Fenghe, but was refused, the Pentagon said.

In the wake of the incident, Secretary of State Antony Blinken canceled a planned trip to Beijing this week that some had hoped would help stabilize bilateral relations, which have tumbled to their lowest level in

decades over trade, human rights, China's threats against Taiwan and the Chinese military's increasing assertiveness in the South China Sea.

The U.S. Has flatly contradicted China's version of events, saying that imagery of the balloon collected by American U-2 spy planes as it crossed the country showed that it was "capable of conducting signals intelligence collection" with multiple antennas and other equipment designed to upload sensitive information and solar panels to power them.

The U.S. Says the balloon was part of a huge aerial surveillance program that targeted more than 40 countries under the direction of the People's Liberation Army. Similar balloons have sailed over five continents, according to the administration.

A State Department official said the U.S. Has confidence

balloon has "a direct relationship with China's military and is an approved vendor" of the army. The official cited an official PLA procurement portal as evidence.

Publicly available records show several Chinese companies have been developing balloons for military use, with some openly touting their connections with the PLA, advertising airships bristling with surveillance and communications gear.

Such high-tech balloons are often far larger than the hot air balloons used for recreational purposes. The one shot down by the U.S. Was 60 meters (200 feet) tall.

State-owned defense contractor China Electronics Technology Group boasted in 2021 that its JY400 balloon could be equipped with radar and equipment to eavesdrop

Biden, Lula to put focus on democracy, climate during visit



AP WASHINGTON

When President Joe Biden and Brazilian President Luiz Inacio Lula da Silva meet in Washington on Friday, the leaders will share some awareness of what it's like to walk in one another's shoes.

Biden, a centrist Democrat, defeated incumbent Donald Trump in a fraught race, securing victory with thin margins in several battleground states.

In Brazil's tightest election since its return to democracy over three decades ago, Lula, the leftist leader of the Workers' Party, squeaked out a win against right-wing incumbent Jair Bolsonaro, who earned the nickname "Trump of the Tropics" and was an outspoken admirer of the former US president.

Both Trump Bolsonaro sowed doubts about the vote, without ever presenting evidence, but their claims their most die-hard supporters.

In the US Capitol, Trump supporters staged the January 6, 2021, insurrection seeking to prevent Biden's win from being certified. Last month, thousands of rioters stormed the Brazilian capital aiming to oust the newly-inaugurated Lula.

Friday's Oval Office talks, just over a month after Lula's swearing-in and the failed attempt to topple his presidency, are meant to spotlight that Brazil's democracy remains resilient and that relations between the Americas' two biggest democracies are back on track.

"Lula, he has everything on the table right now to be a democratic champion, given what happened in Brazil over the past month and a half," said Thiago de Aragao, a senior associate of the Americas program at the Centre for Strategic and International Studies.

"So, having seen Biden in similar situation during January 6th, this is something that they can together focus on." The leaders are expected to discuss efforts to safeguard democracy, Russia's invasion of Ukraine, insecurity in Haiti, including efforts to stem deforestation of the Amazon, according to a senior Biden administration official who briefed reporters about the meeting on the condition of

India's industrial production growth slipped to 4.3 per cent in December from 7.3 per cent in November 2022, mainly due to subdued performance of the manufacturing sector, according to official data released on Friday. However, there was

improvement on an annual basis as the factory output growth measured in terms of the Index of Industrial Production (IIP) stood at 1 per cent in December 2021.

As per the IIP data released by the National Statistical Office (NSO), the manufacturing sector's output grew by 2.6 per cent in December 2022 from 0.6 per cent a year ago. The growth stood at 6.4 per cent in the preceding month of November

Mining output rose by 9.8 per cent during the month under review, from 2.6 per cent in December 2021. Power generation increased by 10.4 per cent in December 2022 com-



pared to 2.8 per cent in the year-ago month.

As per use-based classification, the capital goods segment recorded a growth of 7.6 per cent in December against a decline of 3 per cent in the corresponding month of the



TON-UP ROHIT, JADEJA PUT INDIA ON TOP

Skipper Rohit Sharma conjured up one his most impressive Test hundreds under pressure against a quality Australian attack as India vaulted to a crucial 144-run lead in the series-opener after ending the day two at 321 for 7, here Friday.

Rohit (120) displayed class and composure of the highest order and in the process became the first Indian captain to have scored a century in all three for-

While Rohit's ninth Test hundred is worth its weight in gold, Ravindra Jadeja's (66 not out) 18th half-century is also priceless. The all-rounder's knock will be equally important in the context of the game.

Jadeja once again showed his true worth by adding 61 runs for the sixth wicket with Rohit and another 81 runs for the unconquered eighth-wicket with Axar Patel (52 batting), who is also playing a fine hand.

It was a battle of attrition for Indian batters, especially Rohit and Jadeja with the home team putting on board 244 runs on the second day.
On a slow track where other

batters found the run-scoring extremely difficult, the Indian captain was concentration-personified.

It had the same class as the 161 he scored in against England in 2021 in the Chennai Test. The opener put his best food forward against an attack, led by spinners Nathan Lyon (1/98) and Todd Murphy (5/82), who got a fivefor on Test debut.

In fact, both the off-break bowlers came round the wicket against right-handers to stem the



flow of runs and succeeded

It took Rohit 171 balls to reach his hundred. He hit 15 boundaries and two sixes in a knock that spanned more than four and half hours.

But the hallmark of his innings was the rotation of strike and how he traded risk for cau-

Todd Murphy has had a "special" couple of days and the bespectacled Australian Test debutant, who resembled more like a professor of history rather than practitioner of finger spin, couldn't be happier for his five-wicket haul against India in the ongoing opening Test here.

Murphy has so far picked up 5 for 82 in 36 overs in India's first innings, with the wickets of KL Rahul, Cheteshwar Pujara and Virat Kohli in his kitty.

"It's been a pretty special couple of days and to top it off with a five-wicket haul on debut is more than I ever hope for and it is going to be something that I'll look back on for the rest of my life and be proud of," Murphy said at the end of the second day's play.

Murphy was all praise for the Indian batters and their ability to use their hands against spinners. "I haven't bowled to a lot of people from around the world but I think

the Indian guys they use their hands really well. They get their hands out in front of their pads and they have got a lot of

scoring options too. 'So always a really difficult challenge there. And it was quite tough," he said. Murphy started out as a medium pacer but later found off-breaks to be his calling card.

"I think in all honesty my medium pace wasn't really any good anyway, so it sort of just came a time where I was tinkering in the nets with offspin bowling and yeah, got some really good feedback that what was coming out of my hand was alright. "So, just went from there and kept working at it and it's been the

best thing I've ever done. So thankful I have," he said.

It has been one hell of a journey for Murphy, who was n't even playing first-class cricket a year back and now has five-for in Tests to boast of.

"I think this time last year I was still not in the state side so it sort of has been quite quick progress," he admitted.
