# **Councillors make spectacle of** themselves; mayoral poll put off

AAP, BJP members in MCD come to blows over swearing in of nominated members first

The country on Friday watched in shock newlyelected MCD councillors raining blows on each other, uprooting mikes and toppling tables and benches in a free for all inside the Civic Centre in the national Capital on Friday. As a result, voting to elect mayor and deputy mayor could not take place.

The next date of mayoral election will be decided and announced by Lieutenant Governor Vinai Kumar Saxena.

Visuals from the meeting showed shocking scenes of AAP and BJP workers hitting and pushing each other, hurling tables and chairs and even climbing on desks inside the meeting room of Civic Centre of the Municipal Corporation of Delhi (MCD).

The Congress members walked out of the House amid allegations by the AAP that the party has struck a deal with the BJP. The AAP said never in the history of MCD has nominated members taken oath first and claimed that around a dozen of its councillors got

injured during the scuffle. On the other hand, the BJP claimed seven of its councillors sustained injuries and a couple

of them were attacked by sharp According to MCD officials, it was for the first time in the history of the civic body that a newly elected House

failed to elect a mayor and deputy mayor in its maiden The meeting began with being administered the oath as presiding officer for the elections to the posts of mayor and deputy mayor. The scuffle began after the presiding officer invited nominated councillors or aldermen (those who traditionally cannot vote) to take oath ahead of the elected members (those who can vote). After Sharma invited alderman Manoj Kumar to take his oath, AAP MLAs and councillors raised slogans against the BJP and Prime Minister Narendra Modi. Many also rushed to the well of the House.

The BJP councillors retaliated, raising slogans against the AAP and its national convener Kejriwal. The councillors of both parties were seen pushing and shoving each other. Amid the din, the House was adjourned for over an hour. The situation remained chaotic even after the House was

The LG office has been informed about the ruckus in the MCD House by Municipal Secretary Bhagwan Singh and Commissioner Gyanesh Bharti. The oath taken by the four aldermen is valid," Śharma said. The next date for the MCD House meeting will be declared by the LG office, she said.

The AAP has alleged that the BJP made the alderman take oath first in order to get them voting rights for the election to mayor and deputy mayor. AAP members said elected councillors should have been sworn in before the nominated members.

Delhi Chief Minister Arvind Kejriwal termed the move to invite the nominated councillors for taking oath ahead of the elected ones in the mayoral polls unconstitutional. "Article 243R of the Constitution clearly debars nominated members from voting in the House. Attempting to get them to vote in the House is unconstitutional," Kejriwal tweeted sharing the snippet of the

American banking sector giant Wells Fargo has sacked the Vice President of its Indian operation Shankar Mishra for allegedly urinating on an elderly woman on an Air India flight on November 26.

A four-member Delhi Police team on Friday afternoon landed in Mumbai in search of Mishra, but found his home locked. The Delhi Police has called the pilot and other crew members of Air India flight AI-102 from New York to Delhi in connection with the case of Mishra.

In another development, Mishra on Friday cited the woman's WhatsApp messages to claim that she had "condoned the alleged act" and had shown no intention to file a complaint. "A settlement was made and compensation was paid to the elderly woman on November 28, 2022 but the money was returned by the woman's daughter December 19, 2022," Mishra's lawyers said in a statement.

The company in a state ment on Friday said the allegations against Mishra were "deeply disturbing". "This individual has been terminated from Well Fargo," the firm said in a statement.

The company further said it held its employees to the highest standards of professional and personal behaviour and found these allegations deeply disturbing. "We are cooperating with law enforcement and ask that any additional inquiry be directed to them," the statement added.

# Centre stopping PMGKAY free rice hits poor: BJD BJP says BJD no longer can claim

PDS rice scheme as its own

The spar between the BJD and the BJP that began over Union Government's recent move to scrap the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) intensified on Friday as the former said such a step "harmed" the interests of lakhs of poor people in the State.

BJD national spokesperson Dr Sasmit Patra said Odisha's 3.5 crore people were receiving 10 kg of rice since the introduction of the PMGKAY.

"While a beneficiary gets 5 kg rice under the National Food Security Act (NFSA), another 5 kg was given under the Pradhan Mantri Garib Kalyan Anna Yojana. Now that the Centre has discontinued



getting 10 kg rice a month, will get only 5 kg of it. How can he or she survive with only 5 kg?" questioned

To drive his point home, he gave the example of a poor family of six members living in Balangir's Tusra

"The 5 kg of rice the poor people of Odisha were receiving has been stopped by the Centre. A six-member family of Basant Dharua of Tusra area in Balangir district received 60 kg of rice a month. After the withdrawal of the Pradhan Mantri Garib Kalyan Anna Yojana, the family will now get 30 kg. Can you imagine the hardship for the family after taking away 30 kg from his quota? From now on, Dharua has to buy this rice with the money he would otherwise have to spend on medicine or something else," said In response to the allegation, BJP

State general secretary Golak Mohapatra said, "Finally, Dr Sasmit Patra has accepted the truth. There is a saying in Odia that 'Hanu Mala Belaku Sata Kahe' (The monkey speaks the truth before its death). It seems the BJD's end is near because Sasmit Patra accepted today that the Prime Minister had been providing rice and stopped it now. Previously, the BJD was claiming that it was providing rice to the poor. You (Patra) have to be thanked for accepting the truth that PM

Narendra Modi was giving it and not your party."

'The fact is that the price of 1 kg of rice provided under the Public Distribution System (PDS) was Rs 37.28. Of it, the Centre's contribution and the Odisha Government's contribution stood at Rs 34.28 and Rs 2, respectively. The beneficiary was buying the rice at 1 rupee only. Now, the Centre has decided to bear the entire cost of PDS rice. This decision has left the BJD in the lurch as it was showcasing the PDS rice scheme as its own and thereby reaping huge electoral benefits," said Mohapatra, adding that from now onwards, people of Odisha would receive only Modi's rice. The Union Government spends

nearly Rs 8,444 crore per annum to provide free rice to 3.25 crore of Odisha people under the NFSA. On the other hand, the State Government spends Rs 185 crore per annum as its matching share for implementation of the NFSA.

# HC asks CB to take over Soumya death case



With investigation of the mysterious death of aspiring model Soumya Ranjan Panigrahi making no headway even after a year, the Orissa High Court on Friday directed the Crime Branch (CB) to take over the case and submit a report within three months.

The order came during hearing of a plea of Soumya's sister Soubhagyalakshmi who has alleged that even after the High Court directed the Bhubaneswar DCP to take necessary steps to speed up investigation and update the family members about the probe within a stipulated time, no such response has been made. On January 30 last year, Soumya allegedly died by suicide in Kalarahanga under the Infocity police limits of Bhubaneswar. He was found hanging in his residence; and a note, purportedly written by him, had been recovered from the spot. The letter named a girl with whom Soumya was reportedly in a relationship but was going through a rough patch after getting to know

that she was developing intimacy with another person. While Soumya's family members held the girl accountable for his death, Soumya's sister filed a

complaint with the Infocity

police two days later.

Soubhagyalakshmi sister had, however, alleged that police did not cooperate. On February 19, she even approached the DCP but reportedly got no response even there. Distraught over lack of cooperation by the police, she moved the HC on February 23, after which the court had directed the DCP to update the kin of the deceased about the progress in investigation within three weeks' time. But even after the HC order, the family did not get any information on what steps were being taken by the police to find out the exact cause of Soumya's death.

Consequently, Soubhagyalakshmi once again filed a petition basing on which the High Court, in a hearing, directed the Crime Branch to take over, informed the family's lawyer Byomkesh Tripathy.

# Final Electoral Rolls: 3.23 cr voters in State

Odisha Chief Electoral Officer (CEO) SK Lohani published the final Electoral Rolls of 146 Assembly constituencies of the State on There are Thursday. 3,23,49,341 voters of which 1,64,96,153 are males, 1,58,49,966 females and 3222 belong to the third gender.

The CEO's office said the revision of the electoral roll was not done in the Padmapur constituency due to a byelection there. The revision of electoral roll in Padmapur would commence from January 6 next.

The draft photo electoral rolls of 146 Assembly constituencies had been published on November 9, 2022. Claims and objections for deletion, addition, correction in electoral rolls and transfer of names from one location to another were received from November 9,

2022 to December 8, 2022.

During the revision, 5,94,613 names were approved for first-time enrolment of names; 3,20,506 names were approved for deletion; and 2,14,000 were approved for the correction of names and other details.

In addition to it, 78,260 advance applications from the 17-plus age group prospective voters were also received during the revision programme. The applications would be disposed of in subsequent phases and would be enrolled in the respective quarter of the year. EPIC cards would be door-delivered through speed post to the voters free of cost after enrolment.

CEO office sources said that during the revision, special focus was given on enrolling more and more electors from the marginalised sections of the society like PVTGs, third genders, sex workers and

persons with disability (PwD). In the 2023 draft electoral rolls, the gender ratio was 959, which has been increased to 961 in the final electoral rolls. The number of electors in the age group of 18-19 has increased from 2,10,268 in the draft electoral rolls to 4,46,779 in the final rolls. As many as 7,464 PwD electors have been

The percentage of photo electors in the final electoral rolls, 2023 has increased to 99.99% from 99.74% in final electoral rolls in 2022. The number of service voters increased to 49,919 in the final electoral roll 2023 from 49,897 in the draft electoral roll 2023.

Due to changes in the names of schools, the nomenclatures of 21,219 polling stations have been changed while location of 373 polling stations have been changed with the approval of the Election Commission of India (ECI).

On the other hand, Sports Minister Tusharkanti Behera said the International Hockey Federation (FIH) has certified the Birsa Munda Hockey Stadium as world's largest one in terms of seating capacity.

Sports journalist Jaspreet Sahani said the Birsa Munda Hockey Stadium is the largest hockey stadium constructed solely for the purpose of hockey matches.

The hockey stadiums in Lahore and Chandigarh are part of sports complex.



# **DGCA** issues stern directive to all airlines

'While tackling unruly flyers, use restraining devices when all conciliatory approaches are exhausted'

Days after two incidents of drunk men urinating on women on Air India flights came forth, the Directorate General of Civil Aviation (DGCA) on Friday issued an advisory to the Head of Operations of all Scheduled Airlines for tackling unruly travelers outlining that "restraining devices should be used when all conciliatory approaches have been exhausted". The advisory warned that the airline staff will face action if they fail to act against passengers who are unruly or behave inappropriately.

The DGCA has also sought

a report from Tata Groupowned Air India on an incident of a drunk passenger allegedly urinating on the blanket of a female passenger on the airline's Paris-New Delhi flight last month, which it did not report to the regulator. Air India on Thursday confirmed the incident, which took place on December 6 last year.

"In case a situation - relating to handling an unruly passenger comes up, the pilot-incommand is responsible for assessing the situation quickly if the cabin crew can control the situation and accordingly



airline's central control on the ground for further action. If it becomes difficult to handle the situation with "verbal communication", applying restraining devices should be used when all conciliatory approaches have been exhausted," the advisory said.

"Head of operations are hereby advised to sensitize pilots, cabin crew and Directorin-flight Services of their respective airlines on the topic of handling of unruly passengers through appropriate means under intimation to DGCA" - the advisory reads.

"Non-action/ inappropriate action/ omission by the airlines towards such untoward incidents has tarnished the image of air travel in different seg-

"In the recent past, DGCA has noticed a few incidents of unruly behavior and inappropriate conduct by the passengers on board the aircraft during flight, wherein it is observed that post holders, pilots and cabin crew members have failed to take appropriate actions," the statement reads.

Earlier, the DGCA on Thursday issued notices to the officials and crew of the New York-Delhi flight, asking why action should not be taken against them for "dereliction" of duty while handling the November 26 'urination' incident. The DGCA held that Air India's conduct appeared to be "unprofessional" in the two

# Airport passes with 'distorted' map of India withdrawn, AAI to conduct enquiry: BCAS

es, an official privy to the development said. In a communication to the chairman of the Airports Authority of India (AAI), the BCAS said the embedded holoaccording to the sample hologram approved by the BCAS. "Keeping in view the seriousness of the issue, it is hereby directed that all Aerodrome Entry Permits (AEPs) issued with holograms shall be withdrawn and further printing with these hologram roll shall be stopped with immediate effect," the letter said.

The BCAS also conveyed that the AAI will conduct an inquiry in the matter, find out at which level the lapses occurred, who is responsible for procuring these hologram rolls and take appropriate

action against the responsible officers. The AAI has been directed to submit an action taken report on the issue to the BCAS at the earliest, it said. A person, who is not a passenger with a valid ticket, requires an AEP that is issued by the air-The AEP application form,

which is issued by the BCAS, mentions 13 zones that a person can enter. The permitted areas include the arrival halls, the departure halls, the terminal building, the apron area, the security hold area, cargo terminal among others.

Covid-19 changes the male immune system, the researchers said. Scientists have long believed that the immune system reverts to the previous stable level after viral infection. However, the latest study published in the journal Nature, shows that it depends

on the individual's sex.

National Institute of Allergy and Infectious Diseases (NIAID) systematically analysed immune responses

The team found that Researchers at the US immune systems of men who had recovered from mild cases of Covid-19 responded more robustly to flu vaccines than women who had mild cases or men and women who had never been infected.

The baseline immune statuses in men previously infected with SARS-CoV-2 were altered in ways that changed the response to an exposure different from SARS-CoV-2, the researchers said. "This was a total surprise," said John Tsang, an immunobiologist at Yale University in the US, who was previously at NIAID.

"Women usually mount a stronger overall immune response to pathogens and vaccines, but are also more likely to suffer from autoimmune diseases," Tsang said.

The findings may also be linked to an observation made early in the pandemic: Men were much more likely to die from a runaway immune response than women after contracting the Covid-19 virus.

Their analysis of immune system status down to the individual cell level showed several differences between COVIDrecovered males and healthy controls and COVID-recovered females, both before and after receiving flu vaccinations.

For instance, previously infected males produced more antibodies to influenza and produced increased levels of interferons, which are produced by cells in response to infections or vaccines.

# Cooperative federalism touching new heights under Modi: Officials

With Prime Minister Narendra Modi chairing the ongoing second national conference of chief secretaries, official sources on Friday said the government has heralded a "new era of cooperative federalism" by making the process of policy making and implementation more collaborative and consultative.

Having been a chief minister for close to 13 years himself, Modi knows that the key to development for states is availability of sufficient resources. Taking a significant step in this direction, his government took

share in the divisible pool of taxes from 32 per cent to 42 per cent. This has provided them more resources to design and implement programmes as per their needs, they said. Another example is the

GST Council where both the Centre and states are partners in decision-making. The workings of the council are an example of fiscal federalism with reliance on decision making through consensus, they

Modi has also initiated the unique concept of Pragati, the Information Communication Technology (ICT) based multi-modal plat-form for "Pro-Active Governance and Timely Implementation" (Pragati), involving the Centre and states.

# ₹10 cr in fake a/cs found in cattle case: CBI | Apex court stops HC order staying

Gopal Ghosh died a couple of years ago. But even after his death he managed to open a bank account. At least the records seized by the Central Bureau of Investigation (CBI) probing the cow smuggling case that has seen Trinamnool Congress strongman and Trinamool Congress' Birbhum district president Anubrata Mondal go to jail --- say so. This, whereas the deceased person's brother says that he has no idea of the account of his brother being used by others. "We don't even know that an account was opened in the name of my dead brother," said his brother.

Similarly Sundari Basaki who lives in a mudded house too has an account in the same cooperative bank but she has no idea of how many lakhs have been transacted through that account. "I have not signed

illiterate ... I have not opened any account ... but here you say that I have an account ... it is a bolt from the blue ... several lakhs of rupees were parked in my bank and here we don't have two square meals to eat," says Sundari.

These are only two of 177 instances that the CBI has stumbled upon in a day-long raid in the Suri Cooperative Bank. In course of investigating the cow smuggling case the CBI has found that the accounts were used to legalise crores of rupees allegedly earned from cattle smuggling. Till now trace of Rs 10 crore has been found, CBI sources said adding most of these accounts either belong to dead or non-existent persons or poor villagers who have no inkling of the whopping amount of money that were transacted through their

scamsters managed to get documents required to open accounts relatives of Mamata Mridha another account holder said, "we had submitted copies of our Aadhar, voter cards etc for MNREGA job cards but it seems that they have misused these documents for their purpose."

The CBI is known to have traced the link of the ill-gotten money to Food Department too. According to sources the proceeds from the cow smuggling were used to purchase low quality crops, mostly rice from the farmers and then these were sold to the Food Department. The payments were then received in the fake accounts, sources said.

Incidentally Mondal and his associates had purchased a number of rice mills worth crores in Birbhum and neighbouring Burdwan districts.

The officials on Friday



grilled Abhishek Samanta, the manager of the Cooperative Bank, a state government controlled entity. Samanta is known to have provided crucial information to the investigators, sources said adding the total amount thus transacted may go far beyond Rs 10 crore.

Later, a division bench of the high court refused to interfere with the order of the single judge bench, prompting the petitioners to an appeal in the top court. Meghalaya Chief Minister

Conrad K Sangma and his Assam counterpart Himanta Biswa Sarma had in March last year signed an MoU for demarcating the border in at least six of the 12 contested locations that often raised tensions between the two states. On March 29 last year, the agreement was signed in the presence of Union Home Minister Amit Shah by the Chief Ministers of Assam and Meghalaya.

The pact sought to resolve the protracted dispute in six of the 12 places along the 884.9km border between the two states. The boundary dispute between Assam and Meghalaya has lingered for 50 years. However, efforts to resolve it have gained pace in recent

In the last two years, Tiwari said the BIS has granted the

# Participation of girl cadets more than doubled in past decade: NCC D-G

Talking about the future plans of the NCC, Singh said training is being revamped and use of simulators for training is being increased. At pre-



sent the NCC is using 98 firing simulators, 71 rowing simulators, and 62 flying simulators.

# **UP's dream**


Yogi Adityanath will have to rein in saffron activists if he wants the film city project to be successful

The Uttar Pradesh Government seems to be serious about its dream to make the state a film-making centre. Chief Minister Yogi Adityanath on Thursday met a number of leading lights of Hindi cinema on Thursday for the purpose. In fact, the state has been trying to attract the film industry for quite some time. Film City came up at Noida decades ago, but it eventually got occupied by television news channels. Undeterred by the failure of Noida's Film City to become a major film centre, the Chief Minister interacted with several people from the film fraternity, including producer Boney Kapoor, actor Ravi Kishen (who is also Lok Sabha MP from Gorakhpur), Bhojpuri actor Dinesh Lal Nirhua, playback singers Sonu Nigam and Kailash Kher, actor Suniel Shetty,



and filmmakers Chandraprakash Dwivedi, Madhur Bhandarkar, and Rajkumar Santoshi. A day earlier, the Chief Minister had met actor Akshay Kumar. After the half-an-hour-long meeting, Kumar said, "Many big production houses, producers, directors and actors are waiting for the UP Film City. The development of worldclass film and infotainment city in UP will provide a new option to the cinema world." If that happens, UP will see a lot of economic development and employment generation. As the largest Hindi-speaking state, UP is quite apt to have a film centre. With the state administration keen on a film city, it can become a reality in the foreseeable future. So far, so good. However, it takes more than political will and

administrative support to develop a film city; it also requires a socio-cultural milieu in which creative arts can flourish; and it is here that the shoe pinches. UP, like most other parts of the Hindi heartland, is dominated by the Bharatiya Janata Party and its front organisations. One of the biggest ailments that the saffron party is afflicted with is a kind of split personality disorder. Party leaders and Government functionaries talk about world-class infrastructure, state-of-the-art facilities, the latest technologies like artificial intelligence and machine learning, and so on; they also walk the talk, as evident from the various policies and programmes that the Centre and BJP Governments in states are implementing. Anyone viewing such developments would say that these guys belong to the 21st century. But, unfortunately, many of them also belong to the 17th century; one just has to notice their views on cows and mythology to realise this fact. Many centuries live in the BJP. The 21st century BJP may want UP to emerge as a prominent film centre, but will the medievalists let that happen? That is the moot question. It is a well-known fact that cinema gets the worst treatment from the enemies of free speech; also, most of these enemies are from the Hindutva camp. Ahead of civic polls, Eknath Shinde govt holds 1st global Marathi conference to woo 'Marathi manus'

Then it comes to garnering votes nothing comes to the time-tested plank of regionalism. Playing to the sentiments works like a charm, and if it is Maharashtra it works wonders. Years back Balasaheb Thackeray mobilized people with his call to 'Marathi Manush'; years after he is gone Eknath Shinde and his breakaway faction of Balasahebanchi Shiv Sena are stepping into his shoes to woo the Maharashtra sentiment with his slightly different pitch to Marathi language and playing to the gallery by stoking the border dispute with Karnataka. He is of course backed by the BJP. In his opening address, Kesarkar said, "The aim is that Mumbai is the capital of the Marathi language and the language should be preserved here. Today, our own children have started talking to us in Hindi. That needs to stop. We decided to have the event in Mumbai because Mumbai's spirit is Marathi ..." In a sentence,

he almost laid out the reason of the conference. The Minister forgot that he was talking about the national language Hindi which he thought was bad. Mumbai is a cosmopolitan city, it always was and every Maharashtrian is proud of it. The Marathi language is vibrant, not a dead language that needs to be restored. This could leads to yet another wave of anti-north sentiment. Taking the narrative forward, Eknath Shinde said the conference was a step forward towards the ideology of Shiv Sena supremo Bal Thackeray, where 'Marathi manus' (Marathi-speaking population) was at the centre and should have a say in the system. He should not be driven out of Mumbai. The Marathi Manus pitch works in Mumbai, especially in civic polls. It would be interesting to note what the BJP, the nationalist party makes of the parochial pitch.


# Yak, the ship of high altitudes rules NE

recent visit to Dirang in the West Kameng Pradesh, known as "Arunachal's best-kept secret", proved to be exciting and purposeful. It took me to the Indian Council of Agricultural Research - National Research Centre on Yak (ICAR-NRCY). The Institute is one of a kind. It derives a major source of motivation and strength from its prime research animal- Yak. It is the most resilient creature on earth as it can survive in extreme cold (up to -40 degree centigrade) and hypoxic conditions of highaltitude terrain. Yak sustains the highlander communities across the Trans-Himalayan region by providing them with much-needed milk, meat, wool, hide, and dung and transportation services. The population of Yak in the country stands at 58,000 as per the latest census (2019). The majority of them are found in three major Yak-rearing states-Arunachal Pradesh, Ladak, and Sikkim. The Institute prepares its strategy by taking cues from the existing ground realities in the Yak belt of India.

The main concerns are the drastic fall in the yak population of Ladakh and the dreadful incident of unprecedented snowfall and the severe feed scarcity resulting in the deaths of hundreds of Yaks in Sikkim in 2019. Considering the uncertain situation of Yak owners, the Institute convinced the National Insurance Company Limited (NICL) to provide Yak insurance to sustain the tribal pastoralists in the event of natural disasters and mishaps. To promote Yak entrepreneurship and attract the younger generation to this occupation, the Institute roped in NABARD to provide credit support for Yak farming from leading banks. This unique bond of mutualism forged between Yak and Yak pastoralists serves critical intangible roles like biodiversity conservation, environmental sustainability, and preservation of cultural heritage. Recently, the Institute has signed five MOUs in the areas of value addition of Yak turesque lush green hills, wool, poultry farming to supple-



Yak farmers, collaboration in teaching and research, and providing good healthcare facilities to the Institute staff at cost-effective rates. According to Dr Mihir

Sarkar, Director, ICAR-NRCY, "The Institute has been carrying out cutting-edge research in the fields of Yak production, reproduction and health while providing scientific knowledge and technical support to the Yak rearers (Brokpas)." Besides conducting research, the institute has a strong and active dimension regarding technology dissemination and awareness. The important research highlights include checking the effectiveness of synch protocol and timed Ártificial Insemination in Yaks, designing the blueprint for portable and detachable animal shelters for young ones and milking yaks during migration, identifying the most suitable maize fodder and grain variety to be grown at 5500 ft. above mean sea level. To disseminate knowledge regarding scientific Yak Husbandry, an informative mobile app called "Yak- The Ship of the High Altitude" was launched, recently",.



# India must tax MNCs for revenues here



Ideally, the source country from where an offshore firm is deriving its income should have sole right to collect tax

ver the years, an increasing share of the income generated globally has gone towards boosting the profits. The proportion of corporate profit in global GDP (gross domestic product) went up from 14.5 per cent during 1975 to 16.2 per cent in 2000 and further to 20 per cent during 2019. The growth in profit, in turn, was driven largely by multinational companies (MNCs) – companies which operate in several jurisdictions. Their share in corporate profit increased from four per cent during 1975 to 18 per cent during 2019.

Even more disconcerting is the fact that such companies didn't pay taxes in countries from where they earned profits (call them 'source countries'). According to the Organization for Economic Co-operation and Development or OECD, corporate tax avoidance costs countries anywhere from \$100 billion to \$240 billion annually, equivalent to 4-10 per cent of global corporate income tax revenues.

Developing countries are disproportionately affected because they tend to rely more heavily on corporate income taxes than advanced economies. India is losing about \$10 billion annually.

MNCs don't pay tax in source countries by taking recourse to a disingenuous practice of registering their subsidiaries in low-tax countries such as Singapore, Mauritius, and Ireland, and showing their revenue and profits there regardless of where their sales are made. Over time, this practice has proliferated as is evident from the fact that the share of multinational profits booked in tax havens increased from less than two per cent in the 70s to over 37 per cent in 2019.

To better understand the dynamics, consider an MNC, say Amazon, whose home country is the US; it has all its customers located in India who buy goods and services on former's on-line platform and it has a 100 per cent investment arm/subsidiary registered in a low-tax jurisdiction, say, Ireland.

If Amazon were to have a subsidiary registered in India and record the revenue from sales to Indian customers in this very subsidiary (this indeed is the right way to go), it would have paid tax on such income to the Government of India. But it does not follow this route. Instead, it asks its subsidiary in Ireland to raise invoices on Indian customers even as the Indian entity is crafted more like a service company or commission agent to the parent firm.

Since the revenue is recorded in the books of the Irish subsidiary, the right to collect tax is vested with the Government of Ireland. Being a tax haven, Amazon either pays very little or no tax in that jurisdiction. Not having to pay any tax in India either (as no income is shown here), it gets away with not paying tax anywhere.

The plan also says "no newly enacted digital services taxes (DSTs) or other relevant similar measures will be imposed on any company from October 8, 2021, and until the earlier of December 31, 2023, or the coming into force of the MLC (multilateral

The deal is heavily tilted in favour of the developed countries and brings little gain for India. Picking up from the above example, the plan requires Ireland to impose a minimum tax of 15 per cent in which case Amazon will have no incentive to continue with its subsidiary in that country. In case, Ireland keeps the tax rate

at a lower level say 10 per cent or even 'nil' then the US would impose a top-up tax of 5/15 per cent that would bring the effective rate to 15 per cent. This is in sync with a law

enacted by the Trump administration (2017) to impose" Global Intangible Low-Taxed Income (GILTI). GILTI is applied on the offshore income of US-based MNCs having subsidiaries in low-tax countries at 10.5 per cent. The incumbent President Joe Biden wanted GMCT - the new face of GILTI - to be set at 21 per cent but was eventually lowered to 15 per cent.

The big question is: Can the S – the home country of Amazon collect tax on the profits of its subsidiary in Ireland despite the fact that the latter's income is derived mostly from Indian customers and that the GOI has a right to collect tax on it? This brings us to the second pillar.

The plan allocates to the 'source' country (read: India) taxing rights only to the extent of 25 India from where the MNC/Amazon gets all its revenue and profit be treated as residual, getting the right to tax only 25 per cent? On the other hand, how can the US, which has no contribution to revenue, get away with collecting tax on 75 per cent of the

The initial game plan of the US and other developed countries which are home to MNCs operating from tax havens was to garner

all of the tax on profits booked in those jurisdictions. Now, they have made developing countries sign on a deal which enables them to collect tax on 75 per cent of these profits. This is patently unfair and violates the spirit of the OECD as reflected in its draft paper on "Taxing digital companies" released on October 9, 2019 stating: "Profits of MNCs should be available for taxation in the country where their customers are, irrespective of any physical presence in that market.

As for GMCT, far from any help in addressing the problem of profit shifting and resultant loss of tax revenue, the requirement to impose a minimum tax will take away from India the policy space to lower the tax and attract foreign investment.

To conclude, ideally the source country (read: India) from where an offshore firm is deriving its income, should have the sole right to collect tax on it. Yet, if at all 'non-source' countries are to be given something, they should get to tax on residual basis say 20-25 per cent. India should also pester OECD to drop the GMCT idea; countries should have the freedom to decide the tax rate.

India should also not agree to withdraw the 'equalization levy' (a DST introduced in 2016/2020 in lieu of tax on profits) which under the OECD action plan is required to be done before the new tax rules take effect. The levy should be withdrawn on the date the new regime comes into force.

# Should free trade agreements have a shelf life?

Sunset clause constitutes a critical lever to bring a partner to negotiating table for rebalancing through mid-course corrections

n this jolly season one could easily recall a staple American Christmas comedy trilogy where the protagonist is subject to a legal technicality known as "The Santa Clause" (which is also the film's title) and has to accept all of Santa's duties and responsibilities therein. By the time the third sequel was made, the producers had appended the title "the Escape clause", which begets the question: should agreements have a shelf life?

More recently, one can recall the furor created by the sunset clause in the recent US-Mexico-Canada Free Trade Agreement or USMCA (successor to the expired NAFTA). The sunset clause provision states that the agreement shall terminate 16

years after it enters into force takes "review" of the agreeunless certain conditions are met. The condition starts with a "joint review" of the agreement after six years. At this review, if the three governments express their desire to continue the agreement, the term gets further extended for 16 years from the time of this review.

After another six years have elapsed from the time of the first review, there will be another review and the process will keep getting repeated with extensions for

next 16 years at each review. Critics argue that while there is nothing wrong with updating agreements to keep up with changes in the economy and to fix flaws that have been discovered, but such a

ment to a whole new level.

Let us take a step back here and see what has historically been the shelf life of trade agreements. We know that it was not until the 19th century that the idea of free trade was seeded. The World's first free trade agreement, the Cobden-Chevalier Treaty, was put in place in 1860 between Britain and France, which set off a number of similar treaties in Europe. This "golden age of free trade" in Europe, however, lasted only until the 1880s, whereafter, the rise of protectionism in Germany, the United States and elsewhere made the

treaties irrelevant. In fact, the evolution and find roots in the series of flipflops between liberalisation and protectionism in the trade policies of the developed world. However, post second world war, with the formation of GATT, the larger objective within the democratic west became to pursue a more ambitious and permanent lowering of duties across board and to diminish a country's ability to pull back given concessions.

Even so, today the idea of winners and losers" in trade liberalization following an FTA, is increasingly influencing domestic politics even in the west. Many criticize what they allege to be a "democratic deficit of trade agreements" - limited as they are in their ability to be amend-

long-term changes in the

ecosystem. Adding to the woes of the developing world is the fact that the developed countries, who have a penchant for compelling their trade partners to maximise the tariff concessions, then use nontariff means to undermine those concessions. This often acts as a disincentive for developing countries to pursue ambitious FTAs.

Though Article 62 of the Vienna Convention on the Law of Treaties provides for a unilateral right to terminate or suspend a treaty in case of a fundamental change of circumstances, it sets a rather high bar to clear for termination of FTAs.

The question arises as to provision of a sunset clause demise of trade agreements ed in accordance with the how do we recalibrate signed advantage. Why would the

FTAs and successfully initiate measures to rebalance the commitments that have been made to trade partners.

A sunset clause which has an 'Opt-in' option for its continuation spurs the partners to take affirmative action to recalibrate and is perhaps more effective than a sunset clause with an 'Opt-out' option where the default option is to continue with the FTA.

The argument being that the entrenchment effect of not having this 'Opt-in' provision diminishes the incentive to go for a mid-course correction, especially if one party is reluctant to come to the negotiating table - fearing that they may have to let go of an undue

gainer come to the negotiating table to cede an advantage - unless compelled to. A case in point being the India-Japan CEPA which is long overdue its mid-term review.

Though a conventional liberalist narrative voices deep concerns on using sunset clauses to regulate temporary and transitory issues, yet in the long run the sunset clause constitutes a critical and underappreciated lever to bring a partner to the negotiating table for rebalancing through mid-course corrections, especially if the continuation in-force hinges on it.

On a lighter note, a periodic reaffirmation of commitments and rebalancing is always a good idea for any relationship—trade or

Putin did not appear to make his cease-fire order conditional on Ukraine's acceptance, and it wasn't clear whether hostilities would actually halt on the 1,100-kilometer (684-mile) front line or elsewhere. Ukrainian officials have previously dismissed such Russian moves as playing for time to regroup their invasion forces and prepare additional attacks.

At various points during the war that began Feb. 24, Russian authorities have ordered limited, local truces to

"Based on the fact that a large number of citizens professing Orthodoxy live in the combat areas, we call on the Ukrainian side to declare a cease-fire and give them the opportunity to attend services on Christmas Eve, as well as on the Day of the Nativity of Christ," according to Putin's order to Defense Minister Sergei Shoigu, published on the Kremlin's web-

ness for peace talks came with the usual preconditions: that 'Kyiv authorities fulfill the well-known and repeatedly stated demands and recognize new territorial realities," the Kremlin said, referring to Moscow's insistence that Ukraine recognize Crimea and other illegally seized Ukrainian territory as part of Russia.

# Kremlin-ordered truce uncertain amid suspicion of motives

The impact of Russian President Vladimir Putin's order for his forces in Ukraine to observe a unilateral, 36-hour cease-fire was in doubt Friday after Kyiv officials dismissed the move as a ploy but didn't clarify whether Ukrainian troops would follow suit.

Moscow also didn't say whether it would hit back if Ukraine kept fighting.

The Russian-declared truce in the nearly 11-month war began at noon Friday and was to continue through midnight Saturday Moscow time (0900 GMT Friday to 2100 GMT Saturday; 4 a.M. EST Friday to 4 p.M. ÉST Saturday). There were no immediate

reports of it being broken.

Putin's announcement Thursday that the Kremlin's troops would stop fighting along the 1,100-kilometer (684-mile) front line or elsewhere was unexpected.

It came after the Russian Orthodox Church head, Patriarch Kirill, proposed a cease-fire for this weekend's Orthodox Christmas holiday.

The Orthodox Church, which uses the Julian calendar, celebrates Christmas on Jan. 7.

But Ukrainian and Western officials suspected an ulterior motive in Putin's apparent goodwill gesture. Ukrainian President

Volodymyr Zelenskyy questioned the Kremlin's intentions, accusing the Kremlin of planning the fighting pause "to continue the war with renewed vigor."
"Now they want to use

Christmas as a cover to stop the advance of our guys in the (eastern) Donbas (region) for a while and bring equipment, ammunition and mobilized people closer to our positions," Zelenskyy said late Thursday.

He did not, however, state outright that Kyiv would ignore Putin's request.

# US to send Ukraine dozens of Bradleys in USD 2.85 billion aid package

The US will send Ukraine nearly USD 3 billion in military aid, in a massive new package that will for the first ime include several dozen Bradley fighting vehicles, US officials said on Thursday, in the Biden administration's latest step to send increasingly lethal and powerful weapons to help Ukraine beat back Russian

The aid — totalling about USD 2.85 billion — is the largest in a series of packages of military equipment that the Pentagon has pulled from its stockpiles to send to Ukraine.

It is aimed at getting as much to the Ukrainian forces as possible during the winter months, before spring sets in and an expected increase in fighting begins.

An announcement is expected Friday, said the officials, who spoke on condition of anonymity because details of the package have not been publicly announced. The Bradley fighting vehi-

cles is a medium-armoured

combat vehicles that can serve as a fortified troop carrier on the battlefield. It has tracks rather than wheels, but is lighter and more agile than a tank. It can carry about 10 personnel, and is seen as a critical



# Taiwan president visits base as China protests US ship passage

That has included firing missiles into the sea and sending planes and ships across the dividing line in the Taiwan Strait in August in response to a visit to the island by US House Speaker Nancy Pelosi.

Last month, it sent a recordbreaking 71 planes and seven ships toward Taiwan in a 24hour display of force after expressing anger at Taiwanrelated provisions in a US annual defence spending bill.

# Japan, US to hold security talks before Kishida meets Biden

Tapan and the United States will hold security talks between their foreign and Defence ministers in Washington the day before Japanese Prime Minister Fumio Kishida lands in the US capital next week wrapping up his tour of Group of Seven nations as Tokyo expands its military and deepens its alliance with America amid China's growing influence. Kishida will embark on a

five-nation trip Monday to France, Italy, Britain and Canada ahead of his January 13 summit with US President Joe Biden.

While the two leaders last met during a Group of 20 meeting in Bali, Indonesia, Kishida's Washington visit will be his first as prime minister.

Defence Minister Yasukazu Hamada and Foreign Minister Yoshimasa Hayashi will fly to Washington to join their American counterparts Lloyd Austin and Antony Blinken for their "2+2" security talks on Wednesday, just before their leaders' summit at the White House, Japanese officials said on Friday.

The "2+2" talks are expected to focus on their new national security strategies, released by Iapan in mid-December and the United States in October, and how the two allies plan to tackle security concerns including China, North Korea and Russia.

### Australian charged over travel to ISIS territory freed on bail

n Australian woman Acharged with willingly entering part of Syria that was under control of the Islamic State group was freed on bail on Friday as a debate raged about the risk to the commu-

Mariam Raad, 31, is one of several Australians whose husbands were killed or jailed after they joined the Islamic

State group.
Australia repatriated four such women and 13 children from a Syrian refugee camp in October.

Raad has been living in the own of Young, in New South Wales state, and was first arrested on Thursday. Federal and state police executed warrants at her home and the home of a relative in Sydney.

Raad was charged with entering, or remaining in, a part of Syria that was under the control of terrorists, a breach of federal law. If found guilty, she faces up to 10 years in prison.

Her bail conditions included a requirement to surrender her passport and a ban from her contacting anyone in prison or anyone associated with a terrorist group.
She is also banned from

acquiring a gun.

Her lawyer, Moustafa Khier of Birchgrove Legal, told the Guardian newspaper that the court heard of the "wealth of evidence" that Raad had been working hard to reintegrate herself and her family.

"Mariam has always said that she would comply with any government orders," Moustafa Khier told the Guardian, adding that law enforcement agencies had categorised her as low risk in deciding to repatriate her.

The contours of a deal that **⊥** could make Republican leader Kevin McCarthy the House speaker have begun to emerge after three grueling days and 11 failed votes in a political spectacle unseen in a century.. It has left Republicans in disarray and exposed anew the fragility of American democracy.

The House will be back at it Friday, with Republicans trying to elect their new House speaker — this time, against the backdrop of the second anniversary of the Jan. 6, 2021 attack on the Capitol. The attack was an unimaginable scene of chaos that shook the country when a mob of President Donald Trump's supporters tried to stop Congress from certifying his election defeat. McCarthy made no promis-

es of a final vote that would secure him the speaker's gavel, but glimmers of a deal with at least some of the far-right holdouts who have denied him support were emerging.

"We've got some progress going on," McCarthy said late Thursday, brushing back questions about the lengthy, messy process. "It's not how you start, it's how you finish."

# India to grow at 7% in FY23

# LOSE FASTEST GROWING ECONOMY TAG

**▼**it by weakening demand, the Indian economy is expected to grow at a slower 7 per cent rate in the current fiscal ending March 2023, setting the stage for the country losing the fastest-growing major economy tag economy tag.

The 7 per cent expansion projected in the first official esti-mate released by the Statistics Ministry compares with 8.7 per cent gross domestic product (GDP) growth in 2021-22.

The projections are much lower than government's earlier forecast of 8-8.5 per cent growth but above the Reserve Bank's projection of 6.8 per cent. If the forecast comes true, India's GDP growth will be lower than Saudi Arabia's expected 7.6 per cent expansion.

In fact, India's GDP growth in the July-September quarter at 6.3 per cent was lower than the 8.7 per cent of Saudi Arabia.

The first advance GDP estimates, which are used to work out allocations and other fiscal projections for the next Budget due on February 1, proved to be more optimistic than the actu-al growth in three out of the last

The projections suggest that despite the global headwinds and continued geopolitical uncertainty caused by the Russia-Ukraine conflict, the recovery is on track though there are pressure points. Inflation has been sticky despite a 225 basis points increase in interest rates since last May, which is likely to moderate

As announced in the Union Budget 2022-23, the central government as part of its overall market borrowings will be issuing Sovereign Green Bonds (SGrBs) for mobilising resources for green infrastructure. 'Accordingly, it was notified

in the half-yearly issuance calendar for marketable dated securities for the second half of the fiscal year 2022-23 on September 29, 2022, that SGrBs for an aggregate amount of Rs 16,000 crore would be issued.

"The Government of India has since issued the Sovereign Green Bond Framework on November 9, 2022," it said.

These green bonds would be available in 5-year and 10-

year tenure, it added.

# Sebi mulls standardised approach to valuation of investment portfolio of AIFs


apital markets regulator Sebi on CFriday proposed that alternative investment funds (AIFs) need to adopt a standardised methodology for valuation of investment portfolios managed by

It has been recommended that AIFs should be mandated to carry out valuation of their investment portfolio as per International Private Equity and Venture Capital Valuation (IPEV) Guidelines.

Presently, AIF Regulations focus on disclosures to investors and do not prescribe any guidelines on the methodology to be adopted. As such, managers of AIFs have flexibility to adopt any valuation methodology by disclosing the same to investors in Private Placement Memorandums (PPMs) of schemes of AIFs managed by them.

Currently, the modalities relating to valuation of investment portfolio of the AIFs are not disclosed in the PPMs at the time of submission to Sebi and also not reported to the regulator subsequently.

In its consultation paper, Sebi has suggested criteria of independent valuers appointed by AIFs, reporting of valuation to performance benchmarking agencies and responsibilities of manager of AIF with regard to valuation of their invest-

### Dravid: Team rebuilding for next T20 WC, we have got to be patient with youngsters

Head coach Rahul Dravid has called for patience as the Indian team goes through a rebuilding phase for the next cycle of the T20 World Cup and the youngsters in the side get some experience.

Dravid felt inexperience was one of the main reasons for India's 16-run defeat to Sri Lanka in the second T20I here. The former India captain pointed out that while the visitors had a pretty sorted playing XI, the hosts fielded a completely different side than the one which played the T20 World Cup less than two months back.

"They (youngsters in the team) are very skilful, but as they are learning, it's a tough (job). It's not easy learning in international cricket and you have to learn on the job. So, we've got to have a little bit of patience with these guys, Dravid said at the post-match press conference on Thursday.

Dravid said the team was in the rebuilding phase, given the "next cycle of the T20 (World Cup)" had started. He added that youngsters will be handled patiently and will continue to get support from the team management, hinting that it could be the end of the road for the likes of Virat Kohli, Rohit Sharma and KL

"For us, it was a slightly different scenario (in the T20I series against Sri Lanka) in the of experimenting.
"The boys we are already sense that from the last game we played against England in the semifinal of the World Cup, we've probably only 3-4 boys in the playing XI (now).

"So, we are in a slightly different stage of looking at the next cycle of (the) T20 (World Cup). So, a slightly younger

With the focus shifting to

the 50-over World Cup in India, Dravid feels it is the right time to give as many opportunities to youngsters in T20s as possible.

"The good thing is this year we have the (50-over) World Cup. Because a lot of focus will be on the 50-over World Cup, and the World Test Championship, at least the T20 games that we have, it probably gives us the opportunity to try out a lot of the younger guys.'

India are fielding a newlook side comprising youngsters including Shivam Mavi, Umran Malik, Shubman Gill and Rahul Tripathi.

"Hopefully give them opportunities and just back and support them. I think we've got to be patient with a lot of these young kids. If you look at this team, there are a lot of youngsters playing, especially our bowling attack.

We all need to be patient with them and we need to be understanding that games like this can happen."

With openers Ishan Kishan and Gill and Tripathi -- playing his debut match -not firing, Dravid defended them, saying they've only played a couple of games, and asserted that no chopping and changing will take place for the Rajkot game.

"I haven't thought about the third match right now. Once we go there we will have a look at the wicket. But I don't expect there to be too much

# RONALDO LATEST STAR TO END CAREER IN SOCCER OUTPOST

ristiano Ronaldo is not the first Soccer superstar to he\ad off to one of the world's supposed minor leagues in the latter years of his

The temptation for one last huge payday, to be a trailblazer in a nation looking to boost its standing in the sport, or just to try something different often can be too big to resist. Not every player bows out right at the top like Zinedine Zidane even if the France great was sent off in the last game of his career, the World Cup final of 2006.

Others, like Pelé, Johan Cruyff, Zico, Xavi Hernandez, and now the 37-year-old Ronaldo at Saudi Arabian club Al Nassr, find themselves prolonging their careers at unlikely soccer outposts usually for vast amounts of money.

Here's a focus on a few of them, across five different countries:

It was a move that changed U.S. Sports history. Pelé, the Brazil great

and owner of an unprecedented three World Cup winners' medals, signed for the New York Cosmos in 1975 after being wooed by the team for four years. Pelé's 2 1/2 seasons there — he

earned \$2.7 million, according to the Cosmos' then-general manager Clive Toye — put U.S. Soccer on a path to hosting the World Cup in 1994 and launching Major League

average attendances nearly tripled in Pelé's first year and continued to

He scored 37 goals in 64 matches in the North American Soccer League and did all the PR work required in his mission to make soc-cer mainstream and underpin a surge in youth participation.

We would not be where we are today," MLS Commissioner Don Garber said, "if it wasn't for Pelé deciding to come to the United

So many top players have since made their way to the U.S., typically to end their careers and for lifestyle reasons: Franz Beckenbauer, Johan Cruyff, George Best, David Beckham and Thierry Henry, to name just a few.

After two highly successful spells at Flamengo, either side of two years at Udinese in Italy, the playmaker quit his playing career, only to come out of retirement at the age of 38 to help usher Japanese soccer into professionalism.

He played for four seasons at Kashima Ántlers from 1991-94, a period which took in the inauguration of the J-League in 1993. Zico remained in Japan until 2006, staying at Kashima as its technical director and then coach before becoming the national team's coach



for the four-year cycle up to the 2006 World Cup.

He has since been elected into Japanese soccer's Hall of Fame and is known as the "God of Football" in Japan. Along with England great Gary Lineker, who also played in Japan at the start of the league, Zico is regarded as a key figure in the development of Japanese soccer and its growth in popularity.

Dunga, Hristo Stoichkov and

most recently Andres Iniesta, Spain's World Cup winner from 2010 who has played for Vissel Kobe since

2018, are other major names to have played in Japan.

### **XAVI HERNANDEZ**

Xavi wasn't the first star player to land in Qatar's top league but he might have had the most prominence, given he arrived midway through 2015 — at age 35 — on the back of being the Barcelona captain who lifted the Champions League trophy weeks earlier.

The league had been running for more than 40 years by that point and, since the turn of the century,

had enticed high-profile players such as Marcel Desailly, Pep Guardiola and Gabriel Batistuta in 2003 and 2004 and Raúl González

Even Brazil great Romário came over to the tiny, oil-rich emirate to play, if only for three games in 2003 at a reported cost of \$1.5 million for Al-Sadd, Qatar's biggest club. That was before Qatar, in 2010, won the right to host the 2022 World Cup.

In that 12-year stretch, Xavi one of Spain's greatest players — was the most famous soccer import, his stint in the country lasting six years and following a plan that saw him take his coaching qualifications and

be a World Cup ambassador.

He was a player for Al-Sadd from 2015-19 and then coached the team from 2019-21 before returning to Barcelona as its coach.

A record 35,000 spectators watched the 38-year-old Del Piero's debut, Sydney's membership grew beyond 10,000, and the club's chairman, Scott Barlow, said it lifted the "A-League onto the world stage."

No other player, past or present, in the A-League comes close to matching Del Piero's gravitas — former Liverpool and England striker Robbie Fowler had short stints at two Australian clubs before the Italian's arrival, and Dwight Yorke spent a season at Sydney before that

- so, in a sense, it has been a missed opportunity in a country where rugby league and cricket is king. Australian soccer did get a timely uplift at the recent World Cup

in Qatar when the national team reached the last 16.

### **DIDIER DROGBA**

In 2012, Chinese clubs made a concerted push to attract top stars to its highest league — the Chinese Super League — after getting over the fallout of a corruption scandal that damaged its reputation.

Not enough, though, to dissuade Didier Drogba to sign for Shanghai Shenhua as perhaps the biggest draw of this first batch of leading players that also included Nicolas Anelka. Drogba, then aged 34, was a huge deal at the time, not least because the Ivory Coast striker had just led Chelsea to its first Champions League title by scoring a late equalizer in regulation time and then the clinching penalty in the shootout of the 2012 final.

Drogba called it a "leap into the unknown," with Shenhua chairman Zhu Jun willing to pay Drogba a reported \$300,000 a week to help drag his team up the league and Chinese soccer officials hoping it would boost the country's hopes of becoming a major global player.

Drogba lasted six months before returning to Europe with Galatasaray in a messy split and China never has managed to compete with Europe as a go-to league.
