SUPREME COURT HOLDS WOMEN SUPREME

Medical fraternity safety prime

Terming the incident of the rape and murder of a trainee doctor at the RG Kar Medical College and Hospital in Kolkata as "horrific and horrendous" and "a systemic failure of the State machinery", the Supreme Court on Tuesday constituted a 10member National Task Force (NTF) to formulate a protocol for safety of doctors and healthcare workers at workplace. The SC came down heavily on

the Mamata Banerjee Government in West Bengal, Banerjee slamming it for its "lackadaisical approach" to the case all through. The top court also directed the Central Bureau of Investigation (CBI), which is currently investigating the matter to submit a status report by August 22. The task force will submit its interim report within three weeks and the final report within two months. The top court also appealed to medical community, including doctors protesting across the country, to call off the strike and resume work.

A Bench of Chief Justice of India (CJI) DY Chandrachud, Justices JB Pardiwala and Manoj Misra was hearing matters related to the incident after it took suo motu cognisance of the incident, which has triggered a nationwide strike by doctors and other health

The bench said, "There are legislations to protect medical professionals but they do not address the systemic issues. associations have consistently raised the issue," the court observed pointing out that medical professionals in the course of performance of their

'The constitutional value of equality brooks no compromises on the health, well-being and safety of those who provide healthcare to others. The nation cannot await a rape or murder for real changes to happen on the ground," the bench said.
The SC asked the NTF to

formulate an action plan under two sub-heads — preventing duties have been unfortunate violence, including gender-based

professionals; and providing an enforceable national protocol for dignified and safe working conditions for interns, residents, senior residents, doctors, nurses and all medical professionals. "The NTF shall be at liberty to make recommendations on all aspects of the action-plan highlighted above and any other aspects which the members seek to cover. They are at liberty to make additional suggestions, where appropriate.

"The NTF shall also suggest appropriate timelines by which the recommendations could be implemented based on the existing facilities in hospitals. The NTF is requested to consult

The Ministry of Health and Family Welfare will provide all logistical support, including making arrangements for travel, stay and secretarial assistance and bear the expenses of the members of the NTF, it said. "All State Governments and UT Governments, through their

all stake-holders," the bench said.

Secretaries, in the Ministries of Health and Family Welfare and Government, Central through the Secretary, Union Ministry of Health and Family Welfare must collate information from all hospitals run by the State and the Central Government, respectively on how many security personnel are employed at each hospital and each department.

"Whether there is a baggage and person screening mechanism in place at the entrance of the medical establishment. The total number of resting/duty rooms in the hospital and specific details of the number in each department. The facilities provided in the resting/duty rooms," the bench said. The data as submitted shall be tabulated and filed with an affidavit by the Union Government within one month of this order, it said.

Pulling up judges for expressing personal views and preaching, the Supreme Court on Tuesday set aside a Calcutta High Court judgment acquitting a man who had sex with a minor girl and also junked the High Court's controversial remarks advising "adolescent girls to control their sexual urges".

The court ordered setting up of an independent committee of experts, including one from the Tata Institute of Social Sciences, to ascertain the wish of the victim whether she intended to continue with the accused or was willing to be rehabilitated. The court also directed West Bengal Government to give details to the committee on the income and accommodation they would provide the victim and the child if she decides not to reside with the accused. 'The impugned judgment of the

High Court is set aside and the judgment of the Special Court is restored to the extent of the conviction of the accused for the offences punishable under subsections (2)(n) and (3) of Section 376 of the IPC and Section 6 of the POCSO Act. Accordingly, the accused stands convicted. The acquittal of the accused for the offences punishable under Sections 363 and 366 of the IPC is confirmed," a bench comprising justices Abhay S Oka and Ujjal Bhuyan said.

The bench also directed the West Bengal Government to constitute a committee of three experts, including



a clinical psychologist and a social scientist. "The State Government may take the assistance of NIMHANS or TISS for constituting the committee. A child welfare officer shall be appointed to assist the committee as its coordinator and secretary; (c) The committee shall be formed within three weeks from today," it said.

Holding the accused guilty of the offences punishable under subsections (2)(n) and (3) of Section 376 of the IPC and Section 6 of the POCSO Act, the bench said the issue regarding sentencing will be considered after the committee's report is received.

Badlapur seeks Badla

Massive protests erupted at Badlapur in the adjoining Thane district of Maharashtra over the alleged sexual assault of two fouryear-old girls by a sweeper in the toilet of a leading nursery school and the "delay" in police action. Irate residents staged a "rail roko", agitation crippling suburban train services between Badlapur and Karjat and disrupting normal life in Mumbai's

The citizens took to the street at Badlapur, after the news of the alleged sexual assault on girls in the kindergarten school run by Adarsh Vidya Prasarak Sanstha (AVPS) by a contractual sweeper on August 12 and 13 spread like wild fire in the satellite town, which is located 68 km away from south Mumbai.

Based on the complaint of the parents of the victim girls, the police registered an FIR on August 16 — three days after the incident — under the relevant provisions of the Bharatiya Nyaya Sanhita, 2023 and the Protection of Children from Sexual Offences (POCSO) Act, 2012. A day after the registration of the incident, the accused identified as one Akshay Shinde (23) — was arrested. The protesters laid siege to

for ten-long hours — from 8 am to 6 pm. The protesters squatted on the railway tracks, disrupted services. At one stage in the evening, the police resorted to lathi-charge to quell the protestors. "We will resume he train services between Badlapur and Karjat after the protesters disperse," a senio Central Railway official said. The protests spilled to Badlapur town, where people - including a large number of women — barged into the controversial school premises, by breaking the main gate of the school. They ransacked the premises, smashing the window panes and damaging the furniture and other items. Raising slogans against the school management for its failure to ensure safety to the girl children studying in its kinder-garten school, the protesters raided classrooms and virtually went on a damaging spree.

Elsewhere outside the school, the protesters blocked the roads and highway and hurled stones at the police personnel who tried to quell the angry citizens. The Badlapur town observed a spontaneous bandh, with shops, hotels and other business establishments remaining closed.

bogus telemarketers

The Telecom Regulatory Authority of ■ India (TRAI) on Tuesday hardened its stance on pesky telemarketers, as it directed telcos to take specific measures to curb misuse of messaging services and protect consumers from fraudulent practices.

Continuing its offensive against unsolicited spam calls and messages, TRAI made it clear that from September 1, 2024, all access service providers will be prohibited from transmitting messages containing URLs, OTT links, or call back numbers which are not 'whitelisted' (authorised) by

To enhance message traceability, TRAI has mandated that the trail of all messages from senders to recipients must be traceable from November 1, 2024. Any message with an undefined or mismatched telemarketer chain will be rejected. The latest move assumes significance as TRAI has cracked the whip on unauthorised telemarketers indulging in promotional calls and messages to telecom subscribers. Last week, TRAI directed telcos to disconnect all telecom resources of unregistered telemarketers found making spam calls, and to blacklist them for up to two years.

Centre asks UPSC to cancel "lateral entry" recruitment on 45 positions

The Union Public Service Commission (UPSC) on Tuesday cancelled advertisement recruitment to bureaucracy through lateral entry following a directive to this effect from the Centre. The cancellation comes amid a political row erupting over

The UPSC had on August 17 issued a notification for recruiting 45 Joint Secretaries, directors and Deputy Secretaries through lateral entry — referred to as appointment of specialists (including those from the private sector) in the Government departments. This move had drawn criticism from

Earlier in the day, Union Minister of State for Personnel Jitendra Singh wrote to UPSC chairperson Preeti Sudan asking her to cancel the advertisement so marginalised

August 8. The Junior Doctors Association (JUDA) said that we have withdrawn the strike respecting the High Court's order. But, we will continue our protest by running a parallel OPD. Earlier on Monday is a series of the series on Monday, junior doctors had protested against the Kolkata incident by taking out a bike

JUDA spokesperson Kuldeep Gupta said that after the court's order, junior doctors have returned to work, and we are attending patients by running our parallel OPD. If the patient is in an emergency condition, we are referring to specialist doctors from all departments

present here. More than 50 doctors are doing OPD. Our priority was earlier, is still there and will remain so in future that the patient does not suffer any kind of harm. We are constantly seeing that we are upset with the indifferent attitude of the Kolkata government, and are also demanding the Central Doctor Protection Act.

Junior doctors ended the strike after the order of the High Court in Madhya Pradesh. Junior doctors had stopped work from 12 midnight on August 15. About 46 hours later, they announced the end of the strike Actually on of the strike. Actually, on August 9, a trainee doctor was raped and murdered in Kolkata's RG Kar Medical College. Violence took place in the same hospital late on the night of 14 August, after which IMA decided to protest across

Earlier on August 17 afternoon, the High Court had ordered the junior doctors to end the strike. The court said that they should withdraw their strike by August 20. The bench of Acting Chief Justice Sanjeev Sach Deva and Justice Vinay Saraf said that this method of strike is not right at all. If someone is dying, will you give them medicine after two days? The High Court

had advised the doctors to

return to work.

Meanwhile, after the case of rape and murder of a junior doctor in Kolkata's RG Kar Medical College, the Ministry of Health and Family Welfare has issued an advisory for all the hospitals in the country, in which it has been said that security arrangements in hospitals should be tightened further. Rains start again in the State after one week's gap

fter a break of about A week, the ramy season has started a week, the rainy again in Madhya Pradesh. Heavy rains occurred in 14 districts including Bhopal and Indore. Water entered low-lying areas and houses in Chhindwara and Guna, 5 sluice gates of Tawa Dam were opened in Narmadapuram. The M e t e o r o l o g i c a l Department has issued an alert for heavy rains in 11 districts.

Sagar recorded the highest rainfall of 2.25 inches on Tuesday in the state. Indore received one and a half inches of rain. One and a quarter inches of rain was recorded in Pachmarhi and four and a half inches of rain was recorded in Bhopal,

Jabalpur and Ujjain. Rainfall was witnessed in Betul, Dhar, Guna, Chhindwara, Mandla, Narmadapuram and Malajkhand of Balaghat district. Heavy rains also occurred in Agar district. So far, 28.7 inches of rainfall has been recorded in the state. This is 76 percent of the season. Sheopur has received twice the normal rainfall. Mandla-Seoni are such districts where the rainfall figure has crossed 41 inches.

Senior meteorologist said, 'The low pressure area is still active. This system will move forward in the next 2 to 3 days. This will cause rain in many districts of the state. Activity of monsoon trough and cyclonic circulation will also continue. A strong system will be formed many low-lying areas of the city and BRTS. Many

Department has predicted heavy rains to continue in Shahdol, Amarkantak of Anuppur, Bhind, Morena, Anuppur, Bhind, Morena, Agar-Malwa, Guna, Mandsaur, Betul, Rajgarh, Ujjain and Shivpuri. Also, there is a possibility of lightning with moderate thunder in Udaygiri of Vidisha, Sanchi of Raisen, Gwalior.

Heavy rain started in almost the entire city of Indore from around 4 pm on Tuesday evening. About two and a quarter inches of rain fall was recorded here. Due to rain, waterlogging and traffic jams occurred at many major intersections. Apart from this, heavy waterlogging also occurred in

areas including Palasia, Guitar Tiraha, Scheme 140, Khajrana, Robot Chauraha were flooded up to knee level.

Heavy rains occurred in some areas of Guna district on Tuesday. Heavy rains continued since morning. The drain in Ukawad village overflowed. Due to this, the entire village was flooded. Water filled up to two to three feet.

Bhopal: For the past 8 days Bhopal has witnessed rain and heavy rainfall was witnessed on Tuesday, 4.5 mm of rainfall was recorded in the past 9 hours. Before this, there was bright sunshine, but at 11 am the weather changed and it started raining. Heavy rain continued for an hour and the same amount has been recorded in 16 days.

Two and a half inches of rainfall was witnessed on August 3. There was a break in monsoon for seven consecutive days. Due to this, the day temperature had crossed 33 degrees, but due to rain it came down to 30.6 degrees on Tuesday.

Due to rain, the water level in Upper Lake increased. The level was 1666.40 feet on Monday, which reached 1666.45 feet by Tuesday evening. The gates of Bhadbhada Dam can be opened again as soon as there is a spell of heavy rain.

Earlier the day temperature reached 33.3 degrees on Monday. This was the highest temperature in August.

According to the Meteorological Department, there is a trend of 13 inches of rain in Bhopal in August, but this time only 9.8 inches of rainfall has been recorded, more than 33 inches of rain has been recorded in Bhopal so far, which is about 90 percent of the season, but the indifference of monsoon has also been seen in August. There was good rain in Bhopal for the first 4 days, but after that only light rain continued. Due to this, the quota could not be full till August. This time the sluice gates of all dams in Bhopal have also been opened. All 13 sluice gates of Kaliyasot dam have been opened. 4 out of 8 gates sluice of of Bhadbhada and Kerwa dams were also opened. 

Berasia police have arrested two accused who cheated a 27-year-old victim to the tune of Rs 1.97 lakh. Harassed by the accused, the victim had committed suicide last year in the month of July; 6 mobile phones and more than 12 registered SIM cards were recovered in the action. The deceased identified as Dev Narayan Vishwakarma a resident of Berasia, Bhopal, was duped of Rs 1,97,491 in the name of a loan. He was harassed by agents to transfer the amount to different accounts for processing, fees and refund in the name of loan from Dhani app. Upset by this harassment, Dev

Narayan committed suicide on July 31 last year. This disclosure has been made by Bairasia police in the investigation of the suicide case of the youth. Also, two accused in the case

SC reveals why it took suo motu cognisance of Kolkata doctor rape-murder case

RAJESH KUMAR n NEW DELHI

The Supreme Court on Tuesday revealed why it took suo motu cognisance of the recent horrific rape and murder of a 31-year-old doctor in Kolkata's RG Kar Hospital. Expressing concern over the lack of workplace safety in healthcare institutions, the court in order also took strong exception to the failure by the West Bengal government machinery to stop a large mob which on August 15 vandalised the emergency ward and other areas of the hospital after the crime. If women cannot go to their place of work safely, then we are denying them equality, the apex court said. Senior advocate Kapil Sibal, appearing for the West Bengal government, refuted the observations and submitted that Kolkata police took all necessary action. He said he will place on record all the facts.

"Photos and videos were circulated before the police reached the crime scene. We didn't allow anything to happen and cordoned off the area. Inquest was done and a case of unnatural death was registered immediately. We caught the culprit who was a civic worker. This is not adversarial litigation," Sibal told the court. 

Mizoram receives `8 cr Central assistance for helping refugees

The Mizoram government has received financial assistance amounting to Rs 8 crore from the Centre to provide relief to over 43,000 people from Myanmar, Manipur and Bangladesh, who have taken refuge in the state, the Assembly was informed on Tuesday.

Home Minister K Śapdanga said that Rs 3 crore was received from the Centre during the previous Mizo National Front (MNF) rule, while the state got Rs 5 crore during the current Zoram People's Movement (ZPM) administration.

He was replying to a question opposition member Ramthanmawia.

Sapdanga said that Rs 3 crore received during the previous government was used for providing amenities to refugee camps and other assistance to the people who came from Myanmar.

The remaining Rs 5 crore has not been used and it will be utilised for relief to the refugees, he said.

According to the state home department, a total of 43,737 refugees from Myanmar and Bangladesh and internally displaced people (IDPs)from Manipur have taken shelter in different parts of the state



Refugees from Myanmar accounted for the highest number at 33,724, followed IDPs from Manipur ,,999) and Bangladeshi refugees (2,014), it said.

East Mizoram's Champhai district hosted the highest number of refugees, mostly Myanmarese, at nearly 14,000, the department said. The Myanmar people mostly from the Chin state, who share ethnic ties with the Mizo, have been taking shelter in Mizoram since the military takeover in February

Bangladesh's Chittagong Hill Tracts (CHT) migrated to the state in November 2022 due to the alleged military offensive by the Bangladesh army during its crackdown on an ethnic insurgent group in CHT.

The Kuki-Zo people from Manipur, who also share ethnic ties with the Mizos, have been taking shelter in Mizoram since May 2023 due to ethnic violence between Meiteis and the Kukis in the neighbouring state.

Coaching student found dead in 'suspicious' condition in Kota hostel, parents refuse probe

n 18-year-old coaching Astudent was found dead in a suspicious condition in the bathroom of his hostel room here, police said on Tuesday. Mpox is becoming a global concern. While there is no need to push the panic button yet, it is important to remain watchful

■ n the wake of the COVID-19 pandemic, the world is now facing another significant health challenge: Mpox, previously known as monkeypox. This viral disease, which has traditionally been confined to certain regions of Africa, has seen a disturbing rise in cases across the globe, prompting widespread concern and action from health authorities. Mpox is caused by the monkeypox virus, a member of the Orthopoxvirus genus, which also includes the smallpox virus. The good news is that it is not fatal in most cases and is curable. There is no specific treatment for mpox but most people recover in a few weeks. Supportive care and pain control can help people with good immune systems while those with low immunity can recover with medical treatment. While it is less deadly than smallpox, Mpox can still cause severe illness, especially in those with compromised immune systems. The virus is primarily transmitted to humans from animals, but human-to-human transmission can also occur, particularly through direct con-



tact, bodily fluids, respiratory droplets, or contaminated materials like bedding. Mpox's symptoms include fever, headache, muscle aches, swollen lymph nodes, chills, and a distinctive rash that often starts on the face and spreads to other parts of the body.

As they say, once bitten twice shy, we have just wriggled out of corona pandemic and cannot afford to have another pandemic. It is not an epidemic but can become one if preventive measures are not taken. After a surge in Mpox cases globally Indian airports have ramped up surveillance and precautionary measures to mitigate the spread of the virus. The Ministry of Health and Family Welfare has issued a nationwide adviso-

ry, urging airports to intensify screening processes and ensure that protocols for identifying and isolating potential cases are strictly followed. The World Health Organization (WHO) has reported an uptick in Mpox cases across several regions, with particular concern in areas where the virus had previously been under control. Travellers exhibiting symptoms such as fever, rash, or swollen lymph nodes are being referred for further medical evaluation. Major international airports in cities like Delhi, Mumbai, and Bengaluru are at the forefront of these preventive measures. Special medical teams have been stationed at these hubs to conduct rapid assessments and ensure that any suspected cases of Mpox are swiftly isolated and treated. The focus is not just on inbound passengers; outbound travellers are also being advised to take precautions, particularly if they are heading to regions experiencing outbreaks. While India has not yet reported a significant number of Mpox cases, the proactive measures being implemented at airports are part of a broader strategy to prevent the virus from gaining a foothold in the country. Health experts emphasise that early detection and isolation are key to controlling the spread of Mpox, particularly in a densely populated country like India, where an outbreak could have severe consequences.

In a revolution or a coup the constitution is one of several casualties. The Administration has said that institutional reforms will include reviewing the constitution before any election can take place. All this will take time. It is the early days of regime change with the future clouded with uncertainty. India's new geo-political challenge is shaping and it must now begin engaging relevant stakeholders. Cyber security: Reducing attack surfaces in the digital age

This is achieved by minimizing the potential vulnerabilities and entry points that attackers can exploit to compromise a system, network or organization across various domains including the edge, the core or the cloud.

Some ways we can strengthen our security posture:

Apply Zero Trust principles: Zero Trust is a security

concept centred on the belief that organizations should not automatically trust anything inside or outside their perimeters and instead must verify everything trying to connect to their systems before granting access. Organizations can achieve a Zero Trust model by incorporating solutions like microsegmentation, identity and access management (IAM), multi-factor authentication

to name a few. Patch and update regularly: Keeping operating systems, software and applications up to date with the latest security patches helps address known vulnerabilities and minimize the risk of exploita-

(MFA) and security analytics,

Ensure secure configuration:. Systems, networks and devices need to be correctly configured with security best practices, such as disabling unnecessary services, using strong passwords and enforcing access controls, to reduce the potential attack surface. Apply the principle of least privilege: Limit user and ystem accounts to only have the minimum access rights necessary to perform their

Use network segmentation: Dividing a network into segments or zones with different security levels helps contain an attack and prevents lateral movement of a cyber threat by isolating critical assets and limiting access between different parts of the network. Ensure application security: Implementing secure coding practices, conducting regular security testing and code reviews and using web application firewalls (WAFs) help protect against common application-level attacks and reduce the attack surface of

web applications. **Utilize AI/ML:** According to the Dell Technologies 2024 Innovation Catalyst report, 58% of Indian businesses feel GenAI will provide automation to help

with the efficiency and scale needed to deal with the influx of threats. We can leverage AI capabilities to help proactively identify and patch vulnerabilities, significantly shrinking the attack surface. Work with suppliers who maintain a secure supply chain: Ensure a trusted foundation with devices and infrastructure that are designed, manufactured and delivered with security in mind. Suppliers that provide a secure supply chain, secure development lifecycle and rigorous threat modeling keep you a step ahead of threat

Educate users and promote awareness: By proactively implementing these measures, organizations can effectively reduce the attack surface, helping to mitigate risks and making it more challenging for adversaries to exploit vulnerabilities, enhancing the overall defence posture against new and emerging

THE HIGH COST OF FAST FASHION

Sustainable clothing that is produced ethically should be our responsible fashion choice

Gas pricing: Reforms turn into a control regime



Government's decision to grant a 20 per cent premium on natural gas from the state owned new wells has added complexity to the gas pricing regime



he decision of the Union Government to grant a 20 per cent premium over the APM price (a jargon for administered or controlled price) for any natural gas (NG) that state-owned Oil and Natural Gas Corporation (ONGC) and Oil India Limited (OIL) will produce from the 'new wells or well interventions' from their nominated fields has made the NG pricing more complicated. It is an outcome of a thought process that focuses on unshack-ling the oil and gas industry from price controls to start with but ends up exercising more controls.

Every year, India consumes 59.5 billion cubic metres (bcm) of NG. Of this, nearly 54 per cent or 32.13 bcm is produced domestically, and the balance is met from imports of liquefied natural gas (LNG). Of the domestic gas, around two-thirds is from blocks given on nomination to ONGC and OIL and from fields given under the New Exploration and Licensing Policy (NELP) (launched in 1999) as well as those given to private firms before the NELP. NG supplies from the aforementioned fields known in common parlance as 'legacy fields') are governed by a particular pric-

2023, under the pricing guidelines effective since November 2014, supplies from these fields used to be a weighted average (WA) of prices of NG at four international locations: Henry Hub (the USA), Alberta Gas (Canada), NBP (National Balancing Point) (the UK), and Russian Gas. The prices used for arriving at the WA were over twelve months. It was revised every six months in a financial year (FY).

The four global hubs have fairly mature gas markets and the prices obtained there are pretty reasonable. Moreover, considering that the prices for twelve consecutive months were used for arriving at the WA, it smoothened out the month-to-month variations thereby ensuring that the price to the consumers was 'stable'. From April 2023, the government changed the above system based on the recommendations of the Kirit Parikh committee (2022). Under the new formula, for any given month, the price expressed per million

British thermal units (Btu) (energy units used globally for setting NG prices) is arrived at by taking 10 per cent of the monthly average of the basket of Indian crude oil in the preceding month. The price thus calculated is subject to a price band of US\$4 - 6.50 per Btu. The shift to be the price of Btu. The shift to price is NG with the crude oil price is flawed as natural gas is not a replacement for crude oil. The pricing of NG has to be on its own, especially when nearly half of the gas is used for urea production and power generation. Given the intimate connection of these sectors to food security and the need for affordable electricity (especially, for farmers and poor household consumers) and heavy subsidies are involved, the gas price has to be 'reasonable' and 'stable'. While the earlier formula met both these requirements, the new one effective from April 2023 doesn't as the volatility in crude prices and monthly revisions in NG price linked to crude can create uncertainties for both sectors. To avoid this, the government has put a price band.

What this means is even when the price determined based on crude linkage turns out to be higher (at the current Indian basket price of USD 77 per barrel, the NG price comes to US\$ 7.7 per Btu) than the ceiling of US\$ 6.50 per Btu, the price will be set at US\$ 6.50 per Given the movement in crude price since April 2023 and considering that in the near term, it will continue to rule well above US\$ 75 per barrel, the formulabased price will always be much more than US\$ 6.50 per Btu. So, the ceiling price will be the price to consumers thus rendering the formula redundant. Effectively, thus there is control on the gas

the government wants. wonders whether a premium of 20 per cent allowed on gas supplied from the so-called 'new wells' or 'well interventions' in the nomination fields of ONGC and OIL will make any difference to the situa-

tion on the ground.

Applying a 20 per cent premium to the formula-determined price of JS\$ 7.7 per mBtu (77x0.1), we get US\$ 9.24 per mBtu. But, then there is a cap of US\$ 6.50 per mBtu. So, the price remains at US\$ 6.50 per Btu. The purpose of giving premiums is defeated.On the other hand, if the government intends to build a 20 per cent premium on the ceiling price and give US\$ 7.8 per mBtu then, it makes no sense to put a cap in the first place. The moot point is: if anyway ONGC and OIL are to be given a good price, let this be driven solely by the formula and putting a cap is

At least, there is an element of 'predictability'; firms on their own can calculate as to what price they will be getting. But, here we have an APM price namely US\$ 6.50 per mBtu (call it base price) that is arrived solely at the discretion of the bureaucrat. And, yet another price for supplies from the socalled 'new wells' or 'well interventions' which is arrived at by adding 20 per cent to this. This too is at the discretion of the bureaucrat. Moreover, which fields get the benefit of interventions will also be at his discretion.

Even the pricing of the remaining one-third of domestic NG supplied from the so-called deep/ultradeep and high-pressure/high-tem-perature fields (KG-D6 operated by Reliance Industries and neigh-bouring KG-DWN-98/2 operated by ONGC in Krishna-Godavari basin off the Andhra Pradesh price for two-thirds of domestic production and that too at a level, from 'discretion' and 'arbitrariness'.

Technically though, the firms can go for competitive bidding to determine the price for such sup-plies (referred to as a 'premium' price) this too is which the accidprice), this too is subject to a ceiling linked to the prices of alternate fuels including fuel oil, naphtha, and LNG. On taking charge in 2014, the Modi – government started the process of reforming gas pricing by introducing formula-based pricing for legacy gas and thereafter in 2016 by permitting market-based pricing for supplies from deep/ultra-deep and highpressure/high-temperature fields. But, it has ended up exercising control of both. Meanwhile, the Kirit Parikh committee had recommended the de-regulation of difficult gas fields' prices by January 1, 2026, and the de-regu-lation of APM prices for gas supplies from the legacy fields by January 1, 2027. But, the government is silent on these recommendations. In fact, by adding more categories (read: 'new wells' and 'well interventions'), it has given a trolled pricing regime for NG and attendant bureaucratic red tape is here to stay.



Healthcare under siege: Rising violence, gender disparity, and the fight for justice

The silent struggles of healthcare workers, often overlooked, reveal a disturbing reality of increasing violence in hospitals and clinics

Independence Day Justice of Telangana proudly announced that he had recommended a Protection of Advocates Act to the state government. The applause that followed made me think of the resident doctors marching through the rain in Delhi, gathering their courage to demand a law that protects healthcare professionals from the increasing violence in spaces that are supposed to be

In 2019, the draft Healthcare Service Personnel & Clinical Establishments Bill was introduced, seeking to penalise those who assault healthcare workers. However, the Home Ministry opposed it, stating that no separate law was nec-



BNS and BNSS laws provided adequate protection for medical professionals. Despite this, healthcare professionals' anger is justified. Why

doesn't the public show the Health Reports*, 32% of same solidarity as they did during the Nirbhaya case, where the horrific rape and murder of a physiotherapy student led to nationwide outrage? Even amid a national strike by the Indian Medical Association (IMA) over the rape and murder of a doctor in Kolkata, another tragedy was overlooked—the brutal killing of a nurse, a single mother, who went missing from a hospital in Rudrapur, pital in Rudrapur, Uttarakhand. Her body was found in Uttar Pradesh after she had been strangled and bludgeoned to death.

Similarly, in Gujarat in 2020, an Accredited Social Health Activist (ASHA) worker was raped while on duty. According to a study published in the *Journal of Global

ASHA workers face sexual violence, while 88% experience emotional and economic abuse. Disturbingly, 12% report sexual violence from their husbands, and 64% from beneficiaries and their families. These incidents highlight the pervasive threat healthcare workers face. Last year, a doctor allegedly raped a nurse at a clinic in northeast Delhi. In another case, a Bhopal doctor was accused of confining and raping a 19-year-old patient. Just recently, at the same medical college in Bhopal, a resident doctor was suspended for inappropriate behavior with a cancer patient. Violence against healthcare workers also extends beyond sexual violence. Last month in

Manipur, armed assailants



attacked a children's hospital, and two weeks later, a patient was shot dead at Delhi's GTB Hospital due to mistaken iden-

These violent acts, whether committed against doctors, nurses, paramedics, or patients, must be addressed with the same urgency and seriousness. However, the IMA has yet to make a statement regarding the rape and murder of the nurse in Rudrapur.

Eleanor Roosevelt, who played a key role in drafting the Universal Declaration of Human Rights, once famously said that human rights begin in small, often overlooked

In the context of today's healthcare system, that means the seminar room of RG Kar Medical College or the private hospital in Rudrapur—spaces where violence has occurred, but which remain untouched by reforms.

The Israeli military said Tuesday that it recovered the bodies of six hostages taken in Hamas' October 7 attack that started the war in Gaza, as US and Arab mediators tried to advance an agreement to halt the fighting and release scores of other militant-

The military said its forces recovered the bodies in an overnight operation in southern Gaza, without saying when or how the six died. A forum for hostage families said they were kidnapped alive. Hamas says some captives have been killed and wounded in Israeli

An Israeli airstrike on Tuesday killed at least 10 people at a school-turned-shelter in Gaza City, in what the military said was a precise strike on a Hamas command center. Another strike killed a mother and her five children in central Gaza. The recovery of the remains is



a blow to Hamas, which hopes to exchange hostages for Palestinian prisoners, an Israeli withdrawal and a lasting ceasefire. But it was also likely to increase pressure on Israel's government to reach a deal to

free dozens of hostages who are still believed to be alive.

US intelligence officials said Monday that Iran is responsible for the hack of Donald Trump's presidential campaign. Infrastructure Security Agency. The statement said the Iranian hackers have "sought access to individuals with direct access to the Presidential campaigns of both political parties." The FBI has been investigating attempts to gain access to Democrat Kamala Harris' campaign.

Ex-Saudi official alleges Prince Mohammed forged king's signature on Yemen war decree Yemen, launched with public

former Saudi official on A Monday alleged that Saudi Crown Prince Mohammed bin Salman forged his father's signature on the royal decree that launched the kingdom's yearslong, stalemated war against Yemen's Houthi rebels. Saudi Arabia did not respond to questions over the allegations made without supporting evidence by Saad al-Jabri in a BBC interview first published Monday. Al-Jabri later acknowledged the allegations separately in detail in a statement to The Associated Press.The kingdom has described al-Jabri as "a discredited former government official." Al-Jabri, a former major general and intelligence official who lives in exile in Canada, has been in a long dispute with the kingdom as his two children have been imprisoned in a case he describes as an attempt to lure him back to Saudi Arabia. Al-Jabri also alleges that the crown prince wants him assassinated. "I am myself in this situation by choice," al-Jabri told the AP. "I was a high-ranking Saudi official who dedicated himself to safeguarding his country, recognized for saving thousands of Saudi and Western lives. Now I am a father doing everything possible to secure the release of his children."

His allegation comes as Prince Mohammed serves as Saudi Arabia's de facto leader, often meeting leaders in place of his father, 88-year-old King

Prince Mohammed's assertive behavior, particularly early in his ascension to power around the beginning of the Yemen war in 2015, has extended to a wider crackdown on any perceived dissent or power base that could challenge his rule. Al-Jabri first told the BBC a 'credible, reliable" official linked to the Saudi Interior Ministry confirmed to him that Prince Mohammed signed the decree declaring war in place of his father. Prince

Jabri told the AP that he had reached a deal with U.S. counterparts in the then-Obama administration for Saudi Arabia to launch "an aerial bombardment campaign to eliminate Houthi threats, establish deterrence and force a political process without a ground intervention."

His former boss, Saudi Arabia's then-Interior Minister Prince Mohammed bin Nayef, then chaired a meeting in Saudi Arabia formalizing that plan. Prince Mohammed bin Salman, however, responded with "visible displeasure" at that meeting and said he could beat the Houthis in two months in a ground offensive, al-Jabri claimed. "Surprisingly, a royal order was later issued, overriding the agreed plan and authorizing a ground operation — without the king's knowledge and with a forged signature," al-Jabri told the AP. The U.S. State Department declined to comment on al-Jabri's claims.

Jury clears Texas student's parents of negligence in 2018 school shooting

Galveston (AP): The parents of a former student accused of killing 10 people in a 2018 school shooting near Houston cannot be held responsible for what happened, a jury decided Monday.

The victims' lawsuit sought to hold Dimitrios Pagourtzis and his parents, Antonios Pagourtzis and Rose Marie Antonios Kosmetatos, financially liable for the shooting at Santa Fe High School on May 18, 2018. The lawsuit alleged the parents failed to provide necessary support for their son's mental health and didn't do enough to prevent him from accessing their guns.

Authorities say Pagourtzis fatally shot eight students and two teachers. He was 17 years old at the time.

Pagourtzis, now 23, has been charged with capital murder but the criminal case has been on hold since November 2019, when he was declared incompetent to stand trial. He is being held at a state mental health facility.

In April, Jennifer and James Crumbley were sentenced to at least 10 years in prison by a Michigan judge after becoming the first parents convicted in a US mass school shooting. Pagourtzis' parents are not accused of any crime.

The lawsuit was filed by relatives of seven of the people killed and four of the 13 who were wounded in the Santa Fe attack. The attorney representing Pagourtzis told jurors that while his client did plan the shooting, he was never in control of his actions because of his severe mental illness. Attorney Clint McGuire, representing some of the victims, said the parents knew their son was depressed, getting bad grades, isolating himself, and had taken weapons from their gun cabinet and safe. McGuire said Pagourtzis also wrote disturbing Facebook posts and ordered ammunition and other items online, such as a knife with a Nazi symbol and a T-shirt that said, "Born To Kill."

German court upholds conviction of 99-year-old ex-Nazi secretary

German court on Tuesday Arejected an appeal by a 99year-old woman who was convicted of being an accessory to more than 10,000 murders for her role as a secretary to the SS commander of the Nazis' Stutthof concentration camp during World War II.

The Federal Court of Justice upheld the conviction of Irmgard Furchner, who was given a two-year suspended sentence in December 2022 by a state court in Itzehoe in northern Germany.

She was accused of being part of the apparatus that helped the camp near Danzig, now the Polish city of Gdansk, function. She was convicted of being an accessory to murder in 10,505 cases and an accessory to attempted murder in five cases. At a federal court hearing in Leipzig last month, Furchner's lawyers cast doubt on whether she really was an accessory to

crimes committed by the commander and other senior camp officials, and on whether she had truly been aware of what was going on at Stutthof.

The Itzehoe court said that judges were convinced that Furchner "knew and, through her work as a stenographer in the commandant's office of the Stutthof concentration camp from June 1, 1943, to April 1, 1945, deliberately supported the fact that 10,505 prisoners were cruelly killed by gassings, by hostile conditions in the camp," by transportation to the Auschwitz death camp and by being sent on death marches at

the end of the war. Prosecutors said during the original proceedings that Furchner's trial may be the last of its kind. However, a special federal prosecutors' office in Ludwigsburg tasked with investigating Nazi-era war crimes says three more cases are pending with prosecutors or courts in various parts of Germany.

In the ruling, presiding Judge Gabriele Cirener wrote that the fact that Stutthof wasn't always a death camp that existed for the sole purpose of extermination, such as Auschwitz or Sobibor, wasn't legally relevant.

Spanish woman, believed to be oldest person in world, dies at age 117

Maria Branyas, an American-born Spaniard considered the world's oldest person at 117 years old, has died, her family said on Tuesday. In a post on Branyas' X account, her family wrote in Catalan: "Maria Branyas has left us. She has gone the way she wanted: in her sleep, at peace, and without pain."

The Gerontology Research Group, which validates details of people thought to be 110 or older, listed Branyas as the oldest known person in the world after the death of French nun Lucile Randon last year. The next oldest person listed by the Gerontology Research Group is now Japan's Tomiko Itooka, who is 116

Afresh complaint was filed on Tuesday with Bangladesh's International Crimes Tribunal accusing deposed prime minister Sheikh Hasina and 23 others of committing crimes against humanity and genocide during a rally by an Islamist group in May 2013. Supreme Court lawyer Gazi MH Tamim filed the complaint on behalf of Mufti Harun Ijahar Chowdhury, joint secretary general (education and law) of Hefajat-e-Islam, The Daily Star newspaper reported.

'We registered the complaint, and thus the investigation has started from today," Ataur Rahman, deputy director (admin) of the investigation agency, was quoted as saying by he newspaper.

"Once we complete the preliminary investigation and visit the place of occurrence and the tribunal is reconstituted, we, through the prosecution, will seek arrest warrants against the accused," he said.

The complaint accused Hasina and 23 others of committing crimes against humanity and genocide during a Hefajat-e-Íslam rally at Motijheel's Shapla Chattar on May 5, 2013. This is the fourth complaint

Taiwan conducts live-fire missile drills as China ramps up threats

The exercises took place at the Jiupeng Military Base in a remote area in southern Taiwan. China claims the democratically ruled island of Taiwan as its own territory, to be brought under its control by force if necessary and ramped up its military threat in recent years. Beijing in particular dislikes Taiwan's new President Lai Ching-te, who took office earlier this year and whom Beijing has called a separatist.

Taipei has boosted its deterrence capabilities in response. Missiles, both domestically built and US-made, are key to its defence strategy.

Defence Ministry spokesperson Sun Li-fang said all the missiles launched Tuesday nit their tar gets. "This shows our training is very strict and solid," he said. Beijing did not immediately react to Taiwan's drill. China sends military jets and vessels near Taiwan frequently in what critics call an infimidation tactic. Taiwan's Defence Ministry said early Tuesday it spotted five Chinese military jets and 11 ships close to its shores over the previous 24 hours. One aircraft crossed the median line of the Taiwan Strait, an unofficial demarcation zone between the While its military is dwarfed by

China's, Taiwan has bought high-tech weaponry from the United States, revitalised its domestic arms industry and extended the length of mandatory military service from four months to one year.

Indonesia and Australia on enhance the neighbouring nations' ability to operate their militaries in each other's territory. He noted that Australian Prime Minister Anthony Albanese was the first foreign leader to congratulate him on his election victory.

"We have had our ups and downs as the political situation and the geopolitical situation of course evolved, but I think we are very happy today to have several decades of very close cooperation," Subianto told reporters and added he was determined to continue "this good neighbour relation-

Albanese said he looked forward to attending the president's inauguration in October. Albanese was elected prime minister in 2022 while Indonesian President Joko Widodo was in power. "There is no more important

relationship than the relationship between our two great nations," Albanese said.

SL sets expenditure limits for president election campaign for first time

Colombo (PTI): For the first time, Sri Lanka's upcoming presidential election on September 21 will be subject to ampaign finance regulations following the introduction of the Regulation of Election Expenditure Act in January 2023. According to a gazette notification dated August 16 and published Monday, each candidate is allowed to spend a maximum of Rs 109 per elector for election campaigning activities, totalling Rs 1,868,298,586 (approx USĎ 5 million) per candidate.

The expenditure limit per candidate ĥas been set at 60 per cent of the total amount, while political party secretaries are allowed 40 per cent for their candidate's election campaign activities. The parties must submit expenditure reports to the Elections Commission within 21 days of the election results béing declared, the notification stated Incumbent president Ranil Wickremesinghe, main opposition leader Sajith Premadasa, and leader of the Marxist Janatha Vimukthi Peramuna Anura Kumara Dissanayake are the front runners.

Fire rages at Russian oil depot after drone attack

 $R^{\hbox{\it ussian authorities strug-}}_{\hbox{\it gled on Tuesday to put out}}$ a massive fire in the southern Rostov region for a third consecutive day after an oil depot was hit by Úkrainian drones as Ukrainian forces push into Russia's Kursk region.

The fire at the depot in the town of Proletarsk burned across an area of 10,000 square meters, according to Russian state news agencies. There are 500 firefighters involved in the operation, and 41 of them already have been hospitalized with injuries, according to the Russian state-owned news agency TASS, citing local officials. Úkraine's Army General Staff claimed responsibility Sunday for attacking the oil depot, which was used to supply the needs of Russia's army, calling it a measure "to undermine the military and econom-

Federation." Ukrainian President Zelenskyy said the daring Kursk incursion has allowed his army to capture a significant number of prisoners who could be used in exchange for captured Ukrainians, expanding on Kyiv's objectives for the mission launched two weeks ago. He earlier said that Ukraine sought to create a buffer zone that might prevent further attacks by Moscow across the border, especially with long-range artillery, missiles and glide bombs.

"Overall, this (Kursk) operation became our largest investment in the process of freeing Ukrainian men and women from Russian captivity," Zelenskyy told diplomats on Monday, according to a statement published on Telegram late in the day. "We have already captured the largest

Nine dead after consuming poisonous food in Pakistan

Karachi (PTI): Nine young people, eight of them siblings, died and one was hospitalised after reportedly eating poisonous food in Pakistan's Sindh province, a media report said here on Tuesday. The deceased include five sisters and three brothers in the age group four to 18 years.

As soon as the 10-member family and their guest had dinner on Monday night at Haibat Khan Brohi village near Pir-jo-Goth, Khairpur district, they started falling unconscious, the Dawn newspaper said. Their relatives and neighbours rushed them to Kingri Taluka Hospital where three members of the family died and their bodies were returned to the heirs without autopsy as there were no doctors to perform it. Villagers accused

paramedics and nurses of mishandling the victims in the absence of doctors, leading to the deaths of three family members. "Later, others also succumbed to the poison and hence nine siblings had died since last night," the newspaper said quoting the villagers.

The 10th victim, whose condition is unstable, is under treatment at the hospital, they said. The newspaper further quoted Gul Baig Brohi, father of the victims, who said that his daughters and sons had died due to the absence of doctors and mishandling at the taluka hospital. He also corroborated that no postmortem examination was carried out. According to the United

¬he Reserve Bank of India's The Reserve Dank of Managering (RBI's) inflation targeting regime has worked well and need not be abandoned in favour of a more discretionary regime that could be risky and counterproductive, a new research paper has said.

The paper titled 'Inflation Targeting In India: A Further Assessment' said the weight of food-price inflation in the CPI inflation basket should be reduced to better reflect the circumstances of Indian households.

"The RBI's inflation targeting regime has worked well. Given this record, radical changes such as broadening its mandate or abandoning the target in favour of a more discretionary regime would be risky and counterproductive,"

The paper is authored by economists Barry Eichengreen (University of California, Berkeley) and Poonam Gupta NCAER).

In contrast, the paper noted that the 4 per cent point target, +/-2 per centage point tolerance band and focus on headline inflation remain broadly appropriate.

"Inflation is lower and less volatile; inflation expectations are better anchored, and the transmission of monetary policy is more effective," it

Recently, Chief Economic Advisor Nageswaran had pitched for excluding food inflation from the rate setting calls, saying that the monetary policy has no bearing on the prices of food items, which are dictated by supply side pressures.

Only two games at the makeshift Nassau County Cricket Stadium, including India's opening fixture against Ireland, have got an "unsatisfactory" rating from the game's governing body which remains bullish on promoting cricket in the United States. The surface used for the game

and South Africa also got thumbs down from the match referee.

After a rather long delay, the ICC published the pitch ratings on its website on Tuesday. The tournament, won by India, was played from June 1 to 29.

All eight games in New York ended up being low-scoring affairs, drawing scathing criticism from experts and fans during and after the ICC

The cricket on display in New York was not the best advert for a sport trying to make its presence felt ahead of the 2028 Los Angeles Olympics, where it will make its debut. India played three games in New York while their match against Canada in Fort auderhill was washed out. The drop-in tracks prepared
