

Punjab Cabinet takes a series of steps for enhancing public welfare

fter a hiatus of five months Adue to the Lok Sabha polls, the Punjab Cabinet convened on Wednesday, rolled out a series of decisions aimed at streamlining governance and enhancing public welfare. In a move set to simplify property transactions, the Cabinet granted in-principle approval to eliminate the requirement for a No Objection Certificate (NOC) for land and property registration — marking a sig-nificant shift towards ease of doing business.

Additionally, the introduction of 'The Punjab Fire Safety and Emergency Services Bill, 2024' promises considerable relief for property owners, extending the validity of fire safety certificates from one to three years. Furthering its commitment to accessible justice, the Cabinet sanctioned the creation of 49 posts for seven Gram Nyayalayas, ensuring that legal recourse is within reach for every citizen. Among other key decisions, the reduction of motor vehicle tax on registered tourist vehicles aims to boost tourism in the State.

By approving the elimination of the requirement of NOC for land and property registration, the Cabinet aimed to protect the public from unscrupulous colonizers who sell unapproved properties, leaving buyers to struggle for basic amenities. The State Government is committed to safeguarding the interests of the common man by simplifying the property registration

In another major decision, the Cabinet approved the 'Punjab Fire Safety and Emergency Services Bill, 2024',

which updates the outdated 2012 Act. The new legislation extends the validity of fire safety certificates from one to three years, categorized by building risk levels - low, medium, or high. This reform not only eases the compliance burden on property owners but also ensures better fire and emergency services across Punjab, both in urban and rural areas. The Bill also introduces mandatory insurance provisions against fire risks, aiming to increase efficiency in the Fire

Department's operations. Furthering its commitment to accessible justice, the Cabinet sanctioned the creation of 49 posts for seven new Gram . Nyayalayas in various districts, including Patiala, Barnala, and Gurdaspur. These grassroots-level courts are intended to provide affordable and timely justice, reducing the backlog of cases in higher courts.

Additionally, the Cabinet reduced Motor Vehicle Tax on registered tourist vehicles to make Punjab more competitive with neighbouring states. This reduction is expected to boost vehicle registration in the state, thereby increasing revenue. The Cabinet also approved a new category of additional road tax for luxury vehicles, projected to generate Rs 87.03 crore, and introduced a Green Tax on older vehicles to combat environmental pollution.

Making other crucial decisions to provide timely relief and enhance state welfare, the Cabinet approved the designation of the State Executive Committee as the competent authority to release compensation to the farmers for crop loss due to natural calamities. The decision allows for immediate disbursement of funds exceed-

Three-Day Monsoon **Session from Sept 2**

Punjab Cabinet has sanctioned a three-day assembly session set to commence on September 2. Chief Minister Bhagwant Mann presided over the meeting where the decision to hold Punjab Vidhan Sabha's monsoon session from September 2 to 4 was taken. The session will serve as a platform for the government to seek the assembly's approval on various important legislations passed earlier. The state . Finance Minister Harpal Singh Cheema, during a press briefing, said that the session will begin with an official commemoration of obituaries, while detailed matters will be sorted out by the business advisory committee soon.

In a landmark decision, the Cabinet also greenlit the Punjab State Education Policy for Children with Disabilities, aligning with the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and the Right of Persons with Disabilities Act, 2016. The policy focuses on inclusive education and holistic development of children with disabilities, empowering them to participate fully in social, economic, and self-development significant move, approved the disbursement of cash awards to gallantry award winners as a lump sum, eliminating the need for annual submission of life certificates. This streamlined process also ensures that after the awardee's death, the annuity for their spouse will be

automatically processed, pro-

viding a major relief to the fam-

ilies of these national heroes. Additionally, the Cabinet approved amendments to the Punjab Educational (Teaching Cadre) Group-'C' Service Rules, 2018, and Punjab Educational (Teaching Cadre) Border Area Group-'C' Service Rules, 2018. The amendments divide the 20 percent promotion quota for Master/Mistress cadre among ETT/JBT, HT, and CHT cadres in a 15:4:1 ratio. This change is expected to reduce litigation and open new promotion avenues within these teaching cadres, fostering career growth and stability for educators in Punjab.

To bolster the state's youth and sports sectors, the cabinet decisions also focused on nurturing young talent and providing robust support to athletes. In a major move, the Cabinet approved the Youth Services Policy 2024, a comprehensive strategy designed by the Department of Youth Services to uplift the state's youth. The policy aims to divert young people from the grip of drugs, channeling their boundless energy into constructive avenues such as sports, cultural programs, and social welfare activities. The Cabinet, in another empowered youth population **Environmental Conservation**

Taking steps towards environmental conservation and sustainable development, the Cabinet approved two key initiatives. The Cabinet greenlit the Tree Preservation Policy for Non-Forest Government and Public Lands-2024, aiming to increase the state's forest and tree cover from the current 5.92 percent to 7.5 percent by 2030.

The policy mandates the creation of an inventory of trees on non-forest lands owned by state departments, institutions, and local bodies, with protection measures documented through an online portal. The policy will also establish committees at various levels to oversee the cutting and replanting of trees, ensuring the preservation of green cover, particularly in urban areas.

In a parallel move, the Cabinet approved a project to promote agroforestry and biodiversity conservation in Punjab, with a budget of Rs 792.88 crore, in collaboration with Japan. The project is designed to increase tree cover through agroforestry, conserve groundwater, boost farmers' incomes, and reduce air pollution caused by straw burning.

Additionally, it will focus on integrated watershed management in the Shivalik region, promotion of ecotourism, biodiversity conservation, and wetland improvement. The project, set to be implemented over five years starting from 2025-26, will be developed in partnership with the Ministry of Environment, Forest and Climate Change (MoEF&CC), Japan International Cooperation Agency (JICA), and the Punjab Forest Department.

AAP gains strength as SAD MLA Dr Sukhi joins party; Punjab braces for five bypolls

The Aam Aadmi Party (AAP) in Punjab received a significant boost on Wednesday with the recent defection of Shiromani Akali Dal (SAD) MLA Dr Sukhwinder Kumar Sukhi — a practicing medico. Serving as the MLA for Banga Assembly constituency and holding the position of Deputy Leader of the SAD Legislative Party, Dr Sukhi officially joined AAP in Chandigarh on Wednesday in the presence of Punjab Chief Minister Bhagwant Mann and AAP's national general secretary Dr Sandeep Pathak.

Dr Sukhi's departure is a notable setback for the SAD a party already grappling with internal strife and diminishing political influence. With his exit, SAD's representation in the Punjab Vidhan Sabha has been reduced to just two MLAs – Ganieve Kaur Majithia from Majitha and Manpreet Singh Ayali from Dakha. The loss is particularly significant given that SAD is already struggling with factionalism and declining influence.

Chief Minister Bhagwant Mann warmly welcomed Dr Sukhi into the AAP fold, praising his dedication and alignment with the principles of Dr BR Ambedkar. Mann noted, "Dr Sukhi has been a staunch advocate for the marginalized and has always raised pertinent issues in the Assembly. His straightforward approach has earned him respect from all quarters." He added that Dr Sukhi's experience and commitment would be valuable

assets for AAP. Dr Sukhi, a practicing physician known for his philanthropic work, expressed his appreciation for his previous party but highlighted his admiration for AAP's leadership. "Joining AAP is an honour, especially given its alignment with the ideals of Shaheed Bhagat Singh and Dr BR Ambedkar. My constituency deserves the best, and I believe AAP is committed to delivering that," said Dr Sukhi.

He also recounted his positive interactions with Chief Minister Mann, citing a recent instance where Mann took swift action on a corruption issue involving a Tehsildar. This, according to Dr Sukhi, reinforced his confidence in AAP's commitment to good governance and transparency.

Dr Sukhi's anticipated resignation from his MLA position will lead to a by-election in the Banga constituency, adding to the already scheduled by-elections due to the election of four other MLAs to the Parliament. The constituencies of Chabbewal, Dera Baba Nanak, Gidderbaha, and Barnala will also face by-polls, marking a critical period for both AAP and SAD.

Political analysts view Dr Sukhi's defection as a strategic gain for AAP, which now boasts 92 MLAs in the 117member Punjab Assembly. The addition of a prominent figure like Dr Sukhi is expected to strengthen AAP's foothold, especially in the Doaba region.

SAD 'Stunned' by its MLA's

SAD has been left reeling from the unexpected move of Banga MLA Dr Sukhwinder Kumar Sukhi. The defection has caught the party off guard, with SAD leaders expressing shock and disappointment over Dr Sukhi's decision. Dr Sukhi's departure marked a significant blow to the SAD, a party already facing internal turmoil and declining influence. Sources within the SAD revealed that Dr Sukhi had not previously communicated any grievances or issues with the party leadership, making his sudden move all the more sur-

pokesperson Daljeet Singh Cheema expressed his dismay, stating, "Dr Sukhi had been made a core-committee member and was given proper respect within the party. His departure has come as a shock to us." Dakha MLA Manpreet Ayali, who is the leader of SAD legislative party, described Dr Sukhi's exit as a substantial setback for the Akali Dal. "This move is shocking and comes at a time when the party is already struggling. It is crucial for the party leadership to heed the concerns and demands of the workers," Ayali remarked. He emphasized the need for the party to strengthen its base and address the issues raised by its members to regain its footing.

Punjab's dabangg cop Brar sets record with his fifth President's medal for gallantry

Known for his daring exploits and unwavering commitment to justice, Brar, who currently serves as the Deputy Superintendent of Police with the Punjab Police's Anti-Gangster Task Force (AGTF), has once again made headlines. He has been honoured with his fifth President's Police Medal for Gallantry, securing his place as the most decorated police officer in

Punjab's history. This is Brar's second gallantry award this year. Brar was awarded a medal on the occasion of Republic Day this year for his bravery in gunning down two gangsters -Manpreet Singh alias Manu Kussa, and Jagroop Singh alias Rupa —involved in the murder of renowned Punjabi singer

Sidhu Moosewala. The Union Ministry of Home Affairs on Wednesday announced this prestigious accolade on the eve of Independence Day-2024, marking another significant milestone in Brar's illustrious career. His reputation as a stalwart of law enforcement is underscored by his relentless efforts to take down some of the most feared gangsters in the country. From high-octane encounters to intricate investigations, Brar's bravery has set new standards for police work, earning him not only respect but also a legacy of heroism that continues to inspire.

Brar's most recent medal was awarded for his exemplary role in neutralizing noto-

rious gangster Tejinder Singh, alias Teja, along with his two associates — Amanpreet alias Peeta Dhesi, and Vijay alias Mani Rahon. This operation, which took place on February 22, 2023, in New Fatehgarh Sahib Market, Bassi Pathana, was marked by intense gunfire and strategic precision. Teja, with a criminal record spanning 33 serious cases and a conviction in 11, had previously evaded capture and was sought for the murder of Punjab Police constable Kuldeep Singh. Brar's successful intervention in this highstakes operation showcased his exceptional tactical skills and

unyielding courage.

The journey of this decorated officer began with his first President's Medal for Gallantry in 2011, awarded for his role in arresting members of Rajeev Raja gang during a live encounter at Samrala bus stand. This was followed by his second medal in 2020, which recognized his role in neutralizing Vicky Gounder, a key player in the infamous Nabha Jail break case. His third medal came in 2021, acknowledging his vital role in capturing Ankit Bhadu, a gangster wanted across several states, during a dramatic confrontation in Zirakpur. Brar's fourth medal was awarded earlier this year for his bravery in gunning down two







The Bangladesh cauldron is boiling KALYANI SHANKAR



With New Delhi intensifying border controls, the evolving political landscape of Bangladesh is set to influence regional security and diplomacy

he former Prime Minister of Bangladesh, Sheikh Hasina, abruptly left her country a week ago, causing immediate concern in her country and the region. According to the BBC, Hasina's family, not security officials, convinced her to leave due to safety concerns. Her son stated, "We begged her to leave as soon as the violent mob arrived." Crowds entered her residence shortly after her escape. Political, social, and economic issues, external involvement, and unhappy political opposition caused the down-

India's Foreign Minister, S Jaishankar, has informed Parliament about her visit to India and the potential impact on India's relationship with Bangladesh. The unrest that led to her departure resulted in around 560 deaths and could strain the relationship between the two countries, potentially impacting regional security and foreign relations. Initially, in her long reign of 15 years, Hasina was perceived as a democratic and secular leader of Bangladesh, overseeing an economic turnaround. However, she later became intolerant and authoritarian, cracking down on media critand imprisoning opponents.She maintained cor-

dial relationships with Indian leaders, which sparked anti-India Prime Minister Modi mentioned that he had met her ten times last year. The friendship has been mutual, as Begum Hasina also

reciprocated by driving out the terrorists who targeted India and allowed concessions for transit facilities. She was the first state guest during the Modi government's third term.India has had a special relationship with Bangladesh since it was born in 1971. After her father, Sheikh Mujibur Rahman, the founder of Bangladesh, was assassinated in 1975, Hasina spent six years in India. After that, she shifted to Dhaka to lead the Awami Bangladesh-India relations League. The current student weakened. Her visit to Delhi protests, which started on July 5 against the 30% reservation for descendants of freedom fighters her party, and she stressed the



ment positions, have impacted the political situation in Bangladesh. The Hasina government's proposal to expand this quota led to widespread protests and 200 deaths. Bangladesh opposition parties organized a 'long march' to express growing discontent with the government's policies. At the international level, tensions rose between Hasina and the U.S. when her American visa was revoked after she fled the country. The U.S. State Department emphasized the importance of the interim government in establishing long-term peace and political stability in Bangladesh. The U.K. and other countries also took the same stand. The international community is working to support the interim government led by Yunus, who is responsible for restoring normalcy. New Delhi has set up a monitoring committee and increased border control to address the situation. Madam Khaleda Zia and other opposition leaders were released after Hasina's departure. WAYANAD TRAGEDY COULD BE AVERTED

Madam — The picturesque Wayanad, a hilly district located in the Western Ghats Mountain range in Kerala, is prone to landslides during heavy rains. In Kerala's history, the landslide that occurred recently there and claimed over 400 lives was the

According to the Geological Survey of India half of Kerala's land area is vulnerable to landslides. Wayanad region has had

many tea and coffee plantations. The first landslide occurred in an uninhabited forest area with no access road. The torrent of water carrying mud and boulders swept away or buried the villages of Punchirimattam, Mundakkai and Chooralmala, and wreaked havoc in Meppadi, Attamala and Kunhome.

Mundakkai is a village located more than a kilometre down from the hill that slid first. Chooralmala caved in under the pressure of gushing water from the first landslip and heavy downpour. Irunjipuzha river split into two raging streams and wreaked havoc along its path. When it comes to discussing the early warning of rainfall, the less said, the better.

On July 24, the Agricultural Meteorological Division of the Indian Meteorological Department issued a forecast for Wayanad that predicted only 15 mm rainfall, the day when landslides occurred. Mundakkai, where the landslide hit Wayanad first, got 572 mm of rainfall within 48 hours. However, it shouldn't be overlooked that the Hume Centre for Ecology and Wildlife Biology, an NGO specializing in weather patterns of Wayanad with a network of more than 200 weather monitoring units, had warned of possible landslides two days before the landslide happened.


