In an apparent bid to blunt the Opposition's full-fledged full-fledged campaign against the BJP-led MahaYuti Government and the Centre over the collapse of Chhatrapati Shivaji Maharaj's imposing statue at Rajkot fort in Sindhudurg district ahead of the Maharashtra Assembly polls, Prime Minister Narendra Modi on Friday apologised to Chhatrapati Shivaji whom he described as not just "a revered king or great personality but a

Speaking at a function after laying the foundation stone for ₹76,000 Vadhvan Port in

Maharashtra's Palghar district and kick-starting other developments, Modi recalled that the first thing he did after he was nominated by the BJP as the Prime Ministerial candidate in 2013, was to visit Raigad Fort to offers his prayers to Čhhatrapati Shivaji Maĥaraj at the latter's Samadhi. He said he was blessed with the same 'bhakti bhav' with which he revered his master and embarked on the new journey to serve the nation. Alluding to the collapse of a 35-

tall statue at Malvan in Sindhudurg district, the Prime Minister tendered his humble apology to the legendary Maratha king by saying: "Shivaji Maharaj is not merely a name, a revered king or a great personality but a deity". Indirectly hitting out at the leader of the Opposition in Lok Sabha Rahul Gandhi of the Congress for showing disrespect towards freedom fighter Veer Savarkar, Modi said that his upbringing and his culture made him different from those "who intend to disrespect the great son of the land Veer Savarkar and trample the feeling of nationalism". In an unmistakable criticism of

Assembly polls, Modi said: "People of Maharashtra should remain wary of those who disrespect Veer Savarkar and feel

no remorse for it" The Prime Minister said that his

reverence towards Chhatrapati Shivaji should be seen in the context of the fact that the first thing he did after visiting Maharashtra was to apologise to his deity Chhatrapati Shivaji He also sought Maharaj. forgiveness from all those who Shivaji Maharaj. worship Averring that his government had taken major steps for the growth of Maharashtra in the last 10 years as "a Viksit Maharashtra is the most crucial element of the resolution of a Viksit Bharat", Modi said that the state had the potential and resources to grow due to its coastal proximity, holding immense possibilities for

country's largest container port and will be counted among the world's deep water ports. It will become an epicenter of trade and industrial development for Maharashtra and India," the Prime Minister said.

Being built at a cost of ₹76,000 crore, Vadhvan Port — located near Dahanu town in Palghar district — is expected to be one of India's largest deep-water ports and will provide direct connectivity to international shipping routes, reducing transit times and costs.

Vadhvan Port aims to establish a world-class maritime gateway that will boost the country's trade and economic growth by catering to large container vessels, offering deeper drafts, and accommodating ultra-large cargo ships. Modi, who also inaugurated and laid the foundation steps of 210 C. foundation stone of 218 fisheries projects worth around Rs 1,560 crore and launched Rs 360 crore National Roll Out of Vessel Communication and Support system, said there was a time when Bharat used to be counted among the most strong and prosperous nations due to its maritime capabilities. "People of Maharashtra are well-

versed in this potential. Chhatrapati Shivaji Maharaj took India's maritime capabilities to new heights with his policies and strong decisions for the development of the country," Modi said, adding that even the entire East India Company could not stand in front of Darya Sarang Kanhoji Yaganti.

Dialogue a bygone theme, **EAM warns Pakistan of action**

 $E_{\text{Jaishankar on Friday sent out a}}^{\text{xternal}} \stackrel{\text{Affairs Minister S}}{\text{Friday sent out a}}$ stern message to Pakistan declaring that the era of "uninterrupted dialogue" is over. He also warned that "actions have consequences" in an apparent reference to Pakistansponsored terrorism.

Making these assertions at a book launch event here, he reaffirmed New Delhi's position that terror and talks cannot go together.

The Minister's comments on dialogue with Pakistan came in the backdrop of elections in Jammu and Kashmir in less than 20 days 'The era of uninterrupted dialogue

with Pakistan is over. Actions have consequences," Jaishankar said. "So far as Jammu and Kashmir is concerned, Article 370 is done with. So, the issue is what kind of relationship we can contemplate with Pakistan," Jaishankar said, making it clear that there would be no compromise on this matter.

He also stressed that India would not remain passive in its dealings with Pakistan. "What I do want to say is that we are

not passive, and whether events take a positive or a negative direction, either way, we will react," the Minister added.

On a suggestion that India is content with the relationship to continue as it is, he said, "Maybe yes, maybe no... but what I do want to say is that we are not passive, and that whether events take a positive or negative direction... either way we will react." In his address, Jaishankar also said

"always neighbours are conundrum", and so are "major powers"

Major powers will be a conundrum because they are major, because of the breadth of their interests. They will always have an agenda, which will overlap with us, but to differing degrees, also diverge, he said.

In the case of China, you have a

"double conundrum", because it's a neighbour and a major power. So, the challenges with China fits this double definition, he added. The book "Strategic Conundrum:

Reshaping India's Foreign Policy" by former diplomat Rajiv Sikri talks about India's relationship with its neighbouring countries and the accompanying challenges. The Minister also said there is a

debate in the neighbourhood about SAARC and BIMSTEC, and "all of you know the difference". That is a contrast which illustrates some of the challenges and opportunities of "regionalisation", he said.

Jagdish Tytler to be framed for 1984 riots and murders

Holding that there was sufficient evidence to put him on trial, a Delhi Rouse Avenue Court on Friday ordered framing of charges for murder and other offences against Congress leader Jagdish Tytler in a case related to alleged murder of three people in the North Delhi's Pul Bangash area, almost 40 years after the 1984 anti-Sikh riots.

Special CBI judge Rakesh Sival said there was sufficient evidence against him to put him on trial. "Sufficient ground is there to proceed against the accused person," the Special CBI judge said, posting the matter for September 13 for formally framing the charges when Tytler would be asked if he would like to plead guilty or face trial. Tytler was discharged under

the Indian Penal Code (IPC)'s Section 148 (rioting armed with deadly weapons) as the special judge Rakesh Syal listed the matter for the next hearing on September

Helpless Mamata Banerjee writes to PM a second time

Within a week of writing a letter to Prime Minister Narendra Modi seeking enactment of stringent laws in rape cases — all in the rop of the nationwide protests against the rape and murder of a postgraduate lady doctor at RG Kar Medical College Hospital in Kolkata — Bengal Chief Minister Mamata Banerjee on Friday shot him off a second letter reiterating the earlier demand and expressed her dismay at the alleged lukewarm response her first missive found in South Block.

"You may kindly recall my letter number 44-CM dated August 22, 2024," Mamata wrote, adding with a tinge of discontent that though such issues warranted immediate attention she is vet to receive any reply from him.
"No reply was received from

your end on such a sensitive issue," the Chief Minister wrote in her second letter mentioning, however, that she had indeed received a general letter from the Minister of Woman and Child Development which, she said, was a "generic reply" concerning a serious

"I am of the thought that the after completion of 36 hours



seriousness of the subject and its relevance to society has not been adequately appreciated as this generic reply reflects," Mamata wrote providing details of the measures her Government has taken to prevent such offences.

Mamata's back-to-back express communications come in the wake of tremendous pressure her Government is facing from the community of doctors, the civil society and general public as a whole with streets of the State getting flooded with huge rallies demanding justice for the 31-year-old lady doctor who was brutally raped and murdered in the wee hours of August 9 even as she was taking rest inside a seminar hall of the hospital of non-stop duty. Mamata's letter also comes in

the wake of her Government announcing amendments in the Central laws through a special Assembly Session summoned for that purpose on September 2.

STF uncovers multi-crore Chinese investment scam

The Dehradun cyber I crime police station of Uttarakhand Special Task Force (STF) has exposed a multi-crore Chinese investment scam involving online work from home fraud across India. Three members of the gang, including its leader, were arrested from Gurugram, Haryana, the STF senior superintendent of police Ayush Agrawal said. The STF came to know about the gang after a woman, resident of Saraswati Vihar in Dehradun, registered a complaint stating she was duped of Rs 21 lakh in June 2024. The victim had been lured into joining a Telegram group called Harvey's Appliances Crew 1319 with promises of lucrative work from home opportunities. Initially, the victim received payments for completing tasks, but was later coerced into making multiple de-posits with the promise of higher returns. When the victim tried to withdraw the accumulated amount, she was asked to pay a 50 per cent security fee, prompting suspicion of a scam.

The STF started the investigation and finally arrested three accused, Pratham (24), Shokeen Subhash Sharma (25) and Mukul Godhara (20), from Gurgaon, Haryana late on Thursday, the SSP said. Agrawal said that the police



recovered five mobile phones, five credit cards, nine ATM cards and two Aadhaar cards from the possession of the accused, along with bank account details and mobile handsets used in the crime. The investigation revealed that the accused managed multiple fake bank accounts and transferred the defrauded amount into USDT cryptocurrency accounts with the help of international cyber criminals. He said that the arrested men confessed to their involvement in the scam and the laundering of money through cryptocurrency transactions. They were al-legedly in contact with an international cybercrime syndicate based in Dubai through WhatsApp groups.

They carried out fraudulent activities in India under the syndicate's directions, including withdrawing money from ATMs in Dubai. The SSP said that the accused opened over 50 fake bank accounts and received commissions for selling these fake accounts to Chinese citizens, as well as sending cryptocurrencies. Several citizens from across the country have filed complaints against them. Necessary details will be shared with the police of other states, he added.

Police launch campaign to address stray cattle issue in Pauri

onsidering frequent traffic **→**jams and accidents caused by stray animals-especially cattle on the roads, the Pauri senior superintendent of police Lokeshwar Singh has launched a special 15-day campaign across the district. Though such campaigns are often undertaken by municipal bodies, the police are taking a proactive approach in tackling the problem at their level. The SSP said that the campaign aims to control the problems caused by stray animals and enhance road safety. He has instructed all police

station heads in the district to use public address systems and other communication methods to raise awareness among cattle owners. He said that the focus is on urging residents to register their animals with the Animal Husbandry department and prevent them from roaming freely on the streets. The initiative also highlights the potential hazards of stray cattle, including traffic congestion and accidents. He informed that the police have been actively engaging with the community in the town and nearby villages.

They are emphasising the importance of animal registration and responsible pet ownership, he said. He informed that police are also warning people that failure to register their domesticated cattle or allowing them to roam on the streets will result in a legal action against them under the Uttarakhand Cow Protection Act, 2015 and other relevant acts. The campaign is a crucial step towards ensuring safer roads and a more organised approach to managing stray animals in the district, he added.


Khanna asks district hospital & GDMC to act promptly in rape cases

ED raids multiple locations across five States in U'khand's land registry fraud

 $T_{\text{Directorate conducted}}^{\text{he}}$ Enforcementsearch operations in connection with Uttarakhand's land registry fraud case which is considered the State's largestever registry scam. The raids were reportedly carried out across multiple locations in five States including Delhi, Uttar Pradesh, Uttarakhand, Assam and Punjab. According to the officials, the ED conducted searches at about 18 locations in these five States. Out of 18, about 10 locations were reportedly in Dehradun and nearby areas. The operation targeted several accused of the scam including land mafia, government employees and officials working in registry offices, advocates and certain builders. These accused included advocates Kamal Virmani Imran Ahmad, Mohammad Sameer Kamyab, Ajay Mohan Paliwal, late Kanwarpal Singh alias KP Singh and Ajay Pundir, among several others.

The ED reportedly conducted raids at the properties at the properties scam for over a decade and scammed about Rs 500 crore during this period. As per the police, Singh used to bring old blank papers and stamps from various cities like Meerut and Delhi and used his accomplices to copy old property documents on those blank papers. They used to prepare fake deeds by copying the written

documents on old stamps and blank papers exactly how they were written in original property documents brought by Singh. He reportedly used to destroy original papers by tearing and burning them. He then used to replace the original property papers in the Dehradun's registry office with the help of Virmani and others. They had been allegedly doing this for at least 10 years, as per the police. They all were arrested last year. Singh died in the district jail of Uttar Pradesh's Saharanpur in October last year due to hypertension and heart attack, as per the police. This scam came to light two years ago and since then, the police have registered 12 cases and arrested over 20 accused in the case. The ED's teams conducted raids till late on Friday. The ED's intensified crackdown is expected to expose more individuals and networks involved in this extensive scam, as the investigation progresses across various States.

Reaction of former CMs to MLA's claim create political furore in Uttarakhand

Modi Govt preparing nation's cultivable land for organic farming: Amit Shah

Prime Minister Narendra Modi has set a target for preparation of the nation's vast cultivable land for organic farming. Stating this, the Union Home and Cooperation minister Amit Shah said that with the formation of National Cooperative Organics Limited (NCOL), it will be ensured within a few years that all profits from organic products directly go to the bank accounts of the farmers. In another two to three years, products of 'Bharat' brand will cover all types of vegetarian food, he said. Shah was speaking at the signing of a memorandum of understanding between NCOL and Uttarakhand Organic Commodity Board (UCOB) in New Delhi on Friday. Stating that the organic farming movement has reached an important stage, he said that cooperatives have an important role in Prime Minister Modi's vision of making India the world's largest organic food producing country. "Today there is an awareness about organic products across the world and there is a huge global market for the same. When we increase India's share by tapping this market, the share of our farmers in the profitable business of organic products and their income also increases. The health of the citizens of the country is also linked with organic farming. The chemicals that enter our



body through the use of fertilisers cause many types of diseases. This has also reduced the quality of the land, so much so that in many States the land has started becoming as hard as cement, due to which the risk the contrary, with organic farming, the groundwater level increases, water is saved, production increases and the health of the consumer improves as well. Despite all these benefits, organic farming was not duly promoted," Shah said. The Union minister underlined that, earlier, there was no mechanism to check the quality of organic products and farmers did not get high prices. Also, there was hesitation in using these products. The Modi government established the NCOL to solve this problem. He said that Amul and NCOL together will establish a network of internation-

al level laboratories across the country which will examine both organic land and products. He said that both these recognised institutions will provide reliable organic products to consumers as 'Bharat' of floods has also increased. On and 'Amul' brands. Shah also called upon farmers engaged in organic farming across the country to join with the NCOL. He said that all the organic rice, pulses and wheat produced by the farmers will be purchased by the government. He said that in a short time, NCOL will create a smooth mechanism to send the profits directly to the bank accounts of the farmers. Shah also urged the farmers of Uttarakhand to make their farms completely organic and encourage other farmers towards natural farming. He said that farmers of Uttarakhand should make their fields completely organic and stop using fertilisers.

Kedarnath Yatra to be undertaken at full capacity from Sep 7, says Kothiyal

 $B^{\text{haratiya Janata Party State}}_{\text{spokesman and disaster}}$ management expert colonel (retd) Ajay Kothiyal has stated that the Kedarnath pilgrimage is completely safe. The pilgrimage will be undertaken at full capacity from September 7 on the route used before 2013. Both the routes to this temple will be developed to accommodate more pilgrims in the near future, he said after returning from an inspection of arrangements for the Kedarnath pilgrimage on the directions of chief minister Pushkar Singh

Interacting with the media on Friday, Kothiyal said that the CM had directed that a detailed report should be prepared on the bridle path and other arrangements following the recent disaster in Kedarnath. Stating that he had submitted his detailed report to the CM, he said that the disaster witnessed on July 31 had caused nearly as much damage as the 2013 disaster, adding that the disaster management and other agencies involved had done commendable work. "Our priority is to work on the Yatra management in two parts. Firstly, the bridle path is being strengthened to ensure that

the pilgrimage is not easily disrupted in its last phase from September 7 to November 3. The focus is also on ensuring that construction material can be transported easily for the works being undertaken at important locations in Kedarnath Dham. In the second phase after closure of the temple's portals for the winter, the focus will be on fully resolving the other major hindrances on the route," Kothiyal said. He assured that the pilgrimage to Kedarnath by air or the bridle path is completely safe at present. The old path used before 2013 will be used for the pilgrimage presently and later, the other route being used for the past 10 years will be improved and then reopened. The attempt will be to conduct the pilgrimage on both sides of the Mandakini river in the future so that there is no

Five billion people globally consume less iodine, vitamin E, calcium: Study

Arecent study published in The Lancet Global Health journal has revealed people across all age groups in India and globally, both men and equate amounts of micronutrients critical for health, including iron, calcium and folate.

The study is the first to provide estimates insufficient consumption of 15 micronutrients across 185 countries, taken through diets without the use of supplements, according to an international team, including researchers from Harvard University, US.

The findings suggested that around the world, almost 70 per cent, or over five billion, people do not consume enough iodine, vitamin E, and calcium.

The researchers also found that within a country and an age group, more women were consuming inadequate amounts of iodine, vitamin B12 and iron, compared to men, whereas more men were consuming inadequate amounts of magnesium, vitamin B6, zinc and vitamin C, compared to women.

"Given the observations made by the High Court and the plea taken by the petitioners, we find that respondent No. 4, a recovery agent, in actuality appears to be a group of goons, who use their muscle power to harass loanees on behalf of the petitioner-bank," the bench said in its recent order.

The bench further directed, "If there is any license/authority letter granted by a competent authority to respondent No. 4 to act as recovery agent, the petitioner-bank is directed to make a separate complaint to that authority, regarding cancellation of such such permission/authority letter."

The top Court refused to interfere with the Calcutta High Court order of May 16 by which the bank was asked to pay Chowdhury Rs 5 lakh interim compensation for its conduct in not returning the vehicle to him. The High Court had granted liberty to the loanee to approach the civil Court for higher compensation. Chowdhury had approached

the bank for a loan of Rs 15.15 and upon satisfaction of his credentials, his loan was sanctioned and to be repaid along with interest in 84 equated monthly installments of Rs 26,502 commencing from December 2014. The vehicle (bus) in question was hypothecated to the bank.

that from January 2018, Chowdhury started defaulting in payment of monthly installment and his account was declared a Non-Performing Asset (NPA) on May 31, 2018.

The outstanding amount of loan as on date of NPA stood at Rs 10.23 lakh.

Astudy by the Indian Medical Association (IMA) has highlighted alarming safety concerns among doctors, with a significant number, particularly women, reporting feelings of extreme insecurity during night shifts so much so that some have begun carrying weapons for selfdefense.

This comprehensive survey, involving 3,885 respondents 22 States, was across conducted in the wake of the alleged rape and murder of a trainee doctor at RG Kar Medical College and Hospital in Kolkata. It said about onethird of respondents felt infrastructure and legislative issues. "unsafe" (24.1 per cent) or "very unsafe" (11.4 per cent) come amid the Union Health carrying weapons for self-

during night shifts. Around 45 per cent of doctors reported not having access to a duty room during night shifts.

Those with duty rooms generally felt safer. However, many duty rooms were overcrowded, lacked privacy, and had inadequate facilities, such as missing locks and no attached bathrooms. There were infrastructure Issues also. Duty rooms were often located far from patient care areas (53 per cent), and onelacked attached bathrooms, requiring doctors to venture outside late at

The study has recommended basic amenities, and address enhanced Security, improved



Ministry's directives to the States urging them to increase the number of trained security personnel, install CCTV cameras, improve lighting, and implement alarm systems. It has also asked to ensure duty rooms are secure and equipped with overcrowding and privacy

defense due to unsafe conditions. Issues like verbal and physical threats from patients under the influence, and inappropriate contact in crowded emergency rooms were noted. The study highlights the

urgent need for policy changes to enhance security infrastructure and healthcare settings. Dr. Siddharth Tara, Convenor of the Progressive Medicos and Scientists Forum, emphasised the urgent need for the survey, highlighting that the Indian healthcare system relies heavily on women, including ASHA workers, female nurses, and doctors. He asserted that these professionals deserve to work with dignity and called for the Medical Commission to derecognise medical colleges that fail to ensure the safety of their trainee doctors, citing a lack of administrative accountability. Dr. Shweta Sharma,

psychologist and head of Mansa Global Foundation, described the IMA survey as revealing and critical. She underscored the severe mental trauma experienced by female doctors following the tragic incident at RG Kar Medical College and Hospital in Kolkata. Noting that similar incidents have been reported in the media, she stressed the need for an urgent and comprehensive safety network to ensure doctors can perform their duties without fear or undue pressure.Ends

Manipur can't be broken: CM Biren

The dark side

Sexual exploitation in the Kerala film industry revealed by the Hema Committee report sends shockwaves across the country


■ t is a "me too" moment of the Kerala film industry. The image of the Kerala film industry has touched the rock bottom after Hema committee has reported rampant sexual abuse, lack of basic amenities for women and more. It is all the more shocking as it is happening in the state which has given the most progressive films to the country. The Kerala film industry, known for producing some of India's most critically acclaimed and beloved films, is now under the shadow of a severe crisis. A landmark report from the Hema Committee has exposed the deep-rooted gender issues and sexual exploitation that plague this vibrant film hub, revealing a shocking underbelly that contradicts the industry's artistic achievements. The 290-page report, prepared by a three-member panel headed by retired Kerala High Court Justice K. Hema, offers a scathing indictment of the Malayalam-language film industry. It paints a grim picture of a workplace where sexual harass-



ment is rampant and systemic, and where a "mafia of powerful men" wields control, leaving women vulnerable to exploitation. The Hema Committee was established by the Kerala government in 2017, in the aftermath of a high-profile case that sent shockwaves through the industry.

The Hema Committee's findings have laid bare the systemic problems that have long been ignored or downplayed. The report uncovers a litany of abuses, from the lack of basic amenities like toilets and changing rooms for junior artists to the frequent demands for sexual Favors by powerful men in the industry. It describes the harrowing experiences of

women who have been forced to endure long hours without access to toilets, leading to severe health issues. The panel also found that sexual harassment is not only widespread but often goes unchecked and unreported due to the fear of retaliation. As expected, the Kerala film fraternity has vehemently denied all the allegations. Despite the damning findings, the Association of Malayalam Movie Artists (AMMA), a prominent industry body, has denied the accusations. The organization's general secretary, Siddique, dismissed the claims, stating that conditions for women on film sets have improved in recent years and that the industry is not controlled by a small group of powerful men. However, the report's release has sparked widespread outrage, with activists and opposition leaders demanding immediate action against those implicated. Kerala Chief Minister Pinarayi Vijayan has vowed to take action if any woman who testified before the committee comes forward to file a complaint. As the industry grapples with these revelations, there is hope that this moment of reckoning will lead to lasting change. The Kerala film industry has long been celebrated for its artistic achievements; now, it must also become a beacon of respect, safety, and dignity for all who work within it.

Environment: A casualty

of overtoursim



The future of India's tourism sector depends on a delicate balance between ecological integrity and economic growth, but it needs to be addressed now

ecently the Mayor of picturesque Santorini Island in Greece had to declare an emergency as 17000 tourists descended on the island in one day. The beleaguered residents of the island were advised to stay indoors as swarms of tourists took over the hapless location putting immense stress on infrastructure, accommodation and the local environment including the verdant beaches. This has triggered protests by the locals who took out rallies holding placards that read "no more mass tourism."

Overtourism is characterised by increased pollution and strain on resources like water and energy in a destination that is overwhelmed by an excessive number of tourists, to a point where it negatively affects the local environment, biodiversity, and infrastructure. The telling impact of overtourism is evident in India too. Every year the popular hill stations of north India such as Kullu, Manali and Mussoorie witness serpentine tourist traffic jams that extend over many kilometres to gain entry to these

Thanks to this excess footfall the average ambient temperatures have gone up in many of the Himalayan tourist hot spots. The rising temperatures in these locations have in turn altered the weather patterns. Over the last two decades, the Indian Himalayan region has experienced a consistent decline in snowfall days, severely affecting destinations such as Gulmarg and Auli, which have seen a decrease in skiing tourists and shorter seasons, resulting in lower revenue and local economic strain. Even far-flung religious destinations such as Joshimath have not been immune to this heavy tourism torture with over 10 crore people visiting this revered Himalayan town every year resulting in ecological issues such as land subsidence and crumbling biodiversity. Down south popular tourist states such as Kerala are experiencing the painful consequences of rampant tourism. The above-normal rainfall combined with indiscriminate 2030 the transport-related carbon emissions from tourism are expected to grow by 25% from 2016 levels. Some counhuman activity in the form of tries like Australia have taken



tourism resulted in a change in land use patterns in the plantation areas across Kerala. The God's on Country became a victim of human greed as over-tourism led to increased demand for hotels, restaurants and related businesses. Consequently, indiscriminate building activity on hillsides, exploitation of land and deforestation took place leading to irreversible damage to the environment besides terrain instability issues. The recent tragedy in Wayanad is an unfortunate example that consumed 500 lives and left 400 people injured besides causing immense loss of property. The unfortunate impact of tourism is accurately captured by the findings of the French start-up Murmuration specialising in monitoring the environmental impact of tourism using satellite data. The firm has stated that 80% of tourists visit just 10% of the

world's tourist spots leading to bigger crowds in fewer locations. If this trend continues, the United Nations World Organisation (UNWTO) estimates that by 2030, the number of worldwide tourists, which peaked at 1.5 billion in 2019, will reach 1.8 billion. Furthermore, by

issue. The Australian eco-certification programme for instance promotes minimal environmental impact tourism, which helps tourists make responsible travel choices. South Africa on the other hand supports ethical tourism through its fair-trade tourism certification, which ensures fair wages and working conditions in tourism enterprises. Closer home, Bhutan has adopted a "high value, low volume" policy, which serves a dual purpose and involves a daily fee paid by tourists, which helps fund local community services and limits tourist numbers to prevent over-tourism. However, India has unique

problems and needs more specific and aggressive measures to rein in the issue of overtourism. The beginning point can be the tourism supply chain sector comprising travel companies, cruise companies, ticketing firms and package tour providers. These entities must bear a fair share of responsibility for ensuring a balanced tourist traffic flow across the destinations in

This can be done by abstaining from overselling usual tourist destinations and redirecting travellers to other locations. This will prevent overcrowding of a few traditional tourist hot spots and bring

environmental down stress.The tourism ministry in collaboration with the Ministry of environment working in tandem can employ innovative initiatives to protect the ecology and biodiversity of popular tourist destinations.

This partnership can start by first regulating the tour and ticketing companies. This can be ended by registering each tourist operator and weeding out illegal entities.

The dual ministry partnership can usher in a new era of environmentally conscious tourism. As a part of this, both the ministries can provide unique and non-transferable registration IDs to tourism companies and then periodic workshops can be held for these bonafide members to sensitise them about ecology, biodiversity and climate change issues.

As a part of this partnership, the ministries can also develop algorithm-based software for the tourism sector companies that helps in automatically limiting the tourist flow to popular destinations by limiting hotel and transport availability after a certain quota of tourists are accommodated. This can go a long way in reducing the tourist burden on the environment in these des-

I have floated this question to people and the responses have been divided. Some believe that in a world that is pressed for time, the source of thought is not as important as the thought itself. If served in an easily, digestible manner, it doesn't matter where it comes from – man or machine.

While this view has resulted in the spawning of authors around the world, what remains a cardinal truth is that a story or a piece of writing can be resonant with readers only when it is generated in human consciousness. The chief purpose of art and literature is to be able to strike a chord with readers and not to just disseminate

looking for a part of herself in the stories, a reflection of common human experiences and the books they read to be echo chambers of their own lives in parts or whole. Authentic storytelling brings with it a chunk of the writer's soul and it seeks to merge with the soul of the readers. Anything that is generated by a vast reservoir of readymade ideas will be too perfect to evoke responses. Students may be able to produce perfect sentences and passages that will answer a question, but they will not reflect the personality and character of the writer.

What makes a genuine piece of writing enduring and endearing is the voice of the writer and their ability to draw on personal experiences, intuition and a strong need to connect with the audience.

No matter how the concepts are laid out in an artificial piece of story, they will be less distinctive and more formulaic and impersonal. Maybe, our hustling world needs only quick fixes, and as we discover newer methods to replicate human thought, our spirit will

the synthetic form of writing. It's again about what the audience chooses that will determine the future of creativity. If AI can satiate the population, then why would original writers spend time and energy on creating something from the core of their hearts? It is a scary outlook to hold, as a writer and creative writing coach. While a part of me still refuses to believe the doomsday scenario, I am still betting on ethical and moral considerations to deter people from going all out and claiming themselves to be authors and writers without much intellectual investment. I am under no illusion that writing will remain sacrosanct as it used to be. It will soon become generic and predictable. Or maybe, going forward, AI will be able to generate stylised texts that mimic the voice of a particular writer and erase the distinction between the real and the unreal. It's a scary and depressive scenario, but one that we, as authentic writers, must brace ourselves for. (The author is a columnist

(2.63) This sequence is repeated in the lives of all those who harbour anger. How does spirituality help? Forgive and be done with it. What benefit will be derived by harbouring anger?

Rather one can be a happy person. (5.23)Thoughts of illicit acts are another common problem. Who can claim that he or she doesn't get them: The only exceptions are highly advanced devotees like Swami Vivekananda. What is the spiritual solution? Lord Krishna has drawn the line when He stated, "I am passion in beings, according to religious principles." (7.11) Otherwise, get ready to burn as warned in this verse, "By this insatiable fire in the form of lust, which is the eternal enemy of a knowledgeable person knowledge is covered." (3.39) Close relationships



like marriage require special attention. In spiritual terms, we are packages with both good and bad. Our natures are parts of these. When we are born we bring them into our present lives. These are parts of our fate and don't change much in our lifetime, mainly the major factors. This is the solution for marriage partners. We must accept them as they are. Disliking would not help, acceptance will, as long as there is no violation of dharma like maintaining illicit relationships. From the Geeta we learn that even a man of knowledge endeavours according to his nature; persons follow nature. What will repression do? We will be better served in dealing with others if we embrace spirituality. We will not step in the three doors to hell, which are lust, anger and greed. And if we can control our hateful tendencies, we will endear ourselves to others greatly



The crisis of residential colonies in Punjab

Despite repeated efforts to curb unauthorised development, the reality remains stark: unauthorised colonies have proliferated, and buyers still face numerous hurdles



n its meeting held on August 14, 2024, the Punjab cabinet decided to remove the requirement of PUDA NOC for the sale of plots in the unapproved residential colonies. But the stated objective "to save the buyers from their struggle for basic civic amenities in these colonies" is the same as used by the successive governments amending the PAPR Act 1995 from time to time while its hollowness is so obvious in the reality on the ground. Every time the law has been amended to make some of its provisions more stringent against the colonizers, it has served them more. For example, the PAPR Act 1995 was amended in 2014 to deal with the promoters or estate agents registered under the act but failing to comply with

The amendment changed the punishment of imprisonment from up to three years to a minimum of three years extendable to seven years with a fine from ten thousand to a minimum of Rupees two lac extending to Rupees five lac. But it made ne law ineffectual on the offending col onizers in the past. The cycle of stricter punishment and waiver of the offences in the past has been on since 1995 in the name of saving buyers from cheating and deceit. The notifications, issued in the years 2010, 2013, 2014, 2016, 2018, 2021, and 2022, amending or adding to the law(s) of PAPRA instantiate the continuity in relief to the colonizers in the name of providing relief to the people. The successive governments have been approving the schemes of instituting the need for a 'no objection certificate' NOC' by paying some fee as development charges that the individual plot holders are circumstantially compelled to pay but the real estate agents remain immune to it waiting for the next the cut-off date for the waiver. Given the increased demand for housing and the unregulated activities of "some private colonisers" working with the sole "motive of profits" disregarding "the interests and rights of buyers of plots and flats", the stated objective for repealing the Punjab Regulation of

colonies Act, 1975 and the legislating Punjab Apartment and Property Regulation Act (PAPRA) 1995 was "to check, control and regulate effectively the activities of such private colonisers and protect the interest of the consumers".

The situation originated from the unpreparedness of the government to meet the rising need for housing and post-1990 privatisation policy without any regulating mechanisms. In hind-sight, the Punjab Apartment and Property Regulation Act 1995 was legislated and the Punjab Urban Planning and Development Authority (PUDA) was established to register private colonizers and issue licenses to develop the housing colonies on the agricultural or other land after seeking change in land use (CLU) and approved plans as per rules AGENTS in PAPR Act 1995.

With a huge financial burden on salaries and infrastructure PUDA and its subsequent regional authorities were tasked to enforce 'obligations on promoters and estate agents' to create all civic amenities within a specified time-frame requiring them to hand over the colony to the respective urban local body after NOCs from all the concerned departments. The stated objective of the act (PAPAR) and the authority (PUDA) since then has been to check the growth of unauthorised colonies and enforce the development in the authorised colonies as per rules.

But unfortunately, it has miserably failed in its two-pronged objective: since 1995 the number of unauthorised colonies has risen to more than 15000 while the number of authorised colonies in comparison is much

to act for anyone as a motivation to build houses there. The colonisers have sold all the plots in the name of legal colonies plot-ting a chunk of land on its sidelines without necessary approvals and without developing the approved section to the standards of seeking NOCs from the concerned departments to hand over the colonies to the local body; the irony is that the development authorities prefer not to take any sou moto notice of it. Neither the developer nor any government agency including PUDA undertakes the development responsibility although the rules prescribe stringent action against the coloniser and for PUDA to undertake development by confiscating the mortgaged properties and bank guarantees etc. But PUDA continues to grant extensions year after year while the plot buyer is not able to build

The plot buyers feel legally duped. The unauthorised colonies without change in land use or any

approved plan continued to mushroom where the colonisers created very little infrastructure and sold the plots leaving the plot holders to act as the vote bank approaching the political class for relief. Hence the need for NOCs and their waiver becomes a game of politics rather than a policy. Now that the cycle is complete by the Punjab cabinet decision to waive off the need for NOCs in the unauthorised colonies while the cabinet itself had legislated for the NOCs.

It doesn't matter to the common man which cabinet it was or is; what matters to them is a legal and easy-to-build house policy for them.

Therefore while the government notifies the waiver of NOCs in the unauthorised colonies, it should direct PUDA to confiscate mortgaged properties and bank guarantees to develop all morethan-ten-years colonies and ensure time-bound development of electricity LD systems, sewerage, water supply and roads before selling any plot in the authorised colonies to encourage the planned and legal development and strictly control the unauthorised development in future rather than approve policies to legalise the illegal.

The onus for ensured development should be on the regulator rather than on the buyer of a plot. Let the 2024 notification waiving off the condition of NOCs by the buyers be the last one! Let the common man experience the fundamental right to live a respectable life!

Aid group: Israeli missiles hit convoy to hospital in Gaza

n Israeli missile hit a con-A voy carrying medical supplies and fuel to an Emirati hospital in the Gaza Strip, killing several people from a local transportation company, the American Near East Refugee Aid group said Friday. Israel claimed without immediate evidence that it opened fire after gunmen seized the con-

The strike killed several people employed by a transportation company that the aid group was using to bring supplies to the Emirates Red Crescent Hospital in Rafah, said Sandra Rasheed, Anera's director for the Palestinian territories.

The strike happened Thursday on the Salah al-Din Road in the Gaza Strip and hit the convoy's first vehicle.

"The convoy, which was coordinated by Anera and approved by Israeli authorities, included an Anera employee who was fortunately unharmed,"

Rasheed said in a statement. "Despite this devastating incident, our understanding is that the remaining vehicles in the convoy were able to continue and successfully deliver the aid to the hospital. We are urgently seeking further details about what happened?

Anera planned to release more information later Friday. The Israeli military did not immediately respond to a request for comment Friday from The Associated Press. However, Israeli military spokesperson Lt. Col. Avichay Adraee posted to the social

platform X that "gunmen seized a car at the head of the convoy (a jeep) and began driving." "After the seizure operation and after confirming the possibility of attacking the militants' vehicle alone, the raid was carried out, as the rest of the convoy vehicles were not harmed and reached their target according to the plan," Adraee wrote. "The operation to target the militants removed the risk of seizing the human-itarian convoy." He added: "The presence of armed men inside a humanitarian convoy in an uncoordinated manner makes it difficult to secure the convoys and their staff and harms the humanitarian effort."The United Arab Emirates, which reached a diplomatic recognition deal with Israel in 2020 and has been providing aid to Gaza since the Israel-Hamas war began, did not immediately acknowledge the attack. Ísraeli forces have opened fire on other aid convoys in the Gaza Strip.

Houthi video shows Yemeni rebels planted bombs on tanker now threatening Red Sea oil spill

Yemen's Houthi rebels released footage on Thursday showing their fighters boarded and placed explosives on a Greek-flagged tanker, setting off blasts that put the Red Sea at risk of a major oil spill. The vessel was abandoned earlier, after the Houthis repeatedly attacked it.

In the video, the Iran-backed Houthis chant their motto as the bombs detonated aboard the oil tanker Sounion: "God is the greatest; death to America; death to Israel; curse the Jews; victory to Islam." The blasts capped the most-serious attack in weeks by the Houthis in their campaign disrupting the \$1 trillion in goods that pass through the Red Sea each year over the Israel-Hamas war in the Gaza Strip, as well as halting some aid shipments to conflict-ravaged Sudan and Yemen. The Sounion carried some 1 million barrels of oil when the Houthis initially attacked it on Aug 21 with small arms fire, projectiles and a drone boat. A French destroy

er operating as part of the European Union's Operation Aspides rescued the Sounion's crew of 25 Filipinos and Russians, as well as four private security personnel, after they abandoned the vessel and took them to nearby Djibouti.

The footage released Thursday shows masked Houthi fighters carrying Kalashnikov-style rifles boarding the Sounion after it was abandoned. The bridge appeared ransacked. Fighters then rigged explosives over hatches on its deck leading to the oil tankers below. At least six simultaneous blasts could be seen in the footage.

The footage, as well as comments by the Houthi's mysterious leader Abdul Malik al-Houthi, confirmed an earlier analysis by The Associated Press that the Houthis boarded and planted explosives on the Sounion. The Houthi-controlled SABA news agency described al-Houthi as saying the Sounion attack shows America "is lying in its claims regarding any deterrence of Yemeni operations sup-porting Palestine". "The effectiveness of our operations and their control of the situation is acknowledged by the enemies," al-Houthi said.

Western countries and the United Nations have warned any oil spill from the Sounion could devastate the coral reefs and wildlife around the Red Sea. However, the EU's naval force in the region says it has yet to see any oil spill from the Sounion. Operation Aspides "is preparing to facilitate any courses of action, in coordination with European authorities and neighbouring countries, to avert a catastrophic environmental crisis," the EU mission said. "Together, we can protect the environment and maintain stability in the region." UN spokesman Stephane Dujarric commended the efforts by the international community and the UN special envoy for Yemen, Hans Grundberg, "to secure the immediate access to the vessel and avert an environmental catastrophe". The Houthis have agreed to allow the operation to proceed safely, he said. Dujarric did not offer any indication when it might start

but added that the reports that "the salvage operations for the tanker can proceed with tugboats and rescue ships to access the incident area" are encouraging.On Wednesday, the Houthis suggested they may allow the Sounion to be salvaged, though the rebels already once blocked crews trying to reach the abandoned vessel, the US military

The US State Department declined to directly comment on the video Thursday. It referred to earlier remarks in which spokesperson Matthew Miller warned "the Houthis' continued attacks threaten to spill a million barrels of oil into the Red Sea. an amount four times the size of the Exxon Valdez disaster" in 1989 off Alaska. This isn't the first time the Houthis have used the threat of an oil spill to their advantage. It took years of negotiations before the rebels allowed the UN in 2023 to remove 1 million barrels from the oil tanker Safer off the coast of Yemen, which had been used as a float ing storage and offloading facil-

Germany deports 28 Afghan nationals to their homeland

ermany deported Afghan Gnationals to their homeland on Friday for the first time since August 2021, when the Taliban returned to power. Government

spokesperson Steffen Hebestreit described the 28 Afghan nationals as convicted criminals but did not immediately respond to a request for comment to clarify their offenses.

Interior Minister Nancy Faeser called the move a security issue for Germany. Germany does not have diplomatic relations with the Taliban, requiring the government to work through other channels. It's unlikely that Friday's actions will lead to a wider thawing of relations between Germany and the Taliban, especially after last week's issuing of the first set of laws to prevent vice and virtue Afghanistan. They include a voice outside the home.

German Foreign Minister Annalena Baerbock has slammed the morality laws in posts on X.

"I think sadly in the last decade, we have had in the former president someone who has really been pushing an agenda and an environment that is about diminishing the character and the strength of who we are as Americans really dividing our nation," Harris, in a joint interview with her running mate Minnesota Governor Tim Walz, told CNN. "And I think people are ready to turn the page on that," Harris, the Democratic Party's candidate,

"The American people are ready for a new way forward. Our former president has pushed an agenda that diminishes the character and strength of who we are as Americans, and divides our nation. People are ready to turn the page," she said in a post on X, linking an interview snippet. Harris, who is of Indian and African heritage, also refused to engage in Trump's identity politics during the interview. She eluded questions about Trump's claims over her racial identity, calling those a part of the "same old tired playbook".

Last month, Trump questioned Harris' racial identity at the National Association of Black Journalists conference in Chicago, suggesting she had previously identified as South Asian but "happened to turn Black" for political purposes. Her refusal to comment aligned with her campaign's strategy to avoid leaning into identity politics following Trump's remarks, CNN reported. Responding to a question about a previous debate on the

ders, she said, "I believe there should be consequence. We have laws that have to be followed and enforced that address and deal with people who cross our border illegally. Trump asks federal court to intervene in hush money case in bid to toss conviction

Donald Trump asked a federal court late Thursday to intervene in his New York hush money criminal case, seeking a pathway to overturn his felony conviction and indefinitely delay his sentencing scheduled for next month. Lawyers for the former president and current Republican nominee asked the federal court in Manhattan to seize the case from the state court where it was brought and tried, arguing that the historic prosecution violated Trump's constitutional rights and ran afoul of the US Supreme Court's recent ruling on presidential immuni-

Trump's lawyers said moving the case to federal court following his May 30 conviction will give him an "unbiased forum, free from

local hostilities" to address those issues. If the case is moved to federal court, Trump lawyers wrote, they will then seek to have the verdict overturned and the case dismissed. If it remains in state court, with sentencing proceeding as scheduled, it could amount to election interference, they said. "The ongoing proceedings will continue to cause direct and irreparable harm to President Trump — the leading candidate in the 2024 Presidential election — and voters located far beyond Manhattan," Trump lawyers Todd Blanche and Emil Bove wrote in a 64-page US District Court court filing. Trump was convicted in state court in Manhattan of 34 counts of falsifying business records related to a payment to bury affair allegations that threatened to cloud his 2016 presidential run. Even if the case isn't moved to federal court, the potential delay caused by litigation surrounding Trump's effort could give him a critical reprieve as he navigates the aftermath of his criminal conviction and the homestretch of his

presidential campaign. Separately, the state court judge who presided over the trial, Juan M Merchan, is weighing Trump's requests to postpone sentencing until after Election Day, Nov 5, and to overturn the verdict and dismiss the case in the wake of the Supreme Court's immunity decision. The high court's July 1 ruling reins in pros-ecutions of ex-presidents for official acts and restricts prosecutors in pointing to official acts as evidence that a president's unofficial actions were illegal. Trump's lawyers argue that in light of the ruling, jurors in the

B'desh yearns for new political force amidst uncertainty

fter Bangladesh's recent Apolitical upheaval following Sheikh Hasina's ouster, the deeply polarised country is yearning for a new political force to emerge beyond the traditional Awami League and Bangladesh Nationalist Party binary that aims to create a discrimination-free and more inclusive society.

"We have seen the BNP, Awami League, and Jatiya Party come to power and fail us for decades. It is time for someone new to lead our country," says 60-year-old Ahmed, a rick-shaw-puller in Dhaka, echoing a sentiment shared by many in present-day Bangladesh.

After unprecedented anti-government protests that peaked on August 5, Hasina, 76, resigned as prime minister and fled to India.

The interim government led by 84-year-old Nobel laureate Mohammad Yunus aims to

reform Bangladesh's fractured another player in the political arena and has gone through trust by ensuring a free and fair election, which, if successful, would mark a significant achievement in a nation with a history of electoral malprac-

Yet, people are divided and yearning for a new political force, having experienced all the traditional parties.

While former prime minister Khalida Zia's BNP, long the main opposition party, is expected to participate, people have already tasted its gover-nance in the early 1990s and 2000s, casting doubt on its ability to gain widespread public

The Jamaat-e-Islami, the largest Islamic party in the country, is also a contender after the ban on it was lifted this week, but it too was in power in the early 2000s alongside the BNP.

The Jatiya Party, which held power in the late 1980s, is

Meanwhile, the Awami League, now a political pariah, with its leadership in hiding or exile, is uncertain whether it will be in a position to join the fray.

The possibility of new student parties emerging from the recent upheaval also looms large, potentially shifting the dynamics of the upcoming elections. We, too, had hit the streets by

responding to the call by the students. The students and youth of the nation have given us new hope, and now they must not step back. They have already come up as a force to reckon with, and now they should come up with a fullfledged political party. Amid the growing speculation

about new political players, the role of the student movement remains a critical factor.

While many have suggested that the student-led Monsoon Revolution could lead to the formation of a new political outfit, student leaders have so far refuted such reports.

"We are not here to replicate the mistakes of the past; we want to hold those in power accountable, whoever they may be," Ayesha Siddiqui, a student activist, said. However, with the political

landscape in flux, some observers believe it's only a matter of time before the students channel their momentum into a more organised political form, potentially becoming a new force in Bangladesh's politics. The recent student movement has left many veteran politicians wondering if a new era of political transformation in Bangladesh is on the horizon. Golam Sarwar Milon, the first

president of the Bangladesh Jatiotabadi Chatra Dal—the student wing of the BNP—suggested that the successful movement could pave the way for a new generation of political leaders, potentially challenging the dominance of tra-ditional parties like the BNP, Awami League, and Jatiya Party. "This just may be the beginning of a new era of political transformation in Bangladesh, with students once again leading the way," Milon, who is presently co-chairman of the Jatiya Party (Raushan faction), told PTI. "The logical conclusion is that the students form a new political party. Although they have said they don't want to form any political party, you don't know what's in the future," he said. Other political leaders seem to echo this sentiment. Senior BNP leader Amir Khasru Mahmud Chowdhury mentioned there is no issue if a new

"That would only enhance the democratic system in the country. We are not like the Awami League, which doesn't believe in the democratic process. If the students want to join the political process, they are welcome to do it."

Bangladesh Jamaat-e-Islami supremo Shafiqur Rahman also stated that his party has no objections to the formation of new political entities, emphasising that everybody deserves free and fair elections. There have been no elections

in Bangladesh since 2014. All the elections were fraudulent and did not reflect the people's mandate. We want people to participate in the elections and choose their own representatives democratically," he said. Echoing these sentiments, G M Quader, the chairman of the Jaiiya Party, emphasised that student movements, untainted by narrow political agendas, have played a transformative role in shaping Bangladesh's political land-scape. "Students have a unique advantage because they are trusted by the people," he remarked.

'We have witnessed once again how ordinary citizens have rallied behind them, showing unwavering support and solidarity during the recent protests. Now if they want to form a political party and contest elections, they are free to do it," he said.

Kajal Debnath, a leader of the Hindu minority community and a praesidium member of the Bangladesh Hindu Buddhist Christian Unity Council, believes that there is significant potential for a new political force to emerge, and that "the students who spearheaded the anti-discrimination protests could indeed usher in a more inclusive and discrimination-free society in Bangladesh.

The student movements in Bangladesh have always played a critical role in shaping the country's history, from the 1952 Language Movement to the Liberation War of 1971 and beyond.

However, the recent Monsoon Revolution is being hailed as something different—an unprecedented scale of mass

mobilization that has the

potential to change the course

of Bangladesh's future. Political analysts, however, feel that supporting students during mass movements and electing them as their representa-

tives are not the same.

"It remains to be seen whether new coalitions, arising from the unorganised power of students and citizens, will lead to the formation of a new political party or a reformation of existing structures and bring about a change in the mindset of the mainstream political parties," Zillur Rehman, executive director of the Centre for Governance Studies, a think tank in Bangladesh, said.

Kremlin not worried about Putin visit to Mongolia

The Kremlin says it has "no worries" about President Vladimir Putin's upcoming visit to Mongolia, a county that is a member of the International Criminal Court, which last year issued a warrant for his arrest.

The visit, scheduled for September 3, will be Putin's first trip to an ICC member state since the warrant was issued in March 2023 over suspected war crimes in Ukraine. Under the court's founding

treaty, the Rome Statute, ICC members are bound to detain suspects for whom an arrest warrant has been issued by the court if they set foot on their soil. But the court doesn't have any enforcement mechanism. In a famous case, then Sudanese President Omar al-Bashir wasn't arrested in 2015 when he visited South Africa, which is a member of the court, sparking angry condemnation by rights activists and the country's main opposition party

Putin spokesperson Dmitrv Peskov, who previously stressed that Russia doesn't recognize the jurisdiction of the ICC, told reporters during his daily conference call Friday that the Kremlin has "no worries" about the upcoming trip: "We have a wonderful dialogue with our said.



Japan's Defence Ministry on Friday sought a record 8.5 trillion yen (USD 59 billion) budget for the next year to fortify its deterrence on southwestern islands against China's increasing threat, while focusing on unmanned weapons and AI to make up for the declining number of servicemembers as a result of the country's shrinking population. The ministry's request for 2025 marks the third year of Japan's rapid five-year military buildup plan under the government's ongoing security strategy. Japan aims to spend 43 trillion yen (USD 297 billion)

through 2027 to double its annual military spending to around 10 trillion yen, making it the world's third-largest military spender after the United States and China. The budget request was

approved at the Defence Ministry meeting Friday ahead of a submission to the Finance Ministry for negotiations through December. Japan has been rapidly building up the defense of the southwestern region in recent years amid China's growing military threats and tension in the regional seas.

bookings and operate flights as usual till 11 November 2024," the release said. The merger of Vistara with

Air India was announced in November 2022 and post-completion of the deal, Singapore Airlines will have a 25.1 per cent stake in Air India.

Vistara CEO Vinod Kannan said the merger is about offering passengers more choice with a larger fleet and a wider network while elevating the overall travel experience. "Cross-functional teams from Air India and Vistara have

been working together for many months to make the transition of aircraft, flying crew, ground-based colleagues and, importantly, our valued customers, into the new Air India as seamless as possible," Air India CEO and MD Campbell Wilson said.

SEBI amends rules to regulate unregistered financial influencers

Markets watchdog Sebi bid to regulate unregistered financial influencers or finfluencers amid growing concerns about potential risk associated with unregistered persons. such

In three separate notifications, the regulator has restricted associations between its regulated entities and upposite. and unregistered individuals. This came after the board of Sebi approved a proposal in this regard last month.

As per the notifications, the persons regulated by Sebi and the agents of such persons will not have any association like any transaction involving money, referral of a client, interaction of information technology systems with any other person who, directly or indirectly, provides advice, recommendation or makes explicit claim of return.

'No person regulated by the Board (Sebi) or the agent of such a person shall have any direct or indirect association, with another person who provides advice or any recommendation, directly or indirectly, in respect of or related to a security or securities, unless the person is registered with or otherwise permitted by the Board to provide such advice or recommendation; or makes any claim, of returns or performance expressly or impliedly, in respect of or related to a security or securities, unless the person has been permitted by the

Board to make such a claim,"



By requiring finfluencers to register with Sebi and adhere to specific guidelines, the regulator is setting a standard accountability expertise in the market experts said.

The move would ensure that mutual fund houses, research analysts, registered investment advisors and stock brokers do not partner with finfluencers.

On the other hand, a small window has been provided for investor education from such partnership.

This is subject to a condition that these finfluencers do not provide any recommendation or claim any return or

This came amid growing concern over the potential associated risks unregulated finfluencers who might offer biased

misleading advice. They usually work on commission-based model.

Finfluencers have significantly impacted their followers' financial decisions in the last few years and thus Sebi's regulatory framework can make them accountable and responsible for the advice they provide.



One started out with the Lasha Luxury Dumpling, a Tibetan masterpiece which had juicy, aromatic chicken dumplings wrapped in lotus flour dough. Legend has it that these dumplings had to be bathed in a rich, piping hot chicken broth served right at the table. The experience was as magical as the dish itself. This was followed by the Dynamite Prawn Maki, a creation of Chef Chiro





from Vancouver, crispy prawn tempura, crunchy nori, and sweet sushi rice. The freshness and texture of the prawns really stood out.

Next on offer was the Wasabi Firecracker Prawns - crispy tempura coated prawns tossed in a spicy wasabi sauce, inspired by Chef Jack's offering at his seafood restaurant from his coastal hometown. Sitting in the heart of Delhi, savouring

this delicacy was pure pleasure.

I was then thrown open to the Dim Sum Dare. This dish had four juicy chicken dim sums wrapped in carrot lotus flour and served with chicken broth. The dare was that these had to be consumed with four deadly chili dips, Sesame Sauce, Roasted Pepper Sauce, Sichuan Pepper Sauce, Bhut Jolokia Sauce. I guess my Bengali genes helped me simply cruise through this spice challenge.

I also tried Chef Takashi's exquisite and signature Enoki Truffle Crunch, crispy tempura Enoki mushrooms wrapped in creamy truffle mayo in a delectable sushi roll. They say, one evening in a tranquil forest, Chef Takashi discovered a hidden truffle patch. He then used his discovery to create a creamy truffle mayo teaming it with crispy Enoki mushrooms to create a revolutionary sushi roll. This modern innovation of a traditional Japanese cuisine went on to become a legend.

Of course, I washed all this down with a chilled glass of Kogarashi, a combination of ginger and lime and some cool crispy cucumber flavour. A splash of nonalcoholic ginger beer gave the beverage a fizzy, spicy finish. China Bistro is highly recommended if you crave for authentic Pan Asian cuisine.

ABHINAV BINDRA SAYS TRAINING INDIAN ATHLETES ON MENTAL HEALTH ISSUES A 'WORK IN PROGRESS'

lympic gold medallist Abhinav Bindra on Friday acknowledged training Indian athletes across sports on the aspect of mental health remains a "work in progress", while adding that benefits of the same must reach grassroots level.

Bindra said mental health directly influences overall wellbeing of an athlete and sports administrators also share equal responsibility in it.

"It's an area where there is work in progress acknowledge that. We are a sporting ecosystem which is developing. It is slowly maturing," he said during a virtual interaction organised by Mpower to launch AMP: A Sports Psychology Division to Elevate Athlete Performance.

"This is an aspect that not just from a shooting athlete's point of view, but across the board, which needs to be prioritised. It is something which has a direct influence on the performance of the athlete.

It has a direct influence on the well-being of an athlete. Sports organisations and everybody involved in governance has to also ensure that our athletes perform well, but their wellbeing is of equal importance," he added.



Bindra highlighted presence of a mental health expert with the Indian contingent in Paris Olympics as a step in the right direction. "We've seen progress made even during the Olympics in Paris. It was the first time there was a mental health expert who was with the team. There (also) was somebody for sleep,"

he said.

'There are things that are happening. But we need to keep working with intensity to make sure that this perpetuates down to the grassroot level," he added.

Bindra rejected the notion that athletes today are "softer" than those in the past. "I completely disagree. If that is

the notion to be believed, then the softer ones are winning more than the tougher ones because that's what our results and our history tell us," he said. Bindra revealed how a meditation course, while planning to quit shooting, helped him find "love for the process" after winning the Olympic gold in 2008.

"When I did win that gold medal at the Olympics, my energy was completely drained in the sense that I was physically, emotionally (and) mentally drained. It also required a period of time to just let go and then to recharge my batteries and that wasn't

easy," he said.
"I decided to go on a vipassana

meditation course and it was interesting because I was wanting to actually leave the sport and move on to the next calling. That was my primary drive, to find my new calling."

"I had to meditate for eight nine hours a day in complete silence for 10 days and all I did in that course was to think

in that course was to think back to my sport and think back to how I loved the process of what I was doing," he said. Bindra said he was guilty of not realising his full potential since he judged himself on outcomes of townsments.

of tournaments.
"For far too long, perhaps, I too was guilty in putting myself worth to wear my name, equating myself worth to where my name would appear on the ranking list of a sports competition and that was very silly," he said.

Olympic became champion, (a) world champion, I won many many championships but I failed in achieving my fullest and truest potential and now that I have a chance to look back I would attribute that failure to this lack of balance that I had in my life as an athlete.

"I did not humanise my effort enough and I think that was while it helped me achieve goals it didn't help me get to my very best ability," he added.

On Thursday he was more than happy to be on the sidelines, cheering for his longtime friend Wojtek Czyz as he competed in badminton at the Paris Paralympics.
"I stood next to Elena, his

incredible wife, and we both had tears in our eyes," Klopp said after watching Czyz lose to Britain's Daniel Bethell in the men's singles. "I couldn't be prouder of him. I know sports are all about results, but just seeing him on the court was so touching, and I couldn't get my head around that."

head around that."
Their friendship began about 20 years ago when Czyz, a promising soccer player, suffered a devastating injury in a collision with a goalkeeper that led to the amputation of his lower left leg. During his rehabilitation Czyz met Klopp, who was managing FSV Mainz 05, a second-division German club at the time. club at the time.

They made an immediate connection that grew deeper over the years. Klopp, who stepped down as Liverpool coach this year after more than eight seasons, often uses Czyz's story as a source of inspiration for others.

"Wojtek is constantly doing things I'm not brave enough to do," Klopp said at the La Chapelle Arena in the north of Paris. "Yesterday, he was telling me how easy it is to swim with Czyz's experience as a licensed diving instructor.

started competing in para athletics, winning gold medals for Germany in the 100 meters, 200 meters and long jump at the 2004 Paralympics. After he quit the sport in 2013 he and his wife Elena Brambilla-Czyz bought a catamaran and sailed around the world, helping amputees living on remote islands to get prosthetics.

They arrived in New Zealand

in 2019 where Czyz decided to take up badminton. After just a few years, he got so skilled at the the sport that he earned a spot at the Paris Paralympics, competing for New Zealand. However, Bethell, the No. 2 seed, proved to difficult for the 44-year-old Czyz in the SL3 category for players who practice standing and have a disability in one or both legs. Bethell won in straight sets 21-

Still, Czyz said Klopp's support meant a lot.

"Jürgen is family to me," Czyz said. "It was great having him in my corner, despite the tough loss today. We need people like Jürgen putting the spotlight on

It was a special movement also for Bethell who received a thumbs-up and a "Great job, Dan" from Klopp.

Carlos Alcaraz's 15-match Grand Slam win streak ends in loss to Botic van de Zandschulp

fter double-faulting to fall behind Atwo sets to none - a deficit he's never overcome - in the second round of the U.S. Open, Carlos Alcaraz slung his equipment bag over a shoulder and trudged toward the locker room.

Glancing in the direction of his coach, 2003 French Open champion Juan Carlos Ferrero, Alcaraz pointed his right index finger at his temple, then wagged that finger, as if to say, "I'm not thinking straight."

He might have been excused for being confused by what was transpiring under the closed retractable roof at Arthur Ashe Stadium on a chilly evening, and one set later, Alcaraz's 15match Grand Slam unbeaten streak was over with a sloppy 6-1, 7-5, 6-4 loss to 74th-ranked Botic van de Zandschulp. "It was a fight against myself, in my mind, during the match. In tennis, you are playing against someone that wants the same as you - to win the match and you have to be as ... Calm as you can, just to think better in the match and try to do good things," Alcaraz said. "Today I was playing against the opponent, and I was playing against myself, in my mind. A lot of emotions that I couldn't control."

The result eliminated the pre-tournament men's favorite and certainly was hard to predict beforehand, given the No. 3-seeded Alcaraz's standing in the game, his excellence of late and his opponent's far-lesser resume.

It followed another exit in Ashe for a past U.S. Open champion, Naomi Osaka, who was sent home Thursday by Karolina Muchova 6-3, 7-6 (5). That one, though, was not nearly as out-ofnowhere as what happened to Alcaraz. He won the French Open in June and Wimbledon in July to raise his career total to four major championships, including taking the title at Flushing Meadows in 2022. Then, in early



Maybe, Alcaraz acknowledged, a tennis schedule he called "so tight" drained him too much.

"Probably, I came here with not as much energy as I thought that I was going to (have)," he said. "But, I mean, I don't want to put that as excuse."

What's clear is he never found his footing against van de Zandschulp, a 28-year-old from the Netherlands. Alcaraz was way off, repeatedly missing the sorts of shots he usually makes routinely.

The 21-year-old from Spain came in with a 16-2 record at the U.S. Open, where he never lost before the quarterfinals in three previous appearances. This also was Alcaraz's earliest defeat at any major tournament since bowing out in the second round of Wimbledon in 2021 as a teenager; he's never been beaten in the first round

at a Slam event.

Otherwise, though, he is not someone most folks would have expected to pull off this sort of monumental upset. Consider: van de Zandschulp was just 11-18 for the season at the start of this week and hadn't won consecutive matches at a tour-level event in 2024 until now. "Actually, I am a little bit at a loss for words," he said. "It's been an incredible evening for me.

Sure was. The key stat probably was that van de Zandschulp won the point on 28 of his 35 trips to the net.

The opening set was unbelievably lopsided. With van de Zandschulp's powerful forehands and serves at up to 132 mph finding their marks, Alcaraz never seemed to get comfortable.

He did not produce a single winner in that set and was nearly doubled up in total points, 24-13. The second set was a bit better for him, but not enough so,

and a double-fault gift-wrapped a service break that put van de Zandschulp up 6-5. When Alcaraz pushed a forehand wide to end the next game, van de Zandschulp finished off a hold at love that gave him the initial two sets after 1 1/2 hours of action.

Didn't take long for Alcaraz to fall behind by a break in the third, too, at 3 2, but he made a stand immediately well, with some help, because van de Zandschulp's double-fault ceded a break that made it 3-all. Alcaraz then held at love and smiled as he strutted to the changeover.

That grin quickly was gone, though, because Alcaraz's mistakes kept arriving, and van de Zandschulp never folded.

"Of course I had some nerves, but I think if you want to beat one of these guys, you have to keep your calm and keep your head there," said van de Zandschulp, who will face No. 25 seed Jack Draper of Britain in the third round on Saturday.

New track, new colors, new confidence for Ferrari heading into home race at Italian GP

New track, new colours and renewed confidence for Ferrari as the Formula One team heads into its home race at Monza

Ferrari did better than expected weekend's Dutch Grand with Charles Leclerc earning a second straight podium finish and teammate Carlos

Sainz Jr. Surging from 10th on the grid to place That was a surprise in what was expected to be

a weekend of damage limitation before planned car upgrades at the Italian Grand Prix. Although it was a well-timed morale boost for a team which started 2024 fighting for wins but had dropped out of contention, Leclerc was

quick to temper expectations.
"I don't let the last two races change our expectations," he said. "We are in a difficult moment for the team. We are struggling a little bit with pace at the moment.

"I think we understood quite a few things since Zandvoort ... it was a good race. In Spa, it was good as well.

Here, it should be a bit more in the direction of Spa, so hopefully we'll be a bit more in the fight for the podium. However, for the win, I don't think we quite have that vet.

Indeed, Ferrari has only won one of the past 13 editions of the Italian Grand Prix, with Leclerc delighting the passionate red-clad fans in 2019. Since then, the famed Italian Scuderia's only two podium finishes have been Leclerc's second place in 2022 before he was beaten to third place by Sainz last year.

"I wouldn't say the feeling is that we must do better," Leclerc said. "However, there's definitely a huge motivation because it's not only a normal weekend that starts from the Thursday to the Sunday, but it starts already from Monday in Maranello where we have so many tifosi (fans), and that obviously motivates everybody.

"It seems and it looks like we've had a pretty strong car with a very low-downforce package even in the last few years where performance

was not as good. That's positive because it's our home race and as much as it's giving exactly the same amount of points as other races, emotionally speaking and for the whole team it's definitely a special one." **NEW LOOKS:** Monza is
