

CBI TO PROBE KOLKATA'S BESTIAL RAPE AND MURDER CASE

In a verdict welcomed by the medical fraternity which was fearing destruction of evidence by the State police in the brutal rape and murder of a resident doctor of RG Kar Medical College Hospital Kolkata, in the medical college's seminar hall, the Calcutta High Court on Tuesday ordered a courtmonitored probe by the CBI into the crime.

Ironically, R G Kar Medical Hospital was College considered till a few years ago the best medical college in eastern India.

The Bench of Chief Justice TS Sivagnanam and Justice Hiranmay Bhattacharva, hearing five public interest litigations (PIL) and a private plea, in its order directed the Kolkata Police to immediately hand over the case diary to the CBI official present in the court.

Other related documents are to be handed over to the Central agency by 10 am on Wednesday.

Chief Minister Mamata Banerjee had on Monday set the State police a deadline till Sunday to crack the case failing which, she warned, she would consider transferring the case to the Central agency. The agitators demanding justice for the 31-year-old victim, however, took the Chief Minister's decision with a pinch of salt wondering whether she was giving the



police some extra bit of time to tamper with or destroy evidence.

They also questioned her move to transfer Sandip Ghosh the principal of the RG Kar Medical College to the NRS Medical College.

"While passing the order, the court was particularly perturbed at the facts that the court college authorities did not lodge any FIR and tried to let the crime pass as a suicide case whereas the police registered an unnatural death (UD) case,

.."there was clearly something in it and some people (the authorities) were trying to protect which could not escape the High Court justices' notice," Kaustav Bagchi, a BJP leader and a lawyer who is also one of the petitioners said.

The court on its part wondered why the Health Department transferred Ghosh to the NRS Medical

College within hours of his resigning from his post following intense public outcry. The judges directed the Health Department to force the principal to go on long leave which he did by the end of the day.

The medical students across the State, including those of the RGKMCH however said they were not immediately calling off the 'cease work' stir and would take a decision only after a general body meeting. Welcoming the court order, Bengal Opposition Leader Suvendu Adhikari said his "next step would be to demand the resignation of the Health Minister Mamata who is also the Chief Minister." National Fury: How we treat our women, our saviours, a Doctor!

Medical services such as working of Outpatient Departments (OPDs) and non-emergency surgeries at various Government hospitals across the country, including the national Capital, continued to remain paralysed on Tuesday as the resident doctors' agitation against the rape-murder of a trainee doctor in Kolkata.

On Tuesday, more resident doctors joined the strike led by the Federation of Resident Doctors' Association (FORDA). The incident has sparked widespread protests, with over three lakh junior doctors and healthcare

workers expressing deep on or around the hospital concern over their safety. campus stating it was in violation of High Court Amid the strike led by the FORDA, which said "the strike will not be lifted until justice is done and our demands are met", the National Human Rights Commission (NHRC) has issued notices to the West Bengal Government and the State's police chief in the matter.

The commission on Tuesday said it has sought the reports from these authorities in two weeks.

However, acting tough, as the Delhi AIIMS' Resident Doctors' Association (RDA) continued their indefinite strike on Tuesday too, the hospital administration them against warned holding any demonstration

Union Health Minister JP Nadda in damage control mode

 $D_{\mbox{assault}}^{\mbox{ays after the tragic sexual}}$ and murder of a post-graduate student at a medical college in West Bengal triggering nationwide agitation, Union Health Minister and BJP national president JP Nadda on Tuesday condemned the incident and hoped that the CBI probe will bring out the truth in the case. However, Nadda did not

commit to implementing new laws related to the safety of doctors, a key demand of the medical community which under the banner of the Federation of Resident Association Doctors (FORDA) has been on strike, disrupting medical services in the hospitals.

He, however, assured that the Central Government would take necessary actions against those involved in the incident and promised to address the broader concerns raised by doctors.

Nadda said the incident that took place with the young woman, a PG student in West Bengal, is really heart-wrenching and has shaken the

world and the country. "I condemn it and feel sorry that such an inhumane incident has happened. The way the incident took place and the way the Government has tried to hush it up, no amount of condemnation will be enough. Bengal has become a State where there is no such thing as law and

order. Lawlessness is at its peak and the sad thing is that atrocities on women are increasing day by day and all

this happening despite the State having a woman Chief Minister. This is even more

worrying. "I would also like to say the way the West Bengal Government has tried to hush up and suppress this case, is condemnable in the strongest terms. I welcome the decision of the High Court for the CBI enquiry. The CBI enquiry will bring out the truth."

Regarding his meeting with the delegations of Doctors' Association in the last two days, he said he has assured them that the Central Government will take action against anyone connected with this incident.

"I will definitely find a remedy for this and I am sure that whatever steps are necessary for this, the Government and the Ministry will take them." Meanwhile, the National Medical (NMC), as directed by the Health Minister, issued advisory to all the medical colleges to ensure a safe working environment for



Ayurved had assured it that "henceforth there shall not be any violation of any law(s), especially relating to advertising or branding of products manufactured and marketed by the lateral advertision of the lateral advection of the lateral a marketed by it and, further, that no casual statements claiming medicinal efficacy or against any system of medicine will be released to the media in any form". The top court had said Patanjali Ayurved Ltd is "bound down to such assurance"

Fielding wife against Supriya in LS polls a mistake: Ajit

In a public admission of an error for the second time in less than a week in the run-up to the forthcoming State Assembly polls, Maharashtra deputy chief minister and NCP (AP) Ajit Pawar has said that he had made a "mistake" of fielding his wife Sunetra Pawar against his cousin Supriya Sule in the recent Lok Sabha polls.

Within days after going to town admitting that the Centre's move to ban onion export late last year was a mistake which cost the ruling MahaYuti dearly in the recently Lok Sabha polls, Ajit Pawar pushed the BJP-led

state government's womenoriented flagship scheme Mukhya Mantri Majhi Ladki Bahin Yojana" by admitting his mistake of mixing politics with family.

The ruling MahaYuti – com-prising BJP, Shiv Sena (Eknath Shinde) and NCP (Ajit Pawar) is banking heavily on the "Mukhya Mantri Majhi Ladki Bahin Yojana" populist scheme in the State Assembly polls to be held in October this year. Vijender Gupta, Leader of the Opposition in the Delhi Assembly, has lambasted Chief Minister Arvind Kejriwal's latest ploy as nothing more than a publicity stunt. Kejriwal's proposal to have junior minister Atishi hoist the flag at the Delhi government's Independence Day cel-ebration is just another of his cheap tricks to grab headlines, Gupta declared.

Gupta wholeheartedly endorsed the Lieutenant Governor's decision to appoint Home Minister Kailash Gahlot for the flag-hoisting duty, exposing Kejriwal's blatant disregard for protocol.

Gupta stated that this is not the first time Kejriwal has violated constitutional protocols. He recalled the 2021 fiasco where Kejriwal couldn't even display the National flag correctly during a press conference. Even more shocking was Kejriwal's 2014 attempt to derail Republic Day celebrations with his illconceived Rajpath protest.?

Gupta didn't mince words: "Kejriwal treats our National



flag like it's his party's play-thing. His immature, childish antics are an insult to our nation's most sacred symbol. He has absolutely no right to demean the National flag with his political games."?

The opposition leader tore into Kejriwal's letter to the Lieutenant Governor, calling it a flagrant violation of constitutional rules. "Let's not forget, Kejriwal is behind bars for the liquor scam. He has no business issuing orders from his jail cell," Gupta asserted. Such actions clearly go against prison regulations. Even the Superintendent of the prison has stated that the Chief Minister cannot issue any offiinside the jail. The prison official also warned that if Kejriwal continues such attempts, they would be forced to reduce the privileges and rights he currently enjoys.

Gupta also took aim at Cabinet Minister Gopal Rai for his misguided orders to the General Administration Department. "Both Kejriwal and his Cabinet ministers are out of line, which is why the department has explicitly refused to comply with their

orders", he said. The Leader of the Opposition stated that Kejriwal does not respect either the prison rules or the Constitution. Engaging in such unconstitutional attempts has become a habit for him. Ĝupta reminded that not only Kejriwal, but also his wife, Mrs. Sunita Kejriwal, recently tried to make the Chief Minister's letter viral by showing it to the media, in an unsuccessful attempt.

The Leader of the Opposition appealed to the Aam Aadmi Party and its leaders to maintain the constitutional dignity of the National flag and avoid cial directives or requests from creating any such controversies.

"The policy should ensure adequate safety measures at OPD, wards, and quarters. Furthermore, the advisory stressed the importance of implementing sufficient security

steps, including the deployment of adequate security staff (both male and female) in various areas of the medical college and hospital campus, such as the OPD, wards, casualty, labour rooms, hostels, residential quarters, and other open spaces.

The advisory also emphasised the importance of immediate action by college management in cases of violence against medical students and required that an FIR be lodged with the police.

It stipulated that a detailed report on the actions taken must be submitted to the National Medical Commission (NMC) within 48 hours of the incident.

The water level of the river has touched 204.35 metre at the Old Railway Bridge (ORB). The warning level is at 204.5 metre, Bharadwaj said, adding that around 10,000 to 13,000 cusecs of water is being discharged from the Hathinikund barrage present-

ly. "Munadi" (announcements) to warn people to stay away from the river and stop children from going near the river or swimming in it will start from Tuesday, the minister said. During the inspection, senior officials of I&FC department, senior officials of the revenue department, and

Patients suffer as OPD services at Govt hospitals hit due to docs strike

Elective services in Government hospitals in Delhi remained closed on Tuesday for the second day as resident doctors' continued protesting while raising slogans of 'No safety, no duty' and 'justice for victims' in the hospital premises over the recent rape and murder of a trainee doctor in Kolkata.

The protests in different hospitals across the city including centrally-run facilities All India Institutes of Medical Sciences (AIIMS), Ram Manohar Lohia (RML) Hospital and Safdarjung Hospital have paralysed services such as OPDs (out-patient departments) and non-emergency surgeries.

Meanwhile, AIIMS Delhi has warned its protesting resident doctors against holding any demonstration on or around the hospital campus stating it was in violation of High Court

The stir was in response to a call from the Federation of Resident Doctors' Association (FORDA), which said, "The strike will not be lifted until justice is served and our demands are met." The association on Monday announced an extension of its

indefinite strike after a meeting with Union health ministry officials failed to reach any resolution. FORDA president Aviral Mathur announced after the meeting that the strike would continue on Tuesday. "I, along with the association members and doctors, met with the Union health minister's team on Monday. The Congress-led UDF Deposition on Tuesday said the recent landslides in Wayanad and Kozhikode districts of Kerala indicate that climate change can no longer be ignored, and suggested the implementation of an early warning system to mitigate the impact of natural disasters in the future.

The recommendations were made along with the suggestions given to Chief Minister Pinarayi Vijayan for the rehabilitation of victims of the landslides-hit areas in Wayanad and Vilangad village in Kozhikode, Leader of Opposition (LoP) in the State Assembly V D Satheesan said. The LoP said the opposition has been saying since 2021 that climate change cannot be ignored and that it has to be addressed

"The opposition has now suggested carrying out scientific testing, mapping of disaster prone areas and setting up early warning systems. "For that, scientific institutions and meteorological departments of central and state governments and institutions of international standard like Cochin University should work in concert," he said while speaking to reporters here after submitting the proposals to the CM.

He said that Kerala has faced several natural disasters in the past and, therefore, going forward, any developmental work should take climate change also into account. The



opposition leader further said that the UDF also suggested that the government consider a law for the framing rehabilitation of victims of natural disasters. Satheesan, who submitted the

proposals in person to the CM, said that he received a positive response from Vijavan

Regarding the rehabilitation of the victims, he said that Congress MP Rahul Gandhi

has already promised to build 100 houses and the state government has assured that it would hold talks with the opposition as soon as land for project is found. the Satheesan said the opposition suggested that while building the houses, a township model facilitating community living, should be adopted, instead of simply building homes, so that all the affected persons can live together.

He said that the opposition has also recommended making micro-level rehabilitation packages tailored to the needs of each rehabilitation affected family as they were all affected in different ways "In some cases, children were orphaned, in others only elderly members of the family survived and in some, the earning members died. So, the packages have to be different in each case. We hope the state government will consider the suggestion seriously," he said.



### Sunshine after the storm

Indian agriculture set to benefit from good monsoon and PM Modi's release of climate-resistant seeds

ndia's agricultural sector, the cornerstone of its economy, is set to benefit from a double dose of positive news this monsoon season. With forecasts predicting a normal to above-normal monsoon and Prime Minister Narendra Modi's recent announcement of 109 climate-resistant seed varieties, the outlook for the country's farmers is brighter than ever. These developments not only promise a significant boost for agriculture but also hold the potential to ease inflationary pressures-a key concern for both policymakers and the general public. A favorable monsoon is expected to drive agricultural growth in India, with a report from India Ratings predicting a 4.3% increase in FY25, up from 1.4% in FY24. The monsoon plays a critical role in sustaining food supply, which in turn satisfies consumer demand and helps stabilise food prices. Additionally, a good monsoon increases rural incomes, which can stimulate demand for fast-moving consumer goods (FMCG). Monsoon rains are vital for Indian agriculture, particularly for the



kharif crop season, which includes staples like rice, maize, and pulses. With nearly 60 per cent of India's farmland being rain-fed, a good monsoon often translates to a successful harvest. This year's normal to above-average rainfall has raised hopes for a bumper crop season. A successful monsoon reduces the need for costly irrigation solutions, helping farmers save on input costs. As a result, rural incomes are expected to rise, driving consumer demand in villages and small towns, which are vital engines of the country's economic growth.

Against this promising backdrop, Prime Minister Modi's release of 109 climate-resistant seed varieties marks

a significant step towards securing India's agricultural future. These seeds have been specially developed to withstand the growing challenges posed by climate change, including erratic rainfall, prolonged droughts, and rising temperatures. By enhancing crop resilience, these seeds aim to ensure stable yields even in adverse weather conditions. The introduction of these seeds is a forward-looking initiative that aligns with the government's broader agricultural strategy, which emphasises sustainability and self-reliance. These seeds are expected to reduce crop losses due to unpredictable weather, providing farmers with a safety net and helping to stabilise food production. This could lead to a more consistent food supply. In recent years, inflation, particularly driven by volatile food prices, has been a persistent concern for the Indian economy. A good monsoon and the adoption of climate-resistant seeds could bring much-needed relief to consumers, especially those in lower-income brackets who are most affected by rising food costs. During his second term, Prime Minister Modi had promised to double farmers' incomesa goal that was challenging to achieve at the time. However, that target now seems within reach. The combination of good rainfall and resilient seed varieties could be the key to realising that vision and securing a prosperous future for Indian agriculture.



# Finding fault with the US for internal failures.



The narrative of an 'American hand' in political unrest in South Asia sells, even as the root cause of instability often lie with its own politicians

he United States of America did not have a significant role in the run-up to the independence of the Indian subcontinent from the British Raj. Indeed, the Gadar Party started as a San Francisco-based anticolonial organization, as did the New York-based India Home Rule League founded by Lala Lajpat Rai, but the Government of the USA had remained largely oblivious of the subcontinental developments. It was only in the post-World War 2 tensions between the competing 'blocs', when the Cold War started in earnest, that the USA went into overdrive to control the subcontinental narrative.To further its interest, the USA had backed military dictators in Pakistan, and undemocratic monarchies in Afghanistan and Nepal, while remaining decidedly hostile towards India.

Washington DC tellingly overlooked the genocidal conduct of the Pakistani Generals in what later became, Bangladesh. Americans were instrumental in harnessing toxic religiosity by creating the Afghan mujahedeen, the curse of which continues to this date. Pakistan was a 'Major Non-NATO Ally' and did most of its bidding in the region. The end of the Cold War with the implosion of the Soviet Union in the early 90s coincided with the rise of China as the new principal enemy. This led to a recalibration of allies and enemies, which eventually warranted a more pro-India outlook from Washington DC, even though an unnatural alliance with Pakistan persisted owing to the necessities of Afghanistan and tackling religioterror.

For a variety of reasons, including the continuing 'War on Terror' in Afghanistan, the Middle East, and Iran, to now the latest Israel-Palestine War, perceptions of America within the Ummah (Islamic World), made it naturally unsavoury. This often makes the USA the prime suspect for anything that went wrong in Tehran, Kabul, Damascus, Islamabad to even Dhaka. Invariably the Americans are seen to be partaking in Samuel P Pakistani 'establishment' tak-

Huntington's 'Clash of the Civilisations', which seemingly pits the Americans as a force against the Ummah. Americabashing is a latent and potent undercurrent that is tapped by various political parties in the Islamic countries of the region like Pakistan, Afghanistan, Maldives or Bangladesh, even if the same is genuinely warranted or not. There is no denying that America has had an amoral past with many missteps and convenient overlooking of events, but it is equally true that many political parties have twisted and even extrapolated the same to suggest outsized agendas for Washington DC because they know that such a spiel feeds into the popular and basic instincts of their citizenry.

In Pakistan, amidst the turf wars between the Military 'establishment' and Imran Khan's Tehreek-e-Insaaf government, the wily Imran Khan dialled up a phoney 'cypher' controversy entailing a foreign power i.e., the USA. This move sought to conflate two enemies (one already imagined i.e., USA, and the other requiring some context i.e. Pakistani Military) to apportion a disproportionate role for the Americans, as it was safe and popular to do so. Hasina's purported accusation of the USA plotting regime change in Bangladesh (in her undelivered speech) needs to be read contextually. His supposed stance that she'd be in power if she had given away, "Saint Martin and Bay of Bengal", is more theatrical than factual as Bangladeshis (especially youth) had genuinely tired of her rule.

If anything, the forces that have come to power reflect the sort of spirit and religious tenor that militates against American preferences. Hasina's exit has more to do with her hubris and excesses than with America working overtime to dislodge her. America is just a convenient (though often justified) enemy in Islamic countries and those who are inelegantly bumped out resort to blaming the USA hand on the rebound e.g., Pakistan earlier,

Bangladesh now.

Americans have historically had a say in Pakistani affairs, but the ouster of Imran Khan had more to do with the

# Rupee's fall against dollar is a wake-up call for India BRAJESH KUMAR

As the rupee weakens and inflation rises, strategic economic reforms to boost domestic manufacturing and reduce import dependency are urgently needed

he rupee hit a record low against the US dollar on August 5th and was trading at 84.09 per dollar. This is the biggest fall ever seen in the rupee and the rupee has reached its all-time low. If the currency of any country is stronger than other currencies, then the country is considered strong. In this globalized world, the value of every country's currency against the US dollar not only impacts the economy of that country but also affects the prices of many things in the market.

Rupee has Fallen 20 Times since **Independence:** The rupee has fallen almost 20 times since independence; in 1948, 1 dollar was equal to 4 rupees. At that time there was no debt in the country, then when the first five-year plan was implemented in 1951, the government started taking loans from foreign countries and then the value of the rupee also started decreasing continuously.

The continuous outflow of foreign funds from financial markets and crude oil has increased pressure on the rupee. The economy around the world has seen two major shocks - the COVID-19 pandemic and the Ukraine, Israel conflict. India is also not untouched by this. Today, the condition of currencies in major markets around the world is weak.

Dollar as King: According to the International Standard Organization list, there are a total of 180 currencies around the world, but among them, the American currency 'Dollar' has become a global currency. The price of most of the things exported is paid in dollars. Today the dollar is involved in 80 percent of the world's trade. The US dollar has the status of a global currency, which is why the value of the rupee against the dollar shows whether the Indian curren-

cy is strong or weak. The falling value of the Rupee affects Common People: When the rupee becomes cheaper against the dollar, it has a direct impact on the economy.

The falling value of the rupee brings inflation. Rising prices could accelerate inflation, which is already high. In such a situation, everything from the life of the common man to businessmen and government will be affected by the value of the rupee. The decline in global activity, investors' decision to invest money in sale global markets and increasing tension in global politics are among the main reasons behind the fall of the rupee. Even if we do not take seriously the fall and rise of a few paise in the rupee, they have a big impact on our lives. The fall in the rupee has a direct impact on the country's economy, due to which import of petroleum products will become expensive and freight transportation will become expensive. This will have a direct impact on the inflation of every essential item. There is a sudden increase in all loans taken in foreign currency and the interest paid on them. Studying abroad will also be expensive. Why the Rupee is falling: The value of the rupee completely depends on its demand and supply and import and export also have a direct impact. A country that imports more than it exports has GROSS DOMESTIC a higher demand for dollars. Like India imports more than it exports. India is one of the major importers of crude oil and imports about 80 per cent of the oil, undoubtedly the rising prices of crude oil

Things to do for the value of the Rupee: Although the Central Government has assured to make every possible effort to stop the fall of the Rupee, now the Government will have to take concrete and tough steps. If the government tries to change its economy dependent on oil, then we can save a huge part of the foreign reserves and for this, we all should consider alternatives to oil. During the coronavirus pandemic, there was publicity that the companies leaving China were going to come to India, however, most of these companies have shifted their base to Vietnam, Taiwan, Thailand etc. and only a few have come to India. Every year crores of laptops, desktops and servers are sold in India, in which motherboards memory models and chips are being imported. We are dependent on other countries for these components.

Even today, most of the items are not being produced but are being assembled. There is no justification for the import of Harmonized System products mechanical oment and their parts), and HS-85 (electrical machinery) as most of these items can be produced locally. PLI schemes should be extended to MSMEs and emerging industries to increase exports. The 15 per cent corporate tax rate for new investment in manufacturing should be extended to all industries including the service sector. The expansion and use of new-age technology applications such as Artificial Intelligence (AI), Internet of Things (IoT) and Machine Learning (ML) require tax incentives on capital or oper-ational expenditure. The government should reduce the logistics cost to 6-8% of the GDP which is currently 14%, the good thing is that recently at the G-20 summit, there has been talk of setting up an economic corridor

India remains flawed due to the poor infrastructure of the country. Compared to China, which spends 20% of its GDP on infrastructure development, our country spends only 3%. Way Forward: At a time when the value of the rupee has crossed Rs 84 per US dollar, the role of 'Make in India' becomes very important. According to the International Labor Organization (ILO), India may face a shortage of about 29 million skilled workers by 2030. The economy needs more than policy window dressing to increase manufacturing activity. We need to understand that just passing bills and organizing investor conferences will not be enough to promote industrialization.

The manufacturing sector is constrained by large amounts of paperwork, be it labour, land or environmental clearances, stringent regulations and policy. Taxation and customs policies are complex to such an extent that it is cheaper to import things like medical equipment rather than manufacture the equipment domestically. India can make itself the next 'global factory' in the future, which is already fed up with China and is looking for alternative manufacturing hubs. There is a need to free the manufacturing sector from cumbersome rules. Certainly, the fall of the rupee against the dollar can be controlled through such effective steps. Also, if we start using indigenous goods then the cost of importing foreign goods will be saved. For India to become a \$5 trillion economy by 2025, we need to export at least \$2.5 trillion worth of goods and services, as exports currently contribute about 25% to the total gross domestic product (GDP). India has no time to rest. We have come a long way, but the journey is not over vet.

# Iran rejects European leaders' call to refrain from retaliation

ran rejected a call Tuesday by Lthree European countries urg ing it to refrain from any retal iatory attacks that would further escalate regional tensions. Iran calls it an "excessive request."

The leaders of Britain, France and Germany in a joint state-ment Monday asked Iran and its allies to refrain from retaliation for the killing of Hamas political leader Ismail Haniyeh in Tehran last month. Iran has blamed Israel.

The European leaders also endorsed the latest push by mediators Qatar, Egypt and the United States to broker an agree-ment to end the Israel-Hamas war. Talks are expected to resume Thursday. And they called for the return of scores of hostages held by Hamas and the "unfettered" delivery of humanitarian aid to Gaza

Mediators have spent months trying to get the sides to agree to a three-phase plan in which Hamas would release the remaining hostages captured in its October 7 attack in exchange for Palestinians imprisoned by Israel, and Israel would with draw from Gaza.

After more than 10 months of fighting, the Palestinian death toll is nearing 40,000 in Gaza, according to the Health Ministry there.

Meanwhile, Israel's far-right National Security Minister Itamar Ben-Gvir visited Jerusalem's most sensitive holy site Tuesday, in a pilgrimage seen by Muslims as provocative as regional tensions soar.

Tensions over the compound have fueled rounds of violence before. Ben-Gvir, an ultranationalist settler leader, last visited the compound in July, which the Palestinian Foreign Ministry condemned as a "provocative intrusion" that endangered the fragile status quo regarding the Jerusalem compound.

Ben-Gvir visited the flashpoint



site Tuesday morning as Jews marked Tisha B'Av, a day of mourning commercating the destruction of the biblical Temples. Jews revere the site as the Temple Mount, believed to be the location of the First and Second Temples, and it is a holy site for Muslims as Haram al-Sharif or the Noble Sanctuary. The visit elicited a rebuke from Prime Minister Benjamin

Netanyahu, who said prayers there were a "deviation" from decades-old understandings at the site that prohibit Jewish worship there.

In video released by his office, Ben-Gvir was seen strolling through the compound singing, "The people of Israel live!" while accompanied by dozens of supporters. One supporter yelled a Jewish prayer, which is not permitted under the longstanding arrangement in place at the site meant to ease regional tensions. Ben-Gvir has said he is changing the policy and, despite previous assurances to the contrary by Netanyahu, he repeated the stance Tuesday, adding that "very large progress" had been made to allow Jewish prayer at the site. Netanyahu said there was no change to the policy.

# Israeli strikes kill at least 16

rsraeli strikes in Gaza killed at least 16 Palestinians, including four women and seven children, and orphaned another four children, Palestinian medical officials said Tuesday.

Ten people were killed in a strike late Monday on a house near the southern city of Khan Younis, where Israel ordered mass evac uations in recent days, saying it must act against Palestinian militants.

Nasser Hospital, where the bodies were brought, said another four children, including a 3-month-old infant, were wounded. The infant's parents and their other five children were among those killed

The parents of the other three wounded children were also killed according to the hospital'sz list of casualties.

An Associated Press journalist counted the bodies

A separate strike near Deir al-Balah in central Gaza killed a woman and her twin babies, who were four days old, and their grandmother. Another strike in central Gaza killed a man and his nephew

An Associated Press reporter counted the bodies at the nearby Al-Aqsa Martyrs Hospital and spoke to the father of the twins, who had planned to register their birth on Tuesday.

The head of Bangladesh's government, Nobel laureate Muhammad Yunus, says the high-profile resignations of authorities close to ousted Prime Minister Sheikh Hasina are legal after student leaders who organised protests against Hasina's government issued ultimatums

Sved Refaat Ahmed was appointed the new chief jus-tice on Sunday after his name was proposed by student leaders of the protests.

Students vow to cleanse the political system of Hasina's rule, which they have denounced as autocratic. More than 300 people, includ-ing students and police offi-cers, were killed in the weeks of vielance of violence

Yunus took over on Thursday after student leaders reached out. He said the students told him he was the only one they could trust.

He said he accepted "because these are the guys who broke the local government," describing it as a "student-led revolution"

It's not my dream, it's their dream. So I'm kind of helping them to make it come true, Yunus said

The interim government is expected to announce a new election, but it is not clear when it will be held.

Yunus had been a longtime critic of Hasina and her government.

An economist and banker by profession and known as the thbanker to the poorest of the poor," he was awarded the Nobel Peace Prize in 2006 for pioneering the use of micro-credit to help impoverished people, particularly women. Yunus ran into trouble with Hasina in 2008, when her administration launched a series of investigations into him and his Grameen Bank. He was put on trial in 2013 on charges of receiving money without government permis-sion, including his Nobel Prize and royalties from

a book. Yunus has denied the allegations, and his supporters say he was targeted because of his frosty relations with Hasina.

### Khaleda Zia's BNP to hold sit-in across Bangladesh PTI 📕 DHAKA

The Bangladesh Nationalist Party of former prime minister Khaleda Zia will hold sit-in programmes in front of its party offices across the country on Wednesday and Thursday, demanding a trial be conducted against ousted prime minister Sheikh Hasina for "genocide".

Bangladesh Nationalist Party's (BNP) joint secretary general Ruhul Kabir Rizvi on Tuesday and said that a prayer session will be held to commemorate Khaleda Zia's 79th birthday on Friday and to pray for those killed in the protest, The Dhaka Tribune reported.

Special prayers have been arranged in Hindu temples and other places of worship, the report said.

Rizvi urged all leaders and activists of the BNP and its affiliated organisations to participate in these programmes. Over 230 people were killed in Bangladesh in the incidents of violence that erupted across the country following the fall of the Hasina government on August 5, taking the death toll to 560 since the anti-quota protests first started in mid-July.

An interim government was formed after the fall of the Hasina-led government, and its Chief Adviser, 84-year-old Nobel laureate Muhammad Yunus, announced the portfolios of his 16-member coun-

cil of advisors last week. On Monday, seven political parties, including the Awami League's arch-rival BNP, met Yunus separately and said the interim government could take the time necessary to create a conducive environment for holding free and fair elections, The Daily Star newspaper reported.

Authorities said 15 people were injured, mostly due to smoke inhalation, as the blaze reached outlying sections of a suburb about 15 kilometres (9 miles) from the city centre. ### Harris more incompetent than Biden, Trump tells Musk FBI probing Trump campaign charge of hacking by Iran

 $D_{nominee\ Kamala\ Harris}^{emocratic\ presidential}$ is a "third-rate phoney candidate" and "more incompetent" than her boss President Joe Biden, her Republican rival in the November election, Donald Trump, has said. In a much-anticipated audioonly interview with billionaire tech magnate Elon Musk on Monday on his social media platform X which was delayed by more than 40 minutes due to technical difficulties, the 78-year-old former president said, "She is a radical left lunatic," as he alleged that "she wants to be more Trump than Trump". Launching a scathing attack on the 59-year-old US Vice

President, Trump described Harris as a "third-rate phoney candidate." He reiterated his allegation that Biden being replaced by Harris as a presidential candidate of the Democratic party was a coup. Musk agreed with the former president and said, "Her

#### behaviour is far left."

'She (Harris) had three and a half years, and by the way, they have another five months that they can do something. But they won't do anything. It's all talk," Trump said. "She's incompetent, and he

(Biden) is incompetent. And frankly, I think that she's more incompetent than he is, and that's saying something because he's not too good," he said. Trump would face Harris in the general elections on November 5.

He accused Harris of having failed miserably on border security as hundreds and thousands of people entered the country illegally.

Asserting that he is in favour of legal immigration, Trump said it is illegal immigration that he is against.

"She is such a liar," Trump alleged on X, previously known as Twitter, on the day when he returned to the social media platform. Over a million people lis-

Meanwhile, Musk stressed that people respond to strength and not weakness and said, "We have some really bad people ... we have some really bad people, and I say they are more dangerous than Russia and China. The biggest threat, he said, is

not climate change but nuclear warming.

The conversation between Trump and Musk started with the failed assassination attempt on the former president in Butler, Pennsylvania, on July 13.

"It's very much, I say, an act of God. It's a miracle that it happened," Trump said.

Commenting on the country's economy, he said the US is having the worst inflation in 100 years. Trump accused the Biden-Harris administration of the worsening of the US economy

The FBI is investigating allega-tions that sensitive documents from Donald Trump's presidential campaign were stolen in a cyber intrusion, as well as attempts to gain access to Vice President Kamala Harris' campaign, days after the Trump campaign declared it had been hacked by Iran.

The FBI released a brief statement on the Trump matter reading, "We can confirm the FBI is investigating this matter".

The Trump campaign provided no specific evidence of Iran's involvement, but the claim came shortly after Microsoft issued a report detailing foreign agents' attempts to interfere in the US election in 2024. The report cited an instance of an Iranian military intelligence unit in June sending "a spear-phishing email to a high-ranking official of a presidential campaign from a compromised email account of a former senior advisor".

Two people familiar with the matter said the Biden-Harris campaign was also targeted in the suspected Iranian cyber intrusion that is under FBI investigation. The people spoke on the condition of anonymity because they were not authorised to discuss the details of the investigation. Politico reported Saturday that it

began receiving emails on July 22 from an anonymous account. The source — an AOL email account identified only as "Robert" — passed along what appeared to be a research dossier the campaign had apparently done on the Republican vice presidential nominee, Ohio Sen. ID Vance. The document was dated February 23, almost five months before Trump selected Vance as his running mate.

"These documents were obtained illegally" and "intended to interfere with the 2024 election and sow chaos throughout our Democratic process," Trump campaign spokesperson Steven Cheung said. At least three staffers in the Biden-Harris campaign were targeted with phishing emails, but investigators have uncovered no evidence the attempt was successful, one of the people said. The attempts came before President Joe Biden dropped out of the race. The FBI began investigating that cyber incident in June and intelligence officials believe Iran was behind the attempts, that person said. Officials have also been in touch with tech companies in recent months about the possibility that people linked to the Trump and Biden-Harris campaigns were being targeted through email. Harris' campaign said in a statement, "Our campaign vigilantly monitors and protects against cyber threats, and we are not aware of any security breaches of our systems." It declined to address whether it had identified any state-based intrusion attempts.



# Pak ruling coalition hails ex-ISI chief's impending court-martial

#### TI ISLAMABAD

Pakistan's ruling coalition has hailed the arrest of for-mer ISI chief Lt Gen (retd.) Faiz Hameed in connection with a housing scheme scandal but jailed former premier Imran Khan's party decided to stay neutral and termed it the army's "internal matter".

Hameed served as the director general of Inter-Services Intelligence (ISI) from 2019 to 2021, when Khan was prime minister and was accused of meddling in political affairs at his behest

According to the army, he was arrested on Monday by military authorities and court martial proceedings were initiated against him under provisions of the Pakistan Army Act for alleged misuse of authority. His arrest followed a probe into complaints against him by the owner of Top City Housing Society over an alleged raid at his house.

Asserting that the military's

actions were "internal", for mer premier Khan's Pakistan Tehreek-e-Insaf (PTI) party chairman, Barrister Gohar Ali Khan, said the army is a disciplined and organised institution with its own procedures for dealing with both serving and retired officers, the Dawn newspaper reported. However, members of the ruling Pakistan Muslim League-

Nawaz (PML-N), including Information Minister Attaullah Tarar, Senator Irfan Siddiqui, Senator Afnan, Rana Sanaullah as well as Pakistan People Party will also be proved." (PPP) leader Qamar Zaman



The realities of 1945, when the Council was established, have long been superseded by current geopolitical realities, with the need for change being felt across the board, Ravindra said ahead of next month's annual high-level UN General Assembly session which world leaders will attend. He noted that for the G4, the primary reason for the underper formance of the critical UN Security Council remains the non-representation of Africa, Latin America and the Caribbean, and the under-representation of Asia Pacific in the

members. Among the six new permanent members, two each are proposed to be from African States and Asia Pacific states, one from Latin American and Caribbean states, and one from West European and Other States. "On rights and privileges associated with permanent memberships, such as the veto, we also

support the Common African Position that as long as it exists. it should be available to all permanent members, both new and old alike," Ravindra said. Ravindra said that the G4 is convinced that African representation in permanent and non-permanent categories will be an indispensable part of UNSC reform for a more representative and effective Council.

The group believes it is "inconceivable" that Africa, which constitutes over 70 per cent of the UNSC's agenda items under discussion, does not get a permanent voice at the horse-shoe table.

'We as G4 continue to support fully these legitimate demands and aspirations from the people of Africa," he said, adding that the group's relationship with Africa is anchored in trust and mutual respect, and is focused on ensuring that Africa finds its "rightful" place in a new age of reformed multilateralism.

# Pak's anti-terrorism court rejects bail plea of Bushra Bibi in 12 cases

n anti-terrorism court in APakistan has rejected the bail application of Bushra Bibi, the wife of jailed former prime minister Imran Khan, in 12 cases related to the May 9 violence of last year which erupted when the Pakistan Tehreek-e-Insaf founder was arrested in an alleged corruption case.

Anti-terrorism court (ATC) Rawalpindi Judge Malik Ejaz Asif on Monday after hearing the plea of Bushra Bibi, 49, said that a thorough investigation was required in her case and subsequently dismissed the bail application.

The judge also ordered that the investigation in her case should be completed in seven days. Bibi was seeking bail in FIRs registered in various police stations in

Rawalpindi. Khan and Bushra were present in the court along with dozens of other accused who have been named as suspects in the May 9 violence that left more than 100 people dead.

The violence started after the Pakistan Rangers arrested Khan inside the premises of the Islamabad High Court in a corruption case.

## Yemen's Houthis seize **UNHR office in Sanaa**

#### AP CAIRO

Yemen's Houthi rebels stormed the headquarters of the United Nations' Human Rights Office in the capital, Sanaa, seizing documents, furniture and vehicles, a senior UN official said Tuesday.

The seizure was the latest move in a crackdown by the Houthis on people working with the UN, aid agencies and foreign embassies. The crackdown comes as the Iranian-backed rebels have been targeting shipping throughout the Red Sea corridor over the Israel-

Hamas war in the Gaza Strip. The rebels took over the UN Human Rights Office's premises in Sanaa on August 3, after forcing UN Yemeni workers to hand over belongings, including documents, furniture and vehicles, UN Human Rights Chief Volker Turk said in a statement

"Ansar Allah forces must leave the premises and return all assets and belongings immediately," Turk said, using the official name of the Houthis. A spokesman for the Houthis didn't return phone calls and messages requesting comment.

The UN's Human Rights Office said it had suspended the office's operations in Sanaa and other Yemeni areas controlled by the Houthis following the June crackdown campaign. But it still operates in the parts of Yemen controlled by the internationally recognized government. In June, the Houthis detained more than 60 people working with the UN and other NGOs, according to the UN Human Rights Office. Among the detainees were six workers with the Human Rights Office, who joined two of their colleagues detained by the Houthis in November 2021 and August

2023, it said. Days after the arrest campaign, the rebels said they had arrested members of what they called an "American-Israeli spy network."

The Houthis issued what they purported to be videotaped confessions by 10 Yemenis, several of whom said they were recruited by the US Embassy in Yemen. The UN Human Rights Office said one of its staffers who was detained earlier appeared in a video in which he was forced to confess to allegations, including of espionage, the office said. The Houthis' claims could not be independently verified.

The attacks come as the rebels' main sponsor, Iran, weighs possible retaliation against Israel over the assassination of Hamas official Ismail Haniyeh in July, which has renewed fears of a wider regional war in the Middle East.

Already, the Houthi assaults have disrupted the USD 1 trillion annual flow of goods through the maritime route crucial to trade among Asia, Europe and the Middle East while also sparking the most intense combat for the US Navy since World War II.

The ship was first attacked around 115 kilometers (70 miles) south of the Houthi-held port city of Hodeida, the British military's United Kingdom Maritime Trade Operations center said. An explosive was detonated near the ship, then a small vessel "acting suspiciously" flashed a light near the ship and came close, actions that were followed by a second blast, the UKMTO said.

# US-backed Syrian fighters kill 18 pro-govt gunmen in rare attack

U^S-backed Syrian fighters carried out a rare attack in eastern Syria, striking at three posts manned by pro-govern-ment gunmen and claiming that they killed 18 of them in a major escalation near the border with Iraq.

The renewed clashes in Syria's eastern oil-rich province of Deir el-Zour on Monday came amid high tensions in the region following last month's killings of a top commander of

Lebanon's militant Hezbollah group in Beirut and the political leader of the Palestinian Hamas group in Iran. Israel was blamed for both attacks, and came days after clashes and shelling between the SDF and Iran and Hezbollah have vowed pro-government gunmen left more than a dozen people to retaliate. dead.

The Syrian government, which is backed by Russia and Iran, has vowed for years to liberate eastern Syria from US forces who have been deployed in the area since 2015 to help fight the Islamic State group. # Sensex plunges to 693 on closing, market in the red

Equity benchmark BSE Sensex tumbled nearly 700 points to sink below the 79,000 level on Tuesday, extending its losses for the second straight day due to selling pressure in HDFC Bank, SBI and ITC amid fresh foreign capital outflows.

Besides, deep losses in commodity, banking and financial stocks and concerns over stretched valuation contributed to the steep market decline, analysts said.

The 30-share BSE Sensex tumbled 692.89 points or 0.87 per cent to settle at 78,956.03. During the day, it tanked

759.54 points or 0.95 per cent to 78,889.38. The NSE Nifty slumped 208 points or 0.85 per cent to 24,139. A total of 2,676 stocks declined while 1,266 laggards. advanced and 84 remained

unchanged on the BSE. The domestic market plunged into red terrain in the latter half, amidst mixed global sentiments. Recent IIP data indicates a lacklustre growth in the major manufacturing sector. Persistent selling by FIIs and elevated valuations are further contributing to the decline. "All sectors, especially banking, metal were in red, while HDFC Bank declined due to lower-than-expected passive fund inflows in the recent MSCI index rejig," said

# USA gymnastics says arbitration panel won't reconsider decision

USA Gymnastics officials say an arbitration panel won't reconsider a decision asking gymnast Jordan Chiles to return the bronze medal she was awarded in the floor exercise at the Paris Olympics. USA Gymnastics says it will continue efforts to let Chiles keep the medal.

"USA Gymnastics was notified by the Court of Arbitration for Sport (CAS) on Monday that their rules do not allow for an arbitral award to be reconsidered even when conclusive new evidence is presented," USA Gymnastics said in a statement.

"We are deeply disappointed by the notification and will

continue to pursue every possible avenue and appeal process, including to the Swiss Federal Tribunal, to ensure the just scoring, placement, and medal award for Jordan." CAS voided an on-floor appeal from Chiles' coach that vaulted her to third, saying the appeal came 4 seconds beyond the one-minute time limit for

scoring inquiries. USA Gymnastics disputed the timing, saying in a statement Sunday that the agency submitted video evidence to CAS that showed Team USA coach Cecile Landi first appealed 13 seconds before the



deadline. The dispute over The International Gymnastics such minute details sets up what could be a months- or years-long legal battle over the gymnastics scores.

# **PONTING BACKS AUSTRALIA TO HAND INDIA 3-1 DEFEAT IN BORDER-GAVASKAR TROPHY**

Ricky Ponting believes Australia will have a "point to prove" after two straight Test series defeats at home against India and backed the Pat Cummins-led side to win the five-match Border-Gavaskar Trophy 3-1 come November-December.

India, who have returned victorious in both their previous Test assignments Down Under with identical margins of 2-1, will take on the world No.1 Australia in a five-Test series starting on November 22.

"It's going to be a competitive series. Australia has got a bit of a point to prove against India in Australia on the back of what happened the last the last two series here," Ponting told 'The ICC Review. "We are back to (having) five Tests as well, which is the other really important thing about this series. It has only been four Tests the last couple of time. (To have) five Tests, everyone is really excited by that and I don't know if there'd be too many drawn games.

"I'm obviously going to tip Australia to win and I'm never going to tip against Australia. There will be a draw somewhere and there will be some bad weather somewhere, so I'm going to say 3-1 to Australia," he added. India and Australia have not played a

five-Test series after their bilateral affairs came to be known as the Border-Gavaskar Trophy. Before that, in 1991-92, India had toured



Australia for a five-Test series. Ponting backed India's left-arm seamer Khaleel Ahmed, whom he coached in the IPL at Delhi Capitals, to be a part of India's touring party. "Someone like Khaleel Ahmed, I think, could find himself on the Test

tour. He has just been over in Zimbabwe recently and played that (T20I) series over there, but a left-armer would be ideal for them to have in their touring squad," Ponting said. The former Australia skipper hoped both teams will be deploying fullfledged bowling attacks.

"(Mohammed) Shami will be back fit by then, (Mohammed) Siraj we know will be there-abouts somewhere and obviously (Jasprit) Bumrah is going nowhere. Both teams are going to line up really, really strongly," he said.

Ponting said the competitiveness between India and Australia is quite close to the Ashes rivalry against England.

"I was a part of it when that really started to grow, when the rivalry really started to grow, was it's right at the back end of my career," Ponting

said. "Tve said for the last couple of years now, Australia have always had a fierce rivalry with England, obviously, and a very strong rivalry with South Africa

"But I think India is now sitting right on the back of what an Ashes clash is like and probably overtaken the rivalry with South Africa.

Ponting said while Australia's squad looks more or less settled, it remains to be seen if Steve Smith would like to

to be seen if Steve Smith would like to persist being at the opening slot. "Australia will pretty much pick itself. Probably, the only one question there might be with Australia again, is if (Steve) Smith's the right man to be opening the batting," he said. "That would be the only query that I can see there. But that was all about obviously bringing Cameron Green

obviously bringing Cameron Green back into the side.

'So I'll rephrase it, not whether Smith's the right man to open the batting but whether he thinks it's the right spot for him. Because if he doesn't think it's the right spot, then they'll make a change and get someone else back up there," Ponting added.

# Premier League will have different look when season starts Friday

### The Premier League rarely stands still.

For the 2024-25 season starting on Friday, there are five newly hired managers, around \$1.6 billion worth of new players (and counting), new offside technology, updated financial regulations and a tweaked match schedule.

COACHING CHANGES: A quarter of the coaches will be taking charge of a Premier League game for the first time, with Liverpool (Arne Slot), Chelsea (Enzo Maresca) and Brighton (Fabian Hurzeler) all having new managers and both Southampton (Russell Martin) and Ipswich (Kieran McKenna) gaining promotion with Lopetegui being the new guy at

West Ham after 4 1/2 years of David Moyes at the helm and Steve Cooper replacing Maresca at Leicester, and the dugouts will look different this season. Most of the intrigue, however, will focus on Slot and what style he implements at Liverpool after the team's nearly nine years with the popular Jurgen Klopp. Rock n' roll could turn into

more control, with Slot preferring more of a possession game. SLOWER MARKET: The Premier League's 20 clubs have spent as much on new players in this transfer window as those in Spain, Italy and Germany combined, according to transfermarkt.Com. So why does it feel such a slow summer of trading? Maybe because there have been no blockbuster deals, managers owning no top-flight with the most expensive being experience. Throw in Julen striker Dominic Solanke moving to Tottenham from Bournemouth for



65 million pounds (\$83 million). However, lots of deals for between \$30-70 million quickly add up - and there are still three weeks left in the window, during which Manchester City, Manchester United, Liverpool, Come the end of transfer deadline

day on Aug. 30, don't be surprised if Premier League clubs have spent way more than \$2 billion - even if most are balancing the books with sales because of the league's sterner financial rules.

SEMI-AUTOMATED OFFSIDES: Expect offside decisions to be reached much quicker in the Premier League this season. The competition is introducing semiautomated offside technology for the first time, with the new system set to be launched during the first half of the season. Multiple cameras will track player movements and record data points on parts of the body that are relevant for an offside decision. Data is processed with artificial intelligence to create a 3D offside line that is alerted to the team of VAR officials. It is expected to take an average of around 30 seconds off the length of time it currently takes VAR officials to come to a decision manually. Semiautomated offsides were used at the 2022 World Cup and at the recent European Championship. SPENDING RULES: Last season in

the Premier League was notable for some clubs, like Everton and Nottingham Forest, receiving points deductions for breaking the competition's profitability and sustainability regulations, which are now being more strictly applied. This coming season is the final year of those regulations, with two new forms of spending caps being trialed ahead of their introduction from the 2025-26 season. Teams in England's top division will trial a 'Squad Cost Rules' system, which will limit spending on players to 85% of a club's soccer revenue and net profit or loss on player sales. A second system called "Top to

Bottom Anchoring" limits - or anchors - spending to a multiple of the lowest combined prize money and cash from TV rights forecast to be earned by a team. The league said the systems aimed to "improve and preserve clubs' financial sustainability and the competitive balance of the Premier League" as well as "promote aspiration of clubs. NO WINTER BREAK: The Premier League is renowned for being a relentless slog - even more so this season. There's no winter break for clubs this time, with the season starting later, to give players more time to recover from international tournaments this summer, and therefore being squeezed. Last year, for example, five games were held each weekend over a two-week period, giving teams at least one weekend off over January.
