Modi said there is a need to widely publicise punishments given for atrocities against

women, so that there is a fear of consequence. Without directly mentioning the ghastly crime in West Bengal, Modi said extensive discussions on those receiving punishment should be held so that criminals understand that crimes against women lead to hanging. The Prime Minister said, "Now the need of the hour is that there should be a wide discussion about the criminals who get punished so that even those who commit such sins fear the consequences, including

# Bengal women fiercely seek justice in Kolkata rape and murder horror

In a unique movement, lakhs of women of different age and from different walks of life and irrespective of their financial status on Wednesday hit the streets of Bengal, more so at several points in Kolkata to register their protest against the brutal rape and murder of a young woman in the safety of her workplace, calling to "break free of the shackles on the eve of India's 78th year of Independence." Similar protests were reported from Mumbai, Bengaluru, Hyderabad and even foreign ports like Australia and Oslo. The protest scene was tumultuous at what they call the epicentre of agitations, Jadavpur University, with thousands converging outside University, the causing widespread traffic jams along

the wide boulevards for several kilometers on end. "Is it as though all roads lead to Jadavpur," said Parambrata Chatterjee, a popular Bengali and Hindi film actor. Reports of similar congregations were reported from Coochbehar, Jalpaiguri, Siliguri, Raiganj, Bolpur-Shantiniketan, Bongaon, Durgapur, Purulia, Asansol, Howrah, Midnapore, Barasat, and Rajarhat New Town north of Kolkata.

A senior officer in the State police law and order



department said, "Bengal has shown why it is still different .. such a unique protest I have never seen in 25 years of my life. Not a thousand but several lakh, mostly women, who have emerged on the streets jettisoning pressure." Spurred by the 'Reclaim the Night' campaign, which gained momentum through social media, after Rimjhim a Presidency College postgraduate student of Sociology appealed a few days ago to join her in a midnight protest at 11:55 pm on the ppointed day.

"I did not think so many people would respond like

this... it shows that women. particularly in India have gun powder inside them, waiting or on the verge of explosion,. Meanwhile, Chief Minister Banerjee Mamata Thursday appealed to doctors to rejoin work reminding the nature of their jobs.

"Like the police the doctors too perform emergency duty and I remind them their duty ... I can only appeal to their conscience as several patients are returning to their villages without getting treatment. have learnt that few have died .. I will request them to return to their work," Banerjee said.

### **One nation, one election, Uniform Civil Code, need of the hour: PM**

 $P_{\text{on Thursday batted for two}}^{\text{rime Minister Narendra Modi}}$ crucial issues and made a strong pitch for 'Uniform Civil Code' (UCC) and 'one nation, one election, and said both of these were the need of the hour and would help in the progress of the country. He urged political parties to come forward to realise the dream while contending that frequent polls were creating hurdles in the nation's progress. The Prime Minister made a fresh call for these two contentious issues despite the BJP being 32 short of a majority in the Lok Sabha and depending on allies to reach the halfway mark. In his third term's first from Red Fort, the Prime Minister made an unequivocal pitch for a "secular" civil code instead of the current framework which is "communal" and promoted "discrimination", and also for simultaneous polls, as he fronted the ruling BJP's manifesto promises for a Uniform Civil Code and 'one nation one election'. Both a nationwide UCC and 'one nation one election' have been part of successive BJP's manifestos. While some BJPruled States are working to roll out a Uniform Civil Code, the Centre has so far not taken any legislative measure for its implementation nationally.



realise the vision of the framers of our Constitution. We should welcome diverse opinions and perspectives. Laws that divide our nation based on religion and foster discrimination have no place in modern society. Therefore, I assert that it is time country to or the Secular Civil Code. After 75 years of a Communal Civil Code, it is crucial to move towards a Secular Civil Code. Once this shift takes place, it will eliminate religious discrimination and will bridge the gap felt by ordinary citizens," Modi said. The UCC proposes a common set of laws for all citizens, regardless of their religion, covering matters such as marriage, divorce, inheritance, succession, and adoption. The goal is to have secular laws that override religious laws in these areas. Currently, the UCC is only implemented in Goa, while a bill is under consideration in Uttarakhand. In 2016, the Modi Government asked the Law Commission of India to explore how to develop a code given the "thousands of personal laws" in the country. The Commission's Law 2018 consultation paper on family law reform stated that a unified nation does not necessarily require "uniformity" and that secularism should not conflict with the country's diversity

### Festive season but vendors have little to celebrate

The national Capital may have erupted in celebration of the 78th Independence Day on Thursday, but the festive mood was missing from the once-vibrant streets of Sadar Bazar and Chawri Bazar, usually awash with patriotic fervour and crowded with shoppers buying kites, national flags and other items in the days leading up to the Independence Day and Raksha Bandhan, which falls this year on August 19.

Despair has replaced the usual anticipation the shopkeepers of these markets had from this festive season which brought in good business for them. But this year the vendors confront the grim reality of fewer footfalls and dwindling sales customers away. "Sales have



nosedived because of the long due to frequent spells of heavy rain and resultant flooding wet spell. We have to pack up every now and then because of and water-logging. Mohammad Ahsan, who sells the intermittent rain that has items related to Independence customers scurrying for cover to avoid getting drenched standing on the streets. Unsurprisingly, compared to last year, our earnings are drastically down. The chances

of making up for the loss in the next few days are getting slimmer and slimmer with the water-logging and mud and slush driving away customers." Referring to the "Har Ghar Tiranga" campaign launched by Prime Minister Narendra Modi, he added, "When Modi launched this national campaign, our sales soared to the sky but now with diffused focus on that, this time around the sales have remained very low.

The frequent downpour has severely affected sales of the vendors who wait for these events to earn some extra money but with the woeful lack of civic amenities, mostly a foolproof drainage system, in the city we are struggling to stay afloat.

hazardous manjha. "These injured birds are receiving treatment at our hospital as in many others. They often fall victim to hazardous strings, suffering painful injuries and even succumbing," said Dr Har

As even after first aid treatment, these voiceless creatures may take up to several days or months to recover fully, said Dr Singh, adding many succumb also to the trauma or bruises.

For those who rescue injured birds, Dr Singh has a word of advice: Don't apply turmeric, iodine, or ointments, as these are ineffective.

Avoid pulling out the string if the wound has clotted, as this can exacerbate blood loss. Instead, wrap the bird in a cloth and transport it to a veterinarian or contact a local animal welfare group for proper care," he said. The dangers of glass-coated

become entangled in electrical wires leading to electrocution of those who come into contact with it. 'We have issued advisories against using such manjha, as it poses severe risks when caught in electrical wires," said an official from the BSES,

Yamuna Power Limited. "Kite flying can quickly turn dangerous, even fatal, with the use of metal-coated manjha, a potent conductor of electricity," it said. Also, there have been cases of people getting hurt from strings. "People walking or riding bicycles can suffer severe cuts if they come into contact with manjha. Strings can damage vehicle tires or injure drivers, leading to crashes.

# Vijayan blames Centre for Wayanad landslide

hief Minister Pinarayi Vijayan chose the right time and place to castigate India's claim as a super power in the field of science and technology. Addressing the Independence Day parade at Thiruvananthapuram on Thursday, Vijayan said that the landslides and flood at Wayanad was caused by the poor weather forecast system of the Central Government establishments. "We need specific and sharp weather forecast which gives us the exact time, place and intensity of rainfalls, landslides and earthquakes. The truth is that the country's weather forecast system has no such capabilities," said the chief minister.

Vijayan said that what Kerala was looking for was sharp forecast and not a generalized and vague reports as furnished by the Meteorological Department and other associated wings of the ministry of earth sciences. "Had they given the exact forecast, we would have been able to control the natural disaster to a great extent," said the chief



minister Home Minister Amit Shah had told Parliament that the State was given advance alerts about the impending disaster many days ahead of the July 30 nature's fury. The Meteorological Department as well as the Indian National Centre for Ocean Information (INCOIS), Services Hyderabad are always in the forefront in alerting all States in the country about the pos-

sibilities of tornadoes, heavy rainfall and sea attacks. According to R S Sasikumar, chairman, Save University Campaign and a leading whistleblower in the State, Vijavan has some inherent issues with his way of think-

### Doctors' body to resume strike after two days after WB violence

Shocked at the recent van-dalism at the crime scene of a brutal rape-murder at R G Kar Medical College and Hospital, the Federation of Doctors Resident Associations (FORDA) has announced a resumption of their strike. This decision comes after the strike was initially called off two days ago following assurances from Union Health Minister JP Nadda. The key association has also called upon the Indian Medical Association and Private doctors to join the stir to ensure speedy justice to the victim and safe working environment for their fraternity

FORDA's statement on Thursday highlighted their dissatisfaction with the government's failure to meet their commitments and ensure the safety of healthcare professionals.

"FORDA continues the strike after the recent Tragic Incident at R G Kar and failure of government to deliver on promises in a timely manner as assured," said FORDA in a post on X along with the press statement confirming that they are resuming the strike.

Quoting from the statement,



Dr Sarvesh Pandey, General Secretary FORDA' said that "We strongly condemn the Union Ministry and state government for their failure to honour their commitments and ensure the safety of healthcare professionals during this crisis.

This represents a dark chapter in our profession. Given the gravity of recent developments and the overwhelming call for justice, we have decided to resume the strike, effec-

tive immediately." In solidarity, FORDA has organized a candle march at India Gate on Friday evening, urging doctors and healthcare professionals nationwide to participate. 'The march is intended to

advocate for justice, safety, and respect for healthcare

workers, and to demand a future where such violence is unimaginable," added Dr Aviral Mathur, President, FORDA.

The recent decision by FORDA to resume the strike follows discontent among several resident doctors' associations, which had expressed their intention to continue the agitation despite the initial call-off.

The RDAs of AIIMS, Safdarjung, and RML hospitals criticized the lack of consultation during the decisionmaking process and chose to maintain their strike actions The FORDA on Thursday said that it was working with all stakeholders and Resident Doctors' Associations (RDAs) to develop a strategic plan of action

### **CBI** summons docs of RG Kar **Medical College**

"The officials recorded our statements and wanted to know about the affairs inside the hospital as also the administration and the conduct of the Principal Dr Sandip Ghosh ... I shared whatever I knew about things," one of the doctors said after emerging from the grilling session.

Pets and stray animals can also be harmed by maniha, leading to serious injuries or even death," said Manisha Maan, a former journal-

Despite a ban imposed by the Delhi Government on all forms of manjha and a National Green Tribunal order prohibiting synthetic and nylon manjha, the hazardous strings continue to be sold. Over the past few days, the Delhi police have arrested more than 90 individuals and registered FIRs against them for the illegal sale of this dangerous kite string.

"These legal actions are part of ongoing efforts to curb the use of manjha, especially during festivals and Independence Day celebrations when kite flying is particularly popular. These businessmen are nefarious-

ly importing these banned products. There is a need for stricter enforcement and public awareness as these manification leads to accidents," said Suhaib Farooqui, Senior

Inspector with Delhi Police. Kartick Satyanarayan from Wildlife SOS urged kite fliers to use only plain cotton threads and to responsibly dispose of any discarded strings found entangled in trees. "Kite flying should be done in open areas and avoid times when birds are most active. Steering clear of known nesting sites can also help mitigate risks," he advised. Even if birds survive initial injuries, the lacerations and embedded glass can lead to infections and chronic health problems.

Healing is often slow and complicated, making survival difficult, said Kartick.

Hence, as we enjoy our festivities, it is crucial to recognize and address the serious threats posed to our voiceless avian companions, ensuring both their safety and that

of our communities, he said. Anguished by the plight of birds injured by reckless kite flyers, Anjana Kashyap, a devoted bird lover from Mayur Vihar Phase 2, Delhi, has proposed a novel

approach to address the issue. She suggested that those found guilty of selling hazardous manjha should be asked by the courts to perform community service in bird injury hospitals.

Kasĥyap believes that such an experience would heighten their awareness of the harm their products cause. "Working directly with injured birds could sensitise the accused individuals' understanding of the suffering inflicted by manjha," she asserted. Dr Har Avtar agreed with the sug-

gestion. He said, "Witnessing the consequences firsthand might foster a deeper comprehension of the impact of their actions and the critical need for safer kite-flying practices."

It can also foster a sense of responsibility and empathy, which might influence future behavior, he said adding that "this approach might draw public attention to the serious issues associated with manjha and promote greater awareness of its adverse impact on wildlife."

"Not only are there fewer customers, but the rain has also damaged much of our stocks. Items that once sold for Rs 25 are now being offered at a heavily discounted price of Rs 10 or less. We're barely making enough to feed our kids. Even though there are crowds, sales are non-existent.

People come, check the prices, and leave without buying," Khazal, a 30year-old kite seller, said, describing the current situation as the worst he has experienced.

In the streets, which are dirty and dingy, many women sit on the roads to sell their rakhis.

Seema, a vendor from Seemapuri and the sole breadwinner for her family, is feeling the pinch. "The rain has arrived late this year, which is unusual for this month.

We're struggling to save our stock from getting ruined. There's no profit, just enough to keep the hunger at bay.

Of course, it takes a physical toll when we have to run as soon as the rain arrives to save our inventory.

And once it starts to rain, we have no option but to pack up and leave for home resulting in losses."

Jyoti, who sells rakhis on the roadside, echoes the same frustration.

The rain has been relentless, and sales are less than half of what they were last year. Even last year it wasn't great, but at least we managed to get by. This year, not only is there less excitement, but pickpocketing has also become a major issue. People lose expensive phones and wallets, which further discourage them from coming out to shop."

Mohammad Afsar, who brings rakhis from Muradabad and sells them at different prices, notes, "My shop is somewhat protected, so I haven't suffered as much as those selling on the roadside. For them, the rain means closing up shop or going home empty-handed."

In contrast, his briefest address was in 2017, spanning approximately 56 minutes. His longest I-day speech before Thursday was 96 minutes in 2016 while his shortest speech was in 2017 when he spoke for around 56 minutes. On the 78th Independence Day, Modi also became the prime minister to hoist the tricolour on Independence Day and deliver a speech for the third highest time. Modi delivered his first Independence Day speech in 2014, which lasted for 65 minutes.

His speech in 2015 lasted for about 88 minutes. This was Modi's 11th address as PM and his first after taking charge for a third term. In 2018, Modi addressed from the ramparts of the Red Fort for 83 minutes. Subsequently, in 2019, he spoke for nearly 92 minutes, which was his second-longest to date. In 2020 Modi's I-day address lasted for 90 minutes. Before Modi, Jawaharlal Nehru in 1947 and IK Gujral in 1997 had the longest speeches at 72 and 71 minutes, respectively. Besides, PM Modi broke the record of his immediate predecessor Manmohan Singh by hoisting the national flag from the ramparts of the Red Fort for the 11th consecutive time.

Indira Gandhi holds the record of hoisting the national flag for the second highest time. She did so 16 times, just one short of her father's record. However, this was done in two

different stints from 1966-1977 and 1980-1984. Manmohan Singh, who was prime minister of the Congress-led UPA government for 10 years, hoisted the national flag 10 times between 2004 and 2014. Of India's 15 prime ministers, Gulzarilal Nanda and Chandra Shekhar were the only ones who did not get a chance to hoist the tricolour even once. Chandra Shekhar, who became the first prime minister of India to head a coalition government at the centre, held the top post from November 1990 to June 1991. Nanda, India's second prime minister, served the nation for two brief terms---May 27-June

9, 1964 and January 11-24, 1966. At fifth spot is Atal Bihari Vajpayee, prime minister for 13 days in 1996 and two incomplete terms from 1998 to 2004, with six times. Vajpayee is followed by Rajiv Gandhi, who became the youngest prime minister of India and served for a single term from 1984 to 1989. He hoisted the tricolour five His record was times. equalled by another Congress PM, P V Narasimha Rao, who served as PM for a single term from 1991 to 1996. Lal Bahadur Shastri and Morarji Desai hoisted the flag two times each. Shastri was prime minister from June 1964 to

Those committing such demonic acts must be booked prima facie to reinstate the trust on the government, judiciary and civil society," Modi said.

"I would also like to say that when rapes and incidents of atrocities on women occur, it is widely discussed. But when a person of such a monstrous tendency is punished, it is not seen in the news, but restricted to a corner," he added. His comments come in the backdrop of the horrific rape and murder of an on-duty trainee doctor at a government hospital in Kolkata last week which led to widespread protests. The postgraduate trainee doctor was allegedly raped and brutally murdered on August 9. A civic volunteer was arrested in connection with the crime the next day.

Addressing the nation on the 78th Independence Day, PM Modi said India can emerge

It added that additionally, the department is reinforcing its focus on the theme of Correctional Philosophy by emphasizing education and skill development programs for inmates. "In line with this initiative, the department is collaborating with Max Healthcare Facilities, Primero, Ministry of Tourism GoI, IOCL, FICCI YFLO and India's pride. He exhorted all to Art of Living to provide vocational training and further enhance rehabilitation proserving the nation with greater grams at Delhi Prisons.



Several other organizations are also contributing to skill development initiatives across various jails," it stated.

Golcha also highlighted recent advancements in prison security, including the installation of 1,248 addi-tional CCTV cameras equipped with facial recognition technology to enhance the safety of inmates. "Furthermore, the latest mobile jammers have been installed in six jails of the Tihar prison complex, specifically targeting high-security

# Modi voices concern for safety of **Hindus in unrest-hit Bangladesh**

Prime Minister Narendra Modi on Thursday hoped that the situation in violence-hit Bangladesh will return to normal soon even as he said 140 crore Indians are concerned over the safety of Hindus and minorities in the neighbouring

country In his Independence Day speech, Modi said India is committed to peace and that it will remain a well-wisher of Bangladesh in its development iourney

Modi's remarks came amid

mounting concerns in New Delhi over widespread incidents of attacks on the minority Hindu community in Bangladesh after Prime Sheikh Hasina Minister resigned and fled to India on August 5 following weeks of violent unrest.

The study in question had analyzed 5,926 workers (49% men, 51% women) with an average age of 45 at the start and 65 by the end of the follow-up period. Out of these, 186 cases of AFib were identified.

Among those with AFib, 19% reported high job strain, 25% experienced effort-reward imbalance, and 10% reported both stressors. Notably, over one-third of these participants had been diagnosed with coronary heart disease or heart failure prior to developing AFib.

This research underscores the critical need for employers and employees to recognie and address the psychological and physiological impacts of job stress, aiming to foster environments that promote overall cardiovascular health. More than one-third of participants were diagnosed with coronary heart disease or heart failure before their AFib incidence.

On mursuay, Viswam, while speaking to reporters, said, "It is the view of the CPI that scientific study should be carried out regarding tunnel projects. Going forward with such projects without a scientific will study create apprehensions in the mind of the public." He said that the land in the Western Ghats cannot take any more burden and nature has conveyed that message many times. "That is

what happened in Chooralmala and Mundakkai," the CPI state secretary said. "In the backdrop of the landslides in Wayanad, we need to think twice about any work that may impact the environment," Viswam added. the

In recent years, the world has wit-nessed violence in regions such as Gaza, Cambodia, Bosnia, Rwanda, Congo, Iraq, Syria, Yemen, and Bangladesh. The recurring bloodshed underscores a disturbing pattern: political, ethnic, and religious tensions continue to ignite conflicts that tear societies apart. The situation in Gaza is a prime example, with the Israeli-Palestinian conflict seemingly unending, causing immense suffering to civilians. #### **SC RELIEF FOR PATANJALI**

# Natural regeneration for reversing forest degradation

A shift from plantation-focused efforts to natural regeneration offers a promising solution to fight menace of forest degradation and reversing climate change

s a 'nature-based solution', shifting our approach from plantations to focus on natural regeneration is the way out to overcome forest degradation. A multi-prong strategy is required for more emphasis on reducing the drivers of degradation and restoring degraded forest lands by strengthening participatory forest management. Strengthening age-old practices of joint forest management (JFM), covering activities like assisted natural regeneration (ANR), enrichment plantation, contour trenching, native tree seed dissemination, soil, and improved water conservation practices with people's participation against millions of hectares of new plantation every year will enable us to bear a sustainable result.Forest Department make their huge plantation targets for planting within the forest areas, whereas, civil society organisation and industries do their plantation outside the forest areas.

Rarely do we seek suggestions from common people of the area, as to which plants they like (choice of species) for selection of species during plantation. Mostly it is based on the availability of saplings in local nurseries. Hence, we achieve only about 55-60 % of success (rate of survival) from these plantation drives. Also, generally, we do not give proper care and attention after planting in such large areas.Natural regeneration should be our 'mantra' for restoring nat-ural resilience and diversity in forest vegetation by supporting forest bio-diversi-ty. Supporting natural regeneration is much more economical, than raising new plantations and the best strategy for restoration and rehabilitation to control forest degradation.

There is an urgent need for expanding research on specific conservation and restoration techniques and more funds are to be allotted to support natural regeneration in every state. Forests are our natural capital, providing a plethora of ecosystem services.

Deforestation and degradation of forest and tree resources are accelerating in many parts of our country, due to our developmental target, other anthro-pogenic reasons, and natural disasters. Climate change is further exacerbating these challenges, and affecting natural resources, livelihood of people and pub-

This is majorly due to severe biotic pressure in the form of over-grazing, firewood and fodder collection and illicit felling, forest fire, invasion of weeds, climate vulnerability and pressure on land diversion for development purposes. Most NTFP-yielding species of natural forest of the whole central indian landscape (Madhya Pradesh, Chhattisgarh, Odisha, Andhra Pradesh, Telangana and part of Maharashtra) are very low due to over-harvesting, premature har-vesting and unhealthy practices of fruits, bark, gum and resin harvesting, as unsustainable harvesting practices. The National Forest Policy 1988 envisages that 33% of the geographical area should be under forest and tree cover, and we are far from achieving the target. Most natural forests have a limited number of plus trees which are potential seed-producing trees. The quality of the country's forest in terms of average productivity, per capita availability, growing stock, and forest composition and diversity has declined in the past three decades. To restore ecosystem resilience and increase the forest cover in

the country, afforestation and tree plantation activities have been given high priority but the implementation result is far below the target, to achieve an additional 5 million ha of forest and nonforest land plantation in the Green India Mission (GIM).

Every year during rainy season all 28 states and 8 union territories of India make a reasonable effort towards afforestation activities under various programs and schemes of line departments such as the National Compensatory Afforestation Fund (CAMPA), Mahatma Gandhi National Rural Employment Guarantee Scheme, National Bamboo Mission, Sub-Mission on Agroforestry, National Afforestation Programme (NAP), Green India Mission, etc. aim to increase iorest cover, restore degraded lands, and promote sustainable forest management and take actionable steps towards responding to climate change. Furthermore, investments in climate adaptations by implementing nature-based solutions will reduce the frequency and occurrence of natural disasters and stabilize the ecosystem services that are provided by forests.

The recent incidents of heatwaves across North India or the ravaging floods in Kerala, Uttarakhand and Himachal Pradesh are witness to the devastation caused by disturbing the ecosystem. The forest ecosystem is the master control for our mountain, river, grassland and agricultural landscapes. Indian forests play a critical role in carbon sequestration, fix-ing atmospheric C02 through foliage cover and acting as carbon sinks. Indian forests have 7,204 million tonnes of total carbon stock, to achieve the carbon sequestration target under the Paris Climate Convention. We need to generate an additional 2.5 to 3 billion tonnes of CO2 equivalents by 2030, which helps mitigate climate change.India is the world's 10th highest forest-covered coun-try. As per FSI, the current forest cover of India is 7,13,789 square kilometres, which is 21.71% (forest cover) and 2.91 % tree cover outside the forest area

There is an urgent need to strengthen forest land and resource rights for women and marginalised groups. Lastly, need to strengthen training, skills development resource management and transparent environmental monitoring in forest areas for the regeneration of forestry.

### Substance abuse crisis threatens the future of Uttarakhand youth

Once confined to older adults, drug addiction is now entangling school-aged children, causing alarm and fear among families

◄ he tranquil village of Ganigaon, nestled among the Himalayan mountains of Uttarakhand, is facing a growing menace that threatens its futuresubstance abuse among its vouth.

This issue, once limited to older individuals, has begun to trap even the youngest members of the community, leading to a wave of fear and concern among residents. "In my school, some boys often come after using drugs. They even bring substances to share with others," says Anita (name changed), a 17-year-old student from Ganigaon. "When teachers try to counsel them, they don't listen and sometimes even threaten them. This behavior is not only disrupt-

ing their education but also instilling fear among the girls, whose parents are now hesitant to send them to school?

Social worker Neelam Grundy emphasizes the urgency of the situation: "The rise of substance abuse in the village is a dangerous trend. What started with the elderly has now spread to the youth and even schoolaged children.

We need a comprehensive campaign to tackle this issue, but it can't just be the responsibility of the gov-ernment. The elders in the village need to lead by example and give up this vice so that the younger generation can break free from its grip." The Uttarakhand government, recognizing the growing issue, has launched a

drug-free by 2025. At the administrative level, efforts are being made to curb the spread of this menace. Between 2019 and 2023, over 119 kilograms of charas were seized in 89 cases in Bageshwar district alone, alongside 58 cases of smack trafficking.

These figures show the administration's commitment to tackling the issue, but society must also take responsibility. # More than 40,000 Palestinians have been killed in Gaza: Territory's Health Ministry

AP DEIR AL-BALAH (GAZA STRIP)

ore than 40,000 Palestinians have been killed in the Israel-Hamas war in Gaza, the territory's Health Ministry said on Thursday.

Israel's offensive has also wounded 92,401 people and displaced over 85 per cent of the population from their homes, the ministry in Hamas-run Gaza said. It does not distinguish between civilians and militants in its toll.

The announcement came during yet another push from international mediators to broker a cease-fire in the war, now in its 11th month.

The conflict began October 7 after Hamas-led militants attacked southern Israel, killing some 1,200 people most of them civilians - and dragging roughly 250 hostages to Gaza.

Israel says 111 of the captives have not been released, including the bodies of 39. The hostages include 15 women and two children under the age

In Gaza, health officials have struggled to fully identify the dead as bodies stream into overwhelmed hospitals and morgues where they say the count is compiled amid the chaos of war and displacement.

In its most recent detailed report on the dead, issued on Thursday, the ministry said 40,005 people have been killed. Health officials and civil defence workers say the true toll is likely thousands higher, since many bodies remain buried under the rubble of destroyed buildings in airstrikes.

Israel's air and ground offensive in Gaza has been one of the most devastating military campaigns in recent

history. bombardment and The shelling have killed entire Palestinian families. With cemeteries often unreachable, families fleeing Israeli airstrikes bury their dead wherever possible in backyards, along roadsides and under the staircases of their



#### homes

Israel says it aims to eliminate Hamas. It blames Hamas for deaths because civilian militants operate in civilian areas and have built extensive tunnel networks underneath them. Israeli forces have regularly targeted mosques, schools, hospitals and cemeteries where it claims fighters or tunnels are located, often causing civilian casualties.

The fighting has also killed 329 Israeli soldiers. The Israeli military claims around 15,000 Hamas fighters are among those killed in Gaza but has not provided evidence.

Nearly 85 per cent of Gaza's 2.3 million people have been driven from their homes, fleeing multiple times across the territory to escape ground offensives. During the war, thousands within Israel and in southern Lebanon have also been displaced.

The assault has created a massive humanitarian crisis in Gaza. The entire territory is at high risk of famine and over 495,000 people - more than a

Sanitation systems have been destroyed, leaving pools of sewage and towers of garbage in tent camps packed with displaced families.

The offensive likely either damaged or destroyed 59 per cent of all structures in Gaza by July 3, including 70 per cent of buildings in north Gaza, according to an analysis of satellite data by Corey Scher and Jamon Van Den Hoek, experts in mapping damage

during war. The conflict has sparked fears of a wider regional war, with Lebanon's Hezbollah and the Israeli military trading fire almost daily over their countries' border.

More than 500 people have been killed on the Lebanese side, including some 350 Hezbollah members and 50 fighters from other militant groups, with the rest civilians.

### Mediators set to hold new Gaza cease-fire talks I-Day celebrated in Israel virtually AP DOHA (QATAR)

International mediators were set to hold a new round of talks on Thursday aimed at halting the Israel-Hamas war and securing the release of scores of hostages, with a potential deal seen as the best hope of heading off an even larger regional conflict.

The United States, Qatar and Egypt were to meet with an Israeli delegation in Qatar as the Palestinian death toll from the 10-month-old war nears 40,000, according to local health authorities. Hamas has not said whether it will participate, accusing Israel of adding new demands to a previous proposal that had US and international support and to which Hamas had agreed in principle.

A cease-fire in Gaza would likely calm tensions across the region. Diplomats hope it would persuade Iran and Lebanon's Hezbollah to hold off on retaliating for the killing of a top Hezbollah commander in an İsraeli airstrike in Beirut and of Hamas' top political leader in an explosion in Tehran.

The mediators have spent months trying to hammer out a three-phase plan in which Hamas would release scores of hostages captured in the triggered the war in exchange for a lasting cease-fire, the withdrawal of Israeli forces from Gaza and the release of Palestinians imprisoned by Israel. Both sides have agreed in principle to the plan, which US President Joe Biden announced on May 31. But Hamas has proposed "amendments" and Israel has suggested "clarifications", suggested leading each side to accuse the other of making new demands it cannot accept. Hamas has rejected Israel's latest demands, which include a lasting military presence along the border with Egypt and a line bisecting Gaza where it would search Palestinians returning to their homes to root out militants. Hamas spokesperson Osama Hamdan told The Associated Press the group is only interested in discussing the implementation of Biden's proposal and not in further negotiations over its content. Prime Minister Benjamin Netanyahu denies Israel has



questions over whether the Palestinians returning to cease-fire would last, saying Israel remains committed to "total victory" against Hamas and the release of all the

hostages. The two sides are also divided over the details of the hostageprisoner exchange, including who among the Palestinian prisoners would be eligible for release and whether they would be sent into exile. Hamas has demanded the release of high-profile militants convicted of orchestrating attacks that killed Israe The most intractable dispute has been over the transition from the first phase of the cease-fire - when women, children and other vulnerable hostages would be released -and the second, when captive Israeli soldiers would be freed and a permanent cease-fire would take hold. Hamas is concerned that Israel will resume the war after the first batch of hostages is released. Israel worries that Hamas will drag out the talks on releasing the remaining hostages indefinitely. Hamdan provided documents showing Hamas had agreed to a US bridging proposal under bridging proposal under which talks on the transition would begin by the 16th day of the first phase and conclude by the fifth week. More recently, Hamas has objected to what it says are new Israeli demands to maintain a presence along the Gaza-Egypt border and a road dividing northern and southern Gaza. Israel denies these are new demands, saying it needs a presence along the border to prevent weapons smuggling and that it must search made new demands, but he has also repeatedly raised

#### AP KYIV (UKRAINE)

Ukrainian drone attack on ARussian air bases damaged at least two hangars and other areas, satellite images analyzed by The Associated Press on Thursday show.

Images taken Wednesday by Planet Labs PBC analyzed by the AP show that two hangars at Borisoglebsk Air Base had been struck, with a field of debris seen around

both. It was not immediately clear what purpose the hangars served. There also appeared to be damage potentially done to two fighter aircraft at the base.

Separately, at Savasleika Air Base, one burn mark could be seen on the apron in images Wednesday, though there was no apparent damage visible to the fighter jets and other aircraft there.

Kursk acting Governor Alexei Smirnov on Thursday ordered the evacuation of the Glushkovo region, about 45 kilometers (28 miles) northwest of Sudzha, where heavy battles are taking place, as Ukraine's daring incursion into the bordering Kursk region entered its second week.

The evacuation order suggests Ukrainian forces are gradually advancing toward the area.



Russia also declared a federal-level state of emergency in the Belgorod region. A regional-level state of emergency had been declared a day earlier in Belgorod, and the change in status suggests officials believe the situation is worsening and hampering the region's ability to deliver aid.

Residents who suffer severe health damage will be eligible to receive payments of up to 6,00,000 Rubles (USD 6,600). Those who experience a loss of property are eligible for up to 1,50,000 Rubles (USD 1,700), Russia's Emergencies Ministry said.

Ukraine's chief military officer, Gen Oleksandr Syrskyi declared that Ukrainian forces have taken 1,000 square kilometers of the Kursk region. That claim couldn't be independently verified. The contact lines in Kursk have remained fluid, allowing both sides to maneuver easily unlike the static frontline in eastern Ukraine where it has taken Russian forces months to achieve incremental gains.

Russian military bloggers have claimed that Russian reserves arriving in the region have stemmed Ukrainian advances, but they also noted that Ukrainian small mechanized groups have continued to probe Russian defenses.

Speaking to reporters at the UN on Wednesday, Russia's Deputy UN Ambassador Dmitry Polyansky dismissed Syrskyi's claim of having gained 1,000 square kilometers of the Russian territory. What's happening in Kursk is the incursion of terrorist sabotage groups, so there is no front line as such," Polyansky said. "There is an incursion because there are forests that are very difficult to control?

"a very brief period of time." Polyansky called the Ukrainian incursion an "absolutely reckless and mad operation," and said Ukraine's aim to force Russia to move its troops from eastern Ukraine is not happening because "we have enough troops there.

"We will never again repeat the tragedy of war" and will stick to the country's postwar pacifist resolve, he said at a solemn ceremony at the Budokan hall "In the world where tragic battles have persisted, Japan

will continue its effort to maintain and strengthen the rules-based, free and open international order" and endeavor to resolve difficult global issues, Kishida said. Kishida noted the more than 3 million Japanese killed, the

The controversial shrine honours convicted war criminals among about 2.5 million war dead. Victims of Japanese aggression, especially China and the Koreas, see visits to the shrine as a lack of remorse, and visits by defense officials are considered especially controversial

defense chief to pray at the shrine on the anniversary since then-Defense Minister Nobuo Kishi's 2021 visit.

### Thailand's populist Pheu Thai party gets endorsements to nominate prime ministerial candidate ministerial candidate by the

#### AP BANGKOK

Thailand's populist Pheu Thai party on Thursday was given support by its major coalition partners to nominate one of its two candidates as the new prime minister, a day after former Prime Minister Srettha Thavisin was removed by court order over an ethical violation.

Sorawong Thienthong, secretary-general of Pheu Thai, told reporters at Parliament on Thursday that the party executives are meeting later in the day to decide on its prime ministerial nomination in Parliament, with a vote scheduled for Friday.

Pheu Thai's Srettha was ousted on Wednesday after less than a year in office. The Constitutional Court found him guilty of a serious ethical breach regarding his appointment of a Cabinet member who was jailed in connection with an alleged bribery attempt

It was the second major ruling in a



week to shake Thai politics. The same court last week dissolved the progressive and main opposition Move Forward party, which won last year's general election but was blocked from power, saying it violated the Constitution by proposing an amendment to a law against defaming the country's royal family. The party has already regrouped as the People's Party

Pheu Thai's ruling coalition partners have already given their endorsement for the party's candidate, including the Bhumjaithai party, which came

third in the election, and the promilitary Phalang Pracharath and

United Thai Nation parties. the Anutin Charnvirakul. Bhumjaithai party's candidate and leader is seen as another frontrunner, though he said he would not contest Friday's vote against a candidate from Pheu Thai.

Pheu Thai has two eligible candidates that were put up for the general election in 2023. One is Paetongtarn Shinawatra, the daughter of former Prime Minister Thaksin Shinawatra who is seen as a real patriarch behind

Pheu Thai, Another is Chaikasem Nitisiri, 75, a former Minister of Justice who served in the Pheu Thai government led by Thaksin's sister Yingluck Shinawatra and was removed by a coup in 2014.

Pheu Thai finished second in last year's election but was given a chance to form a government after the winners, reformist Move Forward party, was blocked from taking power by the previous Senate, a militaryappointed body.

Move Forward was then excluded from the coalition by Pheu Thai, who went on to join hands with parties affiliated with the previous militarybacked government that ousted it in a coup. The move drew criticism from some of its supporters but party officials say that it was necessary to break the deadlock and start reconciliation after decades of deep political divisions.

The former senators were given special power to veto a prime constitution adopted in 2017 under a military government. That power expired when their term ended in May, however. New members of the Senate, selected in a convoluted process last month, do not retain the veto. A candidate now needs just a majority from the lower house, or at least 247 votes. The House of Representatives now has 493 sitting members after six were banned from politics as a result of Move Forward's dissolution. Another lawmaker of the Bhumjaithai party is suspended

awaiting a court ruling. While Pheu Thai's key coalition partners endorsed its candidate, all of them reiterated that they would not support a proposal to amend the royal defamation law which became a key issue during last year's election. Pheu Thai discussed the issue during the election campaign but has toned down significantly after becoming the government.

### Mongolia is in tourism spotlight and making it easier to visit

#### AP ULAANBAATAR (MONGOLIA)

With its reindeer sleigh rides, camel racing and stunning landscapes with room to roam, Mongolia is hoping to woo visitors who are truly looking to get away from it all.

Like most countries, its industry tourism was devastated by the COVID-19 pandemic, and it has launched a "Welcome to MonGOlia" campaign to win people back. The government has added flights and streamlined the visa process, offering visa-free visits for many countries. At least 4,37,000 foreign tourists visited in the first seven months of this year, up 25 per cent over the same period last year, including increasing numbers from Europe, the US and Japan. Visitors from South Korea nearly doubled, thanks in part to the under-four-hour flight. Despite the gains, Mongolia's government is still short of its goal of 1 million visitors per year from 2023-2025 to the land of Genghis Khan, which encompassed much of Eurasia in its 13th-century heyday and is now a landlocked nation located between Russia and China.

With a population of 3.3 million people, about half of them living in the capital, Ulaanbaatar, there's plenty of open space for the adventure tourist to explore, said Egjimaa Battsooj, who works

for a tour company. Its customized itineraries include horseback trips and camping excursions with the possibility of staying in gers, the feltcovered dwellings still used by Mongolia's herders. There's little chance of

running across private property, so few places are offlimits, she said. "You don't need to open a gate,

you don't need to have permission from anyone," she said, sitting in front of a map of Mongolia with routes marked out with pins and strands of yarn.

'We are kind of like the last truly nomad culture on the whole planet," she added.

Lonely Planet named Mongolia its top destination in its Best in Travel 2024 report. The pope's visit to Mongolia last year also helped focus attention on the country. Its break dancers became stars at last year's Asian Games. And some local bands have developed a global following, like The Hu, a folkmetal band that incorporates Mongolian and throat traditional instruments

singing with modern rock. Still, many people know little about Mongolia. American tourist Michael John said he knew some of the history about Genghis Khan and had seen a documentary on eagles used by hunters before deciding to stop in Ulaanbaatar as part of a longer vacation.

### White House says deals struck to cut prices of popular Medicare drugs that cost USD 50 billion yearly

The Biden administration is taking a victory lap after federal officials inked deals with drug companies to lower the price for 10 of Medicare's most popular and costliest drugs, but shared few immediate details about the new price older Americans will pay when they fill those prescriptions.

White House officials said Wednesday night they expect US taxpayers to save USD 6 billion on the new prices, while older Americans could save roughly USD 1.5 billion on their medications. Those projections, however, were based on dated estimates and the administration shared no details as to how they arrived at the figures

Nonetheless, the newly negotiated prices - still elusive to the public as of early Thursday morning - will impact the price of drugs used by millions of older Americans to help manage diabetes, blood cancers and prevent heart failure or blood clots.

The drugs include the blood thinners Xarelto and Eliquis and diabetes drugs Jardiance and Januvia. Medicare spent USD 50 billion covering the drugs last year.

It's a landmark deal for the Medicare program, which provides health care coverage for more than 67 million older and disabled Americans. For decades, the federal government had been barred from bartering with pharmaceutical companies over the price of their drugs, even though it's a routine process for private insurers. This meant that drug companies could basically charge whatever they want for lifesaving treatments people rely on, and all Americans paid the price," White House adviser Neera Tanden told reporters in a Wednesday



night call.

The drug deals will become a focal point for Vice President Kamala Harris' presidential campaign, especially since she cast the tiebreaking vote to pass the law. She will join President Joe Biden Thursday to announce the drug prices, their first joint speaking appearance since she replaced him at the top of the Democratic ticket, as they both struggle to convince voters that costs will trend down after years of above-normal inflation.

The pair last appeared publicly together to welcome back to the US Americans detained in Russia who were freed as part of a massive prisoner swap earlier this month.

# **India imports USD 2.8 bn worth** of crude oil from Russia in July

India, the world's third largest oil consuming and importing nation, in July bought USD 2.8 billion worth of crude oil from Russia, second only to China which remains the largest importer of Russian oil, a report said. Russia emerged as India's biggest supplier of crude oil, which is converted into fuels like petrol and diesel in refineries, after Russian oil was available on discount following some European nations shunning purchases from Moscow over its invasion of Ukraine in February 2022.

Imports from Russia, which were less than one per cent of the total oil imported in pre-Ukraine war period, now make up for almost 40 per cent of India's total oil purchases.

China bought 47 per cent of Russia's crude exports, followed by India (37 per cent), the EU (7 per cent), and Turkey (6 per cent), the Centre for Research on Energy and Clean (CREA) said in a report. and Clean Air



This transparency is crucial for clients to understand how AI tools contribute to their investment decisions and to make informed choices about their advisory services.

The possibility of unintended data exposure highlights the need for strong security measures and clear disclosure to clients about the extent of AI tool usage", Trivesh D, COO at Tradejini, a stock trading platform, told PTI.


# SEVENI **OF HOPE AND** RESILIENCE

And, Prof B M Hegde, our own cardio vascular scientist, after studying thousands of patients opine that there is a direct link between junk foods, UPF and cancer and heart ailments.

# WE NEED TO SCORE MORE FIELD GOALS TO WIN FREQUENT OLYMPIC MEDALS: SREEJESH

If there is one thing that goalkeeping stalwart P R Sreejesh would like to see change in Indian hockey, it is the team's dependence on penalty corners for scoring as he believes that field goals need to go up for the country to win an Olympic medal every four years

India scored 15 goals and conceded 12 en route their second consecutive Olympic bronze medal in the justconcluded Paris Games. Out of 15, nine were penalty corners, three were penalty strokes and a mere three were field goals


"Most the times, when the forwards are getting into the circle the first thing that comes into their mind is to go for a penalty corner because that's what we are good at. I am not saying that our forwards are not trying to score field goals," Sreejesh, who retired at the end of the Games, told PTI editors at its headquarters in an interaction.

gold winners comparison, silver-medallist Netherlands and Germany scored 14 and 15 field goals respectively, while fourth-place finishers Spain found the net 10 times from field efforts.

In all, the men's competition in Paris witnessed 78 field goals and 62 from short corners in total.

A penalty corner is awarded when a player commits a foul within the striking circle even if it is not necessarily to stop a possible goalscoring move. The most common cause for a penalty corner is the ball touching a player's feet in the circle.

Sreejesh, who ended his glorious 18year career after winning two



consecutive Olympic bronze medals, felt the Indians will have to do away with heavy reliance on penalty corners and find a way to score more field goals in future

"...When you have better options to score from penalty corners, why should we waste our opportunities? But if we are thinking about the next level for the Indian hockey team, if we wanted to

win Olympic medals, we need to score more field goals as well because defence has got some limitations," he said.

"I shouldn't say this but we are not Germany who can defend one goal for minutes because they are disciplined, they are cultured. The style

and strategy is different than us. "I strongly believe that we made some mistakes and conceded a few goals but we need to sharpen our forwards to score more goals so that the defence gets more comfort," the 36-year-old added

NOT EASY TO BE IN LEAGUE OF GREATS: With two Olympic bronze, two Asian Games gold and a bronze, two Champions Trophy titles and as many Commonwealth Games silver medals in his kitty, Sreejesh has become a legend of Indian hockey, joining the likes of Major Dhyan Chand, Balbir Singh Sr, and Dhanraj Pillay among others. Sreejesh said it is not easy for any player to be in that elite league.

"It is not easy to be in that league. When you are getting into that senior role, when you are getting into limelight, it gets higher because your responsibility then is not only to perform for your country," he said.

He said the elevation to that elite status is a huge responsibility. "Your responsibility is also towards the

juniors, to develop them, to support the coaching," he said.

'You are going to be a mediator between the players and the coaching staff. You are getting into the shoes of a spokesperson for the team, you are becoming an ambassador for your country. So what all things you do should be an example.

### French prosecutors investigate gender-based cyber harassment of Algerian Olympic champ Imane

French prosecutors opened an investigation into an online harassment complaint made by Olympic boxing champion Imane Khelif after a torrent of criticism and false claims about her sex during the Summer Games, the Paris prosecutor's office said Wednesday. The athlete's lawyer Nabil Boudi filed a

legal complaint Friday with a special unit in the Paris prosecutor's office that combats online hate speech.

Boudi said the boxer was targeted by a "misogynist, racist and sexist campaign" as she won gold in the women's welterweight division, becoming a hero in her native Algeria and bringing global attention to women's boxing.

The prosecutor's office said it had received the complaint and its Office for the Fight against Crimes against Humanity and Hate Crime had opened an investigation 'ĥarms human dignity. on charges of "cyber harassment based on vender public insults based on gender critical onl public incitement to discrimination and public insults on the basis of origin." Khelif was thrust into a worldwide clash Khelif a man.
