# CENTRE DEFENDS LAW AGAINST TRIPLE TALAQ

Defending its 2019 Triple Talaq Law in the Supreme Court, the Modi Government has argued that the legislation was crucial for protecting the rights of Muslim women and promoting gender justice.

In an affidavit filed in response to petitions challenging the law, the Government said despite the Supreme Court's 2017 ruling setting aside the practice, it has "not served as a sufficient deterrent reducing the number of divorces through this practice" within the community.

The Government argued that

"neither Islamic nor legal." 'Taking note of all these we are of the considered view that the ordinance in question has been brought into force in accordance with requirements of law only to make more effective implementation of the law laid down by the Supreme Court in the case of Shayara Bano vs Union of India (supra) in the form of an ordinance and we see no reason to make an indulgence into the matter," the Centre said in its 433-page counter affidavit reminding the court three times.

of its own Constitution Bench judgment of 2017 in the Shayara Bano case, which had held triple or instant talaq (talaq-e-biddat) manifestly arbitrary.

This comes in response to a plea by the Samastha Kerala Jamiathul Ulema, which sought a declaration that the Muslim Women (Protection of Rights on Marriage) Act, 2019, is unconstitutional and violative of Articles 14, 15, 21, and 123 of the Constitution. Triple talaq is a form of divorce that was practiced in Islam, in which a Muslim man could legally divorce his wife by pronouncing "talaq"

# Jammu attacked, yet again

One Inspector-rank CRPF officer was martyred on Monday when a heavily-armed group of Pakistani terrorists targeted an area domination patrol party comprising jawans of the Central Reserve Police Force (CRPF) and Special Operations Group of Jammu Kashmir Police (JKP) in the remote Duddu Basantgarh area of Udhampur.

The Monday attack, which occurred shortly after 3.00 pm in the thickly forested belt of Cheel in Duddu, comes close on the heels of the announcement of the poll schedule by the Election Commission for Jammu and Kashmir Assembly.

Till the time of filing the report, the operation in the area was going on and additional reinforcements

were rushed from the district headquarters to prevent the Pakistani terrorists from escaping. The joint team was carrying out a routine patrol when the attack from the Pakistani terrorists came. Official sources said an inspector of the CRPF belonging to the 187th Battalion was hit by a bullet and later succumbed to injuries while being taken to hospital.

The incident has once again brought into focus the lack of human intelligence and ground support enjoyed by the Pakistani terrorists through their well-entrenched network of overground workers in the

Confirming the attack on the joint patrol party, a spokesman the Udhampur police posted a message on the microblogging site X claiming,

"During area domination patrol..., exchange of fire took place between terrorists and joint parties of JKP and CRPF. In the encounter, one Inspector of CRPF suffered bullet injuries and has attained martyrdom. Operation continues". Official sources claimed the same group of Pakistani terrorists has been shuttling in the thickly forested belt of Dudu Basantgarh for a long time and operations launched to neutralise them have not borne fruitful results.

# **CBI** prepares for Lie Detection

¬he Central Bureau of Investigation (CBI) on Monday obtained judicial permission to conduct a polygraph test on Sanjoy Roy, the prime accused in the RG Kar Medical College rape and murature. der case, sources said. The Central agency may also petition the court to conduct a similar test on Sandip Ghosh, the former principal of the college, who, according to agency sources, is "not fully cooperating" with the investigation. Roy, who was initially arrested by the Kolkata Police and later

handed over to the CBI following a Calcutta High Court order, is the only accused arrested so far.

According to sources, CBI officials have found that Roy, a civic volunteer attached to the Kolkata Police, visited RGKMCH three times on the evening and night before August 9, when the body of the postgraduate lady doctor was discovered in a semi-nude condition. Roy first visited the hospital's

surgery department at 6 pm to see a patient. He returned at 11 pm and proceeded directly to the seminar hall of the Chest Department of Medicine on the 3rd floor. Sources said he visited the same location again around 4 am the following morning, staying inside for about 30-35

A postgraduate trainee doctor was raped and murdered at the RG Kar Medical College and Hospital in Kolkata while on duty last week leading to nationwide and even international protests demanding security for

# Delhi LG seeks action on infrastructure accidents

Taking a serious view of several deaths and disruptions in normal life in the city caused by severe waterlogging and flooding this monsoon due to "complete collapse of civic infrastructure", Delhi Lieutenant Governor Vinai Kumar Saxena has directed Chief Secretary Naresh Kumai to submit a monthly report on the inspections conducted by senior officers of the state of civic infrastructure in the Capital.

In a written communication to the Chief Secretary, Ashish Kundra, the Principal Secretary to Saxena, said the LG has advised that an "institutionalised mechanism be put in place for regular inspections" by senior officers of the facilities under their charge. "It would help them get a first-hand feel of the core problems being faced by the citizens and take corrective policy or regulatory measures. The Chief Secretary shall circulate a uniform format of inspection report to all departments and submit a monthly report on the number of inspections done by each officer," read the letter.

Arvind Kejriwal The Government has blamed the bureaucracy for failing to desilt drains ahead of the monsoon season this year. This purported negligence led to frequent waterlogging and

flooding whenever there was rain turning the entire city into another Venice.

Kundra also pointed out that even the Delhi High Court has taken a serious stance of the drains desilting issue, and has made "stinging observations". "The LG has observed that this monsoon has seen the complete collapse of civic infrastructure, leading to unfortunate and avoidable deaths and great hardships to the citizens. The underlying problems are symptomatic of endemic neglect," he has said

in the letter.
"Drains have not been desilted for years, sewer lines are choked leading to flooding even in planned colonies," he added.

According Saxena, all this points to a "complete absence

senior management oversight" in the city, Kundra's letter said.

Sharing the LG's directives on the issue, Kundra said all heads of departments (HoD), Secretaries, Principal Secretaries, or Additional Chief Secretaries need to "draw up a schedule of field inspections" and ensure that all assets or areas are inspected thoroughly.

The inspection note of the Principal Secretary or Secretary of the department shall be submitted to the Chief Secretary with a copy forwarded to the LG Secretariat and the Ministerin-Charge," he said.

Saxena's According to Saxena's directive, the inspection note should summarise the core problem observed with the corrective measures taken

The report should be annexed with geo-tagged pictures of and before after intervention.

the department concerned on a fortnightly basis while the HoDs have to do them on a weekly basis Secretaries have also been advised to conduct inspections every fortnight. The officers have also been directed to review the institutional mechanisms prescribed under various Central and State Acts and ensure that these are fully functional, the letter read. Formulation of any rules, authorities, boards under these laws should be taken up within three weeks," it added. The LG also insisted that there should be a robust field mechanism of inspections at district level

under the district magistrates (DM). The inspection notes need to be submitted to the Divisional Commissioner who shall then send a consolidated note to the Chief Secretary, Kundra said. "District magistrates, SDMs and ADMs shall undertake inspection twice a week in areas of public delivery

# Airlines head North this festive seaso

irfares are heading north-Awards for the festival season, with the average one-way ticket price on key domestic routes being 10-15 per cent more for Diwali and 20-25 per cent higher for certain flights to Kerala cities for Onam, according to an analy-

An analysis done by travel portal ixigo for PTI showed that the average one-way economy class fare for nonstop flight on Delhi-Chennai route during October 30-November 5 period is 25 per

cent higher at ₹7,618. This is in comparison to the fare during November 10-16 period last year.

For the given comparison period, the ticket price is 21 per cent more at ₹5,162 on Mumbai-Hyderabad route and 19 per cent higher at ₹5,999 and at ₹4,930 on Delhi-Goa and Delhi-Ahmedabad routes, respectively.

On certain other routes, fares are higher in the range of 1-16 per cent, as per the analysis. Co-CEO Group Rajnish Kumar said travel demand for Diwali is on the rise with airfares higher than last year.

Chennai, Mumbai-Bengaluru, and Delhi-Hyderabad are seeing average fares ranging ₹4,000-5,000, one-way between

"Popular routes like Delhi-



marking a 10-15 per cent Y-o-Y increase as the festival approaches," he said.

On the other hand, fares have also dropped in the range of 1 per cent to 27 per cent on certain routes for the given comparison period.

While the ticket price for Mumbai-Ahmedabad flight has declined 27 per cent to ₹2,508, the fall is 25 per cent at ₹4,890 for Mumbai-Udaipur flight.

In the case of Bengaluru-Hyderabad flight, the fare has dropped by 23 per cent to ₹ 3,383 and by 21 per cent to ₹7,826 for Mumbai-Jammu flight, the analysis showed.

Also, an analysis of airfare

trends on select routes for the

upcoming festival in Kerala

showed that prices have increased in the range of 1 per cent to 25 per cent on certain routes. At the same time, ticket prices have fallen around 6-35 per cent on some routes.

The figures are average oneway fare for non-stop flights for departure during the September 6-15 period this year compared to August 20-29, 2023 period when Onam

was celebrated. A 30 per cent rise in fare to ₹4,102 has been registered for Hyderabad-Thiruvananthapuram flight for the given comparison period. A similar quantum of

increase is there for Mumbai-Calicut flight to₹4,448. 'Travel demand for Onam festivities has surged this year,

and Thiruvananthapuram have risen by 20-25 per cent year-on-year," Rajnish Kumar said. There have been persisting concerns over high airfares, especially during peak and festival seasons. Against this backdrop, Civil Aviation Minister Rammohan Naidu, earlier this month told Lok Sabha, that the ministry was planning to introduce mechanism to address grievances to ensure passengers were not exploited by unnecessary fare hikes.

## 13 girls sexually abused in fake NCC camp; Tamil politician, principal, 6 others arrested

m ight}$  persons, including vinistic political outfit was arrested in Tamil Nadu's Krishnagiri district for holding a fake National Cadet Corps (NCC) camp and sex-ually abusing 13 girl students who attended the camp. The arrested persons include

the Principal of the school who fell prey to the offer made by Sivaraman, a "prominent" leader of Naam Tamilar Katchi who is a close confidant of party Chief Seeman. This is described as the first of its kind fake mission making use of the NCC, an elite students unit of national eminence.

Sivaraman reportedly convinced the private school authorities that he would get them a unit of the NCC if they could organise a students' camp during 5th August to 9th August in the school itself. The school management obliged Sivaraman in the hope of getting a wing of the NCC sanctioned for the



school. The associates of Sivaraman included a retired CRPF sub-inspector.

The Krishnagiri Police told the media that the school management failed to check the credentials of Sivaraman and his associates and held the camp without consulting the local NCC office. The five day long camp drew 41 students including 17 girls.

Though one of the victims informed Satish Kumar, the Principal of the School, that she was sexually abused by Sivaraman, Kumar and other staff members tried to hush up the matter. Hence the girl student informed her mother about the incident and the latter took up the matter with the police.

The police found that Sivaraman had held such camps in four schools in the district, offering the school management the establishement of

Surprisingly, the school management and teachers were

either ignorant about the functioning of the NCC units or joined the Naam Tamilar Party Leader in his endeavour. When Sivaraman came to know about the police investigation, he escaped to Coimbatore but the cops managed to take him into custody.

have arrested Sivaraman, his three associates involved in the training camp, the Principal, the school correspondent, and two teachers. Further investigation is on to find more details about Sivaraman's adventures. The NTK is an outfit known for its anti-India activities.

### **Modi to visit Ukraine on Zelenskyy's** invitation

In a letter sent to the President the occasion of Rakshabandhan day, Priyanka stated that the presidential assent to the law would reaffirm "our unwavering dedication in advancing women's safety, not only in Maharashtra but across India", at a time when there are large-scale protests over a junior doctor's rape and murder in Kolkata's R H Kar Medical College. The Maharashtra Shakti

Criminal Law (Maharashtra Amendment) Act, 2020, which included grant of a Special Court and machinery for implementation of the stringent law was passed by both the Houses of the Maharashtra Legislature on December 23, 2021, when Shiv Sena's Uddhav Thackeray was the chief minister of the "The bill was significant and

historic as it prioritised women's safety and introduced stringent punishment and prosecution. However, it has been awaiting your assent since then," the Sena (UBT) MP stated in her letter. The bill provides for capital

punishment for certain crimes against women and children

and prescribes a period of 30 days to complete the probe once a complaint is lodged. It puts the onus on social media platforms and Internet service providers to provide data, if needed, for investigation's pur-

The bill stipulated that the investigations in such cases should be completed within 30 days, and extension of 30 more days can be given by senior police officials if valid reasons are provided. Those convicted under the impending law will attract imprisonment of up to three months or/and fine up to Rs 25 lakh. Alluding to the rape and murder of a junior doctor in a Kolkata medical college, Priyanka said: "The Kolkata rape and murder case is a stark reminder since the 2012 Nirbhaya case, of how unsafe we continue to feel.

# Doctors offer services outside Nirman Bhawan in protest

ontinuing their strike for the eighth consecutive day over the rape and murder of a trainee doctor in Kolkata, around 400 doctors and other medics are offering elective outpatient services on the road outside Nirman Bhawan on Monday in a symbolic protest. Doctors sat with sheets of paper showing their names and specialisations - ortho OPD, neurology OPD, psychiatry OPD, PMR - on the road in front of the office of the Ministry of Health at Nirman Bhawan. A doctor sitting on the road to check patients said, "At the hospital, there is no safety or protection. At least here, we have police around us, so we can treat patients here. We have no option but to fight for ourselves, as nobody is doing anything besides offering us sympathy and empty assur-



"The OPD we are operating here is a symbolic protest. We are both protesting and offering OPD services," Doctor Ansar said. Another protesting doctor added, "We want the CBI to catch the culprits (of the Kolkata rape-murder incident) and for the court to impose the maximum punishment. We urge the government to ensure that no such incidents occur in the future?

Around 300 to 400 people gathered at Nirman Bhawan, holding flags and placards and wearing white aprons stained with red and black colours. "We doctors have been protesting here for eight days, and nothing has changed so far. We will not stop; the strike will continue until the Central Protection Act (CPA) is implemented," said one of the protesting doctors.

Doctor Prashasti said that female doctors are scared while working. "We need a safety protection act so we can feel

nobody should have to feel what she went through while working. This brutality has left a mark on our hearts and minds. We need something to help us truly work again, or we cannot continue," she asserted The doctors' strike in the national capital over the rape and murder of a medic at a state-run hospital in Kolkata completed a week on Sunday and is now entering its second week, causing difficulties for patients. Late Sunday, resident doctors announced that their strike will continue and decided to provide elective OPD services in around 36 specialties, including medicine, surgery, obstetrics and gynaecology, paediatrics, ophthalmology and orthopedics, to patients outside Nirman Bhawan on Monday. However, emergency services will continue as before at the

For the past few days, garbage collection in these areas has been irregular, resulting in an accumulation of waste on streets and bins, she said in her letter. The stench from decomposing waste is unbearable, Oberoi said.

In the letter, she directed Kumar to accompany her for daily inspections from August 20 to September 2 to the 12 zones of the MCD to ensure proper cleanliness and sanitation.

'Garbage collection and disposal will be the personal responsibility of the MCD commissioner, who will be held responsible for any unsanitary conditions in any part of the city,

According to an official, the extended contract period of the garbage disposal concessionaire in the Central Delhi zone ended on July 25. In the West Delhi zone, the civic body is facing payment-related issues with the hired agency. Proposals with expenditure of Rs 5 crore and above require the standing committee's approval, which has been pending for around 1.5 years.

# Mayor, MCD Commissioner trade | Court discharges Kamal Nath's nephew in money laundering case

Acity court has discharged an accused in an alleged Rs 354-crore bank fraudlinked money laundering case involving Ratul Puri, the businessman nephew of senior Congress leader Kamal Nath. There is "no iota of legally admissible evidence" against the accused, Special Judge Sanjeev Aggarwal said as he dropped the charges against Nitin Bhatnagar, a Maltese citizen and former relationship manager of the Bank of Singapore.

The Enforcement Directorate (ED) had alleged that Bhatnagar was involved in the 'layering of the proceeds of crime" for Ratul Puri.

In an order passed on Saturday, Judge Aggarwal said, "It cannot be said accused may have committed the offence i.E. To say matter should go to the trial. That is to say, the prosecution has failed to make out a prima facie case for framing of charges qua this accused, for



which he was being prosecuted by filing the prosecu-

tion complaint.' He asked why would the accused to go through rigours of trial all the way if there was no suspicion.

When there is no iota of legally admissible evidence against him to go for trial, doing so would be itself violative of Article 21 of the Constitution of India, as the same cannot be said to be the procedure established by law," Judge Aggarwal said. The bench accepted the arguments made by senior advocate Vikas Pahwa, appearing for Bhatnagar, that no suspicion arose about the accused committing the offence of money laundering. Bhatnagar was arrested by

the Enforcement Directorate (ED) under the provisions of the Prevention of Money Laundering Act (PMLA) on August 22 last year.

The money laundering case stems from an August, 2019 FIR of the Central Bureau of Investigation (CBI) where it was alleged that the company

Moser Baer India Ltd. (MBIL) and its promoters allegedly cheated and defrauded the loan taken from the Central Bank of India to the tune of Rs 354.51 crore. The case was registered after the bank sent a complaint to the CBI.

## Body of seven-year-old boy recovered from open drain in Ashok Vihar

## Two JNU students on indefinite fast admitted to AIIMS, refuse treatment

The strike entered its eighth day on Monday with students protesting against purported unresponsive attitude of the administration over their charter of demands since August 11.

"The two students have signed a document of leave against medical advice (LAMA) and refused to get treatment. We had referred them to AIIMS after accessing their health condition," said Fouzia Firdous Ozair, Chief Medical monsoon deaths in the city for Officer (CMO) of JNU.



When contacted over the matter, JNU Vice-chancellor Santishree D Pandit said, 'They have taken responsibility, refused treatment and signed the LAMA document. So JNU administration has informed their parents that, as adults, they have refused medical treatment."

The protesting students of JNU have been demanding an increase in the merit-cummeans (MCM) scholarship to at least Rs 5,000, the opening of Barak Hostel, which has

remained non-operational since its inauguration in February, and the revocation of the Chief Proctor's Office (CPO) manual which penalises protests on campus with fines up to Rs 20,000.

Their demands also include reinstatement of the Gender Sensitisation Committee Against Sexual Harassment (GSCASH), and the withdrawal of proctorial inquiries initiated against students protesting for water and gender justice issues.

# 'Mamata shameless; proof destroyed at CM behest': BJP seeks resignation

destroyer of the rule of law and the Constitution," BJP National Spokesperson Gaurav Bhatia said at a Press Conference at the BJP Headquarters here. While the Chief Minister did not take concrete steps to ensure a swift probe into the "possibility" of gang-rape and murder of the medic, she got

crime destroyed, he charged.

# Regional parties poised to upset BJP, Cong applecart in Haryana elections

The ruling BJP and the Opposition Congress are the main contenders for power in Haryana but it is the third factor that promises to play spoilsport for either of the two big players, depending on the extent of popular support regional parties and Independents can manage in the Assembly elections.

A consolidation of Opposition votes in the State in the recent Lok Sabha elections pulled down the BJP's tally of 10 seats to five, delivering the remainder to the Congress, but the ruling party leaders are hopeful that third players will now draw in more votes, as is often the case in Assembly

Singh Chautala's estranged uncle Abhay Singh Chautala -- and Independents such as MLA Balraj Kundu draw their core support from Jats, the BJP believes that they will cut into non-BJP votes as the community had largely voted for the Congress in the Lok Sabha

At over 26 per cent of the population, Jats are the biggest caste in Haryana. The BSP's dwindling support is mostly confined to a section of Dalits who had veered away from the BJP in large numbers in the Lok Sabha polls.

Recently, Congress Leader and former Chief Minister Bhupinder Singh Hooda had dismissed the regional parties as "vote-cutters". Nobody will vote for them, he had said, noting that the JJP received less than a per cent vote in the Lok Sabha elections.

It had bagged nearly 15 per cent votes and 10 seats in the last assembly polls. The JJP is fighting an existential battle as it is now left with only three loyal MLAs, Dushyant Singh

Naina Singh Chautala being two of them. BJP leaders involved in the

assembly poll campaign have expressed confidence that a consolidation of the party's traditional non-Jat votes will occur as the poll date approaches, helping it retain power for a third term. The State Assembly has 90 seats. If the BJP also hopes to benefit from factionalism within the Congress, what is a cause of concern for the party is that its vote share in assembly polls often falls by a decent margin from the Lok Sabha elections. After winning its maiden majority in Haryana in 2014, the BJP was reduced to 40 seats in 2019 and formed the government with support from the JJP.

The BJP has appointed Union Minister Dharmendra Pradhan, a seasoned poll hand, and former Tripura Chief Minister Biplab Kumar Deb as election in-charge and coincharge, respectively, for the

with latest equipment for distress monitoring through terrestrial and satellite systems and equipped with advanced communication systems for real-time management of alerts by highly-trained personnel of Indian Coast Guard (ICG) specialising in Search and Rescue procedures, with the rescue aircraft, ships and other facilities. Regional Marine Pollution Response Centre is a first of its kind facility for coordinating

ical pollution, in waters adjoining the coastal States in the Indian Ocean Region. The creation of this centre was first announced by Rajnath during the maiden Indo-ASEAN meeting held in Cambodia on November 22, 2022.

The setting-up of this centre was spearheaded by Coast Guard Regional Headquarters East at its premises within Chennai Port. It has an Emergency Response Centre which will be manned 24x7 by ICG personnel to monitor the marine oil

pollution incidents. The Centre will also impart training in Pollution response techniques to various organisations such as Ports, Oil Handling agencies, Government organisations and private participants. It will also train personnel from friendly countries in combating oil pollution at sea. The practical training will involve actual deployment of various oil handling equipment for maximum exposure to real time oil spill scenarios.

Coast Guard Air Enclave marks a significant milestone for ICG and will play a vital role in maritime security along the Puducherry and south Tamil Nadu coast.

The Air Enclave will be equipped with Chetak and Advanced Light Helicopter Squadrons. Both these helicopters are indigenously built and capable of undertaking maritime patrol, Search and Rescue and other such missions both from land as well as from Coast Guard ships patrolling at

# Key mechanism in gut inflammation tied to vitamin A deficiency: Delhi NII

Ateam of researchers from the Delhi-based National Institute of Immunology, an autonomous research institute

of the Department of Biotechnology has uncovered a key mechanism behind gut inflammation, focusing on immune cells called dendritic

They discovered that these cells, which help regulate the immune system, can malfunction in inflammatory bowel disease (IBD), a chronic gut inflammatory disorder. Leveraging single-cell and bulk

RNA sequencing data from humans and mice, the study revealed that a specific signaling pathway, known as noncanonical NF-B signaling, is significantly active in dendritic cells from patients with IBD and mice with colitis.

Using biochemical and flow cytometry-based analyses, they surprisingly found that this pathway disrupts the production of retinoic acid, a crucial



molecule derived from Vitamin A that helps maintain a balanced immune response in the gut. By interfering with the accessibility of Vitamin A metabolites in the gut, the noncanonical NF-B signaling leads to an increase in inflammation and worsens gut conditions.

When researchers disrupted this signalling pathway specifically in dendritic cells by the Cre-lox method, the mice showed significant improvements in gut inflammation symptoms. They had more beneficial immune cells and higher levels of protective antibodies in their gut, promoting a healthy gut microbiome. Published in the EMBO Journal, the study led by Dr Soumen Basak and his team of researchers identifies a rather unknown role of the noncanonical NF-B pathway in tuning vitamin metabolism in the gut, paving the way for novel treatment regimes. This research promises a pos-

sible shift in treating IBD by focusing on the noncanonical NF-B pathway and micronutrient supplementation. While the canonical NF-B pathway has traditionally been

considered for therapeutic targeting in inflammatory ailments, pharmacological inhibition of this pathway causes undesirable side effects due to its broad involvement in various physiological processes and increases the risk of infec-On the other hand, the non-

canonical NF-B pathway plays a role in a limited set of biological processes, said the

## Climate change intensifying mental health crisis in South-East Asia, says WHO

Expressing concern that an Eestimated 260 million people live with mental health conditions, and over 200,000 people die by suicide annually in the South East Asia region, the WHO on Tuesday called upon the member countries to strengthen mental health systems and services to address this growing challenge that is likely to worsen due to climate change.

"Climate change exacerbates social, environmental, and economic factors that jeopardise mental health, adding further strain to already overburdened health systems," Saima Wazed, Regional Director, WHO South-East Asia said while flagging the issue on Monday. However, there is a huge gap in meeting the needs. She drew attention to a 2021

WHO survey of 95 countries, which said that just 9 had mental health and psychosocial support in their national health and climate change plans. Despite this urgent need, significant gaps remain in both the understanding of these impacts and the availability of mental health services to address them, she added.

A recent report by the UN's Intergovernmental Panel on Climate Change (IPCC) has revealed that rapidly increasing climate change leads to emo-tional distress, anxiety, depression, grief, and suicidal behaviour. Among WHO regions, South-East Asia is most vulnerable to this, she added, at a regional workshop for mental health, held in Indonesia, last

"An estimated 260 million people live with a mental health condition and more than



200,000 people die by suicide every year," she said, noting that climate change is worsening mental health."There is a large gap in both knowledge of and response to, climate change's mental impact on health...There is an evident need to bring together climate and mental health officials from member states to ensure accelerated action to adapt and mitigate climate change impacts and prevent further widening of this gap," Wazed added. To strengthen mental health

systems, the Regional Director called for integrating climate change considerations into policies and programmes for men-

tal health. Wazed also called for addressing the large gaps in funding both for mental health and for

responding to the health

impacts of climate change. Dr Jyoti Kapoor, a psychologist and Founder and Director of Manasthali Wellness, welcomed the WHO's call for action, emphasising its urgency. She noted that recent surveys highlight how climate change and its awareness can lead to severe psychological responses, such as eco-anxiety and climate grief. Dr Kapoor cited a 2021 survey of 10,000 people aged 16–25 across 10 countries, which revealed that nearly 60 per cent were deeply worried about climate change, with over 45 per cent reporting that this anxiety significantly affected their daily lives, including their work and

The Chief Minister submitted that the sanction order was issued without application of mind, in violation statutory mandates, and contrary to Constitutional principles, including the advice of the Council of Ministers, which is binding under Article 163 of the Constitution of India. Siddaramaiah challenged the

August 16 order granting prior approval and sanction under Section 17A of the Prevention of Corruption Act, 1988, and Section 218 of the Bharatiya Nyaya Suraksha

While addressing a meeting of the State Level Bankers' Committee (SLBC) here, the CM said relaxation in interest amounts or extension of time for remitting monthly installments would not at all be a solution in the landslide-

hit regions. "Many of those who had taken the loans are deceased, and their land has become unusable due to the disaster,' he pointed out. "The only thing we can do is write off the entire loans taken by people in these affected areas," Vijayan said. He expressed the



government's displeasure over continuing to deduct monthly installments from the accounts of survivors and urged the SLBC (State Level Bankers' Committee) to take a favourable decision in this matter. Recalling the horrors and impact of the July 30 tragedy, the CM said a large number of landslide victims or survivors had been engaged in farming activities in Wayanad, but the disaster has even altered the very geography of the agriculture lands there.

Citing reports, he said the affected places have become unusable, and no cultivation or settlement is possible in these areas. "Most of the

farmers in the areas have taken out loans. Those who took a loan to build a house had lost the house itself," the CM said, adding that they were not in a position now to repay the instalments.

## Women safety is non-negotiable

The apex court's suo moto congisance of Kolkata rape case could lead to stronger security measures in workplaces

he Kolkata rape and murder case has shaken the nation, sparking widespread outrage and a call to end such horrific crimes. While similar cases in the past, like the Ranga Billa case in the 1970s and the Nirbhaya case in 2012, also provoked national anger, real change has been limited, with crimes against women continuing sporadically. The recent assault and murder of a resident doctor in Kolkata serve as a stark reminder of the ongoing vulnerability women face in the workplace. The Supreme Court of India has taken suo motu cognisance of the Kolkata doctor rape-murder incident. A three-judge bench presided by Chief Justice of India D Y Chandrachud will hear the matter on August 20, 2024. Earlier, the Calcutta High Court expressed displeasure over the handling of the case by the State Government. The incident took place at R G Kar Medical College in Kolkata. The case has been transferred to the CBI. The Supreme Court's decision to take up this case underscores a growing concern about the safety of women in

public spaces, including professional environments. The matter, while primarily focusing on doctors' safety, also opens a window to address the broader context of women's safety across the country.

In a country where women's safety continues to be a major societal concern, the Supreme Court's intervention in the Kolkata case regarding the safety of doctors brings to light a parallel issue— the precarious conditions under which healthcare workers, especially women, operate. While India grapples with various cases of violence against women, the healthcare sector has seen its share of attacks on women professionals, prompting national attention and legal action.

India's struggle with women's safety is long-standing and complex. High-profile cases of sexual violence, harassment, and workplace discrimination have repeatedly sparked public outrage. Despite legal reforms and awareness campaigns, incidents of violence against women remain alarmingly high. Public spaces, including hospitals, which should be places of care, have become dangerous for many women, underscoring the systemic nature of the problem. The healthcare sector is particularly concerning because female doctors and nurses not only face violence from patients' families but also internal issues such as sexual harassment from colleagues and superiors. This dual threat makes their professional life increasingly challenging and unsafe. With the Supreme Court stepping in, it is hoped that this case will lead to more robust security protocols in hospitals and other public institutions. As the Supreme Court examines the Kolkata case, there is hope that this will lead to a more comprehensive approach to women's safety in India. The focus should not just be on doctors but also on broader societal reforms that ensure women can work, travel, and live without fear of violence or discrimination. If the court's ruling leads to enhanced safety measures for doctors, it could set a precedent for other professions as well, where women face similar threats.

# Bangladesh questions Sheikh Mujib's legacy SIDHARTH MISHRA



With institutions under siege and the legacy of Sheikh Mujibur Rahman under attack, the parallels with the French Revolution become starkly apparent

uprising in the neighbouring country Bangladesh. Despite an interim government led by a Nobel laureate economist and entrepreneur Muhammad Yunus in place, the rule of the 'hoi polloi' continues. Mass power is forcing a 'purge' of the various institutions of the state of what are believed to be compradors of the ousted regime.

Even the judiciary has not been spared. It's unlikely that we would have stability returning to the nascent nation founded by Sheikh Mujibur Rahman following liberation from Pakistan in 1971. Mujibur Rahman's legacy, politically represented by his daughter Sheikh Hasina, the ousted Prime Minister of Bangladesh, is today under attack.

Though there are those in the revolution mass and leadership, who would want to distinguish Sheikh's legacy from Hasina's regime. But in the current situation of social turmoil, a manifestation of an ideological bent could be catastrophic.Public uprisings the world over, especially in the post-colonial democracies of the 20th and the 21st centuries, have drawn inspiration from the French Revolution of the 18th century

The revolution which started with the symbolic fall of Bastille and the establishment of the Estates General of 1789, ended with the coup of 18 Brumaire in November 1799 and the formation of the French Consulate with the military under the leadership of Napolean Bonaparte capturing power.

The French Revolution was driven by the ideas of the fundamental principles of liberal democracy. Its causes are generally agreed to be a combination of social, political, and economic factors, which the ruling establishment led by Emperor Louis XVI was unable to manage. What spurred the fall was a financial crisis and widespread social distress.The tall of Louis XVI saw radical reforms including the abolition of feudalism and a declaration of rights. But this did not bring an end to political instability.



The next decade was dominated by the struggle for political control, worsened by economic depression. To overcome the crisis the revolutionaries formed the Committee of Public Safety, which unleashed a reign of terror in which about 16,000 people were executed. Finally in 1799 following a military coup, Napoleon Bonaparte came to seize power marking the end of the revolution. The quick recall of the events of the French Revolution was to establish the fact that insurrection doesn't generally guarantee one thing, the stability of governance. This is best seen in the case of

Ever since its birth, the country has witnessed numerous coups and uprisings with Sheikh Hasina's 15-year regime from 2009-2024 being an exception to the general rule. This period was, till the fall of the government, seen as a period of not only stable authority but also economic growth.Then what brought the fall? Conspiracy theorists are blaming the American Deep State and the Chinese interest but no uprising can happen without local discontent. After coming to power in 2009 through a free, fair, and credible election, Sheikh Hasina subsequently presided over largely non-participative

outperforming India. The country's per capita income tripled in a decade, and the World Bank estimated that over 25 million people were lifted out of poverty in the last 20 years. The anxiety, feverishness and desperation of the student can never compress the period of learning. Humans live in highly stressful and disharmonious conditions. Pressure is exerted on their minds, resulting in an unhealthy lifestyle. Stressful conditions are also created by our feverish attitude and desperation: A mental state when our expectations far exceed the actual requirement. Not living in the NOW and a covetous nature also contribute to mental disequilibrium. The memory of past events has a double whammy on the mind. A pleasant occurrence brings peace, but turbulent experiences make us stressed and fret. Unfortunately, the human mind gives more credence to negative experiences and that leads to the gathering of stress in the mind. A stressful mind can be smoothened only through a 3C policy, namely commitment, control, and challenge. The energy of the mind needs to be channelled productively and this can be done



through proper training and a firm commitment. Challenging situations and tasks endear the human mind: to try something new or different and think out of the box. Renowned psychologists Endler and Parker have enunciated a three-factor model to overcome stress or manage this ail-

(a) Task-Oriented Strategy: The individual should ensure proper time management to complete the task at hand. Also, box out stressful conditions when through experience we are aware of negative possibilities

(b) Emotion-Oriented Strategy: Create a space in the mind to vent anger and frustrations. Literally to let go of the emotions. Develop a belief and hope in a higher power through the power of surrender and sublimate

(c)Avoidance-oriented Oriented Strategy: Create a shield or envelop the mind with an aura of positive thoughts. This works like magic and it mitigates the seriousness of the situation and stressful situations get oblit-

The model merely provides the framework. In reality, relaxation techniques, practising yoga, dwelling deep into meditation, engaging in visualisation (which incorporates features such as imagery and positive imagination), learning breathing techniques like Vipassana and Sudarshan Kriya or even hitting the gym are some of the tools to implement the model

Stress can also be dealt with effectively by acquiring knowledge, taking up responsibility and inculcating a feeling of genuine compassion, love, and concern for humanity. # Why India needs a secular civil code



As India approaches its 76th Republic Day, the question of whether laws should be shaped by religion or remain universally applicable becomes ever more urgent



MinisterNarendra Modi, in his Independence Day address from the ramparts of the Red Fort, dispelled all misconceptions and rumours about the stability and strength of his coalition and showed that he has complete control over the govern-ment. His address also revealed that his goals have remained the same. His speech was filled with energy and strong determination, as it always is.

He stressed the implementation of the Secular Civil Code (CC). He said the Supreme Court has repeatedly discussed and given orders on the Uniform Civil Code (UCC) because a large section of the country feels, and it is correct, that the present civil code is a communal and discriminatory civil code. There is no place for them in modern society.

The need of the hour is a Secular Civil Code (SCC). The Prime Minister's use of the phrase "Secular Civil Code"was interesting. A "Secular Civil Code" (SČC) was used instead of the possible "Uniform Civil Code" (UCC) so that opposition parties could support it appropriately. On November 23, 1948, Article 44 was introduced in the Constituent Assembly by Dr B R Ambedkar as draft Article 35 and was unanimously passed. "Uniform Civil Code for the citizens

The State shall endeavour which proves that this to secure a Uniform Civil Code throughout the territory of India for the citizens." So states Article 44 of our Constitution. During the Constituent Assembly discussion, amendments were moved by Hussain Imam and some other members, "That any group, section or community or people shall not be obliged to give up its own personal law in case it has such a law, and, provided that the personai iaw of any community which is guaranteed by the statute shall not be changed except with the previous approval of the community.

Dr. B. R. Ambedkar, in his reply to the discussion, stated that our country has a Uniform Code of Laws covering nearly every aspect of human relations. We have a uniform and comprehensive criminal code throughout the country, contained in the Penal and Criminal Procedure

We also have the law of transfer of property, which deals with property relations and applies throughthe country. Additionally, there is the Negotiable Instruments Act, among other acts,

country has practically a civil code that is uniform and applicable throughout the country. Dr Ambedkar argued in the Constituent Assembly that the Uniform Civil Code should be viewed as a secular law applicable to all.In 1985, the former Chief Justice of India, YV Chandrachud, shared similar views during the 'Shah Bano' case.

Shah Bano Begum, a the 76th Republic Day, we Musiim woman who had sought maintenance under Section 125 of the Code of Criminal Procedure after her divorce. The initial judgment ruled

in her favour. However, her husband, Mohammed Ahmed Khan, appealed to the Supreme Court, arguing that Section 125 should not apply to Muslims as it contradicted Muslim Personal Law. The Supreme Court disagreed with this contention, asserting that Section 125 applies to all individuals, irrespective of religion or personal law, and dismissed the husband's petition. Eminent Muslim iurists like Chaudhary Haider Hussain and former Chief Justice of Bombay High Court M C

upheld Article 44 (UCC). In the case of John Vallamattom vs Union of India in 2003, the Supreme Court once expressed regret that Article 44 of the Constitution had not been implemented. # House Republicans release impeachment report on President Biden

**AP** WASHINGTON

ouse Republicans have released their initial impeachment inquiry report into President Joe Biden, alleging an abuse of power and obstruction of justice in the financial dealings of his son Hunter Biden and family associates.

The nearly yearlong inquiry by Republicans stops short of criminal any wrongdoing by the president. Instead, the almost 300-page report out Monday ahead of the Democratic National Convention covers familiar ground, asserting the Biden family traded on its "brand" in business ventures in corrupt ways that rise to the Constitution's high bar for impeachment.

With Biden no longer running for reelection, next steps are highly uncertain.

House Republicans have not had support from their own ranks to actually impeach the president, and removal by the Senate is even further afield. Many Republicans prefer to focus attention on the Democratic Party's presumptive presidential nominee Vice President Kamala Harris, with some

probes getting underway. White House House dismissed impeachment inquiry as a "stunt" and encouraged House Republicans to "move on."

"The totality of the corrupt conduct uncovered by the Committees is egregious," wrote the House Oversight and Accountability, Judiciary and Ways and Means panels leading the inquiry.

The report said the Constitution's "remedy for a President's flagrant abuse of office is clear: impeachment by the House of Representatives and removal by the Senate."

Republicans have spent the better part of their time in the House majority with a hyper focus on Biden and his family's businesses, encouraged by Donald Trump as the twice impeached and indicted former president makes a comeback bid for the White

The impeachment inquiry has been a cornerstone of the House GOP's effort, launched by former Speaker Kevin McCarthy shortly before he was booted from leadership and formalized in December under new Speaker Mike Johnson. Republicans are investigating many aspects of Biden family finances going back to 2009 when he was vice president to Barack Obama. Through bank records,

interviews from some 30 witnesses. whistleblower accounts and millions of documents, House

Republicans allege a years-long practice by Hunter Biden and his associates to solicit foreign business deals using the family's proximity to power in

Much of the focus of the report is not on Biden's time as president, but on the years when the Biden family was in turmoil after the 2015 death of his oldest son, Beau, and as the vice president was bowing out of elected office, declining to run for president in 2016. Biden Hunter

The US attorney, David Weiss, was kept on by Garland to insulate the probe from claims of political interference.

Garland has insisted that no one at the White House gave him or other senior officials at the Justice Department direction about the handling of Hunter investigation.

Beyond Hunter Biden, the report includes details of the involvement of Joe Biden's brother, James, in the various family having family businesses.

Republicans have pointed to a series of payments that they claim show the president benefited from his brother's work. They point to a USD 2,00,000 personal check from James Biden to Joe Biden on the same day in 2018 that James Biden received an equal amount from Americore, a

healthcare company. Democrats have House defended the transaction, pointing to bank records they say indicate James Biden was repaying a loan provided by his brother, who had wire transferred USD 2,00,000 to him about six weeks earlier. The money changed hands

Short of impeaching Biden, the House Republicans have issued criminal recommending the Justice

Department prosecute Hunter Biden and James Biden, accusing them of making false statements to Congress as part of the GOP investigation.

Attorneys for those men have argued those claims are baseless or a distraction. Until recently, the president had been a focal point for

Republicans in Congress, but his decision last month to drop out of the presidential race and Harris' ascent to the top of the ticket have forced GOP leaders to reevaluate their marquee investigation.

A year ago, GOP lawmakers had hoped the Biden inquiry would build a strong enough case for impeachment's "high crimes and misdemeanors." But the longer the inquiry dragged and the little direct evidence against Biden investigators were able to produce in public hearings or even in closed-door sessions. the more concerns grew from moderate Republicans wary of a vote on the matter.

The report released Monday makes more than 20 mentions "Biden-Harris administration," previous releases from the committees investigating Biden typically only made direct references to him. And while Harris is not

mentioned on her own in the report, the same committees leading the inquiry have begun to open new probes into her and her vice presidential pick,



# Three security personnel killed in terror attack in NW Pakistan

**PTI** ■ PESHAWAR

Three Pakistani security personnel were killed as militants from the Afghanistan side launched a major attack at a border security post in the restive Khyber Pakhtunkhwa province early on Monday, security authorities said.

The attack comes a day after four security personnel were killed in two separate terror attacks in the same province. In the early hours of Monday, the militants targeted a Pakistani border security post

in the Wara Mamund area in Bajaur district on the Pak-Afghan border in the Khyber Pakhtunkhwa (KPK) province. The ensuing gun battle resulted in the death of three Pakistani security personnel, the sources said, adding that the attack took place in the Gardo sector.

Earlier on Sunday, a policeman and a Station House Officer (SHO) were killed after militants attacked with heavy weaponry the Bargai police station in the militancy-affected southern Lakki Marwat district of the same KPK province.

who had sustained multiple bullet wounds during the exchange of fire, succumbed to his injuries in the hospital.

The militants took refuge in a house close to the police station before the attack. In another incident on Sunday least two Frontier

Constabulary security personnel were killed and three others injured when militants attacked their vehicles in the Maddi area of Dera Ismail Khan district in the Khyber Pakhtunkhwa province. The militants ambushed the security forces convoy, police said.

There has been an uptick in terror incidents across Pakistan, especially in the restive KPK province over the last two years since the Taliban-led dispensation took control of Afghanistan.

Pakistan has consistently asked the Taliban-led interim Afghan government to ensure effective border management on their side of the border and deny the use of Afghan soil by terrorists for perpetrating acts of terrorism against Pakistan.

# Blinken pushes for ceasefire in his 9th trip to Mideast since war began

US Secretary of State Antony Blinken says now is "maybe the last" opportunity to reach a Gaza cease-fire agreement that would return hostages held by Hamas and bring relief to Palestinian suffering after 10 months of

war in Gaza.
Blinken on Monday was on his ninth urgent mission to the Middle East since the conflict began. His visit came days after mediators, including the United States, expressed renewed optimism a deal was near. The trip also comes amid fears the conflict following the killings of top militant commanders in Lebanon that Iran blamed on Israel.

This is a decisive moment, probably the best, maybe the last, opportunity to get the hostages home, to get a cease-fire and to put everyone on a better path to enduring peace and security," Blinken said as he opened talks with Israeli President Isaac Herzog in Tel Aviv.

HERE'S THE LATEST: UN savs a record number of aid workers were killed in 2023, mostly from the agency for Palestinian

Berlin - A record number of aid workers were killed in conflicts around the world last year, and this year may be on course to be even deadlier, the United Nations said Monday.

The UN's Office for the Coordination of Humanitarian Affairs said that 280 aid workers were killed in 33 countries in 2023 more than double the previous year's figure of 118. It said that more than half of last year's deaths were registered in the first three months of the Israel-Gaza war that started in October, mostly as a result of airstrikes.

The office said that this year "may be on track for an even deadlier outcome," with 172 aid workers killed as of Aug. 7.

More than 280, the majority of them with the U.N. Agency for Palestinian refugees, UNRWA, have been killed in Gaza so far,



according to OCHA.

ISRAELI AUTHORITIES SAY POWERFUL EXPLOSIVE' KILLED 1 PERSON IN TEL AVIV: Jerusalem - A blast that killed one person and wounded another in Tel Aviv on Sunday night was a terror attack caused by a large explosive device, Israeli authorities said Monday.

A joint statement from the police and Israel's Shin Bet security agency gave few details other than saying the attack involved "a powerful explosive." They did not identify the attacker or give a motive. Police said Sunday that the explosion killed one person, presumed to be the

'We know that the mutilated body is not that of an innocent bystander but the one who carried the bomb," Tel Aviv District Police Commander, Deputy Commissioner Peretz Amar said. The

statement on Monday only referenced the bystander who was moderately wounded. Israeli media provided security footage that showed the presumed attacker walking down the street wearing a large backpack just before the explosion.

WOUNDED IN A SHOOTING ON A STREET IN ISTANBUL: Istanbul - Police in Istanbul have launched a "large-scale investigation" after a Palestinian was killed and two others were wounded in a shooting as they sat in a car, officials and media said Monday.

The killer dropped a handgun fitted with a silencer at the scene, the Istanbul Governor's Office said in a brief statement. The Demiroren News Agency reported that the man sitting in the driver's seat was killed and his friend seriously wounded in the shooting late Sunday. The killing was carried out by a masked assailant or assailants, the agency said. The victims were sitting on Dilaver Street in the Kagithane district of north Istanbul when the attack happened.

# Major police reshuffle in Dhaka

The chiefs of 32 police stations in Dhaka have been transferred, ▲ days after the transfer of the 18 other officers-in-charge, in a major reshuffle after the ouster of the Sheikh Hasina-led government in Bangladesh, a media report said on Monday.

The order for the transfer came at Sunday, on bdnews24.Com news portal reported. With the latest transfer, the heads of all 50 police stations under the Dhaka Metropolitan Police have been transferred now.

The other 18 officers in charge had been transferred on August 13. According to the report, those transferred will no longer have the 'command power' they did as chiefs.

They have been sent to training centres across the country where they have been tasked with training police personnel. Others have transferred to the Tourist Police, the Armed Police Battalion, or the Industrial Police.

There has been a reshuffling of police at all levels since the ouster of prime minister Hasina on August 5.

Hasina, 76, resigned and fled to India following the massive protest by students against a controversial quota system in government jobs.

An interim government was formed, and 84-year-old Nobel laureate Muhammad Yunus was appointed as its



# Protesters plan large marches, rallies as Democratic National Convention kicks off in Chicago

Crowds of activists are expected to gather in Chicago for protests outside the Democratic National Convention this week, hoping to call attention to such issues economic injustice, reproductive rights and the war in Gaza.

While Vice President Kamala Harris has galvanised the party as she gears up to accept the Democratic nomination, activists say their plans to demonstrate haven't changed. They're ready to amplify their progressive message before the nation's top Democratic leaders.

Their issues cover climate change, abortion rights and racial equality, to name a few, but many activists agree an immediate cease-fire in the Israel-Hamas war is the overarching message of the demonstrations.

They've likened it to the Vietnam War of their generation. The Chicago area has one of the largest Palestinian communities in the nation and buses are bringing activists to Chicago from all over the country. Organisers estimate turnout for Monday's march and rally, on the first day of the convention, to be at least 20,000 people.

"We have to play our part in the belly of the beast to stop the genocide, to end US aid to Israel and stand with said Hatem Palestine." Abudayyeh, a spokesperson for the Coalition to March on the

The coalition is made up of hundreds of organisations,

including students. Activists say they learned lessons from last month's Republican National Convention in Milwaukee. They expect bigger crowds and more robust demonstrations through the The first protest on Sunday

night brought together those calling for abortion and LGBTQ+ rights and an end to the war in Gaza. The march lasted for hours, along a route lined by police, and showed no signs of major conflicts. Illinois Gov. JB Pritzker, who

was under consideration as Harris' running mate, said peaceful protests welcome.

"There are a lot of people who are inside the hall who will believe in some of those messages and carry that with them," Pritzker told The Associated Press in a recent interview. "But importantly, the Democratic Party doesn't shut people out and disallow them from expressing their First Amendment rights." But some have lingering safety concerns, worried that protests

could become unpredictable or devolve into chaos. Chicago, which has hosted

more political conventions than any other US city, has been unable to escape comparisons to the infamous 1968 convention where police and anti-Vietnam protesters violently clashed on live television.

Some businesses boarded up their windows as a precaution and county courts said they would open more space in case of mass arrests. Chicago police say officers have undergone

extensive constitutional policing and deescalation tactics. Coalition activists and the city

have been at odds over the location of the protests and other logistics. A judge sided with the city over an approximately 1-mile (1.6kilometre) march route, which organizers argue isn't big enough for the expected crowds. Abudayyeh said the coalition would continue to push for a much longer route until the march started on

Monday. Also Monday, Philadelphia-based Poor People's Army, which advocates for economic justice, plans to set up at Humboldt Park on the northwest side of Chicago and will feature events with third-party candidates Jill Stein and Cornel West, plus a 3-mile (5-kilometre) march. Aside from the protests the city is also hosting a speakers' stage at a park outside the

convention centre with 45-minute time slots. Most of the organisations who've signed up have the same progressive agenda as the coalition, but the list also includes the Israeli American Council and the conservative-leaning Illinois Policy Institute. A local firefighters union is also hoping to call attention to their contract fight with the city.

# Trump will campaign across country this week as he struggles to adjust to Harris

As Democrats kick off their Convention in Chicago, Donald Trump's campaign is trying to regain its footing after weeks of struggling to adjust to Vice President Kamala Harris

at the top of the opposing ticket. Trump will attempt to undercut the Democratic celebration with a jampacked schedule that includes daily events in battleground states tied to subjects where Republicans think they hold an advantage. It's his busiest campaign week since the winter, when he faced challengers in the Republican primary.

But when Trump has held events billed as policy speeches throughout the campaign, they have often resembled his usual, rambling rally remarks. And as has long been the case during his political career, Trump has undercut his own message with outbursts and attacks that drown out anything else.

The former president and Republican nominee has appeared at times in denial about the reality that Harris, and not President Joe Biden, is now his rival. He's launched deeply personal attacks, lied about her crowds by claiming images of them were generated by AI, and played on racist tropes by questioning her racial identity as she runs to become the country's first Black female and first South Asian

The outbursts have alarmed allies, who worry Trump is damaging his chance in what they believe is an eminently winnable race. Privately and publicly, they have urged him to focus on policy instead of personality, and to do more to broaden his appeal with swing voters as they grow more nervous about Harris' competitiveness.

"If you have a policy debate for president, he wins," South Carolina Sen. Lindsey Graham said Sunday on NBC's "Meet the Press." "Donald Trump the provocateur, the showman, may not win this election?

Trump is scheduled to appear Monday in Pennsylvania to talk about the economy and energy, Tuesday in Bedminster, New Jersey, to talk about

at a joint appearance with his running mate, Ohio Sen. JD Vance. On Thursday, he'll travel to the southwest border in Arizona to talk about immigration before going Friday to Arizona and Nevada.

Graham said he wanted Trump to focus on what he would do on the economy and the US-Mexico border, arguing, 'Policy is the key to the White House. Some people at his rallies agreed with that advice.

He needs to quit talking about Biden other than Harris piggybacking on those policies," said Kory Jeno, a 53year-old from Swannanoa, North Carolina, who was waiting to see Trump speak last week in nearby Asheville. "He needs to keep the conversation on the issues and what he's doing to do for Americans instead of running off on tangents where he's just bashing her and that sort of thing."

But Trump didn't take Haley's advice when asked separately whether he needed to run a more disciplined campaign and pivot away from personal attacks against Harris.
"I'm angry at her," he said. "I think I'm

entitled to personal attacks. I don't have a lot of respect for her. I don't have a lot of respect for her intelligence and I think she'll be a terrible president." He then gave Democrats new fodder at

an event later that night with Miriam Adelson, the widow of casino magnate Sheldon Adelson, who is expected to spend tens of millions of dollars helping Trump regain the White House. As he described giving her the Presidential Medal of Freedom, the nation's highest civilian award, he said it was "much better" than the Congressional Medal of Honor, the nation's highest military

"Everyone who gets the Congressional Medal of Honor, that's soldiers, they're either in very bad shape because they've been hit so many times by bullets, or they're dead," Trump told an audience. "She gets it, and she's a healthy, beautiful woman?

The comment was immediately blasted by the Harris campaign and by some veterans as disrespectful to service members, just as Trump and his running mate, Ohio Sen. JD Vance, have tried to raise doubts about the National Guard record of Harris' running mate, Minnesota Gov. Tim

On Saturday, at a rally in Pennsylvania, Trump repeatedly swerved again from a message focused on the economy to personal attacks against Harris, including a declaration that he is "much better looking" than she is.

Chinese and Philippine Coast guard ships collided at sea, damaging at least two boats, in an encounter early Monday near a new flashpoint in their increasingly alarming confrontations in the disputed South China Sea.

Both blamed the other for the collision near Sabina Shoal, a disputed atoll in the Spratly Islands, where overlapping claims are also made by Vietnam and Taiwan. There were no reports of injuries.

China's coast guard accused the Philippines of deliberately crashing one of its ships into a Chinese vessel. Two Philippine coast guard ships entered waters near the shoal, ignored the Chinese coast guard's warning and intentionally collided with one of China's boats at 3:24 am, a spokesperson said in a statement on the Chinese coast guard's website.

The Philippine side is entirely responsible for the collision," spokesman Gan Yu said. "We warn the Philippine side to immediately stop infringement and provocation, otherwise it will bear all the consequences arising from

The Philippines' National Task

Force on the West Philippine Sea said two of the coast guard's ships, BRP Bagacay and Engano, "encountered unlawful and aggressive maneuvers" from Chinese coast guard vessels while en route to Patag and

Lawak islands in the area. These dangerous maneuvers resulted in collisions, causing structural damage to both Philippine Coast Guard vessels," the statement read. The task force said the collision between BRP Cape Engano

and one of the Chinese ships

created a hole on the deck of

the Philippine ship with a diameter of about 5 inches (12.7 centimetres). About 16 minutes later, the other Philippine ship, BRP Bagacay, was rammed twice on its port and starboard sides by different Chinese vessel, leading to minor structural damage, according to the task

'The (Philippine Coast Guard) stands firm in its responsibility to ensure the safety and security of our maritime domain while addressing any threats to our national interests," it said.

Gan added China claimed "indisputable sovereignty" over the Spratly Islands, known in Chinese as Nansha Islands,

including Sabina Shoal and its adjacent waters. The Chinese name for Sabina Shoal is

Xianbin Reef. In a separate statement, he said the Philippine ship that was turned away from Sabina Shoal entered waters near the disputed Second Thomas Shoal, ignoring the Chinese coast guard's warnings. "The Chinese coast guard took control measures against the Philippine ship in accordance with law and regulation," he added.

Sabina Shoal, which lies about 140 kilometres west of the Philippines' western island province of Palawan, has become a new flashpoint in the territorial disputes between China and the Philippines.

The Philippine coast guard deployed one of its key patrol ships, the BRP Teresa Magbanua, to Sabina in April Filipino scientists discovered submerged piles of crushed corals in its shallows that sparked suspicions that China may be bracing to build a structure in the atoll. The Chinese coast guard later

deployed a ship to Sabina.

Sabina lies near the Philippineoccupied Second Thomas Shoal, which has been the scene of increasingly alarming confrontations between Chinese and Philippine coast guard ships and accompanying vessels since last year. China and the Philippines

reached an agreement last month to prevent further confrontations when the Philippines transports new batches of sentry forces, along with food and other supplies, to Manila's territorial outpost in the Second Thomas Shoal, which has been closely guarded by Chinese coast guard, navy and suspected militia ships.

# deposit insurance coverage

Aperiodical upward revision of the deposit insurance coverage limit, currently at Rs 5, lakh, may be warranted considering multiple factors like growth in the value of deposits, inflation, and increase in income level, RBI Deputy Governor M Rajeshwar Rao has said.

Delivering the valedictory address at IADI Asia-Pacific Regional Committee International Conference by Deposit 2024 hosted Insurance and Credit Guarantee Corporation (DICGC) here last week, the Deputy Governor said it is important to ensure adequacy of insurance coverage for customer deposits.

In India, he said, the number of fully protected accounts constitute 97.8 per cent as on March 31, 2024 of the total number of accounts in the banking system as against the international benchmark of 80 per cent. While the scope and coverage



appear satisfactory at this juncture, there are likely challenges going forward, Rao

'Today we count India to be amongst the fastest growing large global economies and this healthy growth rate is expected to continue in the near future. A growing and formalizing economy can naturally be expected to see a sharp increase in both primary and secondary bank deposits, driving a wedge between the desirable the insurance reserve requirement and the available reserve," the senior RBI

official said in his address on August 14.

At present, limited coverage option is adopted in India with uniform deposit insurance coverage limited to an amount of Rs 5 lakh per depositor of each insured

"Considering multiple factors like growth in the value of deposits, economic growth rate, inflation, increase in income levels etc. a periodical upward revision of this limit may be warranted. This means that the deposit insurer has to be mindful of the additional funding and needs to work out suitable options to meet the same," Rao said.

On funding and risk based premium (RBP), he said, given the diversity in Indian banking sector, ranging from scheduled commercial banks with global operations to cooperative banks operating as a single branch model with limited computerised operations, meeting the data requirements poses a great

## Rupee rises 8 paise to close at 83.87 against US dollar

The Indian rupee appreciated by 8 paise to close at 83.87 (provisional) against the US dollar on Monday, supported by a weak US dollar and a decline in crude oil prices.

Forex traders said fresh foreign fund inflows boosted investor sentiments.

At the interbank foreign exchange, the rupee opened 83.88 against the greenback, then gained ground and touched an intraday high of 83.84, and a low of 83.93 against the American currency.

The local currency finally settled for the day at 83.88 (provisional) against the American currency.

On Friday, the rupee moved in a tight range and settled just 1 paisa lower at 83.95 American against the currency.

Over the past shortened week, the rupee showed minimal fluctuation and narrowly steered clear of the critical 84-mark.

"We expect the rupee to trade with a slight positive bias on rise in risk appetite in global markets and a weak US dollar. Softening of crude oil prices may also support the rupee," said Anuj Choudhary Research Analyst at

Sharekhan by BNP Paribas. Traders said geopolitical tension in the Middle East may cap a sharp upside for the local unit. Investors may remain cautious ahead of PMI data from the US and Fed Chair Jerome Powell's speech at Jackson Hole Symposium for any cues on rate cuts by the central bank. Meanwhile, the dollar index. which gauges the greenback's strength against a basket of six currencies, was trading

If such placement is completed, the fresh issue size will be

reduced. Out of the proceeds from the fresh issuance, Rs 425 crore will be utilised for funding working capital requirements, Rs 172.68 crore for setting up multi-feed stock operations, besides, a portion will be used from its promoter group

In the report, economists acknowledged that in FY23 and FY24 the wedge between deposit and growth of deposits has been



Comptroller and Auditor General (CAG) has asked the Finance Ministry to identify high risk taxpayers in the GST composition scheme on a periodical basis and verify other sources, including third parties, their declared value of sales to check tax evasion.

Based on an analysis of 8.66 lakh composition taxpayers under the central jurisdiction between 2019-20 to 2021-22 fiscals, the Comptroller and Auditor General (CAG) found that a significant number of GST taxpayers have a high risk of crossing the turnover threshold for composition levy scheme (CLS). the data contained in GST viz. GSTR-4A, GSTR-7 along with third party data sources such as IT returns, 'Vahan' database etc.



# Ballester becomes 1st Spaniard to win US Amateur, fending off Iowa's Noah

Tose Luis Ballester, a senior-to-be at Arizona State, became the first player from Spain to win the US Amateur, fending off Iowa sophomore Noah Kent 2 up Sunday at Hazeltine in the 36-hole match on his 21st birthday.

Ballester, who was the only player in the top 10 of the world amateur ranking to reach the round of 16, took the lead on the second hole and never trailed. He joined Jon Rahm as the only players from Spain to win a USGA tournament. Rahm, who also played for the Sun Devils, won the US Open in 2021. "We have many great Spaniards, many great legends," Ballester said.


Ballester trailed at some point in his last three matches before taking control in the grueling final.
