 $A^{s}_{momentum\ across\ different} gains$ parts of Jammu and Kashmir in the run-up to the first round of polling on September 18, the terrorist handlers sitting across the Line of Control (LoC) in Pakistan are hell-bent on disturbing the peaceful conduct of Assembly polls, being held after a

gap of 10 long years. On Thursday, the troops of the Indian army eliminated at least three terrorists while they were attempting to infiltrate inside the

the frontier district of Kupwara. These terrorists were gunned down by the alert troops in two anti-infiltration separate operations along the line of control in the Machhal and Tangdhar sectors of Kupwara. This is the second major incident involving terrorists after the announcement of the Assembly polls in Jammu and Kashmir on August 16.

On August 19, a heavily armed group of Pakistani terrorists targeted an area domination patrol party comprising jawans of the Central Reserve Police Force Indian territory along the LoC in (CRPF) and Special Operations

military forces to be deployed on ground zero to instill confidence among the voters.

During the recently held Lok Sabha polls the Union Territory witnessed over 58 per cent voter turnout across five Parliamentary constituencies. The Election Commission of India is aiming to further improve the voter percentage furnout during the Assembly polls.

In the Jammu region, security forces had also established initial contact with a group of foreign terrorists in the Kheri Mohra Lathi & Danthal areas under the iurisdiction of Budhal police station, Rajouri, past midnight. After a brief exchange of firing as the security forces rushed additional troops to cordon the area the terrorists, taking advantage of the inclement weather, may have fled the area. Residents in the area also claimed heavy firing in the Lathi area of

Khwas around midnight. In Srinagar, Chinar Corps while confirming the killing of two terrorists in the Machhal sector of Kupwara posted on X, "Two terrorists have been eliminated in the ongoing anti-infiltration operation in general area Machhal, Kupwara. Two AK-47 Rifles, one Pistol, four Hand Grenades, and other war-like stores were recovered". Delhi drowns, yet again

Incessant rain since Wednesday midnight in Delhi and its neighbouring areas led to a complete collapse of city's drainage infrastructure causing severe waterlogging and traffic congestions in many parts of the national Capital.

There were reports of tree falling and power outages in several areas. According to reports from civic agencies, most of the low-lying areas underpasses and were inundated with rainwater. Visuals showed vehicles struggling to negotiate heavily waterlogged roads and pedestrians wading through ankle to knee-deep water on most roads, with underpasses almost completely submerged. There was also the risk of an overflow of sewers in many areas.

The Municipal Corporation of Delhi (MCD) received a total of 34 calls regarding waterlogging and tree falling from different parts of the city in 12 hours till 6 pm. According to the India

Meteorological Department (IMD), the Safdarjung Safdarjung Observatory, the city's primary weather station, recorded 77 mm of rainfall bringing the total rainfall for the monsoon season to 825.5 mm.

reported in August 2012, which is the second-highest mark in this period. Moreover, the month received

Gujarat flooded with merciless rains

The situation in rain-battered Gujarat improved slightly on Thursday as the rainfall activity subsided, but Vadodara and some other parts of the State are still reeling under a flood-like situation due to overflowing rivers while the authorities continue the rescue and relief operations.

Rain-related incidents have claimed the lives of 26 people in three days till Wednesday, the authorities said earlier. More than 18,000 people have been relocated and around 1,200 people rescued from flood-affected areas in the state. In some cases, choppers were used by the security forces to take people to safer locations, State Emergency Operation Centre (SEOC) said in its latest update.

Vadodara, the worst-hit city due to recent downpour, heaved a sigh of relief as the water level of Vishwamitri river has come down from 37 feet to 32 feet in the morning. However, several lowlying areas are still inundated.

The river had crossed the danger mark of 25 feet on Tuesday morning following heavy rains and the release of water from Ajwa dam. In a post on X, Chief Minister Bhupendra Patel said, "Gujarat has been receiving incessant rains for the last three days. Prime Minister Narendra Modi called me up today on the second straight day and inquired about the situation." Modi spoke to Patel for the second consecutive day and took stock of the situation.

He also asked the CM to ensure that proper steps are taken to prevent the spread of diseases post floods. Continued on Page 2

Government's Bihar **T**he ambitious plan to construct a materials and the renovation of grand memorial for Jarasandh, a key figure from the Mahabharata and the ancient king of Magadha with his capital at Girivraja (modern-day Rajgir) at lush green Rajgir wildlife sanctuary, has taken a significant step forward. Recently, the Central Wildlife headed panel, bv Union Environment Minister Bhupendra Yadav, approved the project, bringing it closer to realisation. Situated in the protected area in Nalanda district, this project includes the installation of an 18foot tall statue of Jarasandha, various murals depicting his life and achievements, as well as tributes to great freedom fighter and socialist Lok Nayak Jayprakash Narayan also known

as JP. Additionally, the project envisions the construction of an art gallery using prefabricated existing park facilities.

The project is part of the Jay Prakash Udyan Park situated within the sanctuary and officials pin hopes that it is expected to boost tourism given that it is around 100 km from the State capital Patna, and cultural interest by highlighting Bihar's rich historical and mythological heritage. Because of the want of approval, many installed structures are in dilapidated condition.

Given that the project falls within the Rajgir Wildlife Sanctuary, it required extensive consideration for wildlife clearance. The Standing Committee of the National Board for Wildlife, which is the highest decision-



making body of the Central Government for projects in protected sanctuaries and reserves, has now endorsed the proposal. This approval signifies necessary environmental and regulatory criteria, as confirmed by an official from the Union Environment Ministry.

"The State Government had that the project has met the requested the diversion of

approximately 1.8436 hectares of forest land within the Rajgir Wildlife Sanctuary for the installation of the statue and historic murals, alongside the construction of essential facilities such as toilets, a cafeteria, and an art gallery made of prefabricated structures," said the officials.

The proposal has already received recommendations from the State Chief Wildlife Warden, the State Board for Wildlife, and the State Government.

According to the minutes of the meeting of the NBWL, the Chief Wildlife Warden noted that the sanctuary was officially notified in 1978, with park development commencing prior to that and opening to the public in 1979. The ongoing renovation and provision of basic amenities are crucial to maintaining and enhancing the park for public

use," said the minutes quoting the Bihar Government officials about the project being overseeing by the Divisional Forest Officer of the Nalanda Forest Division.

Following deliberations, the Standing Committee recommended the proposal with the stipulation that the region's and fauna remain flora undisturbed. The Rajgir Wildlife Sanctuary is home to various species, including wild boar, cheetal, jungle fowl, porcupine, hare, langur, monkey, and jackal. The central wildlife panel emphasised that the legal status of the land will remain as part of the sanctuary and will be dedicated solely to eco-tourism purposes.

The project proponent has assured that no trees will be cut down as the area falls within an Eco-Sensitive Zone (ESZ) for rich heritage," he said.

night. In a statement issued by the state government, Shinde said that he had asked the State Piblic Works Department (PWD) to set up a committee comprising the nation's best sculptors; civil engineers, expert officers and Navy officers for constructing a grand and magnificent statue of

age with the modern Indian Navy," the Navy said in its statement"The project was conceptualised and steered by the Indian Navy, in coordination with state govt which also provided funding for it.The Indian Navy remains committed to assisting in all measures to repair, restore, and reinstate the statue at the ear-

liest," the statement added. It may be recalled that the 35feet tall statue of Chhatrapati Shivaji Maharaj with a sword in his hand at 12.30 pm on August 26, within nine months after it was unveiled by Prime Minister Narendra Modi on December 4, 2023 as part of the Navy Day celebrations. The collapse of Shivaji statue

has triggered a major political uproar across the state, with the Opposition MVA staging protests across Maharashtra demanding the resignations of chief minister Eknath Shinde and deputy chief ministers Devendra Fadnavis and Ajit Pawar. Ajit Pawar on Wednesday publicly apolo-gised to the "13 crore people of Maharashtra" for the Shivaji statue collapse.

Meanwhile, the Shiv Sena (UBT), a constituent of the Opposition Shiv Sena, staged protests for the fourth consecutive day. Shiv Sena (UBT)'s deputy leader and party spokesperson Sushma Andhare led the protest morcha in Pune on Thursday.

Talking to media persons Andhare hit out at senior BJP leader and MP Narayan Rane for resorting to "intimidation tactics" and handing threats to the media, police and the opposition leaders" when the MVA workers staged a protest in Malvan on Malwan.

"The language used by Rane displayed his character... He was intimidating the media persons, the police and the Opposition leaders carrying out a peaceful protest at the Rajkot Fort. His sole intention is to spoil the communal atmosphere in the state and create disturbances," Andhare said.

She questioned Deputy chief minister Devendra Fadnavis of the ruling BJP if it was he who had asked Rane and his cheap hoodlums to indulge in a ruckus ar Rajkot fort and quell any forms of public protests in Sindhudurg to create castecommunal divides in the state. "If anything untoward happens, then it is only Fadnavis who will be responsible as the state home minister. We demand that Rane should be booked and arrested for disturbing peace and fomenting

violence there," Andhare said. Rane's supporters virtually clashed with the MVA workers at Malvan's Malvan fort. So heated was the atmosphere at the Rajkot fort at Malvan that the workers of the BJP and the rival MVA elbowed one another and shouted fierce slogans against each other. mined to take that ... we are doing nothing illegal ... so no amount of pressure or threat from anyone including the Chief Minister will be shake us," a striking doctor on Thursday said.

This even as the Chief Minister ate her words writing on the X handle that her words were being misinterpreted as she had never threatened the doctors but requested them to join work.

'Let me most emphatically clarify that I have not uttered a single word against the [medical etc.] students or their movements. I totally support their movement. Their movement is genuine. I never threatened them, as some people are accusing me of doing. This allegation is completely false," Banerjee wrote.

Asking the doctors to withdraw cease work Banerjee had on Wednesday said that "the Supreme Court has given powers to the State Governments to take action ... but I am not registering any FIR as this might spoil the sition workers saying she was only targeting the BJP and none else. "I have spoken against BJP. I have spoken against them because, with the support of the Government of India, they are threatening the democracy in our State and trying to create anarchy. With support from the Centre, they are trying to create lawlessness and I have raised my voice against them." Record 100 mm rainfall sinks Gurugram

With the Gurugram recording 100 mm of rainfall on Thursday morning, the residents were seen helpless and multiple stretches across city turned into a river. However, officials claimed that efforts are on to clear waterlogging. Power outages were also reported from different areas of the city. A few hours of rain caused

heavy water logging on multiple stretches across the district. Both vehicular traffic and pedestrian movement have been disrupted due to waterlogging on several roads. Commuters faced huge prob-

lems due to rainwater.Morning rush hour traffic was affected and the police struggled to keep

the vehicles moving. Also, 3-4 feet of water accumulated on several city roads while the rainwater was also seen in the city's industrial area in Sector-37, Sector-34, Khandsa and Wazirabad. The rain started at around 4 am on Thursday and it turned into a heavy downpour till 9.30 am.Traffic movement on the Delhi-Jaipur-Mumbai highway was severely hit due to waterlogging.

Nearly 70 percent of the city was submerged in an average of 3 feet of water with the worsthit areas being Signature Tower Chowk, Hanuman Chowk



(Udyog Vihar), Narsinghpur (NH-48), Haldiram towards Manesar, Basai Road, Nathupur, Z Chowk near Huda City Centre Metro Station, Bilaspur Chowk, Dronacharya Metro Station, Iffco Metro Station, Galleria Market Road, Mayfield Garden Chowk, Sector-12 Chowk, Mini Secretariat, Sector-21/22 Tpoint, Medicity T-point, Bus Stand Road, Sanjay Gram Road, Basai Road and Sheetla Mata Road. With heavy rain lashing the city since the early hours on Thursday, several parts of the district were inundated, and water also entered several houses in Sector 7, Sector 4, Malibu Town, Anjna Colony, Saraswati Enclave,

Sheetla Colony, Rajiv Colony, Ashok Vihar, Palam Vihar and Sushant Lok.

The Gurugram resident took to social media to describe their anguish and held responsible the local authority due for this huge mess. People were seen taking selfies in the water logging area. Cluster bus with 50 passengers catches fire, no casualties reported

The Assam Assembly on Thursday passed a Bill to repeal a law to register marriages and divorces of Muslims. and Disaster

Revenue Management Minister Jogen Mohan had on August 22 tabled The Assam Repealing Bill, 2024 in the Assembly to abolish The Assam Moslem Marriages and Divorces Registration Act, 1935 and the Assam Repealing Ordinance 2024.

Taking part in the discussion, Chief Minister Himanta Biswa Sarma said: "Our aim is not only to abolish child marriages, ... Also to do away with the Kazi system. We want to bring registration of Muslim marriages and divorces under the government system.

He said that registration of all marriages has to be done as per a Supreme Court order, but the state cannot support a private body like that of Kazis for this purpose

Mohan in the Statement of Object and Reasons of the Repealing Bill said, "There remains a scope of registering marriages of intended person below 21 years (in case of male) and 18 years (in case of female)

implementation of the Act throughout the state and it attracted huge amounts of litigation in the court, he added. "There is a scope of misuse by both authorised licensee

(Muslim marriage Registrars) as well as by citizens for underage/minor marriages and forcefully arranged marriages without the consent of the parties," Mohan said. Besides, the registration of marriages and divorces were not mandatory, and the registration mechanism was informal that left a lot of scope for non-compliance of the norms, he added. "It is a pre-independence Act adopted by British India government for the then Province of Assam for Muslim



Registration Marriage and Divorce Bill, 2024. Last month, the Cabinet had

approved the Repealing Bill to abolish The Assam Moslem Marriages and Divorces Registration Act and Rules of which permitted 1935. underage marriages under specific conditions. The Assam Cabinet had approved the decision to repeal the Act on February 23, in a bid to end the social menace of child marriage in the state.

On Tuesday, when Gopi, the first BJP Lok Sabha MP from Kerala, was asked by reporters about the allegations of sexual allegations of sexual harassment against CPI(M) MLA M Mukesh, he replied, "You (media) are not only making people fight each other for your own gains you other for your own gains, you are also misleading public perception. "The complaints are in the form of allegations



telling people? Are you the court? You are not. The court will decide. Let the court decide." Later the same day, when scribes tried to get his reaction over BJP state chief K Surendran's comments that the party's stand is to seek Mukesh's resignation, the actor was seen angrily pushing away some of them. According to the videos, some of the reporters approached Gopi as he was trying to get into his official vehicle, and into his official vehicle, and he pushed them away, saying, "What is this? My way is my right. Please." Thereafter, he got inside the car and left without answering any of the reporters' queries. No report of influx of illegal Bangladeshi immigrants in Nagaland: DyCM Patton

Nagaland Deputy Chief Minister Y Patton on Thursday told the state Assembly there is no report of influx of illegal Bangladeshi immigrants following the political crisis in the neighbouring country. Patton said this while responding to NPF MLA Achumbemo Kikon raising concern in the Zero Hour of state Assembly on possible state Assembly on possible influx following the political

crisis in Bangladesh. Kikon said the North East which shares region international border with Bangladesh is the most vulnerable and expressed fear of illegal immigrants entering Nagaland through other states.

In this, he sought the measures adopted by the state government to curb the influx of illegal immigrants from Bangladesh.

In his response, Patton, who holds the Home portfolio, said India shares 4,096 km long border with Bangladesh with West Bengal having the longest border of 2,217 km and Assam having the least 262 km.

Besides three other states -Mizoram, Meghalaya and Tripura share borders with Bangladesh but not Nagaland, he said.



The DyCM told the House that the possible influx into the state would be via Assam, and asserted that the state government has not let the guards down but it is closely monitoring the situation in proximity close with intelligence and other

agencies. "To ensure that no unnatural influx happens and to remove any anxiety of the people, we have taken steps including directing the administrations district sharing the border with Assam to conduct regular district-level security coordination meetings with other security forces," Patton said.

Informing the House that to date there are no reports of influx of illegal Bangladeshi immigrants in the aftermath of the recent crisis in that country, the Deputy CM assured the people that the government is well prepared with all steps to stop any influx of illegal immigrants to the state.

Adequate measures specific to the district have been initiated to stop illegal influx, he said.

district deputy The commissioners have also been asked to coordinate with their counterparts in Assam for cooperation and regular updates on the matter, and also to intensify Inner Line Permit checking and closely monitor interstate check posts, he said.

The state police have been directed to be on a high alert along the 13 inter-state borders and be vigilant round the clock besides conducting intensified vehicle checking and also keeping a watch in the places of worship, he said.

Kannada actor Darshan shifted to Ballari jail amid tight security

PTI BENGALURU

∕annada actor Darshan Kannasu Thoogudeepa, who is currently in judicial custody in the Renukaswamy murder case, was on Thursday shifted from Parappana Agrahara Central prison here to a jail in Ballari, amid tight security.

The 24th Additional Chief Metropolitan Magistrate court here on Tuesday granted permission to move Darshan to a jail in Ballari, after a photograph of him hanging out with three others, including a rowdy-sheeter, on the lawns of the Bengaluru jail had gone viral on Sunday, sparking an uproar.

The court has also permitted shifting of other co-accused in the murder case to various prisons in the state, and a few of them were relocated today. In the picture, the actor is seen in a relaxed mood, sitting on a chair and holding a cigarette and a coffee mug. Also, a purported video of Darshan speaking to a person over a video call from the prison too had surfaced on social media. According to police sources, Darshan was escorted to Ballari jail via the Andhra Pradesh route for security reasons and to avoid crowding of fans.



They said he was taken out of Parappana Agrahara Central Prison in a police SUV and then moved into a police van near Chikkaballapur on the way to the district headquarters town of Ballari.

Escorted by police officials, Darshan was seen wearing a black t-shirt with a sun glass hung to its neckline and blue jeans, and carrying a water bottle and some clothes on reaching Ballari jail.

A few scenes of the 2017 Kannada movie 'Chowka', in which Darshan had appeared in a cameo role, was shot in the Ballari jail. A court on Wednesday extended till September nine the judicial custody of Darshan along with his friend Pavithra Gowda and 15 others, who are accused in the Renukaswamy murder case

The recent request by the Bharatiya Janata Party (BJP) to the Election Commission of India (ECI) to change the polling date has added another layer of intrigue to an already charged atmosphere. Jat communities, particularly in urban regions. This division was evident in the 2024 general elections, where the BJP won all five Lok Sabha seats in non-Jat dominated areas. The BJP's support base in rural areas has been eroded, particularly among Jats, who have been disillusioned by the central government's response to their protests. The Congress is working to capitalise on this discontent by consolidating a Jat-Dalit-Muslim alliance in rural areas, which could pose a significant challenge to the BJP. In light of these challenges, the BJP's request to change the polling date has sparked controversy. The party argues that the potential for a long weekend could lead to lower voter turnout, particularly in urban areas where it has a strong base. The Congress has dismissed the BJP's request for date change as a sign of nervousness. The Election Commission's decision on the date change will be crucial, as it could influence the electoral outcome in a state where every vote counts. With ten years of incumbency and a narrowing margin of victory, the BJP is leaving no stone unturned to secure a favourable result. Whether the ECI will accommodate the BJP's request remains to be seen, but the upcoming elections in Haryana are shaping up to be a closely contested battle.



How media shapes public perception

In a world where sensationalism often trumps substance, it's time to rethink how we engage with the news and what it says about the society we've built.

he last few weeks have seen some major convulsions at the basic level of the Indian society The listing can be long, depending upon the predisposition and values of the person making a list, or indeed brief if this person wants to strike a judgmental posture on what he considers important. This debate can merit its own resolution but the common-sense approach would make it obvious that the NEET examination and the Kolkata rape and murder episode have touched a very large number of minds and people who are in touch with the media.

This itself raises another basic question. That has to do with the role of the media in attributing to an episode both circulation and importance. The reach and mode of the media become critical in identifying an issue and formulating it. One of the farthest reach of a media is through the radio. By and large, the radio is controlled by governmental agencies. This is followed by television, which is controlled both by the government and by some powerful private media houses. Both clusters claim a popular following, and both are accused of biases. Hence, to a fairly complicated question on what constitutes

much of the news, there is a plausible answer: that which the media of the day decides to project and sustain as news. Thus it is that the role of governance/ownership of the mode of the media, in the identification of news, and sustaining it becomes critical.

This brings us to a basic question: what constitutes news and how is it maintained at the frontlines?

What is projected in so-called news is impossible for a private citizen to verify. That raises the question of the creditability of a channel. The creditability of the channel is itself a matter of popular perception, and it is also nurtured by reputation and



upon the larger intellectual culture of the community where the news circulates. If the community is mature, it has developed safe parameters of credibility and conviction, and therefore one can be reasonably sure that what is being circulated is true. By and large, globally, the media, also, has its methods of checks and balances, standards and credibility, of reach and sustenance. Hence, whereas it may be a

worthwhile debate to consider what constitutes news: origin, sustenance, and dissemination of news has certain standards across the globe. These, are like many things in life, having largely acknowledged standards without much vagouness. These are considered givens of a civil society.

Hence the conclusion that if the general media projects something, it must be the truth, or at least the truth in

good faith. Reference has been made above to the NEET episode and the Kolkata murder and rape case. The jury is out on both cases, and a conclusions are awaited. The civil society is maintained on such pillars.

Essentially, therefore, a question is: what is the kind of society which one has given to oneself and how do its norms get modified and operated, also, through the media?

The strength of a society comes not only from handling the unhappy episodes which lead to news but also from giving positive news the importance that it deserves. It is here again that the media need continuous help in introspection. The basic truth

UKRAINE: INDIA'S DIPLOMATIC TIGHTROPE

PM Modi's historic Ukraine visit signals new foreign policy approach

rime Minister Narendra Modi's visit to Ukraine, last week, comes at an interesting churn of events on the geopolitical landscape. The visit, a first, by any Indian PM since Ukraine was first carved out as an independent sovereign nation, had many layers of interpretations regarding India's new foreign policy approach. The timing was significant as this trip came barely six weeks after PM Modi's state visit to Moscow. The Russia trip was widely criticised by India's strategic ally US, primarily due to the timing.

Even as PM Modi was in Moscow, the NATO leaders were huddled together in Washington, discussing military aid for Ukraine.Meanwhile, Russia bombed a children's hospital in Ukraine leading to the loss of lives for civilians and children. President Zelenskyy had condemned India's PM's first visit to Russia during his third term and the US State Department had also issued stern statements regarding the trip. Indian PM had also avoided participating in the Peace Summit organised in June, to find a political solution to the Russia-Ukraine crisis. The recent visit by PM Modi to Ukraine, even as Defence Minister Rajnath Singh was in Washington DC was a statement regarding India's fine balance diplomacy in times of war. President Biden, called up the Indian PM soon after his visit to Ukraine to apprise him of the prevailing situation.

The readout released from the White House read "President Joseph R. Biden, Jr. spoke today with Prime Minister Narendra Modi of India to discuss the Prime Minister's recent trip to Poland and Ukraine, as well as the United Nations General Assembly meetings in September. The



President commended the Prime Minister for his historic visits to Poland and Ukraine, the first by an Indian Prime Minister in decades, and for his message of peace and ongoing humanitarian support for Ukraine, including its energy sector. The Leaders affirmed their continued support for a peaceful resolution of the conflict by international law, on the basis of the UN Charter." Interestingly, the Indian PM also spoke to President Biden regarding the ongoing crisis in Bangladesh and expressed concern regarding the safety of minorities, especially Hindus, which was highlighted in the Indian statement after the telephone conversation.

The Bangladesh situation omission from the White House readout did create some murmurs across Delhi corridors.India is now making efforts to have its own Europe policy, which is not curated with a Russia factor in mind. For several decades post-independence, the Cold War era, the block approach mostly guided India's foreign policy, especially where Russia was involved. Russia has been a long-standing ally of India and is also one of the biggest exporters of defence equipment. While maintaining silence on sensitive Russia-related topics has been India's long-standing approach, things began to change in the past few years. There is a growing sense of having an independent need-based foreign policy, amongst the top policymakers. PM Modi initiated the concept of "not a time for war" at multilateral platforms such as G20, which started finding global resonance when vocalising concerns regarding Ukraine and Russia. He upped the narrative with his clear message to Russia during his Moscow visit that permanent solutions could not be found on the battlefield. The joint statement issued post PM Modi's meeting with President Zelenskyy read The Indian side reiterated its principled position and focus on peaceful resolution through dialogue and diplomacy. Prime Minister Modi reiterated the need for sincere and practical engagement between all stakeholders to develop innovative solutions that will have broad acceptability and contribute towards early restoration of peace." The message to global leaders, particularly the US and Russia that the recent PM Modi visit highlighted was that India is willing to engage with any nation, even if they may be in opposite camps, to find the best possible outcomes for itself.

Prospects of privatisation of PSUs are bleak

As the Modi government shifts its strategy towards 'prudent public wealth management' the prospect of privatising PSBs are increasingly unlikely.



nnouncing Modi - government's policy on disinvestment of central public sector undertakings (CPSUs) in her Budget speech for FY 2021-22 the Union Finance Minister, Nirmala Sitharaman had talked of privatizing two public sector banks (PSBs) and one insurance company,

A CPSU is an undertaking in which the Central government has majority share holding of more than 50 percent. Disinvestment refers to sale of its shares to private investors. When, such sale results in reduction of the government's shareholding in the CPSU to below 50 percent and concomitant transfer of ownership and management control to

private entity, this is termed as privatization. The disinvestment plans have met with disappointing results so far.

During 2021-22, against a target of Rs 175,000 crore, the actual proceeds from share sale of CPSUs were a meager Rs 15,440 crore. During 2022-23, against a target of Rs 65,000 crore, the actual was Rs 31,059 crore. For 2023-24, the actual was Rs 14,564 crore against a target of Rs 30,000 crore which itself was watered down from the budget estimate (BE) of Rs 51,000 crore. As ioi privatization, except for the sale of Air India to the Tata Group during 2021-22, the government has little to show. Apart from offloading 3.5 percent of its shareholding in the Life Insurance Corporation (LIC), it is selling its stake in the IDBI Bank. The process of selling the latter that start-ed in May 2021 is likely to get consummated during the current FY. However, it can't be termed as privatization as already the bank was operating as a private lender even as the Centre became its passive shareholder consequent to capital infusions to manage former's bad debt losses. Currently, the government and the LIC collectively own 94.72 per cent of IDBI Bank with shareholding of 45.48 percent and 49.24 percent respectively (the remain-ing 5.28 percent is with Public shareholders). Of this, the Centre plans to sell a 60.7 percent stake, comprising 30.5 per cent of its own and 30.2 percent of LIC's. Will the Centre take up selling of PSBs and an insurance company - as promised in the 2021-22 budget?

This is evident in their interventions in other countries, where they create

Various private sector industries played a pivotal role in this growth. Adani Group dominated the list of top value gainers in 2022, adding Rs 8.42 lakh crore to investor wealth.

Israel kills prominent militant |EU urged to rethink ties

The Israeli military said it killed five more militants, including a local commander, early Thursday in the West Bank as it pressed ahead with what appeared to be the deadliest military operation in the occupied territory since the start of the war in Gaza.

Israel says the simultane ous raids across the northern West Bank — which have killed a total of 16 people, nearly all militants, since late Tuesday are aimed at preventing attacks.

The Palestinians see them as a widening of the Israel-Hamas war aimed at perpetuating Israel's decades-long military rule over the territory

The Islamic Jihad militant group confirmed that Mohammed Jaber, known as Abu Shujaa, was killed during a raid in the city of Tulkarem. He became a hero for many Palestinians earlier in the year when he was reported killed in an Israeli operation, only to make a surprise appearance at the funeral of other militants, where he was hoisted onto the shoulders of a cheering crowd.

The military said he was killed early Thursday along with

four other militants in a shootout with Israeli forces after the five had hidden inside a mosque. It said Abu Shujaa was linked to numerous attacks on Israelis, including a deadly shooting in June, and was planning more. The military said another militant was arrested in the operation in Tulkarem, and that a member of Israel's paramilitary Border Police was light-

ly wounded. Israel launched a large-scale operation in the West Bank overnight into Wednesday. Hamas said 10 of its fighters were killed in different locations, and the Palestinian Health Ministry reported an 11th death, without saying whether he was a fighter or a civilian The overall toll of 16 killed

in less than two days would make it the deadliest Israeli operation in the West Bank since Hamas October 7 attack out of Gaza ignited the war there. The Palestinian Health Ministry says over 650 Palestinians have been killed in the West Bank since the start of the war. Most appear to have been militants killed in gunbattles during Israeli operations like the one this week, but civilian bystanders and rock-throwing protesters have also been

killed, and the territory saw a surge of settler violence. Israel says the operations are required to prevent attacks on its citizens which have also risen since the start of the war. Israel captured the West Bank, the Gaza Strip and east Jerusalem in the 1967 Mideast war, and the Palestinians want all three territories for their future state.

The 3 million Palestinians in the West Bank live under seemingly open-ended Israeli military rule, with the Western-backed Palestinian Authority administering towns and cities. Over 500,000 Jewish settlers, who have Israeli citizenship, live in well over 100 settlements across the territory that most of the international community considers illegal.

The raids have focused on refugee camps that date back to the 1948 war surrounding Israel's creation, in which around 700,000 Palestinians fled or were driven out of what is now Israel. Many of the camps are militant strongholds.

Hamas repeated its calls for Palestinians in the West Bank to rise up, calling the raids part of a larger plan to expand the war in Gaza. The militant group has called on security forces loyal to

the Western-backed Palestinian Authority, which cooperate with Israel, to "join the sacred battle of our people". Palestinian Authority President Mahmoud Abbas has also condemned the Israeli raids, but his forces were not expected to get involved.

The war in Gaza erupted when Hamas-led militants stormed into southern Israel and rampaged through army bases and farming communities, killing some 1,200 people, mostly civilians, and abducting around 250. The militants are still holding 108 hostages, around a third of whom are believed to be dead, after most of the rest were released during a November cease-fire.

Israel responded with an offensive that has killed over 40,000 Palestinians, according to Gaza's Health Ministry, which does not say how many were militants. Around 90 per cent of Gaza's population has been displaced, often multiple times, and Israeli bombardment and ground operations have caused vast destruction.

The United States, Qatar and Egypt have spent months trying to mediate a cease-fire that would see the remaining hostages released.

¬he European Union must Trethink its relations with Israel as the death toll mounts in Gaza and the West Bank and impose sanctions on some Israeli government ministers accused of fomenting racial hatred, Ireland and the bloc's top diplomat said on Thursday.

At a meeting of EU foreign min-isters in Brussels, Ireland's foreign minister accused Israel of deliberately targeting civilians as well as Hamas militants with the military campaign it launched almost 11 months ago.

"This is a war against Palestinians not just against Hamas. The level of civilian casualties and dead is unconscionable," Micheal Martin told reporters. "It's a war on the population. No point in trying to fudge this."

Israel's offensive in Gaza has killed over 40,000 people, according to local health officials, displaced 90 per cent of the population and destroyed its main cities. Hamas has lost thousands of fighters and much of its militant infrastructure.

Violence has also surged in the

West Bank since Hamas' October 7 attack inside southern Israel ignited the war there. Israel launched a large-scale operation in the West Bank this week, in which Hamas said 10 of its fighters were killed in different locations.

Martin said a legal opinion issued by the International Court of Justice that Israel's occupation of Gaza and the West Bank is unlawful obliges the EU to take action. The Palestinians have hailed it as "a watershed moment for Palestine, for justice and for international law

'It cannot be business as usual," Martin told reporters. "It is very clear to us that international humanitarian law has been broken." Ties between the EU and Israel – which are major trading partners - are governed by a socalled Association Agreement. Ireland and Spain have been pressing their EU partners to examine whether Israel has broken the rules. The EU is the world's top provider of aid to the Palestinians but holds little leverage over Israel, notably because the 27 member countries are deeply divided in their approach. Austria, Germany and Hungary are staunch backers of Israel, while Ireland and Spain are more vocal in their support for the Palestinians. Nonetheless the bloc does have credibility as a European project founded on

peace. EU foreign policy chief Josep Borrell, with the backing of Ireland, urged the ministers to consider imposing sanctions on certain members of Prime Minister Benjamin Netanyahu's right-wing cabinet over their remarks about the war in Gaza. 'Some Israeli ministers have been launching hateful messages, unacceptable hateful messages, against the Palestinians and proposing things that go clearly against international law and is an (incitement) to commit more crimes," Borrell said.Borrell did not name the ministers, but earlier this month he criticised Israel's Finance Minister Bezalel Smotrich for suggesting that the starvation of Gaza's population of more than 2 million people "might be just and moral" until hostages captured in the October 7 attack are returned home.

HK court convicts two journalists in landmark sedition case

Hong Kong (AP): A Hong Kong court convicted two former editors of a shuttered news outlet on Thursday, in a sedition case widely seen as a barometer for the future of media freedoms in the city once hailed as a bastion of free press in Asia.

Stand News former editor-inchief Chung Pui-kuen and former acting editor-in-chief Patrick Lam were arrested in December 2021. They pleaded not guilty to the charge of conspiracy to publish and reproduce seditious publications. Their trial was Hong Kong's first involving media since the former British colony returned to Chinese rule in 1997. Stand News was one of the city's last media outlets that openly criticised the government amid a crackdown on dissent that followed massive pro-democracy protests in 2019. It was shut down just months after the pro-democracy Apple Daily newspaper, whose jailed founder Jimmy Lai is fighting collusion charges under a sweeping national security law enacted in 2020.

Chung and Lam were charged under a colonial-era sedition law that has been used increasingly to crush dissidents. They face up to two years in prison and a fine of 5,000 Hong Kong dollars (about USD 640) for a first offense.

Best Pencil (Hong Kong) Ltd., the outlet's holding company, was convicted on the same charge. It had no representatives during the trial, which began in October 2022. Judge Kwok Wai-kin said in his written judgement that Stand News' became a tool for smearing the Beijing and Hong Kong governments during the 2019 protests. He said a conviction is deemed proportional "when speech, in the relevant context is deemed to have caused potential damage to national security and intends to seriously undermine the authority of the Chinese central government or the Hong Kong government, and that it must be stopped". from the NHS. Denmark has record 25 govt mins after major reshuffle

Danish Prime Minister Mette Frederiksen on Thursday appointed six new ministers in a major reshuffle of her threeparty centrist government, bringing the number of ministers to 25 — the largest ever in 30 years. One of the ministers will head a new government office of emergency preparedness, climate change and cyber crimes.

'The world has become more troubled," Frederiksen said as she announced that Torsten Schack Pedersen will be in charge of the new ministry, after the reshuffled cabinet was formally presented to King Frederik X. Denmark now joins Sweden to have such a department. Besides the new emergency office, the government

now has two other new ministries, bringing the total to 25, the largest since the 1993-1994 Cabinet of Social Democratic Prime Minister Poul Nyrup Rasmussen who had 24 minis-

Marie Bjerre left her job as minister for digitalisation and gender equality, to become in charge of the European Union affairs, ahead of Denmark's rotating EU presidency in the second half of 2025.

Jeppe Bruus, the outgoing taxation minister, was brought in to head a brand new ministry, which will be coordinating Denmark's green policy. The Scandinavian country has a goal of 70 per cent emissions reductions by 2030 and achieving net zero by 2050.

The order from Justice Alexandre de Moraes on Wednesday is the latest development in an ongoing feud with Musk's platform. The company has clashed with de Moraes earlier this year over free speech, accounts associated with the far-right and misinformation, and it claims to be a victim of censorship.

Earlier this month, X said it was removing all remaining Brazil staff in the country "effective immediately," saying de Moraes had threatened its legal representative with arrest.

Russia continues heavy missile, drone bombardment of Ukraine

Russia conducted a heavy for the third time in four days Thursday, again launching mis-siles and scores of drones that mostly were intercepted, Ukraine's air force said. Russian forces fired five missiles

and 74 Shahed drones at Ukrainian targets, an air force statement said. Air defences stopped two missiles and 60 drones, and 14 other drones presumably fell before reaching their target, it said

Authorities in the capital, Kyiv, said debris of destroyed drones fell in three districts of the city, causing minor damage to civilian infrastructure but no injuries. Russia's relentless and unnerving long-range strikes on civilian areas have been a feature of the war since it invaded its neighbour in February 2022.

Ukrainian officials have recently become more vocal in their long-standing insistence that Western countries supporting their war effort should scrap restrictions on what Ukraine is allowed to target inside Russia with long-range weapons they have provided. Ukraine President Volodymyr

Zelenskyy renewed his pleas for Western allies to untie his hands in deciding what to strike on Russian soil

"All our partners should be more active - much more active — in countering Russian terror," Zelenskyy said late Wednesday. "We continue to insist that their determination now — lifting the restrictions on long-range strikes for Ukraine now — will help us to end the war as soon as possible in a fair way for Ukraine and the world as a whole.

The European Union's top diplomat on Thursday backed Zelenskyy's push for international backers to end their limits. Ukraine has deployed domestically produced drones to strike Russia

Former Russian defence official detained suspected of fraud

A former Russian defence deficial was ordered detained on fraud charges on Thursday in the latest high-profile arrest of a senior mili-tary official in what appears a sweeping investigation into abuse of office in the top ech-elons of the military leadership. Former Deputy Defence Minister Pavel Popov faces up to 10 years in pricon if he is to 10 years in prison if he is charged and convicted after being detained on suspicion of committing fraud, Russian state news agencies reported on Thursday.

The case against Popov relates to business activities at a sprawling park in Moscow sometimes called Russia's "military Disneyland."

Patriot Park, a pet project of former Defence Minister Sergei Shoigu, is designed to inspire patriotism in Russia's younger generations and showcases Soviet and Russian weaponry. It has a firing range, air base, museums and conference center and a massive, khaki-col-ored Cathedral of the Russian Armed Forces, which features mosaics of Soviet and Russian soldiers. Russian President Vladimir Putin personally donated money to commission the main icon for the church, according to the Kremlin. Popov is now the eighth top military figure to be arrested on charges of fraud, bribery or

abuse of office in recent months, including Deputy Defence Minister Timur Ivanov, who was arrested for bribery in April and later dismissed from his position. The

Brussels (AP): The European Union's top diplomat on Thursday ramped up pressure on Ukraine's international back-ers to lift restrictions on the use of weapons they provide the conflict-ravaged country to allow its armed forces to strike targets inside Russia. The US restricts the use of

The US restricts the use of long-range ballistic missiles it provides to Ukraine and some EU members also limit the use of their weapons. Ukraine is desperate to target airfields and other military installations inside Russia that are used to stage attacks on its armed forces and civilians. "We need to lift restrictions on the use of weaponry against Russian military targets, in accordance with interna-tional law," EU foreign policy chief Josep Borrell said as the bloc's foreign ministers gathered in Brussels to discuss Russia's invasion of Ukraine.

"The weaponry that we are pro-viding to Ukraine has to have full use, and the restrictions have to be lifted in order for the Ukrainians to be able to target the places where Russia is bomb-ing them. Otherwise, the weaponry is useless," Borrell told reporters. told reporters. Speaking alongside Ukrainian Foreign Minister Dmytro

Kuleba, Borrell condemned Russia's attacks on civilians and civilian infrastructure. "Russia wants to bomb a European country into full capitulation," he said. Kuleba said that Ukraine's backers would only have themselves to blame if Russia wins. 'The success of Russia depends on one thing: on the preparedness of partners to make bold decisions. If decisions are taken, Ukraine is successful on the ground. If they are not taken, then do not complain on Ukraine, complain on yourself," he said. Kuleba insisted that Ukraine only wants to attack 'legitimate military targets' inside Russia. "If we are supplied a sufficient amount of missiles, if we are allowed to strike, we will significantly decrease the

capacity of Russia to inflict damage on our critical infrastructure and we will improve the situation of our forces on the ground," he said.

SL Prez offers continuity for eco recovery in election manifesto

Colombo (PTI): Sri Lankan President Ranil Wickremesinghe on Thursday offered the continuation of his economic recovery path with the cash-strapped island nation's international partners as the cornerstone of his election manifesto for the presidential election scheduled for next month. The 75-year-old incumbent president is in the fray for reelection in the September 21 polls to continue the recovery programme with his legacy of ending mileslong queues for essentials and guaranteeing livelihoods in a painful reform process. "We must operate within the framework of these agreements," Wickremesinghe, also the finance minister, said, referring to the economic bail-out agreement with the International Monetary Fund, the official

creditor committee comprising 17 countries, China, the World Bank and the Asian

Development Bank. Sri Lanka's bankrupt economy has recorded positive growth under Wickremesinghe's leadership after the island nation reported six quarters of negative growth following the unprecedented economic crisis caused by massive forex shortages in 2022. The public protests due to shortages of essentials, power and cooking gas led to the ouster of Wickremesinghe's pre-decessor Gotabaya Rajapaksa who resigned following mass protests in 2022. The IMF-led reform programme has made the president unpopular, result-ing in the lead of other front runners — Sajith Premadasa and Anura Kumara Dissanayake - in unofficial polls.

"Pakistan has no plans to

engage in any talks with the TTP," she added. She said Islamabad has repeat-

edly raised concerns about the use of Afghan territory against Pakistan. She added that Pakistan also provided intelligence to Afghanistan on terrorism but refused to disclose the details of the intelligence-sharing arrangements. Pakistan has repeatedly called

on the Afghan government to prevent its soil from being used against it by the TTP and other terrorist groups - a claim denied by Kabul

There has been an uptick in the incidents of terrorism in Pakistan since the Taliban took over the government in Kabul in 2021, dashing hopes in Islamabad that a friendly government in Afghanistan would help to tackle militancy. Relations between the two

countries have lately become strained, largely because of the TTP but also due to frequent border skirmishes. In March, Pakistani air force jets

carried out air strikes against terrorists in the border regions of Khost and Paktika inside the neighbouring country. Baloch said that Pakistan's decision to recognise the Afghan Taliban government would be made in consultation with regional partners.

Separately, in a statement issued on the International Day of Remembrance and Tribute to the Victims of Terrorism, the Foreign Office paid tribute to those who lost their lives in counterterrorism efforts and reiterated Pakistan's firm stance against the TTP The spokesperson also con-

demned the recent terrorist activities in Balochistan, reaf-

firming the government's commitment to ensuring the safety of its citizens.

She also said that the China-Pakistan Economic Corridor was a transformational project that had contributed positively and transparently to Pakistan's national development. She said the corridor project enjoys support and popularity in all provinces and across the political divide in Pakistan. She clarified that Pakistan's total public debt relating to the CPEC projects is a small percentage of its total debt. Moreover, she said that the public debt obtained from China has a longer maturity period with low interest rates.

The spokesperson reaffirmed Pakistan's commitment to provide full security to all Chinese nationals, projects and institutions.

Global rating agency Fitch from Thursday affirmed India's sovereign rating at 'BBB-' with a stable outlook. India's rating has remained unchanged at 'BBB-', the lowest investment grade, since August 2006. "Fitch Ratings has affirmed India's Long-Term Foreign-Currency Issuer Default Rating (IDR) at BBB-' with a Stable Outlook," the global rating agency said in a statement.

India's ratings are underpinned by its strong medium-term growth outlook, which will continue to drive improvement in structural aspects of its credit profile, including India's share of GDP in the global economy, as well as its solid external finance position, it said in a statement.

Strengthening fiscal credibility from recent achievement of deficit targets, enhanced transparency and buoyant revenues, have increased the likelihood that government debt can follow a modest downward trend in the medium term, it said.

Nevertheless, it said, fiscal metrics remain a credit weakness, with deficits, debt and debt service burden all high compared to 'BBB' range peers. Lagging structural metrics, including governance indicators and GDP per capita, including also weigh on the rating, it added.

Observing that India is set to remain among the fastest-growing sovereigns globally, it said, "we forecast GDP growth of 7.2 per cent in the fiscal year ending March 2025 (FY25) and 65 per cent in FY26 down 6.5 per cent in FY26, down slightly from 8.2 per cent in FY24."







n international team of scientists, Adrawn mainly from Sri Lanka and India, have demolished the concept of Eelam Tamils in the island nation through a comprehensive genetic study. A three-year long molecular biology research spanning across Sri Lanka and India have established that the population in the island nation is homogeneous in nature and there is no scientific basis for the claims by the Tamils that they had their origin in that country. The findings prove that the demand for a separate Eelam(country) for Tamils is bunkum and thousands of Tamils and Sinhalese massacred in the war for Eelam died for a non-existent cause. "The Sri Lankan population, mainly the Sinhala and Tamils, have massive genetic mixing. If the Tamils had their origin in Sri Lanka, their DNA should be visible and discernible. But it is missing," said Prof Gyaneshwer Chaubey, Department of Zoology, Banaras Hindu University who led the team of scientists in this path breaking research.

The peer-reviewed research paper "Reconstructing the Population History of the Sinhalese, the major ethnic group of Sri Lanka," has been published in iScience, a widely respected scientific portal. While Dr Chaubey led the team of Indian scientists, R Ranasinghe (Institute of Biochemistry, Molecular Biology and Biotechnology, University of Colombo) led the researchers from the island nation. It may be remembered that Dr Chaubey and a team of researchers from Estonia, Harvard and Centre for Cellular and Molecular Biology (Hyderabad) had demolished the Aryan and Dravidian linguistic theory and proved that both of these groups share the same forefathers. "The analysis based on

the frequency of various genetic mutations showed a tight cluster of Sinhalese and Tamil populations, suggesting strong gene flow beyond the boundary of ethnicity and language. A further connection of Sinhalese with the West of India has been established based on the traces of DNA segments. Overall in the South Asian context, Sri Lankan ethnic groups are genetically more homogenous than others", said the team leaders.

The study also found that the Sinhala language spoken in the country is a combination of Konkani, Marathi, Sanskrit and Gujarati and reached the island nation through Arabian Sea. According to K M Raghavan, a Sri Lankan historian, the Tamils could have reached Sri Lanka as part of the Kaurava army units hired by the princes of the island nation to fight for them as private army warriors. The Kauravas, who were defeated by the Pandavas in the Mahabharata War took refuge in the East Coast of India and reached Sri Lanka at the invitation of various Kings in the island nation. Following the Portuguese occupation of Sri Lanka, the Kauravas converted to Christianity and their name was

changed to Karavas. writes Raghavan in his book.

Ramaswami Wijayabalan, plantation owner and Tamil scholar based in Colombo, told The Pioneer that the Tamils in north and north east of Sri Lanka are descendants of migrant workers from Malabar province in present day Kerala. "The Tamil they speak, their food habits and social life have their origin in Malabar. The priests in temples in North and East are addressed as

Gurukkal as they had come here for teaching martial arts and offering poojas," said Wijayabalan. He asked how puttu, appam etc became the staple food of the Jaffna and Batticaloa Tamils. Interestingly, Ceylon and Colombo find mention in novels and short stories in Malayalam whereas the same is not that common in yesteryear literary works in Tamil, said Josephine Jayashanthi, leading novelist in Tamil Nadu. Dr S Kalyanaraman, Indologist of repute, concurred with the findings of Dr Chaubey and his team. "You may be able to distort history but you cannot distort science. The study by Dr Chaubey is based on pure science and no force can repudiate the same," said Dr Kalyanaraman who has deciphered the Indus script.

ormer Australia coach John Buchanan believes India's chances of completing a hat-trick of Test

series wins Down Under will hinge on how the visiting batters, including "ageing' stars Rohit Sharma and Virat Kohli, tackle the hosts' battery of pace bowlers.

For the first time since 1991-92, India will tour Australia for a five-match Test series for the Border-Gavaskar Trophy, with the opening game scheduled to be played at Perth from November 22.

Buchanan, who presided over Australia's golden run in all forms in the first decade of this millennium as head coach, said both India and Australia have plenty of ageing players at disposal but that will not be a deterrent to the competition between the sides.

"Australia (has), since losing to India in the last series, the pace bowling attack with (offspinner Nathan) Lyon, backed up now by Cameron Green or Mitch Marsh, is just a really, bowling powerful really lineup," Buchanan told PTI on Thursday after the launch of 'Ready Steady Go Kids' multisport program for the CP Goenka International School. "India's top order, (Yashasvi) Jaiswal, (Rohit) Sharma himself, (Virat) Kohli, possibly Iyer... they've got to bat really well to establish totals and then the likes of (Jasprit) Bumrah, (Mohammed) Shami, (Mohammed) Siraj will come

Just weeks after hosting the Olympics, Paris inaugurated the 2024 Paralympics on Wednesday with a nearly fourhour-long opening ceremony in the heart of the city.

Against the backdrop of a setting sun, thousands of athletes paraded down the famed Champs-Elysées avenue to Place de la Concorde in central Paris where French President Emmanuel Macron officially declared the

Paralympic Games open. About 50,000 people watched the ceremony in stands built around the iconic square, which is the biggest in Paris and is visible from afar because of its ancient Egyptian Obelisk. Accessibility for athletes in wheelchairs was facilitated with strips of asphalt laid along the avenue and placed over the square. More than 4,000 athletes with physical, visual and intellectual impairments will compete in 22 sports from Thursday until Sept. 8. Organizers say more than 2 million of the 2.8 million tickets have been sold for the various Paralympic events. The opening ceremony was
