Leaders in other states may want to pluck senior bureaucrat Jayesh Ranjan from Telangana, given his accomplishments under the previous Bharat Rashtra Samithi regime and storied networking skills that have funneled substantial investments into Telangana. Yet, in tune with a Tamil proverb 'Yanaikkum *adi carukkum*' (meaning, 'even an elephant can slip'); Jayesh may have been taken for granted at least in some cases by guys smarter than him. 

## Doctor highlights shortage of breastmilk banks in 🚄 India

## MOHAMMED BALEEGH HYDERABAD

With the World Breastfeeding Week underway, a Hyderabad based doctor has highlighted the shortage of breast milk banks in India.

Speaking of breast milk banks, Senior Consultant Neonatology and Pediatrics at KIMS Cuddles, Dr Aparna C said, "Breast milk banking is an upcoming concept wherein a donor mother's breast milk is pumped, pas-teurised and is usually frozen for long-term storage. Whenever a baby is in need of the donor milk, the milk is warmed back to room temperature and given to the baby. It is similar to the process in blood banks. Any mother who has a quantity of milk exceeding her child's requirements and is free of infections such as HIV, Hepatitis B and is non-smok-

er can donate milk." Stressing on the shortage of milk banks in India, Dr Aparna said, there is one milk bank at our hospital which stores 10-12 liters of milk

only purpose is to function via outsourcing to private vendors," Ramesh said on X.

"Not only do these vendors very often have dubious credentials but the NTA itself is headed by a person who presided over the Madhya Pradesh Public Service Commission, which has seen mega-scams," Ramesh said.

In an answer to the Rajya Sabha, the Union MoS for Education revealed that the NTA collected an estimated Rs 3,512.98 crore, while it spent Rs 3,064.77 crore on the conduct of examinations.

# **On the brink of war**

War clouds hover over West Asia as Iran-backed militias attack Israel following the assassination of a Hamas leader

s Iran-backed militias engage in conflict with Israel, a protracted war looms large over West Asia, one of the world's prominent flashpoints. The Israeli-Palestinian Conflict has long been a focal point of West Asian tensions, involving numerous state and non-state actors. Recently, the situation has dramatically escalated following the assassination of a senior Hamas leader, which has ignited a series of violent responses and counter-responses. The international community must intervene to convince the two sides to come to the negotiation table. The United States has expressed support for Israel's right to defend itself while also urging caution to avoid a full-scale war. European nations have echoed these sentiments, calling for an immediate ceasefire and resumption of peace talks. The West must take a definitive stand against the war. On the other hand, Iran has condemned the assassination and justified the militias' responses as legitimate defence against Israeli aggression. Diplomatic efforts are urgently needed to deescalate the situation and prevent further loss of life and destruction. The world must put its act together before it is too late.

Military service comes with 'unlimited liability,' a reality underscored by the valour and ultimate sacrifices of the young soldiers who gave their lives for the country

ecent martyrdom of four Rajesh, Sepoy Brijendra and Sepoy Ajay of the 10th Rashtriya Rifles (Rajput Regiment) are a continuing reminder of the price that a few pay for the entire coun-try. Seemingly service in the Army does not come with a 'Limited Liability' like in a civilian organisation, but with 'Unlimited Liability'. Hardly had the news of Captain Abhimanyu's daredevilry played out in public discourse, earning him the Kirti Chakra, and the news of this Doda operation broke.

Parallels in both cases are significant, even as one was a combat mission, and the other, a rescue mission. The real fire of the Indian Army is not necessarily in its weaponry, training, doctrines, senior leadership etc., but in the proverbial 'junior leadership' of its Young Officers and of Junior Commissioned Officers (JCOs) who ensure that the institution's youthful iron is tempered into steel. Both Capt. Thapa and Capt. Abhimanyu was from that 'junior leadership' fount, one a combatant and the other a doctor, but warriors in their ways. Both had heeded that unsaid call of military leadership to 'lead from the front'. Officers of other militaries tend to lead relatively more entitled and safer lives, which manifests in the Indian Army having the highest 'Officer-to-Soldier fatality ratio.

This young leadership does not take the backseat of 'ordering' but walks first in harm's way, as this is what Capt. Thapa did, as did Capt. Abhimanyu, who answered his conscience to attempt to save his comrade-in-arms from a fire incident. Such stories are the norm in the Indian Army, but not so, in other militaries of the world. Interestingly, both belong to what is proudly called the 'Military Families,' an age-old concept that has survived the cissitudes and institutional

Families' uphold the timeless promise of righteous defence that is passed down through generations. While this solemn tradition of sacrifice is recognised and valorised in the USA, sadly, not so in our Indian context. It is almost unknown and unrecognised. This is particularly surprising because India too has a culture of similar 'Military Families' that dot the mofussil hinterlands. Initially a legacy of the British 'martial caste' regimentation, it is no longer the reserve of any specific societal group, anymore. The rarefied air within these 'Military Families' still resonates with much-forgotten

values like honour, valour, sacrifice, tradition et al, despite many far more compelling reasons to walk a safer and more financially-materially gratifying path. Both Capt. Brijesh Thapa and Capt. Abhimanyu was professionally qualified (the former got through engineering, and the latter, both engineering and medicine) to venture into the lucrative civilian world - vet.

He appeared to be in a state of imbalance Patanjali Yoga Sutras have identified the following as root causes of miseries in life-Avidya, Asmita, Raga, Dwesha and Abhinivesha.1) Avidya—This is nothing but a lack of knowledge or ignorance.

Everything around us keeps changing constantly. It could be our cells, blood, stomach linings, and hair to name some. But we are oblivious to the change. 2) Asmita-This is our intellect and our self. We get stubbornly stuck to our opinions. The caller was fixated on the idea that he was the child of Lord Krishna and stayed put at Tirumala. Yet he was partaking in drugs. 3) Raga-This is nothing but craving. Normally craving arises out of certain pleasurable experiences of the past.

It has a deep imprint on the mind. But such impressions only aggravate our wants and misery. 4) Dwesha—Is nothing but hatred. Hatred is antithetical to craving. Though it arises out of craving, the premise is an unpleasant experience. This could be because of certain trag-



ic moments in the past or unrealistic expectations which do not materialise.5) Abhivivesha-This is fear of the unknown. An emotion that affects all of us. Only a clairvoyant sage through penance and austerity overcomes this barrier. The caller proclaiming to be the son of Lord Krishna was in obvious pain and agony. He could experience ecstasy only through scientific help that is, consulting a psychiatrist, taking proper medication and a wellness programme.

The troubled individual's mind could have undergone say the Happiness Programme of the Art of Living or Vipassana to combat fear. But he remained an escapist by not attending either. Around the world, over-tourism is emerging as a big problem. The overwhelming influx of tourists causes significant hardships for local residents and destinations



he growing problem of overtourism across the globe!Archna DattaRecently, tourism thousands of residents of Barcelona in Spain, protested against tourism, urging tourists to 'go home', waving placards and squirting water guns at outdoor diners, averring that tourists increased prices and put pressure on public services in Spain's most visited city. Not, only Barcelona alone, Venice also introduced a five euro entrance fee to dissuade day-trippers from crowding into the city's limited space and public resources.

Japan, too, has put up a giant screen to block views of Mount Fuii to discourage tourists from gatherings at the iconic spot. Closer home, in Chikamaguluru, Karnataka, police resorted to a special drive at tourist destinations to curb the unruly behaviour of visiting tourists.Now, people have been travelling for centuries, and have traditionally been welcomed to visit countries. While, in India, the spirit of 'atithi devo bhava', treating guests as Gods, prevailed. Over the years, travel as tourism, has turned into one of the most important economic sectors. The ease in global air connectivity and people's increasing craze for exotic visits, adventure and leisure in the internet-connected world, created an unprecedented rise ACCOMMODATION in the number of tourists, which, eventually, evoked a 'tourist phobia', an aversion and social rejection among the locals, as happened in Spain, and elsewhere. In 2019, when, 1.5 billion international tourist arrivals were recorded, a hike of 4% from the previous year, the World Tourism Organisation (WTO) called for managing such a growth of tourists responsibly to best seize the opportunities that tourism can generate for com-

munities around the world'. While, tourism has been described as 'the excessive growth of visitors in areas where residents suffer negative consequences such as permanent changes to their lifestyles, denial of access to civic amenities and damages in their general well-being' (Milano et al., 2019). relationships and induces changes in residents' attitudes towards tourism' (Gössling et al., 2020). Over tourism, also makes urban ife 'more tense and stressful' and

"In the quarter, we have seen good traction from our international operations. This was spearheaded by the offtake of our indigenously designed AGM (Absorbed Glass Mat) batteries We are betting big on growing this space in the coming months," Harshavardhana Gourineni, Executive Director, Automotive & Industrial Batteries said.



## Zomato collected Rs 83 cr in platform fee from customers

ood delivery aggregator Zomato, which began charging platform fee on orders from last August, collected Rs 83 Crore through the new levy till March, the company's annual report has revealed. Platform fee has been cited as one of the three key factors driving Zomato's Adjusted Revenue, which grew 27 per cent year-on-year to Rs 7,792 crore in FY24. "Adjusted Revenue as a percentage of GOV (gross order value), continued to increase primarily due to increase in restaurant commission take-rates, improvement in ad monetization and introduction of platform fee from Q2FY24 onwards," the report stated. All of these factors more than compensated for the reduction in customer delivery charge per order due to the free delivery benefit available on Gold orders, it added. Interestingly, most late night orders in the last fiscal year came from Delhi NCR, while most breakfast orders came from Bengaluru, Zomato shared in the report.

# **RBI likely to keep interest** rate unchanged at 6.5%

#### PNS MUMBAI

Reserve Bank of India (RBI) is likely to keep the key interest unchanged at 6.5 per cent on Thursday, and wait for more (Thursday) macroeconomic data before taking a call on rate cut in line with expectations, experts said.

The US Federal Reserve has decided to maintain a status quo on its interest rate for now and indicated there could be monetary policy easing in the coming months. Amid persist-ing inflationary pressures, RBI will be closely tracking the US monetary policy trajectory before changing its stance on interest rate, which has remained unchanged since February 2023, experts opined.

The Monetary Policy Committee (MPC) may also refrain from rate cut as economic growth is picking up, notwithstanding the elevated interest rate of 6.5 per cent (repo rate).

## IIHL fails to deposit money as per NCLT order RCAP admin tells tribunal; IIHL denies contempt charge

#### PNS NEW DELHI

The administrator of debt-ridden Reliance Capital (RCAP) has filed an affidavit with NCLT, accusing IIHL of noncompliance as the Hinduja Group firm failed to meet the conditions set by the tribunal in a July 23 order.

However, IIHL later in a statement denied allegations saying there has not been any

contempt of NCLT order.

The administrator, in its affidavit seen, informed NCLT that instead of depositing Rs 2,750 crore in the designated escrow accounts of the

Committee of Creditors (CoC) in India and abroad, IndusInd International Holdings Ltd (IIHL) has deposited the money in its own accounts as well as the promoters' accounts.

In a rebuttal to allegations,



IIHL said, there is neither any default nor any contempt by IIHL to comply with its oblig-

ations as directed by NCLT. The order of NCLT required IIHL to deposit monies in escrow account designated by the CoC and not "operated" or "controlled" by CoC, IIHL said in the statement.

CoC has also not provided any escrow arrangement terms and details till date, it said, adding, this left IIHL with no choice but to deposit monies in its own account.

As per the NCLT order dated July 23, the successful bidder, IIHL, had to comply with certain conditions by July 31, 2024.

These conditions included depositing the initial equity amount of Rs 250 crore in a domestic escrow account designated by CoC and Rs 2,500 crore in an offshore escrow account again designated by the lenders by July 31.

The gallery was alive with over 20 mesmerising pieces from the 'Footpath Series', each telling its own unique story through the delicate art of reverse scratching. This technique, a rare and fascinating approach, revealed intricate details and textures that seemed to leap off the canvas. Anju Poddar, known for her discerning eye and appreciation of fine art, shared her admiration for Rao's work. "I like his colour play and how sure he is in his expressions. So many times, I ask him to design for me. I have a pendant specially made from his art. I might not know everything about him, but I have a couple of his papers. Whenever I have a function or guests coming over. I tell him beforehand, and he delivers something unique with a logo. The portrait of the wife and the two kids is something I really like; Padma looks so regal in the painting. I like his humour and satire. These artworks are lively, cutting-edge. His 'flying Hanuman over Poland' and the way he names his pieces are delightful. 'Old Heroine' is my favourite, it's contemporary and vintage both! The motorbike with glasses, the old heroine-it's a blend of contemporary and vintage.'

What truly set this exhibition apart was the artist's signature touch: the playful addition of cooling glasses to his characters. The artist's ability to blend subtle satire with vibrant colours created a delightful visual feast that left a lasting impression.

Kiran K. Mohan, a writer, curator and advisor at Dhoomimal Gallery, expressed her vision for creating a satirical symphony. "I'm a literature student and studying satire has always been fascinating. Seeing it in paintings

Born in 1960 in Vizianagaram, A. Rajeshwar Rao's journey in art has been profoundly influenced by his father, Paidi Raju, an esteemed artist, poet, sculptor and art guru. Rao's early works captured the essence of life and death. reflecting the raw human experience. Guided by his father's anecdotes and poetry, Rao's work embodies a deep understanding of human pretensions and societal norms. His unique technique, inspired by his mentor Subramaniam's glass painting, led him to develop a distinctive style of reverse painting on acrylic sheets, creating vibrant, three-dimensional images on a twodimensional surface.

Rao explained his creative process: "This technique started in the '90s after I finished college. I felt there should be a change in artwork, not just canvas and paper. Subramaniam Gaaru used to do glass painting, and I loved his work. I started scratching, applying colour, and scratching again, creating layers for a three-dimensional effect. A person gifted me an acrylic sheet, and I increased the thickness, making the colors pop vibrantly. It's interesting how the damage done to the art adds beauty to it."

Among the attendees were artists from Delhi, who came to admire and celebrate this unconventional collection. A personal highlight was the series of portraits depicting the artist's family members, each rendered with a blend of affection and light-hearted humour. These portraits were more than just representations; they were intimate glimpses into the quirky traits and personalities of those closest to the artist, brought to life with a perfect harmony of subtlety and vibrancy.

M. Annapurna, an ardent admirer of Rao since childhood, shared her excitement about curating his art. "Every painting speaks to you and has a coil of surprise. His humour and new approach to every work are fascinating. It's a dream come true to curate his art." From clicking pictures with banners of heroes to the deity series featuring Telangana goddesses, his art reflects a blend of satire and cultural commentary. The centerpiece of this exhibition is a painting of Shiva with ten heads on a bike, symbolising the many avatars of gods. The preview was a demonstration of Rao's keen wit and satirical lens, breathing life into a world where the familiar blends with the fantastical. His reverse painting technique on acrylic sheets adds intriguing perspectives, transforming the ordinary into the extraordinary. Each piece invites viewers to engage deeply, with titles that add new dimensions and sometimes trick the eye. As the evening unfolded, guests were treated to an enlightening conversation with the artist, who shared the inspirations behind his work and the unique creative journey that led to the 'Footpath Series'. The atmosphere was filled with lively discussions and shared laughter, making it not just an art show but a joyous celebration of life, humour and the beauty found in the everyday. It was a night that reminded us all of the power of art to connect, amuse, and inspire. "Satirical Symphony" invited art lovers to explore Rajeswara Rao's humorous and critical world, where each piece offers

a new lens to view society. This solo exhibition was a harmonious fusion of wit, observation, and technique challenging and delighting viewers in equal measure.

#### Monsoon and eye health

Styes, or hordeolums, are another prevalent monsoon-related eye issue. These painful, pus-filled lumps on the eyelid result from bacterial infections of the eyelash follicles or oil glands. While styes often resolve on their own with warm compresses and proper hygiene, persistent or recurrent cases might require antibiotic treatment.

Allergic reactions also escalate during the monsoon as the air becomes laden with pollen, dust mites and mold spores. Allergic conjunctivitis is marked by intense itching, redness and tearing, significantly impacting daily activities. Effective management includes minimizing exposure to allergens and the use of anti-allergy eye drops.

#### **Preventive measures**

The cornerstone of preventing monsoon-related eye diseases lies in maintaining excellent personal hygiene. Regular and thorough hand washing is crucial, as is avoiding touching the eyes with unclean hands. Using a clean towel or handkerchief for the eyes and changing pillowcases frequently can help reduce the risk of infections.

Protective measures include wearing glasses or sunglasses when outdoors to protect the eves from rain and wind-blown contaminants. For those susceptible to allergies, staying indoors during high pollen days and using air purifiers at home can help manage symptoms.

Environmental hygiene, particularly controlling water accumulation around living areas, is vital for reducing the breeding grounds for mosquitoes. Mosquitoes can carry vector-borne diseases like dengue and chikungunva that indirectly affect eye health. Ensuring that water does not stagnate in and around the home is essential.

**Diet and nutrition** Diet plays a critical idants that help fight infections. In addition to vita-mins A and C, Omega-3 fatty acids are essential for maintaining eye health.

#### **Professional care**

Regular eye check-ups are more crucial during the monsoon to promptly address any emerging eye issues. Early detection of any abnormalities can facilitate timey treatment and prevent complications. For contact lens wearers, the monsoon demands extra care in lens hygiene. Ensuring that hands are clean before handling lenses and opting for daily disposable lenses can mitigate infection risks.

The role of healthcare providers is also pivotal in raising awareness about these monsoon-related eye conditions. Educating the public through community health programs about preventive measures and the importance of seeking timely medical advice can go a long way in preventing the spread of infections.

#### **Community health initiatives**

Public health systems have a crucial role in addressing these issues, especially in areas with limited access to healthcare. Mobile eye care units and community health workers can be instrumental in providing education and treatment in remote areas. These programs ensure that communities are informed about eye health risks specific to the monsoon and are equipped with the necessary knowledge to take preventive measures.

Local health authorities can also aid by monitoring water quality and controlling mosquito populations, which can help reduce the spread of vector-borne diseases indirectly affecting eye health. By implementing community-wide drainage and waste management strategies, they can minimise water accumulation and reduce the risk of infections.

Educational campaigns can leverage various media platforms to reach wider audiences, disseminating information on symptoms of common monsoon-related eye diseases, when to seek medical help and how to apply simple preventive measures at home.

#### Conclusion

Understanding the risks, adopting preventive measures, and seeking professional health advice timely can ensure that the season can be enjoyed without health hazards. By fostering a community-wide approach to health education and maintaining personal hygiene, the impact of monsoon-related eye diseases can be significantly mitigated. This proactive approach not only ensures individual health but also contributes to public health safety, making the monsoon a season to enjoy in its full glory without reservations.

## Won't retire until I get Olympic medal: Deepika

She has flattered to deceive for four straight Olympics but multiple World Cup medal winning archer Deepika Kumari has vowed not to quit unless she ends up on podium which she feels could be Los Angeles in four years' time. For Deepika, it has always been a case of not being able to display enough temperament in pressure situa-tion at the grandest stage. "Obviously, I want to play more in the future and will continue

my game," Deepika told PTI in an exclusive interaction at the India House here.

"I really want to win an Olympic

medal, and I won't quit until I achieve that. I'll train harder and come back strongly," added Deepika, who has won every international medal except for an Olympic yellow metal.

"Firstly, I will present myself more strongly. There are many things, like quick shooting, that I need to learn a bit more about, and it's very important to train myself accordingly. "What I learned from the Olympics is that late shooting doesn't work; you have no room to make big mistakes, so you have to control that. I will learn that from here," she said in hindsight.

Deepika, 30, appeared in her fourth consecutive Olympics in



Paris, making a remarkable comeback after becoming a mother for the first time in December 2022, when she gave birth to her daughter.

After topping the national selec-tion trials, Deepika went on to

win an individual gold at the Shanghai World Cup in April. Back at her favorite venue, where she had won multiple World Cup medals, Olympic category, working her way up to the quarterfinals with three tough wins. pressure was evident as she had her worst ranking round ever at

the Games. She qualified for the main draw as the 23rd seed, ranking lower than fellow Indian debutants Ankita Bhakat and Bhajan Kaur. Her score of 658 was notably 36 points below that of Korean top seed and eventual gold medalist Lim Sihyeon. 4 win. She was the weakest link in the

## Salukvadze, only woman to compete at 10 Olympics, says she's retiring. For good this time

fter 10 Olympics and 36 Ayears, Nino Salukvadze says she's finally done. The pistol shooter from

Georgia has been ever-present at the Summer Olympics since Seoul in 1988, when she competed for what was still the Soviet Union. At the 2024 Paris Olympics, she became the first female athlete to compete at the Games 10 times.

In that time, the 55-year-old has seen the Games become bigger and more professionalized and says the competition is tougher than ever.

Salukvadze considered retiring after her first Olympics, after she'd won gold and silver medals as a 19-year-old. She nearly walked away in the in newly independent Georgia. She announced her retirement after the Tokyo Games in 2021. This time, though, she says she

Salukvadze may not be total-ly done with the Olympics yet. She's a coach at her own shooting club back home in Georgia and is a vice president of the

national Olympic committee. Salukvadze's record 10th Olympic appearance was recog-nized by the International Olympic Committee.

"IÓC President Thomas Bach has sent his congratulations to Nino Salukvadze in a letter and we understand that the International Shooting Sport Federation is holding an event to honor this achievement," the IOC told the AP in an emailed statement.

Even after 36 years, nothing quite matches the feeling of winning an Olympic gold medal as a teenager back in 1988.

"When I won at the Olympics and stood on the podium, it was indescribable," she said. Even now, Salukvadze added, "I can evoke these feelings in myself in the same way, feel it just the same.
