## KNSU to establish **Sports University: CM**

In a significant development, Revanth Reddy, who has been actively working on the concept of a 'Young India Sports University,' announced a major partnership with the Korea National Sports University (KNSU).

During a recent visit to South Korea, Revanth engaged in detailed discussions with KNSU's President, Moon Won-Jae, which led to an agreement in principle to establish the university in Hyderabad.

"I also had this deep angst about the gap between potential and performance for a long while now. Along with the Young India Skills University (YISU), I have been working on the concept of a 'Young India Sports University' for

Telangana for a while. On my recent trip to South Korea, I met a top delegation of the KNSU (Korea National Sports University), including its president Moon Won-Jae. We had detailed discussions for a part-nership between KNSU and the proposed YISU, and they have agreed in principle to partner with us in establishing it in Hyderabad," Revanth said.

He also revealed that a 200-acre campus has been secured in Hakimpet, and existing facilities, including the Gachibowli stadium, will be upgraded to Olympicsgrade specifications. This move aims to bridge the gap between potential and performance among Indian youth in sports.

Payal Shankar, who has two loans exceeding Rs 2 lakh each, is also being scrutinised by the authorities who are verifying details of her family.



## All loans of farmers less than Rs 2 lakh waived: Tummala

The government will take steps to extend the scheme to waive farm loans up to Rs 2 lakh to those who deposit the loan amount exceeding Rs 2 lakh in banks as per government orders, Agriculture Minister Tummala Nageshwara Rao

In a statement issued on Saturday, Tummala said that all loans of farmers less than Rs 2 lakh across the state have been waived. So far the government has released Rs 17,933.19 crore to 22,37,848 bank accounts of farmers.

He said the details of farmers are being collected and instructions have been given to agriculture officials to upload on the portal if any loan less than Rs 2 lakh has not been

The Minister said the gov-

Fighters from Sudan's paramilitary group rampaged through a central village, looting and burning and killing at least 85 people, including women and children, authorities and residents said Saturday, the latest atrocity in the country's 18-month devastating conflict.

The paramilitary Rapid Support Forces began attacking Galgani in the central province of Sennar late in July and last week RSF fighters "indiscriminately opened fire on the village's unarmed residents" after they resisted attempts to abduct and sexually assault women and girls, Sudan's Foreign Ministry said in a statement.

There are no reported cases of Monkeypox in India as of now, it said. The situation is being mon-

In view of the World Health health emergency of international concern on August 14, a detailed review of the situa-

tion and the preparedness was taken by Union Health Minister J P Nadda at the meeting with the senior officials of his ministry.

It was decided that as a matter of abundant caution, certain measures such as sensitizing the health units at all airports, seaports and ground crossings; readying the testing laboratories (32); gearing up health facilities for detecting, isolating and managing any case are put in place.

The IMA has called for a 24-hour nationwide withdrawal of non-emergency and OPD services by all the modern medicine doctors of the country irrespective of the sector and place of work, while emergencies and the casualties would function, IMA sources here said.

The withdrawal of services commenced at 6 am on Saturday and ends at 6 am on Sunday, they said.



In the end, they gave Rs 17,000 crore for waiving farm loans benefiting only 22 lakh people, KTR pointed out.

KTR declared that the entire loan waiver process is a sham. The BRS will gather detailed information on loan waivers at the village level which will then be submitted to collectors and subsequently to the state government. If the government fails to address farmers' concerns state-wide protests

will commence in two days, he warned. e vowed to pressure the government to ensure that the loans of all farmers are waived. The BRS will start collecting data from the Chief Minister's constituency and then from all other constituencies. If justice is not served, the party will launch direct action,

The BRS call centre has received approximately 1.2 lakh complaints regarding loan waiver. He said that a pro forma will be prepared to collect information, with local MLAs, former MLAs and senior leaders overseeing the process. BRS activists will visit all rural households to collect data directly, he said.

KTR said that loan waiver has not reached at least 40% of farmers who are now in deep distress. He accused the Congress of engaging in attention-diversion tactics to deflect public attention from the failure of the loan waiver

While the Chief Minister claims that 100% of loans have been waived, the government's move to establish special counters for those who did not get their loans waived exposes the administration's doublespeak.

During his first round of questioning on Friday, the former principal was asked about his first reaction after getting the news of the doctor's death whom he instructed to inform the family and how and who contacted the police. Meanwhile, doctors in Delhi, Uttar Pradesh, West

Bengal, Assam, Gujarat, Maharashtra, Karnataka, Ќerala, Chhattisgarh, Bihar, Rajasthan, Jharkhand, Mizoram, and Nagaland among other states joined the 24-hour strike called by the IMA.In the national capital, major private hospitals shut down their OPDs, elective surgeries and IPD services. Resident doctors in the capital have been on an indefinite strike since Monday. As the strike entered its sixth day on Saturday, private hospitals also joined the protest

The Governor's sanction is expected to pave the way for investigating agencies to initiate a probe into the allegations against the Chief Minister. In the MUDA 'scam', it is alleged that compensatory sites were allotted to Siddaramaiah's wife Parvathi in an upmarket area in Mysuru, which had higher property value as compared to the location of her land which had been "acquired" by the MUDA. The MUDA had allotted plots to Parvathi under a 50:50 ratio scheme in lieu of 3.16 acres of her land, where MUDA developed a residential layout.

Under the controversial scheme, MUDA allotted 50 per cent of developed land to the land losers in lieu of undeveloped land acquired from them for forming residential layouts. Opposition and some activists have also claimed that Parvathi had no legal title over 3.16 acres of land. BJP leaders have claimed that the MUDA 'scam' is of the magnitude of Rs 4,000 crore to Rs 5,000 crore. Shivakumar slammed the Governor's move as 'unconstitutional' and 'undemocratic', and asserted that the entire party and the government solidly stood behind Siddaramaiah as he categorically dismissed BJP's demand for Chief Minister's resignation.

## FOREST RIGHTS ACT: A BEACON OF HOPE OR A VICTIM OF EXPLOITATION?



The Forest Rights Act (FRA) of 2006 was heralded as a transformative piece of legislation designed to recognise and empower forest dwelling communities while promoting sustainable forest management. However, the implementation of FRA has faced significant hurdles, including mismanagement, exploitation, and inadequate scrutiny write BKP SINHA and ARVIND KUMAR JHA



he Forest Rights Act (FRA) of 2006, a landmark legislation in India, was introduced to recognise forest rights (FRs) of the Forest Dwelling Scheduled Tribes (FDST) and Other Traditional Forest Dwellers (OTFD) and empower them aiming at strengthening the conservation regime of forests. It was seen as a beacon of hope ushering in an era of community-led sustainable use of forest resources, conservation of biodiversity, and maintenance of ecological balance, which are essential for the sustenance of FRs. The Act however has faced implementation challenges and is overly involved in debates about the fulfilment of this vision indicated in the preamble.

The FRA outlines fourteen distinct FRs for its target group but its initial implementation focused primarily on just two viz. habitation and self-cultivation. This emphasis led to large-scale encroachments by people claiming that they occupied the forest land before the mandated cutoff date of December 13, 2005. Not very surprisingly, the high volume of cases and the pressure to decide them quickly resulted in many ineligible claims getting recognized as valid. This, in turn, encouraged even more people to make similar claims, hoping that theirs would also be approved. During this time, the claims related to Community Forest Rights (CFRs) were given low priority, except for those involving traditionally collected minor forest produce.

In 2012, significant amendments to the FRA Rules were made and new guidelines issued thereafter. Although these amendments purportedly aimed to streamline implementation, they resulted in of these amendments, allegedly extending beyond the Act's original scope, relaxed the eligibility criteria for claimants, allowing non-deserving individuals and communities to exploit the system. The amended Rule introduces a new right, known as the 'Title' to Community Forest Resources.

It enabled communities with only a few members from the FDST and OTFD to make such claims thus allowing the rural elite and powerful individuals to take advantage of the system marginalizing the genuine target group of FRA. Additionally, the evidentiary value of satellite imagery was lowered, making it more challenging to distinguish between legitimate and fabricated claims. No system was established to scrutinize the approved claims while the Tribal Ministry, GOI repeatedly issued directives to review just the rejected ones. In the existing atmosphere, it was 'practical' to approve claims rather than reject them even when the evidence was weak and essential criteria were not met. At times hundreds of cases were cleared in just one meeting which lacked adequate representation of non-officials and women members, and objections by foresters, even when based on ground reality, were generally labelled as anti-tribal and anti-FRA.

The protection-related duties of forest right holders, gram sabhas, and village-level institutions mentioned under Section 5 of the FRA still await alignment with existing Acts and Rules given the purport of Section 13. Some state tribal departments, as nodal agencies for implementation, have excluded the forest department from village-level management plan committees constituted for community forest resources. Such exclusion precludes inputs from trained foresters and consideration of a landscape-based forest management approach, which is essential for ensuring the longterm sustainability of biodiversity, survival of wide-ranging wildlife,

management systems, influenced by electoral politics, may undermine long-term conservation efforts and harm ecological balance. Instances of clear felling and over-exploitation in bamboo coupes, in violation of sustainability principles, have already been observed in some villages.

Encroachments and land-use alteration near watercourses and on slopes pose significant risks. In 1992, the Forest Department attempted to remove encroachments in Mundakai, Wayanad but faced violent resistance resulting in assaults, injuries, and the torching of six vehicles by locals. Over time, emboldened encroachers and developers constructed large resorts on slopes increasing landslide susceptibility. This risk was tragically realized with the recent landslide in Mundakai in

Under FRA also, recognition of claims by ignoring the terrain is an extremely serious issue. In Maharashtra, a 2014 satellite-FRA based study on implementation revealed that out of randomly selected 56,029 claims for cultivation and habitation in Gadchiroli, Gondia, Nandurbar, and Dhule districts: 8.472 and 11,988 sites respectively were within 50 and 100 meters of water bodies or watercourses. Similar claims were found in and the provision of eco-services different districts on slopes that extend beyond village exceeding 20 degrees, Village-centric pockmarked with a total area of documents. The issue reportedly

485 acres, many of which could potentially become the epicentre of additional encroachments and imminent disasters.

To date, 5.18 million acres of forest land scattered over 2.37 million sites have been recognized in the country as individual FRs of cultivation and habitation and the process is still on. The absence of a cut-off date for claim submission, however, makes misuse of the Act easier with time since the verifiability of evidence about 2005 becomes increasingly difficult. It may allow the exploitation of the Act for

political purposes too. An analysis of cases cleared just before elections, for instance, 1,33,920 titles granted to podu cultivators reportedly based on village elders' statements; ramping up of claim clearances in Odisha and Andhra Pradesh; and current invitations for new claims in Jharkhand should be revealing. A worrying trend, however, has emerged in Madhya Pradesh, with encroachers from other villages and districts targeting forest land in Burhanpur district and nearby areas, often with local politician's support. These actions have sparked violent clashes between the encroachers, local villagers, and forest officials, who are struggling to protect the forests. An examination of randomly selected CFR cases Maharashtra reveals that the 'nature' and 'extent' of FRs are often missing from title

exists in other states as well. Understanding the quantity of forest produce (as a forest right) is crucial for the sustainable management of community forest resources and the long-term continuance of the exercise of rights. Accurate quantification can prevent issues such as the dwindling supply of medicinal plants for Ayurvedic industry, which has led to the use of substandard materials and tarnished the reputation of Ayurveda. Unregulated removals could lead to future disputes over forest produce among neighbouring villages which would simply be disastrous.

The process adopted for recognizing Rights over Community Forest Resources (RCFR) raises significant concerns. According to Section 3(1)(i), RCFR of management is admissible only for communities of FDSTs and OTFDs who have traditionally protected and conserved these resources for sustainable use. Further, section 4(3) of the Act mandates that these communities must have occupied the forest land before the cutoff date of December 13, 2005. However, in practice, management rights under Section 3(1)(i) have been liberally granted, ignoring the mandated criteria, on more than 13.5 million acres out of the country's total recorded forest area of 191.5 million acres. The

due to the absence of a deadline submissions, revisit the rules claim Surprisingly, **RCFRs** management have been granted on thousands of acres in the core areas of Tiger Reserves and Protected Areas in Achanakmar, Udanti Sitanadi, Dhamtari, Navegaon Nagzira, and Tansa without fulfilling the required criteria. Apart from the illegalities involved in RCFR cases, the overall situation indicates that the concerned District Level Committees have unauthorizedly transferred the State's responsibility mentioned in Article 51A of the Constitution.

In the past, forests were vast and tribal populations were small and cohesive with minimal influence from market forces. They existed harmoniously. Today, we face a crisis of fractured village populations and fragmented forests. The traditional arrangements that once worked may no longer be effective. Any harm to forest conservation and management has far-reaching consequences and Nature responds to it in compounded ways, leading to unpredictable weather patterns, desertification, global warming, and ecological crises.


These environmental changes exacerbate climate change, creating a vicious cycle that further threatens sustainability and health of our forests and communities. It is trend continues unabated also crucial to set a deadline for claim

submission. under the FRA, and swiftly correct its implementation to benefit genuine beneficiaries. Cancelling irregularly granted rights, removing encroachments, and relocating FR holders from high-risk areas will establish confidence in the administration among the voiceless target group of the FRA.

The Supreme Court must prioritize the hearing of writ petition 109/2008, duly because their earlier order to evict encroachers was stayed on February 28, 2019, due to the Tribal Affairs Ministry's submission that due processes were not followed in implementing the FRA. The ministry had also highlighted that the process of settling the claims and rights of the applicants left much to be desired.

At this critical juncture, the choices we make will shape the destiny of India's forests, its people including forestdependent communities, and its ecology and economy. The question remains: Will the FRA fulfil its promise of empowering legitimate forest right holders while safeguarding India's ecological wealth, or will it succumb to exploitation and misuse? Only time, and our commitment to a sustainabilityoriented implementation of the Act, will tell.

#### **Raj Govt receives investment** proposals of Rs 5.21 lakh cr

he Rajasthan government has received investment proposals worth over Rs 5.21 lakh crore (over USD 62 billion) within two weeks of the announcement of dates for the 'Rising Rajasthan' Investment Summit 2024. According to an official statement, the Bureau of Investment Promotion (BIP), which is the nodal department for the investment summit, has received proposals from some of the biggest names in the Indian and global corporate sector. These projects have the potential to generate about 1.55 lakh direct employment opportunities. The received investment proposals (worth Rs 5.21 lakh crore) amount to over 33 per cent of Rajasthan's present economy (GSDP) which is estimated to be INR 15.28 lakh crore (at current prices) in



#### **CBIC to GST: Consult board** on law interpretation

he CBIC has asked GST officers conducting audit to refer to the board those cases where they face issues of conflicting interpretation of provisions of the tax law. In an instruction to field offices, the Central Board of Indirect Taxes and Customs (CBIC) said during the process of audit, a CGST Audit Principal Commissioner may come across a scenario where a taxpayer has followed a prevalent trade practice based on particular interpretation of Goods and Services Tax (GST) law and more than one such interpretation of the law could result in litigation. "In such cases, it is desirable that the zonal (Pr.) Chief Commissioner make a self-contained reference to the relevant policy wing of the Board i.e. the GST Policy or TRU (Tax research Unit)," the CBIC said, adding that the Commissioner would make the reference before conclusion of the audit and before issuing show cause notice to promote uniformity and avoid litigation.



#### **Maruti to raise deferred tax** liability provision by Rs 850 cr

aruti Suzuki India on Saturday said it would need to increase provision for deferred tax liability by around Rs 850 crore due to the withdrawal of indexation benefit while calculating long-term capital gains on debt mutual funds. The company was making accounting provisions for deferred tax liability on fair value gains on these investments, Maruti Suzuki India said in a regulatory filing. A one-time impact on profit after tax will be felt in the second quarter of the ongoing fiscal, it added. In the Finance (No.2) Act 2024, the indexation benefit has been withdrawn while calculating long term capital gains on debt mutual funds which were purchased prior to April 1, 2023, it added.

"Due to withdrawal of indexation benefit and change in rate of tax from 20 per cent plus surcharge and cess (with indexation) to 12.5 per cent plus surcharge and cess (without indexation), accounting provision for deferred tax liability so created needs to be restated," the automaker

'India needs to create 148 mn additional jobs

India has been a laggard among G20 nations in terms of employment generation and the country needs to create an additional 148 million jobs by 2030 given the population growth, Gita Gopinath

said on Saturday.

India on an average grew at 6.6 per cent for the decade starting 2010 but the employment rate was under 2 per cent, she said at the Delhi School of Economics Diamond Jubilee event here.

So, India's employment rate is much less when compared

to other G20 nations, she

"If you look at India's projections in terms of population growth, India will have to create anywhere between 60 million to 148 million additional jobs cumulatively between now and 2030... we are already in 2024, so in a short period of time we have

to create a lot of jobs," she said.
Given the scale of what is needed, it is going to require basic reforms including land reforms and implementation of labour codes.

To generate more jobs, she said, there is a need for an increase in private investment as it is not commensurate with 7 per cent growth in GDP. However, she said, public investment is going well but private investment has to

She also said that India should revamp its education system so that it can improve the skill set of its workforce.

Besides, she said, there is a need to further ease of doing business, improve the regulatory environment and broaden the tax base.

#### Unilateral measures hamper equitable world trade: Commerce Secy

India on Saturday said that unilateral environmental measures such as the European Union's (EU) carbon tax do not reflect the principles of equity and hamper equitable world trade. Commerce Secretary Sunil

Barthwal said that the Global South countries are facing challenges both in terms of developing climate and sustainable development strategies and responding to unilateral measures such as CBAM (carbon border adjustment mechanism).

"Unilateral environment measures do not reflect the principles of equity and common but differentiated responsibilities; and hamper equitable world trade," he said in a virtual address at the third Voice of Global South

India has on different platforms raised its concerns over the EU's decision to impose carbon tax on certain sectors as it would hurt the country's exports. The country is in discussions with the EU on the subject.

The EU has decided to impose a CBAM, or carbon tax, which will come into effect from January 1, 2026. Initially, it would be imposed on seven carbon-intensive sectors, including steel, cement, fertiliser, aluminium and hydrocarbon prod-

According to the think tank GTRI, the EU-CBAM when fully implemented will result in a 20-35 per cent import tax on Indian firms and the domestic industry will have to share all plant and production details with the

The Global South countries include both developing and least developed nations (LDCs).

The secretary also said that these countries need to increase cooperation in areas of food security and global value chains; address challenges faced by MSMEs and also the challenges posed by the current international trading system.

## Sebi proposes expansion of sustainable fin framework

Markets regulator Sebi has proposed expansion of the sustainable finance framework in the securities market by introducing a new category of financial instruments.

This category will include Social Bonds, Sustainable Bonds, and Sustainabilitylinked Bonds in addition to the current green debt securities. It aims to provide issuers with flexibility in raising funds for projects that align with environmental, social, and governance (ESG) objectives.

In a consultation paper released on Friday, Sebi proposed that issuers, in addition to existing green debt securities, be allowed to raise funds through issuance of social bonds, sustainable bonds, and sustainability-linked bonds. These bonds will collectively be known as ESG Debt Securities.

This will enable issuers to raise money for more sustainable projects, assisting in closing the funding gap for the Sustainable Development Goals.

Sebi said it received representations

Confederation of Indian Industry to expand the scope of the regulatory framework pertaining to sustainable finance to include Social Bonds, in addition to existing Green Debt Securities as a mode of raising sustainable finance, in line with global practices.

As per the consultation paper, Sebi said, "proposed to introduce the concept of Sustainable Securitised Debt Instruments for the purpose of providing originators of the underlying credit facilities which are within such international or domestic frameworks for sustainable finance, and thereby provide investors as well an opportunity to participate in the sustainable securitised debt instruments".

The consultation paper also addressed the initial and continuous disclosures for sustainable securitised debt instruments that would be based on international frameworks.

Initial disclosures could be made in the offer document for the securities, while continuous disclosures might be included in annual reports or other mandated formats.

that issuers of ESG debt securities and sustainable securitised debt instruments appoint an independent external reviewer or certifier, to facilitate transparency and credibility. The review could take various forms

#### Windfall tax on crude petroleum reduced to Rs 2,100/tonne

The government has slashed windfall tax on domestically produced crude oil to Rs 2,100 per tonne, from Rs 4,600 per tonne with effect from Saturday.

The tax is levied in the form of Special Additional Excise Duty (SAED).

The SAED on the export of

diesel, petrol and jet fuel or ATF, has been retained at 'nil'. The new rates are effective from August 17, an official

notification said. India first imposed windfall profit taxes on July 1, 2022, joining a host of nations that tax supernormal profits of energy companies.

The tax rates are reviewed every fortnight based on average oil prices in the previous two weeks,

#### **Govt to empanel AI infra providers** under Rs 10,372-cr India Al mission

The government has invited bids for the empanelment of entities for providing artificial intelligence services on cloud under the Rs 10,372-crore India AI mission, which was approved by the cabinet in March this year. The empaneled agencies,

like data centers and cloud service providers, will have to provide access to high-speed computing AI infrastructure like graphics processing unit (GPUs), accelerators, Tensor Processing Units (TPUs), storage etc to academia, startups, researchers, government bodies among others at the lowest rate that will be discovered

through the bidding process. Under the IndiaAI Mission, supercomputing capacity, comprising over 10,000 GPUs, will be made available to various stakeholders for creating an AI ecosystem.

"With an objective to



empanel service providers for making this possible, IndiaAI - an IBD under Digital India Corporation, MeitY has issued a RFE (request for empanelment)," Meity, Additional Secretary Abhishek Singh said in a social media post.

## 'Majority blue-collar jobs pay less than Rs 20k per month'

Majority of blue-collar jobs in India pay within the salary range of Rs 20,000 or less per month, suggesting that a substantial portion of the workforce is grappling with financial strain, struggling to meet essential needs such as housing, healthcare, and education, a

report has said. Over 57.63 per cent of bluecollar jobs fall within the salary range of Rs 20,000 or less per month, indicating that many workers earn close to the minimum wage, tech-enabled blue collar recruitment platform

WorkIndia said in a report. In addition, the report

cent of blue-collar jobs are in the moderate earning bracket, with salaries ranging from Rs 20,000-40,000 per month.

Workers falling under this category, experience marginally improved financial security but are far from achieving a comfortable standard of living, it said.

The income in this range may cover neces sities but it leaves little room for savings or investments, which highlights the economic vulnerability of a large segment of the





#### **BURMESE BITES:**

## **CELEBRATING** 10 YEARS OF BURMA

n honour of its 10th anniversary, Burma Burma launched 'The Ten-Year Trail' and introduced a special dine-in menu that will be offered until September 30, 2024. So to celebrate this milestone, we were invited to the Burma Burma outlet in Hyderabad. Once I was seated, two different soups were served: Tar La Baw and Sarbuthi. Talking of Tar La Baw, it is a fermented and sun-dried bamboo broth infused with pounded ginger and basil served with red pumpkin and rice vermicelli noodles from the Karen tribe in Kachin, further elevated with a slow-roasted tomato confit. While corn and mushrooms are not a new dish to try, having pumpkins and bamboo broth was certainly a novel experience. But again, being a mushroom person, I couldn't resist but immerse myself in the flavoursome ingredients of sarbuthi. Then I was served the Siman Thoke, a refreshing salad of chickpea tofu and raw papaya with a sour and spicy dressing from Shan. For someone who enjoys spicy food beyond anything else, this seemed a little blunt as I took my first bite. However, the next bite turned out to be a surprise, with the different flavours assorting my tastebuds with their fried

Heading to the next was the Sar-Hype. Woktossed rice noodles, seared mock meat and tofu with tamarind and sawtooth coriander sauce reflecting a complete home-style communal meal that celebrated the flavours of Kachin. This stood as the standout dish for me, beyond a doubt. So basically, the Burma Burma team explained to us how this sauce is used to separate the sticky rice noodles. As I took the first chew, the taste simply bombarded my mouth with its piquancy. Then comes the Highway Meal Parcel, which is a popular food with commuters to Yangon with steamed rice. This was, for a second, an improvised version of the South Indian Thali with a Burmese twist! The concept, as it is named, is that you can pack yourself and just head your way. Inspired

by the sustainable practices of the monasteries of Bago, the Monk's Meal, or Kho Poong with Pebok Chet, featuring bamboo shoot and roselle curry with a spicy fermented soybean relish and rice, were local delicacies that found their place on this celebratory menu. The Burma Burma team, while serving, shared how, just like the monks enjoy their meals being

plain and healthy, without much mirch-masala.

And finally, in the main course, comes the Split

the dish tasted the same.

Gill Mushroom Rice from Kachin, which included foraged split gill mushrooms with rice, flavoured with roasted mushroom extract, garlic and soy, and topped with Burmesepounded tomato. This did not seem to meet my expectations. Coming to the beverages, we were served Mont Let Saung, inspired by the traditional Burmese cooler from the town of Inle, with palm jaggery, coconut milk and toasted coconut shavings, while the Kan Lan Yay combines fresh sugarcane juice with raspberry purée, lime and nori salt. While all three had its own unique flavours depending on their ingredients, Kan Lan Yay, according to me, is a must try and trust me, you'll not be regretful in any way.

A meal without a dessert. Well never! The menu had Burmese Milk Tea Cheesecake, infused with Burmese tea and topped with brown butter streusel, stewed roasted apple confit, cinnamon ice cream topped with cinnamon caramel and spiced tea tuile.

I had the opportunity to try the Seasonal Vegetable Baozi, a vegan delight stuffed with finely minced vegetables and the Katsu Chicken Sando with pickled cucumber and coriander. Chicken Yakitori made its

entrance with tender, smoky skewers, each bite enhanced by the subtle zing of a green onion sauce. The flavours were deep, rich and yet so effortlessly satisfying. Then came the Vegetable Kakiage, a crunchy, golden medley of tempura vegetables, perfectly paired with the delicate sweetness of kaeshi sauce. It was a dish that felt both familiar and surprising, with layers of texture and flavour that kept you reaching for more.

But the true star of the night, at least for me, was the *vegetable* harumaki. These spring rolls were a revelation, crispy on the outside with a symphony of fresh, vibrant vegetables inside. The dipping sauce was like a final brushstroke on a masterpiece, elevating the

dish from mere comfort food to an artful delight. And then, just when you thought it couldn't get better, the baby potato teriyaki arrived. Each bite was a melt-in-your-mouth experience, with the sweet, sticky teriyaki glaze hugging the tender potatoes, leaving behind lingering warmth.

The evening also brought a playful twist with the Japanese Purin, where the airy, crisp purin were filled with a delicate egg mixture that added a rich, velvety contrast to the lightness of the dish. To round off the meal, the Mini Matcha Swiss Roll was a perfect finale. Eggless and utterly divine, the roll was soft and spongy, with the earthy matcha providing a subtle, yet profound depth of flavour—a sweet echo of Japan's tea rituals. As the food delighted our palates, the cocktails were no less a spectacle. The Toki Highball opened the show with a crisp and refreshing blend of Toki Suntory whiskey, soda water and grapefruit, each sipping as invigorating as the first breeze of spring. Then came the daring Toki-O Wasabi Sour, where the bold, fiery kick of wasabi danced with the citrusy notes of lemon, all held together by the smooth embrace of Toki Suntory whiskey. 

he movie *Maharaj*, which starred Shalini Pandey with Jaideep Ahlawat, Junaid Khan and Sharvari (in a special appearance), received great acclaim. Making it a worldwide, not just in India, must-watch! Thus, how could we have overlooked the interview featuring the prominent actress from the same movie?

Our very own South fame from *Arjun Reddy* is still being praised for her delicate handling of Netflix's Maharaj narrative. Her

portrayal undoubtedly brought up significant issues, leaving us wondering where it all started. "I worked on this movie about 2.5 years ago. The power it offered was what spurred me on to do it! I thought the narrative seemed so easy when I heard it. On the narrative seemed so easy when I neard II. On the other hand, when you consider it more broadly, it was certain to have an effect. Naturally, the role was challenging, but I must admit that I was touched by the audience's unwavering faith in me. I didn't appear foolish on screen.

Additionally, Junaid Khan had a significant impact on the *Maharaj* sets. The moment he arrived, everything seemed right to her. It was the era they were instructed to shoot and in that, she really wanted to feel like her character, Kishori. For her, the costume, makeup, hair and set were crucial in achieving that! Therefore, she never even undervalues this!

She also recalls working on Jayeshbhai Jordaar and how Aditya Chopra, at the same time, told her that he was working on a project called *Maharaj*. "Okay, so it's clear that I am a YRF tal-

ent. I've always known he's going to try to get me another movie!

But, for that reason, I felt really empowered as soon as I heard the script. Being an YRF talent didn't matter as much as how much I wanted to join the team of *Maharaj* personally since I genuinely wanted to share this narrative with my fan base. I had never danced on

film before!" acknowledges *Mahanati* fame!

She even showed *Mahanaj* that big stars are not necessary for a movie to succeed and she did a great job in the part! "The set was very comfortable, but when I finished one of the significant scenes, it had a troubling impact on me," says *NTR Kathanayakudu* actor. "For a while, I felt traumatised! As I carried out that scene, I was able to comprehend the impact it had on me. In fact, I found myself rooting for the character even more. I did feel for a little while that the situation had turned a little unsettling."

Further in the interview, the actress admits that, more than chal-

lenging, the scenes should feel exciting to her! Apparently, she always goes with a blank slate on the sets to know what could happen to them. She genuinely doesn't believe in over-preparing until and unless she has been told to do action scenes. That's Shalini Pandey for you! she has been told to do action scenes. The script had the line "drag her out," but when I acted it out with the actor who was meant to be my on-screen sister, it had such a powerful effect! My feelings were very apparent and the entire atmosphere was buzzing with activity. The term "dramatic" is appropriate for it!" You will realise how different Shalini is from her real-life character, Kishori, if you know her or have met her. Without making fun of her, she had to have faith in that persona! The actress said that Jaideep and Junaid were quite helpful on the sets. She had a lot of strange parts to perform and the concept was rather uncomfortable, but her other actors were really helpful. She discovered how much of a straightforward man Junaid really is in real life, and now they are incredibly close friends.

Aditya Chopra helped her realise how much of a "naïve beauty" her character is, as Shalini Pandey recalls. "I did the character so nicely because of this little realisation! After it was released online, I received a lot of positive feedback, which touched me. Among all the reactive feedback, which touched me. Among all the reactions, what I found most interesting—though I didn't see this coming—was how my followers responded to the delicate representation."

The topics covered in her movie were nothing new to the actress. She is acutely conscious of gender inequity and exploitation. She continues, describing the statement of the continues of the cont

ing, "In our circle, we talk about these topics a lot. However, it really freaked me out when I was investigating it in prehistoric times! The ability to discuss all of this openly is one of the reasons I feel so fortunate to live in the modern era. Even thinking about the struggles those women had in the past gave me chills. It is depressing to consider it even." It was during the filming of this movie that she discov-

ered her dancing skills too! "Although my body is a little in the way

some of the dance moves, I still felt like I was a really excellent dancer. I'm attempting to convey how certain bodies have a strong inclination towards dance. All I'd done was western dance. My body was therefore resisting some of the traditional moves. Only after intense practices did I start to shift, both in terms of how I presently walk and how I used to walk. My facial expressions also improved greatly, looking much better on screen." By the end of the interview, all she could remember was how unreal it was when she first started working with Yash Raj Films and how every actress in Mumbai dreams of being referred to as the "Yash Raj Heroine!" To her, it was the realisation of a dream. It is nothing less than a dream come true for her to be acting for all the production houses she had heard about as a child. It seems that they take wonderful care of their actresses!

n a world flooded with fleeting images, there are few photographers who capture the essence of life with the depth and intimacy that transforms moments into timeless stories. For this photographer, the camera is not just a tool; it is a bridge to unseen worlds, a voice for the voiceless and a means to illuminate the pro-

Rana Pandey emerges as a visual poet, weaving narratives that go beyond the surface. A documentary and travel photographer of remarkable depth, his portfolio reveals the multifaceted layers of socio-economic realities and the often-over-looked aspects of human life, all captured through a lens that seeks intimacy and truth.

His journey as a photographer is one of relentless curiosity to unearth stories buried beneath the hustle of daily life. His work doesn't just capture images; it captures the essence of lives lived on the margins, often forgotten by the mainstream. Whether it's the resilient spirit of female car-

mainstream. Whether it's the resilient spirit of female carpet weavers in Mirzapur or the quiet dignity of widows in Vrindavan, his photographs tell stories that resonate with raw emotion and a deep sense of empathy.

Rana's work earned global recognition at *PhotoFest*, a prestigious National Geographic-curated festival held in the enchanting town of Mexico. Out of a staggering 13,000 entries from over 195 countries, his photograph stood among the top 25 to his ability to find beauty in the mundane and meaning in the overlooked. The same year his artistry was celeto p 25 to his ability to find beauty in the mundane and meaning in the overlooked. The same year, his artistry was celebrated at the *Kolkata International Photography Festival*, further solidifying his place among the most evocative visual storytellers of his generation.

With a passion ignited by the socio-economic realities often overlooked by society, this visual storyteller dives deep into the shadows where life's most poignant tales reside. "As a visual storyteller, I believe it is my responsibility to shed light on stories that remain hidden in the shadows," he shares.

The journey to these stories, however, is never straightforward. "Approaching subjects can be tricky, especially when covering sensitive issues," he admits. Trust, he believes, is the key. "Spending time with the people before I start shooting is essential. I listen to their stories, share moments of their lives and only then do I bring out the camera."

One such photograph, which earned him recognition at

PhotoFest in Mexico, stands out among the thousands of images that crossed his path. "This photograph is special to me," he reflects, recounting the serendipitous moment on his first trip to Kashmir. "We encountered a unique traffic jam, hundreds of goats and sheep being herded by nomadic shepherds. One shepherd stood out, carrying a newborn goat on his back. I knew I had to capture that moment." That image, now celebrated globally, symbolises not just human compassion but the unexpected beauty found in the rhythms of daily life.

His project *How India Prays*, released at the House of Lords by Cherie Blair, further cements his reputation as a master of bridging the gap between literature and photography. The book captures the spiritual essence of India in a way that transcends mere documentation, offering a glimpse into the soul of a nation.

But perhaps it was his work on the women carpet weavers of Mirzapur that truly transformed him. "Documenting the lives of the women carpet weavers in Mirzapur was a powerful and transformative experience," he recalls. Amid the blistering heat of May, with temperatures soaring to 40 degrees celsius, he navigated from one weaving center to another, capturing the essence of each woman's story. "The resilience and dedication of these women were profoundly inspiring," he says. The project revealed to him the transformative power of traditional crafts, not just as a means of livelihood but as a source of independence and pride for the women who weave

their destinies thread by thread.

His current project, *Torn between the Tiger and the Tide*, delves into the sensitive issue of human-wildlife conflict in the Sundarbans. Balancing the authenticity of the story with its impact is a challenge he approaches with the same reverence and commitment that has defined his career.

His recent exhibition spotlighted the unseen lives of Vrindavan's widows, a project close to his heart. "The project LEST WE FORGET: A SISTERHOOD CALLED WHITE delves into the poignant narratives of widows in Vrindavan," he explains. Living among them, he documented their stories, forming bonds that transcended the lens. A simple gesture from one of the widows, gifting him a shawl for his mother, left a lasting impression on him. "This moment profoundly moved me," he says, "teaching me what living with pride and dignity truly looks like."

Recognition, in the form of awards from the Istanbul Photo Awards and the Russian Press Photo Award, has come as both an honour and a responsibility. "Such recognition motivates me more than it adds pressure," he confesses.

Documentary photography often requires patience, a quality that has paid off in his work. "Patience and timing are









essential in photography," he notes, recalling a moment in Varanasi at the Blue Lassi shop, where he waited for half an hour before capturing a shot that aligned perfectly with his vision. The photograph, titled "Lost Identities," is a testament to the art of waiting for the right moment.

As he looks to the future, the road ahead is filled with pos-

As he looks to the future, the road ahead is filled with possibilities. Themes of human-wildlife conflict and the interplay between humans and nature intrigue him, offering rich storytelling opportunities that align with his passion for cap-

turing the complexities of life. To aspiring photographers, his advice is simple yet profound: "Start local. Focus on photographing and document-ing stories within your own community." Local stories, he believes, hold just as much significance as those from distant lands and provide invaluable insights and opportunities to hone one's craft.

If given the chance to photograph any historical figure, his choice would be Bruce Lee. "Capturing the essence of the man behind the legend would be a profound honour," he muses, reflecting his admiration for Lee's charisma, strength and groundbreaking contributions to martial arts and film. In the age of social media, his advice is clear: "Stop oversat-

urating your photographs." There are many misconceptions about the life of a travel and documentary photographer, and one he is keen to debunk is the notion that they make money on every trip. "Often, the first trip is more about investing time and resources," he explains. The real income, he says, comes after extensive strategising, preparation and execution.

For this photographer, the world is a canvas of endless stories waiting to be told. And with every click of the shutter, he brings us closer to understanding the raw, unfiltered beauty of the human experience.

From jingles to Jai Hoand beyond

During my growing years, my parents were very lenient towards me. I come from a very orthodox south Indian family. My parents hailed from Chennai, but my dad had moved to Mumbai in pursuit of better job opportunities back in the 60s. Although my parents were orthodox in their outlook, they never placed restrictions on us on matters like cutting hair

longer than my hectic or I'd say a fun life, hehehe!

#### **MOM ASPIRED TO MAKE IT BIG AS A SINGER**

My sisters and I were considered gifted by our parents. My mother, who was grounded in Carnatic music, had aspired to make it big as a singer. But she had to give up her dream because of her family and the need to co-work in her own life. My mother was the one to initially sound my father about our being gifted as singers and to push us into pursuing musical training.

#### ART ALWAYS APPRECIATED

Like in most south Indian homes, we were always motivated to take up any of the art forms, be it Bharatanatyam, Kuchipudi, or learning music. We were encouraged to learn any art form, but whether we were also allowed to make a career out of it is somewhat debatable, given the notion *nahi nahi bachchon* ki shaadi nahi hogi, waghera waghera. Still, my parents were very forward-thinking.

#### **YOUNGEST' SINGER OF IYER HOUSE**

I was the youngest among four sisters; so, I was pampered a lot by all of them. I am close to all three of them. My elder sister (Kalpana lyer) of course gained a lot more respect. I never called the others 'Akka' or 'Didi'. My parents were very comfortable with us calling one another by name. So, we are more like friends even today. We fight like crazy even now (laughs) but you know the bonds are strong. My sister Shobha, who is slightly older than me and I had the same group of friends while growing up; so, she knows my deepest and darkest secrets, haha!

#### WINNING COMPETITION AT 10

There was a lot of music in the family and whenever anybody visited us; my mom would ask me to sing. They'd be like 'She must take up music, irrespective of what else they'd want to do! By the time I was 10, I was singing well. My sister Kalpana, she was like 'Now, let's give it a chance'. My second sister and I entered a competition and I won it, while she stood 6th. After that, the seed was kind of sown and the talent was so special to just let it go.

hat had started off as any teen's ascination for a musical career turned nto a consuming passion for Mahalakshmi lyer, thanks to her mother's vicarious pleasure in honing her singing abilities. Today, Mahalakshmi's voice adorns some of the biggest blockbuster hits to which we can never stop grooving. Well, it's not just in Hindi that she has made a mark. She has been an enduring sensation down south with her melodious numbers.

Born into a traditional south India family in which music occupied a pride of place; she had a congenial environment at home, with her mother, Vijaya, being a proficient Carnatic classical singer, and her father Krishnamurthy a veritable classical music aficionado. They say 'Music runs in the family'. And, to cap it all, Mahalakshmi, the youngest of four siblings, came to be the most pampered one with the family's encouragement of her singing career. Beginning with jingles during her college days, she rose steadily by dint of hard work, eventually working with stalwarts like AR Rahman, Pankaj Udhas, SP Balasubramanyam, Hariharan,

Illaiyaraaja and many more. She reached the acme of her singing career with her voice behind the Academy- and Grammy award-winning song Jai Ho from the movie Slumdog Millionaire. Breaking language barriers, she went on to win hearts down south by working with Illaiyraaja, Hariharan, Mani Sharma and MM Keeravani and Nadeem-Shravan, among others. In her conversation with Tejal Sinha of The Pioneer for our special Dil Se segment, the chanteuse takes us through her growing years, her parents' support throughout her rise as a singer, working with virtuosos and more. Interestingly, she prefaced our chat with her soft corner for Hyderabadis, saying: "I have often performed in Hyderabad. The love the audience brings on there has been tremendous, makes me want to come back to the city again and again. It's always fun and I'm always ecstatic to perform for my Hyderabadi

audience in their city."













#### **WE DID NOT KNOW IF WE STOOD A CHANCE**

My dad was insisting that academics should also be taken seriously and completed. I was a commerce student. We did not have any connections in the film industry or the music industry. In those days, with Lataji and Ashaji being at the top of their game, we did not know if we stood a chance. We had heard that it was very difficult for a young artiste to get a chance. So, we kept learning and 'kept hopes alive', as they say.

#### ATTAINING HER B COM GOAL

During my days in college, I started getting some opportunities. A musician informed me that there was this person who does a lot of these advertising jingles and that he'd like to try my voice. I came back and told my parents about this conversation and they were like 'This is the break you are looking for and try'. I got an opportunity, grabbed it, and did a couple of jingles and slowly the word spread around. In due course, I finished my 3rd year B Com as well.

#### **DEBUT THAT TURNED INTO TRIBUTE**

My playback debut involved doing two songs for Dus. The same week Rahman saab called me. I remember three of these people came up to me, and said 'Oh he (AR Rahman) has heard about you and he is keen to work with you'; so, I was very excited and I kept waiting and finally he called and I went and he was like 'There are just 2-3 lines in the song'. I was like 'Never mind'; I was just dying for this opportunity to work with him. He was such a huge name even back then. So, I recorded the songs and unfortunately the director of *Dus* passed away. The album was released a year later as a tribute. A lot of footage was already shot and for the song we erected a 40-foot-high stage at Juhu Beach in Mumbai. We performed the song Suno Gaur Se to promote the album and the song. It was a wonderful debut.

#### A R RAHMAN'S 2:00 AM CALL FOR OSCARS

We (AR Rahman and I) were on a show on a TV Channel where Rahman sir was the judge and the playback singers were given themes to sing and we had to create a new song. After the shoot, at about 2:00 am in the morning, he was like 'I'd want to record this song with you. Would you like to come now? I was like

Yeah sure' and recorded this song at 4:00 in the morning and came back, slept for a few hours and went for the shoot. We recorded the song and apparently Danny Boyle came and absolutely loved it. However, he wanted a few changes, he wanted more male vocals. I had no idea that the song would go global! We don't get those kinds of briefs when going to record a film song. We just know that we what the film is going to be about. I was extremely happy over the fact that a song of mine is in an international film. The film was a huge hit and then the Grammv and the Oscar happened and it feels so surreal. Even today when I go on stage, this is the song that's always requested the most. In fact, the backdrop in all my shows has a huge Jai Ho written on the screen. It is the biggest feather in my cap.

#### RENDERING BACKGROUND **VOCALS FOR PANKAJ UDHAS**

When I was a beginner, I was waiting for opportunities to go and sing in a studio and learn about studio techniques, voice modulation and all. So I'd grab the opportunities that came my way. Slowly there was this word around that there is this young singer who is good and comfortable singing Indian classical, Indian ghazals or slightly light music or even slightly westernised music. Pankajji heard me calling and said I have this album that I am already doing. I had already recorded something for him in another song for a television serial title song so he knew my voice and knew what capability I had. He told me about his album and it was an 8-song album and he wanted the call of a beloved. All the songs in the album had a woman's voice midway going all through the ghazals. I was very happy, imagining eight songs and I had wonderful parts to sing. It was another test for me as a playback singer too.

#### **ENCOUNTER WITH SP** BALASUBRAMANYAM

I had again gone and sung the song for Rahman saab and I did not know who the male counterpart would be. I came back to Mumbai and after a few months, I realised it was SPB sir who had sung the male part in Velli Malarae. I was whooping after I got to know about it. While I was on a US-Canada tour with Rahman saab, there was this man standing there, who was none other than THE SP Balasubramanyam himself. So humble, down-to-earth. As we met, he instantly said 'Hi Mahalakshmi, we finally meet'. I thought he wouldn't know who I was and here, he was addressing me with so much warmth. Then I watched him perform on stage, effortlessly singing a song. It was like he's just woken up from sleep and sang it like so apt and nothing here or there. It was just amazing. Watching SPB sir performing Roja in three different languages at the same time, because we had a crowd of over 40-45 thousand mix so he would intersperse the lines one in Tamil, one in Telugu and one in Hindi effortlessly without any hiccups, everything was so spot on. He was such a wonderful entertainer. I had my best experience with him.

#### AR RAHMAN & SHANKAR-EHSAAN-**LOY'S TREMENDOUS SUPPORT**

Down south AR Rahman plays a very important role and in Mumbai, it is Shankar Ehsaan-Loy. Shankar-Ehsaan- Loy are my buddies. From the first few commercial jingles to the first song featured in a movie, they have had a significant impact on my

professional journey. I have never encountered music composers as prolific as them. I would call A R Rahman saab 'Mr Spontaneous'. He possesses a quick intellect and acts on impulse. He will say to you. "Here is the song, do as you please with it". He allows you total freedom as a singer and the liberty to interpret the song as you please. He is the most open-minded composer I have encountered. He is known as the most innovative composer because he has consistently challenged musical norms throughout his career

#### **FLAIR OF MULTIPLE LANGUAGES**

I've been fortunate and I keep saying this that I love languages and I have a flair for languages. Every language has its own beauty. I'm very fortunate that I've also worked with the stalwarts from the Marathi industry. In Hindi, I have worked with Shankar-Ehsaan-Loy, Vishal-Shekhar, my first Tamil song which was with Hariharan sir was composed by Ilaiyraaja sir. Talking of Tamil, my mother said you shouldn't sing in Tamil because I was born and brought up in Mumbai and our Tamil was not that perfect. At home, we speak English, Hindi and at times Marathi also. Tamil was the language of communication only when I spoke with my mom and dad. With them too, at times it was with a mix of other languages. She was very concerned about me singing in Tamil (giggles) and then I sang a lot for Rahman sir and all of them have been super-duper hits. Itis difficult to say who played a major role but if you talk about recognition it is obviously because I sang for Rahman sir and in Mumbai for Shankar.

#### TRANSITION FROM HINDUSTANI TO CARNATIC

I was initially apprehensive about singing down south. Generally, in those days they wondered if you had the proper diction but by then I had already started singing in the industry with jingles in various south Indian languages which further polished my south Indian diction. I have learnt Hindustani classical and not Carnatic. My exposure to music was initially Hindustani. For me to go down south and get the very typical Carnatic style was a big plus and made my mom very happy. It gave me challenges to work very hard and live up to expectations.
