### Alwal residents around Chinnarayuni Cheruvu get notices

Indicating official intent to raze all illegal structures, be they longstanding or recently built; residents of Alwal village, particularly those living near Chinnarayuni Cheruvu, have been issued notices by the Additional Collector (Local Bodies) of Medchal Malkajgiri District.

The notices demand the removal of alleged encroachments on the expanse of the water body, sparking alarm and widespread concerns among local people, including those who have been living there for more than 30 years.

The notices, distributed over the past 10 days, cite the Telangana Îrrigation Act 1375, and state that the residents' homes are "illegal constructions within the buffer and Full Tank Level (FTL) areas of Chinnarayuni Cheruvu".

Most of the residents, however, dispute these claims.

# Women's rights groups demand justice amidst rising sexual violence

PNS ■ NEW DELHI

As a series of rape cases shock the nation, women's rights groups from across the country on Tuesday sought expeditious investigation and action, and demanded an end to sex crimes and gender-based violence.

The All India Dalit Mahila Adhikar Manch (AIDMAM), All India Democratic Women's Association (AIDWA), All India Mahila Samskritik Sanghatan (AIMSS), All India Women's Progressive Association (AIPWA), Act Now for Harmony and Democracy (ANHAD), All India Feminist Alliance (ALIFA), All India Lawyers'



Association for Justice (AILAJ) are among the 35 organisations who have made the appeal.

The outcry comes in the wake of shocking incidents of sexual violence from various parts of the country including Kolkata, Manipur, Gujarat, Uttarakhand, Bihar, and Uttar Pradesh, with the statement saying they are a

grim reminder of the ongoing threat to women's safety in India.

The immediate catalyst for this voice of protest is the alleged rape and murder of a 31-year-old medical practitioner at the RG Kar Hospital and Medical College in Kolkata. The case has drawn widespread condemnation, not only for the brutality of

the crime but also for the subsequent "cover-up" by the institution and authorities, the statement said, criticising the response of elected representatives and government officials, accusing them of politicising these tragedies rather than ensuring justice.

"We condemn the actions and inactions of the West Bengal government led by Mamata Banerjee for trying to obfuscate the issue as a suicide case and a political conspiracy, 'transferring' Sandip Ghosh, Principal of the RG Kar Hospital as Principal of the Calcutta National Medical College Hospital, and only rescinding the order under great public pressure." the statement said.

# TG aims to become India's Al Capital

Emphasising that Telangana aims to become India's AI capital with plans for an AI City, integrating AI in governance, agriculture, and schools, Minister for Industries and IT, D Sridhar Babu, highlighted the government's goals at the Hyderabad Software Enterprises Association (HYSEA) meet at Marigold Hotel on Tuesday. Hyderabad is getting ready for the Ganesh Chathurthi celebrations, but the fervour has already started at Dhoolpet. This area is famous for the Ganesh idols for the last so many years. Balapur Ganesh idol and other prominent Ganesh ould be supplied from here.

A team of 20 artists led by Dhulpet-based artist Lakshminarayana Singh are shaping the 18-feet tall Balapur Ganesh idol with moving ears and eyes. Lord Ganesh sits on a five-headed snake (Sesha Nagu), and that snake would move on the crown. "For the first time, the

villagers of Balapur installed the idol in front of the gram panchayat office in 1980. Then onwards, the tradition

is continuing there," he added. A 10-feet tall Ganesh idol of Balapur, which was installed for the first time was sold by artist Lakshminarayana of Dhoolpet for Rs 4,400. At present the 18-feet Balapur Ganesh idol costs between Rs 2.20 lakh and Rs 4 lakh.

### AIG removes a complex brain tumor

The neurosurgical team at AIG Hospitals removed a complex brain tumor from a 54year-old female patient using a new approach that doesn't require any cut or opening in the skull of the patient.

It is known as Endoscopic lateral Trans orbital approach. It is a way for neurosurgeons to reach and treat certain brain areas through a small, carefully made path around the eye using a neuro-endoscope.

The 54-year-old female patient had complained of right-sided visual blurring and headaches for the last six months and was treated as viral encephalitis with no improve-

As her condition worsened, she came to AIG and on evaluation it was found that she is suffering from spheno-orbital cavernous meningioma (SOM), a benign tumor that forms in the region where the sphenoid bone (a bone locatbehind the eyes), the eye socket, and the cavernous sinus (a large vein located at the base of the skull) meet, said the release from AIG.

"Upon multiple discussions, we found that the case is appropriate for a new approach where we will be able to do the excision of the brain tumor without leaving any observable mark on the patient's face or skull." Dr Abĥirama Chandra Gabbita, Senior Consultant Neurosurgeon, AIG Hospitals,

# **Farmers' bodies stage protest at Collectorate**

Farmers' associations staged a massive protest in front of the Collectorate here on Tuesday demanding that the State govern-ment implement a Rs 2 lakh crop

loan waiver at one go and without any strings attached to it. Telangana Rytu Sangham and Telangana Rashtra Rytu Sangham led the protest on a massive scale.

Telangana Rashtra Rytu Sangham district secretary Kondaparti Govinda Rao and Telangana Rytu Sangham district secretary Bonthu Rambabu spoke at the meeting held on the occasion.

### Huge tracts of lake lands encroached upon in dists

### Civil society activists demand that lakes be restored to their pristine glory

WARANGAL

Large tracts of land have been encroached upon in several districts, such as undivided Warangal, Karimnagar, Adilabad and Khammam. The officials, however, have turned a blind eye to these murky happenings so far. Now, with the Hyderabad Disaster Response and Assets Monitoring and Protection (HYDRA) demolishing encroachments and reclaiming the land, civil activists demand a similar drive across the State.

Reports showed that the land grabbers did not ever spare the land allotted for Kaleshwaram temple. As much as 36 acres of the total land allotted for the temple in Jayashankar Bhupalally district is reportedly under encroachment. But, the officials have not taken any action so far.

In undivided Warangal, Kakatiya Tank has been grabbed. The land grabbers were able to encroach upon the tank in cahoots with some officials of the Revenue Department and Municipality.

Similarly in Jangaon district, land-grabbing allegations sur-

faced. The District Collector during the previous government even issued notices to the thenruling party politicians. But, it did not seem to have yielded results.

Vaddepalli Bandham Cheruvu encroached upon. Bandham pond water overflows into streets. As per the official land map, Bandham Pond is spread over an area of 30 acres from Reddy Bazaar, Kuravi Gate area of Mahabubabad to Kambala Pond near Salar Thanda. The tank's catchment area has been reduced to half because of encroachments.

A politically influential person reportedly t grabbed part of the land of Bandham Pond. According to sources, he purchased a small bit of land (3 to 5 guntas) and added 30 more guntas of land which is very much part of Bandham Pond. As a result of this, some of the colonies like Reddy Bazar, CPI Colonies, etc suffered flooding during the rainy season.

Warangal City's Welfare Society and Tanks Protection Committee demanded that the Congress government extend the jurisdiction of HYDRA to the districts to reclaim the land encroached upon by influential people.

# CBI seeks polygraph test of Kolkata police ASI

A polygraph test, also a DDT, can help assess inaccuracies in statements of suspects and witnesses. By monitoring their psychological responses -- heart rate, breathing pat-terns, sweating, and blood pressure -- investigators can determine if there are discrepancies in their responses.

However, these are not admissible evidence during the trial and can only be used to get further leads in a case.

### **Step in the right direction**

Modi Govt launches assured pension scheme for Central Govt Employees, amid concerns of financial implications

he Modi Government has announced the fixed pension scheme for the central government employees. This must be music to the ears of central employees who were not happy with the ongoing market-linked pension scheme and were demanding its scrapping, In a significant policy shift, the Indian government has approved a new pension scheme guaranteeing central government employees 50% of their base salary as a pension. This move marks a departure from the current National Pension Scheme (NPS), which links payouts to market returns. The newly introduced Unified Pension Scheme (UPS) is set to be implemented from April 1, 2025, and will impact over two million federal employees. The shift towards the UPS stems from growing dissatisfaction with the NPS, which was adopted in 2004 as part of a broader fiscal reform. Under the NPS, employees contribute 10% of their base salary, and the government adds 14%, with the eventual pension amount depending on the market returns from invest-

The UPS guarantees that employees who have completed at least 25 years of service will receive 50% of their base salary,

calculated over the last 12 months before retirement, as a pension. This assured payout provides a safety for retirees, addressing concerns about the volatility of marketlinked pensions. While the UPS offers greater security for employees, it also imposes a significant financial burden on the government. The expected cost to the exchequer for the fiscal year 2024-25 is approximately Rs 62.5 billion. This annual expenditure is likely to fluctuate based on the number of employees retiring each year. However, the shift to the UPS raises several concerns. First, the financial sustainability of the scheme is a critical issue. The guaranteed nature of the pension could strain government finances, especially if economic growth slows or tax revenues decline. Additionally, the UPS may lead to disparities between central and state government employees. Moreover, there is a risk that the shift back to a defined benefit pension system could set a precedent for other sectors, potentially leading to broader demands for similar guarantees. This could exacerbate fiscal challenges, particularly in a country where social welfare spending is already under pressure. As India prepares to implement the UPS in 2025, careful management and ongoing evaluation will be essential to ensure that the benefits of the scheme are balanced against its fiscal impact.

# The risk of monetising public education



Commercialisation of these institutions undermines their core mission which is to provide inclusive, affordable high-quality education to all

The Vice-Chancellor of JNU , Prof. C Santhishree D Pandit recently remarked that the country's top university is facing a financial crunch with little regular income generated from its resources. The VC has decided to repurpose the university's properties with private participation. This culture of looking at public academic institutions as a source of revenue has been rhyming among our policymakers during the past several years.

One reason is the huge prime land area holding maintained by the public sector institutions and another is the change in the shift in societal perception. Today's society evaluates everything based on money. The primary objective of public sector academic institutions is to offer an inclusive and excellent education to all sections of the population. Central to these institutions is the concept of education as a public good a valuable asset that has advantages for society as a whole, rather than solely for individuals. Education, in this view, is not simply a product that can be purchased and



sold, but rather a profound process that moulds individuals into knowledgeable, reflective members of society who are capable of making meaningful contributions to the collective welfare.

Their value should be assessed based on the number of enlightened minds generated by these institutions. As we can see it's these enlightened minds who are driving the wheel of the government machinery, and the nation's progress. Public sector academic institutions have been under growing pressure in recent decades to implement business-oriented strategies, which include prioritising income creation. The transition has been prompted by several circumstances, such as decreases in government financing, increasing operational

Consequently, numerous public universities and colleges have resorted to alternate sources of research areas that provide income, such as raising tuition fees, extending online programs, providing executive education courses, renting out spaces and forming alliances with private indus-

The great minds working in every field, including the bureaucrats and political leaders are groomed by these public sector institutions. he romance was in the air as India attained freedom from the British yoke. The period was the 1950s as India embarked upon the socialistic pattern to revive the country, which had inherited an impecunious economy. Two bright students from coastal Andhra landed in rain-washed Delhi University to pursue their dreams. To remain connected with their past, they made recurrent trips to the New Delhi Railway Station to receive students arriving in droves from their state and revive those nostalgic moments. When it is repetitively said, "Those good old days!", in one stroke we send a signal to our Universe that the present is not congenial. As Buddha says, "The mind is everything. What you think you become." If we live in the past, we keep fretting and fuming about the missed opportunities and those past impressions create roadblocks in our physical and metaphysical advance-

On completion of their studies, the more aspiring students stayed back and the less enterprising ones returned home. It was a tiger, smacking its lips and intently looking at the potential prey. The monk ran for his life, with the tiger in pursuit. The monk reached a precipice and had a choice to make, either be devoured by the ferocious tiger or jump off the cliff. Death stared in his face. The monk jumped and fortuitously clung onto a branch of a strawberry tree. He ate the strawberry—considering it to be his last meal and thoroughly relished it. The monk had never had such a meal, as was absolutely in the present moment. A simple yet profound technique of sadhana is to be a witness to all the actions and activities that take place. The actor in us becomes the spectator too. This is what is espoused in the esoteric philosophy of Ashtavakra Gita (a classic dialogue between King Janaka—who himself was a Raj Rishi and the sage Ashtavakra).

Any individual, householder or seeker needs to inculcate habits of equanimity, equilibrium, and equipoise to remain calm, whatever the circumstance or situation, to be contented and remain in the present moment. The protagonist who stayed back in Delhi could fulfil his dreams only partially. His son did qualify for the civil services, but could not join the service of his choice; this was due to excessive pressure applied by family members already in theelite services. Eventually, the son turned into an alcoholic. Perhaps it was because both father and son were not grateful to the Universe and did not adhere to the Law of Gratefulness.

Thus, lives were ruined. Meanwhile, the friend who returned home did not lose his way in the sands of time. He became a trade union leader and politician, living in the present. "Life is one big road with lots of signs. So, when you are riding through the ruts, do not complicate your mind. Flee from hate, mischief, and jealousy," sang Bob

Describing the ministersonly meeting as "productive", Balakrishnan said it also sets the stage for an official visit to Singapore by Prime Minister

"We are also working on all this because very shortly, we will be announcing an Official Visit by Prime Minister Modi to Singapore as well. I cannot give you the specific date, but it will occur shortly," he told



reporters here.

Balakrishnan said advanced manufacturing and semiconductors, as well as aviation and maritime connectivity, are new areas that Singapore and India have added to the high-level platform for discussing ways to enhance bilateral cooperation.

Senior ministers from the two countries held a "productive" round of discussions at the second multi-ministerial roundtable here and explored how the two countries can boost bilateral cooperation in digital, skill development, sustainability, healthcare, connectivity and advanced manufac-

### Next round of India-Australia comprehensive trade pact talks soon

GCCs are centralized units established by multinational companies to manage specific business functions or processes, leveraging cost advantages, a skilled work-



force, and favourable business environments in strategic locations worldwide. GCCs play a vital role in driving efficiency and innovation across sectors such as IT, finance, and

research and development. On the other hand, IT products & services encompass development, production, and management of hardware, software, networks, and ser-

tions in the creation, management and optimization of or access to information and business processes.

GCCs are rapidly surpassing the IT sector in the talent market, especially at entry and mid levels. They offer salaries that are, on an average, 12-20 per cent higher than those in IT services and non-tech industries, TeamLease Digital CEO Neeti Sharma said quoting the report. This wage premium underscores the growing influence of GCCs as they attract top talent from the IT sector to fuel their expansion, signalling a shift in market dynamics where GCCs are emerging as the dominant force, she added.

### **Road developers to see slower** revenue growth of 5-7 pc: Crisil

PNS ■ NEW DELHI

Revenue growth of road engineering, procurement and construction (EPC) companies is expected to moderate to 5-7 per cent next fiscal, as lower national highway awarding weighs on their order books, rating agency Crisil said on Tuesday.

That said, the credit profiles of these companies will remain stable, supported by steady operating profitability and strong balance sheet, it added.

Crisil Ratings senior director Manish Gupta said the revenue growth will be impacted this fiscal and the next – after a compound annual growth rate of 13 per cent over the

Ministry of Road Transport and Highways (MoRTH) awarded an average of 12,500 km projects between fiscals 2022 and 2023, but the number dropped to 8,581 km last fiscal and is seen modest at 8,000 km this fiscal. This slowdown is attributed to procedural issues linked to the approval of cost estimates of projects and restrictions under model code of conduct before elections, transition-linked issues as the government explores build-operate-transfer (BOT) toll model for future projects in addition to its currently dominant modes of EPC and the hybrid annuity model (HAM), it said.

# JAW CLENCHING DILEMMA OF BRUXISM

ou may not be aware of it, but bruxism or tooth grinding is more common than you think. This condition often results from stress and anxiety, which are quite visible in worn-out teeth, aching jaws and morning headaches. It affects anyone; despite the fact that adults remain at risk, most commonly those under chronic stress who have unhealthy lifestyles leading or even people with unaligned teeth due to sleep apnea.

For some people, the tension they feel in their temples gives them away as sufferers while for others its partners who complain of the disturbing sound of grinding at night. Whether it is brought about by stress, anxiety or simply disarranged teeth; this condition can result in life-long dental complications like enamel erosion if not treated. However, there is good news since there are various ways through which you can effectively manage this state so that your grin

remains bright and strong.

Stress is one of the main causes of clenching or grinding teeth. While sleeping, there are individuals who unconsciously grind their teeth mostly because of pressure or nervousness.



It is possible for you to cut down on it by using relaxation methods such as meditation, yoga and deep breathing. Incorporating these practices that reduce anxiety into your daily life will reduce overall stress levels and potentially rid you of bruxism.

Stress-related teeth grinding is a particular problem that may be addressed effectively through Cognitive BehaviouralTherapy (CBT). Through CBT it is possible for individuals to identify triggers which cause bruxism and develop healthier coping mechanisms. For instance, if

one is highly anxious then there are strategies which CBT can employ in order to manage this anxiety hence reducing how often and severely one grinds his/her teeth.

For people who clench or grind their teeth during the night dental night guards are often recommended. These devices are tailored to fit an individual person's mouth and act as shields against further wear. While night guards protect your teeth from damage it also relieves symptoms like migraines, jaw pain and tightness in the muscles. A night guard worn during

sleep may help to save teeth from the harmful effects of bruxism. Some cases may require medication for relief of bruxism signs. Jaw muscle tension can be reduced by muscle relaxants while antianxiety drugs are used in order to minimise anxiety that causes clenching jaw joint disorder (bruxism).

Teeth grinding may also be caused by malocclusion or malpositioning teeth so that they do not meet properly when one chews or bites food. This misalignment can create pressure points that lead to grinding. In such cases, dental correction such as orthodontic treatment may be necessary. By realigning the teeth, this will reduce pressure and tension resulting in relief from grinding which would in turn relieve symptoms and stop further damage on their dentition.

There are several lifestyle changes that can be useful in managing teeth grinding. For instance, reducing your caffeine and alcohol consumption (especially before going to bed) can decrease the likelihood of sleep bruxism. Also, avoid habits such as biting on pencils or pens. If you smoke, quitting may help as it increases the chances of bruxism occurrence.

### **SELF-CARE PRACTICES**

Apart from these treatments, there are a few things you can do at home to help manage bruxism. These include:

• Jaw muscles: Stretching the jaw muscles, and exercises can relieve tension in the jaw muscles specifically associated with teeth grinding. Make sure to consult your dentist or physician before trying any specific mouth

• The heat compresses: Soothing warm compress placed on the jaw muscles helps them relax and reduce muscle tensions that trigger teeth grinding.

• Eating considerations: Refrain from hard or chewy foods that put stress on your teeth and also minimize signs of grinding.

Sleep hygiene: Establishing good sleep habits like ensuring sufficient rest, avoiding alcohol and caffeine will help reduce nocturnal bruxism.

• Regular dental checkups: By making regular visits to your dentist, the early stage of bruxism can be detected thus saving further damage to your teeth. Additionally, a dentist can evaluate if your treatment strategies are working or require changes.

There is no cure for tooth grinding, but it can be effectively managed through various therapies. There are numerous ways to treat this condition such as stressreduction techniques, Cognitive Behavioral Therapy (CBT), dental night guards, medications and dentistry correction among others. Nevertheless, it is crucial to work closely with your healthcare provider or dentist who will advise you on the best treatment option for you. Alternatively, self-care practices e.g., jaw exercises; warm compresses; and maintaining good sleep habits could alleviate bruxism effects in one's life.

Indian golfing greats Jeev Milkha Singh and Jyoti Randhawa will be among 64 international players vying for top honours in the inaugural HSBC India Legends Championships to be played at Jaypee Greens course at Greater Noida from August 30 to September 1.
The first Legends Tour

tournament in the country, which will have USD 0.5 million as prize purse, will also see 2005 US Open champion Michael Campbell of New Zealand in action. The winner of the HSBC

India Legends Championship is set to take home USD 74,250, while the runner-up will receive USD 49,000. The third-place finisher will pocket USD 32,700.

The event will be played over 54 holes and it will be preceded by a star-studded Pro-Am event on August 28 and 29, which will see top golfers play alongside amateurs.

amateurs.
The Legends Tour is a professional golf tour for male golfers aged 50 and over, run by the PGA European Tour. It began as European Senior Tour in 1992 and was rechristened as Legends Tour in 2020.

Jeev is the host of the tournament, co-sanctioned by the Professional Golf Tour of India (PGTI). The event will see a participation from 17 countries.

Randhawa qualified after winning the Legends Tour's tough and challenging Qualifying School finals in Turkey.
"Since I am the host, I will

ensure that I don't win the tournament this weekend? the 52-year-old Jeev joked at the press conference to launch the tournament.

"It's great for the country's golfers and for world golf in general. Golfing career is over when you are 40 or 45. But with the Legends Tour, you can have a second innings after reaching 50

"Now, you can play golf as a career till 60."

Randhawa, also 52, said not only the money, a golfer can also maintain the competitive spirit by continuing to play in the Legends Tour.

"It's good for the budding Indian golfers and amateurs. They will now know that a golfer can play another 10 years after retirement," he

"By playing in the Legends Tour, you are keeping your golfing passion and competitive spirit intact as well as keeping yourself fit." Jeev (twice Asia No. 1 in 2006 and 2008) and Randhawa (once Asia No. 1 in 2002) are well-known names around the world with numerous

appearances in Majors too. Jeev has won four times each on the European and Japan Tours, one on the Korean Tour besides six times on the Asian Tour. Randhawa has

won eight times on the Asian Tour and once in Japan. Jeev, who has played all four Majors, was the first Indian to tee up at the Masters at the Augusta National in 2007. He was a former captain of Asia in EurAsia Cup (Europe vs Asia team event). He has five top 10 finishes on the Legends Tour since 2022.

Besides Jeev and Randhawa, there are other seven Indians in the fray. They are Mukesh Kumar, Digvijay Singh, Harmeet Kahlon, Vijay Kumar, all past winners on the Asian Tour, Amandeep Johl, Vishal Singh and Sanjay Kumar.

The 55-year-old Campbell, who has also won 15 other tournaments around the world, said, "I started playing golf when I was 10. My grandmother told me that time when I achieve success, I should remember I have two hands, one for receiving and another for giving back," he said.

"Legends Tour is great in that way. You keep playing after retirement and inspire youngsters to take up the game. We have to give back to the game."

# New Champions League format promises more

 $T^{\text{he new Champions League}}_{\text{format this season will see}}$ more teams playing more games for more prize money. On Thursday, the Union of European Football Associations makes the draw in Monaco for the match schedule of the new singlestandings league phase that replaces the traditional group

stage. The first new Champions League format since 2003 promises more of almost everything that Europe's wealthiest and most influential clubs wanted from UEFA.

There are four more places in a 36-team lineup; at least eight games each instead of six; Champions League games scheduled in January for the first time; a prize money rise of at least 25% to a minimum of 2.5 billion euros (USD 2.8 billion).

There also was more evidence, at UEFA's European Championship this summer, that constant expansion of international competitions is leaving players tired and unable to perform at their best year-round. The new league phase in European club soccer's marquee event will have 144 total games compared to 96 in

the group stage last season. The "key aims," UEFA said, is to "improve competitive balance and sporting interest and in the process increase the number of meaningful matches - matches with something at stake for both sides - throughout the sides - competition."

In the eighth and final round, all



standings which will decide which eight teams advance directly to the pre-quarterfinals - and with what seedings in a tennis-like knockout bracket - as well as which 16 go into a new knockout playoff round in February, and which 12 are eliminated.

"We simulated that qualification should be possible with an average of 7.6 points, which means two victories and two draws," said 36 teams play on the same January UEFA's head of compet 29 evening to finalize the strategy, Stéphane Anselmo. UEFA's head of competitions Why change such a successful competition?

Money, mostly, though that's not the only reason. The Champions League in Europe has for the past 32 years showcased the highest quality play in world soccer. It let UEFA steer billions of euros (dollars) of prize money to clubs that pay the highest transfer fees and salaries.

Still, influential officials at the European Club Association

(ECA) got bored of the group stage, saying it was too repetitive and lacked drama. They wanted more games against stronger opponents that would be more valued by broadcasters, viewers and new fans worldwide. Their leverage over UEFA was potentially launching their breakaway competition.

The road to agreeing on the format was rocky. A controversial first proposal in 2019, favoring storied clubs, was stopped by a

backlash from mid-ranked clubs and domestic leagues. There was intense turmoil sparked

by the failed Super League launch in April 2021 by most of the same club officials who negotiated Champions League reform with

Final format approval came in May 2022 - when Real Madrid, Barcelona and Juventus were exiled from the talks and still pursued UEFA in court - and it was broadly what the rebel Super League clubs had negotiated.

What is the new format?

Out goes the group-stage format played for 21 seasons where 32 teams were put into eight groups of four teams from a seeded draw. The top two in each group advanced to the pre-quarterfinals. Groups gave each team six games from September into December, playing each rival once at home and once away.
In comes a single-standings league

- 36 teams each playing eight games against eight different

opponents through January.
The top eight in the standings go directly to the pre-quarterfinals in March. Teams ranked ninth to 24th go into the knockout playoffs in February. The bottom 12 teams are eliminated.

In the playoffs, teams ranked Nos. 9-16 are seeded in the draw to play second legs at home against unseeded teams Nos. 17-24.

Who gets the four extra places?

Two for countries whose teams collectively had the best record in UEFA club competitions in the previous season. That was Italy and Germany so the fifth-placed teams in Serie A and the Bundesliga qualified: Bologna and Borussia Dortmund.

The fifth-ranked national league (based on five years of results in UEFA club competitions) gets a third direct entry. That is currently France and Brest was third in Ligue 1.

An extra place goes to the qualifying rounds path for national champions from lowerranked countries. They now play for five total qualifying places

instead of four last season.

How will the draw be done?

The 36 teams come out of four seeding pots graded by each team's "UEFA club coefficient" - its ranking by results in five years of European competitions. The topseeded pot contains recent Champions League winners and beaten finalists, plus Leipzig and Barcelona.

When a team's ball is drawn, its slate of eight opponents - two from each seeding pot, one to play at home and one away - will be allocated by a software program and displayed within seconds.

Match dates will be confirmed Saturday, to avoid city clashes with Europa League and Conference League games being drawn Friday in Monaco. Those lower-tier competitions also are a 36-team single-standings Conference League teams play just six games.

**Billion-dollar prize money fund** Winning the Champions League title in 2023 earned Manchester City 135 million euros (USD 151 million) from UEFA. This season's winner can reach 150 million euros (USD 168 million), with total competition revenue boosted by selling 189 total games instead

Commercial strategy is managed by a UEFA-ECA joint venture, and new sponsors for the Champions League include a cryptocurrency trading platform and a betting

Each of the 36 teams gets a basic 18.6 million euros (USD 20.8 million), then 2.1 million euros (USD 2.
