Fighting valiantly, a young captain of the Indian Army sacrificed his life, on the eve of the 78th Independence Day, while leading an ongoing antiterrorist operation aimed at flushing out Pakistani terrorists hiding in the forested belt of Assar in Doda district of Jammu on Wednesday.

The security forces also neutralised a Pakistani terrorist while the hunt was going on to eliminate two to three other terrorists hiding in the area. It is suspected the terrorists may have fled the area leaving behind one M4 rifle, three bags, and a blood trail.

Defence Minister Rajnath Singh on Wednesday morning convened a meeting in New Delhi on the rising terror-related incidents in Jammu and Kashmir ahead of the 78th Independence Day, it was learnt.

Defence Secretary Giridhar Aramane, National Security Advisor (NSA) Ajit Doval, Army chief General Upendra Dwivedi, Director General of military operations-Lieutenant General Pratik Sharma and heads of the securityrelated agencies attended the meeting,

sources said. Tension prevailed in the area as residents woke up to the deafening sounds of heavy gunfire. In view of the the Independence Day events on Thursday, the security arrangements were further stepped up to prevent any other incident of terrorist violence across the region. The security forces have already been kept in a State of high alert for the past few days to maintain tight vigil along the International border and the areas closer to the line of control.

Army's White Knight Corps Wednesday posted on X stating, "One terrorist has been neutralised in the ongoing operation. One AK 47 has been recovered in addition to the M4 rifle." "Intermittent exchange of firing continues as the operations are ongoing," said the Army.

Meanwhile, the army officer who laid down his life has been identified as Captain Deepak Singh.

Doctors seek Justice for Kolkata colleague, Now

On the third day of their strike on Wednesday in protest against rape and murder of their colleague in Kolkatta, junior residents from over 60 Government medical colleges in cities, including Chandigarh, Hyderabad, Jaipur, Rishikesh, Delhi, Brihanmumbai Municipal Corporation, Guwahati, and Bangalore among others across the country demonstrated a united front, expressing their frustration at the tragic incident through various forms of protest — from wearing black bands and holding candlelight marches to shouting slogans, and staging demonstrations.

Their anguish was palpable as they refused to relent until enactment of the Central Protection Act for healthcare workers. In Telangana, Seethakka garu, Minister of Panchayat Raj and Rural Development of the State came forward to show solidarity with doctors across the country. Continued on Page 2

CBI collects evidence from rape and murder scene



Women to take out midnight march in WB

At the stroke of midnight when India will rise up to celebrate her 78th year of Independence, lakhs of women from Bengal will converge at more than 250 places across the State demanding justice for the raped and murdered lady doctor and more importantly safety and security for the fairer sex. The all-women midnight march has been christened "night is ours" a la the popular slogan "Take Back the Night" that rent the air at Philadelphia in 1975 calling upon the women to unite against the ghastly rape and murder of a woman.

A random call on the Facebook by a student of prestigious Presidency University — to "take control of the night" much in line with the midnight march of Philadelphia — seems to have spread like wild fire with Netizens all over the state down to the village offering to participate in the solidarity march at 11.55 pm.

In a startling disclosure, vet-eran legislator P C George said on Wednesday that politicians belonging to the CPI(M)-led LDF and Congress-led UDF own vast farm houses and plantations in the districts of Dindigal, Theni and Ramanathapuram in ernment initiatives aimed at Tamil Nadu which are all irrigated by water drawn from

Mullaperiyar Dam. This is the reason why they dilly-dally over the demand made by scientists to decommission the 130 year-old Surki dam situated in the border district of Idukki in Kerala.

'The experts drawn out from IIT Delhi were shocked over the safety aspects of the Mullaperiyar Dam and that is why they had called for demo-lition taking into account the safety of four million people spread across five districts in Kerala," said George, a seventime MLA and a one-man army who is Kerala's lead whistle blower against corruption.

Reacting to recent statements made by Chief Minister Pinarayi Vijayan and Irrigation Minister Roshy Augustine that the dam was safe, George said that five legislative committees have found out after discus-

sions with experts that the dam was on the verge of bursting out.

This is a surki dam that was built during 1880, the days when there was no cement. The life period of surki is just 50 years and every year the material is washed away by flood waters. You can imagine what would have happened to Mullaperiyar Dam during the last 80 years," said George while referring to the statements made by Vijayan and Augustine. He also said that less one spoke of the duo's

honesty, the better. George said C Achutha Menon, the CPI Chief Minister during 1969-1977 was instrumental in giving away the State's rights over the dam to Tamil Nadu for reasons best known to him only. 'Though the Dewan of Travancore C P Ramaswamy Aiyer got the Tamil Nadu Government stop the production of power from the Mullaperiyar waters, it was Menon who squandered the gains made by the former," said George.

George, a senior BJP leader in Kerala, said the Tamil Nadu Government has the list of all Kerala politicians, bureaucrats and business barons who own plantations and estates in the

State. "If the Kerala politicians go ahead with the move to build a new dam in place of the outdated Mullaperiyar Dam, the Tamil Nadu Government would release their names and that would be the end of the careers of our politicians," said

George. In a move which could send shocks across the political class in Kerala, George said if here is one person who could make an amicable settlement over the Mullaperiyar Dam, it is Prime Minister Narendra Modi.

"He has all the details associated with the dam. Let him call Vijayan and his Tamil Nadu counterpart M K Stalin for a discussion and the duo would find it difficult to say no to what Modi decides," said George.

At stake is the safety of four million residents in the districts of Kottayam, Idukki, Alappuzha, Ernakulam and Pathanamthitta.

"Kerala and Tamil Nadu had identified another site 1300 ft downstream of the existing dam to construct a new dam. But Kerala made a hasty retreat when it was time for action and this is a suspicious move," said George.



In a major reform to curb Lirregularities, Chhattisgarh Excise Commissioner R. Sangeeta on Wednesday launched a biometric attendance system at liquor shops in the state.

She did this virtually at the Mahanadi Mantralaya in Nava Raipur. Officials from all 33 districts were present. All liquor shop employees in the state will



have their attendance recorded using biometrics.

An official communiqué said Chhattisgarh will be the first state to record the attendance of liquor shop employees through biometrics.

SC allows mineral-rich States to claim royalties from 2005 | Modi, Shah recall Partition horrors

Tn a major victory for mineral-rich States, the Supreme Court on Wednesday allowed them to seek dues from April 1, 2005 on royalty and tax on mineral rights and mineralbearing land from the Centre in a staggered period of 12 years.

A nine-judge Constitution bench headed by Chief Justice DY Chandrachud said the argument for prospective effect of July 25 is rejected. Pronouncing the verdict on behalf of the bench, CJI Chandrachud said by a 8:1 majority, this Court had on July 25 answered the questions referred to it and held that legislative power to tax mineral rights vests with States.

He said Justice Nagarathna will not sign Wednesday's verdict as she had given a dissenting view in the July 25 verdict.

Senior advocate Rakesh Dwivedi, appearing for Jharkhand, said there still remains one issue that the State's Act to collect royalty on minerals and mineralbearing land, which was set aside needs to be upheld. "Unless the Act is declared valid, we cannot collect taxes on minerals and mineralbearing land.

Please list it expeditiously before the appropriate bench," Diwvedi, who appeared along with senior advocate Tapesh Kumar Singh for Jharkhand, said.

Dwivedi was referring to the decision of Ranchi bench of the Patna High Court that had struck down Section 89 of Mineral Area

Development Authority Act of 1992 vide its judgment dated March 22, 1993. Section 89 of the Mineral Area Development Authority Act empowered the State Government of then undivided Bihar to levy tax on not only mineral-bearing land but also land used for commercial or industrial purposes.



India's first dengue vaccine enters phase 3 trials

The Indian Council of ▲ Medical Research (ICMR) and Panacea Biotec marked a significant milestone with the launch of the Phase 3 clinical trial for DengiAll, India's first indigenous dengue vaccine from Pandit Bhagwat Dayal Sharma Post Graduate Institute of Medical Sciences (PGIMS) in Rohtak where the first participant in the trial was vaccinated on Wednesday. The Phase 3 trial will involve

18 Territories.

This extensive study aims to evaluate the vaccine's efficacy and will follow participants for two years.

BJP sweeps Panchayat polls in Tripura, wins 97% of seats

The ruling BJP swept the three-tier Panchayat polls Tin Tripura, winning 97 per cent of seats, an official said on Wednesday.

The BJP secured victory uncontested in 71 per cent of the seats in Gram Panchayats, Panchayat Samitis and Żilla Parishads. The voting for the remaining 29 per cent seats was held on August 8 and the counting ended on Tuesday. The party won 584 Gram Panchayats out of 606, 34 of 35 Panchayat Samities and eight out of eight Zilla Parishads, the official said.

The saffron party had won the both Lok Sabha seats in the northeastern state in June. Out of 96 seats contested in eight Zilla Parishads, the BJP won 93 seats, while the Congress and CPI(M) emerged victorious in two and

one seat respectively, State Election Commissioner Asit

Kumar Das said.

In the case of Panchayat Samitis, the state's party won

173 of the total 188 seats where voting was held. The CPI(M) and the Congress bagged six The opposition CPI(M), and eight seats respectively.

Das said that the BJP won 1,476 of the 1,819 Gram Panchayats seats contested. The CPÍ(M), Congress and the Tipra Motha got 148, 151, and 24 seats respectively. The BJP thanked people for reposing faith in the BJP in the

Panchayat elections. The opposition parties, however, said that they could not field candidates in 71 per cent of the seats because of the alleged terror tactics of the ruling party.

Chief Minister Manik Saha said, "The mandate shows the people continue to keep faith in Prime Minister Narendra Modi and his development programmes. The BJP won 97 per cent of the seats with huge margins. There must be an effort to win 100 per cent of seats in the Panchayat polls in

Bhattacharjee said the party's average winning margin stands at 97 per cent.

Kerala landslides: CM announces `6 L compensation to kin of deceased

Kerala Chief Minister Pinarayi Vijayan on Wednesday announced a compensation of Rs six lakh to the next of kin of those who died in the massive landslides that hit Wayanad district recently and claimed

over 200 lives. Vijayan said that of the Rs six lakh, Rs four lakh would come from the State Disaster Relief Fund and the remaining from the Chief Minister's Disaster Relief Fund (CMDRF).

He also announced that Rs 75,000 would be allocated from the CMDRF to those who lost eyes and limbs or suffered disability up to 60 per cent in the landslides. The CM also said that Rs 50,000 financial assistance would be given to those who suffered disability between 40 to 60 per cent or suffered very

serious injuries in the disaster. Besides that, the survivors opting for rented accommodation or living with their relatives will get Rs 6,000 per month towards rent as part of the rehabilitation of the victims, he said.

This amount, however, will not be available to those who get rent-free or fully sponsored accommodation, he added.

cases of partial In sponsorship, the remaining amount will be allowed as monthly rent up to a maximum of Rs 6,000, the CM said at a press conference here. Vijayan also said that so far 231 bodies and 206 body parts have been found, following the massive landslides that hit parts of Wayanad on July 30.

Assembly adopts resolution for grant of statehood to Puducherry

The Puducherry Assembly On Wednesday unanimously adopted a resolution urging the Centre to concede the plea of the union territory for full statehood.

The resolution was first tabled jointly by the DMK legislators R Siva, A M H Nazeem and R Senthilkumar and by independent member G Nehru alias Kuppusamy. The resolution was subsequently adopted as an official resolution on a request by Chief Minister N Rangasamy. Earlier moving the resolution, Siva said Puducherry had been a Union Territory since its freedom from French rule

some seventy years ago. While other Union Territories like Goa have become full-fledged states and have made stupendous progress, Puducherry had been under the rule by the Union Home Ministry since its merger with the Indian Union.

"If Puducherry becomes a state the expectations of the people for fast development in all sectors would be realised in practice," Siva said.

The demand for statehood for Puducherry had been made since 1972 and the Centre's attention had also been drawn to the plea, the resolution said. Despite repeated pleas, the Centre had not formed any committee and had taken the stand that the present status

(of Puducherry being a Union

Territory) would continue. Hence, the Centre should be urged without a break for grant of full-fledged statehood so that the rights of the people would be respected. "The Centre should concede the demand," the resolution stated. The other DMK members Nazeem and Senthilkumar and the independent member Nehru made a convincing case for grant of statehood for Puducherry.

There was also a suggestion that a joint delegation of leaders of all political parties, legislators and Ministers should go to Delhi and persuade the Prime Minister, Home Minister and the Finance Minister to ensure

that Puducherry became a full-fledged state.

After listening to the views of the members and also their 'emotional and spirited' demand for statehood, the Chief Minister pointed out that the private member resolution be treated as an official resolution.

He welcomed the suggestion of the members who had tabled the resolution that a delegation be taken to the Centre to meet the Prime Minister, Home and Finance Ministers to push the demand for statehood. He also said that the cooperation of MPs from different states could also be sought to back the demand of Puducherry for statehood.



Shanti Gogoi has been wait-ing for 20 long years, seek-ing justice for the killing of her daughter-in-law and her unborn child in an ULFAorchestrated bomb blast during the Independence Day celebration in Assam's Dhemaji town. Gogoi's daughter-in-law and 12 other people, including three children, were killed in the explosion that occurred minutes before the flag hoisting ceremony at the parade ground in the northern Assam town in 2004. 

With New Delhi intensifying border controls, the evolving political landscape of Bangladesh is set to influence regional security and diplomacy

he former Prime Minister of Bangladesh, Sheikh Hasina, abruptly left her country a week ago, causing immediate concern in her country and the region. According to the BBC, Hasina's family, not security officials, convinced her to leave due to safety concerns. Her son stated, "We begged her to leave as soon as the violent mob arrived." Crowds entered her residence shortly after her escape. Political, social, and economic issues, external involvement, and unhappy political opposition caused the downfall.

India's Foreign Minister, S. Jaishankar, has informed Parliament about her visit to India and the potential impact on India's relationship with Bangladesh. The unrest that led to her departure resulted in around 560 deaths and could strain the relationship between the two countries, potentially impacting regional security and foreign relations. Initially, in her long reign of 15 years, Hasina was perceived as a democratic and secular leader of Bangladesh, overseeing an economic turn-around. However, she later became intolerant and authoritarian, cracking down on media critand imprisoning ics opponents.She maintained cor-dial relationships with Indian leaders, which sparked anti-India protests

Prime Minister Modi mentioned that he had met her ten times last year. Irunjipuzha river split into two raging streams and wreaked havoc along its path. When it comes to discussing the early warning of rainfall, the less said, the better.

On July 24, the Agricultural Meteorological Division of the Indian Meteorological Department issued a forecast for Wayanad that predicted only 15 mm rainfall, the day when landslides occurred. Mundakkai, where the landslide hit Wayanad first, got 572 mm of rainfall within 48 hours. However, it shouldn't be overlooked that the Hume Centre for Ecology and Wildlife Biology, an NGO specializing in weather patterns of Wayanad with a network of more than 200 weather monitoring units, had warned of possible landslides two days before the landslide happened. THE DIVINE **PARENTAL ROLE**

Unlike parents, whose guidance can be flawed, God encompasses all wisdom, power and impartiality

he following verse will shed light on this, which is, "You alone are my mother; You alone are my father; You alone are my relative and You alone are my friend; You alone are my knowledge and You alone are my wealth; O Lord of all Lords, You alone are my everything." In verse #7.19 of the Bhagavad-Geeta, Lord Krishna states, "After efforts of many births, a yogi in the end becomes wise, and he takes My shel-ter. A great soul, who considers Lord Vasudeva thus as everything is very rare." The answer, therefore, is: that God is very much more than a mother or father can ever be. These entities, i.e., a mother or a father have severe limitations. Their knowledge is very limited. They don't know the Big Picture.

Far from it, they may guide their children wrongly. On the other hand, God is omniscient. He knows past, present and future also. Lord Krishna informs us what He can do. "By being specially kind, I, situated within, destroy the darkness, born of ignorance, by the shining lamp of knowledge." (10.11) Then, a parent has limited resources that he or she can give to his or her children, whereas God has all the opulence in full. Sanjaya of the Mahabharata fame informs, "Where there is yogeshwara Shri Krishna, and where there is a soul linked to Him, there will be opulences ('soubhagya'), victory (success), wealth, and morality." (18.78)A parent can help only in a limited way. Suppose his or her child is unwell. What can he or she do besides arranging medical facilities and taking care of the best way possible?



A good parent prays additionally for the rapid cure of the child. Because Only God has the power to help us get out of the trouble we get into quickly (18.53); only God has the power to forgive. Parents can be whimsical in their decision-making. They can be partial in dealing with their children; it is natural, but God is always impartial. Lord Krishna states, "I am similarly inclined towards all beings, no one is hateful for Me, and no one is dear; that is God has no preconceived and prejudiced notion towards anyone." (9.29) Many parents are poor role models. They lie but expect their children to be truthful.

What has God instructed us to do? "Whatever a superior person does, other people follow that only. Whatever standard he establishes a common man tries to emulated that." (3.21) What does God do? He always goes by dharma. God is so strict about dharma that He incarnates to reestablish it if it becomes weak. (4.7) Additionally, God is always engaged in doing duties, Lord Krishna says, "I am always carefully engaged in action, because men follow My lead in all respects." (3.34)For parents, only their children are their own, but for God, all souls are His parts. (15.7) He has to consider all of them in all His actions. God is very compassionate towards all of them. Lord Krishna confirms, "I am a wellwisher of all living entities." Our children are forever competing against children of other parents, but for God, all children are His parts and must be dealt with fairly. That is the reason our selfish prayers are not answered. Many parents do not consult their children about their future and try to impose their desires on them. God has forbidden this, when He stated, "Svadharma (duty) of all souls are according to what their natures are." "The four divisions of the human society, based on qualities and activities, have been created by Me." (4.21) One can excel in whatever suits one's nature because it comes naturally. What is the message? God is a parent alright but not in a conventional way. He only takes charge of those souls, who take His shelterParents should also try to be self-supporting to the end by taking active shelter from God; He will take care. Water crisis and the battle for resources

As the world grapples with the escalating effects of climate change, the urgent need to rethink our approach to water management becomes ever more pressing

henever we face drought and heat waves we are reminded to take a relook at efficiency of water management. More than onefourth of the global population, nearly 2.2 billion people do not have proper access to clean drinking water. United Nation's (UN's) goal in this regard is to provide clean drinkng water and sanitation for all by 2030. UN's coordination mechanism on water and sanitation (UN-Water) sets the theme every year. This year's theme was "Leveraging Water for Peace".Air and water are important to sustain life on Earth. The conflicts between the countries, between the states and within society arise when we have to share water for crop irrigation, household purposes, industrial uses and power generation.

The conflict gets often aggravated especially when the availability of water becomes scarce during the pinch period. Treaties between the countries have resolved the disputes. Different forums are also available for the resolution of conflicts at international and national levels.India has 25 major river basins with most rivers flowing across the states. There is the Interstate Water Dispute Act, of 1956 for resolving disputes in the use, control and distribution of river and river valleys. The disputes are contin-uing challenges to federal water governance in the country. To resolve the disputes, there are water dispute tribunals in India namely the Ravi and Beas Water Tribunal, Vansandhara water dispute tribunal, Mahadayi Water Dispute Tribunal, Mahanadi water dispute tribunal, Krishna water dispute tribunal and Cauvery dispute tribunal etc.

The sharing of water of the Cauvery River has been the source of serious conflict between Tamil Nadu and Karnataka. In 2018, the tribunal awarded Karnataka to annually release 192 tmc of water in ten equal monthly instalments to Tamil Nadu. 2023-24 was El Nino (Spanish word mean-ing little boy) year and there has been a deficit in rainfall in the catchment of the river from July 2023 onwards. As a result, the reservoirs were half empty and it became difficult for Karnataka to follow the orders of the tribunal.

Two states started a blame game till early July 2024 when there were good rains in the Cauvery catchment in the latter part of July. As nature was kind, the dispute was resolved and the blame game stopped. The prolonged dispute between the states for sharing water is always traced back to destruction as well as poor maintenance of the catchment of the river and unfavourable weather conditions like El Nino.World Meteorological Organization (WMO) announced that El Nino, a climate pattern associated with the warming of the ocean surface in the central and eastern tropical Pacific Ocean has impacted the monsoon causing below-normal rainfall last year, has gradually weakened. This has been one of the five strongest El Nino on record but remained weaker than 1997-98 and 2015-16. "El Nino typically has the greatest impact on global climate in the second year of its development - in this instance 2024," WMO said. This impact has led to above normal temperature in India till June 2024. WMO further added that there is a chance of La Nina (Spanish word meaning little girl) developing later in the year. La Nina is a climate pattern associat-ed with periodic cooling off the ocean sur-

face temperature and brings normal rains in the region. Western World, Canada and the US are experiencing heat wave conditions even in August this year. The underground water table receded during summer. There has been a public hue and cry in many places in central and peninsular India to access potable water for household needs. The Government and Civic agencies are facing the challenge. Karnataka is one such state where there was an acute drinking water problem in the summer.

Chief Minister Siddaramaiah directed the district administration to establish a helpline and control room to enable the public to register grievances and supply water in tankers to all affected areas. He also directed to tender the work of digging more bore wells to tap underground water for public emergencies. Bengaluru too faced a water shortage. Water supply to the city comes through the pipeline from the Cauvery River located 100 km away. The water has also to be pumped up at many intermediate

Often big rivers originate from the same place and flow in different directions. Johila, Narvada and Son originate from Amarkanthak and flow in different directions. Five rivers namely Koyana, Krishna, Venna, Savitri and Gayatri originate from Mahabaleshwar near Pune. Several important rivers like Fungbhadra and Cauvery also orignate from the Western Ghats. Apart from providing drinking water to several villages and towns, there are numerous irrigation and power projects located on these

rivers. Life is fully dependent on these rivers and except the Himalayan Rivers all others originate from forests. Let us be clear that water is not produced by forests, yet the rivers originate there. Forests are the mothers of rivers and are systems to conserve rainwater in the subsoil and the roots of the trees.

The river source provides a small

stream would be perennial in the non-rainy season, or else it would be a seasonal stream flowing on rainy days. Forests play a significant role in conserving water and making the streams perennial. Further, the streams flowing out of forested catchment would always carry cleaner water without even soil particles in it.

On the contrary, streams flowing through areas dominated by human activities would be muddy and mixed with chemicals and sewage. Further, the rainwater carries a lot of soil and the reservoirs get silted up losing their water holding capac-

Reservoirs located closer to forested areas have a longer life. Maintenance engineers have a dif-ficult time in de-silting reservoirs receiving water from human areas. The rainfall pattern and distribution not only depends upon weather conditions and the direction of wind but also depends upon the density and distribution of forests on land. The pledge we must take is to preserve and conserve natural forests. Forests also play a vital role in the maintenance of the water cycle. More than two years ago, on the sidelines of COP 26 at Glasgow, leaders holding 90% of forests on the planet had pledged to end deforestation by 2030. Of course, India did not sign this pledge. Two more COP meetings have taken place since then, but the issue has not been reviewed by those who pledged. On the contrary, there are reports suggesting that natural forests are being lost at an alarming rate unprecedented warming has also taken its toll and forest fires have remained uncontrolled for months in the US, Canada, European countries, Russia, China, Brazil, and Australia. If we don't save our forests, the perennial water streams will become seasonal.

The perils of blind faith and the rise of India's fraudulent godmen

While India has a rich tradition of genuine spiritual leaders, the influence of these charlatans has surged, fueled by politics and societal insecurities

The Mundaka Upanishad warns of the dangers posed by those who, though ignorant, present themselves as wise. The verse (1.2.8) loosely translates to, "Living in the midst of ignorance and considering themselves wise, fools think of themselves as learned. They wander around, bewil-dered, like blind men led by the blind." This verse serves as a caution against self-proclaimed spiritual gurus who mislead others. India has long been a land of genuine spiritual gurus who have guided millions, providing a path for the masses to follow. However, times have changed. Today, genuine spiritual leaders are often overshadowed by flashy godmen, or "babas," who frequently

deceive people for personal gain. This trend has become particularly dangerous when combined with the politics of numbers, creating a powerful politico-religious phenome-non. These so-called babas often become demigods with political leaders as their disciples, wielding immense power and wealth, even though they claim to have renounced it. To curb the influence of fake godmen, a combination of education, awareness, and strong legal frameworks is essential.

Promoting critical thinking and spiritual education can empower individuals to discern genuine spiritual guidance from deception. Educational institutions, community programs, and media can play a crucial role in spreading awareness about

the characteristics of false gurus and the dangers of blind faith. Encouraging open discussions about spirituality and ethics can help people recognise the difference between authentic spiritual leaders and charlatans.

Additionally, it is crucial to strengthen laws and regula-tions to hold fraudulent godmen accountable. Publicising such cases can also serve as a warning to potential victims. Ultimately, by encouraging critical inquiry, supporting victims, and ensuring justice, society can reduce the influence of fake godmen and safeguard the integrity of spiritual practices.

Another case Thai PM dismissed for breach of ethics

court in Thailand on Wednesday removed Prime Minister Srettha Thavisin from office over an ethical violation, further shaking up Thai politics after the court-ordered dissolution of the main opposition party a week ago. The Constitutional Court ruled

on a case involving Srettha's appointment of a Cabinet member who had been imprisoned in connection with an alleged attempt to bribe a court official.

The court voted 5:4 against Srettha and the ruling removed him from office immediately. The Cabinet will remain in place on a caretaker basis until Parliament approves a new prime minister. There is no time limit for Parliament to fill the position. The caretaker Cabinet could also dissolve Parliament and call a new elec-

The acting PM is expected to be Phumtham Wechayachai of the Pheu Thai party.

Phumtham was first deputy prime minister and commerce minister under Srettha

If Parliament is given the task of choosing a new prime minister, it can select from a roster of candidates nominated for the post last year by the major political parties. The Pheu Thai Party, to which Srettha belongs, has two eligible candidates, including Paetongtarn Shinawatra, the daughter of former Prime Minister Thaksin Shinawatra.

Another frontrunner would be Anutin Charnvirakul, head of the Bhumjaithai Party, which ran third in last year's election. He is currently a deputy prime minister and interior minister. Anuthin, a powerbroker in the vote-rich northeast whose family owns a major construction group, has served in both a military-backed government and the civilian one that it replaced. Also in the running would be two former senior military officers: Prayuth Chan-ocha, who served as prime minister for nine years after staging a coup in 2014, and Prawit office.

baht (USD 55,000) in cash in a grocery bag over a case involving Thaksin, the former prime minister.

Pichit resigned from the post weeks after being appointed when controversy over the incident was revived.

The court said that although Pichit has already served his jail term, his behavior — as ruled by the Supreme Court — was

dishonest. Srettha as prime minister has sole responsibility for vetting the qualifications of his Cabinet nominations, the court ruled. It said he knew about Pichit's past but still nominated him, and therefore it ruled that he violated the ethics codes.

The petition against Srettha was initiated by former members of the military-installed Senate who had refused to approve Move Forward's prime ministerial candidate when the party was attempting to form a government after its election victory.

'Weakening military is weakening nation,' says Pak Army chief

 $P^{\mbox{akistan's}}$ Army chief General Asim Munir has said that any attempt to undermine the nation's powerful military is equivalent to weakening the country. Gen Munir's remarks came days after jailed former prime minister Imran Khan refused to apologise for the May 9 riots and said that the Army owed him an apology since he was "abducted" by the paramilitary rangers on the day of the violence.

Khan, 71, was on May 9, 2023, arrested by the Pakistan Rangers from the Islamabad High Court premises during

his appearance in a corruption case. His arrest sparked countrywide protests and riots by Pakistan Tehreeke-Insaf supporters who damaged civilian as well as military installations across the country.

Meanwhile, at least 70 people were injured by aerial firing in different areas of Karachi during the celebrations of Independence Day on Tuesday night, Geo News reported.

Judge rejects Trump's latest demand in hush money case

Donald Trump has lost his lat-est bid for a new judge in his New York hush money criminal case as it heads toward a key ruling and potential sentencing next month.

In a decision posted Wednesday, Judge Juan M Merchan declined to step aside and said Trump's demand was a rehash "rife with inaccuracies and unsubstantiated claims" about the political ties of Merchan's daughter and his ability to judge the historic case fairly and impartially.

It is the third that the judge has rejected such a request from lawyers for the former president and current Republican nominee. All three times, they argued that Merchan, a state court judge in Manhattan, has a conflict of interest because of his daughter's work as a political consultant for prominent Democrats and campaigns. Among them was Vice President Kamala Harris when she sought the 2020 nomination for president. She is now her party's 2024 White House nominee

last year that Merchan could continue on the case, writing that a relative's independent political activities are not "a reasonable basis to question the judge's impartiality".

Merchan has repeatedly said he is certain he will continue to base his rulings "on the evidence and the law, without fear or favour, casting aside undue influence". "With these fundamental principles in mind, this Court now reiterates for the third time, that which should already be clear innuendo and mischaracterisa-

tions do not a conflict create," Merchan wrote in his threepage ruling. "Recusal is therefore not necessary, much less required." But with Harris now Trump's

Democratic opponent in this year's White House election, Trump lawyer Todd Blanche wrote in a letter to the judge last month that the defence's concerns have become "even more concrete".

Prosecutors cast the payout as part of a Trump-driven effort to keep voters from hearing salacious stories about him during his first campaign.

Trump says all the stories were false, the business records were not and the case was a political maneuver meant to damage his current campaign. The prosecutor who brought the charges, Manhattan District Attorney

Alvin Bragg, is a Democrat. Trump has pledged to appeal. Legally, that cannot happen before a defendant is sentenced. In the meantime, his lawyers took other steps to try to derail the case. Besides the recusal request, they have asked Merchan to overturn the verdict and dismiss the case altogether because of the US Supreme Court's July ruling on presiden-

That decision reins in prosecutions of ex-presidents for official acts and restricts prosecutors in pointing to official acts as evidence that a president's unofficial actions were illegal. Trump's lawyers argue that in light of the ruling, jurors in the hush money case should not have heard such evidence as former White House staffers describing how the thenpresident reacted to news coverage of the Daniels deal.

Earlier this month, Merchan set a Sept 16 date to rule on the immunity claim, and Sept 18 for "the imposition of sentence or other proceedings as appropri-

The hush money case is one of four criminal prosecutions brought against Trump last year. One federal case, accusing Trump of illegally hoarding classified documents at his Mar-a-Lago estate in Florida, was dismissed last month. The Justice Department is appealing. The others - federal and Georgia state cases concerning Trump's efforts to overturn his 2020 election loss — are not positioned to go to trial before the November election.

'Americans give Harris an advantage over Trump on honesty, discipline'

rice President Kamala Harris has a perceived advantage over V former President Donald Trump on several leadership qual-ities such as honesty, a new poll from The Associated Press-NORC Center for Public Affairs Research finds, although Americans are slightly more likely to trust Trump on the economy and immigration.

Nearly half of Americans say that "committed to democracy" and "disciplined" are attributes that better describe Harris. About 3 in 10 say these qualities better describe Trump.

About 4 in 10 say Harris is someone who "cares about people like you" while about 3 in 10 say that about Trump. About 4 in 10 say "honest" better describes Harris and 24% say that quality better describes Trump.

Both parties are racing to define Harris as she prepares to accept the Democratic nomination at the party's convention next week. The poll suggests she carries some of the same baggage that weighed down President Joe Biden before he ended his reelection bid but has advantages over Trump when they're compared to each other. And Democrats continue to be much happier about her candidacy than they were about Biden's

Trump has spent the campaign championing himself as a strong leader who is capable of handling tough crises facing the country and suggesting that foreign leaders wouldn't respect Harris in the White House. But he doesn't have an advantage with Americans on that characteristic, according to the survey. Four in 10 US adults see Trump as a strong leader, and roughly the same share say that about Harris. About 4 in 10 say Trump is capable of handling a crisis, and a similar share say Harris is better positioned to do so.

Americans are about evenly divided between who they think is more capable of winning in November — Trump or Harris. In July, before Biden dropped out of the race, only about 2 in 10 Americans thought he was more capable of winning, while about twice as many thought that about Trump.

'Trump had a better chance when Joe Biden was running," said Lisa Miller, a 42-year-old student in Elko, Nevada, and a Republican. "I think a lot of people who were insecure about Joe Biden are more secure with Kamala Harris' age and cognitive abilities.

Trump has advantages on the economy and immigration:

Americans are more likely to trust Trump over Harris when it comes to handling the economy or immigration, but the difference is slight — 45% say Trump is better positioned to handle the economy, while 38% say that about Harris. The difference is similar in handling immigration. Independents are about twice as likely to trust Trump over Harris on economic issues, and they give him the advantage on immigration as well.

Howard Barnes, a 36-year-old artist in San Francisco, is a Republican who says he trusts Trump over Harris on the border.

"She doesn't really seem to be proactive about it or even interested in it," Barnes said.

Harris has more of an advantage over Trump when it comes to handling issues related to race and racial inequality, abortion policy, and health care. Roughly half of US adults say Harris would do a better job than Trump handling each of those issues, compared with about $\overline{3}$ in 10 for Trump. Harris is especially strong among Democrats, independents and women on the issue of abortion policy. Democrats and independents give her the edge on health care, as well as on issues of race and racial inequality. About two-thirds of Black adults say Harris is the candidate they trust more on that issue, as well as about half

of Hispanic adults and white adults. Harris' strengths also accentuate two areas where Republicans give Trump relatively low marks: abortion policy and issues related to race and racial inequality. Only about 6 in 10 Republicans trust Trump over Harris on these issues.

There are possible signs of trouble for Harris in the poll, though. Only about 6 in 10 Democrats trust her over Trump to do a better job handling the war in Gaza, her lowest rating within her party on the issues asked about. About one-quarter of Democrats say they trust neither Trump nor Harris on this topic.

NZ food bank distributes candy made from potentially lethal Methamphetamine

A charity working with home-less people in Auckland, New Zealand unknowingly distributed candies filled with a potentially lethal dose of methamphetamine in its food parcels after the sweets were donated by a member of the pub-

Auckland City Mission told reporters on Wednesday that staff had started to contact up to 400 people to track down parcels that could contain the sweets —

which were solid blocks of methamphetamine enclosed in candy wrappers. New Zealand's police have opened a criminal investigation.

The amount of methamphetamine in each candy was up to 300 times the level someone would usually take and could be lethal, according to the New Zealand Drug Foundation — a drug checking and policy organisation, which first tested

the candies. Ben Birks Ang, a Foundation spokesperson, said disguising

It was explained the map represented the five inhabited continents and that Australia stood in for Oceania. That in itself might have irritated New Zealanders for whom Australia is the most bitter of sporting rivals.

The Parisian omission had a particular sting because New Zealand had just produced its best-ever Olympic performance. Measured on gold medals alone, New Zealand finished ahead of Canada and Spain, nations many times its size.

On a per-capita basis, New Zealand won one gold medal for every 533,890 people or one medal of any color for every 258,000 people. That placed it third on the per-capital medal table behind Dominica and St. Lucia which both won one gold medal. Dominica has a population of about 67,000 and St. Lucia around 184,000.

Of the 20 medals New Zealand won in Paris, 14 - including eight golds - were won by women or women's teams.

In a letter to New Zealanders from Buckingham Palace, British monarch King Charles commended the Kiwi performances.

"From the rugby field to the velodrome, the team ably and successfully demonstrated the grit and spirit of true Olympians - and true Kiwis," the king said. "It has been enormously impressive to see just how extraordinarily successful your athletes have been in securing New Zealand's highest gold medal count at a single Olympics to date and I hope that all of New Zealand shared in my joy at witnessing the wonderful sporting culture of this great nation on the world's stage.

New Zealanders had to wait several days for the first medal, a gold won by the women's sevens rugby team. Hayden Wilde was among the favorites to win the

"I'm just super, super proud of all our work and to be able to bring this medal back to New Zealand," Butcher said on his return to New Zealand on Wednesday. "We're just really, really proud to be part of the New Zealand team and to be part of that success?

The second week brought a flurry of gold medals. Lisa Carrington won three golds in women's sprint kayaking, bringing her tally to eight golds over three Olympics. Alicia Hoskin won two kayaking golds and Ellesse Andrews won two golds in women's sprint track cycling. Hamish Kerr won gold in the men's high jump after his American opponent, Shelby

Lydia Ko won the women's golf gold medal and now has a full set of medals after winning silver in Rio de Janeiro and bronze in Tokyo. Her win also qualified her for the LPGA Hall of Fame - at the age of 27. New Zealand beat its previous

best tally of eight gold medals at the 1984 Los Angeles Olympics at which it finished eighth on the medal table in the Soviet-boycotted Games. It won seven golds and 20 medals at Tokyo in 2021 and 18 medals at Rio de Janeiro in 2016. Many New Zealanders were

bleary-eyed through the Games. New Zealand is 10 hours ahead of Paris which meant many events were held late at night or in the early hours of the morning New Zealand time.

When the Olympics ended The Times newspaper of London posed the question "Who Won The Olympics." It named New Zealand as the over-achiever of the Games

"Athletes from New Zealand logged an impressive haul of 20 medals at Paris 2024, despite having a population of just over 5 million. Their rate of one medal per 258,000 people is the best among nations to win at least four this summer," the Times said. The New Zealand government

ducted themselves both on and off the field of play," New Zealand chef de mission Nigel Avery said. "There has been a huge amount of manaaki (the Maori word for hospitality) from our team towards the other nations and it's been great to see them showcasing our values and culture.
