ndia's Chief Medical Officer at the Paris Olympics, Dr. Dinshaw Pardiwala, on Wednesday revealed that cutting off Vinesh Phogat's hair was among the 'drastic measures' taken to help the wrestler stay within the prescribed weight limit for her gold medal bout in the 50kg category.However, none of it was enough to prevent her disqualification as she was found 100gm overweight at the time of morning weigh-in. She was set to take on USA's Sarah Hildebrandt after three exhausting bouts on Tuesday.

Vinesh had always competed in the 53kg category. This time Antim Panghal qualified in that division and Vinesh had to slash weight to compete in the 50 kg category

For Olympics, Asian Games, World Championships and Asian Championship no wrestler gets even one gram concession. For the Ranking Series and Invitational events, one gets a concession of 2kg which means that in these events, one can be 52 kg on the bout day even if they are contesting in 50kg category. Sadly for Vinesh, Olympic rules are strict.

Vinesh once disqualified from an Olympic qualifying event prior to 2016 Rio Olympics for being over-weight by 400 grams.

Those who qualify for the gold medal, bronze medal play-offs and repechage bouts again have to come for weigh in on

Vinesh had three bouts of six minutes each on the first day. Eighteen minutes of combat sports can drain a wrestler and he/she needs enough amount of hydration and nourishment.

Every wrestler cuts his/her weight to fight in lesser categories. In case of Vinesh, she fought in 53kg mostly with a natural weight of 55 to 56 kg.

Once Vinesh came into 50 kg category, she had to shed at least 6kg before every competition. The sudden weight-cut is an extremely difficult process. After first day, she gained around 1.5 kg after replenishment.

Quota within quota: Litigation on reservations

Reservations, called 'quota', in education and employment opportunities in the Government have been there since 1950. It was originally meant to be implemented for 10 years. It ought to have been closed after a decade. But it has been extended continually, the last one being in 2020.

In Andhra Pradesh and Punjab, the Scheduled Castes were classified as A, B, C, and D. The journey of such categorization was questioned before the judiciary. Finally, the Supreme Court accepted it on 1 August 2024.

Article 16(4) covers all backward classes, including the Scheduled Castes and the Scheduled Tribes. The expression used in Article 16(4) is "any backward class of citizens". The expression "not adequate-ly represented" covers all socially and educationally

backward classes, who, on account of their backwardness, are inadequately represented in the State's services. The scope of Article 16(4) is wider in its ambit than that of Article 15(4). The expression "backward class of citizens' used in Article 16(4) covers in its ambit the Scheduled Castes and the Scheduled Tribes as well as other backward classes, including the socially and educationally backward ones. The preferential treatment is a facet of equality under Article 14. The constitutional validity

of Section 4(5) of the Punjab Act depends upon whether any such classification can be made within the class of the Scheduled Castes or the Scheduled Tribes or is to be Scheduled Tribes or is to be treated as a homogenous class. Whether it is not permissible to provide any further reservation to the weakest out of the weak, particularly when it has not been possible to trickle

down the benefit of reservation to the weakest, and the same is utilized by the upper class within the group, who enjoy the benefit of reservation to the maximum creating dis-

parities within its class.

A Punjab circular reserved half of the Scheduled Caste quota of two groups Balmikis and Mazhabi Sikhs in 1975, then made a law in 2006, the Punjab Scheduled Caste and Backward Classes (Reservation in Services) Act, 2006. It was followed by a challenge in the High Court of Punjab and Haryana.

This 2020 case referred to a landmark judgment in Indra Sawhney and Ors. v. Union of India and Ors. 1992 Supp (3) SCC, 217 (1992) in which B.P. Jeevan Reddy, J. observed that several castes or tribes within the Scheduled Castes and Scheduled Tribes are not similarly situated. In N.M. Thomas, it was held that the Scheduled Castes are groups of castes, races, tribes, communities, or parts thereof found suitable by the Commission and notified by the President. Caste is nothing but a social

class or socially homogenous class. It is based on occupational grouping. Its membership is by birth, and they inherit the same occupation.

NOT TO CLAIM FOR A PER-CENTAGE OF THE QUOTA

The other class out of the Scheduled Castes/Scheduled Tribes/Socially and educationally backward classes cannot be denied the benefit of reservation and a claim over the whole or a particular percentage of reservation. The State can provide such preference on rational criteria to the class within lists requiring uplift. There is no vested right to claim that reservation should be at a particular percentage.

Justice Arun Mishra con-

cluded that the interpretation of Articles 14, 15, 16, 338, 341, 342, and 342A is a matter of immense public importance and correct interpretation of binding precedents in Indra Sawhney and other decisions. Though we have full respect for the principle of stare decisis, at the same time, the Court cannot be a silent spectator and shut its eyes to stark realities. The constitutional goal of social transformation cannot be achieved without taking into account changing social realities. **THE 2020 JUDGMENT**

Thus, a five-judge bench in

the State of Punjab and Ors, vs Davinder Singh & others(AIRONLINE 2020 SC 699, and https://indiankanoon.org/doc/137059642 /) in a landmark decision, agreed with the sub-categorisation within SCs. Justice Arun Mishra ruled along with Justices Indira Banerjee, Vineet Saran, M.R. Shah, and Aniruddha Bose, on August 27, 2020. A similar reservation-related case came up from Andhra Pradesh. A reference to this AP case is thus highly relevant as it suggests that another five judge-bench did not agree with this kind of candarion (that it is not care.) conclusion (that it is not correct for sub-categorization).

The point of 'homogenous group' in 2024 judgment The judgment emphasized that the Scheduled Castes are not a homogenous group, but

of different races and social backgrounds. Some of these groups were more socially and economically disadvantaged than others. The majority also unequivocally confirmed that sub-classification was not exclusive to the OBC category.

The Supreme Court bench with a 6:1 majority judged that states could create sub-classifications within the Scheduled Caste and Scheduled Tribe categories on 1st August 2024 (State of Punjab &Ors. Vs. Davinder Singh &Ors.2024, INSC 562). The Constitution Bench of the Supreme Court held that sub-categorization within a class is a constitutional requirement to secure substantive equality if the social position of the constituents is not comparable. (readers need to study another five-judge judgment in the AP case.)

TDP sweeps GVMC Standing Committee elections

The Greater Visakha Municipal Corporation Standing Committee elections culminated in a decisive victory for the Telugu Desam Party (TDP), which secured all 10 seats, establishing its control over the committee. The elections, marked by a day of high anticipation and palpable excitement, have become a focal point of political discourse in Visakhapatnam. The voting process commenced early at 7 am and continued until 2 pm. The counting of votes began two hours later.

The announcement of TDP's sweeping victory ignited a tense atmosphere on the GVMC premises. YSR Congress Party (YCP) corporators quickly voiced their discontent, alleging that the elections were

marred by undemocratic practices. Their protests met with staunch opposition from TDP supporters, who rallied in defence of

their party's triumph. Earlier in the day, YCP corporators had raised alarms about the integrity of the counting process, accusing TDP agents of marking ballot papers with pencils. This accusation caused a temporary halt in the counting. The situation escalated when YCP leaders attempted to approach the counting center to address their concerns but were blocked by the police.

Despite the protests and the cloud of allegations, TDP's victory in the GVMC Standing Committee elections remains unshaken, marking a significant political milestone for the party in Visakhapatnam.

Jungle clearance works...

The Minister praised the farmers of Amaravati for being brave despite the difficulties faced during the previous YSRCP government's rule. "A total of 58,000 acres are within Amaravati, while 24,000 acres are covered with trees and bushes like a dense forest. The work has started as per the directions of the CM to clear the jungle immediately. The tender process has been completed and the contractor was told to complete the work in 30 days," the Minister said.

He described the development as the first step for Amaravati works. Once the jungle clearance is completed, the farmers will have a chance to see where the plots were allotted to them by the government. The Minister added that the lease period of Amaravati has been extended for another five years. It has also been decided to continue the pension for another five years even for the landless poor. Minister Narayana said that with the construction of Amaravati, the value of farmers' lands will increase.

Minister Narayana further said that since the YSRCP government has not paid attention to the construction of unfinished buildings for the past five years, the IIT experts from Chennai and Hyderabad are studying the strength and technical aspects of the structures.

All gates of Prakasam open

1.37 lakh cusecs of surplus water discharged into sea

PNS VIJAYAWADA

With huge floods coming from upstream reservoirs on River Krishna, such as Srisailam, Nagarjuna Sagar and Pulichintala Projects, the Prakasam Barrage has received a large amount of water. The Water Resources Department Water Resources Department lifted all 70 gates and discharged the surplus water into the sea. At 6 pm on Wednesday, over 1,37,450 cusecs of floodwater was reaching the barrage. The officials lifted 50 gates by three feet and the remaining 20 feet and the remaining 20 gates by two feet and dis-charged surplus water into

Upper reservoirs Srisailam and Nagarjuna Sagar have reached their Full Reservoir Level (FRL) and the authorities released the surplus water into the river towards the Pulichintala Project. Also, there are chances of increasing flood water from the upper catchment. The Pulichintala Project officials lifted the crest gates and discharged the water downstream about 1.20 lakh

Besides Pulichintala, local flood water of around 17,000 cusecs reached the Prakasam Barrage in the early hours of Wednesday. Vijayawada Irrigation Circle officials lifted all 70 crest gates of the Prakasam Barrage. It was the first time that all 70 crest gates were lifted in this current

According to Krishna Central Division (KC) Executive Engineer (EE) and River Conservator Krishna Rao, surplus water was discharged downstream through 70 crest gates.

As per the reports from the Central Water Commission (CWC), the surplus from the Pulichintala Project will be increased to 2.80 lakh cusecs at Wednesday midnight, he said. Subsequently, the surplus discharge from the Prakasam Barrage will be increased up to 2.50 lakh to 3 lakh cusecs as per the realisation of water, he

EE Krishna Rao requested the Krishna and NTR district authorities, besides the Vijayawada Municipal Corporation, to alert all the officers to take precautionary measures to avoid any untoward incidents along the Krishna River margin on both upstream and downstream of Prakasam Barrage. If the flood water increases to 3 lakh cusecs, all the 70 crest gates will be lifted fully, he said.

On the other hand, Vijayawada Municipal Corporation Commissioner HM Dhyanachandra alerted the officials to take precautionary steps to shift people of lowlying areas to safe places. Also, he said the flood control room was opened on the premises of the VMC. He inspected several roads in the city and instructed the officials to remove the stagnated water on the roads

First mother's milk bank in State opens at Andhra Hospitals

On the occasion of World Breastfeeding week celebrations, Dr PV Rama Rao, Head of Children's Services & Director, Andhra Hospitals highlighted the importance of Mother's Milk Bank at Andhra hospitals, Vijayawada, which was started for the first time in the State.

The benefits of breastfeeding are recognised the world over, with studies showing that exclusively breastfed children are 14 times less likely to die in the first six months than non-breastfed children. Yet, in low-income countries, only 39 percent of children under six months are exclusively breastfed.

The WHO recommends that whenever the mother's fresh milk is not available for the baby, pasteurised donor human milk is the best option. In case of ill, preterm babies, banked milk is as important as the other preterm care. Human milk banking is getting established in India gradually but still we are not up to the mark. Considering the breastfeeding friendly culture in India we are very poor in this field.

Building the right infrastructure for milk banks is important. But equally vital is creating public awareness and support for the programme since it is not easy to persuade any woman to part with her breast

Junction, The Akkayapalli and Ganjigunte colonies were marooned in the rain water



To ensure that water can be used even in Rabi season, 31 storage reservoirs are also being built, as per the release.

The primary objectives of the EOS-08 mission include designing and developing a microsatellite, creating payload instruments compatible with the microsatellite bus, and incorporating new technolofor future operational satellites, the Bengaluru-headquartered Dosimeter.

national space agency said.
"SSLV's third and final

(developmental) flight will launch EOS-08 microsatellite on August 15, 2024, at 09:17 IST from Sriharikota. It completes the SSLV Development Project and enables operational missions by Indian industry and NewSpace India Limited (NSIL)," ISRO posted on "X".

Built on the Microsat/IMSbus, EOS-08 carries three payloads: Electro Optical Infrared Payload (EOIR), Global Navigation Satellite lystem-Refle tometry payload (GNSS-R), and SiC UV

The spacecraft has a mission life of one year. It has a mass of approximately 175.5 kg and generates power of around 420 W. The satellite interfaces with the SSLV-D3/IBL-358 launch vehicle, ISRO said.

The EOIR payload is designed to capture images in the Mid-Wave IR (MIR) and Long-Wave IR (LWIR) bands, both during the day and night, for applications such as satellite-based surveillance, disaster monitoring, environmental monitoring, fire detection, volcanic activity industrial and power plant disaster monitoring.

Constitution is a powerful tool to curb disparity, says CJI DY Chandrachud

Chief Justice of India (CJI) D Chandrachud on Wednesday said the Constitution is a "powerful

tool" to curb disparity and it institutions which meant to guard against inequality.

He said the Constitution provides for checks and balances within these institutions and also stipulates institutional priorities and obligations to the citizens of the country.

Addressing the gathering at the 13th convocation ceremony and founder's day of the O P Iindal Global University here, the CJI exhorted the students to spot injustice in all its facets in the world around

The Constitution is a powerful tool to curb such disparity. It creates institutions and

structures that are meant to guard against inequality, apparent or invisible," he said.

"In that sense, our Constitution performs a horizontal function in that it regulates inter-institutional relationships and a vertical function insofar as it regulates the relationship between the state

and its people," he said.

Justice Chandrachud also implored the students to spend their days and lives not only as ambassadors of their alma mater, but also as the voices of reason in a clutter of noise.

Social factors impact lifespan by up to 18 years Denmark found that while no PNS NEW DELHI

A combination of four social factors -- gender, marital sta-

tus, education and race -could impact risk of early death by up to 18 years, according to a study that analysed US citizens' data to devise a lifes-

pan scoring system. While individual risks and genes partly explain differences in health and death, researchers said that evidence increasingly points to how social conditions, in which people are born, grow, live

and work, shape one's health. The researchers at the University of Southern one of the four factors was more influential than any of the others, the more of these factors a person has, the higher their risk of an earlier death.

The authors also devised a "simple scoring system" based on the four factors to identify those most at risk. According to the scoring system, one's lifespan score could range from a lowest of (minus) 10 to a highest of eight.

For the study, published in the British Medical Journal (BMJ) Open, the researchers took data on registered deaths and population numbers from national statistics and census the analysis.



for the period 2015-19. Overall, 54 different social groups and 12 specific causes of death, representing 11 leading ones in the US such as lung, breast and other cancers, were included in

The team compared the partial life expectancies between age 30 and 90 years of the 54 social groups, which included three types of marital statuses, education and race each.

Partial life expectancy, one of the most commonly used measures of public health, estimates the expected number of years lived between specific ages. In this study, it measures the expected years lived between ages 30 and 90, for a maximum of 60 years of life, the authors

explained. Their analysis revealed "very large" differences in the lifespans between the social groups studied.

For example, the authors found that white never-married men with a high school diploma or less had the shortest partial life expectancy of 37 years, while white married women with a university degree had the longest one of 55 years.
"There is an 18-year differ-

ence between the minimum and maximum partial life expectancies between age 30 and 90 years across the (social groups)," they wrote.

The team also found that the

advantage of the social groups having longer lifespans was not obvious once multiple factors were considered.



Finance Minister yields

Facing a backlash over changes to the property transaction taxation, the FM has given some concessions to homeowners

owing to the popular pressure and critiques from MPs within the NDA coalition, the Central Government has relented to grant some relief for property transactions. Finance Minister Nirmala Sitharaman announced in the budget that the tax on long-term capital gains was reduced from 20% with indexation benefits to 12.5% but without indexation benefits. However, following significant opposition, an amendment is being made to The Finance Bill, 2024. For the transfer of a long-term capital asset such as land or a building acquired before July 23, 2024, the taxpayer can now choose to calculate their tax either at 12.5% without indexation under the new scheme or at 20% with indexation under the old scheme and pay whichever amount is lower. Indexation adjusts purchase price for inflation, reducing tax liability on gains from investments like debt funds. The government eliminated indexation benefits on long-term capital gains, increasing taxable gains. It prevents infla-



The ministry officials had argued that the new tax rate structure, with a lower tax rate minus the indexation benefits, would benefit people in almost all cases. However, the industry experts had different opinions. Industry bodies had sought to rethink the proposal, observing that the removal of indexation benefits amounted to a retrospective tax change for those who had bought properties earlier. They pointed out that this would particularly hurt those who

had invested in assets that had delivered lesser appreciation in value over the years. It was widely feared that the removal of indexation benefits on long-term capital gains would slow down property transactions in the Mumbai real estate market, and the real estate engine of the country and could have cascading effects throughout the country. Besides, several MPs also urged the Government to reconsider the proposal. During the debate on the Finance Bill in the Lok Sabha, TDP MP Lavu Sri Krishna Devarayalu echoed the concerns of other MPs, emphasising that this issue involves taxpayers' hard-earned money and impacts middle-class people the most. He noted that the middle class views real estate as a safe investment and and so should be protected. Indeed he had a point, as the middle-class is facing the pinch of price rise and rising unemployment. If their small investments and savings are wiped off they would have nothing to fall back upon. Providing taxpayers with the option to choose between the two tax regimes would address some of their concerns. Thankfully the finance minister yielded to allow for the second option. This would indeed give some relief to small and middle-class homeowners, providing a more balanced approach to long-term capital gains taxation in the real estate sector.

Renewable energy: Paving the way for a sustainable future

By 2030, India plans to achieve 500 GW of installed capacity from non-fossil fuels, marking a significant shift towards sustainability and energy security

→ndia's growth story over the past two decades has been marked by vibrant economic progress, largely driven by service exports and rising domestic consumption. As of 2024, the economy appears robust, poised to replicate its service sector success by transforming into a global manufacturing hub to leverage its demographic dividend.

A robust manufacturing sector necessitates significant resources, with power being a crucial component. Despite this, India's per capita electricity consumption remains low compared to global averages. As the country embarks on its manufacturing-focused era, electricity demand is expected to rise significantly. To meet this demand while adhering to climate commitments, India plans to add new electricity generating capacity primarily from non-fossil fuel sources. The goal is to achieve 500 GW of installed non-fossil fuel capacity by

By May 31, 2024, India's nonfossil fuel-based power generation capacity stood at 201.7 GW, with renewable energy, including small hydro pro-

jects, contributing 146.6 GW. To meet growing demands, a significant increase in renewable energy capacity is anticipated, supported by the renewable energy procurement roadmap from the Ministry of New and Renewable Energy (MNRE), which targets 50 GW of bids annually from FY 2023-24 to

FY 2027-28. Regulatory policies for the renewable energy sector are governed by both central and state governments, as electricity is part of the concurrent list. Key aspects of central government policy include promoting domestic manufacturing of solar modules and electrolyzers, safeguarding domestic manufacturing, and domestic content requirements, and implementing policies to encourage specif-

ic types of electricity genera-

tion like rooftop solar and offshore wind.

India's renewable energy policy framework adopts a holistic approach, addressing multiple factors. For example, the Ladakh region, with excellent irradiation levels, lacks sufficient infrastructure to integrate its power into the grid. To tackle this, the government announced the green energy corridor. Furthermore, the government identified states with offshore wind potential and introduced a viability gap funding scheme with an outlay of Rs 7,453 crores for installing 1 GW of offshore wind projects. Regulatory policies also aim to enhance self-sufficiency in the energy. The Production Linked Incentive (PLI) scheme, with an outlay of Rs. 24,000 crores, targets achieving gigawattscale manufacturing capacity of high-efficiency solar PV modules. Additionally, the Strategic Interventions for Green Hydrogen Transition (SIGHT) Program, with an outlay of Rs. 17,490 crores under the National Green Hydrogen Mission, supports domestic manufacturing of electrolyzers and green hydro-

gen production. These investments are expected to generate numerous direct and indirect jobs while ensuring energy security.

The government has also introduced schemes to promote distributed solar generation at the household level in both rural and urban areas. The PM-KUSUM scheme aims to reduce the agricultural sector's reliance on diesel and boost farmers' incomes by providing central government subsidies of up to 50% for installing standalone solar pumps and solarizing existing grid-connected agricultural pumps. Farmers can alsoinstall grid-connected solar plants on barren land and sell electricity to local distribution companies (DISCOMs). In the interim budget for FY 2024-25, the government announced the PM Surya Ghar Muft Bijli Yojna, which offers subsidies covering up to 40% of solar panel installation costs. This scheme aims to equip 10 million homes with solar panels, saving INR 75,000 crores in electricity costs.

Te are forever doing material acts like eating, sleeping, 'vihar' (entertainment) and, yes, work. Some of us may be doing some spiritual practices as well. Why is there such a mismatch? Because most people do not realize how beneficial spiritual practices are for a human being. Read on and you will agree. I have chosen ten common spiritual practices for this article. They are simple to do and almost everyone can benefit by doing them. Beginning with praying, what is so difficult to do it? Someone is not well in a family, and a family member prays for his or her quick recovery. Even small children pray for their mother when she is unwell. What happens then? God hears them, as He has eyes and ears everywhere. (The Bhagavad-Geeta 13.13)

What is God's response? He has to consider several factors like what does the person prayed for deserves, what effect it will have on other family members, who is praying, etc. There will be a response, which will be appropriate taking into consideration everything. Let us remember that God knows 'The Big Picture', which includes the past, present and future also.

Whatever God may decide, the act of praying sincerely curbs ego, which helps one to become humble - a necessary quality to be able to deal properly with others. Negligence and tragedy: The price of complacency RAJDEEP PATHAK



The death of three IAS aspirant highlights severe systemic negligence by coaching center management, property owners, and municipal authorities



n reflecting on the powerful speech delivered by Mark Antony following the assassination of Julius Caesar, one cannot help but recall his stirring words: "Friends, Romans, countrymen, I come to bury Caesar, not to praise him." Antony's oration skillfully ignited the Roman populace, who were initially ambivalent towards Caesar's murder. Through his use of rhetorical questions and ironic praise for Brutus and the other conspirators, Antony incited the crowd to question the motives behind the assassination. <

By revealing Caesar's will, which generously bequeathed wealth and public parks to the citizens, Antony further endeared Caesar to the people and painted the conspirators as traitors. The crowd, now convinced of Caesar's benevolence and the conspirators' treachery, erupted into chaos, leading to a violent riot. This turmoil precipitated a civil war, ultimately overthrowing the existing order and paving the way for the rise of the LAPSES. SUCH AS Second Triumvirate' (all 'sought revenge for the murder of Julius Caesar) and the end of the Roman Republic.

A tragic incident in the Capital City of India echoes this (Shakespearean) historical upheaval, where the death of three students (IAS aspirants) has incited public (students') outrage. On Saturday, July 27, 2024 evening, a supposed drainage burst led to flooding in the basement of Rau's IAS Study Circle in Old Rajinder Nagar used as a library where approximately 35 students were present when rainwater began to inundate the basement, creating a panic-stricken atmosphere. Despite attempts to evacuate, three students were trapped and subsequently

This disaster has cut short the dreams of the parents of three students. Unlike Bhola Baba - who philosophically dramatized death as an inevitable part of life following the Hatras stampede tragedy - the negligence displayed by the coaching centre owners in this instance cannot be so easily dismissed. The failure to ensure proper evacuation facilities has underscored the mismanagement of the institution.

Although the Municipal Corporation of Delhi (MCD) has stormed into action, they

cannot fully absolve themselves of responsibility. More than anything else, the basement, intended for parking and storage, was illegally repurposed as a library. As the news became the talk of the town, sentiments of anger and frustration poured amidst huge grief and loss. The incident in Old Rajinder Nagar underscores a pervasive pattern of systemic negligence among various stakeholders, including coaching centre management, property owners, and municipal authorities. The illegal conversion of the basement into a library, without proper safety measures reveals a severe disregard for student safety. Compounded by chronic infrastructure deficiencies such as inadequate drainage systems, this negligence is exacerbated by municipal authorities' failures.

Regulatory lapses, such No-Objection Certificates (NOCs) without thorough verification and compliance checks, further point towards significant enforcement shortcomings.

The Municipal Corporation of Delhi's (MCD) delayed actions in sealing other illegally repurposed basements reflect a reactive rather than proactive enforcement strategy. Additionally, the coaching centre's lack of an effective emergency plan, including proper drills and protocols, significantly contributed to the chaos and heightened the tragedy, demonstrating a critical need for better emergency preparedness, stricter regulations and oversight to prevent such tragedies

in the future. **ENFORCEMENT** Accounts from traumatized students reveal harrowing experiences. SHORTCOMINGS Whether it is Aishwarya Rai, a 30year-old UPSC aspirant from Kanpur, Nakul Tiwari, or Shreya, the very fact that they have been rescued from the terrifying moment of being drowned to death will linger

in their psyche for years to come. The question arises: why does it take such disasters for the administration to take action?

The arrest, bulldozing of illegal constructions and other preventive and punitive measures often come only after tragedy strikes. Videos now emerging tell tales of utter mismanagement and illegal use of properties, breaking all norms. Why are the students only now flagging these issues? Another question is why their seniors, who have perhaps lived and studied in these conditions and are either IAS aspirants or have cleared their examinations, did not raise such issues of negligence in the past. Moreover, if a few of them have become Civil Servants from these coaching centres, why didn't they, over the years, bring this to the notice of the local administration? Another crucial issue is that the commercialization of education, driven by the high demand for competitive exam preparation, should not compromise safety standards, which in this case has resulted in unsafe and overcrowded condi-

The commercialization of education, characterized by the increasing influence of profit-driven motives, brings both benefits and drawbacks to student welfare. On the positive side, it often leads to improved infrastructure, better resources, and innovative teaching methods that enhance the learning experience. Private institutions do attempt to provide advanced facilities and extracurricular activities, fostering a more dynamic and engaging educational environment. This recent incident must become an eye-opener. It critically highlights the need for enhanced regulatory oversight and stricter enforcement of building codes and safety regulations, emphasizing regular inspections and audits to ensure compliance. Investment in infrastructure, particularly drainage systems, is crucial to mitigate flooding risks, espe-cially in flood-prone areas like Old Rajinder Nagar.

Additionally, educational institutions, particularly coaching centres, should be mandated to develop and regularly practice emergency evacuation plans, as safety drills can significantly improve preparedness and reduce panic during emergencies. Increased public awareness about safety regulations and accountability mechanisms is necessary, encouraging students and residents to report violations and demand action from authorities. Moreover, the process for obtaining necessary permits and NOCs should be transparent and stringent, with severe penalties for deviations from approved plans.

crucial. Educating students and residents about safety standards and rights is another key factor. Further, creating platforms for community engagement and empowering residents with safety mechanisms is crucial.

More than anything else, authorities should respond promptly to such reports and take corrective action. While this is a sad moment for all of us to have lost young budding talents of our country in this manner, it is time we foster a culture of accountability, in our endeavour to safeguard the dreams and lives of countless students who come to Delhi in pursuit of their aspirations. The path forward requires a collective effort from authorities, institutions, and the public to prioritize human safety over commercial interests and ensure that such a tragedy never

In the previous session, gold of 99.9 per cent purity closed at Rs 71,700 per 10 grams on Tuesday. However, silver prices bounced back after four straight days of massive decline. Silver rose by Rs 200 to Rs 82,200 per kilogram from Rs 82,000 per kg in the previous trade, according to the All India Sarafa Association. Meanwhile, gold of 99.5 per cent purity also declined by Rs 350 to Rs 71,000 per 10 grams. It had settled at Rs 71,350 per 10 grams in the previous close. Traders attributed the decline in gold prices to a reduction in domestic customs duty and global influences. On the global front, gold at Comex was quoted at USD 2,393 per ounce, down by USD 16 from the previous close. "Comex gold declined as the US Treasury yield headed higher along with the dollar index.

Sebi issues Rs 25-cr notice to Karvy Stock Broking, Parthasarathy

Markets regulator Sebi on Wednesday sent a notice to Karvy Stock Broking Ltd (KSBL) and its CMD C Parthasarathy asking them to pay around Rs 25 crore within 15 days in a case pertaining to misappropriation of clients' funds by misusing the

Power of Attorney. The notice came after they failed to pay the fine imposed on them by the Securities and Exchange Board of India (Sebi). Sebi in April 2023 barred KSBL and Parthasarathy from the securities market for seven years and also imposed a penalty of Rs 21 crore on them for misappropriating clients' funds

by misusing the Power of Attorney given to the broking firm. Individually, the regulator had levied a fine of Rs 13 crore on KSBL and Rs 8 crore on Parthasarathy, promotercum-managing director.
In its fresh notice, the reg-

ulator has vbdirected KSBL and Parthasarathy to pay Rs 15.21 crore and Rs 9.36 crore, respectively, which includes interest and recovery cost, within 15 days.

In the event of non-payment of dues, the markets regulator will recover the amount by attaching bank accounts, attaching as well as selling the entities' moveable and immoveable property.



Hazards of dysglycemia!

Blood sugar is the body's primary energy source. Insulin plays a key role in regulating the blood glucose level and keeps it within a normal range. Uncontrolled blood sugar also known as Dysglycemia is when insulin doesn't work as it should and (blood sugar) glucose stays in the blood. This creates high blood sugar, known as hyperglycemia. Blood sugar can also go too low. This is a condition known as hypoglycemia.

HYPERGLYCEMIA IN DIABETES:

Resistance to the action of insulin or deficiency of insulin can lead to hyperglycemia.

Common complications of high blood sugar

- Diabetic Retinopathy
 Diabetic Retinopathy affects the eye, especially the blood vessels around the retina, leading to vision loss or blindness.
- Diabetic Nephropathy
- Diabetic Nephropathy affects the kidneys, causing them to lose function, leading to kidney failure over time, requiring dialysis or transplant.

- Diabetic Neuropathy affects the nerves, causing numbness in the feet, legs, hands, or arms. It can further damage nerves, affecting the digestive, reproductive, urinary systems and heart.

 Diabetic Foot-Ulcers
- Diabetic Foot Ulcers are open sores that develop on different parts the feet due to nerve damage, poor blood circulation, and infection. They can be very difficult to heal and, when left untreated, can lead to gangrene or amputation.
- Heart attack and stroke High blood sugar for a period can damage the blood vessels. This may lead to heart attacks and strokes.

Hypoglycemia in diabetes:

This is often related to medications for diabetes treatment or when the intake of sugar is insufficient or delayed

Common complications of low blood sugar

- •Low blood sugar causes hunger, shakiness, sweating, dizziness, headache, confusion, irritability, or fainting
- •Low blood sugar can deprive the brain of oxygen and sugar, damaging brain cells and causing cognitive impairment or neurological disorders
- Coma
- •Low blood sugar causes loss of consciousness that can further result in brain damage, organ failure, or death.

- Low blood sugar can affect the heart rhythm and blood pressure, causing cardiac arrhythmias, heart attack,
- or cardiac arrest. Wavs to control high blood sugar
- Adhere to the outlined treatment plan • Monitor the blood sugar levels regularly
- Exercise regularly and stay physically active
- Drink plenty of water and have a balanced diet
- Manage stress and practice relaxation techniques

Ways to control low blood sugar

- · Limit or avoid alcohol intake
- Avoid skipping meals or fasting
- Carry a source of fast-acting sugar tablet
- Wear a medical alert bracelet or necklace • Supervise the blood sugar levels at intervals

Blood sugar is a vital component of the body's metabolism and health. However, it causes irreversible damage to various organs and systems when it becomes too high or too low. Therefore, it is essential to maintain an active and healthy lifestyle and follow the treatment plan prescribed by healthcare experts to prevent or manage dysglycemia. While it may prove to be difficult, patients can seek guidance from peer groups, support programs and associations that provide education and support for people living with diabetes or prediabetes.

Surge in influenza cases

easonal influenza (the flu) is an acute respiratory infection caused by influenza viruses. Seasonal epidemics (the rise of cases) occur mainly during the winter and rainy seasons. Influenza spreads easily between people when they cough or sneeze, with rapid transmission in crowded areas including schools and nursing homes.

Dr. Usha Gaddam, MBBS,DNB (Family Medicine), Apollo Clinic highlighted that of being witnessed over 25 cases per week. "The symptoms usually begin around 2 days after being infected by someone who has the virus. The flu vaccine is a yearly vaccine. Immunity from vaccination goes away over time so yearly vaccination is recommended.

"The djembe is not just an instrument; it's a vessel of energy and healing. It's always played in a group, which creates a communal vibe that's both therapeutic and exhilarating. The vibrations from the drum connect with our chakras, from the Muladhara to the Crown, facilitating a unique form of chakra heal-

ing."
The inspiration for the Djembe Circle came from a Djembe Circle came from a friend, Ayu, an international Djembe player from South Africa. "He introduced me to the magic of drum circles. We would gather and play, immersing ourselves in the powerful rhythms. It was then that I knew I wanted to bring that I knew I wanted to bring this experience to Hyderabad." Thus, in January 2024, the

Starting this journey in Hyderabad, however, was not

without its challenges. "It's a new concept here and many people don't quite understand it at first," he notes. "But once they attend a session, they're hooked. The energy, the camaraderie—it's something you have to experience to truly appreciate." appreciate."

Despite the initial struggles of introducing this new concept, Sai Kumar remains optimistic. "The biggest challenge is getting people to come and try it. But once they do, the djembe speaks for itself."

One particularly memorable session drew 150 participants some travelling from as

ipants, some travelling from as far as Medak. "The feedback was overwhelming. People left feeling rejuvenated and many returned with their families and friends."

The benefits of the djembe circle extend beyond the joy of music. Participants often report feelings of calm,

family alongside *tabla* and *mridangam*, inspired Sai Kumar to explore its potential beyond mere musical expres
Mathematical expressions and unique experience to the city's cultural scene.

Djembe Circle was born, offerimproved social interactions. He recounts, "It's a stress buster. I've seen corporate workers, families and even senior citizens find relief and happiness through these sessions." He recounts a touching story of a woman and her child, who, despite the child being unwell, attended a ses-sion. By the end, he was full of energy and completely healed. Moments like these, he says,

make it all worth it. A typical session with the Djembe Circle is an immersive experience—starting with the basics and introducing the three main rhythms of the djembe, Sai explains, "Then we dive into African tribal music, with everyone singing, dancing, and even shouting with joy. It's not just a musical experience; it's a celebration."

Looking ahead, Sai Kumar dreams of making the diembe a staple in Indian culture. "In the 20th century, we saw many instruments gain popularity. I want the djembe to become one of the prominent instruments of the 21st century," he asserts. His vision extends to schools, colleges and communities across India, spreading the joy and healing power of the djembe. His advice to newcomers is simple yet profound: "Come with an open mind and open heart, and let the rhythm guide you."

Indian boxing stalwart Vijender Singh has alleged that wrestler Vinesh Phogat's disqualification from the Olympics final might be a case of sabotage as elite athletes like her are well-versed with the techniques of cutting weight before major competitions.

Vijender, who is India's first and only male boxer to have won an Olympic medal, knows a thing or two about maintaining weight before major bouts and he said it is shocking that Vinesh was 100gm over in the weigh-in

before an Olympic final.
"I think it might be sabotage.
100gm, you have got to be kidding me. We athletes can shed 5 to 6kg overnight. It is difficult no doubt but we know how to control our hunger, thirst, and exert to the extreme," the middle-weight (75kg) boxer told PTI.

"And when I say sabotage I mean people who are not happy to see India rise as a sporting nation. This girl has been through so much, your heart breaks for her. What more could she have done? Which other test?" he wondered.

Vinesh was the face of a lengthy protest against former Wrestling Federation of India head Brij Bhushan Sharan Singh, who has been accused



Demoralised India need to regroup quickly to win in bronze medal play-off

A heart-wrenching defeat in semifinals

notwithstanding, a demoralised Indian men's hockey team will have to regroup quickly and aim for a second consecutive podium finish at the Olympics when it takes on Spain in the bronze medal play-off here on Thursday.

The Indians played bravely against Germany, putting their defence under pressure from the start and in the process took the lead in the seventh minute through a penalty corner conversion by skipper Harmanpreet Singh.

But the Germans came back strongly in the second quarter and fourth quarters to secure the close win, courtesy some silly defensive lapses from the Indians, especially Jarmanpret Singh.

The Indians too were guilty of wasting too many scoring chances, including as many as 10 penalty corners, while converting two, one directly and another through variation. The opposition teams seemed to have found out a way to deny one of the world's best drag-flicker Harmanpreet as he managed to be on target just once on Tuesday.

The over-reliance Harmanpreet and lack of innovative penalty corner variations seemed to be hurting India badly here as they don't have much options

in their hands. But the return of Amit Rohidas, who missed Tuesday's match after being shown the red card against Great Britain in the quarterfinal, should



penalty corners as he is second best option from set pieces after Harmanpreet.

The Indians were looking to break a 44-year-old jinx to reach an Olympic final but it eluded them narrowly.
The last time India made the

Olympic hockey final was way back in 1980 Moscow Games, which, in fact, was their last of the eight gold medals at the quadrennial event.

À place in final would have at least assured India a silver medal after 1960 Olympics but that also slipped out of hands. But all is not lost for the Indians as they still have a chance to claim a podium finish if they beat Spain on Thursday in the bronze medal

match. For that, the Indians will have to leave the baggage of the semifinal loss behind and come out with a fresh mind to

currently at the fifth spot. But it would be easier said than done for the Indians as Spain, while not matching India's Olympic achievements, has made significant strides in recent decades.

Echikunwoke changes countries

This time at the Olympics, hammer thrower Annette Nneka Echikunwoke got to compete. Not only compete, but win a medal - for the United States.

Three years ago, Echikunwoke arrived at the Tokyo Games ready to represent Nigeria, but she wound up needing to leave before even getting to take a throw. Nigeria was among a handful of countries deemed "high risk" by track's anti-doping regulators in the lead-up to those Olympics - forcing its athletes to be subjected to more drug testing.

Echikunwoke was among those from Nigeria who did not meet the requirement and so was not allowed to participate. The 28-year-old was born in

Ohio and originally decided to represent Nigeria because that's where her parents are from. But after the issues in 2021, she switched her Olympic country to the U.S., and on Tuesday night became the first American woman to earn Summer Games medal

in the hammer, getting a silver. Echikunwoke was in the early lead before Canada's Camryn Rogers won the gold on her second-to-last throw. "I think (this medal) could have happened three years ago, but I'm happy it's happening now,"
Echikunwoke said. "I feel like
everything happens for a reason, even if
it's bad or good or ugly or whatever the
case may be. This is beautiful."

She remembers that time in Tokyo so vividly, such as not being able to walk in


