#### Centre approves 25% enhancement in security deployment at central hospitals

The Health Ministry has allowed enhancement of security deployment by 25 per cent at all union government hospitals, official said, amid protests by resident doctors demanding a central law following the alleged rape and murder of a trainee doctor at a Kolkata hospi-

Officials said that apart from the standard security protocol, the deployment of marshals would also be approved based on individual demands by government hospitals after they conduct their security assessment.

Official sources, however, said bringing a central law based on the RG Kar case "will not make any huge difference" as the alleged rape and murder of the junior doctor at the Kolkata facility was not a case of patient-doctor violence.

The World Health Organisation (WHO) has declared Mpox a Public Health Emergency of International Concern (PHEIC) in view of its prevalence and spread across many parts of Africa. The virus strain this time is dif-

ferent and is more virulent and infectious. But the risk of a large outbreak with sustained transmission is low in the country as per the current assessment." an official source said.

The health ministry has directed officials to enhance surveillance and effective measures to be taken for prompt detection of Mpox cases. It has stressed that the network of testing laboratories should be geared up for early diagnosis of the disease.

At present, 32 laboratories in the country are equipped for testing Mpox. Mishra on Sunday said protocols for prevention and treatment of the disease should be disseminated on a large scale, stressing the importance of running an awareness campaign among healthcare providers about the signs and symptoms of the disease and the need for timely notification to the surveillance system.

An earlier statement from WHO stated that 99,176 cases and 208 deaths had been reported due to Mpox from 116 countries globally since 2022.Mpox cases have been steadily increasing in the Democratic Republic of Congo.

# Unique protest marks Raksha Bandhan by AP JUDA

This protest entered its seventh day with a clear message demanding the safety and protection of healthcare professionals.

At AIIMS Mangalagiri, doctors staged a protest by observing Red Apron Day. In a poignant display of solidarity, female participants tied rakhis to each other. The Resident Doctors, Interns, and stuof AIIMS Mangalagiri reiterated their commitment to the indefinite boycott of all nonservices, emergency including OPDs, IPDs,



Elective OTs, Lab services, and Academic Activities. This boycott aligns with the national movement advocating for the safety and protection of healthcare professionals. The Raksha Bandhan event, where women tied rakhis to one another, underscored their demand for a safe working environment. The peaceful protest will continue until their demands are met, with further actions to be determined based on the evolving national situation.

In a parallel demonstration, junior doctors from Rangaraya Medical College staged a hunger strike, with 30 participants demanding justice for the victimised doctor in Kolkata and the implementation of the Central Protection Act.

As a show of solidarity, co-students and juniors tied rakhis to their seniors, symbolically recognising them as protectors within the college. Similar events were held across all government medical colleges

# Jagan demands completion of R&R works for Veligonda project

YSRCP president and former chief minister YS Jagan Mohan Reddy has demanded that Chandrababu Naidu immediately focus on completing the Rehabilitation and Resettlement (R&R) works of the Veligonda project and make immediate payments so that water can be stored this season, meeting the irrigation and drinking water

Taking to the social media platform X, the former Chief Minister wrote that the Veligonda project, which is the lifeline for the drought-stricken Prakasam district, is being neglected by the TDP coalition government under the leadership of Chief Minister Chandrababu Naidu. Despite the critical need to complete this project and provide its benefits to the people, no significant attention has been given by the current administration, he said.

He mentioned that under the governance of the YSR Congress Party (YSRCP), they successfully completed two tunnels of the project, overcoming several technical challenges, including the COVID-19 pandemic.

He noted that Tunnel-1 was



completed and dedicated to the nation in January 2021, followed by the successful completion of Tunnel-2 in January 2024. Jagan emphasized that this achievement realized the vision of the late great leader Dr YS Rajasekhara Reddy, who had initiated the construction of the project in 2005.

He pointed out that while the two tunnels were completed, the Rehabilitation and Resettlement (R&R) work remains unfinished. He stated that an immediate payment of around Rs 1,200 crores is needed to finalize the R&R process and store water this season. He also mentioned that the previous YSRCP government had already prepared detailed plans for R&R, but after three months in power, Chandrababu Naidu's administration has shown no visible effort to address the issue. He stated that Chandrababu

has been conveniently inflating civil work estimates and awarding contracts for personal gain while neglecting the rehabilitation of displaced people. He also pointed out similar negligence in the Gandikota project, which delayed water storage. He highlighted that only after the YSRCP government took over, Rs 1,000 crores were paid to displaced families, enabling the storage of 27 TMC of water.

YS Jagan mentioned that his government completed the R&R for the Chitravathi project with Rs 250 crores, enabling the storage of 10 TMC of water.

He also noted that Rs 60 crores were spent to finish the diaphragm wall at Brahmasagar, along with the completion of the Telugu Ganga Canal lining, which allowed for the transport of 17,000 cusecs of water and storage of 17 TMC. Additionally, Jagan highlighted that during Chandrababu's tenure, the R&R for the Pulichintala project was neglected, but the YSRCP government allocated Rs 140 crores to complete it, enabling full capacity storage of 46 TMC of water.

#### Revanth helps airl who held mother's funeral with donations

This marks the first time in 20 years that all reservoirs in the state have been full in the month of August.

# **Preetham mounts Kilimanjaro**

Three of them died in the morning, and a fourth, a girl in critical condition, passed away while being transported to Visakhapatnam. Officials reported that the children had been served biryani, samosas, and chocolates on Saturday night after a prayer meeting, and some also ate leftover

biryani the following morning.

In response to the incident, State Home Minister V Anitha stated that the orphanage was operating without government approval and assured that stern action would be taken against its management. After visiting the sick children at King George Hospital in Visakhapatnam, she remarked that many hostels are operating without proper permissions. She emphasised that government-approved hostels are not permitted to serve outside food, but in this case, the children became ill after consuming food brought from outside. In response to the crisis, authorities from the police and medical and health departments have launched an investigation to determine the exact cause of the food poisoning. District Collector M N Harendhira Prasad personally visited KGH to check on the children's wellbeing. He reassured the community, saying, "I want to assure everyone that the children are receiving the best possible care under the supervision of our dedicated medical team.

The doctors are closely monitoring their progress, and I'm pleased to

report that their condition is stable.'

Collector Prasad further elaborated on the efforts being made, stating, "A total of 14 children were brought from Anakapalli, and all of them are currently in the children's ward, where they are receiving advanced treatment. There is no need for concern as their recovery is progressing well.'



### **Women safety is non-negotiable**

The apex court's suo moto congisance of Kolkata rape case could lead to stronger security measures in workplaces

he Kolkata rape and murder case has shaken the nation, sparking widespread outrage and a call to end such horrific crimes. While similar cases in the past, like the Ranga Billa case in the 1970s and the Nirbhaya case in 2012, also provoked national anger, real change has been limited, with crimes against women continuing sporadically. The recent assault and murder of a resident doctor in Kolkata serve as a stark reminder of the ongoing vulnerability women face in the workplace. The Supreme Court of India has taken suo motu cognisance of the Kolkata doctor rape-murder incident. A three-judge bench presided by Chief Justice of India D Y Chandrachud will hear the matter on August 20, 2024. Earlier, the Calcutta High Court expressed displeasure over the handling of the case by the State Government. The incident took place at R G Kar Medical College in Kolkata. The case has been transferred to the CBI. The Supreme Court's decision to take up this case underscores a growing concern about the safety of women in



public spaces, including professional environments. The matter, while primarily focusing on doctors' safety, also opens a window to address the broader context of women's safety across the country.

In a country where women's safety continues to be a major societal concern, the Supreme Court's intervention in the Kolkata case regarding the safety of doctors brings to light a parallel issue— the precarious conditions under which healthcare workers, especially women, operate. While India grapples with various cases of violence against women, the healthcare sector has seen its share of attacks on women professionals, prompting national attention and legal action.

India's struggle with women's safety is long-standing and complex. High-profile cases of sexual violence, harassment, and workplace discrimination have repeatedly sparked public outrage. Despite legal reforms and awareness campaigns, incidents of violence against women remain alarmingly high. Public spaces, including hospitals, which should be places of care, have become dangerous for many women, underscoring the systemic nature of the problem. The healthcare sector is particularly concerning because female doctors and nurses not only face violence from patients' families but also internal issues such as sexual harassment from colleagues and superiors. This dual threat makes their professional life increasingly challenging and unsafe. With the Supreme Court stepping in, it is hoped that this case will lead to more robust security protocols in hospitals and other public institutions. As the Supreme Court examines the Kolkata case, there is hope that this will lead to a more comprehensive approach to women's safety in India. The focus should not just be on doctors but also on broader societal reforms that ensure women can work, travel, and live without fear of violence or discrimination. If the court's ruling leads to enhanced safety measures for doctors, it could set a precedent for other professions as well, where women face similar threats.

With institutions under siege and the legacy of Sheikh Mujibur Rahman under attack, the parallels with the French Revolution become starkly apparent

Though there are those in the revolution mass and leadership, who would want to distinguish Sheikh's legacy from Hasina's regime. The revolution which started with the symbolic fall of Bastille and the establishment of the Estates General of 1789, ended with the coup of 18 Brumaire in November 1799 and the formation of the French Consulate with the military under the leadership of Napolean Bonaparte capturing power.

The French Revolution was driven by the ideas of the fundamental principles of liberal democracy. Its causes are generally agreed to be a combination of social, political, and economic factors, which the ruling establishment led by Emperor Louis XVI was the fall was a financial crisis and widespread social distress.The fall of Louis XVI saw radical reforms including the abolition of feudalism and a declaration of rights. But this did not bring an end to political instability.



The next decade was dominated by the struggle for political control, worsened by economic depression. To overcome the crisis the revolutionaries formed the Committee of Public Safety, which unleashed a reign of terror in which about 16,000 people were executed. Finally in 1799 following a military coup, Napoleon Bonaparte came to seize power marking the end of the revolution. The quick recall of the events of the French Revolution was to establish the fact that insurrection doesn't generally guarantee one thing, the stability of governance. The anxiety, feverishness and desperation of the student can never compress the period of learning. Humans live in highly stressful and disharmonious conditions. Pressure is exerted on their minds, resulting in an unhealthy lifestyle. Stressful conditions are also created by our feverish attitude and desperation: A mental state when our expectations far exceed the actual requirement. Not living in the NOW and a covetous nature also contribute to mental disequilibrium. The memory of past events has a double whammy on the mind. A pleasant occurrence brings peace, but turbulent experiences make us stressed and fret. Unfortunately, the human mind gives more credence to negative experiences and that leads to the gathering of stress in the mind. A stressful mind can be smoothened only through a 3C policy, namely commitment, control, and challenge. The energy of the mind needs to be channelled productively and this can be done



through proper training and a firm commitment. Challenging situations and tasks endear the human mind: to try something new or different and think out of the box. Renowned psychologists Endler and Parker have enunciated a three-factor model to overcome stress or manage this ail-

(a) Task-Oriented Strategy: The individual should ensure proper time management to complete the task at hand. Also, box out stressful conditions when through experience we are aware of negative possibilities

(b) Emotion-Oriented Strategy: Create a space in the mind to vent anger and trustrations. Literally to let go of the emotions. Develop a belief and hope in a higher power through the power of surrender and sublimate

(c) Avoidance-oriented Oriented Strategy: Create a shield or envelop the mind with an aura of positive thoughts. This works like magic and it mitigates the seriousness of the situation and stressful situations get oblit-

The model merely provides the framework. In reality, relaxation techniques, practising yoga, dwelling deep into meditation, engaging in visualisation (which incorporates features such as imagery and positive imagination), learning breathing techniques like Vipassana and Sudarshan Kriya or even hitting the gym are some of the tools to implement the model.

# Why India needs a secular civil code



As India approaches its 76th Republic Day, the question of whether laws should be shaped by religion or remain universally applicable becomes ever more urgent



rime Minister Narendra Modi, in his Independence Day address from the ramparts of the Red Fort, dispelled all misconceptions and rumours about the stability and strength of his coalition and showed that he has complete control over the government. His address also revealed that his goals have remained the same. His speech was filled with energy and strong determination, as it always is.

He stressed the implementation of the Secular Civil Code (SCC). He said the Supreme Court has repeatedly discussed and given orders on the Uniform Civil Code (UCC) because a large section of the country feels, and it is correct, that the present civil code is a communal and discriminatory civil code. There is no place for

them in modern society. The need of the hour is a Secular Civil Code (SCC). The Prime Minister's use of the phrase "Secular Civil Code" was interesting. A "Secular Civil Code" (SCC) was used instead of the possible "Uniform Civil Code" (UCC) so that opposition parties could support it appropriately. On November 23, 1948, Article 44 was introduced in the Constituent Assembly by Dr B R Ambedkar as draft Article 35 and was unanimously passed. "Uniform Civil Code for the citizens -

The State shall endeavour to secure a Uniform Civil Code throughout the territory of India for the citizens." So states Article 44 of our Constitution. During the Constituent Assembly discussion, amendments were moved by Hussain Imam and some other members, That any group, section or community or people shall not be obliged to give up its own personal law in case it has such a law, and, provided that the personal law of any community which is guaranteed by the statute shall not be changed except with the previous approval of the

community. Dr. B. R. Ambedkar, in his reply to the discussion, stated that our country has a Uniform Code of Laws covering nearly every aspect of human relations. We have a uniform and comprehensive criminal code throughout the country, contained in the Penal and Criminal Procedure codes.

We also have the law of transfer of property, which deals with property relations and applies through-out the country. Additionally, there is the Negotiable Instruments Act, among other acts, which proves that this Chagla had also strongly country has practically a civil code that is uniform and applicable throughout the country. Dr Ambedkar argued in the Constituent Assembly that the Uniform Civil Code should be viewed as a secular law applicable to all.In 1985, the former Chief Justice of India, YV Chandrachud, shared similar views during the 'Shah

This case revolved around Shah Bano Begum, a Muslim woman who had sought maintenance under Section 125 of the Code of Criminal Procedure after her divorce. The initial judgment ruled

in her favour. However, her husband, Mohammed Ahmed Khan, appealed to the Supreme Court, arguing that Section 125 should not apply to Muslims as it contradicted Muslim Personal Law. The Supreme Court disagreed with this contention, asserting that Section 125 applies to all individuals, irrespective of religion or personal law, and dismissed the husband's petition. Eminent Muslim jurists like Chaudhary Haider Hussain and former Chief Justice of Bombay High Court M C

upheld Article 44 (UCC). In the case of John Vallamattom vs Union of India in 2003, the Supreme Court once again expressed regret that Article 44 of the Constitution had not been implemented. Supreme Court also asked the government if they were ready to implement the Uniform Civil Code. 2025, when we celebrate

#### **BTL EPC secures Rs 413 cr** contracts

TL EPC Ltd, a Kolkata-based EPC and engineering company, on Monday announced new contracts valued at Rs 413 crore inclusive of GST from public sector companies such as BHEL and SAIL. The company has secured a Rs 267 crore contract from BHEL for NTPC's Lara TPS Stage-II (2x800 MW) project. BTL EPC will provide turnkey solutions for conveyor systems and electromechanical equipment for handling coal, limestone, gypsum, and biomass at the power plant located at Pussore in Chhattisgarh, a company statement said. In addition, BTL EPC has bagged a Rs 96 crore contract from SAIL-Bhilai for the replacement of equipment in its By-Product Plant. This project is expected to be completed within 18 months. The company has also secured over Rs 50 crore worth of contracts for underground mining conveyor supply for several other public and private sector mines.



#### **India allows Nepal to export** additional 251 MW of power

ndia has allowed Nepal to export an additional 251 MW of electricity to the country, marking the first time the Himalayan nation will supply power to Bihar under a medium-term sales agreement, an official statement said on Monday. "India's Designated Authority for Cross-Border Trade has approved an additional 251 MW of power exports from 12 hydropower projects in Nepal," the Indian Embassy in Nepal said in a statement. With this, Nepal would be exporting 941 MW of hydropower from 28 projects. Earlier, Nepal was exporting 690 MW of electricity from 16 projects, it added. Even before this 251 MW approval, Nepal had already become a net exporter of electricity and net revenue generator in the last fiscal year, selling NPR 16.93 billion worth of electricity, the statement said. In October 2021, New Delhi approved 39 MW of electricity exports from Nepal to India for the first time, it said, adding that in less than three years, this figure has grown by more than 24 times.



#### Airfares climb up to 25% for Diwali, Onam season

irfares are heading northwards for the festival season with the average one-way ticket price on key domestic Aroutes being 10-15 per cent more for Diwali and 20-25 per cent higher for certain flights to Kerala cities for Onam, according to an analysis. An analysis done by travel portal ixigo for PTI showed that the average one-way economy class fare for non-stop flight on Delhi-Chennai route during October 30-November 5 period is 25 per cent higher at Rs 7,618. This is in comparison to the fare during November 10-16 period last year. For the given comparison period, the ticket price is 21 per cent more at Rs 5.162 on Mumbai-Hyderabad route and 19 per cent higher at Rs 5,999 and at Rs 4,930 on Delhi-Goa and Delhi-Ahmedabad routes, respectively. On certain other routes, fares are higher in the range of 1-16 per cent, as per the analysis. ixigo's Group Co-CEO Rajnish Kumar said travel demand for Diwali is on the rise with airfares higher than last year.

Finance Minister Nirmala Sitharman on Monday held a performance review meeting with heads of public sector banks and asked them to make concerted efforts to garner deposits.

Deposits have been growing 300-400 basis points lower than the credit growth in the last few months, creating an asset-liability mismatch for

During deliberations on the deposit mobilisation, she said that while the credit growth has picked up, mobilisation of deposits could further be improved to fund the credit growth sustainably, and asked banks to make concerted efforts to garner deposits by conducting special drives.

Sitharaman also advised public sector banks (PSBs) to have better relationships with their customers for efficient customer service delivery, an official statement said.

She asked banks to ensure that employees reach out to connect with their customers, especially in rural and semiurban areas.

The minister also urged the PSBs to explore collaboration to leverage their respective strengths by sharing best practices in emerging areas and equip themselves to keep pace with changes in the banking

While acknowledging the efforts made by the banks to improve the asset quality, the the securification of the



minister suggested optimising the scope of resolution and recovery offered by the National Company Law Tribunal (NCLT) and National ReconstructionCompany Ltd (NARCL).

According to the statement, the issues related to digital payments and cyber security framework were also deliber-

ated in the meeting.
Observing that the issues of cyber security should be seen from a systemic perspective, she emphasised the need for a collaborative approach between banks, the government, regulators and security agencies for mitigating cyber

She urged that every aspect of the IT system should be reviewed periodically and thoroughly from the cyber security angle to ensure that the security of the bank systems is not breached or com-

#### **'Devise suitable products** aligning with MSME clusters'

Finance Minister Nirmala Sitharaman on Monday asked Regional Rural Banks (RRBs) to devise suitable products aligning with MSME clusters to increase banking penetration. During a review meeting with chairpersons of RRBs and CEOs of their sponsored bank, the finance minister emphasised active outreach by the RRB branches located in MSME clusters to ensure credit to small and micro enterprises in areas like textile, wooden furniture. leather, food processing, packing materials etc. that hold immense potential for increasing the loan portfolio. Sitharaman also asked sponsor banks and RRBs to recognise the challenges ahead

maintaining asset quality expanding digital services, and ensuring robust corporate governance. During the meeting Sitharaman underlined that all RRBs must have their own upto-date technology stack to stay relevant and noted that digital banking services like mobile banking will be a boon for regions with relatively challenging physical connectivity (like northeastern states and hilly regions). The sponsor banks have a significant role in these endeavours by providing technical assistance, sharing best practices, and ensuring that RRBs have access to the resources they need to succeed, an official statement issued after the meeting said.

### Sebi categories dues worth Rs 76,293 crore as 'difficult to recover'

PNS ■ NEW DELHI

Capital markets regulator Sebi has segregated dues to the tune of Rs 76,293 crore under "difficult to recover" category at the end of March 2024, marking an increase of 4 per cent from the preceding year.

Of this, a huge chunk is on account of cases pending before court-appointed com-

Difficult to recover (DTR) dues are those that could not be recovered even after exhausting all modes of recov-

ery.
"Segregation of such DTR dues is purely an administrative act and this will not preclude the recovery officers from recovering the amount so segregated as DTR as and when there is a change in any of the DTR parameters," Sebi said in its annual report for 2023-24.

As of March 31, 2024, Sebi identified 807 cases as DTR, with a total outstanding of Rs 76,293 crore, up from 692 cases amounting to Rs 73,287 crore the previous year,

according to the report. Among these 807 cases, 36 are pending due to ongoing proceedings in State PID courts, National Company Law Tribunal (NCLT), National Company Law Appellate Tribunal (NCLAT) involving Rs 12,199 crore.

Additionally, 60 cases are before court-appointed committees, with Rs 59,970 crore at stake.

These two categories together account for 95 per cent of the total amount yet to be recovered.

With regard to 140 DTR certificates falling under untraceable category, 131 relate to individuals and nine relate to companies amounting to Rs 13.3 crore and Rs 15.7 crore, respectively.

The Sebi has been disseminating data on the composition of difficult to recover cases from 2021-22 onwards through its annual report in order to enhance transparency of its enforcement proceedings. The markets regulator said a total of 6,781 recovery certificates were generated till March 31, 2024, of which 3,871 recovery certificates were pending as on March 31,

#### Govt's ethanol blending goal will need more sugarcane: Report

PNS MUMBAI

The government's aim to blend 20 per cent ethanol in petrol by Ethanol Supply Year (ESY) 2025 will require more sugarcane utilisation, a report said on Monday.

This is also likely to improve sugar inventory level and cash flows of millers, it added.

An ESY runs from November to October. India's aim to blend 20 per cent ethanol in petrol by

ESY 2025 -- or 990 crore litres annually -- will require effective utilisation of both grain and sugarcane feedstock to increase its supply, Crisil Ratings said in a

The annual ethanol production from grains is expected to see a significant said the report.

increase to 600 crore litre by the next season (this season's production estimate is 380 crore litre), it stated. The balance will have to be

produced by processing ethanol from sugarcane, which is viable given the substantial capacity in place, it said. This, in turn, can help optimise the sugar inventory, particularly considering the high carry-over stock expected at the end of the current season owing to the government restriction on diversion for ethanol production and exports Ratings said. Blending ethanol will help reduce India's dependence on crude oil imports. The ethanol blending rate has steadily risen 200-300 basis points each season since ESY 2021,

#### **OVL** secures contract extension for Vietnam oil blocks

India's flagship overseas oil firm ONGC Videsh Ltd has secured a 16-year contract extension for producing oil and gas in Vietnam, alongside getting three more years to explore a separate block in the contested waters of the South China Sea, officials

Vietnamese authorities have extended the production sharing contract (PSC) for the producing Block 06.1 in the offshore Nam Con Son basin till 2039. They have also granted an eighth extension for exploring for oil and gas in Block 128 in the

South China Sea, according to officials. OVL, the overseas investment arm of state-owned Oil and Natural Gas Corporation (ONGC), holds a 45 per cent stake in Block 06.1, an offshore block located in Vietnam's Nam Con Son Basin. Acquired in 1988, the block has Zarubezhneft EP BV as the operator with 35 per cent interest and PetroVietnam holding the remaining 20 per cent. The block, which produces about 1 million tonnes of oil and oil equivalent gas, recently got a 16year extension of the production sharing contract effective from May 19, 2023.

# Sebi comes out with modalities to migrate to AIF

Markets regulator Sebi on Monday outlined the process and conditions for Venture Capital Funds (VCFs) for migrating to the Alternative Investment Funds (AIF) rules.

The regulator, in July, permitted VCFs registered before the introduction of AIF regulations to transition to the current regulations by becoming migrated venture capital funds. In its circular, the Securities

and Exchange Board of India (Sebi) said that VCFs can now choose to migrate to AIF Regulations to handle unliquischeme tenure ends. This option is available until

A 'Migrated VCF' is a VCF that transitions to become a sub-category of VCF under Category I - Alternative Investment Fund as per the

AIF norms On application requirements, Sebi said that VCFs wishing to migrate must submit their original registration certificate and specific information as outlined by the reg-

The Indian rupee appreciated by 8 paise to close at 83.87 (provisional) against the US dollar on Monday, supported by a weak US dollar and a decline in crude oil prices.

At the interbank foreign exchange, the rupee opened at 83.88 against the greenback, then gained ground and touched an intra-day high of 83.84, and a low of 83.93 against the American curren-



### John Aprea, Beloved Godfather Part II actor, passes away at 83

Ohn Aprea, the actor best known for his portrayal of a young Salvatore 'Sal' Tessio in *The Godfather* Part II, has passed away at the age of 83. 



# ADITI MANGALDAS ON THEEVOLUTIONOFKATHAK

n the recent past, Aditi Mangaldas's live stage debut of Lost...in the Forest took place. A captivating dance spectacle created, choreographed, performed and recorded by her during the pandemic was shown in this presentation. Aditi Mangaldas's extraordinary ability to meld the ancient traditions of Kathak with modern themes was on display. But given that Mangaldas is regarded as one of the best Kathak dancers in the world, both in India and abroad, it was a signal for us to interview her. That is correct! "Yes, classical Kathak dance is the foundation of my dance path. Tradition is a river that never stops flowing, which is why I have always been inspired to push the limits of the traditional form and investigate modern manifestations. My family is diversified, with businessmen on one side and intellectuals with a background in philosophy and science on the other, unlike many Kathak practitioners who come from wellestablished dance traditions," shares Mangaldas, who received training from Pundit Birju Maharaj and Kumudini Lakhia. She was raised in an eclectic environment, which gave her a sense of freedom and an open mind to ideas and creativity. She does not believe that the traditional and the modern are incompatible. She approached Kathak with a "NOW!" mentality. The original sources of inspiration for her recent live stage debut were many. The poet Kunwar Narayan's text, Naav Mein Nadiya (River in the Boat), was provided to her by Shubha Mudgal, who also created and performed the song. "The idea of *LOST...in the forest!* was impacted by these observations. been taught and is able to breathe, she believes in planting the seed of kathak. But when modern sensibilities, imagery, poetry, textures and social concerns are added to this very seed, a tree with strong roots in kathak but a contemporary resonance begins to bloom. The National Sangeet Natak Akademi Award winner continues, saying, "My greatest guru is life itself. My sources of inspiration include people, things we have done together and shared moments. This idea informs my choreography, as does the wisdom of my gurus and the conversations I have with students and peers. Tose Luis Ballester, a senior-to-be at Arizona State, became the first player from Spain to win the US Amateur, fending off Iowa sophomore Noah Kent 2 up Sunday at Hazeltine in the 36-hole match on his 21st birthday.

Ballester, who was the only player in the top 10 of the world amateur ranking to reach the round of 16, took the lead on the second hole and never trailed. He joined Jon Rahm as the only players from Spain to win a USGA tournament. Rahm, who also played for the Sun Devils, won the US Open in 2021. "We have many great Spaniards, many great legends," Ballester said. "Being able to add my name into that history is pretty sweet."

Both finalists gained exemptions for the Masters and the US Open next year, and Ballester also got a spot in the British Open.


Ballester trailed at some point in his last three matches before taking control in the grueling final. Wearing a red polo, yellow shorts on loan from Spaniard he beat in the semifinals, Luis Masaveu, and black socks to match his country's colors, Ballester went 3 up after four holes on two early birdies. He had a 4-up lead at the lunch break on a vintage 82-degree day with a slight late-summer breeze. Kent, who entered the week as a

long shot at No. 560 in the world amateur ranking, refused to fade on the exhausting final day. 'You don't want to be 4 down going into an 18-hole match, but it's been done before, and I kept telling myself that. Everybody in my

corner kept telling myself that," Kent said. "I fought like crazy out there."

He hit a long putt for eagle on No. 25 - the seventh hole on the course - to move within two. Then after falling behind by four with seven holes to go, the player from Naples, Florida, snapped back to win Nos. 31, 32 and 34 and pull within one. On the 34th hole, Hazeltine's signature lakeside No. 16, Ballester hit into the thick rough off the tee and, after clipping a tree, landed in worse shape in the reeds. He wound

up with a bogey. But with his lead down to one, Ballester got back on track to par the final two holes. He nailed the shot off the No. 17 tee within striking range on the green. "I was juiced. I could feel the



adrenaline in my veins, in my forearms," Ballester said. Kent hit into the bunker off the No.

18 tee, then the rough. His last- Ballester began to cry as he thought chance chip overshot the hole. Once the victory was secured,

Wearing a white polo with a Hawkeyes logo, Kent was attempting to become first Iowa player to win the event. The 19vear-old had the clear edge in fan support with dozens in gold Caitlin Clark shirts cheering from the

gallery.
"I knew it was going to be like that from yesterday. I kind of liked it a little bit," Ballester said.

"When the other guy is feeling it and he's kind of grabbing that momentum and you see all the supporters that are going for him, it can be a little depressing. So it's important to face it with a nice mindset."

Kent hadn't trailed since the 12th hole of his second round match until Ballester took the early lead. Kent beat 17th-ranked amateur and Big Ten rival Jackson Buchanan of Illinois in their 18-hole semifinal match.

Ballester, who won the European Amateur last year, took a congratulatory call from fellow Spaniard Sergio Garcia after his

semifinal win. He shined with the short game all week. "I think it's in the blood," Ballester

said. "It has to be."

Hazeltine, which was designed by Robert Trent Jones and opened in 1962 in what was then mostly farmland and now a suburb filled with lakes and cul-de-sacs about 25 miles southwest of Minneapolis, last hosted the men's amateur in 2006. Since then, the course has seen the PGA Championship (2009), the Ryder Cup (2016) and the Women's PGA Championship (2019). The Ryder Cup is due back in 2029.

The event began Monday with 312 players over two courses, the 130th edition of the tournament that has helped launch many greats of golf into a decorated career on the pro tour.

Jones, Arnold Palmer, Jack Nicklaus, Tiger Woods and Phil Mickelson are among the dozens of notable names who won the U.S. Amateur. Jones won the event a record five times. Woods won three. The last European to win the US Amateur was Viktor Hovland of Norway in 2018 at Pebble Beach.


