CM vows push to rural sector

Janmabhoomi 2.0 to be launched in January 2025

Chief Minister Chandrababu Naidu has emphasised the importance of Panchayat Raj and Rural Development for the advancement of rural areas and pledged to strengthen these sectors. Addressing a review meeting, the

Chief Minister noted that while various programmes had transformed villages between 2014 and 2019, the previous government had undermined these systems. He assured that the Panchayat Raj Department would be directed to enhance infrastructure in villages, ennance infrastructure in villages, including provisions for electricity, gas, toilets, and drinking water. Additionally, he highlighted the need for street lights, drainage canals, cement roads, drinking water cumply and solid waster mean comment. supply, and solid waste management centres in every village. Establishing roads and marketplaces to connect nearby areas was also emphasised. The Chief Minister suggested that the Panchayat Raj department should implement a comprehensive plan to meet these minimum requirements shortly.

Naidu also announced that the Janmabhoomi 2.0 programme would resume in January 2025, focusing on development projects in villages with local participation. The Chief Minister conducted a

The Chief Minister criticised the previous government's diversion of funds meant for village infrastructure, leading to subpar conditions. Currently, Rs 990 crore allocated to the Panchayat Raj Department is being released from the Finance Department. He also noted that the

previous administration had neglected the Jal Jeevan Mission, which aims to provide drinking water to every household, causing the State to fall to 19th position in the mission's rankings.
To address this, Naidu announced

an immediate release of Rs 500 crore from the finance department for the Jal Jeevan Mission and set a target to construct 17,500 km of cement roads and 10,000 km of drainage canals over the next five years.

VIJAYAWADA: Finance Minister P Keshav on Tuesday said the government will release Rs 1,452 crore as funds to local bodies in the State to speed up works at the village and ward levels. According to directions from Chief Minister N Chandrababu Naidu, it has been decided to release Rs 998 crore to gram (village) panchayats and Rs 454 crore to urban local bodies, he said. "Chandrababu Naidu directed that these funds be used to speed up works at the village and ward levels. The release of these funds will financially strengthen the local bodies," said the Finance Minister in a press release. Alleging that the erstwhile YSRCP government had weakened local bodies. Amid spiraling nationwide protests over the rape and murder of a trainee doctor at Kolkata's RG Kar Medical College and Hospital, the Supreme Court on Tuesday constituted a 10-member National Task Force (NTF) to formulate a protocol for ensuring the safety and security of doctors and other healthcare professionals.

Terming the incident as "horrific", the apex court excoriated the state government over the delay in filing the FIR and allowing thousands of miscreants to vandalise the

state-run facility.

It also asked the West Bengal government to not unleash the "power of the State" on peaceful protesters and to deal with them with "great sensitivity in this moment of national catharsis".

The 10-member task force headed by Vice Admiral Arti Sarin has been asked to submit its interim report within three weeks.

The Supreme Court, which directed the Central Bureau of Investigation (CBI) to submit a status report on the progress made in its investigation into the killing, also asked the state government to submit a report on the action it has taken against the vandals.

Target is to achieve 15% annual growth rate and \$2 trillion economy by 2047: CS

State Chief Secretary Neerabh Kumar Prasad announced that the Viksit Andhra Pradesh @2047 Vision Document is set to be launched on October 2. Speaking during a virtual conference from the Secretariat on Tuesday, the Chief Secretary discussed the formulation of the Viksit Andhra Pradesh @2047 plan with Special Chief Secretaries, Principal Secretaries, and Heads of Departments (HoDs). The Chief Secretary stated that the Viksit AP @2047 vision plan is being developed with the ambitious goal of achieving a 15% annual growth rate. The plan aims to transform Andhra Pradesh into a \$2 trillion



economy with a per capita income of \$45,000 by 2047.

The Viksit AP @2047 vision document is scheduled to be presented to the State Council of

Ministers on August 28. From September 1 to 15, the state will seek suggestions, advice, and opinions from the public. The Chief Secretary directed the relevant departmental heads to raise awareness

among district and field-level officials from August 21 to 31. A video conference with district collectors is scheduled for August 27. Additionally, mandal, municipal, and village-level awareness meetings will be held from September 10 to 15. Competitions for high school students are planned from September 10 to 14, with prizes

to be awarded on September 15.

The final draft of the AP Vision @2047 will be completed by September 25. The Chief Secretary noted that preparations are underway to launch the Viksit AP @2047 vision document on October 2, in coordination with NITI Aayog, with the event possibly involving both the Prime Minister and the Chief Minister.

Neerabh Kumar Prasad also stated that as part of Viksit AP @2047, five-year action plans will be prepared for each district, aligned with government priorities. The focus areas include eradicating poverty, infrastructure development, demographic management, and improving the ease of living, with departmentspecific plans to be created accordingly.

The move came after Union Minister of State for Personnel Jitendra Singh wrote to Union Public Service Commission (UPSC) Chairperson Preeti Sudan to cancel the advertisement, so that marginalised communities get their rightful representation in government

The commission had, on August 17, issued a notification for the

In the undivided Andhra Pradesh state also, the Congress had broken self-imposed rules regarding the process of selection of candidates for filling vacant Rajya Sabha seats. In 2002, when the Congress was in the Opposition in AP, it had imposed rules for aspirants stating that losers in the 1999 elections would not be considered. By virtue of its strength in

the AP Assembly, the Congress had a chance to get two out six seats. The undivided AP had 18 RS seats, with six of them being filled through biennial elections. There were nearly a dozen aspirants in ÅP Congress, including Dr. KVP Ramachandra Rao, an aide of Dr.YS Rajasekhara Reddy, Yet, those two seats were filled with two leaders who had lost their Lok Sabha seats in 1999. The party had picked Nandi Yellaiah (Siddipet-SC) and T.

(Visakhapatnam). As the Congress had selected a candidate from the Madiga community, it changed plans of the ruling Telugu Desam Party (TDP) headed by then chief minister N. Chandrababu Naidu. He then zeroed in on former chairman APSRTC Akarapu trict. He was considered by the party cadre as the lucky one as he had lost his Assembly seat (Suryapet-SC) to Dosapati Gopal (Congress) in 1999.

Dr. KVP Ramachandra Rao was on the list of aspirants for four biennial elections --2000,2002,2004,2006 – for the Rajya Sabha. But he found no Rajya Sabna. But he found no place in the final list, despite backing from YSR. At last, KVP got an opportunity in 2008. The party okayed renewal of his membership in 2014. Surprisingly, he was the beneficiary of the Congress party in the undivided AP, though the party disappeared from the AP political scenario following the state's bifurcation.

Later, in disregard of political and social equations, Chief Minister Chandrababu Naidu selected two leaders from his own Kamma community Y. V. Satyanarayana (Sujana) Chowdary and K. Ravindra

ONGC officials.

General Elections. In this case too, the party's political needs had played a decisive role.

The erstwhile YSR Congress Party regime headed by former chief minister YS Jaganmohan Reddy too ignored the feelings and sentiments of party leaders and cadre. Jagan created a flutter in political circles as well as among the public by giving his nod for the candidature of Parimal Natwani, associate of Chairman of Reliance Industries Mukhesh Ambani. Natwani is in no way concerned about AP, much less acquainted with its affairs. Perhaps the idea of establishing a good rapport with Mukesh Ambani outweighed other considerations with Prime Minister Narendra Modi too in the picture.

In 2004, Rashid Alwi, former aide of Bahujan Samaj Party (BSP) leader Mayawati joined the Congress after he

the party leadership. He was given RS ticket from Andhra Pradesh by the Congress' leadership. With a view to weaken Mayawati, the Congress took him in its fold for political brownie points.

At times, parties backed candidates cutting across all barriers. The Communist Party of India (CPI) was allotted one RS seat by the Congress since both were alliance partners in undivided AP. CPI(AP state council) proposed Ajiz Pasha, who was heading the Hyderabad city council of CPI.

It appears that these days RS seats are filled solely for political expedience, regardless of the candidate's credentials and the situation at the ground level. Political parties do make and break rules they themselves frame. Who cares for the party leaders and the cadre, much less for the public?

Retired DGP and State coordinator of the Bahujan Samaj Party (BSP), Dr. Poornachandra Rao, has highlighted the ongoing social and political injustices faced by the Backward Classes in Andhra Pradesh, even after 77 years of independence. He pointed out that until 1983, the State was predominantly ruled by a single caste, the Reddys. Since then, power has alternated between two dominant castes, the Reddys and Kammas, leaving Scheduled Castes (SCs), Scheduled Tribes (STs), Backward Classes (BCs), minorities, and other marginalised communities politically underrepresented.

Speaking at the state-level BC Assembly Round Table Conference held in Vijayawada on Tuesday, Dr Rao stressed the urgent need for a comprehensive caste census. He noted that among the 242 sub-castes in the state, over 50% belong to the BCs. SCs make up about 20% of the population, and STs around 7%. However, despite Reddys constituting just 6% and Kammas 5% of the popu-

lation, seat allocation for Parliament, the Assembly, and local bodies has never reflected these proportions. Furthermore, the representation of SCs, STs, and BCs in key positions—such as Vice Chancellors, Heads of Departments, and notably, judges in the judiciaryremains minimal.

Dr. Rao also highlighted the disparity in the number of MLAs from different communities, despite their similar population sizes. He revealed that in the last 16 elections, there have been 658 Reddy MLAs and 549 Kamma MLAs, while the Yadavs had only 46, and the Goudas

(including Shetti Balija) just 68. This means that nearly 40% of the population remains unrepresented in legislative bodies.

He argued that a comprehen-

sive caste census is essential to address this imbalance. Recently, Chief Minister Chandrababu Naidu announced a 33% reservation for BCs in legislative bodies and 34% in local bodies. However, Dr Rao dismissed this as another diversionary tactic, criticising the lack of sincere efforts to implement these promises. He insisted that a caste census is necessary to determine the exact number of seats to be allo-

The court also expressed its deep concern over the name of the victim, her photographs and video clips showing her lifeless body having been splashed all over the media.

Taking a serious note of mob violence in the hospital and the allegation that the Kolkata police fled the scene, the top court ordered deployment of Central Industrial Security Force (CISF) at the hospital to enable doctors to resume work.

"In the aftermath of the brutal incident and the demonstrations which followed, the State Government was expected to ensure the deployment of the state machinery to prevent a breach of law and order.

"It was all the more necessary to do so since investigation of the crime which took place in the precincts of the hospital was under way. We are unable to comprehend how the State was not prepared to deal with the incident of vandalisation of the premises of the hospital," the top court said.

Govt to complete 1.25 lakh houses by year-end: Kolusu

Housing Minister says target is to complete 7 lakh houses by August next year

The Minister for Housing, Information & Public Kolusu Relations, Parthasarathy, has revealed that his government is targeting to complete 1.25 lakh houses by the end of this year. "However, the government aims to complete around seven lakh houses by August next year," he said. Also, he pledged to strive to complete the houses sanctioned

Minister Parthasarathy made a sudden inspection of the housing material godown at the marketing yard at Kankipadu in Krishna district, along with Krishna District Collector DK Balaji, Penamaluru MLA Bode Prasad and State-level Housing officials, on Tuesday.

He verified the stock registers, distribution receipts, material stocks, and other records. Also, he spoke to the Housing officials regarding cement bags, steel, doors and other materials arriving at the stock point and their distribution. Later, officials explained the housing material distribution to the beneficiaries.

Speaking to the media later, Minister Parthasarathy said that the TDP-led NDA government aims to construct houses for all poor people who have no houses by 2029. Also, he asked the beneficiaries to complete their houses by March next year. Otherwise, they may not get any financial support from the government, he

She explained the NREGA components, material stock, and infrastructure facilities in all housing layouts, besides the construction of the houses under

Later, the Minister instructed the officials concerned to take the steps to complete the housing target as part of the 100-day action plan. He made it clear that quality standards should be followed during construction. He directed the Housing Department to complete the 9,000 houses sanctioned to NTR district under Pradhan Mantri Awas Yojana (PMAY) Urban (BLC) and Gramin on a warfooting.

Minister Parthasarathy said that his government is giving utmost priority to the housing scheme for the poor. In the recently held collectors' conference, the Chief Minister said the government is giving priority to this scheme. Everyone should follow the guidelines. Rs 200 cr allocation sought for Vedavathi Lift **Irrigation Scheme**



The CPI State secretary, K Ramakrishna, has urged Chief Minister Chandrababu Naidu to allocate Rs.200 crore in the State budget to complete the Vedavati Lift Irrigation Scheme within three years, highlighting its importance as a lifeline for the drought-prone Kurnool Western region. He emphasised that once completed, the project will bring 80,000 acres under cultivation and provide drinking water to 10 lakh people across 253 villages and two municipalities.

Ban on outside food in hostels

Move to ensure safety of students in government residential homes, child protection homes, and voluntary organisation-managed hostels

Following a tragic incident where four children died of suspected food poisoning at a hostel in Kailasapatnam village, District Collector Swapnil Dinakar Pundkar has implemented a strict ban on external food in all hostels across the district.

The decision, announced at a meeting at the Collectorate meeting hall on Tuesday, is aimed at ensuring the safety of students in government resi-dential homes, child protection homes, and voluntary organisation-managed hostels. "Fortified food is essential for the health and development of our students," emphasised Collector Pundkar. "By enforcing this ban, we are taking a significant step toward safeguarding their well-being.

District Education Officer (DEO) Krishna Chaitanya supported the directive, noting that students currently receive meals from Akshayapatra, a provider renowned for its

nutritious offerings. He also highlighted the need for proper hydration, urging the installation of R.O. plants in hostels to ensure safe drinking water. "It's crucial that stored drinking water is avoided and fruits and vegetables are properly inspected," Chaitanya advised. He further recommended that larger hostels have a designated officer to oversee operations, while smaller hostels should have a lower-level officer to manage daily activities

effectively.

Welfare Officer Anuradha underscored the importance of ensuring that colleges operate only if they have an attached hostel, which should be accurately identified by mandals. She called for regular health inspections, urging the District Medical and Health Officer (DMHO) to assign PHC doctors to monitor student health closely. The Food Inspector raised concerns about food contamination, stressing that expired items must be disposed of immediately and

ly cleaned. "External food poses a risk of contamination, particularly from colouring spices," the inspector warned.

Food Safety Officer G. Sriramulu supported these measures, stating, "Expired food must be promptly discarded to prevent health risks," while Assistant Safety Controller Venkataratnam informed that violations can be reported through a dedicated helpline at 9704009989. In a follow-up meeting, Shanthi Sri, Project Director of the Women and Child Welfare Department, reiterated the ban on external food and called for a review of safety measures. Tribal protest at Ramannadorapalem over land patta omission

Kondhu tribe has been cultivating cashew nuts and paddy on the land for over four decades

A group of 30 tribal families from Ramannadorapalem village in Kotnabilli panchayat staged a protest on Tuesday, demanding the restoration of their land pattas. The Kondhu tribe, classified as a Particularly Vulnerable Tribal Group (PVTG), has been cultivating cashew nuts and paddy on this land for over four decades. The villagers claim that while they were issued land pattas between 1978 and 1988, with their names duly registered in Webland records, the recent land resurvey conducted by the previous YSRCP government omitted these crucial details from the Record of Rights

"We have been cultivating this land for generations, and now, without our pattas, we are in a helpless situation," said a distressed tribal villager. Despite submitting all required documents, including pattadar passbooks, Aadhaar cards, and photographs, their pattas were excluded from the resurvey records. The absence of pattas has severely impacted the villagers, many of whom had taken loans against their land. They now face immense pressure from banks to repay loans or provide IB records, a situation that has pushed them into a financial crisis. They are also

Appa Rao emphasised the need for a field-level supervision mechanism. He instructed district officials to identify both government-approved and illegal organisations through Gram Sachivalayam, Mandal Level Officers, and women protection officers by the end of August.

He stressed the critical roles of departments such as Education, Welfare, Police, Women and Child Welfare, Health, and Sachivalayam in ensuring that these institutions comply with government regulations. Any organisation found to be violating these rules will face strict action, he warned.

Veligonda project works expedited: Nimmala

Minister for Water Resources Development, Nimmala Ramanaidu, announced that the coalition government has expedited the Veligonda project works, attributing the previous slow progress to the negligence of the former YSRCP government.

India's reservoir storage levels surpass 10-yr average

PNS ■ NEW DELHI

The Central Water Commission (CWC) has reported a significant improvement in the live storage levels of India's reservoirs this year, with the current storage exceeding the ten-year average by 14 per cent.

According to the latest Reservoir Storage Bulletin, the live storage available in 150 major reservoirs across the country is 124.016 billion cubic metres (BCM), which is 69 per cent of the total live storage



capacity of these reservoirs. This marks a substantial ing period last year, when the

storage was 111.85 BCM. The current storage also

exceeds the ten-year average, known as 'normal storage', which stood at 108.79 BCM.

Regionally, the storage levels vary across different parts of the country. In the northern region, which includes Himachal Pradesh, Punjab, and Rajasthan, the storage is at 51 per cent of the total capacity, a decrease from last year's 88 per cent and below the normal storage level of 71 per cent. Conversely, the eastern region, comprising Assam, Jharkhand, Odisha, West Bengal, Tripura, Nagaland, and Bihar, has shown improvement, with storage at 53 per cent of capacity, up from 38 per cent last year and better than the normal level of 50 per cent.

The western region, including Gujarat and Maharashtra, also recorded a positive trend, with 72 per cent of total capacity being filled, compared to 68 per cent during the same period last year and 61 per cent of normal storage.



Take no chances!

Mpox is becoming a global concern. While there is no need to push the panic button yet, it is important to remain watchful

n the wake of the COVID-19 pandemic, the world is now facing another significant health challenge: Mpox, previously known as monkeypox. This viral disease, which has traditionally been confined to certain regions of Africa, has seen a disturbing rise in cases across the globe, prompting widespread concern and action from health authorities. Mpox is caused by the monkeypox virus, a member of the Orthopoxvirus genus, which also includes the smallpox virus. The good news is that it is not fatal in most cases and is curable. There is no specific treatment for mpox but most people recover in a few weeks. Supportive care and pain control can help people with good immune systems while those with low immunity can recover with medical treatment. While it is less deadly than smallpox, Mpox can still cause severe illness, especially in those with compromised immune systems. The virus is primarily transmitted to humans from animals, but human-to-human transmission can also occur, particularly through direct con-



tact, bodily fluids, respiratory droplets, or contaminated materials like bedding. Mpox's symptoms include fever, headache, muscle aches, swollen lymph nodes, chills, and a distinctive rash that often starts on the face and spreads to other parts of the body.

As they say, once bitten twice shy, we have just wriggled out of corona pandemic and cannot afford to have another pandemic. It is not an epidemic but can become one if preventive measures are not taken. After a surge in Mpox cases globally Indian airports have ramped up surveillance and precautionary measures to mitigate the spread of the virus. The Ministry of Health and Family Welfare has issued a nationwide adviso-

ry, urging airports to intensify screening processes and ensure that protocols for identifying and isolating potential cases are strictly followed. The World Health Organization (WHO) has reported an uptick in Mpox cases across several regions, with particular concern in areas where the virus had previously been under control. Travellers exhibiting symptoms such as fever, rash, or swollen lymph nodes are being referred for further medical evaluation. Major international airports in cities like Delhi, Mumbai, and Bengaluru are at the forefront of these preventive measures. Special medical teams have been stationed at these hubs to conduct rapid assessments and ensure that any suspected cases of Mpox are swiftly isolated and treated. The focus is not just on inbound passengers; outbound travellers are also being advised to take precautions, particularly if they are heading to regions experiencing outbreaks. While India has not yet reported a significant number of Mpox cases, the proactive measures being implemented at airports are part of a broader strategy to prevent the virus from gaining a foothold in the country. Health experts emphasise that early detection and isolation are key to controlling the spread of Mpox, particularly in a densely populated country like India, where an outbreak could have severe consequences.



THE HIGH COST **OF FAST FASHION**

Sustainable clothing that is produced ethically should be our responsible fashion choice

Fast fashion, which refers to the rapid production of inexpensive clothing based on the latest trends, has transformed the global fashion industry. Gas pricing: Reforms turn into a control regime



Government's decision to grant a 20 per cent premium on natural gas from the state owned new wells has added complexity to the gas pricing regime



he decision of the Union Government to grant a 20 per cent premium over the APM price (a jargon for administered or controlled price) for any natural gas (NG) that state-owned Oil and Natural Gas Corporation (ONGC) and Oil India Limited (OIL) will produce from the 'new wells or well interventions' from their nominated fields has made the NG pricing more complicated. It is an outcome of a thought process that focuses on unshackling the oil and gas industry from price controls to start with but ends up exercising more controls.

Every year, India consumes 59.5 billion cubic metres (bcm) of NG. Of this, nearly 54 per cent or 32.13 bcm is produced domestically, and the balance is met from imports of liquefied natural gas (LNG). Of the domestic gas, around two-thirds is from blocks given on nomination to ONGC and OIL and from fields given under the New Exploration and Licensing Policy (NELP) INDIA CONSUMES (launched in 1999) as well as those given to private firms before the NELP. NG supplies from the aforementioned fields (known in common parlance as 'legacy fields') are governed by a particular pric-Before April

2023, under the pricing guidelines effective since November 2014, supplies from these fields used to be a weighted average (WA) of prices of NG at four international locations: Henry Hub (the USA), Alberta Gas (Canada), NBP (National Balancing Point) (the UK), and Russian Gas. The prices used for arriving at the WA were over twelve months. It was revised every six months in a financial year (FY).

The four global hubs have fairly mature gas markets and the prices obtained there are pretty reasonable. Moreover, considering that the prices for twelve consecutive months were used for arriving at the WA, it smoothened out the month-to-month variations thereby ensuring that the price to the consumers was 'stable'. From April 1, 2023, the government changed the above system based on the recommendations of the Kirit Parikh committee (2022). Under the new formula, for any given month, the price expressed per million

British thermal units (Btu) (energy units used globally for setting NG prices) is arrived at by taking 10 per cent of the monthly average of the basket of Indian crude oil in the preceding month. The price thus calculated is subject to a price band of US\$4 - 6.50 per Btu. The shift to link the price of NG with the crude oil price is flawed as natural gas is not a replacement for crude oil. The replacement for crude oil. The pricing of NG has to be on its own, especially when nearly half of the gas is used for urea production and power generation. Given the intimate connection of these sec intimate connection of these sectors to food security and the need for affordable electricity (especially, for farmers and poor household consumers) and heavy subsidies are involved, the gas price has to be 'reasonable' and 'stable'. While the earlier formula met both hese requirements, the new one effective from April 2023 doesn't as the volatility in crude prices and monthly revisions in NG price linked to crude can create uncertainties for both sectors. To avoid this, the government has put a

price band. What this means is even when the price determined based on crude inkage turns out to be higher (at the current Indian basket price of USD 77 per barrel, the NG price comes to US\$ 7.7 per Btu) than the ceiling of US\$ 6.50 per Btu, the price will be set at US\$ 6.50 per Given the movement in crude price since April 2023 and considering that in the near term, it will continue to rule well above US\$ 75 per barrel, the formulabased price will always be much more than US\$ 6.50 per Btu. So, the ceiling price will be the price to consumers thus rendering the formula redundant. Effectively, thus there is control on the gas price for two-thirds of domestic production and that too at a level, the government wants. wonders whether a premium of 20 per cent allowed on gas supplied from the so-called 'new wells' or well interventions in the nomina-tion fields of ONGC and OIL will make any difference to the situation on the ground.

Applying a 20 per cent premium to the formula-determined price of US\$ 7.7 per mBtu (77x0.1), we get US\$ 9.24 per mBtu (.7x0.1), we get US\$ 9.24 per mBtu. But, then there is a cap of US\$ 6.50 per mBtu. So, the price remains at US\$ 6.50 per Btu. The purpose of giving premiums is defeated. On the other hand if the government intends to hand, if the government intends to build a 20 per cent premium on the ceiling price and give US\$ 7.8 per mBtu then, it makes no sense to put a cap in the first place. The moot point is: if anyway ONGC and OIL are to be given a good price, let this be driven solely by he formula and nutting a cap i unwarranted.

At least, there is an element of 'predictability'; firms on their own can calculate as to what price they will be getting. But, here we have an APM price namely US\$ 6.50 per mBtu (call it base price) that is arrived solely at the discretion of the bureaucrat. And, yet another price for supplies from the so-called 'new wells' or 'well interventions' which is arrived at by adding 20 per cent to this. This too is at the discretion of the bureaucrat. Moreover, which fields get the benefit of interventions will also be at his discretion.

Even the pricing of the remaining one-third of domestic NG supplied from the so-called deep/ultradeep and high-pressure/high-temperature fields (KG-D6 operated by Reliance Industries and neighbouring KG-DWN-98/2 operated by ONGC in Krishna-Godavari basin off the Andhra Pradesh coast fall in this category) isn't free from 'discretion' and 'arbitrariness'.

One Technically though, the firms can go for competitive bidding to determine the price for such supplies (referred to as a 'premium' price), this too is subject to a ceil-ing linked to the prices of alternate fuels including fuel oil, naphtha, and LNG. On taking charge in 2014, the Modi – government started the process of reforming gas pricing by introducing formula-based pricing for legacy gas and thereafter in 2016 by permitting market-based pricing for supplies from deep/ultra-deep and highpressure/high-temperature fields. But, it has ended up exercising control of both. Meanwhile, the Kirit Parikh committee had recommended the de-regulation of difficult gas fields' prices by January 1, 2026, and the de-regulation of APM prices for gas supplies from the legacy fields by January 1, 2027. But, the government is silent on these recommendations. In fact, by adding more categories (read: 'new wells' and 'well interventions'), it has given a signal that the administered/controlled pricing regime for NG and attendant bureaucratic red tape is here to stay.

Healthcare under siege: Rising violence, gender disparity, and the fight for justice

The silent struggles of healthcare workers, often overlooked, reveal a disturbing reality of increasing violence in hospitals and clinics

uring his Independence Day address, the Chief Justice of Telangana proudly announced that he had recommended a Protection of Advocates Act to the state government. The applause that followed made me think of the resident doctors marching through the rain in Delhi, gathering their courage to demand a law that protects healthcare professionals from the increasing violence in spaces that are supposed to be the safest.

In 2019, the draft Healthcare Service Personnel & Clinical Establishments Bill was introduced, seeking to penalise those who assault healthcare workers. However, the Home Ministry opposed it, stating that no separate law was nec-

essary for doctors. A Right to Information (RTI) response from the Health Ministry later revealed that the draft Bill had been withdrawn. On July 26, 2024, the Health Minister further rejected the idea of a central law, asserting in the Lok Sabha that the newly enacted BNS and BNSS laws provided adequate protection for medical professionals.

Despite this, healthcare professionals' anger is justified. Why

doesn't the public show the Health Reports*, 32% of same solidarity as they did during the Nirbhaya case, where the horrific rape and murder of a physiotherapy student led to nationwide outrage? Even amid a national strike by the Indian Medical Association (IMA) over the rape and murder of a doctor in Kolkata, another tragedy was overlooked—the brutal killing of a nurse, a single mother, who went missing from a hos-Rudrapur, Ittarakhand. Her body was found in Uttar Pradesh after she had been strangled and

bludgeoned to death. Similarly, in Gujarat in 2020, an Accredited Social Health Activist (ASHA) worker was raped while on duty. According to a study published in the *Journal of Global

ASHA workers face sexual violence, while 88% experience emotional and economic abuse. Disturbingly, 12% report sexual violence from their husbands, and 64% from beneficiaries and their families. These incidents highlight the pervasive threat healthcare workers face. Last year, a doctor allegedly raped a nurse at a clinic in northeast Delhi. In another case, a Bhopal doctor was accused of confining and raping a 19-year-old patient. Just recently, at the same medical college in Bhopal, a resident doctor was suspended for inappropriate behavior with a cancer patient. Violence against healthcare workers also extends beyond sexual violence. Last month in Manipur, armed assailants of the nurse in Rudrapur.



attacked a children's hospital, and two weeks later, a patient was shot dead at Delhi's GTB Hospital due to mistaken iden-

These violent acts, whether committed against doctors, nurses, paramedics, or patients, must be addressed with the same urgency and seriousness. However, the IMA has yet to make a statement regarding the rape and murder

Have they suspended the membership of the Principal of rently led by women doctors, RG Kar Medical College, implicated in the Kolkata case? Has the Indian Orthopaedic Association (IOA) taken action against its accused member?

A journalist recently tweeted during a doctors' protest, asking where the female doctors were in leadership positions. This raises a crucial point. According to a study published in PLOS Global Public Health, out of 46 professional medical associations in India, only 9 (less than 20%) are headed by women. Neither the Academy of Hospital Administration (AHA) nor the IOA has ever had a female president. This is despite women demonstrating remarkable leadership in

healthcare—both my hospital

and more than 50% of the heads of departments are women. Clearly, women are capable of leading in healthcare, but they remain under-represented in top positions. Of the 64 individuals currently serving as presidents and secretaries of the 32 state chapters of the IMA, only

three are women. It's time to move beyond token representation. Women doctorsmust be given more leadership opportunities. One of the most balanced and comprehensive statements on the issue of healthcare violence has come from Women in Global Health India. Their statement calls for an end to sexual violence in all healthcare settings, and it emphasizes that

anyone-whether doctor, nurse, paramedic, or even political party member—who commits such violence must face severe consequences.

Eleanor Roosevelt, who played a key role in drafting the Universal Declaration of Human Rights, once famously said that human rights begin in small, often overlooked places.

In the context of today's healthcare system, that means the seminar room of RG Kar Medical College or the private hospital in Rudrapur—spaces where violence has occurred, but which remain untouched

Sowing of paddy, the main kharif crop. begins with the onset of southwest monsoon in June, and harvesting takes place from September. Additionally, the area sown to pulses increased to 120.18 lakh hectare till August 20 of the ongoing season, from 113.69 lakh hectare in the same period last year, the ministry said in a statement. There was a rise in coverage of 'arhar' to 45.78 lakh hectare from 40.74 lakh hectare. Area sown to 'urad' was 28.33 lakh hectare against 29.52 lakh hectare. The area under coarse cereals and 'Shree Anna' (millets) increased to 181.11 lakh hectare from 176 lakh hectare in the year-ago

The Reserve Bank of India's (RBI's) inflation targeting regime has worked well and need not be abandoned in favour of a more discretionary regime that could be risky and counterproductive,

a new research paper has said.
The paper titled 'Inflation
Targeting In India: A Further
Assessment' said the weight of food-price inflation in the CPI inflation basket should be reduced to better

reflect the circumstances of Indian households. 'The RBI's inflation targeting regime worked well.

Given this record,

radical changes

such as broadening its mandate or abandoning the target in favour of a more discretionary regime would be risky and

counterproductive," it said. The paper is authored by economists Barry Eichengreen (University of California, Berkeley) and Poonam Gupta (NCAER). In contrast, the paper noted that the 4 per cent point target, +/-2 per centage point tolerance band and focus on headline inflation remain broadly appropriate.

"That said, the regime can be tweaked to improve performance," it suggested.

The government and the RBI signed an inflation-targeting agreement in February 2015 and amended the RBI Act in May

five years.

India & Lanka sign pact for power generation

The Sri Lankan government and a state-run Indian firm on Tuesday signed an agreement to develop infrastructure for storage, regasification and LNG supply for a combined cycle power plant in the island nation, according to the power and energy ministry here.

The memorandum of understanding (MoU) was signed between Sri Lanka's LTL Holdings Limited and India's Petronet LNG Limited for the infrastructure development of the Sobadhanavi Combined Cycle Power Plant at Kerawalapitiya, north Colombo.

The Sri Lankan Minister of Power and Energy, Kanchana Wijesekera, and the Deputy High Commissioner of India, Satyanjal Pandey, signed the MoU at a ceremony here.

Wijesekara said the power generation could be as low as fifty per cent less here than generation through fuel usage. "MOU for the development

Antfin Singapore Holding on Tuesday divested a little over 2 per cent stake in online food delivery firm Zomato for Rs 4,771 crore through open market trans-

Antfin Singapore Holding Pte is an arm of Ant Financial Group, while the latter is a part of Chinese e-commerce giant Alibaba.

According to the bulk deal data available on the BSE, Antfin Singapore Holding sold 18,54,40,550 shares in two tranches, amounting to a 2.1 per cent stake in Gurugram-based Zomato.

The shares were disposed of in the price range of Rs 257.17-257.46 apiece, taking the transaction value to Rs 4,771.66 crore.

After the share sale, Antfin Singapore Holding's stake has been reduced to 2.14 per cent from 4.24 per cent.

Details of buyers of Zomato's shares could not be ascertained. Shares of Zomato rose 0.27 per cent to close at Rs 263 apiece on the BSE. In March this year, Antfin Singapore Holding pared a 2 per cent stake in Zomato for Rs 2,827 crore.

'SC ruling on royalties and taxes will affect profitability'

Moody's Ratings has said the Supreme Court ruling on royalties and taxes will be credit negative for mining compa-nies like Tata Steel, UltraTech Cement, and Vedanta Resources Ltd, as it will dent their cash flows and affect their prof-

The Supreme Court in its order on August 14 allowed mineral rich states to seek dues from April 1, 2005 on royalty and tax on mineral rights and mineral-bearing land from the Centre in a staggered period of 12 years. "The retrospective taxes are credit negative for companies with mining operations in India such as Tata Steel Ltd (Baa3 stable), UltraTech Cement Ltd (Baa3 stable), JSW Steel Ltd (Ba1 stable) and Vedanta Resources Ltd (Caa3



negative) because the instalment payments will dent their cash flows," Moody's Ratings said in a statement.

"These companies will have to pay state taxes going forward that will hurt their profitability," it said. "While the companies' retrospective taxes could be significant, the effect on their cash flows will be eased because owed taxes will be paid in installments over 12 years beginning 1 April 2026," Moody's Ratings said.

Companies' ability to pass on

higher costs to customers could also mitigate the effect on their profitability, as per the state-ment. However, the new taxes as well as denting cash flows, could prompt them to recalibrate their capital spending plans, it said.

During the hearing on July 31, the Centre and mining companies have opposed the demand of states for refund of royalty collected since 1989.

The July 25 verdict had overruled a 1989 judgement and subsequent decisions of the apex court, which held that only the Centre has power to impose royalty on minerals and mineral-bearing land.

Some opposition-ruled mineral rich states then sought refund of royalty levied by the Centre and taxes from the mining companies since the 1989

Indian cos to spend USD 45-50 bn in capex: Moody's

Moody's Ratings on Tuesday said rated Indian companies will spend USD 45-50 billion annually over the next 1-2 years towards capex as companies boost capacity, with the country's most valued firm Reliance Industries alone accounting for 30 per cent of the spendings.

Investments to increase vertical integration and achieve net zero targets will also keep spending high, Moody's Ratings said in a report on cor-

porates in India and Indonesia. "Rated Indian companies' capex will remain elevated at around USD 45-50 billion annually over the next one to two years. With an annual capex budget of around USD 15 billion spread across its different business segments, Reliance Industries alone will account for around 30 per cent of the portfolio capex," Moody's Ratings

The oil and gas sector and Reliance Industries will collectively account for over 60 per cent of the rated Indian portfolio's spending over the next cou-

Moody's said the seven rated oil and gas companies in India will also account for around 30 per cent of rated Indian companies' capex.

These companies will spend around USD 15 billion annually to expand existing capacity and make green energy investments to reduce carbon transi-

tion risk. For instance, Oil and Natural Gas Corporation Ltd. (Baa3 stable) and Indian Oil will spend USD 6 billion and USD 4 billion, respectively, in each of the next two years on reserves addition, downstream integration and energy transition, Moody's added.






Jayprad Desai's sensational spin on Phir Aayi Haseen Dillruba

hen Jayprad Desai stepped into the world of *Phir Aayi* Hasseen Dillruba, he wasn't merely crafting a sequel but div-ing into a universe already sketched out by the visionary Kanika Dhillon. The story of Haseen Dilruba had already left an indelible mark and now, with the sequel, he found himself tasked with amplifying the chaos, the drama and the sheer pulpiness of the tale.

He admits that this was a different beast altogether! Phir Aayi Hasseen Dillruha wasn't just a continuation: it was an expansion, a world that was larger, bolder and more daring than its predecessor. "The story was already written when it came to me," he shared, acknowledging the challenge of taking something familiar and pushing it to new, flamboyant heights. "I wanted to make the ride more





into a world almost hysterical in its unbelievability vet so artfully crafted that they couldn't help but be swept along. He envisioned a film that would make viewers fasten their seatbelts and prepare for a flambovant, reckless ride, one that was unapologetically bold in its presentation. For him, the film's distinct visual style was crucial in achieving this.

He collaborated closely with the production designer, the director of photography (DOP) and the costume designer to create a cinematic language that would milk the pulp aesthetic for all it was worth.

The use of colour was particularly significant. He detailed how each character's arc was visually represented through a specific colour palette—Rani, for instance, was almost always clad in red, a hue that captured her fiery and passionate nature. Rishu, on the other hand, was bathed in blue, symbolising his more calm and introspective personality. Abhimanyu, whose character evolved dramatically throughout the film, started with a palette of innocence that slowly shifted to green, reflecting his descent into envy and darker emotions.

"All these subtle details were designed to help the audience buy into the larger-than-life story," he explained. The use of motifs like rain, the Taj Mahal and the real locations of Agra further grounded the film in a sense of reality, even as the narrative spiraled into the realms of the fantastical.

But it wasn't just about the visuals. He was determined to ensure that beneath all the flamboyance and madness, the humanity and innocence of the characters remained intact. This was a story that, despite its outrageous twists and turns, had to resonate on an emotional level. "No amount of technical finesse can replace the need to touch the audience emotionally," he noted. "That's what keeps the audience rooting for these characters, despite their flaws."

The process of developing these complex, layered characters was as

intricate as the story itself. He inherited the characters of Rani and Rishu from the first film, but as the new story unfolded they were thrust into even greater crises, revealing facets of their personalities that had previously been hidden. Like in real life, we evolve when confronted with new challenges," he observed. These characters were no different—they grew, they faltered, and they became more colourful and edgy, but he was careful never to lose their

inherent humanity.

One of the most challenging aspects of the film was balancing the various genres it straddled-romance, drama and thriller—all while maintaining the high-pitched, passionate tone that the story demanded. Filming on real locations, such as a railway bridge over the Yamuna River, added an extra layer of difficulty. He recalled a particularly memorable moment involving a 16-foot animatronic crocodile that they had built for a

"Shooting on a real bridge with a real train on a real river was challenging yet amusing," he shares. As they were preparing, a train passed by, and the passengers, unaware that the crocodile was fake, began snapping pictures, convinced they were witnessing a wild creature being captured. "Those kids on the train will probably tell their children one day about the time they saw a giant croc-

odile being pulled from the river." With Phir Aayi Hasseen Dillruba, he understood that the key to making such a larger-than-life narrative work was to embrace its implausibility and lean into it fully. "The thing about pulp is that you cannot take away its larger-than-life experience," he reflected. "You have to make the audience drown in it, to tend to their disbelief and then excite them with the twists and turns."

This film marked a significant step in his growth as a director. Having previously worked on projects in vastly dif-ferent genres, such as the sports biopic Kaun Pravin Tambe and the web series Mukhbir, Desai has shown a remarkable ability to adapt and innovate. With Phir Aayi Hasseen Dillruba, he not only milked the pulp to perfection but also infused it with a distinct cinematic language that made the story more than just a series of sensational twists.

As for his future projects, he hinted at a diverse lineup, a con film inspired by real-life events, a pure romance, and other genres yet to be explored. His advice to aspiring filmmakers is simple yet profound: "Be yourself. Don't ose your identity in trying to cater to what you think the audience wants. Maintain your style, find your voice, and let your passion shine through. It's infectious.

Navigating through Cyanotic and Acyanotic heart defects

here has been a concerning rise in the incidence of congenital heart defects (CHDs) in children in recent years. CHDs are structural abnormalities of the heart that are present at birth and can range from mild to severe. These conditions can significantly impact a child's health and require prompt diagnosis and treatment. CHDs can be broadly categorized into two types based on the presence or absence of cyanosis, a bluish tint to the skin caused by low oxygen levels in the blood. CHDs affect 8 to 9 out of every 1,000 live births, with approximately 25% considered critical congenital heart defects (CCHDs). The incidence of CHDs increases to 2-6% for children with Down syndrome. While the exact causes are not fully understood, genetic factors, maternal health conditions like diabetes, and exposure to certain medications or infections during pregnancy may increase the risk. Early detection through prenatal screening and prompt treatment are crucial for managing CHDs and improving outcomes for affected children.

Cyanotic congenital heart diseases (Cyanotic CHDs)

Cyanotic CHDs lead to insufficient oxygenation of the blood. causing the "blue baby examples include:

Tetralogy of Fallot (TOF) TOF consists of four heart defects: ventricular septal defect (VSD), pulmonary stenosis, right ventricular hypertrophy, and an overriding aorta. These defects reduce blood flow to the lungs and mix oxygenated and deoxygenated blood,

resulting in low oxygen levels throughout the body. Symptoms include difficulty breathing, fatigue, and a characteristic blue tint to the skin.

• Transposition of the Great Arteries (TGA)

In TGA, the positions of the pulmonary artery and the aorta are switched, creating two parallel circulations. Oxygenated blood cycles within the lungs, while deoxygenated blood cycles within the body. This condition is life-threatening and requires immediate surgical correction to re-establish normal blood flow and oxygenation

Tricuspid Atresia

Tricuspid atresia involves the absence of the tricuspid valve, preventing blood flow from the right atrium to the right ventricle. Blood must bypass the blockage through an atrial septal defect (ASD) or a VSD to reach the lungs. This condition leads to significant oxygen deficiency and requires surgical intervention to ensure adequate blood

flow and oxygenation.

• Total Anomalous Pulmonary Venous Return (TAPVR) In TAPVR, the pulmonary veins incorrectly drain into the right atrium or systemic veins instead of the left atrium, mixing oxygenated and deoxygenated blood. This defect necessitates surgical correction to redirect the pulmonary veins to the left atrium, ensuring proper oxygenation.

Acyanotic Congenital Heart Diseases (Acyanotic CHDs) Acvanotic CHDs do not typically cause cyanosis but car lead to heart failure and other complications if untreated.

Common examples include: Atrial Septal Defect (ASD)

An ASD is an opening in the septum between the right and left atria, allowing oxygenated blood to flow from the left atrium to the right atrium. This increases pulmonary blood flow and can lead to complications such as atrial arrhythmias and pulmonary hypertension. Treatment may include surgical or catheter-based closure.

Ventricular Septal Defect (VSD)

A VSD is an opening in the septum between the right and left ventricles, allowing oxygenated blood to flow from the left ventricle to the right ventricle. This

increases pulmonary blood flow and can cause heart failure if significant. Smaller VSDs may close on their own, while larger ones may require surgical repair.

Patent Ductus Arteriosus (PDA)

PDA is the persistence of the ductus arteriosus, a fetalblood vessel, after birth. This allows blood to flow from the aorta to the pulmonary artery, increasing pulmonary blood flow and potentially leading to heart failure and pulmonary hypertension

Treatment options include medication, catheter-based procedures, or surgery to close

the ductus arteriosus. Coarctation of the aorta

Coarctation of the aorta is a narrowing of a portion of the aorta, increasing pressure before the narrowing and reducing blood flow to the lower body. This can cause hypertension and heart failure if untreated. Treatment typically involves surgical or catheter-based interventions to widen the narrowed segment.

Diagnosis and treatment

Understanding and diagnosing these conditions involve clinical examination, echocardiography, and sometimes advanced imaging techniques such as MRI or CT scans. Treatment options vary depending on the specific defect and its severity, ranging from medical management to interventional procedures and surgery.

Early diagnosis and intervention are crucial for improving outcomes and quality of life for children with congenital heart defects. By recognizing the signs and symptoms of both cyanotic and acyanotic CHDs, healthcare providers can ensure timely and appropriate treatment, helping these children thrive and lead healthy lives.

Visser hammered pacer Nalin

Nipiko for six sixes in an over that also included three no

balls. The 28-year-old right-handed batter, who learned the ropes in Sydney grade cricket, was playing in only his third T20I, comes with the reputation of being a genuine power-hitter, who once topped the shot-speed session by Hype Cricket Academy in

New South Wales, clocking a shade over 160 kmph. His big-hitting ability was evident in his knock against Vanuatu -- 132 off 62 balls with five fours and 14 sixes.

"It was clean hitting (by Visser). We did not know it was a world record, and later it was mentioned during the innings break.
"But happy for him, and

happy that we managed a win. Looking forward to the next match," Samoa skipper Jasmat Caleb replied to a PTI query. Samoa will face bitter rivals Fiji in their next EAP match Oualifier Wednesday.

Previously, there were five occasions when a bowler conceded 36 runs in an over and they were Stuart Broad

(2007), Akila Dananjaya (2021), Karim Jannat (2024), Kamran Khan (2024) and Azmatullah Omarzai (2024). Broad conceded six sixes in as many balls against Yuvraj Singh of India in the 2007 T20 World Cup, while Windies batsman Kieron Pollard achieved the feat against Dananjaya during a bilateral T20I at Coolidge, Antigua.

Nepal's Dipendra Singh Airee creamed sixes off Qatar's Kamran Khan in the ACC Premier Cup, while Windies'
Nicholas Pooran hit

sixes during the T20 World Cup this June at Gros Islet. Rohit Sharma and Rinku Singh combined to take 36 runs off Afghanistan pacer Karim Janat at Bengaluru during a bilateral T20I that India won in the first-ever second Super Over.

Pop-ranked Jannik Sinner and women's No. 2 Ayrna Sabalenka earned straight-set victories in the finals of the Cincinnati Open, the first titles at the tournament for both plavers.

Sabalenka on Monday defeated Jessica Pegula 6-3 7-5 for her first title since the Australian Open in January.

Sinner, who turned 23 on Friday, beat American Frances Tiafoe 7-6(4) 6-2 to become the youngest Cincinnati champion since 21-year-old Andy Murray won in 2008. "I'm very happy to be in the position where I am," Sinner

"I'm just trying to keep going this way mentally. It's important to recover to be ready for New York. That's the most important thing." The US Open begins on

August 26 in New York. Sinner and Tiafoe were both playing in their first Cincinnati finals with their previous best results being the third round. Tiafoe forced a tiebreak in the first set, but three straight

errors led to a 7-6 defeat. Sinner had a 5-1 lead in the second before Tiafoe saved three match points to make it 5-2 before Sinner was able to serve out for the win.

Tiafoe had a less conventional path to the final. He won the first set in the quarterfinals on Saturday before Hubert Hurkacz retired with a calf injury then saved two match points to defeat Holger Rune in three sets in the semis.

An American man hasn't won the title in Cincinnati since Andy Roddick in 2006.

Sabalenka moved up a spot to No. 2 in the rankings before the match, then didn't lose a set en

route to her 15th WTA title. She had never gotten past the semifinals at Cincinnati, losing three times in that round. The 26-year-old Sabalenka can

now be considered a favorite at the US Open. The Belarusian missed Wimbledon with a shoulder injury, then returned to the tour at Washington two weeks ago.

"I would say that I'm really playing great tennis," Sabalenka said.


