n a first, Congress-led INDIA Bloc of Opposition Tuesday **_**parties on submitted a notice to bring a motion in Rajya Sabha for the removal of Vice President Jagdeep Dhankhar, accusing him of "partisan" conduct as the chairman of the Upper House. Dhankar is Chairman of the Upper House. If the motion is moved, these

parties need a simple majority to get it passed, but they do not have the requisite numbers in the 243-member House. Opposition members, however, insisted that it was a "strong message to fight for parliamentary democracy". Parliamentary Affairs minister Kiren Rijiju dubbed the move as "extremely regrettable" and said the government is very proud of Dhankar.

Congress leaders Jairam Ramesh and Naseer Hussain submitted the notice signed by 60 Opposition Members of Parliament, including from the Congress, Rashtriya Janata Trinamool Congress (TMC), Communist Party of India (CPI), Communist Party of India (Marxist) CPI-M, Jharkhand Mukti Morcha (JMM), Aam Aadmi Party (AAP), Dravida Munnetra Kazhagam (DMK), Samajwadi Party (SP), to Rajya Sabha Secretary General PC

spearheaded by the Congress, comes in the wake of verbal clashes between Opposition parties and the Rajva Sabha chairman. The Opposition has been upset with Dhankhar over multiple issues. The latest trigger was allowing Bharatiya Janata Party (BJP) members to raise the allegations of links

On behalf of the Opposition, between Congress leaders and organisations backed by billionaire investor George Soros which the ruling party claims are involved in "anti India activities".

> The Opposition said his conduct of the House on December 9, 2024, was particularly one-sided and totally unfair, and said he was "encouraging and provoking" the Treasury Benches to make outrageous remarks. Identify illegal Bangladeshi immigrants, orders LG

Delhi Governor's secretariat has written to the Chief and Commissioner asking for initiating "strict action" against illegal Bangladeshi immigrants residing in the National Capital. According to Raj Niwas officials, the LG Secretariat has asked the Chief Secretary and the Police Commissioner to a special drive spanning over two months to identify illegal Bangladesh immigrants in Delhi and take strict action as per the extant rules in a time-bound The move comes in wake of

the representation made by the delegation of Ulemas and Muslim leaders from Dargah Hazrat Nizamuddin and Basti Hazrat Nizamuddin to Delhi Lieutenant Governor Vinai Kumar Saxena on Saturday. They had expressed deep concern about the attacks being undertaken on the Hindu and other minority communities in Bangladesh and accordingly, demanded stringent action Bangladeshi infiltrators residing in the National Capital. "Prominent Ulemas and

Muslim residents have Illegal requested that Bangladeshi infiltrators should neither be given houses on rent nor should they be given employment by any establishment. Further, they have requested that their children should not be given admission in any government or private school. The Muslim leaders have also demanded removal of illegal

infiltrators from roads, footpaths, parks and other government lands, over which they have forcefully encroached and documents like Aadhar Card, Voter ID, or any other government document illegally acquired Bangladeshi infiltrators be cancelled immediately. They have also demanded that a special drive, like in the past, should be launched to the illegal Bangladeshi immigrants in Delhi and they should be sent back immediately," the letter from the LG Secretariat read. Meanwhile, Chamber of Trade and Industry (CTI) chairman Brijesh Goyal has

urged business communities to reduce their business activities with Bangladesh. The CTI has warned that if the atrocities on Hindus in Bangladesh do not stop, then all the traders of Delhi and the country will end all trade with Bangladesh. "There is also resentment among the businessmen of Delhi against the Mohammad Yunus government of Bangladesh," he said. Security was stepped up

outside the Bangladesh High Commission here Tuesday, as hundreds of people from various organisations, including the Swayamsevak Sangh (RSS), held a protest

march at Chanakyapuri against alleged atrocities and human rights violations against Hindus and other minorities in Bangladesh. Police had put barricades on the Teen Murti Marg on both the carriageway outside the Chanakyapuri police station where hundreds of people from various organisations gathered. Traffic regulated in the area with vehicles redirected alternative routes.

There have been allegations of over 200 attacks on Hindus in various districts of Bangladesh since the fall of the Sheikh Hasina-led Awami League government

Kamran Haider's arrest marked a significant step towards dismantling the international human trafficking syndicate, the NIA said in a statement. Along with his co-accused, Haider was allegedly directly involved in arranging flight tickets and documents for the victims and facilitating their "illegal border crossings" with the help of contacts in the Golden Triangle region. The Golden Triangle refers to a large, mountainous region comprising parts Myanmar, Thailand

SC seeks details from Allahabad HC on Justice Shekhar Kumar's speech PIONEER NEWS SERVICE

Taking cognisance of news reports, the Supreme Court (SC) on Tuesday called for details from the Allahabad High Court on the controversial speech of Justice delivered at a Vishva Hindu Parishad (VHP) Legal Cell function at Prayagraj. "The Supreme Court has taken note of the newspaper reports of a speech given by Mr Justice Shekhar Kumar Yadav, a sitting judge of the High Court of Judicature at Allahabad. The details and particulars have been called from the High Court and the matter is under consideration (sic)," the SC statement read. Sitting judge Justice Yadav the controversial remarks on December 8 while addressing a convention of the legal cell of the Vishva Hindu Parishad in Allahabad. A day later, videos of the judge speaking on provocative issues, including the law working according to the majority, were circulated widely, triggering strong reactions from various opposition parties which questioned his reported statements and labelled it as questioned hate speech. He urged for Uniform Civil Code, blaming

community. "I have no hesitation in stating that this is Hindustan, and this country will function according to the wishes of the majority living here. This is the law. It is not about speaking as a High Court Judge; rather, the law operates accordance with the (majority). bahusankvak Consider this in the context of a family or society - only what ensures the welfare and happiness of the majority will be accepted," Justice Yadav

The judge also used the term "kathmullah", a slur against Muslims. Referring to extremists as "kathmullah", he said that the country should be circumspect about them. "But these kathmullah... this

may not be the right word... but I won't hesitate to say it because they are harmful to country...they detrimental, against the nation, and people who incite the public. They are the kind of people who do not want the country to progress, and we said Justice Yadav at VHP's legal cell function. Kapil Sibal, president of the Supreme Court Association called for the impeachment of Justice Yadav. He also urged the

Prime Minister, Home Minister and Members of Parliament from the ruling party to extend support for impeaching Justice Yadav. Meanwhile, Lok Sabha MPs Ruhullah Mehdi Ásaduddin Owaisi initiated signatures seeking Parliament,

impeachment against Justice Yadav.

Communist Party of India (Marxist) leader Brinda Karat, has written to the Chief Justice of India (CJI) Sanjiv Khanna, demanding action against the Judge. Campaign for Judicial Accountability and Reforms (CJAR) headed by Prashant Bhusnal also urged the CJI to initiate action seeking In house Inquiry and suspension of the Judge for violating the code of conduct for Judges.

No mismatch in **Maharashtra** votes polled and **VVPAT tally: ECI**

the Election Commission **⊥** of India (ECI) Tuesday said no mismatch was found between the votes polled and corresponding tally of Voter Verified Paper Audit Trail (VVPAT) slips in random counting in the last month's Maharashtra Maharashtra month's Assembly elections. The mandatory counting of VVPAT slips from five randomly selected polling stations in each assembly constituency completed successfully, the

ECI said in a statement. Opposition parties in the state had questioned the integrity of Electronic Voting Machines (EVMs) after the ruling BJP-led Mahayuti coalition won a landslide victory in the November 20 elections. The counting of VVPAT slips aims to verify the tally of votes recorded EVMs against the corresponding VVPAT slips, the ECI said, adding that representatives of candidates were present throughout the process.

SC upholds enhanced compensation for KMP expressway landowners PIONEER NEWS SERVICE

The Supreme Court on Tuesday upheld an order enhanced compensation payable to some owners whose land in Haryana was acquired for Kundli-Manesar A Bench of expressway. Justices BR Gavai and KV Viswanathan set aside a November 2021 verdict of the Punjab and Haryana High Court quashing an order of the district revenue officercum-land acquisition collector (LAC), Jhajjar enhancing the compensation. The LAC, in an order passed on September 15, 2020, enhanced the compensation to Rs 19,91,300 per acre along with statutory benefits as awarded earlier by the High Court to similarly-placed land owners. The Court delivered its verdict on an appeal filed by some land owners challenging the high court's November 2021 verdict.

The Bench noted by a November 2004 notification under the Land Acquisition Act, 1894, the land of the appellants in Jhajjar district was acquired for the expressway and by an award in March, 2006, a compensation of Rs 12.50 lakh per acre was determined. It



noted that aggrieved by the award, some similarly-placed land owners preferred a reference for enhancement of compensation before the additional district judge, Ihajjar but the same was dismissed.

The Bench further noted such land owners approached the high court, which in May, enhanced 2016, compensation to Rs 19,91,300 per acre along with statutory benefits. The Bench said on June 30, 2016, the appellants filed an application under Section 28-A of the Act before the LAC, Jhajjar, which held that appellants were entitled to benefit of the high court's May, 2016 verdict and enhanced the compensation. Section 28-A of the Act pertains to re-determination of amount of compensation on the basis of award of the

The matter again came up

before the high court which set aside the LAC's order. Referring to a previous verdict delivered by the court, the Bench noted it was held that statement of objects and reasons of Section 28-A would reveal that the object underlying the enactment of the provision was to remove inequality in payment of compensation for same or

similar quality of land. The Court said it was not in dispute that the first appeal, which was allowed by the high court in May, 2016, was with respect to the land covered by the same notification under which the appellants' land was also covered. "We are, therefore, inclined to allow the appeal. The impugned judgment and order of the high court dated November 25, 2021 is quashed and set aside and the order of the LAC dated September 15, 2020 is upheld," the Bench said.

he icy cold weather conditions have led to intense cold conditions across the state as mercury dipped to 3.5 degree celsius in the night in Pachmarhi which was the lowest of the state. Citizens chose to remain

indoors and those commuting were searching for relief in the sunshine but as soon as they moved inside it was intensely

Nearby region Raisen recorded night at 3.6 degree celsius, Giravar (Shajapur) recorded at 4.1 degree celsius, Rajgarh recorded 5 degree celsius and ed 5.3 degree celsius.

The cold weather in Madhya Pradesh, particularly in Bhopal, has intensified due to icy winds. On Tuesday, cold winds swept through major cities including Bhopal, Indore, Ujjain, and Shajapur, leading to significant dip in tempera-

Bhopal recorded a temperature of 23.4 degree celsius during the day, with a significant drop of 4.5 degree celsius at night, bringing the mercury down to 7.8 degree celsius. This was the lowest recorded minimum temperature in the city in the past two years, as last year the minimum temperature was 8.6 degree celsius and in 2022 it was 8.8 degree celsius.

Cold waves were reported in Damoh, Jabalpur, Seoni, Narsinghpur, Sagar, Narmadapuram, Raisen, Vidisha, Rajgarh, Agar-Malwa, Dhar. Due to the changed weather, the day temperature recorded a dip across all the

Meteorological Department has issued a cold wave in Dhar, Guna-Ashoknagar on December 11, 12 and 13. Ex-serviceman kills wife, commits suicide

Morena: In a tragic incident in Vikram Nagar, Morena, a 45year-old retired army personnel, Devendra Singh, shot and killed his wife, Madhuri (43), before taking his own life. The incident occurred around 4 a.m. on Tuesday. Singh also attempted to harm his two teenage sons, Saurabh (15) and Gaurav (17), who managed to escape after a struggle. The motive behind the killings and suicide remains unclear.

According to initial investigations, Devendra Singh had a heated argument with his wife before the incident. He reportedly woke his sons at gunpoint, who found their mother unconscious. The boys managed to push their father away and flee. Shortly returned to find their father burst is yet to be determined.

President Droupadi Murmu on Tuesday said the human rights discourse so far has been centred on the "human agency" as the violator is assumed to be a human but with AI entering our lives, the "culprit could be a non-human" but an intelligent agent. In her address at an event hosted by the NHRC to mark the Human Rights Day, the President also underlined that cyber crimes and climate change are "new

threats" to human rights. Human Rights Day observed on December 10 every year to commemorate the Universal Declaration of Human Rights (UDHR), which was adopted and proclaimed by the United Nations General Assembly in 1948. The UDHR serves as a



global benchmark for the protection and promotion of human rights. "As we progress into the future, we are confronted with emerging challenges. Cyber crimes and climate change are new threats to human rights," Murmu said. The digital era, while being transformative, had brought with it complex issues such as cyber bullying, deep fake, privacy concerns and spread misinformation, she added.

the importance of fostering a safe, secure and equitable digital environment that protect the rights and dignity of every individual," the President said. In her address, she also touched upon the aspect of AI and its impact on human lives. "Artificial intelligence has now entered our day-to-day life, solving many problems, and creating several new ones too," Murmu said. These include Ayurveda, Yoga, Unani, Siddha, and Homeopathy

The Ayush Visa is granted to foreign nationals whose primary purpose is to seek therapeutic care or wellness treatment at hospitals or wellness centers accredited by government authorities, the National Accreditation Board for Hospitals & Healthcare (NABH), Commission for National Homoeopathy (NCH), or the National Commission for Indian System of Medicine of State for Ayush, Prataprao Jadhav, in a written reply to a query in the Rajya Sabha.

In addition, the Advantage Healthcare India portal, launched by the Union Health Ministry serves as India's official "one-stop" platform for facilitating Medical Value Travel (MVT). It provides essential information for international patients seeking medical treatment in India. Interested patients can access

the portal at www.healinindia.gov.in, said the Minister. It was in 2022, Prime Minister Modi Narendra announced creation of Ayush Visa, seeking to make it a part

cybersecurity. Γhe TTC with India was the European Union's second such technology partnership after the first one with the United States that firmed up in June 2021. The formation of the TTC followed the announcement on it by Prime Minister Modi Narendra Commission European President Ursula von der Leyen on April 25, 2022.

India and the EU are also looking at forging deeper cooperation to ensure a free open, inclusive and rulesbased maritime order in the Indo-Pacific.

In August last year, the EU Naval Force (EUNAVFOR) Atlanta flagship, ITS Durand De La Penne conducted a joint activity at sea with the Indian destroyer INS Visakhapatnam in the framework of the EU's strategy for cooperation in the Indo-Pacific.

Operation Atlanta is a critical maritime security operation under the EU Common Security and Defence Policy (CSDP).

Female constables and head constables will patrol these areas on scooters," Agrawal said. The teams will use black scoot-

ers and matching helmets, ensuring a uniform look that reinforces their authority and accessibility. A dedicated police



control room and helpline number will also be established to support their opera-

The Kalika Patrolling Units will be deployed in schools, religious sites, colleges, markets, cinema halls, malls, parks, tourist destinations, and other sensitive areas. Their focus will be on preventing crimes such as eve-teasing of women and chain-snatching.
The Kalika Patrolling Units

were first announced in June as part of the Chief Minister Bhajan Lal Sharma-led government's efforts to combat crimes against women and children. During the budget announcement, Finance Minister Diya Kumari highlighted that the initiative is aimed at curbing atrocities against vulnerable groups. Man held for sharing bogus bomb alert on IndiGo flight from Nagpur to Kolkata

TMC's Humayun plans new 'Babri Masjid' in Bengal

Kabir who had a few months ago courted controversy and escaped sans penalty for threatening to cut and throw a section of the population in the Bhagirathi river has said that he had made up plans to construct the Babri Masjid in his home town Beldanga. It is the same Beldanga that recently witnessed communal riots during Kartik Puja forcing the Government to suspend internet services and impose pro-

hibitory orders. "I will get constructed a new Babri Masjid in Murshidabad where 70 percent of the population is Muslim ... the mosque will come up at Beldanga block near my home where Muslims enjoy an 80 percent majority,' Kabir a former Minister who was recently reprimanded by his party leadership for speaking out of turn to project Abhishek Banerjee as Deputy Chief Minister "so as to ease pressure on Chief Minister Mamata Banerjee," said. Kabir's statement seems to be

conspicuous by its timing even as it comes amid Bangladesh crisis when there was considerable heat on both sides of the international border.

The foundation stone of the proposed mosque will be laid on December 6, 2025 barely a few months before ahead of the Bengal Assembly elections in 2026. When asked as to whether December 6 fixed as the foundation laying day by him was coincidental or it bore a cloaked implication, he said things had been decided by a committee The TMC MLA said that the mosque would be

Incidentally the Babri Mosque at Ayodhya was demolished by the Kar Sevaks on December 6, 1992 leading to a political turmoil. Kabir is the same TMC MLA who had before the 2024 gen-

eral elections had reminded the

BJP that the Muslims constituted 70 percent of the population of Murshidabad and had said that "if they continue to show aggression then they would be cut and throw into the River Bhagirathi."

While none of the TMC leaders would react to Kabir's plans one of them saying, "the TMC does not interfere into anyone's personal religion," Bengal Opposition Leader Suvendu Adĥikari slammed the Chief Minister for allowing the State to go into the hands of the "reactionary elements."

pendent. He was then associated with the Praia Socialist Party before joining the Congress.

Later, he joined the BJP in March 2017, ending his nearly 50-year-long association with the Congress. In January last year, Krishna announced that he was retiring from active politics, citing his age as the reason. He was the 16th Chief Minister of Karnataka from October 11, 1999, to

Congress). He also served as the

Governor of Maharashtra and was the External Affairs Minister during the Manmohan Singh-led United Progressive Alliance (UPA) government from 2009 to 2012. A law graduate, Krishna studied in the US. He graduated from the Southern Methodist University in Dallas, Texas, and The George Washington University Law School in Washington DC, where he was a Fulbright Scholar. Krishna served as the Speaker



Global warming is becoming reality as 2024 set to be the hottest year on record

s global temperatures soar to unprecedented levels, 2024 is shaping up to be the hottest year on record, a grim milestone that underscores the accelerating Crisis of climate change. European Union scientists have confirmed that the first eleven months of 2024 have set a new high, making this year the warmest since records began. This will be the first year where the global average temperature surpasses 1.5°C above pre-industrial levels, a threshold that world leaders have long warned could trigger catastrophic climate impacts. With this alarming reality, the world faces a rapidly intensifying climate emergency, one that requires immediate and drastic action. The impacts of global warming are already being felt around the world. In 2024, extreme weather events have ravaged communities, causing widespread devastation. Severe droughts have gripped Italy and South America, while fatal floods in Nepal, Sudan and Europe have displaced thousands. Heatwaves in regions like




bon dioxide emissions from burning fossil fuels. These emissions trap heat in the atmosphere, causing global temperatures to rise at an alarming rate. The most effective way to curb this warming is by reducing emissions to net-zero levels, a goal that many nations have pledged to achieve in the com-

ing decades. However, despite these green pledges, global CO2 emissions are on track to hit record highs this year. This contradictory trend highlights the gap between political promises and the real, tangible actions needed to mitigate climate change. This year's UN climate talks produced a \$300-billion deal aimed at addressing the global climate crisis. However, poorer countries have criticised this deal, arguing that it is insufficient to cover the soaring costs of climate-related disasters. While this deal may have made some progress, it is clear that the global response is not yet enough to prevent further warming. The rise of climate change deniers, particularly within the political sphere, has made it even harder to combat this crisis. US President-elect Donald Trump, in particular, has consistently downplayed the severity of global warming and rolled back numerous environmental regulations during his previous term. Under Trump's leadership, the US withdrew from the Paris Agreement, a global pact aimed at reducing emissions and limiting global temperature rise. Such actions would undoubtedly exacerbate the climate crisis, making it even harder to reduce emissions and avoid the most catastrophic effects of global warming. The time to act is now, and the window for meaningful change is rapidly closing.

Philippines confronts Chinese assertiveness




The South China Sea remains a flashpoint of escalating tensions as China intensifies its aggressive maritime activities, targeting nations like the Philippines

NS Admiral Dinesh Tripathi during his customary briefing of media before Navy Day last expressed concern about Chinese maritime activities in the South China Sea, all of which China claims. Two countries it especially targets in SCS are Taiwan and the Philippines in whose waters it has indulged in offensive naval actions. It signed a defence agreement with the US in 1951; last month it signed an intelligence and technology agreement facilitating satellite intelligence and access to high-grade US weaponry following President Marcos promulgating Maritime Zone Act and Archipelago Sea Lanes Act that China denounced and summoned its envoy. US Defence Secretary Llyod Austin told his counterpart Gilberto Teodoro: We are more than allies; we're

The week-long ASEAN summit in Vientiane, Laos from 6 to 12 October witnessed stern exchanges between China, the US and the Philippines especially over the South China Sea at a time when the West is seized with Ukraine and West Asia crises, even as President-elect Trump is issuing multiple threats. While Chinese Premier Li Qiang blamed 'external forces" for interfering in regional affairs, US Secretary of State Antony Blinken said the US is concerned about increasingly dangerous and unlawful activities of China in disputed SCS. Marcos complained to ASEAN leaders that his country continues to be subjected to Chinese bullying and intimida-

Earlier that week PM Narendra Modi attended the 19th India-ASEAN meeting and made a powerful presentation of Delhi's Act East policy and criticised China for its expansionist policy in SCS. Taiwan continues to face periodic challenges as China relentlessly violates the 2016 UNCLOS ruling that the Philippines secured over China's illegal claim to the South China Sea under its 9dash line. During my interaction with Philippines security experts in Manila in June, clashes over the resupply of a marooned vessel in Thomas Shoal 2 had reached the climax; and some suggested it could be a feint for Taiwan. The incident had ruffled feathers in Manila with calls for invoking the US Mutual Defence Agreement which gets triggered only during armed external attack.

Clashes have occurred between the two sides and despite talks and a hotline, no compromise was reached. On September 28 Chinese Navy missile boat fired laser beams at a Philippines Cessna Patrol aircraft while Filipino coast guard vessels continued to be supervision and in a mid-

ships blocked passage of Filipino supplies for the stranded ship.
The Chinese have said that the Philippines ship is illegally

stranded/marooned at the disputed Thomas Shoal atoll which it owns as part of its claim to SCS. China calls it Xianbin Reef which is 150 km west of the Philippines island of Palawan. As before, it had repeatedly said it would promulgate its maritime laws including the use of firearms and arrest offenders in defence of its sovereignty and national interest. Teodoro said at the end of August that Thomas Shoal is a sovereignty issue of the Philippines.

According to South China Morning Post (September 16), Admiral Samuel Paparo, US Indo-Pacific Command accompanied by Gen Romero Brawner, Chief of Philippines armed forces, said there is a range of options as countermeasures for the Chinese grey zone tactics adding the US is ready to escort Philippines ships in SCS in event of a spike in hostilities. Brawner said they would seek help if the Chinese blocked food supplies and soldiers were dying of hunger. In Manila, I was asked whether re-supply by other means like helicopters was feasible and had suggested discussing it with their US allies. Meanwhile, Paparo took a video call with Gen Wu Yanan, PLA Southern Theatre SCS and Taiwan.

Wu attended an International conference at the Indo-Pacific command in Hawaii in September even as Teodoro took the contingency of escalation to the next level, of the Chinese towing away the grounded Sierra Madera which would constitute an act of war; invoking a defence pact with the US. A code of conduct for ASEAN in SCS has been in the works for two decades but

is far from fruition.

It is akin to India's LAC/border with China that Beijing has refused to resolve as it would put a stop to grey zone tactics and salami slicing. India has voiced clear support for the Philippines during the June 17 clash with the Chinese coast guard and Foreign Minister Jaishankar has been on a goodwill visit. Delhi has sold Brahmos anti-ship missiles to Manila, the first country to buy them. Former Defence Secretary, Giridhar Aramane was in Manila recently for the fifth Joint defence cooperation dialogue. While Taiwan may not be on the cards, Thomas Shoal 2 could end up in Chinese possession as Mischief Reef 24 km north of it did in 2012.

Childhood Wounds: The hidden

force behind life's struggles Whether it's self-doubt at work or struggles in relationships, the

roots often trace back to unresolved childhood wounds

ave you ever wondered why life keeps pulling you back, no matter how hard you try to move forward? Maybe you find yourself repeating the same mistakes in relationships, doubting your abilities at work, or battling the constant ache of "not being

enough." It's easy to blame bad luck or personal failure. But often, these struggles run deeper-in unresolved childhood wounds. Childhood is when we learn how to love, trust and value ourselves. But not all childhoods are built on safety and support. Even seemingly small moments can leave deep

A parent saying, "Stop crying, you're embarrassing me," or a teacher comparing you to someone else may seem insignificant at the time but can shape how we see ourselves for years to come. Take Radhika, for example. At 35, she thrived in her career but couldn't maintain a relationship. Every time someone got close, she would pull away, convinced they would leave her eventually. Therapy

revealed that her fear of abandonment stemmed from her father leaving when she was six. Her emotional walls weren't about keeping others out; they were about protecting herself from feeling that pain again. Then there's Arjun, 28, who struggled to hold a job. His pattern was predictable: procrastinate, miss deadlines and eventually lose the role.

He believed he lacked discipline, but therapy uncovered a deeper truth. He had grown up under relentless criticism—nothing he did was ever good enough. That this cycle ends. It's not about

internalised voice followed him into adulthood, leading him to self-sabotage before anyone else could judge him. These aren't isolated stories. Many of us carry invisible wounds from our childhood.

A parent's absence, constant comparisons, or even a single harsh word can create emotional patterns fear of intimacy, perfectionism, or shrinking ourselves to avoid rejection. Over time, these patterns create setbacks that seem external but are deeply internal. Therapy is where

blaming our parents or reliving the past. It's about understanding why we feel stuck and learning how to let go of the pain. Imagine carrying a heavy bag for years, thinking it's just part of life-then discovering you can put it down. That's

what healing feels like. One client described the process beautifully: "For the first time, I understand myself. I'm not broken. I've just been carrying pain I didn't know was there." Your setbacks aren't failures; they're signals that something inside you needs attention. Healing childhood wounds allows you to stop reacting from a place of fear and start living from a place of freedom. It's not an easy journey, but it's one worth taking. The truth is, you deserved love and safety as a child, and you still do

CONTROVERSY AT IIT KHARAGPUR

ORGANISATIONAL BEHAVIOR

As technology reshapes the world at breakneck speed, organisations must evolve to stay relevant

t would be worthwhile to examine how organisations are structured and articulated. In the long haul organisations blessed with individuals willing to experiment, innovate and embrace technology will be the ones that survive. At the pace that technology with its variants is fashioning itself, numerous applications are unravelling virtually by the minute, and the level of obsolescence and attrition of equipment is becoming extraordinarily high. In such a scenario, humans and organisations will be subsumed by various products and their variants. The human mind can no longer remain in the typewriter mode. The garden of Organisational Theory and Behaviour is dotted with eminent scholars. Three pioneers, Adam Smith, Charles Babbage and Robert Owen provided the ballast and the basic groundwork.

Adam Smith advanced the argument that countries and organisations would profit by adopting the tenets of division of labour, what is now termed as specialisation. Charles Babbage in his seminal work postulated: Through the division of labour, the time required for learning a job or skill gets drastically reduced. Right at the stage of infancy wastage of material gets minimised and diminishes. The mind is propelled to take up serious tasks upon attaining superior skills. Way back in 1789, Robert Owen at 18 went on to acquire a factory. He was a utopian, way ahead of his times. In 1825, he promulgated regulated working



hours, child labour laws, public education and business involvement in various community projects – a precursor to CSR. In today's wired world, individuals work from their dwellings. Places with the latest technology and gizmos at their disposal. Over the last decade, the entire paradigm of organisational behaviour has metamorphosed. Technology stares at organisations with peering eyes, the complexity and dynamics of structures having undergone a complete metamorphosis. Let us look at the Indian Railways. There was a time when the operating and manufacturing departments held sway in the decision-making process. Today, it is the technical departments that are the game changers. The concept of fixed work hours is history.

The workforce must be alert 24x7. Thus, employees need to brush up on their skill sets to brace for the challenges of the virtual world. Let us examine the model of direct teaching through online classes- oneon-one, between the teacher and the tutee. The very paradigm may affect teaching techniques in schools and universities. Similarly, qualified doctors instruct their colleagues through Skype or other means during complex surgeries. Be it surgical strikes or wars, instructions are being disseminated to the foot soldiers through the latest technology, like the usage of GPS coordinates and Real-Time Imagery.

In such a scenario, scores of organisational structures, government or those in the private sector must adapt radically in order to survive. The workforce must continuously upgrade their skill set or face extinction. Perhaps emotions of warmth may be lost in the maze of technological evolution. The philosophy of an organisation, its goals and objectives and the behavioural pattern between the structure and the workforce have been stranded in a traffic jam of the kind one encounters in major cities of India like Gurugram. Stephen Hawking has in a rather depressing prognosis, predicted that life would be extinct on this planet on four grounds - nukes, global warming, man-made viruses or robots. Thus, the human mind should reinvent itself and current organisational behaviour and theories or prepare a blueprint to discover a sister planet to inhabit. Aristotle wrote, "We are what we repeatedly do." This paradigm will have to change for organisations to survive.

President Xi rebuffs Trump's threat of tariffs

earing up for Trump 2.0 era, Chinese President Xi Jinping on Tuesday cau-President Al Julping on Accomply tioned there will be no winner in a tariff or tech wars between China and the US and vowed that Beijing would firmly safeguard its interests.

"Tariff wars, trade wars and technology wars run counter to historical trends and economic laws, and there will be no winners," Xi said while meeting the heads of 10 major international organisations, including the World Bank (WB), International Monetary Fund (IMF) and World Trade Organisation (WTO) here. During the meeting, Xi stressed on China's principles for engaging with the US.

"China will always insist on focusing on its own affairs and resolutely safeguard its sovereignty, security and development interests. Meanwhile, China's determination to promote high-level opening up will not change," he said, according to the official media reports here.

Xi's comments came in the backdrop of US President-elect Donald Trump's remarks in an NBC interview that he "got along very well" with Chinese President Xi Jinping and that the two leaders had "communication as recently as this week."

China did not confirm the conversations between Xi and Trump, who is set to take threatened to impose 60 per cent on Chinese exports to the US and also warned of imposing 10 per cent more tariffs if Beijing fails to curb fentanyl, the drug 50 times more potent than heroin and regarded as the root cause for addiction in the US. On Monday, China announced an investigation into US chipmaker Nvidia over suspected violations of the country's antimonopoly law. The investigation is widely seen as retaliation for Washington's latest curbs on the Chinese chip sector.

On China's economy which is facing headwinds of slowdown, Xi told the heads of major international economic organisations that he has full confidence to achieve this year's economic growth target of around five per cent and Beijing will continue to play its role as the biggest engine of world

economic growth. Xi said economies of all countries face their own difficulties. All countries should work together to build an open world economy be innovation-driven, seize important opportunities such as the digital economy artificial intelligence and low-carbon technologies, create new sources of economic growth and support cross-border flows of knowledge, technology and human

It is essential to prioritise national security and social stability as the bottom-line requirement for governance in border areas, Xi said while presiding over a group study session of the Political Bureau of the Communist Party of China on Monday.

Americans realising Trump's tariffs on Canada make life expensive: Trudeau

Canadian Prime Minister Justin Trudeau said on Monday said Americans "are beginning to wake up to the real reality that tariffs on everything from Canada would make life a lot more expensive" and said he will retaliate if Donald Trump goes ahead with them.

Speaking at an event put on by the Halifax Chamber of Commerce, Trudeau also said dealing with Trump will be "a little more challenging" than the last time because Trump's team is coming in with a much clearer set of ideas of what they want to do right away than after his first election win in 2016. The US president-elect has threatened to impose a 25 per cent tax on all products entering the US from Canada and Mexico unless they stem the flow of migrants and drugs.

"Trump got elected on a commitment to make life better and more affordable for Americans, and I think people south of the border are beginning to wake up to the real reality that tariffs on everything from Canada would make life a lot more expensive," Trudeau said.

On the weekend, Trump appeared in an interview with NBC's "Meet the Press", where the president-elect said he can't guarantee that his promised tariffs on key US foreign trade partners won't raise prices for American consumers.

"Let's not kid ourselves in any way, shape or form, 25 per cent tariffs on everything going to the United States would be devastating for the Canadian economy," Trudeau said.

"It would also, however, mean real hardship for Americans as well. Americans import 65 per cent of their crude oil from Canada, significant amounts of electricity. Just about all the natural gas exported from Canada goes to the United States. They rely on us from steel and aluminum. They rely on us for a range of agriculture imports. more expensive.

If Trump makes good on his threat to slap 25 per cent tariffs on everything imported from Mexico and Canada, the price increases that could follow will collide with his campaign promise to give American families a break from inflation.

Economists say companies would have little choice but to pass along the added costs, dramatically raising prices for food, clothing, automobiles, alcohol and other goods.

The Produce Distributors Association, a Washington trade group, has said tariffs will raise prices for fresh fruit and vegetables and hurt US farmers when the countries retaliate. "We will of course, as we did eight years ago, respond to unfair tariffs," Trudeau said. Trudeau said his government is still mulling over "the right

ways" to respond, referencing when Canada put billions of new duties in 2018 against the US in a tit-for-tat response to new taxes on Canadian steel and aluminum.

Many of the US products were chosen for their political rather than economic impact. For example, Canada imports just USD 3 million worth of yogurt from the US annually and most of it comes from one plant in Wisconsin, the home state of then-Republican House Speaker Paul Ryan. That product was hit with a 10 per cent duty. "It was the fact that we put tariffs on bourbon and Harley-Davidsons and playing cards and Heinz ketchup and cherries and a number of other things that were very carefully targeted because they were politically impactful to the president's party and colleagues," Trudeau

Trudeau said when Trump says things he means them but they also know Trump is trying to insert uncertainty and "a bit of chaos" into democracies.

"One of the most important things for us to do is not freak

"Knowing these would be absolutely devastating means we have to take them seriously but it does mean we have to be thoughtful and strategic and not going around making our opponents arguments for him but making our arguments in a significant and united way."

Canadian officials have said it is unfair to lump Canada in with Mexico.

US customs agents seized 43 pounds of fentanyl at the Canadian border last fiscal year, compared with 21,100 pounds at the Mexican border. Most of the fentanyl reaching

the US — where it causes about 70,000 overdose deaths annually — is made by Mexican drug cartels using precursor chemicals smuggled from Asia. On immigration, the US Border

Patrol reported 1.53 million encounters with irregular migrants at the southwest border with Mexico between October 2023 and September 2024. That compares to 23,721 encounters at the Canadian border during that time.

Trump has also claimed the US is "subsidising Canada to the tune of over USD 100 billion a year". On America's trade deficit Canada's ambassador to Washington, Kirsten Hillman, told the AP US had a USD 75 billion trade deficit with Canada last year but noted a third of what Canada sells into the US are energy exports and prices have been high.

About 60 per cent of US crude oil imports are from Canada, and 85 per cent of US electricity imports as well.

Canada is also the largest foreign supplier of steel, aluminum and uranium to the US and has 34 critical minerals and metals that the Pentagon is eager for and investing for national security. Nearly USD 3.6 billion Canadian (USD 2.7 billion) worth of goods and services cross the border each day. Canada is the top export destination for 36 US states.

Luigi Nicholas Mangione, a 26year-old Ivy League graduate from a prominent Maryland real estate family, had a gun believed to be the one used in last Wednesday's shooting of Brian Thompson, as well as writings suggesting anger with corporate America, police said. Late Monday, Manhattan prosecutors filed murder and other charges against Mangione, according to an online court docket. He remained jailed in Pennsylvania, where he was charged with possession of an unlicensed firearm, forgery and providing false identifica-

tion to police. Mangione was sitting in the rear of the McDonald's wearing a blue medical mask and lookdocuments said. A customer saw him and an employee called 911, said Kaz Daughtry, an NYPD deputy commissioner. Altoona Police Officer Tyler Frye said he and his partner recognized the suspect immediately when he pulled down his mask. "We just didn't think twice about it. We knew that

was our guy," he said. When one of the officers asked if he'd been to New York recently, he "became quiet and started to shake," according to a

criminal complaint based on their accounts of the arrest. In his backpack, police found a black, 3D-printed pistol and a 3D-printed black silencer, the complaint said. The pistol had a metal slide and plastic handle with a metal threaded barrel. He was taken into custody at about 9:15 a.m., police said. Mangione had clothing and a mask similar to those worn by the shooter and a fraudulent New Jersey ID matching one the suspect used to check into a New York City hostel before NYPD shooting, Commissioner Jessica Tisch said. NYPD Chief of Detectives Joseph Kenny said Mangione was born and raised

Mangione was arraigned and ordered held without bail during a brief court hearing. Asked if he needed a public defender, he asked if he could "answer that at a future date." He eventually will be extradited to New York to face charges in death, Kenny said.

Police found a three-page document with writings suggesting that Mangione had "ill will toward corporate America," Kenny said. The handwritten document "speaks to both his motivation and mindset," Tisch

Mangione had a ghost gun, a type of weapon that can be assembled at home from parts without a serial number, making them difficult to trace, investigators said.

He also had a passport and \$10,000 in cash — \$2,000 of it in foreign currency, the local prosecutor said. Mangione, who said Hawaii was his most recent address, disputed the amount. Thompson, 50, was killed last Wednesday as he walked alone to a hotel, where pany, UnitedHealth Group, was holding its annual investor conference, police said.

UnitedHealth Group thanked law enforcement in a statement. "Our hope is that today's apprehension brings some relief to Brian's family, friends, colleagues and the many others affected by this unspeakable tragedy," a company spokesperson said.

The shooting shook US businesses and the health insurance industry in particular, causing companies to rethink security plans and delete photos of executives from their websites. The shooter appeared to be "lying in wait for several minutes" before approaching the executive from behind and opening fire, police said.

Mangione attended an elite Baltimore prep school, graduating as valedictorian in 2016, according to the school's website. He went on to earn undergraduate and graduate degrees in computer science in 2020 from the University of Pennsylvania, a school

One of his cousins is a Maryland state legislator and his family bought a country club north of Baltimore in the 1980s. On Monday, police blocked off an entrance to the property, which public records link to the suspect's parents. A swarm of reporters and photographers gathered outside. Mangione went from Philadelphia to Pittsburgh after the shooting, and likely "was in

a variety of locations across the

state," said Lt. Col. George

Bivens of the Pennsylvania State Police said.

"Based on everything we have seen, he was very careful with trying to stay low profile, avoid cameras - not all that successfully in some cases, but that was certainly the effort he was making," Bivens said.

In the days since the shooting, police turned to the public for help by releasing a collection of nine photos and video including footage of the attack, as well as images of the suspect at a Starbucks beforehand. Photos taken in the lobby of a

hostel on Manhattan's Upper West Side showed the suspect grinning after removing his mask, police said.

On Monday, police credited news outlets for disseminating the images and the tipster for recognising the suspect and calling authorities.

Investigators earlier suggested the gunman may have been a disgruntled employee or client of the insurer. Ammunition found near Thompson's body bore the words "delay," "deny" and "depose," mimicking a phrase used by insurance industry critics.

The gunman concealed his identity with a mask during the shooting yet left a trail of evidence, including a backpack he ditched in Central Park, a cellphone found in a pedestrian plaza and a water bottle and say he bought at Starbucks minutes before the attack.

On Friday, police said the killer had left the city soon after the shooting. Retracing the gunman's steps using surveillance video, investigators say the shooter rode into Central Park on a bicycle and emerged from the park without his backpack. He made his way to a bus station that offers commuter service to New Jersey and routes to the East Coast, police

Ethnic armed group claims capture of strategic Myanmar town, control of border with B'desh

AP BANGKOK

One of the most powerful ethnic minority armed groups battling Myanmar's army has claimed the capture of the last army outpost in the strategic western town of Maungdaw, gaining full control of the 271-kilometer (168mile) -long border with Bangladesh.

The capture by the Arakan Army makes the group's control of the northern part of Rakhine state complete, and marks another advance in its bid for self-rule there.

Rakhine has become a focal point for Myanmar's nationwide civil war, in which prodemocracy guerrillas and ethnic minority armed forces seeking autonomy battle the country's military rulers, who took power in 2021 after the army ousted the elected government of Aung San Suu

Khaing Thukha, a spokesperson for the Arakan Army, told The Associated Press by text message from an undisclosed location late Monday that his group had seized the last remaining military outpost in Maungdaw on Sunday.

Gen. Thurein Tun, was captured while attempting to flee the battle, Khaing Thukha said. The situation in Maungdaw could not be independently confirmed, with access to the internet and mobile phone services in the area mostly cut off.

Myanmar's military government did not immediately comment.

Maungdaw, about 400 kilometers (250 miles) southwest of Mandalay, Myanmar's second-largest city, has been the target of an Arakan Army offensive since June. The group captured Paletwa and Buthidaung, two other towns the border with Bangladesh, earlier this year. Since November 2023, the Arakan Army has gained control of 11 of Rakhine's 17 townships, along with one in

neighboring Chin state. Ann, a town in Rakhine that hosts the strategically important military headquarters overseeing the western part of the country, appears to be on the verge of falling entirely to

the Arakan Army. The group posted on the Telegram messaging app late minority, as having illegally

Outpost commander Brig. Friday that it had taken more than 30 military outposts, except the army's western command, which controls Rakhine and the southern part of neighboring Chin state, as well as the country's territorial waters in the Bay of Bengal.

Recent fighting in Rakhine has raised fears of a revival of organised violence against members of the Muslim Rohingya minority, similar to that which drove at least 740,000 members of their community in 2017 to flee to neighbouring Bangladesh for

The Arakan Army, which is the military wing of the Buddhist Rakhine ethnic group in Rakhine state, where they are the majority and seek autonomy from Myanmar's central government, denies the allegations, though witnesses have described the group's actions to the AP and other media.

Rohingya have lived in Myanmar for generations, but they are widely regarded by many in the country's Buddhist majority, including members of the Rakhine

migrated from Bangladesh The Rohingya face a great amount of prejudice and are generally denied citizenship and other basic rights. The border between Myanmar

and Bangladesh extends from land to the Naf River and offshore in the Bay of Bengal.

The Arakan Army said Sunday it had ordered the suspension of transport across the Naf River because police and local Muslims affiliated with the army were attempting to escape by boat to Bangladesh. The rebel group has been

accused of major human rights violations, particularly involving its capture of the town of Buthidaung in mid-May, when it was accused of forcing an estimated 200,000 residents, largely Rohingyas, to leave, and then setting fire to most of the buildings. It was accused of attacking Rohingya civilians fleeing fighting in Maungdaw in August.

The Arakan Army is also part of an armed ethnic alliance that launched an offensive in northeastern Myanmar last year and gained strategic territory along the border with

Kim of working with Yoon and other military and police officers of staging a riot to disrupt the constitution. Prosecutors' offices in Seoul couldn't imme diately confirm the reports. During a parliamentary hearing Tuesday, Kwak Jong-keun, commander of the Army Special Warfare Command liament, testified that he received direct instructions from Kim Yong Hyun, to obstruct lawmakers from entering the National Assembly's main chamber.

Kwak said the purpose of Kim's instructions was to prevent the assembly from gathering the required 150 votes necessary to overturn Yoon's martial law

Kwak is among those who face opposition-raised rebellion charges along with Yoon and Kim, and the Defense Ministry suspended him last week.

Opposition parties and many experts say the martial law decree was unconstitutional They say a president is by law allowed to declare martial law only during "wartime, war-like situations or other comparable national emergency states" but South Korea wasn't in such a situation. They argue that deploying troops to seal the National Assembly to suspend its political activities amounted to rebellion because the South Korean constitution doesn't allow a president to use the military to suspend parliament in any situation. In his martial law announcement, the conservative Yoon stressed the need to rebuild the

country by eliminating "shameless North Korea followers and anti-state forces" in a reference to his liberal rival rivals who control parliament. Since taking office in 2022, Yoon

has been on a near-constant collision course with the main liberal opposition Democratic Party, which has introduced motions seeking to impeach some of his top officials and launched a fierce political offensive against Yoon over a spate of scandals involving him and his wife. The focus of attention is how authorities could investigate Yoon and whether they can detain him. South Korean law gives a presi-

dent immunity from prosecution while in office, except for allegations of rebellion or treason. This means that Yoon can be questioned and detained by investigative agencies over his martial law decree, but many observers doubt that authorities will forcefully detain him because of the potential for clashes with his presidential security service. About 87,000 people were being evacuated in a central Philippine region Tuesday a day after a volcano briefly erupted with a towering ash plume and superhot streams of gas and debris hurtling down its western slopes.

The latest eruption of Mount Kanlaon on central Negros island did not cause any immediate casualties, but the alert level was raised one level, indicating further and more explosive eruptions may occur.

Volcanic ash fell on a wide area, including Antique province, more than 200 kilometers (124 miles) across seawaters west of the volcano, obscuring visibility and posing health risks, Philippine chief volcanologist Teresito Bacolcol and other officials said by telephone.

At least six domestic flights and a flight bound for Singapore were cancelled and two local flights were diverted in the region Monday and Tuesday due to Kanlaon's eruption, according to the Civil Aviation Authority of the Philippines. The mass evacuations were being carried out urgently in towns and villages nearest the

western and southern slopes of Kanlaon which were blanketed by its ash, including in La Castellana town in Negros

Equity MFs inflow drops 14% in Nov; SIP figure remains flat at Rs 25,320-cr

Equity mutual funds witnessed an inflow of Rs 35,943 crore in November, marking a drop of 14 per cent on a month-on-month basis, amid heightened volatility in stock markets driven by various macroeconomic factors, geopolitical events and US election results.

Despite this, it marked the 45th consecutive month of net inflows into equity-oriented funds, reflecting the growing popularity of mutual funds among investors, according to data from the Association of Mutual Funds in India (AMFI) released on Tuesday.

Moreover, monthly contributions from the Systematic Investment Plan (SIP) remained flat at Rs 25,320 crore last month against Rs 25,323 crore in October.

"There was heightened volatility due to various macroeconomic factors, geopolitical events and the US election results. This resulted in investors opting for a wait & watch approach while allocating larger amounts and thus decline in lumpsum flows including flattish SIP numbers for November 2024, Akhil Chaturvedi, CBO, Motilal Oswal AMC, said.

Overall, the mutual fund industry experienced an inflow of Rs 60,295 crore in the month under review, which was way lower than Rs 2.4 lakh crore in October. This could be due to a huge decline in inflows in debt funds to Rs 12,915 crore in November from Rs 1.57 lakh crore in the preceding month.

Despite the decline, the industry's net assets under management rose to Rs 68.08 lakh crore last month from Rs 67.25 lakh crore in October.

"Defying a tumultuous month in the equity market, the mutual fund industry's assets reached a new pinnacle of Rs 68.08 lakh crore, driven primarily by robust inflows into growth-/equity-oriented schemes. The unwavering SIP inflows remained above Rs 25,000 crore in November, showcasing the investors' long-term vision and commitment to



their financial goals, despite the short-term market fluctuations," Venkat Chalasani, Chief Executive, AMFI, said. As per the data, equity-oriented schemes witnessed an inflow of Rs 35,943 crore in November as compared to record inflow of Rs 41,887

"Weak global cues, China's recent economic stimulus, and escalating tensions between Ukraine and Russia impacted Indian equity markets in November 2024, which witnessed relentless selling by foreign portfolio investors. The impact of this was seen on the Indian mutual fund

industry as well, which witnessed 14.19 per cent drop in equity inflows in November on a month-on-month basis," Ashwini Kumar, Senior Vice President and Head Market Data, ICRA Analytics, said. Within the equity schemes, sectoral or thematic category attracted investors with the highest net inflow of Rs 7,658 crore during the month under review. However, flow in the segment was less compared to Rs 12,279 crore in October and Rs 13,255 crore in September. This was followed by flexi cap funds which saw inflow of Rs 5,084 crore last

month. Inflows into large-cap funds declined 26 per cent to Rs 2,548 crore in November from Rs 3,452 crore in the preceding month, while mid and small cap funds registered month-on-month growth of 4.3 per cent to Rs 4,883 crore and 9 per cent to Rs 4,112 crore, respectively. crore, respectively.
The month saw 18 new fund

offerings (NFOs) collecting Rs 4,052 crore while October saw 29 NFOs garnering Rs 6,078 crore. Of this, new index funds launched in November were 10 as compared to 17 launched in October, Mayukh Datta, Chief Business Officer, ITI Mutual

There has been a shift from low-risk categories like largecap and hybrid funds to higher-risk options like small-cap

slowed down last month. With regards to debt-oriented funds, Deepak Ramaraju, Senior Fund Manager,

Shriram AMC, said that the category saw a 92 per cent month-on month plunge in inflow to Rs 12,916 crore in November on the back of withdrawal from liquid funds due to tighter liquidity conditions and possible tax payments.

Overall, 9 out of 16 debt mutual fund categories recorded net inflows in November. Liquid funds experienced the highest outflows, amounting to Rs 1,779 crore.

"Meanwhile, investors showed a strong preference for categories like low-duration funds, ultra-short-duration funds, money market funds, corporate bond funds, and overnight funds. Together, these categories accounted for about 85 percent of the inflows across nine categories that recorded positive figures, highlighting a strong preference for lowrisk, highly liquid investment options," Nehal Meshram,

Research, Morningstar Investment Research India,

Further, investor interest in active duration strategies, such as Gilt Funds, led to inflow of Rs 1,803 crore. This can be attributed to rising expectations of interest rate cuts in the near future, she

added.

Gold continues to glitter with investors showing their affinity towards yellow metal in November as well. Gold ETF category witnessed a net inflow of Rs 1,257 crore in November, which was lower than Rs 1,961 crore seen in the preceding month. "While the fund mobilized was less compared to October, the redemption number was higher. This signifies that investors would have chosen to book profits with gold trading at elevated levels and impending marriage season, where the demand for physical gold is high," Himanshu Director- Manager Research, Morningstar Investment Research India, said.

"Ding did not have to calculate a single line in this whole game, he is being able to play the game based on positional understanding where he is very good," said Carlsen on his new voutube channel.

It might be a tightrope walk for Gukesh but the young Indian is likely to go out there and give his best in the penultimate game.

In case of another draw, there is a decent chance that the chess buffs will get to see the tie-break games.



Tennis legend Andre Agassi on Tuesday emphasised the importance of keeping sports as a part of education, stating that sports teach children the value of losing.

Agassi was discussing the future of sports and education as a foundation for excellence at the TiE Global Summit 2024 in Bengaluru.

"Even when you have a failure, you have to get up and play again the next day. So, what sports is teaching you is that focusing on winning and losing is really a distraction from what we need to be thinking about. We need to be thinking about how to get better," he said.

Agassi, who has been investing in education for the "disadvantaged" since 2001, shared that he has helped build 130 schools for about 80,000 kids in the United States, a feat he attributes to pushing himself to stay ahead of



course-correct course—and needed—to his gruelling tennis career. 'Sports is all about problem-solving. Tennis taught me how to navigate a very intense environment and maintain my objectivity and problem-solving abilities.

Speaking about his rebellious phase, Agassi said it was something he had to go through to reach where he is today.
