### **Lok Sabha passes Bill** to amend Railway Laws

ok Sabha on Wednesday Lpassed a Bill to amend Railway laws with the Government insisting that it will not lead to the national carrier's privatisation. Responding to a debate on the Railway Amendment bill, Railway Minister Ashiwni Vaishnaw said in the Lower House that a fake narrative was set afloat that the amendment would privatise railways. "Their (Opposition) fake narrative on the Constitution has failed... Now this will also fall flat," he asserted.

The Bill was passed by a voice vote after debate which could not be held earlier due to frequent disruptions of House proceedings during the last week. "A few members have said the Bill will lead to privatisation of railways, an attempt has been made to set a fake narrative. I want to appeal to them with all sincerity not to do this, their one fake narrative about the Constitution has already failed," Vaishnaw said. The Railways (Amendment) Bill 2024 which seeks to enhance functioning independence of the Railway Board was introduced in the

previous Parliament session.

The Congress chief said since 1952, no resolution has been brought against the vice president under Article 67 of the Constitution as those who held the post previously never indulged in politics and remained unbiased. He said the Opposition parties have nothing against Dhankhar, "but he left us with no option but to go ahead with the notice for his removal".

### **Ensure manual sewer cleaning** completely eradicated, says SC

 $O_{\text{needed to be done, the}}^{\text{bserving}}$ Supreme Court directed the Wednesday Centre to file an action taken report on the compliance of its direction for ensuring manual sewer cleaning was completely eradicated in a phased manner. A Bench of Justices Sudhanshu Dhulia and Aravind Kumar asked additional solicitor general Aishwarya Bhati, appearing for the Centre, to call a meeting of the Central Monitoring Committee with all the stakeholders within two weeks.

The Committee reviews the implementation of the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013 (MS Act, 2013). "The order passed by the court (in 2023) said that considering development of technology, it was entirely possible to eradicate manual scavenging and employment of labour for sewer cleaning. This has not been done. From the report, it appears that much needs to be done," the Bench said. Senior advocate

Parameshwar, who is assisting the SC as Amicus Curiae, submitted that 40 deaths occurred due to sewer

cleaning and cleaning septic tanks in 2024 but no FIR was filed. He flagged most of the committees as mandated under the Act were not in place, and pointed out noncompliance of the laws. The matter would come up in January, 2025.

Observing a large segment of India's population, involved in manual scavenging, remained unheard muted, in bondage and systematically trapped in inhumane conditions, the top court in 2023 directed the Centre and states to take appropriate measures, to ensure that manual sewer cleaning was completely eradicated in a phased manner.

The SC had asked the Centre to issue guidelines and directions that any sewercleaning work outsourced or required to be done by, or through contractors agencies, did not require individuals to enter sewers. The SC directed Governments pay Rs 30 lakh compensation to the next of kin of those who died while cleaning sewers

It directed all States and Union Territories to make sure all departments, agencies and corporations ensured the guidelines framed by the Centre were incorporated in their guidelines.
The SC had directed in the

case of sewer victims suffering from disability, the minimum compensation won't be less than Rs 10 lakh. If the disability rendered the victim economically helpless, the compensation should not be less than Rs 20 lakh, it said.



#### Yellow alert, cold wave conditions in Delhi: IMD

For the first time after the shift in the season, Delhiites experienced winter chill as the minimum temperature dipped to the season's lowest Wednesday at 4.9 degree celsius in Safdarjung station, dropping five degrees below normal this winter. There has been a three-degree celsius fall in the minimum temperature over Delhi-NCR during the past 24 hours. The Maximum and Minimum temperatures over Delhi are in the range of 20 to 23 degrees celsius and four to eight degrees Celsius respectively.

According to data, the lowest minimum temperature during this period was recorded on December 6, 1987, at 4.1 degrees celsius. The IMD has issued a yellow alert, warning of similar cold wave conditions for the next two days. According to the data, in December 2023 and 2022, there were no cold wave days. However, November 2020 saw cold wave conditions with the minimum temperature plunging to 7.5 degrees Celsius.



### Protests turn violent **Parbhani** city

## Want a drink in Delhi? Sarkari ID proof nikalo!

The Delhi government's excise department has directed hotels, clubs and restaurants serving liquor to verify the age of their clients through hard copies of government-issued identity proofs after violations of the legal drinking age norm were detected. In Delhi, liquor is served only to persons aged 25 years and above. Delhi is now the only metropolitan city with a high even in liquor is barred for those under 25, while wine and beer is allowed at 21. In major global cities such as New York and London, the drinking age is 21 and 18 respectively. Interestingly, the voting age is 18, while the minimum age of marriage for women is 18 and for men it is 21 in India.

The excise department of the Delhi government, during routine inspections by its teams in recent days, found customers younger than 25 years having alcohol at bars, clubs and restaurants. The inspections also revealed that some customers were consuming liquor pretending to have completed 25 years. Complaints were also received by the department that some excise licensees were serving liquor to underage persons, according to a circular issued by the

excise department. As per the data of the excise department, there are around 1,100 HCR (hotel, club, restaurant) category premises in the city including nearly 700 restrobars. The hotels and clubs with excise licence number around 165 and 50. Strangely rushed to Parbhani to review and control the situation in Parbhani city.

most HCR violates the drinking age norms while serving liquor. Under the Delhi Excise Act, 2009, no person or



licensed vendor or his employee or agent will sell or deliver liquor to any person apparently under the age of 25 years for personal or others' consumption. The violations of the age restriction norms were reviewed by the department.

"All the licence holders of hotels, clubs, restaurants (HCR) are hereby directed to be more careful and to not serve liquor to any person under the age of 25 years without verifying the age through government-issued IDs," stated a circular issued by the department.

"In this regard, attention is invited to section 23 of The Delhi Excise Act, 2009 which reads as, "Prohibition of sale to certain persons, - No person or licensed vendor or his employee or agent shall sell or deliver any liquor to any person apparently under the age of Twenty Five years, whether for consumption by self or others," Deputy Commissioner (Excise) Tanvir Ahmed said in a circular issued to hotels, clubs and restaurants.

physical ID instead of virtual IDs shown on the mobile phones (except govt. portals for eg. Digilocker) to minimize the chances of verification of age through fake/edited digital IDs," read the circular. The legal drinking age was a lingering issue in Delhi as it was lower in the NCR cities of Nodia, Gurugram, Ghaziabad and Faridabad. Under the excise policy 2021-22, now scrapped, there was a plan to lower the legal drinking age to 21 years but it failed to materialise as the came under attack allegations of corruption and violations

Further, in pursuance of a campaign launched recently by Delhi to make the city drug-free in the next three years, the excise department has directed the licensees to take e-pledge on its official website and conspicuously display the certificate at the hotels, clubs and restaurants. The department has advised the licensees to create awareness among their staff and customers to cooperate in stopping drug abuse and stay away from its use to have a healthy life. "To curb the menace of drugs, it is

### When criminals forget to wear a mask

Using the advanced Facial Recognition System (FRS), the Delhi Police has arrested three people who secured a loan of Rs 75 lakh by mortgaging a property and preparing forged documents. e nolice Sachdeva alias Roshan Manchanda (61), who had fabricated his property documents and identification credentials to secure the loan. The arrest also exposed the involvement accomplices, Suhail Chauhan and Nitin Verma, who

worked as freelance loan agents. According to the police, the

case was registered in 2019 on the complaint of Harminder Kaur Anand, a Bengalurubased resident, who alleged that the property she purchased in 2011 at Rana Pratap Bagh in Northwest Delhi had been fraudulently mortgaged to a private bank for a loan of Rs 75 lakh.

"The woman was shocked to learn about the fraud during a visit to the property in 2018 when neighbours reported suspicious activities and her Deputy property

The officer further said that the fraudsters had prepared forged documents to mortgage the property and availed the loan subsequently diverting the funds to multiple accounts under fake identities. The gang specifically targeted longvacant properties, creating a chain of fake documents to establish ownership. They then used these forged papers to secure loans from financial institutions. The funds were transferred to various accounts to avoid detection, making it difficult to trace

the money trail, he said.



### Rape accused Dy Collector gets anticipatory bail

Sorte was on leave till 30 November, he had also applied for it, but after that he remained on leave without application till December 10. Neither the application reached the Collector nor it was received by branch incharge.

Branch in-charge and Joint Collector Iqbal Mohammad said Deputy Collector Sorte's leave application was till 30 November. The branch has not received the application after this.

Āfter the victim's complaint a case has been registered against Deputy Collector Sorte in Pachor police station of Rajgarh district on November 14 on the charge of

A woman had complained against Sorte on October 25. The police had taken the matter under investigation and when police failed to register a case even after 19 days, on November 14, the victim lodged an e-FIR on the portal.

The Deputy Collector was not coming to the office since the case was registered. His leave application was also not received after November 30. On the other hand, his chamber opens every day, but the chair remains vacant. An anticipatory bail petition was filed by Deputy Collector Sorte in the Sarangpur court. It was rejected by the court. After getting information about the case, the former Chief Minister had issued letters. After this, a petition was filed in the High Court. From here, anticipatory bail was

granted on December 10.

The AIIMS Bhopal has achieved a significant milestone by successfully performing a rare and complex surgery to treat a 27-year-old patient diagnosed with Chronic Thromboembolic Pulmonary Artery Hypertension.

This procedure highlights AIIMS Bhopal's role as the only state-run hospital in Madhya Pradesh capable of handling such complex cases. The patient initially admitted with sudden shortness of breath and a persistent cough at a local hospital.

Despite symptomatic management, his condition did not improve, prompting his referral to AIIMS Bhopal. The diagnosis revealed Thromboembolic Pulmonary

Artery Hypertension (CTEPH). CTEPH is a rare and serious condition in which blood clots that have formed in the lungs over time cause high blood pressure in the lungs.

#### Patwaris on mass leave to protest suspension of colleagues

wo days after Collector Kaushalendra Vikram ■ Singh placed three Patwaris under suspension, over 100 of their colleagues went on mass leave in protest of what they termed as 'unilateral action' on the part of the district administration.

The protest by the Patwaris comes in the wake of the suspension of their colleagues Kishor Dangi, Pawan Shukla, and Nidhi Nema.

The three were allegedly operating out of private offices, where they sought bribes from landowners to fulfil official responsibilities. Patwaris have long remained the favourites of the outdated land revenue system, which places immense power in their hands. Their unbridled control of the land revenue system had Chief Minister Mohan Yadav remark that they wielded more power in their jurisdictions than even senior bureaucrats.

Entrusted with the upkeep of land records at the Circle or 'Halqa' level for centuries, booming real estate in urban areas has seen Patwaris emerge as dealmakers for land sharks who create large packets of real estate known as 'Chaks' before passing

The city is experiencing severe cold conditions for the last two days. Due to this, the temperature has dropped both day and night. Monday and Tuesday were cold days. The third day, Wednesday, also has similar weather.

Due to severe cold, the timing

of schools in Bhopal has been increased by 1 hour. Now no school will start before 9 am. DEO NK Ahirwar issued these instructions for all governmentprivate schools on Wednesday. This instruction will also be for all CBSE, ICSE and other board affiliated schools. After the order of Collector Kaushlendra Vikram Singh, all schools will start at a new time from Thursday.

In the last 5 days, the night mer-cury dropped to half. The temperature on the night of December 6 was 14 degrees, which reached 6.9 degrees last night. Only once in December, the temperature has reached 15.8 degrees Celsius.

There is a trend of severe cold in the second fortnight of December in Bhopal, but this time severe cold has started in the first fortnight itself.



## Secure messaging apps big challenge to counter online radicalisation: Govt

The use of secured messaging applications like Signal, Telegram, Viber and the dark Web besides end-toend encrypted WhatsApp by radical elements to connect with like-minded individuals is proving to be a "major challenge" for security agencies to counter online radicalisation, government said on Wednesday.

Replying to a question in the Rajya Sabha, Minister of State for Home Affairs Nityanand Rai said as the extensive use of cyber technology is the main tool for propagating radical ideology, cyberspace is being monitored ceaselessly. The minister said at present, apart from state police, the NIA is investigating 67 cases relating to online radicalisation. In these cases, 325 accused have been arrested, 336 accused have been charge-sheeted and 63 accused have been convicted

"Cyber patrolling is done on a regular basis to identify and monitor such content and entities which are targetbeing held with all stake-

ing gullible/depressed/ alienated youth," the minister said. He said websites and accounts involved in communal and anti-India propaganda affecting the sovereignty and integrity of India are being identified and sent to the Ministry of Electronics and Information Technology (MeitY) for action.

During 2024, MeitY has issued directions for blocking

holders and law enforcement

"The use of more secured

messaging applications like Signal, Telegram, Viber and dark Web apart from WhatsApp with end-to-end encryption by radical ele-ments to connect with other likeminded elements has proved to be a major challenge for security agencies in its efforts to counter radicalized individuals online," the minister said.

He said the CBI, as National Central Bureau for India, continues to be engaged with INTERPOL for combating Online Radicalisation.

"During the 90th INTERPOL General Assembly held in New Delhi from 18-21st October 2022, the INTER-POL unveiled the first ever Metaverse which is specifically designed for law enforcement worldwide," he

Rai said in January 2024, the INTERPOL released a whitepaper on a law enforcement perspective on Metaverse and identified the issue of radicalisation, while noting that terrorists may exploit the Metaverse for online recruitment, radicalisation, training and indoctrination of individuals.

### Azam Khan slams INDI Alliance, accuses it of ignoring Muslims

Senior Samajwadi Party (SP) leader and former minister Azam Khan has sharply criticized the INDI alliance, accusing it of ignoring the concerns of Muslims. He urged the alliance to raise the issue of crime and alleged destruction in Rampur in Parliament, just as it did with Sambhal. "Sambhal was targeted only

after the experiment in Rampur succeeded," Khan claimed. "The INDI alliance remained silent on this. If this continues, we will be compelled to reconsider the future of Muslims," he warned.

Azam Khan, currently lodged in Sitapur Jail, expressed his concerns through a letter handed to Rampur SP district president Ajay Sagar, who visited him. Sagar later released the contents of the letter to the public.

Khan accused the INDI alliance of working to eliminate Muslim leadership. "The alliance stood as a silent spectator while Rampur was destroyed. It must clarify its stance or we will be forced to reconsider our future," he

He further alleged that Muslims are being politically marginalized. "The Muslim vote has become meaningless. Their right to vote is being reduced to a tool for genocide. If this continues, we will have to decide whether retaining the right to vote is even worth it.

Khan criticized attempts to destroy religious sites by declaring them controversial. "Other communities cannot be wiped out under the guise of removing disputed places of worship. People conspire and feign sympathy,'

Azam Khan's political influence in Uttar Pradesh has been significant. He was




and served as an MP once from Rampur. His wife, Tanzeen Fatima, also became an MLA, while his son, Abdullah Azam, was elected

During the SP government, Khan wielded immense influence, rivaling even that of a Chief Minister. The state aircraft was often used to transport him to Rampur, which many considered a secondary seat of power.

However, his political dominance began to decline after 2017. His troubles escalated in the 2019 Lok Sabha elections when he made a controversial remark targeting bureaucrats at a rally in Rampur. "Don't fear these collectors and officers; they are just salaried employees. İf Allah wills, I will make them clean my shoes after the elections," he reportedly said.

The remark triggered a wave legal troubles. Investigations linked to land acquisition for Jauhar University led to over 100 cases being filed against Khan and his family. He was declared a land mafia, and both he and his wife were imprisoned.

The legal onslaught began when Anjaneya Kumar was the district magistrate in Rampur. Following complaints from farmers about alleged illegal land acquisitions for Jauhar University, the administration initiated inquiries that snowballed into multiple cases. Khan and his family have since faced prolonged legal battles and jail

### Odisha exempts exempts Rs 4097.67 Crore electricity dues for industries

The Odisha government has exempted electricity dues amounting to Rs 4097.67 crore for 14 industries under various schemes during the last 10 years, Deputy Chief Minister Kanak Vardhan Singh Deo told the Assembly on Wednesday.

In a written reply to a question from senior Congress MLA Taraprasad Bahinipati, the Deputy CM, who is in charge of the energy department, said the electricity duty for these 14 industries was exempted since the financial year 2015-16 under schemes such as the Industrial Policy Resolution (IPR) and the Special Special Economic Zones (SEZ) Policy. According to the statement submitted by Singh Deo, the Odisha government exempted the highest electricity dues of Rs 3599.88 crore for Vedanta Ltd, Jharsuguda, under the SEZ Policy-2015, while the central PSU, Indian Oil Corporation

crore. Additionally, Angulbased Jindal Steel and Power Ltd (JSPL) was granted a waiver of Rs 103.16 crore in electricity duty.

Apart from these exemptions, the Deputy CM further informed the House that the state government has also exempted electricity dues (through rebate on interest for pending bills) amounting to Rs 1324.83 crore for 36 industries under the One-Time Settlement Scheme, 2022 of the energy department.

Under this scheme, the government waived electricity dues of Rs 550.12 crore for Rourkela Steel Plant (RSP), a unit of SAIL, Rs 440.12 crore for IMFA Ltd, Choudwar, and Rs 203.91 crore for the central PSU National Aluminium Company (Nalco), the Deputy CM said.

Among others, the power bills of JSPL, Angul (Rs 35.76 and Rs crore), Aditya Aluminium Ltd, respectively.

Ltd (IOCL), Paradip, received Sambalpur (Rs 17.79 crore), (Rs 16 crore), and Vedanta Ltd, Lanjigarh (Rs 10.13 crore) were also exempted by the Odisha government, he informed.

According to data provided by the engineer-in-chief-cumprincipal chief electrical inspector, power dues worth Rs 1096.32 crore were pending against 23 industries as of October this year, Singh Deo added.

## **Race for Delhi**

With the Delhi Assembly elections on the horizon, the political temperature in the capital is rising

s the Delhi Assembly Elections 2025 draw closer, the political landscape of the national capital is abuzz with activity. Major players—the incumbent Aam Aadmi Party (AAP), the Bharatiya Janata Party (BJP), and the Congress—are gearing up for what promises to be a fiercely contested battle. With 70 seats at stake, every party is refining its strategies to sway the electorate in its favour. The Aam Aadmi Party, led by Arvind Kejriwal, remains a dominant force in Delhi politics. In the 2020 elections, AAP swept the polls, securing 62 out of 70 seats, while the BJP managed only 8, and Congress failed to open its account. However, the 2025 elections present new challenges for the party, including anti-incumbency sentiments and a more aggressive opposition. One of the most intriguing aspects of AAP's strategy is the decision to field senior leader Manish Sisodia from the Jangpura constituency. South Delhi, which has traditionally been a mixed battleground. Sisodia's administrative acumen and popularity could be pivotal in securing a win in this cru-

Yet another aspect is Kejriwal's decision to go solo. Despite initial speculations about a possible alliance between AAP and Congress, Arvind Kejriwal has now said that AAP would have no electoral alliance with Congress. The strained relationship between the two parties, fueled by ideological differences and a history of rivalry, seems to have outweighed any potential advantages of a partnership. Additionally, AAP's leadership might perceive a tie-up with Congress as

a liability, given the latter's diminished presence in Delhi politics. But it also diminishes its own chances as vote split in this scenario is imminent. Congress has dedicated vote bank in Delhi and that could hurt AAP. On the other side, the BJP, aiming to reclaim its footing in Delhi, is expected to focus on its core voter base and polarising issues to galvanise support. The party has intensified its outreach efforts and is likely to emphasise nationalistic themes and the central government's achievements under Prime Minister Modi. However, its challenge remains breaking through AAP's stronghold on key urban constituencies. Congress faces an uphill battle as it tries to regain relevance in Delhi's political scene. The party's lack of significant organisational groundwork and leadership issues have kept it on the sidelines in recent years. However, Congress might attempt to consolidate minority vote and traditional voters to make a dent in the electoral outcome. The decision to avoid an alliance with Congress underscores AAP's confidence but also raises questions about its ability to counter a potentially consolidated opposition. As candidates hit the campaign trail, the capital is set to witness a clash of ideologies, promises and personalities. For now, all eyes are on the unfolding strategies as Delhi gears up for another defining electoral battle.

rebels conquered Syria's capital Damascus and forced President Bashar al-Assad to flee the country is not only surprising, but it may also mark the start of a new era of uncertainty for West Asia as a whole. The excitement with which Syrians welcomed the opposition soldiers demonstrates that Bashar al-Assad has become even more unpopular. His disfavour stemmed from his brutal governance over Syria. Syria has been dealing with insecurity and upheaval for nearly 13 years. Iran has suffered a significant setback with the seizure of Syria by rebel forces. It is dubious that Iran will sit in peace after the demise of the administration it sponsored in Syria.

Even if the rebels win Syria without massive violence, the chances of durable peace are slim because Turkey wants to administer the country its way. Although India's economic ties with Syria have not grown significantly, both countries have joined forces in the battle against terror. Not only that, but Bashar al-Assad has always supported India about Kashmir. Syria has even stated that the elimination of Article 370 in Kashmir is a domestic matter for India and that any country has the right to take the necessary steps to safeguard its residents on its territory. It remains to be seen what kind and how much Syria's posture will alter considering the new circumstances. Indian-Turkish relations have recently improved. While its attitude on Kashmir has softened, India has not attempted to block Turkey's membership in BRICS.

# Rebel forces oust Assad as Damascus falls

The fall of Assad's regime signals a new chapter in Syria's tumultuous history, raising critical questions about the country's path to stability



yrian President Bashar al-Assad's government has been fighting rebel groups with the support of Russia, Iran, Lebanese and Hezbollah right from 2011. Within ten days of rebels getting control over northwestern city of Aleppo and further capturing Hama and Homs, the capital Damascus also fell under their control on December 8. President Assad along with his wife and three children fled the country before rebel forces could reach him. He has been granted asylum in Moscow. His younger brother was tipped to succeed his father as President, died in a road accident.

He was called back from London, where he was practising ophthalmologist, to succeed his father as President of Syria. In the initial months after taking over the Presidency in the year 2000 he was seen as a reformist and pro-people in sharp contrast to his father Hafez al-Assad's three-decade rule with iron hands. Once pro-democracy protests erupted in 2011, he followed the brutal tactics of his father to crush dissent. The conflict escalated into civil war and he was seen unleashing his military to blast opposition-held territories. All supporters of the Assad regime have considerably weakened their backing on account of the ongoing war they are engaged in.
Russian forces have a challenging battle in

Ukraine. Owing to the high level of causalities of soldiers in the battle, Russia has withdrawn its forces from Syria partially and is even further recruiting foreign nationals in the force to keep the war going, which has already been continuing for a quarter to three years. Hamas's terror attack on Israel on October 7, 2023 and Israel's response to Gaza opened several dimensions of the West Asia conflict.

Iran's supported terror groups like Hezbollah in Lebanon, and Houthis in Yemen have denounced Palestinians suffering in Gaza on account of Israeli bombardment and it opened additional fronts for Israel in the conflict. This has also weakened Iran and Hezbollah to provide adequate support to Assad's regime. In addition, 13 years of Syrian civil war has exhausted the Syrian Army. Owing to the corruption in the bureaucratic and political circle of the Syrian government, and the series of Western sanctions, the economy

has been hardly afloat. Further President Erdogan in Ankara, is facing the heat on account of three million Syrian migrants living in Turkiye and more so because Syria dismisses his proposal for deporta-tion of migrants alleging that his country has illegally occupied Syrian areas along the border.

There was an option for Assad to join the Arab League last year, but he did not accept making Arab nations also opposed to him. Earlier with the help of Iran and Russia, he had survived the Arab Spring Rebellion against him, which originated in Tunicia in 2011. The part inated in Tunisia in 2011. The next question is about the future of Syria. Hayat Tahrir al-Sham (HTS) is a Sunni Islamist militant group, that played an important role in the Syrian civil war. It is this group that has led other rebel groups to occu-

py Damascus. The US, UK and UN have designated it as a terrorist organisation. A BLAST bounty of \$10 million was on its chief Abu Mohammad al-Golani's head. UK has indicated lifting the ban on HTS if it delivers on promises like protecting minorities and people's rights. Turkiye has backed some other rebel groups in the Syrian civil war, which do not have good ties with HTS. US-backed Kurdish YPG militia has established control in Syria's northeast, also known as the Kurdish democratic union party (PYD) does not enjoy good and workable relations with HTS. There are separate rebels in Syria's southwest.

It is quite difficult for all the groups to come together and be partners in Syria's new regime. 900 strong military men are maintained by the US in northeastern Syria. The US has maintained this presence in the name of countering ISIS, but its actual goal was the regime change in Syria. The US has now emerged clear winner. As rebels have asserted control over Syria and its capital Damascus, uncertainties remain

The first day was marked by arsenals, looting of shops and banks, and emptying prisons followed by a night curfew, but the second day saw normalcy slowly returning to the capital and other cities. The main rebel commander al-Golani met Assad's PM Mohammad Jalali and Vice President Faisal Mekdad to install a transitional government in Syria. Further, Golani has announced publicly that they would bring out a list of government officials responsible for torturing the

In the meantime, there have been air strikes in Syria by Israeli, US and Turkey forces to protect each of their interests. Iran and Russia have suffered major setbacks with the fall of Assad's government.

Both countries have lost their key

allies. As Sunni Islamic groups are going to be in control of Syria, Iran a predominantly Shia population is more vulnerable to Israeli attacks. When rebel forces took control of Aleppo about a week earlier, both Iran and Russia could not extend adequate defence leading to the fall of even Damascus. Iran was exposed in recent Israeli direct attacks, and Hezbollah was also decimated, no significant support came from Assad. In recent months, Assad's Syria and Iran could not support each other when exigencies arose. Syria is the only state that had joined Iran's 'Axis of resistance' against the US and Israel.

The axis has become weak; even Hezbollah's downfall could not be prevented. Hezbollah has signed a ceasefire deal with Israel ahead of any Gaza deal. The action of the state of Iran and the Iranian Revolutionary Guards Corps (IRGC) to defend Assad did not go well with the people of Iran. It had political and economic costs. The fall of Assad sends a disturbing signal to Iran's supreme leader Ayatollah Khamenei, who now

tance can no longer protect the allies. Assad's fall has also emboldened opposition groups in Iran. Besides these, women are protesting for their rights.

All these may lead to regime change in Iran too. If the Supreme Leader realigns himself with the US by reviving/ softening its stand on the 2015 nuclear deal, then regime change in Iran can be avoided. The last two weeks of violence that culminated in Assad's fleeing Syria, also saw the Shia population enthusiastically taking measures to secure the tomb of Sayyeda Zainab, the daughter of Hazrat Ali and Fatima and granddaughter of Prophet Muhammad. This holy site signifies great importance for Shia Muslims worldwide. To guarantee the security of this precious shrine, Shias from Iran, Iraq and Pakistan are also moving to Syria. The shrine is located in al-Sitt, south Damascus.

Since 1979 Iranian government has provided financial support for the management of the shrine. Severai Snia scholars and celebrities are buried in the shrine and surrounding cemeteries. Since 2012 the town has been under attack from armed militants in neighboring Sunni towns. Many Shia families were driven out of their homes in southern Damascus.

Rockets landing on random places was quite common. Sunni Muslims comprise 74 per cent of Syria's population, whereas Shias are only 3per cent. Shias hold quite a strong sentiment for the shrine; the issue can be a potential flash point between the two sects and would also determine the rivalry between rebel

Will Syria's transition to democracy be smooth? It is possible only when different rebel groups learn to share power.

ndia has been declared as the third-largest energy-to the rising income and improving standards of living. In response to the escalating energy demand, India has set ambitious targets for solar energy capacity, aiming to reach 280 GW by 2030 (the highest among all renewable sources). And owing to the rise in awareness surrounding solar energy solutions, the country has achieved 70.10 GW of solar energy capacity by June 2023, which is 70.1 per cent of the target of 100 GW set in the year preceding. The rising awareness of solar solutions among consumers, particularly rooftop solar solutions, is a notable trend in the solar

energy market. This trend has been driven by



various factors, including technological advancements, innovation, digital revolution to unlock more of the sun's potential and support from the Government. Central Community leaders, particularly in rural and non-metro areas, have also emerged as crucial drivers in promoting the adoption of solar energy solutions. However, despite this awareness, a significant ness of the advantages of solar energy and its widespread adoption. The adoption rate remains relatively low.

Reportedly, the country fell short of its renewable energy target for 2022 by 32 per cent, with an installed capacity of 119 GW compared to the target of 175 GW. Thus, the Solar Spectrum of New India presents both challenges and opportunities on the path towards a sustainable energy future. By addressing issues of accessibility, skill shortages, and perceived costs, stakeholders can work together to accelerate solar adoption trends and pave the way for a brighter, cleaner future for

It's also imperative because the demand for reliable power in urban and rural areas will double by 2030. This surge in

demand will be powered by increased industrial, economic, and domestic consumption activities throughout the coun-

## Ex-defense chief in South Korea tried to kill himself after being arrested over martial law

AP SEOUL (SOUTH KOREA)

South Korea's previous defence minister was stopped from attempting suicide while in detention over last week's martial law declaration, officials said Wednesday, as President Yoon Suk Yeol's office resisted a police attempt to search the compound.

The main liberal opposition Democratic Party plans to introduce a new motion to impeach Yoon for his December 3 declaration that imposed martial law in South Korea for the first time in more than four decades.

Its first impeachment attempt against Yoon last Saturday failed after ruling party law-makers boycotted the vote. The party said it plans to submit the new motion on Thursday to set up a vote on Saturday

Yoon's ill-conceived power grab has paralysed South Korean politics, frozen its foreign policy and rattled financial markets. On Wednesday, rival

North Korea's state media for the first time reported about the turmoil across the border, but the country hasn't showed any suspicious activities.

Shin Yong Hae, commissioner general of the Korea Correctional Service, told lawmakers that former Defense Minister Kim Yong Hyun tried to kill himself the previous night at a detention centre in Seoul. He said correctional officers stopped him and that he was in stable condition.

Kim was arrested early Wednesday after a Seoul court approved a warrant for him on allegations of playing a key role in a rebellion and committing abuse of power. Kim became the first person formally arrested over the martial law decree. Kim, one of Yoon's close associates, has been accused of recommending martial law to Yoon and sending troops to the National Assembly to block lawmakers from voting on it. Enough lawmakers eventually managed to enter a parliament chamber and they unanimous-

ly rejected Yoon's decree, forcing the Cabinet to lift it before daybreak on December 4.

Kim said in a statement on Tuesday that he "deeply apologises for causing significant anxiety" to the public. He said all responsibility for the martial law imposition rests with him and pleaded for leniency for soldiers deployed to enforce

Yoon's office hampers search of presidential compound: Later Wednesday, police detained National Police Agency Commissioner General Cho Ji Ho and Kim Bong-sik, head of Seoul's metropolitan police. They were accused of deploying police forces to parliament to block lawmakers from voting.

The main focus of investigators is finding whether Yoon, Kim and others involved in imposing martial law committed rebellion. A conviction on the charge of rebellion carries a maximum death sentence South Korean police said they sent officers to search Yoon's office on Wednesday to look for any evidence related to the martial law introduction. But investigators failed to enter

the office as of Wednesday

evening, about six hours after their arrival, senior police officer Lee Ho-young said in parliament. Some observers earlier said that the presidential security service won't likely permit searches of Yoon's office, citing

a law that prohibits searches of

sites with state secrets without

approval from those in charge of those areas. Yoon on Saturday apologised over the martial law decree, saying that he won't avoid legal or political responsibility for it. He said he would leave it to his party to chart a course through the country's political turmoil, "including matters related to my term in office."

The leader of Yoon's ruling party later vowed to arrange the president's stable exit from office, saying the party will Korean political chaos and coordinate with Cabinet mem-protests triggered by Yoon's bers over state affairs and that Yoon will be sidelined from duties.

The comments were criticised as unrealistic and unconstitutional, but caused widespread questions about who is in charge of South Korea and its military at a time of heightened tensions with North Korea. The Justice Ministry on Tuesday banned Yoon from leaving the country as he faces investigations.

Vice Defense Minister Kim Seon Ho reiterated Wednesday that Yoon remains in charge of the military. But Yoon hasn't been involved in any major official activities since lifting martial law, except for accepting resignation offers by officials involved in the martial law case and appointing the head for the country's Truth and Reconciliation Commission.

A view from North Korea: A Wednesday article from the North's state news agency reported about the South

protests triggered by Yoon's martial law decree. The report mostly attempted to explain the South Korean events, though it called Yoon "a traitor" and his military "gangsters."

Many experts say North Korea is sensitive to the domestic spread of news on major antigovernment protests in foreign countries, because its own people have no official access to international news and could be affected by such events. The US State Department said Monday that the US-South Korean alliance remains "ironclad" and that Washington is committed to the peace and security of the Korean Peninsula

In his martial law announcement, the conservative Yoon stressed a need to rebuild the country by eliminating "shameless North Korea followers and anti-state forces," a reference to his liberal rivals who control parliament. Since taking office in 2022, Yoon has had nearconstant friction with the

Democratic Party, which introduced motions to impeach some of his top officials and launched a political offensive over scandals involving Yoon and his wife.

Opposition parties and many experts say the martial law decree was unconstitutional. They say a president is by law allowed to declare martial law only during wartime or similar emergency situations, but South Korea wasn't in such a

predicament. They argue that deploying troops to seal the National Assembly to suspend its political activities amounted to rebellion because the constitution doesn't allow a president to use the military to suspend parliament in any situation.

If Yoon is impeached, his presidential powers would be suspended until the Constitutional Court decides whether to restore his powers or remove him from office. If he is dismissed from office, a new presidential election would be

even after Israel reached a ceasefire with Lebanon's Hezbollah and attention shifted to the overthrow of Svrian President Bashar Assad. Both the outgoing and incoming US administrations have said they hope to end the war before the inauguration but months of ceasefire talks have repeatedly stalled.

The strike that killed 19 occurred in the northern town of Beit Lahiya near the border with Israel, according to the nearby Kamal Adwan Hospital, which received the bodies. Hospital records show that a family of eight was among those killed, including four children, their parents and two grandparents

The hospital said another strike near its entrance on Wednesday killed a woman and her two children.

Another strike in the built-up tral Gaza killed at least seven people, according to the Awda Hospital. The dead included two children, their parents and three relatives, it said.

There was no immediate comment from the Israeli military. The military says it tries to avoid harming civilians and accuses militants of hiding among them, putting their lives in danger.

Militants in central Gaza meanwhile fired four projectiles into Israel on Wednesday, two of military said. The other two fell in open areas, and there were no reports of casualties.

The military ordered the evacuation of a five-block area of the built-up Maghazi refugee camp in central Gaza, saying the rockets had been fired from there. The orders indicated that Israel would soon carry out strikes in the area.

The war began when Hamasled militants stormed into Israel on October 7, 2023, killing some 1,200 people, mostly civilians, and abducting around 250 people, including children and older adults. Around 100 hostages are still inside Gaza, at least a third of whom are believed to be dead.

Israel's retaliatory offensive has killed over 44,000 Palestinians in Gaza, according to local health officials. They say women and children make up more than half the dead but do not distinguish between fighters and civilians in their count. Israel says it has killed over 17,000 militants, without providing evidence.

Thousands more Palestinians have gone missing during the war, some after encounters with Israeli troops.

Israel has been waging a renewed offensive against Hamas in Gaza's isolated and heavily destroyed north since surrounded Beit Lahiya, Beit Hanoun and the urban Jabaliya refugee camp, allowing in almost no humanitarian aid and ordering tens of thousands to flee to nearby Gaza

Israeli officials have said the three communities are mostly deserted, but the United Nations humanitarian office said Tuesday that it believes around 65,000 to 75,000 people are still there, with little access to food, water, electricity or health care. Experts have

warned that the north may be experiencing famine.

Sigrid Kaag, the senior UN humanitarian and reconstruction coordinator for Gaza, told reporters at the UN on Tuesday that civilians trying to survive all across Gaza face an "utterly devastating situation."

She pointed to the breakdown in law and order and looting that has left the UN and many aid organisations unable to deliver food and other humanitarian essentials to hundreds of thousands of Palestinians in need.

Kaag said she and other UN officials keep repeatedly asking Israel for access for convoys to northern Gaza and elsewhere, to allow in commercial goods, to reopen the Rafah crossing from Egypt in the south, and to approve dual-use items.

The Israeli military says it allows in enough humanitarian aid and blames UN agencies for not distributing it, saying large amounts of aid have accumulated just inside Gaza's borders. UN officials say Israeli restrictions, the breakdown of law and order and ongoing fighting make it difficult to access the aid and distribute it, and have repeatedly called for

a ceasefire. The United States, Egypt and Oatar have been m talks between Israel and Hamas for nearly a year, and diplomats say those efforts have recently

gained momentum But Hamas has said it will not release the remaining hostages without an end to the war and a full withdrawal of Israeli troops. Israeli Prime Minister Benjamin Netanyahu has pledged to continue the war until Hamas is destroyed and all the hostages are returned and has said Israel will maintain a lasting military presence in some areas.

TikTok has challenged a Canadian government order to shut down the Chinese video-sharing app's business operations in the country that was imposed over national

The company said Tuesday that it filed an application for a judicial review with the Federal Court in Vancouver on December 5, which seeks to set aside the order for TikTok to wind-up and cease its business in Canada.

The Canadian federal government last month announced it was ordering the dissolution of TikTok Technology Canada Inc. after a national security review of its Chinese parent company ByteDance Ltd.

The government is not blocking access to the TikTok app, which will continue to be available to Canadians. TikTok said it has 14 million users in Canada, which is about a third of the population. It has offices in Toronto and Vancouver. The wildly popular platform is owned by ByteDance, a Chinese company that moved

### Man accused of killing UnitedHealthcare's CEO shouts on way to courthouse, fights extradition

The man charged with murder in the killing of the CEO of UnitedHealthcare made it clear he wasn't going to make things easy on authorities, shouting unintelligibly and writhing in the grip of sheriff's deputies as he was led into court and then objecting to being brought to New York to face trial.

The displays of resistance Tuesday weren't expected to significantly delay legal pro-ceedings for Luigi Nicholas Mangione, who was charged in last week's Manhattan killing of Brian Thompson, the leader of the United States' largest medical insurance company. Little new information has come out about possible motivation, though writings found in Mangione's possession hinted at a vague hatred of corporate greed. In his first public words since he was arrested at a McDonald's in Pennsylvania after a five-day search, the 26year-old Ivy League graduate from a prominent Maryland real estate family emerged from a patrol car shouting about an

"insult to the intelligence of the American people" while deputies pushed him inside a courthouse

A law enforcement bulletin obtained by The Associated Press said that at the time of his arrest, Mangione was carrying a handwritten document expressing anger with what he called "parasitic" health insurance companies and a disdain for corporate greed and power. He wrote that the US has the most expensive health care system in the world and that profits of major corporations continue to rise while "our life expectancy" does not, according to the bulletin.

Mangione remained jailed in Pennsylvania, where he was initially charged with possession of an unlicensed firearm, forgery and providing false identification to police.

Manhattan prosecutors were beginning to take steps to bring Mangione to New York, but at a brief hearing Tuesday, defence lawyer Thomas Dickey said his client will not waive extradition and instead wants a hearing on the issue. Mangione was denied bail after claimed to have acted alone.

prosecutors said he was too dangerous to be released.

He mostly stared straight ahead at the hearing, occasionally looking at papers, rocking in his chair or looking back at the gallery. "You can't rush to judgment in this case or any case, Dickey said afterward. "He's presumed innocent. Let's not forget that?

Mangione was arrested in Altoona, Pennsylvania, about 230 miles (about 370 kilometres) west of New York City, after a McDonald's customer recognised him and notified an employee, authorities said. New York police officials have

said Mangione was carrying a gun like the one used to kill Thompson and the same fake ID the suspected shooter had used to check into a New York hostel, along with a passport and other fraudulent IDs.

#### Centre further tightens wheat stock limit for wholesalers, retailers and processors

#### ADB lowers India's GDP growth forecast to 6.5 per cent for FY25

The Asian Development Bank (ADB) on Wednesday lowered India's economic growth forecast to 6.5 per cent for the current financial year from its earlier estimate of 7 per cent due to lower-than-expected growth in private investment and housing demand.

The multilateral development bank has also lowered India's growth forecast for 2025-26 financial year.

Changes in US trade, fiscal, and immigration policies could dent growth and add to inflation in developing Asia and the Pacific, according to the latest edition of Asian Outlook Development

The report also said Asia and the Pacific's economies are projected to grow 4.9 per cent in 2024, slightly below ADB's September forecast of 5 per

"India's outlook is adjusted downward from 7 per cent to 6.5 per cent for this year, and from 7.2 per cent to 7 per cent next year, due to lower-thanexpected growth in private investment and housing demand," ADB said.

Last week, the Reserve Bank also significantly lowered the growth projection for current fiscal year to 6.6 per cent from 7.2 per cent earlier and hiked the inflation forecast to 4.8 per cent in view of slowdown economic activity as well as stubborn food prices.

India's GDP growth fell to a 7quarter low of 5.4 per cent in July-September period of current financial year 2024-25 as against RBI's own projection of 7 per cent. India's growth will remain robust, with the economy supported by higher agriculture output resulting from the summer (or kharif) crop season (which will also put downward pressure on food prices); continued resilience of the services sector; and lower-than-expected Brent crude prices in 2024 and 2025, ADB

It further said strong forwardlooking and labour market indicators, such as PMI for industry and services, urban labour force participation and Reserve Bank of India's industrial outlook, suggest that economic momentum will recover in the coming quarters. The report further said Southeast Asia's growth outlook has been raised to 4.7 per cent this year from a previous forecast of 4.5 per cent, driven by stronger manufacturing exports and public capital spending.

The forecast for next year is unchanged at 4.7 per cent. The Manila-headquartered bank has kept the growth forecast for China unchanged at 4.8 per cent this year and 4.5 per cent next year.

## FIFA prepares to give host of 2034 World Cup to Saudi Arabia

audi Arabia will be confirmed by FIFA as host of the men's soccer 2034 World Cup on Wednesday, giving the oil-rich kingdom its biggest prize yet for massive spending on global sports driven by Crown Prince Mohammed bin Salman.

The decision completes a mostly opaque 15-month bid process which FIFA president Gianni Infantino helped steer toward Saudi Arabia without a rival candidate, without taking questions, and which human rights groups warn will put the lives of migrant workers at risk.

FIFA and Saudi officials say hosting the 2034 tournament can accelerate change, including more freedoms and rights for women. A fast-track path to victory was cleared last year by FIFA accepting a three-continent hosting plan for the 2030 World Cup led by Spain, Portugal and Morocco. That bid also will win Wednesday in a combined approval for the 2030 and 2034

tournament hosts by applause from more than 200 FIFA member federations in an online meeting hosted from Zurich by Infantino.

It will kick off a decade of scrutiny on Saudi labor laws and treatment of workers mostly from South Asia needed to help build and upgrade 15 stadiums, plus hotels and transport networks ahead of the 104-game tournament.

One of the stadiums is planned to be 350 meters (yards) above the ground in Neom - a futuristic city that does not yet exist — and another named for the crown prince is designed to be atop a 200-meter cliff near Rivadh.

During the bid campaign, FIFA has accepted limited scrutiny of Saudi Arabia's human rights record that was widely criticized this year at the United Nations. Saudi and international rights

groups and activists warned FIFA it has not learned the lessons of preparations to host the 2022 World Cup.






