The bronze statue stands 10 feet tall and weighs 10 quintals and was crafted under the supervision of renowned artist Sanjib Biswal and prominent sculptor Laxmidhar Rana along with a team of 20 artisans. It has been installed on an eightfoot-high lotus-shaped pedestal situated prominently at the centre of a roundabout that connects the city to the Netaji Subhash Chandra Bose Setu towards Bhubaneswar.

# **Ex-ORHDC MD** Kumar gets 3-yr RI

### 10th conviction in corruption case PNS CUTTACK

The Court of Special Judge, Vigilance, Bhubaneswar on Tuesday convicted Vinod Kumar, former Managing Director, Orissa Rural Housing Development Corporation (ORHDC), for illegal sanction and disbursement of loan to an NGO and sentenced him to three years' rigorous imprisonment (RI).

Besides, the court also directed Kumar to pay a fine of Rs 25,000.

The court also convicted

Purna Chandra Das, former Executive Director, Technical, ORHDC, and Subash Chandra Panda, State Coordinator, AWARE (NGO), Bhubaneswar in the case.

Earlier, the Vigilance police had charge-sheeted Kumar for showing undue official favour to Panda for illegally sanctioning and disbursement of loan on the basis of fabricated documents without security.

This is the 10th conviction involving corruption in the ORHDC by former MD Kumar and other officials by hatching a criminal conspiracy with private persons





## coastal biodiversity mapping

Experts stress on State's

#### Give several recommendations BHUBANESWAR PNS

m A}$  mapping of the available biodiversity and other natural resources of the Odisha coast in view of enhanced human activities and the increased impacts of global warming and climate change would provide a baseline for making strategies for sustainable management of coastal ecosystem, recommended the experts at the 15th Odisha Environment Congress organised at the Berhampur University recently on the theme 'Environment and Coast'.

The Congress also recommended for constituing a team of experts for advising the government on developing resilient infrastructure along the coast, conducting regular scientific studies on natural disasters, strictly enforcing the Integrated Coastal Zone Management (ICZM) regulations,

conducting a thorough study on the river mouths and creeks along the coast and creating new mangrove forests by plantation initiatives.

Besides, the experts were unanimous on creating a buffer zone along the coast in the form of a green corridor, developing sand dunes and wetlands, taking special measures to protect Bhitarkanika Mangrove Forests from further ecological degradation, long-term study programmes with respect to the fish, bird and dolphin populations in Chilika, an EIA study involving scientific experts for the proposed national highway over the lake, launching liveli-

hood programmes for fishers during the fishing ban period, undertaking special ecorestoration measures in erosion-degraded areas and emphasizing on the environment studies in schools and colleges under the New Education Policy 2020.

## Odisha aims to produce 7.5-GW solar energy This includes 508 MW of to promote renewable en-

ground-mounted, 58 MW of rooftop, and 42 MW of offgrid solar capacity. 28% of the 1,343 MW of renewable energy is in the development pipeline. Top districts for solar potential include Sundargarh (15.23 GW), Angul (14.06 GW), Balangir (11.62 GW), Jharsuguda (11.45 GW), and Dhenkanal(9.70 GW). These are also Odisha's key industrial hubs.



## Inmate stays put in jail for 5 yrs for forgetting home address! Recently shifted to rehab home in Sambalpur

A 34-year-old inmate has been unable to go home for the last 5 years after his release on bail from Sambalpur Central Jail, as he does not remember the address of his home. The District Court recently ordered the permanent remission for him; however due to wrong address the jail officials still could not send him home

and finally lodged him in a rehabilitation home for the mentally challenged in Sambalpur.

According to jail officials, the inmate, identified as Jabira Sattar, son of Muhammad Rehman, is basically from Jharkhand; however, the address mentioned in the chargesheet copy in 2019 is not correct, for which two teams of jail officials visited Jharkhand and Aghora village under the Sonua Police Station in the Ranchi district of Jharkhand, but they failed to find his home there or any-



body of his near and dear or even knowing him.

Though Jabira Sattar had never created any chaos in the prison and had very good behaviour with others, he was not intelligible. Neither the

### other inmates nor the prison staff could understand his language.

Recently, on December 13, the Sambalpur District Court ordered to release him from Sambalpur Central Jail. On the next day he was handed over to Sambalpur Dhanupali police to find his home address and send him to his home. As his address is wrong, police and jail officials visited the mentioned place and verified with the concerned police stations but could not locate his home.

In the end, he was shifted to

Samarth, a shelter for mentally challenged people in the Sambalpur district, in an ambulance.

Dhanupali PS Inspector Subrat Panigrahi said, "The inmate was granted bail in the same month he was jailed in a corex case in 2019. He was charged as per FIR when he was able to tell the address; however, that address was wrong. Our team, along with jail officials, had visited Jharkhand to find his home but in vain. Now he is there in a shelter for mentally-ill people.'

## Rainfall warning issued for several dists Temp to fall from Jagatsinghpur, Ganjam,

# **In Ganjam Tiger skin smuggling racket busted; 11 held** Kali temple donation box looted

### BALESWAR

Forest Department officials have busted a tiger skin smuggling racket and arrested 11 members of the group on Sunday in Baleswar.

Acting on inputs, the Forest Department formed a special team and conducted raids at various locations. During the raids, four suspects from Bhadrak and seven from Mayurbhanj were arrested.

Baleswar DFO Khushwant Singh said, "We received confidential information about the trade of Royal Bengal Tiger (RBT) skin. Acting on the tipoff, we formed a special



team that detained four individuals in possession of the RBT skin. Preliminary investigations suggest the tiger was killed with a bullet, but forensic reports would provide further clarity.'

"The detained individuals provided details about four more suspects, leading to their arrest. These suspects, in turn, revealed the involvement of

three others. In total, we man aged to apprehend 11 individuals linked to this crime," he added further. Earlier, the Special Task Force (STF) of the Crime Branch had seized a leopard skin in Boudh and arrested a person in possession

of it. Similarly, in late November, forest officials arrested two individuals for possessing leopard skins in Kandhamal.

It is often believed that while positive thinking being a trademark slogan (fill your mind with positivity, you shall reap the benefits) in business and society is just a folklore wisdom, negative thinking and negative emotions are just like germs and viruses creating a tendency to avoid things. On an average, it is seen that people who never worry have lower job performance than those who worry from time to time. While positive thinking can yield many benefits, the excessive and rigid search for positivity can bring about the opposite effect. Those who practice negative thinking are more able to

handle difficult situations. Both styles are deadly at the extreme while pessimism becomes fatalistic, optimism becomes toxic. The key is to find a sweet spot having more moderate ranges that can combine the benefits of both approaches.

The success in any field is not a matter of thinking positively or negatively, but it is the choice of strategies that match the thinking styles matters. Positive thinking without a negative balance hinders a person's abilities. Real leadership requires both positive and negative thinking. Negative thinking, if strategically pursued can play a definite role too. Negative visualization can be an excellent antidote to anxiety.

Positive employees are seen as team players but negative workers are viewed as outcasts, troublemakers. The consequence is that the realistic and rational people, usually the negative thinkers, remain unheard. But researchers discovered that negative people com-

municate better, think more clearly, make fewer mistakes, are less gullible and are better at decision-making. The reason is that negative people use the critical part of their brain more successfully than cheerful people. The overall conclusion from researchers is that there's a place for both positive and negative thinking in every workplace. However, what it all comes down to is that negative people pay more attention to their surroundings. They're not always negative solely for the sake of being negative. They're just more cognizant of what's happening around them and as a result their moods change depending on what they notice. Negative thinking isn't superior to positive thinking, but neither is positive thinking the panacea for all workplace ills. Sometimes what's required is a dose of reality. And, it's the negative thinkers, the

ones who are perceived as troublesome, annoying, often provide the cure.

Getting negative can be wonder-

fully empowering, because it drives a respect for the reality of the situation and limitations. Without negativity you can never even begin to plan strategy for engaging, confronting- problems, limitations. While positive thinking produces amazing dreams, visions, goals, negative thinking produces powerful plans and strategies. Positive thinking and confidence improves performance whereas, negative thinking feels realistic, protects us and lowers our expectations.

Since progress and development are the rules of the universe, just a healthy dose of both positive and negative thinking (that of Lord Shree Krishan's and Partha's respectively) are required for a successful organization / society / nation.

## Tragedy repeats: despite SC Guidelines, abandoned borewell accidents continue to claim lives

A fter over 14 years the Supreme Court framed guidelines to prevent accidents involving abandoned borewells, the frequent spate of such incidents highlight the gaps in enforcement and creating awareness of the top court's order.

The issue has come to the forefront again following the spate of such accidents leading to desperate and dramatic rescue operations. Most recently, a minor, Chetna, aged around three vears fell into a borewell in the Kotputli-Behror district of Rajasthan, and the NDRF and SDRF were deployed to rescue her from the 150feet-deep borewell with efforts still underway at the time of filing this report. The treatment would not only include first aid but also diagnosis, in-patient admission, continued outpatient assistance, diagnostic tests, lab tests, surgery,

physical and counselling, psychological help, family counselling among other things. The court clarified availing of

free medical treatment by such victims/survivors from either government or private hospitals was not dependent upon a referral by the state or district legal services authority as it was a statutory right under Section 357C of CrPC, Section 397 of BNSS and Rule 6 (4) of POCSO Rules, 2020. Notably, every medical facility was directed to put up a board at the entrance, reception, counters and all prominent places, in both English and vernacular, declaring the availability of free out-patient and inpatient medical treatment for such survivors

## Atal Bihari Vajpayee's vision blooms: BJP's rise to power marks fruition of 1980 prediction

Delivering one of his more famous speeches at the BJP's inaugural convention at Shivaji Park in Mumbai, Atal Bihari Vajpayee predicted on December 30, 1980 with his signature flourish: 'Andhera chhatega, suraj niklega, kamal khilega' (darkness will end, the sun will rise, lotus will bloom).

As his birth centenary arrives, his words have aged well, with the BJP returning to power for a third straight term at the centre and lotus in full bloom

If Prime Minister Narendra Modi made the BJP's cultural agenda the centre of national politics, Vajpayee helped the party occupy this centre when its cultural agenda was considered an anathema.

A statesman politician and a peerless orator, India's first non-Congress prime minister to have served a full term

The only time he openly denounced a polarising Hindutva cause was when the Babri mosque was demolished in 1992, but his stand was considered an act of political pragmatism necessary for the BJP to realise its political ambitions after fetching merely two seats in the 1984 polls.

With the moderate, poet-atheart and statesman-like Vajpayee as the BJP's prime ministerial face and the party agreeing to put a moratorium on its contentious ideological planks of the Rem temple construction, Article 370 repeal and the Uniform Civil Code, regional parties from across the country were drawn as he led them to poll wins. His passionate moves to improve ties with Pakistan resulted in his spectacular journey to Lahore in a bus in February 1999 and then hosting the Agra Summit with Pakistan's president Pervez Musharraf in 2001 but they met with little success. 

# **Adieu Shyam Benegal**

With passing of Shyam Benegal, Indian cinema has lost a luminary, but his films will continue to illuminate and educate


he curtains have fallen on one of the most illustrious chapters in Indian cinema. Shyam Benegal, the pioneering filmmaker who redefined storytelling in Indian cinema, passed away at the age of 90 on December 23, 2024. He succumbed to chronic kidney disease at Wockhardt Hospital in Bombay Central. Known as the father of Indian parallel cinema, Benegal's legacy remains etched in the heart of Indian filmmaking, his films celebrated for their realism, depth, and transformative impact on society. Born on December 14, 1934, Benegal celebrated his milestone 90th birthday just days ago, surrounded by close family and friends. Yet, even in his twilight years, the veteran filmmaker remained deeply connected to his art. Benegal's career was marked by his groundbreaking contribution to the Indian New Wave movement in the 1970s and 1980s. With films like 'Ankur' (1974), 'Nishant' (1975), 'Manthan' (1976), and 'Bhumika' (1977), he charted a new cinematic course that delved into realism and social



commentary, a stark contrast to the formulaic escapism of mainstream Bollywood.

His films gave voice to the marginalised and explored themes of gender, class struggles, and rural India, bringing to light the unseen facets of Indian society. 'Nishant', a harrowing tale of oppression and resistance, and 'Manthan', inspired by Dr. Verghese Kurien's milk cooperative movement, became cult classics. The latter, crowdfunded by 500,000 farmers, stands as a testament to Benegal's ability to connect with grassroots realities. The film, India's official entry for the 1976 Academy Awards, exemplified his commitment to blending art with advocacy. Benegal's films also

became a platform for some of India's finest acting talents. Actors like Shabana Azmi, Naseeruddin Shah, Smita Patil, and Om Puri found their early footing in his films. Azmi, who debuted in Benegal's 'Ankur', recently shared a poignant moment from his 90th birthday celebrations, underscoring the indelible bond they shared. His collaboration with screenwriter Vijay Tendulkar produced narratives that were both poignant and thoughtprovoking, winning multiple National Awards. From 'Junoon' to 'Netaji Subhas Chandra Bose: The Forgotten Hero', Benegal's oeuvre showcased an unmatched versatility, spanning historical dramas, rural sagas, and contemporary commentaries. Earlier this year, 'Manthan' was restored and screened at the Cannes Film Festival under the Cannes Classics segment, reiterating the timeless relevance of Benegal's vision. Despite his declining health, the event underscored his enduring influence on global cinema. Benegal's storytelling was never confined to entertainment. His films were instruments of change, questioning societal norms and sparking dialogues. His pioneering approach laid the foundation for generations of filmmakers who sought to marry art with social responsibility. Rest in peace, Shyam Benegal, the maestro who showed us the soul of India through his lens.

fter four years of civil war in Myanmar, India has quietly changed its policy towards the Junta from one of total and unfailing support following its coup against democracy to one of nuanced support. Junta leader General Min Aung Hlaing has been advocating holding elections for the last four years but only now with China's assistance, they are slated for 2025. China is playing with both sides: supporting the Junta as well as some EAOs (Ethnic Armed Organisations) especially in the north contiguous with its Yunan province. India too has shifted the goalposts but less perceptibly and engaging some EAOs and the National Unity Government (NUG) after the Junta lost its control in the Rakhine and Chin territories along India and Bangladesh borders.

Last week the Junta's control of the ground began crumbling further with the loss of Ann, Headquarters Western Military Command, the second military command to fall to resistance groups. Junta has lost two airports Thandwe (Rakhine) and Lashio and 75 towns and cities out of some 340 of them. It has also lost control of six border trading posts. 40 of 70 towns in Rakhine have been captured by the Arakan Army which is part of the Three Brotherhood Alliance, the other two being MNDAA and TNLA.

Two critical seaports on the west coast - India-operated Sittwe and Chinese-owned Kyaukphyu - are on AA's target list next year unless Beijing can dissuade it from attacking Kyaukphu though the loss of Ann has opened the gates to it. Magaung is the other target in Rakhine.

On the Thailand border, the Karen National Union took Manerplaw, the Junta losing possession after 30 years. A humanitarian corridor with Thailand has existed with the help of the Junta. In the North, TBA has been persuaded by China to go slow

In the central Sagaing region, Mandalay, the second largest city after Yangon, came under rocket attack last month and National Highway 3 from Mandalay to China border, was under resistance control. These are Bmar-predominant areas in Sagaing, Irrawaddy Delta, the new capital Naypidaw and Yangon. They are likely to lose more ground next year despite pressure from the Chinese on EAOs. Beijing is the key player in Myanmar's economy and is deeply invested in business and industry. Beijing is nursing the Junta and its leader,

Hlaing. He was invited to meet PM Li Qiang after attending the Greater Mekong Subregional Summit at Kunming last month. China is replenishing the Junta's military arsenal - so is Russia - including three fighter jets with assured ammunition supply. It wants to locate a private security company (like in Pakistan) for the protection of its strategic assets like China Myanmar Economic Corridor (CMEC) containing oil and gas pipelines along with a railway link from Kunming to Kyaukphyu.

## Across cultures and ages: The beauty of unexpected friendships



The unexpected joy of forging meaningful friendships in middle age defies the common belief that the best opportunities for connection are behind us

**7**our hat is fantastic. It makes you look more Bavarian than any of us, the concierge quipped as I entered the venue for the coffee-and-cake event at a resort in southern Germany. Although he was stretching the truth - I have neither blonde hair nor blue eyes -I accepted the compliment with a coy smile. "Danke schön," I said, tipping my woolen hat. Just then, another guest remarked, "That's a pretty pin on your hat," pointing to the delicate hand-crafted Edelweiss flower. A cherished gift from my friends, Wolfgang and Amelie, the pin symbolised a friendship that began just a year ago, in this very Bavarian town of Schliersee.

The Wolfgangs - a handsome, warm-hearted couple - are a testament to the unexpected joy of friendships made in middle age. Our bond didn't begin with shared childhoods or decades of history but with a simple "hello" and an open heart. The modest origins of our connection and the way it blossomed over the past year defy the notion that meaningful friendships are reserved



for youth. Our paths crossed serendipitously during an evening walk.

A casual exchange of pleasantries evolved into deeper conversations about life, culture, and shared interests. What began as polite conversation in an Alpine countryside ended with an exchange of coordinates and it continued with texting in the months after. It is widely held that the friends we make in our formative years are the ones who stay, while those forged later in life are fleeting, superficial, or driven by necessity. This belief may hold some truth; adulthood brings with it obligations, scepticism, and wariness. We become cautious in

innocence of youthful camaraderie gives way to guarded interactions, and we convince ourselves that the window for profound friendship has closed. Yet, the Wolfgangs remind me that this window is not sealed shut — it merely takes a little more effort to

Friendships formed in middle age are special not despite our life experiences, but because of them. We bring to these connections a deeper sense of self-awareness, empathy, and

appreciation. There's no rush to impress or to conform. The pressures of youthful identity-building are gone. In their place, we find sincerity, authenticity, and the willingness to value people for who they truly are. They remind us of the universality of human warmth and curiosity. Meeting someone from another country someone whose life, traditions, and language are differ-ent — can feel like discovering an entirely new world. And when such encounters lead to genuine friendship, they break down the invisible walls that geography and cul-

in the intentionality of these connections. In our younger years, friendships are often born of proximity — classmates, neighbours, or college roommates. As adults, friendships require deliberate effort. This intentionality infuses middle-aged friendships with a depth and resilience that can be even more rewarding than the bonds of our youth. I think back to the pin on my hat - that delicate Edelweiss - and I see it as a metaphor for these kinds of friend-

ships. The Edelweiss, a rare Alpine flower, thrives in challenging conditions.

It symbolises courage, devotion, and the willingness to climb new heights. Like the flower, friendships made in middle age might take more effort to cultivate, but they are hardy, resilient, and precious. A year after that first meeting, I found myself once again in Schliersee last month, sharing coffee and cake with the Wolfgangs, laughing over our language blunders and cultural quirks. It is never too late to make friends.

# No justification in US curbs 'We should try again': Punjab Assembly Speaker on Pak firms, says Shehbaz

rime Minister Shehbaz Sharif on Tuesday defended Pakistan's nuclear and missile programme, saying the recent US sanctions against the country's four entities have "no justification".

His remarks came days after the US slapped sanctions on four Pakistani firms, including the state-owned flagship aerospace and defence agency - National Development Complex (NDC) -– on charges of contributing to ballistic missile programme. In addition to the NDC, the three other entities are Akhtar and Sons Private Limited, Affiliates International and Rockside Enterprise. All three are based in Karachi, while the NDC is in Islamabad

"The sanctions placed upon our National Development Complex and other entities have no justification," Prime Minister Shehbaz said while addressing a federal cabinet meeting.

"Pakistan has absolutely no intention for our nuclear system to be aggressive. It is 100 per cent for Pakistan's defence. It's just deterrence; nothing else," he added. The prime minister also said that Pakistan's ballistic missile programme was for defending itself "if God forbid there

Shehbaz noted that the FO had given a "comprehensive response" and said that the missile programme belonged to the entire nation. "It's dearer to them (the public) than their hearts and

# Where does Santa live? It's a trickier question to answer than you may think

THHE CONVERSATION CUEENS-LAND

Sending a letter to Santa can be difficult as no one can agree on where exactly Santa lives. Several countries are competing to claim Santa as one of their citizens. Finland's tourism industry suggests Korvatunturi in Lapland is where Santa keeps his workshop, and the link between Santa and Lapland brings in hundreds of millions of tourist dollars

Danes say Santa is in Greenland. Sweden suggests Mora is the place, and has built the theme park Santaworld

These places certainly look the part with white snow in winter and reindeer. They're also close to the North Pole.

Not so jolly traditions: They also have old and often quite disturbing folklore about the man in red. Pagan Finns celebrated St Knut's Day in wintry January by having men in furry jackets, the nuuttipukki, go from house to house with a Except the sack of presents. nuuttipukki weren't giving gifts and would likely make children cry. and no one in 1866 had actually

They came demanding gifts and would curse bad luck to any household not handing over a present.

Eventually the gift grabbing nuut-tipukki became the gift giving Joulupukki. Like other northern traditions such as the Yule Lads of Iceland, this visitor gave gifts but

only to well behaved children. By the 19th century, Santa Claus was settled in popular awareness more or less what we think of now: a jolly old man with a beard, a sleigh, reindeer and presents, living some-where northern and cold. That image built on but sanitised the more grotesque European folklores of elves, gnomes and other supernatural creatures who either brought or demanded gifts.

But standardising Santa's appear-ance did not settle where he actually lived and worked.

In the mid-19th century the illustrator Thomas Nast portrayed Santa as a jolly old man in Harper's Weekly, and the illustration and the archetype took off. But Nast just showed Santa in a wintry land-

scape

turbed in his workshop. Santa and territorial disputes: The medieval and pagan mytholo-

gies in Finland and Scandinavia give some credibility to these countries' efforts to claim Santa as their

own. After all, these are old legends. Other countries take a more mod-ern approach. The Canadian government makes sure Christmas happens each year by allowing Santa to travel through Canadian airspace. Taking that a step further, in 2013 the Conservative government of Stephen Harper issued Santa and his wife with Canadian passports.

That action might seem twee or whimsical or simply some Christmas fun for children, but it may also have shown that some governments want to claim a lot more than Santa. Harper's gesture came at a time of an international political dispute about ownership of the North Pole and specifically Canadian claims to Artic regions. Somewhere hotter than the Pole: But are all these countries wrong, or being opportunistic?

Despite what we think, where Santa really comes from is a lot hotter and a lot further east - and those red robes would be uncomfortable to wear.

Santa Claus is a name derived from Sinterklaas or Saint Nicholas. Along with pagan elves and gnomes, another element in the long and very complex history of Santa is the Christian bishop St Nicholas of Smyrna. Or is that Nicholas of Myra?

Smyrna, now called Izmir in Turkiye, and Myra, now Demre in Turkiye, are both associated with Nicholas. Just as in northern Europe, different places in Anatolia compete to be associated with Santa.

Nicholas is patron saint of seemingly everything including archers and brewers but also children and sailors. The link with children explains the later association as Santa, especially as Saint Nicholas gave children gifts. The link with sailors is why his legend is known around the world.

A 2017 archaeological dig under the Church of Saint Nicholas in Turkiye was believed to have found the burial place and therefore the

body of Saint Nicholas. A grave full of old bones is not very Christmas-like, but it may be an authentic link between a place and a person which no amount of snow or reindeer in northern Europe could match.



# Bangladesh launches \$5 billion graft probe against Sheikh Hasina in nuclear power plant case

### PTI DHAKA

n anti-graft panel in ABangladesh has launched an investigation against former prime minister Sheikh Hasina and her family in connection with the allegations of embezzling USD 5 billion in the Rooppur nuclear power plant, according to a media report. Indian companies are participating in constructing the Rooppur nuclear power plant which is being built by Rosatom, Russia's state-run

corporation, in Bangladesh. The first Bangladeshi nuclear power plant, the Russiandesigned Rooppur, is being built 160 km west of the Bangladeshi capital of Dhaka.

Rosatom has refuted the "provocative statements" in the media about the Rooppur NPP project. Along with Hasina, her son, Sajeeb Wazed Joy, and Tulip Siddiq, her niece and the UK's Treasury minister, were also questioned, BDNews reported on Sunday.

There are accusations of embezzling USD 5 billion in the Rooppur Nuclear Power Plant project, the report added.

The development came two days after the High Court issued a rule asking why the Anti-Corruption Commission's (ACC) inaction over an alleged transfer of USD 5 billion from the Rooppur Nuclear Power Plant project to a Malaysian bank by Hasina, Joy, and Tulip should not be declared illegal, the report added. According to ACC documents,

## US NSA Sullivan, Yunus discuss human rights' issue PTI SAN FRANCISCO

A mid growing outrage here about the large-scale attack on minority Hindus and their places of worship in Bangladesh, US National Security Advisor Jake Sullivan on Monday spoke with the interim government's Chief Adviser Muhammad Yunus and both leaders expressed commitment to protect human rights in the troubled South Asian nation.

'Both leaders expressed their commitment to respecting and protecting the human rights of all people, regardless of religion," the White House said in a readout of the call between Sullivan and Yunus.

The call comes less than a month before the Biden administration passes on the power to Donald Trump, who would be sworn in as the 47th President of the United States on January 20 next vear

This comes days after Indian American Democratic Congressman Shri Thanedar urged the White House to strongly raise the issue of killing of Hindus and destruction of their temples in Bangladesh with the head of the country's interim government. The United States has a storied history of championing the oppressed and this issue should be no different. When we receive a global call for help, we must respond appropriately as the world's bellwether of human rights. We must urge Prime Minister Muhammad Yunus to fulfill his promise of restoring peace and rebuilding the nation on principles of equality and justice," Thanedar told reporters at the footsteps of the US Capitol last week.

# South Korea's opp party vows to impeach acting president

### AP SEOUL

South Korea's main opposi-tion party said Tuesday it will seek to impeach acting leader Han Duck-soo after he missed an opposition-set dead-line to approve independent investigations into impeached President Yoon Suk Yeol and his wife.

If realised, Han's impeachment would further deepen South Korea's political tumult and worries by neighbouring countries caused by Yoon's stunning December 3 martial law declaration and ensuing impeachment. Han, the country's No. 2 official, has taken over presidential powers and duties since Yoon's impeachment. If he's impeached too, the finance minister is next in line.

The main liberal opposition Democratic Party, which holds a majority in parliament, has slammed Han for vetoing sev-eral opposition-sponsored bills, including a controversial agriculture bill. It also urged Han to quickly appoint justices to vacant seats on the would go down in history as a Constitutional Court, which is disgraceful figure as a puppet

reviewing Yoon's impeachment and will determine whether to dismiss or reinstate him.

Filling the court's three empty posts could make conviction more likely, as it requires the support of six of the court's nine possible members.

The Democratic Party also demanded that Han approve by Tuesday bills calling for the appointments of special prosecutors to investigate Yoon for rebellion over his marital law decree, and his wife for corrup-

tion and other allegations. But Han didn't do so during Tuesday's Cabinet Council meeting, calling for the ruling and opposition parties to negotiate.

Democratic Party floor leader Park Chan-dae responded that there's no room for negotiations about a Yoon investigation, and that his party would begin steps toward an impeachment at once.

An impeachment vote would face legal ambiguities. Most Korean officials can be impeached with a simple majority of parliament, but impeaching the presidents takes two-thirds. The rival parties differ on which standard would apply to an acting pres-

The Democratic Party controls 170 of the National Assembly's 300 seats, so it would need support from members of other parties including Yoon's own to get a two-thirds majority.

The Constitutional Court has up to six months to determine Yoon's fate. If he's thrown of office, a national election to find his successor must take place within two months.



# **UPI transactions jump 33 per cent at** retail stores in India this year: Report

### PTI NEW DELHI

PI transactions at retail stores have increased by 33 per cent in semi-urban and rural areas this year, reflecting the growing adoption of digital payments, says a report.

Moreover, insurance policy purchases and premium collections saw a 127 per cent increase in transaction volume and a 96 per cent growth in new customer adoption during the year, the report by branchless banking and digital network PayNearby said.

"The data highlights the role digital retail stores play in overcoming the challenges of insurance penetration across Bharat," it stated.

The report is based on an analysis of real transaction data derived from over 10,00,000 small retailers (kirana stores, mobile recharge stores etc) offering financial and digital services spread across India in rural

and semi-urban regions. The findings compare business data from January to November 2024 with the same period in 2023. Retail-O-The report, Nomics, stated that there has been an impressive 297 per cent volume rise across credit

products, including business loans, gold loans, personal loans, and revolving credit in rural and semi-urban areas. This significant uptick reflects a growing awareness and demand for credit solutions at the grassroots level, it said

However, micro ATM and Aadhaar Enabled Payment (AePS) Systems cash withdrawals saw a decline in 2024. Both transaction volumes and the average cash withdrawal per transaction saw a slight decline, with the latter dropping from Rs 2,624

in 2023 to Rs 2 482 in 2024 the report said.

AePS withdrawals surged by 35-45 per cent during DBT releases, particularly under schemes like PM Kisan Yojana, compared to the rest of the year.

"Cash withdrawals in Jammu and Kashmir recorded an impressive growth of 58 per cent in value and 74 per cent in volume," the report said. By equipping local retailers with tools to offer diverse services like insurance, ecommerce, and lending, we are empowering them to become key enablers of financial access and economic progress at the grassroots," Anand Kumar Bajaj, Founder, MD & CEO, PayNearby, said. PayNearby is a branchless

In terms of domestic market share, IndiGo topped the list with a 63.6 per cent pie, followed by Air India (24.4 per cent), Akasa Air (4.7 per cent) and Mumbai - took a beating in November. ## ICC announces Champions Trophy schedule, India-Pakistan clash on Feb 23

### PTI DUBAI

India will play all their matches of the Champions Trophy in Dubai with the marquee clash against arch-rivals Pakistan scheduled on February 23, the International Cricket Council (ICC) announced on Tuesday.

PTI had reported last week that India will play all their matches in Dubai including the semifinal and final if they qualify.

As has been the case with ICC events, India and Pakistan have been clubbed in the same group which also has New Zealand and Bangladesh.

Group B comprises South Africa, Australia, Afghanistan and England.

The tournament opener will be played in Karachi on February 19 when hosts Pakistan face New Zealand and the final is scheduled for March 9. The premier 50-over event, last played in 2017, will have 15 matches with at least 10 games scheduled in Pakistan.

Rawalpindi, Lahore, and Karachi will be the three hosting venues in Pakistan with the second semifinal to be staged at the refurbished Gaddafi Stadium in Lahore. Lahore will also host the fin

"What Rishabh Pant has to do, like everybody else, respect the first half an hour; respect a

little bit when he gets in there, whatever the position, unless, of course, India is 525 for 3; then he can tee off," Gavaskar told Star Sports.

Commenting on commenting on the challenges posed by Australian bowlers, Gavaskar added, "... They get the ball to angle across. Pat Cummins and even

(Josh) Hazlewood give him a little bit of a problem; Scott Boland will give him a little bit of a problem because Boland bowls around that area as well."

Australian legend Matthew Hayden, a self-confessed admirer of Pant, urged the Indian batter to embrace his fearless approach, saying it could be a game-changer for the visitors.


