Over 100 students from **UP** stranded in jungle in dark

Over 100 students and school staff accompanying them were left stranded for hours in the evening in the dense Katarniaghat forests in Uttar Pradesh while returning from an educational tour, officials said on Sunday.

The children, aged 14-18, were forced to endure harsh cold during their stay under the open sky without food, water or appropriate clothing for the temperatures after school authorities defied warnings by locals to halt their journey at a safe place, they said.

There were 155 people in total, 130 of them children, they added. According to the district administration, the group from Gonda district had been on an educational tour organised by the New Standard Training Institute Dhanepur.

According to local social worker Jang Hindustani, the group first attempted to cross the Rupaidiha border to Nepal but was stopped because of border regulations. After being denied entry into Nepal, the managers redirected the buses towards the Katarniaghat Wildlife Sanctuary, known for its dense forests and dangerous wildlife, including leopards,

tigers, and elephants.
The buses traversed five forest checkpoints before reaching Amba village, deep inside the sanctuary

The Republic Day parade, which is held every year on January 26, is a showcase of India's cultural diversity and military might. The parade tableaux features from various states and union territories, which depict their unique culture, history, and achievements.

This year, 15 states and union territories will participate in the parade, including Bihar, Chandigarh, Dadra and Nagar Haveli, Goa, Iharkhand, Karnataka, Madhya Pradesh, Andhra Pradesh, Gujarat, Haryana, Uttar Pradesh, and West Bengal.

Opener G Trisha made a doughty fifty before the left-arm troika of Ayushi Shukla, Sonam Yadav and Parunika Sisodia spun web around Bangladesh batters as India scored a 41-run win to emerge champions in the inaugural Women's T20 U19 Asia Cup here on Sunday.

Back home in Vadodara in Guiarat, stylish opener Smriti Mandhana extended her purple patch with a classy 91 off 102 balls, propelling India to 314/9 in the first Women's ODI against the West Indies, here Sunday.

On a spongy pitch, Trisha's 52 off 47 balls (5x4, 2x6) guided India to 117 for seven, but Indian spinners cut through the Bangladesh line-up to bundle them out for 76 in 18.3 overs. The biggest partnership in Indian innings, in fact in the match itself, was between Trisha and her skipper Nikki Prasad - a 41-run alliance for the fourth wicket.

India batters struggled against pacer Farjana Easmin, who took four wickets. Despite that, India were restricted to a belowpar total, and Bangladesh seemed well on track for a win once they reached 44 for two in the seventh over. However, Ayushi (3/17), Sonam (2/13) and Parunika (2/12) took over from that point as Bangladesh lost remaining eight wickets for a mere 32 runs.

Brief scores were shared as India's 117/7 in 20 overs (G Trisha 52; Farjana Easmin 4/32) while Bangladesh's 76 all out in 18.3 overs (Juairiya Continued on page 2 | Ferdous 22; Ayushi Shukla 3/17, Sonam Yadav 2/13, Parunika Sisodia 2/12).

Mandhana, who recorded a 50-plus score for the fifth time in as many innings, got the bulk of the runs in her 110-run stand alongside debutant Pratika Rawal (40 off 69).

The launch pad was provided by Mandhana for the middleorder to go big and that is what the likes of Harmanpreet Kaur (34 off 23), Harleen Deol (44 off 50), Richa Ghosh (26 off 12) and Jemimah Rodrigues (31 off 19) did to take India past

300. After dropping hard-hitting Shafali Verma, India have tried multiple batters to open alongside Mandhana and on Sunday it was the turn of Delhi cricketer Pratika, who batted at a strike rate of 57.97. The 24-year-old was also dropped at mid-off when she was batting on three in the 10th over. Her four boundaries came on the leg-side as she employed the sweep multiple times.

Mandhana, at the other end, entertained the crowd with trademark including a cover drive and pull. India changed gears after the arrival of fit-again skipper Harmanpreet who struck at close to 150 to give the innings a timely move on. The momentum was carried by Richa and Rodrigues who has been in top form of late. For the West Indies, the pick of the bowlers was left-arm spinner Zaida James who took five wickets for 45 runs in eight overs. India could have got a lot more in the death overs but the last three overs only yielded 20 runs with James picking three

wickets in the final over.

CPI(M) slams rule change blocking access to election footage

The CPI(M) on Sunday demanded the immediate withdrawal of an election rule amendment preventing public inspection of certain electronic documents such as CCTV camera and webcasting footage. In a statement, the CPI(M) Politburo expressed its strong objection

amendment, restricting the access of political parties and candidates to electronic records, including video and other digital trails.

The Government tweaked the election rule to prevent public inspection of certain electronic documents such as CCTV camera and webcasting footage as well as video recordings of candidates to check their misuse.

Based on the recommendation of the Election Commission (EC), the Union law ministry on Friday amended Rule 93(2)(a) of the Conduct of Election Rules, 1961, to restrict the type of "papers" or documents open to public inspection.
The CPI(M) said these steps

were initially introduced by the EC in consultation with political parties to ensure greater transparency, and described as "retrograde" the move to amend the rule. Proper consultations were not carried out with political par-

ties on the issue, it alleged. "Media reports suggest that the government held consul-tations with the Election Commission of India while drafting the new rules. However, the Election Commission's reported concurrence was preceded by any consultation with political parties,

contrary to the established precedents over the years," the CPI(M) said.

"The government's argument,

which questions the locus standi of the petitioner on the conduct of the electoral process, is specious. This approach completely excludes political parties' involvement in the procedures to be followed," the Left party said. The CPI(M) said its experi-

ence, particularly during the Lok Sabha elections in Tripura, showed that charges of rigging led to the examination of videographic records within polling booths, ultimately resulting in repolls being announced in almost half the polling booths across both constituencies.

"In this era, where technology is an integral part of the electoral process, the government's move represents a retrograde step," it said.

fter Lieutenant Governor AVinai Kumar Saxena shared a clip of his visit to Rangpuri Pahari, detailing hellish living conditions, where dirty water could be seen filled on streets, drains overflowing, while roads were submerged in the sewage water and residents complaining of huge power bills, Chief Minister Atishi Atishi with senior officials on Sunday visited the area to take stock of the area's civic amenities and pledged swift road restoration and clean-up within a week.

Earlier, taking to X, Saxena shared a video of his visit Rangpuri Pahari in south Delhi and Kapashera in southwest Delhi and said the residents complained about the frequent power cuts and stinking water logged in the alleys and streets. "The stinking water accumulated in the alleys and streets is not rainwater, but from overflowing sewers. The women narrating their problems are from Delhi, not any other state," Saxena said

The Lieutenant Governor had visited the Rangpuri Pahari in MP Ramvir Singh Bidhuri on Saturday after repeated requests from the locals.

After a visit to the Rangpuri Pahadi area, Atishi stated, "I am thankful to LG Sir for attracting our attention to this. If the LG identifies any prob-lem or issue in Delhi, he should inform us, and we will ensure it is resolved. During his visit to New Rohtak Road, the LG pointed out that the road was in a completely broken state." Responding to the concerns, AAP supremo and former chief minister Arvind Kejriwal thanked Saxena for flagging the shortcomings, saying the Delhi government would take steps for improvements. "Earlier, the lieutenant governor had cited the bad condition of the Nangloi-Mundka Road. The road has been constructed and Chief Minister Atishi will soon inaugurate it. Police identify 175 illegal Bangladeshi immigrants in verification drive

Amid politics heating up on the issue of illegal immigrants residing in the national Capital, the Delhi Police on Sunday claimed to have identified 175 people during their verification drive against illegal Bangladeshi immigrants residing in outer

Recently, the Delhi Lieutenant Governor (LG) Secretariat directed the chief secretary and police chief to launch a two-month special drive to identify and take strict action against illegal Bangladeshi immigrants residing in the city. While the BJP alleged the ruling party of using Bangladeshi and Rohingya illegal immigrants as a vote bank, the AAP hit back by accusing the Centre of providing these immigrants with houses and facilities in the Capital.

"The 12-hour verification drive began at 6 pm on Saturday in outer Delhi area," senior police officials said, adding that the police have intensified their efforts to identify and detain individuals residing without valid documentation.

ations, 175 individuals have been identified as suspected illegal Bangladeshi immigrants during extensive verification drives in outer Delhi," a senior police officer said. The city police launched a



illegal Bangladeshi immigrants residing in Delhi on December 11, a day after the LG Secretariat ordered a crackdown on such persons. "Concerned about the growing number of undocumented immigrants, the Outer District Police has launched a series of targeted operations the police officer said.

He further added that special teams, including personnel from local police stations, district foreigner cells, and specialised units, have been deployed to conduct door-todoor checks and gather intelligence on suspected illegal immigrants.

Police said that the operations involved thorough scrutiny of documents and detailed interrogations of the identified individuals. "Verification efforts extended beyond the district, with teams dispatched to the native places of and joint checks in various these individuals in coorditheir respective areas to authenticate their identities," he added.

The accused were identified as 48 year old Raju Vaishnav, 32 year old Jagrat Saihni, 44 year old Parves Kumar, all residents of Delhi, along with 36 years old Yogesh Taneja, 34 years old Tarun Khanna, 38 year old Harvinder Deol from Agra in Uttar Pradesh and 34 year old Manish Jain, 32 years old Kushal and 43 years old Gautam Das, all natives of Rajasthan, a senior police officer added.

The police also recovered 10 mobile phones from their possession. Deputy Commissioner of Police (Ćrime) Sanjay Kumar Sain said they received information about the syndicate led by Raju and his associates operating from Joshi Road in Karol Bagh. "Based on a tip-off, a raid was conducted around 11.30 am on Saturday at a flat on Joshi

Road," he said. The flat had three bedrooms and 10 people, including Raju, and they were found placing bets on laptops and mobile phones during a live match, he added.

Preliminary investigation revealed that the group was betting on the seventh T20 match of the Big Bash League 2024-25 between Hobart Hurricanes and Perth Scorchers, which started at 10.30 am, police said.

During interrogation they revealed that the syndicate operated both online and offline. For online betting, Jagrat had purchased a master ID from a betting website, the officer said, adding that for each transaction, master ID and this racket user are sharing 5 per cent and 95 per cent profit and loss.

The DCP said that the group accepted offline bets by recording them on notepads. "Raju is the mastermind behind the group who convinced other bookies from three different states to join hands to increase profit and reduce losses," he said, adding that he has studied up to eighth standard and is working as a goldsmith.

To earn easy money, he came into this illegal trade and brought all other associates under one platform. He was taking 20 per cent share and the rest of the share divided into all as per their performance and business," the officer said, adding that the flat was rented by Raju in his name for Rs 45,000 per

19-year-old mother hangs self in Malviya Nagar



A 19 year old mother alleged-ly died by committing sui-cide in south Delhi's Malviya Nagar. According to the police, a suicide note has been recovered in which she wrote that no one is responsible and that she has committed suicide of her own accord.

He said that her husband, namely Sandeep, was also present at the hospital and was questioned. "He stated that his wife, aged 38 years, was unable to conceive a child, so on the advice of some relatives, he married the deceased, a native of district West Champaran in Bihar, in September 2023, with the consent of his first wife," the DCP added.

He said that the deceased gave birth to a baby girl who is now five months old. "Today, at around 1:30 PM, while the husband went to pick up his brother's son from school, the deceased allegedly committed suicide by hanging herself in her room. "Institute used terms such as Shubhra Ranjan IAS" and 'Students of Shubhra Ranjan IAS" in its advertisements and letterheads, creating a deceptive impression that Mrs. Shubhra Ranjan is/was an IAS officer. This constitutes a misrepresentation and unfair trade practice under Consumer Protection Act 2019, thereby misleading the public and potential students into believing that the services or guidance provided by them are directly associated with the credibility of an IAS officer. The Institute submitted that it was a clerical mistake, which is not tenable as the term Shubhra Ranjan IAS or @shubhraranjanias has been frequently used on its letterheads and in its advertise-

ments. Institute utilized deceptive practices to create a perception of exceptional quality and success. An advertisement should be truthful & honest representation of facts by making disclosures in such a manner that they are clear, prominent and extremely hard to miss for viewers to notice," the CCPA said.

The consumer regulator said the advertisements violated provisions of the Consumer Protection Act of 2019 related to misleading advertisements by "deliberately concealing important information"

The lack of proper disclosure about successful students' course details deprived consumers of making an informed choice while selecting coaching institutes, the CCPA said, asking Shubhra Ranjan IAS Study to discontinue the misleading ads. On November 22, CCPA

on Vajirao & Reddy Institute for misleading advertisements regarding the results of the UPSC CSE 2022. Vajirao & Reddy Institute in its advertisement claimed "617 selections out of 933 in UPSC CSE 2022" and "We are ranked at 1st position among the list of top UPSC Coaching Institutes in India". CCPA has so far issued 45 notices to various coaching institutes for misleading ads and imposed a penalty of Rs 63.60 lakh on 20 coaching institutes, directing them to discontinue the misleading advertisements.

The Department Consumer Affairs, through the National Consumer Helpline, has successfully intervened at a pre-litigation stage to ensure justice for students and aspirants who enrolled for the UPSC Civil Services, IIT and other entrance examinations.

Dhankhar calls for accountability of lawmakers

Against the backdrop of Parliament witnessing poor productivity due to disruptions, Vice-President Jagdeep Dhankhar on Sunday called for accountability of lawmakers and said people would force them to think why they were sent to Parliament. The death toll in the Mohali building collapse climbed to two with the body of a 29-yearold man recovered from under the rubble on Sunday, even as a preliminary probe suggested that digging in an adjacent plot led to the incident.

The multi-storey building collapsed on Saturday evening in Sohana village of Punjab's Mohali district, with at least five people trapped under its Rescue continued overnight to find possible survivors

Sub-Divisional Magistrate, Mohali, Damandeep Kaur said one male body was recovered during the ongoing rescue operation. He was Abhishek identified Dhanwal from Ambala.

Home Minister Amit Shah slams left parties for turning Tripura into backward state, credits BJP for bringing development

Home Minister Amit Shah on Sunday hit out at Left parties for turning Tripura into a "backward" state during their 35-year rule and said it could witness progress only after the BJP assumed power in 2018.

Addressing a public meeting after visiting a village where displaced Bru tribals were rehabilitated, Shah said that Tripura remained behind on all parameters of development during the communist rule but is now moving forward on the path of progress.

For 35 years, the communists ruled Tripura. communists claimed that they worked for the welfare of the poor. The Congress also ruled Tripura for a considerable time. But the people of the state always remained poor. It was when the BJP came to power that Tripura could witness development," he said.

Shah said when he visited Tripura in 2017 as BJP president and stayed for five days, only 11 people took party membership. "Gradually we started our work. We worked hard and could oust the communists from power" after



toiling for years, he said. The home minister said during the Left rule, just 2.5 per cent of the people used to get piped drinking water and now 85 per cent get potable water. Under the communist rule, there was no free foodgrains for the poor but now each person gets 5 kg rice and everyone is getting free treatment of up to Rs 5 lakh, he said.

Shah said investments have come to Tripura and people are getting free power and LPG connections. Now the school drop rate is less than 3 per cent while enrolment is 99 per cent, But during the Left rule it was very poor, he said.

Tripura is now peaceful following the signing of peace accords with insurgents. With the blessings of Maa Tripurasunderi, Tripura will be one of the most developed states in the country.

Today, I am getting immense happiness," he said. Referring

to the settlement of Bru refugees, the home minister said the BJP governments at the Centre and the state decided to rehabilitate 40,000 displaced people. "The Brus were living in sub-human conditions. But the Left government never took any action to improve their condition. Now we are addressing it and already 11 villages have been set up while one more is in the works," he

Shah said the Brus are now getting all the freedoms enjoyed by any other Indian citizen. They now have an Aadhar card, they are enrolled in the voter list, they have ration cards and all these were ensured by the government, he said.

He said the rehabilitated people were given Rs 1.5 lakh for the construction of their houses, Rs 4 lakh as fixed deposits and Rs 5000 for 24 months as monthly expresses. Bru migrants from three districts of Mizoram - Mamit, Lunglei and Kolasib districts came to North Tripura district in 1997, 1998 and 2009 due to serious ethnic violence in Mizoram between Bru and Mizo communities.

Assam's forest cover shrinks by 83 square kilometre: **ISFR** report 2023

ssam's forest cover has Adecreased by over 83 sq km between 2021 and 2023, with the total area under forest and tree cover in the state now at 30,415.01 sq km, according to the India State of Forest Report (ISFR) 2023.

Minister Environment, Forest and Climate Change, Bhupendra Yadav, had launched the report at the Forest Research Institute in Dehradun on Saturday, with a nationwide increase of 1,445 sq km in total forest and tree cover recorded since 2021.

The total forest area in this north eastern state is 28,313.55 sq km, which is 36.10 per cent of the state's total area, while area under tree cover is 10,718.28 sq km, bringing the total forest and km. The ISFR reported a decrease of forest and tree cover area by 83.92 sq km in

the state. Altogether 4.07 per cent area of the state's forest cover is under very dense forest (VDF), 12.45 per cent under moderately dense forest (MDF) and 19.58 per cent under open forest (OF), as per the report. Assam is among the five states which have shown maximum decrease of forest cover inside the recorded forest area (RFA)/ green wash (GW) category. Tripura has recorded the maximum decreased (116.90 sq km), followed by Telangana (105.87 sq km), Assam (86.66 sq km), Andhra Pradesh (83.47 sq km) and Gujarat (61.22 sq km).

As per the report, between 2021 and 2023 MDF inside RFA/GW for Assam has decreased by 134.32 per cent and scrub by 18.41 per cent. However, VDF has gone up by 43.63 per cent, OF by 4.03 per cent and non-forest (NF) area by 105.07 per cent.

BJP secures third consecutive term in Arunachal Pradesh, wins 46 Assembly seats **PTI** ■ ITANAGAR

Arunachal Pradesh's political landscape underwent a major shift in 2024 as the BJP secured a third consecutive term, winning 46 out of 60 assembly seats in the simultaneous Lok Sabha and state elections. In addition to political developments, the state faced a dark chapter with disturbing revelations of widespread sex trafficking involving

The victory included 10 uncontested wins, attributed to the party's focus on development under Prime Minister Narendra Modi's leadership. Among its allies, the NPP retained five

three, and the People's Party of Arunachal (PPA) claimed two. Three independents were also elected.

The Congress suffered a devastating blow, winning just one of the 19 seats it contested. While Chief Minister Pema

Khandu credited the BJP's

success to development initiatives under the NDA government, gress state president Nabam Tuki acknowledged the defeat, saying the party will continue to fight for the rights of the people. In the Lok Sabha elections, the BJP secured

both parliamentary seats. Besides politics, the state faced a dark chapter in 2024 with assembly seats, the NCP won revelations of widespread sex

trafficking involving minors. A major case surfaced in August when survivors bravely came forward to expose the exploitation. Police arrested nine people who allegedly operated the racket

for years. The Arunachal Pradesh State Commission for Protection of Child Rights (APSCPCR) intervened, recommending stringent action, including dismissing three government employees, among them a police officer, for their involvement. Key suspects, Chaya Dulom, a

health department worker, and her husband David Dulom, a water resources department surveyor, were accused of coercing young girls into the sex trade.

In the same month, an interstate trafficking ring was busted at Ziro in Lower Subansiri district, rescuing four victims, including two minors.

In May, police uncovered another trafficking network involving five minor girls from Dhemaji, Assam. This led to the arrest of 22 people, including traffickers and pimps. Protests against the proposed 12,500 MW Siang Upper Multipurpose Project (SUMP) gained momentum throughout 2024, indigenous communities in Siang and Upper Siang districts environmental and cultural

On October 5, hundreds of residents gathered in Geku village to oppose NHPC's ongoing surveys. NHPC identified three potential sites for the dam, sparking fears of displacement and loss of agricultural land.

Meanwhile, the authorities of the Similipal Tiger Reserve (STR) on Sunday said that it was not averse to putting the tigress under sedation in order to bring her back to the core area of the National Park. STR field director Prakash Chand Gogineni said "Tigress (Zeenat) is moving in West Bengal. The Odisha and West Bengal forest departments are tracking and moving with it. It is fit and fine. Efforts are being made to bring it back by tranquilisation," Gogineni

Claiming that tigress Zeenat, which walked into Jharkhand on the northern side of the Similipal, later moved into West Bengal forests on Friday. He said forest department personnel of both the states signals from her radio collar and efforts are underway to guide her back into Similipal. However, if the animal does not return to her habitation in the core area of the Similipal, the authorities may apply tranquilization alternative mode to bring her back, he said, adding that the three-year-old tigress Zeenat and two-and-half-year-old Jamuna were brought from Tadoba-Andhari Tiger Reserve (TATR) in Maharashtra with the goal of introducing a new gene pool

Centre has informed the National Green Tribunal (NGT) that West Bengal and Bihar are impacted the most by arsenic contamination of groundwater. The tribunal is hearing the issue of rice being susceptible to arsenic contamination because it absorbs more of the toxic semi-metallic element from water and soil Earlier, it sought a reply from the Centre on it.

In an order dated December 16, a bench of NGT Chairperson Justice Prakash Shrivastava and expert member A Senthil Vel noted Shrivastava that the Union Ministry of Agriculture and Farmers Welfare had filed its reply after seeking inputs from the İndian

into the food chain," the Centre said in its reply. There can be a "significant build-up" of the toxic element in rice as it is a water-intensive crop, the reply stated. "Transport of arsenic-contaminated rice grain grown in arsenicroute for arsenic entry into endemic areas to nonagricultural soil which endemic sites and consequent ultimately leads to its entry dietary intakes will also spread

according to the reply, the distribution of arsenic content in plant parts generally followed the order of roots, stems and leaves. "The edible parts of leafy (spinach, fenugreek etc.) underground vegetables (beet, radish etc.) contained much higher arsenic as compared to vegetables with fruit as edible part (brinjal, beans, ladies' finger, tomato etc.). In general, fruit/grain of plants showed less accumulation of arsenic compared to root, stem and leaf," it noted. The reply also suggested various remedial measures to minimise the effect of arsenic in the soilplant system. These include replacing water-intensive rice

varieties with other less waterintensive crops and relatively The tribunal noted that, arsenic-tolerant rice varieties, growing non-edible and leguminous crops during the dry season in the hotspot areas, application of biochar (modified charcoal produced from burning biomass sources), and increased use of green manures and application of silicate fertilizers. The reply also suggested other remedial measures, such as storing arsenic-contaminated groundwater in ponds and subsequent dilution with rainwater along conjunctive use of ground and surface water to dilute the arsenic content. The tribunal then impleaded the ICAR as a respondent and sought its response. It will hear the matter next on April 15.

Guardians of nature: Saving the planet



As the world grapples with the escalating impacts of climate change, the wisdom of indigenous communities shines as a vital resource for environmental preservation

he Role of Indigenous Knowledge Combating Climate Change: A Legacy of Hope The discourse on climate change dominated discussions at COP 2024, the United Nations Climate Change Conference, held in Baku, Azerbaijan, from November 11 to 22, 2024. Rising global temperatures, depleting natural resources, and rampant environmental degradation have emphasised the urgency of adopting sustainable practices and advancing conservation efforts. Amid this pressing crisis, the role of indigenous communities in preserving the environment emerges as a beacon Often referred to as the "guardians

With an unwavering commitment to nature, she planted 30,000 saplings during her lifetime, nurturing them with meticulous

Tulsi Gowda passed away on December 16, 2024, at the age of 86, leaving behind an inspiring legacy of environmental stewardship. Growing up in poverty, Tulsi Gowda's love for plants and forests remained unparalleled. From an early age, she worked in plant nurseries, demonstrating extraordinary skill in nurturing saplings. Her unique ability to identify the 'mother tree" of any species exemplified her deep ecological understanding.

Tulsi Gowda herself believed, "It's not important how many plants you have planted; what matters is now much care you ve taken of those saplings." The contribution of indigenous communities to environmental conservation extends far beyond

India. Globally, these communities represent less than 5 per cent of the world's population but protect 80 per cent of the planet's biodiversity, according to the United Nations. Their traditional ecological knowledge, passed down through generations, serves as a crucial tool for sustainable resource management.

For instance, the Kayapo tribe in Brazil has successfully defended the Amazon rainforest from logging, mining, and industrial agriculture, preserving a vital carbon sink. Brazilian environmentalist and politician Dr. Marina Silva emphasised, "The Kayapo teach us that protecting forests is not just about climate, but about life itself."

Similarly, the Sámi people of Scandinavia maintain ecological balance in Arctic regions through sustainable reindeer herding practices. In New Zealand, the Maori concept of kaitiakitanga (guardianship) promotes a cultural commitment to environmental stewardship, influencing national policies.

The Ogiek of Kenya, through sustainable honey harvesting, continue to conserve the Mau Forest, a critical water catchment area. This echoes Wangari Maathai's belief tha "The future of our forests lies in the hands of those who understand them best indigenous communities."

Their sacrifice during the 1730 Khejarli Massacre, where 363 Bishnois gave their lives to protect sacred Khejri trees, remains a cornerstone of ecological movements. Similarly, the Dongria Kondh tribe of Odisha has valiantly defended the Niyamgiri Hills from destructive mining activities, preserving their sacred land and biodiversity.

The Apatani tribe of Arunachal Pradesh showcases innovative sustainability through wet-rice cultivation and fish farming, while the Soliga tribe of Karnataka safeguards the Biligiriranga Hills using indigenous forest management techniques. Such efforts have inspired broader environmental movements. The Chipko Movement of the 1970s, where villagers in Uttarakhand hugged trees to prevent deforestation, drew inspiration from the Bishnoi's sacrifice. In 2021, a similar initiative saved over 500 sacred oak trees in Jaakhni village, Uttarakhand, near forests dedicated to the local Goddess of

From the hills of Uttarakhand to the sacred groves of Meghalaya, these movements highlight India's enduring envi-

ronmental heritage. Despite their invaluable contributions, indigenous communities face significant challenges, including marginalisation, land dispossession, and exploitation. Empowering indigenous communities to take leadership roles in environmental management has already shown promising results. For example, joint forest management initiatives have demonstrated effective resource management and biodiversity conservation. Combining indigenous knowledge with modern scientific approaches can create innovative strategies for addressing environmental challenges. Practices like the Zuni tribe's waffle gardens in New Mexico, which conserve water in arid regions, exempli-

nous ecological wisdom. In an era of environmental crises, humanity must embrace the profound knowledge of indigenous communities to forge a sustainable future. Their traditions, deeply rooted in respect for nature, hold the key to restoring ecological balance. Slowdown in growth: Is it a temporary blip?



This temporary slowdown, attributed to reduced government spending, raises broader concerns about the structural challenges underpinning India's growth story



he GDP (gross domestic product) growth during the second quarter of the current financial year (FY) ending September 30, 2024, decelerated to 5.4 per cent down from 8.1 per cent achieved during the corresponding period of FY 2023-24. It was the lowest in seven quarters and well below the Reserve Bank of India's (RBI) forecast of 7 per cent. It was even lower than the 6.7 per cent recorded during the first quarter of the current FY ending June 30, 2024.

Union Finance Minister Nirmala Sitharaman observed that deceleration was not a "systemic slowdown"; that it was a temporary blip caused by a reduction in government expenditure (courtesy, elections ended in the June quarter when many projects came to a standstill due to the model code of conduct). She exuded confidence that expansion during the third quarter would make up for the lost momentum. The Ministry of Finance (MoF) expects full-year GDP growth to be 6.5 – 7 per cent. Coming on top of growth of 8 per cent plus achieved during the previous three consecutive years, 6.5 – 7 per cent during the current FY is indeed pressive. Even at this lower level, the Indian economy continues to be the fastest-growing in the world. Then, why should it worry us? Nearly 70 per cent of India's GDP is dri-

ven by domestic consumption; the remaining 30 per cent is driven by investment and export. Domestic consumption includes government consumption and private consumption. Likewise, investment consists of capital spent by the government and private investment. During the last five years, the Central Government has done the heavy lifting especially when it comes to investment. An idea of this can be gauged from its budget outlay 2020-21: Rs 30.42 lakh crore; 2021-22: Ŕs 34.83 lakh crore; 2022-23: Rs 39.45 lakh crore; 2023-24: Rs 45.03 lakh crore; 2024-25: Rs 48.20

The Centre's capital spend during these years was 2020-21: Rs 4.39 lakh crore; 2021-. 22: Rs 5.54 lakh crore; 2022-23: Rs 7.50 lakh crore; 2023-24: Rs 10.01 lakh crore; 2024-25: Rs 11.11 lakh crore. The Central government has also been helping the states

to boost their capital spend. During 2022-23, it provided them with 50-year Rs 100,000 crore interest-free loans.

During 2023-24, such transfers were Rs 130,000 crore. For the current FY, the transfers are kept at Rs 150,000 crore. It has also given incentives to promote investment in the private sector. The mother of all incentives was a reduction in the corporate tax rate to 15 per cent for new manufacturing enterprises and 22 per cent for existing enterprises. In this year's budget, the corporate tax rate on foreign firms was reduced from 40 per cent to 35 per cent. The Centre has also done its bit to

give a boost to private consumption. In the budget for 2024-25, Sitharaman has given relief in personal income tax (PIT) of around Rs 17,500/- annually by changing the tax slabs under the New Income Tax regime and increasing in standard deduction by Rs 25,000/-. Less tax means higher disposable income in the hands of the people hence the scope for more spending. But, initiatives by the government alone can't ensure high growth on a sustainable basis. To achieve high sustainable growth, it is necessary to give a boost to private consumption. The dip to 5.4 per cent during the second quarter of the current FY when the decline in urban demand took a toll even as heavy lifting by the Centre was not available (due to elections) should serve as a warning signal. This brings us to a systemic problem that has hampered growth for decades.

This has to do with inequalities in the distribution of income and wealth. According to an Oxfam report, 'Inequality Kills', the collective wealth of India's 100 richest people in 2021 hit a record high of US\$ 775 billion or over 25 per cent

Conclave, Arvind Panagariya, Chairman, of the 16th Finance Commission said: "The inequality in the sense of the top 1 per cent as a proportion of the bottom 5 percent, yes, that inequality has gone up". Thomas Piketty, a professor at the Paris School of Economics (he is known for his groundbreaking research on economic inequality, wealth distribution, and the dynamics of capitalism) says "the share of India's top 10 percent population is currently at 55-60 per cent". According to him, this should be 30-40 per cent. Whichever source one looks at, we can't wish away the fact that India

This, in turn, has to do with the manner in which fruits of development are shared amongst the people. Unambiguously, the sharing is unequal. According to an analysis of the financials of India's largest companies – those comprising the BSE 500 index - over five years, the profits of corporations included in this index more than doubled from Rs 480,000 crore during 2017-18 Rs 1000,000 crore during 2021-22, whereas their revenue growth was only 47 per cent.

This means that payments to factors of production other than the owners of capital such as to employees/workers, etc., have been kept under a tight leash, resulting in a disproportionate boost to profits. A big slice of these profits has gone to the pockets of the shareholders of these firms.

Thus, the aggregate dividend paid by them increased from Rs 176,000 crore during 2017-18 to Rs 302,000 crore during 2021-22, which is an increase of 72 per cent. In those five years, cumulatively, they paid 34 per cent of aggregate net profit as dividends. This is an unusuof India's GDP. world's largest companies in America's S&P 500. Whether profits to the firms or high dividends to shareholders, it has been paid for or come at the cost of millions of others. Rs 1,000,000 crore profits of firms in the BSE 500 index during FY 2021-22 came at the cost of undermining the purchasing power of millions of consumers.

Likewise, the mammoth dividend fills the coffers of a few - the money that merely adds to their idle cash balances or is spent on a few luxury items - denying millions of workers decent income. The tendency to appropriate a disproportionate share of the proceeds of wealth generation by a few persons at the top can be seen even amongst the owners of small and medium enterprises (SMEs) who ape large enterprises when it comes to making payments to their workers.

The SMEs being employment intensive, a general belief is that giving a boost to them would help in creating more jobs hence, lead to a more equitable income distribution. But, their owners' paying less to workers militates against this objective.

Even the millions of small and marginal farmers who by nature of their occupation play the role of owner as well as worker don't get to earn a good income as a handful of traders buy their crops at throwaway prices even as the minimum support price (MSP) notified by the government remains mostly on paper. When, the enterprise-owning class no matter which occupation it is in and the scale of its operation is intrinsically prone to sharing less with those who are at the receiving end, inequalities are inevitable. In such a scenario, how can we expect a big push to the demand needed for sustained growth?

2 US Navy pilots shot down over Red Sea in apparent 'friendly fire' incident

¬wo US Navy pilots were shot down Sunday over the Red Sea in an apparent "friendly fire" incident, the US military said, marking the most serious incident to threaten troops in over a year of America targeting Yemen's Houthi rebels.

Both pilots were recovered alive after ejecting from their stricken aircraft, with one suffering minor injuries. But the shootdown underlines just how dangerous the Red Sea corridor has become over the ongoing attacks on shipping by the Iranian-backed Houthis despite US and European military coalitions patrolling the

The US military had conducted airstrikes targeting Yemen's Houthi rebels at the time, though the US military's Central Command did not elaborate on what their mission was and did not immediately respond to questions from The Associated Press. The F/A-18 shot down had just flown off the deck of the USS Harry S. Truman aircraft carrier, Central Command said. On December 15, Central

Command acknowledged the Truman had entered the Mideast, but hadn't specified that the carrier and its battle

group was in the Red Sea. "The guided missile cruiser USS Gettysburg, which is part of the USS Harry S. Truman Carrier Strike Group, mistakenly fired on and hit the F/A-18," Central Command said in a statement.

From the military's description, the aircraft shot down was a two-seat F/A-18 Super Hornet fighter jet assigned to the "Red Rippers" of Strike Fighter Squadron 11 out of Naval Air Station Oceana, Virginia.

It wasn't immediately clear how the Gettysburg could mistake an F/A-18 for an enemy aircraft or missile, particularly as ships in a battle group remain linked by both radar and radio communication. However, Central Command said that warships and aircraft earlier shot down multiple

Thirty-eight people are confirmed dead, and over 100 remain missing in Congo after an overloaded ferry — full of people returning home for Christmas — capsized in the river Busira late on Friday night, according to local officials and eye-witnesses. The boat sank less than four days after another one in the northeast of the country capsized, killing 25.

Twenty people are confirmed to have been rescued so far.

The boat was travelling in the northeast of the Congo as part of a convoy of other vessels, and the passengers were primarily merchants returning home for

Pickup truck driver killed by cops in Texas

Apickup truck driver fleeing police careened through the doors of a JCPenney store in Texas and continued through a busy mall, injuring five people before he was fatally shot by officers, authorities said.

The truck crashed into the department store in Killeen, about 68 miles (109 kilometres) north of the state capital Austin around 5.30 pm Saturday and continued into the building, striking people as it went, Sgt. Bryan Washko of the Texas Department of Public Safety said in an evening news brief-

Sunak exits Downing Street, successor Starmer revives hope for FTA with India

The year earmarked for general elections in both India and the UK was destined to throw up many new scenarios on the political front. Among them was a decision to relaunch a "mutually beneficial" Free Trade Agreement (FTA) between the two coun-

Just as India's mammoth democratic exercise edged towards its phased conclusion in 2024, Britain's first Indian-origin prime minister Rishi Sunak surprised many within his own Conservative Party by calling an earlier-than-expected election on July 4 - exactly a month on from a third term win for Prime Minister Narendra Modi's National Democratic Alliance.

This meant the FTA talks, having entered their 14th round of intense negotiations, slipped into a more uncertain phase until the new Labour Party-led government committed itself to deepening our bilateral ties". "We agreed to raise the ambi-

tion of our UK-India comprehensive strategic partnership... Crucially, this work will start with trade and investment, and I am pleased to say that we agreed to relaunch Free Trade Agreement negotiations early in the new year," said newlyelected British Prime Minister Keir Starmer after his first meeting with Modi on the sidelines of the G20 Summit in

Brazil last month. It mapped out a clearly defined landscape for the future of the India-UK trade ties, which official UK government statistics clock at GBP 42 billion a year in the 12 months to June

Sunak may not have succeeded in getting the FTA over the resignation speech at the doorstep of 10 Downing Street, British voters had given a "clear signal" in favour of change.

The 44-year-old leaves behind quite the legacy despite presiding over the Conservatives' worst electoral performance in history. His words that "one of the most remarkable things' about modern Britain is just how "unremarkable" his migrant roots were to the top ob will resonate with many, not least a 1.8-million-strong Indian diaspora.

Govt to infuse ₹500 Crore in IFCI to improve its financial health

The government has decided to infuse Rs 500 crore capital in state-owned IFCI to improve its fine raid, beath, about the financial health ahead of the company's proposed restructuring and consolidation into a group.

With the infusion, the government of India's holding in the company is expected to further increase from existing 71.72 per cent as on September 2024.

The capital infusion plan for IFCI was approved through the passage of the first Supplementary Demand for Grants for 2024-25 in Lok Sabha last

The Supplementary Demand for Grants for 2024-25 made an allocation for an additional amount of Rs 499.99 crore for 'Subscription to the Share Capital of Industrial Finance Corporation of India (IFCI). "Taking into account savings of Rs 50.07 crore available in the same section of the grant, the remaining amount of Rs 449.92 crore will be met from surrender of savings available in the capital section of Demand No.30-DEA and it will not entail any additional cash outgo," the Supplementary Demand for Grants

Earlier this year, IFCI had raised Rs As part of the revival and 500 crore capital through the restructuring, the Department of

The Industrial Finance Corporation of India was set up by the government on July 1, 1948 as the Development Institution in the country.

In the second quarter ended September 2024, IFCI had booked a loss of Rs 22 crore and in the first half of FY24, a loss to the tune of Rs 170 crore.

Financial Services (DFS), Ministry of Finance, last month in-principle approved 'Consolidation of IFCI Group' which entails merger/amalgamation of IFCI and StockHolding Corporation of India Limited and

Additionally, StockHolding Document Management Services Ltd, StockHolding Securities IFSC Ltd, IFIN Securities Finance Ltd, IFCI Venture Capital Funds Ltd and MPCON Ltd shall be direct subsidiaries of the consolidated listed entity that is IFCI.

Established in 1948 as a statutory corporation, IFCI currently has many subsidiaries and joint ventures and associates under its fold. By the early 1990s, it was recognised

that there was a need for greater flexibility to respond to the changing financial system. It was also felt that IFCI should directly access the capital markets for its funding needs. It is with this objective that the constitution of IFCI was changed in 1993 from a statutory corporation to company under the Indian Companies Act, 1956.

After two weeks of buying, FPIs turned net sellers in Indian equities this week, with a net withdrawal of Rs 976 crore amid a strengthening US dollar and steady rise in US 10-year bond yields, impacting investor sentiment.
Foreign Portfolio Investors (FPIs) began the week on a positive note, investing Rs 3,126 crore in equities during the first two trading sessions (December 16-20).

However, the trend reversed in the latter half of the week, with FPIs offloading equities worth over Rs 4,102 crore in the subsequent three sessions. This resulted in an overall net outflow of Rs 976 crore during the week, data from National Securities Depository Limited showed.

this short-term Despite reversal, the broader December trend remains positive. FPIs have infused Rs 21,789 crore into Indian equities so far this month, reflecting continued confidence in India's economic growth potential and its resilient markets.

FPIs adopted a cautious approach due to the US Fed meeting and uncertainty about its outcome and future policy direction, said Himanshu Srivastava, Associate Director, Research,

Morningstar Investment Research India While the Fed cut interest rates by 25 bps for the third time this year, it signalled fewer rate cuts in the future, dampening investor sentiment and triggering global market sell-offs, he added.

Additionally, factors like high valuations, weak corporate earnings for the September expectations subdued results for December, rising inflation, slower GDP growth, and a depreciating rupee have further weighed on investor confidence, he noted. "Rising US dollar (dollar index

above 108) and steady increase in the US 10-year bond yields to 4.5 per cent contributed to the FPIs selling.

"India-specific issues like slowing growth concerns and flat corporate earnings in Q2 also contributed to the FPIs selling. Front-running case: Sebi bans nine entities from market, impounds illegal gains of over ₹21 Crore

Markets regulator Sebi has uncovered a frontrunning scheme involving PNB MetLife India Insurance Company equity dealer Sachin Bakul Dagli and eight other entities, who generated illegal gains of Rs 21.16 crore. The front-running by these entities continued for more than three years.

Sebi, through an interim order, prohibited Sachin Bakul Dagli and eight other entities from the securities market and impounded the unlawful gains made by them. In a statement on Sunday, PNB MetLife stated that it has fully cooperated with Sebi in the investigation and taken disciplinary action against the individual involved.

"In line with our internal processes, we have taken disciplinary action. PNB MetLife is committed to upholding the highest standards of corporate and integrity," the statement

through the accounts of suspected entities DRPL, WDPL and Pragnesh Sanghvi have continued for a significantly long period of more than three years, it added. Accordingly, Sebi has restrained these entities "from buying, selling or dealing in securities, either directly or indirectly, in any manner orders".

Additionally, "an amount of Rs 21,15,78,005 being the total unlawful gains earned from the alleged front running activities, impounded, jointly and severally" from the entities, the regulator said.

With decarbonisation in focus, efforts are being made to reduce emissions and over the years, Indian carriers have operated some flights with a blend of Sustainable Aviation Fuel (SAF) and traditional Aviation Turbine Fuel (ATF). Hemant Mistry, Director of Net Zero Transition at the International Air Transport Association (IATA), said the ecosystem for SAF has developed but there is more

work to be done. "There are some very good opportunities for India right now. One is in terms of SAF feedstocks like agricultural waste... There is a growing understanding on what to do for SAF production. We are talking to a number of companies to understand how we can collaborate... Oil companies," Mistry told PTI in a recent interview in

International Transport Association (IATA) represents around 340 airlines, including Indian carriers, that account for more

"India, the third largest ethanol producer consumer today, has the potential to emerge as a key SAF producer utilising its existing and advanced ethanol

Hence, it is time that Priority Sector Lending (PSL) framework be reviewed every 3-4 years to align based on emerging priorities and PSL allocations should be in line with GDP contributions and sectoral growth potential.

hronic diseases like diabetes, high blood pressure, heart attacks, ✓ strokes, and obesity are rapidly rising in India. The good news is that more than half of these conditions are preventable through actions taken through multi-sectoral policy action, simplified generic drug policies, community action, and empowered individuals.

The most potent ammunition to protect from chronic diseases is a healthy lifestyle. A healthy lifestyle consists of a diet rich in locally available and inexpensive fruits and vegetables, whole grains, pulses, nuts, and seeds, with extreme moderation in salt and sugar, refined foods, and sugar-sweetened beverages. Additional steps include avoiding tobacco and alcohol. Exercise produces endorphins and is addictive. Leisure and physical activity should be part of everyone's life. All these require an empowered community, an enlightened individual, and an energetic polity.





SPECTS OF THE ECOSYSTEMS THAT NEED TO BE PART OF THE

Social norms and policies must achieve the following for a health-promoting Healthy Eating: Healthy foods such as

fruits and vegetables in their raw forms (and cooked), cheap, nuts, seeds, pulses, whole grains, and healthy oils must be made safer, cheaper, and more readily available, accessible, and affordable across access points such as public transport, at the workplace, and in educational institutes.

Controlling portion sizes is critical. Large portions of unhealthy foods and beverages, especially at discounts, have been proven to push people to eat more. Large servings, large plates, supersized meals, and bottomless drinks must be de-incentivised, and smaller portions must be incentivised. Children must be protected from unhealthy foods and beverage advertising onslaught. Also, targeting children by extolling children to persuade them into unhealthy behaviours, food, and beverages should not be allowed.

Eliminating trans fats and tobacco and decreasing artificial sugar and refined foods are universal goals from a scientific perspective.

The unorganised sector dominates the Indian food market and is pricesensitive. Lower taxes on healthy oils, higher taxes on unhealthy oils, and cheaper fresh fruits and vegetables will boost healthy food production and consumption.

Health Promoting Town Planning Critical to Healthier Communities

Scientific research shows that providing wide sidewalks, large parks, and green forests within a 0.5 km radius of every household improves health in many ways, including preventing more than 50 chronic diseases and improving mental health for the residents and families staying in the vicinity. Trees also act as natural filters, reducing air pollution and creating a healthier environment.

A study published in JACC Advances has shown that living in high-traffic, congested localities alongside highways increases the local population's blood pressure and chronic diseases. High air pollution is a public health crisis. Preventing air pollution should be a top priority across all ministries, as well as housing and development. High air pollution can shorten life- spans by 1.7 years and increase chronic diseases like diabetes, high blood pressure, lung diseases, and asthma, among those exposed to high levels of air

The holistic way to address the challenge of chronic diseases is to create a grid environment conducive to healthy eating and healthy living through multiple sectors. This leads to a healthy country, systems, societies, and happy people.

SOLUTION TO POLLUTION

elhi once again finds itself enveloped in a thick blanket of smog with AQI touching an AQI of 349 or 'very poor' category and hapless Delhites are turning to humorous memes for solace. One popular tweet went like this: "Time to give Delhi new namesi: Pollutyens Delhi, Haze Khas, Dhua Kuan

and Chandni Choke." Apart from the stress busting mirth, citizens of the Capital are hostage to an annualised feature when air pollution swerves between 'very poor to severe' levels as the winter sets in, leading to permanent health issues. Delhi has the unfortunate distinction of being the world's worst polluted capital city. The air is unbreathable, thanks to fully dispersed harmful pollutants - around 40% which comes from vehicular emissions. One survey pegs the financial losses to the Delhi NCR at a very conservative Rs 100 crore/day due to poor air quality.

BEEN THERE, DONE THAT

To be fair, the state government has tried its best. In 2001, it moved public transport to CNG as fuel, levied charges on commercial ICE vehicles, banned 10-year-old diesel and 15-year-old petrol vehicles and introduced the oddeven car numbers initiative The Delhi EV Policy was framed to encourage greater use of public transport and a viable supply-chain ecosystem through a combination of fiscal and non-fiscal incentives. Initiatives like "Switch Delhi," unveiled

in early 2021 to create mass awareness and the ongoing 'Red Light On, Gaadi Off' campaign are well intended. Yet, Delhiites continue to bear the brunt of pollution emanating from within and from nearby states.

DELHI STRUGGLES TO MEET EV TARGETS

Despite a target of 25% EVs in new vehicle registrations by 2023-24, Delhi could manage around 12% in the fiscal. While higher than other states, it's a poor record given the pollution levels. Even after compulsory scrapping of old diesel and petrol vehicles in 2021, the city still has 472 vehicles per 1,000 people. Between 2012- 2024, the share of personal vehicles registered was around 92%, but EV 4-wheelers, with just 3% share, have struggled to take off.

Regulatory action and financial incentives are inducing some growth in commercial EV segments, but this has to be accompanied by a parallel or superlative growth in personal EVs, to address the pollution crisis.

LOOK EAST, LOOK WEST

New Delhi can take a few cues from Norway and Nepal - countries that have notched up amazing results in pollution reduction and long-term environmental benefits with their commitments to EV adoption. Norway, a country with a population of 5.5 million and an oil and gas producer, has achieved a 35% reduction in C02 emissions since 2012, improving both air quality and public health. Oslo has the highest per capita number of EVs in the world due to a strict adoption target, generous tax rebates and strategic incentivisation of EV users. With EVs accounting for over 90% of its new car registrations, the world will have to scale up the EV adoption roughly as fast as Norway, if it must meet any net zero targets.

Closer home, EVs account for 50% of Nepal's overall vehicle sales (as of FY24) thanks to sustained incentives and low taxes amid a nationwide urgency to cut down energy imports. With nearly all its energy coming from renewable river-fed

hydroelectricity, Nepal is focusing on infrastructure development to support EV ownership.

REAL SOLUTION TO POLLUTION KEPT AT BAY

With the fast-growing economy creating higher disposable income for its huge middle-class, each passing year, the desire for personal mobility will always be on the rise. One perpetual casualty will be air quality. A Central Pollution Control Board (CPCB) study in Delhi, Kanpur, Bengaluru, Pune, Chennai, and Mumbai categorically concludes that the transport sector will continue to emit most of the Nox, and around 50% of PM2.5 emissions in these cities, if we keep away from greener

transportation. Studies show that subsidies are not a magic bullet unless the switch to EV is made too good to ignore for a customer. Starting with attractive subsidies, customers can be lured by parking benefits, besides manufacturer-offered incentives for upgrades. Most importantly, a modern EV policy with a strong commitment to achieving targets from all authorities would comfort buyers in areas like charging infrastructure. Since many are not fully aware of the need to switch to EVs, regular campaigns must be undertaken. Big cities may pollute more, but smaller and emerging ones are not far behind; every year new towns in Tier 2 and Tier 3 India are making to the WHO's mostpolluted cities list. Unless there's collective will to fast-track EV adoption, Delhi's air pollution will always get tossed around in inter-state bickering and internal political rivalries with fewer solutions.

Rohit should change his tactics, be more attacking batting at No. 6: Shastri

rith skipper Rohit Sharma struggling to decipher a way to score runs in the Border-Gavaskar Trophy, former India coach Ravi Shastri says the stylish batter should go in with a clear mindset, change his tactics, and attack the bowlers.

Rohit missed the opening Test Down Under to be with his family for the birth of his second child. He was expected to reclaim the opener's spot but KL Rahul's impressive 77 in India's win at Perth prompted a rejig of the batting order with Rohit moving down to No.6.

The change though has not been fruitful for Rohit as he has managed 10, 3 and 6 runs in the last three innings, while Rahul has encashed on the opportunity by notching up a fine 84 in the first innings at Brisbane in the third

"I would like to see Rohit Sharma, his tactics change a bit because he can still be extremely dangerous at that number (six)," Shastri opined on ICC Review.

"I think he's got to be very clear in his mindset to go out there and take the attack to the opposition and not worry about anything the cricketer-turnedcommentator added.

Shastri felt Rohit should shun the defensive mindset.

The last thing you want is him to be in two minds whether to defend or attack. In his case, it should be attack. He picks up length quickly, he should take the opposition on

at that number.

"Because if he gets away in the first 10-15 minutes, in any way, he's not got past that 15-20 minutes, half an hour. So why don't you play a natural game, go and take the attack to the opposition and take it from there?

Shastri felt it's the best way for



Rohit to get back into form and win games for India, adding that the best No.6 batters in the world are those who have the ability to counter-attack.

"I think that is his best way of not just coming back into form, winning a game for India as well. Because that number is a crucial number."

The best No.6s in the world are the guys who know how to have the ability to counter-attack. They read the situation well. Yes, if a lot of wickets have fallen, maybe for a little while. You might have to be circumspect, but the intent has to be far sooner than later.

"Especially when you have that kind of ability and especially when you open the batting for India and you have all the shots for Australian conditions.

Rohit had made his Test debut in 2013 at No. 6 position, marking the occasion with a century. Shastri backed Rahul to retain the opener's slot in the fourth Test following his two half-centuries so far in the five-Test series.

"I would have asked him (Rohit) to open in the last Test match (Brisbane) but then the way Rahul has batted, he was a joy to watch and the way he's batting, I believe he struck a purple patch," Shastri

"It could be a position he might just want to keep and enhance the way he's playing because his technique was faultless," said

Shastri. The former India captain said Rahul was currently at the top of his game and his confidence level

too was very high.
"The way he left the ball, the way he allowed the ball to come onto the bat, some of his cover drives were as good as any played by anyone in world cricket at the moment. And so I think when there's that much confidence there, you know, let it be?

Women's players arrested over racist incident in Brazil soccer semifinal

 $F_{\text{players were arrested by}}^{\text{our River Plate women's}}$ Sao Paulo police and accused Paulo's public security told secretariat Associated Press.

On Friday, a Brazil Ladies Cup soccer semifinal between Argentina's River Plate and Brazilian team Grêmio was stopped in the first half after River Plate's Candela Díaz was accused of making monkey gestures to a ball boy, according to broadcast footage and local media reports.

Díaz was detained along with teammates Juana Cangaro, Milagros Naiquen Diaz, and Camila Ayelen Duarte, the players' lawyer, Thais Sankari, told The AP. They remained in custody on Saturday. Sankari said the River Plate

players reacted only after being provoked. "We see in this decision a



great arbitrariness and the Brazilian judiciary's desire to send a message. They used this case for that purpose," she said.

After Díaz's gestures on Friday, the Grêmio players walked off in protest. The referee showed red cards to six River Plate players following an on-field fight and ended the match because there was no longer the minimum number of players required to continue. The score was 1-1 but the referee awarded the match to Grêmio, which will play in the tournament final on Sunday.

The Brazil Ladies Cup banned River Plate from the tournament for two years on

Tournament organizers said in a statement on Saturday that future editions will immediately ban participating team whose athletes or staff "engage in racist gestures on the playing

'The organisation reaffirms its anti-racist stance and emphasises that it will never tolerate such incidents. Grêmio said on X it was pporting its players would file a police report. 'We regret what happened

condemn discriminatory acts," the team said in the statement. Grêmio coach Thaissan Passos said her players told

her River Plate players had previously called them 'monkevs. "Incidents like this cannot

keep happening. How long will we keep pretending racism doesn't exist?" she told local broadcaster SporTV. Díaz has not commented publicly

River Plate also condemned the discriminatory gestures. The club said in a statement on X it was "taking the disciplinary appropriate measures and will continue working to eradicate such
