

# **Centre tables ONOE Bill amid fiery debate**

- Says it won't tamper with states' powers
- Oppn terms it as 'dictatorial'

## PNS NEW DELHI

Two bills that lay down the mechanism to hold simultaneous elections were introduced in the Lok Sabha after a fiery debate on Tuesday, with the opposition terming the move "dictatorial" and Law Minister Arjun Ram Meghwal asserting that the legislation would not tamper with the powers enjoyed by states. The Constitution (129th Amendment) Bill

was introduced in the Lok Sabha by Meghwal after a nearly 90-minute debate, followed by a division of votes. As many as 269 members voted in favour of the Bill and 198 against it.

Meghwal also introduced The Union Territories Amendment Bill, which seeks to align elections in the Union territories of Puducherry, Delhi, and Jammu and Kashmir with the Lok Sabha polls. He said the proposed bills did not attack the "basic structure doctrine, as claimed by the arrangement"

opposition".

Principles such as judicial review, federal character of the Constitution, separation of powers, secular character, supremacy of the Constitution had not changed, Meghwal said, adding that the objections to the Bill were political in nature.

# Govt unveils first-ever Tourism Policy

Aims to attract Rs 15,000 cr investments in 5 years

# To create 3 lakh jobs in the same period

interventions. Aiming to attract investments of Rs 15,000 crore and to create three lakh jobs over the next five years, the policy sets targets to place Telangana among the top five tourism states.

The policy introduces 27 Special Tourism Areas (STAs) to leverage the state's natural, cul-tural and spiritual heritage. Nine key STAs, including Nagarjuna Sagar, Ramappa, Bhadrachalam, Warangal and Charminar, will receive priority attention. These areas will be equipped with robust infrastructure, adventure activities and facilities like water sports and her-itage conservation projects modelled on inter-national standards.

The policy prioritises infrastructure devel-opment to make Telangana globally competitive. The initiatives are positioning the Rajiv Gandhi International Airport as the focal point, constructing mega retail malls, promoting river festivals on the Godavari and Krishna rivers, and enhancing waterfronts with eco-tourism facilities. Helipads, golf tourism and specialized shopping experiences along the Regional Ring Road are part of the proposed framework.

The government has adopted public-private partnership (PPP) models with clear incentives in an attempt to attract private investors. **Continued on Page 2** 

# **Tummala orders** purchase of 25,000 more tonnes of soybeans

The TG Government has issued orders allowing additional purchases of soybeans. Agriculture Minister Tummala Nageshwara Rao issued orders to procure 25,000 more tonnes of soybeans over the quantity announced earlier.

As per a statement issued on Tuesday, the government has already procured 59,000 tonnes of soybeans from farmers through the nodal agency Mark Fed during the monsoon 2024 crop season at the support price of Rs 4,892 announced by the Centre.

Keeping the interests of farmers in mind and as per the request of public representatives and Collectors, the Agriculture Minister gave orders to procure 25,000 more tonnes in addi-tion to the 59,508 tonnes specified by the Centre.

Revenue Minister Ponguleti Srinivas Reddy said that many governance problems have arisen due to the BRS Government's policy of carving out new districts and revenue divisions and that they will try to solve them.

Replying to the demands of MLAs of all political parties for new revenue divisions and mandals in the Assembly on Tuesday, Ponguleti said the government had received proposals for 11 revenue divisions and that the government had issued noti-

He said that BRS MLA Palla Rajeshwar Reddy and R&B Minister Komatireddy Venkat Reddy had demanded a revenue division in Cheryal. However, the government will have to examine all requests for new revenue divisions, he added.

Replying to a question by former Minister Sunitha Laxma Reddy, he said that the government has no intention to scrap any district or revenue division. He said the state has 33 districts, 621 mandals and 76 revenue divisions and that will continue. There is no need for changes in districts and revenue divisions, the minister clarified.

He said the government will direct Collectors to examine the possibility of setting up Makthal and Athmakur revenue divisions and a new mandal in the Alair Assembly constituency.

As per rules securing 10% (17) of seats (175) in the House is necessary to get the main opposition tag. Although the YSRCP couldn't secure the required numbers in the Assembly, it has a strong presence all over Andhra Pradesh. The YSRCP was its lack of preparedness. Recently, some YSRCP district presidents kept away from the party decision to stage dharnas at collectorates. Some senior YSRCP leaders are still analysing their defeat in the LS elections. Surprisingly some seniors patted themselves as they had lost only by small margins. This is quite funny as the party is fac-ing a precarious situation. Many YSRC candidates who lost their seats are believed to be thinking of 'saving' their future by contesting on the tickets of other parties.

The only option now before the YSRC is to launch public movements against the rulers. But that looks like an uphill task as the NDA Government is on a strong wicket and as there is no anti-incumbency.





# Police issue show cause notice to theatre management for 'lapses'

The Hyderabad police has issued a show cause notice to the management of Sandhya Theatre for alleged lapses that led to the death of a woman in a stampede during the premiere of Telugu superstar Allu Arjun's latest film, 'Pushpa 2'

In the notice, dated December 12, the police highlighted 11 "lapses" on the part of the theatre management.

The show cause notice pointed out several lapses, including the theatre management's alleged failure to inform the local police about actor Allu Arjun's arrival on the night of December 4, when the stampede occurred.

Additionally, it noted that the management did not plan proper entry, exit, or seating arrangements for the film's lead actors, despite being aware of the likely public attention they would attract.

According to the notice, there were no proper signboards displaying entry and exit points to guide the people attending the

movie Additionally, the management allegedly encouraged the gathering of fans by erecting large "flexes" outside the theatre "illegally without permission," the notice said. Also, the notice stated that the management failed to arrange adequate security to manage the crowd at the main gates, which led to the untoward incident.

Further, the notice alleged that the management's lapses demonstrated its failure to provide a safe and secure environment



for the public visiting the theatre. It directed the theatre management to show cause why its Cinematograph License

should not be revoked due to the lapses that led to the woman's death.

The management was given 10 days to respond, failing which it would be assumed they had no explanation and further action would be taken without additional notice. A police official confirmed on Tuesday that the theatre management was served a show cause notice, seeking an explanation within 10 days.

On December 4, a 35-year-old woman died, and her eight-year-old son was hospitalised during a stampede-like situation

#### at Sandhya Theatre in Hyderabad. The incident occurred as thousands of fans jostled to get a glimpse of actor Allu Arjun at the premiere of 'Pushpa 2'.

Following the incident, the city police registered a case against Allu Arjun, his security team, and the theatre management under various sections of the Bharatiya Nyaya Sanhita (BNS) at the Chikkadpally police station, based on a complaint lodged by the deceased woman's family.

# **'Make us SBM** coordinators in right earnest'

Village and mandal coordinators working under the Saakshar Bharat Mission (SBM) appealed for their reinstatement. Over 15 people attended Prajavani, hoping the Congress administration would address their issue. # **Kothagudem Municipality likely** to be upgraded as corporation

#### PNS KOTHAGUDEM

It is learnt that Kothagudem Municipality is all set to be upgraded to a municipal Corporation. The Telangana government has reportedly decided to do so.

Currently, there are 13 municipal corporations in the State, and the government is considering promoting Kothagudem as one of them. The proposal is under review, and the government plans to merge Kothagudem, Palvoncha and 35 panchayats across four mandals into the proposed new corporation.

Kothagudem municipality has a population of 188,191 (93,300 men and 94,891 women), while the population in the Palvoncha area exceeds one lakh. The panchayats in the proposed regions-Sujatanagar (11,124 people), Chunchupalli



(41,860 people), Lakshmidevipalli (21,432 peo-ple), and Palvoncha (5,903 peoregion. # Chit fund company shuts up shop in Vikarabad district

In Vikarabad, people from various backgrounds, ranging from the poor to the middle class, are often cheated by chit fund schemes. People join the chit fund schemes hoping to save a portion of the money they earn through hard work. By contributing a certain amount every month, they hope to take out a

larger sum when needed. While invest in companies that manage chit funds. People often trust individual operators, believing they are

more reliable. However, many chit fund companies have already defrauded people by absconding

with crores of rupees. Recently, in the Parigi area of Vikarabad district, a chit fund company shut down and the operator absconded with around Rs 2 crores of subscribers' money. This unexpected development left the people who had invested their money in the company in despair, prompting them to file a complaint with the Deputy Superintendent of Police.

When the victims questioned the chairman of SLNK, Kaukuntla Antharam Devender Goud, he failed to respond. Similarly, when they confronted the company's manager, Giridhar Reddy, he denied any involvement, and the victims alleged that when they went to his home to inquire, his wife insulted them.

The victims expressed their frus-

tration, stating that they had worked tirelessly to save money and had invested it in the chit funds, hoping for a better future. Some had invested for weddings, while others hoped to start businesses. Now, they feel helpless and angry as they are left with noth-

ing. The chairman allegedly transferred all his assets to an office boy's name, claiming he has no assets left, it is alleged. Another victim complained that for three years, they had not been paid rent, and now the company was resorting to threats when asked about the money. The victims have demanded immediate legal action against the company and want their money refunded. They have formally filed a complaint with the DSP.

# People warned against cybercriminals posing as police officials








# Former MLA Kancherla

ing heart conditions are at a higher risk, as blood clots caused by the cold can lead to severe heart attacks. Dr. Naginder, a senior medical expert from Maheswaram Medical College, has advised people to wear warm clothing, avoid stepping out early in the morning, stay hydrated, and use massages to prevent burning sensations in their extrem-

ities. The cold wave has also significantly reduced power consumption across the district. With air conditioners, coolers, and fans switched off, electricity demand has dropped. On December 10, power demand peaked at 3,141 MW, but by Sunday, it had fallen to 2,593 MW. The use of geysers and heaters in the mornings continues, but the absence of cooling appliances in offices and homes has eased the load on the power grid.

# Built to feed the poor; it is now revered by all

Medak, a famous tourist destination in Telangana, is home to the second-largest Christian prayer cathedral in Asia. This year marks the centenary of the Medak Church, and the church is being beautifully decorated for the celebrations. The Medak Cathedral, which is completing 100 years, is an architectural marvel.

Standing at 175 feet tall and 100 feet wide, the construction of this church involved both Indian and foreign experts. The church, built over two floors, remains in perfect condition even after a century. This durability is a testament to the strong construction techniques used, which are believed to have incorporated ancient Indian architectural practices. Not only the walls but also the interior of the church, with its colorful stained glass paintings, is a highlight of the church. These paintings, which depict the birth of Jesus Christ, the crucifixion, and ascension, are eye-catching. What's particularly interesting is that these paintings were not created on a single sheet of glass. Instead, individual pieces of glass were painted in England and then brought to India to be assembled. These paintings are best visible when sunlight falls on

them. Historians suggest that the marbles used in the church's construction were sourced from England and Italy. Special care was taken during the construction to ensure proper acoustics within the church. The church was built using only stone and dung lime, which is another unique feature. The church, with its twostory spacious prayer hall and

# 'Synopsis can't run into 128 pages'

# SC tells registry to take note

PNS NEW DELHI

A synopsis cannot run into 128 pages, the Supr eme Court on Tuesday said and asked its registrar (judicial) to take note, particularly in cases where litigants were allowed to appear in person. While hearing a plea

challenging an order of the Allahabad High Court, a bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah said the appellant, who was appearing in person, had filed a synopsis running into 128 pages, loaded with details, most of which were not relevant.

"We understand that the appellant is not a trained lawyer, but it is for the reg-istry to have asked the appellant to trim down the synopsis. A synopsis cannot run into 128 pages," said the bench. The top court went on to add, "Let the registrar (judicial) take note of this, particularly

the cases where litigants are allowed to appear in person." The bench was hearing an issue pertaining to a matrimonial case when it noted the appellant woman was married to the respondent in 2006 and she got a decree of divorce on the ground of cruelty in 2016.

The bench noted that the high court, in its order passed in December, 2019, restored the Section 125 CrPC petition of the appellant and directed the family court to decide the case in accordance with law. Section 125 of CrPC deals with order for maintenance of wives, children and parents. The bench said the high court had directed the said petition was required to be decided on merits by the additional principal judge, Family Court, Agra. "We see absolutely no reason as to why we should interfere with the aforesaid

impugned order.

# A timely assurance

Sri Lanka assures New Delhi that it will not permit anybody to use its territory to threaten India's security

n what must come as music to the ears of the Indian government, the Sri Lankan President has said that his country will not allow anyone to use its territory to threaten India's security. This assurance comes at a time when China is aggressively pursuing 'Mission Indian Ocean' - which targets India. In a joint statement issued Sri Lankan President Anura Kumara Dissanayake made Colombo's position clear during his dialogue with Indian Prime Minister Narendra Modi in New Delhi. This assurance is seen as a critical development in India-Sri Lanka relations, especially given China's use of Sri Lanka's Hambantota Port for docking its naval surveillance and spy ships, including the ballistic missile tracking ship Yuan Wang 5. China's growing footprint in the Indian Ocean has raised red flags for New Delhi. The Hambantota Port, now under a 99-year lease to China following Sri Lanka's inability to service its debt, has become a hub for Chinese naval operations. Over the past two years, Beijing has stationed the Yuan Wang



5, a 25,000-tonne satellite and missile tracking ship, at Hambantota multiple times. This vessel, equipped with advanced tracking and communication systems, has been closely monitoring satellite and missile activities in the region, creating strategic challenges for India. In 2022, Sri Lanka briefly delayed the docking of Yuan Wang 5 following Indian concerns but eventually allowed the vessel to dock under the guise of 'replenishment.' Since then, Chinese surveillance ships have regularly patrolled the Indian Ocean, adding to India's apprehensions about Beijing's strategic intentions in the region. The agreement between India and Sri Lanka ensures that Sri Lankan territory, including its waters,

will not be used in any manner that could harm India's security or regional peace. This is a welcome relief for New Delhi, which views such commitments as crucial for maintaining stability in the Indian Ocean Region. This of course hasn't happened overnight. India's steadfast support for Sri Lanka during its economic crisis in 2022 has further solidified the bond between the two nations. President Dissanayake expressed gratitude for India's timely assistance, which was instrumental in stabilising Sri Lanka's economy during one of its most challenging periods. As far as China is concerned it has been courting Sri Lanka for the sole purpose of encircling India and getting a foothold in Indian Ocean. China's influence in Sri Lanka has grown significantly, particularly after Colombo defaulted on its \$1.7 billion loan for the Hambantota Port project. India has consistently raised concerns about the strategic implications of Chinese investments and activities in Sri Lanka. In this background the assurance of Sri Lankan president signals Sri Lanka's intent to balance its ties with both regional powers while safeguarding regional stability. The agreement also underscores Colombo's recognition of the importance of India's security and regional stability and paves the way for a stronger, more strategic India-Sri Lanka alliance in the years to come.



# Nepal embraces China's BRI

ndia has cause for extreme worry. In yet another indicator of China's growing sway over Nepal, the two are moving forward to implement Beijing's ambitious Belt and Road Initiative (BRI) in the Himalayan nation. India is not only opposed to this in principle on grounds of sovereignty but also fears it will enable China to increase its already considerable inroads into

Nepal. If 2017 marked Nepal's initial step to coming on board the BRI with an MoU, the year 2024 marks a giant leap for the Himalayan nation in that direction. A framework agreement for cooperation on the BRI was signed during Nepalese PM K P Sharma Oli's visit to China in early December, apart from nine other pacts. With the strategically located Himalayan nation having become a hub for Great Powers contestation, the US too would be uneasy with the latest Beijing-Kathmandu tango. While the US had managed to get Nepal on board its own Millennium Challenge Corporation (MCC) Compact to fund Kathmandu's power and transport infrastructure, the BRI seems far broader. Kathmandu is trying to play down the framework as just a continuation of the 2017 MoU. The framework, however, underlines Kathmandu and Beijing's renewed push for the BRI, an initiative on which New Delhi harbours deep suspicions for what it perceives as China's hegemonic ambitions through debt-trap diplomacy. Sovereignty is another major concern, with the China-Pakistan Economic Corridor (CPEC), another project under BRI, passing through Pakistan-

Punjab's agriculture is facing a harrowing reality-its lifeblood, the soil, is being contaminated by toxic pesticide residues at alarmingly high levels



t's time to face the disturbing truth about Punjab's agriculture-and it's a nightmare. In districts like Bathinda, Mansa, and Ludhiana, up to 60 per cent of farm soil samples are infested with toxic pesticide residues including the deadly chemicals endosulfan and carbofuran—at levels far beyond what's even remotely safe. This isn't just a warning; it's a full-blown crisis, a ticking time bomb, the result of irresponsi-ble, reckless pesticide and fertiliser abuse running rampant in our fields.

On World Soil Day-December 5thwe're forced to confront the cold reality of a rapidly disintegrating agriculture sys-tem, while the world's been talking about "Caring for Soils: Measure, Monitor, and Manage"! The consequences of this mad-ness are devastating. Our once fertile land is transforming into a barren wasteland, and that's only the beginning. These toxic chemicals aren't just staying in the soil. They're seeping into our food chaincontaminating every bite we take and slowly poisoning us all. But it doesn't stop there. These toxic residues are embedding themselves into our very DNA, passing down a legacy of genetic mutations to our children and grandchildren.

For instance, FRAMEWORK FOR Punjab, which heavily depends on rice and wheat cultivation, reports alarming pesticide consumption rates. Between 1994-95 and 2021-22, the Plant Protection Department of Agriculture and Farming Welfare Ministry trained only 585,000 farmers in Integrated Pest Management (IPM), a dismal figure in a nation with over 150 million farmers. According to the International Code of Conduct on Pesticide Management, govern-ments and industry stakeholders must provide comprehensive training and information to farmers and retailers. Yet, the implementation of these guidelines still needs to be more robust. Retailers often serve as farmers' sole point of contact, and in many cases, they disseminate misleading or incomplete information. Data Collection: Bridging

Management Bill 2020 neglects the safety of small-scale farmers, who often lack access to affordable, climate-appropriate personal pro-tective equipment (PPE). Farm workers face heightened health risks without mandatory provisions requiring them to supply adequate protective gear, especially in hot and humid agricultural regions. Labelling and Consumer ProtectionIndia's pesticide labelling standards fall short of both domestic and international norms. Safety information is frequently crammed into illegible leaflets, leaving farm-ers ill-informed about risks and proper usage. Although the Consumer Protection



When Yamini Reddy moved to Hyderabad in 2007 after her marriage, her dreams for the city and the art form she devoted her life to were modest. She envisioned merely a small branch of her parents' established institute in Delhi, where she had honed her craft. "I started with just three to four students. I didn't advertise; it was just a passion project. I was performing a lot at the time, and I thought, why not teach?" she recounts. The result was an organic growth that exceeded all expectations. Today, Natya Tarangini's Hyderabad branch trains over a hundred students, a testament to Yamini's deep commitment to nurturing the next generation of Kuchipudi dancers

to Yamini's deep commitment to nurturing the next generation of Kuchipudi dancers. Her teaching method, Yamini explains, is rooted in the personal and the profound. "We believe in personal training. From the youngest to the senior-most students, we take great care in their growth," she says. Her father, legendary Kuchipudi exponent Raja Reddy, developed a style of choreography and instruction that Yamini and her sister Bhavana have carried forward. "It's a little different from other Kuchipudi styles—people find it refreshing, from the creativity to the teaching techniques. That's why I think word-of-mouth worked so well for us." But beyond technique and

But beyond technique and rigor lies something even more fundamental: her emotional connection to the dance form and its birthplace. "Kuchipudi is native to us Telugu people. When I came back from Delhi, I was so happy to return to the roots—to set up an institute in the birthplace of the dance form itself." Yet, even as she celebrates this cultural legacy, Yamini is candid about the challenges of performing in a world enamored with cinema and digital entertainment.

# Cultural landscape in flux

In Hyderabad, where the glamour of Tollywood often eclipses traditional arts, cultivating an audience for Kuchipudi has become an uphill battle. "T e culture here rich and many parents are eager to teach their children classical dance for the discipline and balance it brings to the mind and body. But as audiences, people are not as engaged as they used to be. They'll flock to anything cinema-related, but standalone classical arts? Not so much," she laments. Yamini believes that consistent performances are crucial for nurturing a cultural ecosystem. "It's not about doing one or two concerts. It has to be a continuous effort. In places like Delhi or New York, you know there's always something happen-ing. There's a monthly calendar for theater, dance, or music performances. In Hyderabad, we don't have that. We need two or three cultural hubs that regularly host programs to grow audiences." This lack of infrastructure, she argues, reflects a

age. "If you invest in something over five years, you'll see a remarkable change. But you need that initial push," she says, adding that such long-term efforts could eventually create a self-sustaining cultural ecosystem in the city. While many art forms are now experimenting

While many art forms are now experimenting with storytelling formats to capture the attention of modern audiences, Kuchipudi has always been rooted in narrative traditions. "It's natural to the art form, which originates from theater and classical arts. We've been storytelling for ages," Yamini explains.

#### **Reclaiming Hyderabad**

Reflecting on her deep connection to Hyderabad, she shared her vision for the future: "I haven't done a full-fledged show in a long time, so of course that is on my agenda for 2025—definitely to bring some new productions to Hyderabad audiences," she states with a determined smile. Beyond performances, her aspirations stretch into community-building. "Maybe, God willing, I'll set up centers where Hyderabadis can

Th set up centers where Hyderabadis can enjoy art in a space dedicated to it. That's a long-term goal," she adds. For her, Hyderabad is not just a performance venue but a fertile ground to nurture her dual passions as an artist and teacher. "Performances are my life," she declares. "I look forward to traveling, performing and taking my work not only in India but abroad as well." At the heart of her choreography is a profound engagement with philosophy. While classical Indian dance is often steeped in religious themes, she emphasises the philosophical undercurrents that unite diverse tradiions.

tions. "For me, more than Indian religion, it is Indian philosophy that has a great impact on my work," she explains. "Religion is intricately involved in the art, but I try to connect it with philosophy. This way, I can weave in influences from biblical or Islamic traditions too. For me, it's the values and the goodness we are trying to impart that are the ultimate takeaway from any presentation."

This ethos was most evident in her celebrated piece, 'My Heart is a Temple', choreographed by her father. A blend of biblical verses and classical Indian aesthetics, it stands as a testament to her ability to seamlessly marry diverse cultural narratives while retaining the integrity of the art form.

The journey forward is brimming with possibilities. She is currently working on two to three new choreographies and is eager to present these on stage soon. But her goals extend far beyond personal accomplishments. With a visionary eye, she dreams of creating platforms that bring artists and

There's no specific "breastfeeding diet" or list of foods to avoid—most women can continue their regular diets without affecting milk quality. While a nutritious, balanced diet supports a mother's overall health, there's no need to eliminate particular foods. Embracing this flexibility allows mothers to focus on their well-being and enjoy a less stressful nursing experience.

# Evidence-based perspectives matter

Studies have always indicated that the benefits of breastfeeding are enhanced immune development, cognitive growth and overall health in children, which great-ly reduce the likelihood of developing chronic diseases. Additionally, breastfeeding cuts down the risk of SIDS (Sudden Infant Death Syndrome) by up to 64% and reduces the risk of total infant mortality by as much as 40%. For mothers, beneficial effects include postpartum recovery and lower risks for certain cancers and other diseases. These outcomes, however, rely on a strong support network, accurate facts, healthcare guidance and social support. The most effective way to foster informed, supportive environments that allow more families to experience these life-changing health benefits is by building a healthier, more resilient society for future generations.

# Captivating drama of love, control & liberation

#### PLOT

et in the 1990s at a strict boarding school in the Himalayan foothills, Girls Will Be Girls delves into the stifling effects of patriarchal norms on women's lives and desires. The story centers on Mira (Preeti Panigrahi), a disciplined and high-achieving student whose orderly world is disrupted by the arrival of Sri (Kesav Binoy Kiron), a charming and mischievous new transfer student. As Mira navigates her growing attraction to Sri, the narrative takes an unexpected turn when her mother, Anila (Kani Kusruti), becomes part of the story. Living nearby to oversee Mira's academic progress, Anila struggles with her own social and romantic frustrations, leading her to compete for Sri's attention. This layered dynamic reveals not only the personal consequences of repressive societal rules but also how these structures influence women's relationships and self-perception across generations.

#### HIGHLIGHTS

Girls Will Be Girls is a poignant psychological drama that delves deep into the layered complexities of a mother-daughter relationship in a patriarchal society. One of

the most striking aspects of the film is its ability to capture the subtleties of repression and rebellion. Mira's internal journey, as she explores her suppressed desires, is intricately juxtaposed with her mother Anila's struggles with her own unresolved frustrations. #### DRAWBACKS

These minor shortcomings, however, do not take away from the film's overall impact.

#### PERFORMANCES

The performances in Girls Will Be Girls are its beating heart. Preeti Panigrahi delivers a magnetic performance as Mira,

masterfully portraying the journey of a young woman torn between societal expectations and her awakening individuality. She captures every nuance of Mira's character, from her moments of quiet rebellion to her raw vulnerability, making her both relatable

and compelling. Kani Kusruti is equally captivating as Anila, Mira's mother. Her portrayal is layered, oscillating between control and yearning, as she struggles with her own unfulfilled desires while attempting to shape Mira's life. Kani's performance brings a level of gravitas to the role, making Anila both a product of societal repression and a perpetrator of it. Kesav Binoy Kiron as Sri, the sly and charisma to his role, becoming the catalyst for both Mira's and Anila's selfdiscovery. The chemistry between the actors is natural and contributes significantly to the emotional resonance of the story.

#### **TECHNICAL ASPECTS**

Shuchi Talati's direction shines in its ability to blend the personal and the political, giving equal weight to the characters' individual struggles and the societal structures that shape their lives. The film bravely tackles the themes of female sexuality and generational trauma, making the audience reflect on how societal expectations influence women's autonomy and relationships. The film's technical brilliance enhances its narrative depth. Cinematographer Jih-E Peng's stunning visuals beautifully capture the contrasting elements of the story. The vast Himalayan landscapes serve as a metaphor for freedom and longing, while the claustrophobic interiors of the boarding school and Anila's home reflect the confinement of the characters' lives.

The production design authentically recreates the 1990s setting, with every detail, from the uniforms to the decor, immersing the audience in the time period. The musical score by Pierre Oberkampf and Sneha Khanwalkar is another standout aspect, subtly underscoring the emotional highs and lows of the characters' journeys without ever overwhelming the narrative.

However, the editing could have been slightly tighter in certain parts of the film, especially in the middle section, where the pacing issues become more evident. Despite this, the technical aspects overall contribute significantly to the film's immersive experience.

#### VERDICT

Girls Will Be Girls is a thought-provoking and emotionally charged exploration of how patriarchal norms stifle women's sexuality and autonomy. With its searing examination of generational trauma and repression, the film offers a unique perspective on themes often overlooked in mainstream cinema. Shuchi Talati's directorial debut is marked by a sharp focus on emotional authenticity, supported by powerful performances from Preeti Panigrahi and Kani Kusruti. The film's ability to intertwine personal struggles with broader societal commentary makes it a significant addition to contemporary Indian cinema.

While its pacing may not appeal to all viewers, the film's psychological depth, stunning visuals, and atmospheric storytelling make it a rewarding experience. Girls Will Be Girls is a must-watch for those seeking a nuanced and courageous portrayal of women's lives and desires in a repressive world.



# Can 'Guru' Gambhir and Nayar offer cogent solutions to technical flaws in batters?

Rohit Sharma and Virat Kohli are copping maximum criticism for being walking wickets during the ongoing Test series against Australia but even Shubman Gill, Yashasvi Jaiswal and Rishabh Pant haven't shown the patience needed to survive Down Under, indicating a larger problem.

Patience is a virtue that one develops over time and Kohli had once showed how it's done during his golden phase between 2014 and 2019. KL Rahul, blessed with sound technique, has displayed that during the current series with scores of 77 and 84 in Perth and Brisbane.

In case of Jaiswal, save his second innings knock of 161 at Perth, a shuffle across the crease is making him a candidate for leg-before.

Gill loves to play on the rise outside the off-stump and away from his body and could be impatient when one bowls the stump and even for Pant, a compulsive stroke player, the ball that leaves him from five metre length with adequate bounce, is creating issues.

So, will head coach Gautam Gambhir and his deputy Abhishek Nayar, who is highly regarded in Mumbai cricket circuit for being a "Mind Coach and Life Coach rolled into one", do anything about it? A former India great, who didn't wish to be named, offered his perspective. "Not all great players or players of

repute happen to be great coaches. They might have done some incredible things as players and knew what to do and how to react during a particular situation," the veteran of 100-plus Tests said.

"But coaching is science and not many can tell why certain things need to be done. Even Gautam used to play with hard hands and dab towards slips in Australia and England.

"You can still work with younger guys but difficult to mould the older ones who don't get enough time to work on their game in a

Watching the dismissals of especially Kohli in Australia, which seemed like a replay of previous ones, has led to growing concerns. Everyone understands the technical flaw, but can anyone provide the corrective measures to break the rut?

Rohit, barring the England tour in 2021, he does not really have a track record in SENA countries in Tests. But with Kohli, the problem of reaching for deliveries on and



outside the off-stump has resurfaced once again and has been a persistent issue for quite some time.

Sanjay Manjrekar's tweet is worth taking note of. "I guess the time has come to

scrutinise the role of a batting coach in the Indian team. Why major technical issues have remained unresolved for so long with certain Indian batters?" he

asked.

Manjrekar's view raises questions

on the role of Sanjay Bangar, Vikram Rathour, and now Nayar. Their official designation might be assistant coach, but they essentially

are batting coaches. Devang Gandhi, who was a touring selector between 2016-17 to 2020-

21, had a more nuanced take compared to the veteran India star. "It would be very easy to target Nayar as a low hanging fruit or for that matter Gautam," Gandhi, who has coached the Delhi Ranji team and Bengal U-19, told PTI during a conversation.

"But they have just come into system. To discuss or nudge a player, first you need to be around for some time and once there is some kind of mutual trust between the two, you can offer him solutions. But at this level, it is more about the experienced player's own

mental make-up." So what is Kohli's problem? Gandhi, a former Test opener and an NCA Level-2 coach, believes it's all about his mental approach. "If you watch his training videos

that are available for public, I find him doing all the right things. During training he is playing close to his body. But the moment it is the match situation, the hands are moving towards those channel deliveries like conditioned reflex or

muscle memory," he explained. Gandhi then blamed it on the rising T20 engagements. "The moment his bat is away from

the body, the bat-face will open up towards cover. Now this is a white ball problem of hitting through the

line. In India the ball will hit the bottom of the bat but in Australia, it

will towards the upper part. "What solution can Gambhir or Nayar possibly give, apart from telling him to not play those deliveries?

"After 30 Test hundreds, Virat doesn't need to be told that but at 36, does he have that patience to accept that now if he scores a hundred, it will be off 200 balls and not 140 like earlier times? Can he bide those extra 60 balls?," Gandhi questioned.

Sachin Tendulkar's epic 241 in the 2004 New Year's Test in Sydney is often cited as a prime example of patience. He didn't hit a single cover drive until he scored his double hundred.

double hundred. "It's about controlling the mind. You can be a sounding board for players like Tendulkar and Kohli but at this stage, you can't coach them. Coaching happens at junior level," Gandhi added.

But can a Gambhir or Nayar help Kohli find a solution?

"Of course, at some point, honest conversations are necessary. But first, they should ask him what his corrective options are and then offer their own if they have something different to contribute," Gandhi concluded.
