Manmohan Singh's last rites to be conducted with full state honours; national mourning of 7 days to be observed: Govt sources.

India's former Prime Minister Manmohan Singh, widely regarded as the architect of India's economic reform program and a landmark nuclear deal with the United States, has died. He was 92.

Singh was admitted to New Delhi's All India Institute of Medical Sciences late Thursday after his health deteriorated due to a "sudden loss of consciousness at home," the hospital said in a statement.

Singh was being treated for "age-related medical conditions," the statement said.

A mild-mannered technocrat, Singh became one of India's longestserving prime ministers for 10 years and leader of the Congress Party in the Parliament's Upper House, earning a reputation as a man of great personal integrity. He was chosen to fill the role in 2004 by Sonia Gandhi, the widow of assassinated Prime Minister Rajiv Gandhi.

But his sterling image was tainted by allegations of corruption against his ministers.

Singh was reelected in 2009, but his second term as prime minister was clouded by financial scandals and corruption charges over the organization of the 2010 Commonwealth Games. This led to the Congress Party's crushing defeat in the 2014 national election by the Hindu nationalist Bharatiya Janata Party under the leadership of

Narendra Modi. Singh adopted a low profile after relinquishing the post of prime minister.



Prime Minister Modi, who succeeded Singh in 2014, called him one of India's "most distinguished leaders" who rose from humble origins and left "a strong imprint on our economic policy over the years."

"As our Prime Minister, he made extensive efforts to improve people's lives," Modi said in a post on social platform X. He called Singh's interventions in Parliament as a lawmaker "insightful" and said "his wisdom

and humility were always visible." Rahul Gandhi, from the same party as Singh and the opposition leader in the lower house of the Indian Parliament, said Singh's 'deep understanding of economics inspired the nation" and that he "led India with immense wisdom and integrity." CM MEETS FILM INDUSTRY BIGWIGS **Revanth takes** full control of Tollywood

Ticket price hikes and benefit shows off the agenda





HYDERABAD

Telangana Chief Minister A Revanth Reddy has made it clear to Tollywood bigwigs that under no circumstances, benefit shows and ticket price hikes will be allowed in the state. Taking full control of the situ-ation, the Chief Minister suggested that film personalities must participate in social service activities and anti-drug campaigns without fail. Although the meeting was widely expected to discuss the raging controversy over the recent Sandhya theatre stampede and the consequent arrest of actor Allu Arjun as well as demolition of N-Convention belonging to film star Nagarjuna Akkineni, none of these items came up for discussion. It was a meeting that apparently followed the agenda set by Chief Minister Revanth, with the participants finally agreeing to come to terms with the state government on all aspects. After the meeting, Tollywood representatives expressed their happiness over the 'positive' manner in which the talks were held and hoped that the currently soured relations between the industry and the state government would improve soon. The Telugu film industry, represented by Telangana Film Development Corporation (TFDC) Chairman Dil Raju, met Telangana Chief Minister Revanth Reddy on Thursday morning. This meeting scotched speculations about the perceived 'gap' between the government and the film industry. "The Chief Minister shared his vision for the development of the Telugu Film Industry and expressed his ambition to make Hyderabad a hub for not only Indian cinema, but also Hollywood," said Dil Raju. Nearly 40 people from the industry, including producers, actors, and directors, attended the meeting. Prominent figures like



Raghavendra Rao, Suresh Babu, Murali Mohan, Allu Aravind, and others shared their views on how to develop Telugu cinema and elevate Hyderabad's status on the international map.

At least 6,000 inmates escaped from

high-security prison in Mozambique's capital on Christmas Day after a rebellion, the country's police chief said, as widespread postelection riots and violence continue to engulf the country.

Thirty-three prisoners died and 15 others were injured during a confrontation with the security forces, the police chief Bernardino Rafael added.

The prisoners fled during violent protests, that have seen police cars, stations and general public infrastructure destroyed after the country's Constitutional Council confirmed the ruling Frelimo party as the winner of the Oct.9 elections. ed on Page 2

BRS surpasses Cong in political donations

The Bharat Rashtra Samithi (BRS) has emerged as the second-highest recipient of political donations in 2023-24, surpassing the Congress in funds received from contributions of Rs. 20,000 and above.

According to data released by the Election Commission of India, BRS

secured Rs. 580 crore in donations; leaving the Congress (Rs. 289 crore) far behind.

The BJP, however, remained the top recipient, garnering Rs. 2,244 crore in crore to the Congress. the same period. Despite this, the BRS's performance underscores its growing prominence, particularly as a regional party with ambitions of BRS under its leader, K expanding its influence nationally.

A significant contributor to both the BRS and the Congress was the Prudent Electoral Trust, which donated Rs. 85 crore to the BRS and Rs. 156

The disparity in overall donations between the two parties highlights the increasing financial strength of the Chandrashekar Rao.

The BJP had declared donations worth over Rs 740 crore ahead of the 2019 Lok Sabha polls, while the Congress had claimed to have received over Rs 146 crore in 2018-

India's 'reforms' man and politician with a difference

He drew the roadmap of India's economic reform, unshackled it from the licence raj and pulled it back from the brink when even all its gold reserve was pledged. Former prime minister Manmohan Singh was the scholar and architect of the India of today who evolved into a stubbornly resolute politician.

Unassuming, erudite, soft-spoken and a consensus builder, Manmohan Singh died on Thursday night at Delhi's All India Institute of Medical Sciences (AIIMS). He was 92.

The Congress leader, who steered the country for 10 years from 2004-2014 and helped set up the country's economic framework as finance minister before that, was a renowned name in the global financial and economic sectors.

The man who famously spoke of studying under the dim light of kerosene lamps in his village without electricity and went on to become a storied academic was the copybook reluctant politician, almost stumbling into the rough and tumble of mainstream politics.

He was the proverbial dark horse when Sonia Gandhi stepped back from taking the prime minister's post, ignoring the clamour from her party, and chose him instead. And so Manmohan Singh the academic bureaucrat became the 14th prime minister of India in 2004.

Theirs was a partnership that lasted 10 years, the equation between Sonia Gandhi and Singh often cited for its equanimity and an example of how a working relationship should really be. Notwithstanding the nevitable tensions

criticised for turning a blind eye to charges of corruption. The going often got tough. During his first tenure as

prime minister, the coalition began to unravel when India signed a civil nuclear deal with the US. It almost cost his government with the Left parties pulling out of the UPA coalition. However, his government survived.

On July 22, 2008, the UPA faced its first confidence vote in the Lok Sabha after the Communist Party of India (Marxist) led Left Front withdrew support over India approaching the IAEA for Indo-US nuclear deal. The UPA won the confidence vote with 275 votes to the opposition's 256, with a record thin 19-vote victory after 10 MPs abstained.

During the fag end of his tenure as prime minister, when he was seen defending his government's record and the Congress' positions on controversial issues such as the 2G scam, Singh spoke up and declared he was not weak.

"I honestly hope history would be kinder to me than the contemporary media, or for that matter, the opposition parties in Parliament," he had said famously in January 2004.

More than two decades later, Congress president Mallikarjun Kharge reacted to Singh's death with a poignant post on X: "Undoubtedly, history shall judge you kindly, Dr. Manmohan Singh ji!"

The decade with Singh at the helm of affairs is widely believed to be an era unprecedented growth and prosperity.

His journey to the acme of India's governance and political power is unique in the annals of India's politics.

Another recognised national party, Communist Party of India-Marxist (CPI-M), received donations worth over Rs 7.64 crore.

Former minister and BRS leader T Harish Rao, along with a team of party leaders, visited KIMS Hospital to enquire about the health of Sritej, who was injured in the tragic Sandhya Theatre stampede. Harish Rao consoled Sritej's family and assured them of the government's support during this challenging time.

Speaking to the media, Harish Rao described the incident as deeply unfortunate. "Sritej is responding well to treatment, and doctors have informed us that his condition is improving. We hope and pray for his full recovery," he said. Rao extended his condo-





Housing sales dip, Hyd sees moderate decline

India's top residential markets, including Hyderabad, witnessed a decline in housing sales in 2024, reflecting the dampening impact of general and State elections coupled with rising property prices. According to ANAROCK data, overall sales across the top seven cities dropped by 4%, with approximately 4,59,650 units sold in 2024 compared to 4,76,530 units in

Hyderabad recorded a 5% decline in sales, with approx-imately 58,540 units sold in 2024, down from 61,715 units the previous year. This places the city among the markets experiencing moderate

declines, alongside NCR (-%), Pune (-6%), and Chennai (-11%). Kolkata faced the steepest fall of 20% in housing sales, highlighting broader challenges across regions.

Despite the sales dip, Hyderabad continued to play a significant role in the national housing market, with substantial contributions in both sales and new launches. The city added approximately 58,335 new units in 2024, accounting for a notable share of the overall supply, though this represented a 24% decline from the 76,345 units

launched in 2023. Average residential prices in Hyderabad surged by 27%, increasing from Rs 5,750 per sq.ft. in 2023 to Rs 7,300 per



prices reflects the robust demand for larger and betterquality homes, a trend observed across most major cities. While the overall sales value of housing units across India jumped by 16% to Rs 5.68 lakh crore in 2024, the

2 cops, computer operator die by suicide

The bodies of Sub-inspector Saikumar, woman constable Shruti and computer operator Nikhil were found after a painstaking underwater search at a lake

Three bodies, including that of a woman police constable and a sub-inspector, were found under mysterious circumstances in a lake in Kamareddy district on Thursday.

The police launched a search operation after learning that the three individuals had been missing since late Wednesday afternoon.

Based on mobile phone location data, they discovered the bodies of the woman constable and a computer operator in a lake in Sadashivnagar mandal during the intervening night of Wednesday and Thursday.

The body of the sub-inspector of Bhiknoor police station was subsequently found in the lake on Thursday morning, according to Kamareddy District

Superintendent of Police Sindhu Sharma told the media. The deceased were identified as Saikumar, constable Shruti (33)

and Nikhil (29). Mystery shrouds the death of the police personnel and the computer operator who was the outsourced employee in the lake. The bodies of constable Shruti and computer operator Nikhil were retrieved from the lake at midnight on Wednesday. Tigers' movement haunt people in Asifabad district

The residents of Kumram Bheem Asifabad district are living in fear with rise in the movement of tigers. As many as eight tigers are roaming in the Kagaznagar corridor and it has sparked fears among the people.

Forest officials have identified four male tigers and two female tigers in the corridor area. As a result of the tigers' move-

ment, people living in nearby forest villages are in fear for their lives. To track and protect the tigers, modern technology such as drone cameras and tracking cameras are being used. Tigers from Maharashtra's Tadoba, Tipeshwar, and Kannergham Tiger Zones are entering the district via the Pranahita river and moving around the forests of

Kagaznagar. The Kagaznagar forest area, being connected to the Tadoba, Indravati, and Abhayaranyas corridors, allows tigers to freely move in and out. The dense forests, abundant water sources, and wildlife are the reasons for the tigers' presence in the region. Recently, two people were attacked by tigers in the district, resulting in the death of a woman and severe injuries to another.

Several animals have also fallen victim to tiger attacks, with some being killed and others injured. In light of this, forest officials are preparing reports on the possibility of establishing a Tiger Corridor in the region.

Currently, there are 42 tigers and 187 leopards in Telangana, according to Forest officials.

The Amrabad Reserve Forest is a suitable habitat for tigers, and in 2017, there were eight tigers there. The number has now increased to 34, including 15 female tigers, 11 male tigers, and eight cubs. In the old Adilabad district area, eight tigers are currently roaming.



National parties bag over 63% of vote share in 2024 LS polls

The six national parties bagged over 63 per cent share of the total valid votes polled in the Lok Sabha elections held this year. The Bharatiya Janata Party (BJP), Congress, Bahujan Samaj Party (BSP), Communist Party of India (Marxist) [CPI(M)], Aam Áadmi Party (AAP) and National People's Party

(NPP) are the six national parties. Besides the six recognised national

parties, 47 recognised state parties and 690 registered, unrecognised political parties contested the parliamentary polls, according to statistical data issued by the Election Commission (EC) on Thursday. According to the data, 3,921 independent candidates contested but only seven of them were elected.

Besides, 3,905 independent candi-dates forfeited the deposits. Their vote share stood at 2.79 per cent of the total valid votes. Out of the 3,921 independent candidates, 279 were women, the EC noted. The none of the above (NOTA) option got 63,71,839 or 0.99 per cent votes in 2024 compared to 1.06 per cent in 2019. Over 97.97 crore citizens had registered themselves as

electors as compared to over 91.19 crore in 2019 -- an increase of 7.43 per cent. Out of these registered electors, 64.64 crore had cast votes in 2024, compared to 61.4 crore in 2019, the EC said. According to the poll panel, any

Indian citizen who registers in the electoral roll is defined as an elector. The elector who eventually votes is called voter.



MP govt approves 16 projects

he Madhya Pradesh government on Thursday gave approval to a group of 16 works that had been left out of the Parvati-Kalisindh-Chambal (PKC) river linking project with an estimated cost of Rs 28,798 crore. "An MoU was signed on January 28 this year between the Union government and governments of MP and Rajasthan to prepare a detailed project report of revised Parvati-Kalisindh-Chambal River Link Project cum Eastern Rajasthan Canal Project. The Centre will bear 90 per cent of the cost of the project, while the remaining will be contributed by the two states," he added.

A blow to regional peace

The fragile peace of South Asia faced a severe setback when Pakistan conducted airstrikes in Afghanistan

n the night of December 24, 2024, a series of airstrikes conducted by Pakistan in Afghanistan's Barmal district of Paktika province claimed the lives of at least 15 civilians, including women and children. The strikes targeted seven villages, causing significant destruction, particularly in areas like Murg Bazaar and Laman, where an entire family of five was killed. This incident has further strained relations between Pakistan and Afghanistan, raising serious concerns about the stability of South Asia. The airstrikes appear to be a direct response to Pakistan's growing concerns over the activities of the Tehreek-e-Taliban Pakistan (TTP). Pakistan has justified the strikes as a necessary measure to eliminate TTP hideouts and secure its borders. However, the Afghan Taliban strongly denies these allegations, claiming instead that the airstrikes targeted civilians, including Waziristani refugees who had previously fled military operations in Pakistan's tribal areas. The implications of this attack extend far beyond the imme-



diate violence, casting a shadow over peace and security in South Asia. The airstrikes, coupled with the Taliban's vow to retaliate, risk escalating into a broader conflict between Pakistan and Afghanistan. Such hostilities could destabilise the region, which is already grappling with insurgencies, cross-border terrorism, and long-standing disputes.

In addition to the geopolitical ramifications, the humanitarian impact is profound. Afghanistan, a nation still recovering from decades of war, now faces further devastation. Civilian populations, particularly refugees, are bearing the brunt of this violence, with villages like Murg Bazaar reduced to rubble and count-

less families displaced. The destruction exacerbates an already dire humanitarian crisis, highlighting the urgent need for international aid and support. This conflict also undermines ongoing peace efforts in the region. Dialogues involving Afghanistan, Pakistan, and other stakeholders, essential for fostering stability, risk being derailed by such incidents. Additionally, it hinders cooperative initiatives against terrorism, a shared threat that requires coordinated regional action. The situation further complicates geopolitics in South Asia, prompting countries like India, China and Iran to reassess their strategies. Pakistan's actions, though driven by immediate security concerns, may strain its relationships with traditional allies and global powers advocating for peace in the region. To address this growing crisis, both countries must prioritise dialogue and cooperation. Constructive bilateral engagement is crucial to resolving mutual concerns, particularly regarding the TTP and border security. Neutral mediators, such as the United Nations, could play a vital role in facilitating these discussions. Beyond bilateral efforts, regional cooperation is essential. A unified initiative led by organisations like the South Asian Association for Regional Cooperation (SAARC) could encourage collective action against terrorism and promote economic interdependence, reducing the incentives for conflict.



Jordan's ambivalent stance on Palestine

While maintaining a façade of solidarity, Jordan's actions often reveal a pragmatic, if controversial, approach to safeguarding its own interests in a volatile region

ordanian reality towards the PalestiniansJ ordanians have had a wounded, complicated, and manipulative history. House of Hashim or e Hashemite dynasty rules Jordan with the current King Abdullah II, as the 41st generation of the direct descendants of Prophet Muhammad. While Hashemites were the Sharif and Emir of Mecca with rule over larger Hejaz, they were violently ousted from the control over the same by the rival Saud family. This military loss led to the loss of the symbolically vital title of the "Custodian of the Two Holy Mosques" to the Saud family, of modern-day Saudi Arabia. Hashemites were also to lose monarchial claim of rule on lands of Syria, Lebanon, Palestine and Iraq and were left with only the Jordanian swathes – which unlike other Arab lands was bereft of oil, natural resources, ports, or any other meaningful lever of power. They had to be creative in dealing with the situation and remaining relevant and protected. Geographical contiguity to Palestinian lands led to Jordan demonstrating fluctuating concern that oscillated from supporting the Palestinian cause to willynilly, acting against the same. During the Arab-Israeli War of 1948, Jordan occupied the West Bank and East Jerusalem (which it annexed in 1950), only to lose the same to Israel in the Six-Day War of 1967.

Historians often note the unique culture of "back channels" (facilitating clandestine meetings) between the Jordanians and Israelis that led to counterintuitive accommodations, even amid war. In the subsequent Arab-Israel War of 1973 (Yom Kippur War), Jordan had curiously avoided joining Arab ranks against Israel. Jordanian King Hussein had secretly flown to Tel Aviv to warn Israeli Prime Minister Golda Meir of the impending Arab plans to attack Israel. Ultimately when Jordan was norally forced to support the war



Practically, they engaged and operated as allies. Post the Hamas terror attack (7th Oct 2023) on Israel and the subsequent and disproportionate bludgeoning of the Gaza Strip, the Jordanians had no choice but to expel the Israeli ambassador to maintain face in the Arab world. However, as it was only Iran and its proxies like the Syrian Bashar Al Assad government and the Lebanese Hezbollah who were offering any meaningful resistance to the Israelis - then the Jordanians did the unthinkable in favour of the Israelis when they shot down Iranian drones attacking Israel. Practically, the Jordanians weighed in favour of the Israeli military (all perfunctory concerns towards the beleaguered

Palestinians, notwithstanding). Iordanians watched silently as Southern Lebanon was

attacked and as the Syrian

regime was overrun by forces

born out of Al Qaeda, ending

the last possible faction that

a long, Jordanian King Abdullah had warned against the spectre of a rising "Shia Crescent" (assertion of Shiite rule in Iran, Iraq, Syria and Lebanon).

He therefore would be presumably pleased to see the decimation of the sectarian rivals, which coincidentally also ended the last modicum of challenge to the Israelis.Beyond vacuous words, the practical conduct of the Jordanians has been suspiciously two-faced on the ostensible redlines as defined by King Abdullah i.e., "No to abandoning the guardianship of Jerusalem and the holy sites, no to the one-state solution, and no for Jordan to be an alternative homeland for the Palestinians".

The picture has perhaps never been further from the socalled Jordanian redlines, as now, the fate of Palestinians, Jerusalem, and the possibility of a two-state solution, is at its lowest. History will judge the conduct of Arab monarchies and their lip-serving commitment towards Palestine, but perhaps none as ambidextrously as the Jordanians, who often fancy themselves to be of the highest order. Despite the nation's economic progress, the persistent issues of undernutrition and micronutrient deficiencies continue to hinder India's overall growth and development, casting a shadow over its aspirations for a healthier future.

The 2023 Global Hunger Index paints a grim picture, with India ranked 111th out of 125 countries and a score of 28.7, indicating a "seri-

ous" hunger situation. Although there has been marginal improvement from a score of 29.2 in 2015, the pace of progress lags behind peer economies. Disturbingly, India records the world's highest rate of child wasting at 18.7 per cent, while 35.5 per cent of children under five are stunted. These figures highlight the long-term health and developmental implications of malnutrition.

Madam - Recently, Prime Minister Narendra Modi has laid the foundation stone of the Ken-Betwa river linking project, the first initiative under the national river linking policy, at Khajuraho in Madhya Pradesh. It is really a welcome step in solving the water crisis in India. Nearly 65 lakh people of Madhya Pradesh and Uttar Pradesh will get drinking water, and more than 7 lakh farmer families of 2000 villages will benefit from the project. Also, it has been proposed to generate 103 MW of hydropower. The project aims to transfer surplus water from the Ken River in Madhya Pradesh to Betwa in UP to irrigate the drought-prone Bundelkhand region.

Under the project, a 77 m high and 2.13 km long Daudhan dam and two tunnels will be constructed on the Ken River. Interlinking rivers can control both floods and droughts. This river linking project can have significant ecological consequences, can impact the biodiversity of the region, and can affect Panna Tiger Reserve too. Even then the project will create many employment opportunities as well as boost the rural economy. Ken-Betwa is the first river linking project under the National Perspective Plan (NPP) for the linking of rivers. The National Water Development Agency should identify a few more river linking projects to avoid floods and to cultivate more lands in drought-prone areas in India.

RBI sets up panel on ethical use of Artificial Intelligence

he Reserve Bank on Thursday announced the setting up of an eight-member committee to develop a framework for responsible and ethical enablement of artificial intelligence (FREE-AI) in the financial sector. Headed by IIT Bombay professor Pushpak Bhattacharyya (Department of Computer Science and Engineering), the panel will assess the current level of adoption of AI in financial services, globally as well as in India. It will also review regulatory and supervisory approaches on AI with focus on the financial sector globally. The panel will also identify potential risks associated with AI, if any, and recommend an evaluation, mitigation and monitoring framework and consequent compliance requirements for financial institutions, including banks, NBFCs, FinTechs, PSOs, etc. The committee will recommend a framework including governance aspects for responsible, ethical adoption of Al models / applications in the Indian financial sector, the RBI said.

Bone loss in women athletes

n athletes, osteoporosis is a common anomaly and is attributed to certain underlying factors or medical conditions that may contribute to both low bone mass and fertility issues in some cases. Hormones play a crucial role in both bone health and reproductive function. Hormonal imbalances lead to compensatory mechanisms that in turn increase the risk of bone fracture. Endurance athletes often experiences reduced food intake which results in reduced energy leading to decreased levels of sex hormones, which can cause physiologic changes that lead to relative osteoporosis despite the loading of the bone during exercise, which would normally increase bone mineral density. Inadequate intake of essential nutrients like calcium and vitamin D, which are crucial for bone health, is also a major contributor to low bone mass. Athletes may have higher nutritional needs due to increased energy expenditure

Where does anabolic steroids play a part in it?

Anabolic steroids, which are synthetic variations of the male sex hormone testosterone, can have both positive and negative effects on bone health, depending on various factors such as dosage, duration of use, and individual susceptibility. Androgen primarily stimulate bone forming osteoblastscausing an increase in bone formation through androgen receptors in bone tissue.

Consequences and other risk factors?

Anabolic steroids cause elevated Renal parameters. It also causes acute renal failure, focal segmental glomerulosclerosis and membranoproliferative glomerulonephritis. Anabolic steroids can cause hypertension and cardiac hypertrophy. These steroids also may adversely affect serum lipids and increase the coagulability of blood, which may leadto a high incidence of myocardial infarction (heart attack) due to spasms, coronary thrombus and coronary atherosclerosis. Lastly, the use of anabolic steroids has been indicated to develop dependency due to feelings of well-being leading to withdrawal symptoms such as depression and fatigue when they stop taking the same.

How can they manage it?

Nutrition counselling, exercise counselling and psychological therapy may all be necessary aspects of treatment. Athletes at risk for bone loss, such as those with a history of stress fractures or hormonal imbalances, may benefit from regular bone density monitoring. This can help identify potential issues early on.

To optimise bone health, adequate nutrition, appropriate weight-bearing exercise, strength training and adequateintake of calcium and vitamin D are necessary throughout life. Dairy products, leafy green vegetables and fortified foods aresome good sources of nutrition. In females, addressing the hypoestrogenic state by considering estrogen replacement has to have beneficial effects on bone mass. Maintain a healthy hormonal

balance through proper nutrition, adequate calorie intake and regular menstrual cycles. It is important to avoid the non-medical use of anabolic steroids, as they can disrupt hormonal balance and negatively impact bone health. For stress fractures with delayed healing adjunctive medications like nasal calcitonin, bisphosphonates and recombinant parathyroid hormone are used to address low Bone mineral density. For athletes engaging in high-impact activities, wearing proper footwear with shock absorption can help reduce the stress on bones and joints. Anabolic steroid abuse can be managed by psychological therapies, endocrine therapies, antidepressants, pharmacological and psychosocial treatments, and overall awareness.

Surge in pectoralis major muscle injuries linked to sports and steroids

Rupture of the pectoralis major muscle used to be a rare injury. But recently we have seen an increase in the same with the majority needing surgical intervention. It is stated that this increase in incidence can be attributed to the increased participation in competitive-contact sports and weightlifting training in combination with the use of anabolic steroids, which probably resulted in stiffer tendons with less collagen elongation, increased vascularisation and cellularity and associated microdamage of collagen fibers following repetitive loading stress.

Nutrition and mental well-being

Our eating habits have an impact on our mental well-being. According to the American Dietetic Association, depression or other mental health issues cause people to eat excessively or insufficiently. Eating too little can result in low energy levels. Low energy levels in the body can be harmful to both bones and the ability to perform long-term tasks. Energy is required for bone formation and remodeling. An athlete requires adequate energy levels to support optimal body functions, macronutrient and micronutrient intake and body composition maintenance. Women experience mood swings during menstruation or in the days leading up to menstruation, which are caused by hormonal fluctuations and can hurt a female's appetite control and eating behaviour. Athletes who eat too little or improperly may lose bone density. Athletes use the majority of their energy from eating to push their bodies through various exercises and activities. To maintain proper bone health, energy is required and some of the energy obtained from eating will be used for this purpose. Aside from menstruation, another factor contributing to improper eating is women's perception of maintaining a healthy body weight. Women who participate in sports that emphasise leanness, weight class, or endurance are more likely to eat too little. However, to maintain body weight, only a small proportion of food is required; thus, diet intake should be carefully planned so that, in addition to small proportions, it meets nutritional requirements. Foods high in vitamin D and calcium are essential for maintaining strong bones. A menstruating women athlete should ensure that she consumes enough vitamin D and calcium. Inadequate energy intake, due to eating disorderscan cause suppression of the normal hypothalamus pituitary axis leading to low bone mass and amenorrhea, commonly referred to as female athlete syndrome. Early detection and multimodality treatment with focus on nutrition is required to maintain the bone health of women Athletes and should be given priority by woman athlete coaches and health care providers as well as educating female athlete on early detection and correction should be given utmost importance.

Top order hepls Australia score 311/6, Bumrah keeps battle alive

asprit Bumrah's knack of coming up with magic deliveries in crunch situations kept India alive after Australia's top-order, headlined by teen debutant Sam Konstas' stroke-filled half-century, guided the hosts to 311 for 6 on the opening day of the fourth Test here on Thursday.

If Konstas' audacious 60 off 65 balls enthralled the near sell-out crowd of over 80,000 at the MCG during a humid morning session, Bumrah's (3/75 in 21 overs) deception of length to dismiss Travis Head (0) also had its takers as chants of 'Boom, Boom, Boooomraaaaaah' reverberated through the stands.

Coming into the Test with back-to-back hundreds, Head couldn't judge the length of a Bumrah delivery that was pitched slightly fuller than what the batter expected. He shouldered his arms trusting the bounce but the 66.2 overs old Kookaburra nipped back to clip the off-bail.

In the next over, he removed an out-of-form Mitchell Marsh (4), having got Usman Khawaja (57 off 121 balls)

with the half-tracker in the post-lunch session. The first two sessions,

however, belonged to Australia with senior players Khawaja, Marnus Khawaja, Marnus Labuschagne (72 off 145 balls) and Steve Smith (68 batting, 111 balls) scoring half-centuries.

The final session was all about Bumrah magic. The Indian spearhead didn't let the hosts completely walk away with the game which they threatened to do at one stage.

He now has 24 wickets in the series. With Mohammed Siraj (0/69 in 15 overs) off-colour, Bumrah didn't have much support save off-spinner support save off-spinner Washington Sundar (1/37 in 12 overs), who bowled a containing line. The duo added 89 runs in such quick time that Labuschagne and last match's centurion Smith didn't need to show any urgency. For Konstas, it all began with

a few play and misses off Bumrah's opening over but as soon as the teenager got his first couple of runs, things

changed dramatically. The fearlessness of youth stood out on the big stage as Konstas pulled off the lapscoop against Bumrah before smashing him over mid-on for another maximum. The fans and experts alike

were forced to think the last time Bumrah (1/50 in 15 overs) was hit for two sixes in his first spell of a Test match. They couldn't because it never happened in a first spell.

The stump mic caught Bumrah saying "Beginner's Luck" but Konstas seemed to have enough wares to answer his probing queries. And it was laced with a lot of spunk as he got into a verbal duel

with Kohli after their shoulders brushed while crossing each other. He often shuffled towards

leg-stump to make room and on one occasion, crunched Bumrah past cover.

Mohammed Siraj was welcomed into the attack with a loud round of boos as he sledged the youngster due to his unconventional hitting

stvle. In all, Konstas hit six fours apart from the two maximums. Only Akash bowled a good channel among the pacers as Siraj was guilty of going too full or too short.

As Australia scored at more than a fair clip, skipper Rohit Sharma had to introduce Ravindra Jadeja (1/33 in 11 overs) in the 16th over to at least stem the flow of runs before it went out of hand.

The decision did pay dividends as the seasoned spinner got an arm ball to skid through with the angle to trap Konstas in front.

Khawaja and Labuschagne then added 65 for the second wicket with the Pakistanborn opener hitting Akash for a couple of boundaries to complete his first fifty of the series.

Andy Pycroft completes 100 **Tests as match** referee

India needed Rohit variation at MCG, says Nayar on axing Gil

Tndia's assistant coach Abhishek Nayar on Thursday defended axing Shubman Gill from the Boxing Day Test, saying it was in team's best interest to not only have Rohit Sharma back to his usual opening slot but also add some sting to the attack by drafting in spin all-rounder Washington Sundar.

Gill, who missed the first Test due to a finger injury, scored 31 and 28 in the Pink Ball Test and looked the most assured among Indian batters. He, however, got out for a duck in Brisbane. With Rohit Sharma opening the innings and KL Rahul coming at No. 3, Gill had to make way for a third specialist all-rounder in Washington.

"Yes, Rohit will come up in the order and more likely than not, he will open the innings. That was the thought process. Unfortunately for Gill, just how things



spanned out, he had to miss out," Navar said at the end of the day's play.

"I just feel for a young player in a position like that, a big day, he wants to make his mark. He understands it's the team's requirement and it's unfortunate, but I wouldn't say that he's been dropped per se. It's just unfortunate that he couldn't find

his place in this game," the former Mumbai stalwart said but the explanation lacked conviction.

He elaborately explained why playing Washington at the MCG made sense ahead of Gill.

"A lot of the decisions when they are made, and the process of it being made, the communication is always there and transparency is there. It's pretty obvious that we felt in these conditions, looking at the pitch, having Washy in the bowling attack will give us that variation, especially towards the end once the ball gets old," he said

"Post the 50 overs, we felt that was an area that we wanted to get better at. We felt Washy could give us that solidarity with Jaddu (Ravindra Jadeja), especially the way Travis Head and Alex Carey were getting runs lower down. So we felt having an offie in the ranks will provide us with that."

"Pycroft, who has also officiated in 238 men's ODIs, 174 men's T20Is and 21 women's T20Is since 2009, said he has enjoyed every minute of the journey to 100 matches as a match referee,' the ICC said on its website.

Pycroft said touching the mark is a great honour and he is thankful to have been afforded the opportunity to officiate all over the world, "embracing different cultures."

"It has been a rewarding journey and I have treasured every moment of it," he added.

Virat Kohli fined 20 per cent match fees for altercation with Sam Konstas

 $V_{\text{voungetor }}^{\text{irat Kohli}}$ and Australian youngster Sam Konstas were on Thursday involved in a physical altercation because of which the Indian superstar was fined 20 per cent of his match fee and handed a demerit point even though it was played down as an accidental bump by the 19-yearold debutant.

The brief showdown took place after the 10th over of the Australian innings on the opening day of the fourth Test here when the players were crossing over. Kohli and Konstas bumped shoulders while moving across the pitch in the face off that was initiated by the travelling star.

Kohli was eventually charged with breaching Level 1 of the ICC Code of Conduct by on-field umpires Joel Wilson and Michael Gough, third umpire Sharfuddoula Ibne Shahid and fourth umpire Shawn Craig.

He accepted the sanctions proposed by match referee Andy Pycroft at the end of day's play.

"Virat Kohli has been fined 20

percent of his match fee and awarded one demerit point for breaching Level 1 of the ICC Code of Conduct," the ICC said in a statement.

"No formal hearing was needed as Kohli accepted the sanctions proposed by Match Referee Andy Pycroft," it added.

After the physical contact, both players quickly turned around to glance at each other and engage in a heated exchange of words before

Konstas' teammate Usman Khawaja stepped in to separate them. The on-field umpires also had a word with the two and things cooled down rather quickly.

Speaking to reporters after stumps, Konstas said Kohli bumped into him but it wasn't deliberate.

"I was just doing my gloves and I think he accidentally bumped me. I think that's just cricket and can happen with tension," said the teenager.

"I think the emotions got to both of us," Konstas had told 'Channel during the second session. The ICC's Code of Conduct states



that "any form of inappropriate physical contact is prohibited in Without limitation, cricket. players will breach this regulation if they deliberately, recklessly

and/or negligently walk or run into or shoulder another player or umpire".

Kohli's match fee for the game was to be Rs 15 lakh but that amount

would be reduced to Rs 12 lakh owing to the fine. This is the first demerit point that Kohli has logged since 2019. Four demerit points over a period of two years

lead to a suspension of one Test. Konstas, who was batting on 27 at the time, went on to hit Jasprit Bumrah for two boundaries and a six in the next over. The teenager scored a stunning fifty on debut before Ravindra Jadeja trapped him leg before wicket.

Nayar, who addressed the media in the end-of-day press conference, also brushed aside the

"When you play a game, there will be emotions but it is not as big as it seems. I wasn't aware of what happened and don't know what was said," he said in response to queries.

Kohli criticised for his actions Konstas might have dismissed it as routine but former Australian skipper Ricky Ponting blamed Kohli for instigating the exchange. He went to the extent of saying that Kohli could face disciplinary action for it.

"Have a look where Virat walks. Virat's walked one whole pitch over to his right and instigated that confrontation. No doubt in my mind whatsoever," Ponting

said on Channel 7 while watching the replay of the incident.

"I have no doubt that the umpires and the referee will have a good look at that. Fielders should be nowhere near the batsman at that stage.

"It looked to me that Konstas India assistant coach Abhishek looked up really late, wouldn't even know anyone is in front of him. That man on-screen there (Kohli) might have a few questions to answer," Ponting added.

> Former India head coach Ravi Shastri, who was at the helm during Kohli's captaincy, said the run-in was unnecessary.

> There is a line and you don't want to overstep that line. That's unnecessary, totally unnecessary. You don't want to see that. You know Virat is a senior player, he has been captain of the side," he said on 'Fox Sports'.

"He will have his own explanations for this but it's something you don't want to see. One person who would be watching, his eyes locked into the proceedings is Andy Pycroft," he added.
