BLUE SKY, BRIGHT SUN, GRAP IV REVOKED

The Supreme Court on Thursday relaxed curbs in Delhi-NCR under the Graded Response Action Plan (GRAP) stage III and IV measures imposed in Delhi following the improved Air Quality Index (AQI). The SC advised the CAQM to also consider adding certain measures under GRAP-Stage III. If the AQI crosses 350, GRAP-III should be imposed and if it crosses 400, GRAP-IV must be imposed, the SC said. Following this, the Commission for Air Quality Management (CAQM) revoked restrictions under Stage-III and Stage IV of GRAP in the entire NCR, with immediate effect. The restrictions have been reduced to Stage 2 of the GRAP which involves less stringent curbs such as a ban on the use of coal and firewood in industries and commercial establishments, including eateries.

This means people using BS-3 petrol and BS-4 diesel vehicles can ply their on the road in the National Capital region. Under GRAP III and IV, diesel-powered medium and heavy goods vehicles (BS-IV or lower) are prohibited, except for essential services while non-essential light commercial vehicles from outside Delhi were also restricted under GRAP stages 3 and 4. All construction and demolition activities, including public infrastructure projects like highways, flyovers, and pipelines, were also banned.

The overall Air Quality Index (AQI) recorded in Delhi was 165, categorised as 'moderate' , the cleanest air day of

December so far. The improvement began on Wednesday afternoon, with AQI levels falling from 211 in the morning to 178 by the evening. Of the 38 monitoring stations that recorded air quality data, only six stations reported levels in the poor category. It marks a significant improvement as on Tuesday, the AQI was recorded in the "poor" category with a reading of 268, compared to 280 on Monday and 285 on Sunday. For the month of

December, the city has not seen such clean air since December 14, 2022, when the AQI was 163. Under GRAP-II, the

restriction will continue which include ban on diesel generators across all sectors,

commercial, and residential areas, increased mechanical or vacuum sweeping and water sprinkling on identified roads, especially in high-traffic areas and pollution hotspots, use of dust suppressants every alternate day during non-peak hours, along with proper disposal of collected dust, intensified inspections at construction and demolition sites to enforce dust control measures and specific actions to focus pollution hotspots throughout the city.

Earlier, a Bench of Justices Abhay S Oka and Augustine George Masih allowed the authorities to go down from Stage IV of Graded Response Action Plan (GRAP) to Stage II. However, the Court also asked the CAQM to put in place additional measures from Stage III. "We have perused the figures of AQI from Nov 18- Dec 4. Up to Nov 30, it was consistently above 300 and it is only during last four days that the levels came down below 300. It is true that at some stage the court will have to leave to the Commission to decide about GRAP applicability. Considering the data placed before us, we do not think that it will be appropriate at

this stage to allow the Commission to go below Stage-II," the SC said. The SC further clarified that when the Air Quality Index (AQI) goes above 350, Stage III will have to be immediately implemented as

In a record of sorts, Ajit Pawar (65), an eight-time MLA from Baramati, has become the Dy. CM for the sixth term.

Given that the three constituents of the MahaYuti, BJP, Eknath Shinde-led Shiv Sena and Ajit Pawar-led NCP, have not yet formalised the nitty-gritties of the new government, the oath-taking

Pricy tomatoes, add sharp bite to veg thali rates

Avegetarian thali's price increased seven per cent, to Rs 32.7, primarily due to a 35 per cent jump in tomato prices to Rs 53 per kg and 50 per cent increase in potato at Rs 37 per kg. A non-vegetarian thali cost inched up 2 per cent to Rs 61.5 in November due to a three per cent increase in the cost of broilers, which have a 50 per weightage computation. A veg thali comprises roti, vegetables, onion, tomato and potato, along with rice, dal, curd and salad. A non-veg thali has the same elements except for dal, which is replaced by broiler chicken. According to a CRISIL Roti Rice Rate (RRR) report for November, the price of potato increased 50 per cent on-year on a low base to Rs 37 per kg from Rs 25 per kg in November 2023 due to a 20 per cent on-year decline in arrivals amid low yield following late blight infestation in Punjab, Uttar Pradesh and Gujarat. Price of tomato increased 35 per cent on-year to Rs 53 per kg from Rs 40 per kg in November 2023.

Additionally, prices of pulses rose 10 per cent, it said, adding that they will decline with fresh arrivals in December, while import duty hike led to a 13 per cent increase in vegetable oil prices.Prices are expected to dip once fresh arrivals begin in December. "Adding to the cost, vegetable oil prices rose 13 per cent on-year due to import duty hike, coupled with the festive and wedding season demand," Crisil

IndiGo Airlines crashlands as one of the worst ranked: report

Tndia's largest air transporter, IndiGo Airlines, has fared poorly in an annual ranking of international airlines and airports released by AirHelp. As per the reports based on air users feedback. Indigo has been ranked at 103rd out of 109 airlines, making it one of the worst performers. Sooner the rankings surfaced the airliner faced a heavy backlash on social media with netizens reminiscing about their experiences with many of them cast aspersions on behaviour of crew and ground staff as well questioning the quality of meals served on board.

Tata's Air India fares slightly better, standing at 61st with a 4.1/10 score for claim handling. At the top of the list, Brussels Airlines has been named the best airline, followed by Qatar Airways. India's largest domestic carrier, rated 4.80/10. The low rating is attributed to underwhelming customer satisfaction and poor handling of flight disruption claims.

The rankings for airlines are based on three criteria, on-time performance, customer opinion, and processing of compensation claims. According to AirHelp, the three criteria contribute to the airline's score in equal measure, or 33.33 per cent each. The analysis covers data from January to October, incorporating on-time performance, customer claims processing, and feedback from passengers across 54 countries on food, comfort, and service.

The report analyses key performance indicators



including flight punctuality, customer service responsiveness, and claim resolution efficiency. Researchers collected data on how airlines handle flight disruptions, manage compensation claims, and deliver consistent service across international routes. The analysis considers not just operational efficiency, but also the human experience of air travel, including factors like crew service quality, meal offerings, and passenger comfort.
Responding to the ranking, IndiGo criticised

the methodology, saying the survey does not disclose the sample size from India, "casting doubt on the survey's credibility." In its statement, IndiGo pointed out that the survey did not disclose the sample size from India or consider the methodology and compensation guidelines followed by the global aviation industry, "casting a doubt on its credibility". The airline emphasised its strong track record, noting that it consistently scores high on punctuality and has the lowest customer complaint ratio among airlines of similar size and operational scale.

People neither have respect nor fear of the law: Gadkari

Union Transport Minister Nitin Gadkari on Thursday said despite the Government's continuous efforts to reduce deaths in road accidents, the casualties have been on the rise as people neither have respect nor fear of the law. Responding during Question Hour in the Lok Sabha, Gadkari said he himself has been a victim of a road accident and is sensitive about the issue.

The minister said there are four factors which can help reduce road accidents, road engineering, automobile engineering, enforcement of law and education of people. "Biggest problem of the society is neither they have respect for the law, nor they have fear of law. There are problems like people don't stop on red signal, don't wear helmets... 30,000 people die only because they aren't wearing helmets. I have been a victim myself, my leg has been broken at four places in an accident when I was Leader of Opposition in Maharashtra and I am

"I have no hesitation in accepting this but distressed that despite trying hard there have been 1.68 lakh road accident deaths this year. A large number of these deaths are because there has not been strict implementation of rule

of roads... Without cooperation from public representatives, media or society, this is not possible. We have increased fines too but people don't follow rules," he said. Gadkari said a car jumped the traffic signal in front of him on Wednesdav.

The Minister urged the Speaker to keep a separate discussion on this issue and asserted that the government is committed to improving the situation.

"The problem also is that there are some black spots and the government has already decided to spend 40,000 crores on blackspots. As per mistakes identified in the detailed project report, blackspots are there, and we are very much committed for that," he said.

Replying to another question, the minister said four contractors have been held

responsible for deficiencies detected in the construction Delhi-Mumbai the Expressway and strict action will be taken against them. After taking note of the matter, experts from IIT Kharagpur and Gandhinagar inspected the expressway and found deficiencies in its construction.

We have issued notices to four contractors and will blacklist them. Strict action will be taken. Action will also be taken against concerned officials," the transport minister said during Question Hour in the Lok Sabha. "After noting deficiencies, we had roped in experts from IIT Kharagpur and IIT Gandhinagar. Initial findings of the report show there are deficiencies in construction," Gadkari said. He said the Delhi-Mumbai Expressway is the country's longest such road and was constructed in the shortest time. "The expressway was constructed at a cost of Rs 1 lakh crore. It has reduced the distance between Delhi and Mumbai by 200 km. The travel time between the two cities has now reduced to 12

Chori chori chupke chupke... cable theft delays Metro ops

 $T_{\text{commuters were in for a rough ride on Thursday}}^{\text{housands of Delhi Metro}}$ morning when services on the busy Blue Line came to a standstill, due to the theft of 150 metres of signalling cable between Moti Nagar and Kirti Nagar stations. For nearly six hours, the Blue Line, an arterial route that connects Dwarka to Vaishali and Noida City Centre, witnessed frustration, delays, and overcrowded platforms, throwing off schedules for office-goers and passengers alike.

As commuters scrambled to adjust, the theft sparked a wave of reactions, including a sharp critique from former Delhi Chief Minister Arvind Kejriwal, who questioned the city's safety under the Union Home Ministry's watch. "Nothing is safe in the national capital. Amit Shah ji, what is happening in Delhi? The cable of the Delhi Metro **Continued on page 8** has been stolen. Nothing is



safe," he said. At 8 am, the Delhi Metro Rail (DMRC) Corporation informed commuters about the incident and later updated that normal services had resumed from 1.38 pm. The line services key areas such as Raiiv Chowk, Yamuna Bank, Mayur Vihar Phase 1, Noida Sector 16, and Noida Sector 18, where many offices are located. With the delay coinciding with morning office hours, passengers faced inconvenience, particularly those commuting to work in

areas served by the Blue Line. In a statement, the Delhi Metro said that 20 maintenance personnel restored the vital section of the Blue Line in a record time of 30 minutes. "A specialised team of 20 personnel was formed and deployed at the affected area at 1 pm to carry out the repair work. A total of 140 metres of cable had been damaged, and these personnel executed the restoration work in a record time of just over 30 minutes. Eventually, normal services

were restored on the Blue Line at 1.38 pm," DMRC's Principal Executive Director Anuj Dayal said. Initially, a decision had been

made to carry out the repair work at night after the end of passenger services. However, considering the convenience of passengers, particularly during the evening peak hours, a quick decision was taken to attempt the restoration during the afternoon non-peak hours, Dayal said.

While the repair work was being carried out on the up line (towards Dwarka), train services continued on the down line, ensuring both directions of travel were operational, he explained. Earlier, the DMRC had stated

that train services on the Blue Line were regulated from the morning due to what appeared to be a case of theft and damage to the signalling cables by miscreants between Safety and Moti Nagar and Kirti Nagar

Doodh mein kitna paani: Court takes four years to deliver verdict

In a rare development, the Additional Chief Judicial Magistrate-I has delivered judgments in four-decades-old cases of food adulteration involving low-fat content in milk and substandard sugar. The verdicts, pronounced in the last week of November, imposed fines and symbolic imprisonment on the accused, marking the conclusion of cases filed under the Prevention of Food Adulteration Act, 1954 (PFA Act 1954). Moti Lal, a milk vendor from

Allunagar Diguriya, was penalised 42 years after being found guilty of selling milk with fat content below the permissible standard. On October 24, 1982, the Food Drug Administration (FSDA)
collected a sample of milk
from him, which failed the fat



content test. The court fined him Rs 3,000 and sentenced him to remain in court custody until the court Similarly, Ram Lal, a milk

adjourned for the day. vendor from Indiranagar, was found guilty of selling adulterated milk with 30% less fat. His sample was taken by the FSDA on June 22, 1988, at Wireless Square. The court imposed

punishment on him as Moti Lal. In a third case, Keshav, the owner of a dairy in

Semrapreetpur, Gosainganj, was also convicted for milk adulteration. A sample collected from his dairy revealed 22% less fat than the prescribed standard. He was fined Rs 3,000 and given a similar symbolic sentence. Reacting to the verdict, an FSDA official said, "This judgment, though delayed, reiterates the importance of food safety laws. Adulteration in essential commodities like milk affects the health of countless individuals, especially children."

The court also resolved a 21year-old case involving adulterated sugar. On September 8, 2003, FSDA officials collected a sample from the shop of Suresh Chandra Gupta, a resident of Bakshi Ka Talab (BKT).

Duped of ₹8 cr by company, investors left in the lurch

Acompany has allegedly duped investors of Rs 7-8 crore under the pretext of high returns on their deposits. Left in the lurch, investors are

now visiting local police stations in a desperate attempt to recover their hard-earned money.

Complaints have been filed against the company in the Bakshi Ka Talaab and Nigohan police stations. The company operated by setting up an office in a village, where it lured people with the dream of

becoming wealthy.
Using actors to endorse the business, the company appointed agents in every village to convince people to invest large sums, often in the range of lakhs of rupees.

Rajkaran Rawat, the former manager of the company, alleged, "I worked with the company for seven years. Initially, all transactions were processed smoothly. However, in December 2022, it became evident that the company was operating dishonestly. Depositors and agents were being defrauded. When I raised objections, I was removed from my position." The company, owned by one Sameer, had its head office in Navi Mumbai, but no FIR has been filed against him yet. Complaints have been lodged against the managers.

The company promoted its fraudulent schemes by travelling with a mobile van through villages, making false promises of high returns.

One major allegation is that the company fraudulently changed the ID details of Rajkaran and his wife.

"Their employee codes were altered without our knowl-

Woman, son arrested for currency exchange fraud

Lucknow (PNS): A woman and her son were arrested for allegedly duping shopkeepers by luring them with foreign currency (Dirham) at discounted rates.

The mother-son duo allegedly carried out their fraudulent operations while staying in a rented house in the city.
DCP (Central) Raveena Tyagi stated that the suspects would deceive victims by promising to sell foreign currency at half its market price. They would then take money from shopkeep-

ers and hand them bundles containing real dirhams on the top and bottom, with waste paper in the middle.

The police are investigating the involvement of other gang members, if any. The DCP further revealed that Aslam (24) and his mother Farzana Begum aka Kajal Sheikh (44), originally from Bengal, were arrested by the Central Zone and Madehganj police teams.

They were living in a rented house in Nishatganj, but had previously resided in East Delhi.

In one incident on November 28, the duo took Rs 3 lakh from Abul Hasan, a businessman from Aliganj, in exchange for a bag that contained only 700 dirhams. On November 21, they also swindled Prem Prakash Saxena, a resident of Naubasta Khurd, out of Rs 30,000.

A youth allegedly set fire to a girl's home on Rae Bareli Road, in the PGI police station area, on Wednesday evening after she rejected his marriage proposal. The fire, which spread to the bedroom, destroyed two motorcycles, a scooter, four bicycles, and several other household items.

With the help of neighbours, the girl's family managed to bring the flames under control before filing a complaint at the PGI police station.

According to the girl's father, the accused, a local resident, had been harassing his daughter for several days. Last week, the 20-year-old

accused had allegedly caught the girl by her hand while she was walking on the street, but passersby intervened and forced him to let go.
In retaliation for the rejection,

the accused set fire to an outdoor cooler and a window, which caused the curtains in the house to burn, the girl's father alleged in the police

The girl's family confronted the

accused's mother the next day. She apologised and assured them that her son would not repeat his actions.

However, the harassment continued, with the accused stalking the teenager whenever she went outside and threatening to ruin her life if she refused his

marriage proposal.
On Wednesday, the situation escalated when the accused allegedly set fire to the family's vehicles parked outside and damaged the front door of their home.

SHO, PGI police station, Ravi Shankar Tripathi confirmed that an FIR had been registered and an investigation had begun based on the complaint. The local outpost in-charge has been assigned to probe the matter further.

Meanwhile, a probe was ordered into the death of a youth who allegedly hanged himself to death immediately after returning from a police the Thakurganj police station late on Tuesday night.

His family members alleged that he felt humiliated after he was kept in the police station for two days in connection with buying a stolen mobile and he took the drastic step as a result. As per reports, the victim identified as Ranieet Kanauiia, a resident of Hari Nagar in Thakurganj, worked as a labourer.

Ranjeet's brother alleged that the victim went to work on November 29 and returned on December 1.

"He looked very upset after he returned home. But he did not share anything with us," he said, adding: "After a lot of pressure, Ranjeet told our mother that he had bought a mobile from a friend and it turned out to be a stolen one. As soon as the SIM was activated, the police caught him. He was kept at police station for two days and released after questioning," Ranjeet's brother claimed.

On Tuesday night, his mother was cooking food at home and other family members had gone to a wedding ceremony. Ranjeet allegedly hanged himself in the meantime. He was rushed to hospital where he was pronounced dead.

A police spokesman said that investigations into the case are ongoing.

Narrow escape for 3 schoolchildren in road mishap

Lucknow (PNS): Three schoolchildren sustained minor injuries in a road accident in Bhav Kheda village under Mohanlalganj police station on Thursday morning.

The accident occurred when a speeding mini truck hit an autorickshaw, which rammed into an SUV parked ahead. The children, who were sitting

in the auto, sustained minor injuries in the incident. Villagers caught the driver and alerted police. The police reached the scene, took the driver into custody, and seized the mini truck.

LU study uncovers surging glacier in central Himalayas

University has revealed the secrets of a surging glacier in the central Himalayas. While many glaciers around the world are retreating due to climate change, scientists have discovered a glacier in the central Himalayas that has surged. The study focuses on an area between latitude N 30.985 and

longitude E 79.642, covering 48 sa km near the Line of Actual Control (LAC) between India and Tibet. The unnamed glacier, located

about 1 km north of the Raykana Glacier in Niti Valley, Uttarakhand, is the subject of this discovery.
The research, led by Dr Vinit

Kumar, associate professor at the University of Lucknow's Department of Geology and Scientist-D at the Wadia Institute of Himalayan Geology (WIHG) in Dehradun, also includes contributions from

Dr Manish Mehta, Dr Gautam Rawat, and PhD student Ajay Singh Rana.

The findings, published in the renowned journal Environmental Science and Pollution Research by Springer Nature, reveal that this previously unknown glacier experienced a significant surge between 1993 and 2022.

Researchers analysed satellite data to study the glacier's rapid advance and retreat, offering new insights into the dynamic nature of Himalayan glaciers and their potential impact on regional water resources.

"This is the first study from the Indian Himalayas to report a glacier surge in the central region, traditionally observed in the Karakoram and Pamir ranges," Dr Kumar said.

"This suggests that the glacier regime is complex and warrants further research into the effects of climate change and how glaciers respond to warming temperatures," he added.

The study also emphasises the importance of continuous monitoring of the glacier's behaviour, as well as the potential risks of hazardous icedammed lakes formed by surging glaciers. These findings are crucial for better development planning in the area as climate change continues to affect these fragile ecosystems.

Winter session of **UP** Assembly from Dec 16

The winter session of Uttar Pradesh Assembly will commence here from December 16. This will be the third session of the Uttar Pradesh Assembly in 2024. The notification for the winter session was issued by the Uttar Pradesh Assembly secretariat

The session is likely to be brief and have four or five sittings. The session is likely to be stormy as the opposition is likely to corner the Yogi Adityanath government, particularly on the Sambhal issue where the violence broke out on November 24 over a court mandated survey of a

mosque. A formal programme of the session is yet to be announced. The agenda and number of sittings of the House will be finalised by the Business Advisory Committee of the assembly. The committee will meet a day ahead of the commencement of the session on December 16. Official sources, however, said the government was likely to table a supplementary budget for the current fiscal 2024-25. The government had sought supplementary grants of Rs 12,909 crore during the second

session of the assembly in July earlier this year. The possibility of yet another supplementary budget comes amid indications that the state government may make an additional budgetary provision for the upcoming Maha Kumbh in Prayagraj. The Yogi Adityanath govern-

ment also seeks to give additional push to its developmental programmes after Bharatiya Janata Party's recent win in the high stakes bypolls in which the saffron outfit won seven out of nine Assembly seats.

Besides the bill for replacing an ordinance promulgated when the Assembly was not in session, the government is also likely to introduce the Uttar Pradesh Nazul Land (Amendment) Bill during the winter session. The bill was introduced and passed by the Assembly in August last. The bill was passed despite the protest by the ruling Bharatiya Janata Party MLAs.

The government, however, developed second thoughts and the bill was tabled in the Uttar Pradesh Legislative Council and referred to the select committee of the House. Official sources, however, indicated that the report on the bill is yet to be finalised by the committee.

'Nature of Ayodhya, Sambhal & Bangladesh events same'

Uttar Pradesh Chief Minister Yogi Adityanath on Thursday accused the opposition of trying to create divide in society, saying the actions of Mughalera ruler Babur's commander in Ayodhya and Sambhal 500 years ago, and the events happening in Bangladesh today, share the same nature and intent. The opposition shot back alleging Yogi Adityanath was indulging in "divisive politics" and peddling "false narratives".

The chief minister, who was in the temple town for the inauguration of the 43rd Ramayan Mela, said Lord Ram had united the whole society and cautioned people against dismissing these issues as distant or irrelevant.

"Had we given importance to unity and not let the strategy of nation's enemies succeed in creating social animosity, this country would have never become a slave. Our pilgrimages would not have

would not have dared to invade us and would be crushed by India's brave soldiers," Yogi Adityanath said.

"But those creating obstacles within the society were able to succeed. Their genes remain the same even today. Those who indulge in caste-based politics to shatter the social fabric are still active," the chief minister said. "Look at the kind of acts our enemies

in neighbouring countries are committing. Remember this, if anyone is under any illusion. Five hundred years ago, a general of Babur committed certain deeds in Ayodhya, similar acts in Sambhal, and what is happening today in Bangladesh -- the nature and DNA of all three are the same," he added. Asked to comment on Yogi Adityanath's

remarks, Congress MP Tariq Anwar said his language doesn't behove a chief min-

"It is surprising and saddening that being a big leader of the BJP and the chief minister of a large state like Uttar been desecrated. A handful of invaders Pradesh, he uses such language which

First get your DNA checked: Akhilesh to Yogi Adityanath

in Sambhal ahead of December 6

Sambhal (PTI): Sambhal administration said it will put up posters of those involved in the November 24 violence, while police beefed up security in the district on Thursday, a day before December 6 - the day Babri mosque in Ayodhya was demolished by the Hindu right in 1992.

Police also estimated the arson and vandalism damage in the Sambhal violence to be worth more than Rs 1 crore.

"We will put up posters of those involved in Sambhal violence ... in all likelihood today," District Magistrate Rajender Pensiya told PTI. He said the authorities have identified more than 400 people in connection with the violence that broke out last month over a local mosque survey. "There is a peace committee meeting at 3 pm and we will discuss the situation with everyone," he said.

'We are currently designing it (poster). It will be finalised today. 400 people have been identified. Posters will be put up after excluding those who have been arrested," he said. Superintendent of Police (SP) Krishna Kumar Bishnoi said efforts are on to nab the

remaining accused.
"So far, 34 people have been arrested, and efforts to apprehend others are ongoing. Names of 83 individuals have emerged, and 400 photographs have been collected. A unique identification process is being carried out," he said.

On the damages, Bishnoi said, "Damages exceeding Rs 1 crore have been reported so far. This includes burnt transformers, broken cameras, and vehicles set on fire. Recovery will be made from the rioters once they are identified, and chargesheets will be filed against them."

He directed the officers of the Public Works Department (PWD) to complete the work of all its six roads in progress in the city by December 31 at any cost. With the cooperation of the Transport department,

In a bid to resolve various issues being faced by the city entrepreneurs with different departments, Divisional Commissioner Amit Gupta chaired a meeting with them on Wednesday. In this Divisional Udyog Bandhu meeting, the issue relating to the activation of the common effluent treatment plant (CETP) installed at Jainpur Growth Centre was raised. For this, it was decided to form a SPV for implementing the minutes of National Mission for Clean Ganga (NMCG). The commissioner directed the deputy general manager of UPSIDA and the deputy commissioner of industries, Kanpur Dehat, to soon hold a meeting with the entrepreneurs to complete the formation of SPV. Expressing concern over laying of a sewer line in Panki industrial area, the DC directed the deputy general manager of UPSIDA to identify land within two weeks and inform the Uttar Pradesh Jal Nigam for the construction of inlet pumping station (IPS) and sewage treatment plant (STP). The chief engineer of Dakshinanchal Vidyut Vitran Nigam Limited informed that the land had been acquired for setting up of an electrical feeder in Bhaunti-Bhimsen area and the substation will be completed within the

next six months. The DC directed the Irrigation department officials to immediately remove encroachment on the roads on both sides of the canal as an alternative route for the movement of entrepreneurs and employees in the Dada Nagar and the Panki Industrial areas. It was informed that the boundary wall constructed by the municipal corporation in the green belt along the road from LML intersection to Bhaunti bypass was getting damaged due to parking. The DC directed the municipal corporation ensure repair of the damaged boundary wall immediately to prevent illegal parking in the green belt. Entrepreneurs also informed that the battery waste (separator) collected and burnt along the canal in the industrial areas was causing severe air pollution and health issues. On this, the regional officer of the Pollution Control Board informed the divisional commissioner that such waste was being disposed of by Ramky Infrastructure.

Countries must observe humanitarian laws: Jaishankar

ountries have right to Crespond to situations but they should be mindful of civilian casualties and must observe humanitarian laws, External Affairs Minister S Jaishankar said in the Rajya Sabha on Thursday.

Responding to supplementaries during the Question Hour regarding India's position on the ongoing conflict between Israel and Palestine, he said, "We condemn terrorism, we condemn hostagetaking. We do believe countries have the right to respond to the situation but countries should be mindful of civilian casualties. They must observe humanitarian law and we would like a ceasefire and an early end of violence."

When asked the reason for India's abstention from a resolution in the UN General Assembly on October 27, 2023, regarding the protection of civilians and upholding legal and humanitarian obligations, Jaishankar said there were many resolutions in the UN General Assembly and in some India abstained and in some, it voted in favour.

According to him, there are several reasons to abstain such as a resolution is not balanced, it is more divisive, it can set a precedence which



it has larger implications. In this particular case, we felt that the resolution was not well-drafted and not wellconsidered. We had reservations on the language. Our concern was not accommodated. That is why we abstained," he said.

Responding to TMC MP Saket Gokhle, who asked about India's position on a ban imposed by the Israeli government on the UN aid agency UNRWA and how India is sending aid to Palestine, Jaishankar said the government has stood by its decision to send humanitarhas consequences for India or ian aid and it has just released

the latest tranche of support

to the UNRWA. He further asked that India always supported a two-state solution and in the UN, India abstained on a resolution against Israeli illegal settlement in the West Bank. What is India's position on the illegal settlement made by Israel in the West Bank in Palestine," Gokhale asked.

"Regarding the two-state solution, we supported the twostate solution. We have been public and unambiguous about that. There should be no cause for confusion regarding a two-state solution," Jaishankar answered.

He reiterated that the wording of resolutions is important for deciding to support them. Talking about the October 27, 2023 resolution, he said, There was no reference to terrorism. There was no reference to hostage-taking. In our mind if a resolution doesn't reflect the entirety of a situation, it is not a balanced resolution. A country like India which is itself a victim of terrorism, if we countenance the fact that terrorism is underplayed and ignored, it is not in our interest that we

do so (support).' When asked about India's position on the International

Court of Justice's warrant against Israel Prime Minister Benjamin Netanyahu, former Israel Defence Minister Yoav Gallant and a Hamas leader for war crimes, the minister said, "India is not a member of the International Criminal When Court.

International Criminal Court was constituted, the question of our membership was conof our membership was considered. For very good reason and after a great deal of deliberation, India decided not to become a member. With regard to any decision passed by the ICC, it is not binding on us."

Highlighting India's humanitarian assistance to Palestine, he said New Delhi has given assistance to people of Palestine at this particular time by making an annual contribution of USD 5 million to UNRWA the main assistance-providing agency.

"This amount traditionally used to be USD 1 Million. This government decided to raise it from USD 1 million to 5 million," he said. Jaishankar added that India has provided 70 metric tonnes of aid of which 16.5 was of medicine in

the central government have been directed, from time to time, to fill up the vacant posts in a time bound manner, Union Minister of State for Personnel Jitendra Singh told Rajya Sabha in a written He was responding to a ques-

tion seeking "details of the total number of vacancies in all central government ministries and departments to date, department-wise".

"Occurrence and filling up of vacant posts in various ministries/departments is a continuous process. The details of vacancies are maintained respective ministry/department," Singh

In response to another question, he said the contractual appointments in government departments are made by the individual ministries/departments strictly based on their requirements, in accordance with the provisions of General Financial Rules,

"Vacant posts have been filled up in mission mode, in Rozgar Melas launched by Hon'ble Prime Minister on 22nd October, 2022. 13 Rozgar Melas have been held at central level in 40-45 cities across various states/Union Territories," the minister said. In a separate reply to a question seeking details of the number of recruitment letters pertaining to the central gov- on contract basis and the



ernment handed over during Rozgar Melas, he said "several lakhs of appointment letters have been issued during the Rozgar Melas".

As part of Rozgar Mela, the vacant posts in central government ministries and various organizations of central government are being filled up in a mission mode, he

Details of various recruitments and vacancies, including category wise breakup are maintained by respective ministries/departments/central public sector undertakings (CPSUs) and the concerned recruitment agencies such as Union Public Service Commission (UPSC), Staff Selection Commission (SSC), Railway Recruitment Board (RRB), Institute of Banking Personnel Selection (IBPS) etc., Singh said.

Replying to another question, he said as many as 63 specialists have been appointed in different Central government departments through the lateral entry mode from 2019 to 2023. Of these, 35 were appointed

Rainfall brought by Western Disturbances mitigates northwest India's air pollution: Govt PIONEER NEWS SERVICE ■ **NEW DELHI**

Tn response to repeated **I** requests from the Delhi government, which had sought the Centre's assistance for artificial rainfall as a potential shortterm solution to improve the city's hazardous air quality, the Government informed Parliament on Thursday that rainfall brought by Western Disturbances in northwest India during the winter months already serves to mitigate the region's air pollution, thus eliminating the need for cloud

It also highlighted experts' concern over potential adverse effects of chemicals used in this

Replying to a question in the Rajya Sabha, Union Minister of State for Environment Kirti Vardhan Singh said his min-



istry received four letters from the Delhi government between August 30 and November 19, asking it to consider cloud seeding as an emergency measure to improve air quality in Delhi during winters.

The minister said expert opinions were sought from the India Meteorological Department (IMD), the Commission for Air Quality Management (CAQM) and the Central Pollution Control Board (CPCB) regarding the feasibility of cloud seeding for

artificial rainfall in the nation-

Citing the experts, Singh said, "Winter clouds in the region are primarily formed due to Western Disturbances (WD), which are short-lived and travel from west to east. When low clouds form due to WDs, they typically result in natural rainfall over northwest India, eliminating the need for cloud

The experts told the ministry that high-altitude clouds, which are typically at elevations above 5-6 km, cannot be seeded due to aircraft limitations.

"Furthermore, effective cloud seeding requires specific cloud conditions which are generally absent during Delhi's cold and dry winter months. Even if suitable clouds were present, the dry atmospheric layer beneath them could cause any developed precipitation to evaporate before reaching the

remain," the minister quoted the experts as saying. Last year too, the Delhi gov-

ernment considered using cloud seeding in collaboration with IIT-Kanpur to improve air quality during winter. The goal was to induce rain to wash away pollutants. However, the project got

delayed because it required permissions from several Central government agencies, including the aviation and environmental authorities.

Cloud seeding involves dispersing substances into the air to encourage condensation, resulting in precipitation. The most common substances used for cloud seeding include silver iodide, potassium iodide and dry ice (solid carbon dioxide). These agents provide the nuclei around which water vapour can condense, ultimately leading to the formation of rain or snow.

There is no proposal to increase the retirement age of Supreme Court and high court judges, the government told the Rajya Sabha on Thursday.

It also underlined that there is no mention of any "cooling off" period in the Constitution for post-retirement assignments for judges. Supreme Court judges retire at the age of 65, while High Court judges demit office at 62. District judges retire at the age

There is no such proposal for increasing the retirement age of judges of the Supreme Court and high courts," Law Minister Arjun Ram Meghwal said. The UPA 2 government had brought a constitutional



amendment bill in the Lok Sabha to bring the retirement age of HC judges on par with that of SC judges. But the bill lapsed as it was not taken up for consideration in the House. Asking a supplementary during Question Hour, AAP's Rajya Sabha MP Raghav Chaddha said judges have been given executive and political roles post-retirement. While some come to Rajya Sabha as members, others become governors after retire-

ment. He claimed that this

raises several questions in the minds of people. "It raises the question of conflict of interest. It raises questions about executive interference in the judicial process. Independence of the judiciary is questioned," Chaddha said.

The AAP MP said many committees have suggested and he also wants to know the government's view that there should be a cooling-off period. He said no judge should be given any political or executive role for at least two years after retirement.

They should also not be given any chairmanship of any committee, he added.

Korean crisis

President Yoon Suk Yeol briefly declared martial law, a move that ignited domestic outrage and international condemnation

brief martial law was imposed in South Korea, a country known to have a stable democracy and prosperity to vie for. The South Korean President Yoon Suk Yeol took this extreme step to preserve his position amid falling popularity. He faces the toughest challenge of his presidency after a controversial decision to impose martial law backfired spectacularly, plunging the nation into a deep political crisis. The fallout has sparked widespread protests, calls for his resignation, and even moves toward impeachment. Yoon declared martial law, citing national security concerns and the need to eliminate "anti-state elements." However, many viewed the measure as a desperate attempt to consolidate power amid mounting political and personal scandals. The backlash was immediate and severe, with lawmakers rushing to overturn the decree and protesters gathering en masse in the streets of Seoul. Within hours, Yoon revoked the order, but the reversal failed to quell public anger.



The damage was done. Yoon's presidency, which began with a narrow 2022 election victory, has been riddled with controversy. His platform, focused on gender neutrality and hawkish stances on North Korea, initially appealed to younger male voters. However, a series of missteps and scandals—ranging from allegations of corruption involving First Lady Kim Keon Hee to tensions with the opposition-controlled National Assembly have steadily eroded his approval ratings. The Democratic Party's landslide win in April's parliamentary elections further isolated Yoon politically. With an emboldened opposition, efforts to impeach

key government officials linked to Yoon's administration gained momentum, leaving the president with limited room to maneuver. The martial law declaration was a lastditch effort by a president grappling with dwindling support and mounting resistance within his own party. Indeed the move was a miscalculation, a desperate attempt which backfired miserably with significant political fallout. The incident has intensified efforts by the opposition to impeach Yoon, with some members of his party now openly calling for his resignation. Protesters have taken to the streets in unprecedented numbers, with labour unions threatening nationwide strikes unless Yoon steps down. The crisis has raised alarm among South Korea's allies, including the United States and Japan have expressed serious concerns. Their worst fear of course is that North Korea may exploit the internal chaos to escalate tensions with the South, further destabilising the region. For South Korea, this moment represents a critical test of its democratic resilience. The swift revocation of martial law suggests that institutional checks and balances remain robust. US-CHINA TRADE WAR HEATS UP

Trump set to amplify Biden's tough stance with tariffs and export controls

he loaded guns are out for the two largest economies of the world, the US and China, even before the original hard hitter Donald Trump takes charge as the new President in January next year. In one of his last "Containing China" measures outgoing President Joe Biden has imposed additional export controls on high-end chips, chip-making equipment to China, which can be used as components or in the manufacturing of weapons as well. The new restrictions also directly target some of the largest chipmakers in China, thus throwing in as many road blocks as possible in the dragon's aggressive weaponisation programme. Not, to be cowered China imposed retaliatory controls on the export of critical minerals such as Gallium, Antimony etc, which are essential components of the chips.

Even as these measures were being announced, President-elect Donald Trump has been threatening the 9 member BRICS nations with severe 100 per cent tariffs, in case, they choose to create an alternate global currency to the dollar. Mr Trump has already threatened Canada, Mexico and the EU with the tariffs scalpel unless they come back to him with offers that are hard to ignore. Trump's third favourite word is tariffs, which he uses as leverage to negotiate trade deals with allies and enemies.

The nations that have faced the latest threat of high tariffs from Donald Trump have already taken a cautionary approach to negotiating with the tough business person. Canada and Mexico have sounded out that would be more interested in sweetening the deal with the US under Trump, than confronting him on the tariff issues. China knows that Trump would be higher on optics, than his predecessor Joe Biden, on issues where the



US considers them as a direct threat. In one of the recently published editorials in the Chinese government mouthpiece Global Times, the Internet Society of China, the China Association of Automobile Manufacturers, the China Semiconductor Industry Association, and the China Association of Communications Enterprises are quoted to have issued statements terming US chips as unsafe and unreliable.

It further states "The US has used this measure to greatly expand its power, affecting many countries and regions, including Japan, the Netherlands, Israel, Malaysia, Singapore, South Korea, and China's Taiwan region. This will severely disrupt the stability of the global industrial and supply chains and undermine the international economic and trade order Incoming President Trump is likely to have a harder stance on export controls and, high tariffs for China imports. The incoming administration is likely to focus on high decibels, high optics, and control China measures than what the Joe Biden administration has achieved. It would be worthwhile to note, that some of the restrictive measures against China introduced, during Trump's first presidency, have only been upgraded and made tougher under President Joe Biden.

Therefore at some level, there is bipartisan support for containing China in the US government. India has been watching this space carefully and knows well that it cannot escape the US tariff cannon for too long. It is also well aware that, there is a trade surplus with the US, which means it exports more than imports. Incoming President Trump even though has good relations with Indian PM Modi, is hardly going to miss this infraction. Obviously, the only safe prediction is a degree of unpredictability. Different countries have had their own experiences from the first Administration and would presumably draw from that to approach the second. Naturally, between two major economies, there will always be some give and take. When we look at economic or technology domains, the case for trusted and reliable partnerships have actually increased in recent years. A lot of what lies ahead would be in fashioning terms of engagement that are perceived as mutually beneficial. "A careful recalibration of India's trade relations is on the anvil, not just with the US, but also with its other allies.

Charting Bharat's role in a multipolar world



Renowned Russian philosopher Aleksandr Gelyevich Dugin advocates for civilisational revival and the decolonisation of the mind



leksandr Gelyevich Dugin, the Russian philosopher, presents a compelling vision of a multipolar world that seeks to restore balance and harmony to international relations. His recent visit to India, during which he delivered an insightful speech at the Russian Centre in New Delhi on November 19, highlighted his ideas on the importance of civilisational revival. Listening to Dugin was a profound experience, as he articulated the need for great civilisations such as Bharat (India), Russia, and China to assume their rightful roles in shaping a new global order. Dugin's philosophy is deeply intertwined with the concept of State-Civilisation, which transcends the boundaries of the Nation-State model imposed by the Westphalian system. In this framework, civilisations are not merely political entities but repositories of spiritual, cultural, and historical identity.

For Dugin, Bharat exemplifies this notion

as it represents a civilisation rooted in ancient wisdom, from the teachings of the Vedas and Upanishads to its rich traditions of Dharmic philosophy. He argues that this heritage uniquely positions Bharat to lead a process of decolonisation—not just politically, but mentally and spiritually. Decolonisation of the mind, Dugin asserts, is essential for nations seeking to reclaim their civilisational sovereignty. Bharat's re-engagement with its Vedic and Upanishadic traditions is not merely an academic exercise but a means of reconnecting with eternal principles that transcend the temporal constructs of modernity. In his view, traditional spiritual processes should be revived as living, evolving frameworks that can guide contemporary governance and social organisation.

He draws a parallel with Russia's return to Orthodox Christianity, which he sees as a similar act of reclaiming spiritual identity in defiance of Western liberalism. The philosopher emphasises that the post-Cold War unipolar world order, dominated by Western hegemony, has exhausted itself. Dugin critiques the universalisation of liberal values, arguing that they are inherently tied to the Atlanticist worldview and therefore unfit to govern the plurality of human cultures. Liberalism, he contends, prioritises individualism and market ideology at the expense of collective, spiritual, and civilisa-

As he wrote in The Fourth Political Theory,

"Modernity is a project that has exhausted itself. The future lies in the revival of traditional societies, metaphysical truths, and spiritual values." For Dugin, multipolarity represents an alternative to this unipolar dominance, offering a framework for civilisations to engage with one another as equals.
This vision is rooted in dialogue rather than conflict, with each civil-

isation contributing its unique insights and values. Bharat, China, and Russia, he argues, form a natural triad that can anchor this new world order. He views these three civilisations as distinct yet complementary, with Bharat's Vedic traditions, China's Confucianism and BHARAT'S REtions, China's Confucianism and Taoism, and Russia's Orthodoxy providing diverse philosophical and spiritual foundations for a balanced with contemporary geopolitical realities, as platforms like BRICS demonstrate the potential for collaboration among major civilisational

TRADITIONS IS powers.
He sees BRICS not merely as an eco NOT MERELY AN nomic bloc but as a symbolic ACADEMIC embodiment of multipolarity—a round table where civilisations can EXERCISE BUT A cooperate without succumbing to Western hegemony. Drawing on the MEANS OF Arthurian legend, Dugin suggests RECONNECTING that the multipolar world should function as a round table, where all WITH ETERNAL participants, including the West, have an equal seat, provided they PRINCIPLES THAT relinquish hegemonic ambitions. TRANSCEND THE Bharats renaming from finding, in Dugin's view, exemplifies the philo-Bharat's renaming from India, in TEMPORAL sophical and cultural depth of this multipolar project.

CONSTRUCTS OF He perceives this act as a profound MODERNITY rejection of the colonial narrative imposed by Western powers. For Dugin, names carry immense metaphysical significance, and "Bharat" embodies a self-affirmed identity that reclaims the spiritual and cultural essence of the civilisation. This aligns with his broader advocacy for civilisations to transcend the artificial constructs of modernity and rediscover their historical and spiritual cores. The philosopher

also stresses the strategic importance of Eurasia in achieving this vision. He argues that the geographic, cultural, and economic ties between Bharat, China, and Russia make them natural allies in reshaping global power structures. By aligning their civilisational and strategic interests, these three powers can mediate international conflicts and create a more equitable world order. As Dugin writes in Foundations of Geopolitics, "Russia's mission is to unite the peoples and nations of Eurasia into a single geopolitical space that rejects Western domination and promotes a multipolar world." Central to Dugin's vision is the rejection of Western universal-

He critiques the West's attempt to impose its values globally, arguing that this approach erases the distinctiveness of other cultures and leads to alienation. In contrast, the multipolar world Dugin envisions celebrates diversity, recognising the plurality of human experience and thought Civilisations he asserts should engage in dialogue while preserving their unique identities. As he states in 'The Great War of Continents, "The salvation of humanity lies in preserving the plurality of cultures and civilisa-

This rejection of universalism extends to Dugin's critique of modernity, which he sees as a destructive force that undermines traditional values. He identifies a global trend toward the revival of traditionalism, noting that civilisations are increasingly turning to their spiritual roots in response to the moral and cultural relativism of liberalism. From Bharat's Vedic revival to Russia's Orthodox resurgence and China's embrace of Confucianism, Dugin sees a world-

wide movement toward reclaiming heritage. "The return to tradition," he writes, "is not an act of nostalgia but a necessity for survival in the face of cultural erosion."

Dugin views Bharat as a cornerstone of this traditionalist resurgence. Its ability to mediate tensions, whether between China and the Islamic world or within the broader multipolar framework, highlights its potential as a stabilising force. Bharat's emphasis on spiritual heritage and cultural unity, he argues, sets an example for other civilisations seeking to harmonise their internal diversity with their external roles. The path to a multipolar world is not without challenges. Dugin acknowledges that the West's resistance to relinquishing its dominance could lead to conflicts, even escalating to dangerous levels. However, he remains optimistic about the long-term prospects of multipolarity, which he sees as a natural evolution of global history. This optimism is grounded in his belief that civilizational revival offers a more stable and equitable alternative to the power struggles of unipo-

In Dugin's analysis, the future lies in the hands of civilisations willing to reclaim their spiritual and cultural identities. Bharat's role is pivotal in this transformation. By embracing its Vedic heritage and fostering partnerships with other great civilisations, Bharat can help shape a world that values harmony over domination. As Dugin wrote in The Fourth Political Theory, "The multipolar world is not a competition of powers but a symphony of civilisations, each contributing its melody to the greater harmony."

Dugin's vision challenges conventional paradigms of International Relations, offering a deeply philosophical and civilisational approach to global politics. By placing spirituality and tradition at the core of his analysis, he provides a framework for a world that celebrates diversity while striving for collective progress. Bharat's role in this vision is both profound and indispensable, symbolising the potential for civilisations to lead humanity toward a more balanced and equitable future.

 T^{he} Bharatiya Janata Party (BJP) and the Congress on Thursday engaged war of words in and out of Parliament over findings of a media report which had alleged links with a US based multi-billionaire regarding which the ruling party alleged that Opposition used baseless reports to tarnish the image of India.

Parliament witnessed uproarious scenes and adjournments after treasury benches alleged Congress led Opposition tried to derail proceedings following the reports which the Opposition vehemently denied. BJP said the Congress had sought to derail Parliament on various issues published by OCCRP, including the Pegasus spying row, questioning the efficacy of vaccines against COVID-19 developed in India and the Hindenburg reports.

While BJP claimed a link between Congress leader Rahul Gandhi and international forces, including an investigative media

platform, trying to destabilise India and that the Congress leader was a "traitor of the highest order", Congress wrote to LokS abha Speaker Om Birla Birla alleging BJP's conduct was a "clear violation" of the decorum and ethics expected of a Member of Parliament.

Rajya Sabha saw uproarious scenes when BJP MP Sudhanshu Trivedi alleged attacks by foreign forces on India's national interests and demanded a thorough probe besides asking all MPs to discuss the serious issue.

He cited examples of the Hindenburg report, Covid vac-cine report and one on Indian farmers, a BBC documentary, Pegasus issue and a video on violence against women in Manipur during the past three years. He also cited the recent report on the indictment of an Indian business house by a US attorney just ahead of the Winter Session.

Even after completing 50 days in the office, Chief Minister (CM) Omar Abdullah is caught in a catch-22 situation over restoring statehood to Jammu and Kashmir (J and K). After recording a historic victory in the Assembly polls, held after a gap of 10 long years, Omar started his second innings with a bang.

In his first cabinet meeting held two days after the oath taking ceremony, the government led by Omar Abdullah passed a resolution urging the National Democratic Alliance(NDA) led Centre to restore state-hood to J and K.

Omar also called on Prime Minister (PM) Narendra Modi and Union Minister of Home Affairs Amit Shah with a categoric demand to restore 'statehood' to J and K.

Subsequently, the J and K Legislative Assembly also passed a motion in support of granting special status to the former state.

So far the Union government has not moved an inch.

On Thursday, Abdullah reiterated his stand on the issue and maintained that he will discuss the issue of restoring statehood to J and K with the PM and home minister Shah very soon. "The prime minister and the home minister were busy with elections in Maharashtra and Iharkhand. But now that they have time, this issue will be taken up so that J and K's statehood is restored soon,"

Abdullah told reporters after attending a function to commemorate the 42nd foundation day of SKIMS Hospital here. Earlier, Omar attended a special prayer meeting marking the birth anniversary of Sheikh Mohd Abdullah.

On the occasion when he asked if the holiday on the NC founder's birth anniversary will be restored, the CM said there are many things that need to be brought back in J and K, but the priority is to restore its statehood first. "There are many other dates as

well, but we have to fight a bigger contest. We have to fight for

the restoration of J and K's statehood. We are hopeful that the PM will keep his promise made not to us, but to the people of J and K during the Lok Sabha election and the Assembly polls that followed," Abdullah said.

"The elections saw huge participation of people. There were no complaints of people being forcibly taken to the booths. Rather, they went on their own and made the elections a huge success with the hope that the promises made to them, especially on restoring J and K's statehood, will be fulfilled," the CM said.

The FSDA, while welcoming the verdicts, emphasised the importance of robust monitoring to prevent food adulteration and protect public health. While the penalties might seem symbolic compared to today's standards, these cases serve as a reminder of the need for both accountability and efficiency in food safety enforcement.



No-confidence vote topples | Yoon replaces defence minister as S Korea's **Barnier govt in France**

m rench\ President\ Emmanuel}$ nation Thursday, a day after the National Assembly ousted Prime Minister Michel Barnier in a historic no-confidence vote that has left France without a functioning government. Macron is expected to focus on stabilising the political crisis and possibly naming a new prime minister to navigate the fractured parliament.

Barnier formally submitted his resignation Thursday morning at the Elysée Palace, fulfilling a constitutional obligation. The no-confidence motion passed by 331 votes in the National Assembly, forcing Barnier to step down after just three months in office — the shortest tenure of any prime minister in modern French history. Pressure to act swiftly: Macron faces the critical task of naming a replacement capable of leading a minority government in a parliament where no party holds a majority. Yaël Braun-Pivet, president of the National Assembly and a member of Macron's party, urged the president to move quickly.

I recommend he decide rapidly on a new prime minister," Braun-Pivet said Thursday on France Inter radio. "There must

Macron took more than two months to appoint Barnier after his party's defeat in June's legislative elections, raising concerns about potential delays

"I believe that stability requires the departure of the President of the Republic," said Manuel Bompard, leader of the far-left Bompard, leader of the far-ieft France Unbowed party, on BFM TV Wednesday night. Far-right National Rally leader Marine Le Pen, whose party holds the most seats in the Assembly, did not explicitly call for Macron's resignation but warned that "the pressure on the President of the Republic

will get stronger and stronger." Macron, however, has dismissed such calls and ruled out new legislative elections. The current French constitution does not call for a president to resign after his government was ousted by the National Assembly.

"I was elected to serve until 2027, and I will fulfil that mandate," he told reporters earlier this week.

The constitution also says that new legislative elections cannot be held until at least July, creating a potential stalemate for policymakers.

Economic uncertainty: The political instability has heightened concerns about France's economy, particularly its debt, which could rise to 7 per cent of GDP next year without significant reforms. Analysts say that Barnier's government downfall could push up French interest rates, digging the debt even further.

Rating agency Moody's warned late Wednesday that the government's fall "reduces the likelihood of consolidating public finances" and worsens the

political gridlock. Macron's speech, scheduled for 8 pm local time, is expected to address these economic challenges while setting a course for the future government.

South Korea's president replaced his defence minister Thursday as opposition parties moved to impeach both men over the stunning yet short-lived imposition of martial law that brought armed troops into Seoul streets.

The main opposition Democratic Party and other small opposition parties sub-mitted a joint motion to impeach President Yoon Suk Yeol on Wednesday over his martial law declaration the previous night. Martial law lasted about six hours, as the National Assembly quickly voted to overrule the president, forcing his Cabinet to lift it before daybreak Wednesday. On Thursday, Yoon's office said he decided to replace Defense Minister Kim Yong Hyun with Choi Byung Hyuk, a retired four-star general who is South Korea's ambassador to Saudi Arabia.

Vice Defense Minister Kim Seon Ho will be the acting minister until Choi assumes the job after a parliamentary hearing. The hearing is a formality as the president holds the power to appoint ministers outside of the prime minister without the approval of lawmakers. Yoon's office didn't provide any further comments by him. vised address that his government was lifting the martial law declaration.

The opposition parties earlier submitted a separate motion to impeach Kim, alleging he recommended that Yoon impose martial law. Kim had offered to resign and apologized for causing disruption and concern to the public. Kim said "all troops who performed duties related to martial law were acting on my instructions, and all responsibility lies with me," according to the Defense Ministry. The impeachment motion

The Democratic Party's continagainst Yoon was introduced in ued impeachment attempts of senior government officials and prosecutors have been a major source of conflict with Yoon, who during his martial law announcement accused the opposition of "anti-state activities" and "paralyzing the government."

Prospects for Yoon's impeachment isn't clear as Yoon's People Power Party decided Thursday to oppose the motion's passage. Choo Kyung-ho, the floor leader of the PPP, told reporters that his party would hold another meeting to determine how to oppose the motion's passage. Observers say PPP members could simply boycott a floor vote or cast ballots against

Impeaching him would require support from two-thirds of the National Assembly, or 200 of its 300 members. The opposition parties together have 192 seats and they need additional votes from the PPP. Some experts earlier said the motion will likely be passed through parliament as 18 PPP lawmakers, who belong to an anti-Yoon faction in the party, already voted down Yoon's martial law decree together with opposition lawmakers. But speaking to reporters Thursday, PPP leader Han Dong-hun, head of the anti-Yoon faction, said he would work to ensure that the impeachment motion doesn't pass though he remains critical of Yoon's action, which he described as "unconstitutional." Han said that there is a need to "prevent damage to citizens and supporters caused by unprepared chaos."

Experts say rival factions in PPP could unite not to repeat their traumatic experiences following the 2016 impeachment of scandal-ridden conservative President Park Geun-hye, which happened after some lawmakers at her own party voted to impeach her. Park was eventually removed from office and arrested in 2017, and the liberals easily won the presidency in a by-election as conservatives remained in disarray.

Syrian army withdraws from Hama after insurgents broke through its defences

The Syrian army says it has withdrawn from the central city of Hama after insurgents broke through its defences, in another setback for President Bashar Assad.

The announcement Thursday came hours after opposition fighters said they had entered the city and were marching toward the centre. The Syrian army said it redeployed from Hama and took positions outside the city to protect the lives of civilians.

Bangladesh's ICT bans Sheikh Hasina's 'hate speeches'

The International Crimes Tribunal (ICT) of Bangladesh on Thursday ordered the authorities to ban the dissemination of all the "hate speeches" of ousted prime minister Sheikh Hasina in the media and on social networking platforms. The order follows Hasina's recent speech, her first public address after fleeing Bangladesh four months back, in which she mounted a stinging attack on the country's interim leader Muhammad Yunus, accusing him of perpetrating "genocide" and failing to protect minorities including Hindus. Bangladesh Sangbad Sangstha (BSS) reported that a two-member tribunal led by Justice Md

Golam Mortuza Mozumder passed the order and directed the authorities to remove all the "hate speeches" of Hasina from social media and take necessary steps to stop their dissemination in future in all types of mass media. Prosecutor Advocate Abdullah Al Noman told the news agency that the tribunal asked secretaries of the ICT Division, Ministry of Information and Broadcasting, and Bangladesh Telecommunication Regulatory Commission (BTRC)

The prosecution earlier filed the petition, pleading to remove and restrict all types of hate speech and incitement by the ousted prime minister, which may intimidate the witnesses or vic-

to execute the order.

Earlier, prosecutor Gazi MH Tamim briefed the media in this regard, saying not only in Bangladesh, making hate speech is a criminal offence in every law and every country around the world. "Sheikh Hasina has made speeches, where she was heard saying she got the license to kill 227 people as the same number of cases were filed against her. She was even heard giving threats to the victims and witnesses of the cases against her, through these speeches," Tamim said.

In remarks delivered virtually to her supporters at an event in New York, Hasina, presently living in India, also claimed that there were plans to kill her

and her sister Sheikh Rehana just like their father Sheikh Muiibur Rahman was assassinated in 1975. Describing Yunus as "power-hungry", Hasina alleged that the places of worship in Bangladesh are under attack and the current dispensation has totally failed

to deal with the situation. Hasina was speaking to supporters of her Awami League party at the event organised on Sunday to mark "Bijoy Dibos" or Victory Day that falls on December 16. Though Hasina made several statements in the last few months, it was her first public address after taking shelter, said an expert closely tracking developments in

DRI report reveals rise in commercial fraud, FTA misuse worth ₹1,427 Crore in 2023-24

The Directorate of Revenue Intelligence (DRI)'s report on 'Smuggling in India' 2023-24 highlights a rise in commercial fraud, including misuse of foreign trade agreements (FTA) by individuals/companies. According to the report, the agencies have detected cases of FTA misuse worth Rs 1,427 crore during 2023-24 compared to Rs 481 crore in 2022-2023.

Moreover, the DRI booked 109 cases involving 8223.61 kg of narcotic drugs and psychotropic substances including 107.31 kg of cocaine, 48.74 kg of heroin, 136 kg of methamphetamine, 236 kg of mephedrone and 7348.68 kg of ganja in 2023-

The seizures indicate an increasing trend of smuggling of cocaine through air the fiscal 2023-24, the DRI of cocaine through air passenger route, from 21 cases in 2022-23 to 47 cases in 2023-24, with majority of seizures effected at airports. According to report, Free included

"Though illicit cigarettes are reportedly manufactured in certain South East Asian countries, it appears that the consignments are initially shipped to Dubai from southeast Asia and then re-

initiated 485 import cases, involving illegal benefits totaling Rs 5,907.79 crore. The most common offenses

declaration/mis-classification (201 cases), misuse of end-use and other notifications (52 cases), misuse of Free Trade Agreements (FTA) (51 cases), undervaluation (47 cases), and evasion of antidumping duties (38 cases). Misuse of the ASEAN-India FTA (33 cases) and Notification No. 50/2017-Customs (27 cases) were also

notable issues. On the export side, 27 cases were booked, involving illegal benefits worth Rs 123.34

The first half of 2024-25 saw cigarette seizures climb by 19 per cent, reaching 3.95 crore accounting for 55% of the sticks, compared to 3.31 crore seizures and the air route

sticks during the same period Illicit foreign currency

seizures have also surged. DRI officials seized Rs 13.8 crore in foreign currency during the first half of FY25, surpassing the Rs 12.4 crore confiscated in all of FY24. Additionally, the agency uncovered a Rs 576 crore trade-based money laundering (TBML) racket. The scheme involved importing cheap electrical goods and cosmetics at inflated prices to channel foreign exchange out of the country.

According to the report, gold smuggling in India follows a "hub and spoke" model. In this system, contraband is first brought into the country and transported to central

hub locations before being

distributed to various

destinations.

During the financial year 2023-24, the DRI seized a total of 1,319 kg of gold, with the land route

contributing around 36%. The DRI has also shared valuable intelligence with Customs field formations, resulting in significant gold seizures by these units. The report highlights how gold smuggling in India has

evolved over time. Smuggling syndicates now employ a wide range of "mules," including foreign families, and s. These nationals, even insiders. syndicates are increasingly

using international departure gates, where airport workers and other staff are involved in smuggling gold from transit passengers. Furthermore, there has been a rise in the number of carriers used by these syndicates to transport smaller amounts of gold,

which helps reduce potential losses if the gold is intercepted by law enforcement. There is a sharp rise in seizures of drugs such as cocaine and methamphetamine,

contraband cigarettes and

illicit foreign currency over the past year.

According to report, the agency conducted 47 cocaine seizures worth Rs 975 crore in 2024-more than double the number recorded in the previous financial year.

The quantity of cocaine smuggled into India, primarily through airports, increased by 9 per cent to 107 kg during the same period. Met hamphet amine smuggling has also spiked, especially in northeastern states like Assam and according to Mizoram, DRI's latest bulletin.



Revamping India's Housing


Government housing schemes often fail due to corruption and

poor execution, highlighting the stark contrast with private sector successes,

he governments at the Centre and the States are sincere in their efforts to provide shelter to those without roofs over their heads. It must be said that food, clothing, and shelter remain the essential elements that constitute the life of any ordinary person. The administrations have conceived and executed many housing projects such as the Prime Minister's Awaas Yojana and the Indira Gandhi Housing Scheme. In Tamil Nadu, former Chief Minister J Jayalalithaa launched a mission to construct houses for the poorest of the poor at heavily subsidised

During the tenure of C Achutha Menon as Chief Minister (1969 to 1977), the Kerala Government launched Laksham Veedu (1,00,000 Houses), a housing scheme for the poorer sections of society. Small houses were built under this scheme across the State for the benefit of people below the poverty line. Although the intention was noble, these houses ended up as dens of all vices. Residents of Laksham Veedu colonies were treated as anti-social elements, as many excelled in dubious professions such as theft, dacoity, bootlegging, pimping, and prostitution. The scheme died a natural death, like many other governmentsponsored initiatives. Later, the LDF Government led by Pinarayi Vijayan launched Life Mission in 2016 with the aim of providing residential accommodation to those without homes. However, this multicrore project is reportedly embroiled in corruption, with central agencies

investigating the issue. In Tamil Nadu, the Slum Clearance Board has constructed four-storey apartments for the poor along the scenic Marina Beach. However, the quality of construction and the ambience are worse than the slums themselves. Why do government schemes fail so frequently? The answer is not difficult to ascertain. Massive corruption involving public works departments, bureaucrats, contractors, and politicians turns these schemes into milch cows. "To hell with the beneficiaries... we can make as much money as possible from these schemes." seems to be the driving mantra of these anti-




The Central Public Works Department, responsible for constructing central government buildings, and the State PWDs, entrusted with building roads, offices, and residential accommodations, are classic examples of corruption in high places. One need only look at the buildings, be they office complexes, hospitals or housing projects for the poor. What stands out is the careless manner in which they have been designed and built. Hygiene and sanitation in these buildings are often appalling. Walls double as spittoons, toilets are worse than hell, and cleanliness seems alien to such structures.

Contrast this with the apartments and villas built by private developers, and the difference is stark. Major players such as Tata Housing, L&T, DLF, Ashok Leyland, the Godrej Group, Hiranandani, Chettinadu Group, Ceebros, Puravankara, and Sobha City (to name a few) create visual treats. Their projects cost a fortune and cater to the affluent, but they stand as a testament to

quality construction and planning. The townships they build, with their panoramic views, starkly contrast the stinking lowincome group apartment complexes constructed by CPWD and PWDs. These public works departments have effectively pecome Public Waste Departments, proving themselves incapable of fulfilling their intended purpose.

It is indeed possible to build beautiful and safe houses for the poor. What is needed is a change in the attitude and approach of bureaucrats. The success of private developers in building well-planned townships and apartments stems from thoughtful planning and treating construction as an art. The life and achievements of Kushal Pal Singh (KP Singh), who single-handedly built the DLF empire, illustrate this point. The township at Gurugram (which I have read about and seen on television) is a breathtaking achievement. Thanks to companies like DLF, India has become a global player in

constructing townships, major software parks, and apartment complexes. Is it not possible for doyens like K P Singh to build affordable housing for the poor?

Such a vision could materialise by loosening the stranglehold of the government (both Centre and State) on these sectors. For every high-end township that private developers construct, they could be tasked with building housing complexes for low-income groups, complete with well-laid-out landscapes. Given proper incentives and recognition, these companies would likely embrace such missions. It would also be crucial to foster respect for business leaders like Singh, the Godrejs, the Tatas, and others. India cannot afford to view its entrepreneurs, who employ millions, with suspicion. Business and entrepreneurship are forms of art that can drive progress where the government cannot.

The memoir Why The Heck Not, by K P Singh with Aparna Jain, is an eye-opener. It highlights the often-overlooked role of Indian entrepreneurs in nation-building. Figures like JRD Tata and Dhirubhai Ambani were visionaries who lacked the recognition they deserved within India, even as foreign media sought their insights. Singh's story, from studying aircraft maintenance engineering in Coventry to heading the DLF Group, is nothing short of inspiring. His advice, peppered throughout the book, offers valuable lessons for parents, youth, and policymakers alike.

After reading the memoir, one cannot help but wish Singh another 95 years of health, strength, and happiness. His contributions to India's infrastructure and business landscape make him a national treasure. The insights he shares about India's fragile infrastructure and the steps needed to achieve the five trillion-dollar economy are profound. His vision of a better, more inclusive India should inspire policymakers to let a thousand flowers bloom.

One blemish on Singh's otherwise remarkable career is his association with a less-than-reputable individual, often referred to as Damaad Shree. With his wisdom and experience, Singh could have avoided such associations and still achieved

Almost every challenge that we faced in last few years, we have stepped up and done well," Cummins spoke with a lot of determination on the eve of the second Test against India in Adelaide.

"I think we need to do that for another home summer and series. From two-three season thing, it has suddenly been a half a generation thing," he added.

Mitchell Starc, Josh Hazlewood (not playing this Test), Mitchell Marsh, and Nathan Lyon are some of the players, who were part of the 2-0 win back in 2014-15. From that point onwards, India have won all

four series - two at home (2017 and 2023) and two overseas (2018-19, 2020-21). So, is there pressure on him to win it back this

time? "I don't think it's pressure. You are playing at home and you want to do well. We know they (India) are a really strong side and lot of us were part of those recent three series (defeats). "Yeah, it's a big series and kind of not looking too far in the past. And every summer, when we play against them we want to do well," Cummins said.

The 31-year-old, who has 272 wickets from 63 Tests, didn't want to compare the Ashes with the Border-Gavaskar Trophy (BGT) but bit. Great young kid."

Just like we have seen, when we have been two, three or four down, then (Mitchell) Marshy or (Travis) Heady have put out a 100. That changes dynamics pretty quickly," Cummins said.
