NO CONFIDENCE IN V-P DHANKAR: OPPOSITION

n a first, Congress-led INDIA Bloc of Opposition parties on Tuesday submitted a notice to bring a motion in Rajya Sabha for the removal of Vice President Jagdeep Dhankhar, accusing him of "partisan" conduct as the chairman of the Upper House. Dhankar is Chairman of the Upper House.

If the motion is moved, these parties need a simple majority to get it passed, but they do not have the requisite numbers in the 243-member House. Opposition members, however, insisted that it was a "strong message to fight for parliamentary democracy".
Parliamentary Affairs minister Kiren Rijiju dubbed the move as 'extremely regrettable" and said the government is very proud of Dhankar.

On behalf of the Opposition, Congress leaders Jairam Ramesh and Naseer Hussain submitted the notice signed by 60 Opposition Members of Parliament, including from the Congress, Rashtriya Janata Dal (RJD), Trinamool Congress (TMC), Communist Party of India (CPI), Communist Party of India (Marxist) CPI-M, Jharkhand Mukti Morcha (JMM), Aam Aadmi Party (AAP), Dravida Munnetra Kazhagam (DMK), Samajwadi Party (SP), to Rajya Sabha Secretary General PC

present spearheaded by the Congress, comes in the wake of verbal clashes between Opposition parties and the Rajya Sabha chairman. The Opposition has been upset with Dhankhar over multiple issues. The latest trigger was allowing Bharatiya Janata Party (BJP) members to raise the allegations of links

between Congress leaders and organisations backed by billionaire investor George Soros which the ruling party claims are involved in "anti-India activities".

The Opposition said his conduct of the House on December 9, 2024, was particularly one-sided and totally unfair, and said he was "encouraging and provoking" the Treasury Benches to make outrageous remarks. INDIA Bloc parties had in August this year also considered submitting a notice for moving a resolution to remove the vice president from his office.

This is the first time that a notice for bringing a motion to remove the Vice President has been moved in the Rajya Sabha. A 14-day notice has to be given and it should be approved by the Deputy

Identify illegal Bangladeshi immigrants, orders LG

Delhi Lieutenant secretariat has written to the Chief Police Secretary and Commissioner asking for initiating "strict action" against illegal Bangladeshi immigrants residing in the National Capital. According to Raj Niwas officials, the LG Secretariat has asked the Chief Secretary and the Police Commissioner to launch a special drive spanning over two months to identify illegal Bangladesh immigrants in Delhi and take strict action as per the extant rules in a time-bound manner. The move comes in wake of

the representation made by the delegation of Ulemas and Muslim leaders from Dargah Hazrat Nizamuddin and Basti Hazrat Nizamuddin to Delhi Lieutenant Governor Vinai Kumar Saxena on Saturday. They had expressed deep concern about the attacks being undertaken on the Hindu and other minority communities in Bangladesh and accordingly, demanded stringent action against Bangladeshi infiltrators residing in the National Capital. "Prominent Ulemas and

Muslim residents have requested that Illegal Bangladeshi infiltrators should neither be given houses on rent nor should they be given employment by any establishment. Further, they have requested that their children should not be given admission in any government Chairman before the motion is taken up.

infiltrators from roads. footpaths, parks and other government lands, over which they have forcefully encroached and anv documents like Aadhar Card, Voter ID, or any other government document acquired illegally by Bangladeshi infiltrators be cancelled immediately. They have also demanded that a special drive, like in the past, should be launched to identify the illegal Bangladeshi immigrants in Delhi and they should be sent back immediately," the letter from the LG Secretariat read. Meanwhile, Chamber of Trade and Industry (CTI) chairman Brijesh Goyal has

urged business communities to reduce their business activities with Bangladesh. The CTI has warned that if the atrocities on Hindus in Bangladesh do not stop, then all the traders of Delhi and the country will end all trade with Bangladesh. "There is also resentment among the businessmen of Delhi against the Mohammad Yunus government of Bangladesh," he said.

Security was stepped up outside the Bangladesh High Commission here on Tuesday, as hundreds of from various organisations, including the Rashtriya Swayamsevak Sangh (RSS), held a protest

march at Chanakyapuri against alleged atrocities and human rights violations against Hindus and other minorities in Bangladesh. Police had put barricades on the Teen Murti Marg on both the carriageway outside the Chanakyapuri police station where hundreds of people from various organisations gathered. Traffic was regulated in the area with vehicles redirected to alternative routes.

There have been allegations of over 200 attacks on Hindus in various districts of Bangladesh since the fall of the Sheikh Hasina-led Awami League government on August 5.

NIA arrests main accused in Laos human trafficking, cyber slavery case

 $T^{\text{he National Investigation}}_{\text{Agency (NIA) on Tuesday}}$ made a major breakthrough in the Laos human trafficking and cyber slavery case with the arrest of an absconding accused, who was nabbed with support of the Delhi Police's Special Cell. Kamran Haider's arrest marked a significant step towards dismantling the international human trafficking syndicate, the NIA said in a statement. Along with his co-accused, Haider was allegedly directly involved in arranging flight tickets and documents for the victims and facilitating their "illegal border crossings" with the help of contacts in the Golden Triangle region. The Golden Triangle refers to a large, mountainous region comprising parts of Myanmar, Thailand and Laos.

SC seeks details from Allahabad HC on Justice Shekhar Kumar's speech

"The Supreme Court has taken note of the newspaper reports of a speech given by Mr Justice Shekhar Kumar Yadav, a sitting judge of the High Court of Judicature at Allahabad. The details and particulars have been called from the High Court and the matter is under consideration (sic)," the SC statement read. Sitting judge Justice Yadav the controversial made remarks on December 8 while addressing a convention of the legal cell of the Vishva Hindu Parishad in Allahabad. A day later, videos of the judge speaking on provocative issues, including judge the law working according to the majority, were circulated widely, triggering strong reactions from various opposition parties which questioned his reported statements and labelled it as hate speech. "I have no hesitation in stating that this is Hindustan, and this country will function according to the wishes of the majority living here. This is the law. It is not about speaking as a High Court Judge; rather, the law operates in accordance with the bahusankyak (majority). Consider this in the context of a family or society - only what ensures the welfare and happiness of the majority will be accepted," Justice Yadav

The judge also used the term "kathmullah", a slur against Muslims. Referring to extremists as "kathmullah", he said that the country should be circumspect about them. "But these kathmullah... this

may not be the right word... but I won't hesitate to say it because they are harmful to the country...they are detrimental, against the nation, and people who incite the public. They are the kind of people who do not want the country to progress, and we need to be cautious of them)," said Justice Yadav at VHP's legal cell function.

Kapil Sibal, president of the Supreme Court Bar Association called for the impeachment of Justice Yadav. He also urged the Prime Minister, Home Minister and Members of Parliament from the ruling party to extend support for impeaching Justice Yadav. Meanwhile, Lok Sabha MPs Syed Ruhullah Mehdi, Asaduddin Owaisi initiated signatures MPs' seeking

No mismatch in **Maharashtra** votes polled and **VVPAT tally: ECI**

 $T_{\scriptsize of~India~(ECI)~on}^{\scriptsize he~Election~Commission}$ Tuesday said no mismatch was found between the votes polled and corresponding tally of Voter Verified Paper Audit Trail (VVPAT) slips in random counting in the last month's Maharashtra Assembly elections. The mandatory counting of VVPAT slips from five randomly selected polling stations in each assembly constituency was completed successfully, the ECI said in a statement.

Opposition parties in the state had questioned the integrity of Electronic Voting Machines (EVMs) after the ruling BJP-led Mahayuti coalition won a landslide victory in the November 20 elections. The counting of VVPAT slips aims to verify the tally of votes recorded EVMs against the corresponding VVPAT slips, the ECI said, adding that representatives of candidates were present

throughout the process.

The Supreme Court on Tuesday upheld an order enĥanced ation pavable to some owners whose land in Haryana was acquired for Kundli-Manesar-Palwal expressway. A Bench of Justices BR Gavai and KV Viswanathan set aside a November 2021 verdict of the Punjab and Haryana High Court quashing an order of the district revenue officercum-land acquisition collector (LAC), Jhajjar enhancing the compensation.
The LAC, in an order passed on September 15, 2020, enhanced the compensation to Rs 19,91,300 per acre along with statutory benefits as awarded earlier by the High Court to similarly-placed land owners. The Court delivered its verdict on an appeal filed by some land owners challenging the high court's November 2021 verdict.

The Bench noted by a November 2004 notification under the Land Acquisition Act, 1894, the land of the appellants in Jhajjar district was acquired for the expressway and by an award in March, 2006, a compensation of Rs 12.50 lakh per acre was determined. It



noted that aggrieved by the award, some similarly-placed land owners preferred a reference for enhancement of compensation before the additional district judge, Ihaijar but the same was dismissed.

The Bench further noted such land owners approached the high court, which in May, enhanced 2016, compensation to Rs 19,91,300 per acre along with statutory benefits. The Bench said on June 30, 2016, the appellants filed an application under Section 28-A of the Act before the LAC, Jhajjar, which held the LAC, Jiajjar, which neight that appellants were entitled to benefit of the high court's May, 2016 verdict and enhanced the compensation. Section 28-A of the Act pertains to re-determination of amount of compensation on the basis of award of the court.

The matter again came up

before the high court which set aside the LAC's order. Referring to a previous verdict delivered by the court, the Bench noted it was held that statement of objects and reasons of Section 28-A would reveal that the object underlying the enactment of the provision was to remove inequality in payment of compensation for same or similar quality of land.

The Court said it was not in dispute that the first appeal, which was allowed by the high court in May, 2016, was with respect to the land covered by the same notification under which the appellants' land was also covered. "We are, therefore, inclined to allow the appeal. The impugned judgment and order of the high court dated November 25, 2021 is quashed and set aside and the order of the LAC dated September 15, 2020 is upheld," the Bench said.

What's in a name? **Communal harmony**

In a rare socio-cultural shift, several Muslim families in Dehari village of Uttar Pradesh's Jaunpur district have started using Hindu surnames like Dubey and Tiwari, claiming Hindu ancestry. They have also embraced practices such as cow service, and traditional Hindu rituals to honor their lineage. Located about 45 km from

Jaunpur's district headquarters, Dehari village has a predominantly Muslim population. The trend Continued on page 8 ago when some villagers

traced their ancestry, sparking widespread curiosity and debate. After that around 30 to 35 Muslim families in the village have adopted surnames such as Dubey, Tiwari, Thakur, and Kayastha, Thakur, and ' claiming historical ties to these castes.

The issue came into the limelight when Naushad Ahmed from Dehri printed his wedding invitation card with the name "Naushad Ahmed Dubey." When asked about the reason, Naushad explained, "Our ancestors were Hindus. I am reclaiming my ancestral gotra (clan) name."

Two minor sisters die as scooter rams into divider

Two minor girls died after a scooter they were riding rammed into a road divider on the Buddheshwar overbridge on Monday evening. One of them died on the spot, while the elder sister succumbed to injuries during treatment at a hospital on Monday.

The victims were identified as Aqsa Bano (12) and Zikra Bano (6), residents of Dubagga. According to the victims' mother Reshma, a native of Hinuna in Amethi, she has been living in a rented house in Salamat Nagar, Andhe Ki Chowki (Dubagga), for the last three years. Her husband Asif works as a driver in Mumbai. There are two other daughters in the family: Kahkashan (10), and Ayesha. Aqsha was a Class VI student. On Sunday evening, Reshma went out to buy vegetables. During her absence, Aqsa asked a neighbour to drive her scooter, taking her younger sister Zikra along for a ride. local community is also

The speeding scooter collided with the road divider as a girl attempted to avoid a car coming from the opposite direction

While descending the Buddheshwar overbridge in Para, the speeding scooter collided with the road divider as Aqsa attempted to avoid a car coming from the opposite direction.

The impact was severe, and both sisters were critically injured. Passersby immediately informed police.

The police reached the scene and rushed the injured girls to KGMU Trauma Centre, where doctors declared Zikra dead on arrival. Despite efforts to save her, Aqsa also passed away during treatment. The tragic incident has devastated their mother and the entire family, and the

mourning their loss.

After the post-mortem on Monday, the family took the bodies to Amethi. The last rites of both sisters are scheduled to take place on Wednesday. Inspector Suresh Singh stated that the vehicle's owner was identified from documents found on the scooter. Once the family submits their complaint, a case will be registered, and appropriate action will be taken.

"Repair work on the road and construction work for a drain have been proposed along the route because of which encroachments have been removed after serving notice, Tripathi told reporters.

He also stressed that the district administration duly informed the mosque management in the past. "The management earlier removed shops attached to it. Now removal of a portion became inevitable because it was constructed later. The rest of the mosque has not been demolished. It is evident from satellite and historical images that the construction was done two-three years ago. Only the encroached part has been removed," Tripathi said.
Additional Superintendent of Police P Vijay Shankar Mishra

oversaw the security arrangements at the site, where five circle officers, station house officers of 10 police stations, and scores of constables were deployed during the demolition

Seeking protection for herself, her son, and their property, she alleged that the threats intensified

According to the complaint, at around 12:15 pm on December

6, she received a call from Sonkar on her son's mobile. Upon answering, Sonkar allegedly ordered her to come outside and issued a warning. Sonkar introduced himself and demanded to know about her son Ashish.

"Ashish has earned enough money until now. I will not let him earn anymore. Tell him that if he tries, I will ensure multiple cases are registered against him, or I will deploy men around your house so you'll remember this your entire life. I was externed from the district for three months because of you people, and now that I'm back in Lucknow, I will not spare you," Sonkar was quoted as saying by the woman in her complaint. She further alleged that at

around 5 am on December 7, Sonkar reached her house and called for her elder son Anshu. "He said he would get Ashish killed. Sonkar, who had a pistol tucked into his waistband,

was accompanied by an associate named Jeet Narayan. He abused Anshu, threatened us, and said he would ensure we could no longer live in the area, adding that we would be beaten with shoes and slippers daily," the complainant alleged. She claimed she had filed a complaint earlier that day, but no action was taken by the

authorities. Later that evening, around 8:52 pm, Sonkar allegedly returned with his brother Arun Sonkar, Mausam Sonkar, Aman Sonkar, and 4-5 unidentified associates. They allegedly abused the woman and her family and attempted to attack her son with an iron rod.

"In fear, my family and I folded our hands and pleaded with Kishan Sonkar and his group to leave. They then threatened to kill us and demanded we leave Lucknow immediately," she alleged, seeking immediate intervention and protection from the authorities.

Tuesday rejected opposition criticism of Allahabad High Court judge Shekhar Yadav for attending and speaking at a VHP event in Prayagraj, and asserted such "awareness meets" would continue to be organised.

Justice Yadav spoke on Uniform Civil Code and other issues during a provincial convention of the VHP's Legal Cell and High Court Unit on Sunday. The videos of him speaking at the event, where he also reportedly said the law should work according to the majority, were circulated widely triggering a strong reaction from opposition parties. Kumar, who is VHP interna-tional president, said on

Tuesday he was not present at the Prayagraj meeting, but was certainly aware of the deliberations.

"We had invited the judge as a faculty to speak on the Uniform Civil Code. We work among former judges, invite them to work for the VHP, for Hindutva. But as far as sitting judges are concerned, we do not expect them or invite them to work for the VHP. Sometimes on topics like the UCC, we do invite them to enlighten us," Kumar told PTI on the phone.

"So, on the issue of UCC, the HC judge said at the meet it was a Constitutional mandate under the Directive Principles of State Policy. He said it should be expected that the directives should be adhered to by elected representatives. He referred to various SC judgments that insisted the governments should evolve a UCC and said that the UCC would be good Kumar said. The VHP leader, however, said

he was not aware of the exact nature of the comments on "majority" attributed to the HC judge, but "I would not be apologetic" even if the HC judge has said so about majority having a say in how the laws should work.

"We had invited the judge to speak on the UCC. I would not be able to authenticate those views of his, but then the sentiments and emotions of the majority society deserve as much respect as the sensitivi-ties of the minority," Kumar

"For example, our respect for cows. They may or may not respect cows. Now we cannot force everyone to respect cows. But then, considering our sensitivities, others may not insist on cow slaughter... (and) if they have certain sensitivities on certain subjects, they should be respected.

"Islam in India is technically a minority, but considering their good numbers, they are a second majority in India. So, unless we develop mutual respect, if not respect, then mutual tolerance for others' sensitivities, there cannot be any integration," the VHP leader said.

"So, I would not be apologetic about it if he (the HC judge) said so. If a majority holds a particular view, then others should not make an issue of it," he said.

Asked further on inviting a sitting judge at the event, Kumar said, "We ask our legal cell to organise awareness sessions or meetings inviting advocates in big numbers to advocate on faiths.

ASHA workers identifying children suffering from pneumonia: CMO

The Social Awareness and Action to Neutralise Pneumonia Successfully (SAANS) campaign is being run from November 12 with the aim of reducing the mortality rate of children up to five years by preventing pneumonia and providing timely and appropriate treatment. Chief Medical Officer (CMO) Dr Sandeep Chaudhary said under it children suffering from pneumonia are being identified at the community level by ASHA workers in urban and rural areas and they are being referred to the hospitals if symptoms are

The CMO said the medical care of children is being continuously supervised and monitored. "About 17.5 per cent of deaths in children below the age of five are due to pneumonia. Pneumonia is caused by lung infection, bacteria, virus and fungal infection. For the good health of the child, all lactating mothers should breastfeed the child immediately after birth till six months and after it they should give proper supplementary food and vitamin A supplements. To prevent diseases, they should

pay special attention to vaccination of the child and hygiene of hands, clean drinking water and household pollution", Dr Chaudhary added.

Deputy Chief Medical Officer

and Nodal Officer of RCH Programme Dr HC Maurya said the doctors and paramedical staff of all communitv health centres (CHCs), primary health centres (PHCs) and district hospitals have been sensitised for the management of pneumonia, and all equipment and medicines have been made available so that the lives of children suffering from pneumonia can be saved in time. "So far, during the campaign, 3,522 children have been examined by ASHA workers, in which 272 children were identified, 118 were treated at the PHCs and 154 were referred to the district hospitals and medical college", he said. He said there can be various reasons for pneumonia in children such as low weight, malnutrition, not breastfeeding for six months and not paying attention to household pollution, not getting measles and PCV vaccination done, congenital malformations like cleft palate, genetic heart defects and asthma increase the chances of pneumonia.

Dresident Droupadi Murmu Pon Tuesday said the human rights discourse so far has been centred on the "human agency" as the violator is assumed to be a human but with AI entering our lives, the "culprit could be a non-human" but an intelligent agent. In her address at an event hosted by the NHRC to mark the Human Rights Day, the President also underlined that cyber crimes and climate change are "new threats" to human rights.

Human Rights Day observed on December 10 every year to commemorate the Universal Declaration of Human Rights (UDHR), which was adopted and proclaimed by the United Nations General Assembly in 1948. The UDHR serves as a



global benchmark for the protection and promotion of human rights. "As we progress into the future, we are confronted with emerging challenges. Cyber crimes and climate change are new threats to human rights," Murmu said. The digital era, while being transformative, had brought with it complex issues such as cyber bullying, deep fake, privacy concerns and spread misinformation, she added.

"These challenges underscore the importance of fostering a safe, secure and equitable digital environment that protect the rights and dignity of every individual," the President said. In her address, she also touched upon the aspect of AI and its impact on human lives. "Artificial intelligence has now entered our day-to-day life, solving many problems, and creating several new ones too," Murmu said. The human rights discourse so far has been "centred on the human agency", that is the violator is assumed to be a human being, who would have a "range of human emotions such as compassion and guilt," she said. "With AI, however, the culprit could be a non-human but intelligent agent. I leave the matter for you to ponder over," the President said.

Global warming is becoming reality as 2024 set to be the hottest year on record

s global temperatures soar to unprecedented levels, 2024 is shaping up to be the hottest year on record, a grim milestone that underscores the accelerating crisis of climate change. European Union scientists have confirmed that the first eleven months of 2024 have set a new high, making this year the warmest since records began. This will be the first year where the global average temperature surpasses 1.5°C above pre-industrial levels, a threshold that world leaders have long warned could trigger catastrophic climate impacts. With this alarming reality, the world faces a rapidly intensifying climate emergency, one that requires immediate and drastic action. The impacts of global warming are already being felt around the world. In 2024, extreme weather events have ravaged communities, causing widespread devastation. Severe droughts have gripped Italy and South America, while fatal floods in Nepal, Sudan and Europe have displaced thousands. Heatwaves in regions like



Mexico, Saudi Arabia and Mali have killed thousands of people, while cyclones have torn through the United States and the Philippines. These events are not just random occurrences; scientific studies confirm that they bear the unmistakable fingerprint of human-caused climate change.

The overwhelming cause of global warming is carbon dioxide emissions from burning fossil fuels. These emissions trap heat in the atmosphere, causing global temperatures to rise at an alarming rate. The most effective way to curb this warming is by reducing emissions to net-zero levels, a goal that many nations have pledged to achieve in the com-

ing decades. However, despite these green pledges, global CO2 emissions are on track to hit record highs this year. This contradictory trend highlights the gap between political promises and the real, tangible actions needed to mitigate climate change. This year's UN climate talks produced a \$300-billion deal aimed at addressing the global climate crisis. However, poorer countries have criticised this deal, arguing that it is insufficient to cover the soaring costs of climate-related disasters. While this deal may have made some progress, it is clear that the global response is not yet enough to prevent further warming. The rise of climate change deniers, particularly within the political sphere, has made it even harder to combat this crisis. US President-elect Donald Trump, in particular, has consistently downplayed the severity of global warming and rolled back numerous environmental regulations during his previous term. Under Trump's leadership, the US withdrew from the Paris Agreement, a global pact aimed at reducing emissions and limiting global temperature rise. Such actions would undoubtedly exacerbate the climate crisis, making it even harder to reduce emissions and avoid the most catastrophic effects of global warming. The time to act is now, and the window for meaningful change is rapidly closing.

Philippines confronts Chinese assertiveness



The South China Sea remains a flashpoint of escalating tensions as China intensifies its aggressive maritime activities, targeting nations like the Philippines

NS Admiral Dinesh Tripathi during his customary briefing of media before Navy Day last week expressed concern about Chinese maritime activities in the South China Sea, all of which China claims. Two countries it especially targets in SCS are Taiwan and the Philippines in whose waters it has indulged in offensive naval actions. It signed a defence agreement with the US in 1951; last month it signed an intelligence and technology agreement facilitating satellite intelligence and access to high-grade US weaponry following President Marcos promulgating Maritime Zone Act and Archipelago Sea Lanes Act that China denounced and summoned its envoy. The week-long ASEAN summit in Vientiane, Laos from 6 to 12 October witnessed stern exchanges between China, the US and the Philippines especially over the South China Sea at a time when the West is seized with Ukraine and West Asia crises, even as President-elect Trump is issuing multiple threats. While Chinese Premier Li Qiang blamed 'external forces" for interfering in regional affairs, US Secretary of State Antony Blinken said the US is concerned about increasingly dangerous and unlawful activities of China in disputed SCS. Marcos complained to ASEAN leaders that his country continues to be subjected to Chinese bullying and intimida-

Earlier that week PM Narendra Modi attended the 19th India-ASEAN meeting and made a powerful presentation of Delhi's Act East policy and criticised China for its expansionist policy in SCS. The Chinese have been testing the waters in the Philippines EEZ in SCS missile boat fired laser beams ilipinos call the West Philippines Sea with several forays against Filipino boats to check how far the US will go in its support. Taiwan continues to face periodic challenges as China relentlessly violates the 2016 UNCLOŚ ruling that the Philippines secured over China's illegal claim to the South China Sea under its 9dash line. During my interaction with Philippines security experts in Manila in June, clashes over the resupply of a marooned vessel in Thomas Shoal 2 had reached the climax; and some suggested it could be a feint for Taiwan. The incident had ruffled feathers in Manila with calls for invoking the US Mutual Defence Agreement which gets triggered only during armed external attack.

Clashes have occurred between the two sides and despite talks and a hotline, no compromise was reached. On September 28 Chinese Navy at a Philippines Cessna Patrol aircraft while Filipino coast guard vessels continued to be chased. CONTROVERSY AT 11T KHARAGPUR

About 100 faculty members have protested by wearing black bands and participating in silent marches on campus. The faculty is reportedly now considering legal action. On December 2, the administration replaced the heads of the departments of mathematics, artificial intelligence, and biosciences and biotechnology. I want to say that when the education minister was informed about the arbitrary behaviour of director VK Tiwari five months ago, why did he not

take any action? Why was the director not removed from his post with immediate effect? Childhood Wounds: The hidden force behind life's struggles



Whether it's self-doubt at work or struggles in relationships, the roots often trace back to unresolved childhood wounds

ave you ever won-dered why life keeps L pulling you back, no matter how hard you try to move forward? Maybe you find yourself repeating the same mistakes in relationships, doubting your abilities at work, or battling the constant ache of "not being enough."

It's easy to blame bad luck or personal failure. But often, these struggles run deeper-in unresolved childhood wounds. Childhood is when we learn how to love, trust and value ourselves. But not all childhoods are built on safety and support. Even seemingly small moments can leave deep

A parent saying, "Stop crying, you're embarrassing me," or a teacher comparing you to someone else may seem insignificant at the time but can shape how we see ourselves for years to come. Take Radhika, for example. At 35, she thrived in her career but couldn't maintain a relationship. Every time someone got close, she would pull away, convinced they would leave her eventually. Therapy

revealed that her fear of abandonment stemmed from her father leaving when she was six. Her emotional walls weren't about keeping others out; they were about protecting herself from feeling that pain again. Then there's Arjun, 28, who struggled to hold a job. His pattern was predictable: procrastinate, miss deadlines and eventually

lose the role. He believed he lacked discipline, but therapy uncovered a deeper truth. He had grown up under relentless criticism—nothing he did was ever good enough. That

internalised voice followed him into adulthood, leading him to self-sabotage before anyone else could judge him. These aren't isolated stories. Many of us carry invisible wounds from our childhood.

A parent's absence, constant comparisons, or even a single harsh word can create emotional patterns fear of intimacy, perfec-tionism, or shrinking ourselves to avoid rejection. Over time, these patterns create setbacks that seem external but are deeply internal. Therapy is where this cycle ends. It's not about

blaming our parents or reliving the past. It's about understanding why we feel stuck and learning how to let go of the pain. Imagine carrying a heavy bag for years, thinking it's just part of life-then discovering you can put it down. That's what healing feels like.

One client described the process beautifully: "For the first time, I understand myself. I'm not broken. I've just been carrying pain I didn't know was there." Your setbacks aren't failures; they're signals that something inside you needs attention. Healing childhood wounds allows you to stop reacting from a place of fear and start living from a place of freedom. It's not an easy journey, but it's one worth taking. The truth is, you deserved love and safety as a child, and you still do

Healing isn't about erasing the past—it's about reclaiming your future. If this resonates, consider giving yourself the gift of therapy. You're not broken—you're healing.

TRANSFORMING ORGANISATIONAL BEHAVIOR

As technology reshapes the world at breakneck speed, organisations must evolve to stay relevant

It would be worthwhile to examine how organisations are structured and articulated. In the long haul organisations blessed with individuals willing to experiment, innovate and embrace technology will be the ones that survive. At the pace that technology with its variants is fashioning itself, numerous applications are unravelling virtually by the minute, and the level of obsolescence and attrition of equipment is becoming extraordinarily high. In such a scenario, humans and organisations will be subsumed by various products and their variants. The human mind can no longer remain in the typewriter mode. The garden of Organisational Theory and Behaviour is dotted with eminent scholars. Three pioneers, Adam Smith, Charles Babbage and Robert Owen provided the ballast and the basic groundwork.

Adam Smith advanced the argument that countries and organisations would profit by adopting the tenets of division of labour, what is now termed as specialisation. Charles Babbage in his seminal work postulated: Through the division of labour, the time required for learning a job or skill gets drastically reduced. Right at the stage of infancy wastage of material gets minimised and diminishes. The mind is propelled to take up serious tasks upon attaining superior skills. Way back in 1789, Robert Owen at 18 went on to acquire a factory. He was a utopian, way ahead of his times. In 1825, he promulgated regulated working



hours, child labour laws, public education and business involvement in various community projects – a precursor to CSR. In today's wired world, individuals work from their dwellings. Places with the latest technology and gizmos at their disposal. Over the last decade, the entire paradigm of organisational behaviour has metamorphosed. Technology stares at organisations with peering eyes, the complexity and dynamics of structures having undergone a complete metamorphosis. Let us look at the Indian Railways. There was a time when the operating and manufacturing departments held sway in the decision-making process. Today, it is the technical departments that are the game changers. The concept of fixed work hours is history.

The workforce must be alert 24x7. Thus, employees need to brush up on their skill sets to brace for the challenges of the virtual world. Let us examine the model of direct teaching through online classes- oneon-one, between the teacher and the tutee. The very paradigm may affect teaching techniques in schools and universities. Similarly, qualified doctors instruct their colleagues through Skype or other means during complex surgeries. Be it surgical strikes or wars, instructions are being disseminated to the foot soldiers through the latest technology, like the usage of GPS coordinates and Real-Time Imagery.

In such a scenario, scores of organisational structures, government or those in the private sector must adapt radically in order to survive. The workforce must continuously upgrade their skill set or face extinction. Perhaps emotions of warmth may be lost in the maze of technological evolution. The philosophy of an organisation, its goals and objectives and the behavioural pattern between the structure and the workforce have been stranded in a traffic jam of the kind one encounters in major cities of India like Gurugram. Stephen Hawking has in a rather depressing prognosis, predicted that life would be extinct on this planet on four grounds - nukes, global warming, man-made viruses or robots. Thus, the human mind should reinvent itself and current organisational behaviour and theories or prepare a blueprint to discover a sister planet to inhabit. Aristotle wrote, "We are what we repeatedly do." This paradigm will have to change for organisations to survive.

s India rises as a global power, it faces a barrage power, it races a currently of challenges and accursations of foreign interference, echoing the complexities of a world where sovereignty is contested. through policies like Atmanirbhar Bharat and calls for a multipolar world. The "American deep state," a nexus of the Pentagon, CIA, and corporate elites, according to the BJP, exemplifies hidden forces working to maintain global hegemony.

Allegations against prominent business figures and reports from groups like the OCCRP are seen as attempts to tarnish India's image and weaken Modi's leadership. Critics of these claims argue that they serve as distractions from domestic challenges, but the BJP cites historical precedents of covert interventions by such networks to justify its position. Trump's presidency also invoked the Bush Doctrine's rhetoric of "You are either with us or against us," highlighting the stark divisions in global alliances. While Modi's government has maintained a deft balance, the BJP sees this dichotomy as emblematic of the pressures India faces from global powers demanding allegiance to specific blocs.

Despite the ban on manual scavenging, which involves manually cleaning and disposing of human excreta, only 249 out of 766 districts in India have so far declared themselves "manual scavenger-free" and uploaded their certificates on the official

This information was shared by the the government in the Parliament on Tuesday.
According to the Prohibition

of Employment as Manual Scavengers and their Rehabilitation Act, 2013 (MS Act), manual scavenging has been illegal since December 2013, following a Supreme Court ruling.

The NIA had chargesheeted Haider and four others in October, in the case relating to a well-organised network of traffickers and touts involved in various illegal activities, the NIA said. The four co-accused were identified as Manjoor Alam alias Guddu, Sahil, Ashish alias Akhil, and Pawan Yadav alias Afzal alias Afroz.

All the accused were "actively involved" in sending vulnerable Indian youngsters to the Golden Triangle region in Lao PDR (Laos), where they were allegedly forced to commit cyber scams targeting European and US citizens, the NIA said. They operated through a consultancy firm, Ali International Services, which functioned as a front for human trafficking, NIA investigations have revealed. President Xi rebuffs Trump's threat of tariffs

earing up for Trump 2.0 era, Chinese President Xi Jinping on Tuesday cautioned there will be no winner in a tariff or tech wars between China and the US and vowed that Beijing would firmly safeguard its interests.

'Tariff wars, trade wars and technology wars run counter to historical trends and economic laws, and there will be no winners," Xi said while meeting the heads of 10 major international organisations, including the World Bank (WB), International Monetary Fund (IMF) and World Trade Organisation (WTO) here. During the meeting, Xi stressed on China's

principles for engaging with the US. "China will always insist on focusing on its own affairs and resolutely safeguard its sovereignty, security and development interests. Meanwhile, China's determination to promote high-level opening up will not change," he said, according to the official media reports here.

Xi's comments came in the backdrop of US President-elect Donald Trump's remarks in an NBC interview that he "got along very well" with Chinese President Xi Jinping and that the two leaders had "communication as recently as this week."

China did not confirm the conversations between Xi and Trump, who is set to take over power on January 20.

During his election campaign, Trump had

threatened to impose 60 per cent on Chinese exports to the US and also warned of imposing 10 per cent more tariffs if Beijing fails to curb fentanyl, the drug 50 times more potent than heroin and regarded as the root cause for addiction in the US. On Monday, China announced an investigation into US chipmaker Nvidia over suspected violations of the country's antimonopoly law. The investigation is widely seen as retaliation for Washington's latest curbs on the Chinese chip sector.

On China's economy which is facing headwinds of slowdown, Xi told the heads of major international economic organisations that he has full confidence to achieve this year's economic growth target of around five per cent and Beijing will continue to play its role as the biggest engine of world economic growth.

Xi said economies of all countries face their own difficulties. All countries should work together to build an open world economy, be innovation-driven, seize important opportunities such as the digital economy, artificial intelligence and low-carbon technologies, create new sources of economic growth and support cross-border flows of knowledge, technology and human

He said after more than 40 years of sustained and rapid development, China's economy has entered a stage of high-quality development and contributed about 30 per cent to world economic growth.

Prioritise national security in border areas, Xi tells officials

Chinese President Xi Jinping has directed officials to enhance the governance and high-quality development in the country's border areas prioritising national security and social stability.

It is essential to prioritise national security and social stability as the bottom-line requirement for governance in border areas, Xi said while presiding over a group study session of the Political Bureau of the Communist Party of China on Monday

He said it is essential to uphold the party's overall leadership in all aspects and throughout the entire governance process in border areas.

'No border area shall be left behind in advancing Chinese modernisation," he was quoted as saying by the state-run Xinhua news agency Tuesday.

In recent years, China has been focussing on the development of

border areas in Tibet along India and Bhutan borders by establish-ing hundreds of well-developed villages.
Tibet had built more than 600

well-off, high-standard border villages, with accessible roads, according to recent official media reports.

The main power grid is extended to all border towns as well as postal services, mobile communication networks, and safe drinking water. At Monday's meeting, Xi also highlighted the necessity of comprehensively promoting standard spoken and written Chinese and the use of unified state-compiled textbooks.

He also called for accelerating the development of an independent Chinese knowledge system for borderland studies, and deepening

research into major theoretical and practical issues related to governance in border areas, the Xinhua reported.

CEO's killing: Suspect faces weapons, forgery, other charges

uthorities arrested a sus-Appect and charged him with murder Monday in the brazen Manhattan killing of UnitedHealthcare's CEO after a quick-thinking McDonald's customer in Pennsylvania spotted a man who officers found with a gun, mask and writings linking him to the ambush.

The chance sighting at the restaurant in Altoona led to a dramatic break in a challenging but fast-moving investiga-tion that captivated the public in the five days since the shooting that shook the business

Luigi Nicholas Mangione, a 26vear-old Ivy League graduate from a prominent Maryland real estate family, had a gun believed to be the one used in last Wednesday's shooting of Brian Thompson, as well as writings suggesting anger with corporate America, police said. Late Monday, Manhattan prosecutors filed murder and other charges against Mangione, according to an online court docket. He remained jailed in Pennsylvania, where he was charged with possession of an unlicensed firearm, forgery and providing false identification to police.

Mangione was rear of the McDonald's wearing a blue medical mask and looking at a laptop computer, court documents said. A customer saw him and an employee called 911, said Kaz Daughtry, an NYPD deputy commission-er. Altoona Police Officer Tyler Frye said he and his partner recognized the suspect immediately when he pulled down his mask. "We just didn't think twice about it. We knew that was our guy," he said.

When one of the officers asked if he'd been to New York recently, he "became quiet and started to shake," according to a

criminal complaint based on their accounts of the arrest. In his backpack, police found a black, 3D-printed pistol and

a 3D-printed black silencer, the complaint said. The pistol had a metal slide and plastic handle with a metal threaded barrel. He was taken into custody at about 9:15 a.m., police said. Mangione had clothing and a mask similar to those worn by the shooter and a fraudulent New Jersey ID matching one the suspect used to check into a New York City hostel before the shooting, NYPD Commissioner Jessica Tisch NYPD Chief of Detectives Joseph Kenny said Mangione was born and raised in Maryland, has ties to San Francisco and a last known

"Our family is shocked and devastated by Luigi's arrest," Mangione's family said in a statement posted on social media late Monday by his cousin, Maryland lawmaker Nino Mangione. "We offer our prayers to the family of Brian Thompson and we ask people to pray for all involved."

One of his cousins is a Maryland state legislator and his family bought a country club north of Baltimore in the 1980s. On Monday, police blocked off an entrance to the property, which public records link to the suspect's parents. A swarm of reporters and photographers gathered outside.

Mangione went from Philadelphia to Pittsburgh after the shooting, and likely "was in a variety of locations across the

state," said Lt. Col. George

Bivens of the Pennsylvania State Police said.

'Based on everything we have seen, he was very careful with trying to stay low profile, avoid cameras — not all that successfully in some cases, but that was certainly the effort he was making," Bivens said.

In the days since the shooting,

police turned to the public for help by releasing a collection of nine photos and video including footage of the attack, as well as images of the suspect at a Starbucks beforehand. Photos taken in the lobby of a hostel on Manhattan's Upper West Side showed the suspect grinning after removing his mask, police said.

On Monday, police credited news outlets for disseminating the images and the tipster for recognising the suspect and calling authorities.

Investigators earlier suggested the gunman may have been a disgruntled employee or client of the insurer. Ammunition found near Thompson's body bore the words "delay," "deny" and "depose," mimicking a phrase used by insurance industry critics.

The gunman concealed his identity with a mask during the shooting yet left a trail of evidence, including a backpack he ditched in Central Park, a cell phone found in a pedestrian plaza and a water bottle and protein bar wrapper that police say he bought at Starbucks minutes before the attack. On Friday, police said the killer

had left the city soon after the shooting. Retracing the gunman's steps using surveillance video, investigators say the shooter rode into Central Park on a bicycle and emerged from the park without his backpack. He made his way to a bus station that offers commuter service to New Jersey and

Americans realising Trump's tariffs on Canada make life expensive: Trudeau

Canadian Prime Minister Justin Trudeau said on Monday said Americans "are beginning to wake up to the real reality that tariffs on every-thing from Canada would make life a lot more expensive" and said he will retaliate if Donald Trump goes ahead with them.

Speaking at an event put on by the Halifax Chamber of Commerce, Trudeau also said dealing with Trump will be "a little more challenging" than the last time because Trump's team is coming in with a much clearer set of ideas of what they want to do right away than after his first election win in 2016. The US president-elect has threatened to impose a 25 per cent tax on all products entering the US from Canada and Mexico unless they stem the flow of migrants and drugs.

'Trump got elected on a commitment to make life better and more affordable for Americans, and I think people south of the border are beginning to wake up to the real reality that tariffs on everything from Canada would make life a lot more

expensive," Trudeau said. On the weekend, Trump appeared in an interview with NBC's "Meet the Press", where the president-elect said he can't guarantee that his promised tariffs on key US foreign trade partners won't raise prices for American consumers.

"Let's not kid ourselves in any way, shape or form, 25 per cent tariffs on everything going to the United States would be devastating for the Canadian economy," Trudeau said.

"It would also, however, mean real hardship for Americans as well. Americans import 65 per cent of their crude oil from Canada, significant amounts of electricity. Just about all the natural gas exported from Canada goes to the United States. They rely on us from steel and aluminum. They rely on us for a range of agriculture imports.

All of those things would get more expensive."

If Trump makes good on his threat to slap 25 per cent tariffs on everything imported from Mexico and Canada, the price increases that could follow will collide with his campaign promise to give American families a break from inflation.

Economists say companies would have little choice but to pass along the added costs, dramatically raising prices for food, clothing, automobiles, alcohol and other goods. The Produce Distributors

Nearly USD 3.6 billion Canadian (USD 2.7 billion) worth of goods and services cross the border each day. Canada is the top export destination for 36 US states.

Netanyahu takes to witness stand for first time in his trial for alleged corruption

Tsraeli Prime Minister **L**Benjamin Netanyahu on Tuesday took the stand for the first time in his trial for alleged corruption setting off what will be weeks of testimony. Netanyahu said "hello" to the

judges. One judge told him he had the same privileges as other witnesses and could sit or stand as he chose.

Netanyahu will answer during his appearances to charges of fraud, breach of trust and accepting bribes in three separate cases. He is accused of promoting advantageous regulation for media moguls in exchange for favourable coverage of himself and his family. He is also accused of accepting tens of thousands of dollars' worth of cigars and cham-



pagne from a billionaire Hollywood producer in exchange for assisting him with personal and business interests. He denies wrongdoing, saying the charges are a witch hunt orchestrated by a hostile media and a biased legal system that is out to topple his lengthy rule. The trial will be an inconvenient legal spectacle for the Israeli leader at a time that he is still fighting a war in Gaza with no end in sight and as he faces with an international arrest warrant over Israel's conduct during that conflict. It is the first time an Israeli prime minister will take the stand as a criminal defendant. an embarrassing milestone for a leader who has tried to cultivate an image as a sophisticated and respected statesman. Netanyahu arrived at the packed courtroom ahead of his testimony, appearing at ease and shaking hands with mem-bers of his Likud party who

Ethnic armed group claims capture of strategic Myanmar town, control of border with B'desh

AP BANGKOK

One of the most powerful ethnic minority armed groups battling Myanmar's army has claimed the capture of the last army outpost in the strategic western town of Maungdaw, gaining full control of the 271-kilometer (168mile) -long border with Bangladesh.

The capture by the Arakan Army makes the group's control of the northern part of Rakhine state complete, and marks another advance in its bid for self-rule there. Rakhine has become a focal

point for Myanmar's nationwide civil war, in which prodemocracy guerrillas and ethnic minority armed forces seeking autonomy battle the country's military rulers, who took power in 2021 after the army ousted the elected government of Aung San Suu

Khaing Thukha, a spokesperson for the Arakan Army, told The Associated Press by text message from an undisclosed location late Monday that his group had seized the last remaining military outpost in Maungdaw on Sunday.

Outpost commander Brig. Gen. Thurein Tun, was captured while attempting to flee the battle, Khaing Thukha said. The situation in Maungdaw could not be independently confirmed, with access to the internet and mobile phone services in the area mostly cut off.

Myanmar's military government did not immediately comment.

Maungdaw, about 400 kilometers (250 miles) southwest of Mandalay, Myanmar's second-largest city, has been the target of an Arakan Army offensive since June. The group captured Paletwa and Buthidaung, two other towns on the border with Bangladesh, earlier this year. Since November 2023, the Arakan Army has gained control of 11 of Rakhine's 17 townships, along with one in

neighboring Chin state. Ann, a town in Rakhine that hosts the strategically important military headquarters overseeing the western part of the country, appears to be on the verge of falling entirely to

the Arakan Army. The group posted on the Telegram messaging app late

Friday that it had taken more than '30 military outposts, except the army's western command, which controls Rakhine and the southern part of neighboring Chin state, as well as the country's territorial waters in the Bay of Bengal.

Recent fighting in Rakhine has raised fears of a revival of organised violence against members of the Muslim Rohingya minority, similar to that which drove at least 740,000 members of their community in 2017 to flee to neighbouring Bangladesh for safety.

The Arakan Army, which is the military wing of the Buddhist Rakhine ethnic group in Rakhine state, where they are the majority and seek autonomy from Myanmar's central government, denies the allegations, though witnesses have described the group's actions to the AP and other media.

Rohingya have lived in Myanmar for generations, but they are widely regarded by many in the country's Buddhist majority, including members of the Rakhine minority, as having illegally

migrated from Bangladesh The Rohingya face a great amount of prejudice and are generally denied citizenship and other basic rights. The border between Myanmar

and Bangladesh extends from land to the Naf River and offshore in the Bay of Bengal. The Arakan Army said Sunday it had ordered the suspension of transport across the Naf River because police and local Muslims affiliated with the army were attempting to escape by boat to Bangladesh.

The rebel group has been accused of major human rights violations, particularly involving its capture of the town of Buthidaung in mid-May, when it was accused of forcing an estimated 200,000 residents, largely Rohingyas, to leave, and then setting fire to most of the buildings. It was accused of attacking Rohingya civilians fleeing fighting in Maungdaw in August.

The Arakan Army is also part of an armed ethnic alliance that launched an offensive in northeastern Myanmar last year and gained strategic territory along the border with

Kwak is among those who face opposition-raised rebellion charges along with Yoon and Kim, and the Defense Ministry suspended him last week.

Opposition parties and many experts say the martial law decree was unconstitutional. They say a president is by law allowed to declare martial law only during "wartime, war-like situations or other comparable national emergency states" but South Korea wasn't in such a situation. They argue that deploying troops to seal the National Assembly to suspend its political activities amounted to rebellion because the South Korean constitution doesn't allow a president to use the military to suspend parliament in any situation. În his martial law announcement, the conservative Yoon stressed the need to rebuild the

country by eliminating "shameless North Korea followers and anti-state forces" in a reference to his liberal rival rivals who control parliament.

Since taking office in 2022, Yoon has been on a near-constant collision course with the main liberal opposition Democratic Party, which has introduced motions seeking to impeach some of his top officials and launched a fierce political offensive against Yoon over a spate of scandals involving him and his wife. The focus of attention is how authorities could investigate Yoon and whether they can detain him.

South Korean law gives a president immunity from prosecution while in office, except for allegations of rebellion or treason. Ahandy lead has slipped through his grip but Indian Grandmaster D Gukesh will rely on his steely resolve to bounce back when he takes on enigmatic defending champion Ding Liren in the 13th game of the World Chess Championship that has been quite a roller-coaster ride for the players.

The 18-year-old Gukesh, who is the youngest challenger to the title, and the 32-year-old defending champion from China have been locked in an intriguing battle in which both have held leads for not too long. They will resume on Wednesday after a day of

The scores are currently tied at 6-6 with the first to reach 7.5 assured of the coveted crown.

After squandering away a full point lead with just three games to go, the 12th round loss was heartbreaking for the young Indian and many experts believe that he will go for an aggressive approach in his last game with white pieces under Classical time control.

It won't be off the mark to say that nerves are likely to play a crucial role in the final stretch.

The scores were tied 5-5 after game



10 but the last two decisive games thereafter have breathed new life into an otherwise well-contested match in which both players have had their chances.

After what he described as a see-saw victory in the 11th game, Gukesh was simply not himself in the 12th game and his idea to play a new position for

the first time backfired spectacularly. If the scores are still tied in the USD 2.5 million championship, tie-break games of shorter duration will be played to determine the winner.

Generally a smooth operator, Liren looked a pale shadow of himself after the 11th game and the case was no different for Gukesh when he was

completely outplayed for the first time here on Monday.

To regain composure is the name of the game here and Gukesh has shown resolve in the past. Liren, on the other hand, was in a

similar situation in the last world championships match against Ian Nepomniachtchi that he won, rallying as many as three times before eventually clinching the tiebreaker. Liren's precision was simply immaculate in the 12th game.

Gukesh did not look the same player and the Chinese took advantage of the situation right from the word go to earn high praise from many in the elite chess circles.

Five-time world champion across formats, Viswanathan Anand, called it a "very impressive game" while Liren himself said, "it was the best game that I have played in recent

While the mind games will go on in the last two games and a potential tiebreaker, American Hikaru Nakamura and world number one Magnus Carlsen feel that the balance had tilted slightly in Liren's favour. "Ding did not have to calculate a

single line in this whole game, he is being able to play the game based on positional understanding where he is very good," said Carlsen on his new youtube channel.

It might be a tightrope walk for Gukesh but the young Indian is likely to go out there and give his best in the penultimate game.




