s New Year's celebrations Adraw near, residents across North India, including Delhi and its surrounding regions, are preparing for an intense cold wave and heavy fog that could impact festivities. While the recent rains have subsided, a significant shift in weather patterns is expected to take hold in the coming days, according to the India Meteorological Department

(IMD). The IMD has forecast a period of very dense fog and a cold wave for Delhi, Punjab, Haryana, and Rajasthan between December 30 and January 2. This sudden drop in temperatures, combined with reduced visibility, is likely to disrupt New Year plans for many. In Delhi, the city's maximum temperature has already dipped to 18 degrees Celsius, about 2.4 degrees below normal, while the minimum settled at 13 degrees Celsius, six notches above the average. However, a sharp drop in the minimum temperature by around six degrees is expected over the

# **Delhi struggles with overflowing drains**

### SAUMYA SHUKLA NEW DELHI

The national Capital is plagued by the problem of a bad drainage system which consistently leaves a stench in many areas and overflows with even a drop of rainfall. Exacerbating the problem, the civic authorities responsible to desilt and clean them to ensure that it don't make the area inhabitable and hamper the lives of the common people, often shrug their responsibility.

One such drain flows from Lado Sarai and Chattarpur area and through most of the posh South Delhi areas. It is open infront of the Central Industrial Security Force (CISF) camp and the Saket metro station. Residents and people working in the area complain of persistent foul smell from the drain, even as they are forced to carry on with their lives amid the stench.

Many do not even remember if they ever saw civic agencies undertaking cleaning work of the drain, which lies right in the heart of the city. Some suggest it was years ago when they saw such an activity. An autodriver who parks his vehicle

right near the drain said that it emits a foul smell, making it very hard to work. "You can get the smell yourself. We smell it daily but what can we do? We have to work here only because customers come here," Lakhinder Singh said.

He resides in Sangam Vihar with his family, which is also not free from the foul smell. A resident of a nearby colony expressed his dissatisfaction with the government over not being able to carry out a cleaning drive on a regular basis. "As far as I remember I have only seen any cleaning of this drain three years ago. Since then, at least three monsoons have passed when waterlogging becomes a very big issue. This drain overflows during the monsoon and creates a very bad situation in the area, especially for people who have their homes here," he said

Another person, who puts up his food stall nearby, recalled how summer makes things even worse when it smells even worse. "A lot of people and tourists come to the Saket area and hence we put our stall here so we can earn some money but sometimes it smells so bad that customers do not want to stand here

and eat. The government agencies should clean such big drains," he said, adding that when foreigners come it tarnishes our image on a global level. Residents in the Khanpur and Sainik Farms area who are experiencing discomfort in their normal lives on a daily basis due to the construction work of Delhi Metro share how the drain is making their lives even worse.

When the smell from the drain reaches even our home, which is not located very close to it, you can assess how it must be," a man residing in Sainik Farms said, adding that it also overflows in monsoon causing waterlogging in the streets and making it hard to travel through the stretch.

Even as there are multiple agencies in Delhi that manage the city's big and small drains, the high court has called for a single agency to look after them. Moreover, the current design of the drainage system, which was put in place almost 50 years ago in 1976, needs to be overhauled since it can only easily drain 50mm of rain in a day with the city coming to its knees whenever it witnesses massive intense rains.

# **Diaspora voter turnout disappoints despite high registrations**

Overseas Indians showed great enthusiasm in registering as electors, with nearly 1.2 lakh enrolling in the voter list, but very less people turned up to exercise their franchise in the Lok Sabha elections this year. As per the data released by the Election Commission, as many as 1,19,374 registered as overseas electors in 2024, with Kerala witnessing the highest registrations at 89,839. In 2019, as many as 99,844 had registered as overseas electors.

The poll authority said only 2,958 overseas electors flew down to participation in the latest polls was

India to participate in the largest democratic exercise in the world. Of these, an overwhelming 2,670

were from Kerala alone. Several large states such as Karnataka, Uttar Pradesh, and Tamil Nadu saw zero turnout of overseas electors. Gujarat, Prime elections. Minister Narendra Modi's home state, saw only two out of 885 overseas electors casting their votes in the Lok Sabha elections. The same was the story in Maharashtra, where only 17 of the 5.097 NRI electors voted. Despite an increase of little over 19,500 registered overseas electors since the 2019 general election, their

While NRI voters is a generic term, the EC describes them as overseas electors — Indians living abroad for a variety of reasons and eligible to vote in the Lok Sabha, assembly and other direct According to the existing electoral law, registered NRI voters have to come to their respective Lok Sabha and assembly constituencies to cast a vote. They have to show their original passport as proof of their identity. Data show that while there were 7,927 registered NRI electors in Andhra Pradesh, only 195 flew down to vote. According to EC, while eligible Indian citizens who



enrol in electoral rolls are called electors, those who actually exercise their franchise are described as voters. In Assam, none of the 19 registered electors voted. Similar was the case with Bihar where none of the 89 registered NRI electors exercised their franchise. Goa too witnessed a similar scenario with none of its 84 voters casting their ballots.

In August 2018, the 16th Lok Sabha passed a bill to allow proxy voting rights to eligible overseas Indians. The bill, however, could not be brought to the Rajya Sabha. In 2020, the EC proposed to the Union Law Ministry to extend the person, the EC said.

Electronically Transmitted Postal Ballot System (ETPBS) facility, so far available only to service voters, to eligible overseas Indian voters as well. It would require changes in the election rules. But the government has so far not taken a call on the issue.

The EC had then told the government that it had been receiving several representations from the Indian diaspora to facilitate voting through postal ballots. The electors cited travel costs, compulsions of employment overseas, and education, among other things, as the reasons for their inability to cast their votes in



Tonsillitis is a painful infection of the tonsils — two lymph node-rich glands in the back of the throat. Symptoms of tonsillitis include swollen tonsils, sore throat, and difficulty swallowing.

The study found that digital assessments may not be reliable, thus increasing the risk of overor undertreatment of a sore throat.

Since tonsillitis is commonly treated with antibiotics, digital assessments

may not be as reliable as warranted, said the team from

physical examinations in the University of Gothenburg determining whether antibiotic treatment is whether in Sweden. To determine whether a

patient needs antibiotics, doctors use the so-called Centor Criteria - fever, tender and swollen lymph nodes in the angles of the jaw, and inspection of the tonsils. However, it has been unclear how well these criteria can be assessed during digital healthcare consultations compared to traditional inperson consultations, the researchers said.

"Our study shows that although digital healthcare consultations are convenient for many patients, they are not reliable enough to assess tonsillitis. To ensure a correct diagnosis and treatment, it is still important to conduct a physical examination," said Patrycja Woldan-Gradalska, a doctoral student at

Sahlgrenska Academy at the university.

The study, published in the journal Infectious Diseases, included 189 patients who sought care at healthcare and urgent care clinics in Sweden between January 2020 and October 2023.

Each patient in the study underwent two assessments: a digital medical assessment via video and a physical examination conducted by another doctor.

The results showed that digital healthcare consultations are not sufficient to assess some of the most important criteria, such as tonsil inspection and lymph node examination.



Replacing the century-old Criminal laws with a new set of legislations for introducing a modern and technology-dri-ven criminal justice system, rolling out the controursial rolling out the controversial Citizenship (Amendment) Act and fire-fighting to check unabated violence in Manipur kept the Union home ministry busy in 2024.

Assisting the Election Commission in holding the assembly elections in Jammu and Kashmir without major incidents and bringing down the violence in Naxal-affected states and northeastern region are the other key highlights of the country's crucial ministry. While the population enumeration exercise Census continues to be on hold for past four years as no decision has been taken by the ministry as to when it will be carried out, the ministry created five year districts in Ladakh and renamed Port Blair in Andaman and Nicobar Islands as Sri Vijaya Puram during the vear.

The three new criminal laws -Bharatiya Nyaya Sanhita, the Bharatiya Nagarik Suraksha Sanhita and the Bharatiya Sakshya Adhiniyam - replaced the colonial-era Indian Penal Code, the Code of Criminal Procedure and the Indian Act of Evidence 1872

respectively. The new laws came into effect from July 1. Home Minister Amit Shah, who piloted the legislations, said the new laws would give priority to providing justice, unlike the colonial-era laws that gave primacy to penal action.

Shah said the laws were not just about changing the nomenclature but bringing about a complete overhaul. "Soul, body and spirit of the new laws are Indian," he said. The new laws brought in a modern justice system incorporating provisions such FIR. Zero online as registration of police complaints, summonses through electronic modes such as SMS and mandatory videography of crime scenes for all heinous crimes.

According to home ministry officials, the new laws have

tried to address some of the current social realities and crimes and are going to provide a mechanism to effectively deal with these, keeping in view the ideals enshrined in the Constitution. The CAA, which was enacted in December 2019 for granting Indian nationality persecuted Hindu, Sikh, Jain, Buddhist, Parsi and Christian migrants from Bangladesh, Pakistan and Afghanistan who came to India on or before December 31, 2014, was rolled out in March and the first set of 14 people were granted Indian citizenship under the law in May. After the enactment in 2019, the CAA got the president's assent a few days later but the rules under which the Indian citizenship were supposed to be granted were issued only on March 11 after over a delay of four years. The passing of the CAA in 2019 sparked protests in different parts of the country

# ISRO set to launch historic SpaDEx mission, demonstrating space docking capability

SRO is set to launch two satellites on Monday night from the Sriharikota spaceport to demonstrate docking and undocking of spacecraft in orbit, which will make India the fourth country in the world to achieve the feat. The Indian Space Research Organisation's (ISRO) warhorse rocket Polar Satellite Launch Vehicle (PSLV) will place the two satellites - SDX01 and SDX02 - in a 476-km circular orbit and attempt the Space Docking Experiment (SpaDEx) in the first week of January, the space agency officials said.

This mission will mark India's entry into the

The SpaDEx mission is expected to be a stepping stone for India's future in space endeavours exploration which include getting rocks and soil from the moon on Earth, the proposed Bharatiya Antariksha Station and landing an astronaut on the lunar surface.

Only the US, Russia and China have mastered space docking technologies. "The docking technologies. primary objective of the SpaDeX mission is to develop and demonstrate the technology needed for

exclusive league of nations rendezvous, docking, and undocking of two small spacecraft (SDX01, which is the Chaser, and SDX02, the Target) in a low-Earth circular orbit," an ISRO official said.

The secondary objective of includes mission the demonstration of the transfer of electric power between the docked spacecraft, which is essential for future applications such as in-space robotics; composite spacecraft control and payload operations after undocking. "This capability is vital for

lunar India's and interplanetary missions. Docking technology enables multi-launch missions and

supports future human spaceflight," Singh said.

After the demonstration of docking and undocking experiments, the two satellites will continue to orbit the Earth for standalone missions for two years. The SDX01 satellite is equipped with a High Resolution Camera (HRC) and SDX02 has two payloads - Miniature Multispectral (MMX) Radiation payload and H Monitor (RadMon).

These payloads will provide high-resolution images, natural resource monitoring, vegetation studies and onorbit radiation environment measurements which have numerous applications, ISRO said

2005-06, However, in Natarajan proposed for the first time in theory that there must be another way for black holes to form, bypassing the formation of a star first, evidence in support of which she and her colleagues at Yale would go on to publish in Nature Astronomy and The Astrophysical Journal Letters in December 2023. In a 2017 paper, Natarajan's team predicted what the James Webb Space Telescope might detect, much before its launch in December 2021 by the US space agency NASA. Looking at images of the early universe, the team found a galaxy 'UHZ1' harbouring an overmassive

black hole at its centre, which possessed all the properties as predicted - it was a few million times the mass of the Sun, heavier than expected and firmly in its place already in the very young universe. "And so, if the first black hole is just a few times the mass of the Sun, and the only way to form these seeds was from the explosion of the first stars as per the traditional path very early in the universe, then there's very little time in the universe to grow to a billion solar masses. How can you grow that much, so fast? There has to be a resolution, Natarajan, recounting the time she came up with the idea, said.

"That was what motivated us to ask, 'Ok, is there has to be another way to make a black hole whose birth mass, or the mass of a black hole when it's born, is not a few times the

mass of the Sun, but actually 10,000 or even 100,000 times the mass of the Sun, so that then you don't have to grow that much to account for what is seen already," she said. The idea is referred to as direct collapse.' The work brought Natarajan multiple accolades, including being featured on TIME's 100 Influential People of the Year list - "unusual" for a scientist. She was also elected a fellow to the American Academy of Arts and Sciences.

"A lot of the creative pursuits, such as poetry, music, astronomy, don't generate monetisable returns in the short-term, per se. But that does not make them any less valuable," she said. Natarajan is also noted for her philosophy on mapping dark matter in clusters of about a thousand galaxies, held together by gravity.

# Danapur division completes 100 years of service, celebrations planned

The historic Danapur division of the Indian Railways network that manages some of the lines and stations originally set up nearly 160 years ago will complete an eventful journey of 100 years on January 1. The division has planned a grand celebration on January 31 at the old Jagjivan Stadium where it will also host an exhibition showcasing its rich history through archival documents, photographs and railway artefacts.

We are also working on a coffee table book on the centenary of the Danapur division. Besides going through our old documents and photographs kept in different departments at the DRM office, we are also trying to crowd-source relevant material for the book," said a senior Railway Ministry official of the Danapur division. Danapur (earlier Dinapore) division was established on January 1, 1925. Its office is located in a majestic building erected in

The old stations at Fatuha, Bakhtiarpur, Barh, Mokama, Gulzarbagh and Bihta, located on a section of this line which

falls within the limits of archival material which can be Danapur division, were built in later years, they said. The current Danapur division spans the rail network from Jhajha to Kuchman.

The Mughalsarai rail network was also part of it before it was carved out as a separate division in later decades after Independence. Till the redevelopment of Patna Sahib station a few years ago, a plaque bearing 'PATNA 1861' embedded on a wall of its building was visible from the platform.

The then East Indian Railway (EIR) system laid the line from Howrah to Delhi, and operations on it begun phase-wise from early 1850s to late 1860s, which included construction of the iconic bridge over Sone river at Koelwar and a bridge each over Yamuna at Allahabad and Delhi, all major feats of civil and

railway engineering. A team at the Danapur DRM office is currently busy scouring through old files and records, searching for old photographs, correspondences and other used in the planned exhibition and the coffee table book.

The red-and-white building located near Danapur station is the centrepiece of a quaint railway colony at Khagaul, dotted with many handsome British-era structures such as the official residence of the DRM, 'Rail Sadan', old railway school and hospital, and a few beautiful churches, besides humble railway colonies.

Danapur division was put under the Kolkata-based Eastern Railway (ER) established in 1952. From 2002 onwards, it came under East Central Railway (ECR), carved out of ER, with headquarters at Hajipur in north Bihar.

According to old publications, after the government of India took over the management of EIR, with effect from 1925, it was split into six divisions -- Howrah, Åsansol and Dinapore, known as lower divisions, and Allahabad, Lucknow and Moradabad, known as upper divisions.

# **Shifting stance**

Trump's support for H-1B visas marks a major shift, offering relief to US companies and Indian tech workers alike

oliticians seldom walk their talk and do not mind taking u-turns even if it means reversing their own previous positions. Donald Trump the US President elect is the latest example. Trump has expressed his support for the H-1B visa program, which facilitates the entry of skilled foreign workers into the United States. This development comes as a marked departure from his earlier stance during his first presidential term, where he labeled the program 'very bad' and 'unfair' to American workers. Trump's latest remarks not only align him with tech magnate Elon Musk but also have significant implications for Indian professionals and US companies. The controversy surrounding the H-1B program reignited when Musk took to social media to vociferously defend the program against criticisms from immigration hardliners. Musk's electric vehicle company, Tesla, alone secured 724 H-1B visas this year, underscoring his vested interest in maintaining the program. Trump echoed Musk's sentiments in an interview,

The move

also counters recent fears of stringent immigration policies that could hinder their aspirations. The US technology sector, which has long relied on the H-1B visa program to address skill shortages, is likely to welcome Trump's shift. Companies like Google, Microsoft, and Tesla have consistently advocated for the continuation of the program, citing a lack of homegrown talent to meet the industry's demands. Musk's pointed critique of American culture's celebration of mediocrity over excellence highlights the role of foreign talent in driving innovation and maintaining the US's competitive edge globally. Trump's stance, however, has drawn ire from far-right activists and prominent figures within his own party. Critics, including Steve Bannon and Nikki Haley, argue that prioritising foreign workers undermines American labour and exacerbates domestic unemployment. Trump's endorsement of the H-1B visa program reflects a pragmatic shift rather than an ideological reversal. Recognising the indispensable role of skilled immigrants in the US economy, his administration's move signals a commitment to fostering economic growth and maintaining technological leadership. hubris Humanity looks to the stars but fails to confront the crises that are unfolding on its soil.The year 2024 will be remembered as one that exposed the profound contradictions of our age. The Western world is at war with itself, consumed by political divisions, economic inequality, and an incapacity to respond to the genuine challenges of our time. The rise of populism, authoritarianism, and unchecked technological advancement portends a future in which the divide between the rich and the poor widens, and the planet teeters on the brink of environmental collapse. In this environment, the struggle for survival will no longer be merely political-it will be existential. We are increasingly forfeiting our collective responsibility, continuing to vie for better accommodations in a sinking vessel, fully aware that we are all doomed to submerge. As we enter 2025, may we dare to confront the tumult of our times with the audacity to question everything, forging a future that challenges the very forces seeking to dominate us. # Musk causes uproar for backing Germany's far-right party AP BERLIN

Tech entrepreneur Elon Musk caused uproar after backing Germany's far-right party in a major newspaper ahead of key parliamentary elections in the Western European country, leading to the resignation of the paper's opinion editor in protest. Germany is to vote in an early election on February 23 after Chancellor Olaf Scholz's three-Chancellor Olar Schoizs inree-party governing coalition col-lapsed last month in a dispute over how to revitalise the coun-

try's stagnant economy. Musk's guest opinion piece for Welt am Sonntag —a sister publication of POLITICO owned by the Axel Springer Group — published in German over the weekend, was the sec-ond time this month he supported the Alternative for Germany, or AfD.

'The Alternative for Germany (AfD) is the last spark of hope for this country," Musk wrote in his translated commentary. He went on to say the far-right

party "can lead the country into a future where economic pros-perity, cultural integrity and technological innovation are not just wishes, but reality." The Tesla Motors CEO also

wrote that his investment in Germany gave him the right to comment on the country's condition.

The AfD is polling strongly, but its candidate for the top job, Alice Weidel, has no realistic chance of becoming chancellor because other parties refuse to work with the far-right party. An ally of US President-elect Donald Trump, the technology billionaire challenged in his opinion piece the party's public image.

"The portrayal of the AfD as right-wing extremist is clearly false, considering that Alice Weidel, the party's leader, has a same-sex partner from Sri Lanka! Does that sound like Hitler to you? Please!' Musk's commentary has led to

a debate in German media over the boundaries of free speech, with the paper's own opinion editor announcing her resignation, pointedly on Musk's social media platform, X.

Air Canada flight catches fire on landing, all passengers evacuated safely

A n Air Canada flight coming from St John's City on Newfoundland Island had a rough landing at the Halifax airport in Goffs in Nova Scotia province that saw the aircraft skid down

A statement issued by the airport said the inci-dent involved Air Canada Flight 2259, which was operated by PAL Airlines, CBC News reported. The incident happened around 9:30 pm local time. The statement does not say how many people were on the plane.

The people on board were evacuated, and then taken to a hangar to be checked out by paramedics, CBC News said.

Due to the incident, the Halifax airport was reopened.

# North Korea's Kim vows toughest anti-US policy before Trump takes office

North Korean leader Kim Jong Un said he will implement the "toughest" anti-US policy, less than a month before Donald Trump takes office as US president, the country's state media reported Sunday.

Trump's return to the White House raises prospects for high-profile diplomacy with North Korea. During his first term, Trump met Kim three times for talks on the North's nuclear programme.

Many experts however say a quick resumption of Kim-Trump summitry is unlikely as Trump would first focus on conflicts in Ukraine and the Middle East. North Korea's support for Russia's war against Ukraine also poses a challenge to efforts to revive diplomacy, experts say.

During a five-day plenary meeting of the ruling Workers' Party that ended Friday, Kim called the US "the most reactionary state that regards anti-communism as its invariable state policy." Kim said that the US-South Korea-Japan secu rity partnership is expanding into "a nuclear mil-

itary bloc for aggression." "This reality clearly shows to which direction we should advance and what we should do and how," Kim said, according to the official Korean

Central News Agency. It said Kim's speech "clarified the strategy for the toughest anti-US counteraction to be launched aggressively" by North Korea for its long-term national interests and security.

KCNA didn't elaborate on the anti-US strategy But it said Kim set forth tasks to bolster military capability through defence technology advancements and stressed the need to improve the mental toughness of North Korean soldiers. The previous meetings between Trump and Kim had not only put an end to their exchanges of fiery rhetoric and threats of destruction, but they developed personal connections. Trump once famously said he and Kim "fell in love." But their talks eventually collapsed in 2019, as they wrangled over US-led sanctions on the North.



North Korea has since sharply increased the pace of its weapons testing activities to build more reliable nuclear missiles targeting the US and its allies

The US and South Korea have responded by expanding their military bilateral drills and also trilateral ones involving Japan, drawing strong rebukes from the North, which views such USled exercises as invasion rehearsals.

Further complicating efforts to get North Korea to rid itself of nuclear weapons is its deepening military cooperation with Russia.

According to US, Ukrainian and South Korean assessments, North Korea has sent more than 10,000 troops and conventional weapons systems to support Moscow's war against Ukraine. There are concerns that Russia could give North Korea advanced weapons technology in return, including help to build more powerful nuclear missiles

Russia and China, locked in separate disputes with the US, have repeatedly blocked US-led pushes to levy more UN sanctions on North Korea despite its repeated missile tests in defiance of UN Security Council resolutions.

Last month, Kim said that his past negotiations with the United States only confirmed Washington's "unchangeable" hostility toward his country and described his nuclear buildup as the only way to counter external threats.

# Azerbaijan's president says crashed jetliner was shot down by Russia unintentionally

zerbaijan's President Ilham Alivev said Sunday that the Azerbaijani airliner that crashed last week was shot down by Russia, albeit unintentionally, and criticised Moscow for trying to "hush up" the issue for days. "We can say with complete clarity that the plane was shot down by Russia. ( ... ) We are not saying that it was done intentionally, but it was

done," he told Azerbaijani state

television Aliyev said that the airliner, which crashed Wednesday in Kazakhstan, was hit by fire from the ground over Russia and "rendered uncontrollable by electronic warfare." Aliyev accused Russia of trying to "hush up" the issue for several days, saying he was "upset and surprised" by versions of events put forward by Russian officials.

"Unfortunately, for the first three days we heard nothing from Russia except delirious



versions," he said.

The crash killed 38 of 67 people on board. The Kremlin said that air defence systems were firing near Grozny, the regional capital of the Russian republic of Chechnya, where the plane attempted to land, to deflect a Ukrainian drone strike. Aliyev said Azerbaijan made three demands to Russia in connection with the crash. "First, the Russian side must apologise to Azerbaijan. Second, it must admit its guilt.

Third, punish the guilty, bring them to criminal responsibility and pay compensation to the Azerbaijani state, the injured

passengers and crew members," he said. Aliyev noted that the first demand was "already fulfilled" when Russian President Vladimir Putin apologized to

him on Saturday. Putin called the crash a "tragic incident" though stopped short of acknowledging Moscow's responsibility. Kremlin spokesman Dmitry

Peskov told Russian state media on Sunday that Putin had spoken to Aliyev over the phone again, but did not provide details of the conversation. The Kremlin also said a joint investigation by Russia, Azerbaijan and Kazakhstan has begun at the crash site near the city of Aktau in Kazakhstan. The plane was flying from Azerbaijan's capital, Baku, to Grozny when it turned toward Kazakhstan, hundreds of kilometers (miles) across the Caspian Sea from its intended destination, and crashed while making an attempt to land. Passengers and crew who sur-

vived the crash told Azerbaijani media that they heard loud noises on the aircraft as it was circling over Grozny.

Dmitry Yadrov, head of Russia's civil aviation authority Rosaviatsia, said Friday that as the plane was preparing to land in Grozny in deep fog, Ukrainian drones were targeting the city, prompting authorities to close the area to air traffic. The crash is the second deadly civil aviation accident linked to fighting in Ukraine. Malaysia Airlines Flight 17 was downed with a Russian surface-to-air missile, killing all 298 people aboard, as it flew over the area in eastern Ukraine controlled by Moscow-backed separatists in 2014.

Russia has denied responsibility, but a Dutch court in 2022 convicted two Russians and a pro-Russia Ukrainian man for their role in downing the plane with an air defence system brought into Ukraine from a Russian military base.

A Pakistan paramilitary soldier has been killed and 11 others injured in firing by the Afghan Taliban forces at the border posts of Pakistan troops, days after strikes by Pakistan targeted the banned Tehreek-e-Taliban (TTP) militants.

According to defence sources, the Afghan troops resorted to "unprovoked fire on multiple Pakistani border posts" in the Upper Kurram district on Saturday morning.

They fired at posts in Ghozgarhi, Matha Sangar, Kot Ragha and Tari Mengal areas using both light and heavy weaponry, sources said. Pakistani forces retaliated, inflicting significant losses on the other side as seven to eight personnel of the Afghan forces were killed in the exchange of fire, sources added. However, in the fire exchange, a "Frontier Constabulary (FC) soldier was killed and 11 others were injured". The incident of firing occurred days after Pakistan targeted terrorist positions in Paktika province of Afghanistan to punish the banned TTP militants, allegedly using Afghan soil to train and attack Pakistan.

The Saturday attack came after militants made an infiltration attempt on Friday night, using the posts controlled by the Afghan Taliban to cross into Pakistani territory, but the attempt was thwarted. "The firing was effectively responded to and there are confirmed reports of heavy losses on the Afghan side with over 15 militants killed and many others wounded," according to sources.

t least three migrants died early At least unce ingrand and Sunday while attempting to cross the English Channel to Britain from northern France, authorities said. The deaths were confirmed after an early morning rescue operation involving

French emergency services and the navy's "Dauphin" helicopter. Around 50 people were stranded in the water and on the beach near Sangatte at around 6 am, according to the regional prefecture. Rescuers assisted 45 individuals, including four who were transported to hospitals.

Three unconscious people were pulled from the water but could not be revived, despite efforts by medical An investigation has been teams. opened by prosecutors in Boulognesur-Mer.

Jacques Billant, the prefect of Pas-de-Calais, said an overcrowded boat may have contributed to the tragedy.

There were more people attempting to board than the boat could hold." he said during a press conference Sunday. Sunday's tragedy comes during a spike in Channel crossing attempts as 2024 draws to a close. Officials have noted a significant increase in attempted crossings over the past days. "Since December 24, 23 maritime

incidents have been thwarted by internal security forces, saving over 1,000 lives," said Billant. "But crossing attempts continue, despite extremely dangerous sea conditions. The water is icy, so survival time in the water is very short." This year has been one of the deadliest for migrants attempting the perilous journey between France and England, one of the world's busiest shipping lanes, with at least 76 deaths reported by officials. Billant blamed human traffickers for putting lives at risk. "These are low-quality boats put into the water solely for profit by these criminal networks, which have no regard for the lives of these children, women and men," he said.

In November, a French court convicted 18 people in a migrant-smuggling trial that shed light on the lucrative but often deadly clandestine business of transporting people across the English Channel. Despite French and British efforts to stop it, the route remains a major smuggling corridor for people fleeing conflict or poverty. Migrants favour the UK for reasons of language, family ties or perceived easier access to asylum and work

# Musk vows to 'go to war' to defend H-1B visa programme; Trump sides with him

 $E_{\text{port from President-elect}}^{\text{lon Musk has received sup-}}$ Donald Trump on his stance on H-1B visas, a day after the tech billionaire vowed to "go to war" to defend the programme used to bring skilled foreign workers to the US.

Musk, who along with Indian-American tech entrepreneur Vivek Ramaswamy has been tapped by Trump to lead his Department of Government Efficiency (DOGE), argued last week that foreign workers are needed for tech companies like Musk's SpaceX and Tesla. Musk on Friday blasted a user on X who used a video of Musk discussing SpaceX processes to go after the billionaire's stance on the visa programme.

'The reason I'm in America along with so many critical people who built SpaceX, Tesla and hundreds of other companies that made America strong is because of H1B," Musk wrote on X.

He also used a profane quote from Tom Cruise's character in the movie "Tropic Thunder" to attack his critics.

"Take a big step back and F— - YOURSELF in the face," Musk said. Trump on Saturday sided with

Musk, saying he fully backs the programme opposed by some of his supporters. "I've always liked the visas, I

the visas. That's why we have them," Trump told the New

York Post newspaper. "I have many H-1B visas on my properties. I've been a believer in H-1B. I have used it many times. It's a great programme,' Trump said

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China.

The tech industry has long called for more H-1B visas to attract highly skilled workers to have always been in favour of the US. Trump's first adminis-

tration restricted the programme in 2020, arguing that it allows businesses to replace Americans with lower-paid foreign workers.

Musk, himself once on an H-1B visa and whose electric vehicle company Tesla has hired workers using the programme, defended the tech industry's need to bring in foreign workers

"Anyone – of any race, creed or nationality – who came to America and worked like hell to contribute to this country will forever have my respect America is the land of freedom and opportunity. Fight with every fiber of your being to keep it that way!" he wrote on X on Friday.



Musk also lashed out at those who prioritise personal gain over the well-being of the country.

those who want America to win. For those who want America to lose for their own personal gain, I have no respect. Zero," he said in a sep-

Musk has been consistently posting on X in favour of the programme.

# Palestinian shot dead in her West Bank home, family blames Palestinian security forces

### AP JENIN (WEST BANK)

Palestinian woman was Ashot and killed in her home in the volatile northern West Bank town of Jenin, where the Palestinian Authority is carrying out a rare campaign against militants.

The family of Shatha al-Sabbagh, a 22-year-old journalism student, said she was killed by a sniper with the Palestinian security forces late Saturday while she was with her mother and two small children. They said there were no militants in the area at the time. A statement from the Palestinian security forces said she was shot by "outlaws" -the term it has been using for local militants who have been battling Israeli forces in recent years. The security forces condemned the shooting and

vowed to investigate it. Separately, a fourth infant has died of hypothermia in the Gaza Strip, where hundreds of thousands of Palestinians displaced by nearly 15 months of war are huddled in tents along the rainy, windswept coast, while an Ísraeli strike on a hospital that the army said was being used by militants killed seven people.

Western-backed The Palestinian Authority exercises limited self-rule in parts of the Israeli-occupied West Bank. It is deeply unpopular among Palestinians, largely because it cooperates with Israel on security matters, even as Israel accuses it of incitement and of generally turning a blind eye to

Israeli report details abuse of hostages held in Gaza: The war began when Hamas-led militante stormed militants stormed into southern Israel on October 7, 2023, killing some 1,200 people, mostly civilians, and abducting around 250, including women, children and older adults. Around 100 hostages are still inside Gaza, at least a third of whom are believed to be dead. Israel's Health Ministry released a report Sunday detailing what it said was widespread physical, psychological and sexual abuse of people who had been held in Gaza.

The report, based on the findings of doctors who treated some of the more than 100 hostages released during a ceasefire last year, said the captives — including children - had been subjected to "severe physical and sexual

abuse, such as beatings, isola-tion, deprivation of food and water, branding, hair-pulling, and sexual assault." The findings, which are to be

sent to the United Nations, could increase pressure on to a ceasefire and hostage release with Hamas. Families of the hostages and their supporters have held weekly mass demonstrations for months, and diplomats have reported recent progress in the longrunning indirect talks.

Strike on a hospital in Gaza City kills 7: An Israeli strike on the upper floor of a hospital in Gaza City on Sunday killed at least seven people and wounded several others, according to the Civil Defense, first responders affiliated with the Hamas-run government. The Israeli military said it struck a Hamas control centre inside the building, which it said was no longer serving as a hospital.

Israel's offensive has killed over 45,000 Palestinians and wounded more than 1,00,000, according to local health authorities

They say women and children make up more than half the fatalities but do not distinguish between militants and civilians in their count. Israel says it has killed over 17,000 militants, without providing evidence.

Netanyahu, 75, is among a cohort of older world leaders, including US President Joe Biden, 82, and Presidentelect Donald Trump, 78, whose health and physical fitness are under deep scrutiny both at home and abroad because of their advanced age and the effect that could have on their leadership.

Netanyahu, who has had a string of health issues in recent years, has gone to great lengths to bolster a public image of himself as a fully healthy, energetic leader. During his trial this month he boasted about working 18hour days, even if those long hours are accompanied by a cigar. But as Israel's longest-serving leader, such a grueling workload over a total of 17 years in power could also take a toll on his wellbeing.

The procedure has already had a fallout: Netanyahu's lawyer Amit Hadad said in a letter to the court the Israeli prime minister would be fully sedated for the procedure and would be hospitalized for "a number of days," asking that his three days of testimony this week be canceled. The court agreed. An acting prime minister will take over for Netanyahu while he is undergoing the procedure, according to an official familiar with the arrangements, although it wasn't immediately clear who will step in. The official spoke on condition of anonymity because they weren't authorized to discuss the details behind the procedure with the media.

With so much at stake in the turbulent

region, Netanyahu's health in wartime is a concern for both Israelis and the wider world

Netanyahu to undergo prostrate surgery

Prostate issues are common for older men, and recovery can be quick: According to Netanyahu's office, the Israeli leader was diagnosed with a urinary tract infection on Wednesday stemming from a benign enlargement of his prostate. The infection was treated successfully with antibiotics but a procedure on Sunday will remove his prostate.

Complications from prostate enlarge ment are common in men in their 70s and 80s, Dr. Shay Golan, head of the oncology urology service at Israel's Rabin Medical Center, told Israeli Army Radio.

He said that an enlarged prostate can block proper emptying of the bladder, leading to a build-up of urine that can then lead to an infection or other complications. After medicinal treatment, doctors can recommend a procedure to remove the prostate to prevent future blockages, Golan said.

In Netanyahu's case, because the prostate is not cancerous, Golan said doctors will likely perform an endoscopic surgery, which is carried out by inserting small instruments into a body cavity, rather than making any surgical cuts in the abdomen to reach the prostate.

The procedure lasts about an hour, Golan said, and recovery is quick. Golan also said that aside from catheter use for one to three days after the procedure, patients can return to normal activity without any significant limitations.

Netanyahu has had some health issues before, including a heart condition: Netanyahu insists he is in excellent health and his office has worked to craft a public image that backs that up. It releases footage of him touring war zones in full protective gear

flanked by gruff military officers, or meeting with defense officials on windswept hilltops in youthful dark shades and puffer jackets.

But that image was shattered last year when Netanvahu's doctors revealed that he had a heart condition, a problem that he had apparently long known about but concealed from the public. A week after a fainting spell, Netanyahu was urgently fitted with a pacemaker to control his heartbeat. Only then did staff at the Sheba Medical Center reveal that Netanyahu has for years experienced a condition that can cause irregular heartbeats.

That revelation came at a time when Netanyahu was dealing with massive anti-government protests. The news about a chronic heart problem stoked further anger and distrust at a time of extreme political polarization in Israel. Last year, Netanyahu was rushed to the hospital for what doctors said likely was dehydration, where he stayed overnight, prompting his weekly Cabinet meeting to be delayed.

Earlier this year, Netanyahu underwent hernia surgery, during which he was under full anesthesia and unconscious. His close confidant, Justice Minister Yariv Levin, served as acting prime minister during the operation.

The prostate removal comes at a turbulent time in the region: As Israel's leader, Netanyahu is at the center of major global events that are shifting the Middle East. With the dizzying pace of the past 14 months, being incapacitated for even a few hours can be risky in the current regional maelstrom.

Netanyahu will be in hospital at a time when international mediators are pushing Israel and Hamas to reach a ceasefire in Gaza as violence there rages on and fighting between Israel and Yemen's Iran-backed Houthi rebels intensifies.

# Lankan HR body cries foul over denial to visit Rohingyas PTI COLOMBO

Sri Lanka's Human Rights Commission has written a letter to President Anura Kumara Dissanayake alleging that they have been denied permission to meet Rohingya refugees staying at a military camp since last week. "On December 26, a team of officials from

the Human Rights Commission of Sri Lanka (HRCSL), including a director, attempted to monitor the detention conditions of these asylum seekers at the Sri Lanka Air Force Camp in Mullaitivu in the Northern Province. However, they were refused access to the asylum seekers," the

letter said. The Sri Lanka Navy on December 20 said they had rescued over 100 Rohingyas from Myanmar in a distressed condition in the seas off the island's northeastern coast.

They were spotted by local fishermen in the Mullaithivu district's Vellamullivaikkal area. The government later said their arrival could be due to a human trafficking racket. "Investigations revealed that they had deliberately landed here and we consider them as illegal immigrants, Deputy Minister of Foreign Affairs Arun Hemachandra was quoted as saying by The Sunday Times here. The HRCSL letter stated that the powers and functions of the commission extend not only to Sri Lankan citizens but to "any person" detained within Sri Lanka. The commission said it had the statutory authority to access the said Air Force Camp and monitor the detention conditions of all asylum seekers, including the children present there. The HRČSL has summoned the controller

general of immigration and emigration and other responsible officials who obstructed the commission's attempts to monitor the detention conditions to appear before it on December 31 to provide an explanation.

# Indian economy to grow at 6.5-6.8 per cent in Foodgrain output set to scale new peak in FY25 on higher domestic consumption: Deloitte 2025 as farm sector eyes 4 per cent growth

### PTI NEW DELHI

Indian economy is likely to grow at 6.5-6.8 per cent this fiscal and slightly higher between 6.7-7.3 per cent in FY2026, boosted by domestic consumption, Deloitte said on Sunday.

Deloitte India Economist Rumki Majumdar said the growth in the first half of the fiscal year 2025 turned out to be slower than estimated as election uncertainties followed by disruptions in activity due to heavy rainfall and geopolitical events weighed on domestic demand and exports.

However, India continues to show resilience in certain pockets that are worth noting -- be it in consumption trends, services growth, the rising share of high-value manufacturing in exports, or the capital market. The government's continued focus on infrastructure development, digitisation, and attracting FDI will be the additional growth booster, enhancing overall efficiency.

"We remain cautiously optimistic and expect the growth rate to remain between 6.5 and 6.8 per cent this fiscal year and slightly higher between 6.7 and 7.3 per cent in FY2026," Majumdar told PTI.

Earlier this month, the Reserve Bank of India cut its growth forecast for the current fiscal to 6.6 per cent from 7.2 per cent projected in June. Deloitte said manufacturing

exports in high-value segments like electronics, semiconductors, and chemicals reflect India's strengthening position in global value chains.

Meanwhile, capital markets have shown stability despite significant FII outflows over the



past two and a half months, thanks to rising participation from retail and domestic institutional investors.

"We anticipate several of these trends to persist through 2025. We believe domestic consumption will remain the cornerstone of India's economic growth, with both rural and urban demand playing key roles.

"A myriad of factors, such as improved agricultural incomes, targeted subsidies, social welfare programmes, government employment initiatives, advancements in digitisation, and stronger services sector growth will help broad-base consumption spending," Majumdar said.

India will have to ride out the rough patch, as several global headwinds pose challenges. Geopolitical tensions, trade disputes, supply chain disrup-tions, and the escalating impact of climate change could weigh heavily on growth and long-term economic stability, she added. Anticinated policy added. Anticipated policy changes and trade restrictions in the US could impact export demand and capital flows into the country. Besides, central

for as many rate cuts next year if inflation starts moving north. Tighter global liquidity will likely limit the RBI's ability to manoeuvre monetary policy. Majumdar said over the next few years, India's growth will hinge on its ability to econom-

ically decouple from global uncertainties. "The Indian economy has the opportunity to turn the lime into lemonade by focusing on

three factors. The first would be to build on its own strengths. Harnessing the demographic dividend and growing middleclass wealth through investments in workforce development and employability will drive consumption, reduce skill gaps, boost the labour market, India will have to ride out the and strengthen capital mar-

kets," she said. The second would be the emphasis on building a selfreliant manufacturing sector that will not only meet India's rising domestic demand but also integrate with the global value chain. Also, by advancing digitally delivered services and targeting high-value segments of global value chains, India

India is poised to achieve new heights in foodgrain production in 2025, driven by favourable monsoon, though significant challenges persist in pulses and oilseeds production as the country's agricultural sector shows signs of robust recovery.

The Agriculture Ministry's initial projections paint an optimistic picture, with kharif (summer) foodgrain production estimated at a record 164.7 million tonnes for the 2024-25 crop year ending June 2025.

Winter crop planting has maintained steady progress, with wheat sown across 29.31 million hectares as of mid-December 2024, while total rabi (winter) crops cover 55.88 million hectares.

"We had a good kharif crop because of normal rainfall, Agriculture Secretary Devesh Chaturvedi told PTÍ

"Overall, the crop prospect for the whole year looks promising," he added, though cautioning against potential heat waves in February-March that could affect the winter wheat harvest. The agricultural sector is pro-

iected to bounce back strongy, with growth projections of 3.5-4 per cent in 2024-25, up from 1.4 per cent in the previous fiscal year.

Agri-economist S Mahendra Dev attributes this improvement to "good monsoon and rise in rural demand".

This growth comes despite localised floods and droughts affecting crops in parts of Maharashtra, Uttar Pradesh, and Rajasthan. Climate change-induced weather



anomalies have particularly impacted onion and tomato yields in certain regions. However, the path ahead isn't without hurdles.

To address the persistent challenge of self-sufficiency in pulses and oilseeds, the government will roll out the National Mission on Edible Oils - Oilseeds (NMEO-Oilseeds) in 2025, backed by a substantial budget of Rs 10,103 crore. The initiative aims to reduce import dependency through targeted interventions and increased sup-

port prices. The horticulture sector has shown remarkable progress, with record production of fruits and vegetables. The success is attributed to improved farming practices and technology adoption under various

government schemes. The sector is witnessing increased technological adoption, with drones and AI-driven tools gaining traction. 'These innovations offer immense potential to enhance productivity," said Ashish Dobhal, CEO of UPL Sustainable AgriSolutions. The government's flagship

PM-KISAN scheme continues

### to provide crucial support, having disbursed over Rs 3.46 lakh crore to more than 11 crore farmers since its 2018 launch.

Seven new agricultural schemes announced in September 2024, with a combined outlay of Rs 13,966 crore, are set for full implementation in 2025. These initiatives span various aspects of agriculture, including digital transformation, crop science, livestock health, and natural resource management.

However, farmer unrest remains a concern, particularly in Punjab and Haryana, where demands for legal MSP guarantees and other reforms persist.

A parliamentary committee has suggested doubling the PM-KISAN support to Rs 12,000 per beneficiary and implementing universal crop insurance for small farmers. While farmer-producer organisations (FPOs) have expanded with 9,204 registrations, they continue to face challenges, including limited market access and weak managerial capacity, potentially affecting their long-term sustainability.

# Rupee tumbles 3 pc in 2024; turbulence to ebb in slow motion in next year

he Indian rupee tumbled 1 3 per cent in 2024 as concerns over slower economic growth and the green buck's global strength weighed, but it was among the least volatile currencies in the world and the headwinds may be less intense in the coming year. Rupee settled at new lows as the year closed as dollar's resurgence weighed on emerg-

ing-market currencies. The action-packed 2024 continued to impact the rupee's exchange rate against major currencies throughout, with a series of geopolitical events ranging from the Russia-Ukraine war and crisis in the Middle East to trade disruptions in the Red Sea and elections across several major economies.

Global factors, including measures taken by major central banks, have hit not only the rupee-dollar dynamics but also disrupted the exchange rates of currencies across all emerging economies.

In fact, the rupee's fall with respect to the dollar has been less than its depreciation in terms of other currencies. And it has ended up with gains compared to euro and the Japanese yen.

Reserve Bank of India's (RBI) ex-governor Shaktikanta Das also said in the central bank's December bi-monthly monetary policy that the Indian rupee has remained less volatile compared to its peers

in emerging markets. Yet, the RBI has been more active in its efforts towards



stabilising the rupee-dollar rate, thanks to increased demand for the greenback due to India's dependence on oil imports and the widening trade deficit.

"RBI was also seen intervening actively in NDF (nondeliverable forward) markets to prevent sharp depreciation of the rupee," said Naveen Mathur, Director Commodities & Currencies, Anand Rathi Shares and Stock Brokers.

This was evident in foreign exchange reserves, which declined from the record high of USD 704.89 billion in late September to USD to USD 644.39 billion as of December 20, 2024, the lowest level in nearly six months.

The foreign currency assets also include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

India's external challenges intensified as China's GDP growth slowed to 4.8 per cent, reducing demand for Indian exports. Besides, supply chain disruptions due to tensions in the Middle East and escalated crisis in the Red Sea hit the trade balance of several countries, including India.





On the eve of his return to the court, Novak Djokovic has weighed in on tennis' highprofile doping cases and criti-cised what he perceives as dou-ble standards in the sport. The former world No. 1, who

I he former world No. 1, who is chasing a record 25th Grand Slam title at next month's Australian Open, expressed his frustration Sunday at being "kept in the dark" regarding top-ranked Lunnik Sinner's doping ranked Jannik Sinner's doping case. Djokovic is the top seed in the Brisbane International this week, making his first appearance at the event since 2009. He will also team up with Australia's Nick Kyrgios in doubles, with the duo headlining Monday's action. Off the court, Djokovic lent his

voice Sunday to Kyrgios's strong criticisms made a day earlier, speaking out at length about the ongoing doping case involving current world No.1 Jannik Sinner.

"I'm not questioning whether (Sinner) took the banned substance intentionally or not," Djokovic said at a press conference Sunday in Brisbane.

"We've had plenty of players in the past and currently under suspension for not even testing positive to banned substances.

"Some players with lower rankings waiting for their case to be

The International Tennis Integrity Agency (ITIA) charged both Sinner and former women's world No.1 Iga Swiatek with anti-doping breaches earlier in the year.

Sinner tested positive twice for an anabolic steroid in March but avoided a ban after the ITIA ruled he was not at fault. The World Anti-Doping Agency has appealed the decision. Swiatek accepted a one-month suspension in November after testing positive for the banned sub-

stance trimetazidine. The Serbian further criticised the lack of transparency from tennis authorities regarding doping breaches.

'The ATP hasn't really talked in depth about it. Why have they kept that case away from the

public? We see Simona Halep's case on the WTA Tour, now Iga Swiatek's case," Djokovic said "It's not a good image for our sport. I'm just questioning the way the system works and why certain players aren't treated the same as others. Maybe some ranking reasons are behind it, or taining reasons are benind it, or some players have more finan-cial backing and stronger legal teams to tackle these cases."

Despite his frustrations, Djokovic remains focused on the season ahead. After undergoing knee surgery earlier this year, he returned to reach the Wimbledon final but skipped the end-of-year ATP Finals, where Sinner capped a domi-nant season with his eighth title. Djokovic is looking to extend his legacy at Melbourne Park, where he has claimed 10 Australian Open titles, and has brought on former rival Andy Murray as his coach for the tournament.

'It's strange for me to share all these kinds of insights about how I feel on the court, some of the secrets of what I'm going through, what I'm thinking about, how I see my game, with somebody who has been one of my top rivals," Djokovic said. "But I'm so glad and very thankful that he has accepted to work with me, and in Australia ... he's very meticulous, dedi-cated, and professional.

# Roar by MCG crowd after Reddy's hundred is something I never heard: CA CEO Hockley

The collective roar of Indian fans after Nitish Kumar Reddy's maiden hundred is something that he has never heard at the MCG, and Cricket Australia's outgoing CEO Nick Hockley said on Sunday that it validated the decision to add a Test to the Border-Gavaskar Trophy.

The CA's decision to increase the number of Tests for the Border-Gavaskar Trophy from four to five has proved to be a masterstroke as crowd attendance and viewership records are set to surpass the hallowed Ashes.

"I want to say thank you to everyone who turned up, the atmosphere last night when Nitish Kumar Reddy scored his hundred, the roar of the crowd was nothing that I have ever heard," Hockley told PTI in an exclusive interaction.

The record total attendance (over five days) for a Boxing Day Test till date is 271,865 against England back in 2013 and the fourth Test involving India has already witnessed a

footfall of 255,462 spectators. With two more days left, CA is expecting the attendance to go well past 300,000. Hockley couldn't be more

thrilled. "Absolutely thrilled with the number of fans that have come round from all over India. It's been an absolutely incredible atmosphere as we got over a quarter million people over the gates and that's too on days one, two and three," Hockley said

"This Border-Gavaskar Trophy has had the biggest Boxing Day crowd ever passing the Ashes and the series is so delicately poised now, it is living up to every hype."

Hockley, who has had a good working relationship with the BCCI, said it was a no-brainer that the four-Test series between India and Australia transformed into a five-match rubber, considering its massive

following. "I think it speaks about the relations between India and Australia and fans are always excited to see these two teams. The five-Test series is what the
