# TRUMP THREATENS BRICS MAHABHARAT BEGINS

President-elect Donald Trump on Saturday threatened 100 per cent tariffs against a bloc of nine nations if they act to undermine the United States' dollar. His threat was directed at countries in the so-called BRIC alliance, which consists of Brazil, Russia, India, China, South Africa, Egypt, Ethiopia, Iran, and the United Arab Emirates. Turkey, Azerbaijan and Malaysia have applied to become members and several other countries have expressed interest in joining.

While the US dollar is by far the most-used currency in global business and has survived past challenges to its preeminence, members of the alliance and other developing nations say they are fed up with America's dominance of the global financial system.

The dollar represents roughly 58 per cent of the world's foreign exchange reserves, according to the IMF and major commodities like oil are still primarily bought and sold using dollars. The dollar's dominance is threatened, however, with BRICS' growing share of GDP and the alliance's intent to trade in non-dollar currencies - a process known as de-dollarisation. Trump, in a Truth Social post,

"We require a commitment from these Countries that they will neither create a new BRICS Currency, nor back any other Currency to replace the mighty U.S. Dollar or, they will face 100% Tariffs, and should expect to say goodbye to selling into the wonderful U.S. Economy."

At a summit of BRIC nations in October, Russian President Vladimir Putin accused the US of "weaponising" the dollar and described it as a "big mistake."

"It's not us who refuse to use the dollar," Putin said at the time. "But if they don't let us work, what can we do? We are forced to search for alternatives." Russia has specifically pushed for the creation of a new payment system that would offer an alternative to the global bank messaging network, SWIFT, and allow Moscow to dodge Western sanctions and trade with

partners. Trump said there is "no chance" BRICS will replace the US dollar in global trade and any country that tries to make that happen "should wave goodbye to America?

Research shows that the US dollar's role as the primary global reserve currency is not threatened in the near future. An Atlantic Council model that assesses the dollar's place as the primary global reserve currency states the dollar is "secure in the near and medium term" and continues to dominate other currencies.

Trump's latest tariff threat comes after he threatened to slap 25 per cent tariffs on everything imported from Mexico and Canada, and an additional 10 per cent tax on goods from China, as a way to force the countries to do more to halt the flow of illegal immigration and drugs into the

He has since held a call with Mexican President Claudia Sheinbaum, who said Thursday she is confident that a tariff war with the United States can be Canadian Prime averted. Trudeau Minister Justin returned home Saturday after meeting Trump, without assurances the president-elect will back away from threatened tariffs on Canada

Maharashtra's outgoing Chief Minister (CM) Eknath Shinde on Sunday said the Bharatiya Janata Party (BJP) will decide on the new CM and assured his full support while ruling out differences among Mahayuti allies over the government formation. Amid peculations that Shinde's son Shrikant Shinde might get the Deputy CM's post and Shiv Sena is keen on the Home portfolio, Shinde said the Mahayuti allies, BJP, Nationalist Congress Party (NCP), and Shiv Sena, will decide the government formation through consensus.

Notably, more than a week after the Mahayuti clinched a massive victory in Maharashtra polls with the BJP emerging as the single largest party with 132 seats, the new government is yet to be sworn in. BJP is moving cautiously as aspirations of its allies, especially Shiv Sena, are high after the massive poll victory.
Interestingly, the BJP legislature

party meeting to elect the leader, who will be the party's chief ministerial pick, is yet to be held, even though Shiv Sena and NCP allies have elected their respective leaders. The BJP has announced that the oath-taking ceremony of the new Mahayuti government will take place on December 5 evening at the Azad Maidan in south Mumbai and Prime Minister Narendra Modi will attend it.

to BJP sources, According Devendra Fadnavis, who has been CM twice and was Deputy CM in the last Eknath Shinde-led government, is the front-runner for the CM's post. A senior BJP leader said that the legislature party meeting may be held on December

The Mahayuti constituents will jointly decide whether only the CM and Deputy CMs will take oath on December 5 or ministers will also be sworn in, a senior leader of the alliance said

Shinde had left for his native village in Satara district on Friday amid speculation that he was not happy with the way the new government was shaping up. He developed a high fever in his village. Talking to reporters in his village on Sunday before leaving for Mumbai, Shinde said that he has already talked about a decision on CM's post taken by the BJP leadership that will be acceptable to me and Shiv Sena and will have my full backing. On speculation that his son and Sabha member Shrikant Lok Shinde will be made a Deputy CM in the new government and whether Shiv Sena has staked the

claim for the home portfolio, Shinde replied, "Talks were on". "A meeting took place in Delhi last week with (Union home minister) Amit Shah, and now we three alliance partners will discuss the nitty-gritty of government formation," he said. Responding to a query on his health, the Shiv Sena leader said he was fine now and had come to his native village to get some rest. "I always come to my village. Why should there be any confusion when I made my stand clear last week," he added.

Senior BJP leader Raosaheb Danve on Sunday told a news channel that the name of the chief minister has been finalised and a confirmation is awaited from the party leadership. NCP chief Ajit Pawar on Saturday said the chief minister will be from the BJP, while there will be deputy CMs from NCP and Shiv Sena headed by Shinde.

## AAP and Congress turn arch rivals in Delhi

Aday after Delhi Congress president Devendra Yadav hinted that the party will go solo, Aam Aadmi Party (AAP) convener Arvind Kejriwal, on Sunday, announced that his party will not form an alliance with the Congress for the upcoming Delhi Assembly luled to take place Kejriwal's February. statement comes despite both parties being a part of the Opposition INDIA Bloc and having contested the Lok Sabha elections in Delhi together earlier this year. However, their joint effort yielded no results, with the Bharatiya Janata Party (BJP) winning all Lok Sabha seats in Delhi. Responding to a query during a press conference, Kejriwal made it clear, saying, "There will be no alliance in Delhi."

development This significant, as it clears the way for a triangular contest in the Delhi Assembly polls, with the AAP, Congress, and BJP vying for power. Kejriwal's decision also comes on the back of major poll drubbing of the



Maha Vikas Aghadi in Maharashtra this month, which Congress is also a part of, drawing criticism from its allies. The INDIA Bloc has adopted a flexible approach, contesting elections jointly in some states while going solo in others.

According to AAP insiders, Congress is a divided house in Delhi so there will not be any split in Muslim and Scheduled Caste voters. "Muslim will vote for AAP as they have no option. Similarly a large part of Scheduled Caste voters will strengthen its vote bank, AAP

has inducted stalwarts of Congress, insiders say. Besides, the AAP strategy is focused on the Congress vote bank here.

The AAP and Congress had also attempted to form an alliance ahead of the Haryana Assembly polls in October but failed to reach a seat-sharing agreement despite multiple rounds of talks.

The Congress and AAP had contested the Lok Sabha Elections this year in Delhi in alliance with each other under the umbrella of the INDIA vote for AAP. To further Bloc. Both parties had even campaigned for each other.

Kejriwal, who was then out on interim bail for the election campaigning, had also campaigned for the Congress and had sought votes for its Opposition party (in the Delhi Assembly). The AAP had contested on

four seats while Congress contested in three seats out of parliamentary However, neither of the two parties could open their accounts, as the BJP swept all seven seats in the city.

However, in contrast to Delhi, the AAP had contested all 13 Lok Sabha seats in Punjab on its own, ditching the Congress in the state. The AAP is in power in Punjab with a huge majority. In 2022 Assembly polls in Punjab, the Kejriwalled party had swept the state winning 92 out of the 117 seats, dislodging Congress from power. Soon after Kejriwal's major

announcement, the BJP took a "friendship with benefits" jibe at the AAP and Congress and underlined the loopholes in the Opposition unity in the state and at the national level.

#### **Chinmoy Krishna Das' bail** hearing on December 3



Acourt in Bangladesh has set December 3 as the date for the bail hearing of Hindu leader Chinmoy Krishna Das arrested last week on sedition charges, according to a media report. Tuesday's hearing will be conducted by Metropolitan Sessions Judge Mohammad Saiful Islam, according to Additional Deputy Commissioner Mofizur Rahman of the Chattogram Metropolitan Police.

A Chattogram court official said that the date for the hearing had already been set but the announcement was delayed due to a boycott and work abstention by lawyers on Wednesday and Thursday. The hearing will

take place on December 3, bdnews24.Com reported. Das, a spokesperson for the Bangladesh Sammilita Sanatani Jagran Jote, was arrested from Dhaka's Hazrat Shahjalal International Airport on Monday for alleged sedition. He was denied bail and sent on Tuesday, triggering

protests by his supporters. A lawyer was killed during violence in Bangladesh's southeastern port city of Chattogram over his arrest. On October 30, a sedition case was filed against 19 people, including Das, at Chattogram's Kotwali Police Station, accusing them of disrespecting Bangladesh's national flag in Chattogram's New Market area during a rally of the Hindu community. Bangladesh's authorities on Thursday ordered freezing for 30 days the bank accounts of 17 people associated with International Society for Krishna Consciousness (ISKCON), including its

former member Das.

## DELHI AND DRUGS TO PART WAYS THIS DECADE, PROMISES LG

National Capital The witnessing staggering increase in the circulation of illicit drugs. In 2024 so far, Delhi has witnessed over 6,000 per cent rise in cocaine seizures while more than 7,000 per cent rise in charas in comparison to 2023, reflecting on the increased mobility of drug traffickers in the city. During the current year till November 15, Delhi Police has arrested 1,520 Narco-offenders in 1,121 NDPS (Narcotic Drugs and Psychotropic Substances Act, 1985, ) cases. It has recovered about 1293.3 kgs of cocaine in the given period as compared to 21.14 kgs of the drugs recovered in 2023, including the recent big seizure of Rs 7,000 Crores worth of cocaine in October.

In comparison to 2023 when only 0.684 kgs of Charas was recovered, the police seized 50.5 kgs this year till November 15, a police officer said, adding that 73.3 kgs of heroin, 4257.3 kgs of Ganja, 103.7 kgs of Opium, and 80.5 kgs of

surge in drugs and to prevent the public from falling in this trap, the Delhi Police on Sunday launched a 'One-Month Comprehensive Campaign as a Pilot Project' with the vision to eradicate drugs from the city within three years.

With the campaign in action, the Delhi Police on Sunday claimed to have recovered Rs 3 Crore worth of Charas and dismantled an international drug syndicate involved in smuggling drugs worth crores into the country using the dark web, cryptocurrency and fake documents with the arrest of its mastermind.

In the first instance of a sustained effort in making the city drug free, Delhi Police's Crime Branch dismantled a narco-syndicate indulged in supplying Charas with the arrest of five key operatives including three Nepal nationals. The syndicate was indulged in supply of drugs from Nepal and Kasol, Himachal Pradesh to Delhi-

A senior police official said that on November 20, a tip off was received regarding supply of Charas by a Nepal national in the poppy head were also recovered. In light of Delhi witnessing such a Majnu ka Tila area, to a local drug



and two persons namely 32-year-Mohd Jameel were arrested, while they were dealing in Charas in a hotel and 1192 grams of Charas classified as a commercial quantity under the NDPS Act was recovered from them. The investigation led to the arrest

of three more traffickers including

Ganga, who was indulged in

supplying Charas at Sangam Vihar,

Wazirabad. She was nabbed with 712 grams of Charas and later on, 13.766 Kg Charas was recovered from her bed room of her house. Ankit Buddha alias Thakren was also arrested, who was arrested from Kasol in Himachal Pradesh and is the main source who used to provide Charas to Prem Thapa. Police also arrested Pradeep Kumar, who used to buy Charas

from Prem Thapa and supply it to drug addicts of Faridabad and

Ballabgarh. In the second instance,

the police nabbed mastermind Lokesh Dhingra on Friday, whose syndicate imported 48 kg of marijuana worth Rs 20-25 crore in over three months, strategically avoiding detection of commercial quantities of the contraband. According to the police, the illegally acquired assets worth Rs 1.5 Crore were also seized. Police started tailing members of

the gang after a parcel containing 1.5 kg of hydroponic marijuana valued at Rs 1 Crore was seized at the RK Puram post office on October 18. More searches led to additional seizures worth Rs 2 Crore in transit. An FIR was registered under the NDPS Act, police said. "The mastermind Lokesh Dhingra alias Loki and his associates, Vivek and Mansher Singh fled after the initial seizures. Vivek was arrested in November 2023 after returning from Thailand. Dhingra and Singh were traced to a Gurugram flat owned by one woman who was arrested for harbouring the fugitives," Deputy Commissioner of Police (crime branch) Satish Kumar said,

adding that the syndicate used

fake SIM cards, privacy tools and

fake IDs to avoid detection, distributing contraband in Noida Dhingra, a and Gurugram. habitual offender, has been detained and sent to jail, he said. The ninth State Level Committee meeting of National Narcotics Coordination Portal (NCORD), was convened on November 20, at Delhi Secretariat. Subsequently, a review meeting was held on November 26, at Raj Niwas, Delhi, under the chairmanship of the LG where he emphasized upon interdepartmental coordination, timely reporting, and strict compliance with directives for making Delhi drug free in three years.



P K Jena deputy director north division of the PTR told this correspondent today There is a strong movement of the top predators. The lesser one the leopards and deer have 'dispersed' in safer areas over the last three or four days.

Betla National Park has around 10 leopards while the count of the deer is 5,000.

Langurs and monkeys make different calls in excitement or distress when they sight leopard and tiger.

"I some weeks ago heard a call of the langurs. It was for a tiger. I and my people went in some direction only to find a tiger basking in the Sun. The Langurs were precisely accurate for the presence of the tiger." recalled Jena

Langurs and the monkeys do espionage to the movement of the tiger and leopard from atop the tree.

About a 'sixth' tiger coming over to the PTR in the past two weeks Jena said "I too have read somewhere about the 6th tiger. Well won't be tempted to call it sixth." "All that I can say with authority is that a tiger did come here from Balrampur side of Chhatisgarh.

"We found its hair, its kill and pug marks all very positively suggestive of its pres-Jena continued to

"But there is no camera trap of this Chhatisgarh visitor. A camera trap image helps us to distinguish its stripes from other tigers. Stripes are very distinctive feature" Jena elaborated.





#### Principal District Judge conducts surprise inspections: Children without legal counsel to be assigned lawyers

Principal District Judge and Chairman of the District Legal Services Authority (DALSA), Anil Kumar Mishra, conducted a thorough inspection of the Ghaghidih Central Jail, the Child Welfare Committee (CWC), and the Juvenile Justice Board (JJB). Accompanying him were Additional Sessions Judge Bimalesh Kumar Sahay, Chief Judicial Magistrate Vishal Gauray, and DALSA Secretary Rajendra Prasad. The inspection aimed to evaluate the functioning of these institutions and ensure the delivery of justice and welfare services.

During his visit to the Juvenile Justice Board, Judge Mishra emphasized the importance of legal representation for juveniles. He directed the JJB officials to ensure that children without legal counsel are assigned lawyers through DALSA. Highlighting the urgency of pending cases, he instructed officials to expedite the process of filling bail bonds for children granted bail. For juveniles unable to furnish bail bonds, he urged the authorities to file modification petitions promptly and focus on the swift resolution of minor cases

At the Child Welfare Committee, Judge Mishra distributed warm clothes among the children. These were provided by DALSA in collaboration with the Lakshya Foundation, showcasing a commitment to the welfare of children under institutional care. The Principal District Judge reaffirmed the importance of providing essential resources and ensuring a nurturing environment for vulnerable children. The inspection at Ghaghidih Central Jail focused on addressing the legal needs of inmates. Judge Mishra instructed the authorities to ensure that prisoners without legal representation are assigned lawyers through DALSA upon submission of an application. He also stressed the need for timely filing of appeals for inmates whose appeals were pending. Additionally, he directed the smooth operation of the Jail Legal Aid Clinic to facilitate inmates' access to justice.

Judge Mishra further instructed the Jail Superintendent to submit applications under Section 479 of the Criminal Procedure Code (CrPC) without delay. This provision, which deals with addressing cases involving habitual offenders, is critical to ensuring timely judicial review. The surprise inspection reflects DALSA's commitment to improving access to legal aid and ensuring the welfare of vulnerable groups, including juveniles and prisoners. It highlights the proactive role of the judiciary in addressing systemic gaps and fostering accountability within institutions. The Principal District Judge's directives underscore the importance of collaborative efforts between judicial authorities and welfare organizations to ensure that justice reaches every corner of society.

# Ajmer Dargah Survey: Ex-bureaucrats ask PM Modi to check 'ideological assault'

Days after a local court ordered a survey of the Ajmer Sharif dargah, a group of former bureaucrats and diplomats has written to Prime Minister Narendra Modi, seeking his intervention to halt all "illegal and pernicious" activities that are an "ideological assault" on India's civilisational heritage and pervert the idea of an inclusive country. Stating that he alone can halt

"all illegal, pernicious activities", the group has reminded Modi that he himself had sent "chadars" on the occasion of the annual Urs of the 12thcentury saint, Khwaja Moinuddin Chisti, as a homage to his message of peace and harmony.

The group of nearly half-a-

Delhi lieutenant governor Najeeb Jung, former high commissioner of India to the United Kingdom Shiv Mukherjee, former chief election commissioner S Y Quraishi, former vice-chief of Army staff Lieutenant General Zameeruddin Shah and former Reserve Bank of India (RBI) deputy governor Ravi Vira Gupta, wrote to the prime minister on November 29 about unknown fringe groups claiming to represent Hindu interests and demanding archaeological surveys of medieval mosques and dargahs to prove the previous existence of temples at these

"Despite the clear provisions of the Places of Worship Act, the courts too seem to respond to such demands with undue alacrity and

"It appears unimaginable, for example, that a local court should order a survey on the 12th-century dargah of the Sufi saint Khwaja Moinuddin Chishti -- one of the most sacred Sufi sites in Asia not just for Muslims but for all Indians who are proud of our syncretic and pluralist traditions

The very thought that a mendicant saint, a fakir, who was an integral part of the Sufi/Bhakti movement unique to the Indian subcontinent and a paragon of compassion, tolerance and harmony, could have destroyed any temple to assert his authority is ridiculous," they wrote.

In the recent past, there have been calls for boycotting Muslim business establishments and eateries, non-rentof Muslim houses at the behest of chief ministers themselves, led by a ruthless local administration, the former diplomats added.

About 1.54 lakh establishments have been hit and lakhs rendered homeless or bereft of their places of business, they said, adding that in most cases, the affected parties are

Muslims.

There is immediate need for an interfaith meeting under your chairmanship where you as the prime minister of an inclusive Bharat should give out a message that India remains a land for all, where faiths have existed together and in harmony for centuries and that no sectarian forces will be permitted to disturb this uniquely pluralistic and diverse legacy," the former diplomats said.

## SC to hear PIL challenging EC's decision | Kolkata's RG Kar ex-principal helped to increase voter's count per polling booth two cartels procure hospital contracts: CBI

The Supreme Court is scheduled to hear on December 2 a PIL challenging the Election Commission's decision to increase the maximum number of voters per polling station from 1,200 to 1,500. A bench of Chief Justice Sanjiv Khanna and Justice Sanjay Kumar will take up the PIL filed by one Indu Prakash Singh, who has challenged two communications issued by the Election Commission in August 2024 increasing the number of voters per polling stations in each constituency across India.

Singh has contended that the decision to increase the number of voters per polling booth was arbitrary and not based on any data. On October 24, the top court refused to issue any notice to the poll panel but allowed the petitioner to serve the copy to the standing counsel of the Election Commission so that its stand on the issue is



suade voters from going to cast

The bench, however, said that the poll panel wants more and more people to vote and with the use of EVMs, it takes a shorter time compared to ballot papers. It said that the poll panel is trying to reduce the time taken to cast votes as much as possible by increasing the number of EVMs at booths. The petitioner has contended that the poll panel's decision

would impact the voters during the assembly elections in Maharashtra and Jharkhand (since concluded) and Bihar and Delhi to be held next year. Singh said that elections are normally held for 11 hours and it takes around 60 to 90 seconds to cast one vote, and therefore 660 to 490 persons can cast their vote in a day at one polling station with one EVM. Considering the average voting percentage to be 65.70 per cent, it is perceivable that a polling station prepared to accept 1,000 electors sees around 650 turn up.

Singh's petition said that there are also booths where the elector turnout is in the range of 85-90 per cent. "In such a situation, about 20 per cent of voters will either end up standing in the queue beyond the voting hours or due to long waiting times, will abandon exercising their right to vote. Neither is acceptable in a progressive republic or a democracy," the PIL said.

Former principal of Kolkata's RG Kar College and Hospital Sandip Ghosh allegedly helped two cartels in procuring hospital contracts, the agency has said in its recently filed chargesheet.

The special court has taken the chargesheet on record but it is yet to take its cognisance because the West Bengal government has not provided sanction to prosecute Ghosh and other accused.

Ghosh had resigned as the principal of the state-run institute on August 12 in the aftermath of the rape and murder of a trainee doctor on its

The CBI has named Ghosh, former House Staff of the medical college Ashish Kumar Pandey, and businessmen Biplab Singha of Maa Tara Traders, Suman Hazra of Hazra Medical and Afsar Ali Khan of Eshan Cafe, in the



charge sheet.

"This case was registered in compliance with the directions of Hon'ble High Court at Calcutta relating to financial irregularities in RG Kar Medical College & Hospital at Kolkata," Spokesperson said.

The CBI has alleged that Ghosh and Pandey appointed several doctors as house staff in violation of the rules, they said.Ghosh helped two cartels -- one run by Singha and Hazra and the other by Khan -- in procuring several contracts of the hospital, the CBI has alleged in its chargesheet filed before a Special CBI court

"On careful perusal, it manifested that sanction order of the competent authority not yet received. Accordingly, cognisance is not taken sans sanction. Let it be kept with the record," the Special Judge said. The Hospital hogged media attention when a trainee doctor was found dead in the chest department auditorium on August 10. It surfaced that she was allegedly raped and killed by a civic volunteer Sanjay Roy in the intervening night of August 9-10.

Ghosh was also under scanner in the case for alleged delay in the probe. In between, the Calcutta High Court ordered a probe into alleged financial irregularities in hospital during his tenure

The High Court order came on a petition by the former deputy superintendent of the facility, Akhtar Ali, who prayed for a probe by the Enforcement Directorate (ED) into multiple counts of alleged financial misconduct at the institute during Gosh's tenure as its principal.

Ghosh served as principal of RG Kar Medical College from February 2021 to September 2023. He was transferred from RG Kar in October last year but inexplicably returned to that position within a month.

The CAG has said according to the legal framework, the Delhi government has to place the audit reports submitted by it before the Assembly and it has in the past written to the principal secretary (finance), requesting him to do the same.

The authority made the submission in its response filed to a petition by city's opposition leaders seeking a direction to place CAG reports related to liquor duty, pollution and finance before the Assembly. "As per the records available with the Answering Respondent, eight reports of the Comptroller and Auditor General of India, pertaining to the NCT of Delhi, are pending with Government of NCT of Delhi for laying before the Legislative Assembly in accordance with the provisions of section 48 of the Government of National Capital Territory Delhi Act, 1991," stated a short reply filed by the CAG and accountant general

(audit) in the matter. "The Answering Respondent thus submits that as per Article 151(2) of the Constitution read with section 48 of the Government of

National Capital Territory of Delhi Act, 1991 and with regulations ... Enjoins upon the GNCTD to place the audit reports submitted by the Comptroller and Auditor General of India on the accounts of GNCTD in the Legislative Assembly of Delhi," it further said.

The response informed that the reports from 2022 to 2024 pertain to finance audits, air pollution, "revenue, economic, social and general sector and PSUs", children in need of care and protection, liquor and public health.

"Again, while forwarding Report No. 3 of 2024 of the CAG to the Principal Secretary (Finance) vide letter dated 19.09.2024, the Delhi Audit Office also reminded him about seven reports of CAG pending with Delhi government for laying them before the Legislative Assembly of the state," the reply said.

The petition, which has been filed by Leader of Opposition in the Delhi Assembly Vijender Gupta and Bharatiya Janata Party (BJP) MLAs Mohan Singh Bisht, Om Prakash Sharma, Ajay Kumar Mahawar, Abhay Verma, Anil Kumar Bajpai and Jitendra Mahajan, is listed for hearing on Monday.

The high court had, on October 29, issued notices to the Delhi government, the office of the Legislative Assembly speaker, the lieutenant governor (LG), the CAG and the accountant general (audit), Delhi and sought their responses to the peti-

The plea has claimed that the 12 CAG reports from 2017-2018 to 2021-2022 are pending with Delhi Chief Minister Atishi, who also holds the finance portfolio.

The plea has further alleged that despite the LG's repeated requests, these reports have not been sent to him for tabling the same before the Assembly.

The petition, filed by advocates Neeraj and Satya Ranjan Swain, said the BJP MLAs had approached the chief minister, chief secretary and speaker in the past but no action has been taken.

"Despite the LG's repeated requests and constitutional obligation, these reports were not sent to the LG and consequently, could not be tabled in the Delhi Legislative Assembly," it said.

The plea has further alleged that a "deliberate suppression of vital information" not only violates democratic principles but also prevents a proper scrutiny of the government's action and expenditures, raising serious ques-tions about its financial proprietary, transparency and accountability. The petitioners, therefore,

have sought directions to the finance department to send a proposal to the LG for "exercising his duties under Article 151(2) of the Constitution of India, 1950, Regulation 210(1) of the Regulations on Audit and Accounts, 2007 and section 48 of the Government of National Capital Territory Act, 1991".

had exonerated former prime minister Rajiv Gandhi in 2004, a year later it quashed all charges against the remaining accused, including the Hinduja brothers, in the politically sensitive case.

Italian businessman Ottavio Quattrocchi, the alleged middleman in the payoff case, was discharged in 2011 by a court which allowed the CBI to withdraw prosecution against

The case involves allegations of a Rs 64-crore bribe in a Rs 1,437-crore deal with Swedish firm Bofors in the 1980s during the then Congress government for the supply of 400 155mm field howitzers, which

The CBI had previously sent letters and reminders to US authorities on November 8, 2023, December 21, 2023, May 13, 2024, and August 14, 2024, but received no information, with the US authorities requesting additional time.

The central agency has now opted to pursue the LR route, where a competent court sends a formal request for information to the relevant authorities in the US, subject to clearance from the Indian government. The CBI had registered the case in 1990, three years after a Swedish radio channel had alleged that bribes were paid by Bofors to politicians and defence officials of India to clinch the deal. The allegations created a big scandal for the Rajiv Gandhi Government and have been used by rival parties to target the Congress. The CBI filed the chargesheets in 1999 and 2000. The Delhi Rajiv Gandhi in 2004, nearly 13 years after he was assassinated by LTTE in a suicide attack. In 2005, the High Court quashed all charges against the remaining accused noting that the CBI failed to prove that the money transferred by Bofors to various agents by Quattrocchi was meant to be paid as a bribe to

and Vishalni Koul -- had moved the high court in 2018 after their provisional selection to the post of legal assistant in the department of disaster management relief, rehabilitation and re-construction under the PM package for Kashmiri migrants in December 1, 2017 forfeited on the ground that they have lost their migrant status having married non-

migrant persons. "One question of public important that arises before this court is whether a woman who has been given a migrant status on account of the suffering endured by her and her fami-



were forced to leave their home and hearth in the Kashmir Valley..., could be discriminated and would stand to lose the said status only on account of fact that she had got married to a non-migrant?

"Holding this would be going against the nature of human beings. Respondents herein, who are ladies and on account of no fault of theirs, had to leave their place of original residence in Kashmir Valley, cannot be expected to remain unmarried only to secure a job in the Kashmir Valley as a migrant," a division bench of Justices Atul Sreedharan and Mohammad Yousuf Wani said in a seven-page order last month. It is also reasonable to

presume that because of the exodus, not every migrant woman would be in a position to find a match who himself was a migrant, it said. The court said in such a situa-

tion, to hold that the woman would lose her status as a migrant only because she, out of the natural urge of forming a family, had to marry a nonmigrant on account of existing circumstances, would be grossly "discriminatory and militates" against the very concept of justice.

'This discrimination becomes even more brazen where a male migrant continues to remain a migrant notwithstanding the fact that he has married a non-migrant. Such a situation has arisen only on account of patriarchy that prevails in the human race. However, in matters relating to employment under the State/UT, such discrimination cannot be countenanced," the court said, dismissing a writ petition filed by the Union Territory against the May 16

# Cyclone Fengal weakens, life in Puducherry paralysed by rainfall, TN's Villupuram affected

fter making landfall near APuducherry on November 30, Cyclone Fengal weakened on Sunday, but torrential downpour under its influence paralysed the union territory, with the Army stepping in to evacuate stranded persons in inundated streets. Old-timers recalled such a fury of nature was not witnessed in this tiny UT for the last three decades. Villupuram in neighbouring Tamil Nadu also suffered following heavy rains and inundation, with Chief Minister M K Stalin terming the rainfall in the district as 'unprecedented.'

Operations at the Chennai airport, which had been suspended on Saturday, resumed past midnight but many flights suffered cancellations and delays initially, officials

According to the latest update from the India Meteorological Department (IMD), Cyclone Fengal has weakened into a deep depression.

"The Cyclonic Storm FEN-GAL (pronounced as FEIN-JAL) over north coastal Tamil Nadu & Puducherry remained practically stationary during past 12 hours, weakened into a deep depression and lay centered at 1130 hours IST of today, the 1st December 2024 over the same region near latitude 12.0°N and longitude 79.8°E, close to Puducherry, about 30 km north of Cuddalore, 40 km east of Villupuram and 120 km south-southwest of Chennai,' the weather office said in a post on 'X.' It is likely to move westwards very slowly and weaken gradually into a depression over north Tamil

Normal life was crippled in Puducherry, as the union territory received 46 cm rainfall, bettering the previous best of 21 cm recorded on October 31, 2004. Cyclone Fengal triggered heavy rainfall, leading to inundation of all residential areas on the outskirts Of boulevard limits. Trees were uprooted at various places under the impact of the cyclonic storm. Power outage was reported in most of the localities since 11 pm on Saturday.

The Indian Army deployed its soldiers and boats and evacuated stranded people. According to a Defence release, about 200 people were rescued from three different locations in Puducherry, including Krishna Nagar. Many housing colonies were waterlogged and residents



dwellings for hours together. Two-wheelers and cars parked on roads partially submerged in rainwater that entered several houses here, residents

All shops and business establishments remained closed and the government set up relief centers to accommodate people evacuated from lowlying areas. Main thorough-fares and arterial roads were waterlogged disrupting daily life. Farmlands with standing crops bore the brunt of the heavy rain. Transport services were hit and voluntary organisations like Pondicherry Heritage Round Table 167 volunteered to supplement the efforts of the government to supply food packets to people staying in relief camps. Meanwhile, in Chennai, Tamil Nadu CM Stalin briefed reporters about the cyclone

He pointed out that Villupuram had received heavy rainfall, with Mailam in the district recording 49 cm, followed by Nemmeli at 46 cm and Vanur (41 cm) in the last 24 hours. "Villupuram has received unprecedented rainfall and we are monitoring the situation," he said. With nearby Cuddalore also

receiving copious rains, Deputy CM Udhayanidhi Stalin has been rushed to oversee the res-cue and relief efforts in both districts, Stalin said.

The two districts are being

monitored. We are going to request the Centre to depute a team to assess the damage in Villupuram, Cuddalore and Chengelpet," the CM said. As regards Chennai, he said that despite heavy rains in the city on Saturday, there was no

### Deaths from AIDS in country came down by 79 per cent: Nadda

Deaths from AIDS in the country came down by 79 per cent while HIV infections fell by 44 per cent in 2023 and the country is committed to achieve the United Nations Sustainable Development Goal of eradicating AIDS by 2030, Union Health Minister JP Nadda said on Sunday.He was speaking at a function here on the occasion of World AIDS

Nadda said the renewed IDS response measures of 'test and treat' and universal viral load testing will be endorsed and AIDS (Prevention and Control) Act 2017 will be implemented in toto. India has worked out a formula of "95-95-95" in view of the target of eliminating AIDS by 2030, he added. "Ninety-five percent of the patients in the country should know that they are infected with HIV, 95 percent of the patients should get treatment and the "viral load" of 95 percent of the patients should be



lessened by antiretroviral therapy medicines," he explained. At present, 81 per cent of patients know they are infected with HIV, 88 per cent patients are being given treatment and the viral load of 97 per cent patients has reduced, the Union minister informed. "In the year 2023, there has been 44 per cent reduction in new AIDS infections in the country, while AIDS-related deaths have reduced by 79 per cent," he said. Nadda said the current prevalence of AIDS is 0.70 percent globally, whereas in India it was 0.20 percent, adding that after a long battle against AIDS, a strong medical system has been developed in

"The situation in the country is not good. Leaders like Mahatma Gandhi, Pandit Jawahar Lal Nehru, Maulana Abdul Kalam Azad, Sardar (Vallabhbhai) Patel, (B R) Ambedkar made this country home for Hindus, Muslims, Sikhs and Christians. Gandhi even sacrificed his life for it,' she said.

"However, people are being pitted against each other (on the basis of religion) and I am afraid we are being pushed towards the 1947-like situation," Mehbooba, a former chief minister, said addressing a gathering of party workers here.

Attacking BJP, she said the government has failed to provide jobs, education, good hospitals and roads to the people and is diverting the attention of the people by targeting mosques on the pretext of finding temples

"This is exactly what is happening in the country. Four innocent youth were recently killed in Sambhal (UP) but who will speak for them. Anyone doing so will be put in jail like Umar Khalid who is behind the bars for the last four years. In the prevailing conditions, there is no one to listen," Mehbooba said.

The PDP leader referred to a petition claiming that the . Ajmer Sharif Dargah was built over a Shiva temple and said people of different faiths including Hindus and Sikhs visit the 800-year-old shrine which is a glaring example of 'Ganga-Jamuni culture. "They also want to dig up this shrine in search

He said that they have demanded the West Bengal government to withdraw the restriction by Monday. "In a joint meeting of the WBPP-TA and West Bengal Cold Storage Association on Saturday, we have decided that potatoes will not be

## **Trump's tariff threat**

Trump risks alienating key partners, intensifying global economic tensions and accelerating efforts to bypass the dollar

rump presidency is yet to begin but the president-elect has already spoken his mind on the US policy and it is not good news for the developing countries. US Presidentelect Donald Trump has issued a stern warning to the BRICS nations—Brazil, Russia, India, China, South Africa and their expanding coalition—which seek to challenge the dominance of the US dollar. Trump's announcement of a potential 100 per cent tariff on these nations underscores the rising tensions across the globe as the BRICS bloc explores alternatives to the dollar. This move highlights the friction between the US and developing economies and could reshape global trade dynamics. It was widely expected that Trump would do everything possible to bail out the US out of debt and would not hesitate to take harsh measures against countries who are harming the US interests regardless of their friendship with the US. For decades, the US dollar has been the cornerstone of global commerce, widely used in trade and serving as the reserve cur-

rency for most nations. However, the BRICS coalition and other developing economies have expressed growing frustration over the disproportionate control that the US wields over the global financial system.

Nations within the BRICS bloc are already discussing plans for a new global currency or expanded use of their local currencies to reduce reliance on the dollar. There is no doubt that Trump's threat of 100 per cent tariffs on BRICS nations reflects a protectionist stance and his determination to defend US economic interests. But that is Trump for you, he doesn't mind taking tough decision even if the whole world is against him. Be it environment or trade or military expeditions

Trump is capable of taking decisions which might be frowned upon the world over. He has categorically said that any attempt to undermine the dollar's dominance would result in severe consequences, including exclusion from the US market. The big problem for developing nations is they depend upon the US market in a big way for their incomes and exporting revenue. Trump's approach reveals his readiness to employ punitive measures against both allies and rivals in the global south, regardless of their historical ties with the US. The implications of such tariffs would be profound, potentially disrupting trade flows, exacerbating economic tensions and alienating key developing nations. A 100 per cent tariff would significantly raise the cost of exporting goods to the US, impacting industries that rely on American consumers. For economies like Brazil and South Africa, which are heavily reliant on exports, this could lead to economic slowdown. But ironically Trump's threats may be counter-productive as many countries may further incentivise their search for alternatives to the dollar. Besides, Trump's hardline stance may push developing countries closer together, fostering stronger ties within the BRICS bloc and beyond. Indeed raising tariff wall in today's world is not a good idea but then Trump has mind of his own.

# Unveiling transnational drug syndicate

The Coast Guard's drug seizure near Andaman islands underscores the ongoing challenge of tackling transnational syndicates engaged in illicit trafficking near the Indian coast

eeding to their motto of Vayam Rakshamah (We Protect), the Indian ■Coast Guard personnel executed a befitting operation in the Andaman and Nicobar waters to mark one of the largest drug busts in Indian maritime history. The haul of nearly 6000 kgs of the banned Methamphetamine near Barren Islands (150 km away from Port Blair) is estimated at around 36,000 crores in the international market. The picture-perfect operation was triggered by the presence of a suspicious trawler (Soe Wai Yan Htoo) in the Indian waters by a Coast Guard Dornier reconnaissance plane which then swooped down and asked the trawler to lower its speed, whilst informing the base. Soon enough, fast patrolling vessels of the Coast Guard were tasked to the place, and they towed the six Myanmarese crew trawler to Port Blair, for further investigations. Ongoing interrogations reveal the presence of an unyielding, trained and secretive crew with the presence of a satellite phone that has all the hallmarks of a major and international drug syndicate. But for now, it marks the ever-vigil capabilities of the Indian Coast Guard in ensuring the integrity of our maritime borders and policing against transnational crime. While the geographical location

of the Andaman and Nicobar Islands naturally lends itself towards fructifying India's strategic "Look East" opportunity (as also dominates the sensitive and narrow Malacca Straits that facilitates 40% of global trade) - it is also in the crosshairs of Myanmar, the largest producer of illegal methamphetamine, which is then exported to markets in the US, Europe to Eastern countries. The restive Shan State of Myanmar (bordering China with an ethnic Han-Chinese populace and multiple insurgent groups widely believed to be supported by China) is also home to the infamous Cantonese Chinese drugs syndicate, Sam Gor (popularly known as 'The Company'). This notorious set-up is involved

in global drug trafficking and is said to be in control of over 40 per networks of key international

cent of Asian-Pacific trade in substances like methamphetamine, heroin, ketamine, fentanyl etc. This lucrative trade is believed to generate earnings up to a staggering \$8 billion, annually. Currently, it is believed to be headed by a Chinese gangster called Tse Chi Lop, who is also widely known by the moniker "El Chapo of Asia". Even though Tse Chi Lop is currently in custody and facing trials in Australia – his organisation Sam Gor and its affiliated operations are continuing,

Ironically, he could have created such a vast drug infrastructure and empire in a region contiguous to the Chinese mainland, where the Chinese have many beholden armed militias, but he never got targeted or arrested by the Chinese authorities. Also strange is the fact that he never attempted to ship his produce towards the Chinese mainland, raising serious doubts if he were to have enjoyed some sort of official patronage from the Chinese authorities. Unsurprisingly, Tse Chi Lop's rise has not been marked by the usual stories of violence and gore of drug lords but by the unusual route of steady industrialisation and establishing well-maintained

partnerships, which are impossible without some sort of sovereign backing. And the Chinese are the masters of asymmetric subterfuge in that they patronise proxies and bad elements, as long as they do the bidding of the Chinese government, and do not direct their illicit trade towards the Chinese mainland. While it is too early to confirm the exact hand behind the recent cache in the Andaman and Nicobar waters, the quantity/value of drugs involved, the location of the trawler arrest, and the nationality of the trawler crew, all point to origins that seem disconcertingly familiar. That the restive Myanmar mainland (with areas like Shan State that are 'no-go' zones to even the Myanmar military) is closer to the Andaman and Nicobar Islands than the Indian mainland, makes the threat real and perennial. It is a testy region given too much Chinese intrigues and ambitions – in fact, the Myanmar-owned Coco Coco Islands (barely 50 km from the northernmost tip of the Andaman Islands range) were believed to have had Chinese militaristic assets, but the same was never proved. The Chinese have planned substantial investments in Myanmar via its Belt and Road Initiative (BRI) which includes projects like the

China-Myanmar Economic Corridor (CMEC) or even the development of the deep-sea port of Kyaukpyu, in Myanmar's Kakhine State. The Chinese have a vested interest in keeping their footprints in the region and it is not beyond them to oscillate from making pure investments in the Myanmar Government to patronizing rebel militias or even drug lords, towards its objectives in the region. India must safeguard its interests and strategic imperatives that beset its distant outpost in the Andaman and Nicobar Islands. Sadly, it is not the first and it wouldn't be the last such operation. Situational status suggests that this specific haul was destined for Thailand, which typically sees a surge around the onsetting festive season, but this too is in the realm of conjecture, as yet. And the real concern is not if this consignment was the handiwork of the Chinese Sam Gor gang (or of the El Mencho-run Jalisco New Generation Cartel), but of the murky linkages with the Chinese authorities, which is always a possibility.

To my fellow writers and artists, I offer this perspective: showcasing our work is not something we do solely for ourselves. It's a way of expressing gratitude for the skills we've been granted. It is an acknowledgement of the universe's generosity and an effort to give back by letting our words reach those who might find meaning and

inspiration in them. yearn for our books to find Let's face it: the literary world about paying homage to the

is saturated. Thousands of books are published every single day, each jostling for space in an overcrowded marketplace. Amid this din, how can anyone possibly stumble upon a book unless it's brought to their notice? By showcasing our work, we're not seeking undue attention; we're simply ensuring that our creation has a chance to be seen and appreciated. Once upon a time, good writing was the golden ticket for a writer. Today, social media has taken on that role with unparalleled reach and immediacy. While humility is an admirable trait, excessive shyness can hinder the reach of our work. Imagine a painter hiding their masterpiece in an attic or a singer performing only in an empty room.

Writing, like any art, is meant for sharing. When we shy away from showcasing our creations, we deny our craft the audience it deserves. We owe it to ourselves and our readers to overcome this reluctance and step forward. By sharing our work, we're saying, "Thank you for this talent. Here is what I've made of it." It's not about vanity; it's

creative force within us. Writing can often feel like a solitary pursuit, but it doesn't have to be. #### **ENSURE MINORITY SAFETY**

Madam — The fresh row of violence against the Hindu minorities once again began in Bangladesh, leading to an escalation of disturbance between Indo-Bangladesh relations. # Freebies: A winning strategy or economic pitfall?

The growing trend of offering freebies in elections raises significant concerns about financial sustainability, governance and its impact on voters' mindset

major factor contributing to the success of the respective political party in the just concluded elections Maharashtra and Jharkhand was freebies - an acronym for "something given free of charge" – particularly those targeted at women. In Maharashtra, the BJP-led Mahayuti alliance launched the Ladki Bahin cash benefit scheme that offered Rs 1,500 a month to every woman with a family income of less than Rs 2,50,000 annually, in the age bracket of 21

The amount was subsequently increased to Rs 2,500 per month. In Jharkhand, under Mukhyamantri Maiyan Samman Yojna (MMSY) Hemant Soren's JMM-Congress-RJD government had initially promised to give Rs 1000 per month to all women in the age group 18-25 years. The amount was later increased to Rs 2500 per month.

The domineering role of freebies in winning elections is visible in almost every State Assembly election held since 2020 when former Delhi Chief Minister Arvind Kejriwal came up with this brand of politics followed by Punjab in 2022 where the Aam Aadmi Party or AAP promised depositing Rs 1000 per month in the account of every woman aged 18 or above. In Karnataka elections held in early 2023, Congress had promised five guarantees including the much trumpeted Gruha Lakshmi under which every woman head of a house gets Rs 2000 a month. In elections held later in 2023, in Madhya Pradesh, BJP promised Rs 1,250 per month under Ladli Behna Yojana; the amount to be gradually hiked to Rs 3,000 per month. In Chhattisgarh, it promised Rs 12,000 per year to married women under the 'Mahtari Vandan Scheme'.

In Odisha, under the Subhadra Yojana, the BJP gives eligible women Rs 10,000 per year, in two instalments of Rs 5,000 each. In future elections, expect all parties to offer such freebies. Already, in the budget for 2024-25, Delhi finance minister Atishi announced the Mukhyamantri Mahila Samman Yojana (MMSY) under which, the AAP government will give Rs 1000 per month to all the women above the age of 18 in the national capital. Now, Arvind Kejriwal has announced six Revdis (another name for freebies) including free power free water free education WOMEN RS 10,000 ower, free water, free education free healthcare and pilgrimage for the elderly. Freebies win elections but these lead to a host of negative outcomes. The most damaging is the abetment to corrup-

The Union Government's standards of financial propriety lay down inter alia that "no authority shall exercise its powers of sanctioning expenditure to pass an order which will be directly or indirectly, to its advantage; and the expenditure from public moneys should not be incurred for the benefit of a particular person or a section of the people unless a claim for the amount could be enforced in a court of law or the expenditure is in pursuance of a recognised policy or custom". The reckless spending of the taxpayer's money on freebies is neither a recognised policy nor is sanctioned in a court of law. It is blatant financial irregularity that amounts to bribing voters using public money solely for gaining advantage in electoral politics. Such a corrupt practice is much worse than the one that involves

an individual candidate distributing cash using his own money to garner votes. Second, unlike 'normal' budget expenses which are planned and backed by wellorchestrated efforts to garner revenue, additional financial liabilities imposed by the freebies promised in the election manifesto affect the budgetary position of the State in a totally 'uncon-trolled' and 'unplanned' manner. There being no corresponding revenue generation against this liability (this being unplanned), this will be at the cost of slashing other essential expenditures including development.

additional borrowings and the unsustainable level. In Punjab, the freebies promised by AAP led to an additional expenditure of about Rs 20,000 crore per annum. Unable to foot the bill from its FUTURE budget, Chief Minister Bhagwant Mann had to approach the Central government to help it raise around Rs 50,000 crore. In Delhi, giving Rs 1000 per month or Rs 12,000 annually to each woman above 18 years for a total of 6.7 million women would cost the exchequer Rs 8000 crore per

Already, the State government faces a fiscal deficit or FD - excess of total expenditure over total revenue - of Rs 18,000 crore during 2024-25 which is 80 per cent higher than the FD for 2023-24 at Rs 10,000 crore. This is despite a steep reduction of over 30 per cent in capital expen-

such a pass that CM Atishi has recently forwarded a request to the Centre seeking a loan of Rs 10,000 crore from the National Small Savings Fund (NSSF). In Karnataka, the five guarantees have punched a hole of over Rs 60,000 crore a year in the State budget leading to a doubling of its FD to over Rs 122,500 crore. The precariousness of the situation can be seen from a comment by the Deputy CM 'The government has no money to give to the MLAs for carrying out development work; courtesy the poll guarantees'. In MP, at the current rate of Rs

Alternatively, this will result in 1250 per month to 12.5 million beneficiaries, the Ladli Behna rojana costs the state exchequer about Rs 18,750 crore per annum. This will go up to Rs 45,000 crore per annum as the quantum of assistance eventually goes up to Rs 3,000 per month. In Maharashtra, the Ladki Bahin Scheme will dent the State exchequer by Rs 46,000 crore annual-Öther states Jharkhand, Odisha

etc are also feeling the pricks of promised freebies. Third, unlike a normal welfare scheme which has a sunset date, the freebies offered by winning parties have none. So, these will continue to be given 'eternally' - no matter which party rules - making perpetual holes in State budgets. Fourth, the money for freebies comes from taxpayers' pockets ('future' tax payers in case, the government borrows). When they know that taxes are used to

may even trigger non-compliance amongst them.

Finally, assured of financial help to meet most of their basic needs perpetually, the freebies cult is changing the mindset of people in a way that makes them complacent towards work. This undermines the very foundation of economic growth.

Left to themselves, political parties will never shun freebies. Can the Supreme Court (SC) force them? In an order in S Subramaniam

Balaji vs the Government of Tamil Nadu & Ors in July 2013, the SC had observed that the distribution of freebies of any kind influences all people. "It shakes the root of free and fair elections to a large degree." Yet, it held "The promises in the election manifesto cannot be construed as 'corrupt practice' under the Representation of People Act (RPA), or any other prevailing law and, hence, distribution of freebies can't be stopped when the ruling party uses public funds for this purpose through the passage of Appropriation Acts in the state Assembly".

The SC hasn't changed its stance even as on January 25, 2022, hearing a PIL on 'freebies', it observed "This is no doubt a serious issue, budget for freebies is going above the regular Budget. This disturbs the level playing field". These exhortations won't help. It should direct the government to enact a law on curbing freebies.

omestic political stability or lack of it can have a considerable impact on the development of renewable energy projects and investment in the sector. A stable government is always considered as a growth enabler whereas an unstable political landscape can derail the growth engine. With political stability, India now India forges ahead towards ambitious renewable energy ambitions. (COP29) in Baku. The Indian government was in a strong position to challenge developed nations on climate change, carbon emissions, and green energy investment

Political stability provides consistent policy and regulatory frameworks that favour and incentivize both domestic and international stakeholders to invest without fear of abrupt policy changes.

With a decadal political stability and policy push, India has made significant progress and achieved a milestone of 200 gigawatts (GW) in non-fossil fuel capacity. # Toll rises to 130 in Pak After Aleppo, Syrian insurgents advance to nearby province sectarian violence

he death toll from sectarian violence in Pakistan's Khyber Pakhtunkhwa province surged to 130, with at least six people killed and eight injured on Sunday, as clashes in the volatile Kurram district continued for the eleventh consecu-

tive day. The clashes between Alizai and Bagan tribes in the district started on November 22, after an attack on a convoy of passenger vans near Parachinar in which 47 people were killed a day earlier. Several passengers who had sustained grave injuries succumbed later, raising the toll in the convoy killing to 57.

Police said the situation remained tense, and violence persists despite a recent ceasefire agreement between the Sunni and Shia groups.

Thousands of Syrian insurgents took over most of Aleppo on Saturday, establishing positions in the country's largest city and controlling its airport before expanding their shock offensive to a nearby province. They faced little to no resistance from government troops, according to fighters and activists.

A war monitor, the Syrian Observatory for Human Rights, said the insurgents led by Hayat Tahrir al-Sham seized control of Aleppo International airport, the first international airport to be controlled by insurgents. The fighters claimed they seized the airport and posted pictures from there. Thousands of fighters also moved on, facing almost no opposition from government forces, to seize towns and villages in northern Hama, a province where they had a presence before being expelled by government troops in 2016. They claimed Saturday evening to have entered the city of

A huge embarrassment for **Assad:** The swift and surprise offensive is a huge embarrassment for Syria's President Bashar Assad and raises questions about his armed forces' preparedness. The insurgent offensive launched from their stronghold in the country's northwest appeared to have been planned for years. It also comes at a time when Assad's allies were preoccupied with their own conflicts.

In his first public comments since the start of the offensive, released by the state news agency Saturday evening, Assad said Syria will continue to "defend its stability and territorial integrity against terrorists and their supporters." He added that Syria is able to defeat them no matter how much their attacks intensify.

Turkey, a main backer of Syrian opposition groups, said its diplomatic efforts had failed to stop government attacks on opposition-held areas in recent weeks, which were in violation of a de-escalation agreement sponsored by Russia. Iran and Ankara. Turkish security officials said a limited offensive by the rebels was planned to stop government attacks and allow civilians to return, but the offensive expanded as Syrian government forces began to retreat from their positions

The insurgents, led by the Salafi jihadi group Hayat Tahrir al-Sham and including Turkeybacked fighters, launched their shock offensive on Wednesday. They first staged a two-pronged attack in Aleppo and the Idlib countryside, entering Aleppo two days later and securing a strategic town that lies on the highway that links Syria's largest city to the capital and

the coast. By Saturday evening, they seized at least four towns in the central Hama province and claimed to have entered the provincial capital. The insurgents staged an attempt to reclaim areas they controlled in Hama in 2017 but failed.

The 2016 battle for Aleppo was a turning point in the war between Syrian government forces and rebel fighters after 2011 protests against Assad's rule turned into an all-out war. After appearing to be losing control of the country to the rebels, the Aleppo battle secured Assad's hold on strategic areas of Syria, with opposition factions and their foreign backers controlling areas on the periphery.

The lightning offensive threatened to reignite the country's civil war, which had been largeLebanon's Hezbollah, which has backed Syrian government forces since 2015, have been preoccupied with their own battles at home. A ceasefire in Hezbollah's two-month war with Israel took effect Wednesday, the same day that Syrian opposition factions announced their offensive. Israel has also escalated its attacks against Hezbollah and Iran-linked targets in Syria during the last 70 days. Insurgents raise flags over the Aleppo citadel

#### NY City paying \$220m to Pak-owned hotel to house illegal immigrants

The City of New York pays USD220 million to rent a hotel owned by the Government of Pakistan to house illegal immigrants, a report claimed on Saturday. Vivek Ramaswamy described the purported revelation as "Nuts." "A taxpayer-funded hotel for illegal migrants is owned by the Pakistani government which means NYC taxpayers are effectively paying a foreign government to house illegals in our own country. This is nuts," Ramaswamy, a Republican, said in a social media post.

Ramaswamy along with Tesla Owner Elon Musk have been tasked by President-elect Donald Trump to improve government efficiency and remove wasteful expenditure under a Department of Government Efficiency built for the purpose.

## Plastic treaty talks draw to close with production limits still under debate

Negotiations on a treaty to end plastic pollution are drawing to a close Sunday as nations continue debating whether part of that should be putting limits on plastic production.

Negotiators spent all of Saturday trying to reach agreement behind closed doors, but the latest draft of the treaty, released Sunday afternoon, leaves the question to be settled in open session. It includes multiple options for several key sections.

For the most contentious of those — the proposal to limit can be recycled.

production — that includes a compromise that would set a target at a later conference and an option to drop the idea altogether. Every year, the world produces more than 400 million tons of new plastic. Plastic production could climb about 70 per cent by 2040 without policy changes. The draft's options also include

possible language to ban some plastic products that are singleuse or contain toxic chemicals, as well as less stringent options. It would also require parties to the treaty to improve the design of plastic products so they don't release microplastics and

Countries could adopt these provisions or make changes when they meet later Sunday. Delegates from some countries say the new draft is too weak. Sam Adu-Kumi, lead negotiator for Ghana, said the draft is full of voluntary measures that won't end plastic pollution but the world needs a treaty that imposes obligations on all par-

No treaty at all would be better than a weak one, Adu-Kumi added. Ghana's communities, bodies of water, drains and farmlands are choked with plastics, and dumping sites full of plastics are always on fire, he

"We are here for a legally bind-ing instrument to end plastic pollution," he said in an interview. "So if we are here and we are getting a treaty that does not address the issues head on, then where are we heading towards? We are not getting anything that will solve the issue. We want a treaty that will be able to solve it. Otherwise we will go without it and come and fight another time." At a news conference earlier in

the day, Panama and Fiji said that if other nations won't join them in standing up for the ambition this treaty requires, they should "get out" of their

They were joined by representatives from Mexico, France, Rwanda and the European Union, who together said they would do everything possible in the final hours to push a treaty forward that will solve the crisis.

# RBI may continue status quo on interest rate: Experts

he RBI is likely to keep the benchmark interest rate unchanged for one more time in its bilateral monetary policy review later in the week as inflation has breached its upper tolerance limit and may also moderate the growth forecast given the disappointing second quarter GDP numbers, experts

Reserve Bank Governor-headed six-member Monetary Policy Committee (MPC) is scheduled to meet on December 4 to 6, 2024. The decision of the rate-setting panel will be announced on December 6 by Governor Shaktikanta Das.

It was widely anticipated that the RBI would start reducing the benchmark interest rates soon but the central bank will have little option this time around as the latest print of retail inflation is The Reserve Bank has kept the repo or short-term lending rate unchanged at 6.5 per cent since February 2023 and experts think some easing could only be possible in February.

Madan Sabnavis Economist, Bank of Baroda said given the rather uncertain global environment and the possible impact on inflation and the fact that currently inflation has been averaging close to 5.9 per cent in the last two months, a status quo on repo rate will be the logical outcome from the policy.

There would be a change in RBI projections for both inflation and GDP as inflation has been higher so far than the RBI forecast for Q3 and GDP growth has come much below expectations in Q2. It would hence be of interest to see what the projections this time are," Sabnavis said.

India's economic growth slowed to near two-year low of 5.4 per cent in the September quarter of this

The central bank last hiked the repo rate to 6.5 per cent in February 2023 and since then it has held the rate at the same level. The RBI kept the repo rate unchanged at 6.5 per cent in its last bi-monthly review (October) also amid risks from higher food inflation.

On expectations from MPC, Dhruv Agarwala, CEO, Housing.Com and

PropTiger.Com opined that the Bank faces the challenging task of striking a fine growth and containing inflation.

June quarter. Total FDI, which includes equity inflows, reinvested earnings and other capital, grew by 28 per cent to USD 42.1 billion during the first half of this fiscal from USD 33.12 billion in April-September 2023-24, the Department for Promotion of Industry and



Internal Trade (DPIIT) data

During the April-September period this financial year, FDI equity inflows rose from major countries, including Mauritius (USD 5.34 billion against USD 2.95 billion), Singapore (USD 7.53 billion) against USD 5.22 billion), the US (USD 2.57 billion against USD 2 billion), the Netherlands (USD 3.58 billion against USD 1.92 billion against USD 1.92 billion), the UAE (USD 3.47 billion against USD 1.1 billion), Cayman Islands (USD 235 million against USD 145 million) and Cyprus (USD 808







## ICC: Jay Shah takes over as new chairman

The 36-year-old Shah, who headlined the BCCI as its secretary for the last five years, is the fifth Indian and the youngest ever to head the global cricket body.

He was the unanimous choice of the ICC's Board of Directors and replaced New Zealand attorney Greg Barclay, who didn't wish to continue for a third consecutive

Before Shah, businessman late Jagmohan Dalmiya, politician Sharad Pawar, lawyer Shashank Manohar and industrialist N Srinivasan have all headed the world cricket body.

Shah, the son of India's Home Minister Amit Shah, will have his task cut out as the Champions Trophy originally scheduled in



As of now, the Pakistan Cricket Board (PCB) has decided to accept the 'Hybrid Model' under which India play their matches in Dubai. But the PCB also wants the same courtesy to be accorded to Pakistan in all four ICC tournaments till 2031, which will be co-hosted or singularly hosted by the Indian cricket board.
