## Take steps to protect harvested paddy: CM

#### **OFFICIALS DIRECTED TO SHIFT PADDY TO RICE MILLS**

PNS VIJAYAWADA

In view of the heavy rain alert for Andhra Pradesh issued by the Met department, Chief Minister N. Chandrababu Naidu has directed all district collectors and joint collectors (JCs) to take proactive steps to protect the harvested paddy crop from potential damage. The CM has issued instructions to follow specific measures to safeguard the crop and minimise losses.

To prevent damage to harvested paddy due to rain, the CM has instructed officials to promptly transfer the harvested crop to rice mills, ensuring it is stored safely and not left exposed to the weather. The Agriculture Department has been directed to issue advisories to farmers, advising them not to harvest paddy during the rainfall. This precaution is aimed at avoiding exposure of the freshly harvested crop to moisture, which could affect both its quality and yield.

In cases where farmers have not used the traditional method of heaping the paddy, the government will provide tarpaulins to cover the harvested crop. Continued on Page 2

## 1L houses for poor by month-end

The State government is prioritising the construction of houses for the poor, particularly under the Pradhan Mantri Awas Yojana (PMAY-1) scheme. Since the NDA-led administration took office, efforts have been intensified to complete one lakh houses and distribute keys to beneficiaries

#### Turtles in peril: Strandings along Vizag coast raise alarm the causes and protect these crea-

The serene shores of Sagarnagar Beach witnessed a sombre sight on Sunday when a large turtle was found dead in the sea, sparking fresh concerns among environmentalists, fishermen, and forest officials. This marks yet another grim episode in the growing num ber of turtle strandings reported along the region's coastline in recent weeks, particularly around Rushikonda.

Environmentalists are alarmed at the distressing trend. the district's vibrant history." The meeting focused on ongoing works under the Amrit Bharat scheme at key stations including Srikakulam Road, Palasa, Ichchapuram, and Naupada. Waltair Divisional Railway Manager (DRM) Manoj Sahu provided updates on the progress.

Minister Naidu advocated for the rapid construction of the Arasavalli Sun Temple structure at Srikakulam Road station, and the expansion of the station from four to six platforms to handle growing passenger traffic. ## 'No Occupancy Certificates in case of violations of norms'

The Guntur Municipal Corporation (GMC) has declared that Occupancy Certificates (OCs) will not be granted to newly proposed multi-storey buildings that violate construction norms. GMC Commissioner Puli Srinivasulu stated that constructions encroaching upon roads, ramps, or drainage systems would face stringent penalties and denial of occupancy per-

On Sunday, Commissioner Srinivasulu personally reviewed applications for OCs in the Gorantla and Reddypalem areas of Guntur city. During inspections, he assessed compliance with key regulations, including setback measurements, road access, and potential encroachments on drainage systems. He directed officials to enforce these norms during approval and construction phases strictly.

The Commissioner emphasised the need to adhere to government-mandated building regulations for safe and sustainable urban development.



He instructed urban planning officials to take stringent action against violations and urged Ward Secretariat planning secretaries to conduct regular inspections of ongoing construction projects. In cases of non-compliance, immediate notices must be issued, and higher authorities informed.

No constructions should encroach upon road ramps or drainage systems. Violations must be rectified immediately," Commissioner disruptions.



## Paddy moisture levels recorded at RKS are final: Collector

District administration committed to providing MSP for paddy

PNS VIJAYAWADA

Krishna District Collector DK Balaji has clarified that the moisture levels recorded in paddy grains at the Rythu Seva Kendras (RSK) are final, assuring farmers that they need not worry about this issue. He stated that the district administration is working hard to provide a Minimum Support Price (MSP) for paddy farmers.

On Sunday, Ćollector Balaji visited villages including Majeru, Lankapalli, and Pupadam Devarakota in Ghantasalal mandal. He interacted with paddy farmers and enquired about the MSP and the transportation of paddy bags. Also, he inspected the paddy procurement in these villages.

Many farmers expressed concerns that due to recent floods, their paddy moisture levels exceed 27-30 per cent, leading them to receive only Rs.1,500 for a 75-kg bag. Fearing further heavy rainfall, they had to sell their paddy even with higher moisture content.

During these interactions, Collector Balaji reassured farmers that the district administration is committed to providing MSP for their paddy. He empha-

## Corruption, neglect destroying KGH

 Patients and staff expose alarming failures at North Andhra's premier healthcare institution

PNS VISAKHAPATNAM

King George Hospital (KGH), a vital healthcare institution for North Andhra, is grappling with corruption, neglect, and systemic failures that threaten its ability to serve the region. Many patients travel from neighbouring States like Odisha and Chhattisgarh for treatment at KGH. However, reports of delayed care, preventable deaths, and exploitation have raised serious concerns about its credibility.

For countless individuals, KGH represents the last hope when other options have failed. Yet, tragic stories of lives lost due to delayed treatment are becoming increasingly common. A senior hospital staff member spoke to The Pioneer anonymously. "Emergency cases are routinely ignored unless they come with strong recommendations or bribes," the

Corruption also seems to be deeply embedded in the hospital's operations. A recent viral social media post exposed a ward boy demanding Rs 1,500 from an elderly woman for basic help, a practice not isolated to just one incident. Ravi Kumar, a patient's relative, condemned it as "pure exploitation" of vulnerable individuals. A heart patient was abandoned until friends had to rush him to the cardiac ward. The lack of empathy from staff is not just unethical but profoundly inhumane. The hospital's deteriorating infrastructure

further complicates the situation. Many patients are forced to bribe staff for essential services, such as wheelchairs. One attendant shared, "I had to pay Rs 200 just to get a wheelchair for my father." Even more concerning is the shortage of critical medicines and working medical equipment, forcing patients to buy medicines from outside sources. Shanti Devi, whose husband is a patient, expressed frustra-



tion: "Doctors prescribe medicines that aren't available here. We're left to fend for ourselves."

Reports have also surfaced of staff working under the influence of alcohol, particularly during night shifts. One senior staff member hinted that random alcohol tests would expose shocking results. Meanwhile, the death toll continues to climb due to gross negligence. A recent report revealed six deaths in a single day, underlining the lethal consequences of the hospital's failures. Despite clear evidence of misconduct, authorities have taken no substantial action. "This is a tragic reminder of KGH's institutional rot," an insider lamented.

Nearby private diagnostic labs are exploiting the hospital's failings, charging patients exorbitant fees for urgent test results. Ramesh, a relative of a patient, criticised the practice: They exploit our desperation, knowing we have no other choice."

"It's heartbreaking to see such utter disregard for human life in a critical institution," said a senior doctor.

## Plea to control skyrocketing rice prices in open market

• Insecurity over move to implement Cash for Grains scheme for ration-card holders

The Muslim United Front and the Muslim Welfare JAC have urged Prime Minister Narendra Modi, Chief Minister Nara Chandrababu Naidu and Minister for Civil Supplies Nadendla Manohar to initiate measures to control skyrocketing rice prices in the open market. MUF and MWJAC president Md. Kaleem said that they wrote letters to PM Modi, CM Naidu and Minister Manohar over the rice prices.

Kaleem said that in the backdrop of the social media posts on the possible implementation of Cash for Grains (rice) scheme through DBT for the ration-card holders, there has been a high degree of insecurity prevailing among the poor and lower middle classes. He opined that giving money instead of rice will definitely not serve the purpose of PDS, especially in South Indian States. He further said that as far as AP is concerned, 63.79 per cent of the population are BPL card holders who receive rice through PDS. Due to the inferior quality of the PDS rice, many of these card holders prefer to sell the rice to millers, hotels etc. through mediators for monetary benefits.

Kaleem recalled that the price of rice (per Kg) in the open market was ranging around Rs 16 during early



2000's. However, the prices are currently Rs.50-60 per kg. He demanded that in this backdrop, the Union Government should adopt a mechanism to distribute the varieties of reasonable quality of rice at subsidised prices to reach an equilibrium point in this regard, where the people could get food grains at an affordable range of prices.

He lamented that the initia-

tive of selling Bharat Rice (Rs. 29 per Kg) via NAFED, NCCF, E-Commerce has not been yielding desired results due to limited number of outlets and inferior quality of the commoditv. He felt that if at all the scheme of reimbursing the amount to the card holders (instead of distributing the commodity) is being considered for implementation, it will cost more burden on the exchequer.

Kaleem stated that instead, it is submitted that the Union Government may use the same amount to reach an amicable deal with the rice-millers so that they could provide a nice quality of rice to the PDS beneficiaries. He further stated that similar price-stabilisation mechanisms could also be devised for other essential commodities such as wheat, pulses etc. He opined that such measures will not only help the Union Government in controlling the Inflation, but also positive results in curbing the unauthorised hoarding of essential commodities smuggling, black marketing. He added that their organisations requested to frame a policy to regulate the prices of essential commodities as well as ensuring subsidised distribution of

the same to every citizen

## Nandigama KV expected to start from 2025-26

 Union Cabinet gives approval; 200 students from Classes 1-5 in first year

The third Kendriya Vidyalaya (KV) in NTR district is all set be established at Nandigama, approximately 55 kilometres from Vijayawada, the district headquarters. Although the school was sanctioned three years ago, its operations were delayed due to various challenges. However, with the consistent efforts of Vijayawada MP Kesineni Sivanath (Nani), the Union Cabinet recently approved the commencement of the school.

The district administration is making the necessary arrangements to start operations at the Government Community Women's Polytechnic Ćollege premises located on Madhira Road, Nandigama. Classes are expected to start at the longcherished Kendriya Vidyalaya at Nandigama from the 2025-26 academic year.

Currently, there are two KVs in the district -- the main one at Satyanarayanapuram and the second one at Guntupalli. Parents are eagerly waiting for the new KV at Nandigama, as they believe that Kendriya Vidyalaya education is the best.

According to the sources, 200 students will be admitted in Classes I-V for the first academic year. As per the New

Education Policy (NEC), each class should have around 40 students. Later on, the strength of the students will be increased every year, the sources added.

Meanwhile, the sources said that the CBSE recognition will be sanctioned from in the 2026-27 academic year as Class VI will be started in that year. As per the rules, Post Graduate Teachers (PGT) recruitment will also be initiated in 2026-27, the sources said

#### 5 acres allotted at Hanumanthapalem

The previous government allotted the Government Community Womlen's Polytechnic College building for the school temporarily. The Nandigama municipality spent Rs.73 lakh to renovate the Women's Polytechnic College. Additionally, the government has allotted five acres of land for the construction of the permanent buildings at Hanumanthapalem, beside AP TIDCO houses.

Also, Mamdoga municipality incurred an expenditure of Rs.50 lakh for the levelling of the land. However, the KV works have not been started yet. The NTR district administration is ready to start the building works soon after obtaining funds from the Union government.

## Mango crop insurance scheme to cover 15 districts in AP

#### State divided into four clusters for implementation of the scheme

The State government has introduced a Restructured Weather-Based Crop Insurance Scheme (RWBCIS) for mango farmers, covering the 2024-25 and 2025-26 seasons. The initiative, aimed at mitigating crop losses due to weather calamities, was announced by Agriculture Ministry V. Alchamaidu in the Minister K. Atchannaidu in the Legislative Assembly.

Under the scheme, the State has been divided into four clusters for implementation. The Insurance Agriculture Company of India Limited has been appointed as the implementation agency. Farmers in

15 identified districts will benefit, with the scheme offering compensation for crop losses. However, the districts of Krishna, West Godavari, Prakasam, and Visakhapatnam have been excluded.

According to G.O.Rt.No. 752 issued by Special Chief Secretary B. Rajasekhar, the scheme includes both Kharif and Rabi seasons, with mangoes added as an additional crop during Rabi. Farmers in Cluster 1, comprising Anantapuram, will pay a 15% premium. Those in Cluster 3, which includes NTR, Kakinada, YSR Kadapa, Annamayya, Vizianagaram, SPSR Nellore, and Chittoor districts, will pay 16.77%. In Cluster 4, covering Srikakulam, Sri Satyasai, Tirupati, and East Godavari districts, farmers will pay a 17.74% premium. Farmers in Cluster 5, which includes Nandyal, Anakapalli, and Eluru, will pay 16.08%.

Participation in the scheme is voluntary for both loanee and non-loanee farmers. Marginal farmers, who will contribute between 15% and 17.74% of the premium, are expected to benefit significantly from this initiative. The scheme aims to provide financial security to mango farmers by addressing crop losses caused by adverse weath-

## Ex-Pithapuram MLA Varma dares YSRCP for debate on Kakinada SEZ land row


## Tribals build makeshift school for their children

Residents of remote hamlets in ASR district show determination for a better future

PNS BAPATLA

The tribals of the agency region in Alluri Seetharamaraju (ASR) district have shown that determination and self-reliance can overcome even the most daunting challenges. Residents of Buruga and Chinna Konela, two remote tribal hamlets in Rompalle panchayat under Anantagiri mandal, have constructed a makeshift school shed using their own resources, emphasising their commitment to education despite systemic neglect. "We cannot wait for someone to come and help us," said Buriga Pentayya, a local villager. "If we don't do this for our children, who will? We want them to study, succeed, and have a better life than we did."

The MPP Elementary School in Buruga village, established 60 years ago, has faced decades of neglect. Although 35 students are enrolled, the lack of a functional building has turned education into a daily struggle. Villagers, many of whom are



makes it difficult for teachers to commute," explained a villager. In 2022, ITDA Project Gopalakrishna Officer Ronanki trekked 15 kilometres to witness the villagers' plight firsthand. His efforts resulted in the appointment of teachers, but the lack of infrastructure persisted. Classes were often held under trees during dry spells and suspended entirely

during monsoons. "In 2012-13,

Rs 13 lakh was sanctioned under the Sarva Shiksha Abhiyan for the school, but it only covered the foundation," said Kona Patti Simhachalam, a resident. "Since then, no progress has been made."

Faced with continued apathy, the villagers sought help from the Freedom Society, which provided benches, chairs, and play equipment. Former Union Energy Secretary EAS Sharma also offered financial support. Inspired, the community rallied together, gathering sticks, stones, and other materials to build a temporary school shed. "Support from organisations gave us the courage to start this initiative," said Somila Appalaraju, the 10th ward

However, the villagers' strugle reflects broader issues. They allege exploitation of their ancestral lands by realtors and officials, made easier by their lack of education. "This is why we fight for our children's education," said S. Shankar Rao. "We want to equip them with the knowl-

edge to protect their rights."

The villagers have now turned their focus back to the government, urging authorities to construct a permanent school building. "We have done our part," said Buriga Pentayya. "Now it's time for the authorities to do theirs. Our children deserve a proper edu-

#### Three students killed as bus overturns in Rajasthan

## India to set up anti-drone unit for border security: Shah

Union Home Minister Amit Shah on Sunday said India will soon create a comprehensive anti-drone unit to secure its borders as the "menace" of unmanned aerial vehicles is going to get serious in the coming days.

Addressing BSF troops at the 60th Raising Day event of the force here at its training camp, about 300 km from the India-Pakistan border, Shah said the initial results of a "laser equipped anti-drone gunmounted" mechanism have been encouraging.
This has led to an increase in

drone neutralisation and detection cases, up from 3 per cent to 55 per cent, along the India-Pakistan border in Punjab, he said. "The drone menace is going to get more serious in the coming days... We are tackling this issue in a 'whole of government' approach with the border guarding forces, defence and research organisations and the DRDO joining hands.

"We are going to create a comprehensive anti-drone unit for the country in the coming time," Shah said.



According to official data, more than 260 drones have been downed or recovered from India's border with Pakistan this year as compared to about 110 in 2023. The maximum number of such interdictions of drones carrying arms and drugs have taken

## Farmers' foot march to Delhi thwarted

#### Haryana police use teargas to disperse protesters

The protesters, dubbed as 'marjeevras', (someone willing to die for a cause), were stopped only a few metres into the march and the standoff continued for over three

## Delhi's air quality deteriorates, AQI crosses 300

Delhi's air quality took a downturn on Sunday, plunging again into the 'very poor' category with an AQI reading of 302 after having improved to the 'moderate' level at the start of December. The air quality had last been

recorded in the 'very poor' category on November 30, with a reading of 346. The 24-hour average Air Quality Index (AQI) of the city

was recorded at 302 at 4 pm on Sunday, marking a deterioration compared to Saturday's reading of 233 (poor' catego-

ry).
Of the 38 air quality monitoring stations in the city, 23 reported air quality in the very poor category on Sunday, compared to only two on Saturday.

Meanwhile, 13 stations recorded air quality in the 'poor' category, and the rest were in the 'moderate' category, according to the Sameer app. At the start of December,



the air quality improved, shifting first to the 'poor' category and then further to the 'moderate' category. But Sunday saw the air qual-

ity deteriorating sharply to the 'very poor' category from 'moderate.' The Central Pollution Control Board (CPCB) classifies AQI between 0 and 50 as "good", between 51 and 100 as 'satisfactory", between 101 and 200 as "moderate", between 201 and 300 as "poor", between 301 and 400 as "very poor", and above 400 as "severe". The primary pollutants on Sunday were PM 10 and PM2.5 with PM 10 levels recorded at 249 μg/m <sup>3</sup> and PM 2.5 levels at

134.4 μg/m <sup>3</sup> at 4 p.m.

These fine particles pose significant health risks as they can penetrate deep into the lungs and enter the blood-

Meanwhile, the Decision Support System (DSS), the primary tool used to assess and estimate the sources of pollution in Delhi, has not been updated November 29.

The latest data available on the website is from November 26 to November 29, and data for the past four days is now

## End of an era

The fall of Damascus to rebel forces and Bashar al-Assad's flight marks a watershed moment in Syrian history

The Assad family's grip on Syria, a legacy spanning more than five decades, has come to an end. The dramatic overthrow of Bashar al-Assad, following the rebel forces' breach of Damascus, marks the end of an era that began with his father, Hafez al-Assad. This monumental shift reshapes Syria's trajectory and poses critical questions for West Asia. The Assad dynasty began in 1970 when Hafez al-Assad seized power in a coup, transforming a politically unstable Syria into a tightly controlled state. Hafez's rule was characterised by ruthless centralisation, sectarian manipulation, and an iron grip on the military. His divide-and-rule tactics entrenched the Alawite minority—a historically marginalised community—to positions of power, ensuring the regime's survival at the expense of institutional robustness. Hafez's successor, his son Bashar, inherited a state rife with contradictions. Initially hailed as a potential reformer, Bashar's presidency quickly descended into authoritarianism, economic cronyism, and brutal sup-



pression of dissent. His consolidation of power alienated Syria's rural majority and exacerbated sectarian tensions, sowing the seeds of unrest that erupted in 2011 during the Arab Spring.

Widespread poverty, corruption, and inequality under Bashar al-Assad's rule alienated vast swathes of the population. Economic mismanagement, compounded by a severe drought in the late 2000s, devastated rural livelihoods and drove migration to overcrowded urban centres, fueling discontent. The 2011 uprising ignited a protracted civil war that fractured Syria. While Bashar managed to cling to power for over a decade, the regime's reliance on military force to suppress dis-

sent alienated many. The state's inability to provide security or basic services during the war eroded its legitimacy. A coalition led by Hayat Tahrir al-Sham (HTS) capitalised on waning regime strength. Despite its controversial history as a former al-Qaida affiliate, HTS's military success and rebranding under Abu Mohammed al-Jolani enabled it to unify disparate opposition factions, culminating in the capture of Damascus. It fell after weeks of fierce fighting, prompting Bashar and his family to flee. The fall of the Assad regime has far-reaching consequences for Syria and the broader West Asia. Syria faces a precarious future, with no clear political alternative to the Assads. The rise of HTS raises concerns about governance and inclusivity in a post-Assad Syria. Without a unifying national vision, the risk of further fragmentation looms large. The power shift in Syria will likely unsettle neighbouring countries. Turkey, which has supported opposition factions, may seek to expand its influence. Iran, a long-time ally of Assad, faces the prospect of diminished leverage, while Israel watches the developments with caution. Indeed, decades of conflict have left Syria with a shattered economy, displaced millions, and decimated infrastructure. The international community will need to step up with aid and reconstruction efforts to prevent further suffering of Syrian people.



## Domestic compulsions get the better of Trudeau



While the Canadian Prime Minister Justin Trudeau's focus on India may serve short-term political goals, it risks long-term damage to bilateral relations

ecently, the Royal Canadian Mounted Police (RCMP) made sensational claims accusing Indian diplomats of engaging in acts of violence, intimidation, and murder targeting Khalistani extremists, allegedly with the help of the Lawrence Bishnoi gang. This accusation came just two days before Canadian Prime Minister Justin Trudeau was scheduled to testify before the Foreign Interference Commission, which was investigating allegations of Chinese interference in elections. These allegations suggested that such interference had benefited Trudeau's Liberal Party, contributing to its electoral success and the loss of seats for Conservative candidates.

Notably, a day before the RCMP's claims, members of Trudeau's government leaked sensitive information to *The Washington* Post (WP) to amplify Ottawa's narrative internationally. On October 16, Trudeau appeared before the commission but devoted significant attention to India instead of addressing the allegations of Chinese interference. He admitted to having no "hard evidence" but only "intelligence inputs" regarding the claims against India, raising questions about his motives.

**Political Diversion** Prime Minister Trudeau faces mounting dissatisfaction among

Canadians over various domestic crises, including high living costs, an unaffordable real estate market, immigration issues, and rising unemployment. Economic challenges such as slow growth, a widening fiscal deficit, and stagnating per capita GDP have further eroded Trudeau's support. Additionally, accusations of personal extravagance and the unpopular carbon tax have compounded public frustration. Speculation abounds that Trudeau may also be contending with internal dissent within his

Ottawa has accused India of being uncooperative in the investigation into the killing of Hardeep Singh Nijjar, a prominent Khalistani figure. However, some analysts suggest the issue lies in Canada's limited geopolitical leverage compared to the United States. For instance, WP reports allege that the CIA assisted in gathering evidence implicating Indian operatives in potential plots against Khalistani leaders. In contrast, Canada has only intelligence inputs from its Five Eyes partners and intercepted conversations of Indian diplomats.

Ironically, while Canada prioritises the safety of Khalistani extremists, acts of violence, hate speech, and threats targeting Indian diplomats, temples, and community leaders have received little attention from Trudeau's government.

Trudeau's Dilemma Recent revelations have further complicated Trudeau's position. Last month, RCMP Commissioner Mike Duheme claimed to have "irrefutable evidence" implicating senior Indian officials in Nijjar's murder. However, Trudeau later ng any such evidence, calling leaks to *The* Globe and Mail baseless and criminal. This inconsistency has fueled speculation about Trudeau's motives and whether external pressures—such as U.S. intelligence directives or

political considerations might be influencing his stance. Future of India-Canada Relations

Despite robust people-to-people ties and ongoing trade, India's relationship with Canada has been fraught with tensions over Khalistani extremism. The issue transcends Trudeau or the Liberal Party and reflects deeper systemic problems in Canadian politics. Conservative leader Pierre Poilievre, while maintaining a neutral stance, has also avoided directly addressing Khalistani extremism, raising doubts about whether a change in government would significantly alter Canada's approach.

India has historically responded to incidents involving Khalistani extremism in Canada with diplomatic protests and calls for accountability. However, experts argue that India should adopt a more proactive and sustained approach, raising the issue at international forums like the United Nations and during bilateral dialogues with Western nations. Emphasising the principles of hate speech exist in Canadian legislation, could strengthen India's case against Khalistani violence.

limate change disproportionately affects the world's poorest and most vulnerable communities. For them, it's not just an environmental issue but a daily struggle for survival. Living in precarious conditions, these populations bear the brunt of climate-induced disasters such as floods, droughts, and extreme weather, which devastate their homes, livelihoods, and food security. It reveals that over 90 per cent of people in the 20 countries most affected by the climate crisis lack access to social protection, such as child or unemployment benefits. ## Advancing the Centre's liberalisation agenda



Agri-marketing reforms can be achieved by enabling bulk buyers to purchase directly at farm gates and creating multiple private-sector e-trading platforms

n June 2024, the Union Ministry of Agriculture and Farmers' welfare set up a 12-member committee, under the chairmanship of additional sec-retary, Faiz Ahmed Kidwai with the mandate to formulate a national policy framework for marketing of farm items and suggest measures to ensure the remunerative prices to farmers. The committee has recommended (i) allowing direct farm-gate purchases of agriculture commodities by bulk buyers, including organised retailers, without having to go through the state-notified mandis or pay the various levies that the operators of these market yards charge; (ii) declaring warehouses, silos and cold storages, including those run by private agencies, as "deemed market yards" (DMYs); (iii) establish and operate multiple e-trading platforms, including e-NAMs (electron-ic-national agriculture market) in the private sector.

Will the suggested measures help in achieving the stated objective? At present, agriculture marketing is carried out under the respectivestate laws viz. APMC (Agricultural Produce Market Committee) Actwhich has widely varying provisions. This hampers the free movement of the agri-produce between different states. Even within a state, there isn't a free flow of the agri-produce as for the administration of marketing it is divided into several market areas and farmers in a given area can sell their agri-produce only at the designated APMC Mandi.

Between APMC Mandis, also market

regulations vary widely. At the mandi, a cartel of licensed traders and commission agents (knownas artisans in local parlance, their job is facilitating transactions betweenthe farmer and the buyer) rules

The duo exploit the farmer to the hilt by giving a low price, rejections, weighing less, delaying payment, etc. Levies such as market fees, anthias commission, rural development cess (RDC) etc further erode her netback. The APMC mandis can handle only a fraction of the quantity farmers bring to sell. So, most of them are forced to come to private local markets, where sales are legally barred.

At these markets, they end up selling their produce to traders at throw The latter have the blessings of corrupt bureaucrats and politicians and hence, won't face any action for violating the law. True, state agencies such as The Food Corporation of India (FCI), purchase in mandis specified crops for running welfare Schemes. They make purchases at the PRIVATE MARKETS minimum support price (MSP) notified by the Centre. But, their purchases are limited. Even so only 6 per cent of farmers mostly rich with larger land holdings – get access to government procurement.

Although many states have made enabling provisions for setting up private wholesale markets, private markets have come up STATES HAVE NOT only in a few states. This is because some states have not framed rules and in others, the rules are far from conducive to AND IN OTHERS, attract private entrepreneurs. A few states like Maharashtra, Uttar Pradesh, Gujarat, Rajasthan and Karnataka have made provisions for farm-gate purchases but these transactions are restricted to select commodities for defined periods, and that too, after paying the taxes to the respective ATTRACT PRIVATE APMCs. Even the e-NAM (an online ENTREPRENEURS trading platform for agri-produce launched by the Centre in April 2016, was



made necessary amendments in their laws toprovide for electronic trading in agri-produce. Moreover, many APMCs have not set up an e-auction platform. The proof of the pudding is in the action. Out of a little over 7000 eating. Out of a little over 7000 regulated wholesale APMC mandis, just about 20 per cent of 1400 STATES HAVE have been integrated into the e-NAM platform. Besides, the farmers registered on the e-NAM por-PROVISIONS FOR tal are 17.5 million which is around 12.5 per cent of the total SETTING UP 140 million.

As for business transacted on the portal, this hovers around 12 per cent of the total value of annual trade in agri-commodities (excluding dairy and meat products). At a fundamental level, the problem has to do with the continued stranglehold of the states on APMCs. In fact, for almost everything that stakeholders need to do for doing business on e-NAM be it pan-state/India license for traders, letting farmers sell on the portal (instead of only at designated Mandi) and so on, they need to get permission from the

state authorities. To cap it all, extant laws don't permit private entities to engage in agri-marketing. Now, the Committee's recommendations to allow direct farm-gate purchas-CONDUCIVE TO es of agri-commodities by bulk buyers, including organised retailers without having to go through the state-notified mandis or pay the various levies that the opera-

charge; giving warehouses, silos and cold storages, including those run by private agencies, DMYs status and setting up multiple e-trading platforms including e-NAMs in the private sector essentially seek to give more options to farmers for selling their produce. But, the million-dollar question is How do you make these ideas work? For bulk buyers to directly purchase from farmers bypassing APMCs - the concerned State will have to make

provision in its APMC Act. Likewise, to enable farmers to sell straight from warehouses, silos and cold storages etc, the State has to amend the law. Similarly, for law and give legal protection to buying and selling to happen on the e-platform, the State will have to make necessary amendments to the Act.

This is acknowledged by none other than the Committee itself when it says "To align with the proposed national policy, the states and union territories would have to notify state policy on agrimarketing as the subject falls in the domain of states". But, the states are unlikely to give the desired relaxations in their laws. In the past, they have done little to liberalise agri-marketing despite much prodding by the Centre; Remember a Model Agricultural Produce and Livestock Marketing (Promotion and Facilitation) Law passed by the latter in 2017 which gave more options to farmers for selling besides a 'single pan-State license' for traders buying from anywhere in the State. But, this was ignored by the states.

Faced with the unwillingness of States to unshackle the farmers

from the clutches of APMCs and the dire need to open up agrimarketing, the Union government used its powers under the Constitution to offer them a parallel front. In September 2020, it enacted the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020 to regulate inter-state trade and intrastate trade, providing for freedom of choice to the farmer or trader to conduct trade and commerce while allowing traders to purchase specified farm commodities directly from farmers anywhere in the country, even outside the State APMCs

To realise the full potential of this ers, it enacted two other laws viz. Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020 and the Essential Commodities (Amendment) Act, 2020.Unfortunately, bowing to year-long protests by a handful of farmers and the Supreme Court order in January 2021 staying their implementation, Modi announced their repeal on November 19, 2021. The SC never said these laws were unconstitutional.

A revolutionary move by the Centre to give a remunerative price to the majority of poor farmers and increase their income was sabotaged by middlemen/ traders who had much to gain from the continuation of the status quo.

The situation can be retrieved only if the SC pronounces its verdict on merit.

There are also privacy-related issues, as embedded insurance depends on leveraging customer data for personalised offers. However, despite these limitations, there are numerous opportunities to

cover a large proportion of the uninsured population. As different sectors and industries are digitised at a good pace, the future of embedded insurance has immense potential for customised and micro-insurance products catering to diverse consumer needs. **Summing Up** 

Embedded insurance has redefined the delivery of insurance services through integration in daily transactions. In the Indian context, the overall increase in the number of digital users and rapid transformation of industries gives an excellent opportunity for insurance companies to bridge the existing insurance gap; the opportunities in this field will be immense.

#### 'Adani's solar contract has tariff lower than competition'

Adani Group's solar power contract, which is at the centre of bribery allegations, has tariffs that are lower than competition and can find new buyers in case the pact is cancelled, according to analysts. US authorities have charged Adani Group Founder-Chairman Gautam Adani and others for being part of a scheme to offer USD 265 mil-lion bribe to Indian officials to gain a contract to supply 8 gigawatt of electricity generated from solar energy by Adani Green Energy Ltd (AGEL). The group has denied all

charges.
"If Adani promoters are found guilty, we believe the size of potential penalty is manageable given it is up to three times the value of the bribe," Nomura said in a

The brokerage said there are about 1.8 GW solar projects commissioned in Gujarat from February-March 2024, with tariff of Rs 2.42 per unit under the 25-year power purchase agreements (PPAs).

These operational projects are running under 5 special purpose vehicles, namely Adani Green Energy Twenty Four A Ltd (AGE24AL), AGE24BL, AGE25AL, AGE25BL, and AGE26BL.

These may have project debt of about USD 685 million, if assuming capex cost of USD 500,00 per megawatt and 75 per cent capex as debt.

## **CII** urges govt to stick to fiscal deficit target

Industry body CII has suggested the government to stick to the fiscal deficit target of 4.9 per cent of GDP for 2024-25 and 4.5 per cent for 2025-26, cautioning that "overly aggressive targets" beyond these could adversely affect India's economic growth.

"India has been growing rapidly amidst a slowing glob-al economy. Prudent fiscal management for macroeconomic stability has been pivotal to this growth," said Chandrajit Banerjee, Director General, CII, elaborating on suggestions for the forthcoming Union Budget.

CII also highlighted the announcement in the Union Budget 2024-25 to keep the fiscal deficit at levels that help reduce the debt-to-GDP

In preparation for this, the forthcoming budget could lay out a glide path to bring the central government's debt to below 50 per cent of GDP in the medium term (by 2030-31), and below 40 per cent of GDP in the long term, CII has suggested. Such an explicit target will

have a positive impact on India's sovereign credit rating and further on the interest rates in the economy, the Confederation of Indian Industry (CII) stated.

"To aid longer-term fiscal planning, the government should consider instituting

The reporting can also include long-term (10-25 years) forecasting of fiscal positions, accounting for the impact of factors like economic growth, technological change, climate change, demographic changes, etc.

Several countries have adopted this proactive ranging from 10 years in Brazil to 50 years in the UK.

"Looking at the next year's budget, CII has suggested sticking to the fiscal deficit target of 4.9 per cent of GDP for FY25 and a target of 4.5 per cent for FY26. However, CII has also pointed out that overly aggressive targets beyond the ones mentioned could adversely affect growth," the industry body said.

CII has suggested three interventions to nudge states towards fiscal prudence.

Firstly, the states could be encouraged to institute statelevel Fiscal Stability Reporting.

## FDI inflows in India cross \$1 trillion

Foreign direct investment (FDI) inflows into India have crossed the USD one trillion milestone in the April 2000-September 2024 period, firmly establishing the country's reputation as a safe and key investment destination global-

According to data from the Department for Promotion of Industry and Internal Trade (DPIIT), the cumulative amount of FDI, including equity, reinvested earnings and other capital, stood at USD 1,033.40 billion during the said period.

About 25 per cent of the FDI came through the Mauritius route. It was followed by Singapore (24 per cent), the US (10 per cent), the Netherlands (7 per cent), Japan (6 per cent), the UK (5 per cent), UAE (3 per cent) and Cayman Islands, Germany and Cyprus accounted for 2 per cent each. India received USD 177.18



billion from Mauritius, USD 167.47 billion from Singapore and USD 67.8 billion from the US during the period under review, as per the data.

The key sectors attracting the maximum of these inflows include the services segment, computer software and hardware, telecommunications, trading, construction development, automobile, chemicals,

and pharmaceuticals. According to the Commerce and Industry Ministry, since 2014, India has attracted a cumulative FDI inflow of USD 667.4 billion (2014-24), registering an increase of 119 per cent over the preceding decade (2004-14).

"This investment inflow spans 31 states and 57 sectors, driving growth across diverse industries. Most sectors, except strategically important sectors, are open for 100 per cent FDI under the automatic route.

FDI equity inflows into the manufacturing sector over the past decade (2014-24) reached USD 165.1 billion, marking a 69 per cent increase over the previous decade (2004 -14), which saw inflows of USD 97.7 billion, an official has said.

#### Aadhar Housing Finance aims AUM of over Rs 25,000 cr

PNS NEW DELHI

Aadhar Housing Finance, which caters to the affordable segment, expects its asset under management (AUM) to cross Rs 25,000 crore by the end of the current financial year.

"We closed the first half with the AUM of Rs 22,817 crore (from Rs 18,885 crore as of September 30, 2023). Going by the growth rate of 23-24 per cent, AUM should increase to Rs 25,000-26,000 crore by the end of March 2025," Aadhar Housing Finance, MD and CEO Rishi Anand said. Focused on the lowincome housing segment, he said, "Our average ticket size stands at Rs 10 lakh with an average loanto-value ratio at 59%.

## Electronics component makers seek Rs 72,500 cr financial package

PNS NEW DELHI

Electronics component makers body Elcina has sought a Rs 72,500 crore (USD 8.57 billion) support package to boost local production of raw materials and cut reliance on imports, an industry official said.

Electronic Industries Association of India (Elcina), the country's oldest industry body of the Indian electronics sector, estimates that the demand-supply deficit for inputs in the electronics segment will increase to USD 248 billion (about Rs 21 lakh crore) by 2030 to cater to projected USD 500 billion electronics production and it would be met largely by imports.

The industry body expects that the government's support for non-semiconductor components can help reduce the deficit in the country by USD 146 billion (Rs 12.36 lakh crore) to USD 102 billion (Rs 8.63 lakh crore).

Elcina Secretary General Rajoo Goel told PTI that unlike finished products where the factory output can go up to 16 times the investment, an electronic components factory can at the most generate an output of three times the invested People hesitate to expand

their investment in electronic components due to low return, high operational cost and long gestation period. Therefore we have requested the government for USD 8.57 billion comprsing USD 2.14 billion for capex to encourage expansion of the industry and USD 6.43 billion as PLI," Goel said.

The government is actively considering a comprehensive package to support the production of non-semiconductor electronic components.

Elcina has included miniature electronic components, printed circuit boards, some discreet semiconductors and active components, metallic components etc in the esti-

According to the industry body, the components for which support is required account for 60 per cent of the total cost of a finished product.

Goel said that out of 60 per cent, non-semiconductor components account for 40 per cent of the total product value and 20 per cent are semiconductors.



## 66 pc businesses surveyed paid a bribe: Survey

A report by online platform LocalCricles said on Sunday that around 66 percent of business firms surveyed across 159 districts admitted that they paid bribes in the last 12

months. The survey, which received 18,000 responses, found that 54 per cent were forced to pay bribes while 46 per cent paid voluntarily to expedite the

"As many businesses would vouch anonymously, bribes remain a way of life when wanting to get government

permit or compliance process, even getting duplicate copy of the authority license or anything to do with property matters. 66 per cent of businesses surveyed paid a bribe in the last 12 months," the report

Only 16 per cent of businesses surveyed claimed that they always managed to get work done without paying a bribe and 19 per cent said they 'did not have a need" to do so.

"Of businesses that paid bribes in the last 12 months, 54 per cent were forced to do so, while 46 per cent paid it for



timely processing. This kind of bribery amounts to extortion where permits, supplier qualification, files, orders, and payments are routinely held up when dealing with Government agencies," the report said.

According to the report, bribery paid by businesses continues to take place despite computerisation in several places, and behind closed doors away from CCTVs.

Businesses admitted to paying a bribe in the last 12 months to different types of entities for qualifying as a supplier, secure quotations

"Though initiatives like the Government eProcurement marketplace are good steps to reduce corruption, there are still openings to engage in corruption for supplier qualification, bid manipulation, completion certificate and payments," the report said.

Business firms that participated in the survey conducted between May 22 and November 30, 2024, said that 75 per cent of the bribes were paid to officials of departments such as legal, metrology, food, drug, health, etc.

n what is being perceived as a big win for Vashu Bhagnani, the Hon'ble Judicial Magistrate Bandra, Mumbai, has directed Bandra Police Station to file an FIR against director Ali Abbas Zafar, co-producer Himanshu Mehra and others under Sections 120-B Criminal Conspiracy, 406, 420 Cheating, 465 Forgery, 468 Forgery for the Purpose of Cheating, 471, 500 Criminal Defamation and 506 Criminal Intimidation, r/w.34 of the Bharatiya Nagarik Suraksha Sanhita/IPC, who had helmed the 2024 multi-starrer Bade Miyan Chote Miyan. September 3, 2024, Vashu Bhagnani had filed a complaint against Ali Abbas Zafar, Himanshu Mehra and others with Bandra Police Station for fraud, forgery, criminal breach of trust, cheating and misappropriation of crores of rupees by falsifying and forging signatures of Vashu Bhagnani during the shooting of Bade Miyan Chote Miyan, but no action was taken by the police.

Thereafter, Vashu Bhagnani sought the Bandra Metropolitan Magistrate Court's direction to register the FIR against Ali Abbas Zafar, Himanshu Mehra and others. The Hon'ble Court, in its order dated 02.12.2024, held that the total amount of alleged fraud and cheating and the number of transactions in the several transactions is very high and they are spread across several places. The Court further held that the evidence that needs to be collected involves several agencies and might be several numbers of documents, and the offenses are cognizable and non-bailable and the allegations are serious, and accordingly the Hon'ble Court ordered the Bandra Police Station to file an FIR under sections 120-B, 406, 420, 465, 468, 471, 500 and 506, r/w.





ith Jashn-E-Ghazal, Sajid Khan rekindles the soul of ghazals, weaving a poignant tribute to his brother Wajid while bridging the echoes of tradition with the rhythms of modernity. In the vibrant corridors of Bollywood, the music of Sajid-Wajid has resonated as more than mere melody; it has been a heartbeat. But when Wajid Khan, one half of the legendary duo, passed away in 2020, the rhythm faltered. Left to navigate the music world without his partner, brother and anchor, Sajid Khan crafted Jashn-E-Ghazal—a tribute to their shared legacy and the timeless music they created together.

In this exclusive interview with The Pioneer, Sajid reflects on his journey of transformation, the making of Jashn-E-Ghazal and the evolving landscape of the

music industry.

"It's a mix of emotions—unexpected and bittersweet," Sajid begins, reflecting on stepping into a solo career after Wajid's passing. "I never imagined working without him, let alone not seeing him by my side. But I feel his presence in everything I do. Life is unpredictable and while I miss him deeply, I'm embracing this new journey. Wajid would have wanted that."

For Saiid, the void left by Waiid was both personal and professional and it extended beyond their family to the industry and fans who cherished their collaboration. "It's natural for people to wonder how one half of a duo will move forward. But I've realised my strength lies within me—music has always been my power. I'm collaborating with new artists, programmers and technicians. Even my daughter, Muskaan, has become a guiding force, suggesting collab-



orations and offering fresh perspectives." Reflecting on his creative process, the Surili Akhiyon Wale composer emphasises his commitment to preserving the essence of Indian musical traditions. "Melody is the soul of our music and I am determined not to let it fade," he says. His passion for ghazals, a genre he believes has lost some of its allure in pursuit of profit over artistry, drives his latest project.

Khan's connection to ghazals is deeply personal. "Our first earnings came from performing at ghazal events," he recalls. As children, Wajid played the guitar, meanwhile, Sajid accompanied him on the tabla. "Our father would give us twenty rupees

as pocket money. Later, we began earning more by playing at qawwali and ghazal sessions." Now, collaborating with the very maestros he once admired feels, as he puts it, "like life has come full circle."

With Jashn-E-Ghazal, Sajid seeks to honour both his brother's memory and the music they loved. The album's first ghazal, Jab Bhi Kisi Nigah Se, performed by Padma Shri Ustad Ahmed Hussain and Padma Shri Ustad Mohammed Hussain, is a soulful reminder of the genre's enduring beauty. Featuring ten ghazals sung by a stellar lineup, including Padma Shri Kavita Krishnamurthy, Hariharan, Anup Jalota and younger voices like Sayli Kamble and Muskan, the album bridges generations with its blend of classical richness and

contemporary appeal.

The *Tenu Leke* composer also reflects on the importance of appreciating legends during their lifetimes. "It's heartbreaking how we remember icons like R.D. Burman only after they're gone. I feel blessed to collaborate with maestros like Shivamani, whom I still call my boss. These partnerships remind me of the cyclical nature of life and music."

While Bollywood has defined much of his career, he is now eager to explore global music markets. "Wajid and I always believed we could make an impact internationally. We even worked on projects with global artists, though they remain unreleased. For now, my focus is on creating a catalog rooted in Sufism and collaborating with incredible voices."

Known for always staying ahead of his time, he attributes this instinct to his father's teachings. "The songs we recorded often released two years later, so planning ahead became second nature. As a solo artist, I'm embracing the freedom to multitask and experiment with genres. Bollywood has taken a backseat for now, but I'm excited to explore Chinese or Arabic music and surprise my fans."

The Jalwa composer also hints at a wealth of unreleased work. "I've composed songs for major films, but if they don't make it to the screen, I'll release them on my channel. For me, it's about reaching a genuine audience, not chasing numbers."

The transition to a solo career has allowed Sajid to reconnect with his family in meaningful ways. "Our careers often take precedence and before you know it, your kids are grown and your parents are aging. Spending quality time with my wife has been especially fulfilling—I'm falling in love with her all over again."

Despite his decades-long career, he approaches his solo journey with the enthusiasm of a newcomer. "I feel like a fresh struggler, discovering new paths and possibilities. Music has always been my sanctuary and I'm excited to see where this journev takes me."

shitij Patwardhan, a multifaceted writer and screenwriter, has made a significant impact in the Marathi film industry. His diverse background in computer science, journalism and advertising has shaped his unique writing style. His writing journey commenced around 2010, following stints as an advertising copywriter and reporter. His educational foundation in computer science and a master's degree in communication and journal ism laid the groundwork.

"I have been fascinated by writing since my teenage years. I explored various formsadvertising, political communication, journalism, radio writing and jingle writing. This exposure helped me grasp different facets of writing."

Patwardhan's first commercial full-length play marked his entrance into the Marathi entertainment arena, leading to his debut film. "Starting as a reporter, then copywriter, playwright and screenwriter was quite a journey," he reflected.

His maiden success came with the 2010 Marathi play, directed by Sameer, now a renowned director. "The play was a sensation in Maharashtra, drawing young audiences back to theaters," Kshitij proudly shared, adding how the film was translated into 5 languages, adapted into a motion picture, how he completed 480 Marathi shows and over 300 Gujarati shows, oh and also received major Maharashtra awards.

"This success validated our writing's relevance to youngsters and today's audience," the Taali screenwriter emphasised adding, "Understanding the audience, staying updated with trends and experimenting with genres keeps my writing fresh." His inspiration stems from real-life experiences, literature and cinema.

Following his success in Marathi cinema, he ventured into Hindi cinema, driven by curiosity. "The transition stemmed from curiosity. Regional industries often harbour biases about Hindi cinema being inaccessible, money-centric and style-driven, relegating creativity." Determined to form his own opinions, Kshitij explored Hindi cinema.

Maddock Films offered Kshitij his first break! Director Michel Musale approached him as a consultant for Sajini Shinde Ka Viral Video (Netflix). Impressed by his work, they collaborated, making Kshitij the dialogue writer and additional screenwriter.

This partnership led to two more projects: a recently filmed project slated for release next year and another written specifically for Maddock Films. Mikhil Musale introduced Kshitij to Ajay Devgn's assistant, securing him a spot on the writing team for Singham

'Previously, I collaborated solely with Sameer. This time, I worked with two female writers, Anushin Chaudhary (Aria, Grahan) and Parinda Joshi (acclaimed book writer and film writer). They taught him invaluable lessons: inclusivity, female perspectives and challenging biases. These writers enriched my writing, making it more inclusive and fresh. 


edged, "Audience love has been pouring in since 2010, growing daily." His focus remains on crafting relatable, relevant and responsive

## Preventing and treating pediatric obesity

besity in children is one of the fastest-growing challenges that parents and pediatricians are facing alike. A staggering 390 million children and when a child consumes food in adolescents aged 5–19 years were overweight in 2022, including 160 million who were living with obesity. It is not just limited to children over the age of 5; 37 million children under the age of 5 were overweight. Overweight and obesity in childhood increase the risk of many lifestyle diseases like Type 2 diabetes and cardiovascular diseases in adulthood.

Obesity and overweight are estimated on the basis of Body Mass Index (BMI). A BMI of more than 23 kg/m<sup>2</sup> is said to be overweight and more than 27 kg/m<sup>2</sup> is said to be obese. Almost 98% of children with obesity do not have any underlying illness. It arises from a sedentary lifestyle and poor dietary

Managing and treating obesity is a challenging task for both parents and children. As the old adage says, 'prevention is better than cure'; there are small modifications that can be done in our lifestyle that can prevent this chronic condition from hampering a child's happi-

months of age has been seen to reduce the chances of obesity. Children should have regular meal timings, including breakfast. They should have at least 8 hours of sleep daily at night. The American Academy of Pediatrics recommends fighting childhood obesity with the '5-2-1-0' rule. It implies children can consume above 5 servings of fruits and vegetables, screen time below 2 hours, participate in one hour of physical activity, and consume 0 sugar-

front of the TV or mobile. Hence, eating meals with a screen on should be stopped. Junk food in the home should be replaced with fruits, and sugary drinks should be replaced with drinking water. Children copy parents in every act, including this one. So parents should start with these habits themselves, which will leave a

long-lasting impact on children.
Once diagnosed with obesity, management should start with lifestyle and dietary modifications. Children should consume regular meals. Breakfast should not be skipped. He/she should have 45 minutes of regular moderate to vigorous physical activity and screen time should be below 1 hour daily. Teenagers are more prone to being body conscious and might face body shaming in the current online world. They should never go for crash dieting or starvation. It could do a lot more harm than being beneficial. Parents should be on the lookout for red flag signs like sudden weight gain, delayed growth and puberty, school absenteeism or teasing by peers regarding weight/appearance, persistent anxiety, depression, or self-harm, anger outbursts, substance abuse and eating disorders. Specialist referral must be sought after in the pres-

ence of these signs.

Remember, obesity runs in families who do not run. Getting obesity under control not only improves health; it also gives a feeling of achievement and happiness.

## Don't waste time in hotel, no room for optional practice sessions, says Gavaskar

Batting legend Sunil Gavaskar has urged India not to "waste" time in their hotel rooms after the early finish of the pink ball Test, but utilise the two extra days by sweating it out in training so they can bounce back in the third game.

India were thoroughly exposed in their 10-wicket loss in the second Test of the Border Gavaskar Trophy with the match ending in less than two-and-a-half dave as Australia bounced back to level the five-game series 1-1. "Look at the remainder of the series as a three-match series. Forget it was a five-Test series. What I would like this Indian team to do is use the next couple of days for practice," Gavaskar told the official broadcaster.

"It's very important. You can't be sitting in your hotel room or wherever you're going because you have come here to play cricket. "You don't have to practice the

whole day. You can practice a session in the morning or afternoon, whichever time you choose, but do not waste these days. You would have been here playing a Test match if the Test match were to go on for five days," he added.
The third Test begins on

the intervening time to get

their rhythm back.

"You have to get yourself that much more time to get into the rhythm because you have not got the runs. Your bowlers haven't got the rhythm. There are others too who need time in the middle," he added.

Indian pacers were found wanting on a fast wicket that offered lateral movement, giving away plenty of runs in the first innings and allowing Australia, especially centurion Travis Head, to take a huge 157-run lead.

Gavaskar added that he did not believe in the concept of optional practice sessions, stating that the decision should solely rest with the captain and coach, not the players.

"This optional practice session is something that I don't believe. The decision for optional training should rest with the captain and the coach. The coach should say, 'Hey, you hit 150, you don't need to come to practice. Hey, you bowled 40 overs in the match, you don't need to come to practice?

"They should not be given the option. If you give the players that option, a lot of them, especially the certainties, will say, 'No, I am going to stay in my room.' And that's not what Indian cricket needs."

He reminded the players that it was a privilege to play for India and they should do it wholeheartedly.
