Centre tables ONOE Bill amid fiery debate

Says it won't tamper with states' powers

#### Oppn terms it dictatorial PNS NEW DELHI

Two bills that lay down the mechanism to hold simultaneous elections were introduced in the Lok Sabha after a fiery debate on Tuesday, with the opposition terming the move "dictatorial" and Law Minister Arjun Ram Meghwal asserting that the legislation would not tamper with the powers enjoyed by states.

The Constitution (129th Amendment) Bill was introduced in the Lok Sabha by Meghwal after a nearly 90-minute debate, followed by a division of votes. As many as 269 members voted in favour of the Bill and 198 against it.

Meghwal also introduced The Union Territories Amendment Bill, which seeks to align elections in the Union territories of Puducherry, Delhi, and Jammu and Kashmir with the Lok Sabha polls.

He said the proposed bills did not attack the "basic structure doctrine, as claimed by the opposition".

Principles such as judicial review, federal character of the Constitution, separation of powers, secular character, supremacy of the Constitution had not changed, Meghwal said, adding that the objections to the Bill were political in

## panchayats in AP by March 2025

Works being carried out under BharatNet-2 Project: AP FiberNet MD

Managing Director of Andhra Pradesh FiberNet, K Dinesh Kumar, announced that broadband services will be extended to all Gram Panchayats (GPs) in the state by March 2025. A review meeting on the progress of the BharatNet-2 project, funded by Digital Bharat Nidhi, was held on Tuesday at the BSNL main office in Vijayawada.

During the meeting, Dinesh Kumar highlighted the progress of the BharatNet project in the state. He stated that the government aims to provide broadband services to all GPs in Andhra Pradesh by March 2025, with the work being carried out at an accelerated pace. He noted that over 15,000 subscribers have already been connected under the BharatNet scheme through FiberNet. By March next year, broadband connectivity will be extended to an additional 11,254 panchayats. Dinesh Kumar also pointed out



that Andhra Pradesh is the only state in the country providing broadband services to all panchayats under the BharatNet-2 project. He emphasised that the state government is taking swift steps to create digital panchayats.

The Central Bureau of Investigation (CBI) on Tuesday arrested a CGST Inspector from the Tirupati GST Commissionerate along with a representative of a Chittoor-based private firm for allegedly demanding and accepting a bribe of Rs 3.2 lakh.

The CBI registered a case on Tuesday, against four persons, including an Assistant Commissioner, a Superintendent, and the Inspector from the Tirupati GST office, along with a private firm representative. The case pertains to demand for bribes by public servants in exchange for providing undue favours to companies. The accused officials had allegedly conducted inspections of various establishments under the guise of official inquiries and later summoned business owners to the CGST office, demanding bribes to settle purported irregularities. On November 5, 2024, they demanded Rs 10 lakh from the firm's representative. Acting on this, the CBI set a trap and intercepted the accused during the bribe transaction. Both the Inspector and the firm representative have been arrested and will be presented in Kurnool court on December 18.

Kakinada District Collector Shan Mohan has revealed alarming details regarding the discovery of 1,320 tons of PDS rice on the Stella L Panama vessel at Kakinada Port. Addressing a press conference on Tuesday, the Collector explained that a team of officials from five departments conducted a thorough 12-hour inspection of the ship's five compartments, collecting 12 samples. The vessel, which was carrying nearly 4,000 tons of rice, was found to have 1,320 tons of PDS rice. The investigation indicated that Satyam Balaji Řice Industries was involved in the export of the rice. Authorities are currently investigating the source and storage locations of the rice.

The Collector assured that the 1.320 tons of PDS rice would be immediately offloaded and seized. Additionally, there are still 12,000 tons of rice to be loaded at Kakinada Port, but loading will only proceed once it is confirmed that none of it is PDS rice. ## Amaravati to be first capital city with piped gas supply

Officials of Indian Oil Corporation (IOC) have proposed making Amaravati the first capital city in the country to be supplied with piped gas. A team led by A Raman Kumar, a member of the Petroleum and Natural Gas Regulatory Board (PNGRB), met with the State government's Chief Secretary Neerabh Kumar Prasad on Tuesday to discuss gas pipeline projects and related developments.

The IOC officials presented the idea of transforming Amaravati into India's first fully piped gas capital city. Drawing a comparison with the Gujarat International Finance for the proposal and assured that the Tec-City (GIFT) in Gandhinagar, where utilities such as gas, electricity, and telecom cables are all under-



ground, they proposed to supply piped gas to residences, business complexes, and institutions in Amaravati, mirroring the setup in GIFT City. Chief Secretary Neerabh Kumar Prasad expressed his support state government would offer full cooperation.

Local fishermen, environmental activists, and experts call for urgent action to protect marine life and livelihoods

The discovery of two dead turtles on the Ratnayyammapeta seashore on Monday, following a similar incident at Pudimadaka on Sunday, has raised serious environmental concerns among local fisher.



Ravi Kumar, a marine biologist. "Their deaths could disrupt these ecosystems, leading to cascading effects that will eventually impact fisheries and coastal communities."

Local fishermen are urging authorities to take immediate nst polluting indus tries and implement stricter measures to prevent untreated waste from entering coastal waters. "If no action is taken, both the environment and our livelihoods will suffer irreparable damage," they warned. Activists are advocating for sustainable practices in industrial operations and shrimp farming, and are also pushing for greater community participation in environmental conservation efforts. The recent discoveries of the turtle carcasses have sparked urgent calls for intervention to prevent further degradation of the coastal environment. Both local communities and experts agree that decisive action is now essential to protect marine life and the livelihoods of those who depend on it.

## Govt trying to weaken cases against Naidu: YSRCP

Accusing the coalition govern-ment of attempting to dilute the cases against Chief Minister N Chandrababu Naidu, the YSR Congress Party (YSRCP) has demanded that the trials be conducted outside Andhra Pradesh, citing largescale scams involving public

money. Addressing the media on Tuesday, former minister Kakani Govardhan Reddy alleged that the government is using its influence to tamper with evidence in multi-crore scams, including the Skill Development project, FiberNet, inner ring road alignment, assigned lands in the capital region, and the Margadarsi issue.

claimed that Chandrababu Naidu was violating his bail conditions by influencing witnesses and manipulating records. "By placing his loyalists in key positions, he is systematically weakening and watering down

Investigations are ongoing, and inspections have been conducted at rice mills in East and West Godavari districts, where 89 mills were found to be supplying rice to the Public Distribution System.

Further inspections are underway at various locations to prevent PDS rice from reaching Kakinada Port.

This follows a visit by Deputy Chief Minister Pawan Kalyan to Kakinada Port, after which district authorities began an investigation into the suspected illegal transportation of PDS rice.

On November 29, Pawan Kalyan, along with Minister for Civil Supplies N. Manohar and district officials, inspected the Stella L Panama vessel, which was believed to be involved in the smuggling of PDS rice abroad.

#### **AP HC EXAMINES RICE SHIPMENT PERMITS AT KAKINADA PORT** PNS VIJAYAWADA

The matter concerning the Port has been brought before the Andhra Pradesh High Court. This is the first successful birth of a female calf in the district using this advanced reproductive method, which is set to revolutionise livestock farming in the region. "This is a major milestone for our district," said Dr YV Ramana, District Joint Director of the Animal Husbandry Department. "The birth of this calf signifies the first successful use of embryo insemination in livestock and opens up new possibilities for enhancing livestock breeding in Vizianagaram and the



broader North Andhra region. We are extremely proud of this achievement The birth is part of the National

Corporation. The project utilises in Kamdhenu Project, an initiative spearheaded by the Animal vitro fertilisation (IVF) and other Husbandry Department and the scientific methods to develop and State Livestock Development preserve embryos in liquid nitrogen,

which are then implanted in cows for breeding.

This technique has tremendous potential," Dr Ramana explained.

Typically, a cow produces only eight to 10 calves in its lifetime. Through embryo transfer and IVF, we can collect up to 150 embryos from a single cow, leading to the birth of 50 to 60 calves. This breakthrough will have a profound impact on livestock farming in the region." The initiative aims to improve the quality and productivity of local cattle, enhancing the genetics of the region's livestock. As part of this programme, two veterinarians in the district have received specialised training to further advance the project's reach and effectiveness.

"As we continue with this initiative, we are dedicated to breeding superior cattle, which will bolster the dairy industry and support farmers in our region," Dr. Ramana emphasised.







# **Power subsidy for aqua** farmers on the anvil

Agriculture Minister Atchannaidu asks officials to prepare plans

approximately Rs 10 per litre. To boost fisheries production, the Minister highlighted the government's initiative to develop 54 state-owned fish seed ponds. He also noted that Andhra Pradesh is collaborating with the Kerala government to set up artificial reefs along the coast, aimed at enhancing marine resources and improving the livelihoods of coastal fishermen.

## Engineers directed to speed up Polavaram project: Nimmala

#### PNS BHIMAVARAM

Minister for Water Resources Management Nimmala Ramanaidu has directed engineers and officials to expedite the works of the Polavaram project and ensure its completion by October 2026.

The Minister laid the foundation stone, performed 'bhoomipooja', and unveiled plaques for various development works at Neredumilli, Penumuru, Kadupalem, Gumparru, and Shiragarapalli vil-lages in Yelamanchili mandal of West Godavari district on Tuesday. Speaking on the occasion, Ramanaidu reiterated that the

Polavaram project is the lifeline of

Andhra Pradesh, crucial for mak-ing the State drought-free and

boosting financial resources. He stated that the civil works of the project must be completed by June 2026, and water impoundment should begin in the same season.

"The works to construct a new diaphragm wall, replacing the damaged one, will commence on January 2, 2025. The engineering officials have assured completion by March 2026, but the Government has set a stricter deadline of December 2025," the Minister said.

He further revealed that while engineers proposed completing the ECRF Gap-1 work by February 2026 and Gap-2 by December 2027, the Government has instruct-ed officials to fast-track these works for completion by July 2026. Highlighting the delays under the previous regime, Ramanaidu claimed that 72 per cent of the Polavaram works had been completed by 2019. However, during the five-year YSRCP tenure, only 3.84 per cent progress was made. He alleged that Rs 2,400 crore was wasted due to the negligence of the previous government, which also burdened the State with debts amounting to Rs 14 lakh crore.

Promising to put the State back on the path of development, the Minister underlined key achievements of the current government, such as enhancing social security pensions to Rs 4,000, announcing the mega DSC, reopening of 'Anna canteens', and implementing the free gas cylinder scheme. Several officials and local leaders were present at the event.

The renovation of the Ratna Bhandar will not be carried out on Saturdays and Sundays, and other holidays, keeping in view the crowd of devotees, the ASI official said.

## 'Synopsis can't run into 128 pages'

## SC tells registry to take note

PNS NEW DELHI

A synopsis cannot run into 128 pages, the Supr eme Court on Tuesday said and asked its registrar (judicial) to take note, particularly in cases where litigants were allowed to appear in person. While hearing a plea

challenging an order of the Allahabad High Court, a bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah said the appellant, who was appearing in person, had filed a synopsis running into 128 pages, loaded with details, most of which were not relevant.

"We understand that the appellant is not a trained lawyer, but it is for the reg-istry to have asked the appellant to trim down the synopsis. A synopsis cannot run into 128 pages," said the bench. The top court went on to add, "Let the registrar (judicial) take note of this, particularly

the cases where litigants are allowed to appear in person." The bench was hearing an issue pertaining to a matrimonial case when it noted the appellant woman was married to the respondent in 2006 and she got a decree of divorce on the ground of cruelty in 2016.

The bench noted that the high court, in its order passed in December, 2019, restored the Section 125 CrPC petition of the appellant and directed the family court to decide the case in accordance with law. Section 125 of CrPC deals with order for maintenance of wives, children and parents. The bench said the high court had directed the said petition was required to be decided on merits by the additional principal judge, Family Court, Agra. "We see absolutely no reason as to why we should interfere with the aforesaid

impugned order.

## 'Too early to make Aadhaar based system mandatory for MGNREGS payments'

A Parliamentary Panel has recommended that the Rural Development Ministry's Aadhaar Based Payment Bridge System (ABPS) for making payments under MGNREGS should not be

made compulsory. In a report tabled in Lok Sabha on Tuesday, the Standing Committee on Rural Development and Panchayati Raj also said alternative mechanism should always operate to ensure that the primary goal of the scheme to provide wages does not get defeated due to

lack of proper implementation of technology.

The Committee pulled up the government on low wages under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGN-REGS) and recommended a better inflation linked index for



payment of wages to the workers. The Committee noted that the APBS has been made mandatory since January 1, 2024. "While accepting the gains of APBS, the Committee is of the view that it is too early to make it mandatory as the problems relating to Aadhar

seeding still have not been resolved leading to exclusion of lakhs of workers," the panel said. "The Committee, therefore, reiterates their earlier recommendation that APBS should not be made mandatory and alternative mechanisms should always



This assurance comes at a time when China is aggressively pursuing 'Mission Indian Ocean' - which targets India. In a joint statement issued Sri Lankan President Anura Kumara Dissanayake made Colombo's position clear during his dialogue with Indian Prime Minister Narendra Modi in New Delhi. This assurance is seen as a critical development in India-Sri Lanka relations, especially given China's use of Sri Lanka's Hambantota Port for docking its naval surveillance and spy ships, including the ballistic missile tracking ship Yuan Wang 5. China's growing footprint in the Indian Ocean has raised red flags for New Delhi. The Hambantota Port, now under a 99-year lease to China following Sri Lanka's inability to service its debt, has become a hub for Chinese naval operations. Over the past two years, Beijing has stationed the Yuan Wang



5, a 25,000-tonne satellite and missile tracking ship, at Hambantota multiple times. This vessel, equipped with advanced tracking and communication systems, has been closely monitoring satellite and missile activities in the region, creating strategic challenges for India. In 2022, Sri Lanka briefly delayed the docking of Yuan Wang 5 following Indian concerns but eventually allowed the vessel to dock under the guise of 'replenishment.' Since then, Chinese surveillance ships have regularly patrolled the Indian Ocean, adding to India's apprehensions about Beijing's strategic intentions in the region. The agreement between India and Sri Lanka ensures that Sri Lankan territory, including its waters,

will not be used in any manner that could harm India's security or regional peace. This is a welcome relief for New Delhi, which views such commitments as crucial for maintaining stability in the Indian Ocean Region. This of course hasn't happened overnight. India's steadfast support for Sri Lanka during its economic crisis in 2022 has further solidified the bond between the two nations. President Dissanayake expressed gratitude for India's timely assistance, which was instrumental in stabilising Sri Lanka's economy during one of its most challenging periods. As far as China is concerned it has been courting Sri Lanka for the sole purpose of encircling India and getting a foothold in Indian Ocean. China's influence in Sri Lanka has grown significantly, particularly after Colombo defaulted on its \$1.7 billion loan for the Hambantota Port project. India has consistently raised concerns about the strategic implications of Chinese investments and activities in Sri Lanka. In this background the assurance of Sri Lankan president signals Sri Lanka's intent to balance its ties with both regional powers while safeguarding regional stability. The agreement also underscores Colombo's recognition of the importance of India's security and regional stability and paves the way for a stronger, more strategic India-Sri Lanka alliance in the years to come.



# Nepal embraces China's BRI

Nepal's deepening ties with China through the Belt and Road Initiative (BRI) have set alarm bells ringing in New Delhi

ndia has cause for extreme worry. In yet another indicator of China's growing sway over Nepal, the two are moving forward to implement Beijing's ambitious Belt and Road Initiative (BRI) in the Himalayan nation. India is not only opposed to this in principle on grounds of sovereignty but also fears it will enable China to increase its already considerable inroads into

Nepal. If 2017 marked Nepal's initial step to coming on board the BRI with an MoU, the year 2024 marks a giant leap for the Himalayan nation in that direction. A framework agreement for cooperation on the BRI was signed during Nepalese PM K P Sharma Oli's visit to China in early December, apart from nine other pacts. With the strategically located Himalayan nation having become a hub for Great Powers contestation, the US too would be uneasy with the latest Beijing-Kathmandu tango. While the US had managed to get Nepal on board its own Millennium Challenge Corporation (MCC) Compact to fund Kathmandu's power and transport infrastructure, the BRI seems far broader. Kathmandu is trying to play down the framework as just a continuation of the 2017 MoU. The framework, however, underlines Kathmandu and Beijing's renewed push for the BRI, an initiative on which New Delhi harbours deep suspicions for what it perceives as China's hegemonic ambitions through debt-trap diplomacy. Sovereignty is another major concern, with the China-Pakistan Economic Corridor (CPEC), another project under BRI, passing through Pakistan-

occupied Kashmir. India is certainly worried about PM Oli-led Nepal once again moving into China's sphere of influence. The CPN-UML would also whittle down leader is widely seen as being India's influence over Nepal. pro-China, and bilateral ties with India were prickly during his previous stints as the PM. India has yet to host Oli since branches of Chinese banks he took charge as PM in July and financial institutions in

this year for the fourth time, with him first heading for Beijing, in a break from the tradition of visiting New Delhi.Also, showing scant regard for New Delhi's sen-sitivities, the Oli government recently allowed 220 Buddhist monks from China to travel to Lumbini, the birthplace of Gautam Buddha even as the Nanhai Buddhism Shenzhen roundtable was being held in Kathmandu.

Oli delivered the inaugural address at this roundtable. There were also reports the China-appointed Panchen Lama would travel to Lumbini, though it did not eventually happen. The Oli government's

encouragement of Beijing's concerted moves to claim Buddhism as a shared heritage will not go down well with New Delhi, which has been making its efforts to build on its shared Buddhist heritage with Nepal.

# Pesticides are poisoning the Punjab soil

Punjab's agriculture is facing a harrowing reality-its lifeblood, the soil, is being contaminated by toxic pesticide residues at alarmingly high levels



t's time to face the disturbing truth about Punjab's agriculture-and it's a nightmare. In districts like Bathinda, Mansa, and Ludhiana, up to 60 per cent of farm soil samples are infested with toxic pesticide residuesincluding the deadly chemicals endosulfan and carbofuran—at levels far beyond what's even remotely safe. This isn't just a warning; it's a full-blown crisis, a ticking time bomb, the result of irresponsi-ble, reckless pesticide and fertiliser abuse running rampant in our fields.

On World Soil Day-December 5thwe're forced to confront the cold reality of a rapidly disintegrating agriculture sys-tem, while the world's been talking about "Caring for Soils: Measure, Monitor, and Manage"! The consequences of this mad-ness are devastating. Our once fertile land is transforming into a barren wasteland, and that's only the beginning. These toxic chemicals aren't just staying in the soil. They're seeping into our food chaincontaminating every bite we take and slowly poisoning us all. But it doesn't stop there. These toxic residues are embedding themselves into our very DNA, passing down a legacy of genetic mutations to our children and grandchildren.

We are breeding a future full of

Management Bill (PMB) 2020 was introduced to replace outdated legislation, but critical concerns must be addressed. While the bill outlines pesticide registration and licensing procedures, it must pro-tect farmers more adequately from hazardous exposure. Statistics from Pesticide Action Network (PAN) International paint a grim picture: approximately 11,000 deaths globally are attributed to accidental pesticide poisoning annually, with India accounting for a staggering 6,600 fatalities. These numbers highlight critical deficiencies in pesticide usage protocols and safety measures.

Farmers and rural communities often bear the brunt of chemical exposures, especially in agriculturally intensive regions. For instance, FRAMEWORK FOR Punjab, which heavily depends on rice and wheat cultivation, reports alarming pesticide consumption rates. With an average usage of 77 kg/hectare, significantly above the national average of 62 kg/hectare, ESTABLISHED IN 1968, IS Punjab ranks third in India after UP and Maharashtra for pesticide con-

Training and Awareness: A Forgotten NecessityThe Pesticide Neglected Imperative Over the past three decades, the indiscriminate use of pesticides has surged, often driven by aggressive market-ing strategies that portray chemi-cal inputs as indispensable for high crop yields.

The limited scale of training initiatives highlights the need for more current efforts. Between 1994-95 and 2021-22, the Plant Protection Department of Agriculture and Farming Welfare Ministry trained only 585,000 farmers in Integrated Pest Management (IPM), a dismal figure in a nation with over 150 million farmers. According to the International Code of Conduct on Pesticide Management, govern-ments and industry stakeholders must provide comprehensive training and information to farmers and retailers. Yet, the implementation of these guidelines still needs to be more robust. Retailers often serve as farmers' sole point of contact, and in many cases, they disseminate misleading or incomplete informa-

Management Bill 2020 neglects the safety of small-scale farmers, who often lack access to affordable, climate-appropriate personal pro-tective equipment (PPE). Farm workers face heightened health risks without mandatory provisions requiring them to supply adequate protective gear, especially in hot and humid agricultural regions. Labelling and Consumer ProtectionIndia's pesticide labelling standards fall short of both domestic and international norms. Safety information is frequently crammed into illegible leaflets, leaving farmers ill-informed about risks and proper usage.

Although the Consumer Protection Act theoretically covers farmers, legal recourse against manufacturers for misleading labels or substandard products is rarely pursued. The Way ForwardIndia can no longer afford to ignore the human and environmental toll of unsafe pesticide practices.

Establishing a robust, farmer-centric legal framework aligned with tional standards is the only way forward to ensure safe and sustainable agriculture. A gradual shift towards agro-ecological farming methods that emphasise nonchemical pest management is imperative. The government must phase out hazardous pesticides and promote environmentally friendly alternatives to safeguard farmers' health and ensure consumer food safety. Addressing the gaps in the Pesticide Management Bill 2020 and adopting proactive measures, such as mandatory training and the provision of accurate information on pesticide usage and risks, are critical steps towards securing safe and healthier future generations. last year. In response, the Reserve Bank of India (RBI) reduced the cash reserve ratio (CRR) by 50 basis points to 4 per cent in December to improve liquidity and stimulate credit growth.

Qualitative indicators present a mixed picture. India climbed 14 ranks on the UNDP

Gender Inequality Index, high-lighting significant strides in countries. Challenges such as lighting significant strides in bridging the gender gap. It also improved its position on the Global Innovation Index, rising from 40th to 39th among 133 global economies, driven by entrepreneurial activity, vibrant startups, and successful public-private partnerships. The Human Development Report 2023-24 placed India at 134th among 193 countries, reflecting gains in life expectancy, education, and Gross National Income. However, no progress was seen in the Happiness Index, where India remains at 126th, largely due to dissatisfaction among older citizens, perceived discrimination, and poor health metrics. Moreover,

India continues to struggle in

environmental performance,

air quality, biodiversity loss, and greenhouse gas emissions demand urgent attention. As India navigates these complexities, it is also undergoing key transitions. The US economy has entered a new phase, and India sees a shift in RBI leadership, with Sanjay Malhotra taking over as the 26th Governor after Shaktikanta Das's tenure.

This will create a new whollyowned subsidiary, ITC Hotels Ltd, to handle its hotels and hospitality business.



## Surging gold imports threaten India's trade balance: GTRI

The country's gold imports in November reached a record high of USD 14.86 billion, registering a four-fold increase, mainly on account of festival and wedding demands, according to commerce ministry data.

Gold imports stood at USD 3.44 billion in November 2023. The GTRI said that the

imports are driven by multiple factors, including growing investment demand, tariff reductions, and loopholes in trade agreements.

This surge has raised significant economic concerns, distorting the trade balance, weakening the rupee, and widening the current account deficit, the Global Trade Research Initiative (GTRI) added.

## Women, equality & conversations in Indian cinema

n an industry where narratives are often stitched claiming 'we can't have a girl on sets because it together from tradition, power dynamics and an unconscious tilt toward gendered hierarchies, it takes courage to push back. The fourth edition of O Womaniya! 2024 brought together voices-actors, directors producers and writers-who not only questioned these norms but provided an evocative roadmap for change. From Ananya Panday and Parvathy Thiruvothu to Ishita Moitra, Richa Chadha, Nikkhil Advani and Shakun Batra, the conversations revealed a shared resolve: to create not just stories of women, but spaces that truly belong to them.

Ananya Panday recalls an extraordinary moment while filming Gehraiyaan, a story that hinged on intimacy, relationships and vulnerability. "At the get-go, Shakun (Batra) said, 'I am willing to sit here with you and Deepika to understand what does a girl need on set and I will make sure it is the most comfortable environment for you." It was a rare and refreshing stance—one that dismantled the entrenched resistance to accommodating women on sets. "We can't start replacing people on jobs but it's about just having a conversation. To ask a woman what it is that she wants, instead of

will be too much work," Panday explains. Parvathy Thiruvothu further speaks to the arduous path women must tread for accountability. Reflecting on the Hema Committee Report, which investigated workplace abuse within the Malavalam film industry, she asserts, "We need a team now to find the solutions to all the problems that have been highlighted.'

Parvathy's frustration is palpable when she notes the film industry's transactional mindset, where employment is often viewed as a chance, not a right. "There is no dignity of work or humanising of genders. That education needs to happen through constant conversation." For years, Parvathy and her peers-through collectives like the Women in Cinema Collective-have been labelled "troublemakers" and "drama queens," battling patriarchal gatekeeping in an industry slow to evolve. Yet she remains optimistic: "The media is now recognising that what we are saying is actually right and accountability is slowly creeping in." As a writer. Ishita Moitra plays with nuance. Her lens doesn't just scrutinise the protagonist; it envelops the entire frame. "What I want to do is



relook at not just the roles of the protagonists but also all other characters. How meaty are the roles for women, especially those over the age of 40?" But Moitra also disrupts a narrow definition of gender equality. "For me, it isn't just about having a women's writer-room. The gaze is more important. Eventually, we are people and it has to be an equal world." Her vision? An action film, a war drama-genres synonymous with masculine bravado-created with a different gaze. "I don't just want to work on womencentric films. I want to create films that might be completely male-oriented but approach them differently. That's the dream.' For Richa Chadha, inclusion is hands-on. In her debut production Girls Will Be Girls, teenage themes and female vulnerability demanded sensitivity-something an all-male crew couldn't guarantee. "We were trying to get a majority female crew, which was very difficult. There was only one woman gaffer, whose father was also a gaffer." The realisation sparked action. "We decided to train women. We applied for a grant and trained ten girls to be gaffers and light

supported by Light N Light." Chadha's initiative challenges systemic barriers—roles that have always been occupied by men are now open to women, not out of tokenism but competence. Richa's initiative resonated deeply with producerdirector Nikkhil Advani, who called for a systemic overhaul. "Why is it that there are not enough light women, carpenters, or spot didi's? Women are called to clean and cook, but not assigned the work of a spot person." His solution? Mandatory vocational training for women across production crews. "This is something we as producers can enforce immediately."

Director Shakun Batra's anecdote exposes a quieter but equally pervasive bias-one where stories are weighed down by fragile masculinity. "I was told recently that the title of my script leaned more towards the woman. I believe a film should be read for its story, not the title. But there are actors who see this as a disadvantage.'

It's an indictment of the system, where scripts must constantly "pacify the men" as the center of the narrative. Batra's experience shines a light on an unspoken rule: a woman's voice, even in fiction must not threaten the male ego





# Modern custodian of Kuchipudi keeping up the eternal rhythms & grace

n a world increasingly captivated by fleeting digital moments, Yamini Reddy is quietly—and resolutely—keeping the timeless tradition of Kuchipudi alive. As a distinguished Kuchipudi dancer, teacher, choreographer and director of Natya Tarangini, her artistry and vision are reshaping how this classical Indian dance form is taught, performed and preserved.

When Yamini Reddy moved to Hyderabad in 2007 after her marriage, her dreams for the city and the art form she devoted her life to were modest. She envisioned merely a small branch of her parents' established institute in Delhi, where she had honed her craft. "I started with just three to four students. I didn't advertise; it was just a passion project. I was performing a lot at the time, and I thought, why not teach?" she recounts. The result was an organic growth that exceeded all expectations. Today, Natya Tarangini's Hyderabad branch trains over a hundred students, a testament to Yamini's deep commitment to nurturing the next generation of Kuchipudi dancers

to Yamini's deep commitment to nurturing the next generation of Kuchipudi dancers. Her teaching method, Yamini explains, is rooted in the personal and the profound. "We believe in personal training. From the youngest to the senior-most students, we take great care in their growth," she says. Her father, legendary Kuchipudi exponent Raja Reddy, developed a style of choreography and instruction that Yamini and her sister Bhavana have carried forward. "It's a little different from other Kuchipudi styles—people find it refreshing, from the creativity to the teaching techniques. That's why I think word-of-mouth worked so well for us." But beyond technique and

But beyond technique and rigor lies something even more fundamental: her emotional connection to the dance form and its birthplace. "Kuchipudi is native to us Telugu people. When I came back from Delhi, I was so happy to return to the roots—to set up an institute in the birthplace of the dance form itself." Yet, even as she celebrates this cultural legacy, Yamini is candid about the challenges of performing in a world enamored with cinema and digital entertainment.

## Cultural landscape in flux

In Hyderabad, where the glamour of Tollywood often eclipses traditional arts, cultivating an audience for Kuchipudi has become an uphill battle "T e culture here rich and many parents are eager to teach their children classical dance for the discipline and balance it brings to the mind and body. But as audiences, people are not as engaged as they used to be. They'll flock to anything cinema-related, but standalone classical arts? Not so much," she laments. Yamini believes that consistent performances are crucial for nurturing a cultural ecosystem. "It's not about doing one or two concerts. It has to be a continuous effort. In places like Delhi or New York, you know there's always something happen-ing. There's a monthly calendar for theater, dance, or music performances. In Hyderabad, we don't have that. We need two or three cultural hubs that regularly host programs to grow audiences." This lack of infrastructure, she argues, reflects a

age. "If you invest in something over five years, you'll see a remarkable change. But you need that initial push," she says, adding that such long-term efforts could eventually create a self-sustaining cultural ecosystem in the city. While many art forms are now experimenting

While many art forms are now experimenting with storytelling formats to capture the attention of modern audiences, Kuchipudi has always been rooted in narrative traditions. "It's natural to the art form, which originates from theater and classical arts. We've been storytelling for ages," Yamini explains.

#### **Reclaiming Hyderabad**

Reflecting on her deep connection to Hyderabad, she shared her vision for the future: "I haven't done a full-fledged show in a long time, so of course that is on my agenda for 2025—definitely to bring some new productions to Hyderabad audiences," she states with a determined smile. Beyond performances, her aspirations stretch into community-building. "Maybe, God willing, I'll set up centers where Hyderabadis can

This set up certiers where Hyderabadus can enjoy art in a space dedicated to it. That's a long-term goal," she adds. For her, Hyderabad is not just a performance venue but a fertile ground to nurture her dual passions as an artist and teacher. "Performances are my life," she declares. "I look forward to traveling, performing and taking my work not only in India but abroad as well." At the heart of her choreography is a profound engagement with philosophy. While classical Indian dance is often steeped in religious themes, she emphasises the philosophical undercurrents that unite diverse tradiions.

tions. "For me, more than Indian religion, it is Indian philosophy that has a great impact on my work," she explains. "Religion is intricately involved in the art, but I try to connect it with philosophy. This way, I can weave in influences from biblical or Islamic traditions too. For me, it's the values and the goodness we are trying to impart that are the ultimate takeaway from any presentation." This ethos was most evident in her celebrated

This ethos was most evident in her celebrated piece, 'My Heart is a Temple', choreographed by her father. A blend of biblical verses and classical Indian aesthetics, it stands as a testament to her ability to seamlessly marry diverse cultural narratives while retaining the integrity of the art form.

The journey forward is brimming with possibilities. She is currently working on two to three new choreographies and is eager to present these on stage soon. But her goals extend far beyond personal accomplishments. With a visionary eye, she dreams of creating platforms that bring artists and

#### Evidence-based perspectives matter

Studies have always indicated that the benefits of breastfeeding are enhanced immune development, cognitive growth and overall health in children, which great-ly reduce the likelihood of developing chronic diseases. Additionally, breastfeeding cuts down the risk of SIDS (Sudden Infant Death Syndrome) by up to 64% and reduces the risk of total infant mortality by as much as 40%. For mothers, beneficial effects include postpartum recovery and lower risks for certain cancers and other diseases. These outcomes, however, rely on a strong support network, accurate facts, healthcare guidance and social support. The most effective way to foster informed, supportive environments that allow more families to experience these life-changing health benefits is by building a healthier, more resilient society for future generations.

## Captivating drama of love, control & liberation

et in the 1990s at a strict boarding school in the Himalayan foothills, Girls Will Be Girls delves into the stifling effects of patriarchal norms on women's lives and desires. The story centers on Mira (Preeti Panigrahi), a disciplined and high-achieving student whose orderly world is disrupted by the arrival of Sri (Kesav Binoy Kiron), a charming and mischievous new transfer student. As Mira navigates her growing attraction to Sri, the narrative takes an unexpected turn when her mother, Anila (Kani Kusruti), becomes part of the story. Living nearby to oversee Mira's academic progress, Anila struggles with her own social and romantic frustrations, leading her to compete for Sri's attention. This layered dynamic reveals not only the personal consequences of repressive societal rules but also how these structures influence women's relationships and self-perception across generations.

#### HIGHLIGHTS

Girls Will Be Girls is a poignant psychological drama that delves deep into the layered complexities of a mother-daughter relationship in a patriarchal society. One of

the most striking aspects of the film is its ability to capture the subtleties of repression and rebellion. Mira's internal journey, as she explores her suppressed desires, is intricately juxtaposed with her mother Anila's struggles with her own unresolved frustrations. Kesav Binoy Kiron as Sri, the sly and charisma to his role, becoming the catalyst for both Mira's and Anila's selfdiscovery. The chemistry between the actors is natural and contributes significantly to the emotional resonance of the story.

#### **TECHNICAL ASPECTS**

Shuchi Talati's direction shines in its ability to blend the personal and the political, giving equal weight to the characters' individual struggles and the societal structures that shape their lives. The film bravely tackles the themes of female sexuality and generational trauma, making the audience reflect on how societal expectations influence women's autonomy and relationships. The film's technical brilliance enhances its narrative depth. Cinematographer Jih-E Peng's stunning visuals beautifully capture the contrasting elements of the story. The vast Himalayan landscapes serve as a metaphor for freedom and longing, while the claustrophobic interiors of the boarding school and Anila's home reflect the confinement of the characters' lives.

The production design authentically recreates the 1990s setting, with every detail, from the uniforms to the decor, immersing the audience in the time period. The musical score by Pierre Oberkampf and Sneha Khanwalkar is another standout aspect, subtly underscoring the emotional highs and lows of the characters' journeys without ever overwhelming the narrative.

However, the editing could have been slightly tighter in certain parts of the film, especially in the middle section, where the pacing issues become more evident. Despite this, the technical aspects overall contribute significantly to the film's immersive experience.

#### VERDICT

Girls Will Be Girls is a thought-provoking and emotionally charged exploration of how patriarchal norms stifle women's sexuality and autonomy. With its searing examination of generational trauma and repression, the film offers a unique perspective on themes often overlooked in mainstream cinema. Shuchi Talati's directorial debut is marked by a sharp focus on emotional authenticity, supported by powerful performances from Preeti Panigrahi and Kani Kusruti. to the side for the third Test after missing the Pink Ball Test at Adelaide due to a side strain.

He had replaced fellow pacer Scot Boland, who played in the day-night Adelaide Test, in the Australia eleven for the ongoing Brisbane Test.

"Unfortunately, just the amount of time that's been lost from the game has made it difficult," he added. Akash Deep, making his debut in Australia, walked in to bat at 213 for 9, with India still needing 33 runs to avoid the follow-on that could have cost them the game.

Alongside pace spearhead Bumrah, he guided India to 252 for 9, frustrating the home team.

Australia had ended day three on 405 for 7 but chose to bat, consuming a considerable amount of game time on a rain affected day four rather than declare their innings.

## Can 'Guru' Gambhir and Nayar offer cogent solutions to technical flaws in batters?

Rohit Sharma and Virat Kohli are copping maximum criticism for being walking wickets during the ongoing Test series against Australia but even Shubman Gill, Yashasvi Jaiswal and Rishabh Pant haven't shown the patience needed to survive Down Under, indicating a larger problem.

Patience is a virtue that one develops over time and Kohli had once showed how it's done during his golden phase between 2014 and 2019. KL Rahul, blessed with sound technique, has displayed that during the current series with scores of 77 and 84 in Perth and Brisbane.

In case of Jaiswal, save his second innings knock of 161 at Perth, a shuffle across the crease is making him a candidate for leg-before.

Gill loves to play on the rise outside the off-stump and away from his body and could be impatient when one bowls the stump and even for Pant, a compulsive stroke player, the ball that leaves him from five metre length with adequate bounce, is creating issues.

So, will head coach Gautam Gambhir and his deputy Abhishek Nayar, who is highly regarded in Mumbai cricket circuit for being a "Mind Coach and Life Coach rolled into one", do anything about it? A former India great, who didn't wish to be named, offered his perspective. "Not all great players or players of

repute happen to be great coaches. They might have done some incredible things as players and knew what to do and how to react during a particular situation," the veteran of 100-plus Tests said.

"But coaching is science and not many can tell why certain things need to be done. Even Gautam used to play with hard hands and dab towards slips in Australia and England.

"You can still work with younger guys but difficult to mould the older ones who don't get enough time to work on their game in a

Watching the dismissals of especially Kohli in Australia, which seemed like a replay of previous ones, has led to growing concerns. Everyone understands the technical flaw, but can anyone provide the corrective measures to break the rut?

Rohit, barring the England tour in 2021, he does not really have a track record in SENA countries in Tests. But with Kohli, the problem of reaching for deliveries on and



outside the off-stump has resurfaced once again and has been a persistent issue for quite some time.

Sanjay Manjrekar's tweet is worth taking note of. "I guess the time has come to

scrutinise the role of a batting coach in the Indian team. Why major technical issues have remained unresolved for so long with certain Indian batters?" he

asked. Manjrekar's view raises questions on the role of Sanjay Bangar, Vikram Rathour, and now Nayar. Their official designation might be assistant coach, but they essentially

are batting coaches. Devang Gandhi, who was a touring selector between 2016-17 to 2020-

21, had a more nuanced take compared to the veteran India star. "It would be very easy to target Nayar as a low hanging fruit or for that matter Gautam," Gandhi, who has coached the Delhi Ranji team and Bengal U-19, told PTI during a

conversation. "But they have just come into system. To discuss or nudge a player, first you need to be around for some time and once there is some kind of mutual trust between the two, you can offer him solutions. But at this level, it is more about the experienced player's own

mental make-up." So what is Kohli's problem? Gandhi, a former Test opener and an NCA Level-2 coach, believes it's all about his mental approach. "If you watch his training videos

that are available for public, I find him doing all the right things. During training he is playing close to his body. But the moment it is the match situation, the hands are moving towards those channel deliveries like conditioned reflex or

muscle memory," he explained. Gandhi then blamed it on the rising T20 engagements. "The moment his bat is away from the body, the bat-face will open up

towards cover. Now this is a white ball problem of hitting through the

line. In India the ball will hit the bottom of the bat but in Australia, it

will towards the upper part. "What solution can Gambhir or Nayar possibly give, apart from telling him to not play those deliveries?

"After 30 Test hundreds, Virat doesn't need to be told that but at 36, does he have that patience to accept that now if he scores a hundred, it will be off 200 balls and not 140 like earlier times? Can he bide those extra 60 balls?," Gandhi questioned.

Sachin Tendulkar's epic 241 in the 2004 New Year's Test in Sydney is often cited as a prime example of patience. He didn't hit a single cover drive until he scored his double hundred.

double hundred. "It's about controlling the mind. You can be a sounding board for players like Tendulkar and Kohli but at this stage, you can't coach them. Coaching happens at junior level," Gandhi added.

But can a Gambhir or Nayar help Kohli find a solution?

"Of course, at some point, honest conversations are necessary. But first, they should ask him what his corrective options are and then offer their own if they have something different to contribute," Gandhi concluded.
