TMC goons tear into ED officials

Several Enforcement officials and Enforcement members of the Central forces escorting them grievously injured on Friday morning when they were attacked and chased away by around two thousand Trinamool Congress members armed with bamboos, brickbats, etc. The incident occurred at Sarberia village of Sandeshkhali Police Station in North 24 Parganas, about 73 km east of Kolkata. The officials had gone there to conduct raids on the properties of SK Sahjehan, a strongman, investigate his alleged role in

the multi-crore ration scam. This scam has already led to the imprisonment Jyotipriya Mallick, the Bengal Forest Minister, formerly in charge of the Food Ministry, last Öctober.

"We were conducting raids at SK Sahjehan's house around 8 in the morning. As the CRPF men were breaking the locks, suddenly thousands of people, including women armed with sticks and bamboos, charged in from all directions. They pushed us around and then attacked us. Our vehicles were literally smashed, and we had to run in all directions for our dear lives," recounted an official. Among the injured was an assistant director-level official, according to sources,

admitted to a private facility in Kolkata. Locals reported that CRPF men had to beat a hasty retreat on the broken vehicles, while some of the

charged at them menacingly. Some sought refuge in the local police outpost, while others rushed to the riverside and were ferried across on police boats, sources added. Apart from the attackers, some levelheaded people in the area privately praised the Central forces for showing utmost restraint in the melee. "God save us and many others... the Central forces are encircled by a thousand acted very professionally by not opening fire. If they had done so, there would have been many casualties, and that could have led to mayhem in the area," said a local teacher who was going to his school in the morning.

The planned nature of the

attack was further supported by reports that the fleeing officials were waylaid at Basanti Highway en route to

Kolkata. ED men fled on auto-rickshaws and totos when hundreds of armed men "Their passage was blockaded by trucks. They were pulled out of their vehicles and hit with bamboo sticks. I saw two of them getting hit on the head, and one was bleeding profusely. We were so afraid that we could not go to help," said a local shopkeeper, adding, "the bleeding officials were not even ready to go to the nearby health centre. They somehow managed to

take auto-rickshaws." "What will you do when you armed people from all sides in a distant land? It was a village, and many of us had to jump into the paddy fields to run to We were running safety. helter-skelter for some time. Are we doing national duty? Are we combat people, or are we dacoits?" an official said,

including the premises of TMC leader Shankhar Adhya in Bongaon and SK Sahjehan in North 24 Parganas. Their premises were reportedly being raided due to their alleged connections to the ration scam. It is also alleged that Adhya has been involved in money trading, and the agencies were looking into his possible role in money laundering related recruitment and ration scams. Switching to Sandeshkhali, Union Minister of State for Home Nisith Pramanik, giving his first reaction to the incident, said, "It is the duty of the State police to provide security, but things work differently in Bengal where security forces are under regular attack."

He said Friday's attack was not on the Central officials but "on the federal structure." He added, "The Centre has taken this matter very seriously, and we will inquire into it with all seriousness. Curiously, local TMC MLA Srikanto Mahato justified the mob attack, calling it "jano

rosh (public anger)."

He said, "How do the villagers know who has come? It could be dacoits; it could be thieves in uniform trying to break open the locks. So they thought that they should protect the house of their dear leader, and they ran to save

Hi-Tech Hosp blast

High drama over identification of 'dead' Dilip Samantray

In a twist to the AC compressor explosion case at the Hi-Tech Medical College Hospital in Bhubaneswar, a victim who was undergoing treatment in the ICU claimed that he is actually Dilip Samantray, who was earlier declared dead in the mishap.

The identity of Dilip, a native of Jatni in Khordha district, has become a cause of confusion. Another victim, believed to be Jyotiranjan Mallick, came out of ICU on Thursday following treatment and claimed that he is actually Dilip Samantaray, leaving the two families perplexed.

As per reports, the hospital declared Dilip Samantray dead on December 30 following the AC compressor blast during gas filling on December 29. There were four persons admitted to the hospital after the blast who worked for the AC repairing agency outsourced by the hospital.

completely charred in the blast was handed over to Dilip Samantray's family by the hospital on December 31 and the family performed his crema-However, injured Jyotiranjan Mallik woke up from the ventilator on Thursday and claimed to be Dilip Samantray leading to confu-

Hi-Tech hospital CEO Smita Padhi said, "All the four persons who were initially injured in the compressor blast are not the employees of the hospital. They are the staffs of an outsourcing agency. A staff of that outsourcing agency had identified the injured after the

"A patient had died on December 30. We were told that

he was Dilip Samantray. Following the procedure, we informed police. The family of the deceased identified the body and signed the inquest. Then, police performed all the required procedures before handing over of the body to

their relatives," she claimed.

Pattajoshi who conducted the psychometric evaluation of the patient said, "When Dilip Samantray's body was handed over to his parents, he had already sustained 95-per cent burns. His face was abnormally swollen. Identifying him was not possible. But his family members were overly emotional. They might have mistaken the body as Dilip's."

"Being said that, Jyoti's family, particularly his father has been seeing him on the hospital bed from the last six days. They are sure that the man is in fact Jyoti. But when the ventilator was removed today, he claimed his name as Dilip Samantray. Sometimes when a patient receives trauma, stays in the ICU for a long time, they may become delirious because of psychosis," Pattajoshi said.

"But when we called Dilip's family to the hospital who are already mourning his death, the patient answered all the questions right. He even knows the answers which Jyoti can't possibly know," he added. Dilip's nephew Manoj

Samantray, who had come to the hospital after being called by the authorities, said, "I addressed him as 'Mamu' and he replied to me exactly like my uncle Dilip Samantray. When we questioned him about his family, his wife, location of his in-laws and other things, he answered them accurately." "When the hospital handed

over the body to us on December 31, it was completely covered in polythene. The body was charred beyond recognition. As the hospital gave it to us saying he was Dilip; so, we believed them and performed his last rites. But I now see that my uncle Dilip Samantray is alive and well," Manoj Samantray said. It is particularly devastating for the Samantray family because Dilip's wife Suna ended her life by hanging from a fan out of grief. She was depressed after hearing about her husband Dilip Samantray's death. She could not bear the grief any-

Notably, another injured person had succumbed while under treatment on Tuesday night. He was identified as

BHUBANESWAR The long-standing demands of the Odisha Veterinary Service Association (OVSA) was finally presented before Inter Ministerial Committee on January 2 where OVSA president Dr Jadunath Parida and general secretary Dr Sankarsan Mahunta elaborated their demands with justification. The meeting ended with a positive note where all the demands of the OVSA were taken for consideration by the members of the Inter-Ministerial Committee. Keeping this in view, the association decided to postpone the mass leave agitation which was scheduled to start from January 4 to 18.

The demands include complete reformation of the department, parity with medical doctors, DACP and non-practicing allowance among others. Though the Veterinary cadre was given Group A status at entry level just two years back, it has created such an anomaly that a veterinarian joining the service will have to serve at a single pay scale for at least 24 to 27 years which is quite demoralizing. This is deplorable when the responsibility of the veterinarians of the State has multiplied, the OVSA said, warning that if the Government will not consider all its demands, then mass leave agitation will resume from Janu-

Giridhar and Sishir had left the Congress and joined the Bharatiya Janata Party (BJP). Hema had distanced herself from the Congress for over a decade now.

Sources said the Congress is

actively contemplating to revoke the expulsion order on Srikant Jena anytime soon. He will rejoin the Congress in the presence of Dr Ajay Kumar in Bhubaneswar.

Sanjaya Bhoi, former Lok Sabha member from Bargarh, and Koraput ex-MLA Krushna Sagaria are also likely to return to the Congress early this month. OPCC president Sarat Pattanayak and party central leaders have reportedly held talks with Bhoi and Sagaria in this regard. Both the leaders, sources added, have consented to return to the party fold.

Indian Navy Daredevils dive in to rescue our citizens

The Indian Navy's elite marine commandos on Friday successfully carried out an operation to intercept a hijacked merchant vessel and rescue several crew members, including at least 15 Indians. The Liberianflagged vessel MV Lila Norfolk was hijacked off the coast of Somalia.

The Navy deployed a warship, maritime patrol aircraft, helicopters, P-8I, and long-range aircraft, along with Predator MQ9B drones following the incident involving MV Lila Norfolk. "All 21 crew members, including 15 Indians, onboard the vessel, were safely evacuated from the citadel," said Indian Navy's spokesperson Commander

Vivek Madhwal. "The sanitisation carried out by MARCOs commandos confirmed the absence of hijackers. The attempted hijacking by the pirates was likely abandoned following a forceful warning by the Indian Navy's maritime patrol aircraft regarding interception naval warships," he added.

Providing details of the operation, Navy

The Indian Navy Marine Commandos boarded the hijacked ship and commenced sanitisation. MV Lila Norfolk was hijacked late on Thursday near the coast of Somalia. The hijacking was reported by the UK Maritime Trade Operations (UKMTO), a British military organisation that tracks movements of various vessels in strategic waterways.

Following the incident, the Indian Navy deployed its

destroyer INS Chennai, and a Navy aircraft constantly tracked the hijacked ship. It was hijacked by pirates 300 nautical miles east of Somalia. The ship was sailing from Port Du Aco (Brazil) and was bound for Khalifa

> Bin Salman in Bahrain. The Indian Navy's maritime patrol aircraft overflew the vessel early Friday and established contact with the vessel, ascertaining the safety of the crew, officials said.

"The Indian Navy remains committed to ensuring the safety of merchant shipping in the region along with international partners and friendly foreign countries," the spokesperson added. Last month, the Navy

deployed several warships into the sea to "maintain a deterrent presence" after a series of recent shipping attacks, including a drone attack near India's coast attributed to Iran by the United States.

The latest attack comes at a time when many vessels have been rerouted from the Red Sea, where Yemen's Iranbacked Houthi rebels have conducted drone and missile attacks in solidarity with Palestinians in Gaza, amid Israel's conflict with Hamas. In the previous month, a drone attack targeted the MV Chem Pluto tanker 200 nautical miles kilometres) off the coast of



Bandh in Rayagada over tribal warden's death

CBI probe demanded PNS RAYAGADA

Vehicular traffic came to a grinding halt, streets wore a deserted look and government and private establishments shut down as the District Adivasi Mahasangha and members of BJP called a 12hour bandh over the alleged murder of a physically-challenged tribal warden, Laxmi Majhi, in Rayagada district on

Seeking justice against torture and murder of tribal people, probe into not just the case of the warden but two other alleged murders of tribal leaders which took place in the district.

On December 21, a seminude body of Laxmi Majhi was recovered from hospital premises. Majhi, a resident of Naketiguda village in Tikiri panchayat of Kashipur block, was working as a warden at Maa Gruha in Chandrapur for the last five years. On the fateful day, she had left Maa Gruha at around 4 pm. Hours later, her fellow workers found her halfcharred body and informed her family who alleged that she had tribal youth leaders Bhagirathi Mandangi and Purushottam Gamango were allegedly killed in December 2010 and December 2019, respectively.

Following Majhi's death, the Zilla Adivasi Mahasangh and later the BJP Mahila Morcha had staged protests alleging police inaction and announced a bandh on January 5. "It's been 16 days since Chandrapur warden Laxmi Majhi was found dead, but police and Crimbe Branch have not yet nabbed the accused. This is not an isolated case. First, BJD leader Bhagirathi Mandangi, then now is the case of Majhi. There has been no headway in their death investigations. We want justice for these people and demand a CBI probe into the three murders," the protestors

Man, daughter run over by truck

I ension mounted in the Rugudi police station area of Keonjhar district on Friday when a man and his daughter were killed in a fatal road accident.

The deceased were identified as Ramsingh Munda (30) and his daughter Turi Munda (5) of Lasarda village under the Bolani police station. The

mishap occurred on the National Highway 520 near Rugudi police station, when they were returning to their village from Rugudi by a motorbike. PESA Regulations 2023

Extend feedback deadline by 3 months: Forum

The Indigenous People's Forum (IPF) expressed dissatisfaction over the Odisha Gram Panchayat (Extension to Scheduled Areas) Regulations 2023 issued by the Panchayati Raj and Drinking Water Department on Wednesday.

The regulations aim to modify several critical aspects, including reservations, ownership of forest produce, money lending control, land preservation, water bodies management, and land acquisition in the Scheduled Areas. The IPF flagged concerns

regarding the notice period and said that in the absence of public feedback, the draft will be treated as the final Gazette copy. It urged for an extended notice period to allow thorough public engagement.

Attended by representafrom Koraput, Malkangiri, Nabarangpur, Rayagada, Gajapati, Kandhamal and Ganjam districts, the meeting discussed the proposed regulations. While acknowledging the regulations' intention to foster governance and peace in Scheduled Areas, they stressed the importance of consulting the 62 distinct tribal groups in Odisha. Each group possesses unique traditional governance systems, indicating the necessity for inclusive discussions to align the regulations with their perspectives and suggestions effectively.

The IPF also raised concerns regarding the alleged lack of dissemination of the notification through Brahmapur editions via print or electronic media. The representatives criticised the State Government for issuing the notification without prior consultations with the diverse tribal groups, thereby overlooking their varied traditional governance systems. Addition-

ally, they lamented the absence of tribal leaders in the consultation process and highlighted the inadequate discussions with tribal communities or the Tribal Advisory Council (TAC) during the regulation formulation.


Ultimately, the IPF strongly opposed the Odisha Gram Panchayat (Extension to Scheduled Areas) Regulations 2023, deeming them incongruent with the Employment Act, 1996. They urged the State Government to extend the public comment deadline, originally set for January 9, by an additional three months until July 9, 2024. Furthermore, they advocated for a comprehensive and inclusive formulation of Gram Panchayat (PESA) regulations, rooted in constitutional mandates and reflective of the social and cultural ethos of tribal communities

"We urged the State Government through memorandum via Odisha Governor Raghubar Das, Chief Minister Naveen Patnaik and Navin Odisha Chairman VK Pandian to address these concerns to ensure equitable governance in Scheduled Areas," IPF convenor Theophil Gomango said.

A press statement issued by the Indian Railways on Friday said the Cabinet was apprised of the signing of the Memorandum of Understanding (MoU) between India and the United States Agency for International Development (USAID)/India on June 14, 2023.

"The MoU provides a platform for Indian Railways to interact and share the latest developments and knowledge in the railway sector," it said

"The MoU facilitates utility modernisation, advanced energy solutions and systems, regional energy and market integration and private sector participation and engagement, training and seminars/workshops focusing on specific technology areas like renewable energy, energy efficiency and other interactions for knowledge sharing," said the note.

According to the Indian Railways, it earlier worked with USAID/India for the deployment of rooftop solar systems across railway platforms.

The MoU states that the Indian Railways and USAID/India will jointly work for long-term energy planning, including clean energy for the Indian Railways. They will develop an energy effi-



ciency policy and action plan for Indian Railways buildings and plan for clean energy procurement to achieve its net-zero vision. "Technical support for addressing regulatory and implementation barriers" and "bid design and bid management support for system-friendly, large-scale renewable procurement" are areas on which the two

sides will work together. Besides, the MoU will focus on supporting the Indian Railways in the promotion of e-mobility and collaboratively hosting events, conferences, and capacity-building programmes in the identified areas.

According to the Railways, the MoU will help reduce its dependence on imported fuel such as diesel and coal, among others. "Deployment of renewable energy plants will give fillip to renewable energy technology in the country. This will help in the development of the local ecosystem, which subsequently gives a boost to local product development," the statement said.

"Technical assistance for the services under this MoU is intended to be provided by USAID under the SAREP initiative. This MoU is not an obligation of funds or a commitment of any kind, and it is non-binding. This does not involve any financial commitment from the Indian Railways," it added.

Ready to extend all support: Modi to Kishida after Japan earthquake

Prime Minister Narendra Modi has written to his Japanese counterpart Fumio Kishida expressing India's solidarity with Japan and its people affected by the devastating earthquake on January 1.

On Thursday, Modi wrote to Kishida that India values its relationship with Japan as a special strategic and global partner, and is ready to extend all possible assistance at this hour, sources said.

Around 90 people were killed when a 7.6 magnitude earthquake struck Japan's northernmost peninsula of Noto on Monday.

The prime minister conveyed to his Japanese counterpart that he is "deeply anguished and concerned" over the earthquake and expressed "deepest condolence" to the families of those killed in the quake, the sources said.

"I am deeply anguished and concerned to learn about the major earthquake that struck Japan on January 1," Modi said.



"I express my deepest condolences to the bereaved families of those who lost their lives. We stand in solidarity with Japan and its people affected by the disaster," a source quoted Modi as writing to the Japanese prime minister.

Japan's Kyodo news agency said on Friday the death toll in the quake rose to 92 with over 240 people still missing. It said authorities doubled the number of Self-Defence forces' personnel taking part in earthquake rescue operations to

Ramesh concerns on VVPATS require no clarifications: EC

Dismissing Congress leader Jairam Ramesh's concerns on the VVPATs, the Election Commission on Friday said that it raised "no new assertions or reasonable and legitimate doubts which require further clarifications", adding the rules governing paper slips were introduced by the grand old party-led government in 2013. In a communication to Ramesh, the poll body also expressed "full faith in the use of the EVMs in the elections" and made it clear that literature in the public domain on EVM including the latest updated Frequently Asked Questions (FAQs) (85 Questions) answers all reasonable and legitimate aspects of the use of EVMs adequately and comprehensively.

Rule 49A and 49M of the Conduct of Election Rules, 1961, governing VVPAT and handling of paper slips was introduced by INC (Indian National Congress) on 14th August, 2013," said the letter signed by Pramod Kumar Sharma, Principal Secretary in the Election Commission. Ramesh had written to the Election Commission on December 30 last year, requesting that a delegation of the Indian National

Developmental Inclusive Alliance (INDIA) be given an appointment to put forth their views on the Voter Verifiable Paper Audit Trail (VVPAT) slips. The opposition alliance



19 voiced doubts about the integrity of functioning of the Electronic Voting Machines (EVMs) and wanted the VVPAT slips to be handed over to the voters, who could drop it in a separate box. The opposition alliance had also demanded 100 per cent matching of the slips and the EVMs.

"The recent letter dated December 30, 2023, does not raise any unresponded issue on EVM/VVPAT," Sharma said. He said the letter dated December 30, 2023, said to be in sequence of the earlier letters "has no new assertions or reasonable and legitimate doubts which requires further clarifications".

The Commission also dubbed as "out of context" the references made to other countries and their Constitutional Courts about the use of the EVMs in the elections. "Based on the outcomes of the elections conducted using EVMs, legal framework, established jurisprudence, technical security and administrative safeguards, the Commission has full faith in the use of the EVMs in the elections," Sharma asserted The poll body pointed out that

political parties and candidates are associated at every stage of handling of the EVMs, starting from FLC, storage, movement, training, randomisation, commissioning, mock polls, start of poll, close of poll counting.

Al model can predict which **Covid variant** to cause wave

Which SARS-CoV-2 variants are likely to cause new waves of infection? You can now know them beforehand as scientists at the Massachusetts Institute of Technology (MIT) in the US have developed a new Artificial Intelligence (AI) model that can predict early before any variant which SARS-CoV-2 variants are likely to cause new waves of infection.

Current models used to predict the dynamics of viral transmission do not predict variantspecific spread.

The team led by Retsef Levi from MIT's Sloan School of Management studied what factors could shape the viral spread based on an analysis of 9 million SARS-CoV-2 genetic sequences collected by the Global Initiative on Sharing Avian Influenza Data (GISAID) from 30 countries, along with data on vaccination rates, infection rates, and other factors.

The findings are published in the journal PNAS Nexus. The patterns that emerged from this analysis were used to build a Machine Learning-enabled risk assessment model.

The model can detect 72.8 per cent of the variants in each country that will cause at least 1,000 cases per million people in the next three months after an observation period of only one week after detection

This predictive performance increases to 80.1 per cent after two weeks of observation.

Fatigue in long-Covid due to muscle cells producing less energy: Research

 $R^{\text{esearchers}}_{\text{Universiteit}} \ _{\text{Amsterdam}}^{\text{dr Vrije}}$ and Vrije Universiteit Amsterdam (VU) have uncovered evidence explaining why individuals with long Covid endure prolonged fatigue, discomfort, and pain after physical activity. The study, published in Nature lished in Nature Communications, examined 25 long Covid patients and 21 individuals who had recovered fully from Covid.

The participants, all of whom were previously healthy and within working age, engaged in a short exercise on a bicycle. The results showed that, on average, those with long Covid had a reduced exercise capacity compared to healthy participants. The researchers looked at the blood and muscle tissue 1 week before the cycling test and 1 day after the

The researchers discovered that the persistent fatigue in patients with long-Covid has a



biological cause, namely mitochondria in muscle cells that produce less energy than in healthy patients.

"We're seeing clear changes in the muscles in these patients, said Michèle van Vugt, Professor of Internal Medicine at Amsterdam UMC.

"We saw various abnormalities in the muscle tissue of the patients. At the cellular level, we saw that the mitochondria of the muscle, also known as the energy factories of the cell, function less well and that they produce less energy," said Rob Wüst, Assistant Professor at Department of Human Movement Sciences at the VU

India, Mauritius ink MoU to jointly develop small satellite

Tndia and Mauritius will Jointly develop a small satellite which will be launched by Indian Space Research Organisation(ISRO)early next year, the Union Cabinet was apprised on Friday.

India and Mauritius had signed a MoU for development of a joint small satellite during the visit of Minister of State for Affairs External Muraleedharan to Port Louis on November 1 last year. The MoU will help to establish

a framework for cooperation between Indian Space Research Organization (ISRO) and Mauritius Research and Innovation Council (MRIC) on the development of a joint satellite as well as for cooperation on the use of the ground station in the island nation.

"Some of the subsystems for the joint satellite will be taken up through the participation of Indian industries and would benefit the industry," an official statement said. The satellite realisation is proposed to be completed in 15 months time



frame, it said. The Union Cabinet, at a meeting chaired by Prime Minister Narendra Modi, was apprised about the

An official statement said the collaboration through the joint development of the satellite will help in further ensuring continuous support from the Mauritius government for the Indian ground station at Mauritius, which is critical for India's launch vehicle and satellite missions.

In addition, the joint satellite building will also help in ensuring MRIC support from their ground station for ISRO's small satellite mission in future. The estimated cost for the joint satellite is Rs 20 crore, which will be borne by India.

Space cooperation between India and Mauritius dated back to 1986 when ISRO established a ground station in Mauritius for tracking and telemetry support for its launch vehicle and satellite missions. The current space cooperation is being governed by the country-level agreement signed in July 2009, which superseded the 1986 agreement.

Based on the interest expressed by MRIC in jointly building a small satellite for Mauritius, the Ministry of External Affairs(MEA) had requested ISRO to initiate discussions on realizing an India-Mauritius joint satellite. The MEA will provide funding for realisation, launch and operation of the

NMC introduces post doctoral fellowship courses in medicine

rn a move aimed to promote research and clinical skill development among post-graduate students, the National Medical Commission, country's top medical education regulator has for the first time introduced post-doctoral fellowship courses in medical colleges regulated by it.

Medical institutions till now were creating and approving these courses at their own level to train doctors.

The regulator recently notified "Post-Graduate Medical Education Regulations, 2023" according to which once a medical college is granted permission to start PG courses or seats, the course will be treated as recognised.

This will solve many difficulties faced by students to register their degree after passing postgraduate examinations, Dr Vijay Oza, President of Post-Graduate Medical Education Board of the National Medical Commission

explained. As per the new regulations which have replaced the Postgraduate Education (Amendment) Regulations, 2018, the existing NEET-PG examination will continue till the proposed National Exit Test (NExT) becomes operational for the purpose of PG admission. The new regulations state that

all post-graduate students will work as full-time resident doctors and for "reasonable working hours" and will be provided "reasonable time for rest" in a day.

They will be permitted a minimum 20 days of casual leaves per year and five days of academic leave per year.

Subject to exigencies of work post-graduate students will be allowed one weekly holiday, the new regulations said.

"Earlier there was no written provision of leaves," Dr Oza

Overarching earth sciences scheme 'Prithvi Vigyan' gets Cabinet nod

 $T^{\text{he government on Friday}}_{\text{approved "Prithvi Vigyan", an}}$ overarching initiative comprising five on-going sub-schemes related to earth sciences, at a cost of Rs 4,797 crore over a five-year period from 2021-26. The Union Cabinet, at a meeting chaired by Prime Minister Narendra Modi, approved the proposal of the Ministry of Earth



Sciences to club the sub-schemes. The schemes are "Atmosphere and Climate Research-Modelling Observing Systems and Services", "Ocean Services, Modelling Application, Resources and Technology", "Polar Science and Cryosphere Research", "Seismology and Geosciences" and "Research, Education, Training and Outreach". "The overarching scheme of 'Prithvi Vigyan' (PRITHVI) will enable

development of integrated multi-disciplinary earth science research and innovative programmes across different MoES institutes," an official statement said.

It said these integrated research and development efforts will help in addressing the grand challenges of weather and climate, ocean, cryosphere, seismological science and services and explore the living and non-living resources for their sus-

tainable harnessing.

The objectives of the overarching "PRITHVI" scheme includes augmentation and sustenance of longterm observations of the atmosphere, ocean, geosphere, cryosphere and solid earth to record vital signs of the earth system and change, development of modelling systems for understanding and predicting weather, ocean and climate hazards, and understanding the science of cli-

mate change
It also includes exploration of polar and high seas regions of the earth towards discovery of new phenomena and resources, development of technology for exploration and sustainable harnessing of oceanic resources for societal applications, and translation of knowledge and insights from earth systems science into services for societal, environmental and economic benefit.

Divided they stand

INDIA bloc fissures widen; can it fight the Lok Sabha elections together as an entity?

he INDIA bloc, considered a strong alliance to take on the BJP when it took shape. is now bogged down by serious internal problems. Cracks within are widening each passing day, with the Congress acting like the big boss and regional parties digging their heels in. To divert attention, Congress president Mallikarjun Kharge is going all out against the Modi Government, pointing out its failures. While the Government tries to play down his remarks, Kharge insists that it is using emotive subjects to distract citizens. The biggest problem for the INDIA bloc is the growing disagreement among its constituents. Varied political beliefs, interests and the desire to secure their own interests are causing these gaps to widen. Lately, there have been public fights on important policies, showing how fragile the alliance is. Even if the Congress chief is right about the Government using emotive issues (like the Ram temple) to shift focus from its failures, it won't be enough to keep the bloc together. Kharge says the ruling party is using



sensitive topics to divert attention from serious issues like economic problems, unemployment and governance failures. While the INDIA bloc is together on these issues, the major problem causing divisions is finalising seat distribution and the formula for it in the upcoming general elections. Regional leaders are firm about pocketing more seats and not sharing their strongholds with national parties like the Congress. For the INDIA bloc to stay intact, three main issues need solving pronto: seat sharing, choosing a PM candidate, and agreeing on a common minimum pro-Leaders also need to stop airing their grievances pub-

licly without consulting others. It does not help when the TMC offers two seats to Congress, and AAP insists on fighting all 13 seats in Punjab. Also, naming Kharge as the PM candidate doesn't make sense until his party leaders agree. The common minimum programme is the least controversial, so that is where they should start, taking it step by step to form a united front against the NDA. Besides, they must also not forget why they formed the INDIA bloc in the first place. It was to dislodge the BJP from power as the ruling party is supposedly sending their leaders to jail, and intimidating them with ED and CBI raids. Ostensibly the whole Opposition came together as these parties were not given a fair chance in Parliament and several Opposition leaders were suspended on one pretext or the other. The INDIA bloc parties must realise they stand no chance against the BJP-led NDA if they fight separately. A divided vote will benefit only the BJP, considering PM Narendra Modi's charisma, as was evident in the recent Assembly elections. The choice is clear for them: fight together or face defeat. As the INDIA bloc deals with internal issues, finding a way forward means committing to open dialogue and compromise; otherwise, the election result is pretty much decided even before the polls are officially announced. Ego has no place in the scheme of things.

Sri Lanka: Quest for reconciliation

Interestingly, in post-conflict nations, many feel truth commissions and reconciliation processes haven't effectively addressed systemic issues

ppointing toothless commissions to investigate alleged crimes and conduct fact-finding is a recurring issue, with some commissions genuinely seeking the truth to implement comprehensive measures preventing recurrence, while others merely aim to buy time and conceal the truth. Regardless of intent, the plight of individuals remains unchanged until addressed, necessitating profound restructuring to mitigate the root causes behind violent social upheavals. Unfortunately, history has shown that democracy has not consistently triumphed. Politicians in post-conflict nations, the so-called liberal democracies, and most of their darling NGOs deliberately ignore democratically resolving the structural problems afflicting broken democracies, often treating victims as mere commodities.

Following nearly 15 years of persistent armed conflict, Sri Lanka has once again reached a pivotal moment with the introduction of a bill to establish the Commission for Truth, Unity, and Reconciliation, marking a significant stride forward. Though belated, this move is undeniably commendable. Against a backdrop of news stories sowing social phobia and fostering negativity among the general public, this development provides a glimmer of hope during precarious times.

The bill, presented as an act, outlines the establishment of the Commission for Truth, Unity, and Reconciliation in Sri Lanka, defining its powers and functions. It further emphasises the necessity of monitoring the implementation of the commission's recommendations to ensure accountability. Recognising truth-seeking as a fundamental right for all Sri Lankans, integral to their right to an effective remedy, the bill underscores the potential contributions of such mechanisms to national unity, peace, the rule of law, coexistence, equality with tolerance, respect for diversity, and reconciliation. The ultimate goal is to prevent disharmony and violence, securing the well-being of all Sri Lankans, including future generations.

The commitment extends to a national policy of truth-seeking and the advancement of national unity and reconciliation, reinforcing the State's assurance of freedom, equality, justice, fundamental human rights, and the independence of the judiciary as recognised under the Constitution. The Commission for Truth, Unity, and Reconciliation, to be neaded by a chairper son and supported by established regional offices, shall be comprised of not fewer than seven and not more than twenty-one

According to the bill's stated objectives, the Commission is mandated to investigate, inquire, and provide recommendations regarding complaints, allegations, or reports related to damage or harm to persons or property, loss of life, or alleged human rights violations anywhere in Sri Lanka. These incidents must be connected to, or consequent to, the conflict in the Northern and Eastern Provinces during the period 1983 to 2009, or its aftermath. However, echoing the pattern of other commissions, it is underscored that the Commission's recommendations do not constitute a determination of civil or criminal liability for any indi-

leadership of former President Chandrika Bandaranaike Kumaratunga. She, with whom we have shared a memorable time in addressing the most sensitive issue in the country, struggled with serious structural degeneration caused by the malpractices of those who wielded power. Her remarkable efforts to bridge ethnic divides in the country were a clear demonstration of her commitment to fostering unity. She never hesitated to acknowledge and categorize any wrong political decisions, whether made by her or even her immediate family members, which I find

truly inspirational. ONUR was established with noble aspirations of achieving lasting peace. However, amidst political uncertainty, the initiatives of this national institute plunged into the abyss of eclipse. In those days, ONUR undertook comprehensive initiatives, addressing issues beyond the surface. We not only engaged with Colombo-based NGOs, which were merely challenging the prevailing narrative that often prioritised a select few while neglecting those in remote areas, but ventured into the North and East. It was remarkable to witness former Tamil Tigers expressing confidence in the central government's efforts and the state administrative mechanism to rebuild and reunite their families-an aspect seldom highlighted. Among ONUR's key projects was Sahodara Pasal, where around a hundred students from various ethnicities, attending different schools, spent a week together in one place. At an event in Kandy, three female students, representing Sinhala, Tamil, and Muslim backgrounds, stood united against the rain, sharing a single hijab as a symbol of strength and diversity. Despite initial misconceptions, these students developed bonds transcending ethnic lines, hugging and crying at the program's end, pledging lasting friendships. Unfortunately, when I revisited ONUR three years later, the prioritisation of crucial social integration initiatives like Sahodara Pasal had waned. This neglect poses a risk of growing disparity and division, deviating from the path toward true unity and reconciliation The irony lies in the disillusionment

of people in numerous post-conflict countries that established truth and reconciliation commissions, including Argentina, Guatemala, Liberia, Rwanda, Sierra Leone, Peru, Nepal, and even the much-praised South Africa. They harbour a collective sentiment that most truth commissions and reconciliation processes have failed to address their systemic issues. What prevails is an overarching politicisation, a malaise that transcends past truths and impedes their ability to break free. To truly escape their plight, they must depoliticise their tragic experiences, reclaim suppressed freedoms, and radically reshape their dismal reality. The key lies in inventing a new form of political solidarity that transcends national, ethnic, cultur al, and religious identities—a bold move to build bridges over mass graves and ruins. Deep and thorough reconciliation alone cannot achieve this, as it inherently aligns with the status quo, perpetuating existing power relations and ideological deadlocks that bear the true responsibility for the tragedy. Victims seek more than reconciliation; they yearn for recognition of their tragic fate, a political cause to emerge from victimhood. Humanitarian assistance, spanning from necessities to weaponry, proves inadequate; genuine liberation arises not from aid but from unwavering political solidarity—a steadfast dedication to freeing them from a decade-long ordeal. History paints a consistent narrative

of conflicts as an inherent facet of human civilisation, profoundly shaping humanity's trajectory. Sri

Alexievich aptly notes war's enigmatic hold on the human experience and its enduring impact on societies. Despite its monumental significance, there's a tendency to downplay the seriousness of war. The grim and daunting nature of conflicts may tempt us to avert our gaze, but avoidance doesn't diminish their historical weight. Wars have consistently redirected the course of human history, both by forging new pathways into the future and closing down others.

Recognising the transformative impact of conflicts underscores the paramount importance of reconciliation. More than a mere talk show or commodity, reconciliation embodies a profoundly humanistic approach to our daily life engagement. It acknowledges the intricate aftermath of war, emphasising the imperative for societies to unite, heal, and carve a path toward more harmonious coexistence. Prioritising reconciliation signifies a commitment to understanding the human dimensions of conilict, nurturing empatny, rebuilding trust, and ultimately striving for a future that transcends the scars of the past. In this light, reconciliation isn't just a historical necessity but an indispensable element in shaping a more compassionate and interconnected world.

Genuine reconciliation drives national consensus, inevitably guiding the nation toward steadfast national interests—the foundational principles of a truly national state. If our education system perpetuates religious and exclusivist ideologies, no matter how empathetic our discourse about victims of a conflict that ended 15 years ago, the seeds of hatred will persist, waiting to explode—an ominous lesson from

Israeli defence minister lays out vision for next phase of Gaza war

srael's defence minister on Thursday laid out his vision I for the next phase of the war in Gaza, describing how Israeli forces would shift to an apparently scaled-down "new combat approach" in northern Gaza, while continuing to fight Hamas in the south of the ter-

ritory "for as long as necessary". Ahead of a visit by the US secretary of state, Yoav Gallant also outlined a proposal for how Gaza would be run once Hamas is defeated, with Israel keeping security control while an undefined, Israeli-guided Palestinian body runs day-today administration, and the US and other countries oversee rebuilding

Israel has come under heavy international pressure to spell out a post-war vision but so far has not done so. The issue is likely to be on the agenda in Secretary of State Antony Blinken's talks this weekend in Israel and other countries in the region. The United States has pressed Israel to shift to lowerintensity military operations in Gaza that more precisely target Hamas, after nearly three dev-

ment and ground assaults.

The vagueness of many of Gallant's provisions made it difficult to assess how much they mesh with the US calls.

The document issued by Gallant was titled a "vision for Phase 3" of the war, and Gallant's office said the phase had not yet begun. It also said the ideas were Gallant's and not official policy, which would have to be set by Israel's war and security cabinets.

Gallant, who is a member of both cabinets, may be aiming to put his personal plan before the Americans ahead of others in Prime Minister Benjamin Netanyahu's coalition, which includes hard-right members likely to want a tougher approach.

Israel's campaign in Gaza has killed more than 22,400 people, more than two-thirds of them women and children according to the Health Ministry in the Hamas-run territory. The ministry's count does not differentiate between civilians and combatants. Israel has vowed to destroy Hamas after its October 7 attack, in which militants killed some

1,200 people and abducted around 240 others.

Much of northern Gaza. which troops invaded two months ago, has been flat-tened beyond recognition. Associated Press footage from Gaza City showed people wandering through a shattered landscape with large fields of broken concrete and splin-tered wood and streets lined with toppled buildings. With the focus now in the

south, Israeli forces are battling Hamas militants in the city of Khan Younis and in urban refugee camps in the centre of the territory.

Some 85 per cent of Gaza's 2.3 million (23 lakh) people have been driven from their homes and squeezed into smaller slivers of the territory. Israel's siege of the territory has caused a humanitarian crisis, with a quarter of the population starving because not enough supplies are entering, according to the UN.

At the same time, airstrikes and shelling across Gaza continue to destroy houses, burying families taking shelter

Mawasi, a small rural strip on Gaza's southern coastline that Israel's military had declared a safe zone. The blast killed at least 12 people, Palestinian hospital officials said. The dead included a man and his wife, seven of their children and three other children ranging in age from five to 14, according to a list of the dead who arrived at Nasser Hospital in nearby Khan Younis.

There was no immediate response from Israel's military Gallant's statement under lined that the war would go on until Hamas' military and government capabilities are eliminated and the more than 100 hostages still in captivity are

returned. In the north, the statement said, forces will shift to a new approach that includes raids, destruction of tunnels, "air and ground activities and special operations". The aim would be "the erosion" of the remaining Hamas presence.

There was no word whether northern Gaza's population, which has almost entirely been driven south, would be allowed to return.

Sri Lanka President backs India-mooted solution to Tamil community's demand

Sri Lankan President Ranil Wickremesinghe on Friday backed the India-mooted 13th Amendment as a solution to address the minority Tamil community's long-pending demand for political autonomy.

India has been pressing Sri Lanka to implement the 13th Amendment which was brought in after the Indo-Sri Lankan agreement of 1987. The 13A provides for the devolution of power to the Tamil commu-

Addressing a group of pro-fessionals in Jaffna, the capital of the Tamil-dominated Northern Province, Wickremesinghe said the devolution of power shouldn't merely be a political concept but an economic reality.

The 13A became a part of Sri Lanka's constitution in 1987 through the direct intervention of the then-Indian government led by prime minister Rajiv Gandhi.

It created nine provincial councils for nine provinces with a temporary merger of the North and East which the Tamil minority claims is their traditional homeland.

"If we examine the provisions of the 13 Amendment, there is ample authority to establish a robust local economy. We pledge not to intervene in those affairs. I am encouraging you to take the initiative," Wickremesinghe said.

Presently, the Western Province is the sole region capable of substantial independent spending, while others are financially dependent on it, he said. "This situation warrants reconsideration. By utilising the powers within the 13th Amendment, each province can chart its course to develop-ment. It's time to put these pow-

Wickremesinghe's willingness to grant full powers other than police to provinces was shot down by the powerful Buddhist clergy who claimed the move could endanger the unitary state of Sri Lanka.

The Liberation Tigers of Tamil Eelam (LTTE) which fought for a Tamil homeland for nearly 30 years had rejected the They fought the Indian Army that was deployed as part of the Indo-Lanka Accord.

In 2013, the Tamils for the first time voted for their own chief minister for the North. The previous provincial elections were severely hampered by

the LTTE's armed campaign.
The current Tamil political parties stay sceptical of the political will in the majority Sinhala south to fully imple-

ment the 13A. The Tamils put forward their demand for autonomy since gaining independence from Britain in 1948 which from the mid-70s turned into a bloody armed conflict.

Over the years, the Sri Lankan government has been aggressive against Tamilian groups following its war with LTTE which collapsed in 2009 after the Sri Lankan Army killed its supreme leader Velupillai Prabhakaran.

Maldivian President Muizzu to visit China next week

Mohamed Muizzu, the new Maldivian President, will pay a state visit to China from January 8 to 12, the Chinese Foreign Ministry announced here on Friday.

Muizzu, who is seen as a Muizzu, who is seen as a pro-China politician, took oath as the eighth President of the Maldives after defeating the India-friendly incumbent Ibrahim Mohamed Solih in the presidential runoff held in September.

Muizzu is visiting China at the invitation of Chinese President Xi Jinping, Chinese Foreign Ministry spokesperson Hua Chunying said in a press

Muizzu's predecessors in the recent past visited India first, considering the wideranging bilateral ties and the Maldives' proximity to India, followed by China which has expanded its influence in the island nation by investing in major infrastructure projects

Turkiye as his first destination for a foreign visit soon after his election followed by the UAE where he met Prime Minister Narendra Modi on the sidelines of the United Nations Framework Convention on Climate Change (COP28) on December 1 and discussed the progress of the wide-ranging bilateral ties.

During the meeting, both leaders agreed to set up a core group to discuss the multidimensional relations and further deepen ties.

The meeting took place after Muizzu requested New Delhi to withdraw 77 Indian military personnel from the Maldives and decided to review more than 100 bilateral agreements between the two coun-

Earlier, Muizzu's government announced its plans to drop a hydrographic survey agreement with India.

Rival Koreas conduct provocative drills along tense sea boundary

he rival Koreas fired artillery I rounds into the sea as part of provocative drills along their disputed sea boundary on Friday, in violation of the fragile 2018 inter-Korean military

agreement. The firing exercises are expected to escalate tensions on the Korean Peninsula. Experts say North Korea will likely intensify a run of weapons tests and its warlike rhetoric ahead of South Korea's parliamentary elections in April and the US presidential election in November, South Korea's Joint Chiefs of Staff said North Korea fired 200 rounds in the waters north of their western sea boundary on Friday morning. It was North Korea's first front-line maritime firing exercise in about a year. Joint Chiefs of Staff spokesperson Lee Sung Joon told a televised briefing that the North's artillery firing was "an act of provocation that threatens peace and heightens tensions on the Korean Peninsula." Lee said South Korea suffered no dam-

In a tit-for-tat step, South Korea had its troops on two border islands fire artillery rounds

south of the sea boundary later Friday, but North Korea's military didn't immediately respond. South Korea's Defense Ministry said the military will maintain a firm readiness to strongly punish any provocations by North

North Korea's state media haven't made any comments.

Ahead of the South Korean drills, authorities blared broadcasts via street loudspeakers and sent text messages to residents on the five major border islands, asking them to evacuate to safe places. They worried North Korea could conduct a new round of firing training in response but lifted the evacuation order a few hours later as they detected no suspicious activities by the North's military, according to local officials.

The Koreas' poorly marked western sea boundary witnessed bloody naval clashes in 1999, 2002 and 2009. The North's alleged torpedoing of a South Korean warship killed 46 South Korean sailors in March 2010, and the North's artillery bombardment of Yeonpyeong Island one of the five border islands where the evacuation order was issued on Friday - killed four South Koreans in November

The 2018 agreement requires the two Koreas to halt live-fire exercises and aerial surveillance in buffer and no-fly zones that they established along their border. But the deal is in danger of collapsing after both Koreas took steps to breach the accord amid bickering over the North's first successful military spy satellite launch in November.

South Korea resumed frontline aerial surveillance in protest at the North's satellite launch. North Korea responded that it would deploy powerful weapons at the border and won't abide by the 2018 deal any longer. South Korea later accused North Korea of restoring front-line guard posts that it had dismantled

under the 2018 deal. South Korea has previously accused North Korea of having already breached the deal numerous times with firing drills at the buffer zones, including one as recently as December 2022 off the Korean Peninsula's east coast. "North Korea is now in the stage of finding a justification for provocation after scrapping the 2018 military agreement," said Lee Sang Sook, a research professor at the Institute of Foreign Affairs and

National Security. "There is a possibility for North Korea to ramp up provocation steadily, so big and small provocations along the western sea boundary and the land border are expected this year." North Korean leader Kim Jong Un fired off fierce, derisive rhetoric against South Korea in a key ruling-party meeting at the end of December. He said South Korea must not be considered as a partner for reconciliation or unification, and ordered the military to use all available means including nuclear weapons — to conquer South Korea in the event of a conflict.

Experts say Kim likely believes that a boosted military capability would increase his chances of wresting U.S. concessions if former President Donald Trump is reelected in the US presidential election. Earlier Friday, North Korea's state media said Kim ordered authorities to increase production of mobile launch vehicles for missiles during a visit to a munitions factory. Kim said the role of the factory producing transport erector launchers, or TELs, is "very important" in bolstering North Korea's national defense because of a looming military showdown

Indian-American medical biller held for million-dollar fraud

61-year-old Indian-origin Amedical biller has been arrested for stealing more than USD 1 million from doctors who provided medical care to injured workers in New York, according to the Attorney General's Office here.

Amrish Patel and his two companies — Medlink Services and Medlink Partners — were charged on Wednesday with 27 felony counts for the thefts they allegedly committed from January 2012 through January 2019, New York Attorney General Letitia James announced.

Patel and the companies were charged with one count of insurance fraud in the first degree, one count of grand larceny in the first degree, one count of grand larceny in the second degree, one count of grand larceny in the third degree, one count of scheme to defraud in the first degree, 11 counts of falsifying business records in the first degree and 11 counts of workers' compen-

sation fraud. He was released with electronic monitoring and a USD 100,000 bond, according to the New York Attorney General's Office.

Patel, who provided billing services to a Brooklyn-based orthopaedic surgery practice, submitted falsified claim forms to the New York State Insurance Fund (NYSIF) to steal at least USD 1.1 million in workers' compensation reimbursements for himself.

Doctors and health care professionals provide crucial care to our communities, and they rely on accurate and ethical billing to sustain these services and ensure our wellbeing," said Attorney General James "When money is illegally

diverted away from doctors and providers, all New Yorkers suffer as a result. Fraud of any kind will never go unchecked in our state, and my office will continue to use every measure to hold accountable those who seek to cheat New Yorkers for personal gain. I thank our partners for their invaluable support and collaboration on this case," James.

Ukraine unleashes drones, missiles at Russian areas

Russian air defences downed dozens of Ukrainian drones in occupied Crimea and southern Russia on Friday, officials said, as Kyiv pressed its strategy of targeting the Moscow-annexed peninsula and taking the 22month war well beyond Ukraine's borders.

Air raid sirens wailed in Sevastopol, the largest city in Crimea, and traffic was suspended for a second straight day on a bridge connecting the peninsula, which Moscow seized illegally a decade ago, Russia's southern Krasnodar region. The span is a crucial supply link for Russia's war effort

The Russian Defence Ministry said its defences intercepted 36 drones over Crimea and one over Krasnodar, part of an emerging pattern of intensified Ukrainian aerial attacks in recent days.

A Ukrainian Neptune antiship missile also was destroyed over the northwestern part of the Black Sea, the ministry said.

R aising serious doubts over whether the scheduled February 8 polls in Pakistan will be held, jailed former prime minister Imran Khan has reiterated his "engineered" removal from power in 2022 by the establishment "under pressure from America" and the lack of "level playing field" in the elec-

The charge in the write-up attributed to him in The Economist published on Thursday with the title 'Imran Khan warns that Pakistan elections could be a farce, has already been denied both by the Pakistan government and the US Department of State.

The write-up paints a scathing criticism of Pakistan's current political scenario even as it reiterates Khan's oftrepeated allegations and ends with the demand for "free and fair" elections for political stability and the need for reforms. He also claims that "with democracy under siege", Pakistan is "headed in the opposite direction."

Founder of the Pakistan Tehreek-e-Insaaf (PTI) party, 71-year-old Khan is incarcerated at the Adiala Jail in Rawalpindi, convicted in the Toshakhana corruption case and being

in connection with the May 9 violent protests by his supporters that damaged military installations across Pakistan.

His nomination has been rejected by the Election Commission of Pakistan (ÉCP) as is the case with that of many other leaders of his party ahead of the February 8 general elections for both national and provincial assemblies.

While expressing fears that the election scheduled for February 8 may not take place at all, the article stated that even if they do, such polls would be a "disaster and a farce" since PTI is being denied its basic right to campaign.

Whether elections happen or not, the manner in which I and my party have been targeted... has made one thing clear: the establishment — the army, security agencies, and the civil bureaucracy — is not prepared to provide any playing field at all, let alone a level one, for PTI," Khan wrote.

The PTI founder went on to describe in detail how his ouster in March-April 2022 was "engineered" under pressure from America, which he alleged, "was becoming agitated with my push for an independent foreign policy and my refusal to provide bases for its armed forces.

Khan also said he wanted to be a tried under multiple other cases, including one under the Official Secrets Act friend to all and not anyone's proxy for war, an opinion shaped by the huge loss-

es suffered by Pakistan, including the loss of 80,000 lives while collaborating with America's "war on terror."

He also described in detail the cipher case, how the caretaker governments are illegal as the elections were not held within 90 days, blamed the ECP for rejecting his nomination, hindering the party's internal elections, and also lodging cases against him and his party colleagues "simply for criticising the Commission.

Meanwhile, Khan's The Economist write-up went viral on social media and garnered a volley of reactions in Pakistan. Some PTI supporters also shared the Urdu translation, some shared screenshots - the original is behind a paywall – and some even went ahead with an audio-visual of Khan reading it out generated using AI.
Pakistan's leading daily The Dawn

said, "While sources within the party were hesitant to comment on how the writing may have been relayed to the publication (in London) from inside prison, they insisted that the words were indeed those of Mr Khan.'

It also said that some observers expressed doubts over whether the article was indeed by Khan, but many noted that the tone and content of the article was consistent with his views.

Earlier, reacting to questions on



Pakistan elections, State Departmen spokesperson Matthew Miller said, we want to see free and fair elections that are conducted in accordance with Pakistan's laws.

"It's not for the United States to dictate to Pakistan how it conducts - the exact specifics of how it conducts its election, but to make clear that we want to see those elections conducted in a free, fair, and peaceful manner that includes freedom of expression, peaceful assembly and association, and ultimately a full, open, reliable, vibrant democratic process," Miller said on Thursday in Washington.

Pak SC reserves verdict in lifetime disqualification case

Pakistan's Supreme Court on Friday reserved its judgment in the hearing of a key case that would settle the issue of lifetime disqualification of some leading politicians, including former prime ministers Nawaz Sharif and Imran Khan.

The verdict is expected to determine once and for all the controversy around the period of disqualification under Article 62(1)(f) of the Constitution and the Elections Act

A 2018 judgment by a five-member bench of the apex court had declared that disqualification under Article 62(1)(f) was for life, but changes made in the Elections Act 2017 on June 26, 2023, by a coalition government led by Pakistan Muslim League-Nawaz (PML-N) restricted it to a five-year term only.

A seven-member bench, headed by Chief Justice Qazi Faez Isa, conducted the hearing on Friday.

During the hearing, the chief justice remarked that the Supreme Court verdict on lifetime disqualification and the amendments to the Elections Act 2017 could not co-exist. He also stated that discrepancies in the apex court's interpretation and the law could result in "confusion" in the upcoming general elections.

At the hearing's conclusion, the

chief justice said a short order would be issued without specifying a time for its announcement.

"We will try to come up with a shorter order as soon as possible. Probably not today, but it will be very soon, God willing," he said.

During the hearing, which spanned several days, the court heard many lawyers, garnering their views on the duration of disqualifi-The remarks made by the chief

justice and some other judges indicated they were not comfortable with the lifelong ban on convicted politicians, the Pakistani media reported.

However, it was not clear if the limit of disqualification should be imposed through a court order or an amendment to the Constitution.

Most of the arguments were in favour of nullifying the concept of the lifelong ban and limiting it to a fiveyear term. However, the chief justice repeatedly said that he also wanted to hear arguments supporting lifelong disqualification and asked lawyers to come forward.

Sharif, former prime minister and also a frontrunner for the fourth term in the February 8 general elections, was disqualified in the Panama Papers case in 2017. His rival Imran Khan, who was disqualified in the Toshakhana corruption case last

year, also was hit by the same law. However, Sharif got a kind of

relief when his party-led government amended the election laws last year to limit the disqualification to five years, which allowed him to file nomination papers for the upcoming elec

The controversy was not over as his candidature has been challenged as the interpretation of Article 62 (1) (f) clashed with the changes made in the Elections Act 2017. The outcome of the hearing would decide the future for both Sharif and Khan, as well as many other politicians. Seventy-four-year-old Sharif's

case was final until the period of disqualification was reduced. However. 1-year-old Khan's disqualification has not attained finality, and his appeal against it is still pending. Incarcerated Khan's nomination

papers for the February 8 general elections were rejected on December 30 based on disqualification due to his conviction in the offence of "moral turpitude" in a corruption case and other reasons, a government official had reasoned.

Earlier, the issue came into the focus of the Supreme Court last month during the hearing of a petition of a politician from Dera Ghazi Khan, Badshah Khan Qaisarani, who was disqualified for producing a fake graduation degree.

Pak Senate passes resolution seeking delay in elections

Dakistan's Senate on Friday approved a reso-I lution seeking a delay in the general election, citing cold weather and security concerns, increasing the political uncertainty ahead of the planned polls on February 8. The resolution, tabled by independent

Senator Dilawar Khan, received overwhelming support in the upper house of Pakistan's Parliament. However, Information Minister Murtaza Solangi and three-time Prime Minister Nawaz Sharif's Pakistan Muslim League-Nawaz (PML-N) party opposed the move.

Senator Khan said that most areas of the country were currently experiencing harsh cold weather, so participation in elections in those areas was unmanageable.

Raising concerns about the security situation, he said the law and order situation was not good and added that politicians were being targeted, including an attack on Jamiat Ulama-e-Islam Fazl (JUI-F) chief Fazlur Rehman.

"Even security forces are being attacked in Balochistan and Khyber Pakhtunkhwa (provinces)," he added.

The resolution was passed with only 14 lawmakers in attendance, according to the Dawn newspaper, despite clear orders by the Supreme Court to the Election Commission of Pakistan (ECP) to stick to its announcement to hold the elections on February 8.

The move by the Senate is expected to increase political and economic instability in the country. The Pakistan Stock Exchange reacted negatively to the resolution, and the share market immediately fell by more than 800 points.

Capitol riot, 3 years later: Hundreds of convictions, yet 1 major mystery unsolved **AP W**ASHINGTON

Members of far-right extremist groups. Former police officers. An Olympic gold medalist swimmer. And active duty US

They are among the hundreds of people who have been convicted in the massive prosecution of the January 6, 2021 riot in the three vears since the stunned nation watched the US Capitol attack unfold on live TV.

Washington's federal courthouse remains flooded with trials, guilty plea hearings and sentencings stemming from what has become the largest criminal investigation in American history. And the hunt for suspects is far from over. "We cannot replace votes and deliberation with violence and intimidation," Matthew Graves, the US attorney for the District of Columbia, told reporters on Thursday.

Authorities are still working to identify more than 80 people wanted for acts of violence at the

Capitol. And they continue to regularly make new arrests, even as some January 6 defendants are being released from prison after

completing their sentences.

The cases are playing out at the same courthouse where Donald Trump is scheduled to stand trial in March in the case accusing the former president of conspiring to overturn his 2020 election loss in the run-up to the Capitol attack.

Here's a look at where the cases against the January 6 defendants stand:

More than 1,230 people have been charged with federal crimes in the riot, ranging from misdemeanour offenses like trespassing to felonies like assaulting police officers and seditious conspiracy. Roughly 730 people have pleaded guilty to charges, while another roughly 170 have been convicted of at least one charge at a trial decided by a judge or a jury, according to an Associated Press database.

Only two defendants have been acquitted of all charges, and those were trials decided by a judge

About 750 people have been sentenced, with almost two-thirds receiving some time behind bars. Prison sentences have ranged from a few days of intermittent confinement to 22 years in prison. The longest sentence was handed down to Enrique Tarrio, the former Proud Boys national chairman who was convicted of seditious conspiracy for what prosecutors described as a plot to stop the trans-fer of power from Trump, a Republican, to Joe Biden, a Democrat.

Many rioters are already out of prison after completing their sentences, including some defendants who engaged in violence. Scott Fairlamb — a New Jersey man who punched a police officer during the riot and was the first January 6 defendant to be sentenced for assaulting law enforcement — was released from Bureau of Prisons' custody in June.

ALL EYES ON THE SUPREME COURT: Defense attorneys and prosecutors are close-

ly watching a case that will soon be heard by the US Supreme Court that could impact hundreds of January 6 defendants. The justices agreed last month to hear one rioter's challenge to prosecutors' use of the charge of obstruction of an official proceeding, which refers to the disruption of Congress' certification of Biden's 2020 presidential

election victory over Trump.

More than 300 January 6 defendants have been charged with the obstruction offense, and so has Trump in the federal case brought by special counsel Jack Smith. Lawyers representing rioters have argued the charge was inappropriately brought against January 6 defendants.

The justices will hear arguments in March or April, with a decision expected by early summer. But their review of the obstruction charge is already having some impact on the January 6 prosecutions. At least two defendants have convinced judges to delay their sentencings until after the Supreme Court rules on the matter.

umn-rimmed courtyards, courts, places of worship, and spacious banquet halls, its floors decorated with patterned mar-

ble and intricate mosaics. The unearthed in the ruins togethbuilding covered a ground area of 15,000 square metres (1,60,000 square feet), a little under the area covered by the US Capitol building.

Shaped like two adjoining, unequally sized, square donuts, the Palace of Aigai was the administrative and spiritual centre of the kingdom. The palace remains and nearby royal tombs are a United Nations World Heritage Site at the area next to the modern village of Vergina. Like a threedimensional jigsaw puzzle, the marble columns were resurrected by fitting pieces of stone

miles) southwest of the port city of Thessaloniki, in northern Greece, Aigai drew international attention in the late 1970s during burial mound excavations in the area of rolling green hills with patches of wild oppies and daffodils.

The late Greek archaeologist Manolis Andronikos led the digs and discovered the royal tombs, recovering a gold casket and other gold artifacts as well as the bones widely believed to belong to Philip II. The discov-

eries revealed the sophistication of the ancient Macedonians who had often been sidelined in historical accounts by attention on Athens.

Angeliki Kottaridi was still an archaeology student at university when she joined the project as a young assistant. She devoted her life's work to the excavations and decades later became the driving force behind the new museum at Aigai, which opened a year ago, and the palace restoration.

She retired on December 31 as head of the region's archaeological service and was

Indian economy outperforming peers: UN

India is projected to grow at 6.2 per cent in 2024, supported by robust domestic demand and strong growth in the manufacturing and services sectors, the United Nations has

The UN World Economic Situation and Prospects (WESP) 2024 report, launched here on Thursday, said that gross domestic product in South Asia is projected to increase by 5.2 per cent in 2024, driven by a robust expansion in India, which remains the fastest-growing large economy in the world.

"Growth in India is projected to reach 6.2 per cent in 2024, slightly lower than the 6.3 per cent estimate for 2023, amid robust domestic demand and strong growth in the manufacturing and services sectors," the report said.

India's GDP is projected to increase to 6.6 per cent in 2025. The report notes that economic growth in India is projected to remain "strong" at 6.2 per cent this year mainly supported by resilient private consumption and strong public investment. While manufacturing and services sectors will continue to support the economy, erratic

rainfall patterns will likely dampen agricultural output, it said. "Indian economy again outperformed its peers, not just this year but the last few years," Chief of the Global Eonomic Division Monitoring Branch, Economic Analysis and Policy Division (UN DESA) Hamid Rashid told reporters

He said that India's economic growth has consistently remained over six per cent and we believe this will continue in 2024 and 2025 as well.'

Rashid noted that although inflation was relatively high for India, it didn't have to raise rates as much and inflation has come down quite a bit.

"That has allowed the government to sustain the fiscal support that it needed," he said adding that "we didn't see significant fiscal adjustments or fiscal retrenchment in India.

"Overall, domestic consumption is growing, household spending has grown, employment situation has improved quite a bit. So we are very optimistic about India's growth outlook in the near term," he said. In response to a question on factors holding back India's economic growth, Director of the Economic Analysis and Policy Division Shantanu Mukherjee

Highlighting risks facing the economy, he said some of those risks are more global in nature.



EV sales in India likely to grow PTI MUMBAI

Electric Vehicle (EV) sales in India is expected to grow at a Compound Annual Growth Rate (CAGR) of 35 per cent with annual volumes likely to touch 27.2 million units by 2032, a report said on Friday.

The report, 'India Electric Vehicle Market Overview 2023', by energy advisory, software and services firm, Customized Energy Solutions, also predicts a recordbreaking sale of 1.7 million units

EV sale in India is projected to touch about 27.2 million units by 2032 and with a CAGR of 35 per cent from 2023-2032 under business-as-usual conditions,

according to the report.
The driving force behind this is a confluence of factors, including the availability of the FAME-II subsidy, which has proven to be a catalyst, with a substantial budget allocation of USD 1.2 billion assigned to subsidise various EV segments, it said.

The central government's commitment to fostering an indigenous EV ecosystem is evident in the approval of a USD 3.5-billion Production-Linked Incentive (PLI) scheme for the manufacturing of automobiles and auto components, thereby nurturing the development of the EV supply chain in the country, as per the report. Besides, state governments are actively supporting the segment through their various respective policies towards EV promotion and and bolstering the manufacturing ecosystem, it stated. States such as Tamil Nadu, Haryana, Andhra Pradesh, and

Uttar Pradesh are leading the charge, providing incentives to encourage both EV and component manufacturing within their borders, it said.

"The confluence of supportive policies, financial incentives, and a burgeoning EV infrastructure lay a robust foundation for the transformative journey ahead," Rahul Walawalkar, Founder and President of India Energy Storage

Alliance and President & MD of Customized Energy Solutions India, said. He, however, added that amid the evolving EV landscape in India, "we see not only challenges but immense opportunities for innovation and growth as well". The challenges include the high cost of EVs, inadequate public charging infrastructure, the necessity for power grid upgrades, and the absence of subsidies in some segments, as per the report.

South African athlete Oscar Pistorius has been released from prison on parole and is now at home, South Africa's Department of Corrections said

The department gave no more details of Pistorius' release. The announcement came at around 8:30 a.M., indicating corrections officials had released the world-famous double-amputee Olympic runner from the Atteridgeville Correctional Center in the South African capital, Pretoria, in the early hours. Pistorius has served nearly nine years of his 13 years and five months murder sentence for killing girlfriend Reeva Steenkamp on Valentine's Day 2013. He was approved for parole in November.

Serious offenders in South Africa are eligible for parole after serving at least half their sen-

The Department of Corrections said in a two-sentence statement announcing Pistorius' release that it was "able to confirm that Oscar Pistorius is a parolee, effectively from 5 January 2024. Reeva? Has Oscar served

He was admitted into the system of Community Corrections and is now at home?

Pistorius was expected to initialv live at his uncle's mansion in he upscale Waterkloof suburb of Pretoria, and a police van was seen parked outside of that

Department of Corrections officials had said Pistorius' release time would not be announced in advance and he would not be paraded" because they hoped to keep him away from the media glare that has trailed him since he shot Steenkamp multiple times through a toilet door at his home in the predawn hours of Feb. 14, 2013.

He will live under strict parole conditions until the remainder of his sentence expires in December 2029.

Steenkamp's mother, June Steenkamp, said in a statement earlier Friday that she had accepted Pistorius' parole as part of South African law. Has there been justice for

Before the killing, Pistorius was held up as an inspiring role model after having had both of his legs amputated below the knee as a baby because of a congenital condition. He became a champion sprinter on his carbon-fiber running blades and

He was accused of being prone to angry outbursts and acting recklessly with guns, while witnesses testified about various altercations he had with others, including an argument in which he allegedly threatened to break a man's legs. Pistorius was first convicted of

After appeals by prosecutors, he was ultimately found guilty of murder and had his sentence increased, although that judgment by the Supreme Court of Appeal still didn't definitively rule that he knew it was Steenkamp behind the toilet door. Pistorius was first sent to prison in 2014, was released on house arrest in 2015 during an appeal and was sent back to prison in 2016. He was initially incarcerated at the maximum security Kgosi Mampuru II Prison in Pretoria but was moved to Atteridgeville early in his sentence because it is better suited

to holding disabled prisoners.

Despite a seven-wicket win at Cape Town to draw their two-match series in South Africa, India were toppled from the top spot in ICC Test rankings by Australia on Friday. Australia's impressive effort to take an unassailable 2-0 lead over Pakistan at home in the on-going three-match series has helped them move up in the rankings. The third match of that rubber is currently underway in Sydney.

"Australia's impressive run at home against Pakistan helped them take the crown of the No. 1 Test team once again, having last held the spot briefly following their WTC Final victory," the ICC stated in a release. In the previous update, India



had more points in their kitty despite being tied with Australia at 118 rating points

leapfrogged by Australia. "With India drawing their the two-Test series against South Africa 1-1 and Australia recording two wins in as many matches against Pakistan, the Pat

Cummins-led side now top the Test rankings," the ICC said. "It's the latest feat in a year full of them for Australia, alongside their ICC World Test Championship Final victory and their ICC Men's Cricket World Cup triumph."

India, however, are placed at the top of the World Test Championship points table following their win at Newlands with 54.16 percentage points from four Tests that include two wins, one loss and a draw.
