Two arrested

A fter arresting two people, the Delhi Police has registered an FIR and formed multiple teams to probe the Rau's coaching centre flooding incident which claimed the lives of three IAS aspirants, who had already cleared their prelims exam and were preparing in the library of the coaching institute for the Mains exams of UPSC. According to the police on Sunday, they have arrested owner Abhishek Gupta and coordinator Deshpal Singh of the Rau's IAS Study Circle and booked them for culpable homicide and under other charges. "Multiple teams have been

formed to investigate the entire incident. We have asked the Delhi Fire Services to provide us report about the building and the basement which was being used as a library but mentioned as 'store room," a senior police officer said.

The officer said the basement was eight-feet below the ground level and more than 18 students

were present in it on Saturday evening when it got flooded after heavy rain. According to sources in the police department, the gate of the basement was closed, but due to high

"The proposed amendment does not require all the residents to obtain the tax clearance certificate," the ministry said in a statement.

As per section 230 of the Income-tax Act, 1961, every person is not required to obtain a tax clearance certificate. Only in the case of certain persons, in respec of whom circumstances exist, which make it necessary to obtain a tax clearance certificate will be required to obtain such a certificate.

Manu first Indian shooter to win medal at Olympics

On July 27 Manu Bhaker had qualified for the final of her event with a score of 580 points, finishing third out of 45 competitors with the topeight going through to Sunday's final.

Bhaker scored 221.7 in the final round in which she fought hard against Korea's Kim Yeji who bagged silver and Jin Ye Oh bagged the gold with a games record of 243.2. Bhaker stated, "I was fighting with all the games I have with all the energy I have. Really grateful that I could win the bronze. I read Bhagwat Gita and always tried to do what I am supposed to do, left everything else to god". "We can't fight destiny," said

Bhaker who appeared in her second Olympic stint. Previously she couldn't make it to the final and registered a bronze in this 2024 Olympic ending a drought in Olympic

At just 22, she made a stunning debut at the International Sport Shooting Federation (ISSF) World Cup in Guadalajara, Mexico, clinching gold in the 10m air pistol final against top competitors like Olympic gold-medalist Anna Korakaki and three-time World Cup medalist Celine Goberville and in her first appearance in

Common Games she clinched gold in 10m air pistol at the age of 16. In 2018, Manu became the first Indian to win a gold medal at the Youth Olympic Games. She has competed in two Olympic Games but faced challenges during her debut in Tokyo three years ago when her malfunctioned in the 1 pistol pistol qualification, preventing her from reaching the finals in both the mixed 10m pistol and 25m pistol events. Despite this setback, Manu is now on a redemption path, earning the distinction of being India's first female

Olympic medalist. achievement, Bhaker has not only inspired millions of young Indians but has also solidified her position as one of the country's brightest shooting stars. Her bronze medal is a testament to her dedication, hard work, and unwavering belief in her

Row as students seek special space for namaz in Kerala college

Nirmala College at Muvattupuzha (established in 1953) in Kerala finds itself in the middle of a new controversy as hundreds of Muslim students in the institution are on a warpath with the college management. On Friday, students under the leadership of SFI (the students' wing of the CPI-M) and Muslim League gheraoed the college principal Father Jestin K Kuriakose, for almost two hours demanding special classrooms/auditoriums for offering namaz.

This is a new development in the history of the 71-year-old college, which was established by the Catholic Church to make higher education accessible to students belonging to the State's high ranges.
"We were taken aback by the action of the students picketing the principal or gheraoing the teachers or management. Till now the Muslim students were making use of the mosques in the neighbourhood for offering Friday prayers. What made them demand for special classrooms or auditoriums remains a mystery," Kuriakose told *The Pioneer* on Sunday.

The demand made by the students has been put up before the college management. "To set apart exclusive prayer auditoriums for students believing in different sects is not an easy task. Though ours is a Christian minority institution, we follow the directives issued by the

This time the Bhopal monsoon entered on 23 June. Since then the rain continues. Due to this, about 60 percent of the rain has occurred in a month itself. The total normal rainfall in Bhopal is 37.6 inches. In comparison, 22.5 inches of water has fallen so far.

Close to the July quota of rain If we look at the data of the last 10 years, this is the lowest rainfall in 10 years. The maximum rainfall of 33.6 inches was recorded in the years 2015 and 2022, while 6.1 inches of rain fell in 2020. This time 13.6 inches of rain has already occurred. An average of 14.4 inches of water falls in Bhopal in July. Now as soon as one inch of rain falls, the quota of July will also be completed.

Police probing the April 24 rape and murder of a 9year-old girl in Madhya Pradesh's Rewa, have found that her teenage brother sexually assaulted her after watching a pornographic video on mobile and then killed her, following which his mother and his two elder sisters helped in the coverup, an official said.

The police cracked the case and detained the victim's 13-year-old brother, their mother and sisters aged 17 and 18 after interrogation of 50 people, intense questioning of the accused persons and on the basis of technical evidence, he said on Saturday. Providing details of the case,

Superintendent of Police Vivek Singh said, "A nine-year-old girl was raped and strangulated to death under Jawa police station limits on April 24, following which the police had registered a case and started a probe.' "The body of the victim was

recovered from the courtyard of her house where she was sleeping at the time of the incident," he added.



Bring back Netaji's remains | Valmiki scam: Is it Nyay to siphon SC/ST money, asks FM from Japan, Modi urged

egendary freedom fighter Legendary incuron. Subhas Chandra Bose's grandnephew Chandra Kumar Bose on Sunday appealed to Prime Minister Narendra Modi to bring back the "mortal remains of Netaji" from Japan's Renkoji temple by August 18.

He also said a final statement should come from the central government on the matter so that "false narratives" about Netaji are laid to rest.

Stating that the NDA-led government took initiative to declassify files related to the freedom fighter, Bose said after the release of all the "10 inquiries — national and international", it is evident that "Netaji perished on August 18, 1945" in an air crash in Taiwan.

"It is therefore imperative that a final statement is made from the Government of India so that false narratives about the liberator of India are laid to rest." Bose wrote in a letter to Modi on Sunday.

"My humble appeal to you is to bring back the mortal remains of Netaji from Renkoji to India by August 18, 2024," he said.

In an interview to PTI Videos, Bose, also a former vice president of the West Bengal BIP, said the declassification process has exposed secret files and "which documents, conclusively establish that Netaji died in this air crash

He said that Netaji wanted to to India after Independence, but could not as he died in the air crash.

"It is highly insulting that Netaji's remains have been kept at the Renkoji temple," Bose said.



"We have been writing to the prime minister for the last three-and-a-half years, that in order to honour the liberator of India, his remains must touch Indian soil," he

Bose maintained that Netaji's daughter Anita Bose Pfaff wants to perform his last rites as per the Hindu tradition. 'I think the Government of

India must respond. If they feel that these remains are not of Netaji, then maintenance should not be provided to keep those at Renkoji. A statement is expected from the prime minister regarding this," he said in the interview. Bose said a few years ago, his family members had visited the Renkoji temple and met the high priest there, who stated that Netaji fought for the freedom of Índia and as such, his remains should be taken to India.

Netaji's grandnephew said the icon's remains should be brought to Delhi and a memorial built to pay homage to the leader.

Judges should use a 'sense of robust common sense' in bail petitions: CJI

hief Justice of India D Y Chandrachud on Sunday said the trial judges prefer playing safe by not granting bail on important issues of crime when it is looked at with a degree of suspicion.

The Chief Justice underlined the need for a 'sense of robust common sense' to look at the nitty-gritty of each case.

"People who should be getting bail in the trial courts and not getting it there, as a result of which, they have to invariably move the high courts. People who should be getting bail in the high courts will not necessarily get it, as a result of which, they have to move to the Supreme Court. This delay

compounds the problem of According to him, all of these those who are facing arbitrary arrests," Justice Chandrachud

He was replying to a question at the end of a keynote address during the '11th Annual Conference of the Berkeley Centre on Comparative and Discrimination. The question was on the arbitrary arrests.

The questioner said we seem to live in a society where one acts first and seeks forgiveness later. This has become particularly true for public authorities acting in a politically motivated manner by detaining activists, academics, journalists and even politicians, including the chief ministers of opposition parties,

actions are taken with deep trust in the face of justice coming very slowly.

In reply, Justice Chandrachud said the Supreme Court has been constantly trying to convey that part of the reason for it is that there is an inherent distrust in the institutions within the country.

'I think it's important that we learn to trust people who may be in a hierarchical legal system, like much below, which are the trial courts. We have to encourage trial courts to be more receptive to the need for accommodating concerns of people who are seeking liberty," the CII said.

"Unfortunately, the problem today is this, that we look at any grant of relief by trial judges with a degree of suspicion. That means that the trial judges increasingly are playing it safe, not granting bail on important issues of serious crimes," he explained.

According to the CJI, judges have to look at the nitty gritties and see the fine prints of each

"You (judges) have to have a sense of robust common sense. Now, unless we, therefore, separate the grains from the chaff in criminal jurisprudence, it's very unlikely that we will have just solutions and to allow for decision makers to separate the grain from the chaff, it's important that we also place a great deal of trust," Justice Chandrachud noted.



Enough is enough

The tragic deaths of three students in basement flooding is a repeat story of administrative apathy and negligence

The incident is both tragic and surreal. It is difficult to comprehend that three students could lose their lives in a coaching centre operated in a basement that gets flooded. In a heartbreaking incident that has once again spotlighted the glaring deficiencies in urban infrastructure and governance, three civil service aspirants tragically lost their lives due to flooding in a basement. This avoidable disaster raises serious questions about official apathy, the flouting of safety norms, and the recurring nature of such incidents. On a fateful evening, heavy rains lashed the city, overwhelming the already inadequate drainage systems. The basement, where the students were studying, was rapidly filled with water. Despite desperate attempts to escape, the rising water levels led to the tragic drowning of the three young lives. The basement, meant for commercial storage, was illegally converted into a coaching centre. With no proper ventilation, emergency exits, or drainage systems, it became a death trap during the downpour. This



incident underscores a stark reality faced by many urban dwellers who are forced to live in substandard and unsafe accommodations due to high real estate costs and inadequate housing policies.

The deaths of these students could have been prevented had there been stricter enforcement of building codes and timely maintenance of drainage systems. However, the incident has laid bare the apathy of the authorities responsible for ensuring the safety and well-being of citizens. Residents in the area had repeatedly complained about the poor drainage and the illegal conversion of basements into living spaces. Despite these warnings, no significant action was taken. The inac-

tion of municipal authorities and the lack of accountability have resulted in yet another tragedy. After the death of three students, it is time for the crocodile tears to flood on the social media. A big section of political class would rather do nothing but just be concerned about such incidents. Indeed it is the nexus between the local politicians, bureaucrats and business owners of dubious credentials to indulge in flouting the norms and make a fast buck. They do not mind playing with the lives of innocent people. The incident is not an isolated one, similar incidents have happened in the past. This is part of a disturbing pattern where safety norms are routinely flouted by the powerful. Illegal constructions, unauthorized conversions, and poor maintenance of infrastructure are rampant in many urban areas including the capital city. Builders and landlords often bypass regulations, compromising the safety of residents for profit. Such incidents are alarmingly frequent, each time highlighting the same issues of poor infrastructure, negligence, and lack of accountability. Despite the public outcry and media attention that follows each tragedy, there seems to be little systemic change. Again, a customary enquiry would be instituted which would give its report when the incident is all but forgotten from the public memory and we as a nation wait for another one to happen.

Honour the unsung heroes of operation Pawan



The lack of public commemoration for the 1,171 soldiers killed in action during Operation Pawan in Sri Lanka highlights a troubling apathy

ndia's future path to greatness shall be marked with supreme sacrifices by its warriors who if confined to the dustbin of state apathy, as reflected by the Government disinclination towards public commemoration of supreme sacrifice by 1171 Indian soldiers KIA during Operation 'Pawan' in Sri Lanka, may adversely impact the national will during inevitable future military confrontations. To recall Operation 'Pawan,' the Indian Peace Keeping Force (IPKF) operation in Sri Lanka, was the largest joint services military operation conducted by India, in the 1971 War. It led to the establishment of

Headquarters IPKF, a Corps-size tri-service organisation with nearly 100,000 troops from the three services under its command. Had the proposed Maritime Theatre Command been in existence, Operation 'Pawan' would have come under its ambit.

The intensity of this 32-monthlong 'politico-military peace keeping' operation, undertaken from 29th of July 1987 to 24th of March 1990, is best gauged from the gallantry awards won and casualties suffered by this force. 1172 Indian soldiers were Killed In Action (KIA), and more than 3500 soldiers suffered grievous injuries. The IPKF was awarded 1 Param Vir Chakra, 6 Maha Vir Chakras, 98 Vir Chakras and scores of other gallantry awards. The ghost of the political failure to see through to the end of its first geopolitical foray in near abroad continues to impact Indian policy establishment even in the present times.

As of now, against the backdrop of a sustained Chinese presence in Sri Lanka, India is struggling to adopt a coherent strategy to deal with the continued intransigence by the Sri Lanka Government to implement the political solution of devolution to the Tamils enshrined in the Indian Sri Lanka Agreement (ISLA) of 29th of July 1987. India is bound to invite hostility from the dominant geopolitical This will mandate it to be prepared for Out-of-area military

operations to secure its econom-

future path to greatness therefore shall be marked with supreme sacrifices by its warriors who if confined to the dustbin of state apathy, as reflected by the Government disinclination towards public commemoration of supreme sacrifice by 1171 Indian soldiers KIA in Sri Lanka, may adversely impact the national will during the inevitable future military confrontations. The Government is very vocal in pronouncing its nationalist credentials but sluggish in putting money into building deterrent capabilities.

Last week's defence budget was a green signal for China to race even further ahead under the illusion there will be no war. Still, policy pronouncements are not enough unless backed by a revitalised and reorganised military competent to safeguard its economic interests, all aspirational talk is mere rhetoric. Building National War Memorials is one thing; honouring the fallen braves appropriately is quite another matter regardless of the outcome because victory or defeat on the battlefield is never complete unless it is surrendered as in 1971.

This is where the IPKF comes into the picture because it was not permitted to complete its military mission. Budget is pro-growth but stability concern remains



Major expenditure items may go out of control, raising concerns about the budget's feasibility; moreover, the Government's gross tax revenue target of Rs 38.40 lakh crore is overly ambitious



n top of a GDP (gross domestic product) growth of 8 per cent plus for three consecutive years, the Union Budget for FY 2024-25 presented by Finance Minister Nirmala Sitharaman on July 23, 2024, has all the ingredients to sustain the momentum during the current year as well. For the current year, she has proposed capital expenditure at Rs 1111,111 crore, which is 17 per cent higher than the revised estimate (RE) for FY 2023-24.In her Budget for 2019-20, she had laid a roadmap for catapulting the Indian economy to US\$5 trillion by 2024-25. In sync with this target, she had projected an investment requirement of over Rs 100 lakh crore to build the infrastructure over five

Out of this, 39 per cent or Rs 39,00,000 crore was to come from the Centre and states each and the balance was Rs 22,00,000 crore from the private sector. The Centre's capital spend during the previous four years was 2020-21: Rs 439,000 crore; 2021-22: Rs 554,000 crore; 2022-23: Rs 750,000 crore; 2023-24: Rs 1000,961 crore. This adds up to Rs 2700,000 crore. Add to tnis Ks 1111,111 crore for 2024-25, the total over five years comes to Rs 3800,000 crore which is more or less close to the amount the Centre intended to contribute. The Central government has also been helping the states to boost their capital spend. During 2022-23, it provided them with 50year Rs 100,000 crore interest-free loans. During 2023-24, such transfers were Rs 130,000 crore. For the current year, the transfers are kept at Rs 150,000 crore.

To promote investment in the private sector, the Centre has reduced the corporate tax rate to 15 per cent for new manufacturing enterprises and 22 per cent for existing enterprises. In this year's budget, the corporate tax rate on foreign firms has been reduced from extant 40 per cent to 35 per cent. rebound in the US economy, India could achieve growth even higher than 6.5 - 7 per cent projected in the Economic Survey for 2023-24. But, there is a flip side to it. is budgeted at Rs 164,000 crore during 2024-25. This is based on the assumption that the declining trend in the international price of fertilizers and raw materials used in their production seen during 2023-24 continues during the current year as well. It takes a small disruption in the global supply chain (given the current highly uncertain geo-political situation, this is quite likely), for this assumption to go haywire. The government will reimburse employers up to Rs. 3000 per month for two years towards EPFO contribution for each additional employee. This Scheme will benefit 50 lakh persons. To make the youth employable, Sitharaman has announced a new centrally spon-sored scheme for skilling in collaboration with States and industry. 2000,000 youth will be skilled over five years under this scheme. One thousand industrial training institutes (ITIs) will be upgraded in the hub and spoke arrangement, with course content aligned to the skill needs of the industry. In agriculture, the measures include initiating 10 million farmers into natural farming in the next two years; releasing 109 climate-resilient new seed varieties across 32 field and horticulture crops in the next 100 days; Jan Samarth-based Kisan Credit Card in five States to give a boost to shrimp farming and export; launch a national cooperation policy; digital public infrastructure (DPI) to create a registry of 60 million farmers with the details of their land over the next three years; developing large-scale vegetable clusters closer to major consumption centres; promoting FPOs, cooperatives and start-ups for vegetable supply chains; pursuing the mission for pulses and oilseeds production etc. All the above announcements sound like the proverbial 'Many a slip between

Cooler weather aids firefighters in battling blaze larger than LA helicopters and numerous air

Forest Ranch (AP): Thousands of firefighters battling a wildfire in Northern California received some help from the weather hours after it exploded in size. scorching an area greater than the size of Los Angeles.

The blaze was one of several tearing through the western United States and Canada, fuelled by wind and heat.

Cooler temperatures and an increase in humidity could help slow the Park Fire, the largest this year in California. Its intensity and dramatic spread led fire officials to make unwelcome comparisons to the monstrous Camp Fire, which burned out of control in nearby Paradise in 2018, killing 85 people and torching 11,000 homes.

Paradise again was near the danger zone on Saturday. The entire town was under an evacuation warning, one of several communities in Butte County. Evacuation orders were also issued in Plumas, Tehama and Shasta counties. An evacuation warning calls for people to prepare to leave and await instruc-

tions, while an evacuation order means to leave immediately. Temperatures are expected to be cooler than average through the middle of next week, but "that doesn't mean that fires that are existing will go away", said Marc Chenard, a meteorologist at the National Weather Service Weather Prediction Centre in

College Park, Maryland. As of Saturday night, the Park Fire had scorched 547 square miles (1,416 square kilome-ters) and destroyed 134 structures since igniting Wednesday, when authorities said a man pushed a burning car into a gully in Chico and then fled. It was 10 per cent contained and moving to the north and east near Chico.

The fire is larger than the city of Los Angeles, which covers about 469 square miles (1,214 square kilometers), and now ranks seventh on the list of the state's top 10 largest wildfires by acreage, Cal Fire said in a social media post.

Nearly 2,500 firefighters were battling the blaze, aided by 16

Jeremy Pierce, a Cal Fire operations section chief, said firefighters were taking advantage of the cooler weather while it lasts: "We're having great success today." Susan Singleton and her husband packed their SUV with clothes, some food and their seven dogs and rushed to evacuate their home this week in Cohasset, a town of about 400 northeast of Chico. They have since learned that their house

burned down. "Everything else we had burned up, but getting them out, getting us out, was my priority, Singleton said on Saturday, standing outside her SUV as her dogs rested. They have all been sleeping in the car outside a Red Cross shelter at a church that does not allow animals, and Singleton, 59, said the next thing is to find a place for her pets to stretch out.

Ukraine strikes oil depot in Russia, Moscow claims new gains

Ukraine on Sunday said it struck an oil depot in southern Russia that supplies the Kremlin's troops as Russian strikes in Ukraine's eastern Donetsk region, where Moscow claimed further gains, left five civilians dead and 15 others wounded.

Ukraine's General Staff said in a statement Kyiv's security services were responsible for a drone strike in Russia's southern Kursk region that morning on an oil depot used to meet the needs of the Russian military, and contains 11 tanks with a total volume of 7,000 cubic metres (about 247,202 cubic feet), adding the attack prompted "powerful explosions and a fire...probably involving containers with oil products".

"The defence forces continue to take all measures to undermine the military and economic potential of the Russian occupiers and force the Russian Federation to stop its armed aggression against Ukraine," the statement said. Earlier on Sunday, Russia's Defence Ministry said seven Ukrainian drones were shot down overnight over Russian territory, while a regional offi-

to the oil depot in the Kursk province. Firefighters were battling the blaze on Sunday morning after three fuel tanks went up in flames, according to acting regional Gov Alexey Smirnov. Smirnov said nobody was hurt.

The Kursk region lies on the border with **Ukraine's Sumy** province where Ukraine has in recent months repeatedly targeted various sites, including oil depots and other military infrastructure, inside Russian territory, with drones and other weapons. Russia may deploy new strike weapons in response to the planned US stationing of longerrange and hypersonic missiles in Germany, Russian President Vladimir Putin said on Sunday. Speaking at a naval parade in Śt Petersburg, Putin vowed "mirror measures" after the US earlier this month announced that it will start deploying the weapons in 2026, to affirm its commitment to NATO and European defence following Moscow's all-out invasion of Ukraine in February 2022.

Lawmakers from 6 countries pressured not to attend conference in Taiwan

Thinese diplomats are pressuring lawmakers from at least six countries not to attend a China-focused summit in Taiwan, participants told The Associated Press.

Politicians in Bolivia, Colombia, Slovakia, North Macedonia, Bosnia and Herzegovina, and one other Asian country that declined to be named, say they are getting texts, calls and urgent requests for meetings that would conflict with their plans to travel to Taiwan, in what they describe as efforts to isolate the self-governed island.

The summit begins Monday and is being held by the Inter-Parliamentary Alliance on China, a group of hundreds of lawmakers from 35 countries concerned about how democracies approach Beijing. The Associated Press spoke to the organizers and three lawmak-

ers, and reviewed texts and emails sent by Chinese diplomats to the lawmakers asking whether they were planning to participate in the summit.

'I'm Wu, from Chinese Embassy," read a message sent to Antonio Miloshoski, a member of parliament in North Macedonia. "We heard that you got an invitation from IPAC, will you attend the Conference which will be held next week in Taiwan?"

In some cases, lawmakers described vague inquiries about their plans to travel to Taiwan. In other cases, the contact was more menacing: One lawmaker told AP that Chinese diplomats messaged the head of her party with a demand to stop

her from going.
"They sent a direct message to the President of my party, to stop me from traveling to Taiwan," said Sanela Klaric, a member of parliament in Bosnia and Herzegovina. "He

showed me the message from them. He said, I will advise you not to go, but I cannot stop you, it's something you have to make a decision

China routinely threatens retaliation against politicians and countries that show support for Taiwan, which has only informal relations with most countries due to Chinese diplomatic pressure. Klaric said the pressure was unpleasant but only steeled her determination to go on the trip "I really am fighting against

countries or societies where the tool to manipulate and control peoples is fear," said Klaric, adding that it reminded her of threats and intimidation she faced while suffering through the Balkans war in the 1990s. "I really hate the feeling when somebody is frightening you.' China vehemently defends its claim to Taiwan, a self-governed island that Beijing views

as its own territory to be

annexed by force if necessary Last week, Beijing criticized Taiwan for its annual Han Kuang military drills, saying that Taiwan's ruling Democratic Progressive Party was "carrying out provocations to seek independence?

Any attempt to whip up tensions and use force to seek independence or reject reunification is doomed to failure," Chinese Foreign Ministry spokesperson Mao Ning told reporters. The Chinese Foreign Ministry did not immediately respond to a request for comment. The Inter-Parliamentary Alliance on China, which aims to coordinate diplomacy in response to perceived threats from Beijing, has long faced pressure from the Chinese government. Some members have been sanctioned by Beijing, and in 2021 the group was targeted by Chinese state-sponsored hackers, according to a U.S. indictment unsealed earlier this year.

Mobile internet restored in B'desh

The mobile internet connection was restored in Bangladesh on Sunday, 10 days after it was restricted by the authorities across the country to stop the spread of fake news on social media amidst the deadly nationwide violence over reforms in the quota system in government

Addressing a press conference here, Minister of State for Information Communication Technology (ICT) Zunaid Ahmed Palak announced that 5GB internet will be given for free to all users for three days after the connection is restored, the Dhaka Tribune newspaper reported

The mobile internet connectivity was restored at around 3:00 pm local time.

Users of Robi, Grameenphone, Banglalink and other operators in Dhaka said they could access the internet through their phones around 3 pm, the

On July 18, the government shut down mobile internet following the escalation of violence across the country. At the time, Palak said the decision was made "in light of the current crisis in the country and to stop the spread of fake news on social media", The Daily Star newspaper reported.

The next day, amid escalating violence, the Department of Disaster Management building was set on fire, adjacent to which was a data centre. While Internet Service Providers Association of Bangladesh (ISPAB) officials said that the fire might cut 30-40 per cent of the bandwidth supply, broadband internet connection for the entire country was disrupted within an hour.

Bangladesh stayed disconnected from both broadband and mobile internet between July 18 and July 23, when broadband internet was restored in However, mobile internet

remained unavailable until Sunday. Regarding access to social

media platforms, Palak said Bangladesh Telecommunication Regulatory Commission (BTRC) has sent letters to authorities of social media platforms, including Facebook, Tiktok and YouTube.

'Their representatives have to come to Dhaka by July 31 to give explanations. Then, after discussing it with them, we will make a decision," he said. The BTRC is responsible for regulating all matters related to telecommunications Bangladesh.

Iran's supreme leader on Sunday formally endorsed Masoud Pezeshkian as president, allowing the reformist politician and heart surgeon to take charge of a country weakened by economic sanctions over its nuclear programme. During an endorsement ceremony, Ayatollah Ali Khamenei urged Pezeshkian to prioritise neighbours, African and Asian nations as well as countries that have "supported and helped" Iran in Tehran's foreign relations policies.

Khamenei criticised European nations for "behaving badly to us" by adopting sanctions, an oil embargo and for calling out alleged human rights abuses. He also condemned Israel for its actions in Gaza in the deaths of children, women and hospitalised people "who did not shoot a single bullet" against Israeli forces

"The Zionist regime is showing

its ugliest face as a war criminal," said Khamenei, accusing Israel of setting a "new record in assassinations" and cruelty. He also denounced the US Congress for allowing Israeli Prime Minister Benjamin Netanyahu to address the legislative body. Speaking at the same ceremo-

ny, Pezeshkian paid homage to Gen. Qassem Soleimani, the architect of Iran's regional military activities, who was killed in ÚS drone attack in 2020. He reiterated his promise to pursue a "constructive and efficient" foreign policy, bolster the rule of law offer equal opportunities to citizens, support families and protect the environment.

In his first official act in office, Pezeshkian appointed Mohammad Reza Aref, 72, as his first vice-president. Aref, who's considered a moderate reformist, held the post between 2001-2005 under former president Mohammad has identified.

Khatami. Aref holds a doctorate in engineering from Stanford University.
Pezeshkian takes over from

his predecessor Ebrahim Raisi whose death in a May helicopter crash that sparked the early election. He will take the oath of office in parliament Tuesday and will have two weeks to form his own cabinet for a vote of confidence in parliament.

The new Iranian president pledged in his election campaign that he would make no radical changes to Iran's Shiite theocracy, embracing Khamenei as the final arbiter in all matters of state. Pezeshkian could bend Iran's foreign policy toward either confrontation or collaboration with the West and faces the constant challenge of hard-liners still pulling the strings in government.

Beijing (AP): Italy's Prime Minister Giorgia Meloni is on an official visit to China this week to try to reset relations as fears of a trade war with the European Union are interwoven with continued interest in attracting Chinese investment in auto manufacturing and other sectors

Meloni met Chinese Premier Li Qiang in the Chinese capital on Sunday ahead of a forum with Italian and Chinese business leaders.

Her five-day visit comes several months after Italy dropped out of China's Belt and Road Initiative, a signature policy of Chinese leader Xi Jinping to build power and transportation infrastructure around the world to stimulate global trade while also deepening China's ties with other nations.

Italy's decision to join in 2019 appeared to be a political coup for China, giving it an inroad into Western Europe and a symbolic boost in a then-raging trade war with the United States. But Italy says the promised economic benefits didn't materialise, and its mem-bership created friction with other Western European governments and the United States. Still, Italy remains keen to pursue an otherwise strong economic relationship with China. Venezuelan poll to have ripple effects throughout Americas

 $P^{\rm olls\ have\ opened\ in}_{\rm Venezuela,\ where\ people}$ are voting Sunday in a presidential election whose outcome will either lead to a seismic shift in politics or extend by six more years the policies that caused the world's worst peacetime economic collapse.

Whether it is President Nicolás Maduro who is chosen, or his main opponent, retired diplomat Edmundo González, the election will have ripple effects throughout the Americas. Government opponents and supporters alike have signalled their interest in joining the exodus of 7.7 million Venezuelans who have already left their homes for opportunities abroad should Maduro win another term.

Polls open at 6 am local time. The number of eligible voters is estimated to be around 17 million. Authorities set Sunday's election to coincide with what would have been the 70th birthday of former President Hugo Chávez, the revered leftist firebrand who died of cancer in 2013, leaving his Bolivarian revolution in the hands of Maduro. But Maduro and his United Socialist Party of Venezuela are more unpopular than ever among many voters who blame his policies for crushing wages, spurring hunger, crippling the oil industry and separating families due to migration.

Maduro, 61, is facing off against an opposition that has managed to line up behind a single candidate after years of intraparty to topple the ruling party.

divisions and election boycotts that torpedoed their ambitions González is representing a coalition of opposition parties after being selected in April as a last-minute stand-in for oppo-

sition powerhouse Maria Corina Machado, who was blocked by the Maduro-controlled Supreme Tribunal of Justice from running for any office for 15 years.

In recent days, Maduro has

crisscrossed Venezuela, inaugurating hospital wards and highways and visiting rural areas where he had not set foot in years. His pitch to voters is one of economic security, which he underscores with stories of entrepreneurship and references to a stable currency exchange and lower inflation rates. The capital, Caracas, saw an increase in commercial activity after the pandemic, bolstering an economy the

Making exaggerated, bogus claims to get refunds punishable offence: I-T Department

The I-T Department has ■ asked income tax return filers to not make bogus claims for expenses, underreport their earnings or exaggerate deductions as this is a punishable offence and causes a delay in issuance of refunds

The ITR filing season for assessment year 2024-25 will end on July 31 for all categories of taxpayers whose accounts are not supposed to be audited.

According to the Income Tax Department and its administrative body Central Board of Direct Taxes (CBDT), over five crore ITRs have been filed, as of July 26. recent communication, the Income Tax Department asked taxpayers to file their returns correctly to get timely refunds. "Refund claims are subject to verification checks, which may cause delays. Accurate filing of ITR leads to quicker processing of refunds. Any discrepancies in the claims made will prompt a request for a revised return (to be filed by the taxpayer)," It cautioned ITR filing

PSU banks may get another 2-year extension to comply with MPS norms

Public sector banks are expected to get another two-year extension to comply with Sebi's minimum public shareholding (MPS) norms, a top Government official has

Out of 12 public sector banks (PSBs), five are yet to comply with MPS norms and the government's holding beyond 75 per cent.

As per the Securities and Exchange Board of India (Sebi), all listed companies must maintain an MPS of 25 per cent.

However, the regulator gave special forbearance to stateowned banks till August 2024 to meet the requirement of 25 per cent MPS.
"We have written to the

Department of Economic Affairs for the extension," Financial Services Secretary Vivek Joshi told PTI in an interview.

Generally, he said, a two-year extension is given and hopefully it should come sooner than later. Five banks have minimum

WTO accepts India, Taipei's request on ICT import duty dispute ruling PTI NEW DELHI

The WTO's dispute settlement body has accepted a request from India and Chinese Taipei not to adopt the ruling against New Delhi's import duties on certain information and technology products till October-end, as both sides are engaged in resolving the matter mutually, an official

The issue came up during a meeting of the dispute settlement body (DSB) in Geneva on July 26.

The DSB agreed to the latest requests from Chinese Taipei and India," the Geneva-based official said.

At the July 26 meeting, India and Chinese Taipei once again requested additional time from the DSB to consider the adoption of the panel rulings in the case initiated by Chinese Taipei regarding India's tariffs on certain high-tech goods.

The two sides had asked that the DSB further delay consideration of the panel reports until October 28, 2024, to help facilitate the resolution of the disputes. The dispute body had earlier

agreed to four previous such requests from India and Chinese Taipei to delay consideration of the reports. As per the rules of the World Trade Organization (WTO), the panel's ruling will have to be adopted by the DSB for implementation within 60 days of the release of the order. However, countries can mutually request the body to delay the adoption of the

ruling. In its report, a dispute panel of the WTO on April 17, 2023, said import duties imposed by India on certain information and technology products violate global trading norms.

US women's Olympic basketball team fine-tunes its defense ahead of first game

One of the challenges that the U.S. Women's basketball team faces at the Paris Olympics with limited practice time is getting everyone on the same page defensively. There's no doubt that all 12

players on the roster can score at will, but it takes time to build the chemistry and trust necessary to be a great defensive team. For now, it's a work in progress,

with the first test coming Monday against Japan.

"We spent a little more time on it," U.S. Coach Cheryl Reeve said before practice Sunday. "Each team that you play poses a different challenge. Certainly Japan, you know plays different than the rest of the group. We have to tweak our scheme a little bit."

Japan plays a style with all five players on the perimeter, which negates a little bit of the Americans' interior advantage. That means that players like Brittney Griner, A'ja Wilson and Breanna Stewart may have to guard more on the outside with no true post player for the Japanese team. "I know I may have to play

outside more defensively and I'm ready for it," Griner said. The two teams met for the gold medal in the Tokyo Games and the Americans came away with a 90-75 victory. Griner finished with 30 points, points, making 14 of her 18 shots. It was the most points ever by a U.S. Player in a gold medal game, surpassing the 29 by Lisa Leslie in 1996

Organizers said they nixed the swimming leg of the triathlon familiarization scheduled for Sunday morning after a meeting about water quality among authorities tasked with carrying out water quality tests. That included representatives of World Triathlon, as well as city and regional authorities. Swimming in the Seine has been banned for over a century in big part due to poor water quality. Organizers have invested \$1.5 billion to prepare the Seine for these Games, and the government has said the river would be clean enough to hold events, including the swimming portion of the triathlon and the marathon swimming

Daily water quality tests in early June indicated unsafe levels of E. Coli bacteria, followed by recent improvements. Parisian Mayor Anne Hidalgo took a famous dip in the river less than two weeks before Olympic events were set to start, fulfilling a promise to show that the long-polluted waterway was clean enough to



host swimming competitions. Heavy rain during the opening ceremony revived concerns over whether the long-polluted waterway will be clean enough to host swimming competitions, since water quality is deeply linked with the weather in the French capital. Since 2015, organizers have invested heavily to prepare the Seine for the Olympics and to ensure Parisians have a cleaner river after the Games. The plan included constructing a giant underground water storage basin in central Paris, renovating sewer infrastructure and upgrading wastewater treatment plants.

Triathleletes have expressed hope that the waters would be clean enough for them to swim

"Hopefully we get to swim, bike and run because I don't swim this much to just run and bike," Spanish triathlete Alberto Gonzalez said.

Australian cyclist undergoes abdominal surgery after fall during Olympic time trial

ustralian cyclist Lucas underwent abdominal surgery overnight at a Paris hospital following a hard crash on rain-slicked time trial on Saturday, the Australian team said.

AusCycling, Australia's cycling governing body, confirmed the procedure early Sunday. No other details were available.

Plapp was among the last riders to start on the 32.4-kilometer (20-mile) course and was laying down a medalworthy ride at the first time check, trailing then-leader and eventual bronze medalist Wout van Aert by just two seconds. But when Plapp reached a technical portion of the course, his bike slid out from under him and he crashed hard onto the pavement.

The crash was not shown on the race broadcast, but AusCycling said Plapp was conscious and moving afterward. He was lifted into the team vehicle and taken to the hospital for precautionary scans, and later he required the abdominal procedure. "Plapp slid under a barrier

fence shortly after passing the first checkpoint approximately 14 kilometers into the 32-kilometer course," AusCycling said. "His parents



and an Australian team doctor were at the hospital with him."

The 23-year-old Plapp, who won bronze at the Tokyo Games as part of the Australian pursuit team, is the reigning national time trial and road race champion. He was supposed to ride alongside Simon Clarke in support of teammate Michael Matthews in the Olympic road race next Saturday.

Remco Evenepoel won the time trial, giving Belgium two riders on the podium, while Filippo Ganna of Italy finished second. But both the women's and men's races were marred by a series of crashes on a course made treacherous

by the rain.

Among those who fell was American rider Dygert, the reigning time trial world champion, who remounted her bike and rallied to finish third behind gold medalist Grace Brown of Australia and Henderson of Britain.

"If we were in Britain, these (conditions) would be absolutely perfect. The roads are better to take corners on. When we're in Spain, France or Italy, I feel like it's a little more icy," said Dygert, who still plans to compete in the road race and team pursuit this Olympics. "But for sure it definitely plays a factor into the race itself.

Due to limited availability of rooms, he had a choice to make: either stay at the Games' Village at the expense of a shooter or stay at a hotel outside. Keeping in mind the best interest of the team, he chose the latter.

Suryakumar is a bowlers' captain, says Axar Patel

rndia all-rounder Axar Patel says new T20I skipper Suryakumar Yadav is a bowlers' captain who allows them the freedom to execute their plans.

The spin all-rounder also said that the team will look to maximise its batting combinations in the ongoing series against Sri Lanka.

Suryakumar and India made a winning start to the threematch series here on Saturday when they crushed hosts Sri Lanka by 43 runs in a high scoring opening T20I.

"I played in the last Australia series with Surya bhai (as captain). I know that he is a bowlers' captain. He gives you free hand (in a way) that you decide first," Axar said at the post-match press conference on Saturday.

"Whenever you get hit, he comes and says that it was a good ball. He keeps giving you inputs. As a player, there is a good bond with him."

Axar recalled the experience of playing under Suryakumar in the five-match T20I series against Australia in India late last year which the hosts won

"As a captain, I have also played with him in the last matches (against Australia) and when I was playing today, I didn't feel



much change," he said.

"In the first three overs when we were going for runs, he was telling me that we can do this or do that and how we can take a wicket. There is no problem if a four or six goes in it. As a bowler, you get confidence from that if the captain is backing you and telling you that you can do

Axar said India's batting lineup in the opening T20I which did not feature Rishabh Pant at the top was formulated with the idea that the team maximises its left and righthand options.

In the last assignment, the T20 World Cup which India won, Pant batted at No 3

whereas on Saturday skipper Suryakumar came out at the coveted spot and the wicketkeeper-batter dropped down to No 4.

"Our team has four lefties and four righties. If there is a leftright combination (in the middle), it becomes very hard for the bowlers to maintain line and

consistently especially with rotations with singles. "Now if there are four lefties,

how can you use them? If you have that chance (to ensure) that there are no two lefties or two righties (in the middle) at the same time.

"If you have that chance, if you have those players in is not much change in the batting, then why not use team's atmosphere," he added.

USA Cricket fulfils critical requirement, appoints **Jonathan as CEO**

USA Cricket has fulfilled one of the two critical requirements to avoid being disqualified as an ICC nations Associate appointing Jonathan Atkieson as its chief executive officer effective August 1.

The USAC was 'put on notice' by the ICC earlier this month for breaching two norms.

While not having a CEO was one, the other was USAC not fulfilling the governance norms which are set by the US Olympic and Paralympic Committee (USOPC).

As per the norm, it is necessary for every sport governing body to earn the National Governing Body (NGB) status which is needed for all sports added in the Los Angeles 2028 Olympic Games.

The International Olympic Committee during its 141st Session and Executive Board meeting in Mumbai last year had given its nod for the inclusion of cricket in the Los Angeles Games.

"UŠA Cricket has announced the appointment of Johnathan

Atkeison as its new CEO, effective August 1st, 2024," the USAC said on its website. Atkeison most recently served as the Chief Operating Officer of USA Rugby. He joins USA Cricket with over 15 years of national governing body experience.

"I'm honoured to join the team at USA Cricket. It's an incredible time for the sport here in the United States with the historic performance of the men's national team in the recent T20 World Cup, the completion of the second season of Major League Cricket, and the first opportunity to showcase cricket in the Olympics here on home soil during the LA28 games," Atkinson said.


