L he National Green Tribunal (NGT) Eastern Zone Bench, Kolkata in its hearing on Tuesday directed the Ganjam Collector to file his personal affidavit within four weeks latest by September 2, showing what action has been taken for removal of the concrete structures standing inside the Tampara lake waters and its conservation area near the district headquarters town of Chhatrapur.

On hearing a petition of the Wildlife Society of Orissa (WSO) versus State of Odisha No 88/2023/EZ and their supplementary affidavit of September 26 along with photographs showing concrete structures and constructions made within Tampara lake, judicial member Justice B Amit Sthalekar and expert member Dr Arun Kumar Verma questioned why have the constructions not been removed, mentioning that the photographs speak for themselves.

The affidavit of the Collector. Ganiam. recorded on Sep-

tuted a committee and its members had visited the site on September 22 and the committee members opined that a detailed analysis on conservation and integrated management plan of Tampara lake for maintaining its water quality and ecology was required. Counsel for the Ministry of

Environment, Forests and Climate Change (MOEF&CC), Government of India Apurba Ghosh had stated citing a letter addressed by the scientist-F dated July 12, 2024, that the proposal for development of tourism infrastructure at Tampara lake has been granted approval by the Union Government's Ministry of Tourism under Swadesh Darshan (Central Scheme) on September 19, 2016.

Ghosh also put in record that a modified DPR (Detailed Project Report) of Coastal Circuit in Odisha under Swadesh Darshan scheme covering Gopalpur, Tampara, Barkul and Satapada was received by the MOEF&CC and the same was being placed before the National Wetland Committee for their inputs under provision to Rule 4(2) of Wetlands (Conservation and Management) Rules 2017. tor to ensure that no illegal constructions will take place or any part of the lake would be encroached or allowed to be encroached.

The petitioner, WSO had mentioned that huge construction works were going on to develop hotels, cottages, resorts and restaurants by the Odisha Tourism Development Corporation (OTDC) within the water area and 50 meters inside the lake. Notably, the 300 hectares lake is a rich source of biodiversity in the area. Both the State Government and District Administration had planned to make it an Eco Tourism Hub in the region.

It is one of the largest freshwater lakes in Odisha, part of Wetland Atlas (2010) under the MOEF&CC and designated Ramsar Site (October 12, 2021). The lake forms part of the Rushikulya basin and just a few kms away from the second largest nesting site of endangered Olive Ridley turtles.

Sponge City concept an answer to BBSR's monsoon woes

hough civilisations have his torically flourished around water bodies, cities today are struggling to deal with water, its presence, absence, and excess. Traffic jams and overflowing roads are visible as problems that demand an immediate response, but they are also symptoms of a wider, interconnected set of issues confronted by our cities. Climate change compels cities to rethink their approach to deal with water in recent years.

The Fifth Assessment Report (2014) of the Intergovernmental Panel on Climate Change projected an increase in extreme weather events, which includes a decrease in the total number of rainy days and an increase in the amount of rainfall received per day. Similarly, urban flooding in Chennai in 2015 was exacerbated by the rampant construction along natural drainage courses such as the Pallikaranai marshlands and the floodplains of the river Adyar, leading to the retention of water meant to be drained out.

In recent years Bhubaneswar received warnings of heavy rain many times, since the Indian Meteorological Department adopted the system decades ago. Since then Odisha State Disaster Management Authority installed a robust

decentralised institutional disaster mitigation system in ground to deal all kinds of response mechanism and moreover, the municipal officials are aware of the locations that are prone to waterlogging as they are required to act, to install pumps in these areas, clean up the choked drains, clear the obstruction over drains etc, as a pre-monsoon precaution. Then it first raises ques-

tions: why does this information that is evidently available not translate into preparatory actions? Extreme rainfall brings a host of problems, and urban residents have to contend not only with the impact of flooding, but the overlapping impacts of flooding and other natural disasters. There have been

shockingly frequent occurrences of water logging in recent years. A question that strikes the mind is why water logging which looks like flooding becomes such a common occurrence?

In recent years, urban flooding has increasingly become an issue of large cities, testing their flood prevention and drainage capabilities. Urban flooding often occurs when rainfall exceeds the city's own drainage capacity, leading to standing water that cannot be drained, causing flooding within the city. According to data, most cities and towns in Odisha suffer flooding

each year, which not only costs lives and damages property, but takes a toll on the environment. The urban flooding problem has grown even more noticeable under the influence of climate change and local weather phenomenon.

As global warming intensifies, global ecosystems are changing, and extreme weather events are becoming more frequent. At the same time, the heat island and rain island effects are becoming increasingly common as urban areas expand. In addition to external factors like frequent heavy rains, the characteristics of the concrete jungle in cities are also one of the main causes of urban flooding.

In pursuit of economic growth, city wetlands, reservoirs, rivers and lakes are filled in for construction. which weakens cities' capabilities to divert excess water. Moreover, urban construction often involves the use of hard surfaces like concrete while neglecting the construction of permeable surfaces, which makes it harder for the ground to absorb rainwater. This leads to increased runoff, inadequate drainage, and a far greater chance of flooding

Specifically, cities like Bhubaneswar, Cuttack, Puri etc lack sufficient drainage channels and do not reserve enough space for rainfall runoff. Due to excessive use of hard surfaces and improper use of land, rainwater cannot be fully absorbed into the soil, causing a large amount of runoff that cannot be effectively drained, thereby producing surface water accumulation.

Further the fragmented management of water resources implemented in Bhubaneswar has not fully utilized the drainage network, resulting in low drainage efficiency. Different types of drainage facilities are managed by different entities, which can easily lead to unclear division of responsibilities and undefined boundaries in the drainage network.

In most cities the management of flood prevention and urban drainage belong to two different departments, one responsible for water resources and another for civic utility infrastructure. Both departments have different requirements and construction standards for urban drainage and flood prevention, which poses a challenge to actually preventing floods. Furthermore, mismatched construction and management of drainage and flood prevention facilities by various transportation departments, such as city roads, highways and railways, do pose challenges.

In addition, the unreasonable planning of urban green spaces also increases the chances of urban flooding. Many green spaces lack facilities to collect and dissipate rainwater from surrounding areas, and some green spaces are even higher than the surrounding ground, causing rainwater to often flow back into the municipal drainage network.

Bhubaneswar today must rethink its approach to water. How can old infrastructure adapt to serve today's needs? Are new technologies the key? Should cities rethink their approach to water financing by fostering public private partnerships? How can cities play a role in reducing water waste turning blue oil into a sustainable opportunity? Bhubaneswar has always been at the forefront of innovation, in setting frameworks that will allow it to become leaders in this field.

Perhaps the idea of Sponge City could be an answer to the above questions. That would control and mitigate flooding, water pollution and water scarcity in urban spaces as water becomes the city's 'most critical resource.' The Sponge City development is new to urban planning in Bhubaneswar that offers a holistic strategy to hopefully improve the ongoing development and urbanisation processes by explicitly considering the urban water cycle.

The key features of the Sponge City concept is to be environmentally adaptive, systematic and comprehensive, and environmentfriendly urban development as systems that absorb, store, infiltrate and purify rainwater. Sponge City aims to promote interactions between socio-economic systems within the cityscape and with the urban water cycle to enhance local urban resilience, particularly in the face of increasingly volatile water related disasters.



near Aaahar Kendra, Bus stand, park, food courts, market places and hospitals.

The city's drainage system was another major point of contention. The meeting underscored the need for improved drainage to prevent waterlogging and flooding during rains. The slow progress in cleaning and maintaining existing drains was heavily criticised.

Poor road conditions and delays in ongoing infrastructure projects were highlighted. The need for timely completion of road repairs and construction was stressed to enhance mobility and reduce public inconvenience.

Health and sanitation concerns were also prominent. The condition and mainte

nance of public toilets were discussed, with calls for renovations and ensuring their usability to meet public health standards.

BeMC meet: Pressing urban issues highlighted

Frustrations with bureaucratic inefficiencies were evident throughout the meeting. Elected representatives accused officials of delaying the implementation of council decisions and losing important files, hindering city development.

A notable decline in public trust towards BeMC was mentioned, attributed to perceived inaction and inefficiency. The meeting underscored the need for better communication and engagement with the community to restore confidence.

Regulation and mainte-

nance of city markets, especially the fish market in Mardaraj and Giri market vending zones, were discussed. The absence of responsible officers during critical times was pointed out as a major issue, affecting market operations.

Problems with vehicle parking and management of municipal vehicles were also addressed. Concerns were raised about unnecessary usage and wastage of resources on nonessential vehicles.

A lack of coordination among municipal departments was highlighted, leading to delays and inefficiencies in executing development projects. The need for a more coordinated approach to urban governance was emphasized.

SC to resume hearing on NEET-UG 2024 petitions

The Supreme Court is sched-L uled to hear on Monday a batch of petitions related to the controversy-ridden medical entrance exam, NEET-UG 2024, which was held on May

The National Testing Agency (NTA) had on Saturday released city- and centre-wise results of the medical entrance exam, which is riddled with accusations of paper leak and inordinate inflation of marks. According to the cause list of July 22 uploaded on the apex court's website, a bench comprising Chief Justice DY Chandrachud and justices J B Pardiwala and Manoj Misra would hear more than 40 pleas, including those filed by the NTA seeking transfer of cases pending against it in various high courts on the NEET-UG row to the Supreme Court to avoid multiplicity of litigations. An analysis of data released by NTA indicated that the candidates who allegedly benefitted from the paper leak and other irregularities did not do well. Some centres, however showed

high concentration of wellperforming students, it

The voluminous data of over 32 lakh candidates from 4,750 centres was not released in a cumulative format but in a drop-down menu for each centre. The data was released on the direction of the Supreme Court which is hearing sever-al petitions over the alleged irregularities as lakhs of aspirants await a final verdict on the fate of the exam.

The performance of the candidates from the centres under the scanner -- such as Oasis School, Hazaribagh, Jharkhand, Hardayal Public School, Jhajjar, Haryana, Jay Jalaram International School in Godhra, Gujarat -- were comparatively much below par.

On July 11, the top court had adjourned till July 18 the hearing on the pleas, including those seeking cancellation of the exam, re-test and probe into alleged malpractices in the conduct of NEET-UG 2024, as the responses of the Centre and the NTA were yet to be received by some parties.

The bench had observed that it had received a status report from the Central Bureau of Investigation on the progress made in the probe.

In an additional affidavit filed in the apex court last week, the Centre said data analysis of the results of NEET-UG 2024 was conducted by IIT-Madras, which found there was no indication of "mass malpractice" or any localised set of candidates scoring abnormally high marks. While hearing the pleas on July 8, the top court had observed that the sanctity of the NEET-UG 2024 has been

"breached". Saying that a re-test may be ordered if the entire process was affected, the bench had sought details from the NTA and the CBI, including the timing and manner of the alleged paper leak, besides the number of wrongdoers to understand the extent of irregularities claimed

by the petitioners. More than 23.33 lakh students had taken the test on May 5 at 4,750 centres in 571 cities, including in 14 cities overseas. The Centre and the NTA, in their earlier affidavits filed in the apex court, had said that scrapping the exam would be "counterproductive" and "seriously jeopardise" lakhs of honest candidates in the absence of any proof of large-scale breach of confidentiality.

SC to hear PIL on electoral bonds

The Supreme Court is scheduled to hear on Monday a pub-lic interest litigation seeking a court-monitored investigation into the electoral bonds scheme. A bench comprising Chief Justice DY Chandrachud and Justices JB Pardiwala and Manoj Misra is likely to hear the PILs filed by NGOs Common Cause and the Centre for Public Interest Litigation (CPIL).

The PIL of the two NGOs alleges an "apparent quid pro quo" between political parties, corporations and investigative agencies.

Terming the electoral bonds scheme a "scam", the plea sought a direction to authorities to investigate the source of funding of "shell companies and loss-making companies which made donations to various political parties, as has been disclosed by the data released by the Election Commission (EC)". The petition has also sought a direction to the authorities to recover the money donated by companies as part of "quid pro quo arrangements where these quo arrangements where these are found to be proceeds of crime". A five-judge Constitution bench had on February 15 scrapped the elec-toral bonds scheme of anony-mous political funding intro-duced by the BIP Government duced by the BJP Government. Following the top court's judgement, the State Bank of India, the authorised financial institution under the scheme, had shared the data with the EC, which later made it public.

The electoral bonds scheme, which was notified by the Government on January 2, 2018, was pitched as an alternative to cash donations made to political parties to bring in transparency in political fund-

ing. Researchers flag tobacco industry's interactive vapes

 $R^{\text{esearchers have red flagged}}_{\text{the tobacco industry's bid to}}$ integrate new electronic cigarette products also known as vapes with interactive features such as touch screens, animated displays, and built-in games to make them appealing to youngsters particularly those tech-savvy.

Published in the journal 'Tobacco Control', the study authored by scientists from the University of California, Riverside, warned that these features could potentially exacerbate nicotine addiction among youth by integrating vaping with gaming behaviors.

The study In their study titled "Pac-Man on a vape: electronic cigarettes that target youth as handheld multimedia and gaming devices", identified several new electronic cigarette models, such as the Craftbox V-Play, which incorporate classic arcade games like Pac-Man and Tetris.

The Bill states that every citizen shall have the right to free internet access and the appropriate Government shall, while ensuring universal access to the internet to all citizens, take special measures to ensure that the citizens who belong to the backward and remote regions of the country are provided equal access to the internet. The Bill seeks to expand the scope of the constitutional right to freedom of speech and expression granted to all citizens of the country by making internet accessible to all for free. Till Saturday night, 76 students who hail from Assam entered from Dawki while another 41 students from Sutarkandi," he said.He also said that students from Barak Valley are mostly coming through Sutarkandi, while those belonging to the Brahmaputra Valley have entered through Dawki.

More students are expected to come in the next few days and



the Assam government has deputed a magistrate and senior police official at Sutarkandi to facilitate their entry into India, Tewari said. "Students from Nepal, Bihar and other states are also coming in. Most of the students belonging to Tripura

Bihar to conduct 'indoor air pollution' study

 $T^{he Bihar State Pollution}_{Control Board (BSPCB)}_{has decided to conduct an}$ "indoor air pollution" study in Patna to identify types of pollutants inside people's homes and their effects, besides suggesting corrective measures.

The study will be first conducted in the capital city and later it will be held in Gaya, Muzaffarpur and a few

other cities of the state. Talking to PTI, Devendra Kumar Shukla, Chairman of the BSPCB, said, "We have initiated talks with the IIT-Tirupati for conducting indoor air pollution study in Patna to identify types of indoor air pollutants, their effects and also suggest corrective measures to reduce it. Our talks with IIT-Tirupati are expected to be finalised very soon."Bihar is probably the first state in India which has decided to conduct an

indoor air pollution study, he said"People must know about the pollution levels inside their homes. The study will be conducted by dividing the city into various zones. A few houses will be selected from each zone for the study using modern techniques," said the BSPCB head.

Air pollution is mostly considered an outdoor concern, but studies suggest that indoor air can be



People are now spending

more time indoors than before with the advent of online learning, entertainment, and shopping, Shukla said.

Since Patna has recently emerged as one of the most polluted cities in the country, the study will begin from there, he added."The ill effects

of indoor air pollution are becoming a serious matter globally. The most affected groups are women and younger children, as they spend the maximum time at home. Indoor air pollutants cause respiratory infections, chronic bronchitis and several other diseases, said Shukla.

Stating that the Indo-Gangetic plains are worst affected due to air pollution, mainly because of dust, he emphasized the need for long-term measures to curb air pollution.

"As for controlling vehicle emissions, there should be a proper traffic system in cities, including Patna, so that there are no bottlenecks that result in snarls which hike pollution," said the BSPCB hike Chairman.



Karnataka HC quashes POCSO case against a man after marriage to victim

The Karnataka High Court has quashed criminal proceedings against a 23-year-old man from Mysuru, who had allegedly sexually assaulted a 18-year-old when she was a minor, following their marriage and production of their marriage certificate.

Justice M Nagaprasanna emphasised that the Protection of Children from Sexual Offences (POCSO) case could be revived if the accused abandons the girl and their child after the case's closure. The court had earlier granted interim bail to the accused to facilitate the marriage with the victim (after she attained the age of 18), requiring him to return to jail with the marriage certificate. The accused complied with it. The court has ruled that

 $T^{he \ monsoon \ session \ of \ the}_{Chhattisgarh} \ legislative$ assembly, scheduled to begin on Monday, is expected to be a stormy affair with the opposition Congress gearing up to corner the ruling BJP on the "deteriorating" law and order situation among other issues. The Congress said it will gherao the state assembly on July 24 to protest against the alleged deteriorating law and order situation, particularly the violence in Balodabazar city last month.Addressing a press conference here, state Congress chief Deepak Baij on Sunday said the last seven months of the Vishnu Deo Sai government saw four

incidents of firing in the state capital, and inter-state gangsters have been spreading tentacles in Chhattisgarh.Baij claimed 300 cases of rape, 80 incidents of gangrapes and more than 200 murders were reported in the state in seven months. "There have been countless incidents of stabbing, looting, robbery and chain-snatching. The BJP has failed to protect the common man," he claimed.While the Congress previous government strengthened the law and order situation in the state, the Sai government has destroyed it in just seven months, he said, accusing the state home minister of making empty statements.

No shortage of coal for power sector: Minister Kishan Reddy

Union Minister G Kishan Reddy said there is "no shortage" of coal for the power sector and the Centre will ensure adequate supply of the dry fuel to meet demand. The long-term demand will be met by increased productivity of Coal India and commercial mines, he said.

"We are supplying coal to all thermal power plants. We have requested plants based on imported coal to switch their technology to utilise domestic fuel. There is no shortage of coal in the country," Reddy, the minister for coal and mines, told PTI. Coal production usually faces hindrances during the

monsoon season.

Some technical issues related to commercial mines were being addressed, he said without divulging the details. Speaking on the power ministry's advisory related to four per cent imported coal blending for domestic blending for domestic thermal plants, the minister said, Coal India is successfully ramping up production but the blending is advised to "mitigate the risk of blackout

due to sudden rise in electricity demand".

Earlier this month, the Nominated Authority of the Coal Ministry held a meeting to review the status of both operational and nonoperational captive and commercial coal mines. During the meeting, the



authority stressed on the need (FY'25)

operationalising coal blocks that are in advanced stages of development. The department appreciated efforts of all allottees in increasing coal production and urged them to achieve the committed output targets for the 2024-25 financial year Last year, these mines

The Ministry of Coal has allocated or auctioned 161 mines with a peak-rated capacity of 575 million tonnes. Of these, 58 have received mine opening permission, and 54 are operational.

produced 147 million tonnes, constituting 15 per cent of the country's total coal production.

In a review meeting held in early June, Reddy stressed on exploration of more blocks for auctions. The government had relaxed

technical eligibility for coal block auctions to attract more participants. It has recently concluded the 10th round of coal block

auctions. The union minister had urged

stakeholders to work all diligently to achieve at least 175 million tonnes of production from captive and commercial coal blocks this year, representing a 19 per cent growth.

As of June 30, 54 captive and said.

commercial coal mines are under production, with 32 allocated to the power sector,

12 to the non-regulated sector and 10 for the sale of coal. The current production from these mines stands at 39.53 million tonnes, registering a strong 35 per cent year-onyear growth.

An additional 11 mines are expected to commence production in FY'25.

Furthermore, 65 non-operational coal blocks are in various stages of obtaining regulatory clearances, distributed across nine states -Arunachal Pradesh, Assam, Chhattisgarh, Gujarat, Jharkhand, Madhya Pradesh, Gujarat, Maharashtra, Odisha, and West Bengal, the ministry

Trouble in Bangladesh

Students rampage in Bangladesh protesting job quota for veterans' families; India calls it an 'internal matter'

D angladesh is going through the worst phase in years as students have taken to the streets protesting the Government's 30 per cent quota for relatives of to the streets protesting the dovernment of opported at 4 a first 105 people including two has been imposed and the army has been deployed after 105 people including two journalists died in the bloodiest protests for a decade. A 'shoot-on-sight' order is also in place giving security forces the authority to fire on mobs, showing the gravity of the situation. Slowly but surely the student protest is turning into an all-out protest against the government as student protesters stormed a prison and freed inmates. The students maintain that job reservation for families of veterans mostly benefits supporters of Hasina, whose Awami League party led the independence movement. Students are struggling in a country where around 32 million young people are neither employed nor in education. Although job opportunities have



increased in certain areas of the private sector, many individuals prefer government jobs due to their perceived stability and better pay. The Government's crackdown on the protesting students has had little effect in controlling the violence. The protests, which began earlier this month, have led to widespread unrest and disruption across the country, leaving many foreign students in precarious situations.

About 15,000 Indians live in Bangladesh, of whom around 8,500 are students. Around 4,000 students are still awaiting their turn to be evacuated. The MEA spokesperson Arindam Bagchi has

confirmed that 1000 Indian students have been safely brought back home. The families are anxiously waiting for the return of stranded students. The Indian High Commission in Dhaka has set up a dedicated helpline to assist students and provide real-time updates on the repatriation process. Students have been advised to stay in touch with the mission and follow its guidance closely. A communication blackout has been in place since Thursday, including the suspension of mobile data and text message services. Besides, the Government's high-handedness in dealing with the protests has only escalated the tension and put the Hasina Government in a bad light. Prime Minister Sheikh Hasina's government is facing one of the most severe challenges of her 15-year tenure. Indeed, it is one of the biggest challenges Sheikh Hasina has faced in years. The student protests are turning into general protests against the government. Sheikh Hasina has appealed to students to wait for the court verdict on the issue but to no avail. India meanwhile has termed the unrest in the neighbourhood as an 'internal matter of Bangladesh' but must be concerned as Sheikh Hasina's Government maintains good relations with India and any disruption may impact Indo-Bangladesh relations.



The evolution of cricket and umpiring

Cricket has undergone significant transformations. The journey includes not only victories but also bloopers and game changing umpiring mistakes RATHORE

he elusive cup reached home amidst thunderous applause and the rapturous welcome of the men in blue. As the euphoria settles and the cricketers (a lot richer) and fans (a lot happier) go home, it is time to look back and think about the evolution of the game and its future direction. As ardent followers of the game, it made us think how far we have come from the age of Maharaja Ranjitsinh ji to Kerry Packer to the glam world of the IPL. The history of cricket can only be complete with the history of bloopers, misjudgements and game-changing (quite literally) umpiring mistakes. The lovehate relationship between the Indian cricket team and umpire Steve Bucknor is well known, particularly in the famous monkey-gate test match. We still remember vividly the anger we felt when Sachin Tendulkar was given out LBW in a controversial decision by Bucknor when India toured down under in 2003. However, we have come a long way since then, thanks to the ever-increasing use of technology. The gentleman's game has a rich history of evolution in its rules and regulations, particularly in umpiring. Initially, cricket matches featured just one umpire, but as the game grew in complexity and intensity, it came the system of having two umpires. The second umpire, positioned at square leg, was introduced to assist with decisions that the main umpire at the bowler's end might miss, such as run-outs and stumping, thereby enhancing the accuracy and fairness of on-field decisions. In the 1990s, the third umpire system, enabled by technology, changed cricket umpir-What the field umpires ing. considered unjudgeable, they could now refer to the third umpire, who in turn can watch theoretically unlimited replays of what transpired before giving a verdict... The Decision Review System (DRS), introduced more recently, further revolutionised strate a compelling need for the game. It allows players to challenge on-field umpire deci-sions, with the third umpire Football referees make instanreviewing the play using various taneous decisions on fouls,

side calls, which are critical for maintaining the flow and fairness of the game. While technology, such as the Video Assistant Referee (VAR), supports these decisions, the subjective nature of many calls-like tackles or handballs-requires the immediate and nuanced judgment of on-field referees. This dynamic is quite similar to cricket, where the on-field umpires' interpretation of situations, like appealing for a catch or judging a no-ball, often involves subjective judgment that technology cannot fully replicate.Despite the evident utility of on-field umpires, modern technology has permeated the game so much that the need for having onfield umpires is becoming questionable.

The advancement of technology in cricket umpiring has undeniably enhanced the accuracy of decisions and the integrity of the game. However, technology cannot replace umpires' human touch throughout the game

by managing player interactions and upholding decorum. However, the current system of having two on-field umpires now brings an element of redundancy.

One on-field umpire renamed as a referee, supported by comprehensive technological systems and a vigilant remote umpire, could suffice. While the remote umpire can pass decisions aided by technology, the referee could help smooth the conduct of the game and ensure that all the rules and spirit of the game are upheld. This would streamline the officiating process and speed up the game.

This hybrid model that combines the strengths of human wisdom with technological aids could offer the best solution, ensuring the game's efficiency and integrity are upheld. Bihar's business boom: A new era of development



As Bihar strengthens its infrastructure and undertakes reforms, it is poised to become a hub of economic activity and innovation

year ago, when the Adani Group decided **A**to invest Rs. 8,700 crore in Bihar, it attracted the attention of investors from all over the country. The bureaucracy of Bihar, supporting the Nitish government, has made development and investment its campaign. Why can't entrepreneurs come here? The credit goes to the officers who returned from central deputation in Delhi. Additionally, Nitish Kumar, the head of the current NDA government in Bihar, strengthened his political connections. In Delhi, many JDU MPs became influential in the power corridors, such as Lallan Singh and Sanjay Jha, whose responsibilities increased. Bihar has successfully convinced the Center, resulting in several policy changes in energy and industry. As a result, Bihar is becoming self-sufficient in energy, a development appreciated in other BJP-ruled states

Similarly, the process of identifying and allocating land for industry has begun, and naturally, investors have started project reconnaissance. This seems to be a turning point.In makhana, potato, and toma-



tourism, officials started working tirelessly to provide important information, and selfie points began to be established at tourist locations. Consequently, groups like Mayfair Hotel opened Bihar's first five-star hotel in Purnia. This new initiative led to proposals worth about Rs.10,000 crores in the field of food processing at the Bihar Investors Meet. However, Bihar's misfortune has been that although proposals came in, investors did not follow through in proportion.

But now, the situation is changing. A cursory glance shows that Bihar is an agriculture-based state. The state's agriculture roadmap discusses processing units for various

crops like fruits, vegetables, grains, and makhana. Especially, products of litchi, mango, guava, banana,

to have been the main focus. Many investors showed interest, but most left projects incomplete. Currently, according to the Chamber, 15 companies are interested in food processing and have expressed a desire to invest about Rs10,304 crores. Companies like Godrej, Foods, Anmol and

Bangladesh's Pride Food are also showing interest. Prime Minister Modi has appointed Bihar's young minister Chirag Paswan and experienced minister Giriraj Singh in these ministries with great expectations. Bhagalpuri silk has now entered the international market for the textile industry in Bihar. Additionally, many units related to handloom and khadi clothes are working on a very small scale in Bihar. Until now, investors were unaware of Bihar's cottage industry potential. The responsibility for expanding this sector lies with senior leader and MSME Minister Jitan Ram Manjhi. The climate here is also suitable for

the textile industry. The government has 44 old proposals regarding textile, leather, and food processing that need

to be brought to Bihar. In the past, many reasons hindered industrial growth in Bihar. Law and order problems were discouraging, but now better electricity and roads are attracting everyone. Today, India is the thirdlargest domestic civil aviation market in the world after China and America. Some states like Bihar lagged in aviation due to political differences, but the Bihar government is now gearing up for aviation infrastructure. In the proposed aviation plan for Bihar, apart from the Greenfield Airport in Bhagalpur and Rajgir, a Flying Training Academy in Begusarai, small cities of Bihar are also included. Existing airstrips in Saharsa, Munger, Birpur, Valmiki Nagar, Chĥapra, Madhubani, Kishanganj, and Dalmianagar will be renovated and upgraded. In the Kosi area, many highway constructions are underway. The day is not far when, Bihar transforms into a developed state but it depends on preferential treatment the state gets in Union Budget.

NARCOTIC HELPLINE LAUNCHED

Madam - On 18th July, the Union Home Minister inaugurated the National Narcotics Helpline, 'MANAS' (Madak Padarth Nishedh Asuchna Kendra). The helpline, accessible through the toll-free number 1933, a web portal, and a mobile app, allows citizens to anonymously report drug trafficking activities. Although 'MANAS' collects personal information, it guarantees that the identity of the informant will be kept confidential.

This anonymous reporting system could be expanded to cover other types of crimes. 'Crime Stoppers', a collaborative effort between police and civil society, enables citizens to anonymously provide information about crimes or suspects via phone calls, online forms, or mobile apps.Many individuals, despite having critical information about crimes, are hesitant to speak directly with the police due to fears of testifying or concerns for their safety. Crime Stoppers ensures the anonymity of those reporting suspected criminal activities. Crime Stoppers helplines do not display caller numbers or trace calls.

Upon receiving a call or a completed anonymous online form, they compile a report that excludes any information that could identify the caller. This report is then forwarded to the relevant authority, such as the police, customs, or the NCB, for further investigation. Founded in the US in 1976 (1-800-222-TIPS), Crime Stoppers has since been adopted in the UK (0800 555 111), Australia (1800 333 000), and South Africa (08600 10111). Since its inception in the UK in 1995, Crime Stoppers has received over 2.2 million actionable calls, leading to the arrest and charging of more than 151,000 individuals and the seizure of illegal drugs worth over £367 million.

According to the recent National Crime Records Bureau (NCRB) Report 2022, released in December 2023, 5,824,946 cognizable crimes were registered in

2022. This includes over 1,200 crimes against women and 445 crimes against children per day. The establishment of an Indian Crime Stoppers initiative is urgently needed.

India's bold climate leadership amidst global heatwave concerns


India stands out as a beacon of hope, demonstrating unwavering commitment through innovative climate initiatives and sustainable practices

his year's record spell of an intense heatwave in Delhi, during which temperatures touched 50°C, highlighted concerns over the adverse effects of climate change globally. India remains a beacon of hope through its actions as part of the global efforts to stem climate change. Through myriad initiatives, the country has demonstrated its unwavering commitment to environmental sustainability. India's journey toward climate action began in 2009 when the country voluntarily pledged to reduce the emissions intensity of its GDP by 20-25% by 2020 compared to 2005 levels. Impressively, India achieved a 24% reduction within the stipulated timeframe. In alignment with the Paris Agreement, India submitted its

Nationally Determined Contributions (NDCs) to the UNFCCC in 2015, setting forth eight ambitious targets for 2021-2030, further reinforcing its commitment to combating climate change. Tree plantation and forest conservation are at the heart of India's environmental efforts. Through programs like the National Mission for Green India and the Compensatory Afforestation Fund

Program further incentivize tree plantation and forest restoration. India's commitment to wetland conservation is equally impressive, with 80 designated Ramsar sites. The Mangrove Initiative for Shoreline Habitats and Tangible Incomes (MISHTI) aims to promote and conserve mangroves, which are vital for carbon storage and marine biodiversity.

The country has implemented the Plastic Waste Management Amendment Rules, 2021, ban-

ning the use of single-use plastics. Renewable energy is another area in which India excels. The National Green Hydrogen Mission, launched in January 2023, aims to position India as a leader in green hydrogen technology. The Initiatives like the Green Credit country ranks fourth globally in renewable energy capacity. India's environmental initiatives extend beyond its borders. The country plays a piv-otal role in global platforms such as the Global Alliance for Circular Economy and Resource Efficiency. India has made notable strides in addressing climate change, earning a commendable 7th place in this year's Climate Change Performance Index (CCPI), up one spot from last year, making it one of the highest performers globally.



India's high ranking in the GHG Emissions and Energy Use categories underscores the country's efforts to manage its environmental impact despite its large population. Notably, India's per capita emissions remain relatively low, aligning with global benchmarks aimed at limiting temperature rise to well below 2°C above the pre-industrial average.

However, the path forward is complex, and critical areas still require focused attention and accelerated action. India continues to rely heavily on coal, oil, and gas to meet its growing energy demands. This dependence is a major contrib-utor to GHG emissions and severe air pollution, especially in urban areas. While there is a slight positive trend in the adoption of renewable energy, the pace of this transition is too slow to meet urgent climate goals.

Despite high marks in emissions and energy use, India receives a medium rating in Climate Policy and Renewable Energy. The country has clear long-term policies focusing on renewable energy, including the domestic manufacturing of renewable energy com- fuels, championed by India

ponents. Yet, the implementation of these policies needs to be more effective.

The COP26 announcement by Prime Minister Modi, setting a net-zero emissions target for 2070, has been criticized by experts for lacking ambition. The call for a faster phase-out of coal, reduced reliance on gas, and a significant expansion of renewable energy is strong

India's heavy reliance on coal presents a significant challenge. Despite high taxes on petrol and diesel, consumption has not decreased. Some experts view these taxes as effective, while others highlight the government's dependence on the revenue they generate. The rephrasing from 'phaseout' to 'phase-down' for fossil

and China at the last COP, was a setback for global climate commitments. Large-scale renewable energy projects in India have also faced criticism for negatively affecting local communities through land grabs and unequal resource distribution. Policies have been largely mitigative rather than transformative, often overlooking adaptation and disaster risk management. There is a growing call for policies that incorporate ecosystem-based solutions and prioritize equity, ensuring that climate actions benefit all segments of society. India needs a more bottom-up approach to policy implementation, incorporating the needs and demands of tribal and rural communities. (The writer is a NCAER fac-

Deadly unrest leaves scores dead

 $B^{\mbox{angladesh}\mbox{s}}_{\mbox{Sunday scaled back a con-}}$ troversial quota system for government job applicants, in a partial victory for student protesters after days of nationwide unrest and deadly clashes between police and demon-strators that have killed scores of people.

Students, frustrated by shortages of good jobs, have been demanding an end to a quota that reserved 30% of government jobs for relatives of veterans who fought in Bangladesh's war of indepen-dence in 1971. The government

previously halted it in 2018 following mass student protests, but in June, Bangladesh's High Court reinstated the quotas and set off a new round of protests.

Ruling on an appeal, the Supreme Court ordered that the veterans' quota be cut to 5%, with 93% of jobs to be allocated on merit. The remaining 2% will be set aside for members of ethnic minorities and transgender and disabled people. The protests have posed the most serious challenge to Bangladesh's government since Prime Minister Sheikh Hasina won a fourth consecutive term in January elections that were boycotted by the main opposition groups. Universities have been closed, the internet has been shut off and the government has ordered people to stay at home

The protests turned deadly on Tuesday, a day after students at Dhaka University began clash-ing with police. Violence continued to escalate as police fired tear gas and rubber bul-lets and hurled smoke grenades to scatter stone-throwing protesters. Bangladeshi authorities haven't shared any official numbers of those killed and injured, but the Daily Prothom Alo newspaper reported

Russia scrambled fighter jets to intercept US bomber planes over Barents Sea

R ussia said Sunday it scrambled fighter jets to intercept two US military long-range bomber aircraft that approached the Russian border over the Barents Sea in the Arctic. "The crews of the Russian fighters identified the aerial target as a pair of US Air Force B-52H strategic bombers," Moscow's defence ministry wrote on the social media platform Telegram, specifying that the planes scrambled were MiG-29 and MiG-31 fighters.

"As the Russian fighters approached, the US strategic bombers turned away from the State Border of the Russian Federation," the ministry said. The US routinely carries out flights over international waters. Moscow has recently responded more aggressively to the exercises, accusing the US

in June of using its reconnaissance drone flights over neutral waters in the Black Sea to help Ukraine strike Russian-occupied Crimea.

Last month, Moscow warned of "direct confrontation" between Russia and NATO, and Russia's defence minister ordered officials to prepare a "response" to US drone flights over the Black Sea, in an apparent warning it may take forceful action to ward off the American reconnaissance aircraft.

Washington and Moscow have clashed before over the issue. In March 2023, a Russian Su-27 fighter jet damaged a US MQ-9 Reaper drone, causing it to crash into the Black Sea. It was the first direct clash between Russian and US forces since the Cold War.

A repeat of such a confrontation could further fuel tensions over the war in Ukraine.

Coventry (England): Since mindfulness it's something you can practice at home for free, it often sounds like the perfect tonic for stress and mental health issues. Mindfulness is a type of Buddhist-based meditation in which you focus on being aware of what you're

sensing, thinking and feeling in the present moment. The first recorded evidence for this, found in India, is over old. The 1,500 years Dharmatrata Meditation Scripture, written by a community of Buddhists, describes various practices and includes reports of symptoms of depression and anxiety that can occur after meditation. It also details cognitive anomalies associated with episodes of psychosis, dissociation and depersonalisation (when people feel the world is 'unreal").

In the past eight years there has been a surge of scientific research in this area. These studies show that adverse effects are not rare. A 2022 study, using a sample of 953 people in the

US who meditated regularly, showed that over 10% of participants experienced adverse effects which had a significant negative impact on their everyday life and lasted for at least one month.

According to a review of over 40 years of research that was published in 2020, the most common adverse effects are anxiety and depression. These are followed by psychotic or delusional symptoms, dissociation or depersonalisation, and fear or terror.

Research also found that adverse effects can happen to people without previous mental health problems, to those who have only had a moderate exposure to meditation and they can lead to long-lasting symptoms.

The western world has also had evidence about these adverse affects for a long time. In 1976, Arnold Lazarus, a key figure in the cognitive-behavioural science movement, said that meditation, when used indiscriminately, could induce "serious

depression, agitation, and even schizophrenic decompensation". There is evidence that mindfulness can benefit people's wellbeing. The problem is that mindfulness coaches, videos, apps and books rarely warn people about the potential adverse effects. Professor of management and

Meditation can even worsen mental health problems

ordained Buddhist teacher Ronald Purser wrote in his 2023 book McMindfulness that mindfulness has become a kind of "capitalist spirituality". In the US alone, meditation is worth US\$2.2 billion (£1.7 billion). And the senior figures in the mindfulness industry should be aware of the problems with meditation.

Jon Kabat-Zinn, a key figure behind the mindfulness movement, admitted in a 2017 interview with the Guardian that "90% of the research [into the positive impacts] is subpar".

In his foreword to the 2015 UK Mindfulness All-Party Parliamentary Report, Jon Kabat-Zinn suggests that

psychiatric problems such as mindfulness meditation can eventually transform "who we are as human beings and individual citizens, as communities and societies, as nations, and as a species".

This religious-like enthusiasm for the power of mindfulness to change not only individual eople but the course of humanity is common among advocates. Even many atheists and agnostics who practice mindfulness believe that this practice has the power to increase peace and compassion in the world.

Media discussion of mindfulness has also been somewhat imbalanced. In 2015, my book with clinical psychologist Catherine Wikholm, Buddha Pill, included a chapter summarising the research on meditation adverse effects. It was widely disseminated by the media, including a New Scientist article, and a BBC Radio 4 documentary.

But there was little media coverage in 2022 of the most expensive study in the history of meditation science (over them. They're usually told to just keep meditating and it will go away

Research about how to safely practice meditation has only recently begun, which means there isn't yet clear advice to give people. There is a wider problem in that meditation deals with unusual states of consciousness and we don't have psychological theories of mind to help us understand these states.

But there are resources people can use to learn about these adverse effects. These include websites produced by meditators who experienced serious adverse effects and academic handbooks with dedicated sections to this topic. In the US there is a clinical service dedicated to people who have experienced acute and long term problems, led by a mindfulness researcher. For now, if meditation is to be used as a wellbeing or therapeutic tool, the public needs to be informed about its potential for (The Conversation) harm.



Hezbollah fires dozens of rockets at Israeli kibbutz

Lebanon's militant Hezbollah Group said that its fighters fired dozens of rockets into northern Israel on Saturday, targeting a kibbutz for the first time in nine months in retaliation for an Israeli drone strike earlier in the day that wounded several people including children. Also Saturday, the militant Palestinian group Hamas said it fired rockets from Lebanon toward an Israeli army post in the northern Israéli village of Shomera in retaliation for the "Zionists massacres" in the Gaza Strip. Hamas has carried out such attacks form Lebanon over the past several months, but they have been rare.

On Saturday night, an Israeli airstrike on the southern coastal village of Adloun hit an arms depot and it was followed by a series of explosions that hit nearby villages with shrapnel, said state-run National News Agency, or NNA. The agency said that three people were slightly wounded in the nearby village of Kharayeb and

hospitalized. The agency didn't give further details about the arms depot, but it was believed to belong to Hezbollah, which has a wide presence in the area. The explosions lasted more than an hour after the airstrike, NNA said. Hezbollah's attack earlier in the day with dozens of Katyusha rockets on the northern Israeli kibbutz of Dafna came few hours after an Israeli drone strike hit a car in the southern

Lebanese village of Burj al-Muluk, and shrapnel from the missile wounded several people who were standing nearby. NNA said that the wounded civilians are Syrian citizens and they included children. The Israeli military said that

about 45 projectiles were detected crossing from Lebanon into northern Israel in three separate barrages. It said that some were intercepted, while others fell in open areas, causing no injuries, but triggering several fires in the Golan

Heights. On Friday, Hezbollah said that it fired rockets at three villages in northern Israel for the first time in retaliation for a strike that killed several people the night before.

Hezbollah began firing rockets shortly after Hamas' Oct. 7 attack on southern Israel, saying it aimed to ease pressure on Gaza. The exchange of fire and airstrikes, which has been limited to a few kilometers or miles on each side of the border, has displaced tens of thousands of people in both countries.On Wednesday, Hezbollah leader Hassan Nasrallah warned that his group would retaliate against Israeli strikes in Lebanon that inflict civilian casualties "by firing rockets and targeting new villages that were not targeted in the past." Since early October, Israeli airstrikes in Lebanon have killed more than 450 people, mostly Hezbollah members,

but also around 90 civilians and noncombatants. On the Israeli side, 21 soldiers and 13 civilians have been killed.

ISRAEL SHOOTS DOWN YEMEN MISSILE

The Israeli military said it intercepted a missile fired from Yemen early Sunday, hours after Israeli warplanes struck several Houthi targets in the Arabian peninsula country. The Israeli airstrikes — in response to a deadly Houthi drone strike on Tel Aviv were the first time Israel is known to have responded to repeated Houthi attacks throughout its nine-month war against Hamas. The burst of violence between the distant enemies has threatened to open a new front as Israel battles a series of Iranian proxies across the region.

The Israeli army late Saturday confirmed the airstrikes in the western Yemeni port city of Hodeidah, a Houthi strong hold.

It said the strikes, carried out by U.S.-made F-15 and F-35 warplanes, were a response to

hundreds of Houthi attacks. Israel, along with the U.S., Britain and other Western allies with forces in the region, have intercepted almost all of the Houthi missiles and drones. But early Friday, a Houthi drone penetrated Israel's air defenses and crashed into Tel Aviv, Israel's commercial and cultural capital, killing one person.

The Israeli military said Saturday's strike, some 1,700 kilometers (over 1,000 miles) from Israel, was among the most complicated and longestdistance operations by its air force. It said it hit the port because the area is used to deliver Iranian arms to Yemen. The Ministry of Health in Sanaa said that 80 people were wounded in a preliminary toll of the strikes in Hodeidah, most of them with severe burns. The Israeli attack unleashed a massive fire in the city's port. "The fire that is burning now in Hodeidah, is seen across the Middle East and the significance is clear," said

Israel's defense minister, Yoav Gallant. He vowed to carry out similar strikes "in any place where it may be required."

The Houthis are among several Iranian-backed groups to have attacked Israel in solidarity with Hamas since the Oct. 7 attack by the Palestinian militant group triggered the ongo-ing Israeli offensive in Gaza. In addition to fighting Hamas, the Israeli military has been engaged in daily clashes with the Hezbollah militant group in Lebanon. These clashes have raised concerns that the fighting could spill over into a full blown war with Lebanon and beyond.

The Hodeidah port is also a gateway for supplies to enter Yemen, which has been engulfed in civil war since 2014, when the Houthis seized much of northern Yemen and forced the internationally recognized government to flee from Sanaa. A Saudi-led coalition intervened the following year in support of government forces, and in time the conflict

turned into a proxy war between Saudi Arabia and Iran. The war has killed more than 150,000 people, including fighters and civilians, and created one of the world's worst humanitarian disasters.

Houthi spokesman Mohammed Abdulsalam post-ed on X that the "blatant Israeli aggression" targeted fuel storage facilities and the province's power station. He said the attacks aim "to increase the suffering of the people and to pressure Yemen to stop supporting Gaza."

Abdulsalam said the attacks will only make Yemen's people and armed forces more determined to support Gaza. "There will be impactful strikes, Mohamed Ali al-Houthi of the Supreme Political Council in Yemen wrote on X.

Secret Service admits denying Trump campaign's security requests

Rehoboth Beach (US) (AP) : The Secret Service now acknowledges it denied some requests by Republican presidential nominee Donald Trump's campaign for increased security at his events in the years before the assassination attempt on him at a

recent rally. In the immediate aftermath of the July 13 attack, the law enforcement agency had denied rejecting such requests. But the Secret Service acknowledged late Saturday, a week after the attempt on Trump's life, that it had turned back some requests to increase security around the former president.

The reversal is likely to be a key focus of a congressional hearing on Monday where Secret Service Director Kimberly Cheatle is expected to appear before lawmakers who have been expressing anger over security lapses that allowed a 20-year-old gunman to climb atop the roof of a nearby build-ing at Trump's rally in Butler, Pennsylvania, and fire his weapon.

Trump was wounded in the right ear, one rallygoer was killed and two others were injured. "The Secret Service has a vast, dynamic, and intricate mission. Every day we work in reat environmen to ensure our protectees are safe and secure across multiple events, travel, and other chal-lenging environments," the agency's chief spokesperson, Anthony Guglielmi, said in a statement released late Saturday to The Washington Post. The newspaper was first to report on the agency's reversal, which it said was based on detailed questions submitted to the agency. "We execute a comprehensive and layered strategy to balance personnel, technology, and specialized operational needs," Guglielmi said. He said the agency will rely on state and local law enforcement departments in some cases where specialized Secret Service units are unavailable. "In some instances where specific Secret Service specialised units or resources were not provided, the agency made modifications to ensure the security of the protectee," Gugliemi said.

When Kimberly Cheatle led the Secret Service's operations to safeguard the American president and other dignitaries, she said she would talk to agents in training about the "awesome responsibility" of their job.

This agency and the Secret Service has a zero fail mission," Cheatle, who is now director of the agency, said in 2021 dur-

ing a Secret Service podcast called "Standing Post." "They have to come in every day pre-pared and ready with their game face on."Now, the Secret Service and its director are under intense scrutiny over that "zero fail" mission following an assassination attempt on former President Donald Trump during a July 13 rally

in Pennsylvania that wounded his ear. Lawmakers and others across the political spectrum are questioning how a gunman could get so close to the Republican presidential nominee when he was supposed to be carefully guarded. Cheatle, who will testify before lawmakers Monday after congressional committees and the Biden administration launched a series of investiga-



tions, told ABC News that the shooting was "unacceptable." When asked who bears the most responsibility, she said ultimately it is the Secret Service that protects the former president.

"The buck stops with me," Cheatle said. "I am the director of the Secret Service." She said she has no plans to resign, and so far she has the administration's backing.

Democratic President Joe Biden appointed Cheatle in August 2022 to take over an agency with a history of scandals, and she worked to bolster diverse hiring, especially of women in the male-dominated service. The second woman to lead the Secret Service,

2021 for a job as a security executive at PepsiCo. Biden brought her back.

Now, she faces her most serious challenge: figuring out what went wrong with the agency's core responsibility to protect presidents and whether she can maintain the support or the job itself — to make changes.

Details are still unfolding about signs of trouble the day of the assassination attempt, including the steps taken by the Secret Service and local authorities to secure a building that the shooter, Thomas Matthew Crooks, climbed within an estimated 147 yards (135 metres) of where Trump was speaking. It is inexcusable." Rep. Brendan Boyle, D-Pa., said in a statement Saturday that "the evidence coming to light has shown unacceptable operational failures" and he would have no confidence in Cheatle's leadership if she were to stay in the

The House Oversight and Accountability Committee subpoenaed Cheatle to appear Monday, and she is expected to be there. After the shooting, Cheatle

and the female Secret Service agents who protected Trump have faced scathing criticism and questions about whether Cheatle lowered hiring standards. Supporters are adamant that has not happened.

"It is disrespectful to the women of the Secret Service of the Department of Homeland Security and to women law enforcement officers around the nation to imply that their gender disgualifies them from service to the nation and their communities," said Kristie Canegallo, Homeland Security's acting deputy secretary. Like many law enforcement agencies, the Secret Service has been wrestling with how to attract and retain agents and officers.

Women account for about 24 per cent of the agency's staff, according to the agency's website. In a May 2023 interview with CBS News, Cheatle said she was conscious of the "need to attract diverse candidates and ensure that we are developing and giving opportunities to everybody in our workforce,

and particularly women." Two years ago, Cheatle took over the agency of 7,800 special agents, uniformed officers and other staffers whose main purpose is protecting presidents, vice presidents, their families, former presidents and others. In announcing her appointment, Biden said

Cheatle had served on his vice presidential detail and called her a "distinguished law enforcement professional with exceptional leadership skills" who had his "complete trust.

Cheatle took the reins from James M. Murray as multiple congressional committees and an internal watchdog investigated missing text messages from when Trump supporters stormed the U.S. Capitol on Jan. 6, 2021. The Secret Service says they were purged during

a technology transition. Going back further, there have been other problems at the Secret Service, including a prostitution scandal before President Barack Obama's trip to Colombia in 2012 and a man who jumped over the White House fence in 2014 and made it into the building. The Homeland Security Department did not make Cheatle available for an interview, but Canegallo defended her work. Canegallo said Cheatle advocated for a law passed this year that authorized overtime pay for Secret Service agents and successfully oversaw nine high-profile events such as political conventions.

He managed to get the mini-mum wage boosted last year and his pension plan approved by congress earlier this year, but he has struggled to persuade legislators to adopt his ideas on labour laws and the health system.



The coalition of political parties that joined Petro's government at the beginning of his term has broken up due to ideological differences. Meanwhile, numerous corruption scandals involving govern-ment ministers and the president's eldest son have decreased Petro's popularity

Leftist parties loyal to the president have their highest number of legislative seats in

Colombia's history, but they lack the 50% majority needed to pass legislation on their own and have been forced to bargain with parties on the centre and the right.

For healthcare, Petro wants a government agency to be in charge of collecting billions of dollars in insurance fees from Colombians, sidelining the private insurance companies that currently manage much of the health system.

For the labour sector, he wants to make it harder for companies to hire workers on temporary contracts and also require employers to pay workers full wages on rest days.

He also proposed Saturday that legislators reduce the work week from 47 hours to 40, arguing that could increase employment and spur productivity.

Trump holds first rally after assassination attempt

Grand Rapids (US)(AP): Donald Trump is holding his first campaign rally since he survived an attempted assassination, returning to the battleground state of Michigan alongside his new running mate."It was exactly one week ago, even to the hour, even to the minute," Trump said, reflecting on the July 13 shooting in Pennsylvania that left him with a bloodied ear, killed one supporter in the crowd and left two others injured.

"I stand before you only by the grace of almighty God," he said, the white gauze on his ear now replaced by a skin-coloured bandage

"I shouldn't be here right now," he went on. "Something very special happened." Trump was joined by Ohio Sen. JD Vance at the pair's first event together since they became the GOP's nominees at the Republican National Convention in Milwaukee.

"I find it hard to believe that a week ago, an assassin tried to take Donald Trump's life, and now we have got a hell of a crowd in Michigan to welcome him back on the campaign trail," Vance said, speaking before Trump's arrival. Michigan is one of the handful of crucial swing states expected to determine the outcome of November's presidential election. Trump narrowly won the state by just over 10,000 votes in 2016, but Democrat Joe Biden flipped it back in 2020, winning by a margin of 154,000 votes on his way to the presidency.

At the rally, Trump talked about the shooting, acting out how he turned his head toward a chart of southern border crossings projected on a giant screen, narrowly dodging the bullet that hit his ear. "I owe immigration my life," he said. "It's true?

Hours before he took the stage, Trump's supporters crowded the streets of downtown Grand Rapids in anticipation of the former president's remarks. Supporters began lining up Friday morning, and by Saturday afternoon, the line stretched close to a mile from the venue's entrance.

Close to an hour before he was set to take the stage, supporters had filled nearly every seat in the 12,000-person Van Andel Arena.

Many were seen wearing shirts featuring the image of Trump, on stage, after he was

shot, pumping his fist in the air after sur viving the shooting, along with the usual red "Make America Great Again" hats.

Mike Gaydos, who travelled from Indiana with his three sons to attend the rally, said he didn't consider himself a "huge" Trump supporter in the past but wanted to show support for him following the attempted assassination.

Numerous streets, closed as an additional security precaution, were dotted with vendors selling food and apparel.

Downtown Grand Rapids also saw a sig nificant police presence, with officers stationed on nearly every block, while others patrolled on horseback and bicycles. The heightened security outside the venue created a tense environment, with some attendees mentioning that drones overhead had made them nervous.

Attendees were required to pass through a metal detector upon entering the downtown Grand Rapids indoor arena, yet the presence of security inside appeared consistent with previous events.

This is the tightest I've ever seen the security," said Renee White, who said that she's been to 33 of Trump's rallies.



Sitharaman set to make history with 7th consecutive Budget

"In line with our strategy of category development, we have made significant have made investments in advertising. We were the fifth largest advertiser in India in 2023, from being number 17 in 2021. We are adding to this e are autorio investments in GCPL with distribution," GCPL Managing Director and CEO Sudhir Sitapati said.

GCPL's spending on 'Advertising and Publicity' was Rs 1,011 crore for the financial year ended March 2024. This was 47 per cent higher than Rs 687.34 crore a

year before. In India, we are now spending over Rs 1,000 crore in advertising, from Rs 350-400 crore a few years ago, a significant increase. We realised that our categories were being run differently across the world, advertising across the world, advertising agencies were different, production was being done differently," he said.

The company owns popular brands like Cinthol, Godrej No 1, HITS and Good Knight. "From multiple agencies, we moved to a single agency, which is our in-house agency, the LightBox," Sitapati said, adding that "from multiple" rationalisation strategy across

HOW TO TWEAK LIQUOR OUTLETS' CLOSING TIME TO CURB BINGE DRINKING?

This article aims to explore a relationship between the closing time of liquor outlets and binge drinking behavior, hints at how the relationship functions as a socially sanctioned dark pattern, and suggests a design intervention to reduce the effect.

Assuming the current closing time is 11 pm, liquor outlets can be shut in a staggered manner i.e. 40% of outlets close at 10 pm, another 40% at 11 pm, and the last 20% at 12 midnight. The day's closing time for each outlet is decided by a daily lottery and revealed to dealers by Excise authorities only fifteen minutes before closing i.e. at 9:45 pm, 10:45 pm, and 11:45 pm, respectively. Α randomization will ensure that no particular store would complain of lower revenue. The second sludging method would be to ration the alcohol that can be sold to last-minute consumers (who assemble even at these arbitrary closing times) to just a 'quarter' i.e. 180 ml, to

inge termed preventable public health problem by the US Centers for Disease Control and Prevention (CDC), refers to the consumption of an excessive amount of alcohol in a short time. The US National Institute on Alcohol Abuse and Alcoholism quantifies the pattern as four and five or more drinks - each standard drink is defined as containing 14 grams of pure alcohol - in about two hours for women and men, respectively. Though binge drinkers are not dependent on alcohol, the practice is harmful in its being associated with outcomes like vehicle crashes, intimate partner violence, sexual abuse, besides heart and liver disease, among others. The newest recommendations from Canada's healthcare regulator permit no more than two drinks per week thus ruling out the office worker's weekly binge drink. In 2019, the economic burden of alcohol, on India, due to illness and productivity loss was estimated at 1.5% of GDP per year, right until 2050. As per India's National Family Health Survey 5 (NFHS-5) conducted between 2019 and 2021, alcohol consumption of men aged between 15-54 years declined by 6.1% compared to NFHS-4 in 2015-16, and that of women in the same age bracket stayed put. However, the sales of alcoholic beverages in India many to believe that

Alcohol bought from packaged liquor outlets during the COVID-19 lockdowns is now suspected to be the reason behind a fifth of the UK population staring at the risk of alcohol dependency. But, it is also the case that restrictions do not necessarily work. In Russia, truncated trading hours led to decreased consumption of factorymade vodka and its partial substitution by samagon (homemade vodka) by the people most exposed to the curbs. In India, the motives behind changing liquor sales hours can be quite unrelated to the risk of crime or alcohol dependence. Governments in Delhi or Uttar Pradesh, among others, have often extended sale timings for reasons

To simplify the problem, we will confine the discussion to a) liquor outlets selling alcohol to binge drinkers and b) only for takeaway. Perhaps the most notable example of this pattern of consumption, dubbed the 'Six o'clock Swill', is from the early 20th century when New Zealand and Australia shut their bars at 6 pm causing drinkers who finished work at 5 pm to rush and get drunk in the remaining hour. This influence has been linked intergenerationally to high per-capita consumption in these countries even to this day. As India formalizes its business and digitizes all its transactions, especially in urbanized pockets, it will also find ways to monitor all liquor sales in real time, including sales of packages beyond certain sizes. In any case, liquor sales contribute significantly to state governments' revenue and therefore the capacity to regulate them (via such sludge interventions) does exist. State Governments may also save in the longterm as their bills of healthcare burden from alcoholism, law enforcement, and the social costs of problem drinking get dialed down. As is true for most interventions, ours may also be circumvented. At his peak, he was ranked No.18 in the world in singles and No. 23 in doubles. He along with Richard Evans was inducted into the Hall of fame in the 'Contributor Category'.
