

New Criminal Laws kick in

Ending colonial era laws from Monday, three new laws— Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Act (BSA) — will come into effect across the country, replacing the British era Indian Penal Code, Code of Criminal Procedure and the Indian Evidence Act, respectively.

The new laws will bring in a modern justice system, incorporating provisions such FIR, Zero online police registration of complaints, summonses through electronic modes such as SMS and mandatory videography of crime scenes for all heinous crimes. The new laws in India marks

crimes against children, and the placing women, nation at the forefront. This is in stark contrast to colonial era laws, where concerns like treason and treasury offenses outweighed the needs of ordinary citizens.

The Government has held regular meetings with States and Union Territories and they are fully geared up in terms of technology, capacity building and awareness generation to implement the new criminal laws. BNS has 358 sections (instead

of 511 sections in the IPC). A total of 20 new crimes have been added and the imprisonment sentence has been increased for 33 of them. The amount of the fine has been increased in 83 crimes and mandatory minimum punishment has

a significant shift in priorities, been introduced in 23 crimes.

The penalty of community service has been introduced for six crimes and 19 sections have been repealed removed from the bill. BNSS has 531 sections (in

place of 484 sections of CrPC). A total of 177 provisions have been changed in the bill, and nine new sections as well as 39 new sub-sections have been added to it. The new act has added 44 new provisions and clarifications. Timelines have been added to 35 sections and audio-video provision has been added at 35 places. A

total of 14 sections have been repealed and removed. BSA has 170 provisions (instead of the original 167 provisions, and a total of 24 provisions have been changed.

The new laws have also prioritised the investigations for offences against women and children, ensuring timely completion within two months of recording information. In the new criminal laws, it has become mandatory for forensic experts to visit crime scenes for serious offences and

collect evidence. Summons can now be served electronically, expediting legal processes, reducing paperwork, and ensuring communication efficient between all parties involved. Continued on Page 8

Prime Minister Narendra Modi resumed his monthly radio programme "Mann ki Baat" on Sunday thanking the countrymen for their unwavering faith in the Constitution and the democratic system and participating in the Lok Sabha election 2024 in which over 65 crore of them voted. The radio programme of Modi had been paused since the last broadcast on February 25 due to the elections.

Addressing the nation in his first Mann Ki Baat programme after assuming office for a third term, PM Modi expressed that he missed the conversation with the public since the broadcast. He February thanked people and congratulated the Election Commission and every

person associated with the process as he touched on a host of issues in his 30-

minute radio address. The Prime Minister also The Prime Minister also cheered Indian athletes who will be competing in the Paris Olympics starting next month, and urged people to use "cheer4Bharat" hashtag to motivate them. He said the performance of Indian players in the previous Olympics in Tokyo had won the hearts of every citizen, and the participating athletes have been since wholeheartedly engaged in the preparations for the Paris Olympics. "If we take all the players together, then all of them have participated in nearly

900 international competitions. This is a very big number," he said, adding that Indians will get to witness certain things for the first time.

Manoj Kumar Singh takes over as UP Chief Secy

Manoj Kumar Singh, an Indian Administrative Services (IAS) officer of the 1988 batch of Uttar Pradesh cadre, has taken over as the new chief secretary of the state.

He has succeeded Durga Shanker Mishra, a 1984 batch officer of the same cadre. Singh will also continue as Infrastructure and Industrial Development Commissioner.

Durga Shanker Mishra, then posted as secretary, housing and urban development, at the Centre, was repatriated to his home state on December 29, 2021, only two days before his retirement, and was posted as the chief secretary of Uttar Pradesh. Mishra's appointment as the chief secretary on the cusp of retirement came as a big surprise to many as it was believed to be the first case of its kind in the country. Later he was given another one-year extension by the Centre in December 2022. As his tenure was about to end in December 2023, he was granted a six-month extension citing the Lok Sabha elections.

However, this time, Mishra was not given a fourth extension, and the government has now entrusted the responsibility of chief sec-retary to Manoj Kumar Singh. Originally from Ranchi, the capital of Jharkhand, Manoj Kumar Singh is considered one of the most influential bureaucrats in



the state. He currently oversees several important departments. As additional chief secretary, he has held responsibilities of Panchayati Raj and Horticulture and Food Processing departments, playing a key role in implementing numerous govern-ment schemes. Manoj Kumar Singh is due to retire in July 2025. Manoj Kumar Singh currently holds two key positions as the agriculture production commis-sioner and the infrastructure and industrial development commissioner of the state. In addition to these roles, he is also serving in senior capacities as the additional chief secretary of Panchayati Raj and Food Processing departments, as well as the chairman of UPDA, UPSHA and PICUP, all of which

During the COVID-19 period, Singh was initially part of Team 11 and later Team 9, where he played a significant role in controlling the spread of COVID-19 in rural areas.

Parliament is set to witness heated debates on a range of issues like the NEET paper leak row, the Agnipath initiative and inflation when both the Houses reconvene on Monday. Besides the paper leak matter, the Opposition parties under the INDIA Bloc are also likely to raise the issue of unemployment and the alleged misuse of probing agencies by the NDA Government when Parliament is scheduled to take the debate on the Motion of Thanks of President's Address. The Lok Sabha has allocated 16 hours for the debate on the Motion of Thanks, which will conclude with the reply by Prime

Minister Narendra Modi on Tuesday. In the Rajya Sabha, 21 hours have been set aside for the debate and the Prime Minister is likely to reply on Wednesday. Opposition INDIA Bloc members forced adjournment in Lok Sabha when the House was to take up the debate on the Motion of Thanks on the President's Address, demanding a dedicated discussion on the NEET issue. AAP Rajya Sabha MP Sanjay

Singh on Sunday announced that leaders of the INDIA bloc will protest in the Parliament complex on Monday morning against the BJP and Prime Minister Narendra Modi's alleged misuse of the CBI and the ED to target Opposition leaders.

"The BJP-led Central Government

and its prime investigating agencies are misusing power. Modi is targeting Opposition parties and filing fake cases. The CBI and the ED have filed false cases and investigations against every Opposition leader, from senior Congress leaders Sonia Gandhi and Rahul Gandhi to Mamata Banerjee to DMK leaders. They have arrested Delhi Chief Minister Arvind Kejriwal and Jharkhand Chief Minister Hemant Soren. The ED and the CBI will go against whoever speaks against and does not join the BJP," Singh said at a press conference on Sunday.

NEET-UG was conducted by the NTA on May 5 with around 24 lakh candidates appearing. The results were announced on June 4, but they were followed by allegations of question paper leaks in States such as Bihar, besides other irregularities.

BJP member and former Union Minister Anurag Thakur is set to initiate the debate on the Motion of Thanks on the President's Address which is to be seconded by first term Lok Sabha member Bansuri Swaraj, the daughter of BJP stalwart late Sushma Swaraj. The debate has already been

initiated in the Rajya Sabha by member Sudhanshu Trivedi on Friday but could not proceed due

He said the response from the customers was overwhelming and the women make Rs 30 for every umbrella crafted by them.

The Karthumbi brand of umbrella has become a status symbol for the fashion

conscious women of the State and many parts of the country. "I make 10 to 20 umbrellas per day and the work is done after completing my other works like the employment guarantee programe. It has helped me to employment buy a scooty too," said Lakshmi Unnikrishnan, a homemaker belonging to

Mudugar tribals. Prasad said at the time of launching Karthumbi umbrellas, they used to pay each woman Rs 50 per umbrella. "The Covid 19 pandemic, and the deluge literally put an end to our business. But the determination of the women workers from the tribal communities helped us to sustain the venture.

Avalanche hits Gandhi Sarovar near Kedarnath

 $A_{\mathrm{Gandhi}}^{\mathrm{massive}}$ avalanche hit the four kilometre above the Kedarnath Dham in Uttarakhand early Sunday morning. This avalanche that occurred near the Chorabari glacier fell into the valley in the same area but there was

no loss of life or property. Devotees who went to visit the Kedarnath temple this morning captured the natural phenomenon, which occurred around 5 am, on their mobile phones.

A huge cloud of snow was seen sliding down with speed the venture. and stopped after falling into a deep ravine. The avalanche

occurred in the upper region of the Gandhi Sarovar in Chorabari glacier, below the snow-covered Meru-Sumeru mountain range located at the

upper end of Kedarnath valley.

Rudraprayag District Disaster Management Officer Nandan Singh Rajwar said there was no loss of life or property due to the avalanche. The entire area, including the Kedarnath valley, is safe, Rajwar said. Gopal Singh Rauthan, an employee of Garhwal Mandal Development Corporation, was present in the temple when the avalanche occurred. There was a lot of curiosity among the devotees who saw this natural phenomenon for about five minutes. Another avalanche occurred in the Chorabari glacier on June 8, Rauthan said.

FIRE ERUPTS IN FLAT

There will be a demand to stop the implemen-tation of these laws and to reintroduce them in Parliament for proper examination and deliberations. These were passed hastily while 146 opposition MPs were under suspension," he said. The CPI-ML leader said that in order

to beautify and build a riverfront in Akbarnagar, Lucknow, the administration bulldozed the homes of poor families who had been living on the banks of the river Kukrail for decades. "The houses of about 1,200 families were demolished in Akbarnagar, and now the administration is set to remove other settlements of the poor in Lucknow including Abrarnagar, Khurramnagar. Not only in Lucknow, eviction of poor farmers and small businessmen is taking place in other dis-tricts, including Ayodhya," he said.

He said by staging the protest, the party would ask the government to stop the eviction of the poor, stop the oppressive bulldozer rule, regularise the settlements of the poor, provide free houses and civic amenities along with adequate compensation to the displaced people of Akbarnagar.

"I have worked mostly in the rural areas and I feel good that I am able to take care of the health of poor and helpless patients. "Most women have to face diseases. Due to hesitation, they are not able to share their problems with anyone else. In such a situation, I consider myself very fortunate. After completing her duty, she spends all her time with the family", she said, adding that whether it is home or hospital, she fulfils her responsibilities with full honesty and energy. Superintendent of Urban Community Health Centre Durgakund Dr Sarika Rai said that after completing MBBS she

was selected in the PMS in the year 2007. "In 2008, I was made in charge of the Durgakund Health Centre, then it was a maternity centre. After this, gradually the number of patients increased and facilities were also increased. Now this centre has become the First Referral Centre (FRU), where services of surgery along with delivery are being provided", she said, adding that till now she has done more than 500 cesarean deliveries and more than 10,000 sterilisations. Parliament should pass law on quota to exceed 50 per cent cap: Congress

ongress on Sunday said Parliament should pass a law to enable reservations to exceed the 50-per cent cap, a day after NDA constituent JD (U) demanded that the quota increase in Bihar be included in the 9th schedule of the Constitution.

At a meeting of the Janata Dal-United's national executive here on Saturday, the party expressed concern over a recent Patna High Court verdict strik-ing down the Bihar government's decision to increase the quota for the Scheduled Castes (SCs), Scheduled Tribes (STs) and Other Backward Classes (OBC) to 65 per cent from 50 per cent.

In a political resolution passed at the meet, the JD(U) urged the BJP-led Centre to put the state's law under the Constitution's 9th Schedule to rule out its judicial review.

Congress chief spokesman

More tribals opting for Govt hospitals over traditional healers, reveals study

A s India targets malaria elim-ination by 2030, a study from Northeastern Meghalaya indicates a positive trend: tribal communities increasingly seek treatment at government hospitals instead of traditional healers. This shift, partly due to the belief that timely and effective malaria treatment is available in the public health system, reflects significant progress in the country's malaria control efforts, according to the study published in the journal Malaria.

"By recognising these evolving attitudes, policymakers and healthcare providers can better tailor their interventions and communication strategies to more effectively address ongoing needs and concerns as India faces the 'last mile' in malaria elimination," the researchers noted.Malaria in India is predominantly concentrated in the eastern and central parts of the country, particularly in forested and hilly states with tribal pulations and limited healt

Researchers examined community preferences for treatment and the use of healthcare services, such as visiting public or private health facilities or seeking care from traditional healers.

The study found growing acceptance of public health providers, with the majority of participants preferring public healthcare institutions like PHCs for malaria treatment, citing affordability and the availability of free services. In the three districts, participants and healthcare providers noted that frontline alth workers were

equipped with basic rapid diag-nostic tests (RDT) for malaria, allowing for prompt identification and timely referral for appropriate treatment. This improved outcomes and reduced the risk of complications.

In the SGH district, community members reported a significant decline in seeking traditional healers for malaria treatment due to increased awareness of diagnostic tests, treatments, and services available at PHCs or hospitals. The availability of diagnostic tools used by village ASHA and ANM workers at health sub-centres also encouraged villagers to seek help from these healthcare providers.

Navy Chief ends Bangladesh visit, eyes new avenues



The new team is woefully short of bench strength and faces a serious quality issue, with some members lacking commitment and motivation to the cause. Despite this, they have come out, much like the Aussies always do in any competition, riding their luck on abrasive aggression, hype and self-belief. It is certainly a technique that has worked well for them against most oppositions, forcing them on the back foot from which they seldom recover. But as we have just witnessed in the ongoing T-20 World Championships with their unexpected departure, bluster doesn't cut much ice with teams that are determined to win and unafraid of battle. Perhaps Team Modi would do well to keep this in mind.The truth is Team Modi is on a very sticky wicket, not unlike those in the Caribbean, with uneven bounce and unpredictable turns. Not surprisingly, they are already three down with not much to show on the board. s per recent research and studies, younger employees are report-A around 85% of the working parents in the creative, marketing and ing more struggles at work while older ones are doing better. Also, related industries feel pressure to prioritize work over parenting duties while a greater proportion also feels they must sacrifice family life to achieve their career goals. An individual at the workplace often comes across situations where they have too many tasks that need to be completed within a limited timeframe without adequate breaks or rest periods. Moreover, not receiving sufficient recognition or rewards for hard work or perceived unfair treatment or favoritism creates a stressful and demoralizing work environment making it difficult to make decisions and remember tasks which can lead to anxiety and cause stress due to a variety of psychological, physiological and situational factors. When an individual experiences work pressure, it triggers the body's stress response, known as the fight or flight response which releases stress hormones like cortisol and adrenaline, which prepare the body to deal with perceived threats. While this response can be beneficial in short bursts, prolonged activation can have negative effects on both physical and mental health resulting in increased heart rates, headaches and fatigue. Also, constant pressure can impair cognitive functions, making it difficult to concentrate, make decisions and remember tasks, which further increases stress.

There is no denying the fact that work pressure is a natural part of most jobs and can sometimes act as a motivator (such as when prompting a student to study before an important exam), helping individuals stay focused and productive but when the pressure becomes excessive or prolonged, it leads to stress, strain, nervous tension or anxiety. Maintaining a healthy balance between pressure and stress at the workplace is crucial for both productivity as well as employee well-being. Organizations must work towards setting clear communication and expectations by ensuring that job roles and responsibilities are clearly defined and communicated; an environment where managers are approachable and available to support their teams are well created and the distribution of the



tasks and responsibilities are even to avoid overburdening of any single employee. Introducing wellness programs such as yoga, meditation or fitness classes along with access to counseling and support services for employees dealing with stress, regularly acknowledging and rewarding employees for their hard work and contributions, and promoting teamwork and collaboration to create a supportive and cohesive work environment, creating a feedback loop where employees can voice concerns about their workload and suggest improvements, implementing strict antiharassment policies and ensure they are enforced are a few strategies that can help organizations create a work environment where pressure serves as a motivator rather than a stressor. Apart from organizations working towards employee well-being, it becomes crucial for the individual working at any level to maintain a balance between work pressure and family stress as it can be challenging to maintain overall well-being. Prioritizing what is most important both at work and at home, defining clear boundaries between work and family time focusing on high-priority tasks and letting go of less critical ones, maintaining a healthy lifestyle, engaging in hobbies and activities that are outside of work and staying updated on stress management techniques are a few strategies that can help an individual build resilience and manage work stress more effectively. Remember, when stressed, individuals have a more difficult time creating short-term memories and turning those short-term memories into long-term memories. By understanding the causes of work pressure and implementing effective strategies to manage it, individuals and organizations can reduce stress and create a healthier, more productive work environment. India first in world to compile checklist of its entire fauna

PNS NEW DELHI

India has compiled a India has compiled a comprehensive checklist of its entire fauna, encompassing 1,04,561 species, making it the first country in the world to achieve this milestone. This is available on the "Fauna of India Checklist Portal" which was launched on the 109th Foundation Day of the Zoological Survey of India (ZSI) in Kolkata on Sunday by Union Environment Minister Bhupender Yadav. On the occasion, he emphasised that this first comprehensive document on India's faunal species will position the country as a global leader in biodiversity documentation.

France's exceptionally high-stakes election begins

 $V_{\rm France\ were\ casting\ ballots}^{\rm oters\ across\ mainland}$ Sunday in the first round of exceptional parliamentary elec-tions that could put the government in the hands of nationalist, far-right parties for the first time since the Nazi era.

The outcome of the two-round elections, which will wrap up July 7, could impact European financial markets, Western support for Ukraine and how France's nuclear arsenal and global military force are managed. Many French voters are frus-

trated about inflation and economic concerns, as well as President Emmanuel Macron's leadership, which they see as arrogant and out-of-touch with their lives. Marine Le Pen's anti-immigration National Rally party has tapped that discontent, notably via online platforms like TikTok, and dominated preelection opinion polls.

A new coalition on the left, the New Popular Front, also poses a challenge to the pro-business Macron and his centrist alliance Together for the Republic. It includes the French Socialists and Communists and the hardleft France Unbowed party and

"People don't like what has been happening," said Cynthia Justine, a 44-year-old voter. "People feel they've lost a lot in recent years. People are angry. I am angry."

She added that with "the rising hate speech," it was necessary for people to express their frus-trations with those holding and seeking power.

"It is important for me because I am a woman and we haven't always had the right to vote," Justine said. "Because I am a Black woman, it's even more important. A lot is at stake on this day."Pierre Leclaer, a 78year-old retiree, said he cast his year-old retiree, said he cast his ballot for the simple reason of "trying to avoid the worst," which for him is "a government that is from the far right, pop-ulist, not liberal and not very Republican."

Macron called the early elec-tions after his party was trounced in the European Parliament election earlier in June by the National Rally, which has historic ties to racism and antisemitism and is hostile toward France's Muslim community. It also has historical ties to Russia.Macron's call was an audacious gamble that French voters who were complacent about the European election would be jolted into turning out for moderate forces in national elections to keep the far right out of power.

Instead, preelection polls sug-gested that the National Rally is gaining support and has a chance at winning a parliamen-tary majority. In that scenario,

The teen was killed late Friday in Utica after officers in the city about 240 miles (400 kilometers) northwest of Manhattan stopped two youths a little after 10 p.m. in connection with an armed robbery investigation, police said. The youths, both 13, matched the descrip-

tions of the robbery suspects and were in the same area at around the same time the day after, police said. One was also walking in the road, a violation of state traffic law.

The body camera video released by police captures an officer saying he needs to pat them down to ensure they don't have any weapons in their possession. Immediately one of the two — identified by police as as Nyah Mway — runs away. Authorities froze frames of the video where

Authorities froze frames of the video where a running Nyah Mway appears to point the gun at the pursuing officers. Police also edited the video to insert a red circle around the weapon to show it to viewers. The officers believed it was a handgun,

one of the officers fired a single shot that struck the boy in the chest, Williams stituck the boy in the cliest, whitains said. The teen was given "immediate" first aid by the officers and taken to Wynn Hospital, where he died, the chief said. The replica gun carried by the teen "is in with GLOCK markings, signatures, detachable magazine, and serial numbers," Lt. Michael Curley, a police spokesperson, said via email. "However ultimately it fires only pellets or BB's."

A bystander video posted to Facebook shows one of the officers chasing after Nyah Mway and tackling him to the ground. It also shows the officer punching the teen as two other officers arrive. Mway, and as the two are wrestling on the ground, Husnay opens fire. Officers initially thought Nyah Mway may have shot himself, and Patterson says,

'I don't know if he shot me." It is not clear whether he is referring to Nyah Mway or his fellow officer. Patterson was not struck. Bystanders scream at the police throughout the recordings, and at one point an offi-cer yells back: "We're trying to save him right now!"

The other youth was detained in the back of a police vehicle and was not involved in the shooting. The police department released the body

∽hinese President Xi Jinping will attend the 24th sum-mit of the Shanghai Cooperation Organization (SCO) in Kazakhstan's capital Astana this week, the Chinese Foreign Ministry announced on Sunday.He will also pay a state visit to Tajikistan, it said. From July 2 to 6, President Xi will attend the 24th Meeting of the Council of Heads of State of the SCO in Astana, the ministry said.

Officials say the situation in Afghanistan, the Ukraine conflict and boosting overall security cooperation among the SCO member countries are expected to figure in the summit. The SCO, comprising India, China, Russia, Pakistan, Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan, is an influential economic and security bloc that has emerged as one of the largest transregional international organisations.



India will be represented by External Affairs Minister S Jaishankar, the Ministry of External Affairs (MEA) earli-

er said. Officials say there is a likelihood of a meeting on the sidelines of the summit between Jaishankar and Chinese Foreign Minister Wang Yi, who is expected to accompany Xi. If it takes place, it will be the first high-level meeting between Indian and Chinese officials after the formation of Prime Minister Narendra

Generally, the Indian prime minister participates in the SCO summit, providing an opportunity for Indian and Chinese leaders on the sidelines of the heads of the state meeting of the eight-member bloc. But since Modi has decided to skip it, significance is attached to the likely meeting between Jaishankar and Wang in the

light of a four-year-long frozen relations between the two countries over the standoff in Eastern Ladakh.

Relations between the two countries hit a low except for trade ever since the eastern Ladakh border standoff erupted on May 5, 2020, following a violent clash in the Pangong Tso (lake) area near Galwan. Since the May 2020 clashes, the two sides have so far held 21 rounds of Corps Commanderlevel talks to resolve the stand-

New York (AP) A sense of concern is growing inside the top ranks of the Democratic Party that leaders of Joe Biden's campaign and the Democratic National Committee are not taking seriously enough the impact of the president's troubling debate performance ear-lier in the week.DNC Chairman Jaime Harrison held a Saturday afternoon call with dozens of committee members across the country, a group of some of the most influential members of the party. He did not acknowledge Biden's weak showing Thursday night or the avalanche of criticism that followed.

Multiple committee members on the call, granted anonymity to talk about the private discussion, described feeling like they were being gaslighted — that they were being asked to ignore the dire nature of the party's predicament. The call, they said, may have worsened a widespread sense of panic

among elected officials, donors and other stakeholders. Instead, the people said, Harrison offered what they described as a rosy assessment of Biden's path forward. The chat function was disabled and there were no questions allowed. Many donors, party strategists and rank-and-file DNC members are publicly and privately saying they want the 81-year-old Biden to step aside to allow the party to select a younger replacement at the Democratic National

Convention in August. As of now, though, Biden's closest allies insist he remains wellpositioned to compete against Republican Donald Trump and have given no indication they will push him to end his campaign

Those best positioned to replace him — Vice President Kamala Harris, California Gov. Gavin Newsom and Michigan Gov. Gretchen Whitmer among

them — reiterated their support for Biden after the debate. Many are anxiously awaiting the first major round of postdebate public polling to determine their next steps.

Polls from CNN and 538/Ipsos conducted soon after the debate found that most debate-watchers thought Trump outper-formed Biden. But the two men's favourability ratings remained largely unchanged, just as they did in the aftermath of Trump's conviction on charges in New York that he illegally participated in a hush money scheme to influence the 2016 election. In a subsequent appearance on MSNBC, Harrison downplayed the sig-nificance of the conference call, which he said was part of a regularly scheduled communication "to talk about the state of the race" and the upcoming national convention with the DNC's many elected members

Retirement fund body Subscribers addition declined by over 4 per cent to 1.09 crore in 2023-24 compared to a year ago, as per a report by Ministry of Statistics & Programme Implementation (MoSPI).

According to the report 'Payroll Reporting in India: An Employment Perspective –January to April, 2024', the Employees' Provident Fund Organisation (EPEO) Organisation (EPFO) recorded 1,09,93,119 gross addition of new members in 2023-24 compared to

1,14,98,453 in 2022-23. The gross addition of new members was affected due to the pandemic and declined from 1,10,40,683 in 2019-20 to 85,48,898 in 2020-21. It bounced back to 1,08,65,063 in 2021-22.

The Centre as well as states had imposed lockdown restriction in 2020 and 2021 to curb the spread of deadly coronavirus in the country, which had hit economic

employment. The data shows that in the last five fiscal years till 2023-24, the gross new members addition by EFPO had not recovered to pre-covid level of 2018-19.

The gross addition of new members was 1,39,44,349 in 2018-19.

Since April 2018, the ministry has been bringing out the employment related statistics in the formal sector covering the period September 2017 onwards, using information on the number of subscribers who have subscribed under three major schemes, namely Employees' Provident Fund

(EPF), Employees' State as Insurance (ESI) and National Pension Scheme (NPS).

The numbers of subscribers are from various sources and there are elements of overlap. Therefore, the estimates from various sources are not additive, it stated.

The report also showed that the gross addition of members of Employees' State Insurance Corporation (ESIC) also dipped to 1,67,60,672 in 2023-24 from 1,67,73,023 in 2022-23.

However, according to the report, the new addition of subscribers increased under NPS to 9,37,020 in 2023-24 from 8,24,735 in 2022-23.

Urja Ganga gas pipeline

The construction of the Rs 12,940-crore 'Urja Ganga' gas pipeline, India's most ambitious project taking environment-friendly fuel to eastern parts of the country, has been delayed by nine months and will now be completed by March 2025, state-owned GAIL (India) Ltd said.

The 3,306-kilometre Jagdishpur-Haldia-Bokaro-Dhamra pipeline was originally targeted for completion by June 2024. But due to "delay in right of use (RoU) availability", the completion schedule has been

completion schedule has been revised "from June 2024 to March 2025", GAIL said in a stock exchange filing. The bulk of the pipeline has already been constructed, and gas has started to flow in most cities along the route cities along the route.

Traditionally, natural gas was available for use as fuel to generate electricity, make fertiliser or turn into CNG and cooking gas only in the western and northern parts of the country, as pipelines taking the fuel from source to users were limited to these parts. In October 2016, work on

laying a pipeline from Jagdishpur in Uttar Pradesh to Haldia in West Bengal, Bokaro in Jharkhand and Dhamra in

Odisha began. The line was extended to Guwahati in Assam from Barauni in Bihar, a length of 726 km, to take the fuel to hereto-unconnected states in

hereto-unconnecteu states in the eastern region. The Jagdishpur-Haldia-Bokaro-Dhamra Pipeline (JHBDPL), popularly called the Pradhan Mantri Urja Ganga pipeline, is to supply gas to the eastern states of Bihar, Jharkhand, Odisha and West Bengal.

GAIL, the firm executing the pipeline, said its board of directors in a meeting on June



28 approved the revision of the completion schedule.

The completion schedule for the 240-km Dhamra-Haldia pipeline has also been revised from June 2024 to March 2025, it added.

The company on May 10, 2019, stated that it has completed awards of all major contracts worth Rs 10,500 crore for pipeline supply and laying of the integrated 3400-km Jagdishpur-Haldia and Bokaro-Dhamra Natural Gas Pipeline (JHBDPL) and Barauni-Guwahati Pipeline (BGPL)

pipeline. The government provided 40 per cent viability gap funding amounting to Rs 5,176 crore for execution of JHBDPL. For Barauni-Guwahati the pipeline, a 60 per cent viability gap funding, amounting to Rs 5,559 crore, has been provided by the government.

The Pradhan Mantri Urja Ganga pipeline will connect all the geographical areas (more than 90) spread over Uttar Pradesh, Bihar, Orissa, West Bengal and further to the northeastern region of India. When the project is fully

completed, the northeastern/eastern part of India will become an integral part of the gas-based economy with the twin benefits of the

cheapest gas transportation through Urja Ganga and gas pricing reforms.

Sindhu is currently training at Hermann-Neuberger Sportschule in Saarbrucken, Germany after her proposal

was cleared by the sports ministry. She will be heading to Paris directly from there when

the Games begin on July 26. .. Physically and mentally I am right there, I just have to be smarter and my coach Agus (Dwi Santoso) has been taking

care of that, my trainer has been taking care of my physical part. "I am working on all the strokes, whether it is defense, or attack or netplay, it is important to be perfect in all things. "So I'm not focussing on just

one stroke or technique, because you never know what it is going to be, there are players who are smart enough to change and move to plan B.

"So you need to be prepared for it and I am focusing on practicing each and everything to make everything perfect --each stroke, all techniques."

Asked why she picked Germany as her training base ahead of the Games, Sindhu said: "Prakash (Padukone) sir,



and we all discussed and thought, it will be a good place, it is near to Paris, it is in between nowhere, so I am much more focussed.

"I have taken few sparring partners and have a team and currently training here has been very peaceful. I can focus even more before the Olympics."

Sindhu has spent most time on the court in the run-up to the Olympics but she hasn't been consistent enough or beating the top players. The Indian, though, did manage a runnerup finish at Malaysia Masters super 500. "It took me some time to come

back (from injury) and I feel that now I'm doing well. Coming to the finals is not an easy thing. And, finishing matches, not finishing matches, it depends on how we play. "Sometimes nothing might work out," she said referring to the loss in Malaysian Masters

final. "I feel that there's been a lot of improvement and I know that I

can do much better and I'm confident that I'm getting there. I need to keep believing in myself and keep working much harder.

"I feel the Olympics is something where it will be very different. I don't want to compare with others but looking at my form, I'm in great shape and it's just that you have to play very differently with every player.

"It's a different style of play. I think the strategy will be very different whether it is Chen Yu Fei or An Seyoung. It also depends on the draws, with whom I play. Looking forward to going to the Olympics. So, yeah, hoping for the best."

Sindhu, who trained under Pullela Gopichand for many years, moved from Hyderabad to Bengaluru after trying out four different coaches in 12 months.

The ace shuttler feels the level of competition now is very high. "I've played two Olympics and this will be my third and every time the game keeps changing, every Olympics there are different players.

"So it is going to be very challenging and really hard because one is we know each other's game and two is the game has completely changed and I think there are a lot of players who would be looking at your game, how you're

playing, what are they doing, what needs to be done.

"So there are a lot of tactics and techniques which will go into this and also physically and mentally you need to be much more stronger, much smarter." Talking about her mentor Padukone, Sindhu said he has been helping her out by pointing out flaws.

[®]Prakash sir has been seeing my matches and he's been telling me a few things if I'm making mistakes. He observes a lot. "When he sat behind me in the last All England and French Open, his inputs were quite simple. He just always told me that you know just play freely and just give your best.
