Bill to bar judges from joining politics post retirement listed

Private Members' Bills listed in Rajya Sabha for the upcoming Monsoon Session include one that seeks prohibition on holders of Constitutional posts like judges joining a political party post retirement, a few Bills on artificial intelligence and deepfake, as well as one on amending the citizenship law. In all, 23 Private Members' Bills have been

listed for introduction in the upcoming session in the Upper House. The Upper Constitution (amendment) Bill, 2024 (amendment of articles 124, 148, 319 and 324 and insertion of new articles 220A and 309A), listed by RJD MP AD Singh, seeks to bar those retiring from Constitutional posts, like judges and former election commissioners from joining political

Kanwar Yatris embark on tough political journey

After major allies like JD (U) and LJP, BJP's another significant ally in the NDA --the Rashtriya Lok Dal -- on Sunday demanded the Uttar Pradesh Government roll back its order that eateries along the Kanwar route must display the names of their owners, saying the pilgrimage does not belong to any one religion or caste. Union Minister Jayant Chaudhary said kanwariyas ask no-one their religion when they seek any service from them, neither should the matter (the pilgrimage) be linked to

any religion. Chaudhary also wondered if one should wear a name tag on one's clothes to identify one's religion.
"Where all one would be made to place these identifiers! Should we now wear name tags too? So that one knows who to shake hands with?" he said.

"It seems that the order was taken without much thought and the Government is adamant on it because the decision has been taken," Rajya Sabha member Chaudhary told reporters here.

Biden ends 2024 re-election bid

Embattled US President Joe Biden on Sunday announced that he will end his candidacy for re-election in 2024, saying "it is in the best interest of my party and the country". Biden's decision follows weeks

of intense pressure from fellow Democrats after his disastrous presidential debate performance against his Republican rival and former US

president Donald Trump last month. The 81-year-old president's decision comes four months

before Americans go to the polls on November 5. It has been the greatest honour of my life to serve as your President. And while it has

been my intention to seek reelection, I believe it is in the best interest of my party and the country for me to stand down and to focus solely on fulfilling my duties as President for the remainder of my term," Biden, said in a message to fellow Americans in a six-paragraph open letter posted on social media.

Such a decision from Biden comes amid a visible deterioration in his health. The president is currently in self-isolation at his Delaware residence after he tested positive with COVID-19. Biden said he will speak to the



nation later this week in more detail about his decision.

"For now let me express my deepest gratitude to all those who have worked so hard to see me reelected. I want to thank Vice President Kamala Harris for being an extraordinary partner in all this work. And let me express my heartfelt appreciation to the American people for the faith and trust you have placed in me," Biden said. In his one-page letter, Biden said over the past three and a half years, we have made great progress as a nation. Today, America has the

strongest economy in the world. We have made historic investments in rebuilding our nation in lowering prescription drug costs for seniors, and in expanding affordable health care to a record number of Americans. He noted that his administration has provided critically needed care to millions of veterans exposed to toxic substances.

Landslide in Kedarnath kills three

Three devotees died and eight others injured in a landslide on the Kedarnath Dham trekking route in Uttarakhand's Rudraprayag district on Sunday, officials

Rudraprayag District Management Disaster Officer Nandan Singh Rajwar said the accident happened at around 7:30 am near Chirbasa area on the Gaurikund-Kedarnath trekking route when the devotees were hit heavy stones and debris falling down from the hill. The State Disaster Response Force (SDRF) and disaster management teams reached the spot and started a search and rescue operation, he said.

Those killed have been

identified as Kishore Arun Parate (31), from Maharashtra's Nagpur, Sunil Mahadev Kale (24), a resident of Maharashtra's Jalna district and Anurag Bisht from Rudraprayag, Rajwar said.

According to SDRF sources, so far the bodies of three devotees have been recovered from the debris, while eight others were rescued in an injured condition and immediately rushed to the hospital. The rescue operation was still underway, they said.

Nipah Virus claims a life in Kerala, Centre on alert

m ollowing}$ the death of a 14-boy from from lapuram district Kerala, who tested positive for Nipah virus on Sunday, the Centre has rushed a "One Health" outbreak multi-member response team to investigate the case. The boy had fever and showed symptoms of acute encephalitis syndrome inflammation and swelling of the brain usually due to an infection. He has been on a

ventilator since Friday. The team from the Union Health Ministry will identify epidemiological linkages and provide technical assistance

to the State. The Centre has urged the State to carry out active search for Nipah virus cases in the family of the boy, neighbouring areas, and areas with similar topography. In a statement on Sunday, the

Ministry said the from the district exhibited the acute encephalitis syndrome and was admitted to a healthcare facility in Perinthalmanna before being transferred to a higher health centre in Kozhikode.

He succumbed to the disease and samples were sent to the Pune-based National Institute of Virology, which confirmed Nipah virus infection, it said. State Health Minister Veena George said With the death of the 14-year-old on Sunday, the total number of deaths due to Nipah in Kerala since 2018 has gone up to 21.



the boy from Pandikkad suffered a massive cardiac arrest at 10.50 am on Sunday and efforts to revive him failed.

"He was on ventilator support. The urine output had reduced this morning. After a massive cardiac arrest, the revival efforts failed and he passed away at 11.30 am," George said.

The Minister said the funeral will be held following international protocols. Further matters on the

funeral will be decided only after the district Collector holds discussion with the boy's parents and the family," George said. Kerala has had a number of

Nipah outbreaks since 2018 when 17 of 18 infected persons had died while one death was reported in 2021, and two in 2023. With the death of the 14-

Following the death of the teenager, Kerala Government has also been asked to trace all contacts of the boy over the last 12 days.

Strict quarantine of the contacts and isolation of those suspected to have the infection has been advised. Samples for the contacts and suspected cases have to be sent for laboratory

testing. The Indian Council of Medical Research (ICMR), on the state's request, sent monoclonal antibodies against the infection to the state. While the monoclonal antibodies had reached before the death, it could not be used because of the poor general condition of the boy, according to a statement by the union health

ministry. Fruit bats are the usual reservoir of the virus, and humans can become infected by accidentally consuming bat-contaminated fruits. Continued on Page 8

and has aided many users in attaining the title of "social media influencers". The changing algorithms of the social media platforms majorly Instagram, YouTube and Facebook have changed the landscape of fame, forcing such influencers to make content out of the way, even to the extent of risking lives to shine in the masses at a place where everyone wants to shine.

Expecting a glittering journey, many influencers face criticism and failure, while some go to extreme lengths, even risking their lives, to create distinctive

led to an increase in mishaps with the influencers while filming content. The social media platforms have promised likes, views, and shares at the expense of safety. Recent cases like the case of Aanvi Kamdar, a travel influencer, 26 years old with over 2, 80,000 followers on Instagram and 833 subscribers on Youtube, fell from 300 feet at the Kumbhe waterfall in Maharashtra

He died in a road accident on May 3, 2023, on the Yamuna Expressway in Aligarh, Uttar Pradesh. He was a motorcycle enthusiast and made videos on the same. He was riding a Kawasaki Ninja ZX 10R bike while attempting to exceed 300 km/h speed. These are just a few of the many incidents where influencers have met with fatal outcomes while chasing digital fame. Countless micro-influencers face similar dangers, often while filming an Instagram without making headlines.

Shiva temples adorned for Shrawan

City temples are gearing up for the first day of Shrawan on July 22, which also happens to be the first Monday of the month, making it doubly aus-picious. Lord Shiva temples across the city are expecting huge crowds of devotees and are making preparations accordingly.

Mahant Divya Giri said she was expecting more than two lakh devotees to visit the Mankameshwar temple. "We are expecting no less than two lakh devotees because it is both the first Monday and the first day of Shrawan, and devotees will ensure they come for darshan. Had it been only the first day of Shrawan, devotees might have opted for other days of the week to offer prayers, but on Monday, it will be almost mandatory for them to visit the temple," she said.

She said that they had apprised the administration, the nagar nigam, and the JalKal department about the narrow approach road to the temple, which has a lot of encroachments and would prove to be a hindrance in managing the crowds. "There are two queues of devotees moving on this

approach road, and people return from the same path they enter. This area is also sensitive, and we have concerns that a situation like the one in Hathras does not arise here due to the huge crowds," she said. The Mahant further stated that they had written several times to the nagar nigam to remove

"We can manage the crowds inside the temple, but how can we manage the crowd outside? There are often miscreants among the devotees in the crowd. If there is an untoward incident, no vehicle would be able to come up on the approach road because of the encroachments. We have drawn the administration's attention to this issue many times, hoping they would find a solution, but there has been no response. If any incident occurs, the organisers will be blamed," she added

The special rituals of Guru Purnima began early in the morning at the Gorakhnath temple and concluded with a collective aarti. The ceremonial programmes followed a spesequence.



Akhilesh faces difficult task of selecting successor in assembly

Samajwadi Party president Akhilesh Yadav, basking in glory of stellar performance in recent Lok Sabha elections in which his party won 37 seats in UP, has to take a difficult decision of selecting his successor as the leader of opposition in UP assembly. The monsoon session of the UP assembly is commencing from July 29. Akhilesh Yadav was elected to UP assembly in March 2022 from Karhal assembly seat and he held the post of the leader of opposition.

The post fell vacant in June after he was elected to Lok Sabha from Kannauj and decided to retain his Lok Sabha seat and resigned from UP assembly. The front runner for the post is his uncle Shivpal Singh Yadav— the younger brother of party founder Mulayam Singh Yadav.

Akhilesh Yadav had a running feud with his uncle in January 2017 after he took command of the party after dislodging his father Mulayam Singh Yadav.

er uncle Ram Gopal Yadav is party leader in Rajya Sabha. The sources said the party MLAs close to Akhilesh Yadav were not in favour of giving command of the 105 MLAs to Shivpal Yadav. This section, which is in favour of strengthening the PDA (Pichhada, Alpsakhyak and Dailt) plank of the party, wants either a Dalit or a non-Yadav OBC leader as leader of opposition in the UP assembly.

Shivpal Yadav had parted company with nephew and floated his own political party in April 2027. However, the family was reunited after the death of Mulayam Singh Yadav in October 2022.

Sources in Samajwadi Party said Akhilesh Yadav may bring somebody from outside the family as five members of the first family of the party, including Akhilesh Yadav, have already been elected to Lok Sabha, Three cousins and wife of Akhilesh Yadav were elected to Lok Sabha while anoth-

While the decision lies with the leadership, there is a divide within the party as some feel that Shivpal Yadav, who is well connected with the cadre, can take the MLAs along better. However, considering the recent Lok Sabha elections, it is felt that the party could give the responsibility to a senior Scheduled Caste leader like Indrajeet Saroj, who is a Pasi like (Lok Sabha MP) Awadhesh Prasad, to convince the community that once in power, the party would give due leadership roles to them or to a non-Yadav OBC leader like Ram Achal Rajbhar," a party leader said.

However, the drawback of both Saroi and Raibhar is that they are former Bahujan Samaj Party leaders and a section of the party wants an established name to take over.

The idea behind floating their name is to use the leader of opposition post to push the party's PDA plank that had helped the SP expand beyond its traditional Muslim-Yadav voter base during the Lok Sabha elections.

"Caste equations aside, there are many veteran leaders like former assembly speaker Mata Prasad Pandey," said an SP leader. However, 81-year-old Pandey's age and the opposition's desire to take a more aggressive stance until the next assembly polls have led many to believe that he is not the most suited for the role of leader of opposition. The rank and file of the party wants an aggressive stance against the ruling in view of the coming bypolls to 10 UP assembly seats and the larger goal of coming to power in the 2027 state assembly

2 boys bathing in pond drown

Two teenage boys drowned while bathing in a pond located in the outskirts of a village here, police said on Saturday. The deceased have been identified as Ayush Verma (14) and his relative Pratik Verma (13)of Majra Nathupur under Bondi police station area, the police said. Drones, remote vehicles to map, survey Rihand dam for cracks

The Yogi Adityanath government will soon conduct a crack mapping and identification survey of the Rihand Dam in Pipri, Sonbhadra.

The assessment and marking of above-water and underwater cracks will be carried out using remotely operated vehicles (ROVs) and underwater drones. Uttar Pradesh Jal Vidyut Nigam Limited, under Uttar Pradesh Rajya Vidyut Utpadan Nigam Limited (UPRVUNL), has begun the process to select an agency for this task.

The survey will include videography of a 35,000square metre riverbed area, utilising 2D and 3D data capturing technology.
The upstream surface map-

ping will be completed, forming the basis for a detailed project report on the dam's condition.

This process will be completed within three months after the agency selection and work allocation, with an estimated cost of ₹ 76.50 lakh. The crack identification

process at Rihand Dam, renowned for its unique natural beauty and that attracts tourists from Uttar Pradesh, Bihar and Madhya Pradesh, will utilise cutting-edge tech-nology. State-of-the-art equipment will conduct videography above and below the water on the dam's upstream wall to assess parameters such as measurements (length, width, and depth) and the condition of

The inspection will cover an area up to the reservoir floor (approximately 35,000 square metre) and an area above water (approximately 10,000 square metre).

construction materials.

This work will be carried out using ROVs equipped with data capturing devices, lowlight HD cameras, depth sensors, altimeters, and lasers for underwater assessment and unmanned aerial vehicles (UAVs) for 2D and 3D data capturing. Using the data collected from the survey, defects will be identified and marked with specialised software, and measurements will be reported for areas above the water level to detail the defects. Each frame will be placed and geotagged on the dam, referencing a marking grid on its face.

The engineer-in-charge (executive engineer, Rihand Colony Civil Maintenance Division, Pipri, Sonbhadra, UP) will serve as the nodal authority overseeing the execution of the work. The engineer-in-charge will monitor each stage carried out by the contractor agency. Following the inspection, a visual analysis of the raw data will be submitted, identifying any visible issues such as cracks, potholes, or material deterioration. Each frame will be geotagged and depthmarked.

The agency will prepare and provide a detailed project report, a soft copy, and a processed HD video on a pen

11 killed in rain-related incidents | Dedicated Country Desks set

Eleven people were killed in Frain-related incidents across Uttar Pradesh in a 24-hour period ending Saturday evening, Relief department officials said. According to the Relief depart-

ment, from 6:30 pm on Friday to 6:30 pm on Saturday, five persons drowned and five others were killed after being hit by lightning. One person in Ghazipur district was killed after snake bite. Uttar Pradesh recorded an

average of 7.3 mm rainfall in the 24-hour period. Of the 75 districts, 19 recorded excess rainfall in this time period, with Hamirpur recording a maximum rainfall of 163.2

The Relief department has also alerted local administration in Gorakhpur, Siddharth Nagar and Gonda districts where rivers have been flowing near the danger level mark. "We are coordinating with local administration to miti-gate any kind of damage caused by adverse weather conditions. All units are ready and are on standby mode," State Relief Commissioner GS Naveen Kumar said.



SC to resume hearing on NEET-UG 2024 petitions

The Supreme Court is sched-L uled to hear on Monday a batch of petitions related to the controversy-ridden medical entrance exam, NEET-UG 2024, which was held on May

The National Testing Agency (NTA) had on Saturday released city- and centre-wise results of the medical entrance exam, which is riddled with accusations of paper leak and inordinate inflation of marks. According to the cause list of July 22 uploaded on the apex court's website, a bench comprising Chief Justice DY Chandrachud and justices J B Pardiwala and Manoj Misra would hear more than 40 pleas, including those filed by the NTA seeking transfer of cases pending against it in various high courts on the NEET-UG row to the Supreme Court to avoid multiplicity of litigations. An analysis of data released by NTA indicated that the candidates who allegedly benefitted from the paper leak and other irregularities did not do well. Some centres, however showed high concentration of wellperforming students, it

The voluminous data of over 32 lakh candidates from 4,750 centres was not released in a cumulative format but in a drop-down menu for each centre. The data was released on the direction of the Supreme Court which is hearing several petitions over the alleged irregularities as lakhs of aspirants await a final verdict on the fate of the exam.

The performance of the candidates from the centres under the scanner -- such as Oasis School, Hazaribagh, Jharkhand, Hardayal Public School, Jhajjar, Haryana, Jay Jalaram International School in Godhra, Gujarat -- were comparatively much below par.
On July 11, the top court had

adjourned till July 18 the hearing on the pleas, including those seeking cancellation of the exam, re-test and probe into alleged malpractices in the conduct of NEET-UG 2024, as the responses of the Centre and the NTA were yet to be received by some parties.

The bench had observed that it had received a status report from the Central Bureau of Investigation on the progress made in the probe.

in the apex court last week, the Centre said data analysis of the results of NEET-UG 2024 was conducted by IIT-Madras, which found there was no indication of "mass malpractice" or any localised set of candidates scoring abnormally high marks. While hearing the pleas on July 8, the top court had observed that the sanctity of the NEET-UG 2024 has been "breached".

Saying that a re-test may be ordered if the entire process was affected, the bench had sought details from the NTA and the CBI, including the timing and manner of the alleged paper leak, besides the number of wrongdoers to understand the extent of irregularities claimed

by the petitioners. More than 23.33 lakh students had taken the test on May 5 at 4,750 centres in 571 cities, including in 14 cities overseas. The Centre and the NTA, in their earlier affidavits filed in the apex court, had said that scrapping the exam would be "counterproductive" and "seriously jeopardise" lakhs of honest candidates in the absence of any proof of large-scale breach of confidentiality.

> Terming the electoral bonds scheme a "scam", the plea sought a direction to authorities to investigate the source of funding of "shell companies and loss-making companies which made donations to various political parties, as has been disclosed by the data released by the Election Commission (EC)". The petition has also sought a direction to the authorities to recover the money donated by companies as part of "quid pro quo arrangements where these are found to be proceeds of crime". A five-judge Constitution bench had on February 15 scrapped the electoral bonds scheme of anonymous political funding intro-duced by the BJP Government. Following the top court's judgement, the State Bank of India, the authorised financial institution under the scheme, had shared the data with the EC, which later made it public. The electoral bonds scheme,

which was notified by the Government on January 2, 2018, was pitched as an alternative to cash donations made to political parties to bring in transparency in political fund-

Researchers flag tobacco industry's interactive vapes

 $R^{\rm esearchers\, have\, red\, flagged}_{\rm the\, tobacco\, industry's\, bid\, to}$ integrate new electronic cigarette products also known as vapes with interactive features such as touch screens, animated displays, and built-in games to make them appealing to youngsters particularly those

Published in the journal 'Tobacco Control', the study authored by scientists from the University of California, Riverside, warned that these features could potentially exacerbate nicotine addiction among youth by integrating vaping with gaming behaviors.

The study In their study titled "Pac-Man on a vape: electronic cigarettes that target youth as handheld multimedia and gaming devices", identified several new electronic cigarette models, thox V-Play which incorporate classic arcade games like Pac-Man and Tetris. These devices also feature animations that change with each puff, built-in Bluetooth for customisation, and celebrity endorsements with promotional trading cards.

The study holds importance in the context of India too where despite being banned by the Government, vaping products are being found to be sneaked in the schools and colleges where students have been using them without any fear of law. In fact, in India, the menace has been all around which has prompted 'Mothers Against Vaping', a united front of concerned mothers combating the promotion of New-Age Tobacco Devices such as e-cigarettes, vapes, electronic nicotine delivery systems, heat-not-burn products, e-hookahs and simi-lar devices among Indian children and youth to join hands with celebraties like Nandita Das, Baichung Bhutia, Deepa Malik, Dutee Chand, Neha Dhupia to take up the cause. In November 2023, a large consignment of e-cigarettes worth Rs 50 lakh coming from China



was nabbed on the Khutar-Puranpur highway in Shahjaĥanpur, Uttar Pradesh. Similarly, a seizure at Chennai airport in November last year involved the confiscation of 11,700 e-cigarettes worth Rs 3.5 crore coming from China.

In the present study, researchers, including Man Wong and Professor Prue Talbot, expressed concern that these advanced features make electronic cigarettes more appealing to youth who may not have been interested in nicotine products previously. They emphasised that coupling nicotine with activities ing and could potentially widen the market for smart vapes among young users.

Drawing the attention of the health regulatory bodies, Talbot and Wong called for stringent regulation of these devices by overnment agencies like the Food and Drug Administration (FDA). The researchers also proposed measures to restrict features that enhance attractiveness to youth, and even suggest considering a ban on disposable vapes due to their evolving features and potential for increased waste generation.

The study also noted that these new smart vapes are affordable, priced around \$15-20, and offer enhanced functionalities compared to earlier models. However, the disposable nature of these vapes contributes significantly to environmental waste, exacerbated by the inclusion of screens, Bluetooth, and digital storage.

Talbot underscored the importance of increasing awareness about the rapid evolution of vape designs and enhancing surveillance to promptly remove products targeting youth from

In a significant development, the Employees' Provident Fund Organisation (EPFO) has reported a record addition of 19.50 lakh net members in May 2024, marking the highest increase since the issuance of its first payroll data in April 2018.

An official from the Ministry of Labour and Employment said that May 2024 saw a robust addition of 19.50 lakh net members, indicating a year-over-year growth of 19.62 per cent compared to May 2023. This surge is attributed to increased employment opportunities and enhanced awareness of employee benefits. The official also said that approximately 9.85 lakh new members joined EPFO in May 2024, marking a 10.96% increase from April 2024 and an 11.5 per cent increase from May 2023. Notably, the 18-25 age group constituted 58.37% of these new enrollments, reflecting a trend of youth entering the organised workforce.

But at the same time, around 14.09 lakh members exited and re-joined EPFO-covered establishments in May 2024, demonstrating a year-over-year growth of 23.47 per cent compared to May 2023. This indicates a preference among members to transfer their EPF accumulations when switching jobs, ensuring continuity of social security benefits, the



The payroll data also showed a significant increase in female membership, with around 2.48 lakh new female members joining in May 2024, marking a 12.15 per cent increase from May 2023. The net addition of female members stood at approximately 3.69 lakh, reflecting a 17.24 per cent year-over-year

Štate-wise breakdown showed that Maharashtra, Karnataka, Tamil Nadu, Gujarat, and Haryana emerged as the top states/UTs for net member additions, accounting for 58.24 per cent of the total additions. Maharashtra led with 18.87 per cent of net members added during the month.

Students rampage in Bangladesh protesting job quota for veterans' families: India calls it an 'internal matter'

angladesh is going through the worst phase in years as students have taken to the streets protesting the Government's 30 per cent quota for relatives of the veterans who fought its war of independence in 1971. A national curfew has been imposed and the army has been deployed after 105 people including two journalists died in the bloodiest protests for a decade. A 'shoot-on-sight' order is also in place giving security forces the authority to fire on mobs, showing the gravity of the situation. Slowly but surely the student protest is turning into an all-out protest against the government as student protesters stormed a prison and freed inmates. The students maintain that job reservation for families of veterans mostly benefits supporters of Hasina, whose Awami League party led the independence movement. Students are struggling in a country where around 32 million young people are neither employed nor in education. Although job opportunities have



increased in certain areas of the private sector, many individuals prefer government jobs due to their perceived stability and better pay. The Government's crackdown on the protesting students has had little effect in controlling the violence. The protests, which began earlier this month, have led to widespread unrest and disruption across the country, leaving many foreign students in precarious situ-

About 15,000 Indians live in Bangladesh, of whom around 8,500 are students. Around 4,000 students are still awaiting their turn to be evacuated. The MEA spokesperson Arindam Bagchi has

confirmed that 1000 Indian students have been safely brought back home. The families are anxiously waiting for the return of stranded students. The Indian High Commission in Dhaka has set up a dedicated helpline to assist students and provide real-time updates on the repatriation process. Students have been advised to stay in touch with the mission and follow its guidance closely. A communication blackout has been in place since Thursday, including the suspension of mobile data and text message services. Besides, the Government's high-handedness in dealing with the protests has only escalated the tension and put the Hasina Government in a bad light. Prime Minister Sheikh Hasina's government is facing one of the most severe challenges of her 15-year tenure. Indeed, it is one of the biggest challenges Sheikh Hasina has faced in years. The student protests are turning into general protests against the government. Sheikh Hasina has appealed to students to wait for the court verdict on the issue but to no avail. India meanwhile has termed the unrest in the neighbourhood as an 'internal matter of Bangladesh' but must be concerned as Sheikh Hasina's Government maintains good relations with India and any disruption may impact Indo-Bangladesh relations.

Madam - On 18th July, the Union Home Minister inaugurated the National Narcotics Helpline, 'MANAS' (Madak Padarth Nishedh Asuchna Kendra). The helpline, accessible through the toll-free number 1933, a web portal, and a mobile app, allows citizens to anonymously report drug trafficking activities. Although 'MANAS' collects personal information, it guarantees that the identity of the informant will be kept confidential.

This anonymous reporting system could be expanded to cover other types of crimes. 'Crime Stoppers', a collaborative effort between police and civil society, enables citizens to anonymously provide information about crimes or suspects via phone calls, online forms, or mobile apps.Many individuals, despite having critical information about crimes, are hesitant to speak directly with the police due to fears of testifying or concerns for their safety. Crime Stoppers ensures the anonymity of those reporting suspected criminal activities. Crime Stoppers helplines do not display caller numbers or trace calls.

Upon receiving a call or a completed anonymous online form, they compile a report that excludes any information that could identify the caller. This report is then forwarded to the relevant authority, such as the police, customs, or the NCB, for further investigation. Founded in the US in 1976 (1-800-222-TIPS), Crime Stoppers has since been adopted in the UK (0800 555 111), Australia (1800 333 000), and South Africa (08600 10111). Since its inception in the UK in 1995, Crime Stoppers has received over 2.2 million actionable calls, leading to the arrest and charging of more than 151,000 individuals and the seizure of illegal drugs worth over £367 million.

According to the recent National Crime Records Bureau (NCRB) Report 2022, released in December 2023, 5,824,946 cognizable crimes were registered in

The time is ripe for Bharat to make use of its historical wisdom, embrace global opportunities, and drive towards a prosperous and inclusive future



his year's record spell of an intense heatwave in Delhi, during which temperatures touched 50°C, highlighted concerns over the adverse effects of climate change globally. India remains a beacon of hope through its actions as part of the global efforts to stem climate change. Through myriad initiatives, the country has demonstrated its unwavering commitment to environmental sustainability. India's journey toward climate action began in 2009 when the country voluntarily pledged to reduce the emissions intensity of its GDP by 20-25% by 2020 compared to 2005 levels. Impressively, India achieved a 24% reduction within the stipulated timeframe. In alignment with the Paris Agreement, India submitted its

Nationally Determined Contributions (NDCs) to the UNFCCC in 2015, setting forth eight ambitious targets for 2021-2030, further reinforcing its commitment to combating climate change. Afforestation

Management and Planning ning the use of single-use Authority (CAMPA), India encourages the use of barren land for tree plantations.

The country ranks third globally in net forest area gain, with 21.71% of its geographical area covered by forests. Initiatives like the Green Credit Program further incentivize tree plantation and forest restoration. India's commitment to wetland conservation is equally impressive, with 80 designated Ramsar sites. The Mangrove Initiative for Shoreline Habitats and Tangible Incomes (MISHTI) aims to promote and conserve mangroves, which are vital for carbon storage and marine biodiversity.

While there is a slight positive trend in the adoption of renewable energy, the pace of this transition is too slow to meet urgent climate

Despite high marks in emissions and energy use, India receives a medium rating in Climate Policy and Renewable Energy. The country has clear long-term policies focusing on renewable energy, including the domestic manufacturing of renewable energy components. The COP26 announcement by Prime Minister Modi, setting a net-zero emissions target for 2070, has been criticized by experts for lacking ambition. The call for a faster phase-out of coal, reduced reliance on gas, and a significant expansion of renewable energy is

India's heavy reliance on coal presents a significant challenge. Despite high taxes on petrol and diesel, consumption has not decreased. Some experts view these taxes as effective, while others highlight the government's dependence on the revenue they generate. Large-scale renewable energy projects in India have also faced criticism for negatively affecting local communities through land grabs and unequal resource distribution. The inflation has also hit restaurants and catering services trying to absorb the price rise in their production cost for now. Harsh Sisodia, manager of Udupi restaurant at ITO, stated how these prices affect their profits while they only increase the price of their dishes once every year in January.

'We only increase our prices once every year in January. However, these price rises keep happening and specifically this time it has been considerable. You see we do not compromise on our food quality, hence whatever the prices maybe we keep recipes the same. Our Uttapam has so many vegetables including onions and tomatoes. Its price and quality remain the same despite the two fold rise in the prices of these vegetables," he claimed, adding the weekly cost of

acquiring vegetables for the eatery has gone up from six to seven thousand to 14,000 to 15,000.

B'desh top court scales back govt jobs quota

Deadly unrest leaves scores dead

Bangladesh's top court on Sunday scaled back a controversial quota system for government job applicants, in a partial victory for student protesters after days of nation-wide unrest and deadly clashes between police and demon-strators that have killed scores

of people. Students, frustrated by short-Students, frustrated by shortages of good jobs, have been demanding an end to a quota that reserved 30% of government jobs for relatives of veterans who fought in Bangladesh's war of independent of the state of th dence in 1971. The government previously halted it in 2018 following mass student protests, but in June, Bangladesh's High Court reinstated the quotas and set off a new round of protests.

Ruling on an appeal, the Supreme Court ordered that the veterans' quota be cut to 5%, with 93% of jobs to be allocated on merit. The remaining 2% will be set aside for members of ethnic minorities and transgender and disabled people. The protests have posed the most serious challenge to Bangladesh's government since Prime Minister Sheikh Hasina won a fourth consecutive term in January elections that were boycotted by the main opposition groups. Universities have been closed, the internet has been shut off and the govern-ment has ordered people to stay at home.

The protests turned deadly on Tuesday, a day after students at Dhaka University began clashing with police. Violence continued to escalate as police fired tear gas and rubber bullets and hurled smoke grenades to scatter stone-throwing protesters. Bangladeshi authorities haven't shared any official numbers of those killed and injured, but the Daily Prothom Alo newspaper reported

Saturday that at least 103 people have died so far.

Sporadic clashes in some parts of Dhaka, the capital, were reported on Saturday but it was not immediately clear whether there were any fatalities.

Ahead of the Supreme Court hearing, soldiers patrolled cities across the South Asian country. Home Minister Asaduzzaman Khan said the stay at home order will be relaxed from 3 pm to 5 pm on Sunday for people to run essential errands.

Meanwhile, the government has declared Sunday and Monday as public holidays, with only emergency services allowed to operate.

Protesters argue the quota system is discriminatory and benefits supporters of Hasina, whose Awami League party led the independence movement, saying it should be replaced with a merit-based system. Hasina has defended the quota system, saying that veterans deserve the highest respect for their contributions in the war against Pakistan, regardless of their political affiliation. Representatives from both sides

met late Friday in an attempt to

reach a resolution and Law Minister Anisul Huq said the government was open to dis-cussing their demands. Their demands included the reform of the current quota system, the reopening of student dormitories shut by the police following the clashes and for some university officials to step down after failing to protect campuses from the violence.

The main opposition Bangladesh Nationalist Party has backed the protests, vowing to organize its own demonstrations as many of its sup-porters have joined the studentled protests. However, BNP said in a statement its followers were not responsible for the violence and denied the ruling party's accusations of using the protests for political gains. The Awami League and the BNP have often accused each other of fueling political chaos and violence, most recently ahead of the country's national election, which was marred by a crackdown on several opposition figures. Hasina's government had accused the opposition party of attempting to disrupt the vote.

Nepal PM Oli wins vote of confidence in Parliament

Nepal's newly appointed Prime Minister KP Sharma Oli comfortably won a vote of confidence in Parliament on Sunday, nearly a week after he was sworn in to lead a coalition government in the Himalayan nation.

Oli secured 188 votes in favour of the Vote of Confidence motion tabled by him while 74 votes were cast against the motion. Out of a total of 263 members of the House of Representatives, who were present, one member abstained. Oli, 72, required 138 votes out of a total of 275 votes to pass the floor test in the House of Representatives (HoR). Prime Minister Oli has won the vote of confidence in the Lower House, Speaker of the HoR Dev Raj Ghimire announced after the counting of votes. As the

Parliament meeting started,

Prime Minister Oli tabled the motion seeking a vote of confidence from the House. Speaker Ghimire gave around two hours for HoR members

and representatives from ruling and Opposition parties to discuss the motion. He then allotted time for the Prime Minister to give his response to the issues raised by HoR members. The voting process started after the Prime Minister concluded his deliberations.

Responding to issues raised by the HoR members Oli said, "I was not and will not get involved in corruption neither will tolerate if any one practices so." He said that the two larger parties "Nepali Congress and CPN-UML came together to maintain political stability, checking corruption and bring good governance."

"This coalition government will create a reliable eco-system for stability, development and

good governance," asserted Oli, House of Representatives House of Representatives members belonging to the ruling alliance Nepali Congress, CPN-UML, Lokatantrik Samajwadi Party and Janata Samajwadi Party Nepal were among those who voted in favour of Oli's Vote of Confidence motion.

Opposition parties CPN-Maoist Centre, CPN-Unified Socialist, Rashtriya Swotantra Party and Rastriya Prajatantra Party among others voted against Oli during the floor test. The veteran Communist leader was sworn in on Monday as the Himalayan nation's prime minister for the fourth time. He was administered the oath of office and secrecy along with 21 other members of the Cabinet. According to Nepal's Constitution, Oli needed to secure a vote of confidence from Parliament within 30

days of appointment.

SL workers in Bangladesh not affected by violence

Colombo (PTI): The Sri Lankan workers in Bangladesh have not been affected by the civil commotion in the country, authorities here said on Sunday. It is estimated that around 3,000 Sri Lankans are serving in Bangladesh currently. Their situation is being closely monitored by the the Foreign Employment Bureau. Bangladesh has been reeling Over 90 people have been killed in the clashes that began weeks ago, according to reports from Dhaka, though the exact number of deaths is not yet clear. Law enforcement authorities in Bangladesh have imposed a nationwide curfew as the clashes between protesters demanding withdrawal of a job quota system and police continued across the country. Meanwhile, the MFA has said that it is paying special attention to the safety of Sri Lankan students in Bangladeshi universities, Newsfirst reported.

S Korea boosts border propaganda broadcasts North Korea flies more trash balloons

South Korea's Joint Chiefs of Staff said the North Korean balloons were flying Sunday morning north of Seoul, the South Korean capital, after crossing the border. It said later Sunday that the South Korean military was responding by expanding loudspeaker broadcasts at all major sections of the Koreas' 248-kilometre-long border.

Experts say North Korea's expanding ties with Russia could embolden Kim Jong Un to stage bigger provocations.

Pakistan condemns attack on consulate in Germanc city Frankfurt **PTI** ■ ISLAMABAD

Dakistan on Sunday con Pdemned the attack on its consulate in the German city of Frankfurt along with the failure of German authorities to protect the diplomatic facility.

In the incident which occurred on Saturday, "the security of Pakistan's consulate in Frankfurt was breached, endangering the lives of its consular staff", the Foreign Office said without identifying the nationality of the attackers. "Pakistan strongly condemns yesterday's attack by a gang of extremists on its consulate in Frankfurt, Germany and the failure of the German authorities to protect the sanctity and security of the premises of its consular Mission," it

said. Under the Vienna Convention on Consular Relations, 1963, it is the responsibility of the host government to protect the sanctity of the consular premises and ensure the security of diplomats,

"We are conveying our strong protest to the German governernment to take immediate measures to fulfill its responsibilities under the Vienna Conventions and ensure the security of the diplomatic missions and staff of Pakistan in Germany," it said.

Pakistan also asked the German authorities to take immediate measures to arrest and prosecute those involved in the incident and hold to account those responsible for the lapses in security. Media reports indicated that the attack occurred during a protest by Afghan citizens and videos circulating on social media show the protesters storming the consulate, throwing stones, and removing the Pakistani flag. The attackers also attempted to burn the flag. According to details, 8 to 10 Afghan nationals were involved in storming the Pakistani consulate and fled after taking down the Pakistani flag. So far, no arrest has been made.

Russia scrambled fighter jets to intercept US bomber planes over Barents Sea

 $R^{\hbox{\it ussia said Sunday it scrambled fighter jets to intercept}}$ two US military long-range bomber aircraft that approached the Russian border over the Barents Sea in the Arctic. "The crews of the Russian fighters identified the aerial target as a pair of US Air Force B-52H strategic bombers," Moscow's defence ministry wrote on the social media platform Telegram, specifying that the planes scrambled were MiG-29 and MiG-31 fighters.

"As the Russian fighters approached, the US strategic bombers turned away from the State Border of the Russian Federation," the ministry said. The US routinely carries out flights over international waters. Moscow has recently responded more aggressively to the exercises, accusing the US in June of using its reconnais-sance drone flights over neutral waters in the Black Sea to help Ukraine strike Russian-occupied Crimea. Last month, Moscow warned of

"direct confrontation" between Russia and NATO, and Russia's defence minister ordered officials to prepare a "response" to US drone flights over the Black Sea, in an apparent warning it may take forceful action to ward off the American reconnaissance air-

Washington and Moscow have clashed before over the issue. In March 2023, a Russian Su-27 fighter jet damaged a US MQ-9 Reaper drone, causing it to crash into the Black Sea. It was the first direct clash between Russian and US forces since the

Cold War. A repeat of such a confrontation could further fuel tensions over the war in Ukraine.

Coventry (England): Since mindfulness it's something you can practice at home for free, it often sounds like the perfect tonic for stress and mental health issues. Mindfulness is a type of Buddhist-based meditation in which you focus on being aware of what you're sensing, thinking and feeling in the present moment.

The first recorded evidence for this, found in India, is over 1,500 years old. The Dharmatrata Meditation Scripture, written by a community of Buddhists, describes various practices and includes reports of symptoms of depression and anxiety that can occur after meditation. It also details cognitive anomalies associated with episodes of psychosis, dissociation and depersonalisation (when people feel the world is

In the past eight years there has been a surge of scientific research in this area. These studies show that adverse effects are not rare. A 2022 study, using a sample of 953 people in the

"unreal").

US who meditated regularly. showed that over 10% of participants experienced adverse effects which had a significant negative impact on their everyday life and lasted for at least one month.

According to a review of over 40 years of research that was published in 2020, the most common adverse effects are anxiety and depression. These are followed by psychotic or delusional symptoms, dissociation or depersonalisation, and fear or terror.

Research also found that adverse effects can happen to people without previous men-tal health problems, to those who have only had a moderate exposure to meditation and they can lead to long-lasting symptoms.

The western world has also had evidence about these adverse affects for a long time. In 1976, Arnold Lazarus, a key figure in the cognitive-behavioural science movement, said that meditation, when used indiscriminately, could induce "serious

psychiatric problems such as depression, agitation, and even schizophrenic decompensation". There is evidence that mindfulness can benefit people's well-being. The problem is that mindfulness coaches, videos, apps and books rarely warn people about the potential adverse effects.

Meditation can even worsen mental health problems

Professor of management and ordained Buddhist teacher Ronald Purser wrote in his 2023 book McMindfulness that mindfulness has become a kind of "capitalist spirituality". In the US alone, meditation is worth US\$2.2 billion (£1.7 billion). And the senior figures in the mindfulness industry should be aware of the problems with meditation.

Jon Kabat-Zinn, a key figure behind the mindfulness movement, admitted in a 2017 interview with the Guardian that "90% of the research [into the positive impacts] is subpar".

In his foreword to the 2015 UK Mindfulness All-Party Parliamentary Report, Jon Kabat-Zinn suggests that

mindfulness meditation can eventually transform "who we are as human beings and individual citizens, as communities and societies, as nations, and as a species".

This religious-like enthusiasm for the power of mindfulness to change not only individual people but the course of humanity is common among advocates. Even many atheists and agnostics who practice mindfulness believe that this practice has the power to increase peace and compassion in the world.

Media discussion of mindfulness has also been somewhat imbalanced. In 2015, my book with clinical psychologist Catherine Wikholm, Buddha Pill, included a chapter summarising the research on meditation adverse effects. It was widely disseminated by the media, including a New Scientist article, and a BBC Radio 4 documentary.

But there was little media coverage in 2022 of the most expensive study in the history

of meditation science (over US\$8 million funded by research charity the Wellcome Trust). The study tested more than 8,000 children (aged 11-14) across 84 schools in the UK from 2016 to 2018. Its results showed that mindfulness failed to improve the mental wellbeing of children compared to a control group, and may even have had detrimental effects on those who were at risk of men-

tal health problems. Is it ethical to sell mindfulness apps, teach people meditation classes, or even use mindfulness in clinical practice without mentioning its adverse effects? Given the evidence of how varied and common these effects are, the answer should be

However, many meditation and mindfulness instructors believe that these practices can only do good and don't know about the potential for adverse effects. The most common account I hear from people who have suffered adverse meditation effects is that the teachers don't believe them. They're usually told to just keep meditating and it will

go away. Research about how to safely practice meditation has only recently begun, which means there isn't yet clear advice to give people. There is a wider problem in that meditation deals with unusual states of consciousness and we don't have psychological theories of mind to help us understand these states.

But there are resources people can use to learn about these adverse effects. These include websites produced by meditators who experienced serious adverse effects and academic handbooks with dedicated sections to this topic. In the US there is a clinical service dedicated to people who have experienced acute and long term problems, led by a mindfulness researcher. For now, if meditation is to be used as a wellbeing or therapeutic tool, the public needs to be informed about its potential for harm. (The Conversation)



Anger is one of the most potent and corrupting emotions. It has the ability to deeply affect our holistic functioning — our destructive mind, body, and spirit. This emotion often arises from various triggers and can develop over time if left unattended. Although the onset of anger might seem sudden, it is rarely a binary phenomenon; there are numerous nuances involved.

Broadly speaking, anger can arise from various primary causes. Personal loss or a feeling triggers it, as does a perceived lack of control. Sometimes, anger stems from a disconnect from reality or denial, while inflexibility and a lack of acceptance can also contribute. Expectations and issues of

Additionally, ego and genetic predispositions can influence how and why we experience this powerful emotion.Interestingly, anger is frequently a byproduct of fear, uncertainty, and a desire for control—elements perceived by our mind as obstacles to fulfilling our desires. Most instances of anger arise from inappropriate attitudes and a lack of acceptance.

The neurological response to anger lasts only a few seconds. However, the real issue lies in holding on to this anger, which

disrupts the natural flow of the universe and corrupts our sensory and cognitive faculties. This prolonged anger can distort our self-perception and the way we view situations, ultimately making us vulnerable.

Legendary Indian tennis players, Leander Paes and Vijay Amritraj, the heroes of many a historic transcending triumph generations, on Sunday became the first two exponents of the sport from Asia to be inducted into the International Hall of Fame. Paes, 51, whose list of achievements include the 1996 Atlanta Olympic Games men's singles eight bronze, men's doubles and 10 mixed grand doubles slam crowns besides several Davis Cup famed victories, was given the rare honour in the 'Player Category'.

Vijay Amritraj, 70, reached men's singles the quarterfinals Wimbledon and US Open twice each besides guiding India to the Davis Cup finals twice -- in 1974 and 1987. At his peak, he was ranked No.18 in the world in singles and No. 23 in doubles. He along with Richard

He is one of only three men in tennis history to capture a career Grand Slam in both disciplines. Paes, who hails from Kolkata, competed in seven straight Olympic Games between Barcelona, 1992 to Rio, 2016, the most

in tennis history. Reflecting on his journey, Paes said, "A few of us are very blessed to be born into legacy. Today, sitting here at the International Tennis Hall of Fame, I wouldn't have ever dreamt it, playing street cricket and street football barefoot back in Calcutta.

"I am so excited to share this with all of you, representing every young boy and girl around the planet who has a dream in their mind, passion in their hearts and fire in their belly," said Paes, who partnered Mahesh Bhupathi in men's doubles and took Indian tennis to great heights before their acrimonious split.

At the moment, no issue with that (adductor niggle), it's fine, it looks good, hoping to remain like that till the Olympics," the coach, who has been with Chopra for close to five years, told PTI in an exclusive interview from Antalya, Turkiye where they are currently based for
