Express coach derailment in UP leaves two dead

wo passengers were killed and 20 injured when eight coaches of the Chandigarh-Dibrugarh Express derailed near Gonda in Uttar Pradesh on Thursday.

A railway bulletin said in the wake of the accident, three trains were being run on diverted route. The diverted trains are 15707 Katihar-Amritsar Amrapali Express, 15603 Guwahati-Jammu Tawi Amarnath Express and 15910 Lalgarh-Dibrugarh Avadh Assam Express.

Gonda District Magistrate Neha Sharma, who reached the spot, said eight coaches of the train got derailed. He said the injured are being rushed to hospital and relief operations are on at the site.

A 40-member medical team and 15 ambulances are at the spot and more medical teams and ambulances are being

rushed there. Commissioner Kumar said.

noise of the coaches leaving the track and toppling over to the left was followed by loud cries of the passengers, especially children. The passengers started coming out of the emergency windows and doors of the tilted sleeper coaches, and some went back to pull out their belongings. In the AC coaches, passengers helped each other break the window panes and pull out those injured or stuck. Passengers had to wade through knee-deep water in the fields on either side of the track to reach the nearby approach road. Others,

shocked by the accident or injured, sat on the track itself, waiting to be rescued. When police teams reached the spot officials made announcements asking people to stay away from the

Army prepares for long haul in Jammu

While gradually inducting more troops on ground zero, the Indian Army is preparing for the long haul ahead of flushing out Pakistani terrorists occupying Jammu Heights'.

Prime Minister Narendra Modi also reviewed the current security situation in Jammu in the wake of number of terrorist attacks in the past weeks. He chaired a meeting of Cabinet Committee on Security (CCS), which includes Defence Minister Rajnath Singh and Home

deployed along the higher reaches of the Kathua district bordering Himachal Pradesh to plug the gaps and block the escape routes of infiltrating terrorists.

Troop deployment is also being reviewed across the frontier districts of Rajouri and Poonch as the region has witnessed repeated ambushes on army trucks and patrol parties since October 2021. The security forces are also contemplating setting up additional posts in the upper reaches of the Doda and Kishtwar districts to block the traditional routes of crossing into the Kashmir valley.

Within days after controversial probationary IAS officer Puja Khedkar was shunted back to her Mussoorie-based alma mater on disciplinary grounds, the police arrested Khedkar on Aanorama Thursday for allegedly threatening some farmers at gunpoint to grab their land at Mulshi taluka in Pune district. Manorama — who had been absconding for nearly a week after a video showing her threatening farmers at Mulshi in a bid to usurp their land went viral — was traced to a small lodge, Parvati Niwas, near Mahad Raigad town in district where the visiting Pune rural police reached and arrested her. Manorama was later brought back to Pune where a court Judicial Magistrate First Class SG Barde remanded her in police custody till July 20. A former Sarpanch (village headwoman) of Bhalgaon in Pune district, Manorama had been staying at the lodge under a fake name of 'Indu Dnyandev Dhakane' with another person identified as 'Dadasaheb Dnyandev Dhakane'. Acting on a complaint lodged by farmer Pandharinath Pasalkar (65), the Paud police had registered a complaint against Manorama and her husband Diliprao Khedkar, both residents of National Housing Society in Baner, and one Ambadas Khedkar of Ambi village in Haveli, and other unidentified persons.

On Wednesday, student protesters demanding reforms in the quota system in government jobs announced plans to enforce a complete nationwide shutdown on Thursday in response to the actions of the security forces. The clashes left at least six people, including four students, dead across the country.

A key coordinator of the movement, Asif Mahmud, in a Facebook post, said all establishments, barring hospitals and emergency services, will remain closed, and only ambulance services will be permitted to operate.

The movement urges students from all educational institutions to participate and calls on guardians to support their cause, a newspaper reported.

Meanwhile, authorities called out the paramilitary Border Guard Bangladesh (BGB) troops in four major cities after hundreds of policemen in riot gear fanned out in public university campuses across the country.

In the 2024 Lok Sabha elections, the party lost its parliamentary majority, securing 240 seats, a decrease of 63 seats compared to their 2019 performance. Notably, in the crucial State of Uttar Pradesh, the party's seat count dropped from 61 in the previous term to 33 in this election.

"During the holy month of Shravan, many people, especially Kanwariyas, abstain from certain food items in their diet," the Muzaffarnagar Police stated through its

social media posts. "In the past, such instances have come to light where some shopkeepers selling all types of food items on Kanwar Marg named their shops in such a way that it created confusion among the Kanwariyas and created a law and order situation.

To prevent such a recurrence, hotels, dhabas and shopkeepers selling food items on Kanwar Marg have been requested to voluntarily display the names of their owners and employees... This system has been prevalent in the past, too," the advisory

further said. The fresh advisory came after the administration's earlier order asking eateries, including roadside carts, to display the names of the owners in front of their shops faced severe criticism. Police personnel had also started to enforce the order.

that messaging application may also be investigated (on) why they did not accept my request despite my specific complaint. Later on I realised that the accused persons has used forwarded my calls to his number," read the FIR.

"It is surprising that the mobile network service provider did not even ask whether I was sure about it and in micro seconds forwarded my call to some unknown number which was not even in my contact list," it said. The judge said the issue will

also be raised with the Telecom Regulatory Authority of India.

HC reserves order on Kejriwal's plea for additional meetings with lawyers

The Delhi High Court on Thursday reserved its order on a plea by Chief Minister Arvind Kejriwal, arrested in Delhi excise scam cases, seeking additional virtual meetings with his lawyers, a move both the Enforcement Directorate (ED) and the Tihar jail authorities contested while insisting the law was equal for all.

The AAP leader's counsel submitted he was facing around 35 cases across the country and, for a fair trial, he required two additional meetings with his lawyers via video conference to discuss the issues.

Opposing Kejriwal's petition, Tihar jail authorities contended there are many prisoners who have 100 cases pending against them and they are allowed only two meetings with their lawyers but are still managing with it.

The Enforcement Directorate (ED) alleged that Kejriwal was

using his meetings with lawyers for sending out instructions to

the ministers of the Delhi government. Having heard the contentions of the parties, Justice Neena Bansal Krishna said she was reserving the order which

will be passed in chambers. While opposing Kejriwal's petition, the counsel for the jail authorities said he initially sought only two additional physical meetings with his lawyers and now he wanted two more virtual meetings. The change of mode cannot change the rule which allows a prisoner to have only every week. The ED's counsel said similar prayers were made before a division bench of the high court in a public interest litigation but the prayer was rejected. The Delhi prison rules are far more liberal as compared to rules elsewhere in the country, the lawyer said, adding all prisoners in Delhi jails are treated equally and all get to meet their lawyers twice every week. ¬he Delhi Police has arrestd twelve men for allegedly stealing 3.5 crore from a transporter's office at gun-point in north Delhi's Gulabi Bagh area.

According to the police on Thursday, the incident took place in the Kishanganj area last week when a few persons entered the transporter's office and robbed him at gunpoint.

Deputy Commissioner of Police (north) Manoj Kumar Meena said that the police has recovered 1.5 crore and while eight people were arrested on Thursday in connection with the robbery, four were nabbed earlier.

"On July 11, a PCR call was received in Police Station Gulabi Bagh regarding robbery of cash at a transport



company office in Kishanganj area. On enquiry it was found that July 11 at about 10:45 pm about seven to eight persons having their faces muffled and carrying guns and knife, forcefully entered office of Bikaner Assam Roadlines India Ltd and surrounded present staff in the office.

They snatched keys of the safe and robbed 30 lakhs kept in the locker and fled from the spot," the DCP stated.

The pollution in Delhi has become so severe that it has reached the level of a public health emergency. Gupta stated that the deterio-

rating air quality has severely impacted the health of our citizens, causing a continuous decline in the quality of life. In the letter, Gupta mentioned that despite the gravity of this crisis, the Aam Aadmi Party government in Delhi has failed to propose or implement any effective solutions. Instead, they have been busy blaming the BJP, completely neglecting their responsibilities towards the people of Delhi. Over the past decade, there has been a complete lack of constructive strategies to tackle this prob-

Citing an RTI, Gupta wrote that shocking information has come to light regarding the status of the Delhi Pollution Control Committee (DPCC). The RTI revealed that by June 2024, the number of DPCC employees had reduced to 107 regular employees and 87 contract employees, significantly lower than the previous year's figures. Last year, there were 111 regular employees and 122 contract employees.

Noting the significant reduction in staff, Gupta stated that this means the DPCC is currently operating with only 54 per cent of its sanctioned capacity, severely hampering its ability to effectively address serious pollution challenges in the city. The people of Delhi are bearing the brunt of this, with pollution-related diseases such as asthma, cough, and allergies making life difficult.

CM meets Union Minister Gadkari, demands approval for infrastructure expansion projects

Chhattisgarh Chief Minister Vishnu Deo Sai on Thursday met Union Road Transport and Highways Minister Nitin Gadkari and discussed significant infrastructure projects aimed at enhancing connectivity to promote economic growth in tribal regions.

Sai proposed new national highway projects to make road transport in the state more accessible and convenient, increasing direct connectivity to tribal areas. The Union Minister has

eportedly gave necessary instructions to the officials concerned. During the meeting at the

Union Minister's residence, Sai focused on the urgent need to expand the national highway network in the state to connect remote tribal areas with major economic centers. Deputy Chief Minister

Arun Sao and Chhattisgarh Finance Minister O P Chaudhary, Secretary to the Chief Minister P Dayanand, Rahul Bhagat, Public Works Department Secretary Kamalpreet Singh and other department heads and officials of the central government were also present in the meeting. Pointing out that currently, Chhattisgarh has 20 national highways spanning a total length of 3,575 km, the Chief Minister said that for the social and economic development of the state there is a necessity to declare additional roads as national highways and to upgrade and widen the existing routes. The Chief Minister mentioned that Chhattisgarh has sent proposals for 13 works worth Rs 1,383 crore to the Ministry under the Central Road Fund in the



year 2024-25 and sought timely approval for these projects.

The Chief Minister also gave proposals for two new national highways. Raigarh-Dharamjaigarh-Mainpat Ambikapur-Uttar Pradesh border and Kawardha-Rajnandgaon-Bhanupratappur-Antagarh-Narayanpur - Gidam -Dantewada-Sukma. Raigarh-Dharamjaigarh-Mainpat Ambikapur-Uttar Pradesh border: The proposed 282-kilometer route starts from Chhattisgarh's Raigarh (NH-49) and connects Mainpat, district and divisional headquarters Ambikapur (NH-43) via Dharamjaigarh and reach Uttar Pradesh border via Wadrafnagar. Foreign Secretary Vikram Misri will pay a two-day visit to Bhutan beginning Friday, in his first trip abroad after assuming charge of the top post.

In Bhutanese capital Thimphu, Misri will meet Prime Minister Misri will meet Prime Minister Tshering Tobgay, Foreign Minister DN Dhungyel and Foreign Secretary Pema Choden among others, the Ministry of External Affairs (MEA) said while announcing the visit.

The foreign secretary's visit underscores the "highest pri-ority" the government of India attaches to its 'Neighbourhood First' policy, it said. Misri will also receive an audience with Bhutanese King Jigme Khesar Namgyel Wangchuck, accord-ing to the MEA. \In their talks, Misri and

Choden are expected to carry out a comprehensive review of the bilateral ties, including issues having mutual security interests, people familiar with the visit said.

'Foreign Secretary Vikram Misri will pay an official visit to Bhutan from July 19-20, which will be his first visit abroad after taking over as the foreign secretary," the MEA said.

"During the visit, Foreign Secretary Misri will receive an audience with His Majesty The King of Bhutan. He will call on the Prime Minister, Minister of Foreign Affairs and External Trade, and meet the foreign secretary and other senior officials of the Royal Government of Bhutan," it said.

The MEA said the two foreign secretaries will also co-chair the India-Bhutan development cooperation talks. "The visit is in keeping with the

tradition of regular high-level exchanges between India and Bhutan, and underscores the highest priority Government of 'Neighbourhood First' Policy," it said in a statement. Last month, the Bhutanese

Prime Minister was among the leaders of seven countries from India's neighbourhood and the Indian Ocean region who attended the swearing-in cere-mony of Prime Minister Narendra Modi and the Union

council of Ministers. Misri's visit to Thimphu also comes against the backdrop of China and Bhutan looking at an expeditious resolution of their festering boundary row that could have implications for India's security interests.

Around 10 months back, Bhutan's then Foreign Minister Tandi Dorji held talks with his Chinese counterpart Wang Yi in Beijing.

A Chinese readout on the talks said Bhutan firmly abides by the one-China principle and stands ready to work with China for an early settlement of the boundary issue.

New Delhi has been keeping a close eye on the negotiations between Bhutan and China on their boundary row as it could have implications for New Delhi's security interests, especially in the Doklam tri-junction.

In August last year, China and Bhutan agreed to expedite and take simultaneous steps to implement a "three-step roadmap to resolve their festering boundary dispute.

In October 2021, Bhutan and China signed an agreement on the "three-step roadmap" to expedite negotiations to resolve

their boundary dispute. The signing of the pact came four years after the Indian and Chinese armies were locked in a 73-day stand-off at the Doklam tri-junction after China tried to extend a road in the area that Bhutan claimed belonged to it.

The India-China stand-off in the Doklam plateau in 2017 even triggered fears of larger conflict between the two neigh-Bhutan had said the area belonged to it and India supported the Bhutanese claim.

Citing Periodic Labour Force Survey Series, Ramesh said the average real earnings over time have stagnated between 2017 and 2022 across all employment types - salaried workers, casu-



al workers, and self-employed workers He further cited data from Centre for Labour Research and Action to claim that real wages of brick kiln workers have stagnated or declined between 2014 and 2022. Conviction in child marriage cases still low, says report

The conviction rate under the Prevention of Child Marriage Act stands at 11 per cent while for all other crimes against children it is 34 per cent, according to a new report. In 2022, out of the total 3,563 child marriage cases listed for trial in courts under the Prohibition of Child Marriage Act, a mere 181 cases were successfully concluded in terms of trial completion.

Despite the fact that there are 3,365 cases pending, with the current rate of disposal, the country may take 19 years to clear the backlogs as of 2022, according to a report by the India Child Protection (ICP) research team which was released by child rights body the National Commission for Protection of Child Rights

The total number of child marriage cases registered during the last five years was less than the number of girl child marriages taking place in a single day in the country, according to a new study. On an average, only one case of child marriage per district was registered for pros-ecution in 2022.

The report said the official data has showed that out of 63,513 children of kidnapping and abduction who were recovered in 2022, 15,748 (25%) were kidnapped and abducted for the purpose of either 'marriage' or 'illicit intercourse'. Of this, 15,142 children recovered in 2022 were kidnapped solely for the purpose



of marriage. This report used a multi-faceted approach, combining primary data gathered at the village level through engagement with key stakeholders, including Panchayati Raj Institution functionaries and NGO activists involved in child protection initiatives.

Secondary data from the National Family Health Survey-5 (NFHS-5) and the Crime in India Reports published by the National Crime Records Bureau (NCRB) from 2018 to 2022 were analysed, along with an extensive literature review to enhance understanding of the barriers to child marriage elimination efforts and their impact on children, particularly girls. The primary data was collected from a sample of 1,132 random villages across 20 districts of Assam, encompassing a total population of 21 lakhs and a

child population of 8 lakhs. The report said 81 per cent reduction in the instances of child marriage between 2021-22 and 2023-24 in the state.

In absolute numbers, the incidence of child marriages in the

study villages has declined from 3,225 cases in 2021-22 to 627cases in 2023-24.

In 30 per cent of the villages surveyed in Assam, child marriage has been completely eradicated. Additionally, 40 per cent of villages reported a significant decline in the occurrence of child marriage.

The study said 98 per cent of the respondents believed that the Assam government's strict law enforcement initiatives in 2023 had a substantial and striking influence on the reduction of child marriages within their communities.

The overwhelming majority of respondents acknowledged the effectiveness of stringent enforcement measures in curbing child marriage.

In 12 districts, out of 20, over 90 per cent of respondents believe that taking legal action such as arresting individuals and filing FIRs in cases related to child marriage can effectively address the occurrence of such cases. Overall, the same percentage for all 20 districts stands at 72 per cent.

SC orders release of YouTuber jailed in TN

The Supreme Court on I Thursday ordered the release of YouTuber 'Savukku Shankar who was detained under the Goondas Act in May by the Tamil Nadu Police. Granting the interim relief to Shankar currently lodged in the Coimbatore Central Prison, a bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah said it would not decide the case on merit as Madras High Court is seized of the matter.

The bench recorded the submission of lawyers appearing for the parties that they will mention the matter before the Chief Justice of the High Court or before the appropriate bench on Monday or Tuesday seeking to expedite the hearing in the matter.

"We are definitely of the view that the petitioner has no hands in the delay caused in the matter. In the peculiar facts, the petitioner be released



till the case against detention asked is decided by the high court," the bench said while clarifying that its order pertains only to the preventive detention mat-If the petitioner is in jail in any

other case, this order will not affect that, the bench said. The top court was hearing an appeal challenging the Madras High Court order adjourning the habeas corpus petition that was filed by Shankar's mother challenging his detention under the Goondas Act. At the outset, the apex court

Based on the orders of Commissioner of Police, Greater Chennai, Sandeep Rai Rathore, the detention order under the Goondas Act was served on Shankar by a cyber crime (Chennai) police inspector on May 12.

There are seven cases pending against Shankar in Chennai police's central crime branch/cyber crime out of which three are under investigation, charge sheets have been filed in two and the remaining are pending trial, according to a Chennai police press note. Shankar, 48, was arrested by Coimbatore police on May 4 for alleged derogatory statements about women police personnel/police officials in

an interview to a YouTube channel.

Other cases Shankar faces include one for possession of ganja, which was registered by Theni police.





has Landslide disrupts traffic on Goa-Karnataka route

PTI PANAJI landslide occurred in a ghat section of Alandslide occurred in a gnat section of Goa in the wee hours of Thursday following incessant rains, disrupting vehicular traffic movement from the state to neighbouring Karnataka, police said.

The India Meteorological Department (IMD) has issued an 'orange alert' for Goa, predicting heavy rains in the next 24 hours. In the last one day, both North Goa and South Goa districts received heavy showers. Ponda taluka in South Goa

received the highest 190 mm rainfall, according to the IMD. The landslide occurred near Dudhsagar Temple at Anmod Ghat, located on the southern boundary of Goa, leading to Karnataka, a police official said. Traffic movement from the ghat section to areas like Belgaum and Khanapur in Karnataka was disrupted, he said.

"A huge pile of mud was seen on the road near Shree Dudhsagar Temple in the ghat region. Personnel of the fire and emergency services rushed to the spot to clear it, but it could not be removed till morning," he said. Traffic movement through the Anmod Ghat will remain closed at least till the afternoon, the official said. Anmod Ghat is an important link between Goa and Karnataka, used for going to Belgaum and Khanapur in Karnataka and Kolhapur in Maharashtra. Several vehicles were seen lined up in the ghat section after the incident, as per sources. Police were stopping the vehicles at Mollem check post, alerting travellers about the landslide.

Many vehicles carrying essential items like

milk and vegetables pass through this route. Goa continued to receive heavy rains on Thursday amid the 'orange' alert.

The IMD bulletin said heavy rains at scattered places with very heavy showers at isolated places are expected along with strong surface winds over North Goa and South Goa districts.

The Gujarat Anti Terrorist Squad (ATS) has busted a mephedrone manufacturing unit on the outskirts of Surat city and seized drugs and raw materials of Rs 51.4 crore, an official said on Thursday. Three persons — Sunil Yadav,

Vijay Gajera and Haresh Korat — have been arrested in this connection, an ATS release said.

It was found that the three persons had hired an industrial shed at Kareli village in Palsana taluka of Surat district on a monthly rent of Rs 20,000 to manufacture mephedrone, also known as MD drugs, using various materials, it said.

The ATS officials recently received a tip off that Yadav, Gajera and Korat were involved in manufacturing mephedrone at the shed in Kareli and selling it to

Mumbai resident Saiyad, the release said.

Based on the information, a team of ATS raided the shed in Darshan Industrial Area of Kareli on Wednesday night and apprehended Yadav and Gajera from the spot while Korat was nabbed from a place in Junagadh in the early hours, it said.

The ATS recovered kilograms of mephedrone and 31.4 kg of raw materials valued at Rs 51.4 crore from the unit, which was sealed after the raid, the release said. A preliminary probe indicated Yadav was into chemical trading business and learnt the technique of manufacturing mephedrone from the Internet.

The three persons came started together and manufacturing the drug at the shed and had already delivered 4 kg of mephedrone to Saiyad some time back, the release said, adding further probe was on into the case.

Bill of woes

Karnataka Govt puts local job quota bill on hold after the State's IT industry reacts strongly

he Karnataka government has put on hold a bill requiring reservations for locals in the private sector following significant backlash from the industry. The Government will reconsider the bill before presenting it to the state Assembly. This decision came just hours after the state cabinet approved the bill, which proposed reserving 50 per cent of management positions and 75 per cent of non-management positions for Kannadigas in the private sector. The Karnataka State Employment of Local Candidates in the Industries, Factories, and Other Establishments Bill, 2024, was to be presented in the Assembly on Thursday. Chief Minister Siddaramaiah, along with his ministers, praised the bill, emphasising their "pro-Kannada" stance and stating that their main priority is to "ensure the welfare of Kannadigas." However, the bill met with tough resistance from the IT industry that criticised the bill, arguing that it would hinder the growth of the tech sector in Bengaluru and negatively affect the IT industry in Karnataka. The



rationale behind the bill was to address the high unemployment rates among the state's residents and to ensure that local talent is given priority in job opportunities within Karnataka.

But industry leaders felt that a quota system for locals would hinder the ability of companies to hire the best talent available, potentially compromising their competitiveness and productivity. Besides, if implemented this bill would have legal and constitutional issues. The bill could violate the right to equality and freedom of movement, as enshrined in the Indian Constitution and could face significant hurdles in courts, leading to prolonged legal battles. Furthermore, the proposed

bill raised concerns about increasing regionalism and social tensions. It was feared that such a policy could create divisions between locals and non-locals, leading to a less cohesive society and potential conflicts. According to a report by the Federation of Indian Chambers of Commerce (FICCI), Karnataka's overall unemployment rate is 2.7%, which is lower than the national average of 4.2%. But these figures hide the low employability of the local populace. But to correct it with populist measures is not the best solution. Instead of mandating job reservations, the Government should focus on improving education and skill development programs for locals. Enhancing the quality of education and providing better vocational training could empower local youth to compete effectively in the job market. Now that the bill has been withdrawn it could come back later in a different form. The decision to put the bill on hold has significant political implications. The Karnataka Government has averted a standoff with the IT industry and other businesses but it may disappoint its support base which was expecting job opportunities. Nonetheless, suspending the bill will likely reassure businesses and investors. But the Government will have to focus on providing employable skills to locals, so that they could get employment in Karnataka's IT industry.

The price paid at the human level cannot be comprehended through the aid of books, cinematography, or visuals. As the generation that experiences it gradually passes away, the tremors of partition remain. This cannot be done well as a method of problem-solving for contentious issues. One wonders if the realization is sufficiently around to the effect that 'enough is enough'. The hatchet needs to be buried before the agony continues to reign with many real forms of misery. The

The harsh reality of child labour in rural Bihar



Despite Government efforts, the economic realities force families to make children work, often resulting in their exploitation

Raiju (name changed), an 11-year-old boy **B**^{an} Telia village in Kudhni block, 22 km from Muzaffarpur in Bihar, wakes up every morning like other children. However, instead of going to school, he heads off to work as a labourer, a burden he has borne for the past three years. Baiju, who belongs to the Mahadalit community, used to attend school. Life changed after his father's death, as he was forced to drop out of school and start working to support his family. He explains that his mother's meagre income is not enough to sustain the six members of their family. Consequently, he had to give

up his education and begin working. She does not have enough money to educate her children, forcing her to send Baiju to work.

Child labour is a grave issue affecting millions of children worldwide, and in our country, it has reached alarming proportions. According to a UNICEF report based on the 2011 census, there are approximately 10.1 million child labourers in India, including 5.6 million boys and 4.5 million girls. Most child labour- the family with his income may not have official statistics



ers can be found working in domestic services, tea shops, and brick kilns. In India, child labour is more prevalent in rural areas compared to urban ones. Children from socially and economically disadvantaged communities are often compelled to work in these areas, stripping them of their fundamental right to

education and perpetuating the cycle of poverty. This not only obstructs their education but also hampers their overall development. Children should be in school

and playing, not toiling as labourers. Pinki Devi (name changed), a 45-year-old resident of Telia village, has two children who have left school to work as labourers. She explains that her husband, a daily wage labourer, is often ill. In such a situation, it became impossible to support

alone, forcing her to send her children to work. Social worker Phuldev Patel points out that children from the most economically vulnerable Dalit and Mahadalit communities are predominantly involved in child labour. The dire economic conditions of their house-

holds compel them to abandon their education and start working. He asserts that the actual number of child labourers is significantly higher than what official statistics reveal

The government provides free books, notebooks, uniforms, and mid-day meals under the Right to Free and Compulsory Education to encourage children to attend school. However, the harsh economic realities overshadow these provisions, pushing children into labour. He further notes that human traffickers exploit this vulnerability, selling children as labourers in other states.Local journalist Amritanj observes that, like Telia village, there are numerous remote rural areas in Muzaffarpur where children work as labourers. He notes that the government

on this issue because it is carried out in a highly systematic manner. Although the strict child labour laws and the vigilance of the local administration have reduced the rate of child labourers in recent years, it has not been entirely eradicated. Even today, children can be seen working in brick kilns, tea shops, grocerv stores, construction sites, and as domestic helpers. As in previous years, this year too, the World Day Against Child Labor was observed on June 12 in India and around the

world. When children in a society begin working as labourers at a young age instead of attending school, it prompts deep introspection within that nation and its society. They must confront why a child is forced to abandon books for labour. When a child's right to childhood, is denied, and they are thrust into labour, they endure physical, mental, and social exploitation, transforming their childhood into one marred by labour-an ordeal known as child labour.

FIRSTCOLUMN FALLOUT OF TRUMP'S ASSASSINATION ATTEMPT

It could have far reaching implications for the US presidential elections and the US politics

A week is a long time on the volatile chessboard of global affairs, however, the recent assassination attempt of former United States of America President Donald Trump would leave a deep impact on future courses of action. While several European leaders and some in the Middle East have been subjected to violent life-threatening attempts in the recent past, the bullet grazing past former president Trump's ears has left a shrill range of questions for world leaders. It may be too early to predict whether the assassination attempt would translate into a landslide victory for Donald Trump who is facing a rematch with current President Joe Biden in the November polls.

The Democrats in the US are a divided lot, with many leaders, internally questioning President Joe Biden's pitch for a second shot to the Oval Office, given his several public gaffes related to his age. Most of the public debates in the US and several other think tank zones across the world, have been debating President Biden's mental alertness and, if elected for a second time he would be able to complete his full four-year term. Any midway change due to a severe illness, which is being anticipated, would be a dampener for the US President's bid for a second run. Much like in every significant democracy, including India, the electorate in the US is a divided lot, with a deep gorge running right through the middle of the supporters of Trump and Joe Biden. The Democrat's attack on Trump and his supporters has been on the lines similar to what the opposition parties in India rallied around, during the recently concluded parliamentary elections.

The key message to their voters is to save the country from dictatorial forces (Trump /PM Modi), who will upend the constitution under their larger-than-life cult status leaders. This created a rift in the electorate, in an already ruptured society, constantly fed with an ocean of information primarily on social media, sending conflicting versions of the same events. Politics and rhetoric apart, it would be an interesting prism to watch the social messaging playing out with Trump coming back to the battlefield (election campaigns), after, he left the stage in Pennsylvania, with an iconic raised fist, and the US flag flying in the background. The pic-



ture is likely to define the resilience of the US democracy for a long time to come. Mr Trump in his few interviews, seems to have humbled down from the life-altering event, where he almost ended up being in the coffin rather than the Oval Office. It would be worthwhile to watch out if the former President sobers down on some of his key manifesto items such as immigration and freedom to choose (including the right to possess firearms for self-protection). Immigration would be a closely watched topic from a global perspective, including India, where the largest chunk of immigrants land on US shores through legal or illegal routes. Donald Trump's Vice President choice J D Vance has a spouse who is a PIO. His wife's parents are immigrants from Andhra Pradesh and in a way, the choice defines the pluralistic nature of American Society. It would be a long shot to assume that if Trump gets a second term, his views and policies on immigration would be sobered due to his VP. Similarly, a Trump comeback could have a farreaching impact on bilateral trade relations especially with India. One may argue that India has bipartisan support in Washington DC on several defence and technology partnerships, carefully nurtured over a decade by PM Modi.PM Modi is perhaps the only PM, who has worked with three US Presidents in the last decade and is likely to see one of his former friends either Trump or Biden coming back in November. It may be uncertain times, however, the past relationships and promise for securing the future of the Indo-Pacific should be a super glue to hold India's US relationship under a new regime.

Rising political violence and struggles in the US -

The attack on Donald Trump underscores the nation's turbulent political climate raising concerns about the stability of American democracy and society.

s the United States hurtling towards an internal civil war? Alex Garland's recent film 'Civil War,' which premiered earlier this year, depicts a fictional yet chillingly plausible sce-nario of such a conflict. This leads us to consider whether the repercussions of USinitiated wars in recent decades, aimed at maintaining supremacy, now echo omi-nously at home, haunted by the spectres of those who perished globally. That is the inexorable wheel of karma. The shocking assassination attempt on former President Donald Trump at a rally in Butler, Pennsylvania, thrusts this issue into stark relief. In the aftermath, numerous conspiracy theories swirled around the incident, casting a spotlight on secret agencies whose heads have publicly voiced criticism against Trump. A police sniper had photographed the shooter, Thomas Matthew Crooks, just half an hour before the 20year-old opened fire on Trump during the rally, suggesting multiple missed opportunities to prevent the attempted assassi-nation, as reported. Despite the attack, Trump's political stature has only strengthened, evidenced by his selection of Republican Senator JD Vance as his running mate for the 2024 presidential elec-tion. Once a vocal critic of Trump, Vance now stands as a staunch ally, vigorously defending him and endorsing his policies. The incident, which reshaped Trump's political narrative—where a bullet grazed his ear—left him wounded but resolute. This assault, though shocking, accentuates a longstanding history of political violence in the United States, a phenomenon entrenched since the nation's inception. Abraham Lincoln, the 16th president, was the first to be assassinated, shot by John Wilkes Booth in 1865. Lincoln's support for Black rights during the Civil War, marked by the Emancipation Proclamation, has been cited as a motive for his assassination. Subsequent presidents, including James Garfield, William McKinley, and John F. Kennedy, also fell victim to such violence, with Garfield being shot in 1881, McKinley in 1901, and Kennedy in 1963.

Each of these assassinations profoundly impacted the nation and its political structure. Political violence has not been confined to presidents alone. Presidential candidates like Robert F. Kennedy and THAT NORMALISE George C. Wallace were also targeted, with Kennedy being killed in 1968 and Wallace being left paralyzed in 1972. Presidents like Gerald Ford and Ronald Reagan survived assassination attempts, highlighting the persistent threat of violence in American politics. The United States today exemplifies how a state structure can deteriorate when policymakers focus more on external affairs, neglecting internal issues. For instance, the fentanyl crisis devastates U.S. communities, with toddlers and infants increasingly falling victim to the potent opioid, which is 50 times stronger than heroin, according to public health experts. While adults account for the majority of fentanyl-related deaths, more children under 5 are either dying or ending up in emergency rooms after testing positive for the drug, due to accidental ingestion or exposure at home. The number of child overdoses has surged even as overall drug overdose rates in the country have declined recently. California leads in total fentanyl deaths, with 6,473 reported in 2022, while West Virginia has



the highest death rate per capita. This is a prime example to understand how the internal structure is falling apart. This cannot be stopped by exporting ammunition stocks and advanced weaponry to Ukraine and Israel through front channels while to other proxy wars in Africa and elsewhere through back channels. In societies, the root issue often isn't just institutions but the erosion of core values. Without a cohesive value system, managing politics becomes daunting.

This dilemma arises: while progress demands new values, preserving core societal values is crucial for stability and harmony. Neglecting this balance risks societal chaos and moral crisis. The inevitable decline, akin to the set-ting sun, cannot be halted by force alone. The political climate in the United States reflects the consequences of its global actions, suggesting a looming downfall through unpredictable events. Trump is a product of long-standing policies that have often ignored domestic ramifications.

He represents a symptom, not the cause, of the systemic issues within American politics, stemming

such detectors can rapidly triangulate and locate a shooter. The shooter, Thomas Matthew Crooks, used a gun that was legally purchased by his father, which he had access to at a gun range the previous Friday. Questions arise about whether the gun was bought specifically for him, as Pennsylvania law allows 20-yearolds to buy guns. Initial gunfire originated from the shooter's position, with subsequent bursts detected from unidentified sources, as reported by news sources. Despite Secret Service snipers reportedly firing a single shot to neutralise the threat, discrepancies with acoustic evidence persist, necessitating further scrutiny of ballistic recordings for clarity. Questions arise over security failures allowing a 20-year-old to breach measures and reach a rooftop near Trump, firing multiple shots. Thomas Matthew Crooks, identified as the primary shooter, raises speculation about a potential second shooter. Described as a loner without a social media presence, Crooks' unexpected role and the presence of explosives in his vehicle suggest possible exploitation. Criticism of rally security focuses on inadequate building coverage, allowing the shooter an unimpeded view of Trump, and exposing significant security vulnerabilities. These shortcomings emphasise systemic flaws in pre-event security protocols and the need for rigorous reforms. Political violence, however, has rarely solved the issues it aims to address, often creating a climate of fear and leading to further crackdowns on dissent. Historically, such violence

has only resulted in cycles of disaster, undermining the causes it purported to support. What we can see is that nihilism pervades American culture, dealing a fatal blow to its cultural and spiritual development. This decline in values undermines democracy itself. Democracy, while liberating individuals from traditional constraints, necessitates self-judgement—a task hindered by the erosion of traditional Western values. Without a genuine guiding societal value system, the state structures of any nation inevitably falter in fulfilling their role in shap-ing individual decisions.

The collapse of collective ideas correlates closely with societal institutions and behaviours. As Wang Huning, a leading Chinese politi-cal theorist, argued in his book 'America Against America," "The American spirit confronts pro-found challenges, compounded by the younger generation's unfa-miliarity with traditional Western values. This spiritual shift raises critical questions about its impact on societal development and governance." The viability of any social system hinges not solely on legal frameworks but on collective belief in fundamental values guid ing behaviour. If these values falter, the sustainability of the social order is called into question. The attempt on Trump's life demands a reevaluation of rhetoric and policies that normalise political violence. The incident calls for a reevaluation of gun laws and the broader societal acceptance of violence as a means to resolve conflicts. All sides of the political divide must recognise the danger of escalating violent rhetoric and its potential to incite further violence. This incident serves as a wake-up call to address the deeper issues within American society and politics, emphasizing the need for a shift towards reasoned discourse and humane policies. Ironically, America has been compelled to a point where it can't afford to lose Trump.

RTI implementation faces challenges as the CIC is short of staff

Despite the formation of a new government, vacancies remain unfilled, exacerbating delays and overwhelming the few remaining commissioners

n September 13 last year, the Central Un f o r m a t i o n Commission (CIC) admitted a second appeal from this columnist under Section 19 (3) of the RTI Act, 2005. The appeal, apart from seeking imposition of penalty on the CPIO, for denial of information, also contained a few relevant suggestions for better implementation of the Act. However, on November 6, Ms Punhani, Saroj the Information Commissioner who dealt with cases for that particular ministry retired at the end of her tenure. On the same day Uday Mahurkar, another Information Commissioner retired, whereas their colleague Suresh Chandra had retired two days earlier. Several other

Information Commissioners like Ms. Vanjana N. Sarna, Neeraj Kumar Gupta and Dr. Amita Pandove had retired earlier last year at the end of their respective tenures. Y. K. Sinha, the Chief Information Commissioner, retired on October 3 whereupon Heeralal Samariya, the Information Commissioner was elevated to the position of Chief Information Commissioner.

Commission plummeted to a mere three by the end of 2023, from the maximum permissible ten at the beginning of the year. Even after the formation of the new government last month, little interest has been shown in filling up the vacancies that exist. The reduction in the strength

of the Commission has led to a proportionate overload of second appeals and complaints at CIC Bhawan. The second appeal of this columnist, already pending for ten months, is likely to see an indefinite waiting period. The outcome could hardly be compared with a long wait in the judiciary. been satisfactorily disposed at tion violated he deflected the matter saying the file was under submission (there is no such ground for denying information under the RTI Act, 2005 even if the file is submitted with the PMO or Rashtrapati Bhawan).

the November 5 presidential election. He said the world saw a spirit that could "never be broken". "In that moment, my father didn't just show his character, he showed America's character when he stood up with blood on his face and the flag at his back. The world saw a spirit that could never be broken," Trump Jr, a businessman said. He said the US came "millimetres away" from one of its darkest moments.

"A brave firefighter died, others were injured, and as those bullets rained down, we came millimetres away from one of the darkest moments in our nation's history," he said. He said after the assassination attempt, the Republican pres-

President Joe Biden has tested positive for COVID-19, halting his campaign at a critical juncture in the presidential election when he was facing increasing pressure about his health and concerns about his viability as a candidate.

I'm sick," Biden, 81, wrote on X. Biden tested positive for COVID-19 on Wednesday, disrupting a key campaign event in Las Vegas meant to shore up support with Latino voters.

"He is vaccinated and boosted and he is experiencing mild symptoms, White House Press Secretary Karine Jean-Pierre said in a statement.

Biden has returned to his home in Delaware where he will self-isolate and will continue to carry out all of his duties fully during that time. The White House will provide regular updates on the president's status as he continues to carry out the full duties of the office while in isolation, she said. The president was scheduled to

speak at the Unidos event in Las Vegas on Wednesday afternoon

'His symptoms remain mild, his respiratory rate is normal at 16, his temperature is normal at 97.8 and his pulse oximetry is normal at 97%. The President has received his first dose of Paxlovid. He will be self-isolating at his home in Rehoboth," the White House said.

"I feel good," Biden told reporters, as he boarded Air Force One in Las Vegas to fly back to his beach house in Delaware. He was not wearing a mask, nor were the people closest to him on the tarmac. It's unclear where and when the president contracted COVID-19. But the sudden diagnosis will place him behind closed doors at a time when Democratic lawmakers have been clamouring to see him out front.

Centres for Disease Control and Prevention (CDC) recommends staying home until the infected person has been with-out a fever - with no feverreducing medicine - for at least 24 hours and symptoms have been improving for 24 hours. It then recommends wearing a

mask for five days after. The president's physician, Dr Kevin O'Connor, said that Biden "presented this afternoon with upper respiratory symptoms, to include rhinorrhea (runny nose) and nonproductive cough, with general malaise"

Public failed by UK govt, finds damning **COVID** inquiry

Court: Closing arguments in espionage trial of WSJ reporter will be Friday Yekaterinburg (Russia) (AP):

Closing arguments in the espi-onage trial of US journalist Evan Gershkovich will be held Friday, a Russian court said, as the proceedings picked up speed in a case that has seen the reporter held in pre-trial custody for over a year.

Gershkovich attended a trial session for a second day behind closed doors on Thursday, the court said. He faces charges that he, his employer and the US government vehemently denv

Unlike previous sessions in which reporters were allowed to see Gershkovich briefly before the proceedings began, there was no access to the courtroom and he was not seen, with no explanation given. Espionage cases are typically shrouded in secrecy.

Gershkovich, 32, was arrested on March 29, 2023, while he port ησ trin Authorities claimed, without offering any evidence, that he was gathering secret informa-tion for the US. The Americanborn son of immigrants from the USSR. Gershkovich is the first Western journalist arrested on espionage charges in post-Soviet Russia.

Seoul (AP): South Korea's top court ruled Thursday that samesex couples are eligible to receive the same health insurance benefits as heterosexual couples, a land mark verdict hailed by human rights groups. The Supreme Court said it ruled that the state health insurance agency's refusal to provide spousal insurance coverage for gay couples was an act of discrimination that violates the constitutional principle of equality Thursday's ruling is final and cannot be appealed. "Today's ruling is a historic vic-

tory for equality and human rights in South Korea," Amnesty International said in a statement. "The court has taken a significant step towards dismantling systemic discrimination and ensuring inclusivity for all." A legal battle between a gay couple, So Seong-wook and Kim Yong Min, and the National Health Insurance Service began after the insurance agency revoked So's registration as a dependent of Kim, prompting So to file an administrative suit.In 2022, the Seoul Administrative Court ruled in favour of the insurance agency. Seattle police fire officer who said Indian student killed had 'limited value' fired

New York/Seattle (PTI): A US police officer, whose insensitive comments and laughter following the horrific death of a 23vear-old Indian student had caused outrage, has been fired from the Seattle Police Department.

Jaaĥnavi Kandula was struck by a speeding police vehicle driven by Seattle Police Officer Kevin Dave as she was crossing a street on January 23 last year. Dave was driving at more than 119 kmph on the way to a report of a drug overdose call. Kandula was thrown 100 feet when she was struck by the speeding police patrol vehicle.

In bodycam footage released by the Seattle Police Department, Officer Daniel Auderer was heard laughing after the deadly crash and had remarked: "Uh, I think she went up on the hood, hit the windshield, and then when he hit the brakes, flew off the car...But she is dead." After making these comments, Auderer "laughed hard for four seconds," the department's Disciplinary Action Report said. Auderer's body-worn camera also captured him saying, "Yeah, just write a check. Just, yeah (laughter). USD 11,000. She was 26, anyway. She had limit-

ed value." When asked at an Office of Police Accountability interview about his comments that Kandula had "limited value",

NASA cancels its moon rover mission

Washington (AP): NASA has said that it is cancelling its water-seeking moon rover, citing cost overruns and launch delays.

The Viper rover was supposed to launch in late 2023 aboard a lander provided by Astrobotic Technology, but extra testing and increased costs kept delaying the mission, threatening other projects, the space agency said on Wednesday. The rover had aimed to explore the moon's south pole. About \$450 million had been spent so far on its development,

The announcement comes days before the 55th anniversary of the Apollo 11 mission, which landed Neil Armstrong and Buzz Aldrin on the moon on July 20, 1969. NASA said it plans to study the presence of lunar ice through other projects.

Astrobotic still plans to fly its Griffin moon lander — minus a rover — by the end of next year. The company's first moonshot ended in failure in January with a fiery plunge over the South Pacific.

Ursula von der Leyen re-elected as European Commission pres

Von der Leyen raised both fists in victory as the Parliament President Roberta Metsola read out the result at the legislature. The re-election ensures leadership continuity for the 27-nation bloc as it wrestles with crises ranging from the war in Ukraine to climate change, migration and housing shortages

A majority in the 720-seat legislature voted for the German Christian Democrat after a speech in which she pledged to be a strong leader for Europe in a time of crisis and polarization

Von der Leyen gained 401 of the 707 votes cast. There were 284 votes against her candidacy, 15 abstentions and seven void ballots. The secret ballot came hot on the heels of strong gains by the far right in last month's election for the European Parliament. "I will never let the extreme polarisation of our societies become accepted I will never accept that demaogues and extremists destroy our European way of life. And I



stand here today ready to lead the fight with all the Democratic forces in this house," von der Leven said in her final pitch. If lawmakers had rejected her candidacy, it would leave leaders of the 27-nation bloc scrambling to find a replacement as Europe grapples with crises ranging from the war in Ukraine to climate change. Instead, the continent now has an experienced pair of hands at the helm. In a speech that sought to shore up support from across the political spectrum, von der Leyen pledged to strengthen the EU economy, its police and border agencies, tackle migration and pursue policies tackling climate change while also helping farmers who have staged protests against what they call stifling EU bureaucracy and environmental rules. She also took a swipe at Hungarian Prime Minister Viktor Orban and his

recent visit to Russia shortly after his country took over the rotating six-month EU presidency. "This so-called peace mission was nothing but an appeasement mission," von der Leyen said as she vowed that Europe would remain shoulder-to-shoulder with Ukraine. One radical right lawmaker, Diana Iovanovici-Sosoaca of Romania, was escorted out of the parliament's chamber for

heckling a speaker during the debate following von der Leyen's speech. Iovanovici-Sosoaca briefly wore what appeared to be a muzzle and held up religious icons before being led out of the room. Over the past five years, von der Leyen has steered the bloc through a series of crises, including Britain's exit from the EU, the COVID-19 pandemic and Russia's invasion of Ukraine. She has also pushed a Green Deal aiming to make the EU climate neutral by 2050. As the debate ended, she told lawmakers: "I hope to have your trust and confidence for the next years. Long live Europe." Von der Leven's election came as newly elected UK Prime Minister Keir Starmer was welcoming some 45 heads of government to discuss migration, energy security and the threat from Russia as he seeks to restore relations between the UK and its European neighbours. The Bangladesh government on Thursday expressed willingness to hold talks with the students protesting against the quota system in jobs after fresh violence erupted across the country as they attempted to enforce a nationwide shutdown over the issue. Authorities deployed Border Guard Bangladesh personnel across the country including the capital, to maintain law and order, the official BSS news agency reported.

Addressing a press conference, Law Minister Anisul Huq said the government decided to sit in for a dialogue with protesting students and entrusted him and Education Minister Mohibul Hassan Chowdhury with the task of the discussion. 'Whenever they agree, we will sit...it could be held this (Thursday) afternoon even,

he said. "Government has agreed to hold talks with the quota reformists," he told journalists at a press briefing. He also said Bangladesh Prime

Minister Sheikh Hasina asked the law minister to take the initiative to hold an early hearing of the quota-related case pending with the Supreme Court. He said he has already instructed the Attorney General to take

AG will file an appeal with the Supreme Court on Sunday seeking an early hearing of the case

The government has decided to form a judicial probe committee led by High Court Justice Khandaker Diliruzzaman to investigate the violent incidents that have claimed at least seven lives, including four students.

The committee will be formed upon receiving approval from the chief justice.

The law minister also requested the protesters to either end or suspend their protest as the government is ready to hold talks with them.

Fresh violence erupted in Bangladesh on Thursday after an overnight lull as thousands of students attempted to enforce a nationwide shutdown.

Mainstream media and witnesses said the protesters clashed with police, leaving many people injured and prompting people to stay indoors. Owners preferred to keep many shopping malls shut.

According to TV footage, riot police fired rubber bullets and tear gas canisters to disperse protesters while students aligned with Prime Minister Sheikh Hasina's ruling Awami League confronted them on the

sticks. Witnesses said the protesters laid a siege on the state-run Bangladesh Television Bhaban in the Rampura area in Dhaka and damaged its front side while some 1,200 staff, including journalists, were stranded

inside. The protestors overnight vowed to enforce a "complete shutdown" after days of demonstrations and violent clashes that left at least seven dead.

The seventh death was report-ed on Thursday in Dhaka. Government offices and banks were open as paramilitary Border Guard Bangladesh (BGB), riot police and elite anti-crime Rapid Action Battalion (RAB) patrolled streets in Dhaka and other major cities, but the attendance appeared thin because of limited transport.



Pak govt targets more social media platforms; FB, Insta restricted across multiple service providers

Lahore (PTI): After successfully blocking X for over six months, the Pakistan government has targeted more social media platforms - Facebook and Instagram - and restricted their access to the people, a step seen as a plan to impose a complete ban on social media Since Wednesday, Facebook and Instagram have been restricted in Pakistan, causing users to experience difficulties accessing the social media platforms across various internet service providers (ISPs).

Some users are also experiencing issues with other Metaowned apps, such as WhatsApp. There has been no official word so far from the Pakistani government regarding restrictions placed on access to Facebook and Instagram. The ban comes amid an ongoing tussle between the superior judiciary, former premier Imran Khan's Pakistan Tehreek-i-Insaf (PTI) and the powerful military establishment which is apparently running the government.

The Punjab government led by Chief Minister Maryam Nawaz earlier had asked the federal government to ban all social media platforms — YouTube, X, WhatsApp, Facebook, Instagram, TikTok, etc — from 6 to 11 Muharram (July 13 to 18) in Punjab, a province of over 120 m people, to "control hate

material, misinformation to avoid sectarian violence" during the holy month.

Navatel, a telecommunication company, said on X on Thursday: "Facebook and Instagram services have been disrupted with all service providers across the country for the last two days. This blockage is in addition to the already blocked Twitter/X. Pakistan Army Chief Gen Asim Munir has already declared social media a "vicious media" and underscored the need to fight against this "digital terrorism."

the portfolio of foreign minister has also called for placing a complete ban on social media. Both the military and the government have been receiving backlash on social media since the ouster of former prime minister Imran Khan through a no-confidence motion in April 2022. The government has arrested dozens of social media activities of Khan's party since then. After keeping mum on the ban on X for about five months, the Ministry of Interior recently told a higher court that it had taken the step as "X is a threat to peace and national security as it spreads "misinformation and incites violence?

FTA to boost India-Russia commerce

PTI NEW DELH

Steps such as increasing local currency trading workable and a free trade agreement with the Eurasian Economic Union will help boost trade between India and Russia, think tank GTRI said on Thursday

India should not worry over the trade deficit, as it is getting crude petroleum oil at cheaper than market rates from Russia and it is also cutting India's overall oil import bill, the Global Trade Research Initiative (GTRI) said.

Since the Ukraine war began in February 2022 and the US imposed sanctions on trade Russia, the relationship between India and Russia has shifted significantly.

There has been a sharp increase in imports from Russia, resulting in a notable trade imbalance

Exports during the financial year 2020-21 and 2023-24 grew by 59 per cent, while imports surged by about 8,300 per cent, the report said, adding the trade deficit rose from USD 2.8 billion before the war in 2020-21 to USD 57.2 billion at present. It said that the import surge is solely due to India's strategic procurement of crude oil from Russia influenced by favourable trade terms and Russia's need to find new markets amidst Western sanctions. During Prime Minister Narendra Modi's Russia visit on July 8-9, India and Russia have set an ambitious bilateral trade target of USD 100 billion by 2030.

With current bilateral trade at USD 65.7 billion in 2023-24, the target seems achievable, GTRI Founder Ajay Srivastava said. In 2023-24, India's exports to Russia were 4.3 billion,



billion. Share of crude oil and petroleum products in imports was 88 per cent. India exports a diverse range of products to Russia including smartphones, shrimp, medicine, meat, tiles, coffee, parts of airplanes and helicopters, chemicals, computers, and fruits.

has competitive 'India advantage in these products and hence the potential to export more to Russia. India should prepare a product-level strategy to promote exports," Srivastava said. while imports driven by On local currency trade, crude oil stood at USD 61.4 the report said that trade

cannot be settled in rupee due to limited international use of the Indian rupee and Russia's reluctance to accumulate it beyond a limit.

After the Ukraine war, the US put sanctions on Russia, not allowing it to use SWIFT (Society for Interbank Worldwide Financial Telecommunication) pipeline for dollar transactions.

The key question for India is finding the best way to pay Russia the amount equal to USD 60 billion in trade deficit.

"Local currency trading would be the best solution. To facilitate this, India needs to establish a transparent and open currency exchange. This exchange would provide clear, market-determined exchange rates between local currencies like Indian rupee and other currencies such as the Russian rouble, Malaysian ringgit, Thai baht, or Chinese yuan," it

said. It added that this would not only give banks a reliable reference for issuing letters of credit but also help understand businesses currency volatility better. "Countries with currency surpluses, like Russia with

its Indian rupee surplus from oil exports to India, could exchange their surplus for other currencies more efficiently in such a multi-currency exchange platform," it said.

It also suggested making the International North-South Transport Corridor (INSTC) functional. The INSTC is a 7,200-

multi-modal kilometer route linking India with Iran, Azerbaijan, Russia, Central Asia, and Europe. "When functional, it would reduce transit time between India and western Russian ports from 45 to 25 days and cut freight costs by 30 per cent compared to the Suez Canal route. INSTC, despite these advantages, has limited use due to underinvestment in infrastructure," it said.

The frequent loading and unloading of cargo along the INSTC and the involvement of sanctioned Iran also pose logistical challenges. Chabahar is a key part of this corridor. India is negotiating the

'India-Eurasian Economic Union (EAEU) Trade Agreement" with Russia, Kazakhstan, Kyrgyzstan, Armenia, and Belarus. Formal talks for the agreement have not yet started.

Recycling industry body demands zero duty on aluminium scrap imports

Ahead of the budget, recycling industry body urgeḋ the MRAI has government to remove the import duty on aluminium scrap, saying it will help promote sustainability in the industry

According to the Material Recycling Association of India (MRAI), the recycling process of aluminium scrap emits only 0.3 million tonnes (MT) of Co2 on per tonne of production compared to 14 tonnes of carbon emissions on the production of 1 MT of aluminium through smelters route which involves maintaining of coal-based capacities for power supply. "Among the key challenges faced by the Indian aluminium recycling industry is 2.5 per cent import duty on aluminium scrap. It is a key raw material for aluminium recycling and the government should make it to zero until the quality material (scrap) is available in sufficient quantity in the domestic market,"AI said in a letter to Finance Minister Nirmala Sitharaman

Finance Minister Nirmala Sitharaman will present the full Union Budget for the



in Parliament on July 23.

Many countries have realized the importance of scrap that it is sustainable because of recyclable in nature. The demand driver for aluminium in the next few years is going to be substantially higher due to India's projected higher growth of GDP and ambitious infrastructure development. The production of primary aluminium metal is also with the associated large consumption of volumes of natural resources, bauxite ore and coal and the generation of large quantities of solid wastes, it noted. "Aluminium recycling has become an important part of aluminium production in India because it is much less energy intensive than the production of primary

aluminium,"AI said. Lower per capita aluminium consumption of 2.5 kg in India is also a challenge against a world average of 11

kg, as the recycling industry has to rely more on imports for quality aluminium scrap to meet the shortfall. "India's aluminium recycling industry plays a pivotal role in efforts to harmonising combat climate change and bolster environmental sustainability. Recycling helps

Geoffrey Boycott undergoes successful surgery

England cricketing great Sir Geoffrey Boycott has undergone a successful surgery to remove a tumour from his throat, his daughter Emma said. The former England batter had undergone extensive chemotherapy for the same in 2002. But in May, the 83-year-old learnt his cancer had returned.

"Just to let everyone know my Father, Geoffrey, has successfully come out of surgery this evening after a 3 hour operation to remove his throat cancer.

"Yet to see him but surgeon says it went well. He asked that I post an update," Boycott's daughter Emma tweeted from the cricketer's account on Wednesday. In his illustrious career

spanning 1964 to 1982, Boycott scored 100 firstclass hundreds while amassing over 8,000 runs in 108 Tests at an average of nearly 48.

Former Australia player and head coach Darren Lehmann reacted to the news along with ex-England players Alan Butcher and Michael Vaughan, who posted a red heart on X.

'Thanks for the update, please pass on our thoughts to the whole family and

glad the surgery went well," Lehmann wrote, while Butcher wrote, 'Great news'. While announcing his diagnosis last month Boycott had said, "In the last few weeks, I have had an MRI Scan, CT Scan, a PET Scan, and two biopsies, and it has now been confirmed I have throat cancer and will require an operation."

"From past experience, I realize that to overcome cancer a second time I will need excellent medical treatment and quite a bit of luck, and even if the operation is successful, every cancer patient knows they have to live with the possibility of it returning. So I will just get on with it and hope for the best," he added.

Cycling Federation of India (CFI) secretary general Maninder Pal Singh on Thursday said the COVID-19 pandemic dashed their hopes of participation at Paris Olympics but asserted they "have plans in place" for 2028 Los Angeles Games.

The country has won three medals in cycling at the Asian Games but is yet to see representation at the Olympics

When asked about India's failure to qualify for cycling at the Paris Games, Maninder said COVID-19 affected their plans during the qualification campaign

^{*t*}Cycling is not a sport that you can equate to others when it comes to Olympic qualification. It takes two and a half years to qualify for the Games.



Besides taking part in the qualifiers, one needs to attain points from events of various classes," he told PTI in an interaction arranged by HCL. "This year, we were hopeful of

our riders qualifying. But, because of COVID, events in Asia took a hit, unlike Europe, where the riders took the required points to qualify. "Nonetheless, we are well on cyclists. "Cycling alone cannot thrive on its riders, but it is hugely dependent on its infrastructure, not only the equipment but also the coaches. And, it's not easy to get since the infrastructure is very expensive.

"About 4-5 years back, there were some velodromes that were not being utilised due to some problems. While Chennai already has one, there's one coming up in Kolkata and also one in the state of Odisha. Currently, we have about 16-17 velodromes in the country." Maninder was in the city on Thursday to launch a cyclothon event, an initiative of the CFI to promote the sport in the country

Besides the cyclothon, he affirmed that plans were in place to produce certified coaches along with some talent hunt programmes.
