YSRCP to back Birla?

Former chief minister YS Jagan Mohan Reddy's YSR Congress Party (YSRCP) will support BJP MP Om Birla in Wednesday's Speaker's post, according to sources on Tuesday evening. The YSRCP, which was defeated by its arch-rival TDP in the general MPs in the Lok Sabha.

In the 2019 elections, the YSRCP had a significant victory in the southern state, winning 22 out of 25 seats. However, this year, the scenario changed dramatically. Chandrababu Naidu's TDP, which also won the Assembly election, secured 16 seats, while its allies - the BJP and actor Pawan Kalyan's Jana Sena Party - won five seats between them.

While the YSRCP's support may not be critical, given that Birla and the BJP already have the numbers to ensure victory, it underscores a recent trend.

The YSRCP has frequently backed the BJP in Parliament, especially in the Rajya Sabha, assisting in the passage of key legislation when the BIP lacked sufficient numbers.

During the previous government, Jagan's party supported the passage of the Citizenship Amendment Act and the abrogation of Article 370.

The additional four votes from the YSRCP mean that Birla will have the support of 297 MPs, giving him an even more decisive

Jagan asks Speaker to recognise him as Oppn leader

YSRCP chief and former chief minister YS Jagan Mohan Reddy on Tuesday requested Assembly Speaker C Ayyannapatrudu to recognise him as the leader of the opposition and his party as the principal opposition party. Reddy made this plea in a let-

"Law mandates that whichever party has the highest number of seats in the Opposition should be recognised as the principal opposition," Reddy said in the letter. He claimed that no law states that 10 per cent seats are required to confer the principal opposition party status, and added that such a practice has not been followed in Parliament or the state's assem-

According to Reddy, making him take oath as a member of the Assembly after the swearing-in of ministers recently was against tradition. He alleged that the ruling NDA alliance of TDP, BJP and Jana Sena had already decided not to confer him the status of leader of the opposition.

Tribals take initiative to build road amid govt inaction

Tribal communities in remote hamlets like Buruga and China Konela, located in the ASR district, have started building an 8-kilometer road from Buruga to Vonija village in Mentada mandal, Vizianagaram district. Faced with long-standing infrastructure neglect, they've taken matters into their own hands, relying on voluntary labour (shramdaan) to drive this initiative forward.

For years, these communities have suffered from a lack of essential infrastructure, prompting around 100 villagers to take matters into their own hands. Over the past week, they have diligently cleared a 1.2 km pathway connecting Buruga village to Vonija village. Their ambitious goal is to extend this road by an additional 7 km within the coming month.

A stark disparity exists between India's progress on the world stage and the realities faced by its tribal communities. Despité decades of independence, these communities lack essential infrastructure, particularly proper road access. This compels residents to undertake arduous journeys of 10-12 km on foot, often carrying critical-



ly ill patients or pregnant women in improvised stretchers. Only after reaching the nearest accessible point can they be transferred by ambulance to medical facilities.

A tragic incident earlier this year highlighted the dire situation. In April 2024, Sara Kothaiah, a tribal man from China Konela hilltop hamlet, had to carry the body of his twoand-a-half-year-old son, Eswara Rao, who died at a private hospital, on his shoulder for 8 km. The ambulance could not reach China Konela from Vonija due to the lack of road connectivity.

CPM leader K. Govinda Rao criticized the tribal welfare department for failing to construct the road between Buruga and Vonija despite allegedly spending over Rs 1 crore on the project. "Officials claim to have spent significant funds, but no tangible work has been done," he stated.

Buruga Pentayya, a respectcommunity leader, expressed hope for swift intervention from the newly elected government. "We urge the authorities to acknowledge the challenges we face and take prompt action," he said. "Construction of a road would significantly improve our quality of life and alleviate the daily struggles we endure.'

Somula Yerayya, Kothayya, and Somula Appalaraju, fellow villagers, echoed Pentayya's sentiments. "By undertaking this project ourselves, we not only aim to secure improved infrastructure but also highlight the urgent need for development in our region," they stated.

This grassroots initiative undertaken by the Buruga and China Konela communities exemplifies their unwavering resolve and resilience in the face of adversity. As they diligently progress with their road construction project, they remain hopeful for governmental support and recognition of their efforts.

New policy and infra push to triple AP's IT industry turnover

The newly-formed NDA coalition government is ready to unveil a comprehensive strategy aimed at catapulting the State's IT industry to an annual turnover target ranging between Rs 8,000 to Rs 10,000 crore. Presently, the sector generates an average annual turnover of Rs 2,500 to Rs 3,000 crore, with Visakhapatnam serving as its

Local IT entrepreneurs have actively engaged with the new IT Minister, Nara Lokesh on Monday emphasizing the crucial role of policy stability and government support in achieving substantial growth. concept cities in Rushikonda and Bhogapuram aim to complement existing infrastructure and attract further IT investments. Additionally, the forthcoming Adani data centre project in Visakhapatnam is poised to augment sectoral growth, leveraging the city's strategic advantages and burgeoning infrastructure. However, the sector faces several challenges, such as a shortage of office spaces, limited international connectivity, delays in incentive disbursements, and a drain of skilled professionals to larger metropolitan areas. Addressing these obstacles is critical for sustained growth and long-term

O Naresh Kumar, Vice-President of the Rushikonda IT Park Association, has articulated these concerns and presented several recommendations to Minister Lokesh. Kumar has proposed substantial measures including rent-free office space allocations and rent subsidies for new companies, alongside initiatives for skill development in emerging fields like artificial intelligence and cybersecurity.

Kumar's suggestions also include the establishment of a finishing school modelled after Infosys' IT Mysore campus, aimed at nurturing talent in cutting-edge technologies. He emphasized the urgency of addressing these issues through regular engagements between the government and local industry representatives to foster a conducive business envi-

FIR filed against former MP of Vizag

An FIR has been lodged in a criminal case against former YSRCP Visakhapatnam MP MVV Satyanarayana, his audi-Gannamaneni Venkateswara Rao (GV), and realtor Gadde Brahmaji at Arilova Police Station on 22 June 2024. This development stems from allegations related to the contentious Hayagreeva

The complaint, initiated by Jagadeeswaru, head of Hayagreeva Constructions, accuses Satyanarayana and his associates of fraudulently signing blank documents under the guise of a Memorandum of Understanding (MOU). These documents were purportedly used in an attempt to sell valuable lands belonging to



Hayagreeva Constructions.

The gravity of the accusations led to the registration of ten non-bailable sections under FIR No. 227/2024. In response to the FIR, Satyanarayana has swiftly moved to the High Court, filing a quash petition to challenge the charges brought against him. His legal team is expected to argue for the dismissal of the FIR, claiming the accusations are unfounded and politically motivated.

This case follows another incident wherein MVV Satyanarayana was issued a notice by the Greater Visakhapatnam Municipal Corporation (GVMC) to stop work on an extensive construction project named 'MVV The Peak,' situated across the Tycoon Hotel intersection road in Siripuram, Visakhapatnam.

This project, spearheaded by former YSRCP MP MVV Satyanarayana, has faced significant opposition from residents. The order, directed at H R R Constructions Pvt Ltd and 17 other associated entities, follows numerous complaints about the damaging impact of ongoing massive drilling and rock blasting activities on the foundations of nearby houses.

CRACKDOWN ON ILLEGAL CONSTRUCTIONS

GVMC issues notice to ex-minister Amarnath

Greater Visakhapatnam Municipal Corporation (GVMC) Commissioner CM Saikanth Varma has issued a notice to former minister Gudivada Amarnath. This action comes in the wake of a serious allegation raised by Jana Sena corporator Peethala Murthy Yadav during the Public Grievance Redressal System (PGRS) on Monday. Yadav's complaint highlights the alleged construction of illegal multi-storied commercial complexes along the Chittivanipalem National Highway in Gajuwaka, prompting swift municipal intervention.

A big cat suspected to be a leopard has mauled a woman to death in Nandyala district on Tuesday, a forest department official said.

Additional Principal Chief Conservator of Forests (APPCF, Wildlife) Shanti Priya Pandey said the incident occurred 1 km inside the Nagarjunasagar Srisailam Tiger Reserve (NSTR). "The woman is from Pacherla village in Nandyala district. The woman's body has been sent for post-mortem," Pandey told PTI, sharing the preliminary information.

Located in the Nallamala hill ranges, an offshoot of the Eastern Ghats, NSTR is 3,728 sq km big, spread across Palnadu, Nandyala and Prakasam districts.

Bapatla man's killer in USA arrested

PNS VIJAYAWADA

The US police have arrested Davonta Mathis (21) for killing Dasari Gopi Krishna (32), who hailed from Bapatla in Andhra Pradesh. Gopikrishna, was shot dead at the convenience store in Pleasant Grove, Dallas, on Saturday. During the robbery, Mathis brazenly entered the store, approached the counter, and shot Gopikrishna multiple times, including in the head.

The assailant then proceeded to pilfer items before fleeing the scene. Gopikrishna was shifted to the hospital in critical condition but succumbed to his injuries.

Mathis, who was initially apprehended and charged with robbery, now faces the grave charge of capital murder due to Gopikrishna's untimely demise. The deadly incident was captured on the supermarket's CCTV cameras, providing crucial evidence in the case. Gopikrishna, a native of Yajali village in the Bapatla district, had completed his engineering at a private institution and had ventured to the US in search of job opportunities eight months back. He was residing with a relative and working at the supermarket when the tragic incident

occurred. death The Gopikrishna left his family, friends, and relatives in a state of shock and grief. He is survived by his wife and son. Efforts are underway to repatriate his mortal remains to his hometown, with his uncle, Laxman, expecting their

arrival by Thursday.

TDP to contest for VMC **Standing Committee seats**

Despite the YSRCP holding the majority in the Vijayawada Municipal Corporation (VMC) Council, the Telugu Desam Party (TDP) is planning to contest for seats on the VMC Standing Committee. The TDP aims to secure at least two out of six posts in the committee, currently chaired by Mayor Rayana Bhagya Lakshmi. To achieve this, TDP corporators are strategising to win these seats.

VMC Commissioner Swapnil Dinakar Pundkar has issued a notification for the election of the six Standing Committee posts. For the past three years, these positions have been held by YSRCP corporators.

In the recent general elections, the TDP, BJP, and JSP alliance won the majority of MLA seats in the state, forming the government. Consequently, the TDP is now targeting the prestigious VMC. According to the notification, nominations from corporators will be accepted until July 1.

In the 2021 municipal elections, the TDP won 14 divisions, but one member, Kesineni Swetha, resigned, and another switched to the YSRCP. The YSRCP currently has 50 corporators, with one member switching to the

party leadership believes some YSRCP corporators might vote for TDP candidates. Therefore, the TDP is keen on participating in the Standing Committee election. According to TDP sources,

a final decision will be made after consultations with MLAs and party leadership. Some corporators have already expressed interest in contest-ing for the VMC Standing Committee. A senior corporator mentioned that if the election uses a secret ballot, the TDP will contest.

Commissioner Pundkar has invited nominations from corporators for the Standing Committee, with the process closing on July 1. If more than six nominations are filed, an election will be necessary. Otherwise, an election will not be required, according to VMC officials.

When contacted by 'The Pioneer', TDP floor leader N Balaswamy stated that the final decision would be made after consulting party leader-ship and MLAs. He noted that there are still five days left to file nominations.

Financial institutions approved loans for houses ranging from 300 to 430 square feet for the re-allocated beneficiaries. With a twoyear grace period, these loans have now transitioned to requiring monthly installments. This financial burden falls upon families who are still paying rent for their current residences, creating a financial strain.

While loan approvals proceeded, construction overseen by the Greater Visakhapatnam Municipal Corporation (GVMC) has yet to be completed. Only 7,500 houses have been handed over to date, leaving a considerable number of beneficiaries in a precarious situation. Complaints to GVMC officials have yielded limited results, prompting some beneficiaries to formally lodge grievances.

10 more fishermen arrested by Sri Lanka, CM tells Centre

52 drug samples fail regulatory body's quality test

ndia's apex drugs regulatory body has found the samples of around 50 drugs, including that of widely-used paracetamol, pantoprazole and some antibiotics for treating bacterial infections, as not of standard quality. Of these sub-standard drugs, 22 are manufactured in Himachal Pradesh, according to the alert issued by the Central Drugs Standard Control Organisation (CDSCO) for the month of May. Besides

Himachal Pradesh, the samples were collected from Jaipur, Hyderabad, Waghodia and Vadodara in Gujarat, Andhra Pradesh and Indore, among other places. A total of 52 samples have failed the quality test conducted by the CDSCO, according to the drug alert issued on June 20. Sources said state drug regulators have reportedly sent notices to the pharmaceutical companies concerned and the failed samples would be recalled from the



Russia looking at Indian PM Modi's brief visit to Moscow

India and Russia are looking at the possibility of a brief visit to Moscow by Prime Minister Narendra Modi in early July to hold wide-ranging talks with Russian President Vladimir Putin, diplomatic sources said on Tuesday.

If the visit takes place, it will be Modi's first trip to Russia in nearly five years. His last visit to Russia was in 2019 when he attended an economic conclave in the Far East city of Vladivostok.

Though there is no confirmation from the Indian side on Modi's possible visit, a Kremlin official in Moscow said active preparations are underway for

"I can confirm that we are preparing a visit by the prime minister of India. We cannot (say) the dates as yet, because the dates are announced by the parties in agreement," Yuri Ushakov, an assistant to the Russian president, said.



"But we are actively preparing. I will emphasise once again, this visit will take place," he told reporters, replying to a question.

Diplomatic sources said the Indian prime minister's daylong visit is being planned around July 8, adding there is no finality on the date yet and various options are being explored.

If Modi travels to Russia, then he and President Putin are set to hold the India-Russia annual summit after a gap of three years.

The annual summit between the prime minister of India and the president of Russia is the highest institutional dialogue mechanism in the strategic partnership between the two countries.

So far, 21 annual summits have taken place alternatively in India and Russia.

The last summit was held on December 6, 2021, in New Delhi. President Putin had visited India to attend the sum-

sealing 28 MoUs and agreements, besides coming out with a joint statement titled "India-Russia Partnership for

Progress

Peace,

Prosperity" Prime Minister Modi and President Putin last held bilateral talks on the margins of a summit of the Shanghai Cooperation Organisation (SCO) at Samarkand in Uzbekistan on September 16,

In the meeting, Modi had famously pressed Putin to end the conflict in Ukraine saying "today's era is not of war".

"I know today's era is not of war. We discussed this issue on phone several times that democracy, diplomacy and dialogue touch the entire world," Modi had said.

Since the Russian invasion of Ukraine in February 2022, Modi has held several telephonic conversations with Putin and Ukranian President Volodymyr Zelenskyy.

Cong crushed spirit of Constitution for maintaining a family in power: Shah

IAF chief: India must invest in modernisation of armed forces

IAF Chief Air Chief Marshal V R Chaudhari said on Tuesday the contemporary security landscape presents "multifaceted challenges" from border disputes and terrorism to cyber threats and regional volatility, and India must invest in modernisation of its armed forces to navigate through these "turbulent times".

Delivering a keynote address at a seminar here, the IAF chief also said modern warfare is characterised by rapid technological advancements, asymmetric threats and the need for a comprehensive understanding of geopolitical, social and cultural contexts.

His remarks come amid the backdrop of evolving geopolitics with conflicts being seen in some of the regions of the world.

The seminar was hosted by the Indian Air Force (IAF), College of Air Warfare (CAW) and Centre for Air Power Studies (CAPS) at the Air Force Auditorium at Subroto Park to mark the culmination of the

third Warfare & Aerospace asserted.

Strategy Programme (WASP). This programme has enabled us to refine the definition of scholar warriors," the IAF chef said.

This "multi-faceted landscape" requires such military personnel who are not only adept at combat but also possess a deep understanding of the broader implications of their actions, the air chief marshal said.

'Ruckus' over hooch tragedy

AIADMK MLAs suspended from TN assembly for a day

Members of the opposition AIADMK in the Tamil Nadu Assembly were suspended for a day on Tuesday for allegedly creating a ruckus after they tried to raise the issue of the Kallakurichi hooch tragedy during Question Hour.

Chief Minister M K Stalin recalled that the house had already debated the issue in detail, and he had outlined the steps taken by the government following the tragedy.

As many as 58 persons have died so far after consuming illicit arrack on June 19 in Kallakurichi, and several dozens of people are still under treatment in various hospitals.

Stalin alleged the main opposition party was indulging in "planned activities" in the house. unable to stomach his party DMK-led alliance winning "40/40", netting all the 39 Lok Sabha seats in Tamil Nadu and the lone Puducherry segment in the just-concluded elections.

NHRC issues notices to **Tamil Nadu govt, DGP**

PNS NEW DELHI

-he NHRC on Tuesday said it has issued notices to the Tamil Nadu government and police chief in connection with the hooch tragedy in Kallakurichi district and sought a report in a week. Till Monday, 58 people had died in the district after consuming illicit liquor. As many as 219 people have been admitted to various hospitals. In a statement, the National Human Rights Commission (NHRC) said it has taken suo motu cognisance of a media report that several people lost their lives after consuming spurious liquor in Kallakurichi. Reportedly, a large number of people including women are under treatment in hospitals and some of them are in critical condition. The content of the news report, if true, raises a serious issue of violation of the right to life of the victims, it said. States have the exclusive power to regulate the production, manufacturing, possession, transportation, purchase and sale of liquor. Accordingly, notices have been issued to the chief secretary and the director general of police of Tamil Nadu, seeking a detailed report within one week, the statement said The report is expected to include the status of the FIR. the medical treatment of the victims who are hospitalised and the status of disbursement of the compensation to the aggrieved families by the state government, it said

TALKS OVER WATER SHARING WITH B'DESH Centre denies Mamata's claim of not including Bengal

PNS KOLKATA

The Centre on Tuesday claimed that the West Bengal government was kept wellinformed and actively involved in the review and renewal process of the 'India-Bangladesh Treaty'.

Its assertion was, however, rejected by the Mamata Banerjee administration stating that there was no formal or informal policy consultation regarding the water-sharing issue. A senior official of the Department of Water

Resources, River Development and Ganga Rejuvenation, under the Ministry of Jal Shakti, said West Bengal government officers participated in the meetings, held between August 2023 and April 2024, to review the 'India-Bangladesh Treaty' of 1996.

"There are communications which revealed that the West Bengal government was not only informed but there were representatives who also actively participated in the process by providing critical data necessary for the water

sharing treaty's renewal considerations. These actions unequivocally show that the state government was kept well-informed and actively involved in the treaty's review and renewal process," the official told PTI from New Delhi.

He said that on July 24, 2023, a committee was constituted to carry out an internal review of the India-Bangladesh Treaty of 1996 on the sharing of waters of the Ganges and to formulate India's strategy for its renewal or extension

MP ministers to now pay IT; Cabinet revokes 52-yr-old rule

Madhya Pradesh Cabinet on Tuesday decided that state ministers will have to pay their Income Tax, instead of the state government bearing such burden.

Chief Minister Mohan Yadav in a statement said the Cabinet has taken a decision to strike off the 1972 rule, under which the state government was paying the Income Tax on the salaries and perks of ministers.

The cabinet decided that all ministers will pay the Income Tax on their salaries and

allowances, Yadav said. Administration Minister



Kailash Vijayvargiya said during the cabinet meeting, the chief minister gave a suggestion that the ministers themselves pay their Income Tax.

The suggestion was accept-Urban ed and hence the decision was taken in this regard, he said.

'Non-coffee drinkers at 60% more risk of dying'

PNS NEW DELHI

Non-coffee drinkers who sat for six or more hours a day were at almost 60 per cent higher risk of dying compared to coffee drinkers sitting for less than six hours, according to a research published in the journal BioMed Central (BMC) Public Health.

This indicated an increased risk of dying in sedentary people not consuming coffee, but not among those drinking coffee, researchers following over 10,000 adults in the US for up to 13 years said

The researchers at the Medical College of Soochow University's School of Public Health in China also found that sedentary coffee drinkers were at a 24 per cent lower risk of death compared to non-coffee drinkers sitting for at least six hours a day.

The result, not featuring in the study, was calculated at The Washington Post's request, according to the media website's report. "The benefits of coffee consumption in improving overall survival in adults compared to sedentary behaviour are



manifold," the authors wrote in the study. Consuming coffee lowers risk of metabolic problems known to worsen inflam-

mation, which contributes to heightening death risks because of sedentary behaviour, they

said. In their study, the authors found that the risk of dying from any cause significantly lowered -- by 33 per cent -- among a fourth of all the participants consuming highest amounts of coffee compared to non-coffee drinkers.

The results were consistent with those from previous studies, which have found a link between drinking more coffee and a lowered risk of dying from

any cause and heart disease, they Compounds present in cof-

fee, including caffeine and polyphenols, are anti-inflammatory in nature. However, how exactly coffee works in the body to lower risk of dying is still unclear, the researchers said. Further, the team also found that sitting for more than eight hours a day was linked with over 40 per cent higher risk of death from any cause and almost 80 per cent higher risk of dying due to heart

A new leaf

The 18th Lok Sabha begins on a promising note amid Opposition challenges to the Government

he much-awaited inaugural session of 18th Lok Sabha started on June 24th. This marks a pivotal moment in India's democratic journey. With the NDA returning to power albeit with lesser seats would make it a much-balanced house than the 17th Lok Sabha in which NDA had brute majority. However, the political landscape has undergone significant shifts which will reflect in the functioning of the new Lok Sabha. Indeed, the priorities set in this session will shape India's trajectory for the next five years. The first session of the 18th Lok Sabha hit the controversy on its very first day. The leaders of the INDIA bloc staged a protest outside Parliament on Monday, coinciding with the oath-taking ceremony of newly elected Members of Parliament. Key figures, including Congress President Mallikarjun Kharge, party leader Sonia Gandhi, and Samajwadi Party leader Akhilesh Yaday, held copies of the Constitution as they demonstrated against the BJP-led NDA government. The swearing-in process for other Union ministers and



newly elected MPs was conducted by Pro-tem Speaker Bhartruhari Mahtab. Members of the Congress and the INDIA bloc, who are part of parliamentary panels, opted out of assisting with the oath-taking process for the newly elected MPs. They expressed their dissatisfaction over the appointment of BJP MP Bhartruhari Mahtab as pro-tem Speaker instead of their preferred candidate, eight-time Congress MP K Suresh. This is a first indication that the functioning of this Lok Sabha would not be smooth.

The 18th Lok Sabha's first session will continue until July 3. The election for the Lok Sabha Speaker is set for June 26, and President Murmu will address a joint

session of both houses on June 27. Interestingly this session will see the appointment of a Leader of the Opposition for the first time in a decade. The session is expected to be contentious, with the opposition poised to challenge the BJP-led NDA on various issues, including the Speaker election on June 26, paper leaks in NEET-UG and UGC-NET exams, and disputes over the pro-tem Speaker's appointment. The opposition aims to address rising prices, food inflation, fatalities due to extreme heatwaves, and recent 'irregularities' in exam administrations. The 18th Lok Sabha is expected to prioritize measures to boost economic growth, tackle inflation, and create employment opportunities. The new session is also expected to focus on social justice, addressing issues related to inequality and ensuring that the benefits of economic growth reach all sections of society. Besides India's strategic interests and security concerns are expected to be prominent in the 18th Lok Sabha's deliberations in the wake of terrorist attacks in Jammu. Beefing up security and restoring law and order in various parts of the country should be taken up on priority. This session not only sets the legislative framework but also reflects the aspirations of a diverse and dynamic nation, eager to carve out a resilient and equitable path forward in a rapidly changing global landscape.

Inordinate delay in naming new army chief



The Govt's decision to extend the tenure of Chief of Army Staff by 30 days, instead of announcing the new appointee has sparked controversy and conjecture

T is intriguing why the appointment of Lt Gen Upendra Dwivedi was not announced on 26 May but on 11 June which would have obviated a 30-day extension to COAS Gen Manoj Pande and the unnecessary speculation that followed. Government would not have been deterred by Model Code of Conduct for election as it had already appointed VAdm Dinesh Tripathi as Chief of Naval Staff on 19 April. That a supersession was contemplated but not implemented as the '400 paar' goal even 272 mark were missed probably led to discretion superseding valour . Further NDA allies had already flagged the Agniveer issue!

Strange are the ways of the government. Just six days before Pande's superannuation-bringing the appointment down to wire- it ordered an extension after he had been feted out by his successor on 21 May. The extension was quite baffling. Government officials like Cabinet Secretary, Home Secretary and others (including Director ED) who run government for politicians get extensions as a matter of routine. In the case of ED's Sanjay Mishra, Supreme Court had to intervene to issue a deadline. But bureaucrats have made themselves indispensable like the repetition of NSA shows. The extension to COAS triggered extensive speculation:

The last extension was given to COAS Gen Gopal Bewoor who succeeded Field Marshal Manekshaw. This extension ensured that Lt Gen PS Bhagat, a Victoria Cross winner was denied the post of COAS, opening the path for Lt Gen Tappy Raina, a Kashmiri, to get the coveted job. Incidentally, both Bewoor and Bhagat were Rimcollians (studied at RIMC Dehradun) and good friends. Appointments of CDS and COAS have got highly politicised but their stature diminishing- as their most conegation in the seating plan during PM's oath taking ceremony demonstrated.

No one but they are to blame. Equally unusual was Defence Minister Minister Rajnath Singh being welcomed back to MOD by CDS Gen Anil Chauhan holding

A month's extension in the armed forces is a first, though in one case, extension was given for one day. The extension will affect the line of succession beyond the present contenders. WE ARE PLAYING THE SCRIPT OF LIFE

The world is a stage where we each have a unique, pre-scripted part to play

ecently a veteran actor from the Indian film industry was given the Highest Civilian Award for his contribution towards spreading cultural values across the Globe through his acting career. While he was given the award, everyone in the audience stood up to give him a standing ovation with so much love and respect to the legend, who brought so many characters to life on celluloid screen. We all have experienced this euphoria in theatres, while a heroic character makes an entry on screen, there are loud cheers, whistles, applause and more. And at the end of the film, the hero wins the audience's hearts and steals the show. Whether he plays a prince or a pauper, it does not matter as his fans throng the theatres to catch a glimpse of him.

The beauty of his performance lies in his ability to internalize the character to the extent that he and his role seem one to his fans. But even while doing it, he is very much conscious of the fact that he is merely an actor in a particular drama, his role is carved, his dialogues are scripted and the costumes are designed for that particular character. Hence, his greatness lies only in playing the role to the best of his capability. On his long journey to stardom, every actor often turns a spectator and critiques his own work so that he can improve upon his act. It is this element of detachment from the different roles he plays that allows him to progress, play multiple roles simultaneously with clarity and then return to his personal life at the end of the day.

Not many of us know that the world cycle is very much similar to this drama in which all of us are actors with unique parts. Everyone is the protagonist in his life and can become a hero who draws applause. However, today we hardly find anyone cheering for the other person. Because, there is great dissatisfaction either with each other's performance or the script. As a result the drama appears to have become a tragedy. There is widespread chaos with actors criticizing each others' performances instead of theirs. The reason for this trouble is that most of us act without the knowledge that the earth is a stage and we have all come here to play our individual roles. Secondly, each actor's role is unique and pre-scripted and hence trying to match it with anybody else's



is futile. Thirdly, the diggest law of the world drama is that it is ever beneficial for everyone. In the absence of this understanding or its consciousness, we get attached to our roles, forget to change our costumes and make-up and lose the flexibility to adapt to each part. Take a simple example of a person who plays a son, a husband, a father, a friend and several other roles at the same time. If he is in the consciousness of being a male. he could dominate his wife at home or look down upon his female staff at office. At work, he would stick to his role of being a boss so much so that he forgets to become their colleague. On the other hand, if he is conscious that he is an actor and must like a hero win everyone's hearts, then he would understand the requirements of his role and become active, accurate and attractive at whatever he does.

Living the peaks and troughs of each character we play, we drain ourselves and are unable to muster enough strength to meet the demands of each role or take well the twists in the scenes, as a result of which there are emotional upheavals and sorrow becomes a regular visitor when the purpose of the drama is to help the actors experience joy and happiness. On the other hand, if we become detached to the roles we play and keep faith in the eternal law that the drama has been scripted for universal benefit, the feeling of loss and gain, comfort and pain would begin to dissolve and our mind would stop to question the developments in every scene. So, the moral of the story is that we should be detached and yet be involved in the part we are playing. That's the quality to be a superstar in this World Drama.

Water crisis in Delhi is entirely man-made



The ruthless exploitation of natural endowments and that too when resources are being put to misuse is unconscionable

he gravity of water crisis facing Delhiites has forced the Delhi government to approach the Supreme Court (SC) seeking its intervention to direct neighboring states Haryana, Uttar Pradesh, and Himachal Pradesh (HP) to provide additional raw water supply to the national capital. Initially, the SC directed HP to release 137 cusecs of raw water which translates to 70 million gallons per day (MGD) of more water for the city. It also asked Haryana to make arrangements for ensuring its free flow

But, now with HP claiming that it can't release more than what it is already giving (70 MGD), the top court has directed the Upper Yamuna River Board (UYRB) to convene a meeting with all parties and take a decision expeditiously'. The mandate of UYRB is to inter alia regulate the allocation of available water flows amongst the beneficiary States and

also monitoring the return flows.
Is Delhi really short of water?
According to Delhi's Economic Survey
Report 2023, the overall water requirement of the city is 1,290 MGD, with an increase in the summer months. Against this, the Delhi Jal Board (DJB) which has the mandate to manage the water supply in the city (including procurement of raw water from various sources, its processing in water treatment plants or WTPs and its distribution) had said on April 3, 2024 in a written statement that water production in the capital stood at around 990 MGD on average between March end and start of April. The DJB actually produced 1,002 MGD on June 7, 2024. Further, the Economic Survey of Delhi, 2023-24, says, "As per Outcome Budget (Q2 of 2023-24) of DJB, the total distribution losses are at about 52.35 percent". Distribution losses is a sophisticated nomenclature for pilferage of water supplies by tanker maria and industries. The pilferage is happening at all stages of the water supply chain viz. the WTPs, conveyance systems and distribution systems. This couldn't have happened without the connivance of the authori-

Deduct 52 percent pilferage or 520 MGD from production of around 1000 MGD, the quantity available for consumption by households in Delhi would be 480 MGD. This is barely 37 percent of the demand estimated at 1290 MGD. It sounds bizarre! If, that were the case, nearly 2/3rd of Delhiites would have been without drinking water; a complete disaster. That hasn't happened even as we see people chasing water tankers in several parts of Delhi.

So, what are we missing? There is something fundamentally wrong with the way mandarins in the government estimate the requirement. Ideally, this should be done from the demand side which involves conducting household survey, collecting data on how much each unit needs, aggregating and so on. Instead, they look at the total supply in the past say 2023-24, presume that that much quantity was consumed and apply an incremental factor/percentage increase to arrive at the requirement for

In this process, they end up including even the pilfered quantity in the requirement. It means that 1290 MGD also includes 520 MGD of water plundered by dubious operators from the system

(assuming that 52 per cent pilferage has continued in the current year). Minus this, the requirement of households was 770 MGD. This being higher than the net availability of 480 MGD, Delhiites are feeling the stress.

Unambiguously, plunder of water by tanker mafia is at the root of Delhi's water woes (last year, Delhiites were spared as the HH demand being muted, the net supply after accounting for the greed of the tanker mafia was sufficient to meet it). But, for this, the entire production of 1000 MCD would have been available for HH consumption resulting in a surplus of 230 MCD (1000-770) forget any shortage that we are experiencing

A sustainable solution to Delhi water woes requires that the State government addresses pilferage on a war footing. Yet, its over-whelming focus has been on getting more raw water from Haryana, Uttar Pradesh, HP etc. While, making the demand it is oblivious of the fact that all its nine WTPs are already operating above their installed capacities (yielding a total of around 1000 MGD which is around 47 MGD more than the combined capacity of all nine WTPs) and that the DJB won't be able to deliver more even if it gets more raw water from the neighboring states.

As for addition to the processing capacity, last year, the Chief Minister Arvind Kejriwal had approved an action plan to increase water production by 131 MGD in the short-term and by 380 MGD in the long-term. İt

involved construction of a new plant at Chandrawal, with a capacity of 105 MGD and completion of another plant at Dwarka, which has the potential to increase production by 50 MGD. That plan hasn't made much headway. While, work on Chandrawal plant is yet to start, even the Dwarka project which was to come up by March 2024 is running behind schedule. Unable to manage water supplies

from the rivers viz. Yamuna, Ravi-Beas, Ganga and so on, the Delhi government is now increasing its dependence on groundwater which currently contributes a little more than 10 percent almost 100 percent increase over the level five years ago. According to the Central Ground Water Board (CGWD), over 41 percent of Delhi's total area is overexploited even as it has been drawing more groundwater than it recharges. The total annual groundwater recharge decreased from 0.41 billion cubic meters (bcm) in 2022 to 0.38 bcm in 2023, while the annual extractable groundwater resource available decreased from 0.37 bcm to 0.34

This is not a healthy trend. The ruthless exploitation of natural endowments and that too when resources are being put to misuse (read: diversion of water meant for HH consumption to industrial use) is unconscionable.

Apart from the huge imbalance between the demand and supply, the gross mismanagement and irregularities in running Delhi's water supply systems is also push-

ing DJB to the brink of financial bankruptcy. Pilferage of more than half of water supply means the Board doesn't get any revenue on that much quantity. Then, you have Kejriwal's free scheme that involves no payment for consumption up to 20,000 litres a month per household.

Even for HHs who get the bills and haven't paid for years, the Chief Minister has been trying to get a one time settlement package cleared by the Lieutenant Governor which will tantamount to the State exchequer foregoing thousands of crore. Finally, there are reports of payments been made by the households albeit to private entities (authorized to collect the money) but never reached the revenue depart-

All this has led to a pathetic situation whereby DJB which until a decade back was making profit today has an accumulated debt of over Rs 70,000 crore. The Board is able to run its operations solely because it can borrow money from banks and other financial institutions (FIs) backed by sovereign State guarantee. Left to fend for itself, it would have collapsed long ago. One shudders to think of what this would entail for water supply to the capital city. The water crisis as also seriousness of problems on other infrastructure fronts such as electricity etc and overall governance issues in Delhi calls for some drastic action by the Centre.

combat drug abuse globally. Besides, the primary objective is to address the multifaceted issues of drug abuse and trafficking by raising public awareness, promoting preventive measures, and advocating for robust policies and programs. Educating communities about the severe dangers and consequences of drug abuse and illicit trafficking is essential. Fostering international cooperation is crucial for a comprehensive approach, emphasizing global partnerships and collaboration among law enforcement agencies to dis-mantle drug trafficking networks. Addressing these objectives will create a more informed, prepared, and united front against the global drug Going by the 2024 theme -

"The evidence is clear: invest in prevention", the message of the Secretary General of the United Nations António Guterres is pertinent in which he reiterated that drugs inflict profound suffering, deteriorating health and wellbeing, with overdoses claiming countless lives annually. To him, the rise of more lethal synthetic drugs and record-breaking illicit drug production fuels crime and violence globally, impacting the most vulnerable, especially youth. Those struggling with substance abuse face repeated

victimization from the drugs, societal stigma, and harsh responses. To break this cycle, we must invest in evidencebased prevention programs that safeguard individuals and communities, disrupt illicit including heart disease and

economies, and prioritize rehabilitation, education, and harm reduction'. He cited the example of Portugal saying that prevention is effective. António Guterres said, "As this year's theme reminds us, breaking the cycle of suffering means starting at the beginning, before drugs take hold, by investing in prevention."

But what does 'Drug Abuse' actually mean? Drug abuse can be defined as the improper or excessive consumption of illegal drugs or prescription medications for non-therapeutic purposes.

Drug abuse severely impacts physical health, manifesting in serious conditions. Reports point that chronic cocaine or methamphetamine abuse leads to cardiovascular issues,

stroke. Smoking drugs like crack cocaine can cause lung cancer, while intravenous drug use increases HIV risk. Other risks, as medical reports point, include nasal damage from snorting, liver and kidney disease from prolonged substance use, and oral cancer from smokeless tobacco.

Contaminants in illicit drugs are linked to leukemia, and severe weight loss is common among stimulant addicts. Besides, mental health issues include depression, anxiety, memory and learning problems, insomnia, violent behaviour, delusions, paranoia, confusion, extreme mood swings, and substance dependence. Some report also suggests that the relationships between drug-related crime, crimes

that affect the environment,

and convergent crime are complex and evolving.

Drug cultivation and trafficking and crimes that affect the environment are surging in the

Amazon Basin. Also, the 'UNODC World Drug Report 2023' highlights social and economic inequalities driving drug problems and their environmental and human rights impacts and rising conflicts. Treatment coverage remains low, with only one in five affected receiving help, notably lacking in some regions. Recent data from the Government of India reveals alarming statistics: more than 10% of the population grapples with psychiatric disorders such as depression, neurosis, and psychosis. A substantial segment, comprising 15 individuals per 1000, engages in drug

use, while chronic alcohol addiction affects 25 per 1000 people. The availability of psychiatric and de-addiction beds starkly contrasts with demand, with only 20% of the required facilities accessible nationwide, leaving an alarming 80% shortfall in inpatient care

Following a tailored treatment plan involving detoxification, counseling, and possibly medication is crucial. Lifestyle adjustments such as adopting healthy habits and avoiding triggers support recovery. The way out is, facing the problem, discussing and treating it with experts' guidance, but not being the escapist.



Telcos place bids worth about Rs 11,000 cr in five rounds

Telecom operators placed bids worth about Rs 11,000 crore on the first day of the spectrum auction that saw five rounds of bidding, according to sources. The government has put over 10,500 Mhz spectrum valued at Rs 96,238 crore on the block. "Telecom operators have placed bids of around Rs 11,000 crore on Day 1. The auction will resume on Wednesday," a source aware of the development said.

According to the Day 1 spectrum auc-

tion report issued by the Department of Telecom, biddings took place mainly in the 900 and 1800 Mhz bands.

Reliance Jio, Bharti Airtel and Vodafone Idea are participating in the auction.

Reliance Jio has deposited the highest earnest money of Rs 3,000 crore for the spectrum auction, which provides the company with the firepower to bid for maximum radiowaves among the three telcos.

Bharti Airtel has submitted an EMD of Rs 1,050 crore and Vodafone Idea (VIL) of Rs 300 crore.

Adani to invest Rs 1.3 lakh cr in FY25 across portfolio companies

Adani group plans to invest about Rs 1.3 lakh crore across its portfolio companies this fiscal as it doubles down on its USD 100 billion investment guidance over the next 7-10 years to grow businesses, group CFO said on Tuesday.

The investment across portfolio companies that range from ports to energy, airports, commodities, cement and media will be 70 per cent met through internal cash generation and the remaining through debt, Group CFO Jugeshinder 'Robbie' Singh told reporters here.

The projected capital expenditure or capex for 2024-25 (April 2024 to March 2025) fiscal is 40 per cent higher than what the portfolio is estimated to have incurred in FY24.

The group had previously guided a USD 100 billion capex over the next 7-10 years. Most of this investment is going to go into the group's fast growing businesses -- renewable, green hydrogen and airports and infrastructure, he said.





'I had to perform martial arts sequence on top of a HANGING CLIFF FOR DEVRA O NEAL'

ot just as an actor but also as a voice artist, Kathak and Bhangra dancer, Anushree Shukla has developed a great sense of love for the arts. Also, as the lead organiser for Myna Speaks, an initiative of the Myna Mahila Foundation supported by the Megan Duchess of Sussex and Prince Harry, she has also worked towards discussing women's menstruation issues in India.

She also participated at the Cannes Film Festival this year. As an actor, she has played a gamut of roles, from being a handmaiden to a landowner to a school-going teenager to supernatural characters and characters with mental illnesses in Hindi. She's given so much to her art that one of her roles required learning and rehearsing in Marathi! Meanwhile, as a voice artist, her diversity really just increases. "For an upcoming Netflix film, I've replaced the actor's voice to be British English," reveals Anushree. In Strange Destiny, her character required an Arabic accent, which was extremely interesting to perform. She's also voiced an American accent in Masaba Masaba and a French accent in Aranyak. Speaking of some unique skills she has picked up for her characters, she shares, "The most interesting skill was learning mar-tial arts for my character Devra O Neal, a warrior princess for Paul Hacker's book adaptation, *The Gathering: A Quest for Steel*. We shot the film in Manasa Valley Hills, Hyderabad, the same famous location where *Baahubali* and *KGF* were shot. It was a medieval epic fantasy action, so I had to climb and hike steep rocks, sword fight in large barren lands and perform a martial arts sequence on top of a hanging cliff. Luckily, I love the outdoors and have been hiking, rock climbing for many years, so that experience played to my advantage."

Hosting events across the globe offers unique cul-tural insights. And for her, it's always interesting travelling to host different events. She recalls, "I was in Assam to host the 4-day Brahmaputra Valley Film Festival and the most important cultural insight a host can adopt is pronunciation and language. Apart from ensuring that the event was running on time, that everyone's bios were correct, humouring the filmy audience and asking insightful Q&A questions, it was very important to learn the correct Assamese pronunciation of films and filmmakers' names." Likewise, at Cannes, she hosted *Tasveer* Matchmaking: Find Your Funds, where they had about 180 filmmakers meet 18 funders, many of whom were from all parts of the world. It's important to ensure that while a lot of the crowd is South Asian and 'Hinglish' comes naturally to her, many might feel excluded, so she was asked to speak only in English. "The same goes for when I hosted the *Tasveer Film Festival* in Seattle. But one commonality amongst all the events is crafting the message in a fun and digestible way for the audience. Also, people love josh

and dancing."
Well, in this interview, we also mentioned her collabora tion with the Myna Mahila Foundation. So we further spoke about the same and she shares, "Well, back in 2019, I worked with Myna's founder, Suhani Jalota, to create Myna Speaks 2019. It was a one-of-a-kind event where we spoke about the challenges of menstruation in the urban slums. Brought

young girls to discuss the health and sanitation issues, social taboos of periods and tangible education-cum-employment opportunities for women in slums. Apart from organising the event, I also hosted it and kept the tone informational and the decorum formal but urgent." In 2023, she started her podcast called *The Nush Corner*, where she interviews actors, directors and film professionals about life, habits and movies. Basically, it is a way for her to showcase her fun personality while doing what she loves best meeting new people and learning about how they became who they are today. But the challenge she faced was "being my own crew, writer, director, interviewer, coordinator and editor. Luckily, I have the support of the best co-producers and we received immense love and support from our friends, family and audience. But if I were to do it all over again, I wouldn't be so hard on myself every time I was behind schedule or did not edit and post on time. I speculated that every beat and instance would transition perfectly. Sometimes setting unrealistic goals restricts you from completing the very task that gives you joy. Season 1 features the strongest women I know: Malvika Nair, Salonie Patel, Sonia Rathee, Mona Shetty, Pranati Rai Prakash, Anushree Mehta, Yogita Bihani and Rita Meher, Season 2, while in it's nascent stages, will now include

some of the coolest men I know too." On the work front, she has played the lead antagonist in a horror short which is in postproduction right now and there are talks about developing it into a series! Then there is *Prison*; the film in which she played the lead which was screened at the Kolkata Literary Carnival on a 70-mm screen, it was surreal. "I also directed my first short film, which is in post-production right now and have another project I'm signed onto in the pipeline but can't speak much about," shares the rising star, adding, "Every stage gives you a new sense of ease in your speech, way I ask and answer questions.

Prolific tattoo artist Prashant Yaduvanshi guides The Pioneer through his artistic process!

n many different contexts, tattoos represent selfexpression, identity, perseverance and confidence. Prashant Yaduvanshi, an accomplished tattoo artist, took up the art form and quickly gained notoriety. Through his art, he conveys his profound connection to the spiritual and

"At first, I worked under the name Ayahuasca Ink, symbolising the consumption of knowledge and artistic inspiration akin to the transformative experience of Ayahuasca," the tattoo artist says, describing a highly personal quest for meaning and expression. "I accepted tattooing as my identity as I developed, emphasising my responsibility to pass on the knowledge and abilities I have gained along the way.

His intense love of art led him to make the crucial decision to leave his engineering college. He sees tattoos as a significant way to establish a spiritual connection. The founder of Shaman Ink states, "I want to capture the essence of spirituality and transformation, assisting people in healing and discovering a deeper connection with themselves." His upbringing in India also gave him a deep love for narrative and symbolism. The renowned cover-up tattoo artist tells us that symbolism and storytelling are fundamental to his designs, which enable him to produce tattoos that are not only aesthetically striking but also culturally relevant and significant. He discusses how this cultural background has influenced his artistic style! Regarding his abilities to cover up tattoos and blend old ink into fresh, he is apparently a recipient of numerous international awards. He says that integrating technical

prowess with creative vision is a complex process. After having a thorough consultation with people, he grasps their goals and narrative. "I study the old tattoo, considering factors like its size, colour and placement," the artist reveals. "I create a design that not only covers the existing tattoo but also enhances it, transforming it nto a work of art that people can wear with pride using m proficiency in colour and black-and-grey realism. He claims that the seamless appearance of the cover-up stems from his special ability to conceal darker parts with lighter shades of grey." Instead of being a correction, he continues, "It almost seems like the client's first choice!"

The artist continues, "Every element I incorporate holds a significant meaning, transforming the tattoo into a narrative that resonates with the people's life experiences and aspirations," further elaborating on how symbolism forms the foundation of his creations, particularly for cover-ups. In addition to making the designs aesthetically pleasing, he makes sure they offer a sense of completion and fresh starts that are full of meaning for the individual.

The tattoo artist goes on to say, "Through thorough consultations, I build a rapport with people, ensuring their stories and preferences are reflected in the final piece." This further explains the importance of consultations and active listening in his approach to creating individualised tattoo designs. "By actively listening, I am able to distill their ideas into artwork that accurately reflects them."

He must take a very collaborative approach in order to strike a balance between the people's requests and his artistic vision. The artist further shares, "I think it's important to involve people throughout the design process, incorporating their inputs while subtly guiding them towards choices that align with my artistic integrity establishing a synergy that guarantees the people's individuality and creative abilities are harmoniously blended."

He also tells a moving tale about one of his creations: "It's about a person who came to me with a tattoo that symbolised a painful chapter in their life. During our talks, gained knowledge about their process of recovery and development. We changed the previous tattoo to represent rebirth and tenacity—a phoenix emerging from the ashes. Rewarded with a tearful response from the person, which served as a reminder of the transformational potential of

It's assumed that obstacles are a part of the process for all artists and tattoo artists are no exception. The seasoned tattoo artist tells us of one major obstacle he encounters: "Balancing artistic vision with people's expectations is a significant challenge. To overcome this, it is necessary to ensure that people are aware of the nuances of tattoo art through education and clear communication." He goes on to say that in order to provide a range of styles and patterns, it is important for him to stay current with emerging techniques. He often attends conferences, workshops and international seminars in order to do this. The winner of the Belgium Tattoo Convention's "Best Coverup Artist" title also enthuses, "Networking with other artists and engaging in continuous learning through online and courses keens me at the forefront of th industry." For a tattoo artist, maintaining personal cleanliness and safety are essential. He said that using disposable needles and tubing for every session, together with strict sterilisation methods, are crucial. "I use premium inks that are safe for skin and my studio is always well-sanitised. In addition, I teach people on how to take care of themselves in order to avoid infections and guarantee healthy healing," the tattoo artist adds.

We now learn about his future goals as our conversation draws to a close. With the words, "I want people in India to know that they can receive world-class tattoo artistry right here in their own country," he expresses his desire to mentor up-and-coming artists and encourage others.

UNDERSTANDING SEXUALLY TRANSMITTED

oresent a significant global health challenge primarily transmitted through unprotected xual contact. This comprehensive article delves into various common STDs, their mptoms, diagnostic methods, prevention strategies and management options.

STDs encompass a broad spectrum of infections, each with distinct characteristics and health implications:

- Gonorrhea: Caused by Neisseria gonorrhoeae, it commonly manifests with urethral discharge and painful urination.
- Syphilis: Caused by Treponema Pallidum, syphilis progresses through primary (painless ulcer), secondary (skin rash, mucous membrane lesions) and potentially devastating tertiary stages affecting various organs.
- Lymphogranuloma Venereum: Caused by Chlamydia trachomatis serotypes L1, L2, and L3, it presents with painless genital ulcers and enlargement of groin lymph nodes.
- Chancroid: Caused by Haemophilus ducreyi, it presents with painful genital ulcers and can cause enlargement of groin lymphnodes.
- AIDS (HIV infection): Human Immunodeficiency Virus (HIV) weakens the immune system, leading to Acquired Immunodeficiency Syndrome (AIDS), characterised by opportunistic infections and malignancies.
- Genital Herpes: Caused by Herpes Simplex Virus (HSV), it results in painful genital ulcers and recurrent outbreaks.
- Condyloma Acuminata (Genital warts): Caused by Human Papillomavirus

(HPV), it presents as cauliflower-like growths on genitalia and may lead to various cancers.

- Molluscum Contagiosum: A viral infection causing small, raised lesions with central dimpling.
- Viral Hepatitis: Hepatitis B and C viruses can be sexually transmitted, leading to liver inflammation and long-term complications.
- Bacterial Vaginosis (BV): Characterised by a shift in vaginal flora, leading to discharge and odour.
- Trichomonas Vaginitis: Caused by Trichomonas vaginalis, it results in vaginal discharge and irritation.
- Fungal Vaginitis: Often caused by Candida species, leading to vaginal itching and discharge.
- Scabies: A skin infestation caused by Sarcoptes Scabiei mites, causing intense itching and skin lesions.
- Pediculosis pubis (Pubic lice): Parasitic infestation causing itching in the genital

These infections can present with local symptoms such as ulcers, discharge, and pain, and may lead to systemic complications like pelvic inflammatory disease (PID), infertility and in severe cases, septicemia.

Diagnosis and testing

Diagnosing STDs involves a combination of clinical evaluation and specific laboratory tests:

- Clinical examination: Helps identify visible symptoms like ulcers, rashes, or discharge.
- Laboratory tests: Including cultures of vaginal secretions, serological tests like VDRL for syphilis, and nucleic acid amplification tests (NAATs) for HIV and other infections, are crucial for accurate diagnosis.

Prevention strategies

Preventing the transmission of STDs is essential and involves:

- Safe sexual practices: Including consistent condom use, reducing the number of sexual partners, and avoiding high-risk behav-
- Aseptic procedures: During medical interventions and childbirth to prevent infections.
- Vaccination: Vaccines are available for hepatitis B and HPV, reducing the risk of liver cancer and cervical cancer, respectively.



Treatment and management

Treatment approaches vary based on the type of infection:

- Viral STIs like HIV, HSV, and HPV have limited treatment options; management focuses on antiviral therapy to control symptoms and reduce transmission.
- Bacterial infections such as syphilis and gonorrhea are treated effectively with antibiotics.
- **Treatments** like topical creams or procedures to remove the genital warts are used.

Syphilis: Progresses through distinct stages with varied clinical manifestations and can lead to severe organ damage if untreated.

■ Genital herpes (HSV): Causes recurrent painful lesions and remains incurable. managed with antiviral medications to alleviate symptoms.

HPV (Human Papillomavirus): Causes genital warts and increases the risk of cervical, anal, and other cancers; management includes topical treatments and HPV vaccination.

Pubic lice (Pediculosis pubis): Requires direct physical contact for transmission and is managed with topical insecticides.

HIV/AIDS: A global challenge

Human Immunodeficiency Virus (HIV) remains a significant global health concern due to its profound impact on individuals and communities worldwide. HIV weakens the immune system, making infected individuals susceptible to opportunistic infections and cancers, ulti-

mately progressing to Acquired Immunodeficiency Syndrome (AIDS), despite advancements in antiretroviral therapy (ART) that can control the virus and improve quality of life, HIV/AIDS continues to pose challenges due to ongoing transmission, stigma associated with the infection and the socioeconomic disparities affecting access to healthcare and prevention services. Efforts to combat HIV include prevention through education, widespread testing, and ensuring access to treatment and support services for all affected populations.

- Transmission modes: Include sexual intercourse, sharing needles and perinatal transmission from mother to child
- Diagnostic tests: Like ELISA, Western blot and HIV RNA PCR are crucial for early detection and management.
- Preventive measures: Include promoting safer sex practices, routine HIV testing and avoiding breastfeeding for HIV-positive mothers.

In conclusion, understanding and managing STDs require comprehensive strategies encompassing prevention through education, widespread vaccination, prompt diagnosis and effective treatment. While bacterial infections like syphilis and gonorrhea are treatable with antibiotics, viral STIs such as HIV and HSV present ongoing challenges due to their lifelong nature and limited treatment options. Public health initiatives must emphasise education, access to testing and early intervention to reduce the prevalence and impact of these infections globally. By promoting safer sexual practices and expanding vaccination programs, we can strive towards mitigating the burden of STDs and improving overall public health outcomes worldwide.

¬he pinpoint accuracy of Jasprit Bumrah allows other bowlers in the Indian team to go for wickets even in extreme pressure situations, said Arshdeep Singh. pacer

The 25-year-old left-arm pacer is among the leading wicket-takers in the T20 World Cup with 15 scalps in six games at an average of 11.86 and economy rate of 7.41 runs per over.

Bumrah, on the other hand, has taken 11 wickets in the same number of games, conceding just 4.08 runs per over, a rarity in the shortest

"I guess a lot of credit goes to Jasprit because he puts a lot of pressure on the batters. He gives what, three or four runs

in and over," Arshdeep said after the 24-run win over Australia in Saint Lucia on Monday.

"So, batsmen are coming hard against me and when they are trying, I just have to try and bowl my best ball and there are a lot of chances of getting wickets there because on the other hand they see the runs are not coming and the asking rate is going high.
"So, they take more risk against me and there's a

chance always of getting a wicket there. So there's a lot of credit of my wickets that goes to Jasprit," he said.

Spinner Kuldeep Yadav once again provided the wickets when the team was in need and only three games into the tournament, he has taken his tally to seven scalps.

"Kuldeep is a champion



spinner. Whenever he gets a chance, he delivers and he's always been in the wickets and today as well he was bowling from the tough end and even against the wind, he managed to bowl at around 6 an over and took crucial wickets.

conference. "We feel sorry for that. We will try to come out of this situation in the future."

Crestfallen he may be, but Shanto drew some positives form the campaign.

Rishad (Hossain) has bowled very well in almost all matches in a big tournament like this. There were a lot of positives, but as a batting unit, we let down the fans and the people

of our country.

Hotentially record-shattering hundred, but milestones "don't matter" to India skipper Rohit Sharma, whose sole aim while batting is to "put bowlers under pressure" by hitting them all over the field.

Rohit's 92-run knock that came off 41 deliveries steered India to a 24-run win over former champions Australia in their final Super 8 outing of the ongoing T20 World Cup on Monday. The record for the fastest T20 World Cup hundred belongs to West Indian swashbuckler Chris Gayle, who pulled it off in 47 deliveries in the 2016 edition. Expectedly adjudged player of the match for the memorable effort, which was punctuated by eight sixes and seven fours, the 37-year-old said his focus was only on maintaining the "tempo" of the match. India will take on England in the

second semifinal on June 27.

"It was a good wicket, and you want to try and back yourself to play those kinds of shots. I've been trying to do that for a few years now, and I'm glad it came off today. The fifties and hundreds don't matter, I wanted to bat with the same tempo and carry on. "You want to make big scores,

yes, but at the same time you want to make the bowlers think where the next shot is coming, and I think I managed to do that today," he added. "You need to put the bowlers

under pressure, and you need big scores for that. I tried to access all sides of the field, not just one side."

Winning was not a 'breeze' for India and Rohit said he had to tweak his batting style to take the wind out of the 2021 champions' sails.

Rohit played some delectable strokes on the off side after his opening partner Virat Kohli departed for a duck. With wind a perpetual hindrance, Rohit said he had



to play more strokes on the off side to negate the impact. "I thought right from over number one, there was a strong breeze blowing across. They (Australia) changed their plan, bowling against the breeze, so I realised I had to open up the off side as well," he said.

"You've got to factor in the breeze and understand that the bowlers are smart as well

and open up all sides of the field. When you keep an open mind and not just think of one shot, you can access all areas of the field," said the India skipper after the match.

"...When you're playing on grounds like this where wind is a factor, anything is possible, but I thought we used the conditions very well. It was very pleasing to see

how we were getting through those overs and getting the wickets at the same time. Rohit also said he knew wristspinner Kuldeep Yadav would be at his potent best in the

Warner makes low-key exit from cricket after Afghans beat Bangladesh

Australia batting great David Warner's 15-yearlong international career, dotted with glorious

controversies equal measure, has come to an anticlimactic end Afghanistan beat Bangladesh, eliminating the former champions from the T20 World Cup at the Super Eight phase.

Australia, the 2021 champions, finished at third place in the Super 8s Group 1 table with just two points -- from the win against Bangladesh. They had suffered a shocking loss to Afghanistan and a humbling defeat to India.

The 37-year-old Warner, who made his international debut in January 2009 in a T20I

match, thus made a low-key exit from international cricket with Australia's 24-run loss to India on June 24 at Gros Islet being his last match.

There was no guard of honour or standing ovation, befitting one of Australia's all-time great batters. He made six runs off six balls in the match, edging Arshdeep Singh as Suryakumar Yadav took a low catch. He walked off the pitch with his head down, not knowing whether that was his last game.

Warner's retirement has been gradual. He played his final ODI match in the World Cup final win over India in November 2023 and his last Test against Pakistan in January. He has long signalled that this T20 World Cup would be his final tournament. He retires as Australia's highest



scorer and seventh-most prolific batter in the world in T20 format with 3,277 runs from 110 matches, at an average of 33.43 and strike rate of 142.47. He scored one hundred and 28 fifties in the shortest format.

From 112 Tests, he has scored 8,786 runs at an average of 44.59 with 26 hundreds and 37

fifties between 2011 and 2024. He also scored 6,932 runs from 161 ODI matches at an average of 45.30 with the help of 22 centuries and 33 half centuries. Warner, who has 49 centuries across formats and close to 19,000 runs in international cricket, had acknowledged that his name will forever be linked to the sandpaper gate scandal that took place at Newlands, Cape Town during a Test match against South Africa in

Warner's involvement in the scandal in the Newlands Test, when Cameron Bancroft used sandpaper to scuff the ball earned him a one-year ban, the same punishment as that of the-then skipper Steven Smith. Warner was also banned for life from taking any leadership role in the Australian cricket

Test cricket at very low point in West Indies: Sarwan

Ramnaresh Sarwan, one of the most prolific batters to have played for the West Indies, is leading a comfortable life after retirement but when one talks him to him about the health of Test cricket in the region, he paints a grim picture, fearful of a talent exodus to the USA.

The unexpected growth of T20 cricket and players' preference for the shortest format has put red-ball cricket on the backburner. First-class teams play as little as five games per season, which Sarwan thinks should be increased to at least

Speaking to PTI, the 44-year-old also lamented the lack of cricket facilities in the region. He featured in 87 Tests and 181 ODIs aggregating more than 10,000 runs across formats and played alongside fellow Guyanese Shivnarine Chanderpaul and the great Brian Lara for the better part of

his career. "Yeah well Test cricket is at a very low point to be honest. Among the games that we are playing again in the Caribbean, I don't think it's sufficient to develop our players but I also think there is this major threat of T20 cricket where a lot of people are showing interest in the shortest format," he said.

"I think one of the biggest challenges we've had is facilities in the region. I think the cricket board has been working on it. So we'll see what happens," he added.

I see lot of Caribbean players moving to USA

Sarwan has nothing against players making money from the plethora of franchise leagues but the lure is impacting the format he loves and took great pride playing. With the way the game is going, Sarwan foresees a mass exodus of the Caribbean players to mainland America where the game has got a major push with hosting of the T20 World Cup and inclusion of the sport in the 2028 LA

Olympics programme. "I think having T20 format in the US which is so close to the Caribbean with so many players of course they would have the opportunity now to participate in the short format of the game in the US.



people jumping ship in terms of coming to the US and start participating in T20 and of course try and see if they could find a way in terms of becoming legal in the US and then start hopefully pushing the play in the US," said Sarwan, who also spends a lot of time in the US. The former West Indies

captain has lot on his plate. He runs a couple of restaurants in Georgetown, one being an Italian-American joint and the other serves Thai and Indian fusion food.

Talking more about Tests, Sarwan, who was known for his sound technique and wrist work, said an immediate solution is not in sight.

"I don't think it's something that can be done only in the Caribbean. I think the ICC probably would have to intervene to put a limit in terms of how many T20 tournaments are being played around the world.

"Of course you want to have the best players available for all those leagues and of course you also want to be able to represent the countries. So I think it's a major challenge in terms of saying what is the ideal scenario. At some point in time, the ICC probably would have to intervene which I really don't see happening in the near future," said Sarwan. Has the pride of playing for West Indies diminished in the era of T20 leagues?

"I don't want to say it's diminished. But probably because of the shorter format of the game, it has taken a lot of players' attention. So, they probably would have worked more in the shorter format rather than the longer format.


