'Simple and effective governance my policy'

CM Naidu asks officials to immediately put an end to illegal activities in Kuppam

On the second day of his visit to Kuppam constituency, Chief Minister Nara Chandrababu Naidu said that 'simple government and effective governance' is his policy. The CM received grievances from the people directly at the R&B guest house on Wednesday. Later, he held a review meeting with the officials at Kuppam Degree College in the afternoon. He spoke to the officials about the development works in the constituency.

Chandrababu directed all the officers to be prepared for the virtual and physical working system. Taking serious view of the incidents of rowdyism, violence and ganja abuse in Kuppam segment, Chandrababu directed the officials to immediately put an end to such illegal activities.

The Chief Minister also ordered the police officials to immediately withdraw the cases against innocent persons registered under political compulsions. Giving the roadmap for the officials on the schemes that are to be implemented in Kuppam in the coming days, Chandrababu made it clear that the poverty elimination will begin at Kuppam.

Making it clear that there will be a vast difference between the previous government and the present administration, Chandrababu said that there will be no forcible mobilisation of the public for meetings, no heavy convoys and sirens.

"I have already informed the cabinet ministers not to hold any kind of meetings after 6 pm any day and the officers, too, should react fast to

perform their duties more effectively," he added. The Chief Minister is very particular that the law enforcement agencies should act firmly against those who are violating norms and indulging in rowdyism.

Recalling that the officers have functioned under several compulsions in the past five years, he said that the situation was so alarming that he could not visit his home constituency and interact with the local people. "Even an attempt to murder case and several other cases were registered against me though till 2019 there was no single case filed against me,' Chandrababu pointed out.

Court sends Kejriwal to 3-day CBI custody

PNS NEW DELHI

A Delhi court on Wednesday sent Chief Minister Arvind Kejriwal to the CBI's custody for three days after the central agency arrested him in a corruption case related to the alleged excise scam. Special Judge Amitabh Rawat passed the order on an application moved by the Central Bureau of Investigation (CBI), which formally arrested Kejriwal after obtaining permission from the court.

"The CBI's application is allowed for three days. The accused be produced before 7 pm," the judge said.

The application seeking Kejriwal's arrest was moved by the CBI after the Aam Aadmi Party (AAP) leader was produced before the court from the Tihar jail, where he was lodged in judicial custody in a money-laundering case linked to the excise "scam" being probed by case.

A new AI-based model could predict the onset of Alzheimer's disease by analysing an individual's speech, the developers said. Trained on audio recordings of

patients with mild cognitive impairment -- early stages of memory loss, the model achieved 78.5 per cent accuracy in forecasting whether patients would remain stable or progress to

dementia within six years, according to the researchers. The researchers at Boston University, US, used record-



ings of initial interviews of 166 patients aged 63-97 and trained the model using machine learning to discern patterns

between speech, demographics, diagnosis, and how their condition was worsening. The model analyses interview

content such as spoken words and sentence structure, rather than as enunciation or speed, showed the study published in the journal Alzheimer's and Dementia.

'We combine the information we extract from the audio recordings with some very basic demographics - age, gender, and so on - and we get the final score," said Ioannis C. Paschalidis, a professor of engineering and the study's corresponding



Less than 50% road repair works done: Janardhan Reddy

PNS VIJAYAWADA

Minister for Roads, Buildings, Investment and Infrastructure BC Janardhan Reddy has made it clear that his primary goal is to repair the damaged R&B roads on a war-footing and make them pothole-free. He took charge as the minister at the State secretariat on Wednesday, amidst the chant-

ing of Vedic pundits.
On the occasion, Minister
Janardhan Reddy said that out of Rs 14,970 crore allocated to the R&B department in 2014-19, Rs 12,64 crore, i.e. 80 percent, was spent on road repairs. During the previous government's tenure, Rs 19,428 crore was allocated in the budget and only Rs 9,015 crore (46 per cent) was spent. Moreover, due to non-payment of bills of Rs 2,261 crore, the contractors are facing a lot of trouble even though the works are being done, Janarthana Reddy said.

The minister said that there are 8,164 km of national highway roads, 12,653 km of State highway roads, 27,062 km of main district roads, 5,663 rural roads and a total of 53,542 km roads in the State, out of which 45,378 km are within the State. In the last five years, due to non-releasing of funds, repairs to the roads and filling of pot-

Poor maintenance of roads by previous government led to bad condition and potholes



holes have not been done. Based on priority, the roads should be laid with a layer of black top (Bitumen) once every five years, which was not done.

The minister said that at present, around 9,080 km of roads are in bad condition and there are immediate proposals for 8,161 km of main district roads and 3,340 km of State roads to be repaired. He said that the government has decided to repair the damaged roads and make the roads free of potholes. They have received proposals of Rs 284 crore for filling potholes and emergency repairs from the district authorities and are

considering the sanction.

Minister Janardhan Reddy disclosed that two projects with the financial assistance of New Development Bank have been sanctioned in the State with the financial assistance of Rs 6,400 crore, of which 70 per cent is New Development Bank's loan and 30 per cent is State government's share. Under the first phase of Rs 3,014 crore, works are being done in 13 packages, and so far works worth Rs 510 crore have been done. The Minister said that the previous government

did not pay the advance loan given by the New Development Bank to the contractors on time, so the work was going at a snail's pace.

Similarly, under the Central Road Infrastructure Fund (CRIF) scheme, 115 works of 1,605 km are being carried out at a cost of Rs 1,959 crore, while already 39 works of 350 km have been completed at a cost of Rs 428 crore and 76 works of 1,255 km at a cost of Rs 1,531 crore are in progress, said the

Minister Janardhan Reddy explained that if the Central government releases Rs 483 crore for the payment of CRIF works in 2023-24, only Rs 253 crore was paid by the previous government for CRIF works and about Rs 230 crore was diverted without payment to the contractors.



The court, considering the evidence, witness testimonies and the arguments presented by government advocate Ashok Chaudhary, found the six police personnel quilty.jk

jects," the leading space scientist said. At a press conference on the sidelines of the Space Congress, he said, "We need to create more internal demand. That implies internal demand is not enough. All of us are working towards that. The

demand will come from the

user side, from the communication segment, which, of course, includes big satellite builders.'

"We would like to find orbital slots and frequencies which can be given to indus-try to build satellites and launchers. This is the first demand. InSpace has already announced a funding plan to create a new earth observation constellation. That's again

another step towards creating nternal demand."

Somanath although the cost of accessing space decreased signifcantly globally,

largely due to SpaceX, India's rocket costs have not seen similar reduc-

50% adults in India insufficiently physically active

PNS NEW DELHI

Almost 50 per cent of adults in India engaged in insufficient levels of physical activity in 2022, according to a study published in The Lancet Global Health journal.

Far more women in India (57 per cent) were found to be insufficiently physically active, compared to men (42 per cent), in line with trends across the South Asian region, the

study found. The insufficient levels of physical activity in women in the region were, on average, 14 per cent higher than those in

men, it said. The South Asian region also ranked the second highest in terms of adults being insuffi-

ciently physically active after high-income Asia Pacific region, an international team of researchers, including those from the World Health Organization (WHO), said.

Globally, the authors found that about a third of the adults (31.3 per cent) were insufficiently physically active -defined as not performing at least 150 minutes of moderateintensity physical activity per week or 75 minutes of vigourous-intensity physical

activity per week. would not be met. This was up by five per cent from 26.4 per cent of the adults worldwide insufficiently engaging in physical activity in 2010, they found, and if the 2010-

In India, a little over 22 per cent of the adults engaged in insufficient physical activity in the year 2000, while in 2010, close to 34 per cent of the adults were insufficiently physically active, the researchers based surveys to estimate the number of adults performing insufficient physical activity for 197 countries and territories from 2000 to 2022.

The team also found that around the world, older adults, both men and women, aged 60 years and above, were increasingly engaging in insufficient physical activity.

Physical inactivity is known to heighten risk of developing non-communicable diseases, including diabetes and heart disease. Rising levels of physical activity, along with an increasingly sedentary lifestyle, are contributing to increase in cases of these diseases and burdening healthcare systems around the world, according to the WHO.

Optimistic outlook

Indian economy continues to grow despite facing hurdles like inflation and unemployment


n his second term, Prime Minister Modi had given a call to make India a 'five trillion economy.' Though the dream is still to be realised, it gave a sense of direction and hope to India's entrepreneurs and stakeholders. But every goal has a meandering path one must negotiate to reach it. Indeed, as the world's fifth-largest economy, India continues to capture the attention of global investors and economists alike. It is a key player in the global economic landscape. However, several impediments need to be done away with to reach the goal. Recently, Shaktikanta Das, the Governor of the Reserve Bank of India (RBI), expressed confidence in India achieving a 7.2 per cent GDP growth rate for the current fiscal year. This assertion is significant from the policy point of view and needs scrutiny of the factors contributing to this optimistic outlook. No doubt, India's economy has shown resilience in the face of various challenges, including the aftermath of the COVID-19 pandemic and global geopolitical tensions. Several economic



indicators reveal a mixed yet promising picture. In recent years, the Indian economy has been touted as the fastest-growing economy in the world. The Indian economy has demonstrated robust growth in recent years, recovering from the pandemic. Its GDP grew by 7.8 per cent in the first quarter of FY 2023-24, indicating a strong economic momentum.

But on the downside, price rise and Inflation are a big cause of concern. Right now, the Consumer Price Index (CPI) inflation stood at 4.6 per cent in May 2024, within the RBI's comfort zone of 4% ±2% which could be counted as a positive indication for the growth. Another grey area of the economy has been unem-

ployment. The unemployment rate remains a critical issue, with urban unemployment at 7.8 per cent and rural unemployment at 7.4 per cent in June 2024. Despite improvements, job creation in key sectors like manufacturing and services remains low. Jobs are essential for sustaining growth which is a red flag for growth right now. Sincere efforts need to be made to tackle this menace as it can mitigate all the positive indicators. 

The dark days of India's Emergency



This period saw the suspension of civil liberties and the censoring of the press leaving an indelible mark on the nation's political landscape

inashakale Viparith Budhi (Sanskrit for 'as doom approaches mind reverses') is what Lok Nayak Jayaprakash Narayan told his friends when he was arrested and was being led off by the cops on 25th June 1975 after the proclamation of internal emergency across the nation by the then Prime Minister Indira Gandhi. Even members of her cabinet came to know about the proclamation of emergency from the next day's newspapers and the Akashwani bulletins.Jagmohan Lal Sinha, a judge of Allahabad High Court heard the election petition filed by socialist party leader Raj Narayan against Indira Gandhi alleging that she had violated all rules specified in the statute book while fighting the 1971 Lok Sabha election from Rae Barelli. There was a nationwide belief among the leaders of the opposition parties that chemically treated ballot papers were used in the election. These ballot papers were supplied by the then USSR and they bore the symbol of Congress(Indira) but remained invisible at the time of voting. It as said that the voter's original mark would disappear after voting, and the Congress mark would appear. (Ref: Courting Destiny, A Memoir by Shanti Bhushan, who appeared for Raj Narayan in the case). But Shanti Bhushan decided not to go ahead with the charge of the fake ballot paper and preferred the allegation that Indira had misused government machinery in fighting the poll. The court was convinced of the charge that she had misused her position and power while fighting the poll. Justice Sinha set aside Indira's election and disqualified her for six years. But Sinha stayed his judgment to enable Indira Gandhi to appeal to the Supreme Court. the Centre were summarily dismissed making use of the provisions under Article 356 of the Constitution. Press Censorship was imposed which made newspapers get prior sanction from censoring officers to publish news. To date, India has not experienced the kind of dictatorship that was in force during the days of internal emergency. The Constitution was distorted and misinterpreted while Courts of law were sterilized. The Preamble of the Constitution itself was amended unconstitutionally and terms like Socialism, secularism and unity of the Nation

were inserted in it. This was done after putting all opposition members of parliament in prison under the DIR (Defense of India Rule 1962) and the Maintenance of Internal Security Act 1974, the statutes that gave power to the government to jail anyone daring to question Indira Gandhi's superiority. Lalu Prasad Yadav named his daughter Misa Bharati to commemorate his arrest under the said Act during the emer-

the Nehru-Gandhi clan!Indira Gandhi and the Congress failed to learn anything from the drubbing they got for subverting the Constitution. In 1984, the Congress again derailed people's mandate by getting the N T Rama Rao-led TDP government in Andhra Pradesh dismissed and anointing a faction led by Bhaskara Rao as chief minister. But NTR succeeded in getting his chair back thanks to the initiative by the opposition parties that included Janata Party, BJP and anti-Indira forces. Rajiv Gandhi during his tenure as Prime Minister tried in vain to muzzle the media by attempting to enact a legislation "Defamation Bill" to curb any kind of reports against the Government. This had to be dropped midway through due to massive protests against

the same.

One has lost count of the number of times State governments were dismissed by the Congress-led Government at the Centre misusing the provisions of the Constitutions. B R Ambedkar, the architect of the Constitution, was against the terms socialism and secularism for obvious reasons. n the vibrant tapestry of India's democracy, the concept of a welfare state has been a cornerstone since its establishment. Embedded in the Constitution, the commitment to justice, equality, and the promotion of general welfare forms the foundation of India's identity. However, within this grand vision lies a harsh truth often neglected - the challenges faced by persons with disabil-

Despite the existence of legal frameworks like the Rights of Persons with Disabilities Act, 2016, and international obligations such as the United Nations Convention on the Rights of Persons with Disabilities (2006) and the Sustainable Development Goals (SDGs), the everyday experiences of disabled individuals paint a different pic-

In India, disability is not merely a physical or mental condition; it is a complex barrier that impedes access to basic rights and opportunities. From systemic discrimination to inadequate infrastructure, persons with disabilities face obstacles in every aspect of life. Essential areas like edu-



cation, employment, and healthcare - the pillars of a welfare state - often remain inaccessible dreams for them. Education is frequently highlighted as a key to progress and empowerment. However, for many disabled students in India, quality education is an elusive reality. Despite the National Education Policy and the Right to Education Act, educational institutions often lack the necessary support systems and infrastructure to accommodate diverse needs. The disparity in the national enrolment average between disabled and nondisabled students is stark, with the national average for non-disabled students at 28.4% and less than 2% for disabled students. Government data from UDISE+ shows a dropout rate exceeding 75% for students with disabilities in high-

er education.

disabilities is bleak. Despite efforts to promote inclusivity, the private sector remains largely indifferent, often citing concerns about productivity, costs, and a perceived lack of talented resources. Consequently, unemployment rates among the disabled population are disproportionately high, exacerbating their economic vulnerability and reliance on social welfare schemes.

Healthcare, another critical aspect of a welfare state, presents its own set of challenges for persons with disabilities. Limited access to specialized care, the high cost of assistive devices, and stigma within healthcare settings contribute to their marginalized status. Amidst these challenges, the notion of India as a welfare state falls short for millions of disabled citizens. The true measure of a welfare state lies not in lofty ideals or legislative frameworks alone but in tangible improvements in the lives of its most vulnerable members. It is crucial for the government, civil society, and

Firstly, disability should be viewed not as a deficit but as a diversity that enriches the social fabric. Secondly, significant investment is needed in accessible infrastructure and services across sectors. From barrier-free buildings to inclusive technology, creating an environment that accommodates diverse abilities is essential for fostering equal participation. Proactive measures such as affirmative action policies, vocational training programs, and sensitization initiatives for employers are necessary.

To achieve a truly inclusive society, concerted efforts are needed on multiple fronts. India's journey towards becoming a welfare state must prioritize the rights and dignity of persons with disabilities. Disability should not be an afterthought but an integral part of policy and decision-making processes.

very year, food grain production in India reaches new record levels, yet retail prices continue to climb. In the 2023-24 period, rice production reached a record high of 1.367 lakh tonnes, and wheat production also hit a record

with 1,129 lakh tonnes. Despite these increases. the government's Department of Consumer Affairs reports that retail wheat prices have risen by about 6%, with rice prices increasing even more sharply. Additionally, the prices of pulses have seen a significant spike over the past year. This paradox of high production and rising prices is largely due to low procurement. As of June 2024, the wheat stock in the central pool stood at 299.05 lakh tonnes, a 5% decrease from June 2023, when it was 313.88 lakh tonnes. This year, the wheat procurement target was set at 310 lakh tonnes, but only 260.71 lakh tonnes were procured. This shortfall threatens to destabilize the entire government-run procurement system, which could lead to cascading effects on the Public Distribution System (PDS) and ultimately cause further

We try different things, but something or other keeps on going merciful, has indicated how this can be alone. er face is bathed in sweat and her hair is dishevelled. But neither the scorching June heat nor the humidity can wear down the wide smile on Arti's face. Even the power cut at the Aga Khan Foundation's Project Lehar Centre, where she has been coming for entrepreneurial training, cannot dim her joy. She has just admitted her young daughter to one of the top English medium schools in Bahraich district in Uttar Pradesh. This is a dream come true for the 19-

year-old single mother whose own education came to an end after being married off as a child. What has made this feat even more special for her is that it was the school that expressed keenness to admit her four-year-old daughter. The telephone call from its founder inviting her to fill out the form came soon after Arti was returning from the school having been told admissions for the session were closed. While the call and offer to waive all tuition fees came as a big surprise to Arti, it was not totally unexpect-

Ever since Arti, an e-rickshaw driver, hit the national headlines for winning the prestigious Amal Clooney Women's Empowerment Award in May this year, she has become a celebrity in Bahraich. Given to young women around the world in recognition of their determination and ability to overcome challenges and make a difference, the international award has catapulted Arti from being just another pink e-rickshaw driver to the official brand ambassador for women's empowerment in Bahraich, an aspirational district with low socio-

economic indicators. The buzz around her has been non-stop since her return from London where she went to receive the award from the King's Trust International founded by King Charles. There has been unrelenting attention by local and national media to know more about her remarkable jour-

ney, including her ride in a pickrickshaw to meet King Charles at the award reception in Buckingham Palace. She has also been publicly felicitated by top leaders and officials of the district. But all this would have never been possible had Arti not met the Aga Khan Foundation (AKF) Project Lehar team. Instituted to provide vocational training, entrepreneurship, and life skills courses to marginalised young women, Project Lehar run by AKF in partnership with The King's Trust International, enables girls and young women from disadvantaged backgrounds to learn, earn, and thrive. When the team met Arti, she was living with her BAHARAICH'S mother in Baharaich's Risia block Having left an abusive marriage, Arti was directionless. Married at 13 and a mother at 14, Arti lacked both skills and confidence. On her mother's insistence, she agreed to join Project Lehar. Little did she know that her life was about to change.Not far away, in Lauki, another village in the same block a young widow with three children was struggling to make two ends meet after the death of her husband. She was only 20 when she came in touch with the Lehar team.

Left to fend for her children alone, Bitti wanted to do something other than supporting her family as a daily wager and registered for the project.Here she would meet Megha, Saira Bano and Bhagyalakshmi, all young widows with similar backgrounds and living in difficult circumstances. Fate was about to give these four and Arti a collective second chance at life.In June 2023, when Seema Shukla Project Coordinator, state programme

manager Sudhir and the AKF team were mulling over the possibility of teaching them to drive and using this skill as a means of livelihood on the lines of the popular Sakha cabs driven by only women, it was Monika Rani, the dynamic Bahraich district magistrate, who turned this idea into

"We were considering how to make the girls economically self sufficient and hit upon the idea of launching the pink e-rickshaw initiative under the government Mission Shakti scheme to empower women and expand their income earning opportunities. We wanted to give single mothers, widows and women separated from their husbands the first chance to come out of the house, increase their mobility and regain their confidence," says Monika Rani. So on October 2, 2023, these five girls were chosen as the first recipients of a batch of 10 girls from Project Lehar to be given the pink e-rickshaws under this innovative scheme.

A loan of Rs 1.66 lakh was provided and repayable in 38 months at an EMI of Rs 4500. Since then, there has been no looking back. Not only have the women paid eight instalments already, but they are also transforming their lives. From eating just one meal a day, Saira Bano can now give her children proper nutritious food. "I have seen days where my two children and I ate just namak

and roti. Now I earn enough to fulfill every need of my children. I want to do better so that I can build my own house and get an electric connection so that my children don't have to study under a lamp and I don't have to pay to charge

confidence Bitti has gained has given her the courage to demand her right to the family land. She has filed a case in the civil court and wants her father-in-law to put her deceased husband's share in her son's name. "I am paying the fees for the lawyer from the money I earn as a e-rickshaw driver. I never thought I would be able to take such a big step," reveals Bitti. Bhagyalakshmihas opened a tiny kiosk selling biscuits, sweets and pencils for her mother from her earnings. "I want to expand my business. My dream is to make my elder daughter a doctor and the younger one a policewoman. When my income increases I will shift them to an English medium school. I want my children to have a bright future,' she says. For Megha too, the e-rickshaw has been life-changing. "I am happy because my economic situation has changed for the better. Now I can give my children better food. I have admitted the two children to private English medium school and can the monthly fee of Rs 250 for both of them Education will ensure they never have to live on charity like I did." While association with Project Lehar and the opportunity to become self-reliant thanks to the pink e-rickshaws has turned their lives around, it has been their confidence that has helped them hold their heads high in a male-

The constant torment for the three of us stems from society's disdain for 'transgressive' love and an unquestioned acceptance of violence against women by family members. Familial and domestic violence is perpetuated and reinforced each time someone scrutinizes and polices one's queerness through one's body. Hope often dwindles with seemingly unending cycles of individ-

Vedanta Resources would have redu ced its debt by over USD 650 million since the start of the current fiscal year in April. Stock exchange data showed 18.5 crore shares of Vedanta Ltd changing hands in a block deal. The number of shares that changed hands in the block deal amount may be worth Rs 7,967.8 crore

India's spectrum auction fetches over Rs 11,300 cr

India's spectrum auction concluded within a few hours of bidding on day-2, with telcos buying over Rs 11,300 crore worth of radio waves in all, which is just 12 per cent of the Rs 96,238 crore minimum value that government had estimated for the spectrum on

The auction, where a total of 10 GHz of spectrum ranging between 800 MHz to 26 GHz was placed on the block, fetched total bids worth Rs 11,340 crore, sources with knowledge of the matter said. In all, only 140-150 MHz are estimated to have been sold in seven rounds.

Five rounds of bidding happened on the opening day on June 25, but Wednesday did not see much action, leading to officials declaring the end of the auction at around 1130 hrs. The 2024 auction - that was

held after a gap of nearly two years - saw radio waves in 800 MHz, 900 MHz, 1800 MHz, 2100 MHz, 2300 MHz, 2500 MHz, 3300 MHz and 26 GHz

On expected lines, the auction this time around has been low-key as market watchers had anticipated limited bidding, with telcos primarily focusing on spectrum renewals, and selective sprucing up on radio waves for boosting their coverage.

Reliance Jio, Bharti Airtel and Vodafone Idea (VIL) are vying for the radio waves that support high-speed mobile services, in these auctions.

The operator-wise breakup of the bids, or exact amount that telcos dished out individually, is not immediately clear and will be known once an official announcement comes.

As per the day-one spectrum auction report issued by the Department of Telecom on Tuesday evening, bidding took place mainly in the 900 and 1800 MHz bands. The operator also placed bids for the 2100 Mhz band spectrum in

Real estate consultant Cushman & Wakefield on Wednesday released a report 'Is India Building Enough to Power Digital Transformation?'

The report conservatively estimates the potential data centre capacity India will require to align with other major economies. There will be a requirement of an additional 1.7-3.6 GW data centre capacity, over and above the planned development of 2.32

GW Colo capacity.
At the end of 2023, India's installed colocation (Colo) data centre capacity stood at 977 MW (IT load). About 258 MW came in 2023 across its top seven Indian cities.



This is a formidable number and surpassed the capacity addition in 2022, which stood at 126 MW, the report said.

The consultant noted that at over 19GB, Indians have been the highest consumers of data per month among comparable

Despite this, India today lags in internet and smartphone penetration, reflecting the scale and extent that the data centre segment is headed

India's current under-construction Colo capacity addition stands at 1.03 GW for 2024-2028, with an additional 1.29 GW being planned, taking the total projected capac-

ity to 3.29 GW by 2028. This exponential growth is propelled by a confluence of factors, including a significant increase in data consumption fueled by rising digital penetration and adoption of data-intensive technologies, the consultant said.

SEZ developers can install solar power panels under existing norms

The Commerce Ministry has asked development commissioners of SEZs to consider requests of developers of these special economic zones for installation of solar power panels under the existing SEZ guidelines for power generation, transmission and distribution norms.

In a communication to the Development Commissioners (DCs) of all special economic zones (SEZs), the Department of Commerce said that various requests have been received from EPCES (Export Promotion Council for EOUs and SEZs) as well as SEZ developers for installation of solar power panels as capital goods in



these zones for solar power generation for captive use. "The matter has been exam-

ined in consultation with DGEP, CBIC. Accordingly, the DCs are requested to consider such requests from developers/codevelopers" under the power guidelines issued on February 16, 2016 by the department, the communication said.

The Directorate General of Export

Promotion (DGEP) is an extended arm of Central Board of Indirect Taxes and Customs (CBIC). Under those guidelines, a power plant, including non-conventional energy power plant, to be set up by developer/co-developer in an SEZ as part of an infrastructure facility will be in the non-processing area of the SEZ only.

Narrowing trade deficit, rise in remittances aid current account surplus: CRISIL PNS KOLKATA which was 0.2 per cent of the

India's current account surplus in the fourth quarter of the 2023-24 fiscal was aided by narrowing of the merchandise trade deficit, an increase in remittances and a surplus in services trade, according to a CRISIL report released on Wednesday.

The country's current account recorded a surplus of USD 5.7 billion, which is 0.6 per cent of the GDP, in the fourth quarter of the last financial year.

It was in deficit of USD 8.7 ter of the 2023-24 fiscal, the billion, equivalent to one per cent of GDP, in the third quar-



In the corresponding fourth

quarter of 2022-23, the country's current account was also in deficit of USD 1.3 billion,

The improvement in current account balance to 0.6 per cent of GDP surplus in Q4 fiscal 2024, from a deficit of 0.2 per cent of GDP a year ago reflects improvement on all three fronts i.e. merchandise trade deficit narrowed, services trade surplus increased and remittances rose," the

CRISIL report said.
Financial flows also increased leading to accretion in foreign exchange reserves during the fourth quarter amounting to USD 30.8 billion, it said. The country's foreign reserves, as of June 14, 2024,

stood at USD 652.9 billion. The report said even though

the FDI inflows continued, there has also been a rise in outward FDI, leading to a reduction in net flows, the report said

Healthy momentum in goods exports and expected moderation in imports suggest that the current account deficit (CAD) is likely to remain manageable this financial year (2024-25) as well.

Strong external buffers are crucial at this juncture because of global risks stemming from geopolitical uncertainties, tariff and trade wars have heightened, the report added.

Participatory-note investment surges to Rs 1.49 L cr

rities -- stood at Rs 1,49,120 crore at the end of March 2024, way higher than Rs 88,600 crore in March-end 2023.

On a month-onmonth basis, the investment number slightly slipped from Rs 1,49,517 crore at the end of February. The growth in P-notes generally aligns with the trend in FPI flows. When there is a global risk to the envi-ronment, investment through this route increases, and vice-versa.

The result of all that planning for how to have a bloody mental breakdown on screen: "It was actually really fun."

"As dark and fucked up as that seems now, that was probably one of the most enjoyable sequences I've had on the show," he said, "I had a ball doing it. It can't get weird enough or dark enough for me and I love that. We get to do things on screen that we never get to do in real life, so it was a huge amount of fun."

We'll soon find out if this season of *The Boys* stays wicked and twisted enough for Starr from here on out as episode 5 of season 4 premieres on Thursday.

states, understand what the governments are doing there, benchmark some of the good initiatives taken by the government to promote tourism in those states, identify those good decisions that they have taken, benchmark them and then start looking at implementing them in Telangana.
Going ahead, according to the

executive committee member, there needs to be a proper infrastructure set up before they think about the tourism aspect. Therefore, they are actively looking at what the government does in terms of investing in places in need of infrastructure, creating a public-private partnership and getting investments from corporations to invest in such places. HRATS also organises training programs for employees working in smaller hotels.

According to area director of Taj Krishna Hyderabad, most governments today realise the power of tourism because it predominantly creates a lot of jobs and improves the overall GDP of the state. Talking about their vision going ahead, the president shares, "It is to have a proper tourism policy for Telangana, due for quite some time now. Having an industry status for the hospitality industry is also overdue. While many states have done that, it's something that w are working hard towards. Along with the development of tourism in the state, it's also equally important to look at new skilling centers, which is extremely important to support the growth of tourism in the state."

Some common factors are changes in lifestyle, delayed childbearing and genetics. Every year, approximately 25,000 new cases rise in India, which highlights the need to improve screening & prevention to manage the


increasing healthcare burden.

A unique case of a 13-year-old girl experienced significant abdominal distention and mild discomfort, that had been ongoing for approximately three months. Despite these symptoms, the patient was able to maintain a good appetite and perform her daily activities normally. Upon evaluation, an initial ultrasound revealed a large mass occupying much of her

abdomen. To further evaluate the situation, a CT scan was conducted, which confirmed the presence of large mass. Decision to proceed with surgery was taken. Exploratory laparotomy was performed, to successfully remove 8.5 kg mass from her ovary. This surgical procedure was essential for directly examining the abdominal organs and to determine the extent and spread of the disease. During the operation, a specific procedure called Salpingo-oophorectomy was performed on the left side, which involved the removal of the ovary and fallopian tube. This step was critical in addressing the underlying cause of the distention and ensuring that any pathological tissues were effectively managed. Thus alleviating the symptoms and preventing further complications related to the mass. Remarkably, the other ovary and fallopian tube, as well as her liver and rest of the abdominal cavity, were found to be normal. This case highlights the critical importance of imaging in diagnosing significant ovarian masses and underscores the effectiveness of timely surgical intervention.

Maintaining ovarian health is crucial for women's overall well-being, fertility and hormonal balance. To promote healthy ovaries, women can adopt practical tips such as consuming a balanced diet rich in antioxidants, vitamins and minerals, engag-ing in regular physical activity, avoiding smoking and excessive alcohol consumption, managing stress levels, and getting adequate sleep. Additionally, women should undergo regular gynaecological check-ups to detect any potential issues early on and seek medical attention promptly or if they experience any unusual symptoms or changes in their menstrual cycle. By prioritising ovarian health, women can enhance their quality of life and prevent various reproductive and hormonal disorders.

SA, Afghanistan look to rise above deep scars to seal T20 WC final berth

Tournament story-makers Afghanistan will be up against perennial dark horses South Africa in the first semifinal of the T20 World Cup here, a much-anticipated showdown that will be historic irrespective of the outcome.

Without belittling the poised run of the Proteas, Afghanistan have been the revelation of this ICC showpiece.

They found life and fighting spirit to rise above the ravages of war back in their country, best exemplified by an astounding win over 2021 winners Australia, whom they had never beaten before.

There were multiple heroes -- skipper Rashid Khan has been immense throughout, pacers Fazalhaq Farooqi and Naveenul-Haq have given early breakthroughs, Gulbadin Naib conjured a miraculous spell against the Aussies while Mohammad Nabi remained perseverant.

Opener Rahmanullah Gurbaz leads the batting chart with 281 runs, while Farooqi is on top of the bowling list with 16 scalps. It is a story in itself as how two Afghanistan players have raced past some marquee names to the top of the stats table.

But all of it can come to nothing if they fal-ter at the Brian Lara Academy, a venue named after the West Indian legend who has supported Afghanistan to the hilt.

The Afghans are a skilled set of cricketers, on whose back the team rose brilliantly from the low-tier obscurity of the early 2000s. So, they are not unfamiliar to intense competition and T20, more than any other format, offers them the chance to challenge the big brothers.

But they have never competed in the semi-final of a World Cup, and the Afghans now need to control their nerves to overcome a

fancied opponent. Head coach Jonathan Trott affirmed his side was not perturbed by the big occasion.

"We go into the semifinal with no scarring

or no history. This is uncharted territory for us. But, by no means, do we feel like we're going into the semifinal just to compete.
"We're there to win the semifinal. We've beaten some major teams," Trott said after the win over Bangladesh.

South Africa's scars also run deep but they are purely of cricketing nature.



In the past, the Proteas have assembled some high-velocity squads but never managed to enter the title round of a T20 or 50-over World Cup after their re-admission into world cricket in 1991.

To change that long-running show of misfortune, South Africa need to tame not just Afghanistan but also the demons in their own minds.

The signs have so far have given hope.

In this event, they have shown a propensity to win the clutch moments, their Achilles Heel in previous global tournaments, that often prop up without any warning.

But here, they have notched up victories as close as one-run (vs Nepal), four-run (vs Bangladesh) and three wickets (vs West Indies). South Africa of old could have bungled in those situations, but Aiden Markram's side has displayed remarkable fortitude. They seem to have escaped the hackneyed C-Word.

Experienced left-arm spinner Keshav Maharaj explained his team's run in this

World Cup.
"If you look at previous World Cups, the small moments, we haven't really won. It's good to see that all the games have come really close and we've found a way, so it's building the character within the team.

"It prepares us for certain opportunities that we could get and cross over the line in those small moments. These are things that we've never done before. So, it's good to see us get-

ting into that," said Maharaj. His words offer a true reflection of the col-

lective effort South Africa have made here. There is only one South African player in top-10 batters' list. Quinton de Kock is placed sixth with 199 runs from seven matches, while none of their bowlers feature inside the first 10.

But here they are, playing in the semifinal and they will have to negate those small, key moments against Afghanistan, perhaps in the next match too.

For once, South Africa might not feel overwhelmed by that thought.

If Afghanistan too can keep their heartbeats in check, a classic for the ages seems well on the cards.

A ustralia captain Mitchell Marsh saw the funny side of Afghanistan all-rounder Gulbadin Naib's theatrical complaining of cramps in a T20 World Cup match against Bangladesh, terming it as "one of the funniest things" he has ever seen on a cricket

Naib, who was fielding in the slip, fell on his back while clutching his thighs during the 12th over, just after coach Jonathan Trott signalled to slow down the proceedings as rain was imminent with Afghanistan ahead in the proceedings in the must-win Super Eights game.

"I was almost in tears laughing and at the end of the day it had no bearing on the game. So, we can laugh about it now - but, gee, it was funny. It was outstanding," Marsh told cricket.Com.Au.

Bangladesh were chasing 115 for a win then, and fell behind the DLS par score of 83 at the end of the 12th over at 81 for seven.



However, Naib later bowled two overs and participated with vigour in Afghanistan's victory celebrations without showing any hint of 'cramps.

The ICC's playing conditions stipulate that a player can get up to two-match ban for 'deliberate or repetitive" time wasting tactics, but that Naib might just escape with a first and final warning by the match refer-

With the win, Afghanistan knocked Australia out of the T20 World Cup, and

Marsh said the 2021 champions have only themselves to blame for the exit.

'We watched it (the match) as a group. It was obviously a pretty amazing game, wasn't it? A lot of twists and turns.

"Obviously, you want to keep playing this tournament and that was our only way of doing it. But there's also the element that it was completely out of our control and we only had ourselves to blame for that," said Marsh. The all-rounder said the team was dejected after the fall of the final Bangladesh

Pacer Naveen-ul-Haq trapped Mustafizur Rahman in front of the wicket to signal a famous win for the Afghans.

We were all flat (when the final wicket fell). We were desperate to continue on in the tournament. But fair play to Afghanistan they beat us and they beat Bangladesh and they deserve to be in the semifinals," added Marsh. Afghanistan will face South Africa in the first semifinal of the T20 World Cup at Trinidad on Thursday

squad, stands out particularly for Jasprit Bumrah's current form. He's fit, accurate, fast, and highly skilled. No team seems to have an answer for

"In a 120-ball game, having someone like Bumrah with his pace for 24 balls makes a huge difference. India has looked confident even in tough



situations and on difficult pitches in America.

"Their batters, like Rohit Sharma who played a magnificent innings against Australia, seem to be back in form," he added.

The pitch in Guyana has

favoured the bowlers in the past by slowing down as the game goes on.

Spinners have dominated at this venue, and the pacers get some help early on but teams have reached scores of 170-180

in the ongoing World Cup.
