

# **Delhi LG cracks whip on illegal immigrants**

elhi Lieutenant Governor Vinai Kumar Saxena has issued instructions to District Magistrates and the Commissioner of Police to identify illegal immigrants in Delhi, and take action in coordination with Central government. "Lieutenant Governor's attention has been drawn to reports on social media and other reliable sources that there is a sudden spurt in the number of illegal immigrants in Delhi. There is also a rise in encroachment by such people on public roads, footpaths, parks etc," stated an official letter from LG's office.

The letter has been forwarded by the LG's Principal Secretary to the Chief Secretary of Delhi, Commissioner of Police, Commissioner of Municipal Corporation of Delhi (MCD) and Chairman of New Delhi Municipal Corporation (NDMC). Delhi A senior official from the MCD told The Pioneer that in light of the letter, a drive will be carried out to identify and evict such people from the land belonging to the MCD, and any illegal immigrants will be reported to the law enforcement agency.

According to reports, at least 20,000 Rohingya are registered in India with the United Nations High Commissioner for Refugees (UNHCR, also known as the UN Refugee Agency) and an estimated 1,100 such people live in New Delhi, including at the Kalindi Kunj camp in South-east Delhi. Ahead of the Delhi Assembly polls, due early next year, the Bharatiya Janata Party (BJP) leaders in Delhi have been accusing the ruling Aam Aadmi Party (AAP) of "patronising the Rohingyas and Bangladeshi living illegally in the city and gaining votes from them". The LG's letter also mentioned that many illegal migrants are being given various



ID cards in Delhi, and this has the potential to impact electoral politics, "there are reports that efforts are underway for getting their identity documents such as Aadhar, Election Identity Card, etc, prepared on the basis of fake documents and adopting a manipulative process. It added that these documents are

being claimed as citizenship documents by the illegal immigrants. "Election Identity Card, if issued to illegal immigrants, provides them the most powerful right of democracy i.e. Right to Vote in our country. Giving such rights to illegal immigrants cannot be accepted by any Indian Citizen and such moves can even be detrimental to National security," the letter stated. The letter added that the Chief Secretary may issue instructions to District Magistrates through Divisional Commissioner to exercise extra caution in verification of people applying for identity documents. "Separately, Commissioner Police may also issue instructions to field level officials to be extra vigilant Delhi, and in light of this, Delhi's

specially while undertaking inspections of squatters along road side and on vacant Government land," it stated, adding that Delhi Police shall conduct a special drive for one month for identification of illegal immigrants and take further action in coordination with central agencies. "All government agencies should also ensure that no unauthorised occupation of public places takes place anywhere in the city as directed by the Supreme Court of India," the letter read. Reacting to the LG's direction, Delhi BJP accused the AAP of viewing it through a political lens. Delhi BJP President Virendra Sachdeva stated that previously, encroachments on Delhi's footpaths and around parks were mostly done by hawkers, but in recent months, Resident Welfare Associations and trade organisations have consistently drawn attention to encroachments by Rohingyas and others, who have been settling along roadsides and in parks. "During this period, both small and large criminal incidents have occurred on the streets of

Lieutenant Governor Vinay Kumar Saxena has directed the Police Commissioner to take action. It is unfortunate that the AAP is politicising the serious issue of encroachments by Rohingyas and others, which is related to the security of Delhi and the BJP strongly condemns this," he said. Reacting to the letter by the LG, the AAP claimed that the BJP is merely using the issue of illegal immigrants for political gains. "A thorough investigation should be launched on how illegal immigrants are entering our country in the first place. For this, the direct responsibility lies with Amit Shah, and the Union Home Ministry," the party said in a statement. It asked that if there are illegal immigrants, how many are there? "This is a massive failure, and the lack of action on detentions highlights it further," they claimed. Further, Delhi's ruling party

claimed that while on one hand, the BJP is granting citizenship to illegal immigrants, and on the other, it is staging a farce of an investigation. "The BJP must stop this hypocrisy and put a rest to its dirty politics," the AAP said.

November 12, Enforcement Directorate (ED) raided multiple locations in pollbound Jharkhand, apart from West Bengal, in a money laundering investigation linked to alleged illegal infiltration of Bangladeshi nationals, official sources said. A total of 17 places were raided in the two neighbouring states by the Ranchi office of the federal probe agency, a day before the first phase of polling in Jharkhand. Visuals of Central Reserve Police

Force (CRPF) personnel positioned outside a hotel located on Bariatu Road in Ranchi and a resort in the city were captured by media teams as ED teams scoured for documents, ledger entries and financial records inside. It was in September that the ED had filed a case under the Prevention of Money Laundering Act (PMLA) to probe an instance of alleged infiltration, and trafficking of Jharkhand leading to the generation of alleged slush funds. Prime Minister Narendra Modi and other Bharatiya Janata Party (BJP) leaders had also accused the State Government of aiding such infiltration leading to the altering of the demographic landscape of the tribal-dominated areas of Santhal Pargana and Kolhan regions during the recent poll campaign. Uttar Pradesh Chief Minister Yogi Adityanath on Monday accused the ruling Jharkhand Mukti Morcha-led coalition of converting Jharkhand into a 'dharmashala' for Rohingyas and Bangladeshi infiltrators. Earlier this week, Union Home Minister Amit Shah had announced that a committee would be formed, if the BJP is voted to power in Jharkhand, to identify and drive out infiltrators from the state besides reclaiming land grabbed by them.



## **BCCI stumps PCB dream of Champions Trophy visiting POK**

The Board of Control for Cricket in India (BCCI) on Friday strongly objected to Pakistan Cricket Board's (PCB) purported move to take the Champions Trophy for a tour of the disputed 'Pakistan Occupied Kashmir' (POK), prompting the global body International Cricket Council (ICC) to put the promotional event on hold. The tournament, last played in 2017, is already in limbo after

the BCCI officially intimated ICC about the Indian cricket team's inability to travel to Pakistan. The PCB in return, as of now, has rejected the proposed 'Hybrid Model' with India playing its matches in Dubai. The schedule has also been put on hold and the new controversy could only make things ugly. It is learnt that BCCI secretary

Jay Shah on Friday spoke to the top brass of the ICC and condemned this move by Pakistan and has urged the global body to take strong note. The BCCI secretary, after it came to his notice, called up the ICC and was extremely critical of

PCB's move to conduct a Trophy tour of multiple cities which fall Pakistan Occupied under Kashmir," a senior BCCI official privy to the development said according to reports, adding, "He has urged the ICC to take strong action. As far as Islamabad is concerned, there is no issue but there can't be any Trophy tour to POK.

The Trophy Tour is part of the global body's promotional campaign, involving visits to multiple cities as per discussions between the international body and the host country.

However, the Pakistan Cricket Board (PCB), without prior consultation with stakeholders, announced on its official social media that the Trophy would be taken to Skardu, Murree, and Hunza, areas that fall under the disputed territory. "Get ready, Pakistan! The ICC Champions Trophy 2025 trophy tour kicks off in Islamabad on 16 November, also visiting scenic travel destinations like Skardu, Murree, Hunza and Muzaffarabad. Catch a glimpse of the trophy which Sarfaraz Ahmed lifted in 2017 at The Oval, from 16-24 November," the PCB tweeted.

Deoghar airport for nearly two hours on Friday after his special Indian Air Force (IAF) aircraft developed a snag, flew back to Delhi in another plane. PM Modi was supposed to return to New Delhi on the IAF plane after addressing a rally in Bihar's Jamui, around 80 km from Deoghar. Senior Congress leader and Leader of Opposition Rahul Gandhi too faced a two hour delay in the schedule due to a grounded helicopter close to the place where PM's craft was held.

The PM visited Jamui to attend a function marking the 150th birth anniversary of tribal leader Birsa Munda, celebrated as Janjatiya Gaurav Divas.



"PM Modi left for Delhi from Deoghar in another special aircraft after his IAF plane developed a technical snag. The aircraft could not be rectified on time. The PM had to wait for more than two hours, Deoghar Deputy Commissioner Vishal Sagar said. While Modi waited for the issue to be resolved, the region's airspace was declared a "noflying zone".

Meanwhile, Congress leader Rahul Gandhi was also caught in a similar situation in Godda, Jharkhand. Rahul's helicopter, which was supposed to take him back after addressing an election rally, was grounded for about two hours, prompting allegations from the Congress that the delay was politically motivated.

'Our Íeader Rahul Gandhi's helicopter was not allowed to take off for about two hours, posing a grave threat to his life. This was a security lapse at the behest of the Centre," state minister Deepika Pandey Singh alleged.

Congress also Friday complained to the Election Commission against the alleged grounding of Rahul Gandhi's helicopter in poll-bound Jharkhand and sought its urgent intervention in ensuring a level-playing field in poll campaigning.

Addressing a gathering of tribals at the Janata Maidan here on the occasion of Janajatiya Gaurav Divas, organised to commemorate the 150th birth anniversary of Birsa Munda, a revered tribal freedom fighter, Majhi criticised the previous BJD government for failing to implement the PESA Act, accusing it of harbouring an "anti-tribal" attitude. "The BJD government never wanted to ensure the socioeconomic development of tribal communities. Our government will guarantee allaround development for tribals," he said.

Odisha is among 10 States with Fifth Schedule Areas where the PESA Act is applicable. In terms of tribal population, Odisha ranks third in the country after Madhya Pradesh and



Maharashtra. The Act empowers tribal communities by granting them greater authority in self-governance and ensuring the protection of their unique social and cultural practices in the Fifth Schedule Areas.

As per the spirit of the PESA Act. 1996, power and authority should be devolved to gram sabhas and panchayats.

Odisha has 13 PESA districts, six fully-covered districts, Malkangiri, Nabarangpur, Rayagada, Mayurbhanj, Sundargarh and Koraput, and seven partially-covered districts, Ganjam, Keonjhar, Sambalpur, Kandhamal, Kalahandi, Baleswar and Gajapati. Of Odisha's 314 blocks, 121 have been identified as Tribal Sub-Plan blocks.

According to experts, since the PESA Act is a Central law, the Union Government should have framed its rules as was done for the Forest

Rights Act, 2006. States such as Himachal Pradesh, Rajasthan, Telangana, Gujarat, Chhattisgarh, Madhya Pradesh and Maharashtra have already notified their PESA Rules while Jharkhand has floated a draft for public consultation. Reacting to the Chief Minister's remarks, BJD leader Pradeep Majhi refuted the allegations of tribal neglect.

"The BJD government, under the leadership of Naveen Patnaik, has undertaken significant initiatives for the socioeconomic development of tribal communities. Special Development Councils were established for their upliftment alongside measures to provide quality healthcare, education and livelihood opportunities," he stated.

On this occasion, the CM also laid the foundation-stones for projects worth Rs 1,535 crore aimed at the development of tribal communities.

Keeping the huge footfalls during the holy Kartika month in view, a restriction on devotees entering the shrine through the three gates except for the Lions Gate was imposed. They were entering only through the Lions Gate. To decide on the devotees'

From Sarai Kale Khan to **Birsa Munda Chowk, a historical journey**

Mediaeval era origin Sarai Kale Khan Chowk dating back to the 16-17 Century will now be called Birsa Munda chowk in a tribute to the tribal icon and freedom fighter. The renaming, on the occasion of his 150th birth anniversary, was announced on Friday by Union Minister of Housing and Urban Affairs Manohar Lal. November 15 was declared 'Janjatiya Gaurav Divas' by the Central government in 2021.

Sarai Kale Khan is one of the busiest areas of Delhi, particularly due to the Inter-State Bus Terminal (ISBT) from where buses ferry travellers to destinations across north India. In the past, it was known as Moocho Waali Sarai


(Inn of Moustaches) because every man had long moustaches, which was a symbol of masculinity in those days.

The renaming of the historic area, comes ahead of the Delhi Assembly polls, and was announced by the minister on the occasion of the unveiling of a statue of Birsa Munda by Union Home Minister Amit Shah and Delhi Lieutenant Governor Vinai Kumar Saxena at the Baansera Bamboo Park near Sarai Kale Khan inter-state bus terminus (ISBT) in south-east Delhi. President Droupadi Murmu, Prime Minister Narendra Modi and several leaders also paid tributes to the great leader.

Birsa Munda spearheaded a tribal movement that started in the

independence movement. Born in 1875 in present-day Jharkhand, Munda had challenged British rule and is credited with mobilising tribals against the empire. He died in British custody at a young age of 25 years. Munda, the hero of the Indian tribal freedom struggle, played a pivotal role in inspiring the tribal community of the Chotanagpur region to fight for their independence. He led the armed revolution known as "Ulgulan" (the rebellion) against British rule. He belonged to the Munda tribe in the Chhotanagpur Plateau area. He spearheaded an Indian tribal mass movement that arose in the Bihar and Jharkhand belt in the early 19th Century, to protest British colonisation.

Munda rallied the tribals to fight against the forceful land grabbing carried out by the British government, which would turn the tribals into bonded labourers, and force them to abject poverty. He influenced his people to realise the importance of owning their land and asserting their rights over it.

He founded the faith of Birsait, a blend of animism and indigenous beliefs, which emphasised the worship of a single god. He became their leader and was given the nickname, 'Dharti Aba' or the father of the earth. He died on June 9, 1900, at age 25.

# To boost animal husbandry sector Cabinet clears 4 proposals of Rs 1,823 crore

L he State Cabinet on Thursday approved four proposals worth Rs 1,823 crore for the development of animal husbandry, including 'Goal for Management and Treatment of Animals' (GOMATA) scheme

The GOMATA scheme will be implemented in the State for 3 years from the current financial year (2024-25) with a total budget outlay of Rs 342.65 crore, Chief Secretary Manoj Ahuja said.

The scheme aims to benefit the livestock farmers of the

State through delivery of veterinary service at veterinary institutions and at farmers' doorstep through treatment, vaccination, disease control and surveillance, he said. scheme.

The implementation of the scheme will facilitate phase wise vaccination of 2.5 crore and treatment of 1.30 crore livestock annually, he informed.

Similarly, the State Cabinet also decided to implement another scheme named as "Prani Sampad Samruddhi Yojana (PSSY)" with a total budget outlay of Rs 1,031.19 crore for 5 years (2024-25 to 2028-29) to enhance meat and eggs production, he said.

This sub-scheme aims at benefiting 3,73,928 farmers in-

# Changing nature of the press Navigating the age of digital media and misinformation

The landscape of journalism has undergone unprec edented changes across the globe over the past two decades. Once dominated by newspapers, magazines and television, the field of news media is now deeply intertwined with the digital age, shaped by social media, real-time news apps, blogs and an increasingly blurred line between credible news sources and unverified content. This transformation has redefined the nature of the press with significant implications for journalists, audiences and democracy itself.

One of the most significant shifts in the press has been the decline of print newspapers and magazines. Readership and advertising revenues for traditional media have decreased dramatically as digital platforms have taken the lead. Publications that were once household names have closed their doors, and others have turned to online-only formats to cut costs and reach broader, digital-savvy audiences. The rapid rise of social media has further amplified this trend as

people now have the power to access breaking news with the swipe of a finger, 24/7.

Major national news outlets in India like 'The Times of India,' 'The Hindustan Times,' 'The Asian Age,' 'Deccan Chronicle' and 'The Pioneer' and international dailies like 'New York Times' and 'The Washington Post' now rely heavily on their digital presence and subscriptions, developing mobile apps, push notifications and interactive digital content to retain their reader-

ship. Many small-town newspapers, including the Odia vernacular dailies, have also started focusing on enhancement of their digital presence.

The digital age has not only changed the way we consume news but also who creates it. The internet has made it possible for anyone to report news, post updates and opinions. share This democratisation of information has fostered a diversity of voices that would not have been possible in the pre-digital era. Independent journalists, bloggers and citizen journalists have gained followings by reporting on niche topics or lo-

cal events often overlooked by larger media outlets. While this has allowed for a wider array of perspectives, it has

also raised questions about the credibility of information. When news is crowd-sourced or shared on social platforms without rigorous fact-checking, it can be difficult to separate well-researched reporting from misinformation.

Another defining feature of the modern press is the use of algorithms to shape the news we see.

On platforms like Facebook, Twitter and TikTok, algorithms decide which stories appear in our feeds based on our previous interactions. This selective exposure often creates "filter bubbles," where readers are primarily exposed to viewpoints they already agree with, leading to a form of echo chamber. Although these algorithms aim to show users the content they are most likely to engage with, they can unintentionally polarise audiences and limit access to a balanced perspective on current events. In the current digital landscape,

misinformation and "fake news" are pervasive issues. The ease of sharing content on social media has given rise to a staggering volume of false or misleading information, which can spread rapidly before fact-checkers have a chance to verify its accuracy. This phenomenon is especially concerning in the context of politically-charged topics, where deliberate disinformation campaigns can influence public opinion and, ultimately, democracy. The press now faces a new re-

sponsibility: to actively combat misinformation while upholding ethical standards of accuracy and objectivity. Fact-checking organisations have become an essential part of the journalism ecosystem, working to quickly verify or debunk viral stories. Platforms like Twitter (now X), Facebook and YouTube have implemented their own measures such as labeling questionable content and promoting verified news sources, but these actions alone are not enough to stem the tide of misinformation.

In the past, a handful of well-established news outlets were regarded as the primary gatekeepers of information. Today, however, audiences have access to a dizzying variety of sources, each with its own perspective, style and level of credibility. As a result, the traditional markers of authority such as established reputations, journalistic credentials and editorial oversight have been challenged by new forms of media that prioritise entertainment value, personal branding and immediacy over traditional reporting standards.

Increasingly, people trust their news from social influencers, popular bloggers and even podcasts over traditional news channels. This shift complicates the way audiences perceive authority and reliability, prompting news organisations to rethink how they build and retain trust.

In a world filled with misinformation, where traditional news models are giving way to an often chaotic digital sphere, the role of a free press in upholding democracy is more critical than ever. Today's media not only reports the news but also holds governments accountable, sheds light on important social issues and gives voice to underrepresented communities. But to maintain this vital role, the press must adapt to the challenges of a fragmented media landscape while preserving the values that have long defined journalism: integrity, transparency and a commitment to the truth.

Five children aged three to five years tragically drowned during Kartika Purnima festivities. Incidents occurred in Baleswar, Malkangiri and Cuttack districts while retrieving floating boats.

The mishaps are learnt to have occurred when the deceased children went into water bodies to collect floating boats

girls aged about five years drowned in a pond at Panishapada village under Basta police limits in Baleswar district. The deceased have been identified as the daughters of Dilip Kumar Das and Manas

Nanda, two villagers of Panishapada. As per reports, the girls

were last seen playing in the backyard. Later, they might have noticed boats floating in the nearby pond and went there to bring them while not being watched by their family members.

Not finding them at the spot where they were playing, their family members launched a frantic search.

Later, they were rescued from the pond and rushed to the nearby Rasagovindapur Community Health Centre (CHC).

However, it was too late by then. The doctors at the CHC declared them received dead.

In another shocking incident reported from Saundia village under Khaira police limits in the same district, a three-year-old boy drowned in a pond.

Similar incidents were also reported from Champanagar in Malkangiri and Salepur in Cuttack where a minor girl (age not known) and a three-yearold boy drowned.

## Brahmapur Mayor's security withdrawn She mulls legal

In a controversial move, the State Government has withdrawn the personal security officer (PSO) assigned to Brahmapur Mayor Sanghamitra Dalai, without any prior notice or official explanation.

The sudden decision has raised concerns over selective treatment, as the mayors of Bhubaneswar and Cuttack continue to receive govern-

ment-provided security. Sources indicate that the withdrawal of security personnel came as a shock, especially since Brahmapur is one hind the decision.

Mayor Sanghamitra Dalai, who had not been informed in advance about the development, expressed her disappointment over the issue. "No official communication or written directive has been provided to me regarding the withdrawal of my security. This sudden decision not only undermines my safety but also affects my dignity," she stated.

Despite maintaining silence initially, Mayor Dalai has now decided to take the matter to court. She emphasized that if the government intended to withdraw security, it should have done so for all three Mayors across the State

m he\ Forest\ Department\ of}$ Keonjhar division has registered a case against 13 people in connection with the illegal felling of trees in Krushnapur reserve forest, which is an elephant habitation under Champua Range of Kalikaprasad forest beat.

Meanwhile, the village is deserted as people have fled their houses in order to evade arrest after the case was registered. So, the Forest Department is yet to make any arrests.

According to sources, the Keonjhar Forest Department had given permission to fell down 2,505 eucalyptus trees to Krishnapur Van Suraksha Samiti (VSS) in the reserve forest. However, more than double the number of trees including some rare species were allegedly cut down, due

to lack of proper supervision. villagers The of

Krushnapur lodged written complaints with Keonjhar district Collector Vishal Singh, DFO Dhanraj HD and the Champua sub-collector, when no action was taken by the local forest officials despite several complaints. Following the complaints, ACF Akshay Chhatria who is in charge of Champua range, was asked to conduct an inquiry into the matter. The villagers alleged that the counting was stopped

midway as a large number of trees were found cut during the counting. If it is properly counted by an independent team, then the number of illegal felled trees would be much more than cited, they said.

The Forest Department registered a case against Ranjan Kumar Mahanta, president of the VSS, and 12 others

"Around 1,123 more trees were found to have been cut. A case has been registered in this regard. The accused would be arrested," said forester Sunita Baghel, adding that after registration of the case, the accused are absconding. Meanwhile, the villagers

have submitted a memorandum to the Chief Minister grievance in Keonjhar against the forest officials who are supervising the work.

DFO Dhanraj HD said, "13 persons were booked after registering a case (OR 14 CH of 2024-25) in the incident and more inquiry is going on."

When the government is spending crores of rupees to create forests by planting trees, ironically, in Keonjhar division, the department is allowing a large number of trees to be cut affecting the habitat of wild animals, lamented environmentalists.

## **Jitendra Singh bats for private-public partnership to tackle Diabetes**

Diabetes is too serious to be left solely to the medical professionals, Jitendra Singh, Union minister for earth sciences and science and technology, said as he advocated for increasing public-private partnership in the efforts to achieve truly optimal results.

He made these remarks at the 52nd Annual Conference of the Research Society for the Study of Diabetes in India (RSSDI), in collaboration with the Diabetes International Federation (IDF), which commenced on the occasion of World Diabetes Day on Thursday.

The two-day conference brought together over 5,000 healthcare professionals, national and international

experts, and prominent speakers to discuss and address the growing diabetes epidemic in

India, where more than 10 crore people are currently affected, according to the latest report from the Indian Council of Medical Research (ICMR). "Just as economics is too serious a subject to be left to economists alone, I believe we can say that diabetes is too serious to be left solely to the medical professionals. The Uttar Pradesh Public Service Commission (UPPSC) has rescheduled the PCS (Preliminary) Examination for December 22, after intense student protests. However, agitation continues as students demand that the Review Officer-Assistant Review Officer (RO-ARO) examination also be conducted in a single day

'The commission has assured fairness through a high-level committee, but we need a written commitment that the RO-ARO exam will be held in one shift," said one protester. UPPSC officials argue that conducting the RO-ARO exam in one shift is logistically challenging due to the high number of candidates over 10.7 lakh registered for the exam. Strict government directives limit the use of private or substandard centers, allowing only government-approved venues with-in a 20-km radius of district headquarters.

Even with the inclusion of universities, medical colleges, engineering institutions, and other government facilities,

there are not enough centers to accommodate all candidates in a single shift.

As a solution, the UPPSC plans to conduct the RO-ARO exam over multiple days using a normalization process to ensure fairness in evaluation. The decision has judicial

The decision has judicial backing; the Supreme Court upheld normalization in its January 2024 ruling in "Uttar Pradesh State and Others vs. Atul Kumar Dwivedi and Others".

Omkar Nath Singh, Under Secretary of UPPSC, stated that a committee has been formed to ensure the RO-ARO selection process is transparent and fair. "The committee will analyze all aspects and submit its report soon," he added.

Students remain uncon vinced, arguing that normalization introduces discrepancies and diminishes fairness. "We initiated this protest to ensure that both exams are conducted on the same terms. While the PCS exam will now be held in one day, the commission's approach to RO-ARO remains unclear," said a student leader.

More than two decades after deserting their village due to Maoists, around 25 tribal families are planning to return to their native place in Chhattisgarh's Narayanpur district.

Nearly 100 members of these families had left their homes in Gaarpa village located in Abujhmad after Naxalite started targeting them in 2003

They were then settled on the outskirts of Narayanpur town on a tract of government land, where they took up agriculture for livelihood.

Now, 21 years after their desertion, these families recently visited their native place and have been planning to resettle there after police set up a camp there to facilitate development works and ensure security for local population.

Abujhmad, bordering Maharashtra's Gadchiroli district, was considered a Maoist fortress until recently. On October 4, security forces scripted their most successful anti-insurgency operation in Chhattisgarh by gunning down 31 Naxalites during an encounter in the area. "Leaving the ancestral land

was never easy. We had no



option but to flee for the sake of our lives." 60-year-old Sukkuram Nureti told PTI. Nureti's family was among the 25 families that left Gaarpa in April 2003. Nureti hails from the Abujhmaria community, a particularly vulnerable tribal

group. "Of the 80 families in the village, around 25 were followers of 'Gayatri Pariwar' and Naxalites objected to it. They threatened us with dire consequences if we did not quit following 'Gayatri Pariwar'. So we decided to leave the vil-

lage," he said. Nureti said they always wanted to return.

"Now it seems our dream will come true as a police camp has been set up and

things have started improving there," said Nureti, who has served as a member of Janpad

panchayat in the past. Nureti and others who had left the village visited Gaarpa last week and opened a Lord Shiv temple that had remained shut since 2003. "We are planning to resettle in the village as we have our farmland and homes there," he said.

Making significant inroads Abujhmad, the into Chhattisgarh police have set up security camps in Gaarpa, Kasturmeta, Mastur, Irakbhatti, Mohanti and Horadi villages in the past eight months. The Gaarpa camp came up on October 22. 

# **Right to breathe**

As Delhi air turns toxic, Delhiites face severe health risks; the capital needs long-term solutions, not knee-jerk reactions

elhi's air quality has plummeted to hazardous levels, with the city's Air Quality Index (AQI) soaring to a staggering 428, marking the worst pollution levels in the country. As a result, the Commission for Air Quality Management (CAQM) has announced the enforcement of stringent Graded Response Action Plan (GRAP)-3 restrictions starting at 8 AM on Friday. On Thursday, the 24-hour AQI for the city reached 428, signaling a "severe" air quality category, which poses serious health risks to the population, especially children, the elderly and those with pre-existing respiratory conditions. The current AQI level of 428 puts Delhi in the "Severe" category, indicating that the air is dangerously polluted and immediate action is required to prevent further deterioration of public health. In response to the deteriorating air quality, the CAQM has imposed the following GRAP-3 restrictions to mitigate the pollution levels: All non-essential construction and demolition activities in Delhi and the surrounding National Capital Region



(NCR) are suspended to prevent dust and particulate matter from exacerbating the pollution. Vehicles that do not meet the latest emission norms are banned from the roads. Specifically, petrol vehicles that do not comply with BS-III (Bharat Stage III) standards and diesel vehicles that fall under BS-IV norms are prohibited from operating within Delhi and parts of NCR.

These measures are expected to significantly reduce the amount of pollutants being emitted into the air, especially from construction sites and older vehicles, which are major contributors to air pollution. The current spike in pollution levels to a combination of factors. The calm winds and a sharp drop in temperature have trapped

pollutants in the air, preventing them from dispersing. The weather conditions have created a 'smog blanket' over the city, intensifying the effects of vehicular emissions, industrial pollution, and the burning of crop stubble in neighbouring states. The Supreme Court of India has taken note of the deteriorating air quality and has scheduled a hearing on November 18 to discuss further enforcement measures. The court has emphasised that every citizen has the fundamental right to breathe clean air, as protected under Article 21 of the Indian Constitution. Delhi's pollution crisis has now drawn significant national and international attention. While the immediate focus is on enforcing short-term measures like the GRAP-3 restrictions, experts argue that lasting solutions require systemic changes, including stricter emissions standards, better waste management, and a push for cleaner public transportation options. As the city continues to grapple with the toxic smog, Delhi residents are urged to stay indoors as much as possible, avoid strenuous outdoor activities, and wear N95 masks to protect themselves from the harmful effects of the air pollution. In the coming days, it is hoped that both weather conditions and Govt interventions will bring some relief, but the long-term health of the city's residents depends on sustained efforts to curb the sources of pollution.



# **US-Iran tensions:** War clouds over West Asia

With regional stability hanging in the balance, the world watches anxiously as West Asia braces for the potential fallout of escalating hostilities

n July 3, 1988, the US Navy's USS Vincennes, in an act of brazen military overreach, shot down Iran Air Flight 655, a civilian airliner carrying 290 passengers, over the Persian Gulf. The Navy's justification-that this was an "unintentional error"- belies the harsh reality: this was not a mistake, but rather an emblematic instance of Western indifference to the lives of those deemed expendable.

The Navy mistook a commercial flight for an enemy fighter jet, launching two surface-to-air missiles and killing all aboard. Yet, the US response was not to acknowledge a moral failing, but to double down on its denial, offering neither a genuine apology nor reparations to the victims' families. This tragedy was a grim reminder of the West's longstanding practice of dehumanising the peoples of West Asia in its relentless pursuit of geopolitical dominance. For the Iranian people, it was not merely a military blunder; it was a stark dismissal of their humanity, reinforcing the deeply entrenched belief in Western circles that the lives of those beyond its borders are, at best, collateral damage in the pursuit of power.

The echoes of this tragedy persist today, amplified by the volatile relationship between the US and Iran. Just days after Donald Trump's re-election, the US government claimed to have uncovered a plot by Iran to assassinate the president. Iran vehemently rejected these allegations, with Foreign Minister Abbas Araqchi dismissing them as a "third-rate comedy" and accusing the US of fabricating a narrative to justify further aggression. Araqchi's deri-sion-mocking the absurdity of an assassin "sitting in Iran and talking online to the FBI"-renewed the deep mistrust that defines the US-Iran relationship.

Now that Trump has secured a second term and will become the 47th President of the USA, it is clear that his foreign policy, especially towards Iran, could become far more aggressive, with disastrous consequences. His planned and often opportunistic in appointments of hawkish figures their foreign policy, Iran's

such as Pete Hegseth as Secretary of Defence, Steven C Witkoff as Special Envoy on West Asia Affairs and Mike Huckabee as Ambassador to Israel - suggest that peace in the West Asia is more distant than ever. These choices reflect a growing alignment with Israel's interests, further inflaming tensions and laying the groundwork for a catastrophic conflict-one that could see a war against Iran as the ultimate culmination of decades of Western interven-

tion. This looming disaster cannot be divorced from the historical legacy of Western interference in West Asia. Iran's relationship with the West has been shaped by centuries of betrayal and manipulation. A defining moment in this fraught history was the CIAbacked coup of 1953, which ousted Iran's democratically elected Prime Minister Mohammad Mossadegh after he sought to nationalise Iran's oil industry. This act, orchestrated by

Western powers, reinstated the Shah's brutal regime, sowing the seeds for the 1979 Islamic Revolution. This history of intervention, driven by oil and geopolitics, instilled a deep sense of betrayal in the Iranian consciousness a senti-

neighbours have repeatedly failed to put regional unity ahead of external pressures. Yet, the geopolitical manipulations that have shaped this region's history are part of a broader pattern: the West's refusal to recognise the sovereignty of nations it deems strategically irrelevant.

The Iranian people have grown ever more resolute in their refusal to capitulate to external demands. This isolation, initially born of necessity, has also transformed into a profound existential struggle. In response, Iran has sought alliances with nations like China and Russia and forged relationships with non-state actors in the region. These alliances-born not of ideology, but of pragmatic necessityhave allowed Iran to exert regional influence, shifting the balance of power in ways the West never anticipated. In his first term, Trump used

**REPEATEDLY FAILED** a two-pronged strategy to **TO PUT REGIONAL** weaken Iran: connecting other Arab nations in favour of UNITY AHEAD OF Israel through the Abraham Accords, a treaty engineered by **EXTERNAL** his Jewish-origin son-in-law, PRESSURES Jared Kushner, and secondly, targeting key personalities who enabled Iran's influence in the region while funding efforts by Iranians living abroad working against Iran.

In his second term, which could be more refined and sharpened by the experiences he earned in the last eight years-both in office and out-

side the White House-his actions could become far more unpredictable. Consequently, the potential for war against Iran is no longer a distant fear; it is a rapidly approaching reality. It would affirm the West's view that the lives of Iranians, like those across the Global South, are expendable in pursuit of geopolitical dominance, making this a war of choice, not necessity, with existential stakes for Iran.

In this context, the responsibility to avoid war does not lie solely with the U.S. or Iran, but with all the nations of the region, including those of the Arab world.

Despite their differing beliefs, histories, and alliances, it is incumbent upon Arab nations to take a united stand against the spectre of war. The voices of Arab leaders, particularly those who have long been caught in the geopolitical crossfire of the US-Iran conflict, must rise in defence of regional peace and stability. Divisions must be set aside in favour of collective action that prioritises the preservation of life and sovereignty over ideological differences. The world, and particularly the nations of West Asia, must strive to find a path of diplomacy and dialogue, to avoid yet another destructive war that will further tear apart the very fabric of the region. 

# Bangladesh: A nation's press under pressure

Attacks on media houses and journalists continue notwithstanding the interim Govt's claim that it is committed to upholding media freedom

he media's independence is under severe attack in Bangladesh under the interim government headed by chief advisor Muhammad Yunus. The attack is two-pronged. One of these is directed against media houses and journalists perceived to have been supporters of the Awami League and the government when Sheikh Hasina headed both. The second targets non-aligned media establishments, editors and journalists, including those known for standing up to the Awami League government's repressive media regime. The objective is to pressure them into toeing the line laid down by the young sparks dominating the Anti-Discrimination Students Movement (ADSM) and rabidly anti-Awami League and fundamentalist Islamist elements in sections of the media and the interim government.

Coming to media houses, eight channels were attacked on August 5, 2024, itself, when Sheikh Hasina left for India. Among them was Ekattor TV's office in Baridhara, Dhaka, which was vandalised and burnt down; also attacked on the same day in Dhaka were the premises of Samay TV, and ATN Bangla. On August 19, an armed mob attacked and severely damaged the establishment of East West Media group, which runs Kaler Kantha (Voice of the times) Bangladesh Pratidin (Bangladesh daily), both Bengali-language newspapers, Daily Sun, an English-language daily, News24BD, a television news channel, Radio Capital, a radio station, and Banglanews24, an online Bengali daily. The mob assaulted journalists, injured a woman journalist and harassed women employees.

As for journalists, according to Reporters Without Borders, a globally-respected international NGO headquartered in Paris, "baseless accusations of killing protesters have been brought against nearly 140 journalists. Twenty-five have been charged with "crimes against humanity. Many of them have gone into hiding because they fear being arrested and jailed.

A number of journalists have been arrested and jailed. Their ranks include Shakil Ahmed, former head of news at television channel Ekattor TV, and Farzana Rupa, its former chief correspondent, who were arrested from Hazrat Shahjalal International Airport, Dhaka, on August 21, 2024, when were about to board a Turkish Airlines flight to Paris via Istanbul, along with their daughter. The two of them remain in prison, as do Mozammel Haque Babu, chief executive officer of Ekattor TV and Shyamal Datta, editor of Bhorer Kagaz (Paper at Dawn) who were arrested on September 15. In a letter emailed recently to Muhammad Yunus, Jodie Ginsburg, chief executive officer of the Committee to Protect Journalists (CPJ), a respected NGO promoting press freedom and defending the rights of journalists worldwide, urged him to ensure, among other things, respect for the "procedural rights of four incarcerated pro-Awami League journalists: Farzana Rupa, Shakil Ahmed, Mozammel Babu and Shyamal Dutta, including their right to a free trial." The arrests are hardly surprising. According to a report in the Dhaka Tribune dated September 19, 2024, the ADSM leader, Nahid Islam who, besides his other hats, is advisor in charge of the Ministry of Information and Broadcasting, thundered at a press conference on the previous day that the "instigators" of the July-August massacre



[of protesters] would be brought to justice no matter whether they identified themselves as journalists, writers and artists. Doubtless, the interim government was to decide as to who were to be brought to justice.

Just two examples would show how utterly arbitrary and vindictive **EIGHT CHANNELS** such decisions have been. The one is the continued incarceration of WERE ATTACKED Shahriar Kabir, an internationallyrespected human rights activist, ON AUGUST 5, champion of secular humanism, 2024, ITSELF, advocate of the bringing war criminals of 1971 to justice, author and WHEN SHEIKH journalist. The second is the arrest, on November 6, 2024, of the noted HASINA LEFT FOR television actor, Shomi Kaiser, daughter of Shahidullah and Panha Kaiser. Shahidullah, a noted writer and journalists, disappeared after being abducted by Pakistani army personnel and their collaborators from the ranks of Bangladesh Jamaat-e-Islami and allied organisations like al-Badr, al-Shams and Razakars. His brother, Zaheer Raihan, also disappeared while looking for him. Panna Kaiser was an Awami League Member of Parliament (1996-2001) who worked in the area of youth welfare. Apart from arrests on false charges, the cancellation of accreditation cards, which has reached a total of 167 at the time of writing, is being used as a weapon against journalists. Such cards are important for identifying oneself as a journalist, and securing entry into restricted areas, government offices and meetings. Referring to the matter, Celia Mercier, Head of South Asia Office of Reporters Without Borders,

another globally-respected NGO whose mission is to act for freedom, pluralism and independence of journalism, and defend those who embody these ideals, has said,

"The decision to rescind the accreditation cards of journalists considered close to the previous government is politically-motivated and punitive, and has the effect of intimidating the press. It encourages self-censorship and threatens the very existence of opposition media. This decision by the Information and Broadcasting Ministry [of Bangladesh] is incomprehensible, coming just a week after it took a positive step by establishing a mechanism for reporting cases of harassmentary on Sheikh Mujib and Sheikh Hasina, suggesting that these outlets are paving the way for fascism by creating contrasting narratives. He further said that the media had fostered hatred towards Islam, misrepresented societal divisions, and perpetuated a narrative of eternal gratitude towards India for its role in Bangladesh's liberation. Significantly, Mahmudur Rahman said this in the presence of Chief Advisor Muhammad Yunus' press secretary, Shafiqul Alam.

Events like this have been creating a climate in which channels and publications, including the two of Bangladesh's leading paper which Rahman criticised, are sought to be but under compulsion to conform to the kind of reportage and comment the interim government expects of them. All this makes a mockery of the interim government's assertions that it is for the freedom of the press and its moves like the setting up of a commission for hearing allegations of harassment by journalists. An editorial in The Daily Star, datelined November 7, 2024, delivered a damning indictment of the situation and the interim government's role when it said, "In our pursuit of a fair, anti-discriminatory Bangladesh, few values are as vital as press freedom. We are, therefore, concerned by the persistent intimidation, harassment, and censorship faced by journalists, which shows how the media landscape remains fraught with obstacles? TS President-elect Donald U Trump has said his administration will focus on ending the Russia-Ukraine war, as he lamented the killing of people in the conflict. He also said his administration

will also work on bringing peace to West Asia. We're going to work on the Middle East, and we're going to

work very hard on Russia and Ukraine. It's got to stop," Trump said during a gala for the America First Policy Institute held at his Mar-a-Lago estate on Thursday.

This was his first major speech and public appearance after his stunning electoral victory in the November 5 presidential elections.

"Russia and Ukraine's got to stop. I saw a report today. Thousands of people over the last three days were killed. Thousands and thousands of people were killed. They happened to be soldiers, but whether they're soldiers or they're people sitting in towns, we're going to work it," he said. The President-elect has consis-

tently said his priority is to end the war and stem what he characterises as a drain on US resources, in the form of military aid to Ukraine. Meanwhile, Lisa Curtis, who

## N Korea tests exploding drones

Seoul (AP): North Korea tested exploding drones designed to crash into targets and leader Kim Jong Un called for accelerating mass production of the weapons, state media said Friday.

The country's latest military demonstration came as the United States, South Korea and Japan engaged in combined military exercises involving advanced fighter jets and a US aircraft carrier in nearby international waters, in a display of their defense posture against North Korea.

North Korea's official Korean Central News Agency published photos of Kim talking with officials near at least two different types of unmanned aerial vehicles. They included those with X-shaped tails and wings that look similar to the ones the country disclosed in August, when Kim inspected another demonstration of drones that explode on impact.

The drones flew various routes and accurately struck targets, KCNA said. Its images showed what appeared to be a BMW sedan being destroyed and old models of tanks being blown up.

## **Israeli strikes kill at least 12 Lebanese rescuers**

### AP BEIRUT

n Israeli airstrike killed at Aleast 12 Lebanese rescue workers on Thursday inside a civil defence centre in the eastern city of Baalbek, according to health and rescue officials, hours after state media in Syria said Israeli strikes in and around the capital killed at least 15 people. Lebanese emergency workers were digging through the rubble Thursday evening to search for more of their colleagues still trapped under the destroyed rescue centre, the group said in a statement. At east three civil defence members were wounded.

There was no immediate comment from the Israeli military. Lebanon's civil defence forces have no affiliation with the militant group Hezbollah, and they provide crucial rescue and medical services in one of the world's most war-torn nations.

The Health Ministry con-demned what it called a "barbaric attack on a Lebanese state-run health centre",

adding that "it is the second al members were killed. The Israeli attack on a health emergency facility in less than two hours." In southern Lebanon, an Israeli strike on Arabsalim village targeted the Health Authority Association, a civil defense and rescue group linked to Hezbollah, killing six people, including four para-medics, the Health Ministry said.

Earlier, Israel carried out at least two airstrikes on the western Mazzeh neighbourhood of Damascus and one of the suburbs of Syria's capital, Qudsaya, killing at least 15 and wounding another 16, Syria's state news agency said. An Associated Press journalist at the scene in Mazzeh said that a five-story building was dam-aged by a missile that hit the basement.

The Israeli military said it hit infrastructure sites and command centres of the Islamic Jihad militant group. In Syria, an official with

ritain's Treasury chief Rachel BReeves said Friday that she is "not satisfied" by official figures showing the British economy's rebound from recession slowed down sharply in the third quarter of the year, with most sectors stagnating.

The Office for National Statistics said growth during the July to September period was just 0.1 per cent. That was lower than the 0.5 per cent recorded in the previous threemonth period and below market expectations for 0.2 per cent. The statistics agency said overall output in September actually shrank, a development that has further fueled accusations from critics of the new Labour government that its pessimism

dragged the economy down in

its first few weeks in office. On coming to power in July for the first time in 14 years, the government described its economic inheritance from the former Conservative administration as the bleakest in decades, requiring urgent action to fix the public finances. The Conservatives' Treasury spokesperson, Mel Stride, sought to pin the blame for the slowdown on the new government, saying the deterioration in business and consumer confidence was a direct result of it "talking the economy down." Reeves used the budget to raise taxes sharply, mainly on business, as well as increasing spending on public services, such as the state-run National Health Service, and borrowing

on investments.

"Improving economic growth is at the heart of everything I am seeking to achieve, which is why I am not satisfied with these numbers," Reeves said following Friday's figures. Prime Minister Keir Starmer

has said raising economic growth is his government's number one priority over the next five years. Since the global financial crisis in 2008-9, the British economy has underperformed relative to previous years and actually slipped into a modest recession in 2023. The Resolution Foundation think tank said the British economy has been a "roller-

coaster" over the past year and that its medium-term performance has been "staid and stagnanť

As a result of the third-quarter slowdown, the think tank said the UK has fallen below the US at the top of the growth leaderboard of the Group of Seven leading industrial economies. This all serves to highlight that the government's mission to renew strong economic growth is both extremely hard, and absolutely necessary," said Simon Pittaway, the think tank's senior economist.

One factor hobbling the economy, many economists say, is Britain's departure from the European Union in 2020, which has made trade more difficult. Though the post-Brexit trade agreement between the two sides ensured there would be no tariffs placed on goods, exporters are finding life tough.

US president-elect Donald Trump, who enjoys very good relationship with Prime Minister Narendra Modi, is expected to build on the progress made during his first term and continue strengthening ties with India, his South Asia point-person at the White House during his first term has said. Speaking to PTI in an interview, Lisa Curtis, who served as deputy assistant to president Trump and as National Security Council senior director for South and Central Asia from 2017 to 2021, also said she expected the same bumps for India and the US, as in Trump's first term, including tariff, dependence on Russia over arms supply and oil purchase from Iran

"I think that President (elect) Trump will pick up where he left off with India. He clearly has good feelings, goodwill toward India, and I really see this as an opportunity to just continue building the relationship and really solidifying that partner-ship," Curtis said.

2021), there was an "elevation of the US-India relationship" because of the importance of India and its role in dealing with challenges from China, she said. Curtis pointed out that there was also a notable mutual respect and personal connection between Trump and Prime Minister Modi. "We could see that during the

said 'There were a couple of bumps in the road, and this was mainly when President Trump would tweet about the Indian tariffs. He really wanted American companies to have more access to the Indian market. He would often, before a meeting, tweet out something. It was almost a

negotiating tactic, I think, that he was doing. He did this with many countries. That did cause some irritation in the relation ship. But I don't think these tweeting incidents about Indian tariffs overwhelmed the broader relationship," she said. "We could probably expect similar things to happen in the

future as well. But I think everybody's more prepared for Trump's style and his negotiation style. His very transactional approach, trying to get a good deal for the American people,' she added. Responding to a question, Curtis

said the priority this time needs

to be on the security partnership between the two countries. She added. "This is an area where the interests of both sides converge. Both the United States and India have a lot of concerns when it comes to China, such as its attempts to dominate the technology market and efforts to be the hegemon in Asia. Neither India, nor the United States want that to happen. So, they have a deep mutual interest in cooperating?

# **Indian economy in sweet spot, forecasts 7.2** per cent growth in 2024: Moody's Ratings



Indian economy is in a sweet Lspot, with a mix of solid growth and moderating inflation, Moody's Ratings said, forecasting a 7.2 per cent GDP growth in the 2024 calendar year and 6.6 per cent in the next.

In its Global Macro Outlook 2025-26, the rating agency said the global economy has shown remarkable resilience in bouncing back from supply chain disruptions during the pandemic, an energy and food crisis after the Russia-Ukraine war began, high inflation and consequent monetary policy tightening

"Most G-20 economies will experience steady growth and continue to benefit from policy easing and supportive commodity prices," it said.

However, post-election changes in US domestic and



international policies could potentially accelerate global economic complicating ongoing stabilisation. The aggregate and net effects of trade, fiscal, immigration and regulatory policy changes will expand the range of outcomes for manufacturing activity.

countries and sectors On India, Moody's said the fragmentation, real GDP expanded 6.7 per cent year-over-year in the second quarter (April-June) of 2024, driven by a revival in consumption, household robust investment and strong

High-frequency indicators including expanding manufacturing and services PMIs, robust credit growth and consumer optimism signal steady economic momentum in Q3.

"Indeed, from macroeconomic perspective, the Indian economy is in a sweet spot, with the mix of solid growth and moderating inflation. We forecast 7.2 per cent growth for calendar year 2024, followed by 6.6 per cent in 2025 and 6.5 per cent in 2026," it said. Moody's said household

consumption in India is poised to grow, fuelled by increased spending during the ongoing festive season and a sustained pickup in rural demand on the back of an improved agricultural outlook. Additionally, rising capacity utilisation, upbeat business sentiment and the government's continued thrust

on infrastructure spending should support private investment.

"Sound economic fundamentals, including healthy corporate and bank balance sheets, a stronger external position, and ample foreign exchange reserves also

bode well for the growth outlook," it added. Sporadic food price pressures continue to inject volatility in the disinflation trajectory. Headline inflation breached the upper end of the RBI's 4 per cent (+/-2 per cent) tolerance band for the first time in more than a year in October, accelerating to 6.2 per cent amid a sharp jump in

vegetable prices. "Despite the near-term uptick, inflation should moderate toward the RBI's target in the coming months as food prices ease amid higher sowing and adequate food grain buffer stocks," the agency said.

Centre urges states to fill 663 vacant posts in consumer forums

The Union government on Friday directed states to accelerate the appointment process for 663 vacant positions across state and district consumer commissions. expressing mounting concern over vacancies that threaten to undermine consumer rights protection.

Consumer Affairs Secretary Nidhi Khare, who reviewed the situation with state government officials, expressed "deep concern" about increasing vacancies in consumer commissions compared to previous years. According to official data, 18 posts of President and 56 posts of members are lying vacant in state commissions as of October 2024.

At district level, 162 posts of President and 427 posts of members are vacant across the country, the consumer affairs ministry said in a statement.



Singh said. The members in the committee must work with the foresight of Edwin Lutyens, who planned what is known as New Delhi almost a century ago, he added.

"These futurists, planners and a collective of individuals with wisdom and experience should then craft an enduring blueprint of the urban infrastructure development of

at least all the major metro cities of India that will last a century," Singh suggested. The PMO should ideally monitor the committee monthly, with the PM personally overseeing it once a quarter, he added.

Singh said the committee findings should also be made public regularly so that people are informed of plans that will fortify their children's lives through the development of India's urban infrastructure. ## Japan's economy grows for second straight quarter on back of consumer spending

## AP TOKYO

apan's economy eked out an annual rate of 0.9% growth in the July-September period as consumer spending held up, government data showed Friday. The world's fourth-largest economy grew 0.2% in the fiscal second quarter, marking the second straight quarter of expansion, following 0.5% growth in April-June. Seasonally adjusted gross domestic product, or GDP, measures the value of a products nation's and services.

The annual rate shows how much the economy would have grown or contracted, if the quarterly rate continued for a year.

Private consumption, which makes up more than half of Japan's GDP, grew 3.6% on the back of healthy household consumption, according to preliminary Cabinet Office data. Recent data show wages and employment are improving. Spending was lower than the previous quarter, partly because of severe weather that crimped spending and shut down

some factories. Recent income tax reductions helped boost spending. Exports grew 1.5%. The

weakening yen is a plus for exports, tending to make Japanese products cheaper overseas. But the impact was relatively limited in the latest quarter.

Domestic demand grew at an The Japanese yen was trading annualized rate of 2.5%. at 160-yen levels earlier this at 160-yen levels earlier this year. It's now trading at 150ven levels.

Prior to the last two quarters, the economy contracted 0.6% in the January-March quarter after recording a 0.1% growth in October-December in 2023 highlighting how Japan's economy recently slipped into periods of contraction in between weak expansion.

"We believe the Japanese economy will continue to grow gradually, supported by growth in overseas economies," said Katsutoshi Inadome, senior strategist at SuMi Trust. He noted winter bonuses many Japanese get in coming months should also



The KNMA Theatre Festival offers a fresh take on theatre, exploring vulnerability and human connection. With productions like 'Love and Information,' it challenges traditional narratives and invites audiences to reflect on the complexities of identity and emotion, says SAKSHI PRIYA

heatre is a mirror of the human condition." This timeless quote captures the essence of why we turn to the stage - to reflect on who we are, how we live and the world we inhabit. Theatre has the power to make us confront uncomfortable truths, question our beliefs and reimagine the possibilities of human connection. It's a place where vulnerability, in all its forms, becomes not just a theme, but the lens through which we view the world. At the inaugural KNMA Theatre

Festival, I was reminded of this power in the most profound way. Held at the serene Sunder Nursery in New Delhi, the festival celebrated contemporary theatre and its ability to speak to the issues that matter most today. Curated by Kirtana Kumar, the festival's theme, The Power of Vulnerability, couldn't have been more fitting. It was a celebration of the delicate, yet potent, human experiences that shape us. From class and gender to sexuality and identity, the performances unearthed the often overlooked quiet, struggles that define our society. One of the most thoughtprovoking performances experienced was Love and *Information*, a play that stripped back the complexities of modern life, revealing the raw emotions beneath. Presented by the National Centre for the Performing Arts (NCPA) in association with Aasakta Theatre, this production, directed by Mohit Takalkar, took

a unique approach to storytelling. Adapted from *Caryl Churchill's* original, Love and Information is a radical departure from traditional theatre, with no central characters and no linear plot. Instead, the play is made up of over fifty short scenes, each one fleeting and fragmented, much like the way we experience life today in an age of endless scrolling and information overload. The play delves into questions of how we make sense of our lives, how we connect with others and ultimately, how we love. In an era dominated by social media and constant connectivity, these questions

seem more urgent than ever. As I sat in the audience, I couldn't help but reflect on the themes of the play, which mirrored the very nature of our times, alienation in the face of constant exposure, the erosion of privacy, and the blurring of boundaries between the self and the digital world.

What struck me most about Love and Information was its non-linear structure. Each scene, often lasting only a few seconds, felt like a snapshot of a fleeting moment in time. There were no central characters to follow, no clear narrative to grasp, just a series of disconnected ignettes that came together to form a larger, more complex picture. It was as if we were channel-surfing through different lives, only catching a glimpse of each before moving on to the next. Yet, in this chaotic rush, the play's true message emerged: that in a world overflowing with data and distractions, it is our emotional connections that truly define us.



As I watched the actors move effortlessly between characters, it became clear how much we, as individuals, are shaped by the constant flow of information and the pressure to stay connected. Each actor brought something unique to their role, embodying the vulnerability of a generation struggling to balance their digital lives with their real-world emotions. Visually, the production was nothing short of stunning. The lighting design by Vikrant Thakar was minimalist yet powerful, shifting seamlessly to enhance the emotional tone of each scene. The sound design by Anita Kushwaha further amplified the experience, creating an atmosphere that



data but struggle to make genuine emotional connections. The rapid-fire scenes, with their fragmented glimpses into people's lives, forced me to reconsider the way we view love and information and the spaces in between. Theatre like this is what makes us sit up and pay attention, it forces us to question, to reflect and to confront the uncomfortable truths about the world around us. And that is precisely what the KNMA Theatre Festival set out to do. It didn't just offer performances; it created

a space for dialogue, for conversation and for collective reflection on the role of theatre in today's society.

Beyond the performances, the festival also included a symposium, a workshop and lecture demonstrations that delved deeper into the themes of vulnerability in contemporary theatre. These discussions, led by scholars and practitioners like *Dr. Anuradha Kapur*, Vivek Madan and Dr. Abhilash Pillai, explored how the pandemic has shifted the landscape of theatre and how artists are grappling with new ways of telling stories in a post-pandemic world. The entire experience was a reminder of how theatre is a living, breathing entity, always evolving, always challenging us. The festival brought together artists, audiences, and scholars, all united by the belief that theatre is not just a form of entertainment, but a mirror to society, a space where we can reflect on who we are and who we want to become.

Leaving the amphitheatre after Love and Information, I found myself Information, contemplating the profound vulnerability at the heart of the play. It was a vulnerability that felt familiar, one that I recognised not only in the characters on stage but in myself.

In a world that's increasingly disconnected, theatre offers a space to explore our shared humanity, to embrace the discomfort. the uncertainty, and, ultimately, the beauty of being human. 
life, from his exile to his victory over Ravana. The Kathak sequences captured Lord Ram's inner strength and resilience, drawing the audience into his journey

"As I write this, my heart swells with gratitude, pride, and a touch of nostalgia. Today, I step off the competitive tennis court for the last time. "For over three decades, this

game has been my sanctuary, my greatest teacher, and my most faithful companion. From the first swing of my racquet to representing India on the grandest stages, the journey has been nothing short of extraordinary," he wrote.

The Chennai-born player, who turned pro in 2010, finished with a singles record of 11-28 and a doubles record of 1-1. His highest doubles ranking was 248 which he attained in 2018
