IT grad arrested for sending death threats to UP CM PNS MUMBAI

The Mumbai police have arrested a 24-year-old woman for allegedly giving a death threat to Uttar Pradesh Chief Minister Yogi Adityanath, an official said on Sunday. The woman, identified as Fatima Khan, who has done BSc in Information Technology, Information Technology, resided in Ulhasnagar area of neighbouring Thane district of Maharashtra with her family members. Her father is into timber business, the official said. The woman is well qualified but is mentally unstable, the police said.

The Mumbai traffic police's WhatsApp number on Saturday received a message from an unknown number threatening that if Adityanath did not resign from the CM's post within 10 days, then he would be killed like NCP leader Baba Siddique, the official said. During the probe, the police found Khan had sent the message, he said.

The Mumbai Anti-Terrorism Squad (ATS) in a combined operation with the Ulhasnagar police traced the woman and apprehended her, the official said. Further investigation was on into the matter, the official added. The police are on alert as Adityanath is likely to come to Maharashtra for campaigning for the November 20 state assembly polls, as per officials. Former Maharashtra minister Baba Siddique was shot dead in Mumbai's Bandra area on October 12.


A thick layer of smog engulfed the National Capital on Sunday, and the Air Quality Index (AQI) continued to deteriorate, crossing the 500 mark, two days after Diwali. The government may soon consider banning BS-III petrol and BS-IV diesel fourwheelers, dust suppression measures, and forbid all nonessential construction activities. In areas like Shahdara and Anand Vihar, the AQI remained above 500 after 11.30 am on Sunday. The air pollution level lies in the alarming 'hazardous' action in the aarming nazardous category (above AQI 400) in most parts of the capital, with PM2.5 levels over 59.6 times more threatening than the World Health Organisation's (WHO) prescribed limit.

An average AQI stood in the "very poor "category at 382 in Delhi. A day before, it had been slightly worse at 339 but did not slip into the 'severe' level as forecast because of favourable atmospheric conditions such as warmer temperatures and strong winds. According to weather analysts, it is likely that wind speed will drop further and, therefore, worsen the pollutants status. Local factors, including construction activities, heavy

The IITM, in its six-day outlook Sunday, said that the air quality is likely to be in the 'very poor' or 'severe' category. It also stated, "Meteorological conditions are likely to be extremely unfavourable for dispersion of pollutants." The 24-hour average Particulate Matter (PM)2.5 and PM10 were 180.4 ug/m3 and 303.9 ug/m3, respectively, according to the Central Pollution Control Board (CPCB) as of 1 pm on Sunday. The 24hour averages of PM2.5 and

PM10 pollutants are three times higher than the national prescribed standards of 60 ug/m3 and 100 ug/m3, respectively.

The onset of Industrial Revolution was a transformative era, bringing significant advancements in both, development and urbanization leading to rapid technological progress, industrial growth, and socioeconomic change. It reshaped societies around the world. Groundbreaking inventions like the steam engine, mechanization of factories and advancements in transportation - railways and steamships - boosted our production capabilities leading to the establishment of large-scale industries. Simultaneously, there was growth of cities and rapid urbanization which became epicentres of industrial activity as factories required concentrated labour force resulting in mass migration from rural to urban areas

Shift of population from rural to urban areas transformed small towns into bustling cities often unplanned and characterised by rapid construction of housing, roads and public infrastructure. Industrial and technological progress also led to profound social and economic changes giving rise to a new working class and a redefined economic system. Over a period of time, this rapid urbanization has resulted in haphazard living conditions, pollution and public health issues. Coupled with climate change issues arising out of industrial growth - greenhouse

pollution - have spelled doom for the people living in cities. Urban centres the world over and particularly Indian cities are increasingly vulnerable to the impacts of climate change and climate emergency due to their high population density, rapid urbanization, and geographical location. Many metropolitan cities in India particularly Delhi,

Ahmedabad, Hyderabad etc. suffer from the urban heat island effect where the built environment - concrete, asphalt etc. absorbs and retains heat leading to higher temperature compared to rural areas. Temperatures exceeding 45 degrees centigrade culminate in heat-related illness, particularly among vulnerable population of the elderly and those living in slums. This also leads to health risks like heatstroke, dehydration and other heat stroke-related issues. In 2015, heat wave claimed over 2500 lives in India many of whom were staying in urban clusters. Indian cities are also prone to flooding due to their geographical location, outdated drainage systems and increasing frequency of torrential rainfalls. Coastal cities like Mumbai, Chennai and Calcutta are facing severe risks from rising sea levels and storms and cyclones. Mumbai in particular, experiences flooding during the Monsoon rainfall disrupting

gases, CFCs, soil, water and air transportation, damaging infrastructure and displacing a huge population particularly living in informal settlements. Woes of poorly maintained drainage system has been witnessed in cities like Bangalore and Delhi exacerbating the risk of flash floods during heavy rains. Recent flooding of many areas in Bangalore paralyzed the city submerging

residential and business areas. Many Indian cities are marred by acute water shortages due to prolonged droughts and over-extraction of groundwater. There are serious issues related to urban planning in Indian cities which is often haphazard with high density of population. The city of Chennai faced its worst drought in 2019 when most reservoirs went dry and there was unregulated groundwater extraction. Water reservoirs in and around cities are also prone to encroachments and pollution leading to water scarcity. At the same time we also rely heavily on the monsoon for filling of water reservoirs, rivers and supply of water for daily usage. However, erratic weather conditions often result in drought-like conditions which increase the risk of water shortage in urban areas. Other climatic conditions affecting urban centres include rising sea levels and coastal erosion, land water and air pollution and rising atmospheric temperature. These factors have devastating

vector-borne diseases, heat stress and water borne illness. Such conditions also impact economic life of those living and dependent on climate-sensitive sectors like agriculture, fisheries and informal economies. Loss of livelihoods and damage to the infrastructure are of major concern for a population which often lives subsistence and is socially vulnerable Indian cities are at the forefront of climate change impacts

Haryana Chief Minister Nayab Singh Saini, reviewing the availability of DAP fertilizer with the senior officers of Agriculture and Farmers Welfare Department on Sunday, made it clear that there is no shortage of DAP in the State and there is no need to panic buying among farmers. Saini said that in October

2023 during the Rabi season, the total consumption of DAP was 1,19,470 Metric Tons (MT), whereas the consumption in October 2024 is 1,14,000 MT. The availability of the DAP in the state is 24,000 MT as on Sunday and rake planning has been done for daily infusion of DAP for the farmers.

The Chief Minister further said that during the 2023 Rabi season, a total of 72697 MT was consumed in November. As a result of the State Government's efforts, the Centre has allocated 1,10,000 MT of DAP fertilizer for the month of November, of which 41,600 MT has been planned on the rake movement for the first week of November and another 40,000 MT for the second week and will taper to another 20,000 MT in the third week of November 2024

Meanwhile, an official spokesperson informed that the rake planning for DAP has been prepared. Bhiwani, Dadri, Rohtak, Mahendergarh, Karnal, gically positioned at market places. NPK is a balanced fertilizer providing all essential nutrients and is recommended as an effective substitute for DAP, the officer said.

Moreover, the Rabi season officially commenced from October 1, marking a pivotal moment for Harvana's agricultural sector. With targets set, wheat is projected to be sown across an impressive 25 lakh hectares, while oil seed crops will cover a substantial 10 lakh hectares

About 80 percent of oil seed crop sowing has already been completed, and wheat sowing is progressing at a brisk pace. The farmers who have sown mustard this season have been desperate for the supply of DAP fertilizer. At several places the police were called to control the crowd of farmers who had gathered in front of the offices of cooperative societies for the fertilizer.

With the wheat season also beginning in the state, the Haryana Government has made its preparations for the supply of Urea fertilizer too. This season, the projected total consumption of Urea stands at 11LMT and the state already boasts a robust inventory of 4.26 lakh MT of the fertilizer. Urea is India's most widely used fertilizer, with its consumption or sales rising from 26.7 million tonnes (MT) to 35.7 MT between 2009-10 and 2022-23, said sources in the Department.

ED targets cyber fraud in 'digital arrest' scams

Days after Prime Minister Narendra Modi urges people to guard against the menace of 'digital' arrests, probe agencies said they are taking action against this category of cyber crime with the ED filing a charge sheet in one such case and the I4C issuing a fresh advisory. The Enforcement Directorate (ED) issued a statement on Saturday, saying it filed a prosecution complaint before a special Prevention of Money Laundering Act (PMLA) court in Bengaluru last month against eight accused who allegedly "lured" common people through "fake" IPO allotments and stock market investments through fraudulent apps.

"Probe found that a huge network of cyber scams in India, involving fake stock market investments and schemes digital arrest executed primarily through social media platforms like Facebook, Instagram, WhatsApp, and Telegram. "Known as 'pig-butchering' scams, stock market investment scams entice victims with promises of high returns, using fake websites and misleading WhatsApp groups that appear connected to reputable financial firms," the Enforcement Directorate said.

Scammers, it said, establish credibility through fake ads and fabricated success stories, ultimately leading victims to invest significant amounts. The ED said some victims of this scam were "manipulated" under the guise of a fake arrest (digital arrest) by the

It said 'digital' arrest scams involve fraudsters posing as law enforcement officials, intimidating victims into transferring their savings by fabricating scenarios that suggest illegal involvement of the victim, the federal agency said. The Indian Cyber Crime Coordination Centre (I4C) issued a public advisory on Sunday asking people to "Beware of Digital Arrests" reminding that "those making video calls are not police, CBI, Customs officials or judges". They are cyber criminals, the organisation that functions under the Union home ministry said. The advisory asked people to not fall for these "tricks" and report such crimes "immediately" by calling the national cybercrime helpline 1930 or logging at the portal

radio address on October 27 flagged the issue of fraudsters targeting people with 'digital' arrests and urged people to adopt the mantra of stop, think and take action" when faced with such a scam, asserting that these steps will provide digital security to them. The ED said it booked a money laundering case into this crime after studying multiple police FIRs and it arrested eight persons, also named as accused in its the charge sheet filed on October 10, named Charan Raj C, Kiran S K, Shahi Kumar M, Sachin M, Tamilarasan,

Prakash R, Ajith R and Aravindan and 24 related companies. All the arrested persons are currently lodged in jail under judicial custody. This cyber crime case involves proceeds of crimes to the tune of Rs 159 crore and the court has taken cognisance of the ED charge

sheet on October 29, it said. The ED said fraudsters, in order to perpetrate this fraud, obtained hundreds of SIM cards which were either linked to the bank accounts of shell companies or were utilised to create WhatsApp accounts. "The anonymity afforded by these untraceable SIMs allow scammers to defraud victims with a reduced risk of immediate detection. The scammers created 24 shell companies in Tamil Nadu, Karnataka and some other states to facilitate acquisition and laundering of proceeds from cybercrimes," it said.

These shell companies, registered mainly at the addresses of coworking spaces (where no actual business presence exists), have used fake bank statements in filings before Registrar of Companies as proof of commencement of business of these companies. Scammers operated through "mule" accounts to transfer

the funds and the proceeds are ultimately converted into cryptocurrency and transferred abroad, the ED probe found.

One of the accused, Charan One of the accused, Charan Raj C, played a "key" role in this scheme by recruiting individuals for directorships and managing bank account openings. Shashi Kumar M assisted in "incorporating" several shell companies which became instrumental in collecting and integrating became instrumental in collecting and integrating proceeds of crime into the banking system. Kiran S K, linked to several shell companies as per the ED, had connections with bank accounts of multiple shell entities created by overseas scammers, who submitted fake documents incorporate these companies. Sachin M, a Director in several firms, "admitted" to assisting overseas scammers in recruiting dummy directors and facilitating bank accounts, being "well aware" of their illegality, according to the agency. Tamilarasan played a "significant" role in facilitating these activities, collaborating with both Indian and overseas

scammers and he "assisted" in opening bank accounts for shell companies. Like Cyberforest Technologies Pvt. Ltd., and "knowingly" continued these operations despite of knowledge of their despite of knowledge of then connection to cybercrime, the agency said. The ED said it has "incriminating" evidence like chequebooks and communication records to say that these individuals

participated in a syndicate that laundered proceeds from cyber frauds across India.

Maha Congress seeks ban on cotton imports, asks CCI to purchase produce at guranteed price

mid reports about the Aimport of 22 lakh bales of cotton and the consequent concerns about the potential fall in the prices of the domestic cotton, the Maharashtra Congress has urged Prime Minister Narendra Modi to impose immediate ban on the import of cotton and direct the Cotton Corporation of India (CCI) to purchase cotton at the guaranteed price.

In a letter written to the Prime Minister in the run-up to the November 20 State Assembly polls, Maharashtra Congress chief Nana Patole said that despite Maharashtra - which is home to over 40 lakh cotton farmers, having produced substantial cotton this year, the reports of the country importing 22 lakh of cotton had sparked concerns among the cotton farmers about the potential fall in the domestic cotton prices. "This import, combined with 11 lakh unsold bales held by

Incidents of rape and murder plague Bengal, five rapes in three days

Bangladesh protests

Protests erupt in Bangladesh as international voices express concern over escalating human rights crisis

ens of thousands of minority Hindus in Bangladesh took to the streets on Friday, demanding immediate protection from ongoing violence and harassment following the recent political upheaval. The protests, primarily held in the southeastern city of Chattogram, saw around 30,000 Hindus gather, raising slogans for justice and security. The demonstrations were heavily guarded by police and military personnel, as Hindu community leaders urged the interim Government to intervene amid rising attacks on their community. The protests follow a series of reported attacks against the Hindu minority, which has been particularly vulnerable since the overthrow of Prime Minister Sheikh Hasina's secular government in August. After Hasina's departure, Nobel laureate Muhammad Yunus was appointed to lead an Interim Government, which has faced criticism for its alleged inability to maintain order and protect minority groups. The influential Bangladesh Hindu Buddhist Christian Unity Council claims that over 2,000 attacks



on Hindus have occurred since August, a period marked by escalating violence from hard-line Islamist groups. Hindus represent approximately 8 per cent of Bangladesh's population of nearly 170 million, while the Muslim majority makes up around 91 per cent. Despite being a significant minority, Hindu communities say they are inadequately protected and often targeted amid political and social instability. The unrest has also affected other groups; reports indicate that supporters of Hasina's Awami League party and its ally, the Jatiya Party, have faced violence as well. The recent spike in violence has sparked international concern. United Nations human rights officials, along with

global advocacy groups, have voiced alarm over the human rights situation in Bangladesh under the Interim Government. Indian Prime Minister Narendra Modi expressed concern over the attacks, while US President Joe Biden's administration announced that it is monitoring the situation closely. Adding his voice to the chorus, former US President and current presidential candidate Donald Trump condemned the "barbaric violence" targeting Hindus, Christians, and other minorities, describing Bangladesh as "in a total state of chaos." The Hindu activists who have been rallying since August are pressing the Government with a list of eight key demands which include the establishment of a minority protection law, the creation of a dedicated ministry for minority affairs, and a specialised tribunal to address and prosecute incidents of violence against minorities. Friday's protest in Chattogram was partly fuelled by recent sedition charges filed against 19 Hindu community leaders. As Bangladesh continues to grapple with political and religious tensions, minority communities remain on edge. With increasing international attention and escalating domestic demands for protection and justice, the Interim Government must restore peace and address the rights and safety of its minority groups, else there is a clear danger of it plunging into anarchy and eventually into a civil war.

America decides: Will Kamala make history

he upcoming election for the White House is of immense significance, as it will determine the next tenant of the White House and shape the future of the United States. Whether America will get its first woman president or a second Donald Trump term is a debate going on among not only the politicians but also the public. A week before the November 5 presidential polls, election fever hit the country hard. However, there is a possibility that knowing the final result may take a few more dates. Narrow victories in a handful of swing states will likely determine who gets the top job. Polls and prediction markets are signalling a Republican sweep in the election.

As the Republican candidate, Donald Trump, and the Democrat nominee, Vice President Kamala Harris, wrap up their campaigns, the potential impact of this election on the future of the United States cannot be overstated.

It is no surprise that the campaign has been not only highly negative but also personal, with Trump attacking his rival, hitting her below the belt and calling her "dumb." While the reports claim that the fight is very tight, with Trump leading now and Kamala making up her lead, the suspense will continue for a few more days, even after the election date. The Electoral College is the system that decides presidential elec-tions: A candidate must secure at least 270 votes - allocated by state based on the outcome of their respective vote - to win the White House. Although certification sabotage has not yet resulted in such an extensive delay, many attempts have been made before. County election boards generally have no legal authority to investigate any allegations of fraud or irregularities.

Tight races in crucial battleground states in 2020 and an increase in mail-in voting amid the COVID pandemic saw prolonged vote counts.That helped fuel unfounded claims of election malfeasance pushed by Trump and his allies. State election law provides other checks and safeguards through which suspected Trump is relentless in attack-



irregularities can be adjudicated. These mechanisms are designed to resolve disputes. Extended delays in countylevel certification could run against deadlines for certifying statewide results. According to the Associated Press, the winner will likely not be projected for days. However, states and the whole election results are typically "called" long before final votes are counted. In 2020, President Joe Biden won. The result was called for four days after November 3, when Pennsylvania's result was confirmed.

The state gave Biden 20 electoral college votes, taking over the 270 required to win. In 2016, Hillary Clinton conceded to Trump the morning after the election. With the presidential contest in the final countdown and Harris and Trump maligning the opponent, the vice president has called Trump dangerous. Harris insists she's doing both - establishing a contrast with Trump and laying out her agenda on the economy, immi-

FINDING STILLNESS AMIDST A FLOOD OF THOUGHTS

C ometime back I had written a piece on "Mind Management" and received certain queries about the generation of multi-D ple thoughts and the acceptance by people that the mind was not at ease. It was frightening and troubling that several people of various age groups were plagued by all kinds of negative thoughts. People were troubled by thoughts arising during the whole day and particularly at night time. 

Food subsidy reforms: Can Govt tackle mounting costs-

Timely disbursement of funds to FCI would go a long way to streamline the Pradhan Mantri Garib Kalyan Anna Yojana, which provides free food grains to the people



he Ministry of Finance (MoF) has released Rs 97,000 crore towards food subsidy expenses in the first half of the current financial year (FY) to the Food Corporation of India (FCI). This is over two-thirds of the required fund support of Rs 147,000 crore to FCI during the current FY. The MoF is expected to release the balance amount by December 31, 2024. Under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY), the Centre asks the FCI and other state agencies to procure food from the farmers at MSP (minimum support price) and distribute it to around 820 million people for free. Under the Scheme, each beneficia-ry gets 5 kg of food per month. The entire cost i.e. MSP paid to farmers plus handling and distribution cost (HDC) is reimbursed to the FCI/other state agencies as a subsidy. The money comes from the Union Budget's allocation for 'food subsidy'.

The FCI conducts the bulk of the food procurement, handling and distribution operations on behalf of the Centre. At Rs 147,000 crore, it gets around 72 per cent of the total food subsidy Rs 205,250 crore the budget estimate (BE) for 2024 25. The government is duty-bound to make timely payments to FCI to enable the latter to conduct its operations 'smoothly' and 'effectively'. What is so special about the current FY? In the past, thanks to inadequate budgetary allocations (often prompted by the compulsion to keep the fiscal deficit excess of total expenditure over total receipts - under check), the government's payments to FCI had fallen short, forcing the latter to take recourse to working capital from banks to sustain operations. To bridge cash-flow mismatch, the extant arrangements provided for the FCI to avail a short-term loan with a tenure of 90 days up to Rs 75,000 crore at any given point in time. This led to an increase in subsidy as interest cost on loans taken from designated banks (the interest rate ranges between 6.98 per cent to 7.36 per cent per annum) had to be reimbursed to the FCI. The gap between budget allocation and actual requirements used to be so huge that cash

credit limits sanctioned by the banks proved to be inadequate. This prompted the FCI to even borrow funds from the National Small Savings Fund (NSSF). The NSSF is a public account (estab-lished on April 1, 1999) where all deposits received under National Saving Schemes are credited. All withdrawals by depositors are made out of the accumulations in this Fund. Normally, the govern-ment is not expected to use the NSSF to meet its revenue expenditure and expenses on food subsidy fall in this category. Yet, it encouraged the FCI to encroach on the Fund to plug the shortfall in its receipts. When the FCI started taking loans from NSSF in FY 2016-17, the Centre had committed to release the subsidy arrears to enable FCI to pay back the loans in subsequent years. But, that was not to be as subsidy arrears kept mounting, and FCI continued borrowing increasingly from NSSF. At the end of 2018-19, FCI's cumulative borrowing from NSSF was Rs 200,000 crore. This continued into 2019-20 on a much larger scale. In that year's budget, Finance Minister Nirmala Sitharaman had kept the BE for food subsidy at Rs 184,000 crore and drastically reduced it to Rs 109,000 crore in the revised estimate (RE) just because she wanted to keep the FD close to the target. Against this, the requirement being Rs 219,000 crore, the shortfall of Rs 110,000 crore was made up by FCI borrowing from NSSF. In the budget for 2020-21, she kept BE at Rs 116,000 crore against the requirement of Rs 137,000 crore. TV Somanathan, the then expenditure secretary, saw nothing wrong in the above practice arguing that borrowings by FCI were against the assets it held in the form of food stocks. The argument was flawed since loans

were taken against subsidy receivable from the Centre. In the case of wheat, for instance, on every kilo sold under the National Food Security (NFSA), the sub-sidy was Rs 23 (MSP plus HDC of Rs 25 minus Rs 2 being the price paid by the beneficiary). The loan was given against this amount promised by the Centre.

This liability couldn't be adjusted against the food stock, which, on giving to the NFSA beneficiary would fetch only Rs 2. The Secretary further argued that keeping these borrowings off the Centre's balance sheet would pre-vent crowding out, and help the private sector borrow from the market at a lower interest cost. This needed to be weighed against erosion in the credibility of fiscal consolidation, which is inevitable when a strict liability of the Centre is kept off its balance sheet. A wrong can't be justified simply because the honest course of reflecting the liability in the Union budget would lead to problems for private firms. The government recognised the flaw in the above approach even as Sitharaman made a course correction while presenting the budget for FY 2021-22. In the RE for FY 2020-21, she provided for a massive allocation of Rs 529,000 crore. That amount included Rs 462,000 crore towards payment of subsidy to the FCI against a claim of Rs 216,000 crore by the latter. The excess amount was used by the FCI to extinguish all its accumulated liabilities to the NSSF. During 2021-22, 2022-23 and 2023-24, the government stayed on course with allocation for food subsidy at Rs 372,000 crore, Rs 287,000 crore, and Rs 211,394 crore respectively adequate to fully cover the require-ment. As for payments to the FCI, during 2021-22, the subsidy received was Rs 208,000 crore against the claim of Rs 207,000

crore. During 2022-23, the amount received was Rs 200,000 crore against the claim of Rs 204,000 crore. During 2023-24, the FCI received Rs 139,000 crore against the claim of Rs 133,000

crore. During the current FY, having already received 2/3rd of its likely annual requirement, Rs 147,000 crore, during the first half, the FCI is expected to receive the balance 1/3rd by December 31, 2024. It receives the money almost round the clock, meaning it doesn't have to resort to short-term credit even from banks (forget NSSF), as its operational expenses are fully met from timely reimbursement of subsidy dues by the Center. From the Centre's perspective, all its liabilities regarding food subsidies are 'fully' reflected in the budget for any given FY. The gov-ernment no longer indulges in window dressing, no carryover of subsidy dues, and the process is fully 'transparent'. Moreover, there is no interest cost doost to subsidy payments as the FCI need not borrow. But the unsustainable increase in food subsidies continues to haunt us. This has to do with 'universal' coverage of PMGKAY (820 million beneficiaries and at least 100 million waiting to be included as per an order of the Supreme Court), promise to give them 'free' food eternally, purchase of 'unlimited' quantum of food from farmers at MSP resulting in high stocks with FCI (at 44 million ton, its stock of rice as on October 1, 2024 is over three times the requirement) and associated high carrying cost, reimbursement of cost to FCI on 'actual' basis and pilferage of subsidized food. Addressing these maladies calls for major reforms in the Scheme. Can Modi bite the bullet?

surgery is another gamechanger, with the potential to reshape the field by allowing for data-driven insights and

more precise treatment planning. Through AI, vast amounts of patient data can be analysed to identify optimal surgical approaches and predict complications.

Such AI insights combined with robotic precision could minimise human error and variability in outcomes, enhancing both surgical efficiency and patient safety. Currently, robotic systems are already being used in spinal procedures, aiding in the precise placement of screws, rods, and other implants. With AIdriven data analytics, robotic assistance could reach new levels of effectiveness. AI systems could improve preoperative planning based on large datasets, enabling more accurate hardware placements and efficient decision-making. This

technology can analyse past surgeries to predict potential complications and suggest the most effective treatment paths, offering a personalised, databacked approach to surgical care. Furthermore, AI-driven analytics have the potential to predict patient outcomes based on prior cases, guiding surgeons on probable recovery trajectories and aiding patient consultations. ISSICON 2024's workshops reflected this commitment to enabling technologies by providing participants with hands-on experience in emerging techniques, such as robotic and navigationassisted spine surgery and robotic-assisted rehabilitation. The conference was aligned with the World Health Organisation's Rehabilitation 2030 initiative, reinforcing a

global commitment to improving access to advanced rehabilitation services, particularly in underserved areas. To ensure the longevity of these innovations, IŠSICON 2024 is developing eight position state-ments, created through preconference deliberations and expert discussions, to serve as guidelines for SCI care. Khamenei threatens Israel, US with 'a crushing response'

ran's supreme leader on Isaturday threatened Israel and the US with "a crushing response" over attacks on Iran and its allies.

Ayatollah Ali Khamenei spoke as Iranian officials are increasingly threatening to launch yet another strike against Israel after its October 26 attack on the Islamic Republic that targeted military bases and other locations and killed at least five people. Any further attacks from either side could engulf the wider Middle East, already teetering over the Israel-Hamas war in the Gaza Strip and Israel's ground invasion of Lebanon, into a wider regional conflict just ahead of the US presidential election this Tuesday.

"The enemies, whether the Zionist regime or the United States of America, will definitely receive a crushing response to what they are doing to Iran and the Iranian nation and to the resistance front," Khamenei said in video released by Iranian state media.

The supreme leader did not elaborate on the timing of the threatened attack, nor the scope. The US military operates on bases throughout the Middle East, with some troops now manning a Terminal High

Altitude Area Defense, or THAAD, battery in Israel.

The USS Abraham Lincoln aircraft carrier likely is in the Arabian Sea, while Pentagon press secretary Maj Gen Pat Ryder said Friday that more destroyers, fighter squadrons, tankers and B-52 long-range bombers would be coming to the region to deter Iran and its militant allies.

Early Sunday, the US mili-tary's Central Command said B-52s from Minot Air Force Base's 5th Bomb Wing arrived in the Middle East, without elaborating. The 85-year-old Khamenei had struck a more cautious approach in earlier remarks, saying officials would weigh Iran's response and that Israel's attack "should not be exaggerated nor downplayed." Iran has launched two major direct attacks on Israel, in April

and October. But efforts by Iran to downplay the Israeli attack faltered as satellite photos analyzed by The Associated Press showed damage to military bases near Tehran linked to the country's ballistic missile program, as well as at a Revolutionary

Guard base used in satellite launches. Iran's allies, called the "Axis of Resistance" by Tehran, also have been severely hurt by ongoing Israeli attacks, partic-



ularly Lebanon's Hezbollah and Hamas in the Gaza Strip. Iran long has used those groups as both an asymmetrical way to attack Israel and as a shield against a direct assault. Some analysts believe those groups want Iran to do more to back them militarily. Iran, however, has been dealing

with its own problems at home, as its economy struggles under the weight of international sanctions and it has faced years of widespread, multiple protests. Âfter Khamenei's speech, the Iranian rial fell to

691,500 against the dollar, near an all-time low. It had been 32.000 rials to the dollar when Tehran reached its 2015 nuclear deal with world powers. Gen Mohammad Ali Naini, a

spokesman for Iran's paramilitary Revolutionary Guard which controls the ballistic missiles needed to target Israel, gave an interview published by the semiofficial Fars news agency just before Khamenei's remarks were released. In it, he warned Iran's response "will be wise, powerful and beyond the enemy's comprehension."

"The leaders of the Zionist regime should look out from the windows of their bed rooms and protect their criminal pilots within their small territory," he warned. Israeli air force pilots appear to have used air-launched ballistic mis-siles in the Oct. 26 attack.

Khamenei on Saturday met with university students to mark Students Day, which commemorates a Nov. 4, 1978. incident in which Iranian soldiers opened fire on students protesting the rule of the shah at Tehran University. The shooting killed and wounded several students and further escalated the tensions consuming Iran at the time that eventually led to the shah fleeing the country and the 1979 Islamic Revolution.

Israel 'struck' Gaza clinic during polio campaign; army denies

Palestinian officials say an Israeli drone strike on a clinic in northern Gaza where children were being vaccinated for polio wounded six people, including four children. The Israeli military denied respon-

sibility. The alleged strike occurred Saturday in northern Gaza, which has been encircled by Israeli forces and largely isolated for the past year. Israel has been carrying out another offensive there in recent weeks that has killed hundreds of people and displaced tens of thousands.

It was not possible to resolve the conflicting accounts. Israeli forces have repeatedly raided hospitals in Gaza over the course of the war, saying Hamas uses them for militant purposes, allegations denied by Palestinian health officials.

Dr Munir al-Boursh, director general of the Gaza Health Ministry, told The Associated Press that a quadcopter struck

the Sheikh Radwan clinic in Gaza City early Saturday afternoon, just a few minutes after a United Nations delegation left the facility

The World Health Organisation and the UN children's agency, known as UNICEF, which are jointly carrying out the polio vaccination campaign, expressed concern over the reported strike.

The reports of this attack are even more disturbing as the Sheikh Radwan Clinic is one of the health points where parents can get their children vaccinated," said Rosalia Bollen, a spokesperson for UNICEF.

Today's attack occurred while the humanitarian pause was still in effect, despite assurances given that the pause would be respected from 6 am to 4 pm." Lt Col Nadav Shoshani, an Israeli military spokesman, said that "contrary to the claims, an initial review determined that the (Israeli military) did not strike in the area at the specified time." A scaled-down campaign to administer a second

dose of the polio vaccine began Saturday in parts of northern Gaza. It had been postponed from October 23 due to lack of access, Israeli bombings and mass evacuation orders, and the lack of assurances for humanitarian pauses, a UN statement

The administration of the first dose was carried out in September across the Gaza Strip, including areas of northern Gaza that are now com-pletely sealed off. Health officials said the campaign's first round, and the administration of the second dose across central and southern Gaza, were successful.

At least 100,000 people have been forced to evacuate from areas of north Gaza toward Gaza City in the past few weeks, but around 15,000 children under the age of 10 remain in northern towns, including Jabaliya, Beit Lahiya and Beit Hanoun, which are inaccessible, according to the UN. The final phase of the polio vaccination campaign had aimed to reach an estimated 119,000 children in the north with a second dose of oral polio vaccine, the agencies said, but "achieving this target is now unlikely due to access constraints."

They say 90 per cent of children in every community must be vaccinated to prevent the spread of the disease.

The campaign was launched after the first polio case was reported in Gaza in 25 years a 10-month-old boy, now paralysed in the leg. The World Health Organisation said the presence of a paralysis case indicates there could be hundreds more who have been infected but aren't showing symptoms. The war began on Óctober 7, 2023, when Hamasled militants stormed into southern Israel, killing some 1,200 people, mostly civilians, and abducting another 250. Israel's offensive has killed over 43,000 Palestinians, according to Gaza health authorities, who do not say how many were combatants but say more than half were women and children.

n Iranian-American jour-Analist who once worked for a US government-funded broadcaster is believed to have been detained by Iran for months now, authorities said Sunday, further raising the stakes as Tehran threatens to retaliate over an Israeli attack on the country.

The imprisonment of Reza Valizadeh, acknowledged to The Associated Press by the US State Department, came as Iran marked the 45th anniversary of the American Embassy takeover and hostage crisis on Sunday. It also followed Iran's Supreme Leader Avatollah Ali Khamenei threatening both Israel and the US the day before with "a crushing response" as long-range B-52 bombers reached the Middle East in an attempt to deter Tehran.

REACTION TO NORTH KOREA'S MISSILE TEST US flies long-range bomber in drill with S Korea, Japan

The United States flew a long-range bomber in a trilateral drill with South Korea and Japan on Sunday in response to North Korea's recent test-firing of a new intercontinental ballistic missile designed to strike the US mainland, South Korea's military said.

North Korea on Thursday test-ed the newly developed Hwasong-19 ICBM, which flew higher and stayed in the air longer than any other missile it has fired. North Korean leader Kim Jong Un called it "an appropriate military action" to cope with external security threats posed by its rivals. On Sunday, the US flew the B

1B bomber to train with South Korean and Japanese fighter iets near the Korean Peninsula. demonstrating the three coun tries' firm resolve and readiness to respond to North Korea's advancing nuclear and missile programs, South Korea's Joint Chiefs of Staff said in a statement

The trilateral aerial training was the second by South Korea, the US and Japan this year, the statement said. The US often responds to major North Korean missile tests with temporary deployments of some of its powerful military assets

"The barbed wire had to be opened so that the families could have this event."

García said he expects migration into the US to continue regardless of who wins Tuesday's election. Family reunions, he said, will continue, too

Trene Cuevas will never forget the sound of the waves crashing below her apartment's balcony. If only there had been a flash of lightning in the darkness to let her glimpse what

sounded like a roaring sea. "It was a constant fear because we didn't have light to see by," Cuevas told The Associated Press. "We could hear the roar of the waves, which was unbelievable. The street was completely flooded and we were hoping for some lightning so that we could at least see what situation we were in. It was all waves, currents everywhere. "We have that sound of the waves burned in our memory." The devastating flash floods in eastern Spain this week that claimed over 200 lives and destroyed countless homes and livelihoods also seared a scar of terror in many survivors

Cuevas, a 48-year-old embryologist, is a resident of Chiva, a village perched on a hill about 30 kilometres from Valencia city, whose southern outskirts were likewise ravaged by the floods on Tuesday

Chiva got more rain in eight hours than the town had experienced in the preceding 20 months. Cuevas was at home and saw how the gorge dividing her village suddenly over-

ers of mud left by the water. Five thousand more soldiers are arriving in the area this week-end to help the 2,500 already deployed. Thousands of police officers have also been sent in. But for now it is the people themselves still leading the way. "Now we need to clean up and try to get back to normal because there are more rains forecast for the weekend, and that won't help," Cuevas said. "We are trying to get everything ready for when the rains comes back. Because they will."

Chinese scholars highlight Ramayan's footprints in China buried in Buddhist texts

hina has had footprints of Uthe stories of Ramayana cloaked in Buddhist scriptures for centuries, scholars here have said, bringing to the fore perhaps for the first time, the influence of Hinduism in the country's checkered history.

At a symposium on "Ramayana- A Timeless Guide" organised by the Indian Embassy here on Saturday, a host of Chinese scholars associated with longstanding research on religious influences, made candid presentations tracing the historical routes through which Ramayana reached China and its influence on Chinese art and literature.

"As a classic intertwining the religious and the secular world, the influence of Ramavana has grown ever more significantly through cross-cultural transmission," Dr Jiang Jingkui, Professor and Dean of the Institute for International and Area Studies of Tsinghua

University said. "China, too, has absorbed elements of this epic, which not only left traces in Chinese (majority) Han culture but was also reinterpreted and given new meaning in Chinese Xizang (Tibetan) culture," he said. China officially refers to Tibet as Xizang. This cultural migration and


adaptation demonstrate the openness and flexibility of Ramayana as a classic and worldly text," Jiang said. The earliest content related to Ramayana in China was introduced into the Han cultural sphere, primarily through Buddhist scriptures, he said. While it was not fully incorporated as a complete work into the Han cultural sphere, parts of the epic were incorporated into Buddhist scriptures, he said, citing Chinese translations of Buddhist scripts in which "key figures such as Dasharatha

and Hanuman were noted as Buddhist characters". 'A famous example is that

Hanuman was transformed into a Monkey King who obeyed Buddhist teachings, blending into classic Buddhist moral narratives," Jiang said. The Monkey King with human characteristics called Sun Wukong, has remained forages in the best-loved and most enduring Chinese literature and folklore.

In his presentation, Pro Liu Jian of the National Institute of International Strategies of the Chinese Academy of Social Sciences, said many Chinese scholars agree that Sun Wukong can be traced to

Hanuman, though some scholars say he is a "domestic product". "Chinese scholars generally agree that the image of Sun Wukong comes from that of Hanuman. Therefore, Sun Wukong is not a domestic product, but a character from India," he asserted. Speaking on



the topic 'Footsteps of Ram in China, Prof Qiu Yonghuai, Chief expert and Deputy Director of China Centre for South Asian Studies of Sichuan University, in her presentation displayed photos of a wide variety of different Hindu deities in the museum Quanzhou, in China's Fujian province. She even showed a photo of a Buddhist temple managed by a Hindu priest. "It was primarily through

Buddhism that Indian culture took its stronghold in China. This is the reason why in the history of Sino-Indian cultural relations, Hinduism occupies a negligible position," she said. "Multifaceted Indian culture both Buddhist and non-Buddhist — made its mark on Chinese soil," she added. Jiang, in his speech also recalled how the famous seventh-centurv Chinese scholar Xuanzang

who visited India, studied at

Nalanda University and brought back a host of Buddhist scriptures providing detailed accounts of Ramavana stories he heard during his pilgrimage. "However, due to the Hindu background of Ramayana and the predominance of Buddhism in China, the text was neither fully translated nor widely circulated within Han culture," he said. The first Chinese translation of Ramayana from Sanskrit was done by Ji Xianlin in 1980.

li's translation was a "significant breakthrough for Chinese academia, providing Chinese readers with access to an Indian lit erary classic and establishing a new bridge for Sino-Indian cultural exchange," Jiang said.

Ji dedicated nearly a decade to translating this vast work of twenty-four thousand verses, and his version has become a cornerstone for the study of Ramavana in China, he said. Jiang added that Ramayana has a more extensive and long-

standing history of influence in Tibet, where it was first introduced during the period of the Tubo Kingdom.

Through literary works and theatrical performances, Ramayana has not only become a subject of in-depth study among Tibetan scholars but has also gained widespread popularity among common people in Tibet.

'This demonstrates the powerful vitality of Ramayana as a cross-cultural classic," he said 'Ramayana is not only an epic but also a profound exposition of the ideal personality and ideal society. Through the actions and words of Rama, as well as the establishment of the 'Ram Rajva' the epic presents multiple dimensions of the concept of 'Adarsh' (ideal) in Indian cul-

ture," he said. In his address, Indian Ambassador to China Pradeep Kumar Rawat said Ramayana is believed to be the oldest poet ic work of human civilisation.

"While the historians have not come to a definite conclusion about the time period when the Ramayana was written, there is astronomy-based research finding that date Ramayana to about 7th Century BC," he said. The Ramayana has also tran

scended geographical boundaries, adapting itself to seamlessly merging into local cultural tapestry, while maintaining its core values," he added

SEBI proposes to allow InvITs, REITs, SM REITs

Markets regulator Sebi has proposed allowing Real Estate Investment Trusts (REITs), Small and Medium REITS (SM REITS) and Infrastructure Investment Trusts (InvITs) to use interest rate derivatives for hedging risk

Also, the regulator has suggested approving locked-in units for REITs and InvITs to be transferred among sponsors and their groups similar to rules for promoters in listed companies, to help sponsors manage their holdings without compromising "skin in the game'

Additionally, Sebi has suggested permitting fixed deposits to be considered as cash equivalents when calculating leverage for REITs and InvITs, clarifying credit rating requirements for REIT and InvIT borrowings, and setting a timeline for filling vacancies on their boards and expanding the asset base for REITs and SM REITs.

The regulator has also proposed to permit REITs to invest in liquid mutual funds. It has suggested measures to facilitate ease of doing business for REITs and InvITs, along with investors' protection.

According to its consultation paper, Sebi is considering allowing REITs and InvITs to hedge against interest rate fluctuations by using derivatives like interest rate swaps.

This could help stabilise cash flows, reduce risks, and protect unitholder interests, especially for long-term infrastructure projects. It is also proposed to define

'Common Infrastructure for REIT regulations. business То enhance

flexibility for REITs, it has been proposed to clarify that facilities like power plants, heating/cooling systems, water treatment, and waste treatment plants -- serving one or more REIT assets -will qualify as "common infrastructure" under REIT rules

This applies even if these



facilities are not located within a single project due to their technical requirements. These facilities should supply and be used exclusively by REIT assets. For power plants, however, any excess power can be sold to the state utility/grid as per regulations, with any credits or payments going towards the benefit of REIT assets.

To improve transparency, it has been proposed to amend the governance norms for quarterly reporting of InvITs. Currently, quarterly results for the investment manager and its business segments are presented to the investment manager's board, but there is no direct requirement for InvITs to report their performance.

Magicpin slashes platform

The proposed amendment would clarify that quarterly results should specifically reflect the performance of the InvITs themselves, not just investment the managers. This change aligns InvIT regulations with REIT regulations, where the focus is on the quarterly results of the REIT itself.

Also, it has been suggested to align the composition of NRCs in REIT and InvIT managers with listed companies under the LODR regulations.

Currently, all NRC members for REITs and InvITs must be independent directors. The proposal allows a mix of independent and nonexecutive directors, similar to listed companies.



India sees significant gains in export competitiveness across key sectors

India's export competitiveness has witnessed healthy gains in multiple sectors particularly petroleum, gemstones, agrochemicals and sugar during the last five years, as these segments have increased their share in global trade, according to the commerce ministry data.

according to the commerce ministry data. The other sectors where the share of India's exports has increased during 2018 and 2023 are electrical goods, pneumatic tyres, taps and valves, and semiconductor devices devices.

devices. The ministry data analysis showed that petroleum exports rose to USD 84.96 billion in 2023, with India's putton in 2023, with India's market share surging to 12.59 per cent last year from 6.45 per cent in 2018, positioning it as the second-largest global exporter. It was ranked fifth in 2018.

2018. In the precious and semi-precious stones segment, the country's share in global shipments has soared to 36.53 per cent last year from 16.27 per cent in 2018. It has propelled the country to the top position in the category, with exports reaching USD 1.52 billion in 2023 from USD 0.26 billion in 2018. 0.26 billion in 2018.

It was at the second spot in 2018. Similarly, in cane or beet sugar, the country's outbound shipments have more than quadrupled to USD 3.72 billion from USD 0.93 billion in 2018. India has achieved tremendous growth in the

export of cane or beet sugar, with its global market share increasing from 4.17 per cent in 2018 to 12.21 per cent in

2023.

"As the world's second-largest exporter of sugar, India's success can be attributed to both favourable agricultural policies and its strong production base.

The country has capitalised on the growing global demand for sugar, especially in regions like Southeast Asia and Africa," an official said. India's share of the global market for insecticides and fungicides has also shown healthy improvement.

The country increased its global share from 8.52 per cent in 2018 to 10.85 per cent in 2023, with exports reaching USD 4.32 billion.

India's ability to meet international agricultural and environmental standards and its emphasis on innovation in world market rising to 1.4 per cent, and the country now ranks ninth globally compared to 25th in 2018. This underscores India's potential to become a key player in the global semiconductor supply chain. agrochemicals have led to this improvement, the official said. India is now the third-largest exporter globally against the 5th position in 2018, the data

Lower sales realisation hit margins of cement makers

Major cement manufacturers reported a decline in margins in the September quarter, mainly on account of lower prices, leading to lower sales realisation.

Barring three leading cement producers UltraTech Cement, producers UltraTech Cement, Ambuja Cement, and Dalmia Bharat other smaller players, including Nuvoco Vistas Corp, JK Cement, Birla Corporation, and Heidelberg Cement, reported a decline in topline and sales volume in the second quarter of the current fiscal year current fiscal year. Industry observers said the

increase in sales volume of UltraTech and Ambuja Cements is mainly due to the several acquisitions by both companies that consolidated their position further in the

industry. The industry also faced challenges such as extended monsoon, floods, and a slow pickup in government demand, cumulatively leading

towards a weak demand. Power, fuel, and other costs, however, largely remained stable for the industry. The all-India average cement price was around Rs 348 per 50 kg bag in June 2024. It decreased 11 per cent year-on-year to Rs 330 per bag in September, though it increased 2 per cent on a month-on-month basis. In the first half of FY25, In the first half of FY25, cement prices declined 10 per cent year-on-year to Rs 330 per bag. A year earlier, the average prices stood at Rs 365 per bag and Rs 375 per bag in FY23, according to an Icra report.

India slips to 2nd in WTC as Australia takes top spot

India lost their top position in the World Test Championship standings, slipping to second place after suffering an embarrassing home series defeat to New Zealand on Sunday. India lost to New Zealand by 25 runs in the third and final Test in Mumbai resulting in

Test in Mumbai resutling in a 0-3 whitewash, their first in a home Test series since South Africa's 2-0 win in 1999-2000. This was also for the first time India have been swept 0-3 in in a home series.

It was India's fifth loss in the ongoing WTC cycle, causing a significant drop in their points percentage (PCT), which fell from 62.82 to 58.33.

India thus dropped to the India are now schedule to fly second spot behind reigning Down Under to play the fivechampions Australia, who have regained the top spot



with a PCT of 62.50. Border-Gavaskar match Trophy, which has gained

more significance now as both teams will be vying for the top two spots. India were considered favourites to win a majority

of their remaining matches in their quest for a third consecutive WTC final appearance.

However, to qualify for the final without depending on external results, they now must win four of their remaining five games -- a challenging task in Australia. Australia, on the other hand, are in a better position as they need to win four of their

remaining seven Tests. New Zealand's historic series sweep in India has also bolstered their WTC final

aspirations. They have climbed to the fourth spot with a PCT of 54.55, while Sri Lanka occupy third place with a PCT of 55.56 PCT of 55.56.

South Africa, currently fifth with a PCT of 54.17, also remain in contention for a top-two finish and a place in the next year's one-off Test at Lord's
