uoyed by the success of BAssembly elections in Haryana right after the Lok Sabha polls, a high voltage campaign led by Minister Narendra Modi, several Union Ministers and Chief Ministers has set the tone and tenor of the first phase of Assembly elections in Jharkhand, and bypolls in 31 seats spread across 10 states, most watched Wayanad Lok constituency, which will be held on Wednesday amidst tight security arrangements. The second phase of

Prime Sabha

Assembly polls and bypolls is scheduled on November 20 which will see second phase of Jharkhand, single phase Maharashtra and several bypoll Assembly pockets including that in Uttar Pradesh. Counting will be held on November 23, as per the Election Commission dateline. Though these by-elections are not going to have any bearing on the governments, they are seen as a big test for the Congress and the INDIA Bloc which failed to put up a united show in the recent Harvana Assembly polls. Most of these seats fell vacant after the sitting MLAs contested the Lok Sabha

elections and won while in

constituencies, bypolls are being held due to

bypoils are being field due to death of the representatives. Congress general secretary Priyanka Gandhi Vadra is making her electoral debut from Wayanad vacated by her sibling Rahul Gandhi who also won from the Rae Bareli parliamentary constituency. Voting will be held in seven

Voting will be held in seven seats in Rajasthan, six in West Bengal, five in Assam, four seats in Bihar, three in Karnataka, two seats in Madhya Pradesh, and one seat each in Chhattisgarh, Gujarat, Kerala and Meghalaya. Votes will be counted on November

Though polling was also scheduled for two seats in Sikkim, Soreng-Chakung and Namchi-Singhithang, Sikkim Krantikari Morcha (SKM) nominees Aditya Golay and Satish Chandra Rai have already been declared unopposed after their rivals withdrew from the race.

In Rajasthan, bypolls will be held in Jhunjhunu, Dausa, Khinvsar, Deoli-Uniara, Chaurasi, Salumbar and Ramgarh. In Salumbar and Ramgarh, the bye-elections were necessitated due to the demise of the sitting MLAs, Amritlal Meena (Bharatiya Janata Party) and Zubair Khan (Congress) respectively.

The ruling Trinamool Congress (TMC) in West Bengal had won five of the six seats, Taldangra, Sitai-SC, Naihati, Haroa, Medinipur, and Madarihat - in the 2021 Assembly polls. Madarihat seat was held by

### **ED** raids multiple locations in Jharkhand, WB

The Enforcement Directorate (ED) on Tuesday raided multiple locations in poll-bound Jharkhand apart from West Bengal in a money laundering investigation linked to alleged illegal infiltration of Bangladeshi nationals, official sources said A total of 17 places are being covered in the two neighbouring states by the Ranchi office of the federal probe agency, a day before the first phase of polling in Jharkhand. Visuals of Central Reserve Police Force

(CRPF) personnel positioned outside a hotel located on Bariatu Road in Ranchi and a resort in the city were captured by press teams as ED teams scoured for documents, ledger entries and financial records inside. The ED in September filed a case under the Prevention of Money Laundering Act (PMLA) to probe an instance of alleged infiltration and trafficking of some Bangladeshi women into Jharkhand leading to the generation of alleged slush funds. Prime Minister Narendra Modi and other

Bharatiya Janata Party (BJP) leaders have accused the State Government of aiding such infiltration leading to the altering of the demographic landscape of the tribal-dominated areas of Santhal Pargana and Kolhan regions during the recent poll campaign. Uttar Pradesh Chief Minister Yogi Adityanath on Monday accused the ruling Jharkhand Mukti Morcha-led coalition of converting Jharkhand into a 'dharmashala' for Rohingyas and Bangladeshi infiltrators.

### Overaged vehicles choking NCR

#### One crore end-of-life cars are still running on Delhi's roads

As there is no letup in worsening air pollution in Delhi and its neighbouring region as the air quality index here remains in the 'very poor' category for the past 13 days, the Commission for Air Quality Management (CAQM) directed to launch actions to remove highly polluting end-of-life (EoL) vehicles (petrol vehicles older than 15 years and diesel vehicles older than 10 years) still reported to be plying in Delhi.

The National Capital Region (NCR) still has over one 1.06 Crore 'overage' vehicles (End of Life (EoL) running on the roads illegally and adding to the pollution. Of them, only 26,064 vehicles have been seized in 2023 and 6011 till September 2024.

In Delhi, the transport sector is the most significant contributor at 15.496 per cent, as per the Decision Support System data by the Indian Institute of Tropical Meteorology (IITM). The PM2.5 concentration is currently 40.4 times the World Health Organization (WHO) annual PM2.5 guideline value.

Data shows there are 60,14,493 such vehicles in Delhi. Of them, only 24,706 have been impounded so far. A survey by the Delhi government in October estimates there are 15,0000-2,00000 EoL vehicles still on roads. An estimated 1.1 million vehicles enter and exit Delhi daily, further worsening the air quality. The traffic congestion caused by this vehicle influx also intensifies pollution, particularly nitrogen oxides (NOx), which account for 81 per cent of NOx pollution in Delhi. Data shows that during peak traffic hours (5 pm - 9 pm), when average traffic speed drops to 15 km/h, NO2 levels are 2.3 times higher than noon levels (12 pm - 4 pm) when traffic speed averages 21 km/h.

These congestion-related emissions worsen air quality, especially during winter when inversion layers trap pollutants close to the ground. According to the Ministry of Road and Transport, Haryana has over 27.50 lakh while Uttar Pradesh has over 12.38 lakh such vehicles. Rajasthan has 6.06 lakh such vehicles. Transport department Officials said that there are a large number of EoL vehicles plying on the roads, causing traffic snarls here. In an order to Delhi, the Commission has directed that EoL vehicles should be denied fuel at petrol pumps and more importantly, immediate legal action should be taken against such vehicles, including impounding and further disposal in accordance with RVSF Rules, 2021 and other extant policies of the respective State Governments and the GNCT Delhi.

"As a deterrent measure, all such EOL vehicles are identified through the Automated Number Recognition (ANPR) camera systems at petrol pumps. Delhi has piloted one such innovative and effective solution which envisages Automated Number Plate Recognition (ANPR) camera systems which are in the process of being installed at all 500+

fueling stations in the capital city". 'These cameras, besides capturing and displaying the registration details o[ all the vehicles that enter the premises of the fueling station, also have a provision of integration with VAHAN database and thus the status of "EoL" vehicles or vehicles without valid Pollution Under Control Certificate "PUCC" can be readily captured by the system. The system further has a provision for an audio message which is relayed in respect of such non-compliant vehicles entering the premises of the fueling station," it said.

"In view of the high polluting nature of EoL vehicles and considering that such a large fleet, while de-registered, is still reported to be plying, NCR States / GNCT of Delhi, there is an urgent need to launch / intensify drives against such vehicles. While much more intensified "onroad" drives should be taken up to guard against such overage vehicles plying on roads or parked in public spaces, suitable technological interventions and intelligent solutions also need to be employed towards identification / detection of such EoL vehicles still running in the



### **Canada temple** cancels event amid protest threats

The Brampton Triveni temple in Canada has cancelled a consular event after the Canadian police warned them of an "extremely high and imminent" threat level of violent protests.

The Life Certificate event, organised by the Consulate General of India, Toronto, was scheduled for November 17 at the temple premises. It was part of the consulate's many camps for issuing Life Certificates for pension purposes. On Monday, the temple authorities said the event was cancelled due to "official intelligence from Peel Regional Police, stating that there is an Extremely High and Imminent Threat Level of violent protests".

...We must make the appropriate decision to cancel to ensure the safety of Brampton Triveni Mandir devotees, community visitors, and the general public," the temple authorities said in a statement. "We are deeply saddened that Canadians now feel unsafe coming to Hindu Temples in Canada," it added.

Temple authorities called on Peel Police to address the threats being circulated against the temple and provide security guarantees to the Canadian Hindu community and the general

The cancellation came almost a week after protestors carrying Khalistani flags clashed with devotees at a Hindu Sabha temple and disrupted an event co-organised by the temple authorities and the Indian Consulate at Brampton. Last week, the Consulate General of India in Toronto said it was cancelling some of its scheduled consular camps after the Canadian security authorities conveyed their inability to provide minimum security protection to its organisers.

After the protests at the Hindu Sabha temple in Brampton on November 3, the Ministry of External Affairs said that New Delhi remains "deeply concerned" about the safety and security of Indian nationals in Canada. India condemned the attack with an

expectation that those indulging in violence "will be prosecuted". The relations between India and Canada have

come under severe strain following Prime Minister Justin Trudeau's allegations in September last year of a 'potential" involvement of Indian agents in Khalistan extremist Hardeep Singh Nijjar's killing.

New Delhi rejected Trudeau's charges as "absurd." Nijjar, a Canadian citizen, was designated a terrorist by India.

### **Bodies of two Meitei New entrance exam series in January** men recovered

 $B^{\text{odies of two elderly men}}_{\text{belonging to the Meitei}}$ community were recovered on Tuesday morning in Manipur's Jiribam district suspected militants and security forces broke out a day before, police said.

Operations are underway to trace three women and three children, who have been reported missing since the violence erupted in Jiribam on Monday, IGP (operations) I K Muivah said.

The bodies of the two men, Laishram Balen and Maibam Kesho, were found lying in debris during a search operation in the Jakuradhor Karong area where a few shops were set on fire by suspected militants on Monday, another senior officer said.

"The two elderly men belonging to the Meitei community died after the insurgents torched a few shops in the Jakuradhor Karong area," he said.

district Jiribam imposed administration prohibitory orders to avoid any untoward incident in the area, the officer said. A



shutdown has been observed since five am on Tuesday in Kuki-Zo majority areas in the hills to protest against killing of suspected insurgents in the gunfight with security personnel, another police officer said.

The Kuki-Zo Council called for a total shutdown in the hill areas of the state from 5 am to 6 pm on Tuesday to express their "collective grief and solidarity for those who

were brutally shot dead". The police had said 10 suspected militants were killed in the fierce gunfight with security forces on Monday after insurgents in camouflage uniforms, armed with sophisticated weapons, fired indiscriminately at a police station and an adjacent CRPF camp in Jiribam district. However, a senior officer had put the toll at 11.

### **Retail inflation rises** to 6.21 per cent

etail inflation rose to 6.21 per cent in October Refrom 5.49 per cent in the preceding month mainly due to higher food prices, breaching the Reserve Bank of India's (RBI's) upper tolerance level, according to official data released on Tuesday.

The consumer price index-based inflation was 4.87 per cent in October 2023. The National Statistics Office data showed that inflation in the food basket rose to 10.87 per cent in October from 9.24 per cent in September and 6.61 per cent

in the year-ago month.
The RBI, which kept the key short-term lending rate unchanged earlier this month, has been tasked by the government to ensure inflation remains at 4 per cent with a margin of 2 per cent

### surge of patients post **UPNL** workers strike

Aday after Uttarakhand Purva Sainik Kalyan Nigam Limited (UPNL) workers boycotted work on Monday, the OPD at the Government Doon Medical College hospital witnessed a surge in patients on Tuesday. Many patients claimed that due to the UPNL workers' strike on Monday, they were unable to properly access services at the OPD, leading them to return the next day. They have urged the hospital administration to prepare an action plan to ensure smooth service delivery under such circumstances in the future. Notably, UPNL employees staged a protest march towards the secretariat on Monday. These workers, who are employed through UPNL, organised the protest to highlight their long-standing demands for salary allowances and appointment-related issues. As a result, around 450 GDMC hospital workers, also employed through UPNL, participated in the protest. In light of this situation, a patient Manju Negi said that she had visited the OPD on Monday to visit the physician. However, the disruption caused by the workers' strike led to long queues and delays at the billing and registration counters, due to which she had to visit the hospital again on Tuesday. She emphasised the need for the hospital administration to devise an effective plan for such circumstances. Another patient Vishnu Dixit said that due to the public holiday on Tuesday, the GDMC OPD opened till 12 PM instead of 2 PM. Nevertheless, he observed a high number of patients in the registration queue for the OPD due to the impact of Monday's workers' strike, prompting many patients to revisit the hospital on Tuesday. This resulted in overcrowding and difficulty for other patients to see the doctor promptly. He explained that he had waited in the OPD registration queue for over an hour and had not received his service number. Numerous other patients and their attendees have raised the same issue regarding the increase in visitors following the return of hospital workers after the strike.

### Accident in Doon claims six young lives, one sustains serious injuries

Six youths were killed and one sustained serious injury in a road accident near ONGĆ intersection in Dehradun in the wee hours of Tuesday. Chief minister Pushkar Singh Dhami also expressed deep sorrow over the tragic accident. The superintendent of police (City) Pramod Kumar said that the police received a report of a collision between a container truck and an Innova car at 1:33 AM. Police arrived at the scene to find the Innova car severely damaged after colliding with the rear of the container truck. The car, carrying seven people, was completely wrecked. Kumar informed that six of the passengers died on the spot, while one person was critically injured and taken to Synergy Hospital for urgent medical attention. The bodies of the deceased were taken to the morgues of Deen Dayal Upadhyay Coronation hospital, Government Doon Medical College (GDMC) hospital and Indresh hospital. He informed that according to the prelimi-



nary investigation, the container was approaching from Kishan Nagar Chowk, while the Innova was coming from Ballupur Chowk. During the container's crossing, it seems that the Innova driver possibly misjudged the speed and distance of the truck, and attempted to cross the road. In a collided with the back of the container that resulted in the fatal crash. Initial investigations suggest overspeeding as a likely cause of the accident, the SP city said. The deceased have been identified as Guneet (19), a resident of GMS Road, Navya Goyal (23), resident of Tilak

m ollowing\ a\ tragic\ accident}$ that claimed six young lives in the wee hours of Tuesday, the Dehradun senior superintendent of police Ajai Ŝingh has appealed to all citizens to abide by traffic rules irrespective of the time of the day. He raised serious concerns about the dangers of neglecting traffic rules at night. The accident, believed to have been caused by overspeeding, is a grim reminder of the risks involved in night time driving when many people mistaken ly assume that fewer vehicles on the road means no need for caution. According to the SSP, a common issue is that drivers tend to drive at high speeds, fail to follow lane discipline, and even take shortcuts by driving on the wrong side of the road, all in the belief that roads are empty and there is no one to monitor them. He said that drivers should remember that fewer vehicles do not mean no vehicles. This misconception often leads to

overspeeding and reckless manoeuvres, which can quickly turn deadly. The Dehradun superintendent of police (City) Pramod Kumar said that one of the most overlooked aspects is the frequent operation of heavy vehicles like trucks on the road at night. The recent accident, where an Innova collided with the rear of a container truck, highlights the severe consequences that can arise when drivers fail to accurately judge the speed and position of other vehicles. In this case, overspeeding and misjudgment during a crossing attempt are believed to have been contributing factors. He emphasised the need for drivers to stay vigilant and strictly adhere to traffic rules, regardless of the time of day. He urged everyone, particularly young drivers, to avoid overspeeding and prioritise safety over haste. Every life is valuable, and responsible driving can prevent such heart-breaking incidents, he added.

### **Warm clothing sales** drop in Dehradun

The delay in the onset of winter chill this year has caused a decline in sales for shopkeepers selling winter clothing in Dehradun's main markets such as Paltan Bazaar, thanda Bazaar and others. The Jhanda Bazaar and others. The delay in the arrival of the winter chill is causing people to avoid warm clothing which they generally start wearing in November. In past years, the cold weather typically began to set in by the end of October, prompting residents to start prompting residents to start wearing warmer clothing. However, due to the delayed onset of the chilly weather with temperatures remaining above normal in Dehradun and other parts of the State this year, local shopkeepers in Dehradun have experienced a 50 per cent decrease in sale of

A shopkeeper at Paltan Bazaar Aditya Kumar noted that the sale of winter clothes has been impacted this year due to the delayed start of the winter season. Typically, people shop for winter clothes in November to prepare for the cold weather, but this year, the comparatively warmer temperatures have caused a delay peratures have caused a delay in the purchase of winter clothing. As a result, shopkeepers like him have stocked fewer winter clothes than usual, he

"I have been selling winter merchandise for five years at Paltan Bazaar. In past years, the month of November saw a high demand for winter clothing. However, this year, the delay in the onset of the winter chill in November has resulted in a 50 per cent decrease in sales compared to the previous year," shopkeeper Mohan Negi said.

He further added that consequently, due to this decline in sales, he had made the decision not to increase the stock of winter items in the months ahead, as it is anticipated that winter sales will remain low this year.

Many other shopkeepers selling winter items, including socks and woollen caps, have expressed the same concern over the decrease in the sales of winter clothing this year due to the delay in the winter chill.

### Reel making trend causes public nuisance, congestion at Paltan Bazaar



### **Deliver tangible results**

With 2024 set to be the hottest year on record, the stakes for COP29 are higher than ever

he 29th annual UN climate summit, COP29, has officially begun in Baku, Azerbaijan. This year's conference brings together diplomats, climate experts, activists, and political leaders from nearly 200 countries to address critical issues in the fight against climate change. However, the event is already facing challenges, both from the host country's fossil-fuel-centered economy and the re-election of Donald Trump as US President, which could impact future climate commitments from one of the world's largest emitters. COP29 is being held in Azerbaijan's capital, Baku, a decision that has sparked criticism from environmentalists worldwide, with activists like Greta Thunberg referring to the summit as a "greenwash conference." This year's COP has been dubbed the "Finance CoP" due to its focus on securing adequate funding for climate action. Low-and middle-income countries are advocating for significant financial support to help them reduce greenhouse gas emissions and transition to renewable energy. The UN esti-

mates that developing countries, excluding China, need more than \$2 trillion annually by 2030 to make meaningful progress.

The current debate centers on who will finance these initiatives. In 2009, wealthier nations pledged \$100 billion annually in climate financing for developing countries, a goal they only reached two years behind schedule. Now, many of these recipient countries are calling for a new target of at least \$1 trillion per year to effectively address climate challenges. Countries such as China and the UAE, which are still classified as "developing" but are major emitters and fossil-fuel producers, face pressure to contribute more substantial-

ly to the climate finance fund. Another core issue at COP29 is the review of Nationally Determined Contributions (NDCs), the plans each country submits outlining their goals to reduce greenhouse gas emissions. With the next round of NDC updates due in early 2025, this summit is a crucial opportunity to solidify targets that align with the Paris Agreement's goal of limiting global temperature rise to 2 degrees Celsius by 2100. The hope is that countries will commit to more ambitious emission reductions and be transparent about their paths toward net-zero emissions. COP28, held in Dubai in 2023, marked the first time a COP agreement openly called on countries to transition away from fossil fuels. However, progress has been inconsistent. The International Energy Agency's (IEA) tracking tool, established in April 2024, shows mixed results, with many countries struggling to meet their renewable energy targets. COP29 in Azerbaijan faces substantial challenges, from balancing climate goals with fossil fuel interests to addressing the financial needs of developing nations. If COP29 is to be a success, it must result in tangible commitments to climate finance, renewable energy, and unity among nations. This will be essential to ensuring that COP29 is remembered as a turning point in the global response to climate change—not as a missed opportunity.

## Domestic tensions add to Oli's predicament



Amid a mounting internal criticism, Nepal's Prime Minister KP Oli faces daunting challenges, from managing a coalition to dealing with China

Diwali and Tihar vacation in Nepal is continu-Here is a flash report from Pokhara. After a turbulent 18month rule, in which former Prime Minister Prachanda had to seek a vote of confidence five times, the two leading parties Nepali Congress and Unified Marxist Leninist unholy alliance ended CPN(Maoist) kingmaker Prachanda's rule of just 32 seats in a 205-member house. PM KP Oli-led coalition is short of a two thirds majority. They share 4 to 3 in NC's favour in ruling the seven provinces. The promise of Ram-Rajya is unlikely to materialise. Two things stand out: an uneasy stability in government; and Oli's apparent unpopularity. Oli's only claim in his first 100 days is a positive stock market. And breaking the tradition of a Nepalese PM's first overseas visit to India by going first to China from 2 to 6 December, which high profile foreign minister Arzu Rana is organising. India not inviting Oli to become PM is a deliberate omission which was served to late PM Sushil Koirala also a decade ago. Oli's standing as a leader has

diminished because he is a junior partner to NC which is seen favoured by India, and due to his apparent loss of control and power over UML. A front-page report in Kathmandu Post (5 November) illustrates this. But alleged corruption cases against him and his supporters including the super department store chain Bhat Bhateni owner Min Bahadur Gurung have dimmed his reputation. On occasions, he was greeted with the chant "Oli chor, desh chhod". Still, Oli retorted: "wait and watch my party perform during 2027 elections". He is hoping to resuscitate his image from his visit to China. His stock with India is low. While Rana was given a red carpet welcome in India – meeting PM Modi, NSA Ajit Doval and Secretary to Prime Minister PK Misra – Oli's vith Modi on the sidelines of UNGA was low-key. The China visit will have the Oli hallmark. He will meet President



Exim Bank of China for the China-constructed Pokhara International Airport – a white elephant like Hambantota in Sri Lanka – to grant though China has insisted it is part of the BRI loan. Oli is expected to sign the BRI implementation plan which China has been pressing but so far, Nepal has resisted as Kathmandu wants BRI to come under a grant scheme and not a highinterest loan. The BRI deal has been pending since 2020. Oli during his 2018 China visit had outlined 35 projects which were trimmed to nine projects under BRI. If Oli can persuade China of his 'grant scheme for BRI' or place some of the nine projects under it, he will have made a big breakthrough. Strangely few protest about Chinese intrusions in the north. The Jeevan Bahadur Shahi report which had recently mapped Chinese encroachments, missing border pillars and illegal construction, has been quashed.

Nepali leaders willingly oblige Beijing over the One China policy that has ensured the 'Great Wall of China' on the border to prevent Tibetan inflitration and migration to Dharamsala. ### Staying grounded: Lessons from the 1984 elections and anti-Sikh riots

### Both politicians and journalists risk misjudgment when they distance themselves from the realities on the ground

he 1984 election results were a shock to 👢 many. Rajiv Gandhi won a record-breaking 414 seats, toppling major political figures. Veteran leaders like Atal Bihari Vajpayee and Chandra Shekhar faced unexpected defeats-Vajpayee in Gwalior and Chandra Shekhar in Ballia. But this story is less about the triumphs or losses and more about a crucial lesson this journalist learned from an open-hearted conversation with Chandra Shekhar. In an interview, this journalist asked the seasoned leader if he had anticipated the wave that swept away even stalwarts like himself.

Shekhar replied candidly: "To be honest, I had become



disconnected from the grass roots. I didn't realise there was such a wave." This realisation left a lasting impact on the journalist, shaping their perspective going for-

The same kind of shock had reverberated through the nation during the 1977 elections, but in the opposite

her own seat in Rae Bareilly, while her son Sanjay Gandhi lost in Amethi. The Congress party was


routed, failing to win a sin-gle seat in Uttar Pradesh or Bihar. Despite her stature and the counsel of her closest advisors, Indira Gandhi had also become detached from grassroots sentiment. This disconnect was something this journalist later witnessed in the field of journalism itself. During the 1984 anti-Sikh riots, this journalist returned from the field after witnessing the violence firsthand.

His editor, Ayub Syed, was discussing the events with a senior journalist, OP Sabherwal, who was

Sabherwal likened the situousted from power, losing ation to 1947, predicting that the riots would continue indefinitely.

The journalist respectfully intervened, sharing what he had observed in RK Puram: a Gurdwara under attack, granthis being rescued by the army, looters scattering when a single soldier raised his hand, and a crowd dispersing with just a shout. He explained to his seniors that the violence was being stoked by the Congress government, with rioters emboldened by police assurances of impunity. The journalist conveyed that

the riots were far from uncontrollable and could be stopped whenever the government chose. And he was direction. Indira Gandhi was analysing the riots from afar. proven right; the violence



ceased once the government decided it had gone too far. The lasting lesson? Whether a politician or a journalist, detachment from reality clouds judgment. Without a connection to the ground, even the most obvious forces at play can go unseen.

The 1984 election and subsequent events taught a vital lesson about staying con-nected to the grassroots. Rajiv Gandhi's landslide victory, which swept aside prominent leaders like Atal Bihari Vajpayee and Chandra Shekhar, highlight-ed how even seasoned politi-cians could lose touch with

public sentiment. În a candid interview, Chandra Shekhar admitted his own disconnect from the grassroots, mirroring

the misjudgment that cost Indira Gandhi the 1977 election. This theme resonated again during the 1984 anti-Sikh riots, where a journalist's firsthand observations clashed with distant analyses in the newsroom. The violence, stirred by political agendas, was ultimately controllable when authorities chose to act.

The takeaway? For both politicians and journalists, a disconnect from on-theground realities can obscure clear judgment, leaving critical forces unrecognised. Staying rooted is essential to understanding and addressing the true dynamics at play in any situation.

Addressing the opening ceremony of the World Leaders Climate Action Summit at COP29 here, Guterres sought urgent measures to support developing nations, which are bearing the brunt of climatefuelled catastrophes despite contributing relatively little to global emissions.

The rich cause the problem, the poor pay the highest price," Guterres said, pointing out that developing nations face disproportionate impacts from climate change, such as food insecurity, infrastructure damage, and biodiversity loss.

"Developing countries must not leave Baku empty-handed. A deal is a must and I'm confident it will be reached," he

### Amsterdam police warn of fresh unrest | UK supports India for a day after rioters torch tram

**AP** ■ THE HAGUE

senior police officer Awarned Tuesday of calls for more rioting in Amsterdam, after dozens of people armed with sticks and firecrackers set a tram on fire Monday night as the city faces tensions following violence last week targeting fans of an Israeli soccer club. Olivier Dutilh, of the Amsterdam police force, told a court hearing that "we have signals that there are calls for similar" unrest in the west of the

Police said the fire Monday was quickly extinguished and riot officers cleared the square. Images online showed people damaging property and setting firecrackers. There were no reports of any injuries.

Police said it was not clear who started the unrest and whether it was related to what happened last week. Some rioters could be heard on video shared on social media using slurs against Jewish people.

Police noted the tense atmosphere since five people were treated in the hospital and dozens detained Thursday following a Maccabi Tel Aviv-Ajax match. Youths on scooters and on foot went in search of Israeli fans, punching and kicking them and then fleeing to evade

The mayor has banned all demonstrations in the city and declared several parts of Amsterdam risk zones where police can stop and check anyone. Dozens were detained on Sunday for taking part in a pro-Palestinian demonstration in central Amsterdam that had been outlawed. A small demonstration was ended by police Tuesday outside Amsterdam City Hall during a debate about the unrest, Dutch broadcaster NOS reported.

The UK has reiterated its The or has remainent membership for India in the United Nations Security Council (UNSC) as part of an expansion of the international panel to ensure it can continue to rise to the pressing challenges faced by the world. In an address to a UN General

Assembly plenary in New York on Monday, UK Ambassador to the General Assembly Archie Young reflected upon Prime Minister Keir Starmer's statement at the UNGA back in September calling for UNSC reforms to ensure the global multilateral system is "more representative and more responsive".

Besides India, Young stressed that the UK wants permanent representation for Africa,

Brazil, Germany and Japan. "The UK believes that a reformed Council, coupled with a collective, renewed commitment to the UN Charter, would strengthen the Council. so it can continue to rise to the challenges the world is facing; that is why we remain a strong supporter of UN Security Council Reform. The Council must be expanded, to better reflect the world today," said

"We continue to support an expansion in both the permanent and non-permanent categories of membership to a total in the mid-twenties. We want to see permanent African representation, and permanent seats for Brazil, Germany, India and Japan," he said.

Reflecting on the 2023 Security Council reform agenda at the UN General Assembly, Britain's UN representative recalled the perilous and dangerous state of the world at the time and the challenge this posed to the multilateral system.

He noted: "A year later, the situation is even more acute, and the need to strengthen our multilateral system through reform, ever more pressing During his address to the UN General Assembly September, my Prime Minister reflected on the increasingly complex and interconnected challenges the world, and our multilateral system, are facing," he said. "Conflict touches more countries now than at any time

in the history of the United Nations, exacting a terrible human toll in Ukraine, Gaza, Sudan, and elsewhere in the world. The Security Council's role - and its responsibility for international peace and security – is as important now as it

Young admitted that agreeing on a model of reform for the Security Council will be "difficult" but asserted the importance of tackling the issue.

"It is incumbent on all of us to work together, in the spirit of compromise, to deliver the change we know is needed. The UK is committed to doing just that, and we look forward to detailed and constructive discussions in the intergovernmental negotiations, which we hope will move us forward towards text-based negotiations," he added.

The UK's intervention came as Permanent India's Representative to the UN Parvathaneni Harish also focussed his address at the plenary session on urgent UNSC reform

"As we begin this year's deliberations, we note that the reform of the UN Security Council was once again identified as a critical and immediate priority at the summit of the future discussions by our leaders. However, in spite of several decades of collective reiteration of this sentiment, it is disheartening that we have had no results to show in this regard since 1965 when the Council was last expanded in the nonpermanent category alone," he

## Vistara flies final journey as it merges with Air India

After operating for nearly years, full service carrier Vistara flew into the sunset on Tuesday early morning operating its last flight from the national capital to Singapore.

Vistara a joint venture between Tatas and Singapore Airlines has now merged with Air India, creating an enlarged entity that is now the country's largest international carrier and second-largest domestic

UK115 flight from Delhi to Singapore was the last flight of Vistara with the code 'UK' while UK986 from Mumbai to Delhi was the carrier's last domestic flight.

Starting a new chapter in India's fast-growing civil aviation space, the merged entity operated its first flight with the code 'AI2286' from



Doha to Mumbai.

In the domestic sector, the integrated entity's first flight AI2984 took off from Mumbai to Delhi.

All the four flights landed at their respective destinations early in the morning on Tuesday, according information available on the tracking website Flightradar24.Com.

According to an official, the two airlines have been merged, passengers are being issued Air India boarding passes and check-in counters of Vistara at airports have become that of Air India.

### Nirmala Sitharaman to meet state FMs for pre-Budget

Union Finance Minister Nirmala Sitharaman is likely to meet her state counterparts on December 21-22 for pre-budget consultations and meeting of the GST Council, an official

meeting assumes significance as states finance ministers would present their recommendations for 2025-26 Budget to be unveiled on February 1, 2025.

The 55th GST Council meeting would be held during one of these two days in which the much awaited decision on exemption or lower GST rate on health and life insurance would be taken.

The Council may also take up some rationalisation exercise and reduce tax rates on a host

of common items from 12 per The GST Council in its 54th cent to 5 per cent as per the recommendations of a panel of state ministers.


The two-day meeting is slated to take place in Rajasthan, either in Jaisalmer or Jodhpur, the official added.

Last month, the group of ministers (GoM) on health and life insurance GST broadly agreed on exempting insurance premiums paid for term life insurance policies, and senior citizens' health insurance from GST.

Also, GST on premiums paid by individuals, other than senior citizens, for health insurance with coverage of up to Rs 5 lakh is proposed to be exempted. However, 18 per cent GST will continue on premiums paid for policies with health insurance cover of

meeting on September 9 had tasked the GoM to finalise the report on GST levy on insurance by October-end. Separately, the GoM on GST rate rationalisation has also suggested that the GST Council rejig tax rates on a host of goods, including packaged drinking water, bicycles, exercise notebooks, luxury wrist watches, and

shoes. This rate rejig is expect to result in revenue gain of about Rs 22,000 crore. The GoM on rate rationalisation proposed reducing GST on packaged drinking water of 20 litre and above to 5 per cent from 18 per cent. If the GoM's recommendation is accepted by the GST Council, GST on bicycles costing less than Rs 10,000 will be reduced to 5 per cent from 12 per cent.



### **Majority of Indian businesses invest** in Al but only 39 per cent ready to fight ransomware attacks: Report

Cybersecurity firm Sophos on unveiled "Cybersecurity Playbook for Partners in Asia Pacific and Japan", which stressed the urgent need for enhanced measures organisations increasingly face sophisticated cyber threats, especially those augmented by artificial

The findings revealed that while 70 per cent of Indian organisations have implemented cloud security strategies and over half of the respondents surveyed are in AI-driven investing measures,

significant gap remains in

overall preparedness. "Only 49 per cent have established security maturity frameworks and 44 per cent report meeting security standards. Additionally, just 39 per cent feel prepared to withstand a prolonged ransomware underscoring the ongoing need for robust cybersecurity advancements," the report

While Indian businesses are embracing AI to enhance they recognise its dual nature both as an asset and as a potential security risk, it added.

The research, conducted in 2024, surveyed 900 companies across India, Australia, Japan, Malaysia, the Philippines, and Singapore, of which 200 were from India.

Commenting on the dual nature of AI in cybersecurity, Sunil Sharma, Vice President of Sales for Sophos in India, said enterprises are taking AI seriously, both as a powerful ally and a potential threat.

"The fact that organisations are significantly boosting their cybersecurity budgets is a great sign that the country is committed to protecting its digital infrastructure. growing investment in key areas such as threat detection, incident recovery, and data protection not only reflects businesses but also highlights their readiness to tackle the complex challenges posed by AI-driven cyber risks," he

Further, the survey revealed that only 5 per cent of Indian firms depend on a single security vendor, while 71 per cent utilise three or more to handle their cybersecurity demands.

Multi-vendor setups are anticipated to increase as businesses look specialised, adaptable solutions.

The increasing investments in cybersecurity and the preference towards multiple expert vendors present a significant opportunity for MSPs to help enterprises improve their customers' defences with a customised approach, Sharma said.

The Boeing 777 aircraft has a seating capacity of 400 passengers in a dual-class

business and 376 economy class seats, the airline said. In the wake of Pratt & Whitney engine issues, the airline has grounded many impacting its aircraft, capacity.

Last month, IndiGo, which also became India's first airline to have more than 400 aircraft, said the number of grounded aircraft has reduced to the high 60s from the mid-70s and will further come down to the sub-60 level by the year-end.

At the end of September, the carrier had a fleet of 410

As part of expanding its international network to long-haul destinations, IndiGo, in May this year, placed a firm order for 30 Airbus A350-900 aircraft.

### Rupee closes all-time low against US dollar

The rupee fell 1 paisa to a new lifetime low of 84.39 (provisional) against the US dollar on Tuesday as persistent foreign fund persistent foreign outflows and a strengthening greenback against major dented crosses overseas investor sentiments.

Forex traders said the rupee is likely to trade between 83.80 and 84.50 in the medium term, with the Reserve Bank significant downside, aided by its robust foreign exchange reserves.

At the interbank foreign exchange, the rupee opened at 84.39 against the US dollar. During the session, the local currency touched a high of 84.39 and a low of 84.41. It finally settled at 84.40 (provisional), a decline of just 1 paisa against the US currency, registering a loss for the fifth straight session.

On Monday, the rupee dropped I paisa to hit a new lifetime low of 84.38 against the US dollar.

In the last five sessions, the local unit has lost 32 paise against the greenback. "The rupee traded weaker as

foreign funds continued their selling spree in the Indian market. However, the rupee received some relief from



falling crude and gold prices, as the reduced pace of decline could potentially improve India's import bill in the coming months," said Jateen Trivedi, VP Research Analyst Commodity and Currency, LKP Securities

Despite this, the dollar index's continued strength above 105 is expected to maintain pressure on the rupee, limiting any significant recovery in the near term. With resistance near the 84.25-84.30 zone and support is seen lower at 84.55. This week's focus will be on the US CPI data release, which could dollar's influence the trajectory. Also, the platform should share data with the regulator when requested and act on its It should provide badges to non-compliant content and

permitted advertisers, or educational providers can post securitiesrelated content on the platform. Additionally, such platforms

can remove fraudulent or

Held to a 2-2 draw, the Indians decided to throw numbers upfront and mounted raids after raids on the Korean citadel and in the process secured penalty corners in quick succession but they lacked variation from the set pieces and the efforts were mostly one dimensional.

The 31-year-old Italian will look to cap his career revival this week by becoming one of 10 players from the European tour to be eligible to claim dual membership and a PGA Tour card for the 2025 season. The season-ending World Tour Championship starts on Thursday in Dubai and only an unlikely turn of events will deny Rory McIlroy from being crowned as the European tour's best player for a sixth time, leaving him two off Colin Montgomerie's

record haul.

There will be more suspense elsewhere, though, notably in that race for those PGA Tour cards — a structural tweak created in 2022 in the wake of the so-called strategic alliance between the European tour and PGA Tour in the face of mounting pressure from the breakaway LIV Golf series. The presence of Manassero in

the 10-man list, as it stands, only elevates the interest Blessed with a smooth swing and a deft touch, Manassero

was a golfing prodigy, winning the British Amateur in 2009, the silver medal at the British Open for low amateur the same year, and also becoming the No. 1 amateur in the world.

By 2013, he'd won four events on the European tour — including the BMW PGA Championship, the flagship event on the tour, to move

into the world's top 25. Then came the career dip, which plunged him into self-

and ultimately doubt retirement — albeit for only a few months while he assessed where to go with his life. He eventually decided to give

golf another go, beginning his rebuild on the lowly Nordic Golf League and the Alps Tour, which is on the third tier of European golf. His talent shone through and last year he sealed a return to

the Éuropean tour with a win at the Jonsson Workwear Open in March being universally celebrated in the golf fraternity. That helped to put him in a strong position to claim the end-of-season bonus of a

PGA Tour card, and he headed to Dubai in fifth place among non-exempt players, behind Thriston Lawrence, Hojgaard, Paul Rasmus Waring — the winner in Abu Dhabi last week — and Niklas Norgaard.

The expected bounce and pace on the pitch here will be an encouraging factor as well for the Indian duo.

### Players believing in our style of play is the key, says Manolo Márquez

Márquez had a rough start to his coaching stint with the national team as India were held 0-0 by Mauritius in September and beaten 0-3 by Syria in the Intercontinental Cup, also in Hyderabad.

His boys put up an improved showing, especially in the second half, against Vietnam in a 1-1 draw last month in Nam Đ?nh.

The Spaniard has continued the trend of calling up new players in each FIFA window so far. This time, Hmingthanmawia Ralte, Vibin Mohanan, Irfan Yadwad and Thoiba Singh Moirangthem earned their first national team call-ups. Since taking charge in July, Márquez's priority has been to utilise the friendly matches and training sessions to find the best group of players for the 2027 AFC Asian Cup Qualifiers, scheduled to start in March 2025.

"It's true that we want to check some new players. But obviously it's impossible to change the whole group and call 40 players in March. It's true that we are finding the group. It means that we have maybe 14, 15, 16 players who will be there, but we don't know exactly. And there are a lot of players who can get there," the coach said.

"Obviously, it's still four months, and the situation can change with a lot of things unfortunately with injuries and the players' domestic form. But, I repeat again, as a coach you need to find the group which can play the style that we

In a way, it's a dangerous game because the players are in the middle of the fight for the ISL and this is just one friendly game in November, and the next camp will be in four months.

"But I am very confident in this group and I feel we will have a good performance next Monday," said Márquez. Still awaiting his first win with India, Márquez remains patient. For now, the key is to find the groove with the right hunch and get results where right bunch and get results where they matter the most.

"Obviously everyone wants to win every game. But the feeling we got after the draw with Vietnam was completely different from what we got after drawing with Mauritius or losing to Syria.
