

RESULT DAY: WINNER TAKES IT ALL Centre opposes ex-SC judges panel

ne-and-a-half months after an interesting day of counting of votes for the Haryana Assembly elections which ultimately retained the Bharatiya Janata Party (BJP) government for a third straight term with initial trends showing a massive lead by Congress, another season of a bitterly contested election, in Maharashtra, and Jharkhand, as well as bypolls in Wayanad Lok Sabha seat, and Assembly segments in Uttar Pradesh, will conclude on Saturday afternoon with the declaration of results.

While Wayanad is set to pave the way for Congress candidate Priyanka Gandhi to Lok Sabha who shall join her brother Rahul and mother Sonia in the Parliament stakes are high for BIP-led National Democratic Alliance (NDA), and Congress-led INDIA bloc in both states, as well as a battle of prestige in the by-polls of Punjab Kerala, Üttarakhand, and a crucial one in Uttar Pradesh, post the BJP's dismal performance in this year's General Elections.

The results of Uttar Pradesh by-polls will be a huge contributing factor in setting a narrative for the next Assembly polls in the state, due in 2027. By-elections to 48 Assemblies constituencies and two Parliamentary constituencies spread across 15 states were also held simultaneously. The Elections for the 81-seat Jharkhand Assembly took place on November 13 and 20, while Maharashtra, which has 288

Assembly seats, went to polls in a single phase on November 20.

But in Maharashtra fissures have emerged within the ruling BJP Shiv Sena combine Mahayuti and the Opposition Congress, Shiv Sena Maha Vikas (Udhhav) Aghadi (MVA) as who will head the next government with several contenders for the chief minister's post currently held by Shiv Sena's breakaway faction Eknath Shinde who toppled Congress and NCP backed Uddhav Thackeray regime.

According to media reports from Mumbai, Maharashtra

Congress remarks that voting trends suggest the Congress will get the maximum number of seats has not gone down well with alliance Shiv Sena (UBT), whose tall leader Sanjay Raut insisted the chief ministerial face will be decided by all alliance partners jointly once the MVA secures majority. However, BJP leader Pravin Darekar batted for Deputy Chief Minister Devendra Fadnavis for the

top post.
"I think if anyone from the

BJP is becoming the CM then it will be Devendra Fadnavis," he said. On the other hand another partner NCP advocated for their party chief and Deputy CM Ajit Pawar for the coveted job. Down South, elaborate

Canada dismisses report linking PM, Doval to criminal activities

The Canadian government has dismissed a media report linking Prime Minister Narendra Modi, External Affairs Minister S Jaishankar and National Security Advisor Ajit Doval to criminal activities in Canada, including the alleged plot to kill Sikh separatist Hardeep Singh Nijjar, terming it as "speculative and inaccurate".

The denial made by Nathalie G Drouin, National Security and Intelligence Advisor to Canadian Prime Minister, on Thursday came a day after India strongly trashed the report as "smear campaign". Quoting an unnamed senior national security official, 'The Globe and Mail' newspaper on Treader security of the security of t and Mail' newspaper on Tuesday reported that Canadian security agencies believe Prime Minister Modi knew about the killing of Nijjar and other violent plots. The official said Canadian and American intelligence tied the assassination operations to Home Affairs Minister Amit Shah. Also in the loop, the official said, was Doval and Jaishankar.

Ten Naxalites were killed in an encounter with security personnel in Chhattisgarh's Sukma district on Friday, a senior police official said. Chief finister Vishnu Deo Sai hailed security forces and said the era of peace and progress has returned to the Bastar region, which includes Sukma.
The gunfight broke out in

the morning in a forest within the jurisdiction of the Bhejji police station when a joint team of security personnel was out on an anti-Naxalite operation, said Inspector General of Police (Bastar

Range) Sundarraj P. The operation was launched based on inputs about the of Maoists presence belonging to Konta and Kistaram area committees of Naxalites on forested hills of Korajguda, Dantespuram, Nagaram and Bhandarpadar

villages, he said. Bodies of 10 Naxalites have been recovered from the spot so far, he said. Besides, a cache of weapons, including an INSAS rifle, an AK-47 rifle and a Self Loading Rifle (SLR), were also seized, he said.

The search operation by the District Reserve Guard (DRG) and Central Reserve Police Force (CRPF) is still underway in the area, he

added. Chief Minister Vishnu Deo Sai praised security forces and asserted that his government's priority is to establish peace, facilitate

development and ensure the safety of citizens in the Bastar region. "Security forces gunned down 10 Naxalites in a

Skipper Jasprit Bumrah made amends for his debatable toss call to bat first with a mesmerising opening spell that left Australia scurrying for cover at 67 for 7 and helped India make an emphatic comeback after a flop show with the willow on Test of the Border-Gavaskar Trophy 2024.

The match, which was billed as a battle between two out of form batting units, lived up to the prediction at least on the first day. As many as 17 wickets fell, which is the first time in seven decades for a Test match on Australian soil. The stand-in India skipper, much to everyone's surprise, opted to bat on a track with a liberal grass cover which generated appreciable seam movement and midriff high

But neither the youngsters nor the seasoned ones in the

Indian line-up were up to the task. It was debutant Nitish Reddy's gutsy 41 and Rishabh Pant's 37, including an unbelievable sixer, that got India to 150 in 49.4 overs with Josh Hazlewood (4/29), Mitchell Starc (2/14 in 11 overs), Pat Cummins (2/67 in 15.4 overs) and Mitchell Marsh (2/12 in 5 overs) sharing the spoils. Supreme Court reserves verdict on 1976 amendment to preamble of Constitution

The Supreme Court on Friday observed the 1976 amendment to the Constitution adding terms socialist, secular and integrity to the Preamble underwent judicial reviews and it cannot say whatever Parliament did during the emergency period was all nullity. A bench of Chief Justice Sanjiv Khanna and Justice Sanjay Kumar reserved its verdict on a batch of pleas filed by former Rajya Sabha MP Subramanian Swamy, advocate Vishnu Shankar Jain and others, challenging the inclusion of the words "socialist" and "secular" in the Preamble to the Constitution.

The CJI, however, said, "The subject amendment (42nd amendment) has been subjected to a lot of judicial reviews by this court. The Parliament has intervened. We cannot say that whatever Parliament did at that time (emergency) was all

nullity." The words "socialist", "secular" and "integrity" were inserted into the Preamble to the Constitution under the 42nd constitutional amendment moved by the Indira Gandhi government in 1976. The amendment changed the description of India in the Preamble from a "sovereign, democratic republic" to a "sovereign, socialist, secular, democratic republic". Emergency in India was declared by the late PM Indira Gandhi from June 25, 1975 to March 21, 1977. The bench said it would pronounce its order on the issue on November 25.

Former Rajya Sabha MP Subramanian Swamy, who filed a separate plea, pointed out even the subsequently elected union government led by Janata Party supported the inclusion of these words in the Preamble. He said the question was whether it should be added as a separate paragraph to the Preamble instead of saying in 1949, it was adopted as social-



ist and secular. Swamy said, 'Not only the emergency Parliament adopted this but (it) was also subsequently supported by the Janata Party government's Parliament by a 2/3rd majority, in which this particular aspect of socialism and secularism was retained." He added, "The issue here is only this much - whether we would make out that this should come as a separate paragraph because we cannot say that in 1949 these words

were adopted. Therefore, the only issue that remains is, having accepted this, we can have a separate paragraph below the original paragraph." Swamy's plea contended the Preamble not only indicated the essential features of the Constitution but also the fundamental conditions based on which it was adopted to create a unified integrated communi-

During the hearing, the bench

refused to refer the matter to a larger bench as sought by petitioner and said "being socialist" in the Indian sense was understood to be a "welfare state". The bench then noted, "The way, we understand socialism in India is very different from other countries. In our context, socialism primarily means a welfare state. That is all. It has never prevented the private sector, which is thriving well. We have all benefited from it. Justice Khanna said the word socialism was used in different contexts worldwide and in India it meant the state was a welfare one and must stand for the welfare of the people and should provide equality of opportunities. He said the top court held "secularism" to be part of the basic structure of the Constitution in the 1994 S R Bommai case.

Advocate Ashwini Upadhyav who too has filed a petition said he was not against the concepts of "socialism" and "secularism" but opposed their insertion into the Preamble. The bench said Article 368 of the Constitution granted power to Parliament to amend the Constitution and it extended to the Preamble as well.

"The Preamble is part and parcel of the Constitution. It is not separate," it said, making it clear the court won't go into the inquiry that the Lok Sabha in 1976 could not have amended the Constitution and that amending the Preamble was a constituent power, exercised only by the Constituent Assembly. rift in Uttar Pradesh by-polls **BISWAJEET BANERJEE** tion stemmed from ticket distribution. BJP fear sabotage, internal

The Bharatiya Janata Party (BJP), still reeling from allegations of sabotage during the Lok Sabha elections, is now grappling with a similar situation in the recently con-cluded by-elections for nine Assembly seats in Uttar Pradesh (UP).

Inputs received by the party's leadership about internal sabotage during voting have raised alarms, prompting an urgent review of the damage caused. Sources within the BJP reveal that saboteurs have been identified, with the most significant disruptions reported in Kundarki, Katehari, and Phulpur constituencies. Complaints began surfacing soon after candidates were announced for key constituencies including Majhawan, Katehari, Kundarki, and Sisamau. Despite efforts by senior leaders to address the unrest, opposition from with-

in the party persisted. In some areas, the dissatisfacoverlooked, in favor of candidates chosen based on caste equations, reportedly worked against the party's official nom-

Inputs also indicate that in Inputs also indicate that in Majhawan sabotage was not limited to BJP ranks. Workers from allied parties within the National Democratic Alliance (NDA) were allegedly involved in undermining the BJP's prospects despite public appeals from top alliance leaders for unity ers for unity.

The situation echoes the party's struggles during the Lok Sabha election, where infighting and candidate dissatisfaction proved costly. Aiming for a clean sweep of all 80 seats in UP, the BIP managed to assure the seat of the UP, the BJP managed to secure only 36 seats

The Lok Sabha results reportedly caused friction between the government and the party organisation, with top leaders divided over the reasons for the defeat. These unresolved issues appear to have resurfaced in the by-elections, amplifying internal discord.

The by-elections are seen as a litmus test for the BJP's organisational discipline and electoral strategy, especially with the 2027 Assembly elections on the horizon. While the party hopes for favorable results, senior leaders are bracing for potential fallout if outcomes fall

short of expectations. Insiders believe that if the byelection results mirror the Lok Sabha disappointments, the party could witness intensified blame games and a widening rift among its top brass. Despite the turmoil, BJP lead-

ers remain optimistic about better-than-expected results. The by-elections are critical for the party to maintain its dominance in the state and rebuild its image ahead of future electoral battles.

CBI files new chargesheet in NEET UG paper leak

CBI has filed its fifth chargesheet in the NEET UG examination paper leak case on Friday against five persons, including key gang member Amit Kumar Singh of Bokaro who allegedly orchestrated and executed the leak, officials said.

In the chargesheet filed before the special CBI court in Patna, the agency alleged that Singh was the key planner of the gang and was aided by Sudip Kumar and Yuvraj Kumar of Bokaro, Abhimanyu Patel of Nalanda and Amit Kumar of Patna in the distribution of the leaked papers to aspirants in Bihar and Jharkhand, they said.

"With this, the total chargesheeted accused in this case stands at 45, and all of them are still in judicial custody," a CBI spokesperson coid in a statement. said in a statement.

The spokesperson said the chargesheet has been filed under various sections of the Indian Penal Code such as 120-B (criminal conspiracy), 109 (abetment), 409 (criminal (cheating), 380 (theft), 201 (causing disappearance of 411 evidence) and (dishonestly receiving stolen

property) and under section 13(2) read with section 13(1)(a) of the Prevention of Corruption Act, 1988 (as amended in 2018).

The CBI took over the investigation on June 23. "Names of the candidates who are beneficiaries of the paper theft or unfair means and names of the MBBS student who had solved the stolen paper or who had appeared in the exam as impersonators have already been identified shared NTA/Ministry of Education," the statement said.

The NEET-UG is conducted by the National Testing Agency (NTA) for admissions to MBBS, BDS, AYUSH and other related courses in government and private institutions. This year, the exam was conducted on May 5 at 4,750 centres in 571 cities, including 14 abroad. More than 23 lakh candidates appeared for the test.
The Bihar Police launched a

Temperature falls, AQI rises

However, Delhi still ranked as the second most polluted city in the country, only behind Bihar's Hajipur (AQI 403). While Delhi's AQI was the worst in the country on Mondav and Tuesday, with readings exceeding 450 in the "severe plus" category, it recorded the thirdworst ranking on Wednesday before moving to the second place on Thursday. Earlier in the season, favourable conditions such as strong wind speeds and easterly winds contributed to better air quality. However, these same conditions are now linked to high Air Quality Index (AQI) readings.

According to SAFAR-India, Alipur recorded an AQI of 389, while Anand Vihar recorded 410, Ashok Vihar 395, Bawana 411, Burari Crossing 369, Dwarka Sector 8 380, IGI Airport 357, ITO 344, Jahangirpuri 426, Jawaharlal Nehru Stadium 342, Lodhi Road 267, Mandir Marg 356, Mundka 402, Najafgarh 353, Narela 383, North Campus DU 346, Okhla Phase 2 374, RK Puram 372, Rohini 397, Shadipur 402, Siri Fort 359, Vivek Vihar 398, and Wazirpur 413 among others. The Decision Support System for Air Quality Management in Delhi pointed out the transport sector as the most significant contributor at 15. 16 per cent. While the

residential sector contribution is 3. 123 per cent, industries contributed 2.877 per cent, construction 2. 148 per cent, energy sector 1 727 per cent, waste burning 1.348 per cent, and road dust 1.502 per cent. Keeping in view of restrictions imposed by the Commission for Air Quality Management (CAQM) under the stage IV of the Graded Response Action Plan, the roads in Delhi witnessed reduction in traffic on most roads and intersections due to banning entry of trucks, BS 3 and BS 4 vehicles, staggering timings of government offices and work from home facilities.

The city roads, which are usually jammed with the traffic flow especially in peak hours, were visibly deserted. Addl/CP (Traffic) Satyaveer Singh Katara stated that the effect of these instructions including work from home for government employees and schools being shifted to online mode is evident as there has been about 25 per cent of reduction of traffic in Delhi. "The reduction is also helping in bringing down the aqi as is visible," he said. Further, complying to the orders of Supreme Court to the Delhi Police to ensure vigilance at entry points in the city for trucks, the officer added that they have deployed teams of traffic personnel at 13 different points including Badarpur, Ghazipur, Singhu border, Tikri border, Loni and Rangpuri border.

The falling temperatures have triggered people to take out their blazers and scarves as the city is witnessing colder days. According to the India Meteorological Department (IMD), the night time temperature recorded on Wednesday was 11.2 degrees Celsius, while Tuesday night saw a low of 12.3 degrees Celsius, making them the third and fourth lowest of the season so far.

The city, covered in a blanket of fog and smitten by chilly wind, saw a maximum tem-



perature of 27.2 degrees Celsius, a degree above the nor-

The humidity levels fluctuated between 97 per cent and 71 per cent during the day, according to the weather department. The IMD has forecast moderate fog for Saturday, with the maximum and minimum temperatures expected to settle at 28 degrees Celsius and 12 degrees Celsius.

According to the Air Quality Early Warning System for Delhi, there has been a slight rise in minimum and maximum temperatures over Delhi/NCR during the past 24 hour. "The Maximum and Minimum temperature over Delhi is in the range of 25 to 27 degrees Celsius and 9 to 12 degrees Celsius respectively. The maximum temperature was below normal by 1 to 3 degrees Celsius and the minimum temperature was near normal most places over the

The traffic cops issued 39,100 challans till October 31 in 2023, which rose to 49,348 this year.

"These 14 markets witness high daily footfall. The figures clearly indicate an intensified crackdown on parking violations in these busy commercial hubs,"

"People are doing gambling there. It seems they are drug addicts there. What are police doing, are they aware of the ground reality. How can people stay there (in public spaces). This gives bad name to police,"

Over 1.12 lakh trees will be felled to make way for Kanwar Yatra route: UP Govt informs NGT

The National Green Tribunal(NGT)has been informed by the UP govern-ment's environment department's environment depart-ment that over 1.12 lakh trees will be felled in the protected forest area in the state to make way for the upcoming Kanwar Ýatra route.

The NGT had sought a reply from the secretary of the state's environment department in a case pertaining to the felling of more than one lakh trees and shrubs in the protected forest area. The area in question spreads

across three forest divisions of Ghaziabad, Meerut and Muzaffarnagar for the proposed route between Muradnagar in Ghaziabad and Purkaji in Muzaffarnagar. The reply, filed by UP principal secretary, Department of Environment, and dated November 19 said, "It is important to mention that the Public Works Department (PWD) received permission to cut 1,12,722 trees/plants for



the Kanwar Marg project, as approved by the (Union) Ministry of Environment, Forest and Climate Change on February 28, 2023.

It said at present, 25,410 trees had been marked and assigned for felling, of which 17,607 were cut by the PWD under the supervision of the Uttar Pradesh Forest Corporation. "Presently, the tree-cutting work has been suspended by PWD since August 9, 2024, and tree felling in certain stretches of the proposed alignment has not commenced," said the

reply uploaded on the tribunal's website on Friday. Noting that the tribunal asked the secretary to enumerate the number of trees under the UP Tree Protection Act provisions, the reply stated such an enumeration was not be possible in the stretches where

cleared during the drive. "In the future, once PWD finalises a revised road alignment with width of 15-20 metre, joint inspections will identify and enumerate any remaining trees to be felled.

This ensures that all relevant vegetation is comprehensively accounted," the reply said.

Climate Change, the study estimates that a 1-metre sea level rise by 2100 would affect over 14 million people along the Southeast Atlantic coast, from Norfolk, Virginia, to Miami, Florida. The study holds relevance for India which has a large number of people living not only along the coastal areas but also dependent on sea for their livelihood.

Geosciences. "The risk of flooding, compounded by sinking land and

beach loss, could displace millions and damage critical infrastructure unless robust adaptation strategies are implemented," said Shirzaei. The findings, in collaboration with the US Geological Survey,

are based on assessments of the cumulative impact of multiple climate-driven coastal hazards, including sea level rise, flooding, beach erosion, sinking land, and rising groundwater. All these are expected to worsen significantly by the end of the 21st century. Further, the researchers noted that coastal storms and hurricanes will amplify the risk of flooding over land. With 1 metre of sea level rise, overland flooding will affect up to 50 per cent of residents in the region, impacting US\$770 billion in property

≁arnataka BJP president BY KVijayendra on Friday launched a blistering attack on the Siddaramaiah-led Congress government, accusing it of issuing controversial Waqf land notices to farmers and discontinuing central schemes to fund its poll guarantees.

In an interview to PTI, Vijayendra claimed growing dissent within Congress ranks, MLAs reportedly frustrated over frozen constituency development funds and the chief minister's leadership style.

"Siddaramaiah consistently blames the Centre to hide his administrative failures. The state's resources are poorly managed," the BJP state chief said, highlighting what he called a "desperate" situation in Karnataka's governance. He alleged that on one hand the ruling party is unable to

fulfil the poll guarantees, while on the other hand the development activities have come to a standstill across all 224 assembly constituencies as legislators are unable to secure grants for local projects, he said. "Out of 224 assembly constituencies, no MLAs are getting grants for development activities," the son of former chief minister of Karnataka B S

Yediyurappa claimed. The BJP chief particularly criticised recent policy decisions that he claimed hurt the poor, including hikes in milk prices, fuel costs, stamp duty, and a 20 percent increase in government hospital charges. "All these decisions of the Siddaramaiah government are affecting both the poor and farmers," he stated.

The comments by Viiavendra came even as BJP intensified its protests against notices issued to farmers under the Waqf law.

"We are holding dharnas across the state. Our senior leaders will tour Karnataka in December first week against this move," he said, adding, "In the name of Waqf, poor farmers should not be cheated and their land should not be taken away.'

He alleged that Siddaramaiah directed commissioners to issue notices farmers, triggering widespread protests.

Cars the main culprit

Delhi's residents continue to bear the brunt of the city's toxic air, which is mostly driven by cars and not stubble burning

nome November and the capital city of Delhi turns into a gas chamber with AQI shooting to severe category. Most often the farmers are blamed for burning stubble and winds taking the fumes to Delhi. But that is not the true picture. Delhi vehicles are the main culprit, as has been indicated by many studies. So nothing is done and till it is swept away by the wind, smog hangs over the city. This year is no different. Delhi's air pollution has escalated to catastrophic levels, with the Air Quality Index (AQI) frequently crossing into hazardous territory hovering in the vicinity of 500. This public health emergency has fueled political blame games between the State and Central Governments, with stubble burning by farmers in neighbouring states often cited as the primary cause. However, research and scientific studies tell a different story: the real culprit behind Delhi's toxic air is not stubble burning but the city's overwhelming vehicular emissions. Vehicular traffic is consistently identified as the leading source of pol-



lution in Delhi. A 2019 study by the Council on Energy, Environment and Water found that vehicles contributed between one-third and two-thirds of Delhi's harmful particulate matter. This alarming contribution is tied to the city's explosive growth in vehicle ownership. Between 1990 and 2018, the number of registered vehicles in the National Capital Region increased fivefold. Delhi alone accounts for over 11.8 million vehicles. 90 per cent of which are cars and two-wheelers. The volume of vehicular traffic has turned the capital into a pollution hotspot, with transport emissions driving air quality deterioration throughout the year. In contrast, stubble burning, often portrayed as the main

villain in Delhi's pollution narrative, plays a far smaller role. A 2017 study revealed that stubble burning contributed less than 3 per cent to Delhi's annual particulate matter. Even during its peak season from mid-October to early November, the share of pollution from crop residue burning is limited to 8 per cent, according to a 2023 report by the Centre for Science and Environment. Most of Delhi's pollution originates locally, with vehicular traffic contributing the largest share. This pattern becomes even more evident when air quality fails to improve after the stubble-burning season ends. Despite these findings, public discourse and policy responses disproportionately focus on stubble burning. This misplaced focus has real consequences. While interventions like subsidies for crop residue management have reduced farm fires, the overall air quality in Delhi remains dire because transport emissions and other local sources remain largely unaddressed. Addressing Delhi's air pollution crisis requires an urgent shift in priorities. Expanding and improving public transportation is crucial to reducing dependence on private vehicles. Cleaner fuels and technologies, such as electric vehicles, must be promoted alongside stringent enforcement of emission standards. Recognising this reality and acting accordingly is imperative. Until then, the capital's air will remain a health hazard.

Global concerns over gender bias in politics.



In the wake of Donald Trump's victory, a survey unveils deep concerns over the future of women's rights, reproductive autonomy and gender equality in the US

n the aftermath of Donald Trump's electoral victory for the second term, a prominent US daily conducted a survey among more than five thousand women voters for their reactions. A majority of them expressed concerns about the erosion of 'rights', and 'their reproductive future', and aired an array of emotions such as 'sadness,' 'scariness', 'disappointment, 'hurtfulness', 'betrayal' and 'heartbreaking'. Comments of some first-time voters also denoted despair, as many of them felt that their voices were 'more silenced than ever' and that they had been 'left empty-handed'. While a 36-year old woman rued that 'it is clear that men wanted to hold onto power... sexism won this election.

While, another leading US daily attributed Harris's defeat to her greater emphasis on issues like 'abortion rights' and the 'protection of democracy, and for not paying adequate attention to the state of the economy or immigration, which many Americans viewed as the most pressing issues. Harris, on the other hand, in her concession speech urged her supporters to 'remain vigilant' and keep fighting for their values. Nevertheless, many non-profits working for reproductive freedom urged Democrats to 'developing a long-term plan to directly confront the sexism - both within their party and the nation - that hampered, both Harris and Hillary Clinton, the only women to win a major party's presidential nomination. In the US, women occupied 28 per cent of congressional seats in 2023, while Democrats had an edge over the Republicans, with 41 per cent of seats, and Republicans with only 15.4 per cent of members.

Women are 32.7 per cent of all state legislators, 48 per cent of Democrats and 20 per cent of Republicans. Democratic women are at or above parity with Democratic men in 26 state legislatures. While Republican women fall short of parity with udiican men in ali states, holding one-third or less of al and systemic difficulties Republican seats in 47 state leg- (Raje, 2019), created women's islatures. Evidence also suggests that women's political careers are often influenced by 'family and relational considerations, and if they face higher costs for their career achievements, they shy away from pursuing such objectives. At the same time, other researchers pointed out voters' bias and discrimination which matter quantitatively in women's electoral prospects. Even political party leaders, act as gate-keepers, if they are aware of voters bias against women, and are inclined to promote male candidates, rather than female contenders, as a votes-maximising strategy

(Esteve-Volart and Bagues (2012). Nevertheless, data from the latest wave of the World Value Survey (2017-2020), in Western Europe found that less than 20 per cent of survey respondents express agreement with the statement 'Men make better political leaders than women do.

Now, what is the way out? The introduction of gender quotas in candidate lists in different countries like Sweden (Besley et al., 2017) is more or less effective in empowering women, and improving the 'quality' of the elected politicians, particularly by regulating the composition of candidate lists (Campa and Hauser, 2020). Many also suggested that a combined politico-economic strategy that emphasises women's inclusion in the labour market, and the re-distribution of economic roles within couples, could change gender-role attitudes and help women to make entry into positions of political power (Folke and Rickne, 2020 and Campa and Serafinelli, 2019). As the world remains deeply entrenched in patriarchal mindset, sexism and gendered divisions of labour, women's share as chief political executive is still outnumbered by

Manipur in turmoil: Unraveling the roots of violence



The State is caught in the throes of a complex conflict fueled by ethnic tensions, socio-economic disparities and narco-terrorism

anipur, one of the seven northeastern states of India, holds strategic importance due to its geographical location. It shares borders with Nagaland to the north, Mizoram to the south, Assam to the east, and Myanmar to the west.

Often referred to as the gateway to Southeast Asia, this state is home to diverse ethnic communities, including the Meiteis (approximately 53 per cent), Nagas (around 24 per cent) and Kuki-Chin-Zomi tribes (about 16 per cent). However, Manipur has recently experienced its worst violence in over a decade. More than a year of unrest has left over 226 people dead, more than 1,500 injured, and displaced over 60,000 residents. Understanding the root causes of this conflict requires examining several interconnected issues

(a) Demand for Scheduled Tribe (ST) Status

The spark for the current violence was a Manipur High Court directive urging the state government to consider granting the Meitei community Scheduled Tribe (ST) status. This decision was met with strong opposition from tribal land ownership laws.

Understanding the ST Status Debate:

Manipur is geographically divided into two main regions: The valley (10 per cent of the total area): Predominantly occupied by the Meitei community, it is more developed and politically influential, with Meiteis holding 40 out of 60 legislative Assembly seats. The hills (90 per cent of the total area): Primarily home to tribal communities, these areas lag behind in education, employment, infrastructure, and representation

While residents from the hills can migrate to the valley for opportunities, valley residents are restricted from purchasing land in the hills due to

The Meiteis fear that an increasing number of hill residents settling in the valley threatens their identity and culture. ST status for Meiteis would limit land purchases in the valley, potentially safeguarding their heritage.

On the other hand, the Kukis argue that Meiteis already dominate key sectors such as governance, education, and the economy. Granting them ST status, they claim, would exacerbate the marginalisation of hill tribes.

(b) Narco-Terrorism Manipur's proximity to the Golden Triangle and Golden Crescent has made it a hotspot for drug trafficking. Illegal poppy cultivation in the region is reportedly controlled by powerful drug lords, whose operations are threatened by government crackdowns. These drug lords, facing intensified enforcement efforts, have allegedly fueled violence by supplying arms and ammunition to militant groups, further destabilising the region. (c) Eviction of Encroachers Approximately 32 per cent of Manipur's forests are classified as protected under the Indian

Forest Act and Wildlife

Protection Encroachments by hill tribes and illegal immigrants for farming and settlements have led to significant deforestation. Recent government-led eviction drives have targeted encroachments, prompting accusations of anti-tribal bias and deepening tensions between the valley and hill communities.

Voices from the Hill Tribes Many people from the Kuki-Chin-Zomi communities claim to oppose violence, emphasising their peaceful protests against the High Court's order. They argue that militant groups responsible for the initial clashes do not represent their communi-

A Way Forward for Peace over half of the insurgencies in northeastern India are concentrated in Manipur, making its stability crucial. Fostering dialogue among all stakeholders, addressing grievances equitably, and ensuring inclusive development are essential steps toward lasting peace in the region.

G20: COPING WITH NEW REALITIES

G20 Summit's toned-down declarations on Ukraine, climate finance and West Asia

he recently concluded G20 summit in Brazil, could well serve as an early preview in what could be the realignment of global forces in the next year and beyond with the new incoming President of the USA. First, some major optics moments, such as the family picture for G20 leaders, which didn't have US President (of course some others were missing too). Second, winding down of several commitments from the Delhi declaration to just passing mention regarding the situation in Ukraine and climate finance. Third, the entire G20 summit is being riddled with speculation on whether the multilateral platform would survive a Trump presidency, and if so, with what effectiveness

The view in Washington DC is similar, especially in the government circles. Every government official, some of whom may have served under Trump's first presidency, is well aware of his working ways. The incoming administration has an additional extra non government supervisor, the world's richest person Elon Musk, who has his own unique style of functioning. Many in DC, understand that their, managers have one foot out of the door, and things would change, at least for the next four years post the inauguration on January 20. Trump's foreign policy outlook, if the past presidency is any reference, is likely to be transactional. Trump can parallel have public shouting matches and back door negotiations with friends and foes. He has already talked about ensuring long lasting peace in Ukraine, at a time, when under President Biden's patronage, US missiles are landing in Russian territory. Similarly, the proposal to impose higher tariffs on Chinese products, may sound sweet to

many, but knowing the sharp businessman Trump is, he may well cut a sweet deal with President Xi Jinping, which could potentially be of benefit to both nations. On India, Trump has called it out to be the tariff king and likely to make a case for imposing tariffs in reciprocal approach, for sectors where he thinks, US exports are getting impacted. India's chief economic advisor has already sounded out a cautionary note on incoming Trump presidency. He has been quoted as saying that with Trump administration's views on trade and tariffs, plus a slowing global economy, India may have to look beyond exports as the primary drivers of growth. India has taken several steps such as providing incentives for manufacturing in various sectors, but except for mobile phones, the growth has been slow. It would not be hard to assume that the sluggish offtake for India for manufacturing in sectors it has recently provided incentives, may well be on the slow lane for some years. What can however, change the game would be the transactional style Mr Trump has, which is well known not just to senior India ministers and bureaucrats but the PM Modi himself (who is known to share a warm relation-

Coming back to G20, while Delhi declarations had significant paragraphs on India promoted "not an era of war for Ukraine, the Rio De Janeiro declaration just mentioned, "Specifically concerning the war in Ukraine, while recalling our discussions in New Delhi, we highlight the human suffering and negative added impacts of the war with regard to global food and energy security, supply chains, macro-financial stability, inflation and growth." Clearly the world leaders didn't want to come out with any peace formulas, in face of President Trump assuming office next year. Similarly, the paragraph on West Asia focused on humanitarian aid, instead of taking either party's side. It read "While expressing our deep concern about the catastrophic humanitarian situation in the Gaza Strip and the escalation in Lebanon, we emphasize the urgent need to expand the flow of humanitarian assistance and to reinforce the protection of civilians and demand the lifting of all barriers to the provision of humanitarian assistance at scale.

Hope floats for Sri Lanka in Dissanayake



Dissanayake's unprecedented mandate in Sri Lanka's newly elected parliament presents a mix of hope and immense challenges in the quest to rebuild the nation

nura Kumara Dissanayake, Sri Lanka's newly elected President, has emerged victorious in the November 14, 2024 parliamentary elections, securing an unprecedented landslide victory that will undoubtedly reshape the nation's political landscape. Known for his Marxist leanings, Dissanayake and his National People's Power (NPP) coalition have shocked the political establishment by gaining significant traction in minority-dominated regions-undermin-ing the caste-driven politics that have long dominated the North, East and Central provinces. This triumph, achieved through a focused, strategic campaign, signals a bold rejection of the entrenched political elites and offers a forceful critique of Sri Lanka's frail democratic institutions. The magnitude of this victory speaks to a populace dis-illusioned by years of political stagnation and corruption.

After casting his vote, Dissanayake attended the 35th-anniversary commemoration of JVP founder Rohana Wijeweera, paying homage to the movement's resilience in the face of relentless oppression. Recounting its history of brutal suppression and bans, Dissanayake framed the JVP's struggle as an enduring fight for democracy, justice, and equality, despite decades of violence and persecution. "The history of our movement is one of unyielding resilience," he stated, honouring the sacrifices of fallen comrades. His rhetoric was one of defiance, and he emphasised that the JVP's ability to withstand adversity has kept its ideals intact.

Looking to the future, Dissanayake invoked the symbolism of "donning new garments," suggesting that the time has come to shed the old and embrace transformative change. The message was clear: Sri Lanka's political and economic systems are overdue for an overhaul, and his leadership intends to deliver just that. This moment represents more than a simple electoral win; it marks the dawn of a new political order, one rooted in the principles of progressive change and democratic service to the people.

The economic crisis that has ravaged the

nation since its 2022 bankruptcy and subsequent default on foreign debt, looms large over this electoral victory. While Dissanayake's rise reflects a demand for systemic change, it also places him at the epicenter of an economic storm, where recovery will require deep structural reforms. Yet, his victory cannot be divorced from the grim reality: Can a country reeling from financial collapse truly embark on the path to transformative change? The pressure to reform and recover is intense, both from within Sri Lanka and from international actors, and failure to meet these expectations could spell disaster.

Sri Lanka's long and tumultuous democratic journey provides critical context to this election. Since gaining independence in 1948, the country's democracy has been a paradox: simultaneously resilient and fragile, moving between progress and decline. Nationalist policies have repeatedly sidelined minority communities, with discriminatory measures like the Sinhala-Only Act of 1956 deepening ethnic divides. Successive governments,

often manipulated for political gain, have left a trail of unresolved grievances, and this fractured political landscape has stymied meaningful progress. Despite civil wars, uprisings, and systemic inequality, Sri Lanka's democracy has endured, offering fleeting moments of hope-only to be followed by setbacks and challenges that have hindered its progress. This backdrop of violence and division underscores NOT JUST A the difficulty in achieving a truly inclusive democracy.
In this historical context, Sri

Lanka managed to hold another parliamentary election, notable not for its violence but for the absence of it.

The Election Commission confirmed that the election was conducted freely and fairly-a rare glimmer of progress in a nation accustomed to electoral turmoil.The results, released on November 15, 2024, were nothing short of historic. Dissanayake's NPP secured 159 out of 225 seats, gaining a two-thirds majority, a feat unprecedented under Sri Lanka's proportional representation system. The NPP's 61.56 per cent share of the vote shattered records, surpassing the United People's Freedom Alliance's (UPFA) 2010 high. In a remarkable surge, the NPP

districts-again, setting new benchmarks. With 6.86 million votes, their victory represents a stunning political realignment, shifting from a meager 3 per cent in the previous election to an electoral force capable of rewriting the country's political script. In stark contrast, the main opposition party, the Samagi Jana Balawegaya (SJB), led by Sajith Premadasa, secured just 40 seats, a distant second. While the SJB's defeat is a blow to

the opposition, Premadasa's ability to hold the opposition leadership could provide an awkward but necessary check on the NPP's power, particularly given the inexperience of most of its members. Dissanayake's administration, already facing an inexperienced and fragmented legislative body, will have to navigate internal rifts while ensuring political stability. The introduction of anti-defection laws will likely be one of the first challenges on the

This election is not just a triumph of the NPP; it is a bellwether for Sri Lanka's future, revealing widespread disillusionment with traditional political parties, which are increasingly seen as inept and corrupt.

yet, the mandate for change is not without its contradictions. Voter secured 152 constituencies and 21 turnout plummeted to just 68.93

per cent, with over 5 million people abstaining from the vote. This decline in electoral participation is a sobering reminder of the disconnect between the electorate and the political system-a symptom of the deep distrust that persists in Sri Lanka's democratic framework. For the NPP, this poses both an opportunity and a challenge: Can it unite a fractured nation while addressing the systemic inequities that continue to stiffe its potentials

Dissanayake's sweeping victory provides him with the political leverage to pursue bold reforms, including the drafting of a new constitution, a task made possible by his overwhelming mandate. But his agenda is audacious: economic self-reliance, social equity, and fiscal discipline, all while addressing the deep-seated ethnic divides that have long plagued Sri Lanka. The NPP's ambition is to overhaul the nation's political and economic systems, but entrenched political factions will not surrender their power easily. Dissanayake's rise is a rejection of the old order-but whether he can truly dismantle it, or merely become another cog in its machinery, remains to be

Trump's re-election sparks climate policy shift: US at a crossroads amid global action

As the world shifts toward renewables, the US faces mounting pressure to balance its growth with environmental responsibility

ith the re-election of Donald Trump, the United States is poised to enter a critical period of climate policy retrenchment. Trump's policies promise increased fossil fuel production and the reversal of major clean energy investments, threatening global efforts to combat climate change.

Trump's proposed energy policies suggest a substantial setback for climate action. His administration aims to roll back the Inflation Reduction Act (IRA), which has allocated billions of dollars in tax credits for renewable energy projects and EV incentives, spurring substantial private sector investment. In 2024 alone, global clean energy spending hit \$2 trillion, dou-



ble the amount invested in fossil fuels. Yet, Trump's proposed policies could throttle US participation in this growth, reinforcing dependency on fossil fuels rather than joining the global trend toward clean energy, where renewables now constitute the most economical choice in many regions.

The implications of a second US withdrawal from the Paris Agreement-a prospect Trump

has not ruled out-are profound. When Trump first exited the Agreement in 2017, it allowed other nations to delay action under the guise of US non-participation. If Trump follows through again, it could stymie global climate funding negotiations, particularly for countries. Although the US has committed to contributing to a \$100 billion global fund for climate adaptation and mitigation, the administration's climate skepticism puts these financial obligations at risk. Without US leadership, experts fear slower progress on international agreements crucial to keeping global warming within the Í.5°C target.

Domestically, Trump's policies would deepen the US dependency on fossil fuels. His

administration's strategy emphasises maximising domestic oil and gas production, particularly from reserves Trump calls "liquid gold." However, the fossil fuel industry's employment numbers tell a different story: the US green economy supports over 10 million jobs compared to 300,000 in fossil fuel industries. The economic case for green energy is clear, yet Trump's vision includes reestablishing subsidies for oil, coal, and natural gas, effectively sidelining the renewable sector In 2023, electric vehicles comprised 18 per cent of global car sales, a significant jump from just 2 per cent five years prior. Yet, Trump has criticised electric vehicles and promised to impose tariffs on imported Chinese EVs, potentially rais-



ing prices and diminishing $\mathop{\rm EV}$ adoption in the US market. These policies might inhibit US competitiveness in EV manufacturing and battery technology, where other nations-especially China-have taken the lead. Another concerning proposal from Trump's allies involves dismantling federal programs that support climate research and environmental regulation. Plans under

defunding key agencies like the National Oceanic and Atmospheric Administration (NOAA) and scaling back the Environmental Protection Agency's greenhouse gas monitoring. Without federal support for climate research and mitigation, the US could lose critical insight into atmospheric changes. In a geopolitical context, Trump's re-election could weaken the US influence in global climate governance.

Given the US role in controlling financial institutions that facilitate climate finance, its withdrawal or failure to meet commitments could reduce climate funding, a key agenda item at the COP29 summit in Baku. As the world's largest historical emitter, the US has "Project 2025" advocate for a responsibility to lead by

example. Yet, with US emissions having only fallen 5 per cent since 1990-compared to the EU's 35 per cent reduction-the country's role as a climate leader is increasingly tenuous under Trump's leadership. Despite federal opposition, analysts believe that state governments, corporations, and financial markets will continue advancing climate action, albeit at a potentially slower pace.

Over the past decade, bipartisan support for renewable energy has increased, driven by iob creation and energy independence rather than environmental motives alone. With or without federal backing, the economic engine for clean energy remains robust, with new manufacturing plants and energy storage facilities rapid-

ly coming online, particularly in states that benefit from IRA-funded projects. Given that federal policy directly influences emissions standards, environmental regulations, and international commitments, the pace of progress could indeed slow, with repercussions for both the US economy and global climate goals. If Trump's policies take effect, is it likely that the US will fall even further behind on international climate standards? What risks will US industries face if they resist the global shift to cleaner energy, only to find themselves competing in a marketplace that increasingly penalises high-emission practices?

Many in Gaza eating once a day, as hunger spreads amid aid issues

Yasmin Eid coughs and covers her face, cooking a small pot of lentils over a fire fed with twigs and scrap paper in the tent she shares with her husband and four young daughters in the Gaza Strip. It was their only meal

Wednesday — it was all they could afford.

"My girls suck on their thumbs because of how hungry they are, and I pat their backs until they sleep," she said. After being displaced five

times, the Eids reside in central Gaza, where aid groups have relatively more access than in the north, which has been largely isolated and heavily destroyed since Israel began waging a renewed offensive against the militant group Hamas in early October. But nearly everyone in Gaza is going hungry these days. In the

For months, Yasmin and her family have gone to bed hungry. "Everything has increased in price, and we cannot buy anything," she said. "We always go to sleep without having dinner." She misses coffee, but

a single packet of Nescafe goes for around \$1.30. A kg (2 pounds) of onions goes for \$10, a medium bottle of cooking oil for \$15 — if available. Meat and chicken all but vanished from the markets months ago, but there are still some local vegetables. Such sums are astronomical in an impoverished territory where few people earn regular incomes.

Crowds of hundreds wait hours to get food from charities, which are also struggling. Hani Almadhoun, co-founder of the Gaza Soup Kitchen, said

his teams can offer only small bowls of rice or pasta once a day. He said they "can go to the market on one day and buy something for \$5, and then go back in the afternoon to find it doubled or tripled in price". Its kitchen in the central town of Zuweida operated on a daily budget of around \$500 for much of the war. When the

amount of aid entering Gaza in November. Around 500 plummeted in October, its trucks entered each day before plummeted in October, its costs climbed to around \$1,300 a day. It can feed about half of the 1,000 families who line up each day.

THE SHARP DECLINE IN AID, AND US ULTIMATUM

Israel says it places no limits on the amount of aid entering Gaza and has announced a number of measures it says are aimed at increasing the flow in recent weeks, including the opening of a new crossing. It blames UN agencies for not retrieving it, pointing to hundreds of truckloads languishing on the Gaza side of the border. But the military's own figures show that the amount of aid entering Gaza plunged to around 1,800 trucks in October, down from over 4,200 the previous month. At the current rate of entry, around 2,400 trucks would come into Gaza

The UN says less than half the truckloads are actually distributed because of ongoing fighting, Israeli denial of movement requests, and the breakdown of law and order. Hamas-run police have vanished from many areas after being targeted by Israeli airstrikes.

The war started Oct 7, 2023. when Hamas-led fighters stormed into Israel, killing some 1,200 people, mostly civilians, and abducting around 250. Around 100 hostages are still inside Gaza, at least a third of whom are dead, and Hamas militants have repeatedly regrouped after Israeli operations, carrying out hit-andrun attacks from tunnels and bombed-out buildings.

Israel's retaliatory offensive has killed over 44,000 Palestinians, more than half of them women

and children, according to local health authorities, who do not say how many of the dead were fighters.

The United States warned Israel in October that it might be forced to curtail some of its crucial military support if Israel did not rapidly ramp up the amount of aid entering Gaza. But after the 30-day ultimatum expired, the Biden administration declined to take any action, saying there had been some progress. Israel meanwhile passed legislation severing ties with UNRWA. Israel accuses the agency of allowing itself to be infiltrated by Hamas allegations denied by the UN. Israeli news outlets have reported that officials are considering plans for the military to take over aid distribution or contract it out to private security companies. Asked about such plans Wednesday, government spokesman David Mercer said

"Israel is looking at many creative solutions to ensure a better future for Gaza".

Yoav Gallant, the former defence minister who was seen as a voice of moderation in the far-right government before being fired this month, warned on X that handing over aid distribution to a private firm was a "euphemism for the begin-

ning of military rule". As that debate plays out in Jerusalem, less than 100 km (60 miles) away from central Gaza, most Palestinians in the territory are focused on staying alive in a war with no end in

"I find it difficult to talk about the suffering we are experiencing. I am ashamed to talk about it," said Yasmin's husband, Hani. "What can I tell you? I'm a person who has 21 family members and is unable to provide them with a bag of

UN reports heavy clashes in Lebanon

Israeli troops fought fierce battles with Hezbollah fighters on Friday in different areas in south Lebanon, including a coastal town that is home to the headquarters of UN peacekeepers.

A spokesman for the UN peacekeeping force known as UNIFIL told The Associated Press that they are monitoring "heavy clashes" in the coastal town of Naqoura and the village of Chamaa to the northeast. UNIFIL's headquarters are located in Naqoura in Lebanon's southern edge close to the border with Israel "We are aware of heavy shelling

in the vicinity of our bases, UNIFIL spokesman Andrea Tenenti said. Asked if the peacekeepers and staff at the headquarters are safe, Tenenti said: "Yes for the moment." Several UNIFIL posts have been hit since Israel began its Öctober 1, leaving a number of

peacekeepers wounded. The fighting came a day after the International Criminal Court issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu, his former defence minister and a Hamas military leader, accusing them of war crimes and crimes against humanity over their 13-month war in Gaza and the October 2023 attack on Israel respectively.

The warrant marked the first time that a sitting leader of a major Western ally has been accused of war crimes and crimes against humanity by a global court of justice.

Israel's war has caused heavy destruction across Gaza, decimated parts of the territory and driven almost the entire population of 2.3 million people from their homes, leaving most dependent on aid to survive. Israel launched its war in Gaza

The ICC last year issued an arrest warrant for Russian President Vladimir Putin and a number of other top Russian officials, accusing them of war

Moscow's eyes they're "null and void". Asked if the ICC warrants for Netanyahu and others can help resolve the tensions in the Middle East, Peskov said: "Well, in general, the actions of the ICC are unlikely to help anything. That's the first thing. And secondly, we don't see any point in commenting on this in any way, because for us these

Hungary PM vows to disregard int'l arrest warrant for Netanyahu

Hungarian Prime Minister Viktor Orban on Friday denounced the International Criminal Court's issuing of an arrest warrant for Israeli Prime Minister Benjamin Netanyahu, saying he would defy it by inviting him to Hungary.

accused International Criminal Court (ICC), the world's top war crimes court based in The Hague, of "interfering in an ongoing conflict for political purposes," saying the decision to issue the warrant for Netanyahu over his conduct of the war in Gaza undermined international law and escalated tensions.

Member countries of the ICC. such as Hungary, are required to detain suspects facing a warrant if they set foot on their soil, but the court has no way to enforce that.

The ICC issued the arrest warrant on Thursday for Netanyahu as well as for his former defence minister and Hamas' military chief, accusing them of crimes against humanity in connection with the 13month war in Gaza.

The warrants said there was reason to believe Netanyahu and former Defense Minister Yoav Gallant used "starvation as a method of warfare" by restricting humanitarian aid



and intentionally targeted civilians in Israel's campaign against Hamas in Gaza — charges Israeli officials deny. In his comments Friday, Orban, a close Netanyahu ally, called the arrest warrant "outrageously impudent" and "cynical." He said he would invite Netanyahu to Hungary later Friday and vowed to disregard the warrant if the invitation is accepted. 'We will defy this decision, and

it will have no consequences for him," Orban said. Hungarian Foreign Minister Peter Szijjarto earlier criticised the ICC's warrant as "absurd." Israel and its top ally, the

United States, are not members of the court. But other Israeli allies, including some of its close European friends, are put in an awkward position by the warrants.

Several, including France, welcomed the court's decision and signaled they might arrest Netanyahu if he visited

White House press secretary Karine Jean-Pierre said President Ioe Biden's administration was "deeply concerned by the prosecutor's rush to seek arrest warrants and the troubling process errors that led to this decision.

Netanyahu on Friday praised Hungary for its stance on the warrant, saying in a statement: 'Against the shameful weakness of those who stood by the outrageous decision against the right of the State of Israel to defend itself, Hungary — like our friends in the United States is displaying moral clarity and standing by justice and truth." The action by the ICC came as the death toll from Israel's campaign in Gaza passed 44,000, according to local health authorities, who ay more than half of those killed were women and children. Their count does not differentiate between civilians and

combatants.

Trump nominates Bondi as his next Attorney Gen after Gaetz's withdrawal

Washington (PTI): Presidentelect Donald Trump has selected Florida Attorney General Pam Bondi as his nominee for Attorney General, hours after his initial pick Matt Gaetz withdrew his name amid controversy over alleged sexual misconduct.

A second Australian teenager who fell critically ill after drinking tainted alcohol in Laos has died in a hospital in Bangkok, her family said Friday, bringing the death toll in the mass poisoning of foreign tourists to six.

An officer at Vang Vieng's Tourism Police office, who refused to give his name, told The Associated Press on Friday that a "number of people" had been detained in the case but that no charges have yet been filed. Staff at the Nana Backpacker Hostel, which was still operating but not accepting new guests, confirmed that the manager and owner were among those taken in for questioning.

Tourist police offices are common in Southeast Asia and are set up specifically to help with incidents involving tourists and other foreigners

The US State Department on Friday issued a health alert for citizens traveling in Laos, warning of "suspected methanol poisoning in Vang Vieng, possibly through the consumption of methanol-laced alcoholic drinks," following similar alerts from other countries whose citizens were involved.

chancellor". He said that "Olaf Scholz is a strong chancellor and he is the right candidate for chancellor".Pistorius' announcement

resolves the question of who will run in the election expected on Feb 23, but a week of very public arguments is widely viewed as having damaged a party that was already far behind the main opposition centre-right Union bloc in polls. Rather than building momen-

tum from Scholz's firing of his finance minister two weeks ago, which put an end to his unpopular three-party coalition, party members have aired public doubts about the chancellor. The Social Democrats' rivals have already determined who will lead their campaigns. The Union nominated Friedrich Merz as its challenger in September. Scholz's remaining coalition partners,

the Greens, named Vice Chancellor Robert Habeck to head their challenge on Sunday. While Scholz has made clear for months that he intends to run for a second term and his party's leadership had made clear that it backed him, the lack of a formal nomination so far created space for persistent speculation that the party might instead choose Pistorius who enjoys much higher popularity.On Monday, two influential lawmakers said Scholz's 'current standing is strongly linked" with the failed coalition, which collapsed in a dispute about how to revive Germany's stagnant economy, and that they were hearing a lot compliments Pistorius.

In this regard, in February 2023, the Union Cabinet approved the establishment of 2 lakh PACS, dairy, and fisheries cooperatives over the next five years. To ensure timely implementation monitoring of the plan, the Home and Cooperation

Minister launched a Standard Operating Procedure (SOP) guide. According to the plan, NABARD will establish approximately 70,000 new multi-purpose PACS (M-PACS), NDDB will form and strengthen around 1,03,000 dairy cooperative societies (DCS), and the National Fisheries Development Board (NFDB) will establish approximately 11,500 fisheries societies cooperative (FCS). Additionally, governments will set up

around 25,000 new M-PACS, dairy, and fisheries cooperatives. In the last six decades, through

the collaborative efforts of

NDDB and the state and central governments, approximately 1.44 lakh active dairy cooperatives have been established across the country. Now, under the "White Revolution 2.0" initiative, there is a plan to form 1.03 lakh new multi-purpose cooperative societies (M-DCS) and empower existing ones

over the next five years. This will be a significant achievement and will take milk production and distribution in the country to new heights. Multi-purpose PACS (M-PACS) are emerging as commercial hubs. By adopting new model bylaws, these societies are now conducting over 25 different business activities, including dairy. Three national-level multi-

state cooperatives have been established to link grassrootslevel cooperatives to national and international value chains: 1. National Cooperative Organics Limited (NCOL) 2. Bhartiya Beej Sahakari Samiti Limited (BBSSL) 3. National Cooperative Export Limited These initiatives represent a

revolutionary step in the history of India's cooperative movement. They aim to connect local cooperatives with broader markets, enhance their capabilities, and open new avenues for growth. country. The National Cooperative Organics Limited (NCOL) aims to realize the potential of organic products and create a healthy agricultural ecosystem. Meanwhile, National Cooperative Export Limited (NCEL) works to enhance cooperative trade and promote Indian products globally.

NDDB is the main promoter of NCOL. The establishment of NCOL aligns with the government's "Whole of the Government Approach, which involves collaboration with relevant ministries, departments, and agencies. NCOL operates comprehensive organization the collection, procurement, certification, testing, branding, processing, storage, and marketing of organic products.

Similarly, to improve crop yields and develop a system for conservation and promotion of indigenous natural seeds, BBSSL has been established to produce procure, and distribute quality seeds under a single brand through the network of cooperatives. BBSSL will help increase the production of quality seeds in India through

cooperatives. To create a global identity for domestic products, NCEL has been established as an umbrella organization to facilitate exports for the entire cooperative sector of the country. This committee will promote cooperative efforts in agriculture, horticulture, dairy, poultry, livestock, fisheries sugar, spices, organic products, fertilizers, and more.

Cooperative institutions have

built a strong infrastructure in the country. By better coordination and utilization of these resources, the collective impact can be further enhanced. To increase the income of member farmers, cooperatives will need to adopt new strategies. The indictment of Adani I Group's founder Gautam Adani by US prosecutors could renew questions over ports-to-energy conglomerate's governance practices and damage its reputation, S&P Global Ratings said Friday.

US prosecutors have charged Adani and seven others including his nephew Sagar, with agreeing to pay about USD 265 million in bribes to Indian government officials to obtain favourable terms for a solar power supply contract. Adani Group has denied all charges, calling them "baseless", and said it would seek "all possible legal recourse".

"The allegations could renew questions over the group's governance practices and damage its reputation. We will watch for any signs of weaker funding access or

lenders -- which could be demonstrated by the lowering of funding limits, non-renewal of facilities, or significantly higher credit spreads," S&P Ratings said in

After the news of the indictment broke, equity and bond prices across Adani group companies have fallen sharply. The group has cancelled a USD 600 million concluded bond sale.





Jannik Sinner leads Italy back to the Davis Cup semifinals

No. 1-ranked Jannik Sinner won matches in singles and doubles to lead defending champion Italy to a 2-1 comeback victory over Argentina, earning a return trip to the Davis Cup semifinals.

"I'm here trying to do the best I can in the singles," Sinner said on Thursday.

"If they put me on the court in doubles, I'll also try my best." On Saturday, Italy will face Australia in a rematch of last vear's final, but this time it will only be for a chance to play for the championship. Australia eliminated the U.S. 2-1 earlier Thursday to reach the final four at the team competition for the third consecutive year.

The other semifinal, to be contested Friday, is the Netherlands against Germany. The Dutch got past Rafael Nadal and Spain in the quarterfinals earlier in the week, sending the 22-time Grand Slam champion into retirement. Italy fell behind 1-0 in the quarterfinals when Argentina's Francisco Cerúndolo defeated Lorenzo Musetti 6-4, 6-1 on an indoor hard court at the Palacio de

Deportes Jose Maria Martina Carpena in southern Spain. But then in stepped Sinner, whose season already includes two Grand Slam trophies — at the Australian Open and U.S. Open — plus the title at the ATP Finals last weekend in Turin, Italy. First he overwhelmed Sebastián Báez 6-2, 6-1. Then Sinner teamed with Wimbledon runner-up Matteo Berrettini in the

deciding doubles match to win 6-4, 7-5 against Andres Molteni Gonzalez. "He carried me today," Sinner

said about Berrettini. After arriving late to Malaga from Turin, Sinner did not get a

chance to practice on the Davis Cup competition court before taking on Báez and stretching his streak to 22 sets won in a row.

"In three minutes, he was perfectly comfortable on court," Italy captain Filippo Volandri said. "He's a special

Volandri swapped out his original doubles team, Simone Bolelli and Andrea Vavassori, for Sinner and Berrettini, and the change paid dividends. Australia, the Davis Cup runner-up the last two years, advanced when Matt Ebden and Jordan Thompson beat the surprise, last-minute American pairing of Ben Shelton and Tommy Paul 6-4, 6-4 in that quarterfinal's deciding

doubles match. The Shelton-Paul substitution for Paris Olympics silver medalists Austin Krajicek and Rajeev Ram was announced about 15 minutes before the doubles match began. Ebden and John Peers beat Krajicek and Ram in the Summer Games final in August.

The Australians broke once in each set of the doubles. In the second, they stole one of Shelton's service games on the fourth break opportunity when Ebden's overhead smash made it 5-4. Thompson then served out the victory, closing it with a service winner before chestbumping Ebden.

21st-ranked Shelton made his Davis Cup debut earlier Thursday in singles against 77th-ranked Thanasi Kokkinakis, who emerged from a tight-as-can-be tiebreaker by saving four match points and eventually converting his seventh to win 6-1, 4-6, 7-6 (14). No. 4 Taylor

Cricket Australia to pay tribute to late Phillip Hughes on 10th death anniversary

Australia has planned a series of initiatives to mark the 10th anniversary of the tragic death of Phillip Hughes including a tribute before the start of the second Test between India and Australia at the Adelaide Oval scheduled from Decem oer 6-10

CA will also honour the late Australian cricketer during the upcoming three Sheffield Shield games, as players will wear black armbands and flags will fly at half-mast.

A promising left-hander who played 26 Tests, Hughes lost his life just days before his 26th birthday in 2014 after being struck by a bouncer during a domestic match. South Representing

Australia, Hughes was hit on an unprotected area below his left ear while attempting a hook shot against Sean Abbott at the SCG. Despite wearing a helmet, the impact proved fatal.

We understand this will be a time of reflection for the many people who knew and admired Phillip Hughes," Cricket Australia (CA) CEO Nick Hockley said on Friday. "We wanted to ensure that Hughes family, particularly,

comfortable with commemorations and that we celebrate Phillip's life and incredible achievements

appropriately," he added.
The home association, which has produced a special documentary on him, will broadcast it ahead of the second Test, as part of a twoweek commemoration

A moment's silence will also be observed before play on day four of all matches.

Batting on 63, Hughes collapsed before receiving mouth-to-mouth resuscitation and was subsequently taken to St Vincent's Hospital, Sydney, where he underwent surgery and was placed in an induced

Hughes, however, could not recover from the blow and died on November 27. The left-hander was viewed as one of the promising Australian cricketers as the team went through a transitional phase.

In the Australia-India Adelaide Test that followed his death a decade ago, the southpaw was named as the home team's 13th player with 63 (the score he was batting at in his last match) seconds of applause observed ahead of the game.

Australia's senior pacer Mitchell Starc on Friday played down the chatter around India batter KL Rahul's contentious caught behind dismissal on the first day of the opening Test here, saying it was a "regulation wicket". Rahul's dismissal kicked up a
