Sebi abolishes 1% Security deposit

Markets regulator Sebi on Thursday abolished the requirement of a mandatory security deposit with the exchanges before a public issue in a bid to facilitate ease of doing business for issuer companies. The move will be applicable with immediate effect, the Securities and Exchange Board of India (Sebi) said in a circular. Before this, any company that is looking to launch a public issue of equity shares has to deposit with the stock exchanges an amount equal to 1 per cent of the issue size. The deposit was .

Rs 1,750 cr: Adani's bribe to Jagan for solar power deal?

In a significant legal development, the US Securities and Exchange Commission (USSEC) has indicted billionaire industrialist Gautam Adani for allegedly paying ₹1,750 crore to former Andhra Pradesh Chief Minister Y.S. Jagan Mohan Reddy. The payment was purportedly made to influence State electricity distribution companies (DISCOMs) to sign a deal to procure 7 GW of solar power from the Solar Energy Corporation of India (SECI) under a manufactur-

ing-linked project.

Court documents filed in New York referred to "Foreign Official #1" as a high-ranking figure from Andhra Pradesh who held office between May 2019 and June 2024. Although the fling did not explicitly name Jagan Mohan Reddy it alleged that Gautam Mohan Reddy, it alleged that Gautam Adani met the official multiple times in 2021 to finalise power sale agreements (PSAs) between SECI and the State's DISCOMs.

The court papers further revealed that Gautam Adani, along with his nephew Sagar Adani, Vineet Jain, and others, had promised bribes totalling ₹2,029 crore (approximately \$265 million) to Indian officials. Of this amount, Jagan Mohan Reddy alleged-

On Wednesday, US prosecutors in New York formally charged Gautam Adani, Sagar Adani, and six others, including Vineet Jain, CEO of Adani Green Energy, and former Azure Power executives, for offering bribes to Indian officials to secure lucrative solar energy contracts.



Clinging like a leech, a gang of usurious moneylenders are fleecing not only the poor but also the business people in the district. They are allegedly extorting excess interest rates and engaging in rampant exploitation. People, including the poor and common workers, are getting caught in the jaws of loan sharks. The victims are struggling to pay back the loans. Unable to repay the excessive interest, they are facing severe

In the united Adilabad district, some moneylenders are operating under the guise of finance companies, charging high interest rates on loans given to innocent people. In the agency areas of Adilabad district, like Utnoor and Ichoda towns, they have even put up boards with the names of different finance companies. They are going to tribal villages and collecting high interest. They do not hesitate to resort to violence if the money is not paid on time. Despite all this, the

concerned authorities are turning a blind eye.

Moneylenders are causing trouble for the borrowers who have paid back their loans on time by demanding monthly interest. If the loan is not paid, not only the borrowers but also their family members are being harassed. These moneylenders are even threatening to harass the women and parade them on the streets as a punishment for not repaying the loans. They threaten to kidnap and kill them, and even warn that they will abduct young girls from the house. Those who are unable to

repay their loans are at a loss for what to do, and are going through severe emotional turmoil. Unable to bear the harassment of the moneylenders, many are resorting to suicide. Recently, in Nirmal district, a person was beaten up by moneylenders for not paying back the money.

A family from Nizamabad recently committed suicide by jumping into the Godavari River at Basara in Nirmal district. An auto driver in the Bhains mandal committed suicide due to the pressure from moneylenders. Many such tragic incidents have occurred, with sensitive individuals unable to endure the harassment of moneylenders, leading them to take their own lives.

Some white-collar professionals, who evade taxes and work in various government sectors, are routing their black money through the moneylending business. They provide loans to ordinary people at high interest rates. If the borrowers use the loan for business and succeed, they earn enough to pay off their debts. But if the company fails, they are unable to repay the loans and are subjected to severe harassment, leading to a loss of dignity in society, and many tragically end their lives. Moneylenders are spreading their tentacles across both towns and villages. They lend money at interest rates ranging from 5 to 15 per cent, and some even offer loans at 20 per cent interest rates. Despite the high rates, innocent people are taking loans without understanding the consequences and eventually find themselves in deep trouble, some resorting to suicide.



Common people hit hard by rising prices

The pices of essential commodities has surged significantly, putting immense pressure on middle and lower-middle-class, besides the poor families. They are now forced to cut back on their purchases. With wages remaining stagnant, the rising prices of staples like rice, pulses, vegetables, and edible oils have left many strug-

gling to balance their budgets. Key items like vegetables have seen sharp price hikes, contributing to a growing inflationary trend. For instance, the price of tomatoes soared to Rs 100 per kilogram last month, while garlic was being sold at an eye-watering Rs 350 per kilogram. Though tomato prices have slightly eased, garlic continues to remain prohibitively expensive.

Similarly, the cost of other staples, such as potatoes and onions—used widely across households—has also

surged.
Compared to last year, edible oil prices have gone up by 20 to 30 per cent, exacerbated by reports of traders creating artificial scarcity during festival seasons to inflate

The situation is particularly challenging for middle-class families, where it has become increasingly difficult to manage household expenses unless both spouses are working. In many cases, the same products are being sold at different prices, with a variation of Rs 5 to Rs 10 between shows in the same town. The absence shops in the same town. The absence of price lists at Rytu Bazaars and retail outlets further adds to the confusion. The price regulation committee, which is supposed to meet quarterly to monitor prices, has reportedly not been active in its reviews.

À closer look at the price changes over the past year reveals startling

Toor dal: Rs 160 per kg, (up from Rs 130), moong dal Rs 120 per kg (up from Rs 90), groundnut Rs 120 per kg (up from Rs 90), ginger Rs 100 per kg (up from Rs 60), Garlic Rs 350 per kg (up from Rs 150), potatoes Rs 50 per kg (up from Rs 25), etc.

These dramatic price increases are making it increasingly difficult for households to stretch their budgets, particularly when salaries have remained unchanged, and inflation continues to eat into purchasing

Residential schools lack basic facilities

Students are often hailed as the future of the country, playing a crucial role in nation-building. However, this idealistic view can ring hollow when the reality they face is far from what they deserve. The students are raising the issue time and again.

It is alleged that in residential schools, students are raising serious concerns about their living conditions. Many of them are forced to bathe with cold water from open sources, even in the winter, and are deprived of basic amenities such as bathrooms with

Their ability to have a full meal is compromised, and their grievances remain ignored. Worse still, these students have no means to share their struggles with anyone in authority.

At a minority social welfare school in town, students are accusing the school of serving rotten vegetables and rice infested with worms. Despite the onset of winter, they continue to endure the discomfort of cold water for bathing. The lack of privacy in bathrooms

without doors, especially for girls, is food.

a constant source of distress. Promises of funding for repairs to essential facilschool buildings have been made but remain unfulfilled, deepening the students' frustration.

This situation is also raising concerns among the parents, who are beginning to question whether the government's commitment to education is sincere.

Despite the repeated appeals to the school principal and government officials, the issues persist without reso-

The government's claims of prioritizing education seem empty, and suspicions are growing about the proper use of funds allocated for the development of school facilities.

There is increasing doubt that resources are being mismanaged by contractors. In light of these ongoing issues, students are urging district minister Ponnam Prabhakar to take urgent action to improve the school's facilities, ensure students receive proper meals, and hold accountable the principal, warden, and the contractor responsible for the substandard

Food poisoning incident: Axe falls on headmaster, MEO

Taking serious view of 50 students of Manganoor Zilla Parishad School taking ill after district, the school headmaster Muralidhar Reddy, incharge headmaster Bapu Reddy and mid-day meal in-

eating mid-day meal at in the charge were placed under suspension. The services of the agency which provided midday meals were terminated.

On Wednesday, in the dis-

trict headquarters school in Maganoor mandal in Narayanpeta district, not less than 50 students fell ill after consuming the midday meal. Following the instructions of Chief Minister Revanth Reddy, an inquiry was ordered, and the Mandal Education Officer and the headmaster were suspended. Orders were also issued to cancel the midday meal agency. District Collector Sikta

Patnaik, who is inquiring into the incident, visited the the school in Maganoor mandal Thursday. She inspected the school kitchen and store rooms, checked the rice being provided to the students, and questioned Education Department officials and local villagers.

During this inspection, the District Collector stated that she is terminating the services of the midday meal agency and the formation of a mess committee in every school in the district. This committee will have one or two teachers who will be responsible for ensuring the quality of food by tasting it before serving it to Meanwhile, students from

School, who have been admitted to the Government General Hospital Mahabubnagar after they took ill due to suspected food poisoning, complained that they served breakfast that was infested with worms.

Maganoor Zilla Parishad High

Videos showing the students complaining about the worm-infested food from their hospital beds quickly went viral on social media platforms

Although the hospital management attempted to downplay the incident, the news soon spread. When a few BRS leaders visited the hospital, police tried to stop them, leading to arguments.

Former Minister V Srinivas Goud visited the hospital to speak with the students. Addressing the media, he strongly condemned the incident, pointing out that students who had been admitted due to food poisoning were then served stale and worminfested food.

"I personally spoke with the students and nurses on duty. They confirmed that worms were found in the upma (semolina breakfast dish) and other dishes, and the nurses told me that the food was quickly discarded in the trash bins," said Srinivas Goud.

He further questioned how the government could mishandle the situation when the students' health was already compromised. "If anything more serious were to happen, who will be held responsible, and who will answer to the parents of these students?" he asked.

Centre announces staggered work timings for employees

The Centre on Thursday announced staggered working timings for its employees in view of the severe air pollution in Delhi, according to an order issued by the Union personnel ministry. Employees have also been asked to pool vehicles and use public transport to minimise vehicular pollution.

These measures may be adopted by ministries/departments/organisations as per their functional requirements ensuring that it should not have an adverse impact on efficiency and productivity in any manner," the order read.

Given the severe-plus air pollution levels in Delhi, various ministries, departments and organisations of the central government are advised to adopt staggered timing in respect of offices located in the Delhi-National Capital Region,

it said. The order said offices can be open from 9 am to 5.30 pm and 10 am to 6.30 pm.
"The officers/staff using per-

sonal vehicles should be encouraged to pool vehicles and to use public transport to minimise the vehicular pollution," it added.

After a week of 'severe' pollution levels, Delhi's air quality has improved slightly but is still in the 'very poor' zone.

At 9 am on Thursday, the national capital recorded an Air Quality Index (AQI) of 376, according to the Central Pollution Control Board (CPCB).

The move assumes significance as a body representing the Central Secretariat Service (CSS) officers had on November 18 demanded work-from-home, staggered working hours and air purifiers in all office buildings to mitigate the health impact of the severe pollution levels.

Mending fences with China

Faced with a slowing economy and increasing geopolitical challenges, Beijing seems eager to seek a thaw with India

n a notable shift, the Chinese government has signalled its intent to recalibrate its ties with India following a series of disengagement measures along their disputed border. The thaw reflects both strategic considerations and economic imperatives as Beijing grapples with slowing economic growth and rising geopolitical challenges. After years of strained relations exacerbated by the 2020 Galwan Valley clash, which resulted in casualties on both sides, the disengagement at friction points offers a moment to 'look into the future.' Chinese officials and business leaders have expressed optimism about a potential reset in ties, framing peace and stability as prerequisites for deeper bilateral engagement. China's economy has been under pressure from multiple fronts: sluggish growth, weakening consumer demand and the looming threat of escalating tariffs from the United States under Donald Trump's proposed policies. Beijing has already announced two rounds of monetary and fiscal stimulus packages, with a third expect-



ed soon, aiming to rejuvenate its domestic economy and strengthen trade ties with key partners like India. India, with its vast middle-class market and growing manufacturing sector, represents an attractive prospect for Chinese businesses.

Despite a persistent trade imbalance—India's imports from China stood at \$99.59 billion in 2023, dwarfing its exports of \$16.23 billion—there is scope for collaboration. Chinese businesses see opportunities in India's pharmaceuticals, services and burgeoning electric vehicle market. China's business leaders and scholars have called for a pragmatic approach that separates border issues from economic and cultural ties.

Influential figures in China's economic hubs—Beijing, Shanghai and Shenzhen—have emphasised the benefits of collaboration. Companies like Shanghai Pharmaceuticals and carmaker BYD have expressed interest in leveraging the Indian market, highlighting areas like healthcare and electric vehicles as promising fields for cooperation. While Beijing appears eager to reset relations, New Delhi's emphasis on resolving border disputes as a precondition for normalisation remains a sticking point. India is likely to continue leveraging its trade policies to address the trade deficit and ensure balanced economic ties. Additionally, mutual trust needs rebuilding after years of diplomatic and military standoffs. Indeed, the disengagement along the border is a significant step toward restoring confidence between the two nations. If both sides prioritise dialogue and economic cooperation, the thaw could lead to a more stable and mutually beneficial relationship. China's acknowledgment of India's potential as a key trade and investment partner, coupled with India's focus on reducing its trade deficit and securing fair access to Chinese markets, could lay the foundation for a new era in Sino-Indian relations. Whatever the reasons behind China's willingness to engage in dialogue, this is an opportunity that must be

Congress party's political opportunism

he relationship between the Congress Party and the Adani Group is a masterclass in political hypocrisy. Three quarters of sewage from the northern plains is discharged into the Ganga without treatment. The Central Pollution Control Board states that BOD levels should be less than 3 mg per litre for bathing, but in the Ganges, BOD levels can be up to 6.4 mg

per litre. Therefore, swimming in the river, which has high levels of harmful bacteria and toxic chemicals, can increase the chance of developing diseases like viral fever, nausea, typhoid, hepatitis, gastroenteritis and so on. The Ganga Action Plan was launched in 1985 with the aim of improving water quality through interception, diversion and treatment of domestic sewage and to prevent toxic and industrial chemical wastes from identified polluting units from entering the Ganga should be strictly implemented. he cell rang and dropped from her hands. There was an agonising silence across continents. Her only son in the US, a brilliant student, committed suicide. Bill Maher writes, "Suicide is man's way of telling God: You can't fire me, I quit." But do brave men commit suicide? It appears to be a permanent solution to a transitory problem. Marcus Trescothick and Chetan Sharma come to mind. The former suffered from xenophobia in the subcontinent and Chetan Sharma after being hit for that last ball six at Sharjah by Javed Miandad lost his mojo and rhythm.

Fear, anxiety, emotional upheavals, unpleasant feelings, panic attacks and phobias are all symptomatic of a fragile and delicate mind. A fragmented mind is invariably a victim of irrational fear. Dedicated bank for MSMEs to boost credit access



This new initiative seeks to bridge that gap and stimulate job creation and economic activity by providing MSMEs with the financial support they desperately need

he government plans to establish a dedicated bank to lend directly to Micro, Small and Medium Enterprises (MSMEs) to enhance credit availability in this crucial sector. The industry has called for increased financial support, as current institutions like the Small Industries Development Bank of India (SIDBI) primarily focus on refinancing loans rather than providing direct funding. In contrast, state financial and industrial development corporations do lend directly to MSMEs.

However, many, such as the Punjab State Industrial Development Corporation (PSIDC) and Punjab Finance Corporation (PFC), are experiencing funds crunch and have stopped credit flow. PSIDC gathered liabilities worth Rs 4700 crore, therefore, has not given any fresh loans to any company for the last 16 years. According to an Ernst&Young(EY) report, MSME credit penetration in India is only 14 per cent, significantly lower than in larger economies like the US and China, where the figures are 50 per cent and 37 per cent, respectively. Indian MSMEs face a critical credit shortage of? 25 trillion, indicating a substantial untapped credit market. Increasing lending to MSMEs can stimulate economic activity and create jobs. The proposed establishment of a separate bank dedicated to the MSME sector would help address these direct credit shortages. However, the government needs to finalise various details, such as the bank's ownership structure, which may adopt a hybrid public-private partnership model. Although large banks operate in the sector, they often struggle to meet the unique needs of MSMEs.

Countries in Europe provide valuable lessons by grouping MSMEs with home loan customers, both considered small borrowers. If the government does not establish a new bank, SIDBI could be transformed into a full-fledged bank focused on direct lending to MSMEs instead of merely refinancing. SIDBI plays a vital role in financing India's MSMEs and is owned by a consortium that includes the government and major financial institutions. In 2023-24, the National Bank for Agriculture and Rural Development (NABĂRD) supported the agricultural sector with a loan portfolio of Rs 6.68 lakh crore, with the agriculture CREATE JOBS.THE tribute significantly to exports and sector contributing 18 per cent to the country's GDP. On the other hand, SIDBI had a refinancing loan portfolio of? 84,000 crore in FY 2023-24, with the MSME sector contributing 30 per cent to the GDP.For micro and small enterprises to grow, obtaining capital remains one of their most significant challenges.

The Reserve Bank of India (RBI) has designated MSMEs as a priority sector and directed banks to allocate 40 per cent of the Adjusted Net Bank Credit (ANBC) to priority sectors, including MSMEs. However, a study by the RBI has found that most banks do not exceed 25 per cent for MSME credit. SIDBI's future growth depends on how effectively commercial banks fulfil their priority sector lending targets. A report by ICRA warns that if

In the US, MSMEs can access funding through various federal and state programmes. The Small plays a vital role by offering loan guarantees and encouraging banks and other financial institutions to lend to small businesses. The Microloan Programmes provide capital for various business needs, including working capital, equipment purchases, and real estate acquisitions. Furthermore, the US government supports MSMEs through grants, venture capital initiatives, and state-specific funding programs tailored to local business environments. This diverse range of financial products ensures that MSMEs can find suitable funding options for their specific requirements.

In European Union countries, MSMEs benefit from robust financial support frameworks

financing. The EU also promotes MSME funding through programs focused on the competitiveness of enterprises and small and medium-sized enterprises, which emphasise innovation and competitiveness.In China, the government has implemented several measures to enhance MSMEs' access to finance through dedicated banks, such as the China Development Bank, which offers targeted lending. Local governments have established credit guarantee funds as well. Moreover, China's financial technology sector has significantly grown, with online lending platforms and digital financial services providing alternative funding sources for MSMEs.

Way Forward: The inherent challenges faced by MSMEs cannot be overlooked. It is essential to address the issues within the MSME sector that hinder financial accessibility. As recommended by the Parliamentary Committee on Finance, the comprehensive approaches in EU, and China serve as valuable models for India to enhance its financing landscape for MSMEs, improve credit access, and make these enterprises globally compet-

The government also proposed establishing a Merchant Credit Card (MCC) Scheme for traders and a Vyapar Credit Card (VCC) for micro-units, similar to the Kisan Credit Card (KCC). Under the Credit Guarantee Fund, a scheme to provide short-term loans with interest subvention is still awaited. There is still much work to be done to ensure that all MSMEs can access affordable and timely financing.

India's gender gap in labour force participation: A missed opportunity

India must act swiftly to secure its digital future in an era where technological prowess is now essential for national security

recent International Labour Organisation A and Niti Aayog report shows that less than 50 per cent of women are in the labour force in India, compared to 80 per cent of men, and this proportion has not increased since 1990.

India is presently realising a demographic dividend, with the largest number of the young working population in the age group of 15-34. The above trend in women's labour market participation has serious implications for the economy, indicating a need for transition.

The Periodic Labour Force Survey (PLFS) conducted by the Ministry of Statistics & Programme Implementation (MoSPI), presents a slightly optimistic Russia between 2011-2021

picture, where women's participation in the labour force has notably increased to 37 per cent from 23.3 per cent in 2017-18.

Although growing, these figures are disgracefully low compared to 69 per cent in China and 57 per cent in Bangladesh. A similar comparison of female literacy rate in India with Sri Lanka, China, South Africa and

shows a remarkable growth from 59.28 per cent to 69 per cent for India, but it is way below all other countries where the figure is greater than 90 per cent, due to their dedicated efforts to female literacy.

The female labour supply traces a U-shaped curve to economic growth in many developed countries implying an initial fall in the supply with an increase in the GDP of the country, but later showing a positive trend. However, in India, this upward trend is not realised implying that economic growth has not generated adequate jobs for

According to the OECD report (2019), women in

minutes a day on unpaid work as against 52 minutes by men. The division emphasises that a woman's "appropriate" role may be dominated by patriarchal structures, societal expectations, and traditional bias, and are restricted to caregivers and homemakers. There is also a considerable gender-based wage gap of about INR 4,014. On average, men earn INR 12,048 per month while women earn INR 8,034, or about 33

per cent less than men. This illustrates the stereotypes and gender biases that affect employment decisions, promotions, and wage negotiations. Recently, Indian policymakers and government have undertaken sev-India spend on average 352 eral initiatives and schemes



to raise the status of women with better access, eliminating barriers, and gender parity in the educational

Programmes like Sarva Shiksha Abhiyan, Beti Bachao-Beti Padhao, and the National Programme for Education of Girls at

Elementary Level (NPEGEL) countries in terms of gender aim to combat gender bias, guarantee inclusive education, and improve access to education for all.

The Central Board of Secondary Education (CBSE) also introduced the "Udaan Scheme" in 2022 to encourage and facilitate female students to pursue higher education in Science, Technology, Engineering, and Mathematics (STEM)

This is relevant as the Indian global compatibility centres (GCCs) show only 6.7 per cent of women in executive roles and 5.1 per cent in deep tech organisations. According to the World Economic Forum's annual Gender Gap Report 2023, India ranks 127 out of 146

parity, an improvement of eight places from 2022. The underutilised talents and unrealised potential and skills of women are crucial for redeeming the benefits of demographic dividend. A comprehensive strategy including education beyond secondary schooling with a focus on skill development can design a long-term employment-oriented development strategy, acting as a catalyst in achieving goals as set under United Nation's Sustainable Development

Price stability bedrock for sustained growth: RBI Guv

Reserve Bank Governor Shaktikanta Das on Thursday said price stability acts as a bedrock for sustained growth, and the central bank's endeavour is to bring down retail inflation to 4 per cent on a durable basis.

Speaking on 'Balancing Inflation and Growth: The Cardinal Principle of Monetary Policy', he said resilient growth has given the Reserve Bank of India (RBI) the space to focus on inflation to ensure its durable descent to the 4 per cent target.

"A stable inflation or price stability is in the best interest of people and the economy. It acts as a bedrock for sustained growth, enhances the purchasing power of people and provides a stable environment for investment," he said.

He was addressing a highlevel policy conference of central banks from the Global South here.

The Governor said when the RBI took a pause on the policy rate in April 2023 after



raising it by 250 basis points, it was important to anchor market expectations from running ahead or front running the central bank.

It was, therefore, emphasised that it was a pause and not a pivot. This was to ensure that past rate actions were transmitted fully to the broader economy, he said.

The focus was on anchoring inflation expectations by emphasising our firm commitment to re-align inflation with the target, he said.

"We also categorically said that it is not enough to be within the tolerance band and that our job is not finished until we reach the target of 4 per cent on a durable basis," the Governor added.

He further said, while the global economy has managed to hold its ground in the highly stormy weather of the last few years, clouds of uncertainties still loom on the hori-

Policymaking in this environment of heightened uncertainty is akin to driving a car through a foggy path ridden with speed bumps. These are conditions which will test the

driver's patience and skill.

CEA asks India Inc not to seek protective cover of weak currency

Chief Economic Advisor V Anantha Nageswaran on Thursday advised India Inc not to seek protective cover of weak currency as it is not a substitute for productivity and investment in research and development. A weak currency

can be good for exporters, making their products relatively less expensive for buyers abroad.

Nageswaran further said the reliance on weak currency should not be instrumental to boosting exports, "if anything, it should

be part of the policy arsenal to be deployed contextually, but not as a substitute for productivity, investment in R&D and quality, but as a complement at

"We should not be thinking about in terms of the transformation of competitiveness, which is to continuously expect the weak currency to bail us," he said at an event organised by the Institute for Studies in Industrial Development (ISID).

Noting that China relied on weaker currency but it was guided by domestic productivity leaps in the first decade and also in the last decade of the new millennium.

"In many other developing

countries, including India, weak exchange rate actually has become a protective cover for lack of productivity.

"It was used to hide our inefficiencies. That should not be the case,"

waran said.

He pointed out that China's exchange rate policy accentuated the competitiveness that its domestic productivity gains were already conferring on its



Directed by Arjun Jandhyala, the film carries the unique touch of acclaimed filmmaker Prashanth Varma, who provided the story. "It was around a year and a half ago that he narrated the story to me and I liked it instantly," shares Ashok. Prashanth Varma, known for his film *HanuMan*, pitched

the story to Ashok even before its release. "The success of *HanuMan* is definitely a big advantage for us. It adds credibility and momentum to our film," Ashok notes, adding that director Arjun Jandhyala and his team made a

few tweaks to the original story.
Film maker Arjun Jandhyala, who has worked closely with Boyapati Srinu in the past, brings that influence to this project. When asked about the Boyapati connection, Ashok explains, "This film has the essence of a Boyapati-style movie, with a lot of action and emotional scenes. You can definitely see his mark in it.

Much of the filming took place in Vizianagaram. Was the regional accent incorporated into the dialogue? Galla clarifies, No, we didn't stick to the accent. Since this is a commercial film, we decided against it." He also feels that shooting in live loca-

Reflecting on the differences between his debut film *Hero* and this project, he says, "We wanted to showcase some variation in my look and character. series, Cummins believes players would not have the time to be distracted by the IPL auction that would take place in Jeddah on Sunday, the third day of the match.

The blockbuster series will be a survival of the fittest as Australia look to avenge successive losses on home soil when they go head-to-head from Friday.

paternity leave. Bumrah also said that the team has finalised its playing XI although he will reveal it only at the toss.

'We have finalised our playing XI and you will get to know tomorrow morning before the start of the match," the skipper said.

Pujara backs KL Rahul at No. 3, believes Jaiswal can do a Warner

heteshwar Pujara, who knows a thing or two about grinding the Australian attack in their den, on Thursday backed KL Rahul to bat at the vital number three slot in the Border-Gavaskar Trophy, and said the swashbuckling Yashasyi Jaiswal is capable of doing what David Warner did in his prime.

The five-match Test series begins here on Friday.

"I don't know the batting order. I would prefer him (Rahul) at No. 3 because he has the experience to bat there," Pujara said in Star Sports press room.

Rahul, however, is expected to open with youngster Yashasvi Jaiswal, while Karnataka's Devdutt Padikkal is being considered for No. 3 to maintain a leftright combination.

"It seems the team is preferring Devdutt (Padikkal) at No. 3 for the left-right combination. He has batted at 5-6 and in the middle order. It will be easier to bat at No. 3 than opening. If he can bat at No. 3, it will be good."

Pujara, currently sidelined from the Test set-up, praised Jaiswal and compared his batting with that of Australian great David Warner.

"One of the most talented cricketers India has produced.... I'm very confident that going forward, he has a lot to prove. I know he will play a key role in this series if we have to win.

"His role would be one of the most important ones. He can play a role

similar to what David Warner used to do

for the Australian team. "Being an opener, he holds the key. He's mentally tough. He loves batting, hits a number of balls. He has a long way to go across the formats

Pujara said the youngsters must play with self-confidence and without the fear of failure.

'I will tell them the first battle is a mental battle. Self-confidence and belief are needed to make runs in these conditions. When there is pace and bounce, there is a chance of the ball hitting the body. You have to come out of that fear," Pujara

On tackling short-pitch deliveries in Australian conditions, Pujara said the batters will have to identify the deliveries they should leave.

"As a batter, you need to understand your strengths. We often end up playing hook shots we aren't quite capable of. On Indian pitches, most short-pitched deliveries are below shoulder level. But in Australia, they're often above shoulder height.

"As a batter, you need to identify which balls to leave and which to play. Those below the shoulders are the ones you can pull, but you need to be in control of the shot. Sometimes you leave the ball, and sometimes you pull. You can't have a set rule -- you just need to look at the ball

and play according to the situation. Be in the present moment," he said. Kohli needs a start

Virat Kohli may be going through a lean patch but Pujara believes his past success in Australia will help him to turn things

around.
"There is a lot of expectation of him. The number of matches he's playing and the athlete Virat is, he doesn't get enough breaks in between. That is why sometimes, when you're not getting enough breaks, your body and confidence go down a bit. That's normal. "He has got some break. He's at a place where he likes to compete. If someone is having a go at him he would like to give having a go at him, he would like to give it back to the bowlers -- that's how he

started his journey.
"He has set high standards for himself. He has that awareness. He has been a leader and is probably the best in the circuit. He's aware of what's expected of him and how many runs he has to make." Liga Deportiva Alajuelense threatens FIFA with legal action in bid for spot at Club World Cup

The winningest team in Costa Rica is asking FIFA for a spot in next summer's Club World Cup and is willing to take legal action if denied. Liga Deportiva Alajuelense, which has won 30 league titles, wants FIFA to enforce the rule that forbids clubs from the same ownership to participate in the tournament.

"The claim is based on the principles of eligibility set in the rules of the tournament," the club said in a press release. Team spokesman Marco Vazquez noted that Mexican clubs Leon and Pachuca belong to the same owner, Jesus Martinez, of Grupo Pachuca.

"Those are the rules that FIFA established there cannot be multi-ownership,"



Vazquez said Wednesday. "There are two Mexican clubs from the same owner and the rulebook is clear. What we are asking is to review what FIFA itself established." The FIFA-run competition has been expanded from seven teams to 32 and will be staged in the United States from June to July next year. "We hired a law firm in Spain, and they have all the details," Vazquez said of potential legal action. FIFA has not publicly reacted to the team's announcement and didn't immediately answer a request for

comment. Alajuelense is the best-ranked team in Central America for the CONCACAF but 40th overall in the region. CONCACAF has four spots in the Club World Cup. The teams that qualified are: the Seattle Sounders, Monterrey, Leon and Pachuca. Lionel Messi's Inter Miami will participate as a guest of the host.

All five clubs were announced for the Dec. 5 draw in Miami. In Mexico, besides Leon and Pachuca, there are another two companies that own two or more clubs in the first division. Grupo Caliente owns Tijuana and Queretaro, while Grupo Orlegi controls Atlas and Santos.

But the future augurs well for the Indian team as the players look to gain much-needed exposure by rubbing shoulders with the best of the world in the first-ever fourteam women's Hockey India League, starting in Ranchi on January 12 and finishing on January 26.
