State's failure to submit data delays NDSA report

The submission of the National Dam Safety Authority (NDSA) expert committee report on Medigadda, Annaram and Sundilla barrages has been delayed due to incomplete tests and missing data from the state government, said Vedire Sriram, the Advisor to the Union Jal Shakti Department.

Sriram gave these details through an affidavit submitted before the Justice PC Ghose Commission.

The affidavit outlined issues connected to the Kaleshwaram Project, including aspects of planning and the collapse of the Medigadda Dam's piers. The document also mentioned recent developments and clarified action taken by the authorities.

The NDSA gave its initial report on November 3, 2023, after the piers of the Medigadda Barrage sank. Sriram said that the TG govern-

ment has not completed the geotech-

nical tests recommended by the NDSA, leading to delays. He disclosed that state engineers had filled potholes under the barrage without the NDSA's approval through grouting. Critical geotechnical data under the barrages has been lost complicat-

ing the assessment process, he said. The NDSA committee suggested conducting geophysical tests at specific locations and submitting the results for analysis. However, Sriram pointed out that the NDSA has not

'Action plan to enforce HC orders on Musi'

Senior officials of the Telangana Government met on Tuesday to deliberate on the High Court's directives endorsing the Musi River Revitalisation Project.

The meeting focussed on formulating an action plan to comply with the court's orders, including the removal of encroachments and

restoration of water resources. During the meeting, officials discussed strategies for enforcing the judgement, including surveys to identify encroachments, alternative housing arrangements for displaced individuals and ensuring compliance with the 1,317 Fasli Act

and the Hyderabad Irrigation Act. The High Court, in its judgement, dismissed 46 petitions challenging eviction notices issued under the project. The court backed the state's efforts to reclaim the Musi River's buffer zones, full tank level (FTL), and riverbed areas from unauthorised buildings, emphasizing the historical and legal framework protecting water resources in the region.

The court referred to the catastrophic Musi floods of 1908, which prompted the Nizam administration to build Osman Sagar and

Adani scam: How political nexus lets the guilty evade justice

he United States' legal action against the Adani Group has sent shockwaves through global financial and political circles, unveiling allegations of financial and ethical misconduct. At the heart of this unfolding controversy lies a contentious solar power agreement between the erstwhile YS Jagan Mohan Reddy-led Andhra Pradesh government and the Solar Energy Corporation of India (SECI). This deal is now mired in suspicion, with explosive claims that Adani either paid or pledged a staggering Rs 1,750 crore as an 'incentive' to the then Andhra Pradesh regime. These allegations spotlight larger issues of corruption, accountability, and the opaque nexus between politics and big business.

BJP member Dilip Saikia, who was in the chair, adjourned the proceedings for the day after official papers were laid on the table.

Himayat Sagar reservoirs for flood control and water supply. These measures were complemented by the enactment of the 1317 Fasli Act 8, which categorized all water bodies and related structures as government property.

Despite these laws, the court noted widespread encroachments on water bodies and riverbeds, including unauthorized religious and private buildings. It highlighted the subsequent Hyderabad Irrigation Act of 1357 Fasli, introduced in 1948, which strengthened protection for water resources and vested enforcement powers with government irrigation officers. The High Court issued several key directives like to serve notices and to remove encroachments in the Musi River's buffer zones, FTL and riverbed. The HC also asked the admin to survey affected residents and provide alternative housing form them as per state regulations.

The HC also asked the admin to compensate individuals with valid title deeds for acquired land and to strictly adhere to timelines for clearing encroachments. The HC also directed municipal authorities to consider its guidelines from previous judgments while addressing stay or injunction requests. Petitioners and encroachers were instructed not to block government surveys.

Citing the government's claims of spending Rs 54,280 crore on farmer welfare, he dismissed the figure as inflated. "Of this amount, Rs 27,486 crore was allocated for pro-

grammes like Rythu Bima, free electricity and paddy procurement which were initiated by the BRS government. Any government would have had to continue these schemes," he

Harish demanded that the Congress government address its actual financial obligations to farmers, which he estimated at Rs 40,800 crore. This includes Rs 14,000 crore for pending loan waiver, Rs 7,500 crore for Kharif Rythu Bandhu, Rs 3,000 crore for tenant farmers, Rs 16,000 crore for agricultural labourers, Rs 3,000 crore for crop bonuses and Rs 11,700

HC flays authorities over midday meal incidents

PNS HYDERABAD

The Telangana High Court has expressed strong disapproval of repeated incidents of students falling ill after consuming midday meals at a government school in Maganoor in

Narayanpet district.
"How can school officials be so negligent while children are repeatedly falling sick? This is a serious issue," the court remarked during the hearing of a Public Interest Litigation

The PIL raised concerns about the lack of hygiene and quality in midday meals served in government schools. The court noted that three such incidents were reported within a week and questioned, "Are officials waiting for children to die before taking

action?" The court also criticised the Advocate General (AG) for taking a week to verify information from district officials, remarking, "Do officials only work when the court inter-

venes?" The AG confirmed that the students' illness was caused by consuming 'kurkure' snacks. The court has directed authorities to submit a detailed report on the actions taken and ordered investigations into similar incidents in Maganoor,

Karimnagar and Burugupally. The next hearing has been scheduled for Monday.

A woman died under suspicious circumstances after falling from the ninth floor of My Home Bhooja Apartments in Raidurgam.

Raidurgam inspector Venkanna explained to The Pioneer that Rajesh Babu (54), a resident in the ninth floor of My Home Bhooja Apartments, was connected with Ashvita Singh from Odisha for surrogacy purposes. In the process, Ashvita was not allowed to go outside. She resisted to help the person for surrogacy and planned to leave. While on her escape from the floor she slipped to death, said the Raidurgam Police. A case has been registered.



HYDRAA Commissioner inspects lakes amidst land-grab complaints

In response to complaints from locals regarding encroachments Commissioner Ranganath conducted an on-site inspection on Wednesday.

He visited several lakes, including Nizam Talab Lake (Turak Cheruvu) in Nizampet, Medi Kunta Lake in Madhapur, Yee Dulakunta, Neknampur Lake in Narsingi, Vanam Cheruvu in Tellapur, Chellikunta and Mella Cheruvu. During the visit, several local residents lodged complaints about encroachments on The locals submitted petitions

requesting the restoration of the lakes and provided details about their history. They also raised concerns that the beautification of the lakes, such as constructing fences around them, is being used as an excuse to encroach on the buffer zones.

Further complaints were made about sewage from gated communities flowing into the lakes, caus-



ing pollution.

In response, Commissioner Ranganath assured the locals that steps would be taken to prevent further encroachments on the lakes. He instructed officials to gather full details on the lakes and

ensure that no encroachments occur.

He also assured the public that after a comprehensive review, necessary action would be taken to preserve the lakes and prevent encroachment.

7 booked for illegal water connections in Shamshabad

The Hyderabad Metropolitan Water Supply and Sewerage Board (HMWSSB) has filed criminal cases against seven individuals for illegally obtaining water connections without proper authorisation. The accused, residents of Kumari Basti, Yadav Bast and Kappugadda areas under the Shamshabad section of O&M Division No. 18, were found to have two water connections each, one of which lacked necessary documentation. The individuals identified as B Ravi, B Krishna, B Kumar, B Anjaiah Mahboobi, K Balaraj and T Bhaskar failed to provide valid certificates for one of their connections during a field inspection conducted by HMWSSB officials. HMWSSB has issued a stern warning to residents, stating that any unauthorised water or sewerage connections will result in criminal prosecution. Citizens are urged to report such illegal activities to the HMWSSB vigilance team at 9989998100 or 9989987135.



Huge stock of antibiotics worth Rs 1.33 crore seized

The Drugs Control Administration (DCA) of Telangana has seized a massive stock of antibiotics worth Rs 1.33 crore from the manufacturing facility of Jodas Expoim located at Biotech Park, Karakapatla, Siddipet district.

The seizure was made following the discovery of unauthorised packing and fraudulent export

activities.
The DCA officials raided the manufacturing unit at Biotech Park and found significant quantities of antibiotics in the finished goods warehouse.

The company was found to be in violation of the Drugs and Cosmetics Act, 1940.

During the raid, officials discovered that a batch of Ampicillin

Sulbactam 1000 mg + 500 mg injections, consisting of 38,175 vials was falsely labeled as being manufactured by Jodas Expoim when in reality, it had been produced at Indian Genomix, a separate facility in Medchal-Malkajgiri district, Telangana.

The antibiotics. which were meant for export to Russia were incorrectly labeled and falsely claimed as products of Jodas Expoim.

Further investigation revealed that other antibiotic similar stocks had been exported to Russia between October and November 2024 under fraudulent claims of manufacturing by Jodas Expoim.

These antibiotics were in fact pro-duced by other pharmaceutical compa-

Task Force seizes 9 kgs of ganja from delivery boy

In a joint operation, the Commissioner's Task Force, West Zone team, and Banjara Hills Police apprehended one individual for possession of 9 kilograms of dry ganja and arrested seven consumers who had purchased the narcotic substance. The accused, identified as Santhosh Kumar Rout, a 25-year-old Swiggy delivery agent and a native of Odisha, was caught based on credible information.

Santhosh Kumar Rout, originally from Kendjahar district in Odisha, came to Hyderabad in 2021. Initially working as a security guard and delivery agent, his income proved insufficient for his needs. Seeking an easier source of income, he a known ganja peddler from Odisha. Santhosh purchased the narcotics from Govind and transported approximately 9 kilograms of ganja to Hyderabad by train.

to victims in two online fraud cases PNS HYDERABAD The Hyderabad City Cyber

Crime unit successfully refunded Rs 8,46,227 to victims of two separate online fraud cases. The victims, both housewives from Hyderabad, had been cheated in scams involving fake job offers and investment schemes. In the first case (Cr. No.

2039/2024), a 52-year-old woman was defrauded by scammers posing as representatives of IBU Consulting Pvt. Ltd., UK. The fraudsters convinced her to transfer Rs 4,22,560 for a fake job and work visa. The Cyber Crime unit, led by Inspector K Prasad Rao and Sub-Inspectors Yadagiri D Shekar and R Murali froze the fraudulent amount, guided the victim to ensured the entire amount was refunded to her bank account.

In the second case (Cr. No. 2958/2024), a 49-year-old woman lost Rs 7,65,110 in a

part-time job and investment scam. Fraudsters lured her with promises of high returns, convincing her to transfer the amount to their accounts.

The investigation team, including Inspector K. Prasad Rao and Sub-Inspectors Uma and D Shekar, froze a portion of the fraudulent funds and facilitated the refund of Rs account.

The Cyber Crime unit has issued a public advisory to warn citizens about the rising menace of fake online job offers and investment

schemes. Scammers often use platforms like Telegram, WhatsApp, Instagram and Facebook to promote fraudulent apps and websites. These schemes promise high returns, use fake profit screenshots and sometimes transfer small amounts to victims' accounts to gain their trust. Čitizens are advised to be

cautious of offers like "Work from Home," "Click & Rate," and "Earn Easily." Avoid sharing financial or personal details without veri-

fication. Check for SEBI endorse-

ments when dealing with investment platforms.

The Cyber Crime unit emphasised the importance of reporting such incidents immediately. Victims can reach out to the helpline num-National Cyber Crime Reporting Portal (cybercrime.gov.in). Prompt reporting increases the chances of recovering funds put on hold

by scammers.

UPSTREAM MUSI: WHERE DOOM AND DREAM CONVERGE

a grim reminder of what happens when people start disregarding natural resources.

The hydrologist Srinivas said, "What we see is a natural river bed and is not disturbed heavily. The banks are clearly distinguished and a proper channel of river. The flow channel is also clear. The slopes contain the flood during higher flows which is the natural condi-

At Himayath Sagar, where another branch of the Musi originates, the river retains its natural conditions with visible slopes and depressions. Yet, the air here is thick with the stench of decomposing waste, with miscellaneous objects such as helmets, wedding trash, and other refuse lining the banks. The growing pollution overshadows the serene beauty of this upstream stretch, underscoring the urgent need for intervention.

A foundation stone laid in 2012 by the then home minister Sabita Indira Reddy for BT road stands next to Musi at Kismathpur, Rajendranagar. Let alone the BT road, there is a graveyard and right next to it a huge luxury

apartment is being constructed. Visible, graveyard and the Giridhar Propera - a luxury apartment are in the buffer zone, right next to each other. The gated community is next to Musi and graveyard. In Rajendra Nagar, the river faces a different challenge-an invasion of water hyacinth. This stretch of the Musi is choked with the plant, reducing its flow to a near standstill. While this section is free from encroachments, looming luxury apartments near the buffer zone threaten its stability.

Srinivas observed, "Musi River is coming from Himayath Sagar at Kismatpur. Inside the river, there are no encroachments but the river doesn't have any flows and filled with algae and water hyacinth".

Unchecked urban development here could tip the balance irreversibly. The check dam at Upparpally offers a peaceful retreat, a stark contrast to the polluted stretches downstream. The dam retains water from Himayath Sagar, creating a small waterfall and deep pools. This spot, still untouched by urban chaos, attracts children from nearby areas. People from the vicinity spend time here enjoying the peace surrounding the stretch fo the river. However, experts fear that the lack of maintenance and

growing urban pressures could soon rob Upparpally of

The hydrologist said, "Water is deep here. It is a check dam constructed on Musi, which is stopping the water coming from Himayath Sagar. There is a spill way, the excess water is going into Musi River".


As the Musi reaches Bapu Ghat, its problems intensify. The site, which marks the confluence of water from Himayath Sagar and Osman Sagar, is overwhelmed by encroachments. Towering apartments and commercial establishments stand openly in the river's buffer zone. The air is filled with a pungent stench, a mix of decaying waste and untreated sewage, making it difficult to appreciate the location's historical significance. Plans for appreciate the location's historical significance. Plans for the tallest Gandhi statue here are underway, but the river's deteriorating state casts a shadow over the project. From Bapu Ghat, apartments and gated communities built years ago including the likes of Rajapusha, are visible. A proper life has been established along the banks at Attapur area abutting Musi with several residential apartment of the life of Palaceters and Palaceters and Palaceters and Palaceters. ments, including Pearl Heights and Rajapushpa's Silicon Ridge. For the upstream, the hydrologist recommend-



ed, the need for immediate actions to protect and restore the upstream stretches of the Musi River: Regular cleanup drives are essential at Gandipet and Himayath Sagar to preserve their natural flow. Removing water hyacinth from Rajendra Nagar can improve water flow and ecological health. Strict action against encroachments, especially near Bapu Ghat, is critical to restore the river's width and flow. Awareness campaigns and public participation can foster a sense of responsibility for the river.

Despite its challenges, the upstream Musi holds the potential for revival. With timely interventions, this historically significant river can once again flow as a source of pride for Hyderabad and its people.



Govt halts ethanol factory in Nirmal district

After two months of protest, people erupted in joy on Wednesday at Dilawarpur village in the district with the State government issuing orders halting the construction of an ethanol Farmers announced the withdrawal

58,929 waqf properties facing encroachment: Govt

According to sections 54 and 55 of the Waqf Act, the chief executive officer of state waqf boards has the power to take legal action against unauthorised occupation and encroachment of waqf properties, Rijiju pointed out.

A glimmer of hope

While the ceasefire offers a reprieve from conflict, its

durability is not guaranteed, a lasting resolution still remains elusive

n a significant development for West Asia, Israel and Hezbollah, the Iran-backed militant group operating in Lebanon, have agreed to a ceasefire after months of intense conflict. The agreement, brokered with the intervention of the United States and France, comes into effect at midnight Israeli time on November 27. It is being hailed as a potential step toward de-escalation in the region, but its success and long-term implications remain uncertain. The ceasefire agreement aims to restore calm along the volatile Israel-Lebanon border. It mandates that Hezbollah and other armed groups in Lebanon halt all offensive operations against Israel. In return, Israel will refrain from military actions targeting Lebanon. A key aspect of the deal is the acknowledgement of United Nations Security Council Resolution 1701, which calls for the disarmament of militias and the exclusive authority of Lebanese state forces in the southern region. Israel has also agreed to withdraw its forces from positions

south of the Blue Line within 60 days, provided the terms are upheld.

This ceasefire does not mean that Isreali forces are back to barracks. Israeli Prime Minister Benjamin Netanyahu, has emphasised the need to focus on Iran. Israel agreed to truce as there were logistical challenges, including delays in weapons and munitions deliveries, which necessitated a pause to replenish stocks and prepare for future operations. The ceasefire comes amid a broader context of regional instability. The war between Israel and Hamas, which erupted in October 2023 after a brutal terrorist attack on Israeli civilians, has already

claimed tens of thousands of lives. There is no let up in Israel's attacks on Gaza where the human crisis is getting worse. The fighting extended to Israel's northern border when Hezbollah escalated its attacks, prompting Israel to retaliate. While the ceasefire offers a glimmer of hope, challenges loom large. The success of the agreement depends on its strict implementation, particularly the disarmament of militias in Lebanon. The Lebanese government, already struggling with economic and political crises, will face immense pressure to assert its authority over Hezbollah, a deeply entrenched and well-armed organisation. Whatever the reasons for this truce but it definitely gives peace a chance. The agreement's implications for regional peace are profound. If upheld, it could reduce tensions along Israel's northern border, allowing displaced civilians to return home and facilitating humanitarian relief in affected areas. For Lebanon, the deal could bolster its sovereignty by curbing the influence of armed non-state actors, potentially paving the way for greater stability. However, unresolved issues, including the ongoing Israel-Hamas conflict and tensions with Iran, continue to pose risks to lasting peace. The role of the US, France, and UNIFIL will be critical to ensuring compliance and rebuilding trust.

hy do the residents of Delhi experience pollution every year while the ruling class blames it on stubble burning in the neighbouring states of Haryana, Punjab, and Uttar Pradesh? Can't they find a permanent solution instead of debating who will pay for the burning machines and other related expenses? The air pollution levels in Delhi are eight times higher than the WHO's prescribed limits. It has reached a level where the judiciary, executive, and parliament blame each other, and the severe pollution level continues. Returning from a month-long holiday in the US, I was immediately struck by the urgency of the pollution crisis as I landed in Delhi, past midnight this The dark skies, sheets of dust,

heat, and difficulty in breathing welcomed me as a stark reminder and a pressing call to action. The pollution levels in Delhi have soared to their highest this week. It has reached hazardous levels, causing state officials to limit movement and revive plans to stimulate artificial rain to clear toxins. This forced the schools and offices to close due to cloaking the city in thick brown smog and demanded immediate action. The number of respiratory diseases in children and older adults is rising, along with other health issues. In cold winters in the north, smog covers the area every year and traps harmful pollutants from fires, construction, and factories. This issue worsens when farmers burn their fields after harvesting rice to prepare for new crops. The same or even worse scenario unfolds yearly, reaching alarming levels over time. In its 2024 manifesto, the Aam Aadmi Party (AAP) government in Delhi did not include promises to reduce pollution, unlike previous ones. Instead, the manifesto focused on the National Clean Air Programme (NCAP) and ways to cut pollution. APP highlighted the need for citizen involvement and plans to use electric buses to control pollu-

and the state governments which are the real culprits. Every winter, smoke from farm fires engulfs Delhi and covers the Delhi skies.

Farmers resort to burning as it is the cheapest method of clearing their fields.

The state governments demand that the Centre provide funds to assist farmers in reducing smoke emissions, but the issue persists yearly. Meanwhile, politics also plays its role. The BJP governs the Centre, while AAP rules Delhi and Punjab. The Congress remains an onlooker. This attitude does not help implement an effective plan.

She leaves behind a profound legacy, having nurtured and inspired many. Though she is no longer among us, her influence continues to guide and motivate

n 1999, I first discovered the Cinefan Asian Film Festival. Excited, I headed to the India Habitat Centre (IHC) to collect a pass, only to learn that the festival was open to all. I couldn't believe my ears. Being new to Delhi, I had assumed that everything came at a price, but this experience proved me wrong. During the festival, I came to know Aruna Vasudev, the Festival Director. I also met filmmakers and critics from around the world, making it an unforgettable experience. The following year, I eagerly awaited the festival and even took seven days of leave from work to immerse myself in films. My journalist friends noticed my dedication and shared it with Aruna Vasudev. They told her about a boy from West Delhi who traveled daily, spending mornings to midnight watching films out of sheer love for cinema. That year, I managed to watch 37 out of the 42 films screened, missing a few only because I attended seminars. espite various initiatives, a significant gender gap persists in learning and earning opportunities between men and women. Skill development can be a transformative force, enhancing women's professional growth and economic independence. By acquiring skills, women can access broader job opportunities, empowering them socially and economical-

À survey titled "Women's Economic Empowerment," conducted in 2023-24 by the Indian Statistical Institute Delhi, explores women's skill development and employment landscape. It reveals that 7 out of 10 women lack economic independence. India ranks 142nd out of 146 countries in the Global Women's Economic Participation and Opportunities Index. Women in India contribute only 17 per cent to the GDP, which is less than half the global average. Their economic participation is essential for sustainable development, gender equality, and poverty reduction.

According to the McKinsey Global Institute (MGI), integrating 68 million more women into the workforce by 2025 could potentially increase India's GDP by USD 0.7 trillion. The World Bank also reports that including 50 per cent of women in the workforce could boost India's GDP growth by 1.5 percentage points.<

The International Labor Organization (ILO) states that India's Women's Labor Force Participation Rate (LFPR) was about 32.8 per cent in 2023, while it was 67.2 per cent for men. Women are primarily found in specific sectors such as agriculture (73.2 per cent), education (44.1 per cent), and healthcare and beauty-wellness (31.4 per cent). An estimated 7.5 crore women are expected to join the workforce in the coming decade. To ensure that this vital human resource—nearly half of the country's workforce—is effectively utilised and contributes at least 25 per cent to national economic growth, the government must prioritise skill development for women's empowerment. In addition to these gaps, prevalent gender stereotypes affect skill acquisition. Women generally pursue skills in beauty and wellness, textiles, clerical work, and healthcare. The DP-WEE study indicates that 30.2 per cent of skilled women aged 18 to 35 primar-

Airfares have moderated in 2024, says Govt

he government has said airfares have moderated in 2024 compared to 2023 and notably, a decline in air ticket prices was observed in various routes during festival seasons. Amid concerns in certain quarters that air ticket prices are ruling high, Minister of State for Civil Aviation Murlidhar Mohol told Rajya Sabha that airfares are not subject to regulation by the government and airlines have the flexibility to determine their airfares based on their operational needs while adhering to existing rules. "...the government generally refrains from regulating airfares to maintain market competitiveness, however it remains vigilant, and the government intervenes to shift capacity from one sector to another to prevent exorbitant pricing to ensure passenger comfort and welfare," he said in a written reply on November 25. Airfares are dynamic and is a function of demand and supply. With continuous engagement with airlines & Online Ticketing Agents (OTAs) and keeping a watch on the movement of airfares by the government, Mohol said airfares have moderated in 2024 relative to 2023.



Second phase of PM e-Drive notified

uyers of cargo electric three-wheelers will continue to avail the subsidy benefit as the government has Dadvanced the second phase of incentives for such vehicles under the Rs 10,900-crore PM e-Drive Scheme. The move comes as the subsidy allocation for the ongoing financial year on L5 category electric three-wheelers has already exhausted with the registration of over 80,000 such vehicles till November 7. Also, the subsidy amount has been capped at Rs 25,000 per vehicle, down to half from Rs 50,000 per vehicle for the 80,546 vehicles registered between April 1 and November 7, 2024. According to the latest notification published on November 26, up to 1,24,846 vehicles to be registered on the Vahan portal from November 8, 2024 to March 31, 2026 will be able to avail subsidies at reduced rate of Rs 2,500/kWh, down from Rs 5,000/kWh in phase I. When the scheme was announced in September this year. 80.546 electric three-wheeler cargo vehicles were targeted to be supported for FY25 and 1,24,846 units for FY26.



Godrej Properties launches QIP to raise Rs 6,000 cr

odrej Properties on Wednesday launched its qualified institutional placement (QIP) to sell equity shares to investors for raising up to Rs 6,000 crore to fund its growth plan. Last month, the company's board approved raising of up to Rs 6,000 crore through the issue of securities. In a regulatory filing, Godrej Properties informed that the QIP Placement Committee authorized the opening of the issue on November 27, 2024. The panel also approved the floor price for the QIP issue, being Rs 2,727.44 per equity share. Godrej Properties' share price closed at Rs 2,833.05 apiece on Wednesday, down 2.35 per cent from Tuesday. The company is one of the leading developers in the country. It has a major presence in Delhi-NCR, Mumbai Metropolitan Region (MMR), Pune and Bengaluru. It has entered into Hyderabad market recently. In the last fiscal, the company's sales booking jumped 84 per cent to a record Rs 22,527 crore, the highest among listed realty firms in 2023-24. Godrej Properties has set a target of achieving Rs 27,000 crore worth of sale bookings.

French aircraft, defence industries should look at India to set up base'

Commerce and Industry Minister Piyush Goyal on Wednesday urged the French aviation sector to explore opportunities to set up manufacturing facilities in India.

He said that India is the world's largest aviation market with 1,500 planes ordered

with the capability of taking the order up to 2,000. "Indian companies have 1,500 aircraft on order and have the option to take it to 2,000. It would

also be in the best interest of French companies to look at Indian manufacturing possibilities, to look at expanding their own sales in India for both aircraft, spare parts for aircraft, maintenance, repair and overhaul and all other associated industries," he said while addressing the Asia-Pacific Forum of French Foreign Trade Advisors.

A large part of the order of aircraft by Indian companies has gone to French manufac-

India has increased the number of airports to 125 from 75 in 2014 and by 2029, 75 more airports will become operational.

"It gives huge opportunities for companies who wish to develop airports and other associated industries," Goyal

The minister also suggested for joint production partnership between Indian and French com-

panies in the defence sector for the world markets. "We are encouraging companies

from across the world to manufacture in India. We allow 100 per cent ownership of defence manufacturing companies.

"We don't even insist on technology transfer in most cases," he said.

Goyal also invited French companies for partnerships with India in the area of agriculture and food processing, renewable energy, electric vehicles, artificial intelligence and quantum technologies, and services sector.

Despite this humongous responsibility, the nine illustrious decades of RBI's existence and 75 years of experience as a regulator and supervisor have built a foundation of a strong financial sector which could support the country in fulfilling its developmental aspirations, Rao added.

India to spend over Rs 9 lakh cr on power transmission infra

The National Electricity Plan (Transmission) covers the transmission plan till 2031-32, said Minister of State for Power Shripad Yesso Naik in a written reply to the Rajya Sabha on Monday.

As per the Plan, 1,91,474 circuit kilometres (ckm) of transmission lines and 1274 Giga Volt Ampere (GVA) of transformation capacity would be added (at 220 kV and above voltage level) in the 10year period from 2022-23 to 2031-32.

mission capacity is planned to increase to 143 GW by 2026-27 and further to 168 GW by 2031-32, from the present level of 119 GW. The Plan also highlights new

technology options transmission, cross-border interconnections and private sector participation in transmission.

He informed the House that total expenditure likely to be incurred on this plan is about Rs 9,16,142 crore.

The Transmission Plan provides visibility to the Electricity Generators, Equipment Manufacturers, Transmission Service Providers (TSP) and investors 33.25 GW of High Voltage in Transmission Sector.

Fiscal deficit likely to be at 4.75 pc of GDP: IndRa

PNS MUMBAI

The government will be able to register the fiscal deficit at 4.75 per cent in FY25, 0.19 per cent lower than the budget aim, by reigning in expenditure, domestic rating agency India Ratings and Research said on

Wednesday. The revenue expenditure, excluding subsidies, will be 0.12 per cent of GDP, lower than the budget estimate, the rating agency added.

Its chief economist and head of public finance Devendra Kumar Pant said the government capital expenditure will come out to be Rs 62,000 crore lower than the estimate of Rs 11.11 lakh crore.

Pant was quick to add that the government capex will still be 10.6 per cent higher than the year-ago period. The government was initially envisaging a 17.6 per cent growth in the key

number. Even as there is a dip in the government capital expenditure projected, the capex to GDP in FY25 at 3.21 per cent is estimated to be at a two-decade high,

the agency said. "The FY25 capex growth has



been impacted by the general elections in May 2024, and capex in 1H FY25 shrank 15.42 per cent year-on-year. To achieve the FY25 (BE) target, capex in 2H FY25 must grow

52.04 per cent, which appears to be a daunting task," it added. Among ministries, railways, and road, transport and highways will breach their FY25 capex allocations, the agency

DrKondapalli Neeharini, a relentless torchbearer of Telugu literature, seamlessly balances the roles of homemaker and literary trailblazer. inspiring countless women along the way. Hailing from Chinna Pendyala in Jangaon district, her journey was shaped by her parents' powerful legacy—her mother, a leader in women's empowerment and her father, a freedom fighter and the first Lok Sabha MP from

Her notable works, from poetry collections like Arra Talupulu to her biographies and travelogues, reflect her deep social consciousness and feminist perspective. She has dedicated decades to preserving cultural legacies, notably through her biography of her father-in-law, DrKondapalli Seshagiri Rao and her exploration of Telangana's history through her PhD thesis on the Oddaraju brothers.

Her contribution to literature has earned her numerous accolades. including the prestigious Amruthalata Award, the She Award and international recognition, yet she remains grounded, known for her humility and deep empathy. Her literary journey began quietly, as many do. "I was always inclined toward writing," she says with a smile that suggests fond memories of simpler times. 





"His body was completely relaxed when he came into bat in the second innings. In the first innings, because of the fact that India had lost two wickets early, he would have also been under pressure," Gavaskar said on Star Sports.

Cricket is religion in India but not roadblock for other sports: Coe

World Athletics boss Sebastian Coe is quite aware that cricket is nothing short of "religion" in India but he feels it shouldn't be viewed as a "roadblock" for other sports, which can challenge its dominance by producing trailblazers like javelin thrower Neeraj Chopra to capture the public imagination.

Coe, one of the candidates for next year's International Olympic Committee (IOC) presidential elections, has been in the country for the past two days, meeting Prime Minister Narendra Modi and sports minister Mansukh Mandaviya among others to discuss the growth potential of Indian

Expressing faith in the country's potential to become a powerhouse, the four-time Olympic medal-winning former middle distance runner said, "When you have an Indian athlete winning Olympic titles and world championships, then you are in good shape.

"When you have athletes of the calibre and high profile of Neerai, then you can actually mount a very good challenge to other sports. And look, we know the national religion is cricket " he stated phonic interview with PTI on Wednesday.

"It's really important that India have athletes that capture the



imagination of the public, ultimately the broadcasters. And Neeraj does both," added Coe, who also headed the 2012 London Olympics bid.

Chopra won an unprecedented track-and-field gold in the Tokyo Olympics before adding a silver to his kitty in Paris this year making him an all-time great in Indian sports at a mere 26 years of age.

Cricket not a roadblock for

other sports

Cricket enjoys massive following in India but Coe said it is not a roadblock for others and they should find innovative and creative ways to gain popularity. "It (cricket) shouldn't be (a roadblock), because every country has sports that ar dominant. It would be like saying in the UK, well, football is an inhibitor for track and field. We have one of the best

track and field teams in the UK that we've had for many years," the 68-year-old Coe said.

"You have to live with what you have to live with. And you can't just sit there saying, well, India, the cricket or football or rugby or wherever these sports are really strong. You sort of give up, you don't.
"You have to be more innova-

tive, more creative. The sporting landscape is very competitive. Cricket is a very dominant sport in India. I watch it all the time," said the long-time administrator, whose grandfather was an Indian (hotlier Sardari Lal Malhotra).

Bayern Munich fans protest against PSG president Al-Khelaifi

Bayern Munich fans protested against Paris Saint-Germain president Nasser Al-Khelaifi during the teams' Champions League match.

The supporters in Bayern's stadium's Südkurve held up several banners making clear their opposition to the Qatari businessman during the first half of Bayern's 1-0 win. One banner showed Al-

Khelaifi's face with a line over it, another accused him of being "plutocratic" with an expletive, and more banners read: "Minister, club owner, TV rights holder, UEFA ExCo member & Darrich & Chairman all in one?' The 51-year-old Al-Khelaifi is

fans for his influence on European soccer as chairman of the European Club Association, Qatar Sports Investments — the owner of PSG — and the Qatari stateowned beIN media group. He also joined UEFA's executive



unpopular among the Bayern Al-Khelaifi has long drawn scrutiny for apparent conflicts of interest because of his various roles. sponsorship deals with Qatar, which was accused of human rights abuses before it hosted the 2022 World Cup. The fans eventually got their way last year when Bayern's long-run-ning sponsorship deal with Qatar Airways was not renewed.

The Sueddeutsche Zeitung newspaper reported at the time that the decision came from Oatar. Sheikh Tamim was reportedly unhappy with the Bayern fans' constant criticism and the club's failure to distance itself from their protests.

Phillip Hughes remembered on 10th death anniversary as Abbott gets teary-eyed

Sean Abbott was seen wiping away tears as family and friends paid tribute to the late Australian cricketer Phillip Hughes on Wednesday to mark the 10-year anniversary of his tragic death after being struck on the neck

while batting.
Abbott bowled the fatal delivery that struck Hughes during a Sheffield Shield match between New South Wales and South Australia in 2014 at

the Sydney Cricket Ground. NSW players consoled Abbott as they stood for an emotional tribute, including observing a minute's silence, before the start of play on day four of their Sheffield Shield match against Tasmania at the

25 ODIs and one T20I for Australia, lost his life three days before his 26th birthday. Players in the Sheffield Shield have been wearing black armbands in matches since Saturday as a tribute to Hughes.

'Today marks the 10-year anniversary of the passing of our treasured son and brother, Phillip Joel Hughes," the family said in its message.

"Phillip was a loving, humorous and an infectious person to be around.'

According to reports in local media, Abbott was consulted in advance about whether he would be comfortable with a match being scheduled on the anniversary of one of the most saddest moments in Australian sports.

The family further said, "He Hughes, who played 26 Tests, always aimed to make those



around him smile and enjoy the little things in life, where his beautiful smile would come to life. He shined bright even in the tough times, which is a testament to who he was as a person, and we loved everything about him. "He was the light of our lives. Phillip had a profound love for his family and lived his life with respect to everyone around him. Cricket Australia had

planned in advance a series of initiatives to mark the 10th anniversary of Hughes' death including a tribute before the start of the second Test between India and Australia at the Adelaide Oval scheduled from December 6-10.

"Phillip, the small-town country boy, became an Australian Test, One-Day and Twenty-20 cricketer, where he played on the toughest pitches around the globe, alongside the toughest of cricketers on the world stage, but never forgot where he came from and who helped along the way," the family said in the message. "He was a unique individual that took risky and adventur-

ous strides to conquer the dreams he set for himself to become test baggy green number 408. "He played cricket for all the right reasons and had the ability to take it all in his

stride. He loved being a part of a team and representing Australia for the game he loved so deeply. Cricket Australia, which has

produced a special documentary on him, will broadcast it ahead of the second Test between India and Australia, as part of a twogramme. Batting on 63, Hughes collapsed before receiving mouth-to-mouth resuscitation and was subsequently taken to Sydney's St Vincent's Hospital, where he underwent surgery and was placed in an induced coma. Hughes, however, could not recover from the blow and died on November 27. The left-hander was viewed as one of the promising Australian cricketers as the team went through a transitional phase.

In the Australia-India Adelaide Test that followed his death a decade ago, the southpaw was named as the home team's 13th player with 63 (the score he was batting at in his last match) seconds of applause observed ahead of
