Another encounter, high alert winter in Kashmir

light consecutive incidents of terrorist violence in a gap of 20 days in Kashmir valley, after the formation of the Omar Abdullah government, have sent alarm bells ringing in the entire security grid to gear up for the long winter ahead.

The pattern of strikes also shows a disturbing trend as the terrorist handlers picked up dormant and least expected areas to target the security forces. The terrorist handlers have also shifted their focus from the Jammu region back to Kashmir valley to drive a wedge between the newly elected popular government and the security establishment. Recently, when Lieutenant

Governor Manoj Sinha chaired a meeting of the Unified command headquarters in the aftermath of a dastardly attack on the construction workers in the Gagangir area of Sonamarg newly elected Chief Minister Omar Abdullah remained conspicuous by his absence.

The selection of targets and timing of these attacks suggested the terrorist handlers wanted to demonstrate their capabilities to strike at will despite the huge presence of security forces in the hinterland. Two days after the grenade attack hit the shoppers in the busy 'Sunday market' near the TRC centre in Srinagar, a group of heavily armed terrorists were trapped by the security forces in the Kaitsan forest area of Bandipora on Tuesday.

The security forces launched the operation on receipt of credible inputs about the presence of Operation was launched by the terrorists in the area. Till the time Indian Army, Jammu and Kashmir

Meanwhile, Sinha warned on Tuesday that the houses of those providing shelter to terrorists would be razed to the ground as he asked people to stand up against the perpetrators of terror. He also said if security forces, the Union Territory administration and people come together, then terrorism could be eliminated from the region in a year.

I have directed the forces not to harm any innocent but the culprits will not be spared. If anyone provides shelter to terrorists, then his house will be razed to the ground. There will be no compromise on it," the LG said at a function in north Kashmir's Baramulla district.

In a veiled reference to some of the politicians vocal on the issue, Sinha said some people make statements that atrocities are being committed on those providing shelter to terrorists. "However, this is not an atrocity, but a demand for iustice and such justice will continue," he added.

Sinha said some people are trying to disrupt the peace in Jammu and Kashmir. "Our neighbour is trying, but it does not worry us. It is the people here who are doing it on its directions (that is a cause of concern). It is not just the job of the forces and the security administration but the people as well to identify such people," he said. He added that if the forces, administration and people come together, then "it (terrorism) will not remain here for more than a year. But if the people give them shelter and then say we are doing injustice to them, then that is not right."

We have upheld validity of UP Madrassa Law: SC

In a big relief to Madrassas in Uttar Pradesh, the Supreme Court on Tuesday upheld the constitutional validity of the 2004 Uttar Pradesh Board of Madrassa Education Law, and set aside an Allahabad High Court verdict quashing it on the ground that it was violative of the principle of secularism. However, the Bench of Chief Justice of India (CJI) DY Chandrachud with Justices JB Pardiwala and Manoj Misra set aside provisions of the Act which empowers the Madarsa Board to prescribe course of instructions and text books for higher education - 'kamil' (postgraduate course) and 'fazil' (junior research programme). The SC held that these particular provisions are in violation of these the University Grants Commission Act (UGC Act). The Bench said that the High Court erred in holding that the law was violative of the principle of secularism. "We have upheld the validity of the UP madrassa law and moreover a statute can be struck down only if the State legislative lacks the competence," Chandrachud said while pronouncing the verdict.
The order came as a big relief

to teachers and students of UP Madrassas as the High Court had ordered closure of the seminaries and relocation of students to other schools in the state. On March 22, the High Court declared the Act as "unconstitutional" and violative of the principle of secularism, and asked the Government State accommodate madrassa students in the formal schooling system. In a breather for about 17 lakh Madrassa students, the SC stayed the HC order on April

The three Judge Bench of the SC said the legislative scheme of the law was to standardise the level of education being prescribed in Madrassas. The bench heard a battery of lawyers including senior advocates Abhishek Manu Singhvi, P Chidambaram, Mukul Rohatgi, representing petitioners against the HC verdict.

The SC said that a law can be struck down for violation of fundamental rights under part III of the Constitution or on grounds of legislative competence but not for violation of basic structure. "Statute can be struck down only for violation of part III or legislative competence and not for violating basic structure.

Who will be the next POTUS?

A presidential campaign marked by upheaval and rancour approached its finale on Election Day as Americans decided whether to send Donald Trump back to the White House or elevate Kamala Harris to the Oval Office.

Polls opened across the nation on Tuesday morning as voters faced a stark choice between two candidates who have offered drastically different temperaments and visions for the world's largest economy and dominant

military power. Harris, the Democratic vice president, stands to be the first female president if elected. She has promised to work across the aisle to tackle economic worries and other issues without radically departing from the course set by President Joe Biden. Trump, the Republican former president, has vowed to replace thousands of federal workers with loyalists, impose sweeping tariffs on allies and foes alike, and stage the largest deportation operation in US history.

The two candidates spent the waning hours of the campaign overlapping in Pennsylvania, the biggest battleground state. They were trying to energise their bases as well as Americans still on the fence or debating whether to vote at all.

"It's important, it's my civic duty and it's important that I vote for myself and I vote for the democracy and the country which I supported for 22 years of my life," said Ron Kessler, 54, an Air Force veteran from Pennsylvania who said he was voting for just the second time.

States cannot takeover all private properties: SC

In a majority 7:2 ruling, the Supreme Court on Tuesday held that states are not empowered under the Constitution to take over all privately-owned resources for distribution to serve the "common good". A nine-judge bench headed by Chief Justice DY Chandrachud, however, said states can stake claim over private properties in certain cases. Justice BV Nagarathna partially disagreed with the majority judgement penned by the CJI, while Justice Sudhanshu Dhulia dissented on all

aspects.

The majority verdict pronounced by the CJI Chandrachud overruled Justice Krishna Iyer's fivedecade-old ruling that all privately owned resources can be acquired by the State for distribution under Article 39(b) of the Constitution.

"We hold that not every resource owned by an individual can be considered a material resource of a community only because it meets the qualifier of material needs," said the majority of the judges led by CJI, supported by six Judges. The SC held that for a privately-owned property to qualify as a material resource of the community, it must meet certain tests first.

While reading her decision, Justice Nagarathna said she had concurred with the CJIled majority on certain issues and wrote some opinions in response to Justice Dhulia's judgement. "How does ownership and control of material resources privately owned transform into material resources of the community for distribution as best to sub serve the common good. This is the crux of my judgement," Justice Nagarathna said.

Speeding DTC bus mows down Delhi Policeman, IT student

Two days after two traffic policemen on duty were dragged on the bonnet of a car, two persons, including a Delhi Police constable, who was on a night patrolling duty, and a B.Tech student died in a gruesome incident after a Delhi Transport Corporation (DTC) bus mowed them down on Monday night, near the Monastery Market in North Delhi due to over speeding. The horror unfolded around

10.15 pm when a green DTC bus went out of control, climbing a pavement outside the Monastery Market on Ring road, and subsequently hitting a billboard pole. The impact of the collision was such that it knocked the billboard off from its base. The bus then hit a pedestrian and an on duty police constable of Civil Lines police

station. The vehicle finally came to a halt when it crossed the road, and crashed into a road divider. The crime scene revealed the severity of the disturbing accident with the

the road and the damaged bus that stood stranded in the middle of the road till it was towed in the late afternoon. "The green DTC bus, operating on the route from Sarai Kale Khan to Nand Nagari via ISBT, developed some technical snag. Around 10.38 pm, the Police Control Room (PCR) received multiple calls claiming that the bus had swerved off the road near the Monastery Market, causing extensive damage and leaving two people critically injured," Deputy Commissioner of

However, according to the police sources, the bus was speeding when the incident occurred, and a blood sample of the driver has been sent to test if he was under the influence of alcohol. The accident claimed two lives

'Batenge toh katenge' V/s 'Judenge toh jeetenge' BISWAJEET BANERJEE

In response, SP chief Akhilesh Yadav took to social media with the counterslogan "judenge toh jeetenge" (if we unite, we will win), emphasising positive politics. "In the interest of society, the Chief Minister should rethink

his negative outlook and consider changing his advisors," Yadav wrote, urging Adityanath to adopt a more inclusive approach. He added, "A good leader nurtures positive thoughts and keeps both his sleeves and arms

Collapse at Bullet Train site kills worker, injured three

One worker died as a temporary structure collapsed at a construction site on the Mumbai-Ahmedabad Bullet Train corridor in Gujarat's Anand district on Tuesday evening, officials said.

The incident took place at Vasad village, said Superintendent of Police (SP) Gaurav Jasani. "Preliminary information suggests that four workers were trapped

between concrete blocks, two of them have been rescued. One of the workers died in hospital," he added. A temporary structure of steel and concrete blocks being used for well foundation work fell down, said an official of the National High Speed Rail Corporation Limited (NHSRCL) which is executing the project. The site is near the Mahi river near Vadodara, and a rescue operation was being carried out using cranes and excavators, he added.

The four-day Chhath Puja began with 'nahai-khai' on

President of the All India Bhojpuri Samaj, Prabhunath Rai, said that nahai-khai denotes cleanliness and hygiene from "ghar to ghats".

"Chhath Mahaparva is the wor-ship of Lord Surya. In this puja, women pray for the longevity of their husbands and sons. Lord Surva is the real God, and by worshipping him, a person becomes healthy and ener-getic. This puja has been prac-tised since ancient times. It is clear in this puja that special care must be taken regarding cleanliness," he said.

He explained that Chhath Puja began on Tuesday with eating and bathing. Kharna will be celebrated on Wednesday (November 6), the main puja and 'arghya' will be offered on November 7. The 'arghya' will be offered to the rising Sun on November 8.

Rai stated that all senior officials from the Lucknow Municipal Corporation and Lucknow Development Authority, including Municipal Commissioner Inderjit Singh, visited the Laxman Mela ghats on Tuesday to review cleanliness and other security arrangements.

He mentioned that at the Chhath Puja Ghat, Laxman Mela grounds, grand lighting arrangements have been made along the banks of the Gomti River so that there are no issues with people coming and going. The police administration has set up a one-way directional route, allowing people to enter from one side and, after performing the puja, exit from the other side.

Steamers will be available on the Gomti river, and the water police have been deployed to ensure that no untoward incidents occur. Divers will also be

present. "Various officials have already visited the ghats to inspect the preparations," he said. He also stated that security DM takes stock of arrangements

A fter the alleged murder of an elderly priest in the Dubagga police station area on Sunday night, the police are yet to obtain any leads regarding the best of the little "This is why the case was registered under weaker sections," he said.

While the police maintain that the murder stemmed from a property and family dispute, the family members reject this theory, asserting that someone known to the victim was involved.

His wife Ramshri told reporters that after feeding him dinner, she had gone to her daughter Rajni's house next door. The roofs of both houses are connected. Ramshri heard the sound of people jumping on the tin roof of her house. Her daughter raised an alarm, suspecting a thief had entered the house. Ramshri called her husband but received no response. She then locked the gate of the house and went to her husband's portion. When she reached the door, it was bolted from the inside, and there was still no response. Looking through the grill with the help of her mobile's torch, she saw her husband lying on the floor. She called her son Umashankar and informed him about the incident. Soon, the sons and the police arrived at the scene. The police did not allow anyone to enter the house.

ple jumping onto the tin roof of their house. Fearing something untoward, she quickly went to her husband's home. When Umashankar entered, he found his father lying in a pool of blood, with apparent signs that his head had been When she switched on the torchlight on her mobile, she crushed.

Harisharan, originally from Mall, owned five houses in Lucknow. His three sons-Vijay Shankar, Dev Shankar, and Jaishankar—live together in one house in Saatganj Wazirbagh.

His fourth son Umashankar and fifth son Ramlakhan live in separate houses near the Thakurganj Mari Maata Temple.

Harisharan lived in one of the two houses in Maura Khera Shiv City, with his wife living next door with their daughter Rajni and son-in-law.

ADCP (West) Vishwajeet Srivastava said that there is a possibility that someone close to the priest may have been

involved in the murder. There is no evidence of robbery or theft. The mobile phone and valuables were found safe in the house. The killers seem to have entered the house with the intention of murder. We are investigating all possible motives, including family dis-

putes, property issues, and robbery," he said. There is also speculation in the area that Harisharan had another wife, with whom he had three children. Aman's father, following his

son's insistence, went to the office at Mama Crossing in May 2023, where he met Pawan Pandey, Sarvesh Pandey, Ajay Kumar, and

Chandra Shekhar Kumar, all of whom were said to be involved in the job placement. The fraudsters promised to secure Aman a position as a surveyor at NCERT in Bareilly, valid until the age of 58, with the job renewed every five years. They further stated that Rs 3.5 lakh would need to be paid in instalments for the jol

that an advance of Rs 50,000 would be required, and Rs 1.25 lakh would be due upon receiving a stationery kit. Following this, Aman transferred Rs 50,000 online to Pradeep Pandey as an advance. On the day the stationery kit was delivered, Rs 1.15 lakh in cash was handed over.

The accused told Aman's father

Subsequently, the fraudsters sent an appointment letter for the job via mobile phone, claiming to be from Sarvesh

Pandey, supervisor at NCERT. Upon receiving the appointment letter, Aman sent the remaining money to the fraudsters online. In total, Rs 3.5 lakh was paid to the accused. After receiving the appointment letter, Aman began his work in July 2023, visiting schools to collect data, which he sent to Krishnkant, the supervisor under the All India Programme Survey at NCERT. However, despite working, Aman did not receive any salary. When he enquired about his payment, the concerned individuals kept assuring him that his salary would be released soon. By the evening of July 26, 2024, all the accused's mobile numbers were switched off. Following a complaint, Vikas Nagar police have registered an FIR, and the matter is under investigation.

6-year-old girl killed in road mishap

Lucknow (PNS): A six-yearold girl was killed in a road accident while her parents suffered critical injuries after a speeding car hit the motorcycle the trio were riding in the Dubagga police station area. The incident occurred on Saturday, but a case was registered on Monday.

The police registered an FIR based on the complaint of the deceased child's uncle and are searching for the accused using the car's registration number. According to Sanjay, Ramjeet told him that he was leaving and would have to come back to the flat again. Ramjeet then went off for his

work, and Sanjay later left for the hospital with his wife. At around 9:56 am on the same day, Ramjeet contacted Sanjay and asked where the keys were, as he (Ramjeet) had arrived. Sanjay informed him that the keys were with the security guard and told Ramjeet to collect them from him. "When I

opened the door to the flat, I found that everything inside the room had been scattered. The lock chain of the bag kept in the room was also open, and Rs 2.75 lakh was missing. I had kept Rs 3 lakh for my treatment, of which I had taken Rs 25,000 to the hospital. The remaining Rs 2.75 lakh, along with my wife's gold chain weighing about 18 grams, and two gold rings weighing about 3 grams each, were also missing," Sanjay said He tried calling Ramjeet Rajbhar, but his phone was switched off. "I then went to Park Road and informed Dharm Prakash Chaudhary about the incident. He told me not to worry, assuring me that Ramjeet would be found and that my money would be returned," Sanjay added.

Sanjay said that Ramjeet's acquaintance, Gorakh Sahni from Maharajganj, who works as a cook at a residential apartment on Park Road, claimed to know Ramjeet and had also visited his house. "Don't worry, stay calm. I will go with you to his village and get your money back," Gorakh reassured Sanjay. The victim trusted Gorakh and returned to Diamond Apartment. "When I came to Park Road to meet Gorakh the following day, September 3 2024, I found that Gorakh was not there, and his phone was also switched off. I suspect that driver Ramjeet Rajbhar and cook Gorakh Sahni together stole my money and jewellery," the victim said. The police have registered a case in this regard.

The number of registered vehicles in the city has increased by 5.8 per cent since last year, according to the IITR post-monsoon report released recently.

A senior scientist from the IITR explained that the registered vehicle inventory for Lucknow city and other primary information were collected from the RTO (Regional Transport Office) as of March 31, 2024. Based on the vehicular inventory, a 5.8% increase in registered vehicle numbers was observed in the city from the previous year (2022-23).

The total number of CNG and electric buses operated by UPSRTC in the city is 55 and 146 respectively by 2024.

The city has also recorded continuous growth in the number of e-vehicles over the years. The number of multi-articulat-

ed vehicles has increased from 7,879 in 2022-23 to 8,233 in 2023-24. Light commercial vehicles have increased from 4,074 to 4,685, buses from IITR REPORT

5,076 to 5,362, from taxis 63,648 to 64,569, light motor vehicles from 11,240 to 22,426, two-wheelers from 2,012,795 to 2,098,522, cars from 544,698 to 599,023, tractors from 30,899 to 32,783, and trailers from 2,174 to 2,307. The total number of

vehicles has increased from 2,816,293 to 2,979,734. Autorickshaws have increased by 88 per cent, tempo taxis by 71.8 per cent, buses by 17.2 per and electric vehicles by 51 per cent. Various oil and gas com-panies have provided data on the total number of fuel outlets (petrol, diesel, and CNG) in Lucknow, which stand at 173. It was found that the con-

sumption of petrol, diesel, and CNG increased by 99.8%, 85.7%, and 141.5% respectively, while LPG consumption decreased by 78.1% in 2023-24. "Dominant sources of poor air quality in the city include traffic emissions, construction and demolition activities (buildings, flyovers, elevated roads. new roads), waste burning, cooking fuel combustion, road dust entrainment, etc. Despite

Remarkably, the unit can be fully operational within 12 minutes of deployment. Jointly developed and rigorously tested by the Indian Air Force, Indian healthcare institutions and defence technology experts, the Bhishma Cube exemplifies cutting-edge innovation in mobile healthcare." During his visit to Ukraine in August, Prime Minister Narendra Modi presented Bhishma Cube units to President Volodymyr Zelensky, underscoring its value in global emergency

FACE RECOGNITION CAMERAS TO BOOST SAFETY AT RLY STATIONS

In its efforts to make Maha Kumbh 2025 not only a grand event but also a safe one, the Uttar Pradesh government is enhancing security across both the Mela grounds and Prayagraj's railway stations.

With approximately 10 crore people expected to travel by train for Maha Kumbh, the railway authorities are implementing comprehensive security measures.

This capability helps control suspicious activities or potential stampede situations before they escalate. He added that for Maha Kumbh, approximately 650 CCTV cameras and 100 face recognition cameras will be installed at railway stations for the first time. Surveillance will cover routes, shelters and platforms at all nine railway stations in Prayagraj city. The security setup will be in place by the end of December, with all equipment operational by January, well ahead of the Maha Kumbh's commencement.

Local residents rushed the principal to a nearby hospital,

dead upon arrival. Upon receiving information about the murder, the police reached the scene and cordoned off the area.

Under the new rules, the selection and appointment of the state's police chief will be done by a committee chaired by a retired judge of the High Court.

'I have heard that arrangements are being made to grant a senior official a permanent position and extend his tenure by two years. The question is, will those making this arrangement themselves be around for two years? Could this be an attempt to take control from Delhi into their own hands? "Delhi vs Lucknow 2.0," the SP chief said in a post on X while responding to the UP government's new guidelines for selection and appointment of the

"The policy requires a nomination committee headed by a retired

judge of the High Court to appoint the police chief in the state. It also establishes a minimum tenure of two years for the DGP. The Uttar Pradesh government has

approved a new set of rules giving

itself the authority to appoint the DGP at the state level. Seeking the approval of the Union Public Service Commission for the appointment will no longer be required. In a cabinet meeting chaired by Chief Minister Yogi Adityanath, the Director General of Police, Uttar

Pradesh Selection and Appointment Rules, 2024 was approved. As per the new manual, the DGP

will be appointed only when there are at least six months left in the officer's service. To be eligible for selection, candidates must have six months of service remaining on the date of creation of the vacancy and only those officers who are currently serving as DG at Level 16 of the Pay Matrix will be considered for the new role.

The next UP assembly elections are due in March 2027, nearly two years from now. The Samajwadi Party, which gave a noteworthy performance in the recently concluded Lok Sabha elections, is hoping to continue the winning streak in the 2027 assembly polls.

UP bags top spot in **Veergatha Project 4.0**

Mayawati hails SC verdict on madrasas, private properties

Bahujan Samaj Party chief Mayawati, on Tuesday, said the Supreme Court's verdict on the madrasa law in Uttar Pradesh would end the controversy over education imparted in such institutes and the uncertainty surrounding them.

In view of the decision of the Supreme Court, there is a possibility of madrasas getting recognition, especially in Uttar Pradesh, and stability in their smooth functioning, the former chief minister of Uttar Pradesh said. In a post on X in Hindi, the BSP supremo said, "Welcoming the decision of the Hon'ble Supreme Court today declaring the UP Madrasa Education Board Act, 2004 as valid and constitutional. This will surely end the controversy over madrasa education in UP and the uncertainty of thousands of

madrasas.> "Its proper implementation is essential," she

The Supreme Court has upheld the constitutional validity of the Uttar Pradesh Board of Madrasa Education Law, 2004 and set aside an Allahabad High Court verdict quashing it on the grounds of being viola-

tive of the principle of secularism. The BSP chief also welcomed the Supreme

Court's decision on private properties.
"The decision of the 9-judge bench of the Supreme Court to not consider every private property as a part of community property under Article 39 (B) of the Constitution and to prevent its acquisition is also welcome," the former chief minister of UP said. Until now the government had the right to



acquire all private properties for the common good. In a majority 7:2 ruling, the Supreme Court held that states are not empowered under the Constitution to take over all privately-owned resources for distribution to serve the "common good".

Meanwhile, the BSP released the list of its star campaigners on Tuesday for the by-elections to be held on nine seats of the UP assembly. It includes 40 names, including BSP supremo Mayawati and Satish Chandra


These 'maharathis' will campaign for the victory of BSP in the by-elections.

Man kills wife, 3 children in | Chhath fervour grips Varanasi Kashi, found dead in village

 ${f I}$ n a shocking incident, a man allegedly killed his wife and three wards in Bhadaini area under the Bhelupur police station here on Tuesday. Later, the body of accused was found in his own semi-furnished house about 10 kilometres away from

The 45-year-old businessman shot dead his wife and three children and fled from the house. The incident is said to have taken place on Monday night. However, it came to the light on Tuesday morning as the neighbours thought that the sound of firing was of fire-crackers due to the festivals of Diwali and Chhath. About 10-12 hours after this sensational murder of four persons information came that the body of accused Rajendra Gupta was found in a village in Rohania police station area. The police had reached the spot to investigate the matter, last reports received here said. Rajendra Gupta's body was found in a semi-constructed house in Mirapur Lathia.

After receiving the information about the murder of four persons, the police of Bhelupur police station along with forensic experts and dog squad reached the spot. Rajendra Gupta lived there along with his wife Neetu (42), daughter Gaurangi (16) and sons Navnendra (20) and Subendra (15) in the street in front of the power house in Bhadaini. According to reports, the incident came into the light when maid reached the house on Tuesday morning and then the neighbours informed the police about it. When the police went to Rajendra's ĥouse, Neetu was lying dead in a pool of blood along with her three children. However, Rajendra was missing from

Prima facie, it has come to light that Rajendra was in contact with a 'tantrik'. According to some tenants Rajendra was influenced by a 'tantrik' who told the latter that his wife and children were an obstacle in his progress and that's why Rajendra killed his wife and children. Later, the police started searching for the *tantrik* along with Rajendra whose body was found later. According to the police, Rajendra's criminal history is being investigated.

The four-day famous Dala Chhath festival began in the holy city of Kashi with religious fervour on Tuesday with the 'Nahay Khay' (bathing and eating) event. Crowds of women were seen in different markets to purchase sugar canes, various types of fruits and other articles. Besides, efforts are going on in full swing to make the ghats of Ganga and Varuna rivers clean. Despite all efforts of the administration, many Ganga ghats still look dirty as large amount of silt was collected there due to the flood in the river earlier. Meanwhile, a good number of women reached various ghats to take a holy dip in the sacred water of the Ganga river before starting preparations for the festival. The tough 36hour long 'nirjal vrat' will start on Wednesday after 'Kharana'. Chhath-related articles were seen being sold on the roadside at various places in almost all the main markets, including Sigra, Lanka, Luxa, Godowlia, Chetganj, Maidagin, Jagatganj, trans-Ganga Ramnagar, Parao etc and many places in the trans-Varuna areas, including Shivpur, Bhojubir, Orderly Bazar, Pandeypur, Pahadia and Sarnath. In recent times, the festival has become very popular in the city as it is seen that lakhs of people turn up at ghats during the puja. According to information, in view of the high sale of fruits during the festival, hundreds of trucks of apples and bananas reached Pahadia Mandi, the biggest fruit market of

Purvanchal (eastern Uttar Pradesh), a day ago. However, the prices of various fruits have jumped up sharply by 20 to 30 per cent. Besides, efforts are also going on in Banaras Locomotive Works (BLW) to make Surya Sarovar ready for the festival.

As the first 'arghya' of the Chhath Puja will be offered to Surya Bhagwan at the sunset on November 7 while second and last on the next day at the time of sunrise which will mark the end of the festival, the local administration has made elaborate security and other arrangements both in the midstream of Ganga, its 88-odd ghats and adjoining areas where several traffic restrictions will be imposed from Thursday afternoon to late Friday morning hours. In view of Chhath festival, 45 motorboats of Water Police, National Disaster Response Force (NDRF) and PAC flood relief team will patrol in the Ganga from Samne Ghat to Namo Ghat and towards Ramnagar on November 7 evening and

November 8 morning. More than 800 policemen will be deployed on the Ganga ghats. Besides, Nagar Nigam has started preparations for barricading at famous ghats to control the crowd. Split skin grafting successful

A 75-year-old resident of Nihalapur was suffering from flesh-eating bacteria disease for two months. While undergoing treatment at a hospital in Pandeypur, about 20 per cent of the skin on his left leg had rotted. For its treatment, he was referred to New Delhi where he had to undergo plastic surgery. Due to his poor financial condition, he was poor financial condition, he was unable to get treatment. He was successfully treated at the Community Health Centre (CHC) Gangapur (Pindra) by split skin grafting method. This information was given by CHC Gangapur surgeon Dr Shrikant Patel here on Monday.

Dr Patel, who did the skin grafting said skin grafting skin

ing, said skin grafting is a surgical procedure, in which the skin of a damaged part of the body is replaced with healthy skin. In this procedure, healthy skin is taken from any other part of the body such as buttocks, thighs and upper arms. The place from where healthy skin is taken is called 'donor site' and the place where the skin is applied is called 'recipient site. The piece of healthy skin taken out to apply on the damaged skin is called 'graft' and when the graft is obtained, it is called 'autograft'. Chief Medical Officer (CMO) Dr Sandeep Chaudhary said efforts are being made to provide better medical services at all the CHCs of the district and under this the skin grafting

surgery done at CHC Gangapur is an excellent initiative. He praised the entire medical team, including the Superintendent of Gangapur CHC and congratulated them for successfully doing skin grafting.

India to launch European Space Agency's Proba-3 mission in December

India will launch the European Space Agency's Proba-3 mission early next month from the spaceport at Sriharikota, Science and Technology Minister Jitendra Singh said here on Tuesday. He said the two satellites that are part of the Proba-3 mission to study the Sun were brought to Sriharikota on Tuesday morning for integration with ISRO's Polar

(PSLV). "Proba-3 mission of the European Space Agency will be launched by a PSLV rocket from Sriharikota in the first week of December," Singh said at the Indian Space Conclave organised by the Indian Space Association. The mission is likely to be

Satellite Launch Vehicle

launched on December 4. The two Proba-3 spacecraft will be launched together by the PSLV-XL launcher and placed in the highly elliptical orbit which will ascend to 60,000 km away from Earth



before coming as low as just 600 km.

This high orbit is required because the pair of spacecraft will perform their active formation flying for a planned six hours at a time around their maximum altitude, where Earth's gravitational pull will be diminished, as will the amount of propellant needed to fine-tune their positions.

Proba-3's two satellites will enable sustained views of the Sun's faint surrounding atmosphere, or corona, that has previously only been

visible for a few brief moments during solar eclipses viewed from the Earth.

To achieve this the shadow being cast between the spacecraft must remain in a precise position, which means they must fly autonomously in formation to an accuracy of a single millimetre - about the thickness of an average

fingernail. This is the first time that an ESA mission is being launched from India since the original Proba-1 Earth-observing mission in 2001.

Climate driven changes in Ganga plains: DST Study

Tracing vegetation patterns in the Ganga plain from palaeoclimate records with the help of pollen and multi-proxy studies, a team of Indian scientists have shown how climate-driven vegetation changes played a crucial role in shaping human history in the Indian subcontinent over the last 2000 years. using Besides using pollen extracted from sediment

taken from cores Sarsapukhra Lake in Varanasi district, Uttar Pradesh, as well as other multiproxy analyses, the scientists from Birbal Sahni Institute of Palaeosciences (BSIP), an autonomous research institute under the Department of Science and Technology (DST), also employed the Earth System Paleoclimate Simulation (ESPS) model to reconstruct monsoon patterns over the past two millennia.

The study's findings show that alternating periods of warm and cold temperatures, such as the



Ages Cold Period, Medieval Warm Period, and Little Ice Age, significantly influenced vegetation and climate. These shifts in climate likely played a role in shaping human migrations, as well as the rise and fall of major Indian dynasties like the Guptas, Gurjar Pratiharas, and Cholas.

The study holds importance given that there is a notable scarcity of paleoclimate records for the late Holocene (approximately 2,500 years) in the Central Ganga Plain (CGP), highlighting a significant research gap in understanding past climate patterns in this region.

Cowardly attack

The temple attack in Canada raises concerns over the safety and rights of the Indian diaspora in Canada

he recent attack on the Hindu Sabha Mandir in Brampton, Canada, has once again brought to light the tense diplomatic situation between India and Canada, with both nations navigating an increasingly complex web of domestic and international issues. The incident, marked by violent clashes involving pro-Khalistani extremists outside the temple, was swiftly condemned by both Canadian Prime Minister Justin Trudeau and Indian Prime Minister Narendra Modi. However, the response from each leader underscores the stark differences in their approach, further straining bilateral ties. Prime Minister Modi's condemnation of the attack was resolute and pointed. Taking to social media, he expressed his disappointment over the attack, calling it a "deliberate" act against Hindu religious sentiments and stressing that "such acts of violence will never weaken India's resolve." PM Modi did not hold back from calling on the Canadian government to ensure justice and uphold the rule of law, sending a clear message that India expects Ottawa

to take decisive action to protect its diaspora. While Trudeau also condemned the temple attack, his statement notably avoided any direct mention of the pro-Khalistani extremists involved. This omission reflects a recurring issue in Trudeau's handling of Indiarelated tensions within Canada, where a vocal pro-Khalistani community has been implicated in acts perceived as hostile by India. Trudeau's hesitance to directly address this faction has been a persistent irritant in India-Canada relations, amplifying concerns in New Delhi about Ottawa's stance on issues impacting Indian diaspora and the wider Hindu community in Canada. The attack also comes at a time when broader diplo-

matic relations between the two countries are under significant strain, with recent allegations and counter-allegations creating a sense of mutual mistrust. Last September, Trudeau alleged that India might have been involved in the death of Hardeep Singh Nijjar, a known Khalistani activist, who was killed under mysterious circumstances in Canada. Although the Canadian Prime Minister has yet to provide concrete evidence for this claim, the accusation has deepened divisions between the two nations, prompting India to refute any such involvement and criticise the Canadian government's stance. Modi's recent comments have also touched on an additional point of contention: the alleged surveillance of Indian consular staff in Canada. This has not only raised security concerns but has also highlighted the increasing difficulty Indian diplomats face within Canadian borders. The presence of surveillance, paired with incidents like the temple attack, fuels a perception that pro-Khalistani extremists are becoming emboldened, even as Trudeau's administration appears reluctant to fully confront these groups. With each new incident - whether it be a temple attack or allegations of state-backed assassination plots - the divide only seems to grow wider, testing the resilience of both countries' commitments to a constructive relationship.

India's tribute to the architect of unity



In a historic tribute to Sardar Vallabhbhai Patel, the Government has announced sesquicentennial celebration to honour Patel's unyielding legacy in unifying India

Amit Shah has announced that to honour Sardar Patel's 'monumental contributions', to commemorate, his 'enduring legacy as the visionary behind the establishment of one of the world's most robust democracies and his pivotal role in unifying India from Kashmir to Lakshwadeep' which 'remains indelible, the government, under the leadership of Prime Minister Modi, will celebrate his sesquicentennial from 2024 to 2026.

After the nationwide movement to erect the Statue of Unity, this is another watershed occasion, when the legacy of Sardar Patel would be commemorated and cherished. This honour was long due and is richly deserved. The Sardar's centenary in 1975, was a given a short-shrift. It was deliberate. The Indira-led Congress, busy enforcing an unethical and draconian 'Emergency', had little time to commemorate Sardar

A commemoration would have certainly raised hard questions. Moreover, could Sardar's democratic legacy be commemorated, with the entire Opposition, minus the crooning communists, behind bars? One of Patel's foremost biographers, Rajmohan Gandhi, writing in 1991, spoke of how acknowledgements in the case of Nehru were 'fulsome' and in the case of Gandhi 'dutiful', but in the case of Patel, were 'niggardly.' Speaking of the Nehru centenary celebrations in 1989, Gandhi writes, that it 'found expression on a thousand billboards, in commemorative TV serials, in festivals and in numerous other platforms.' While Patel's centenary on October 31, 1975, four months after Emergency was clamped, 'was by contrast, wholly neglected by official India and the rest of the Establishment.'

In a long interview with Harry Hodson, British economist and his biographical opus, LK editor. Patel's shadow and troubleshooter-in-chief, VP Menon, recalled a day when the usually tolerant and absorbing Patel chose to talk back to Nehru. 'You think you made the Congress?', he snapped, 'We are all co-builders in it. You think I want your posi-



tion? If that was the case, I would not have resigned my Presidency and asked Gandhiji that you should take over. I told him that I would stand down.' 'There was rare emotion in the Sardar's voice, writes Narayani Basu in her biography of Menon citing that particularly acerbic encounter. The post Sardar Patel Congress was made to believe that it was Nehru alone who made it and therefore only he and his political progeny were worthy of commemoration and remembrance. VP was saddened to 'see that under the veil of idealism and greatness Nehru wrapped himself in, there existed a vindictive and petty man.

For someone who saw Patel so closely for many intense years, VP told Hodson, how Sardar 'died as a very, very bitter and sad man', and 'Panditji should never have treated him the way he did.' That propensity of negating Patel and his contribution to our national march percolated through Nehru's dynasty and the Congress that he shepherded post-Patel. In Advani has rightly described the Congress's dégringolade, after Patel, arguing that 'after Sardar Patel passed away, there was no one left in the Congress Party to counterbalance Nehru's negative views on various important issues.' very time we see death or attend a funeral, we experience something like cemetery-induced reclusion which makes our mind & body numb. This makes us question the very purpose of our life. We start thinking that if death is the be-all and end-all of it-all, and it can kill anyone, anytime, then why should we bother about doing good deeds and fear punishment for our sins? There are mainly two kinds of people who have two different beliefs in this regard.

The first kind of people believe in the rebirth of human beings and strongly feel that the account of our good and bad deeds will be settled on the day of judgment when the dead rise from their graves, and then there are the second kinds of people who not only believe that human souls are reborn, but they also feel that humans transmigrate into 8.4 million species before getting a human birth again. However, there is very little knowledge about the third kind of people who believe that human souls take rebirth and are always in the human body.

Let us suppose that humans are not reborn. In that case what reason would there be to perform good deeds and desist from bad ones? n a decisive step to enhance industrial growth in Punjab, the NITI Aayog in partnership with the Aayog in partnership with the Punjab Government, has sought feedback from stakeholders to explore the potential of MSMEs as a driver of export growth. This initiative is essential for identifying and promptly resolving industry challenges. To meet the objective of boosting Punjab's exports, MSMEs must be equipped with a comprehensive State Export Promotion Policy, linking them to sustainable growth and significant employment gengrowth and significant employment gen-

Exports are a fundamental pillar of a state's development, and a strategic geo-graphical location is vital for ensuring global competitiveness and job creation factors for robust economic growth. For instance, Haryana once a barren expanse, has emerged as one of the top five states for export value, thanks to its advantageous proximity to the National Capital Region (NCR). Currently, Haryana outpaces Punjab with five times more exports. Coastal states with access to seaports are a step ahead in engaging in international trade, while landlocked regions like Punjab endure higher trade costs and transit challenges. It is unacceptable that policymakers have not prioritised Punjab's geographical disadvantages as a landlocked border state. The remoteness from seaports, inadequate connectivity, and frequent protests have created significant barriers to investment, resulting in a concerning decline in the industrial sector—a crisis that Punjab can no longer afford to ignore. The non-competitive environment for Punjab's MSMEs, stemming from their distance from seaports, must be addressed head-

These challenges are surmountable, and it is crucial to focus on empowering Punjab's vital MSMEs, which have the potential to become an "Export Engine" and deserve a fair platform to compete on equal terms. According to NITI Aayog's latest Export Preparedness Index (EPI), Punjab ranks a disappointing 10th with a score of 58.95, while Haryana Notably, Gujarat has the highest number AND COMPELLING of districts among the top 25 in the country for export share (54 per cent), followed by Maharashtra with five districts, Haryana with one, and Punjab with none—only a meagre 2 per cent of the country's exports.

Therefore, it is essential for Punjab to actively engage in export promotion initiatives for every potential MSME to dramatically increase its export figures. Why a State-Specific Policy Needed: The Foreign Trade Policy (FTP) for 2023-2028 has set an ambitious target of achieving \$2 trillion in exports by 2030. However, with 766 districts across the country, it is unacceptable that only 43 cities designated as centres of export excellence receive crucial financial incentives for global market surveys, brand promotions, warehouse establishment, and zero customs duty on capital goods for export-oriented production.

This glaring disparity in the distribution of incentives underscores the urgent need for a more inclusive, state-specific policy. The current focus on a handful of Towns of Export Excellence' severely undermines the principles of 'One District, One Product' and 'Sabka Saath,

Every district in Punjab possesses significant untapped potential.

It is essential to identify addition al districts for bolstering export operations, aligning with the imperative 'Vocal for Local' and 'Make in India' initiatives. India's vision of transforming each district into an export hub demands the active engagement of MSMEs from all districts. The time for action is now.MSMEs Export Potential: Punjab boasts an impressive 14.65 lakh MSMEs, which are the backbone of the state's industrial growth and are primed for global expan-

These MSMEs are powerful hubs, excelling in industries such as textiles and apparel, bicycles, hosiery, tractors, automobile components, hand tools, machine tools, sports goods, engineering goods, footwear, and leather goods. They constitute a staggering 99.7 per cent of all MSMEs in the region, employing 65 per cent of the industrial workforce and generating 78 per cent of the state's total industrial output. These industrial clusters possess immense poten-

tial and can be fostered further.Ludhiana stands as a powerhouse, ranking first(Rs 20,140 Crore export business) among the top ten exporting districts with an export business valued at Rs 55,844 Crore for 2023-24. It leads the nation by producing 92 per cent of India's bicycle parts and 75 per cent of all bicycles, commanding an 80 per cent share in bicycle exports from India.

While India currently lags behind China in bicycle exports, we have a clear and compelling opportunity to elevate our global export targets by at least 10 per cent over the next two to three years, particularly in untapped markets in the US, Europe, and Africa. In the farm equipment sector, Punjab is a force to be reckoned with, hosting one-third of the total original equipment manufacturers (OEMs) and standing as the leading tractor manufacturer. With a commanding 34.3 per cent share in exports, Sonalika ITL stands as the largest tractor exporter(Rs 3000 Cr) in 2023-24. Despite India's current 2.2 per cent share in the global market, the potential for over 2 lakh tractors to be exported in the next 2-3 years to burgeoning markets such as Brazil, Argentina, Turkey, SAARC, and African nations is undeniable. Jalandhar dominates the sports goods sector,

producing 45 per cent of the nation's total and contributing to 75 per cent of the country's sports goods exports. While China cur-rently leads with a 42.2 per cent share, India's scant 0.56 per cent share of global exports highlights the tremendous untapped potential for growth. The time is ripe for Punjab to seize lucrative opportunities in markets like the USA, UK, Brazil, Germany, Mexico, South Africa, Colombia, and Argentina, and make a formidable mark on the global stage. The Way Forward: To enhance the competitive edge of MSMEs in foreign trade, it's crucial to allow the flow of bilateral trade from Punjab through the Wagah Border of Pakistan to Middle Eastern countries, CIS nations, Europe, and the US. Establishing a Directorate of Exports in the state is vital for aligning the state and central gov-

Harris already voted by mail in her home state of California. She'll have a watch party at her alma mater, Howard University in Washington. Each candidate would take the country into new terrain. Harris, 60, would be the first woman, Black woman and person of South Asian descent to serve as president. She also would be the first sitting vice president to win the White House in 32 years. A victory would cap a

other in American history. Harris ascended to the top of the Democratic ticket less than four months ago after Biden, facing massive pressure from his party after a disastrous debate performance, ended his reelection bid.

Trump, 78, would be the oldest president ever elected. He would also be the first defeated president in 132 years to win another term in the White House, and the first person convicted of a felony to take over the Oval Office.

Having left Washington abandoned by some allies after January 6, Trump defeated younger rivals in the Republican primary and consolidated the support of longtime allies and harsh critics within his party. He survived an assassination attempt by millimetres at a July rally. Secret Service agents foiled a second attempt in September.

A victory for Trump would affirm that enough voters put aside whirlwind campaign unlike any warnings from many of Trump's

former aides or instead prioritised concerns about Biden and Harris' stewardship of the economy or the US-Mexico border. It would all but ensure he avoids going to prison after being found guilty of his role in hiding hush-money payments to an adult film actress during his first run for president in 2016. His sentencing in that case could occur later this month. And upon taking office, Trump could end the federal investigation into his effort to overturn the 2020 election results. The election has huge stakes for America and the world. The potential turbulence of a second Trump term has been magnified by his embrace of the Republican Party's far right and his disregard for long-held democratic norms. Trump has used harsh rhetoric against Harris and other calling Democrats, them "demonic", and has suggested military action against people he calls "enemies from within". Harris,

pointing to the warnings of Trump's

former aides, has labelled him a "fascist" and blamed Trump for putting women's lives in danger by nominating three of the justices who overturned Roe v. Wade. In the closing hours of the campaign, she tried to strike a more positive tone and went the entire last day Monday without saying her Republican opponent's name. Heading into Election Day, federal, state and local officials expressed confidence in the integrity of the nation's election systems. They nonetheless were braced to contend with what they say is an unprecedented level of foreign disinformation - particularly from Russia and Iran - as well as the possibility of physical violence or cyberattacks.

Both sides have armies of lawyers in anticipation of legal challenges on and after Election Day. And law enforcement agencies nationwide are on high alert for potential violence. The outcome of the race was being closely watched around

the world, with the future of American support for Ukraine, US fidelity to its global alliances and the nation's commitment to stand up to autocrats hanging in the

Harris has vowed to continue backing Kyiv's defence against Russia's full-scale 2022 invasion. Trump has sharply criticised Ukraine, praised Russian President Vladimir Putin and suggested he would encourage Russia to attack NATO allies of the US that Trump considers delinquent.

Voters nationwide also were deciding thousands of other races that will decide everything from control of Congress to state ballot measures on abortion access. More than 82 million people voted early shy of the record set during the 2020 pandemic, when Trump encouraged Republicans to stick to voting on Election Day. This time, he urged his voters to lock down their ballots in advance and they complied in droves.

Israeli strikes kill 30 in Gaza Elon Musk's USD 1 million-a-day voter

▼ sraeli strikes killed at least 30 people overnight in Gaza, according to Palestinian health officials. Strikes early Tuesday killed 10 people in the Gaza Strip, including four children and two women, and a strike late Monday on the northern Gaza town of Beit Lahiya killed at least 20 people, including eight women and six children. Israel has been waging a massive offensive in northern Gaza — which was already the most isolated and heavily destroyed part of the territory — for nearly a month.

Despite growing pressure from the United States and others in the international community for a cease-fire in Gaza and Lebanon, intensified Israeli strikes against the Hezbollah militant group are expanding beyond Lebanon's border areas. Israel is also fighting a seemingly endless war against Hamas in northern Gaza.

Since the conflict between Israel and Hezbollah erupted in 2023, at least 3,000 people

13,500 wounded in Lebanon, the Health Ministry reports. More than a year of Israel's war against Hamas in Gaza has killed more than 43,000 people, Palestinian health officials say. They do not distinguish between civilians and combatants, but say more than half of those killed were women and children. The war began after Palestinian militants stormed into Israel on October 7, 2023, killing some 1,200 people — mostly civilians — and abducting 250 others.

The Lebanese Red Cross will try again to remove bodies from a strike site: The Lebanese Red Cross will send another convoy Tuesday to Wata al-Khiam in southern Lebanon to search for and remove the bodies of 15 people killed in an Israeli airstrike, Lebanon's state-run National News Agency said.

Paramedics accessed the site of the strike two days prior and removed five other bodies, but needed to return with larger vehicles to remove the rubble.

Most appear to have been militants killed in battles with Israeli forces, but the dead also include civilian bystanders and people killed during protests. Palestinians have carried out dozens of stabbing, shooting and car-ramming attacks against Israelis since the

sweepstakes can proceed, says judge

The USD 1 million-a-day voter sweepstakes that Elon Musk's political action committee is hosting in swing states can continue through Tuesday's presidential election, a Pennsylvania judge ruled Monday.

Common Pleas Court Judge Angelo Foglietta — ruling after Musk's lawyers said the winners are not chosen by chance — did not immediately give a reason for the ruling. Philadelphia District Attorney

Larry Krasner had called the sweepstakes a scam that violates state election law and asked that it be shut down. The winners of the sweepstakes

did not win by chance but are instead paid spokespeople for the group, Musk's lawyers said in court Monday.

Musk lawyer Chris Gober said the final two recipients before Tuesday's presidential election will be in Arizona on Monday

and Michigan on Tuesday.

"The USD 1 million recipients are not chosen by chance," Gober said Monday. "We know exact-ly who will be announced as the ÚSD 1 million recipient today and tomorrow."

Chris Young, the director of America PAC, testified that the recipients are vetted ahead of time, to "feel out their personality, (and) make sure they were someone whose values aligned" with the group. The disclosures prompted a

lawyer for District Attorney Larry Krasner to call the effort a "scam" that is "designed to actually influence a national election." Musk's lawyers, in closing arguments, called it "core political speech" given that participants sign a petition endorsing the US Constitution. They said Krasner's legal bid to shut down the sweepstakes under Pennsylvania law was moot because there would be no more Pennsylvania winners before the programme ends

Krasner believes the giveaways violates state election law and contradict what Musk promised when he announced them during an appearance with Republican presidential nominee Donald Trump's campaign in Harrisburg, Pennsylvania, on October 19.

"We're going to be awarding a million dollars randomly to people who have signed the petition every day from now until the election," Musk vowed. Young also acknowledged that

the PAC made the recipients sign nondisclosure agreements.
"They couldn't really reveal the truth about how they got the money, right?" asked Krasner lawyer John Summers.

"Sounds right," Young said. In an October 20 social media post shown in court, Musk said anyone signing the petition had "a daily chance of winning USD

Summers grilled him on Musk's

and "randomly," prompting Young, who also serves as the PAC's treasurer, to concede the latter was not "the word I would have selected."

Young said the winners knew they would be called on stage but not specifically that they would win the money.

Musk did not attend the hearing. He has committed more than USD 70 million to the super PAC to help Trump and other Republicans win in November.

"This was all a political marketing masquerading as a lottery," Krasner testified Monday morning. "That's what it is. A grift." Lawyers for Musk and the PAC said they do not plan to extend the lottery beyond Tuesday. Krasner said the first three winners, starting on October 19, came from Pennsylvania in the days leading up to the state's October 21 voter registration

US gives Israel 'fail' grade on improving aid to Gaza so far

The Biden administration is stepping up criticism of Israel for not doing enough to improve humanitarian conditions in Gaza as a 30-day deadline looms for Israeli officials to meet certain requirements or risk potential restrictions on military assis-

The administration also is condemning recent violence against Palestinians in the West Bank by extremist Jewish settlers and says those responsible must be held to account.

State Department spokesman Matthew Miller on Monday gave Israel a "fail" grade in terms of meeting the conditions for an improvement in aid deliveries to Gaza laid out in a letter last month to senior Israeli officials by Secretary of State Antony Blinken and Defence Secretary

Llovd Austin. He said there were still roughly nine days until the deadline expires, but that limited progress thus far has been insufficient. "As of today, the situation has not significantly turned around," Miller told reporters. "We have

seen an increase in some measurements. But if you look at the stipulated recommendations in the letter, those have not been

A day before the election, the Biden administration called out its close ally, with support for Israel a key issue for many voters and the humanitarian crisis for Palestinians also a factor for many in the race. Canadian cop suspended for attending pro-Khalistan protest outside Hindu temple

A Canadian police officer has been suspended for participating in a pro-Khalistan protest outside the Hindu Sabha temple in Brampton, according to a media report. On Sunday, protestors carrying Khalistani flags clashed with people at the Hindu temple and disrupted a consular event coorganised by the temple authorities and the Indian Consulate.

There were unverified videos circulating on social media about the protest. The videos appeared to show demonstrators holding banners in support of Khalistan, as reported by the Canadian Broadcasting Corporation.

The Peel Police is "aware of a video circulating on social media which shows an off-duty Peel Police officer involved in a demonstration," said Media Relations Officer Richard Chin in an email to CBC News.

"This officer has since been suspended in accordance with the Community Safety and

Policing Act," he said. "We are investigating the circumstances in totality depicted in the video and are unable to provide further information until such time that this inves-

tigation is complete." Peel police previously said three people have been charged after violence erupted as Indian consular officials visited the Hindu Sabha Mandir temple Sunday. Videos circulating on social media show demonstrators holding banners in support of Khalistan, the CBC report added.

Korea fires multiple missiles towards sea ahead of US election

North Korea on Tuesday fired multiple short-range ballistic missiles toward its eastern sea, the South Korean military said, as the country continued its weapons demonstrations hours before the US presidential election.

South Korea's Joint Chiefs of Staff didn't immediately specify the number of missiles detected or how far they flew. Japan's Defence Ministry said the missiles were believed to have already landed at sea and there were no immediate reports of damage.

The launches came days after North Korean leader Kim Jong Un supervised a flight test of the country's newest intercontinental ballistic missile designed to reach the US main-

In response to that launch, the United States flew a longrange B-1B bomber in a trilateral drill with South Korea and Japan on Sunday in a show of force. That drew condemnation from Kim's powerful sister, who on Tuesday accused North Korea's rivals

'aggressive and adventuristic military threats."

South Korean officials have said that North Korea was likely to dial up its military displays around the US presidential election to command the attention of Washington. South Korea's military intelligence agency said last week that North Korea has also likely completed preparations for its seventh nuclear test.

Outside officials and analysts say North Korea eventually hopes to use an expanded nuclear arsenal as leverage to win concessions such as sanctions relief after a new US president is elected. There are widespread views

that Kim would prefer a win by Republican candidate Donald Trump, with whom he engaged in high-stakes nuclear diplomacy in 2018-19, seeing him as a more likely counterpart to give him what he wants than Democratic candidate Kamala Harris.

During campaigning, Trump boasted about his personal ties with Kim, while Harris said she

North Korean state media claimed last week that the Hwasong-19 it tested on October 31 was "the world's strongest" ICBM, but experts say the solid-fuel missile was too big to be useful in a war situation. Experts say North Korea has yet to acquire some critical technologies to build a functioning ICBM, such as ensuring that the warhead survives the harsh conditions of atmospheric re-entry.

Tensions between the Koreas are at their highest point in years as Kim has repeatedly flaunted his expanding nuclear weapon and missile programmes, while reportedly providing Russia with munitions and troops to support President Vladimir Putin's war in Ukraine.

According to the US, South Korean and Ukrainian intelligence assessments, North Korea is estimated to have sent between 10,000 and 12,000 troops to Russia. If they start fighting against Ukraine forces. it would mark North Korea's won't "cozy up to tyrants and first participation in a largescale conflict since the end of the 1950-53 Korean War.

On Monday, US State Department spokesperson Matthew Miller told reporters that as many as 10,000 North Korean soldiers were in Russia's Kursk region near Ukraine's border and preparing to join Moscow's fight against Ukraine in the coming days. That's up from the 8,000 troops that the US government mentioned Thursday.

After a meeting in Seoul on Monday, South Korean Foreign Minister Cho Tae-yul and EU foreign policy chief Josep Borrell expressed "deep concern" over the possibility that Russia might transfer nuclear or ballistic missile-related technology to the North in exchange for its arms and military personnel.

Such transfers would "jeopardize the international nonproliferation efforts and threaten peace and stability on the Korean Peninsula and across the globe," they said, while calling on North Korea and Russia to immediately withdraw the North's troops from

S Korea fines Meta \$15 m for illegally collecting information on Facebook users

South Korea's privacy watchdog on Tuesday fined social media company Meta 21.6 billion won (\$15 million) for illegally collecting sensitive personal information from Facebook users, including data about their political views and sexual orientation, and sharing it with thousands of advertisers.

It was the latest in a series of penalties against Meta by South Korean authorities in recent years as they increase their scrutiny of how the company, which also owns Instagram and WhatsApp, handles private information. Following a four-year investigation, South Korea's Personal Information Protection Commission concluded that Meta unlawfully collected sensitive information about around 980,000 Facebook users, including their religion, political views and whether they were in samesex unions, from July 2018 to March 2022.

It said the company shared the data with around 4,000 adver-

South Korea's privacy law provides strict protection for information related to personal beliefs, political views and sexual behavior, and bars companies from processing or using such data without the

involved. The commission said Meta amassed sensitive information by analyzing the pages the Facebook users liked or the advertisements they clicked

The company categorized ads to identify users interested in themes such as specific religions, same-sex and transgender issues, and issues related to North Korean escapees, said Lee Eun Jung, a director at the commission who led the investigation on Meta.

"While Meta collected this sensitive information and used it for individualized services, they made only vague mentions of this use in their data policy and did not obtain specific consent," Lee said. security measures such as removing or blocking inactive pages. As a result, hackers were able to use inactive pages to forge identities and request password resets for the accounts of other Facebook users. In September, European regulators hit Meta with over \$100 million in fines for a 2019 security lapse in which user passwords were temporarily exposed in an unencrypted form. Meta's South Korean office said it would "carefully review" the commission's decision, but

more comment. In 2022, the commission fined Google and Meta a combined 100 billion won (\$72 million) for tracking consumers' online behavior without their consent and using their data for targeted advertisements, in the biggest penalties ever imposed in South Korea for privacy law

violations. The commission said then that the two companies didn't clearly inform users or obtain their consent to collect data about them as they used other websites or services outside their own platforms. It ordered the companies to provide an "easy and clear" consent process to give people more control over whether to share information about what they do online.

The commission also hit Meta with a 6.7 billion won (\$4.8 million) fine in 2020 for providing personal information about itsx users to third parties without consent.

Living the American dream: A challenging journey for Indian immigrants

The pursuit of living an American dream isn't always as shiny as it looks from outside for the Indian immigrants. While navigating the complex US immigration system, it can be fraught with

obstacles. The path to permanent residency and citizenship can be long, uncertain, and emotionally taxing, often putting a strain on personal and professional lives.

For many people, the H-1B visa is a conundrum. While a popular route for skilled Indian

workers, it comes with its own it won't work for me." set of challenges as it has a limited availability. The annual cap on H-1B visas means that many qualified applicants are left out due to the lottery sys-

Ajeet who came to this country realised that the H1B route wasn't meant for him. He calls the US immigration system "broken".

"I call this the broken immigration system. India is such a large country and we are given the same seven per cent quota as any other small country. How is it fair? I figured the H1B system is a lottery system and

He chose to start a business and sponsor his own visa. He runs a fast casual Indian restaurant that he says serves healthy Indian food at a very fast pace. As a young woman full of dreams, Meeta Damani came to the US from India about 20 vears ago. For several years, she couldn't work in the country and stayed as a dependent.

This period traumatised her and she went into depression. "I went through a terrible depression and then I decided to make a documentary on the issue to tell this story through that. They didn't allow depen-

dents on H4 work back then and even now it is very sketchy. I think what is needed is a permanent solution to the H4 issue, what we have as of now is just an executive order and anyone tomorrow can change it," she said. Spouses and children of H-1B

visa holders face their own set of challenges. Many dependent visa holders are not allowed to work, leading to financial strain and loss of professional identity. Children on dependent visas may face obstacles in pursuing

higher education or finding employment after turning 21.

Rahael has been in the US for the last 14 years now. Due to delays in the naturalisation process, her 17-year-old daughter runs the risk of "aging out" in a few months.

"I have been here on a dependent H4 visa. My daughter is turning 18 this month and she will go to college next year. She has to let go of a lot of opportunities because of this. She is aging out and if our citizenship status doesn't change until she turns 21, she runs the risk of being sent back to India," Rahael said.

For Indian immigrants, the path to permanent residency or

green card is particularly daunting. Due to per-country limits, Indian nationals can face wait times of 50 years or more for employment-based

green cards. Sonal Sharma has been working as an immigration lawyer for 10 years in the New Jersey area. She says she gets to see such desperate situations with her clients caught in the immigration conundrum.

There are a lot of stories I come across. One of them I can remember is when a principal H1B member passed away and the dependents didn't not know what to do then. They sudden-

ly had no place to call home. It have the right spirit, you can is a sad situation", Sharma said. She feels that the backlogs and the long wait for green cards is causing people to lose so many opportunities. There is a lot of uncertainty with this system for immigrants. Priya, a marketing professional, is also a social media influencer who along with her husband talks about immigration issues in the US. They are very popular among youngsters and other Indians who seek solutions to their

immigration issues. "Evervone's story is very unique when you come here. But what we have learnt is that if you

Government launches Phase II of subsidised wheat flour, rice sale under 'Bharat brand'

government Tuesday launched phase-II retail sales of wheat flour and rice under the Bharat brand at subsidised rates to provide relief to consumers

from high prices. Wheat flour (atta) will be sold at Rs 30 per kg and rice at Rs 34 per kg in 5kg and 10kg packets through cooperatives NCCF, Nafed and Kendriya Bhandar and ecommerce platforms.

"This is a temporary intervention to provide relief to consumers," Food Minister Pralhad Joshi said after flagging off the mobile vans of these cooperatives.

The government has allocated 3.69 lakh tonne of wheat and 2.91 lakh tonne of rice from the Food Corporation of India (FCI) for the phase-2 retail intervention under the Price Stabilisation Fund.

This intervention will continue till the allocated stock gets exhausted. If more (is) required, we have enough stock and will allocate again," Joshi said.

Under the new pricing structure, wheat flour will be available in 5kg and 10kg packs at Rs 30 per kg, while rice will be sold at Rs 34 per kg -- a slight increase from Phase-I rates of Rs 27.5 and

Rs 29 per kg, respectively. Addressing concerns over lower rice sales in Phase I, Joshi emphasised that the government's objective wasn't business-oriented.

"Our motto is to give relief to consumers and control prices in the market," he said, adding that the government would consider introducing smaller pack sizes demanded.

The minister also called for a study to understand price firmness despite surplus rice stocks, though maintaining those prices were "largely under control", with only slight fluctuations in normal quality varieties.

The previous phase, from October 2023 to June 30, 2024, saw the distribution of 15.20 lakh tonne of wheat flour and 14.58 lakh tonne of rice.

On future allocations, Joshi assured adequate stocks for continued intervention if required.

Minister of State for Food BL Verma and Food Secretary Sanjeev Chopra were also present at the event.



Tenders have been floated for buying organic cow dung at Rs 3 per kg, and the successful bidders will also provide bags, transportation and stocking facilities, State Agriculture Minister Chander Kumar said on Tuesday. With a thrust on organic

farming, hi-tech techniques will be used in agriculture to increase farmers' income, he said, adding that the monthly income of a farm family should be between Rs 20,000 to Rs 25,000 to sustain agriculture.

The Congress party had promised to buy cow dung at Rs 2 per kg before the last assembly polls, but we do not wish to buy raw cow dung and would purchase organic dung for Rs 3 per Kg, he told

Paris Olympics displaced nearly 20,000 people, local associations say

Nearly 20,000 people were forcibly displaced in the lead-up to the Paris Olympics

lead-up to the Paris Olympics from tent camps or shelters in the Paris region, a coalition of more than 100 community groups said Monday. In its report, the group Le Revers de la Médaille, which translates as "the other side of the medal", claimed that 19,526 people were displaced from informal housing between April 2023 and September 2024 as part of what it calls "social cleansing" by authorities. The report notes that some people were notes that some people were evicted multiple times and, as a result, may be counted more than once.

than once.
As the city prepared to host millions of spectators for the Games, facilities and infrastructure underwent significant renovation, which the report alleges included the eviction of migrants and squatters from visible locations near event venues.

locations near event venues. Paul Alauzy, spokesperson for Le Revers de la Médaille, claimed that there is direct evidence linking these displacements to Olympic preparations.

There are images, internal government documents, and eviction orders explicitly referencing the Olympics as justification," Alauzy said on Monday. Monday.

The group's data highlights a surge in eviction operations - 260 between April 2023 and Sept 2024 - up 41% from the same period in 2021-2022.

French officials did not immediately respond to the group's estimate. The city imposed exceptionally strict security measures for the Games and notably the Games and notably the unprecedented opening ceremony all along the Seine River, which required a double-checked process and a QR code to attend.

French President Emmanuel Macron also addressed the issue in August, claiming that France had successfully created a social legacy linked

to the Olympics.
"I'm not forgetting that we have succeeded in creating a social legacy for the Olympic Games, with more than 200 marginalised people who used to live on the streets around the venues now having a permanent home," Macron said at a conference on Aug 12, the day following the Olympics closing ceremony.

In its report, the coalition is now advocating for a reevaluation of the Olympic hosting model, proposing a permanent site for future editions and more sustainable practices to mitigate the risk of displacements.

Currently, Agni Chopra's First-Class average stands at a box office 99.06 and it has attracted as much, may be even more, attention as some of the biggest Bollywood chartbusters his father has So, what is the secret of his levels, has come in the Plate produced.

In only nine games since his debut in the Ranji Trophy Plate league for Mizoram earlier this year, Agni, son of Bollywood filmmaker Vidhu Vinod Chopra and film critic Anupama Chopra, has garnered 1585 runs with eight hundreds and four fifties.

So I've not thought about anything else. My second goal was to score double hundreds because last vear I didn't score a single double hundred," said Agni, adding that specific work on his fitness has also helped him pile up big scores. His domination of bowlers, which has seen his average touching Bradmanesque-

League so far, and Agni nourishes the dream of getting into Elite League with Mizoram.

"I don't think too far into the future. Of course, in terms of the larger picture, I would love to be picked in the Duleep Trophy, or India A, to play in the IPL, to hopefully, one day, represent India," he said.

"For me what works best is (when) I always focus on the next game. I don't even think about the second game. I only think about what's next because in order to play for India, I have to do well in the next game."

But for it, Agni knows that, he will have to play in the Elite



segment of the Ranji Trophy. "I would love to represent an Elite division team, then maybe play for IPL and India. But to do those things, I have to play well at the level I'm playing right now and to do that, I also have to score runs in the next game. So, I genuinely think about only the next game," he said.
