## Amit Shah's ultimatum: 'Hemant Soren's days are numbered

PNS: JAMSHEDPUR

Union Home Minister Amit Shah on Monday made a strong political pitch during the Vijay Sankalp Sabha at Adityapur football ground, where he claimed that the 'countdown for Hemant Soren has begun," promising strict action against those involved in corrupt practices. He warned that BJP would bring Jharkhand's corrupt leaders to justice, claiming that under a BJP-led government, corrupt officials would face severe consequences for their actions.

Addressing a crowd. Shah announced that a BJP government would ensure that intruders marrying local women would not have any legal claim to Jharkhand's land. He emphasized that any land acquired by intruders under the pretext of marriage would be repossessed. Shah committed to establishing a committee to identify and take action against intruders, stating that the initiative would be launched as soon as the BJP forms a government in the state.

Shah took the opportunity to accuse the current administration, led by Hemant Soren, of widespread corruption. He cited recent law enforcement recoveries. including Rs. 350 crores and 30 crores allegedly confiscated from the homes of a



Congress MP and a state minister, as evidence of corruption within the government. He expressed support for Champai Soren, who, he alleged, faced mistreatment

for opposing infiltration. During the event, Shah also extended birthday greetings to Champai Soren, the MLA from the Seraikela constituency, who rose and acknowledged the crowd in

In his 22-minute speech, Shah launched a comprehensive critique of the Soren administration, declaring that the countdown for Hemant Soren's tenure had begun. He assured the public that if BJP takes power, it will tackle unemployment by implementing policies to pro-

vide relief to the state's job-

seeking youth.

Shah's speech was met with significant attention, reflecting BJP's intensified focus on Jharkhand ahead of the upcoming elections. The BJP's promises on infiltration, unemployment relief, and anti-corruption measures are expected to resonate with a segment of the electorate. highlighting issues that could shape the political landscape in

Jharkhand. Shah highlighted the case of Champai Soren, who,

according to him, faced public humiliation and removal from his position for raising concerns about Bangladeshi infiltration. Shah assured the people of Seraikela that a government would honor and support Champai Soren, contrasting his treatment under the current administration

Detailing BJP's promises for Jharkhand, Shah criticized the Jharkhand Mukti Morcha (JMM), Congress, and Rashtriya Janata Dal (RJD) as parties plagued by corruption. He referenced recent controversies involving large cash recoveries. including the significant sum discovered at the home of Alam Gir Alam's servant, as evidence of alleged deepseated corruption within the state's ruling parties. Shah emphasized that a BJP-led government would launch strict anti-corruption measures, holding those responsible accountable.

The issue of Bangladeshi infiltration was a focal point of Shah's speech, with the Home Minister reiterating BJP's commitment to safeguarding Jharkhand's borders and addressing public concerns about the impact of unchecked migration. He appealed to the crowd, stating that only a BJP government would take decisive action to protect Jharkhand's resources and integrity.

Chief Minister Assam Biswa a high-energy addressed rally at Birsanagar, where he made strong remarks about the current state government, accusing it of failing to deliver on its promises and fostering corruption. Sarma, speaking before a large crowd, termed the upcoming elections as a crucial battle for the state's future, particularly focusing on the issues of land, security, and livelihoods. ## Strict Guidelines: Campaigning ends, dry day begins

With the voting date set for November 13, in East Singhbhum district, the District Election Officer Ananya Mittal and Senior Superintendent of Police Kishore Kaushal announced the enforcement of key election-related restrictions. The 48-hour silence period before polling day, effective from 5 pm on November 11. 2024, aims to ensure a peaceful and fair election process Mittal emphasized that

after 5 pm on November 11, all forms of election campaigning, including public meetings, processions, roadshows, and rallies, will be strictly prohibited. The use of loudspeakers will also be banned to maintain peace and order in the district. Furthermore, political workers or individuals who are not residents of Purbi Singhbhum district and do not have any electoral connections (such as being a voter or candidate) will not be allowed to remain in the district after the deadline.

"Any non-local political workers or campaigners who are not directly involved in the election process in East Singhbhum will have to leave the district by 5 pm today,' said Mittal.

In addition, the election authorities have ensured that

government and non-government offices, as well as public establishments within the district, will remain closed on the day of voting. A 48-hour dry day has

also been declared starting from 5 pm on November 11 to 5 pm on November 13, during which the sale, distribution, or consumption of alcoholic beverages will be prohibited within the polling In preparation for the

elections, strict monitoring measures have been implemented. Static surveillance teams, flying squads, and expenditure surveillance teams have already seized illegal goods, including liquor, drugs, cash, and gift items, worth more than Rs 10 crore at various inter-state inter-district check-

Voters in East Singhbhum will cast their votes at 1,913 polling booths across the district. On November 12, polling parties will be dispatched from the designated centers at Co-operative College and LBSM College, ensuring smooth logistics for the voting day. Following the polling, all EVMs from the six assembly constituencies will be brought to the Co-operative College for safe storage and counting.

District officials, including Returning Officers for Potka, Jamshedpur Jamshedpur West, and Jugsalai, along with Deputy Election Officer Priyanka Singh and District Public Relations Officer Panchanan Oraon, were present at the press conference.

These measures aim to ensure free, fair, and peaceful elections, as the district prepares for the crucial polls on November 13.

# 11 militants killed in Manipur

leven suspected militants were killed in a gunfight with security forces in Manieur's Tell forces in Manipur's Jiribam district on Monday, officials said. Two CRPF personnel also sustained injuries during the heavy exchange of fire that happened at Jakurador Karong in the Borobekra sub-division. The condition of one of them was stated to be critical.

Militants in camouflage uniforms, armed with sophisticated weapons, fired indiscriminately at the Borobekra police station, and the CRPF camp located alongside it around 2.30 pm, officials said. A few of the militants broke out and went to the Jakurador Karong market, around 100 metres away, and torched several besides attacking some houses, they said. As the security forces militants or went into hiding

retaliated, a heavy exchange of fire began and 11 suspected militants were killed, they added. The gunfight lasted a little over an hour, officials said. A relief camp was also located within the premises of the police station, and five missing, they said.

people living there went It was not clear whether these civilians were kidnapped by the retreating after the attack began, they said, adding that a search was underway for them. The bodies of those killed were brought to the Borobekra police station, officials said. Following the incident, prohibitory orders under Section 163 of the BNSS were imposed in the area, according to a notification. "There is apprehension of widespread disturbance to peace and public tranquillity or a riot or any affray in the area and grave danger to human lives and properties because of unlawful activities of some anti-social elements," said the notification prohibiting assembly of five

or more persons. Borobekra sub-division has witnessed multiple incidents of violence since Iune. It is one of the worst-affected areas of the district. Last week, a 31-year-old woman was killed during an attack on the Zairon Hmar village by armed militants. At least six houses were reduced to ashes in the attack, according to the police. More than 200 people have been killed and thousands

rendered homeless in ethnic violence between Imphal Valley-based Meiteis and adjoining hills-based Kuki-Zo groups since May last year. Ethnically diverse Jiribam, which was largely untouched by the clashes in Imphal Valley and the adjoining hills, witnessed violence after the mutilated body of a farmer was found in a field in June this year. Thousands had to leave their homes and take shelter in relief camps due to incidents of arson. A CRPF jawan was also killed in an ambush by militants during patrolling

# Form special cell to ensure cracker ban implemented: SC

Calling it a mere "eyewash", the Supreme Court came down heavily on the Delhi Police for failing to comprehensively implement the firecracker ban in the National Capital and only seizing raw materials. A bench of Justices Abhay S Oka and Augustine George Masih therefore directed the Delhi Police Commissioner to immediately inform all the stakeholders concerned about the ban order and ensure no sale and manufacture of crackers.

The Bench observed that and Haryana Punjab Governments remained reluctant to act against farmers who resort to stubble burning in the fields, leading to a rise in air pollution. "We direct Delhi police commissioner to form a special cell to ensure effective implementation of the ban on fire crackers. We direct Delhi police commissioner to file a record the steps taken by them to enforce ban," it said. The SC wondered why the Delhi delayed Government imposition of the ban on firecrackers till October 14, when the order of ban was issued.

The right to live in a pollution-free atmosphere is a fundamental right under Article 21 of the Constitution. Prima facie, we are of the view that no religion promotes any activity that promotes pollution or compromises with activity health of the people," observed the bench. The SC further asked the Delhi Government to decide before November 25 on a "perpetual" firecracker after consulting stakeholders.

Observing the reluctance of Punjab and Harvana Governments on taking action, the Bench also asked how the stubble burning incidents had seen a rise on the day of Diwali recently. "How can this happen? How come this increased in Diwali? Why personal affidavit putting on are you sparing your officers?

They are sparing the farmers. Farmers are filing IA [Intervention Application] before us because they are fearing things. And now you all are sparing your officers," the Court asked. In the order, the SC said the

states must explain the nonprosecution of farmers accused of stubble burning. "Even today we find reluctance on the part of governments in taking action under the Section 14 of CAQM Act, 2021. We have observed in earlier orders that instead of direct prosecution, States are still busy in Just issuing show cause notices despite flagrant breaches. States owes explanation to us on non prosecution," it said, directing strict compliance of the rules in this regard. The Bench was hearing the case concerning pollution in Delhi. It is specifically examining the action taken by authorities across Punjab, Haryana and Uttar Pradesh to stubble curb burning



#### Murder trial against Jagdish Tytler will continue: HC

The Delhi High Court on Monday made it clear that the murder trial in a 1984 anti-Sikh riots case against Congress leader Jagdish Tytler would continue. Justice Manoj Kumar Ohri was hearing a plea filed by Tytler seeking a stay on the trial proceedings taking place against him in a Delhi court. The court would continue with the hearing on November 29.

"It is made clear the trial will

continue. Same will be subject to the outcome of the present proceedings," the judge ordered. Tytler's counsel submitted the case was listed for the recording of evidence of a prosecution witness before the trial court on November 12 and the trial court was asked to not proceed till the High Court decided his plea against the framing of charges order. Senior advocate HS Phoolka,

representing the victims, opposed the plea arguing the witness was old and suffered from various ailments and being subjected to multiple appearances. She would be appearing in court for the fourth time, he said.

## **Terrorist Pannun** threatens Ayodhya **Ram Mandir**

Pannun on Monday issued threats targeting Hindu temples, including the Ram Mandir in Ayodhya. In a video by the banned Si



(SFJ) outfit Pannun, currently staying in the United States, and Canada, warned of an attack on November 16 and 17. The video, reportedly recorded Brampton, Canada, is aimed inciting violence against Hindu places of worship.

In his statement, Pannun said, "We will shake the foundations of Ayodhya, birthplace of the violent Hindutva ideology", a direct threat to one of India's most sacred sites. The video shows images of Prime Minister Narendra Modi praying in the Ram Temple during its Pranpratishta in January this year. Pannun has also warned Indians in Canada to stay away from Khalistani attacks on Hindu temples. Last month, Pannun cautioned passengers against flying on Air India flights between November 1 and 19. Pannun claimed the period coincided with what he called the 40th anniversary of the 1984 "Sikh

## Stuck in a crossfire, trekkers dial 100, forces respond and rescue

PIAL 100- An integrated Emergency Response system Sunday came to the rescue of two budding trekkers in Srinagar, who were caught in a crossfire in the Zabarwan forest of Srinagar, following reports of suspicious movement of terrorists in the highly guarded area.

security forces resorted to speculative firing to establish contact with the terrorists spotted in the area, the trekkers, who climbed the hills to themselves in the serene atmosphere, panicked and took shelter behind the rocks to avoid being hit by bullets.

security forces rushed reinforcements to cordon off the entire area one of the trekkers acted smartly and dialled 100 informing the police control room about their whereabouts in the vicinity of the encounter site.

Responding swiftly to the SOS call made by these trekkers the ongoing operation was halted and both the trekkers were rescued by the security forces from the forest area of Zabarwan According to preliminary report the operation was launched in the highly guarded area on Sunday after noticing the suspicious movement of two individuals with rucksacks. The trekkers were later identified as Tariq Ahmad Mir and Mufti Ziyan. They are both employed at a well-known missionary school in Srinagar.

After safely rescuing both the trekkers the police shifted them to a local police station for questioning, where their identities and credentials were thoroughly verified. The duo were released after confirmation that both of them were innocent.

Following the incident, Jammu and Kashmir Police issued an advisory for trekkers and adventurers, urging them to alert local authorities before venturing in sensitive areas and highsecurity zones.

# Campaigning ends on 43 seats for first phase of polls in State

## Polling personnel reach 195 booths by helicopters on Monday

Preparations for voting have
been completed. On Monday,
out of 225, polling personnel
have been sent to 194 polling
stations through heli-dropping. Polling personnel will
be sent to the remaining
booths through heli-dropping
on Tuesday. He said that
there will be no helidropping
in the second phase.

In the first phase, voting will be held on November 13 from 7 am to 5 pm. The voting time at 950 booths will be 4 pm, but people standing in the queue will be able to vote even after the end of the voting time. He said that political leaders and workers who have gone from outside for election campaigning etc. to the polling area have to leave that place immediately. Only those who are voters of that area will be able to stay there. He said that the

Election Commission has a clear guideline that no outsider will stay in the polling area. In this, the decision for exemption in case of illness will be based on the result of the medical board's examination. Kumar was addressing a press conference at Nirvachan Sadan, Dhurva on Monday.

He said that the privacy of voting is mandatory. In this situation, carrying a mobile, taking photos, and making videos inside the polling booth is illegal. There is also a provision of punishment if caught doing so. Action was

also taken after such cases were caught during the Lok Sabha elections.

The Karhal constituency in Uttar Pradesh's Mainpuri district has transformed into a political battleground with the upcoming by-election turning into a crucial test for both the Samajwadi Party (SP) and the Bharatiya Janata

Party (BJP). Representing the SP is Tei Pratap Yadav, grandson of the late Mulayam Singh Yadav, who is fighting to retain the family's political stronghold. His main rival is Anujesh Yadav, a BJP candidate and brother-in-law to SP MP Dharmendra Yadav, who presents himself as a "rebel" from the influential Yadav

family of Saifai. The Karhal seat previously held by SP chief Akhilesh Yadav, who vacated it after winning the Kannauj

BJP's Union Minister SP Singh Baghel. With the seat now vacant, the BJP has strategically fielded Anujesh Yadav to challenge Tej Pratap and make inroads into the

SP's Yadav vote base. "This election is about giving Karhal its share of development. Voters are ready for a double-engine government with Modi at the Centre and Yogi Adityanath in the state," Anujesh said, adding that other communities like the Shakyas, who are second in population only to the Yadavs, are keen to support the BJP for economic

Historically, Karhal has been an SP fortress. Since 1993, the SP has won six of the seven elections held, with the BJP only managing one victory in actively supported her.

seat in the 2024 Lok Sabha election. Akhilesh won has maintained its Karhal in 2022, defeating dominance, but the BJP's focus on a Yadav candidate has intensified the contest, raising questions about shifts in the constituency's political

alignment. Local journalist Neeraj Mehre commented, "The BJP hopes to replicate its 2002 success. However, the Yadavs' loyalty to the SP and their historical ties with the Mulayam family make this a formidable

challenge." Akhilesh Yadav and his wife and Mainpuri MP Dimple Yadav, has been at the forefront of Tej Pratap's campaign. Dimple, known for her close ties with voters in the region, has led door-todoor interactions, senior family members like Shivpal Yadav Dharmendra Yadav

Notably, Tej Pratap previously represented Karhal from 2014 to 2019 after winning a by-election following Mulayam Singh Yadav's resignation. Married to Lalu Prasad Yadav's daughter Raj Lakshmi, Tej Pratap also carries the political legacy of the Yadav clan.

With Karhal's electorate of approximately 3.75 lakh voters, the Yadavs comprise the largest share at around 1.3 lakh, followed by Scheduled Castes (60,000), Shakyas (50,000), Thakurs (30,000), and other communities. The BJP's choice of a Yadav candidate is seen as an effort to fracture this vote base, while the Bahujan Samaj Party (BSP) has fielded a Shakya candidate, potentially dividing the vote further. Additionally, the entry of Chandrashekhar Azad's Azad's candidate may siphon off Dalit support, adding complexity to the SP's traditional advantage.
BJP district president Rahul Chaturvedi confidence in Anujesh's local connections and the development track record the Yogi-Modi under administration. "Karhal has benefited from our crime-free governance, and the people want to see more development," he stated. While the BJP seeks to

penetrate this SP bastion, the SP leadership romains SP leadership remains optimistic. An SP leader said that disillusionment among farmers and youth with the BJP government strengthens Tej Pratap's chances.

## **India bears the brunt**

This year's high death toll and losses due to climate change underscore the urgent need for policy action

ith over 3,200 fatalities, extensive crop damage across 3.2 million hectares, and 2.3 lakh buildings destroyed in the first nine months of 2024 alone, the country's vulnerability to extreme weather events is undeniable. These findings of the 'India Climate Report 2024' from the Centre for Science and Environment (CSE) give a shocking picture of the impact of climate change on the country. The report underscores that 93 per cent of the days between January and September were marked by extreme weather, a clear indication that climate-related disasters are becoming not only more frequent but also more severe. The report's findings reveal a staggering increase in extreme weather events. In 2024, India faced climate extremes on 255 out of 274 days, a record when compared to previous years. Notably, over 35 of the 36 states and union territories experienced such events, with states like Karnataka, Kerala and Uttar Pradesh witnessing over 40 additional days of climate extremes compared to 2023.



The grim statistics point to a significant toll on human life and livelihoods. Kerala, Madhya Pradesh and Assam were the hardest-hit states in terms of fatalities, while Andhra Pradesh saw the greatest destruction of homes, and Maharashtra experienced the largest crop damage. Among the notable phenomena in 2024 were prolonged heatwaves and an unprecedented number of warm nights. Besides, the monsoon season was particularly disastrous, with heavy rains, floods and landslides occurring every single day from June through September. Assam, for example, faced extreme weather on 111 days out of 122, highlighting the relentless impact of intense rainfall and flooding. The 2024

India Climate Report also points to a significant data gap. While the India Meteorological Department (IMD) has made strides in tracking events like warm nights, it lacks absolute temperature benchmarks, which many other countries use to enhance climate data accuracy. The lack of comprehensive, real-time data on climate-related damages impedes effective planning and resource allocation, especially in vulnerable regions. Several factors have contributed to India's vulnerability which must be addressed. The lopsided development, scant regard to the climate impact and allowing reckless construction in hills must stop. This pattern of 'bad development' worsens the impact of natural disasters, transforming regions with poor infrastructure or unplanned urban sprawl into highrisk areas. As the world approaches the dangerous threshold of 1.5°C of warming above pre-industrial levels, India's situation signals the urgent need for effective climate policies, mitigation strategies and public awareness. The 'India Climate Report 2024' serves as a somber reminder of the escalating costs of climate inaction. A collective and urgent response is needed, one that includes better data collection, sustainable urban planning and policies aimed at reducing greenhouse gas emissions. Only then can India hope to protect its people and environment.

onald Trump has made history by winning the 2024 US Presidential election, securing 292 Electoral College votes and defeating Kamala Harris, the media's favoured candidate. His resounding victory marks a significant comeback and has reignited debates globally about what his second term might bring. This election wasn't without its drama, as Trump survived an assassination attempt on September 15, 2024, amid allegations of interference from powerful interest groups attempting to prevent his reelection. ## **FIRST COLUMN BREAKING THE CYCLE OF BURNOUT**

Addressing mental health with managerial support is essential for a healthy workplace



umerous studies found that high job demands, low control, low social support and job insecurity are significant risk factors for depression in the workplace while, factors such as excessive workload, lack of control, poor work-life balance and unsupportive work environments trigger burnout. Research in all these areas has grown substantially in recent years, revealing valuable insights into how these mental health challenges affect individual employees and organisations. In today's fast-paced and highpressure work environment, burnout and depression have become prevalent challenges affecting employees across industries. While burnout is often a result of chronic workplace stress characterised by exhaustion, cynicism and a feeling of reduced accomplishment, depression on the other side, is a mental health disorder marked by persistent sadness, lack of motivation and feelings of hopelessness that may affect all areas of a person's life.

Both can severely impact employee wellbeing, workplace productivity and organisational success. Burnout and depression in the workplace are typically rooted in multiple factors often exacerbated by modern work conditions and expectations such as excessive workload and unrealistic expectations, lack of control and autonomy, poor work-life balance, toxic work environment and insufficient recognition and reward. There is no denying that when employ-



ees lack the time and resources to recover and recharge or have no input into their work, their sense of helplessness can contribute to both, they become more susceptible to burnout and over time, even depression. Moreover, a hostile or untrusting work environment can erode employee morale and mental health contributing to burnout and, in some cases, even depression. The impact of burnout and depression extends beyond individual suffering and affects the workplace as a whole.

As stated earlier, to maintain productivity, employees experience burnout and depression which may consequently lead to decline in productivity thereby impacting the profitability and overall performance. It is quite often stated that absenteeism and presenteeism both have significant implications for workplace productivity and team morale. Now when the levels of burnout and depression within an organisation are high, it will create a culture of dissatisfaction, resulting in a lack of engagement and trust among employees and as a result can harm collaboration, innovation and the company's reputation, thereby making it difficult to attract and retain top talent. It will end up driving employees to leave their jobs in search of a healthier work environment. Addressing burnout and depression in the workplace requires both—structural changes within the organisation as well as individual efforts. By creating a culture where employers foster an environment that values open communication and employees express concerns without the fear of stigma or reprisal; training managers to identify symptoms of burnout and depression and to respond effectively; providing small gestures of appreciation through praise, bonuses, or other rewards can significantly improve job satisfaction, and help in reducing stress and the likelihood of burnout. Organisations can create a healthier, more productive and more sustainable work environment where employees and the company can thrive.

The new US President's economic policy is expected to focus on higher tariffs on all imports – 10 per cent across the board, and as high as 60 per cent on those from China, restrictions on immigration as well a reduction of corporate tax rate to 15 per cent for all companies man-ufacturing in the US. All this could eventually fuel higher inflation in the US and subsequent action by the Federal Reserve. For India, it could impact key export sectors such as pharmaceuticals, textiles and IT ser-

This may affect sectors where India has maintained high tariffs to protect domestic industries, such as agriculture and manufacturing. This is a highly sensitive issue for the Indian policymakers. The NDA government has taken conscience steps to ensure protection for the domestic griculture and otner sectors. The IT companies, like TCS, Infosys and Wipro, rely heavily on the US for both revenue and talent deployment. "It could make Indian exports less competitive in the US market, impacting revenue," says a report by the economic think tank Global Trade Research Initiative (GTRI). It may hit China the most being the largest US trade partner. Many Indians believe that Indian exporters could benefit from the vacuum created as they also expect to fill the Bangladesh garment export fall by 6.2 per cent.

The expectations may not be a reality, as the US itself strives to be a manufacturing hub, which is termed "America First". Besides, if a new tariff regime begins it may require intense effort and allowing concessions for increasing Indian exports. While the

barriers are high, apart from the government's diplomacy, some large companies are already in touch with the Trump coterie to mollify the issues as they are keen on setting up new ventures in the US or with US companies. His previous immigration policies affected Indian professionals,

especially those reliant on H-1B visas. Stricter immigration controls may hinder the mobility of Indian IT workers and engineers to the US, posing potential chal-lenges for the Indian tech industry. The IT companies are giving preference to indigenous US workers. It reduces opportunities for new entrants. India's leading status as a generic drug exporter to the US could be hit with new regulatory hurdles and tariffs, impacting companies like Sun Pharma and Dr Reddy's. Additionally, India's steel and aluminium industries may suffer if Trump reinstates tariffs on these metals, as he did during his previous term. His preference for fossil fuels and his resistance to international climate commitments could discourage joint US-India investments in renewable energy, a priority for India. It could impact Indian solar and renewable energy companies.

Trump's support for India in defence and security matters is unpredictable. His prior attempts to mediate between India and Pakistan on issues like Kashmir created unease in New Delhi, which values its autonomy in regional matters. Possibly sensing this China entered into a border agreement with India after four years of logjam. An Indian concern is that the West Asia war zone extends to Iran now. India is simultaneously developing ties with the Taliban in Afghanistan. The recent rate cut by the US Fed

Reserve and the latest presidential polls have disturbed Indian stock markets, which continue to fall. Along with this, rupee parity with the dollar touches new lows with a one-day fall of 21 paise to Rs 84.30 on November 6 and a further decline to Rs 84.38 on November 8. It may go down to Rs 85, the market says. There are also positive aspects in the US-India relationships, which

Trump ensured earlier too.
His personal equation with Prime
Minister Narendra Modi had warmed up the ties. It is expected that high-profile events like Howdy Modi in Houston and Namaste Trump at Ahmedabad will be repeated to cement public engagements, and personal diplomacy and strengthen people-to-people ties. Indian exports and trade with the US might increase under Donald Trump for several reasons, despite his protectionist America First stance India, with its growing manufacturing sector and cost advantages, emerged as a potential alternative to China for certain goods. If Trump continues to push for decoupling from China, India could benefit by positioning itself as a substitute supplier in many areas including semiconductors. Despite many issues, it is expected that US firms moving away from China could set up shops in India. Some like Ford set up 200,000 vehicle manufacturing units in Chennai for exports. McDonald's is also expanding. Ups and downs apart, India and the US are likely to have better ties for strategic reasons by engaging in intense negotiations also to end proposed sanctions against 19 Indian companies.

## Women waste pickers in India: Transforming waste management amidst challenges

#### Recognising the intersection of caste, gender and class in the waste sector is essential to building a cleaner, more equitable world for all

n India, women waste pickers play a vital role in ▲ waste management, particularly in urban and semiurban areas. They are part of a larger, often invisible workforce within the informal waste sector, which comprises around 1.5 million workers. These women, mostly from marginalised backgrounds, undertake roles in waste collection, sorting, and sometimes even in supervisory capacities. Despite contributing significantly to recycling operations, they earn approximately 33 per cent less than their male counterparts, underscoring deep-rooted gender inequalities in this

The rise of initiatives like the Swachh Bharat Mission



(SBM) has shifted the land scape of waste management in India. Many Urban Local Bodies (ULBs) now employ more women in front-end roles, such as door-to-door waste collection and material sorting at Material Recovery Facilities (MRFs). This inclusion has led to improved Swachh Survekshan rankings for

enhanced cleanliness and waste management efficiency. Despite this progress, women waste pickers continue to face multifaceted challenges, including genderbased violence, caste discrimination and limited economic mobility.

Case Studies: Studies from cities like Ambikapur, Bengaluru, and Tinsukia highlight the significant positive changes brought about by involving women in waste management.

Ambikapur, Chhattisgarh: With a population of around 146,000, Ambikapur became the cleanest town in its population category, mainly due to a large female workforce in waste management. Out of 550 jobs created, 457 were an 80 per cent female workforce that greatly contributed to cleanliness and operational efficiency. Bengaluru, Karnataka: In

collaboration with the NGO Hasiru Dala, Bengaluru created over 1,200 jobs in the waste sector, with 92 per cent occupied by women. These women played various roles, from collecting fees to supervising sorting operations, positively impacting the city's cleanliness and Swachh Survekshan rankings.

Tinsukia, Assam: Once one of the dirtiest towns in Assam, Tinsukia witnessed a remarkable transformation due to the involvement of women waste workers employed by an NGO. Of 108 jobs created for waste these ULBs, reflecting filled by women, resulting in collection and supervision,



46 were allocated to women, enabling the town to achieve the status of the fastest-moving clean city in its category. Challenges Faced by **Women Waste Pickers:** Despite their essential con-

tributions, women in the waste sector face a range of difficulties. Hazardous working conditions expose them to toxins and diseases and their work often goes unrecognised. Many women waste pickers are Dalits or women in waste manage-

Adivasis who endure societal stigma, which reinforces their marginalisation and limits their social mobility. They lack access to formal recognition, fair wages and safety measures, making them some of the most vulnerable in India's workforce. The absence of specific policies addressing women waste pickers aggravates these issues. The informal nature of their work, coupled with limited research on gender dynamics in waste management, restricts policy interventions, leaving women out of leadership roles and decision-making processes.

Intersection of Caste and **Gender in Waste Work** Caste adds another layer to the marginalisation of

work," waste picking and sorting are stigmatised, especially for women from marginalised castes. This reinforces social hierarchies that exclude them from fair participation and economic upliftment. Scholars like Nancy Fraser and Martha Chen emphasise that caste and gender intersectionality compounds discrimination, limiting women's bargaining power and political representation in waste management. Addressing such complex intersections requires policies that recognise these overlapping identities and create inclusive opportunities for women waste pickers. To address these challenges and create a more equitable

policies should adopt a gender-sensitive approach, ensuring that women have access to leadership roles and opportunities for entrepreneurial development. By promoting women in management roles, their economic empowerment and social standing can be enhanced.

Trump is scheduled to be sworn in as the 47th President of the United States on January 20, 2025. Ukraine has been

informed about the Trump-Putin call.

"During the call, which Trump took from his resort in Florida he advised the Russian president not to escalate the war in Ukraine and reminded him of Washington's sizable military presence in Europe, said a person familiar with the call, who, like others interviewed for this story, spoke on the condition of anonymity to discuss a sensitive matter," The Washington

Post reported. However, Kremlin spokesman Peskov in Moscow said the Western media reports of the phone call between Putin and Trump are "untrue", state-run TASS news agency reported.

"There was no conversation.. This is completely untrue; it's pure fiction," Peskov said. Meanwhile, Steven Cheung,

Trump's communications director, told PTI he would not comment on the private calls between President-elect Trump and other world leaders.

"President Trump won a historic election decisively and leaders from around the world know America will return to prominence on the world stage. ## Japan's parliament re-elects Ishiba as PM despite his coalition's recent loss

Japan's parliament reelected Prime Minister Shigeru Ishiba on Monday after his governing coalition suffered the worst election loss in more than a decade. forcing the struggling leader to form his second Cabinet in just over a month since taking office. Ishiba's ruling Liberal Democratic Komeito together lost their majority in the 465-seat Lower House, the more powerful of Japan's two-house parliament, in the Oct 27 election due to continued voter outrage over financial misconduct by his party and its lukewarm response.

A special parliamentary session convened Monday to pick a new leader in a vote required within 30 days of a general election. Ishiba beat top opposition leader Yoshihiko Noda 221-160 in the first runoff in 30 years.

Ishiba reappointed most of his previous Cabinet members, including Foreign Minister Gen Nakatani and Chief Cabinet Secretary Yoshimasa Hayashi, but had to replace three who lost seats or were affected by the election results. Ishiba is expected to hold a news conference to explain his new Cabinet and policies. Ishiba has refused to step down

and showed willingness to cooperate with additional coalition partners to boost stability and help him pursue his party's policies. Ishiba will struggle in the coming months as he must gain consent from the opposition on policies including the budget and other legislation, experts

servative opposition, the Democratic Party for the People, whose seats quadrupled to 28 under its popular leader Yuichiro Tamaki, whose proposal for raising the basic tax-free income allowance and increasing takehome wages garnered support

from low income and younger voters. Tamaki only wants to cooperate with Ishiba's party on policy — not as part of a coalition — since he wants to use his leverage to increase his party's standing ahead of the next election. However, Tamaki was recently stung by a magazine article exposing an extramarital Monday.

Ishiba's government is preparing for his trip later this month to Asia Pacific Economic Cooperation and Group of 20 summits, as well as a possible meeting with President-elect Donald Trump on his way home.

## **Trump names Tom Homan as** 'border czar'

**AP** NEW YORK

President-elect Donald Trump says that Tom Homan, his former acting US Immigration and Customs Enforcement director, will serve as "border czar" in his incoming admin-

"I am pleased to announce that the Former ICE Director, and stalwart on Border Control, Tom Homan, will be joining the Trump Administration, in charge of our Nation's Borders," he wrote late Sunday on his Truth Social site. Homan was widely expected to be offered a position related to the border and Trump's pledge to launch the largest deportation operation in the country's history. In addition to overseeing the southern and northern borders and "maritime, and aviation security," Trump said Homan "will be in charge of all Deportation of Illegal Aliens back to their Country of Origin," a central part of his agenda.

He says he had "no doubt" Homan "will do a fantastic, and long awaited for, job." Such a role does not require Senate confirmation.

In an interview on Fox News Channel's "Sunday Morning Futures," Homan said the military would not be rounding up and arresting immigrants in the country illegally and that ICE would move to implement Trump's plans in a "humane manner.'

## China working on nuclear propulsion for new aircraft carrier

China has built a land-based prototype nuclear reactor for a large surface warship, in the clearest sign yet Beijing is advancing toward producing its first nuclearpowered aircraft carrier, according to a new analysis of satellite imagery and Chinese government documents.

China's navy is already the world's largest numerically, and it has been rapidly modernising. Adding nuclear-powered carriers to its fleet would be a major step in realising its ambitions for a true "blue-water" force capable of operating in seas far from China in a growing global challenge to the United States.

"Nuclear-powered carriers would place China in the exclusive ranks of first-class naval powers, a group currently limited to the United States and France," said Tong Zhao, a senior fellow at the Carnegie Endowment for International Peace in Washington, DC

"For China's leadership, such a development would symbolise national prestige, fueling domestic nationalism and elevating the country's global image as a leading

nower. Researchers at the Middlebury Institute of International Studies in California said they made the finding while investigating a mountain site outside the city of Leshan in the southwest Chinese province of Sichuan, where they suspected China was building a reactor to produce plutonium or tritium for

Instead they concluded that China was building a prototype reactor for a large warship. The project at Leshan is dubbed the Longwei, or Dragon Might, Project and is also referred to as the Nuclear Power Development Project in documents provided to The Associated Press. Neither China's Defence Ministry nor Foreign Affairs Ministry responded to requests for comment. There have long been rumours that China is planning to build a nuclearpowered aircraft carrier, but the research by the Middlebury team is the first to confirm that China is working on a nuclear-powered propulsion system for a carrier-sized surface warship.

"The reactor prototype at Leshan is

the first solid evidence that China is,

in fact, developing a nuclear-pow-ered aircraft carrier," said Jeffrey Lewis, a professor at Middlebury and one of the researchers on the project. "Operating a nuclear-powered aircraft carrier is an exclusive club, one that China looks set to join." Drawing on satellite images and public documents including project tenders, personnel files, environ $mental\ impact\ studies -- \ and\ even$ a citizen's complaint about noisy construction and excessive dust - they concluded a prototype reactor for naval propulsion was being built in the mountains of Mucheng township, some 70 miles (112 kilometers)

southwest of Sichuan's provincial capital Chengdu.

It is alleged that Khan and his wife caused a loss to the tune of GBP 190 million or over PKR 50 billion while facilitating a property tycoon.

Khan's counsel Salman Safdar received the questionnaire in the presence of both the accused in the last hearing. The couple was directed to submit their responses to the court on

In the November 7 hearing, lawyers for Khan and Bushra completed the cross-examination of the last and 35th witness at Adiala jail, taking the case conclusion to the final stage. As per the charges of the case Khan and other accused allegedly adjusted PKR 50 billion sent by Britain's National Crime Agency (NCA) to the Pakistani government as part of an agreement with a property tycoon.

Subsequently, the then-prime minister Khan got approval for the settlement with the UK crime agency from his cabinet on December 3, 2019, without disclosing the details of the confidential agreement.

# RBI issues framework for reclassification of FPI to FDI

The Reserve Bank of India (RBI) on Monday issued an operational framework for reclassification of investment made by a foreign portfolio investor to foreign direct investment (FDI) if the entity breaches the prescribed limit. Currently, an investment made by foreign portfolio investor along with its investor group (FPI) should be less than 10 per cent of the total paid-up equity capital on a fully diluted basis.

Any FPI investing in breach of the prescribed limit has the option of divesting their holdings or reclassifying such holdings as FDI subject to the conditions specified by the RBI and Sebi within five trading days from the date of



settlement of the trades to FDI causing the breach. As per the framework, the The RBI has issued an FPI concerned will have to

# Barcelona hit by absence of injured Yamal, loses to Sociedad in Spanish league

MADRID: Missing injured Lamine Yamal, Barcelona saw its seven-game winning run come to an end with a 1-0 loss at Real Sociedad in the Spanish

Yamal, one of the team's key players this season under new coach Hansi Flick, was ruled out before the game because of a right ankle injury.
He was replaced by Fermín López and the teams attack - by far the best in the league with 40 goals scored in 13 matches - struggled in the Basque Country, unable to get a single attempt on target against Sociedad.
Sheraldo Becker scored a 33rd-

minute winner to move Sociedad, which had lost two of its last three games in all competitions, to eighth place. Barcelona has a six-point lead over second-place Real Madrid, which routed Osasuna 4-0 at home on Saturday with a hat trick from Vinícius Júnior. Madrid has a game in hand



after its visit to Valencia was postponed because of the deadly floods in the Valencia region. Barcelona striker Robert Lewandowski, the league's leading scorer with 14 goals, had a first-half goal disallowed for offside.

Yamal injury

Barcelona said Yamal sustained

a "severe right ankle contusion" in last Wednesday's game against Red Star in the Champions League. "Over the past few days, he has undergone treatment, but the discomfort has yet to subside. His recovery will determine his availability," the club said. Flick said the club tested Yamal

on Sunday to see if he could play "but it was not possible."
